

Strike At Dacron Is Started

Second Major Work Stoppage At Plant By Picket Line; Pay Hike Sought

GRIFTON—Labor trouble which cropped up a few miles from here this morning caused the second major stoppage on construction work at Du Pont's multi-million Dacron plant in less than two months. Between 1,000 and 1,200 workers were estimated to be off their jobs today as they observed the three-man picket line thrown up at the entrance of the plant site at 6:45 this morning.

The picketing was being done by members of the Construction and General Laborers Union (A.F. of L.) which a spokesman said represents approximately 250 union members working on the Du Pont project. Although official information on the strike was scarce this morning, J. L. Dew of Wilmington, business manager of local 1102 of the Construction and General Laborers union, told a reporter that members of his union had struck for a 15-cent an hour wage increase. Dew said the increase had been allowed by a ruling last week by the Wage Stabilization board, and that the union decided Tuesday night to call the strike for higher pay.

Policemen Named As Justices Of Peace By Scott

Governor W. Kerr Scott has appointed four members of the police department justices of the peace. The commissions were issued without any limitations upon jurisdictional authority as justices of the peace.

The governor's letter accompanying the commissions of appointment states: "It is understood by me that this commission is desired by you only to enable you to exercise all the rights, privileges and powers useful and necessary to issue warrants and fix bonds while in the performance of your duties as peace officers in the city of Greenville."

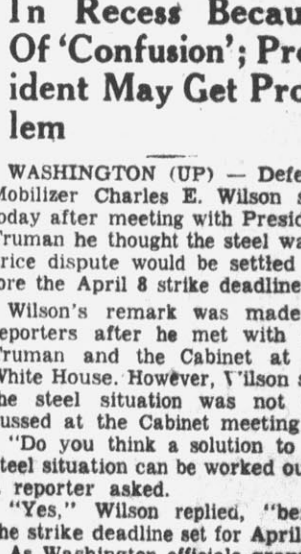

But many a person is not able to resist the temporary relief which comes from smothering a portion of his brain and thereby snuffing him for the time being to forget or to evade.

That this is a tragically unwise way to approach any problem goes without saying. We need always to remember that life is a school and that the Master in charge of that school puts problems before us with the expectation that we will work them out, and grow in so doing. To toss the problem into the wastepaper basket is only to pile up trouble for ourselves on that day when the final examination will be held.

And for every one of us there is a final examination in prospect. The Bible calls it Judgment Day. It occurs many times (spelled with small letters, and finally spelled in caps).

Tar Heel Promotion Is Paying Dividends

The state of North Carolina is becoming more promotion conscious all the time, and it is paying off for Tar Heelism not only in dollars, but in a lot of good publicity as well.

Not only is the state bureau of advertising spreading the fame of North Carolina around the nation through its program, but individual cities and business organizations as well are spreading the good word that is bringing outsiders into the state off and on during each year.

The Azalea Festival in Wilmington this week-end is attracting thousands of people from various parts of North Carolina and other states as well. North Carolina's coastal and mountain resorts bring in out-of-state people by the thousands each summer. The Singing on the Mountain and numerous other annual affairs started as local projects are gaining recognition which reaches beyond the boundaries of the state.

All of them, large and small, are helping to carry North Carolina to the fore in the minds of people in other parts of the nation.

It took a long time for the state to become conscious of the many things it could offer visitors and residents, but now that North Carolina is promoting itself, the efforts are paying dividends and promising even larger ones in the future.

One Way To Get The Answers

It is going to be interesting to watch the two million dollar "libel, slander and conspiracy" suit which boisterous Senator McCarthy of Wisconsin has filed against Senator Benton of Connecticut.

There are few high government officials in the nation who have not come under the heated blasts from McCarthy in the past several years. He has made a great many charges about Communist infiltration of the government in his Senate speeches, but in few instances has he offered concrete evidence to back up his claims.

His blasts have made headlines and the government effort to root out Reds has made headway, but a direct connection between the two remains doubtful in our minds.

Senator Benton was a key figure in a movement to have McCarthy ousted from his seat in the legislative body because of perjury, fraud and calculated deceit of the American people which Benton said McCarthy was guilty of in his anti-Red campaign.

Whether the two-million dollar suit will ever actually come to trial remains to be seen, but we seriously doubt it will. If it does, it will be a spectacle for the American people to observe. It should bring forth the answers to a great many questions which have been raised about McCarthy during his stay in the Senate.

A Buck The Citizens Can Not Pass

Just seven more days remain in the filing period for the municipal elections in Greenville, and the field is still wide open for candidates.

As a matter of fact it is so wide open, we are beginning to wonder if there are any well qualified citizens in Greenville who are interested in having a seat on the governing board of the city.

When the city offices closed yesterday afternoon there was not a single candidate registered for the coming election, and only two of the four incumbents whose terms expire June 30 had indicated publicly they would seek re-election. Alderman J. E. Waldrop of the fifth ward has said officially he will not seek re-election, so that leaves the fifth ward without an immediate prospect for the office.

The Reflector is deeply concerned about the pathetic lack of interest in city government shown by the citizens of Greenville.

Here is Greenville, a city of upwards of 17,000 people with a property valuation of \$19,000,000 on the tax books. Each year the city government collects and spends more than \$350,000 of the taxpayers money.

Yet when it comes time to select the men who will sit on the board of aldermen—the board of directors of the city's business—the posts practically have to go begging.

How can the people of the city expect to have the efficient, progressive government they want if they do not take an interest in the city's business, and in seeing that good men are chosen from a good field of candidates for the places on the board of aldermen?

The members of the city administration come under a lot of criticism for the manner in which the city business is handled; but fundamentally, the shortcomings are the fault of the city's citizens who year after year fail to take an interest in city government affairs.

National Whirligig

WASHINGTON—A generally unrecognized anti-Truman development is the fact that so many of the men who have been chairman of the Democratic National Committee since 1920 oppose his renomination. Also lined up against him are two former secretaries of state—Cordell Hull of Tennessee and James F. Byrnes of South Carolina.

For reasons of partisan loyalty, some of the men named below may choose to issue formal denials of this statement, which is their political prerogative. Such denials are an old and accepted Washington custom, especially in a hard election year involving control of the White House and Congress.

PREFERENCE—The hostile list begins with 80-year-old George White, former governor of Ohio. Now wintering in Hobe Sound, Fla., he maintains business and banking connections in his home at Marietta, O. He also keeps a few fingers in state and national politics.

Mr. White was named national chairman by James M. Cox of Ohio in 1920, when he and Franklin D. Roosevelt headed the Democratic ticket. Mr. White admits that he favors Senator Taft, although he would probably support General Eisenhower, if the latter wins the nomination.

Mr. Hull, who served in the mid-twenties, is ill and old. Although Truman has tried to carry out certain of his foreign policies, he has been unable to make them effective. It is understood that the venerable Tennessee likes Eisenhower, with a preference for Governor Stevenson and Senator Russell on the Democratic side.

TIES—F. D. R.'s three national party leaders—James A. Farley, Ed Flynn and Frank C. Walker—are reported to be in the Stevenson camp.

"Big Jim" quit F. D. R.'s political household because he could not go along with the violation of the two-term tradition. The same reasoning, as well as other factors, would lead him to prefer another candidate than Truman next November.

In and out of office, Mr. Farley has always had friendly ties with the southern statesmen now in revolt against the "fair deal." The late Carter Glass of Virginia, as well as Senator Byrd of the same state, a Russell sponsor, were two of his closest friends on Capitol Hill.

STANDARDS—Mr. Flynn's reasons for opposition are eminently practical. The Bronx boss doubts whether he could elect or reelect his borough, state and Congressional candidates, if the Missouriian heads the ticket next fall. Their success is far more important to his tenure in New York City politics than the return of Truman to the White House.

Mr. Walker never liked politics. He endured its demands only out of personal friendship and admiration for F. D. R. But in view of his high ethical standards, and his detestation of the Pendleton type of politics, he will make no efforts on behalf of the White House incumbent. He is understood to favor Stevenson against the field.

Clem Shaver of West Virginia is also reported to be of the reservation. He was John W. Davis' selection for the national chairmanship, when the New York lawyer headed the ticket in 1924. The late Mr. Davis joined with several Democratic leaders, including former Chairman John J. Raskob, in protesting against a third-term nomination for F. D. R.

LONESOME—Now, in view of Truman's open break with his hand-picked chairman, Frank E. McKinney of Indiana, the man from Missouri, as he admits in his recent autobiography, "Mr. President," is a "very lonesome man."

His principal and most active promoters for renomination are his White House cronies, Secretary Matthew J. Connelly and Major General Harry H. Vaughan, his World War I buddy and military attaché.

Around Capitol Square

Reflector Bureau By LYNN NISBET Am. Afternoon Dallas

FIXED—Several inquiries have been received at State Democratic Headquarters about holding precinct meetings and county conventions on dates other than those set by the state committee. Chairman Everett Jordan has advised that no change can be made in the date of the precinct meeting, since the Party Plan of Organization specifies that the state committee shall fix a common date. The precinct meeting can be held at any time during the day of May 10 that is most convenient for the voters. Customarily rural precincts hold their meetings in the afternoon, urban precincts at night. Majority of the county elections are held at noon on Saturday, May 17, but if it is desired in any county to have an earlier or later session it can be legally held on that day.

CONFUSING—Another major cause of confusion is the separate registrations required for state-county and municipal elections. To a lesser degree the extra registration sometimes called for in cases of special tax or bond elections. It can well happen that a person who has registered and voted twice at the same polling place within the past year will still be unregistered and ineligible to vote so far as the upcoming primary is concerned. Though cooperative action of Wake County and the City of Raleigh, precinct lines within the corporate limits of the city have been made to conform with county precinct lines and a unified single registration scheme adopted which is designed to eliminate confusion in the future. Similar action may have been taken or planned in other communities. That means, however, that not a single citizen living in Raleigh can vote in the May 31 primary unless he or she gets the name properly entered on new registration books sometimes between 9 a. m. May 3 and sunset on Saturday, May 17.

PROCEDURE—Precinct registrars are required by law to have the books at the polling places between 9 a. m. and sunset on each of the three Saturdays—May 3, 10 and 17. At other times the citizen desiring to register must seek out the registrar at his home or business office. In every instance responsibility rests upon the person desiring to register to ascertain the proper precinct and find the registrar. It is permitted, but not required by statute, for the registrar to carry the book around through the precinct for convenience of the citizens. It is not legal for the registrar to enter any name on the book except in presence of the person desiring to register to ascertain some years ago of precinct workers accumulating lists of names and having them registered without their personal appearance is definitely unlawful. After the sun goes down on May 17 there is no legal way for a citizen not registered to qualify as a voter in the May 31 primary. There are provisions for registering in special cases on general election day.

QUALIFICATIONS—Proper registration is an absolute prerequisite for the right to vote. The statutes set out qualifications for registrants in negative form by listing those not allowed to register and vote as follows: "First, persons under 21 years of age; second, idiots and lunatics; third, persons who have been convicted or confessed their guilt in open court, upon indictment, of any crime the punishment of which is now or may hereafter be death; fourth, persons who have been convicted or confessed their guilt in open court, upon indictment, of any crime the punishment of which is now or may hereafter be imprisonment for more than one year; fifth, persons who have been convicted or confessed their guilt in open court, upon indictment, of any crime the punishment of which is now or may hereafter be imprisonment for more than one year; Luke, Physician and Historian

HE WAS ST. PAUL'S LOYAL FRIEND AND COMPANION

Scripture—Luke 1:1-4; Acts 1:1-2; 16:6-10; 27:27; 28:1-10; Colossians 4:14; II Timothy 4:11.

By NEWMAN CAMPBELL WHY DO people write books? Some write text books of information because they wish to instruct others with their knowledge or to share it with others. Some have very active imaginations and feel that what they visualize — characters, plots, scenes, etc.—will make good stories that others will read—and from which they will make money.

In our last lesson we read of St. Paul's vision of the man from Macedonia who asked help for his country. Luke was with him then. The 27th chapter of Acts tells of their determination to sail to Italy, and of the great storm that they encountered—a vivid and exciting story indeed. He writes of the 14th night when their boat was being driven up and down in Adria, and about midnight the shipmen thought that they drew near to some country.

Still others, whose lives seem to them to have been interesting, wish to tell of their experiences in a book; or of adventures in far-off lands among strange people, feeling the world will be interested in their wanderings and in such unfamiliar places and people. Some write to cheer the world up with their wit and wisdom, and some write of our times so that we may, perchance, get a better look at what is going on in the world, or to instruct future generations about what occurred before they were born. That is history.

Swimming on "boards, and some on broken pieces of the ship," they escaped to land. When they reached shore "they knew that the island was called Melita." The "barbarous people" showed them great kindness; "they kindled a fire, and received us every one, because of the present rain, and because of the cold." Paul gathered a bundle of sticks for the fire, and a viper "came out of the heat, and fastened on Paul's hand." The people thought Paul must be a wicked man and the viper would kill him as punishment. However, Paul shook the reptile off into the fire and was unharmed. Seeing this the barbarians decided he must be a god.

St. Luke, the physician, a fine writer, wrote to acquaint his

friend, Theophilus, evidently a fellow Greek Christian, so that he might better understand the faith that he possessed.

Did you know that Luke—a Gentle who had never seen Christ—wrote more of the New Testament than any of the other writers? He wrote the Gospel According to St. Luke, and also the Acts of the Apostles—and what beautiful books they are!

The chief man of Melita was named Publius, and his father was very ill with a fever. Paul visited him, and as he entered the room where the man lay, "he prayed, and laid his hands on him, and healed him."

He begins: "Forasmuch as many have taken in hand to set forth in order a declaration of these things which are most surely believed among us."

After that other came who had diseases and were healed. So the castaways were loaded with honors.

"Even as they delivered them unto us, which from the beginning were eyewitnesses, and ministers of the word; it seems good to me also, having had perfect understanding of all things from the very first, to write unto thee in order, most excellent Theophilus."

In writing to the Colossians, Paul stated that Luke, the beloved physician, sent his greetings. Luke apparently was not only Paul's physician, but his constant companion, in or out of prison.

The Book of Acts is also addressed to Theophilus and speaks of "the former treatise" that he had written, "of all that Jesus began both to do and teach."

In writing his last letter to Timothy, whom he called his "beloved son," on the eve of his martyrdom, Paul says, "Only Luke is with me. Take Mark and bring him with thee: for he is profitable to me for the ministry."

"Until the day in which He was taken up, after that He through the Holy Ghost had given commandments unto the Apostles whom He had chosen."

The Gospel of St. Luke is called the gospel of humanity. It is also the gospel of womanhood. He gives us the story of the annunciation to Mary, of Mary's song of praise to God, her visit to Elizabeth; of Simeon's words to Mary in the temple; the story of the widow of Nain, of the ministry of the women from Galilee, of Jesus' visit to the home of Mary and Martha, and the account of the women at the crucifixion.

St. Luke was a good reporter. Doubtless he had questioned the Apostles minutely on all phases of Christ's life and works and of their association with Him. He was an extremely accurate reporter and historian.

His is also the gospel of the world Saviour.

The report by the News and Observer that Bill Dole can go to Davidson if he wants to seems to have come as a big surprise to everyone. Including Dole.

The East Carolina football coach couldn't be reached despite numerous attempts to contact. However, the News and Observer this morning quoted him as saying last night that he was "quite surprised." Dole went on to tell the News and Observer sports department that the news came "as a shock." He said he has no contacts at Davidson and, furthermore, had not even considered the job.

That seemed to be the situation which prevailed in the East Carolina College athletic office. Dr. N. M. Jorgensen, college athletic director, hadn't even heard of the report and had not seen a newspaper when he was contacted.

"I don't know anything at all about the report," Jorgensen told the Reflector this morning. "Coach Dole has promised that he would let us know first if anything ever came up in this manner. What Coach Dole told the News and Observer goes for me, too. It's quite a surprise."

Davidson has been looking for a new coach for the past weeks, or even since Crowell Little resigned to go into the automobile business in High Point. The Davidson teams are members of the Southern Conference and have not been powerful teams at all for the past few years. Their one claim to athletic fame has been in tennis, a sport in which the Presbyterian school has consistently produced top-ranking teams.

Cherry Point's Marines threw everything but the kitchen sink at East Carolina yesterday in pounding the Pirates 10-2 in the first home game of the year for Coach Jack Boone's club. The Flyers used two home runs, a triple play,

and nine other hits in pounding four Pirate hurlers.

They will meet Elon at Elon tomorrow before returning to the campus. Atlantic Christian will be the next home opponent. They'll come to Greenville Monday in a renewal of the Battle of the Bohunk Bucket.

There was big crowd—mostly students—at the game yesterday. They kept up a constant line of chatter and most of them stuck it out until the end of the game even though the Pirates were behind and the setting sun was shining directly in their eyes.

The winning margin for the Marines came in the fourth frame when Stan Zuchowski led off with a walk from Rose. That's when Marizich banked out his home run.

The Marines added another two runs to their total in the seventh inning. Art Remsa led off with a home run over the right field fence to account for one of the tallies. Then, Holstein and Pensky rapped out singles to put two more men on the sacks with no outs. Pitcher Tony Petkavich struck out but Vengen came through with a single into rightfield to score Holstein.

Four runs in the eighth and one in the ninth closed the scoring for the Cherry Point team. The Pirates picked up their second run in the eighth inning on a couple of defensive lapses by the visitors.

First baseman W. C. Sanderson led the hitting for the Pirates with three singles in four times at the plate. Holstein banged out three hits for the Marines but the big blows were the four-baggers by Marich and Remsa.

Only History Will Tell Quality Of Present U.S. Foreign Policy

By JAMES MARLOW

WASHINGTON — (AP) — Before the presidential campaign is over both sides will have flooded the American people with a river of words on foreign policy.

The Republicans will represent the Truman policy as no policy at all or as a hasty patchwork to meet unexpected situations. The Democrats, of course, will defend it as thorough and thought-out.

When the campaign subsides it's doubtful the people, drenched in the claims and counterclaims, will have a much clearer picture of American foreign policy than they have now.

A historian, examining this period a hundred years from now, may decide that what passed for a policy was truly a patchwork or that it was a good policy, indeed, but not well understood by all the people.

If it's the latter, he may conclude the critics of the policy were far more active and effective in criticizing it than the Truman administration, including the State Department, was in defending and explaining it.

Perhaps it is only a coincidence that at this moment the State Department has produced an 80-page document, called "Our Foreign Policy, 1952," to explain and justify American actions abroad under the Truman administration.

It is not a brand new notion. The State Department says Truman himself first suggested such a document in 1949 and one similar to the 80-page list was published by the department in 1950.

There were 200,000 copies of the first one. The government printer will turn out 300,000 copies of the new one. For 25 cents they can be obtained from the Department or the Superintendent of Documents in Washington, D. C.

Groups and organizations interested in foreign affairs, and in buy some of these but since there are only 300,000 copies, most of the 150 million Americans will never see them.

The very fact that the President and Secretary of State Acheson thought it worth while, or perhaps necessary, to produce the explanation at all raises a question.

Why haven't the President and Acheson been far more active, particularly on the radio and TV, in explaining to the people the foreign policy of the administration?

Truman and Acheson made one of their infrequent radio and TV appearances a few weeks ago. In a one-two-punch, they carried to the people their fight for the administration's eight-billion-dollar foreign aid program.

Perhaps the fact that the President recently permitted a book about his conversations and diaries and views on men and events—to be published is an admission he has not done enough to communicate with the people.

Acheson certainly has been urged by some of his advisers, who watched the critics belittle him and his work, to go to the people on TV and present a case for himself and the foreign policy.

Instead—and in spite of the fact that he won friends with his TV performance at the Japanese Peace Treaty signing in San Francisco — Acheson seems to have withdrawn into himself.

Maybe the endless criticism has had that effect on him, since he is a sensitive man. But even his news conferences have become dull.

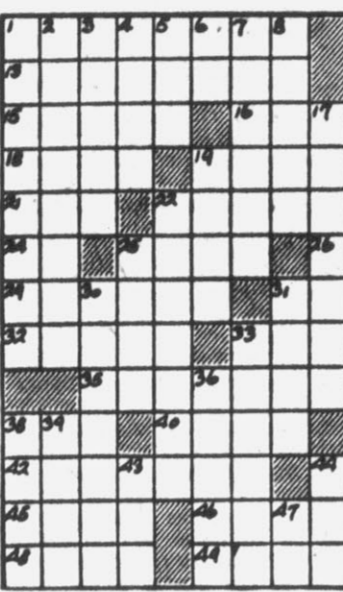

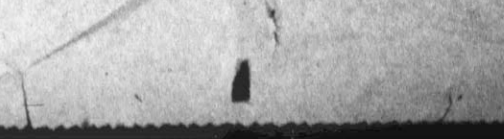
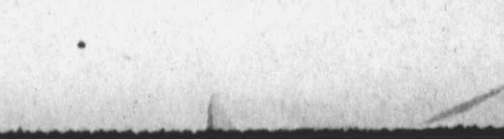

Kinston Tobacco Case Is Heard By Supreme Court

RALEIGH (AP)—The State Supreme Court heard arguments yesterday in an appeal growing out of a move to require five tobacco companies to place buyers on a fifth sale operated by the Kinston Tobacco Market.

The tobacco buying companies appealed from an order signed by Superior Court Judge Henry Stevens requiring them to place buyers on the fifth sale. The order was sought by the Kinston Tobacco Board of Trade.

The Kinston Market, which has had four sets of buyers on its tobacco auction market for many years has been trying to get a fifth set. It began operating the fifth sale about three years ago.

In arguing the case for the tobacco companies, lawyer Victor Bryant of Durham told the Supreme Court that the Kinston Board of Trade has no authority to require tobacco companies to place buyers on any particular sale. He added that the companies are not bound by rules and regulations of the Board of Trade.

The tobacco companies which are appealing Judge Stevens' order are:

Liggett and Myers, American Suppliers, Imperial, Export Leaf, and Kinston Tobacco Co.

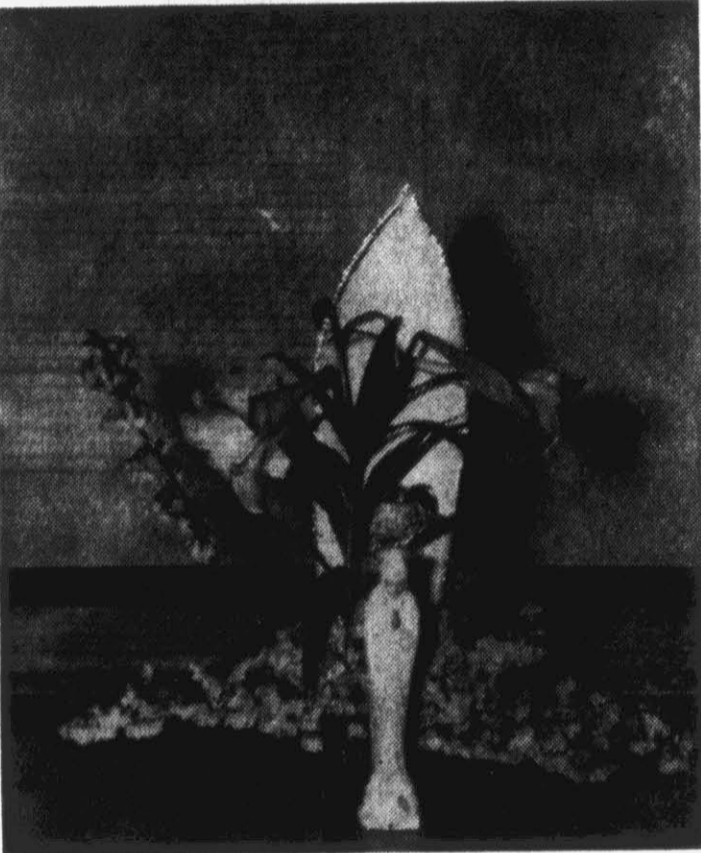

(Continued From Page Four) be imprisoned in the State's Prison, unless such person shall have been restored to citizenship in the manner prescribed by law." The applicant also must be able to read and write; must have been born in the United States or naturalized, must have lived in North Carolina for one year and in the precinct four months. There are further provisions in the law setting up formulas for determining place and time of residence. It has been held by competent legal authority that if age and residence requirements will have been met by the general election on November 4, the applicant may be registered to vote in the primary.

GIMMICK — There are one or two "gimmicks" in the statute. One is the Grandfather Clause applying only to those registering prior to December 1, 1908. The other is the loophole provision on the literacy test, which requires the applicant to show "to the satisfaction of the registrar" his ability to read and write in the English language a section of the constitution. Alleged abuse of that discretionary authority has occasioned charges that many otherwise qualified Negroes have been refused the right to vote, and that prejudiced registrars have barred competent voters identified with parties or factions which the registrar did not like.

RESPONSIBILITY — Main point to keep in mind is that the individual citizen has the respon-

ability to see that his or her name is properly entered on the registration books before sundown on May 17. If the citizen does not present himself to the registrar in person between 9 a.m. on May 3 and sunset on May 17, he cannot blame anybody else for not being eligible to vote in the primary on May 31.

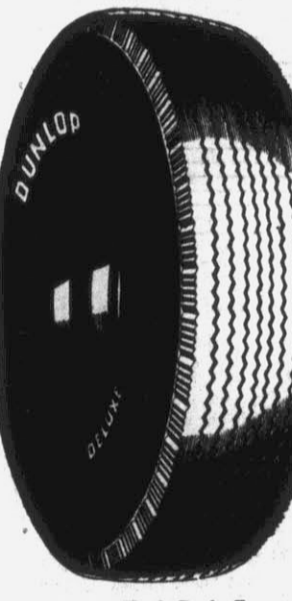
