Swartz Calls For Utilities Growth

Urges Commission To Continue Rural Electrification Program With REA Funds As Originally Planned; Points Out Lag In City's Own Needs

Greenville Utilities Superintendent Martin Swartz has urged the local Utilities Commission to continue its rural electrification program with REA funds to complete the work originally outlined under the present expansion program. Swartz's appeal for the continuation of the expansion program came in a letter to Commission Chairman Roy Martin which Swartz released to the press yesterday. Swartz recommended in the letter that the Utilities Commission "use REA funds at two per cent interest rate, on our rural line extensions and overbuild, and use our net revenues to take care of water, sewer and electric extensions inside our city limits and not issue any more tax anticipation bonds."

He pointed out that the city is "now at least six months behind in water and sewer extensions for the new homes being built inside the city limits, and to bring this program up to date, it is necessary to finance in some form." In the letter to Martin, Swartz discussed at length the rural electrification program of the Greenville Utilities under its REA loan and declared: "We are not living up to our good faith if we do not continue this program in giving (electrical service) to the rural people who have already wired their homes, bought electric appliances, made application for service and paid their deposits. I want to urge our Commissioners to go along with this program until it is completed, because it is good business for the Utilities Commission and good business for our merchants; and every consumer on our lines is Greenville-minded and is one of our rural citizens." Swartz's letter, dated April 28, came less than a week after the Utilities Commission failed to give its approval to a proposal that present rural electrification work be continued on an additional 17.52 miles of lines in the area served by the Greenville utilities. The area in question was included in original plans for the current electrification project, but the \$399,000 construction contract let by the utilities was on a per customer basis, and the contract will be fulfilled without construction of the additional 17.52 miles of lines. The total cost of the addition has been estimated at \$42,000. The present project without the addition is expected to come to a total cost of \$47,000. The letter to Commission Chairman Martin covered more than three typewritten pages, and in it Swartz reviewed the REA loan made to the city for the current project, and also the question of whether the loan can be considered as part of the bonded debt of the city. Swartz said the letter: "I wish to call your attention to Section 5 in the above article which states there is to be printed on each bond—'This bond is not a debt of the city.' The city only obligates itself to collect the revenue from the consumer. As mentioned before, this is the standard procedure of REA, and when our present loan contract was drawn up and agreed to between the Utilities and the Federal Government it was identical with the former contract of 1942 when we used REA funds for extending our rural lines." Pres. Truman Informs Steel Negotiators He Is Ready To Increase Wages Of Industry

Aviation To Soon Feel Oil Strike

WASHINGTON (UP)—President Truman served notice today that he is prepared to raise wages in the government-operated steel industry next Monday, or as soon afterward as possible, if union and management negotiators fail to agree on a new wage contract. "I do not want the government to fix terms and conditions of employment," the President told steel union and management officials at the opening of a White House mediation conference. "That is your job, not ours. If we must take action it will be something that is not satisfactory to either side. But we will have no choice if you cannot agree." "I didn't send for you just to make a speech. I sent for you for action and, gentlemen, I want it." The President at the same time promised the steelmakers that stabilization officials "are prepared to consider" the industry's claims for higher prices "on their merits." The government was understood to be ready to give the union a "package" of 17 1/2 cents an hour in wage increases and fringe benefits—the first installment on a three-step raise proposed by the Wage Stabilization Board and demanded by the union. There was considerable question, however, whether Mr. Truman would order a union shop. As the President was addressing the steel company and union negotiators, counsel for the industry were asking the Supreme Court to order a wage freeze pending judicial disposal of the issues in the steel controversy. The steel request was filed with the court in a memorandum replying to the government's petition for review of a district court ruling invalidating the government's April 5 seizure of the steel mills. A strike of 650,000 CIO steelworkers was called off yesterday by Philip Murray at the President's request. Mr. Truman, who told the negotiators that their fight "can be settled in a few hours," began reading from a prepared statement but concluded with a number of off-the-cuff remarks. The President appealed "as the head of the greatest government of the world," to the union and company negotiators "to get down on earth and talk to each other without any ill-feeling." "The President made it clear to the company presidents that the government will make no advance commitment on a big price boost before the wage issue is settled. More than 80 per cent of the union steelworkers remained idle today as two major producers called back only maintenance and service crews. U. S. Steel Corp. and Jones & Laughlin held off recalling upwards of 200,000 production workers even though Murray ended a nationwide steel strike yesterday at Mr. Truman's request. Other "Big Six" companies—Republic, Bethlehem, Youngstown Sheet & Tube and Inland— notified their 150,000 steelworkers to return to work. Other small producers normally remain idle over the weekend.

Urge Action On 'Leak' In Government Secrets

WASHINGTON (UP)—Senate investigators prodded the Agriculture Department today to suspend or fire an official accused of feeding highly confidential information about U. S. cotton purchases to an Egyptian cotton broker. Chairman Allen J. Ellender (D-La.) of the Senate Agriculture Committee said he hoped Secretary Charles F. Brannan would take "judicial notice" of committee testimony about Clowis D. Walker and "suspend him immediately." If Walker is not eventually cleared, Ellender said, "he should be dismissed summarily." Walker, head of the cotton branch of the Production and Marketing Administration, was summoned to a conference today by his boss, PWA Administrator George Geissler. Brannan was out of town, but some sources said Geissler had authority to fire or suspend Walker or accept his resignation. Walker told the United Press he had no plans to quit. Ellender said he would send a record of the committee's hearings on the Egyptian cotton deals to the Justice Department as soon as it is completed. "The committee was told yesterday that Walker once suggested that the government buy Egyptian cotton for its stockpile direct from his personal friend, Loufty Mansour, instead of through open bids. The suggestion was overruled by Geissler, who thought buying through bids was a "better policy." Mansour, an Egyptian, represented the Egyptian firm R. and E. Huri and Co., which made large profits in 1951 on sales of cotton to the United States. Harold Mesibov, an Agriculture Department investigator, told at length about Walker's close dealings with Mansour. He related how relations between Walker and Mansour were so close that the Egyptian apparently had complete information at all times on the government's secret plans to buy Egyptian cotton. Mansour's firm was highly successful in the bidding for American business. But Mesibov said Walker's role apparently was supplying the Egyptian with advance information and not in any "irregularities" in the actual awarding of the contracts. Walker insisted he never disclosed confidential information to the Egyptian.

Babson Probes Grass Roots Of Need For Moral Rejuvenation

By ROGER W. BABSON BABSON PARK, Mass. — We read much in the newspapers these days about the need of America to undergo a moral rejuvenation. In this column I have tried repeatedly to give suggestions as to how to bring this about. I have suggested religion, ethics, education, thrift and a closer attention to land ownership as some of the remedies. Today, I shall attempt to go further into the "grass roots" of the problem. Where Do We Belong? About the turn of the century a great sociologist named Charles Horton Cooley coined a new word: "Socius." This man said that you could look at any man from two points of view: (1) As a member of his social group; or (2) you can look at any man as an individual apart from his group, or as a rugged individualist. It is the latter that we want politicians and labor leaders want all men to be. If they can submerge individuality, they will then be able to achieve their goals. This explains why the Russians are working so hard to develop collective farms. The independent farmer thinks too much as an individual, to fit into the Russian purposes. This also applies to Chinese farmers who own their farms, but not to "renters." Let's Look At History In the "horse-and-buggy" era of our history the rugged individual rarely, if ever, let his own private convictions be submerged by the group judgment of a committee, board of directors, or political par-

THE LAW OF HABIT
The law of habit is inexorable. Once we do a thing, it becomes easier to do it the next time. The psychologist William James, writing a half-century ago, declared that every act we perform tends to bring about a little change in our nervous system which, when the act is repeated, allows energy to flow more easily over that nerve course than it did before.

We all recognize the law of habit as it operates in the acquiring of a skill. The concert pianist started as an awkward youngster practicing scales. The juggler and the magician acquired their skill after years of practice. The surgeon comes to the full ripeness of his power only after years of hard work and after the experience of thousands of delicate operations.

But the law of habit works in reverse. If we neglect a duty, it is easier to neglect it the next time. Harbor an evil thought today and I will probably put in its appearance again before the day is over and certainly will be on hand tomorrow. Indulge a mood and it becomes oppressive. Give full rein to an illicit desire and it comes at last to fill the whole of your horizon and to dominate every desire.

Every day we are either building good habits or bad habits. We are never too old to break bad habits, but the best way to deal with a bad habit is not to let it get started.

A Challenge To Accept Unhesitatingly

Pitt Countians again are being given a specific opportunity to go to bat for their most prized possession—East Carolina College.

The Daily Reflector heartily endorses the idea of a \$100,000 Pitt County Memorial Foundation for East Carolina College and we are anxious that the people of Pitt County give careful consideration to the foundation both in terms of what it will mean to the college and what it will mean to Pitt County.

For too many years the people of Pitt County have taken the college for granted, putting little into the institution, and yet reaping vast dividends from the small financial support they have given the college. Truly there is no other man-made asset Pitt County has which means as much to its people from a business, cultural or educational standpoint as East Carolina College. There is no other asset which has greater potentialities, provided it is properly nourished by the local people.

When East Carolina College was established in 1907, Pitt County voted a \$100,000 bond issue to aid in the founding of the college. After that the county rocked along and let the college do likewise. There was no real effort to promote or aid the school in a financial way until a few years ago when the people of the county raised \$25,000 for a stadium for the college.

Admittedly that is a relatively small amount to put into an institution which has brought Pitt County dividends multiplied many times over week after week and year after year since the college was established.

From a strictly financial standpoint, it is easy to see what the college is adding to the economy of Pitt County. During the current fiscal year alone the college is spending \$1,358,950 for its operations, and another \$1,103,529 for permanent improvements. Add to those figures the half million dollars a year the college students spend in the business places of Pitt County, and it is readily seen that it is no small part of the county's economy.

As President Messick has said, East Carolina is no longer a fresh water college. It is the fastest growing college in North Carolina, and already its enrollment has surpassed that of some of the older, more highly regarded institutions of the state. Yet East Carolina is rapidly carving a place for itself among the top ranking colleges of the state, and is attracting attention across the nation.

If its growth is to continue, the school must have the positive, active help of the people of Pitt County. Good wishes are no longer enough.

Surely we can count in dollars and cents what East Carolina College means to Pitt County, but there is hardly a price that could be set on what the college has meant to the county in educating its young people to build a better and more progressive

community here at home. The \$100,000 Pitt County Memorial Foundation for East Carolina College is truly one of the most promising and most worthy proposals for Pitt Citizens we have heard in many years.

Pitt Countians should unhesitatingly accept the challenge to establish the foundation for East Carolina College and for themselves.

We Aren't Doing Too Badly After All

Eastern North Carolina is by no means missing out on its share of appropriations for military bases. The expenditures for new bases and expansions of old bases are giving a boost to the economy of the section.

Secretary of Defense Lovett has asked Congress for authorization for work on military bases in North Carolina amounting to almost \$44,500,000 beginning July 1. Of course the requests may be trimmed by the time Congress gets around to appropriations for the projects, but at least North Carolina has its name in the pot in no small way.

The funds for which Lovett asked Congress this week include \$15,325,000 for Fort Bragg; \$195,000 for a navy auxiliary field at Edenton; \$237,000 for an air facility at Weaverville; \$18,895,000 for an air base at Raleigh-Durham and \$9,736,000 for Seymour Johnson field at Goldsboro.

That amounts to a goodly sum in anybody's bankbook, and although none of the money is to be spent in the immediate area around Pitt County, we should not feel too badly about it. The Defense Department requests for those five military installations amounts to just about the same thing the DuPont company is spending just outside Grifton on its new Dacron plant.

Of course we'd like to have all the capital outlay by Uncle Sam and private industry we can get right here in our midst, but when we stop to consider the situation, maybe we are not doing as badly in that direction as we sometimes think.

National Whirligig

WASHINGTON—There seems to be great confusion as to how we entered the Korean war," writes C. H. O. of Buffalo, N. Y. "A says that the United Nations 'initiated' this action. B says that President Truman was directly responsible without any go-ahead signal from the U.N., but that the U.N. later confirmed the action by agreement and the sending of token forces."

INTERVENTION—Answer: B is correct. As soon as word of the North Korean Communists' crossing of the 38th parallel with armed forces was reported to Washington, President Truman summoned a council of his military and diplomatic advisers at Blair House. With the exception of Louis A. Johnson, then Secretary of Defense, they favored American intervention. Johnson was concerned over direct action because of our military weakness in that area, but diplomatic considerations advanced by Secretary Acheson prevailed.

PRESSURED—As a result of several conferences, Truman ordered "sea and air" units in the Far East to give assistance to South Korea. He phoned Trygve Lie, secretary-general of the United Nations, asking him to convene an emergency meeting of the U. N. Security Council.

This body then issued a call for U. N. members to "furnish such assistance to the Republic of Korea as may be necessary to repel the armed attack." As B says, the U. N. was pressured into the conflict by the fact that the United States had already committed its forces.

But the Security Council could not have reinforced Washington's position if Moscow had not threatened a boycott of that agency. Had a Stalin representative been present, his veto could have prevented any affirmative, aggressive action, and we would have been on our own. As a matter of fact, other U. N. members have contributed only "token forces" up to now.

SECRET—"San you explain," asks R. F. of Dayton, O., presumably a Taft supporter, "why General Eisenhower, while still in uniform and active service, has been permitted to take part in politics, make plans for winning the nomination for president, announce his views on controversial public issues, and engage in many other activities supposedly barred to an officer of the army?"

Answer: That is a politico-military secret. Technically, everything R. F. says is true. It is probable that a minor figure who engaged in similar activities would be suppressed or disciplined, although the brass has become more lenient in this respect in recent years. They interposed no objections when General MacArthur entered the Wisconsin presidential primary in 1948.

GENEROUS—But it would be extremely embarrassing for President Truman, the commander-in-chief, or for the Joint Chiefs of Staff to rebuke " Ike" or to restrain him.

For Truman to do so would seem to be political discrimination that would help Eisenhower. Moreover, I suspect that Truman would like to see "Ike" become his successor. He is acting that way, according to his own party leaders.

The members of the Staff are old friends and former subordinates—comrades in arms, so to speak. They have the kindest feelings toward "Ike," and are plugging for his nomination and election. As such, he will be their next commander-in-chief.

In the last analysis, General Eisenhower is too great a national and world leader to be hamstrung by political or military men who owe so much to him. In fact, it is probably a good thing that the White House and the Pentagon have a broad and generous outlook on these questions.

THANK-YOU—"Is it true," inquires E. H. G. of Ontario, Cal., "that President Truman once wrote the Communist newspaper, the New York Daily Worker, a complimentary article that was published in that sheet?"

Answer: It is not true. As many other public figures have done, he sent them a formal, thank-you note because of a favorable comment they had made about him. And at the time the Daily Worker was following the Moscow "party line," which advocated friendship and cooperation with the United States.

In checking the temperatures registered by the thermostat Charlie found that it was only two degrees off, and as far as Charlie could get away from the thermostat he found that there was a variance of only one degree. His own, however, was 50 degrees off! After checking, he was able to set

the dial at the right temperature. Charlie's hobby is about the least expensive of any you can name. The type of thermometer he uses costs only \$3.50.

Another wife objected to the peek on the check her male gave her en route to his coat and hat. "There is not greater insult than an absent-minded kiss," she affirmed.

Several more wives groused about the silent treatment accorded them by husbands with a chronic habit of reading the newspaper at breakfast. Spin a globe and put a finger any place. The chances are you will point to an area that is having economic troubles. And in most foreign areas the problems are much more serious than in America, where a drop of a few percentage points in sales has caused many business men to cry into their martini.

Here is a hop, skip and a jump through major nations abroad: Great Britain: Short of foreign exchange. Food sharply rationed. Unemployment in some industries (textiles, etc.); manpower shortages in others (coal mining, etc.)

Japan: Textile production down 40 per cent. Imperatively needed export markets hard to find because of conditions in China, lack of ships, and customs barriers in U. S. and elsewhere. Considerable unemployment.

Australia: Fall of world wool prices has cut export earnings in half, forcing slicing of imports.

France: In another of a continuing series of politico-economic crises. Prices have risen so much the highly profitable tourist industry is threatened.

Spain: Drop in world demand for oils has reduced external earnings, by the rubber prices complicated by a bumper olive crop.

Italy: Suffering from unemployment and political unrest.

India: Fall in prices of burlap, pepper and shellac has hit income and is bankrupting many dealers who expanded during the boom in these commodities. Food still short.

Malaya: Torn by Communist strife and financially weakened by the fall in rubber prices caused largely by the expansion of natural rubber production in the U. S.

Latin America: Hot spots in most countries. Argentina, a great beef-producing nation, has decreed two meatless days a week. The Bolivian revolt was engendered largely by a depression, worsened because U. S. refused to pay a high price for tin. Chile, depressed, has slashed imports. Brazil is suffering from unemployment and political unrest.

Conditions behind the Iron Curtain are difficult to ascertain. They appear to be poor in the European satellites, extremely critical in China, ravaged by war, disease and revolution.

WASHINGTON—Frances Clarke Sayers lies awake nights thinking about a national children's library center here. There's a far-away chance her hopes will come true. A well known specialist in library work with children, and herself author of several children's books, Mrs. Sayers has been appointed by the Library of Congress to make a study looking toward the development of an effective children's literature program in the library.

In addition to surveying the already extensive collection of both domestic and foreign children's books, now "scattered all over the library," and planning for assembling them "where people can lay their hands on them," she has been asked to help develop a program to stimulate wider interest in children's literature.

"Previously," she says, "children's literature has been considered without relation to the audience for which it was intended. Now people are beginning to realize that the study of children's books is a source of valuable knowledge on history, customs, manners and educational development."

Mrs. Sayers' appointment was made possible by funds provided by a joint committee of the American Association of University Women and the Association for Childhood Education International, as well as a number of individual donors. She is on loan from the New York Public Library.

Mrs. Sayers, a tall, modish, contagiously enthusiastic woman, says a national center for the study of children's literature has untold possibilities. "It will take some doing and more money than is now available, however," she said.

Mrs. Sayers commutes to New York's Greenwich Village to spend weekends with her husband, Alfred Sayers, a bookman and free lance research writer, and her cook, Lucinda, who has been with her 20 years, and after whom she named her first book "Blue-bonnets for Lucinda." Her latest is a story about a little girl and a cat, "Ginny and Custard."

"I write mostly for little girls between the ages of seven and 12," she told me. "I'm all right with people and places, color and atmosphere, but I have trouble with plots."

Around Capitol Square

RUN-OFF—Political observers are speculating on whether there will be a second state-wide primary, since it is virtually certain that the nomination for Governor will be decided on May 31. Majority opinion is there will be a run-off for Lieutenant Governor and Associate Justice of the Supreme Court and in one or more congressional districts. Reasoning is that there probably would not be a second primary call for any one of these offices. There is considerable sentiment in favor of letting the high man take the office, but there is also deep-rooted feeling that no person ought to assume high office with less than a majority of the voters participating in the primary expressing their choice for him.

MULTIPLE—With six able men contesting for the Supreme Court and four for Lieutenant Governor it is regarded as very unlikely any one will receive a clear majority. Reports from the ninth and twelfth congressional districts indicate improbable majorities for any one of the three candidates in each race. There almost certainly will be numbers of counties in which no nomination will be made for county commissioner, general assembly or other local offices. The impact of all these incomplete elections, with very probable run-offs in a large part of the state

anyway, is believed sufficient to justify the call for another chance in the statewide races.

INSIDE—The old fellow stood for a few minutes watching the workmen cleaning off the outside walls of the state capitol. He liked the effect and was pleased that the cleaned spaces did not look as raw or new as he had feared. "It seems to me," he observed, "that they are cleaning up the wrong side of the walls up a little cleaning up on the inside seems more in order." The reporter thought he might get a good quote or two about what cleaning up the fellow had in mind. He refused to elaborate.

IDENTITY—H. F. Seawell Jr., Republican candidate for Governor, known to his friends as "Chub," got a big kick out of an incident reported to him from his country of Moore. Hubert Olive was in Moore the other day and was being escorted around by supporters who introduced him to those casually met on the streets and roads as "the next governor of North Carolina," sometimes without giving his name. Seawell said he was told that on one occasion the man to whom Olive was being presented quickly extended his hand and said, "Mr. Seawell I'm so glad to meet you, and you can count on my vote."

NUMBER TWO—As the primary approaches—it's just four weeks off—there is greatly increased interest in the contest for the No. 2 place in state government. In some sections the lieutenant governor's race is taking precedence over the No. 1 contest. That has occasioned some peculiar developments. There seems to be general opinion that Luther Hodges would make a good governor, and a large part of his support is traceable to the fact that the lieutenant governor will succeed to the top office if anything happens to disqualify the man elected as governor. Marshall Kurfess is working night and day and is lining up support in some unexpected places by reason of his personality and "likeability." Roy Rowe is also giving full time to the campaign and is capitalizing on the fact he is the only candidate who has had any legislative experience—and except in cases where the lieutenant governor is called upon to substitute for the governor, his main job is presiding over the State Senate. The fourth candidate, Ben McDonald, is not making much impression upon the voters. Each of the three leaders sincerely believes he will lead the ticket and publicly claims nomination in the first primary. Pin 'em down and each will admit he may have to

What Other Papers Are Thinking

THE CONSTITUTION STILL STANDS
(The Durham Sun)
Seizure of the steel industry by the President of the United States has been declared illegal by United States District Judge David A. Pine in Washington. We say "seizure by the President" rather than seizure by the Government because the President is only a part of the Government, as the Court held.

There is, in the Constitution, the Court found, no express power granted the President embracing such action as the steel seizure, there is no grant of power from which such authority may be inferred, there is no enactment of Congress authorizing such exercise of power.

The Constitution, asserted the Court, lodges in Congress, not the President, "the power to provide for the common defense and the general welfare." Judge Pine rested his conclusion on a statement by the late Chief Justice William Howard Taft that justified and vindicated by affirmative Constitutional or statutory provisions, or it doesn't exist.

As for precedents cited by Government attorneys, Judge Pine declared it "his opinion that illegal acts, although unchallenged, do not legalize or sanctify later illegal acts.

A steel strike would be harmful, the Court conceded, but expressed the conviction that the harm to the Nation from the strike "would be less injurious to the public than the injury that would flow from a timorous judicial recognition that there is some basis for this claim to unlimited and unrestrained executive power, which would be implicit in a failure to grant an injunction."

Judge Pine's thinking seems wholly sound throughout. Whatever he facts in the case, the Court said in effect, the law is paramount and he heaved, as he saw it, to the line of the law.

While the facts have not been heard—and while the President was not a party to the action before the Court, the effect of the decision was a ruling on

that issue raised by the President which transcends the issue of the crisis in question, the steel strike. By his assertion of "unlimited and unrestrained power" under the general welfare clause, the President raised the question of the very validity of the Constitution itself.

Judge Pine, therefore, has ruled on that issue. He has ruled that the President is not above the Constitution and that the power is not outside the Constitution and that the power is not outside the Constitution but under it. All Americans if they adhere to the Constitution must agree.

Judge Pine's court is a lower Federal court. It is not the tribunal of last resort and the case will go on to that ultimate judiciary body in this country, the Supreme Court of the United States. At this point, however, the Constitution has been upheld. It has been declared superior to the will, the whim or the convictions of any President. Presidents come and Presidents go. The Constitution endures. Thus far, it still stands.

Light Vote Anticipated In City's Off-Year Election

Won't Compare With Large Turnout Of Past

When Greenville voters went to the polls in last year's municipal elections, 2,906 ballots were cast, a total City Clerk H. H. Duncan says is the highest in the city's history.

But last year was Greenville's "general election," when the mayor, judge of recorder's court, solicitor of recorder's court and five aldermen were elected. "With only four aldermen to be elected this year," Duncan reports, "we do not anticipate anywhere near the 2,906 votes cast in 1951."

New Precedent
In addition to a record vote, the 1951 municipal elections featured the establishment of a second precedent. Contrary to former elections, last year each qualified voter in the city voted for one alderman from each of the five wards—regardless of the voter's residence.

Therefore, the policy had been for voting residents of each ward to vote only for aldermanic candidates from that ward. "This year, as last, the names of all candidates for office will be placed on one ballot," the city clerk explains. "Each voter in the city, whatever his ward residence, may vote for one candidate from each ward."

Law Passed 1951
That amendment to the city election statutes became law in the 1951 session of the N. C. General Assembly. Operating under the gavel of Mayor W. S. Stafford, the board of aldermen approved the amendment at a meeting held January 4, 1951. The amendment passed the legislature in time to be put into effect in the city elections last May.

This year only four seats on the board of aldermen are to be filled by election. They are the seat each fourth and fifth wards. E. Waldrop, who is rounding out his second term as alderman from the fifth ward, has announced that he will not be a candidate for a third term.

The three incumbent members of the board who have filed to succeed themselves are, C. B. Mayo from the second ward, Robert Elks from the third ward and J. E. Collins from the fourth ward. Only Elks and Collins are opposed.

Withdraws Candidacy
A. B. Stallworth, who filed as a candidate in opposition to C. B.

Mayo, recently withdrew from the race because of "pressing business." Elks is opposed by J. E. Johnson and George Pugh is making a race of it against Collins in the fourth ward. Jimmy Wells filed for the fifth ward seat vacated by Waldrop and has no contest.

Present elective officials who were elected last year and will not have to run again until 1953 are: Mayor Lester D. Page; Judge of Recorder's Court Charles Whedbee; Solicitor of Recorder's Court Eli Bloom; and aldermen Heber Tripp from the first ward, R. E. Rogers from the second ward, R. E. Howell from the third ward, Robert L. Smith from the fourth ward and J. S. Jenkins from the fifth ward.

Two Precincts
For purposes of voting, Greenville is divided into two precincts containing five wards. Residents of precinct number one, composed of wards one and two, register and vote at the Pitt County Courthouse. Precinct number two residents, made up of wards three, four and five, register and vote at the city hall.

The first ward encompasses all territory in the city limits lying North of Second Street extending across Tar River. Ward number two is made up of the areas lying between Second Street and Fifth composed of all the triangular area lying between Fifth Street and Dickinson Avenue. The fourth ward covers the properties between Dickinson Avenue and Evans Street, and ward five is composed of properties in the triangular area east of Evans Street and south of Fifth Street.

Registration Slow
City registration books have been open every day except Sunday since April 23, and will close at sunset today. Registrars at both the Pitt County Courthouse and the city hall report that registration has been "very slow" throughout the entire registration period.

At the courthouse this morning, only 73 persons had registered to vote, and of that number 15 are transfers. The registrar at the city hall discloses a slightly higher figure of 80, of which 12 are transfers. A tabulation of those figures shows that only 153 people have registered during the 10-day period since April 23. Officials opine that since this is an "off election" year, only a fraction of the nearly 3,000 people who voted last year will cast their ballots Monday.

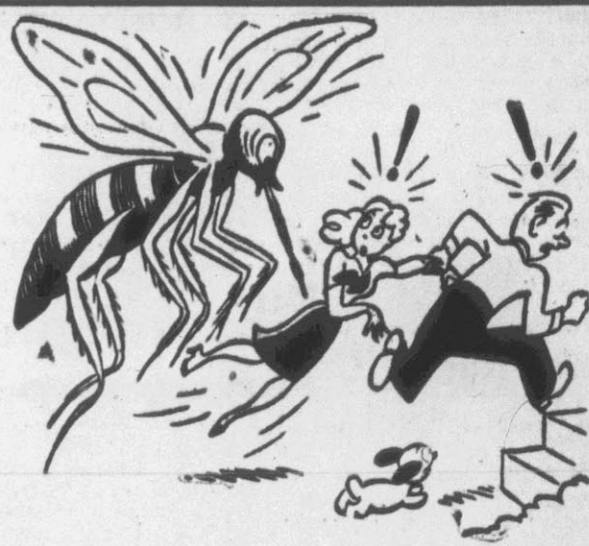

Climbing over the Chicago Cubs, the Giants inched into second place last night, a scalp that came behind Brooklyn, when Whitey Lockman's home run touched off a two-run outburst that gave the New Yorkers their fourth victory in a row and a 10-inning 5-3 verdict over Pittsburgh's patchwork Pirates.

"I hope very much that I can play when I get out," said Williams, who will be 35 years old when his 17-month hitch is up. "I certainly will if I'm able."

Kentucky Coach Continues His Denial Of Scandal Connections

AUSTIN — (AP) — Adolph Rupp, basketball coach of Kentucky, told President Herbert Hopper of the Texas High School Coaches Association today that he was not connected with the basketball scandal at Kentucky.

Rupp, who had been contracted to serve as basketball instructor at the Texas coaching school at Ft. Worth next August, said he would withdraw if new developments in the case scheduled for next week failed to satisfy the Texas coaches of his innocence of the accusations.

"I am just as innocent of the things I am accused of as you are," Hopper said Rupp told him by telephone.

Judge Paul B. Streit of New York, in suspending sentence against three former Kentucky basketball players for shaving points, said he had evidence that Rupp consorted with bookmakers and condoned the association of his players with them.

With this news, Hopper contacted members of the board of directors of the Texas High School Coaches Association regarding dropping Rupp from its staff of instructors.

Here attending the Texas Inter-scholastic Meet, Hopper today contacted both Rupp and Paul Bryant, football coach of Kentucky.

When Rupp made his statement of innocence, Hopper said: "Under the circumstances a decision is postponed until next week."

If Rupp did not withdraw from the staff, the association would attempt to pay him off on his contract.

Horse Racing Can Get Complicated

NEW YORK — (AP) — According to the "definitions and interpretations" of The Jockey Club Rules of Racing there are thirteen (13) varieties of races. Races fall into two main categories — stakes and purses.

A "stakes" is a race in which stakes are made by the owners of the horses in the form of nomination, eligibility and starting fees, all of which goes to the winner. The racing associations put up an additional amount referred to as "added money." The major portion of this goes to the winner together with the stakes. The remainder goes to the second, third and fourth horses.

Purses do not require any nomination. The entire amount is provided by player and coach. Rose starred as the racing association.

A claiming race is one in which every horse starting may be claimed for the price set in the conditions. In some claiming races a range in claiming price is allowed with weight off for every \$500 below the top price, according to the conditions.

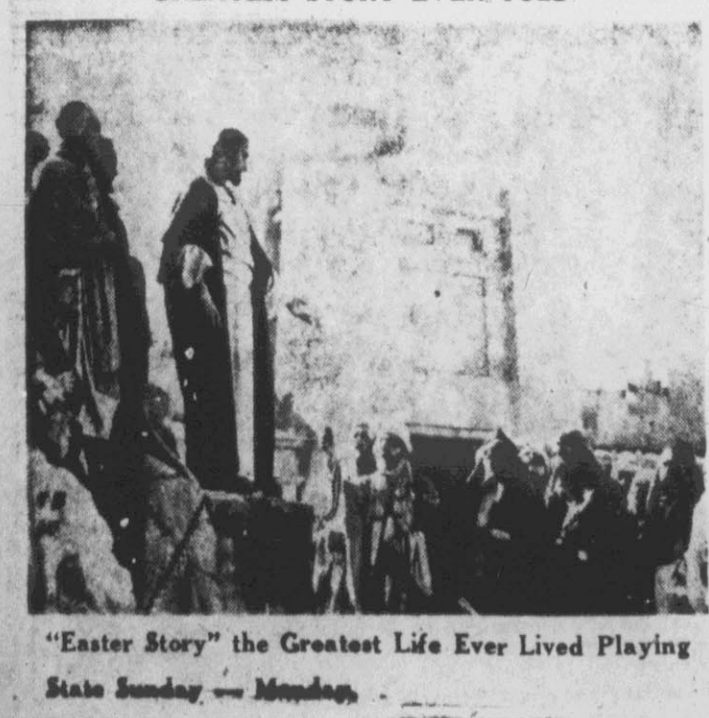

Hill Gail, Blue Man Lead Hopefuls In Running Today

LOUISVILLE, Ky. (UP) — Sixteen colts and a gelding go out on the ancient racing oval at old Churchill Downs today for the 78th running of the Kentucky Derby, America's greatest turf classic.

A crowd of 100,000 started jamming the sprawling stands on the outskirts of Louisville when the gates opened at 8 a. m. They came early to see Calumet Farm's bid to rewrite the racing history books with a favored colt called Hill Gail and a surprise running mate named Top Blend, sent in as insurance against mud.

While it showered briefly yesterday afternoon, the track was expected to be lightning fast with no more showers anticipated until after the big race goes off at 4:30 p. m. (EST).

Calumet's 6 to 5 pair of favorites can boost the stable into a new record of five Derby triumphs and at the same time hand Rose Run records of six wins to trainer Ben Jones and five to jockey Eddie Arcaro if the nod goes to Hill Gail. Arcaro bowed the early arrivals that he, at least, was in form yesterday when he won the 78th running of the Kentucky Oaks — the Kentucky Derby for fillies — with Calumet's Real Delight to set up a possible sweep of the three-Downs spring meeting. Arcaro won the Derby Trial on Tuesday aboard Hill Gail.

But he'll face rougher opposition today than he did in hand-riding Real Delight to a length-and-three-quarter triumph over 14 rivals.

Like, for instance, Blue Man, second choice at 4 to 1. The Flamingo and Experimental No. 2 winner will have Conn McCreary aboard. Even a gelding will take a shot at the Calumet cannon-ball, although only seven geldings ever have won the race in 77 previous runnings and none have turned the trick since Clyde Van Dusen in 1929. This hopeful is Sam Screen, a 30 to 1 shot.

The \$97,300 net to the winner in this \$125,350 stake — barring scratches — was enough to attract just about any among the three-year-old crop that can run faster than a trot. Rated as a 6 to 1 third choice were James J. Amiel's entry of Count Flame and Master Fiddle, while back of them at 8 to 1 came Cold Command.

Also given a fine chance were Gushing Oil, 12 to 1 off his wins in the Louisiana and Arkansas derbies and the Blue Grass Stakes, and the 15 to 1 Arroz, Hannibal and Sub Fleet.

From there in a race which will be seen over 49 television stations on CBS-TV, the challengers are strictly of the long shot variety. Happy Go Lucky is 20 to 1 with Pinter, while the field — Swoop, Brown Rambler, Stag Tails and Eternal Moon — are 30 to 1 along with the gelded Smokescreen.

Hill Gail has the pole position in the starting gate and, on a fast track, is expected to duplicate his record smashing run in the one-mile Derby Trial as he goes out front and attempts to run away from his challengers.

go through a run-off—if the second high man calls for a second primary.

PRECEDENT—One reason state policy-making boards are slow to act is because fully justifiable action in one instance may be pleaded as precedent for later action perhaps not quite so well supported by facts. One of the main pleadings of lawyers for President Truman in the steel seizure case was that other Presidents had established precedent by exceeding constitutional authority. The State Highway and Public Works Commission faced precedent from two directions at its meeting Thursday. By accepting invitations to hold meetings here and you over the state during the past year, the commission was embarrassed in declining an invitation to hold a meeting at Rocky Mount this spring. The embarrassment

was enhanced by statements publicly made at Rocky Mount that refusal to meet there would be construed as continuing the policy of promise without performance" in connection with road and street work under former Commissioner R. E. Earp, resigned to manage Olive's campaign for Governor. The commission also deferred action on a request for maintenance of a

street in Statesville, largely because it would set a precedent for similar appeals from other municipalities, although the special condition was admitted.

Commissioner Henry G. Shelton of Tarboro—next door neighbor to Rocky Mount—suggested George Richardson of Raleigh, whose division embraces the whole city, ought to be heard from. Richardson had no comment, and the Clark-Coble idea prevailed.
