Schools Expecting Set Record

All Signs Point To Capacity Enrollment, Or Over, Here Tuesday

By MURIEL SHOTWELL Reflector Staff Writer With last year's large enrollment plus present registration figures, the Greenville City School System expects the largest enrollment in its history when the schools open Tuesday, September 2.

J. H. Rose, superintendent of the city schools, said today that the indicating signs point to record-breaking enrollment with all buildings being occupied to capacity "It may be necessary to open additional classrooms at the NYA Center on Elm Street," said Rose.

The superintendent said the school board has buildings at the center with steam heat and adequate toilets which can be used if necessary. The vocational department of Greenville High School is already using one of the buildings and the special vocational school for elementary children is using another; therefore, Rose said, it will be a simple matter to expand the program at the center.

The special elementary program is being expanded and in addition to Mr. James Vinci this school will have the services of Henry Wood who taught at Needham Broughton High School in Raleigh last year. This year the program may include girls as well as boys.

Rose said an attempt is being made in this school to build an elementary program around the experiences of the pupil. "It has been so successful for the past two years that it is no longer considered a special school but an elementary school for grades five to eight inclusive and the chances are that a third teacher will be added to that school this year," said Rose.

Other changes in the city school system is that a number of children will have to be moved from the Training School to Third Street and West Greenville because of the increasing amount of building in the eastern part of the city.

The superintendent stated that indications are that there will be excessive enrollments in this part of town in grades two, four, six and seven. Also, the Training School will have one less teacher than last year. Additional teachers have been added to Third Street and West Greenville Schools.

An additional teacher of public school music has been employed. The new teacher, Mrs. Joan Gray, will assist James Rodgers in teaching woodwinds and strings for the band and orchestra.

During the summer, painting and repairing has been going on. New equipment has been bought and the school board has continued its program of modernization of buildings and equipment so that today the board considers the school buildings of Greenville as modern as those of any city.

There have been few changes in the teaching staff for the coming year and all the schools have the same principals as last year. At a meeting of the school board yesterday, an insurance policy for all children, costing \$1.50 per year, was adopted. It is the same policy which was in effect for the last two years and proved satisfactory, said Rose.

Heavier Tobacco Sales On Friday

Local Leaf Market Sold 1.6 Million Pounds Yesterday

With a total of 1,629,860 pounds sold, the Greenville market disposed of more tobacco yesterday than has been sold on any other one day thus far this season.

Official figures released this morning show that the local market yesterday sold 1,629,860 pounds of tobacco for \$773,074.46—an average of \$47.44 per hundred pounds.

"Yesterday's sale was the largest day's sale this season," Sales Supervisor W. L. Whedbee said in reporting the figures. "Only the 1,621,756 pounds sold on opening day August 21 even approaches yesterday's total."

Total market figures for the season thus far are: 5,745,422 pounds sold; \$2,790,429.58 paid out; for a season's average of \$48.57 per hundred pounds.

Sales Thus Far Figures for the first week's sales—which includes only Thursday and Friday of last week—show that 2,170,914 pounds of tobacco was sold for \$1,081,862.29. The first week's average was \$49.84.

In the second week ending yesterday, 3,574,508 pounds were sold for \$1,708,447.29—an average of \$47.80. Whedbee said yesterday's sales were full on practically all floors.

The supervisor announced that there will be no sale on the Greenville market Labor Day—"in fact markets will be closed for the holiday all over the country."

Local Underpass Again Scene Of Road Mishap

Three Injured As Car Strikes Van Jammed Under Trestle; One Hospitalized In Unconscious Condition

Greenville's death trap for transfer truck, Highway 43's railroad underpass, last night claimed more victims as its toll steadily rises.

A heavily loaded transfer truck, which became lodged under the 12-foot trestle, was rammed from the rear by a car, sending its three occupants to the hospital, one in a critical condition.

According to the story furnished by the driver, he approached the trestle and started to ease his truck through the underpass when it became lodged against the low-hanging structure.

The driver then was quoted as saying he got on top of his truck to see if it could be moved without damage to the unit and was descending from the truck when he heard squealing tires and something hit the truck.

A car driven by James Langley, 19, of Route 1, Greenville, had plowed into the rear of the stalled van demolishing the car and injuring the three occupants of the car.

Langley suffered severe head injuries and was removed to Pitt Memorial hospital in an unconscious condition. Others injured were Wilbert Rossion of Mount Olive, who suffered lacerations of the forehead and other injuries; and Donald Stocks of 118 West 10th Street, who received bruises and minor cuts.

All three of the injured were admitted to the hospital. No charges have yet been placed against either driver by investigating officers who have not completed their investigation.

The accident marks the fourth time in recent months that transfer vans coming into Greenville have been wrecked when they struck the

Five MIGs Destroyed, 11 Damaged In Blazing Duels

SEOUL, Korea (UP)—American Sabre jets dealt Communist air power a crushing defeat today as they destroyed five Communist MIG-15s, probably destroyed one and damaged 11 of the Russian-built jets in a series of blazing air duels over North Korea.

It was the best day of hunting the Sabres have had in August and the 17 claims brought the monthly toll to 82 MIGs destroyed, probably destroyed or damaged.

The previous best "kill" total this month came Aug. 5 when four were destroyed and nine damaged.

Seventy-nine of the fighter-interceptors tangled with about 100 MIGs in a series of late afternoon battles near the Suho reservoir on the Yalu River and over the impor-

tant Red city of Sinuju in northwest Korea. The MIGs came out to seek revenge for their defeat Friday when they tried vainly to crack through a ring of F-86 Sabres protecting fighter-bombers in a massive strike on Pyongyang.

American Superforts also stepped up pressure by blasting an important Red power plant in northwest Korea.

The raid came a few hours after Allied fighter-bombers hit the North Korean capital of Pyongyang with one of the heaviest assaults of the war.

Seventeen Japan-based B-29s roared over the Choson No. 1 plant and dropped high explosives on a huge powerhouse, switchyard and

transformer area. The Superforts were over the target for nearly three hours. They used electronic aiming devices to shower down bombs on some undamaged areas and on installations the Communists had been trying to repair.

Returning pilots said they made "excellent bomb runs" and that anti-aircraft fire was "meager." Two Communist night-fighters made passes at the B-29s but fired no shots.

Fifth Air Force fighter-bombers attacked troop and supply concentration depots later today. They destroyed nine buildings and damaged nine others in a raid on a supply dump at Puitang-Po, south of Yonan.

Allied planes flew a record 1,443 sorties to dump bombs, bullets and napalm on Pyongyang Friday but suffered relatively minor losses, considering the intense curtain of flak thrown up by the Reds.

Far East Air Forces revealed that for the past seven days, the U. N. lost only two F-84 Thunderjets and one Navy AD-3 to Communist ground fire and one Australian jet to "unknown cause."

The Air Force said three records were set in Friday's air activities. The 1,443 sorties set out over Pyongyang was the largest number to hit a single target. A total of 1,526 sorties was flown altogether during the day. And the Fifth Air Force alone mounted 1,360 of the sorties.

Bethel Schedules Harvest Festival

Parade and Day-Long Program Is Planned September 23

BETHEL—Centering around Bethel's sweet potato market, a Harvest Festival will be launched for the first time this year.

A number of committees, headed by general chairman Mayor R. L. Martin, have been working on the festival for some time, lining up a parade, speakers, exhibits, contests and other events. The festival will be a one-day affair, scheduled for Thursday, September 25.

Mayor Martin said the events would be led off with a parade featuring a well-known cowboy, high school bands in the county, floats, decorated cars and bicycles and other novelties. Cash prizes will be offered for the best float, bicycle and novelty. The parade will end at the sweet potato auction grounds and be concluded with a musical program by participating bands. Following a number of announcements, Frank Jeter of the State College will address the group.

The afternoon events, following a barbecue dinner, will begin with the opening of the exhibits in potato storage warehouse number one. Cash prizes will be given for the best fill of potatoes with all potatoes attached to the vine; best one bushel and three bushel display of potatoes; best two trays of six potatoes; best hill of corn; best stalk of cotton; and best hill of peanuts; and for the best exhibit put on.

The Bethel Theatre will sponsor a free movie for the afternoon. Cash prizes will again be offered in a number of contests for school boys and girls. The contests lined up are a chop stick potato roll; sweet potato relay race; sweet potato peeling contest; and a sweet potato basket race.

Night events will include a hillbilly band and program. Prizes will be presented during the program which will be followed by square and round dancing in Blount's Potato House.

WASHINGTON (AP)—James A. Farley, former Democratic chairman, told President Truman today that Gov. Adlai Stevenson is going to win a "very substantial victory" in November.

Farley talked with reporters at the White House after a 15-minute visit with the President. Farley said he repeated to Truman what he said in an interview in New York yesterday, that the Democratic Party has better unity than at any time since 1936.

Death In County

Bicyclist Injured Aug. 6 Succumbs In Hospital Friday

Pitt chalked up its eighth traffic fatality yesterday afternoon when a 55-year-old Winterville man died of injuries received on August 6.

Coroner Griffin H. Rouse yesterday afternoon reported that Walter L. James of Route 2, Winterville, died in Pitt Memorial Hospital where he had been confined since he was injured on Saturday night, August 6, on the Winterville highway.

James was riding his bicycle around eight o'clock Saturday night when struck by a car operated by Jesse Rollins of Winterville.

James was rushed to Pitt Memorial Hospital in a serious condition but was later reported to be doing "well."

Coroner Rouse this morning reported an autopsy was performed on the man to see if he died of injuries sustained in the accident. However, the report on the findings have not been made known yet, and will probably not be released until Monday, Rouse said.

A definite date has not been set for an inquest, but one will be held in the near future, Rouse stated.

Driver Rollins was released by Patrolman Jim Davis and Cpl. C. E. Whitfield, investigating officers, following the accident pending the outcome of the victim's condition.

Navy Tug Sunk By Enemy Mine In Korean Waters

TOKYO (UP)—A loose enemy mine floating off Korea's east coast sank the 1,589-ton fleet tug USS Sars yesterday and two sailors were killed, three are missing and four were seriously injured, the Navy announced today.

The 205-foot Sars plunged to the bottom of the ocean off Hungnam 16 minutes after the explosion, but 92 officers and men survived the disaster.

Lt. William M. Howard, of Norfolk, Va., commander of the tug, was among those who escaped.

The Navy said the detonating mine's explosion damaged the tug's communications equipment and prevented the sending of distress signals.

However, three ships were on the scene within 30 minutes and picked up the survivors.

Emergency Warnings Raised As Hurricane Moves In Northwest Direction; Georgia And South Carolina In Path

JACKSONVILLE, Fla. (UP)—The Atlantic hurricane moved toward the coast today and emergency hurricane warnings were ordered for the strip between Fernandina, Fla., and Georgetown, S.C.

In a special 9 a.m. advisory, the weather bureau at Miami placed the hurricane about 110 miles east of St. Augustine, Fla., and said it is "moving very slowly northwestward at about 10 miles an hour, attended by a small area of hurricane force winds around the center."

Strongest winds were estimated at 50 to 60 miles an hour.

A slow movement in a northwesterly direction is expected to continue, the weather bureau said.

All interests on the Georgia and South Carolina coasts should take immediate hurricane precautions. This is an emergency.

Fernandina is about 30 miles north of Jacksonville.

The weather bureau ordered storm warnings to remain up as far south as Jacksonville and as far north as Wilmington, N.C.

In the path of the storm on its present course is the entire coastline of Georgia and a good part of the South Carolina coast, a region of many summer resorts and pleasure islands.

In an advisory at 5 a.m. EST the Miami weather bureau located the center of the tropical disturbance, the season's first, about 130 miles east-southeast of Jacksonville.

The bureau said the hurricane had slowed in forward motion, in said it was hoped the new plan would lead to "an early and equitable solution of the present dispute."

Wants To Obtain 35 Comet Jets

LONDON (UP)—Capt. Eddie Rickenbacker said today he still wants to buy 35 British Comet jetliners for his Eastern Air Lines in the United States if the British can deliver them within three years.

The World War I ace told a press conference that the deal for the Comets depends on how soon the DeHavilland Aircraft Co. can deliver the jet air liners.

Rickenbacker said he wanted the planes by 1955 or early 1956. The British said earlier this week that they could not promise delivery before 1957.

Some time later the woman paraded back down the hallway, casting a sly glance at "the not too bright officer," as he disappeared through the doorway leading into the street.

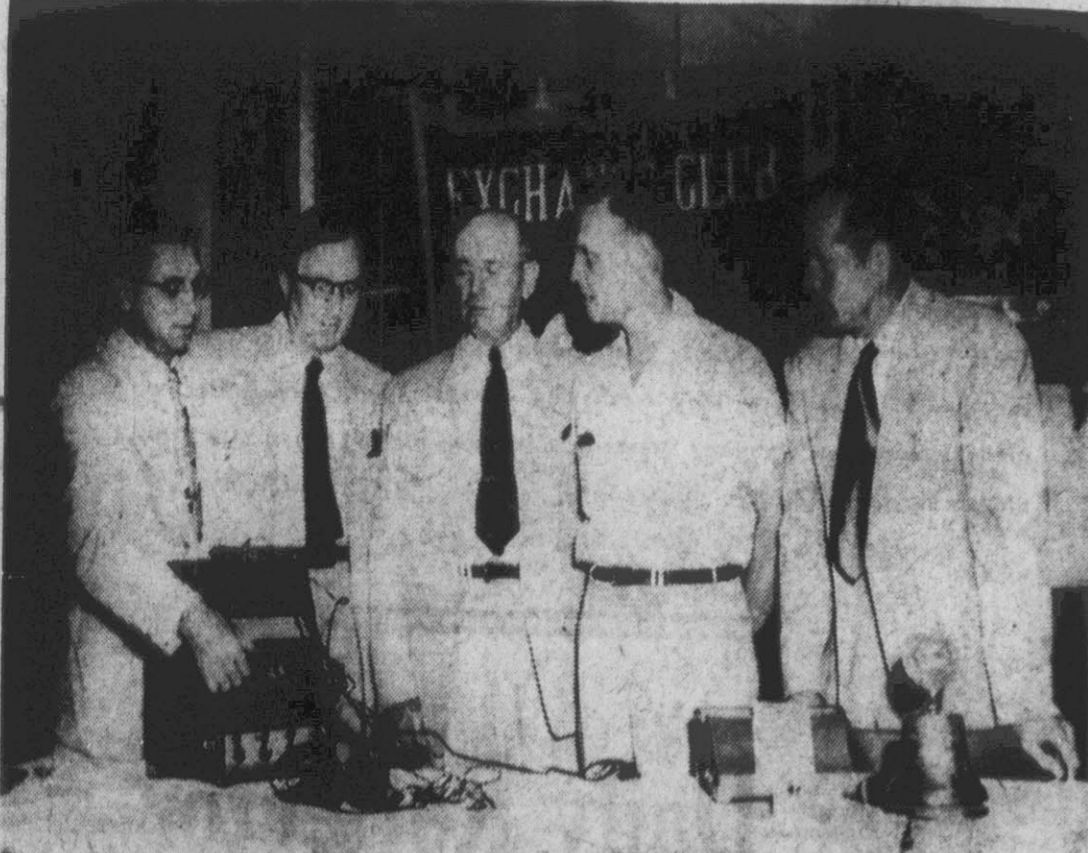
While a wave of laughter was still going around the room, in walked the Lieutenant of detectives, who lowered his head and said, "I didn't think that you would do a thing like that to me."

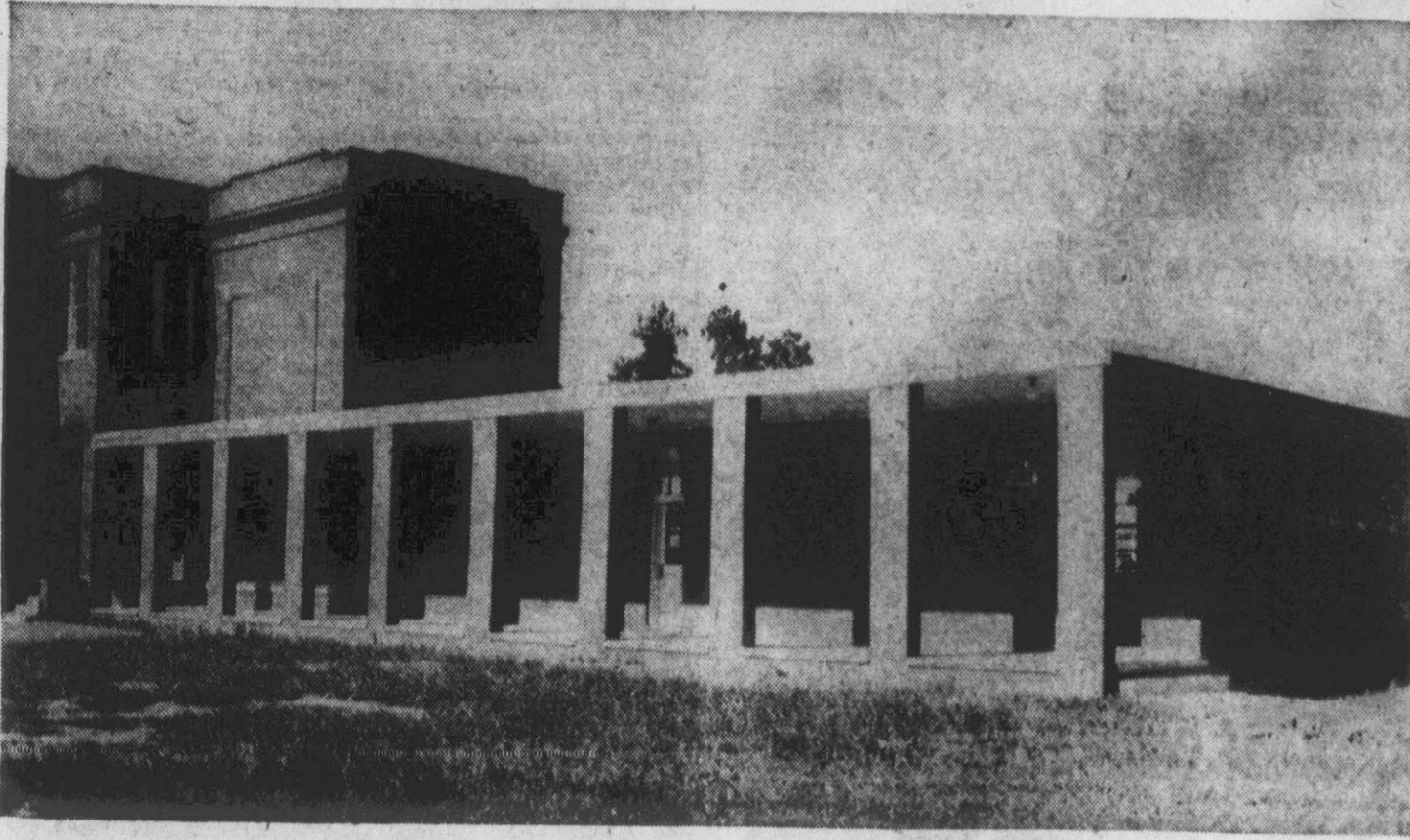

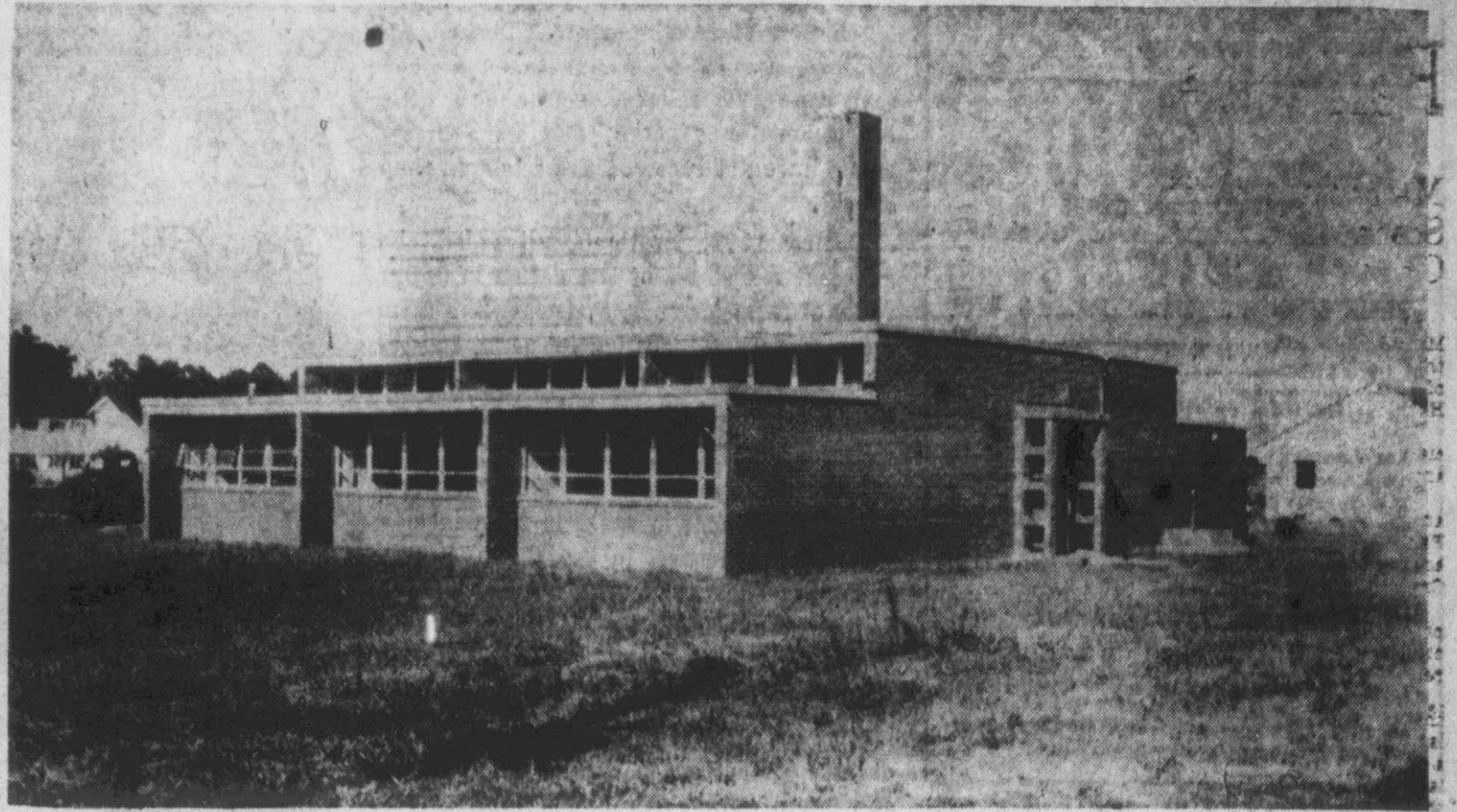

# County Schools Open With Many New Buildings In Use

Tuesday was just another day to most people in the Pitt County but to young boys and girls it was a day that comes only once a year. No, it wasn't Christmas in August—it was back to school.

And to most of the kids in the county, it was a return to the same classrooms and buildings as last year and the year before. But to some, especially the Negro children, new classrooms of ultra-modern design awaited occupation.

The new buildings, called "clear-story" or "deep classroom" design showed that a change from the old type school is progressing rapidly in the county.

The new type of classroom is deep and normally measures around 33 by 22 feet. The advantage of these new rooms is less exterior wall exposed to cold which makes them easier to heat. The position of windows in the new type classroom lets daylight in from many angles.

**Negro Building Program**  
Construction work last year and through the summer marked rapid extension of the building program for Negro schools. Additional classroom space and new buildings have been recently constructed for Negro students at Grifton, Winterville, Fountain, Grimesland, Bethel, and Stokes.

Two new classrooms, following the modern design, were added to the six-room unit at Grifton plus a boiler room, janitor's rooms, and toilets. This new building cost the county approximately \$42,586.

Robinson Union School at Winterville boasts a new four-room primary addition with toilets. In addition to the new building, 3,600 feet of sewer line was added; the whole project costing around \$47,337.

Work on the new eight-room school for Negroes at Fountain was completed last Spring but was

not occupied until this by students. In addition to the school, the land and equipment brought the cost of the project to \$70,418.

Students at the Pitt County Training School at Grimesland were hard at work yesterday clearing the grounds around their new classroom building. The new building contains eight classrooms, toilets, and has steam heat. It was constructed at a cost of \$87,131, with the new equipment mounting the total cost to around \$70,531.

The new Negro School at Bethel was occupied last year just before school closed. The frame and brick building has three classrooms and steam heat. Equipment costing around \$1,500 brought the total cost of the project up to \$45,131.

A new building for Negro students is under construction at Stokes and is expected to be completed in 90 days. The new building will have six classrooms, toilets, and steam heat. With a water system costing \$1,500, land costing \$1,200, and equipment at \$1,500, the total cost of the project will be close to \$49,500.

The most recent construction in the building program for white schools was at Chicod where two classrooms, also of the modern type, were added. This unit cost around \$20,075.

**New Buses In Sight**  
Along with a rapid growth in school buildings, the growth of Pitt County's fleet of school buses is also evident. D.H. Conley, superintendent of the county schools, said that new buses would be added to the present fleet of 132 at the rate of five to six units each year until the need is reached.

Conley said six new buses will serve students this year, taking care of Negro school students who ride the bus to school. One new bus is in operation for Grifton students and another is in operation on the Falkland-Farmville road.

In addition to these, two will be added for Sallie Branch School students when the present construction program is complete there; one will be added for Pitt County Training School students; and another will be added for Winterville students. No new buses will be added to the fleet for white school children.

**Curriculum Guide**  
During the summer months, the two school supervisors, Miss Annie Lee Jones and Mrs. Edna E. Baker, worked on a curriculum guide for the elementary school program in the county.

The two supervisors recently issued the 87-page booklet on a

suggested curriculum for the year in which elementary schools, grades one through eight, could follow.

The introduction to the booklet explains that it is to be used to attain a certain degree of uniformity in the classroom instruction in the Pitt County elementary schools. The suggestions made in the guide are to help plan for the pupils in the various subject areas in each grade level.

Since it is designed as a guide, the booklet suggests sequence material to be presented, objectives and skills and abilities that can be developed by students.

## Youth Impersonated Truman In Swindle

BASIN, Wyo. (UP)—The FBI today held a 16-year-old boy who impersonated President Truman and talked an 83-year-old widow out of \$200 to "fight communism."

The boy, whose name was withheld, was charged with "impersonating a federal officer—to wit, Harry S. Truman."

The lad's third attempt to get money from the woman ran his demands up to \$2,000. The widow became suspicious and called in local authorities and the FBI.

His confidence game began when he and two companions demanded \$150 from the widow so one of the boys "could visit his mother in Alaska."

George Burton, special agent in charge of the FBI in Denver, said the boy returned to the widow's home Aug. 8 wearing a business suit and dark glasses. He passed himself off as an agent of the "U. S. Secret Ranger Service," Burton said, and got \$200 to "fight communism."

Then the boy played his trump card. He impersonated the President.

From Plymouth, Mich., where he had hitch-hiked, he sent the woman a letter. It was signed "Harry S. Truman, Pres. of U. S."

Here is his letter: "This is a very important letter from me, the President of the United States of America."

"I am asking a great favor from you. Read every word of this! "There is a boy in Plymouth, Mich., where I am a, he has no legs nor no arms & I was in hopes that you would send this boy \$2,000.00 two thousand dollars for new arms and legs, which were shot off fighting for his country."

The letter then gave an address to which the money should be sent. "Do not let anyone else read this letter or you will get into plenty of trouble."

"Please send the money right away as soon as you get this letter do not wait one day to send it. "Yours Truly, "Harry S. Truman "Pres. of U. S. "P. S.: Send it right away. "Burn this envelope and letter!"

## And How Shaggy Is Our Shaggy Dog?

Ever hear the story about the shaggy dog? Well, maybe you have, and maybe you haven't; but it goes something like this: The keeper of the dog took great pride in his pet, and bragged incessantly about the heavy coat of the animal, the fact that he took such good care of it, and the fact that the dog was the most perfect specimen of a shaggy dog in the world. But when the time came for the selection, the judges looked at the canine in question, and calmly commented, "O that dog ain't so shaggy."

In a great many respects, that story sort of reminds us of the situation which now exists between the military leaders of the nation and the congressional watchdogs whose responsibility it is to view and evaluate the nation's military strength and progress.

While the Secretary of the Army, the Secretary of the Air Force and Secretary of the Navy were pointing to the growth and qualities of their pet "shaggy dogs" before the national convention of the American Legion, congressional investigators—the peoples' watchdogs on this defense and mobilization build-up—were uttering bitter criticisms and charging miserable "blundering" had kept the nation from attaining the military might it should have since the beginning of the Korean War.

Particularly was the nation's air power a bone of contention between the "shaggy dog" masters and the sideline judges. Air Force Secretary Finletter was telling Legionnaires the United States is building a "dreadful force" of atomic air power and added it will be "the most devastating thing" in aerial history. Shifting from the future to the present, the Secretary asserted the nation's defenses are "in pretty good shape" as it is now.

At almost the same instant the Senate preparedness subcommittee was charging blundering by high officials has slowed the nation's air buildup to the point that national security is threatened. It added that the United States has lost "mastery of the air" and had as of July 1 "only one-half of the combat wings with modern equipment which were deemed necessary." The report pointed out that the Air Force actually possessed now fewer fighting planes than it had before the Korean War began.

Well, there we have it. Is the dog or is the dog not so very shaggy? On the one hand we have the keeper who praises his pet to high heavens. On the other hand we have a set of judges—possibly a little less biased than the keeper—who see the situation altogether differently.

Unfortunately the shaggy dog of American defense is too large for the people to view. We have to rely on the views of the keepers and the watchers, discount each view slightly, and draw our own conclusions.

## Agriculture Is Aiding Economic Stability Too

Of late, North Carolina has been enthusiastic, if not boastful about its growing industrial development. Although agriculture has by no means taken a back seat, it has, we believe, been taken a little too much for granted, and its achievements have not received the attention they should.

During 1951, North Carolina led the Southeastern states of the nation in dollar value of farm incomes, and when the farm incomes were tallied, led its nearest sister state by almost \$300,000,000.

The farm income for the Southeastern states last year jumped 23 per cent over the previous year, and while North Carolina's 26 per cent increase in farm income was not the highest in the group, it was three per cent above the average of the Southeastern states.

The state's farm income during 1951 totaled \$756,900,000 compared with a farm income of \$467,656,000 in Georgia, its nearest competitor. It can not be denied—and few people try to do so—that agriculture is still the principal economy of most of North Carolina, particularly Eastern North Carolina. The influx of industry is adding stability to the economy, but by the same token, improved farming methods are contributing tremendously to the economic stability of the Eastern section of the State.

Good crop years and high prices of course pointedly affect the farm income of North Carolina, but improved farming methods which continue year after year prove to be more constant factors in raising the farm income of the state. Much progress has been made along this line in Pitt and other counties, and there is still room for more.

## National Whirligig

WASHINGTON—"Do you believe," asks Mrs. T. F. of Brooklyn, N. Y., "that Stevenson can and will give us the change of policies and faces at Washington which so many millions want? To me, this is the big issue of the campaign."

DIFFICULT—Answer: Governor Stevenson can do it, and I believe that he will, from his public statements and actions. I know only two members of the Cabinet who would like to cling to their juicy jobs—Secretaries Chapman and Brannan.

Changing the guard at Washington, however, is a more difficult task than is generally appreciated. Most of the members of important commissions are appointed for specific terms, and cannot be removed except on charges. Many top officials in the policy-making bureaus and departments are under Civil Service, and immune to political vicissitudes. Finally, even minor government employees have a voice in major decisions. Although they simply assemble statistical data and prepare reports, the manner in which they do that work affects the conclusions eventually reached.

CUE—Having observed four changes of Administration at Washington, however, it is my experience that government officials and employees take their cue from the man at the top—namely, the President. Only a few, and they are easily spotted, try to impose their own theories and prejudices in defiance of presidential policy and instructions.

For instance, the general atmosphere and the attitude of every federal official, from Cabinet member to messenger boy, changed when Coolidge succeeded Harding. There was a similar change, though for the worse, when Truman took over.

EVIDENCE—Ironically, as evidence that minor government officials share even the Supreme Court's habit of studying and acting on the election returns, I may cite the case of Milton Eisenhower, now president of Penn State College and brother of the Republican presidential nominee.

Milton was named as public relations director at Agriculture during the Coolidge Administration. He was a conservative Kansas Republican, and he agreed with and publicized the Coolidge-Jardine-Hyde views on farm problems.

He was such an excellent advocate of their limited ideas on this subject that he won promotions and pay raises. Their farm policy, of course, was utter laissez-faire, or do-nothing to rock the boat. It was a sink-or-swim program for the farmer.

OPPORTUNIST—When Franklin D. Roosevelt's triumph swept Wallace, Tagwell and other agricultural revolutionists into Milton's department, he was pained. He asked friends, including the writer, whether he should tell the incoming radicals that he was a Coolidge conservative, and resign.

He stayed on. In fact, he became the most noisy and enthusiastic advocate of Roosevelt-Wallace-Tagwell proposals for unprecedented aid to the Supreme Court originally held unconstitutional aid to farmers.

An opportunist, Milton wanted further advancement. Single-handedly, he created the post of land coordination manager, and wangled it for himself. As the title suggests, his new office transformed this erstwhile Coolidge servant into the chief exponent and executor of federally planned, regimented and subsidized agriculture.

In short, a strong and determined President can, if he will, cleanse Washington from basement to the attic.

SECURITY—"If a person becomes 65 years old and owns a little home," inquires W. N. of Beckley, West Va., "does he have to give his home away before he can draw Social Security payments?"

Answer: I get many letters like this, and they worry me lest misunderstanding of the law deprive some aged person of legitimate benefits. The answer is that no matter how much property a person owns, or how large an income he has from investments, he is entitled to Social Security money. In fact, he may even earn as much as \$900 a year from daily work.

Scheme—"How could Truman's salary be increased to \$150,000," asks W. B. of Deposit, N. Y., "when shall neither be increased or diminished during the period for which he shall have been elected?"

Answer: President Truman's friends on Capitol Hill bypassed that barrier quite easily. They passed the increased salary law between his election in 1948 and his inauguration in January, 1949. Therefore, he got the raise before the period for which he had been elected, since he did not take office until some time after the bill was passed. Speaker Rayburn devised the scheme as an old Truman buddy.

## Around Capitol Square

BLESSED - It was one of those things that just happen, without any advance notice or planning. Two men met on a street corner and started talking. They were joined by another and another until about half a dozen were involved in the discussion. The talk started about a bus wreck, moved on to California earthquakes and other catastrophes. Main point was the relative freedom of North Carolina from any of these major disasters. This area seems to be singularly blessed in that respect.

FLASH - Of course we have suffered from flash floods and localized storms. But the mountain barricade on the west against devastating winds, and protection of the outer banks against tidal inundations on large scale, have prevented the total havoc experienced in some other parts of the country. That doesn't help the few families victimized by tornadoes and floods, but it does support the idea that North Carolina as a whole is very fortunate in its geographic barriers against total disaster.

DROUTH - The nationwide drouth this summer affected North Carolina less than many other states. In a few communities the damage was heavy, but it is a known fact that the vote among agricultural leaders on the question of requesting state designation as a "disaster area" was very close. Rains came too late to save some farms, but on state-wide scale it is still doubtful whether relief should have been asked at Federal government expense. Certainly there was none of the devastating experience of some mid-western states this year and previously when "dust bowls" replaced normally productive farms. It is of record that the State Banking Commissioner and numerous private bankers protested news stories emanating from Washington that North Carolina could not take care of its own needs resulting from the drouth.

EARTHQUAKES - Two or three oldsters in that street corner confab recalled childhood stories of their fathers about the Charleston earthquake 65 years ago. It was admitted that an earthquake might play havoc anywhere anytime and that no preliminary warning could be expected. Boasting about freedom from earthquakes obviously is very foolish. But the historic fact cannot be ignored that only since this particular part of the world has been "civilized" has it experienced serious upset from that source, whereas within that same period the West Coast of North America and many other parts of the world have been subjected to recurring disturbances—some of them reaching tragic proportions.

COMFORTING - It is understandable that the few families which have been victimized by river floods and tidal waves and localized cyclones cannot agree that North Carolina is peculiarly blessed with protective mountains and sand banks. The farmer whose fields and pastures have been completely ruined by drouth cannot be expected to join the hallelujah chorus of thanksgiving for protection against a dust bowl. But by and large, North Carolinians have the comforting assurance that nature has provided reasonable guarantee against complete disaster in these respects.

HEADS UP - So, North Carolinians are keeping their heads up. Despite the drouth and the questionable placing of North

Let us go the rest of the way, moving in on the remaining credit and the utilities and we're precisely where Britain is. No one ever wanted to go that way, though we've been led against our wishes. Give Reuther and some more enough rope and we'll go the rest of the way, whether we like it or not.

## Business Today

Some economists, particularly stock-market specialists who live in an anxious world anyway are concerned that wholesale and retail price indexes have followed separate paths this year. Logically and traditionally, the two lines ought to keep within nodding distance of each other on a sheet of graph paper. But the U.S. Bureau of Labor Statistics index of retail prices has been rising steadily for five months and is perched on a new peak, while some of the wholesale commodity price indexes currently are about 20 per cent below their 1951 highs.

That could mean a correction in one or the other of the indexes currently are about 20 per cent below their 1951 highs.

That could mean a correction in the other of the indexes is in the making, although this department won't attempt to guarantee it.

A possible correction could either result from a drop in the retail index, popularly known as the cost of living index, while the commodity indexes remain down in the cellar. Or, the cost of living could stay up while commodity prices start climbing to their level.

But there's another possibility the economists tend to overlook. The two sets of indexes could stay further apart than formerly. For one thing, immediately after Korea the more volatile wholesale indexes shot up faster and further than the retail charts, and their resultant plunge itself could be considered a correction.

For another the spread between prices of raw materials and those of finished products has tended to increase anyway in recent years because of higher marketing costs. This is especially true in the food field where more and more foods are pre-packaged, pre-cooked or otherwise readied for easier homemaking, like the ready-made cake mixes, cheeses you spread with a knife, washed spinach, etc.

Certainly it's hard to visualize an immediate drop in the general level of retail prices, meaning the overall cost of living. Some cost-of-living items have come down already, like clothing, textiles, and several lines of household equipment. But food prices continue inexorably high, and the rent index goes up in small but steady amounts every month on the Bureau of Labor Statistics graph.

It seems more reasonable to expect a partial correction in the disparity of the two indexes would result from an upswing in commodity prices. Note the

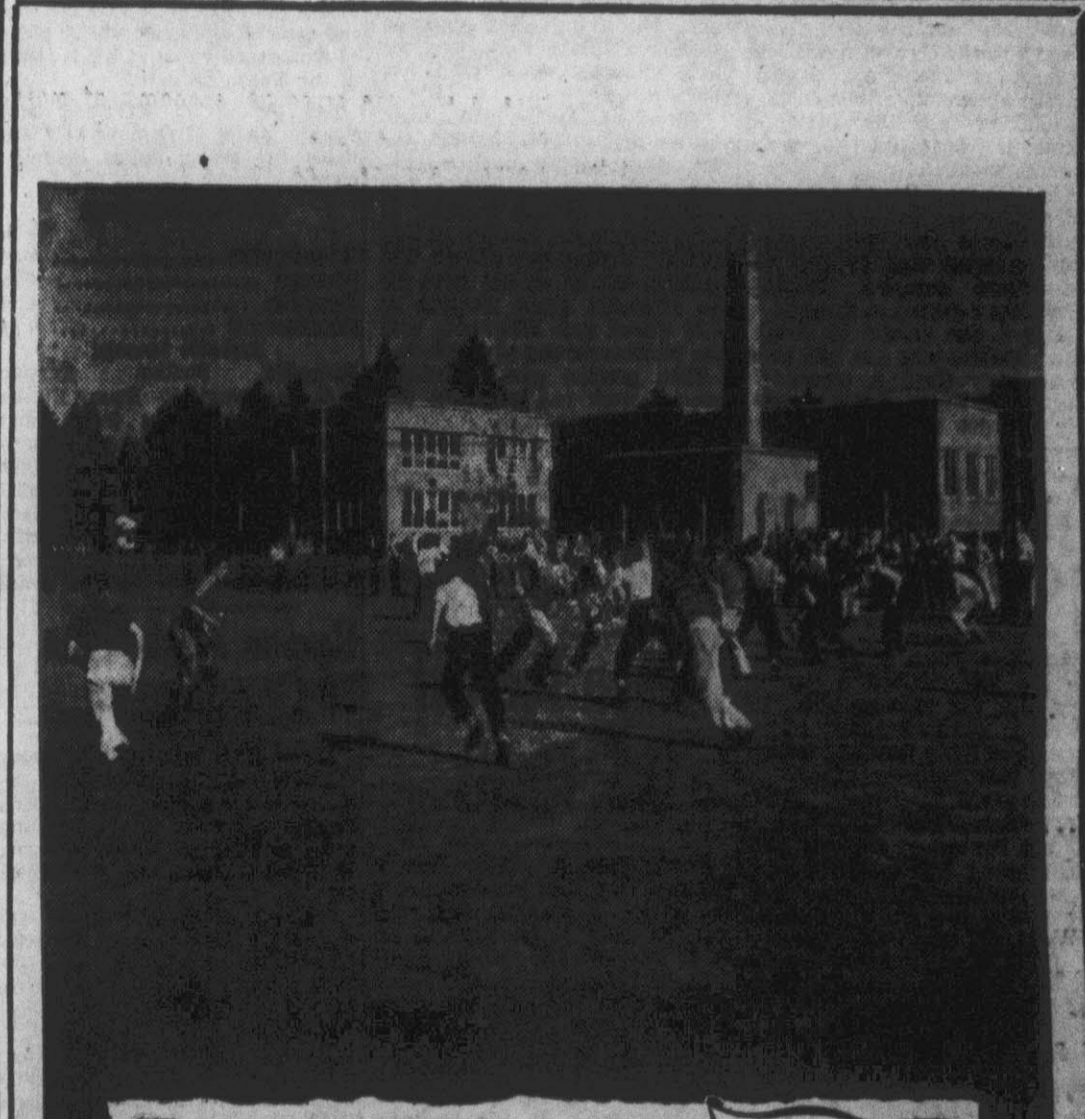

When A Team Is Too Good Did you ever hear of a college team being forced to quit participating because they were too good?

Well, so has been the fate of the Appalachian State Teachers College wrestling team. R. W. Watkins, veteran Mountaineer wrestling coach, has requested the athletic committee to drop intercollegiate wrestling because of inability to schedule matches.

This inability is directly the result of the splendid 19 years coaching record of Coach Watkins, who rolled up a mark of 134 wins, 14 losses, and 18 consecutive Carolina AAU wrestling titles.

In 1950, Appalachian was unofficially listed as the Southern wrestling champions by virtue of their undefeated season. Chief opponents that year were the Southern Conference Champion Washington & Lee Generals, and Southeast Conference Champion Auburn.

During the 1950 season the team set a new national scoring record of 360 points for the year. This record virtually assured the abandonment of the sport. Teams which had heretofore been on the Mountaineer schedule suddenly found it convenient to seek matches elsewhere.

The 1951 schedule did not provide too much in the way of entertainment for the student body, so rather than schedule an insignificant program Watkins asked that wrestling be dropped.

It is a fine tribute to Coach "Red" Watkins who has had just about every thrill a successful coach could have. And it is fitting that due to his inability to

schedule worthy competition, Coach Watkins has asked that the sport be removed from intercollegiate competition.

**More About Little League**  
The figure may sound slightly exaggerated but Little League officials are convinced that in a few years the total of Little Leagues in America will pass the 5,000 mark. That total is not a goal, but merely a prediction made on the basis of League increases in the last few years.

Few other sports programs in the history of the nation have grown as fast as Little League Baseball. The pattern for the last four years has been the same... each year the total of Leagues has more than doubled.

If there is any way possible to produce baseball stars of the future that can compare with those of the revered "old boys" of the Little League program is it.

**Twice A Day Everyday**

"As soon as he receives his orders the Marine Corps will release the story."

NEW YORK, Aug. 30 (UP)—The Giants' famed baseball "miracle" which was born amid a backdrop of bedlam and hysteria a year ago, may be laid gently to rest by a group of unsympathetic Brooklyn pall bearers tonight.

Interment is scheduled for Ebbets Field where Sal (the once-magnificent) Maglie will make a last-minute attempt to breathe some life in what certainly appears to be a dying Giant baseball body.

The Doughty Dodgers, who went into mourning themselves after Bobby Thomson's historic homer sounded their death knell last October, will nominate either Johnny Rutherford or Cockey Billy Loes to face the Giants tonight in the first of the final seven games between the two clubs.

Rutherford and the imperturbable Loes, who blandly declares, "I don't know why everybody gets so excited whenever we play the Giants," have been well rested for tonight's test against Maglie and will be shooting to increase Brooklyn's lead to 10 full games over the moribund Giants.

Brooklyn's mad-dash toward the National League flag suffered an inconsequential delay at the hands of young Warren Hacker of the Cubs yesterday.

Limiting the Dodgers to four hits—one of which was Roy Campanella's 20th homer of the season—Hacker gained his 12th victory of the year against six defeats. Chicago drove Preacher Roe from the mound with three runs in the seventh inning.

Harr. Chiti began Roe's downfall with a single and rode home easily on Roy Smalley's triple to pinch-hitter Bruce Edwards singled home Smalley. Another single by Frank Baumholtz drove Roe from the mound although Edwards was caught trying to make third. Ben Wade came in and yielded singles to Bill Seren and Hank Sauer for the Cubs' third run of the inning.

It was the only National League game scheduled. Cleveland sliced the Yankees' American lead to a single game by beating Detroit, 4-2, while New York bowed to Washington, 3-2.

Walt Masterson, who held the Yankees to six hits including a pinch home run by Johnny Mize with two out in the ninth, was credited with his eighth victory as he out-hurled Vic Raschi.

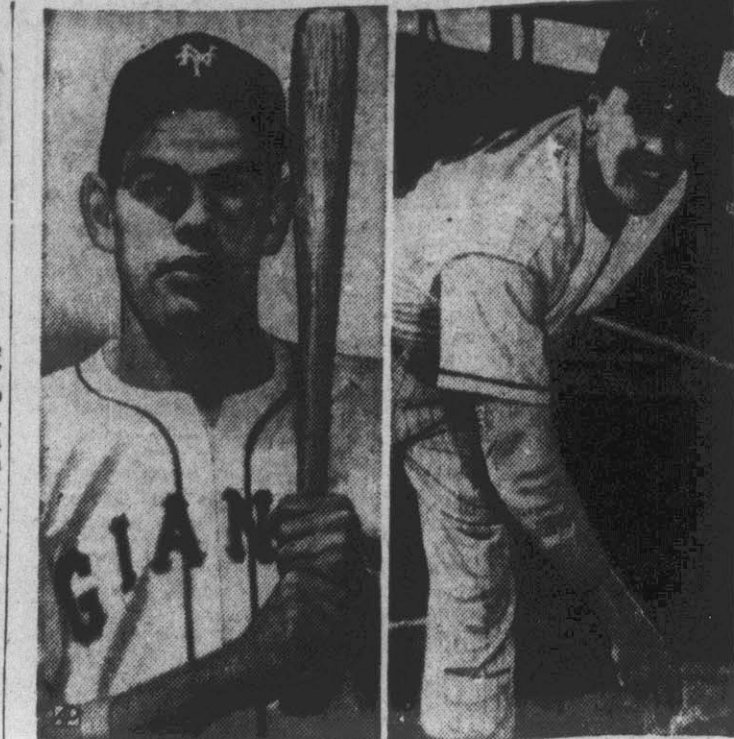
Raschi put the Yankees ahead with a single that scored Billy Martin, who had doubled in the third, but Gene Coan tied the game with a homer in the eighth.

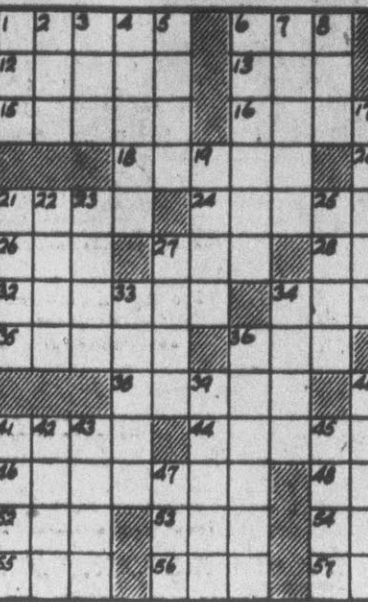

## See Union Shop For Railroads

WASHINGTON (UP)—Union officials confidently predicted today that Western railroads would follow the course of Eastern carriers and sign a union shop agreement with non-operating rail workers. They were doubtful about South-eastern railroads.

Seventeen non-operating unions scored a major victory last night when they signed the first widespread union shop agreement in the railroad industry with the Eastern group of railroads. The agreement

requires a worker to join a union within 60 days after he is employed. It becomes effective Sept. 15.

George E. Leighty, chairman of the Railway Labor Executives Association, said representatives of the 17 unions would meet here Wednesday to work out strategy for reaching a similar union shop agreement with Western and South-eastern railroads.

The Western railroads, which broke off talks with the unions two days after they opened last week, have been holding out for a watered-down type of union shop similar to that signed between the CIO United Steelworkers and the basic steel industry. The steel agreement permits new employees to drop out of the union and allows old employees to stay out of the union if they so desire.

The Southeastern railroads, which led opposition to the union shop during fact-finding hearings, thus far have refused even to bargain on the union shop issue.

## Fire Destroys Passenger Ship

HAMILTON, Ont. (UP)—A triple-decked Great Lakes passenger ship was destroyed by fire as she lay at dock here early today. Authorities said there were no casualties.

The E. S. Hamilton, used for picnics, excursions, moonlight cruises and sight-seeing trips, burned to the waterline in two hours. She usually carries as many as 400 passengers on her trips in Lake Ontario.

## Newsboys Plan Promote Bonds

WASHINGTON (UP)—Some 200,000 newspaper boys from 500 daily newspapers will promote sales of defense bonds Oct. 4.

Treasury Secretary John W. Snyder announced yesterday that on "Newspaper Boy Day" the carriers will deliver a special sales appeal for the new Series E defense bonds to 12,000,000 American homes.

## Audiometer Presented By Exchange Club To Assist Children Of County

Pitt County school children who suffer from poor hearing, but apparently are unaware of it, will be given a helping hand this year, thanks to the Greenville Exchange Club.

Last night the club formally turned over for use by the County and City schools an audiometer, a specially designed instrument for detecting faulty hearing among youngsters.

The brief ceremony was held at the weekly meeting of the local Exchange Club as the instrument was presented to city school superintendent June H. Rose and county school superintendent Don H. Conley.

Opening the meeting last night, President Bill Riggs, stated to the group that "It is a pleasure to be doing what we have been looking forward to for some time. It was several months ago that we wanted to do something which would benefit the people of the county as a group. It was then that we looked to the schools and saw our need there.

"It was agreed to purchase an audiometer to screen the children in the school system who are suffering from faulty hearing and therefore cannot do their best work and keep up with their fellow students."

A napkin sale was held and the result was overwhelming, as between \$1,100 and \$1,200 was raised, enough to purchase the machine.

It was further agreed by the club, the president pointed out, that in the event that a person was found to need their hearing corrected and could not afford the expense, that the local club would attempt to aid in paying for the needed treatment or equipment.

"We purchase the machine, which we think is the best of its kind in every way, and it was not bought until information was received on the various types of units and the best one selected from them," he said.

Dr. Melvin Hoot, who has played a primary role in securing the machine, spoke briefly saying "Who will benefit the most from this service? A person's entire life can be changed by the testing. It will mean the making of a useful citizen instead of a retarded one," the doctor pointed out.

"What you Exchange Club members have done, actually, is to adopt a bunch of orphans, ones who need assistance with their hearing," he said.

Past President Robert Moyer, under whose leadership the drive for the machine was initiated, stated "Everybody should be proud to have had a part in the buying of the instrument and in its future."

In accepting the machine June H. Rose said, "The children of the machine will be placed in the hands of a trained person where it will do the most good. It has been needed for years and now we can render a service long overdue."

County School Superintendent Don Conley accepted by saying, "On behalf of the rural school children I am deeply grateful for this machine. It has long been a needed item and will be used at once to screen the faulty hearing of many of our children."

Dr. Haney inducted Alderman Robert Elks as a member of the Kiwanis Club and outlines some of the club's history and policy.

### Milk Price Hike Said Due Drouth

"The increase in the price of milk is due to the recent drouth in North Carolina and declaring this an emergency state by the U. S. Department of Agriculture," John B. Webb Jr., manager of Carolina Dairy Products, Inc., said today.  
"The price of milk, now 24 cents a quart, will be increased to 25 cents September 1. The dairymen in the state have been hard hit for pastureage and they are going into the winter months with scant supplies of feed," Webb declared. "In order to stay in business producing the milk we need so much, it is necessary that the producers receive more money for milk."

Webb said his company is passing the penny increase along to the milk producers.

"We have worked hard in recent years to encourage an increase in the dairy herds in this part of the state," he said, "and we believe we have reached that goal. If we want these dairy cattle owners to stay in business and supply the community with milk it is important that they make a profit."

Webb displayed to a reporter handbills from different parts of the state announcing sale of dairy herds "because there is so little profit in the business now, with the high cost of feedstuffs."
