Supply Center In North Korea Is Target Of Allied Bombing Attack

Secondary Explosions Indicate Ammunition Destroyed; Light Ground Action

SEOUL, Korea (UP)—Air Force Thunder jets and Marine fighter-bombers hurled tons of bombs and napalm today on a vast Communist troop and ammunition center 15 miles southeast of Pyongyang, capital of North Korea as U. N. artillery smashed a Chinese attack on Sniper Ridge.

Returning pilots reported secondary explosions from the blistering air attack sent "glowing balls of fire" shooting into the air, indicating the area contained rockets or other ammunition.

While the fighter-bombers were carrying out their deadly mission, American Sabre jets patrolled "MIG alley" in northwest Korea. However, they made no contact with communist MIG-15 jet fighters.

Other Allied fighter-bombers dropped bombs on Communist positions, concentrating their attacks on the ridge sector north of Kumhwa on the central front.

The central front air strikes came a few hours after a pre-dawn Allied artillery barrage smashed a Chinese attack on Sniper Ridge.

A squad of Reds advancing in the darkness towards Rocky Point, a hill jutting eastward from Sniper, in an apparent test of South Korean defenses, were spotted by United Nations big guns. They pumped shell after shell at them, forcing the Reds to break and flee back to their own positions.

Northwest of Yonchon, U.N. night raiders ripped into a Chinese outpost, surprising the Reds into a withdrawal. Then the Chinese mustered a 200-man counter-attack and charged up the hill in a violent assault.

The outnumbered Allied unit pulled off the position and returned to its own lines. The action took about 10 minutes.

North of Chorwon on the central front, an Allied patrol sparred with a small Red force just after midnight, then broke off the fight. When they returned to their own lines, the U. N. soldiers discovered they were missing a man.

Covered by artillery, mortar and a tank barrage, the raiders searched through the darkness until they found their comrade. He was unhurt.

The rest of the 155-mile battlefront was quiet except for patrol contacts.

Thick clouds shielded Red supply trucks as they rumbled toward the front during the night.

B-29 superforts and B-26 invaders attacked supply and rail targets deep in North Korea, bombing by radar.

Former Queen Of Italy Succumbs

MONTPELLIER, France (UP)—Former Queen Elena, the beloved "madrina"—first mother of the land-of-pre-war Italy, died here today following a lingering illness. The frail widow of the late King Victor Emmanuel had been suffering from cancer for several years.

Death came, according to an announcement by her attending physician, Dr. Paul Larmarque, as she attempted to arise from her bed at her Villa Mas Rouel.

H-Bomb Plant Secrecy Invoked

AUGUSTA, Ga. (UP)—The mantle of official secrecy will drop over the sprawling, 315-square mile Savannah River H-bomb plant in South Carolina in little more than two weeks.

The Atomic Energy Commission said after 12:01 a. m. Sunday, Dec. 14, only persons employed at the plant and authorized persons on official business will be permitted in the area.

Chilean Police Denounce Student Hoax In Reporting Of Septuplets

SANTIAGO, Chile (UP)—Federal police headquarters denounced as a student hoax today a report that the wife of a Santiago laborer gave birth to seven baby girls.

The police statement said there will be serious consequences for those involved. Midwife Adela de Figueroa said the 32-year-old mother Carmen Molina gave birth to the seven infants within an hour last night at a maternity home in the Santiago suburb of Conchalí.

Mrs. de Figueroa said the children were doing well, but that the mother was in a semi-conscious state and had been given oxygen. Authorities said the midwife informed two federal police—Oscar Ortega and Aquiles Barrera—last night of the multiple birth.

UN Vote Near On Indian Truce Plan

Compromise Formula Assured Of Passage By At Least 50 To 5 Margin Over Soviet Objections

UNITED NATIONS, N. Y. (UP)—The United Nations Political Committee hoped for a vote in its Korean debate today, with India's compromise peace formula sure of passage by at least 50 to 5 over Soviet objections.

The United States has announced it will accept the Indian compromise formula. Soviet Foreign Minister Andrei Y. Vishinsky has declared that both Russia and Communist China reject it.

Despite Red opposition, the endorsement of the plan by the U. S. assured it of overwhelming passage with few veto abstentions. Although there was little hope of a Communist change of heart, a landslide U. N. vote for the Indian measure was sought in the belief it would provide an effective propaganda weapon.

A U. S. spokesman stated that a second revision of the Indian measure met the "clarification" Secretary of State Dean Acheson had asked for and that the American delegation would vote for it, provided a Danish amendment also is accepted.

V. K. Krishna Menon, who authored the compromise plan on instructions from Indian Premier Jawaharlal Nehru, was scheduled as main speaker at today's meeting. He was expected to accept the Danish amendment.

As it stands, the Indian proposal calls for the problem of war prisoners resisting repatriation to be submitted to a high-level political conference—provided for in the tentative Panmunjom agreement—within 90 days after a Korean cease-fire. If any prisoners have not been repatriated in an additional 90 days, "responsibility for their care and maintenance and for their subsequent disposition shall be transferred to the U. N."

The Western majority of the U. N. thus conceivably would be free to resettle the non-repatriables in line with American views. The Danish amendment simply cuts the period in which the political conference could discuss the prisoners' future from 60 to 30 days. This was the best bargain the U. S. could gain in its demand for a definite "freedom deadline" for all prisoners.

Italian Statesman Seriously Ailing

ROME, Italy (UP)—Vittorio Emanuele Orlando, 92-year-old Italian World War I premier, remained in a serious condition today from a cerebral hemorrhage and heart attack suffered a week ago.

His doctors said they were not optimistic of Orlando's recovery because of his advanced age.

Two-Day Session Of 'Law-Making' Opens In City Today

Student representatives from 10 North Carolina high schools assembled in Greenville this morning for the annual two-day congress held under the auspices of the National Forensic League.

Greenville High School chapter of NFL is host this year to the 54 student legislators who are delegates from various high schools in this district.

The practice session in law-making will continue through tomorrow afternoon and is being held at Jarvis Memorial Methodist Church. At the conclusion of the congress, awards will be presented to outstanding senators and house members, and pins will be given all presiding chairmen.

Six bills are on today's congressional agenda. They are: 1. to prohibit the advertising of all intoxicating beverages; 2. to provide federal aid for the nation's rural libraries and library services; 3. to require all automobiles to be protected by liability insurance; 4. to provide for the United States to cooperate with Canada for joint building of the St. Lawrence River Seaway; 5. to change the name of America to Columbia in memory of the founder; and 6. to favor World Federal Government.

Due to the size of the local NFL chapter Greenville High School has the most members in the house, 13. Local officers are: Bobby Laughton, president; Virginia Smith, vice-president; Patsy Brooks, secretary; Donna Tabar, treasurer; and R. B. Starling, advisor.

Pitt County high schools represented at the congress are: Belvoir, Ayden, Stokes and Greenville. Other high schools attending are: Kinston, Marion, Concord, Roxboro, Raleigh and High Point.

TOOWOOMBA, Australia (UP)—Sister Elizabeth Kenny, who a week ago suffered an attack of cerebral thrombosis, was reported today to have contracted pneumonia and her chances of recovery were said to be "slight."

Her doctors continued to list her condition as "critical."

Australian Airline officials appealed to officials at Honolulu and the Canton and Fiji islands to cut formalities as much as possible in order not to delay an air transport flying a package of serum to Sister Kenny's bedside.

The serum—known as trypsin—was sent from the United States.

Women, Children Among 36 Victims Of C-54 Crash

TACOMA, Wash. (UP)—At least 36 persons, including 13 women and children, were killed early today when an Air Force C-54 crashed and burned while attempting a landing in heavy fog.

There were at least three survivors—one of them the eight-year-old son of a serviceman—Col. Jack Stovall, commanding officer of Military Air Transport Service at McChord Air Force Base said there were 32 passengers and seven crewmen aboard the ill-fated plane.

They included 14 wives and children of servicemen enroute from Fairbanks and Anchorage, Alaska. Volunteer rescue workers helped police pull charred, dismembered

bodies from the wreckage. Some of them were sickened by the bloody tragedy, and one man had to be treated at a hospital when he broke down and sobbed like a child.

It was the fifth Air Force plane to crash while flying from or in Alaska in less than 30 days, and the second transport lost in less than a week.

One of the survivors, Bobby Wilson, 20, a serviceman whose rank and home town were unknown, was in very critical condition at Tacoma hospital and was not expected to live.

The flaming wreckage of the four-motored military air transport service plane was strewn over a one-block square vacant field only a mile and a half north of McChord Air Force Base. Only the tail section of the craft was recognizable.

The sickly smell of death and burned human flesh mixed with

the fog. The bodies of the victims—many charred and dismembered almost beyond recognition—were lined in neat military rows beside a dirt road which skirted the field. They were lifted early through the fog by automobile headlights.

Eyewitnesses described the pitiful cries of injured babies and one volunteer worker saw three dead babies lying on the smoking crash scene.

A headless woman was carried from the scene in a blanket. City, county and state police worked with armed air police and medical corpsmen in the gruesome search for bodies. The white uniforms of hospital attendants were predominant in the glare of the headlights.

A chaplain moved slowly through the rows of bodies beside the road. A baggage check stub found in the wreckage said "Fairbanks."

The survivors were identified as

eight-year-old Joseph Iscovitti and Airman 2-C Curtis Reed, about 20, a Negro.

Hospital attendants said that two servicemen, Robert Cook and Bobby Wilson, 20, died after the crash. The ranks and hometowns of Cook and Wilson were not immediately known.

The dead also included Staff Sgt. Raymond Smith, 20, hometown unknown.

An ambulance driver who was among the first to reach the scene said from three to six persons survived.

The flaming wreckage of the four-motored transport was strewn over a large area. Only the tail section was recognizable.

McChord Field was fogbound as the giant transport let down for an instrument landing. The plane barely missed Oakwood Manor housing project in South Tacoma, crashing within 100 yards of the nearest homes.

City's Christmas Decorations Go Up Here Monday

Crew Goes To Work Monday Morning; Santa Parade Scheduled Dec. 6

Christmas decorations will begin going up along Greenville's streets Monday morning as the city officially enters the Christmas season.

Mrs. Cora Powell, secretary of the Greenville Merchants Association which annually handles the decorations in the business district, said this morning preliminary preparations of the decorations are being completed and a crew will begin putting the decorations on the streets Monday morning.

The street decorations this year will consist of the traditional colored lights, fresh green mountain laurel, Santa heads and other themes pertaining to the Christmas season. The lights in the decorations will be turned on December 6.

A big Santa Claus parade is slated for the morning of December 6 at 10 o'clock and will include bands, floats, decorated bicycles, dogs and jacks of all kinds, horses, ponies and mules. All of them and a large number of Greenville children will take part in the parade which will herald the pre-Christmas arrival of Old Saint Nick in Greenville.

Six floats already have been slated to appear in the parade. Mrs. Powell said this morning. Floats, she said, will be sponsored by the Tuberculosis Seal Committee, the Junior Woman's Club, American Red Cross, Greenville Oil Distributors Association, Greenville Florists Association and Liggett-Myers Tobacco Company.

The Merchants Association secretary added that floats of business firms are invited to participate in the parade, but will not be eligible for the \$50 in prizes which will be offered for floats. Each commercial firm in Greenville will be allowed one float or one decorated automobile in the parade.

In addition to the floats, trophies and cash prizes are being offered in eight other categories of entries in the parade. Prizes will be offered for the pony division, saddle horse division, buggy surrey or hack division, costumes, dogs, pets, decorated bicycles, and for the best team of mules or horses in the parade.

Entries for the parade must be listed at the Merchants Association in the municipal building where entry numbers for each classification in the parade will be assigned. Entries for the parade will not be accepted after December 5.

Military Buildup

LONDON (UP)—Red China now has a 2,000,000-man army backed by a 2,000-plane airforce, according to reports reaching here today from behind the Iron Curtain.

The bulk of this massive force is to be concentrated in the north—in Manchuria which borders on the Korean frontier, and in Sinkiang province in the west, adjoining Russia.

About 1,000,000 men are stationed in South China.

These reports of the continuing Red Chinese military buildup were received here with considerable interest, in the light of the Korean situation and the Communist rejection of India's peace plan, submitted to the U. N. in New York.

Top CIO Officials Pledge Eisenhower Their Support

But Also Announce Determination To 'React Vigorously' To Any Effort To Cut Living Standards Or Attack Labor

NEW YORK (UP)—Leaders of the CIO pledged support today to President-elect Eisenhower, but told him they would "react vigorously" to any effort to cut living standards, to attack labor or to obstruct progress toward worthy goals for our American democracy.

The group of CIO officials and vice presidents of its most powerful unions said after a conference with Eisenhower that they made no suggestions as to his appointment of a secretary of labor. In a formal statement, after the conference, they said:

"We did, however, emphasize that the secretary of labor should be a person who is devoted to the strengthening of the Department of Labor and to the interests of Democratic American trade unions."

The group conferred with the president-elect in his hotel headquarters after Eisenhower had met with MME. Vijaya Lakshmi Pandit, leader of the Indian delegation to the United Nations. He declined to say whether she had briefed the president-elect on India's compromise formula for peace in Korea.

MME. Pandit had been expected to give Eisenhower first-hand ex-

planation of the Indian proposal in preparation for his forth-coming visit to Korea.

Following his hour-long conference with the CIO leaders, Eisenhower posed with them for pictures. He stood with David J. McDonald, acting president of the United Steel Workers, on his left and Walter Reuther, president of the United Automobile Workers, on his right. Those two are the largest and most powerful of the CIO unions.

Joseph Curran, National Maritime Union president who has been regarded as a dark horse in the race for the CIO presidency, said as the group went in that they had "some recommendations" to give to Eisenhower.

The labor post and that of secretary of commerce are yet to be announced, although sources close to Eisenhower said he already had selected his nominees. Gov. Sherman Adams of New Hampshire, who will serve as assistant to the President, announced Thursday two more selections for top White House jobs. They were James C. Hagerty as press secretary and Maj. Gen. Wilton B. Parsons (ret.), as special assistant to the President.

Czech Diplomat Knew 3 Years Ago He Was Going Home To Face A Hangman

WASHINGTON (UP)—Former Czechoslovakia Foreign Minister Vladimir Clementis, who faces the hangman's noose for treason, considered staying in America when he was in this country three years ago.

But then, during days of desperate indecision, he wavered and, although he knew he might pay with his life, he decided to return to Communist Czechoslovakia to face the fate he was sure awaited him.

Clementis made the fateful—and fatal—decision in November, 1949, while he was representing Czechoslovakia at the United Nations. He learned he had fallen from favor with his government and had been accused of "deviationism"—the worst crime with which a Communist can be charged.

His fears were well-grounded. Clementis was condemned to death yesterday in the Prague purge trial of 14 former high Red officials.

The story of Clementis' indecision three years ago and the preliminary action he took to gain sanctuary in the United States have been held in the tightest secrecy. The tale could not be told while he had a chance to save his life.

The court's verdict apparently cut Clementis' last shred of hope. He was sentenced to death on charges of treason, espionage and plotting to overthrow the Communist regime he helped erect in 1948.

Even today the names of those who tried to get sanctuary for Clementis in this country cannot be revealed. Some are now behind the Iron Curtain.

### Ask Re-Entry To Land Of Israel

BOMBAY (AP) — Fifty-eight of the 128 Indian Jews who returned from Israel last August charging racial discrimination have petitioned Prime Minister David Ben Gurion for permission to resettle in Israel.

The dark-skinned emigrants to Israel made news when they started a hunger-strike to compel Israeli authorities to send them back to India. Now they have called for financial assistance for a second attempt at integration in the Jewish homeland.

### One Crop Tops Brazil's Exports

NEW YORK (AP) — Dependence of Brazil's economy on a one-crop export-coffee is illustrated by figures for the first half of 1952, reported by the Brazilian Government Trade Bureau here.

During the first six months, coffee accounted for 69 per cent of total export volume with a value of \$487,820,833. The next highest single export item was raw cotton which accounted for only 3.6 per cent of total export trade with a value of \$25,204,725.

### No Requirements To Drive A Car

SOUTHBRIDGE, Mass. (AP)—South Dakota is the only state that requires no examination, issues no license and sets no legal standard for motor vehicle operators. All that is required is that the driver be at least 15.

The survey, published by the American Optical Co., says that all other states require licenses and have driver examinations. Age requirements for drivers range from 14 in Arkansas, Idaho, New Mexico, North Dakota, South Carolina and Texas to a high of 17 in New Jersey.

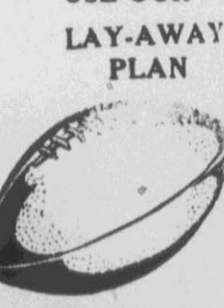

## Strength for the Day

**THINK IT OVER—SERIOUSLY**  
Someday! We cringe, do we not, everytime we read an account of such a tragedy in the newspapers. Someone has taken the life God committed to his care and cast it away, with all the opportunities, in an hour of pain and despair.

If you ever ponder such a thing, stop and think what it means. You're in trouble? So has everyone at some time or other. But the recuperative powers of life are amazing. You can see it now, but no matter how overwhelming this situation seems, the time will come when it will be a memory—perhaps a poignant one, but a memory, not a reality. But suicide will be an eternal reality, the consequences of which you will continue forever to experience.

Think of your loved ones. You may say that this situation is more than you can bear. How about the disappointment and horror which your loved ones will go through as a result of your act? If you have children, you may inflict upon them an emotional wound which will run them in later years. You will be running away and letting them take the rap.

Suicide is not only a sin—it is a sin of which you can never repent, and how can there be divine forgiveness without repentance. The horror of this should stay your hand.

## Fourth Best Year Did You Say?

There were a great many surprised people in Pitt County who read the official tabulation of activities on the Greenville tobacco market for the 1952 season.

Before the figures were made public, there were few individuals who would have believed that the 1952 season would prove the fourth best season in the 62-year history of the market. Most of the people around the county were talking about how poor the crop was, how little money there is in circulation and how economically rough the months between now and next tobacco season will be.

To be sure, the farmers of Pitt County have suffered a terrific income loss on their tobacco crop this year compared with last year. Pre-fall predictions set the loss on Pitt's tobacco crop at \$10,000,000 because of dry weather; and according to the figures released this week, the money paid out by the Greenville market was approximately \$10,000,000 less than last year.

There is no getting around the fact that ten million dollars out of the pockets of the people in Pitt County in one year makes quite a dint. Nevertheless Pitt's economy has lacked a long way of going to the dogs just because tobacco was not as good this year as in 1951.

There have been only three years in the past 62 that the Greenville tobacco market paid out more money than it did this year. Those years were 1951 (the best in history), 1950 and 1946. There have been other years much slimmer economically than 1952 has been and Pitt always managed to get by in spite of the fact that it had to do a little belt-tightening here and there.

We can see no reason for the people of the county to get the business "jitters" because of the income drop this year. Those who have farmed or engaged in other business in Pitt County for any length of time have learned to expect fluctuations from time to time.

They also have learned that the economy of the county during recent years has become much more stable in spite of seasonal fluctuations, and they have learned that Pitt, while still leaning heavily on tobacco, has developed other sources of farm and business income which help greatly when tobacco hits a seasonal slump.

## Throw That Old Line In The Scrap Pile

We've listened to that line for 30 months!

Don't tell us we are going to have to listen to it for another four years under a Republican administration too.

"If there is a war . . . If war comes . . . Should a war break out . . ." And so on and so forth.

Administration officials, members of Congress and other higher-ups in the federal government have been using such phrases in connection with federal spend-

ing, defense preparations and other government activities since long before the outbreak of the Korean War.

Ever since the Korean conflict began in June 1950 the same line has been used. To put it bluntly, The Reflector is getting mighty tired of hearing the politicians talk about "if there is a war."

They know just as truly as the rest of the people of the United States that this nation is locked in a war today, just as surely as it ever has been engaged in military conflict in its history. This talk of "police action" in Korea is a lot of bunk and everybody knows it.

We think perhaps with the new administration and a new Congress, both controlled by the Republican party, we would cease to hear such trite phrases. But apparently the term "if there is a war" is going to be used as a whipping boy, an alibi, and an excuse by some Republican leaders just as it has been used during the past two and a half years by some Democratic leaders.

Just this week the man who is slated to be the new chairman of the powerful House Appropriations Committee, Rep. John A. Taber of New York used the "if there is a war" line as a crutch for a statement on budget cutting. Actually Taber said expenditure in the federal government could readily be lower, and "they should not under any circumstances except war, be higher."

Most folks agree that federal expenditures could be lowered without affecting the welfare of the nation or the efficiency of any vital program. But why use the old stock phrase as an excuse for cutting the budget.

Some of the governmental leaders may think they can convince the American people our boys are engaged in a hot game of tiddledy-winks in Korea by talking "if there is a war;" but we believe the people are well enough informed not to swallow that sort of trite.

Compared with recent conflagrations, the Korean War is limited in geographical scope, but it still is a war. Why not admit it?

With all these "if there is a war" excuses, we think the government leaders are barking up the wrong tree. They are wasting their breath and not doing the nation or themselves any good by continuing to use the threadbare line the country has long since tired of hearing.

## National Whirligig

WASHINGTON—The Prague trials of Czechoslovakian Communists for disloyalty confirm State Department and United Nations data that Stalin is deeply disturbed over growing resentment against his iron rule among the satellite nations.

Indeed, his concern over widespread hatred toward the Russians throughout his empire, including China, is the surest safeguard against his provoking a World War III in the near future. He cannot depend upon the wartime support of the 600,000,000 people inside his police state.

As a generalissimo of guerrillas in World War II, he knows well how a hostile populace could hamstring his forces in the field. He fought Hitler with these tactics.

**SHOCK TROOPS**—The prevalence of "Titoism" in such a strategic area as Czechoslovakia is especially threatening to his program of expansion and conquest. The hard-fighting Czechs are his shock troops in the Balkan Peninsula. Without control of this country, he has no direct access to other satellites in that territory.

With Greece, Yugoslavia and Turkey, a hostile Czechoslovakia would be a permanent threat to the flank of Russian armies invading Central and Western Europe. In short, Stalin cannot think of waging large-scale war against the Western world, unless he can continue to control his puppet government at Prague.

**STALIN WORRIED**—Diplomatic experts find support for this theory in the contrast between his 1953 purge of veteran Bolsheviks and his current prosecution of Czech subordinates. The difference in procedure between the two pogroms indicates that Uncle Joe is really worried.

In the 1935 affair, Western diplomats and newspaper correspondents were permitted to attend the courtroom trials, which were conducted by Prosecutor Andrei Vishinsky, now Soviet delegate to the United Nations.

They reported that former Soviet officials stood in the dock and confessed gladly, even enthusiastically, to their traitorous conduct. Even Joseph E. Davies, then U.S. Ambassador to Moscow, sent this information to Washington.

It was then believed that Stalin was simply employing the purge to rid himself of political rivals for leadership. Subsequent revelations prove that the defendants were hatching a conspiracy with Hitler to overthrow the Communist regime. They were disappointed and disgusted with Stalin's perversion of their original plans for Russian revolution and progress.

**WESTERNERS BARRED**—In the meantime, the experience of Robert Vogel and many other victims of Red prosecutions have given us an explanation of these confessions. They are induced by months and even years of drugs, torture and twisted psychological treatment. It is humanly impossible for the victims to conceal their real or supposed crimes.

In view of this exposure of his practices, Stalin has barred all Westerners from the current trials. He realizes that the West would regard them as a farce. However, he is giving full publicity to them in Russia and behind the iron curtain as a warning to prospective rebels against his regime.

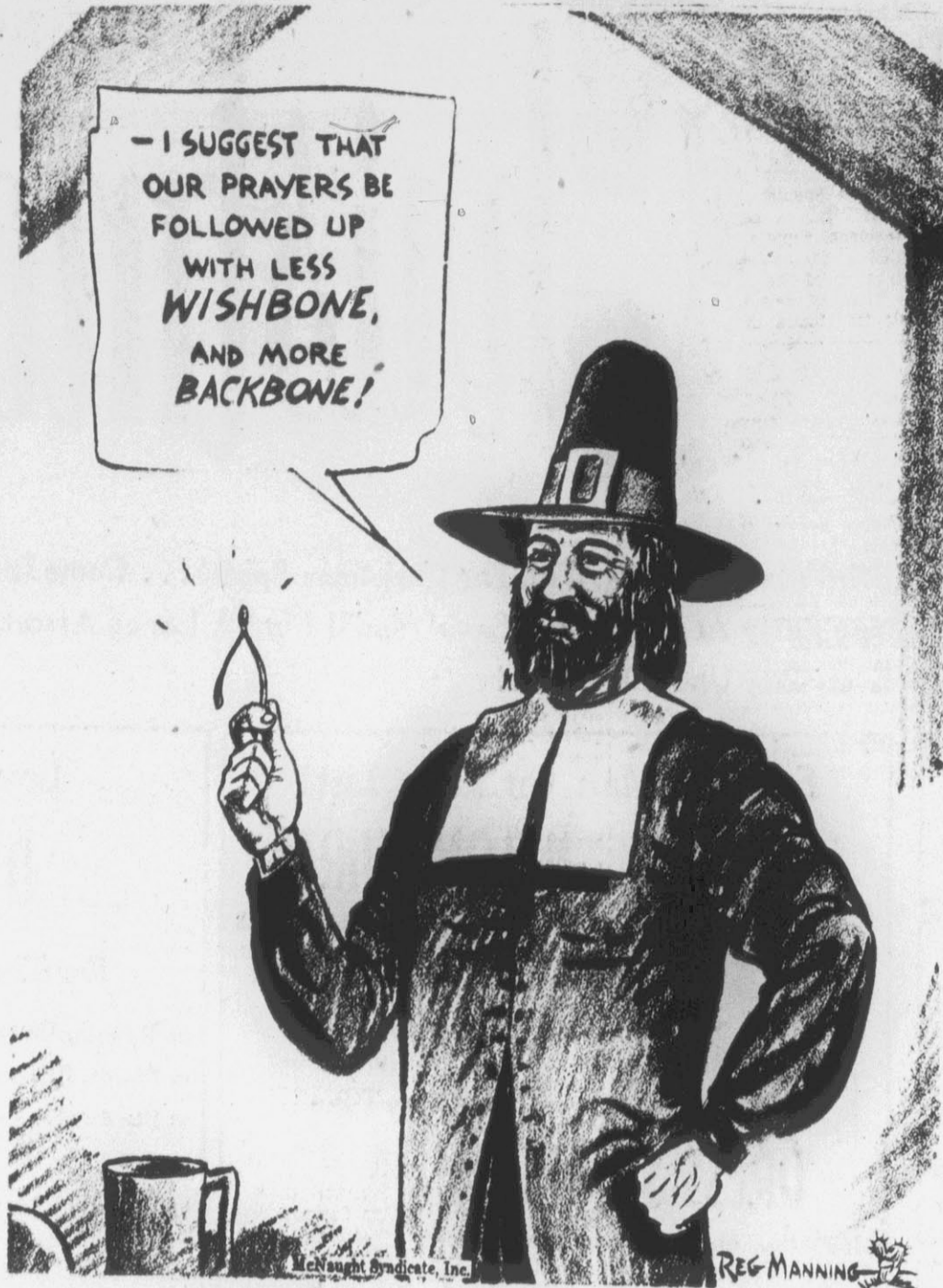
It is obvious that, unless there were practical grounds for this legal massacre of Communist leaders of Czechoslovakia, Moscow would not stage it. Save for the scare effect throughout the Soviet's police state, the advertising is the worst possible kind for Stalin's supposedly benign and helpful rule at home and abroad.

**EISENHOWER DENOUNCED**—The timing of the Prague trials suggests that Stalin tried to do his re-rite bit for the defeat of Eisenhower for President. For this revelation of internal weakness underwrites the Eisenhower-Dulles demand for a more aggressive campaign to stir up anti-Soviet hostility behind the iron curtain.

Incidentally, John Foster Dulles, who will be the next Secretary of State, has been named as a contact man and American spy in the more fantastic phase of the alleged Czechoslovakian conspiracy. He and his brother, Allan S., who is deputy director of the Central Intelligence Agency, are charged with egging on several of the Prague defendants.

Eisenhower, of course, is regularly denounced in the Russian press as our major warmonger, having supplanted President Truman and Secretary Acheson. So, had the Prague prosecution not been postponed until after the election, it might have rolled up a few more million votes for the GOP.

## Somebody Told Me

By I. J. (Jack) EDWARDS, JR.

Popular Science magazine is a little ahead of schedule in picking the top stories in the field of science for 1952. It's interesting to notice that the important stories are split between medicine to save human lives, and war, to destroy them.

Waldemar Kaempffert, science editor of the New York Times, picked the new anti-tuberculosis drugs as the biggest story in 1952. Called hydrazides, the drugs were first used with remarkable results at New York City's Sea View Hospital.

Kaempffert says, "After nine months of clinical experience, it turns out that the hydrazides are no perfect solution of the problem presented by tuberculosis. The TB bacillus quickly adapts itself to most antibiotics and chemical therapeutic agents, the hydra-

zides included."

Even if this drug is no perfect solution, it far surpasses all other attempts at curing TB. Nate Haseltine, science editor of the Washington Post, also thinks that TB drug story is the biggest in 1952. Mr. Haseltine insists that the drugs are not the quick home cure that many had believed them to be, but they are nevertheless a boon to humanity.

Three experts chose the progress in curing infantile paralysis as the biggest story. William S. Barton, science editor of the Los Angeles Times, voted for a chemical treatment that rebuilds muscles attacked by polio. In some cases this treatment increases the muscles 40 per cent.

Another expert said he thinks the development of the mechanical heart is the biggest news. Three

Detroit doctors have used this "heart" to pump blood through a patient for 50 minutes while his heart was opened to fix a valve. The mechanical heart works like a six-cylinder automobile engine; in fact, General Motors helped develop it. This is the first step in a plan to by-pass the human heart while it is being repaired.

Other experts picked the development of the hydrogen bomb as the biggest story. However, all scientists are looking for a development of this power to be used for peaceful means, instead of war.

There are definite possibilities for peaceful use, but so far the efforts have not been in that direction. Scientists are hoping for more emphasis on peaceful uses. And I thank you.

## Around Capitol Square

By LYNN NISBET

**COST** — What did it cost to get each of the nearly a million and a quarter votes cast in the recent general election voted and counted? First of all, the State and the 100 counties spent close to half a million dollars on two primaries and the general election, for such essential purposes as printing and distributing ballots, providing registration books, paying registrars and judges of election, paying members of State and County Boards of Elections for time spent of official business, and such like.

**CANDIDATES** — Financial reports filed by candidates in the primaries could be tabulated but only at tremendous effort and expense, because the task would entail checking records in 100 clerks of Superior Court offices for county candidates and the Secretary of State's office for district and state-wide candidates. Almost \$100,000 was reported to the Secretary of State, and estimates made by conservative business men are that when the reports of all candidates for constable, register of deeds, recorder court judge, county commissioner, member of the General Assembly and all other local offices are totaled the aggregate amount will approximate a million dollars. That seems reasonable, since it would average only \$9,000 per county in addition to reports filed at Raleigh.

**PARTIES** — Reports of the Democratic and Republican parties and the Citizens for Eisenhower group filed with the Secretary of State for the general election amount to nearly \$150,000. How much was reported to the several clerks of court on county level, and how much of the total spending by national committees

should be charged to North Carolina, are speculative questions. So is the tremendous total of individual spending not required to be reported and a good bit by special committees or groups which might be legally obligated to report, but did not.

**\$3 MILLION** — Your reporter has talked to a good many people about this matter of cost per vote, including Charles M. Britt, chairman, and Raymond Maxwell, executive secretary, of the State Board of Elections; Thad Egan, secretary of state, with whom state-wide and district reports must be filed; and numerous of the candidates for big and little offices. Opinions as to total spending varied widely among these individuals but a sort of cross-section weighted-balance of all estimates leads to conclusion that, when all factors are considered, each one of the votes cast in North Carolina cost somebody about two dollars. When the value of time used by the voters to go to the polls is counted in for two primaries and one general election the per vote cost might be upped to about \$2.50. The State Board of Elections certified Tuesday that 1,211,010 votes were cast for President, and 1,179,645 for Governor. The votes for other State offices were slightly less, but it is probable that the aggregate for twelve members of Congress and for all county, local and legislative offices was close to that cast for president. Which means at \$2.50 apiece, the votes cast in North Carolina cost somebody right about three million dollars.

**BOOKKEEPING** — Like all figures having to do with operating or living expenses on the one hand and income on the other that \$3 million item is largely

one of bookkeeping. It is believed, and the belief is supported by reasonably thorough investigation, that the actual selling or buying of votes in North Carolina is a rare occurrence. The fact that some three million bucks were put into circulation in the state on account of the election means that it was shared by newspaper and radio owners and employees, garage and filling station men and automobile drivers, grocers and clothing store merchants, and that for most part the same folks who paid in the money in campaign contributions got it back in legitimate business operations. And each and everyone of them got a big bonus in the consciousness that there was a real election and that democracy does work—although it doesn't work for free.

**GEOGRAPHY** — Official certifications by the State Board of Elections of the November 4 vote further emphasizes the concentration of Republican strength in the Piedmont area of North Carolina. Eisenhower carried 31 counties for President. Seawall carried 11 counties for Governor. The only county carried by Eisenhower that can be classified as eastern was Brunswick, and he got that by the slim margin of seven votes, 2,358 to 2,351. He carried four border counties—Burke, Caldwell, Rutherford and Wilkes. Nine mountain counties were in his column—Ashe, Avery, Buncombe, Clay, Henderson, Madison, Mitchell, Transylvania and Watauga. The other 17 counties are generally counted as Piedmont area—Alexander, Cabarrus, Catawba, Davidson, Davie, Forsyth, Gaston, Guilford, Iredell, Lincoln, Mecklenburg, Montgo-

## What Other Papers Are Thinking

LEADER OF THE OPPOSITION

What is to be the future of the man the Democratic Party nominated as its presidential candidate in 1952?

After the election Governor Stevenson received thousands of communications, some of them from persons who did not vote for him, expressing admiration for him and his sort of campaign. Some of these people expressed the hope that he would not drop from sight, that his obvious talent and training could be put to useful service for the country. A number of newspaper columnists and other observers have voiced the same hope. There have been suggestions that he might serve well as a college president, that he might make

periodic speeches by radio and television, even that he might find a place in the cabinet or fill some other high government position.

Often it happens that the defeated candidate is completely washed up. Governor Thomas E. Dewey did run for the presidency twice, but after his second defeat he decided to let that be his last one. Alfred M. Landon has lived in comparative obscurity since his 1936 defeat. The string of defeated Democratic candidates in the 1920's never tried again. But Wendell Willkie was an exception; he remained an influence, and his capabilities were put to good use by the man who defeated him. It seems likely that Governor Stevenson is also an exception to the general rule, one of the same

sort as Willkie.

He has announced that he plans to return to the practice of law at the end of his term as Governor of Illinois. He would be politically silenced if he accepted governmental appointment. Presumably he could speak his mind freely if he became the president of a college or university. General Eisenhower and Harold Stassen never let their positions at Columbia and Pennsylvania interfere with their campaigning. Governor Stevenson would also be free to speak if he goes through with his plan to practice law. Governor Stevenson's personal desires must be considered, although he must realize that his choice is important not only to himself but to his party and to his nation.

## Business Today

By ELMER ROSSENER

Cotton is an uneasy king this year. With the textile industry not yet fully recovered from last year's slump, the tumbling price of cotton is again pressing down quotations on such staples as print cloth.

The fact is, cotton is in superabundance all over the world, and a big worry to most cotton-producing countries. In spite of last summer's drought, the U.S. production of a fluffy white stuff is expected to reach nearly 15 million bales of 500 pounds each. Add to that a stock on hand of almost three million bales.

How much of it can we expect to use up in shirts and sheets? Well, last year's use of cotton was a little over nine million bales, and so far this year's consumption has been running a little less. We can't export all the surplus because other cotton-growing countries have an abundance of it too and are fighting for markets.

The surplus indicates continued low prices for cotton goods for some time, especially since rayon is selling below its pre-Korean level, and there's increasing competition to cotton from other synthetic fibers.

Cotton products have gone up more since 1950 than some of the other products made from some of the other major fibers. For example, men's suits are comparatively higher now than worsted suits. Remember when you could buy a medium-quality shirt for \$1.50 in department-store sales? Or a house dress for one buck? But the truth is, before World War II cotton textiles were a very depressed line. It's doubtful that cotton items will ever go back to that low state of affairs.

In the U.S. the price of raw cotton last week hit 34.2 cents a pound, the lowest price since before Korea. In Egypt, where cotton is the chief crop, the Government has closed the cotton market because of the decline in prices, and has undertaken to market the "fire crop."

Nations who now import cotton could use some more; they are mostly reported to have only small stocks. But these countries

as usual are short of dollar exchange and will need help from us if they are to buy our cotton.

So don't be too surprised if you observe our own Government taking steps—and looking for ways—to increase our own use of cotton and also embarking on new aid programs to sell some abroad.

### OLDER WORKERS ABSENT LESS

Employers should reconsider the reluctance some show about hiring older workers, on the basis of a recent survey by the U.S. Department's Bureau of Labor Statistics. The study found absenteeism and injury-frequency rates are lower on the average for employees over 45 than for their younger co-workers. But, the department reports, even under pressure of limited manpower supplies, industry has hesitated to employ the older worker until all other supplies of labor have been exhausted. The fact is, workers over 45 now constitute over one-third of our labor force.

### PLAN NEW FIGHT ON EXCISE TAX

One of the first demands the new Congress will be greeted with in January is a drive for the elimination of the 20 per cent excise tax on jewelry. The American National Retail Jewelers Association has already written to the Senate Finance Committee and the House Committee on Banking and Currency asking for relief from the tax.

# May Question Snyder On Tax Refund Claims

WASHINGTON (UP) — House tax scandal investigators today considered questioning Treasury Secretary John W. Snyder about a multi-million dollar tax refund case before he leaves office in January.

The House Ways and Means subcommittee headed by Rep. Cecil R. King (D-Cal.) announced it will hold a closed-door meeting Tuesday to determine whether to conduct December hearings to cross-examine Snyder.

Rep. Carl T. Curtis (R-Neb.), a member of the group, gave immediate support to the proposal that Snyder be called to testify before the Republican administration takes office.

"I want his testimony as secretary of the Treasury and not as private citizen Snyder," Curtis said.

Snyder was written the subcommittee that there was nothing unusual or improper about his efforts

several years ago to speed action on a \$20,000,000 tax refund claim by Universal Pictures, Inc. He sent the letter in answer to charges by Rep. John W. Byrnes (R-Wis.) that he showed an "unusual interest" in the case which was eventually settled for less than \$3,000,000.

At its closed door meeting next week, the subcommittee may also decide what portions of the 3,000-page "Oliphant log" to make public.

The log is a record of telephone conversations and conferences during Charles Oliphant's four years as chief counsel of the Internal Revenue Bureau. Oliphant resigned last December while under subcommittee fire. He has never been charged, however with any wrongdoing.

The log, which was obtained by the subcommittee recently, may provide enough new material for a continuation of the sensational tax scandal investigation which has in

led to wholesale firings, resignations and criminal indictments of tax officials.

## Historic Prison To Be A Shrine

MANILA (AP) — The Philippines government will convert historic Ft. Santiago—hell-hole prison for many Filipino martyrs and heroes during the Spanish and Japanese regimes—into a national shrine.

President Elpidio Quirino has created a committee for the rehabilitation of the old fort, which was virtually razed during the battle for Manila in 1945.

# Big Leagues May Add New Teams

PHOENIX, Ariz. (UP)—Frank Shaughnessy, president of the International League, said today machinery has been set in motion to create two new major leagues within the next five or six years.

Shaughnessy, a member of a major-minor league special realignment committee, said his group would make a detailed report to the mid-winter baseball meetings next week in Phoenix, "and I think it will be one of the most exciting developments of all."

The veteran baseball executive said there were tremendous obstacles to be overcome but that eventually "all parts of the nation will have major league ball."

The two new major leagues, he said, probably would be on the Pacific Coast, and in the East and Midwest where a combination group would be formed of the top cities in the current structure of the International League and American Association.

"There is no question that there are a number of cities which right now deserve major league ball because of their population, and naturally we want to move clubs up to the level they deserve," he said.

"That goes not only for teams seeking major league status but for the whole structure of baseball down to the Class C and Class D levels. Our realignment committee has been working on this for some time and we will have much to report."

Shaughnessy said he could not foresee any immediate major changes in the baseball map.

"The first step was taken last year when the Pacific Coast League was given an open classification above the Triple A status of the International League and American Association," he said. Eventually, the other two leagues also will get that open classification.

GREENSBORO, N. C. (UP)—A 65-year-old Bible scholar announced plans today for his second search for the remains of Noah's Ark, this time by helicopter.

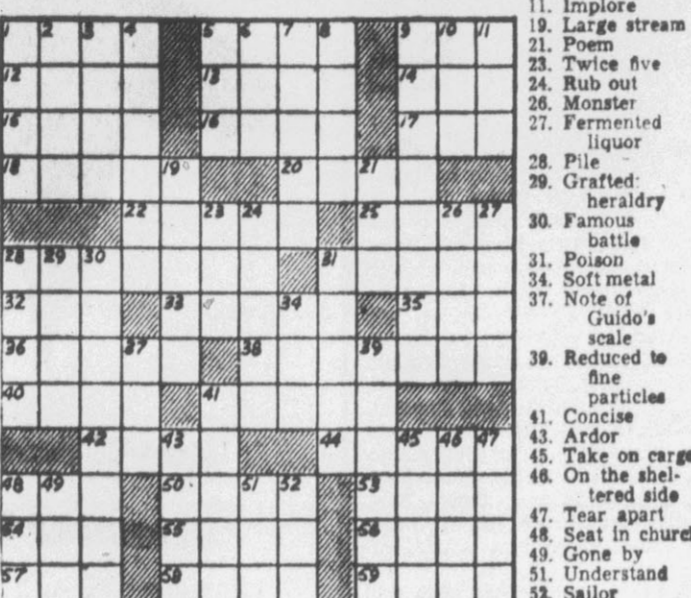

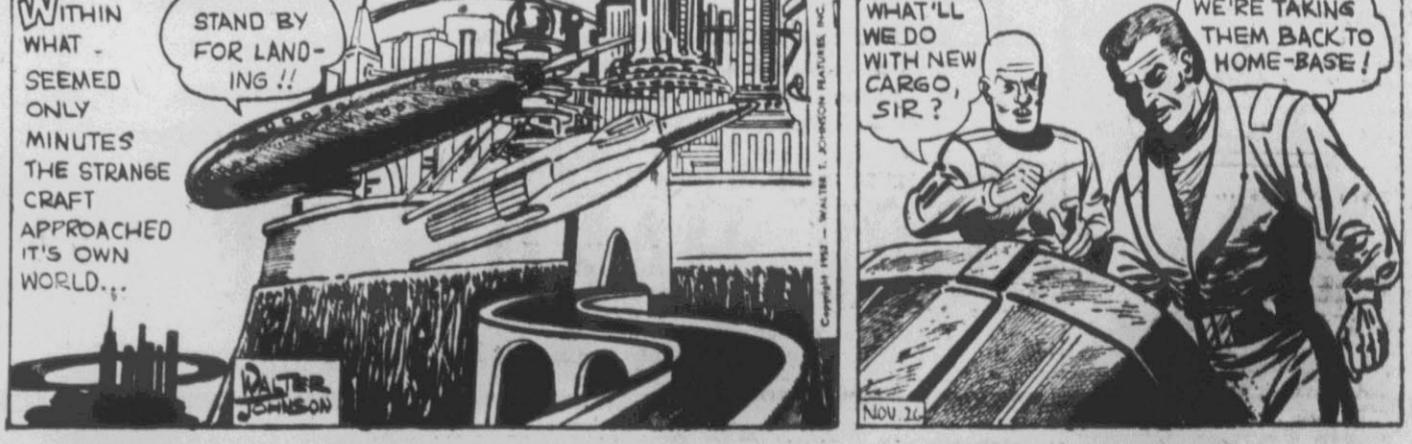

## Czech . . .

(Continued from Page 1)

Details of the intricate maneuvers by which his friends tried to save him are known only to a handful of American officials and three newspapermen.

Shortly after Clementis learned he had been charged with deviation from orthodox Russian communism a close friend contacted a leader of the Czech anti-Communist underground in New York. The friend asked if there was a way to get the Czech re-ign minister American sanctuary. He said Clementis wished to stay in the United States.

The underground leader contacted a former diplomatic official, who contacted an editor of a prominent New York newspaper.

Clementis' friend and the underground leader both were under surveillance by Communist agents. The American official and editor also were shadowed during the "negotiations."

Meetings were held by the Czech underground leader, the former American official and the editor. The editor was asked to use the prestige of his newspaper to intercede for Clementis with the U.S. government.

The underground leader asked if the editor could give Clementis "assurances" of safety. The editor gave those assurances. They were conveyed to Clementis through his friend.

The newspaper was to print the story of Clementis' "leap to freedom" and to provide the Czech foreign minister with a hideout.

Several days passed while Clementis debated what course to take. He could choose safety or he could return to Czechoslovakia.

A firm believer in communism, Clementis was apparently tortured at the thought of "betraying" the cause he believed in. His "offense" was that he believed communism in Czechoslovakia should follow different lines than those dictated by the Russian politburo.

He hesitated for days. Then he decided to veto his friends' efforts and go home.

For several months Clementis continued to hold his rank as foreign minister. Then he vanished. It was believed here he had been "purged." He was "resurrected" to face the purge trial.

He had chosen death.
