'Script' Of Assault Is Defended

Divisional Commander Says T-Bone Hill Attack Of Great Value To Troops

WITH 7th DIVISION, Korea (UP)—Maj. Gen. Wayne C. Smith today defended his so-called "scenario script" attack Sunday on T-Bone Hill as a "success" and of "tremendous value" to his front-line forces.

He expressed surprise at the congressional uproar over the raid against a knob on T-Bone Jan. 25 in which three men were killed. "The conduct of the individual men was splendid," the 7th Division commander said. "The unit is a highly spirited one and comes from a battalion which originally helped in conquering Triangle Hill."

Smith said the mission was "to secure prisoners, destroy the offensive works of the enemy and to secure all information possible about the objective area."

Furor over "Operation Smack" led today to the dismissal by Smith of the division's public information officer, Capt. Clair Wolfe, who was given his job back a few hours later, however.

Asked if the exceptional air support was the reason for the number of visitors and correspondents, Smith said:

"That's right. "I cross the front many of these actions have been relatively successful," Smith said. "This one was successful except for securing a prisoner."

He said results might have been better "had there been more mass bombing."

He said the reason no prisoners were taken was that two platoon leaders and their platoon sergeants were wounded. The infantry did not move out as quickly at the outset as it should have and the objective area was covered only 40 per cent by bombs and napalm.

Concerning a description of the elaborate and showy preparation, he said, "a number of people who are unfamiliar with the armed services wonder about the amount of small detail included in the brief notes."

"This type of briefing and preparation of notes is customary. It was no different materially than that used in any combined operation."

No official reason was given at first for Wolfe's dismissal, but it was believed he first lost his job over the public stir resulting from the much-publicized operation.

A division spokesman said later, "It was a misunderstanding."

The criticism over the T-Bone Hill assault came from congressmen who said it might have been staged for several high-ranking generals and newsmen who were given in advance a three-ounce cardboard-encased "time-table" of what was to happen.

The time-table was dubbed a "scenario" in one report published in the United States. War correspondent here in that had seen scores of other time-tables drawn up for officers for various kinds of operations.

In Washington, House military leaders urged congressional colleagues to go slow in blasting the T-Bone Hill attack as a "staged show" without military objective.

The House leaders said when the full story is told this weekend it probably will show the raid was justified by military necessity and by high-ranking officers and correspondents should have been present.

The assault on T-Bone Hill made Sunday was dubbed "Operation Smack."

One company of the Second Battalion, 31st Infantry Regiment, 7th Division made the assault with another company standing by in reserve.

The American soldiers battled to within 15 yards of the peak and then were forced to retreat before an onslaught of Communist grenades. Three men were killed and 47 injured, but the Army said about 57 of the injured returned to duty the next day.

Looters Stage Small Crime Wave Locally Three Safes Robbed In Night

Thieves looted local safes with happy abandon, and law enforcement officers were called into overtime work as three strong boxes within a limited area were broken open and looted last night.

Total takings for the night was estimated at over \$5,000 in cash and checks.

The robberies were being probed by the Sheriff's department, SBI agents and Greenville city detectives.

Largest haul of the night was reported from near Ayden, where a private home was entered and a safe containing over \$4,000 opened.

The second robbery was at the Chocod High School where the safe crackers made off with \$650, in cash and checks.

A robbery at the West End Tea Room, Negro Cafe in the western section of Greenville in which \$160

was taken, rounded out the night's wave of robberies.

The West End Tea Room was discovered entered and robbed early this morning by its proprietor when he came to open the place for his morning business.

P. J. Norfleet stated that the first he knew of the safe looting was when he entered his stock room, located at the rear of the building, and found the broken safe.

The safe had been pried open in a crude cracking operation; the instruments being used not known at the time.

Norfleet reported that he had \$172 in the safe when he locked it up last night.

However, officers located \$18 of the missing cash under piles of books scattered when the safe was opened and apparently overlooked by the robbers in their haste.

Norfleet stated that he could find nothing else missing from the build-

ing. A box containing some costume jewelry was lying in front of the looted safe untouched by the robbers.

Chief S. G. Gibbs, N. H. Byrd, and R. G. Rogerson were working on the robbery.

In another of the three safe robberies that took place in the county last night, thieves entered Chocod school and hauled away the school safe containing approximately \$650 in cash and checks.

Pitt Sheriff Ruel W. Tyson said this morning of the total amount, \$500 was cash—the remainder was in checks. The sheriff reported the front door was broken open and the safe was taken from a small room just off the principal's office.

An investigation into the theft is being conducted by the Sheriff's Department, identification officer "Cap'n" S. B. Dorsey and Clyde Pentress, SBI agent.

Hope Row Over Stocks Will Be Forgotten Defense Appointees Okayed

WASHINGTON (UP)—President Eisenhower's defense appointees were finally assured of Senate confirmation today and administration supporters hopefully predicted that the "5-day row" over their industrial stocks soon will be forgotten.

It probably will be Monday before the Senate goes through the formality of confirming Roger M. Kyes as deputy secretary of defense, Robert T. B. Stevens as secretary of the Army, Harold E. Talbot as secretary of the Air Force, and Robert B. Anderson as secretary of the Navy.

But the nominees were already over the real hurdle-clearance by the Senate Armed Services Committee. To get it they had to part with stock totaling more than \$2,000,000 in defense-contracting firms.

Sen. Harry F. Byrd, a pro-Eisenhower Virginia Democrat who set off the whole controversy, called for peace.

He told a reporter that Mr. Eisenhower's nominees "have now satisfied the law" which forbids a federal official to transact business with any firm in which he has a private financial stake.

"We took the (Charles E.) Wilson case as a standard and held to the line," Byrd said. "Now the appointees can do a good job; these are good men and their military troubles with Congress soon will be forgotten."

Senate Republican leader Robert A. Taft (O.) agreed. He said he does not foresee political repercussions from the squabble.

Some Democrats thought otherwise but they are holding their fire for the present.

Sen. Francis Case (R-S. D.), an armed services committeeman, said it was not up to the appointees themselves.

"A lot will depend on the way they perform," he said. "As of now I would regard the fight they have been through as damaging, but the net result may be a highly meticulous attitude and a better quality of performance, and one which offsets all that has happened."

Stevens, who pleaded with the committee at a long, emotional hearing Thursday not to make him give up his \$2,486 shares in his family's big textile firm, finally surrendered in the face of adamant senatorial insistence that he could not be confirmed without selling the stock. A short while later, Talbot announced his own decision to sell.

Kyes and Anderson had been approved earlier after they took similar action.

'Unity Mission' For Secretary And Foreign Aid Chief Dulles Departs For Europe

WASHINGTON (UP)—Secretary of State John Foster Dulles flew to Europe today to deal with the problems facing the free world's efforts to achieve "peace, security and economic health."

Dulles and foreign aid chief Harold E. Stassen took off from National Airport on a unity mission in President Eisenhower's personal plane after breakfasting with Mr. Eisenhower at the White House.

Dulles said that Mr. Eisenhower "gave us suggestions and guidance" for their nine-day tour of seven European nations.

"Mr. Eisenhower wished us Godspeed" after breakfast," Dulles said. "We reviewed together the matters likely to come up in

the various countries we are going to visit."

In a formal statement which he issued shortly before taking off, Dulles reiterated that he was not going to make "new commitments," but gather information of the "common problems" facing the Atlantic community.

"President Eisenhower has asked Mr. Stassen and me to make this trip to Europe in order to gather information about problems which we and other nations of the Atlantic community must deal with in our common effort to attain peace, security, and economic health," Dulles said.

Stassen said he was "confident" that the mission to Europe "will be a constructive opening move in

Mr. Eisenhower's new administration."

Both left the White House with these parting words from Mr. Eisenhower:

"Good luck and have a nice trip. Think of me when I'm out there sweating Monday."

On Monday, Mr. Eisenhower will deliver his State of the Union message in person to a joint session of Congress.

High administration sources said Mr. Eisenhower's instructions to them were to check the status of the European unity drive and if it is "falling apart" to find out what can be done quickly to get it going again.

The fear prompting the quick tour is that disunity in Europe would weaken the free world's defenses against Communist aggression, curb Congress' interest in supporting U. S. foreign policies there, and prompt a new era of suspicion and distrust among the allies.

When the information is gathered Dulles and Stassen will return home Feb. 9 to shape new American programs for cooperation with

Europe for presentation to the President and Congress. One major issue will involve the fate of the proposal by the former Truman administration that Europe get the lion's share of a new \$7,600,000,000 foreign aid program.

In Europe, Dulles also will seek to dissuade top British and French statesmen from making any hurried trips to Washington to confer directly with Eisenhower. They will be asked to delay their plans as long as possible.

Dulles will face some close questioning in Europe. In his first speech Tuesday, he voiced a veiled threat that U.S. aid might be cut off or trimmed from countries blocking unity in Europe. He emphasized the need for rapid action on the "somewhat stalled" proposal to create a six-nation European defense force under the North Atlantic Treaty.

According to reports from Europe, Dulles' warning "prompted more resentment than approval."

The reports added that his arrival was awaited with "a combination of diplomatic reserve and apprehension."

Adenauer Hopes Dulles Will Destroy 'Illusions'

German Chancellor Emphasizes Europeans Must Help Themselves; Warns Of Possible Decline In U. S. Interest

BONN, Germany (AP)—Chancellor Konrad Adenauer declared tonight he hopes Secretary of State John Foster Dulles will "destroy the illusions" of those who think the United States will guarantee the security of Europe without Europeans doing anything to help themselves.

The chancellor said in a broadcast that he wished this could be made plain especially to Germans and other Europeans who oppose the treaties to raise West German divisions for the projected European defense army.

He said that if the European Army scheme collapses "American interest in Europe will decline" and there will be a resurgence of isolationist sentiment in the United States.

Adenauer urged the people to heed Mr. Dulles' warning in his first foreign policy speech on Tuesday that the United States might have to "give a little re-thinking" to its

relations with Western Europe unless the Europeans speeded up their program for unification.

Therefore, Adenauer said, the fact-finding tour of Europe which Dulles started today with MSA Director Harold Stassen is "of the greatest significance."

The chancellor's broadcast took place on the twentieth anniversary of Adolf Hitler's rise to power. Noting this date, and the recent furor over Allied charges that pro-Nazi sentiment is resurgent in West Germany, Adenauer declared:

"There will never be another Jan. 30, 1934. We have a healthy and alert democracy. The federal republic is a useful and reliable partner for a unified Europe."

Adenauer predicted that both France and Germany would overcome opposition to the European army treaty and the related Allied-German peace contract. But he warned:

Moon-Gazers Enjoy Clear Eclipse View

Moon gazers of Pitt County had a ring-side seat last night as Ole Man Moon went through one of his rare antics.

Clear skies gave local observers a good picture of the total eclipse which began as the moon came up about 5:30. As the moon came over the horizon in the fading light, it was surrounded by a copper glow and appeared almost as if it were behind a translucent cloud.

As the hands of the clock moved toward 6 and a few minutes following, the ruddy color deepened, and by 6:05 the moon was totally blocked out. About 7:30 the moon began to shake off the earth's shadow with its ascension across the heavens, and for another hour and a half local citizens who braved the crisp night watched the moon emerge bit by bit.

By 9 o'clock the show was over.

For people hereabouts, it was the best show of its kind the moon had put on in many a year. The skies were clear, and the night was bright. The air had a nip in it, but it wasn't too cold for amateur astronomers—youngsters and grown-ups alike—to remain out-of-doors to watch the three hour performance.

The shadow of the earth crept up on the lower left-hand surface of the moon and passed over the familiar satellite, and off the right-

hand top edge.

As the eclipse entered its final stages, the moon emerged in its regal splendor to brighten the night with a soft glow.

Burglars Enter Ayden Residence

AYDEN — Burglars entered the home of W. H. Moore near here last night while the family was absent, cracked Moore's private safe and got away with 40 \$100 bills and a quantity of silver.

In reporting the robbery this morning, Sheriff Ruel W. Tyson said the safe was forced open inside the Moore home while the owner and his family were visiting a neighbor scarcely 200 yards from the house.

According to the sheriff, Moore said he was absent from home approximately two hours and heard no noise from that direction while at the home of a neighbor. He returned home about 9 o'clock, and discovered the robbery.

In addition to the \$4,000 in \$100 bills, Moore said the robbers took 18 silver dollars and a five dollar gold piece. Tyson explained that the safe was opened by prying off the combination and punching the pin until the tumbler fell inside.

No arrests have been made, and the investigation is being continued by the Sheriff's Department and "Cap'n" S. B. Dorsey, city and county identification officer.

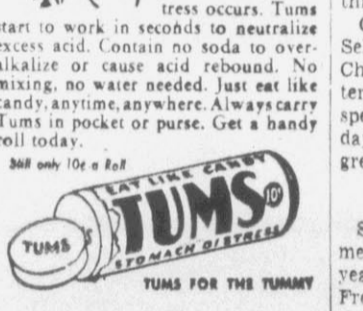

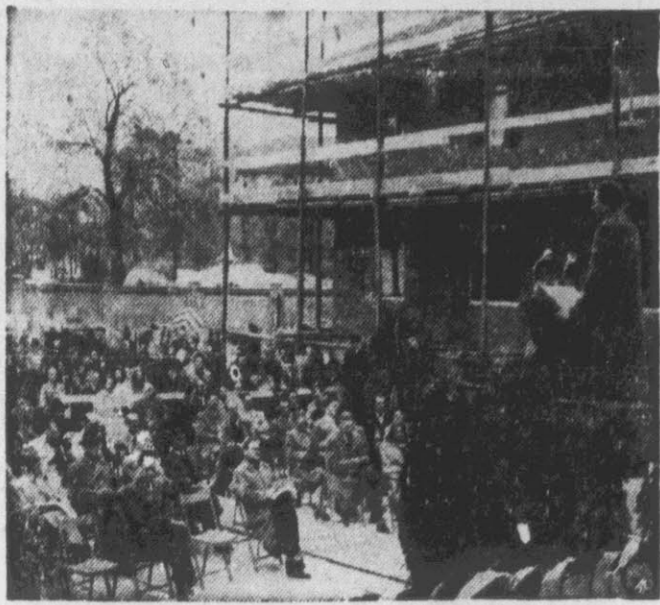

Trouble Is Anticipated By Radio Free Europe

MUNICH, Germany—Radio Free Europe, a vast psychological warfare enterprise with estimated costs of 15 to 20 million dollars, is operating from month to month in Munich on an "ad hoc" basis. The document will be worthless once the West German peace contract takes effect and restores radio sovereignty to the Germans in their own country.

Chancellor Konrad Adenauer's Foreign Office has orally promised that it will issue a license to RFE when the occasion arises. But this promise is a three-party government coalition will win a tough national election.

Even if this license is certain to be hedged with qualifications, RFE's wooing of Poles resettled in former German provinces in Czechoslovakia and Poland. RFE's in the S. Germanland has already produced broadcasts "not entirely satisfactory" to Bonn.

for the Voice of America, U.S. Army stations, and the West German transmitter of RIAS, the American government's station in Berlin. These are tied up with the peace contract.

It is plain that the German-based broadcasts of Radio Free Europe contribute more to the U.S. cold war offensive in Eastern Europe than anything done by Voice of America. So why wasn't RFE wrapped up in the guarantee for VOA?

The reason is that RFE describes itself as "a private organization" and the U.S. government therefore does not openly negotiate it.

There are millions of dollars invested here in buildings and equipment, including a 130,000-watt medium-wave transmitter beamed day and night at nearby Czechoslovakia. Other powerful transmitters broadcast full daily programs to Hungary and Poland. Brief but frequent news reports are sent by short-wave to Romania, Bulgaria and Albania.

West German government could share policy-making with the seriously weakened RFE's influence, especially among the Czech and Polish peoples. It speaks now as their "free radio."

Such a U. S.-German partnership policy, appears to be an unavoidable step next year if RFE's tenure in Munich is to be maintained at all.

CAMP STONEMAN, Calif. (AP)—One hundred and five convicted deserters and AWOLs, the Army's first mass shipment to Korea under the new "get tough" policy, arrived here under guard yesterday for movement to the battlefield.

All but two—who had finished light sentences for being absent without leave—were confined in the Camp Stoneman stockade pending departure aboard transports within three to seven days.

A spokesman said the group, which arrived by plane from the stockade at Camp Breckenridge, Ky., was the first to be shipped off to war in a crackdown on run-aways suspected of shirking combat.

Construction In Goldsboro Area Has Boom Ahead

RALEIGH (AP)—Goldsboro's construction workers, who have been suffering a work shortage, soon should be experiencing a work boom.

This week's issue of the "Employment Security News," published by the State Employment Security Commission, reports a number of new construction projects getting under way in the Goldsboro area.

Large numbers of workers will be needed, the bulletin says, for a seven-million-dollar improvement and construction program at the U.S. Air Force's Seymour Johnson Field.

Still others will be needed for a \$500,000 Negro housing project, and for a \$500,000 hospital construction program in Duplin County.

"These construction programs," declared the bulletin, "will relieve the unemployment problem that has existed."

could quite get down to the source of the problem of high taxes. Unless the Republicans are careful, they may not either.

It is obvious the United States must maintain a huge budget at least for the next few years to augment its defenses and to build the strength of the nation for its increasingly difficult role in international affairs. It is likewise obvious that federal taxes can not be reduced until the federal spending is reduced.

Indeed, federal spending must be reduced several billion dollars a year before we get out of the red in our annual operations. After we get into the black again, we can start reducing taxes.

The point is, waste by the federal government is the first and foremost obstacle in the way of a tax reduction. As long as millions are pushed into the cracks and knot holes of federal agencies — without the people getting their dollar's worth for each dollar spent — the federal budget is going to remain abnormally high.

Any administration is charged with a large portion of responsibility for economic operation of the government; but when it actually comes down to saving dollars and cents, members of Congress can do a far more effective job than the administration branch alone.

Congress holds the purse strings. Where and how taxpayers' dollars are spent depends upon how tightly Congress holds those strings. As the Reflector has pointed out previously, there are many outstanding examples of efforts for government economy for which Democratic members of Congress are responsible. There is no reason why, under Republican leadership, economy efforts can not be continued with the increasing tempo which was evident during the last few years the Democrats had control of the government.

Economy in government is by no means a partisan issue. Both major parties are vitally interested in it, and both parties should push the issue.

But to have economy, the waste which has congressional sanction — extravagant patronage and over emphasis of pet projects of individual Representatives and Senators — as well as the waste which comes about through unsound management must be eliminated.

Before the man on the street can feel any tax weight off his pocketbook, Uncle Sugar's belt must be tightened from all the way around.

National Whirligig

WASHINGTON—Re-establishment of the supremacy of the American Constitution, Federal and State laws over United Nations decisions will be sought at the current session of Congress by leading Republicans on Capitol Hill.

Although the movement may embarrass the Eisenhower Administration, it is believed that the President and Secretary Dulles are sympathetic to the basic idea. Otherwise, they will tangle with Senator Wiley of Wisconsin, chairman of the Senate Foreign Relations Committee and American delegate to the U.N. and with Senator Jenner of Indiana, chairman of the Senate Judiciary Committee.

Even former Secretary Dean Acheson favored a limitation on U.N. power in this field, but he never outlined his position officially. He was waiting until test cases raising the question reached the Supreme Court.

AMERICAN INVESTMENTS ABROAD—The controversy has been revived in an acute form as the result of a recent anti-American decision in the U.N.'s Economic and Financial Committee. By the overwhelming votes of 31-1 and 25-3, this body jeopardized present and prospective U.S. investments abroad.

The resolution, which had the support of the Soviet, South American and Arab blocs, virtually bars the U.S. Government from extending any protection to private investments in foreign countries. Indeed, it prevents the State Department from making vocal or written representations against nationalization, confiscation or outright seizure. It makes no provision for compensation.

State's latest viewpoint was set forth in an official letter to Dwight C. Baum of San Marino, Calif. After reading a reference to the U.N. resolution in this column, he protested to former Secretary Acheson. Unless rescinded, Mr. Baum said that American economic assistance to foreign nations would be as "futile as the handing of a quarter to a bum on Skid Row."

NO POSITIVE STAND—The need for Congressional clarification is revealed graphically in the reply which Mr. Baum received from Walter Kotschnig, Director of the Office of U.N. Economic and Social Affairs in the State Department. His communication shows that the State Department has no definite or positive stand on this extremely important problem.

Kotschnig admits that the resolution is "most unfortunate," and "still not acceptable" to the United States. He then refers to amendments supposed to safeguard the flow of private capital in international channels, but it is clear that these are only meaningless and pious hopes. They have no binding effect on public or private debtors overseas.

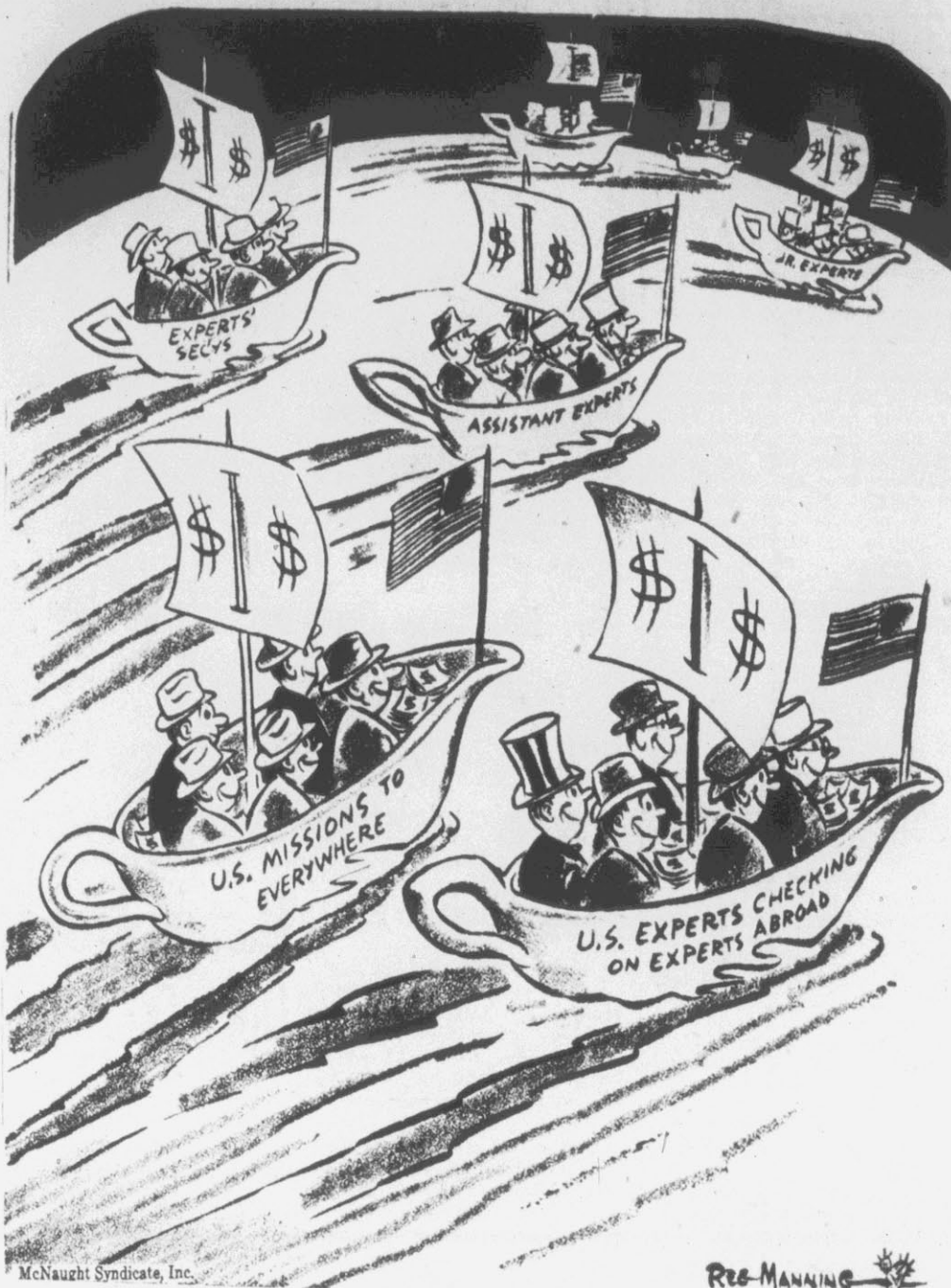
MAY CONTINUE PROTESTS—Next Kotschnig comes to the crux of the problem as it affects American sovereignty. He attempts to minimize the effect of the resolution by giving the "interpretations" which the State Department places upon it. He says that, according to our understanding of the resolution, the U.S. may continue to make diplomatic protests whenever "property of American national is nationalized by foreign governments."

But the State Department's "interpretation" obviously is not the same as that read into the resolution by the 31 and 25 nations which voted against us. It will not give our government or aggrieved "nationals" any standing should a protest against nationalization be lodged with the United Nations or in any other international body which does not accept our one-sided "interpretation."

MUDDLED AFFAIRS—Senators Wiley and Jenner, as well as a majority of the Congress, are not satisfied with such a muddled state of affairs. They insist that our legislative body declare, by a constitutional amendment, if necessary, that no international organization in which the Soviet bloc has so much power, shall run the internal affairs of the United States.

In that demand they have the support of such powerful groups as the American Bar Association, the American Legion and Veterans of Foreign Wars, the Daughters of the American Revolution and the Confederacy, and just plain Americans.

That same afternoon I was talking to a local preacher and said, "Some day when both of us have time I want to talk to you about death. That's a subject that I want to know a lot more about than I do."

"OK," he said. "Any time."

The idea I want to discuss, I went on, is that I'm not ready to take that first trip to Wilkerson's. To the best of my knowledge I'm living right, so I can't understand why I'm not ready."

"You have faith," he said, "but

your mind is not at ease. If you are completely at ease then death is no problem. I've seen quite a few people die, but none of them were ready."

"It's like this: One time I was putting up a television antenna on a high building, with my regular assistant. Come on," I said, "let's get up there." The assistant plainly said that he wasn't going.

"What's the matter?" I said. "Don't you believe that if you fall off and are killed you're going to Heaven?"

"Yes, sir," the assistant said, "but I'm not sure of what's up there. I'm sure of what's down here."

So the question arises: How many of us are sure enough of what's up there, and that we're

going to be ready to die? I put it to the preacher this way: "What I want to know is can I tell from up there how my family will look next year, and the year after?"

"You can see them," he said, "better from up there than you can down here. Not only can you see their present, but their future as well. And for all we know you can have influence on them from up there."

My talk with the preacher is to be continued at a later date, when both of us have more time. When you stop to think about it, death is a very unpleasant subject that is seldom discussed. It must be because most people aren't ready to die. I suppose our preachers' biggest job is to get us ready. And I thank you.

Around Capitol Square

SOLUTION — The Board of Conservation and Development solved one of its problems by the simple expedient of ignoring both the problem and board's own by-laws. After a brisk discussion Monday over the appropriate hour during the winter meeting for election of officers, and decision to defer the election until next day, followed by some off-site conferences overnight, the board adjourned without doing or saying any more about the matter. That was in face of by-law requirement that at the winter meeting in odd numbered years the board shall elect a chairman, a vice chairman and a secretary for two year terms.

PRECEDENT — Immediately upon adjournment reporters converged on Chairman Miles Smith to find out what had happened. At least some of the newsmen knew of resolutions — motions which had been prepared apropos to the situation, but which were not brought from under cover. Chairman Smith was ready with the answer: "The board dealt with the by-law requirement for election exactly as the General Assembly has dealt with the issue of re-appointment." Smith had stated the day before that because of demands of his own business he could not accept another term. He got at "last a part of one forced upon him by default."

REORGANIZATION — Terms of five members of the board expire by limitation on May 1, and rumors have been current for months that Governor Umstead has in mind a general reorganization of the C & D department. None of the board members interviewed would admit knowledge of any specific request from the Governor, but opinion prevailed that some contact had been established with Watts Hospital in Durham where he is recuperating from a mild heart attack more than two weeks ago, but still keeping in close touch with affairs of State and that the Governor desired that no action be taken at this time. He has not disclosed his plans for the department, but opinion is general that he will ask for legislation enabling him to appoint the full board this year, to more clearly define the responsibilities of the director and the board, and to weld the diverse and sometimes discordant divisional activities into a more coherent department.

CONTINUING — Dr. Silverter Green was the most active member of the board in the election matter. On Monday he vigorously contended for immediate action, and on Tuesday he credited with maneuvers which led to indefinite postponement. The failure to elect officers and the acceptance of invitations to hold the spring meeting at Ellsabeth City and the fall meeting at Doughton Park indicates the continuity of State agencies. Governors come and go every four years; personnel of the boards, commissions and departments changes from time to time; but North Carolina goes on. In the event that the next meeting of the board of conservators is held, it will be entirely different people around the table, and even a different name for the agency, the essential duties of the board will be the same as they are and have been.

House committees on education held their first meetings Wednesday morning in the same room, but at different times—thereby wasting a lot of time and requiring State Superintendent Charles Carroll to make a speech twice. Senate Chairman Fred Røyster called his group together at 10 o'clock and had promised House Chairman Gordon Maddrey to be through by 10:30. Actually the House members cooled their heels in the hall for 20 minutes, while the Senators were dealing with matters of equal importance to both groups. Carroll gave a briefing on the aims and objectives of his department, discussed some of the problems facing the public school system, and suggested the desperate need for more money to enlarge operations of the state supervisory agencies in order to further aid the individual schools. Major projects included consolidation of schools, recruitment of teachers, especially in the elementary field, and more adequate enforcement of attendance laws. The incoming school population, evidenced by Carroll's report that "for the first three months of the current school year was about 915,000. He pointed out that if only one percent of these stay away from school any day, that means nearly ten thousand absentees."

CAN BYRNES SPEAK FOR THE SOUTH?

(Durham Morning Herald) Feeling the need to interpret the South to other parts of the nation, the Southern Governors Conference has set up a sort of public relations program and Governor Herman Talmadge of Georgia, conference chairman, has named Governor James F. Byrnes of South Carolina to direct it.

So far as this newspaper is aware the nation has not yet had an opportunity to see any of Governor Byrnes' handwork in this new endeavor. But Americans everywhere know a great deal about Governor Byrnes' work in South Carolina during the past couple of years, and one wonders if the Governor's handwork equips him for the job of presenting with success "the South's viewpoint," whatever that might be, to the rest of the nation. One wonders, indeed, if the Governor's ideas of "the South's viewpoint" are well received in the South itself.

In noting Governor Byrnes' assignment, the St. Louis Post-Dispatch, reminding its readers that Governor Byrnes "has been saying some of the most extreme, bigoted, and inflammatory things that are being said on the race question," wonders if the Governor's career has "alleviated misunderstanding about the South, or produced new puzzles to cause concern about his region."

It's a good question and the answer is more important to the South than to any other section. Any Southerner would have a difficult time interpreting "the South's viewpoint" to the rest of the nation, but one suspects that Governor Byrnes is beaten before he even begins. His leadership in the campaign to close the public schools in South Carolina in the event public school segregation is declared unconstitutional by the Supreme Court certainly marks him in the minds of Americans generally as a racial extremist. His checkered career may make him an object of curiosity, but scarcely one would think, fits him to be an interpreter of the South as it is and as it wants to be.

Governor Byrnes would be an ideal choice to present the Byrnes viewpoint, but one doubts that he is even an acceptable choice to present "the South's viewpoint."

Three Rules For Avoiding Crime

EVANSTON, Ill. (U.P.)—A sociologist has come up with these three rules which he says will help you from becoming involved in crime:
1. Stay home on Saturdays.
2. Watch your step between 10 P.M. and midnight.
3. Avoid personal contacts as much as possible in the summer.
Gerhard J. Falk, a University of Pennsylvania sociologist, said he formed his rules on the basis of statistics prepared since the turn of the century to show the influence of the season on the crime rate. Falk's report was printed in the Journal of Criminal Law, Criminology and Police Science published by the Northwestern University school of law. He said his studies showed crimes against the person are more numerous in summer when people are in more frequent contact. This sort of crime generally is at its lowest ebb during the winter, Falk added. History shows that more rebellions occurred in summer months than in any other season. To Falk it's proven that people are just plain harder to get along with in hot weather. Statistics showed crimes of all kinds occurred most frequently between the hours of 10 p.m. and midnight, according to Falk's report. And the week end has a greater crime frequency than midweek, with Saturday the worst day, Falk concluded.

A much-troubled Atlantic Christian College basketball team comes to Greenville tonight for a North State Conference battle with the first-place East Carolina College Pirates but Coach Jack McComas of the Bulldogs isn't too optimistic about his team's chances in the renewal of the Battle of the Bohnk Bucket.

The battered wooden water pail, symbol of athletic supremacy between the two schools, is expected to remain in Greenville because of the poor physical condition of the Bulldogs. No less than six of the ACC players are either out with injuries or will be slowed up because of illness.

Perhaps the most serious injury of all is the one suffered by forward, Jim Peebles. The sophomore forward from Raleigh who is the team's leading scorer smashed his finger in an automobile door on January 16 and is not yet completely healed. Peebles, 6-4, is one of the team's leading rebounders and was expected to be their main strength under the boards.

In addition to Peebles, the Bulldogs count Gilbert Ferrell, Jerry Williams, Reid Ingraham, Bill Price, and Del Whitley on the injured list. Ferrell has a bad knee which may keep him out of action for the remainder of the year. Williams, a freshman forward, has a sprained ankle. Ingraham and Williams are both suffering from influenza and Whitley is out for the second time this year because of pneumonia.

Some of the slack caused by injuries may be taken up by the promotion of freshman Howard Ham to the varsity. Ham has been playing with the Jayvees but his good work thus far has resulted in an at least temporary promotion.

The Pirates, on the other end of the stick, expect to be in near-top physical shape for the game. Charlie Huffman the junior forward who has suffered recently from shin splints, is back in good shape. He has been playing regularly but he hit his peak only Wednesday night against High Point when he scored 20 points.

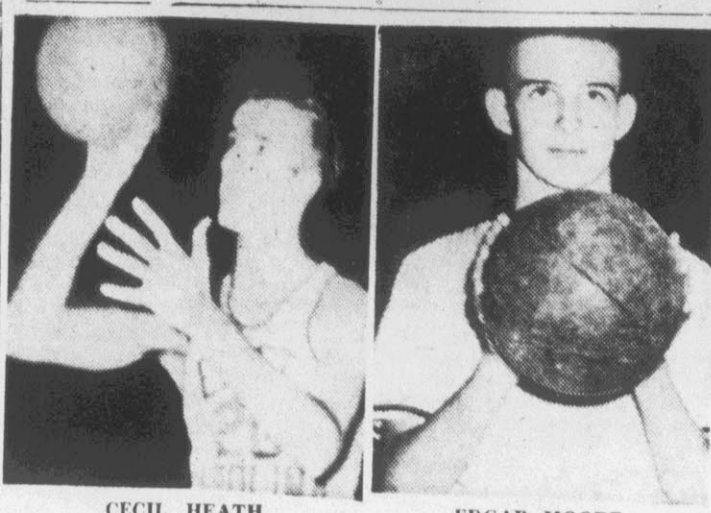
The rest of the first team will be in good shape, too. Sonny Russell, fresh from a 38-point performance against High Point, will be at his usual place at forward. Bobby Hodgson, the team's number two scorer, will be at center. Cecil Heath and J. C. Thomas will be the guards.

The Pirates, in first place with an 8-2 record, will take on another North State Conference team tomorrow night when they lock horns with Western Carolina in their "big" home game. The Cats won the first meeting 102-97, in Cullowhee.

East Carolina Rounds Turn In Stretch Drive

HIGH POINT—Coach Howard Porter's East Carolina Pirates didn't "sew-up" first place in the North State Conference standings Wednesday night but they made a long stride in that direction with their impressive victory over High Point.

The win stretched the Pirates' record to 8-2 for the year and put them at least a full game ahead of the rest of the pack. They have won six games remaining on their schedule with four of them carded for ECC's Memorial Gymnasium and one in neighboring Wilson. The only long trip planned is for Monday when the Pirates have to journey to Boone to play Appalachian in a return engagement.

Before the Boone trip, however, the Pirates have two home contests to settle. Friday night, they'll meet Jack McComas' thoroughly unpredictable Atlantic Christian Bulldogs. Saturday, they'll get a second chance at Western Carolina, a team which edged the Pirates 102-97 in Cullowhee a week ago.

Victories Friday and Saturday—something which can't be guaranteed in the North State Conference—would put the Pirates in high cotton and a win Monday night would put them weighing the stuff.

Getting the three wins will be a big order, though, because of the quality of competition.

First of all, ACC seems to be special in upsetting the big boys. Earlier this year, they bumped off High Point and stronger as the season progresses. In addition to that, they want a victory over the Pirates perhaps more than anything else.

Western Carolina's toughness has already been proved once. As long as Ronald Rogers, Ned Straehla and Jim Jordan are in the line-up, they'll give anybody a rough time.

Appalachian has lost once to the Pirates this year but they've got one big factor in their favor Monday night: the Pirates have never won in Boone. Last year for instance, the Bucs thought they had the game won but the Mountaineers came through with a last-minute rally which resulted in a 73-72 win. The Apps are tough on their home court and don't lose any too often.

Anyway, it's a long time until tournament time in late February. All the old bugaboos facing the Pirates will be dealt with in the future like they've been treated thus far—one at the time.

Carolina, Oklahoma In Important Games

NEW YORK (UP)—The Oklahoma Aggies and the North Carolina Tarheels risk their conference leaderships tonight as a full program of important games ends the temporary lull in college basketball caused by mid-year examinations.

Including these two pacemaking clubs, no fewer than five of the nation's highest-ranked teams are slated for action with California, Brigham Young, and Southern California on view.

The Aggies tangle with Tulsa at Stillwater, Okla., in one of the top games of the week and one that may be a key to the Missouri Valley Conference race. The Aggies, ranked seventh nationally, are on top with a 2-0 mark but Tulsa, enjoying one of its finest seasons in history, is right behind with 3-1.

North Carolina, rocketing to the front of the Southern Conference in Frank McGuire's first year as coach, and now No. 17 nationally, is expected to add another notch to its 11-1 league record against Davidson at Davidson, N. C.

California, leader of the Southern Division of the Pacific Coast Conference, and holding No. 14

ranking nationally, steps out of the league for a game against St. Mary's of California. While Southern California, ranked No. 18, also goes outside to play Santa Barbara.

Brigham Young, ranked No. 15, meets Montana in a Skyline Conference game. A win would move BYU within one victory of first-place Wyoming.

Fred Dwyer Wins Wanamaker Mile

NEW YORK (UP)—Fred Dwyer, America's newest indoor track sensation, said today he believes he can crack Gil Dodds' indoor mile record of 4:05.3—"but not this year."

Dwyer, a 140-pound Villanova senior, reeled off his fourth 1:35 victory in as many tries Thursday night when he won the Wanamaker Mile in 4:08.2 in the Millrose Games at Madison Square Garden.

It was his first Garden victory, his fastest mile, and the fourth fastest in the 28-year history of the Wanamaker. Only Dodds' indoor record, set in the 1948 renewal; Chuck Fenske's 4:07.4 in 1940 and Don Gehrman's 4:07.5 in 1951 were faster.

Walt Molineux, Brown University senior, surprised by taking second place. He finished three yards behind Dwyer, while Fred Witt and Don Gehrman, who ranked as the country's top indoor milers until this season, slogged in third and fourth, respectively.

"Sure, I think I can get down to Dodds' record," Dwyer said. "But not this year. Maybe next year."

Dwyer's performance drew most of the cheers from the crowd of 15,000 although Olympic champions Bob Richards, Andy Stanfield, Harrison Dillard, Mal Whitfield and Horace Ashenfelter won their events in impressive style.

Richards won the pole vault with a leap of 15 feet, 1-2 inch; Stanfield won the 60-yard dash in 6.3 seconds; Dillard captured the 60-yard high hurdles in 7.3 seconds; Whitfield took the 600-yard run in 1:10.9; and Ashenfelter finished half-a-lap ahead of Gordon McKenzie of the New York Pioneer Club in winning the two-mile run in 8:54.6.

N.C. State Is Hard Pressed In Southern Conference Race

RALEIGH, N. C. (UP)—Folks began wondering today whether the almost ancient reign over Southern Conference basketball by the North Carolina State Wolfpack under Coach Everett N. Case may be slipping with age.

The answer may come tomorrow night when N. C. state plays a

battling and fired-up Wake Forest team before a capacity crowd here. Since the Case era began, the Wolfpack has made the big Southern circuit its undisputed case kingdom and stopping ground. The big 12,500-seat William Neal Reynolds Coliseum here became the throne room and Case's acres ruled

with an iron hand. But things have been changing fast. Upstarts like North Carolina Wake Forest and George Washington are giving N. C. State its big

best scare in seven years. Surprisingly N. C. State has dropped two conference games already both by one-point margins. Outside the conference, the "Pack, eighth ranked nationally, has dropped two more games — to St. John's and Villanova, both upsets. On the other side the wolfpack has 16 impressive victories over some of the toughest opposition.

N. C. State clearly has been pointing for the return match against Wake Forest — this time on the home court here. But at Philadelphia, the Casemen showed signs of a tailspin and a Wake Forest victory would end State's chances to finish atop the regular season standings this year — and more important, the tournament title they have won so often would look a lot farther away.

The lineup for the March tournament appears almost set. Regarded as chinchos to make the eight-team affair are North Carolina's youthful "wonder" boys of Coach Frank McGuire, now leading the league Wake Forest, N. C. State, George Washington, West Virginia, Maryland, Furman and either Richmond or Duke.

In conference action last night South Carolina, fighting uphill against a 54-point effort by the nation's top-scoring duo, upset Furman 74 to 72 and cast at least a temporary damper on the Purple Paladins' aim at a snug conference tournament berth.

Frank Selvy, playing with an injured ankle, fired in 29 points and teammate Neild Gordon got 25 to pace Furman. But the Gamecocks outscored the favored visitors in three periods and held a 61-47 lead going into the final quarter.

Furman went to work with a desperate rally in the last 10 minutes, getting its final two points on a set shot by Bobby Chambers as the gun sounded.

Joe Smith paced South Carolina with 23. It was the third win for South Carolina against severe league losses. For Furman it was the third defeat against five wins.

League-leading North Carolina is a heavy favorite to down Davidson tonight for the 12th Tar Heel victory against a lone loss to Maryland in overtime.

William and Mary, its tournament chances almost extinguished, will rank a heavy favorite over Virginia Tech. The Gobblers have an overall record of one win and 10 setbacks and have lost five in the league.

Outside the conference The Citadel plays at Newberry.

Fans Assured Cards Remain In St. Louis

NEW YORK (UP)—Fred Saigh, face-to-face with a crucial conference with Baseball Commissioner Ford Frick and National League President Warren Giles, assured St. Louis fans today that he would not sell his controlling interest in the Cardinals to any syndicate which would transfer the franchise to another city.

Saigh, rejecting "feeler" offers from syndicates in Milwaukee and Houston, revealed his stand early today before meeting with Frick and Giles in the commissioner's office at 9:30 a.m. e.s.t.

The meeting will be Saigh's first with baseball's highest executives since he was sentenced to 15 months in jail for tax evasion. Frick and Giles were expected to give Saigh a reasonable length of time to dispose of his Cardinals' stock.

Neither Frick nor Giles has made any statement about Saigh's personal baseball future, preferring to confer with baseball's attorneys before doing so. But the Cardinals' president himself has announced he will sell out because he doesn't want "to embarrass baseball."

Saigh's decision to bar a transfer of the franchise to another city cleared the path for William Walsingham Jr., a vice president of the Cardinals since 1947, to head a syndicate which would buy up Saigh's 90 per cent interest and continue the franchise in St. Louis.

Saigh announced the decision after a midnight conference with Walsingham, Manager Eddie Stanky and a high baseball official in a fashionable mid-town hotel.

Asked point-blank after the conference whether he would sell his stock to a syndicate which would move the franchise, Saigh replied: "No, I'm opposed to doing that. I want the club to remain in St. Louis."

Saigh, sentenced to 15 months in prison and fined \$15,000 for income tax evasion, has been given until next May 4 by the court to clear up his financial affairs.

of all Mexico. But he'd had one weakness. Women. And one had betrayed him for a pouch of federal gold. He faced southward, observing a long smear of risen dust above the barren plain. That would be the federal cavalry coming to do last night at San Sebastian. It was characteristic of Jim Rimbaud that he didn't glance at Durango again. The smoky years had given him a gambler's fatalism. Durango was dead. Finished. And so was his fabulous dream of driving Porfirio Diaz from the palacio national. There had been some chance of winning the revolution while Durango lived, but now there was no chance at all. Calculating the distance between this dry river bed and the oncoming riders, Rimbaud decided that it was not more than three miles. A matter of minutes. A man couldn't make a stand here. Nor anywhere this side of the border hills. Rimbaud plodded over to the horses and gave the down-headed animals a squint-eyed appraisal. There seemed little choice between

Plans To Fight Deportation To 'Certain Death'

CAMP CARSON, Colo. (UP)—An Army lieutenant said he was ready today to fight an order which would deport a wounded Korean veteran to his native Poland where he faces possible Communist execution.

Lt. Charles W. Brooks of the 11th Armored Cavalry said Thursday night that Sgt. Janusz Clucinski, a fugitive from Red Poland who was imprisoned by the Russians during World War II for underground activity, should be made an American citizen.

Instead, Brooks said, Clucinski has been ordered discharged from the Army, into which he was drafted, and deported to Poland. A Communist death penalty awaits Clucinski if this happens, Brooks said. And he quoted the sergeant: "If I have to die, I'd rather be shot in this country than to die over there."

Brooks, a reserve officer from Roodhouse, Ill., was hopping mad when he told of Clucinski's plight. "I think the Senate should investigate this," Brooks said. "This man should be made an American citizen. He is under a death penalty if they send him back to Poland. He has an outstanding record in the last war. He was fighting against the Russians in Poland when he was only 15. And he was wounded under rather heroic circumstances in Korea."

Brooks said he had no authority to speak for the Army, and was accompanying Clucinski's cause out of personal conviction that an injustice is in the offing.

Brooks did not make it clear the Polish sergeant was being deported for illegal entry to the U.S. or some other offense affecting an alien.

Clucinski jumped a Polish ship at New York in January, 1950 and turned himself in to Newark, N.J., immigration authorities, Brooks said, but was allowed to remain in this country. His Army serial number indicates that later he was drafted somewhere on the East Coast.

Bill For Income Tax Reduction Has Heavy Committee Backing

WASHINGTON (UP)—Rep. Daniel A. Reed's plan to cut personal income taxes July 1 has the support of a large majority of the House framing House Ways and Means Committee, a membership poll disclosed today.

Only two of the 25 committee members—both Democrats—said flatly they would vote against Reed's bill if it is brought up as scheduled Feb. 16.

Seven other members—all Republicans—said they had some reservations about the proposal, particularly the timing of it.

But none of the GOP members said they would vote against it.

Reed, New York Republican who is chairman of the committee, wants to reduce personal income taxes about 11 per cent for the last half of 1953, or the equivalent of about 5 1/2 per cent for the full calendar year.

Federal income tax payers will get an 11 per cent cut effective next Jan. 1 under present law. Reed proposes to advance this relief by six months.

Speaker Joseph W. Martin Jr. (Mass.) and House Republican leader Charles A. Halleck (Ind.) have made clear their displeasure with Reed for proceeding without a green light from them. They feel that the new Republican Congress must make a record on cutting federal spending before it sets about reducing taxes.

But Reed is going ahead with his plan. He says the difference in views among high-ranking Republicans has put rank-and-file GOP members of the Ways and Means Committee on the spot.

Some are frankly worried whether they should support Reed, or whether they should try to win a delay in committee consideration of the bill. Indications are that if the bill says it will, then most of the doubtful Republican members will vote for it.

They will do so with the knowledge that Martin and Halleck won't let the tax bill get to the floor until after some of the big appropriations bills for fiscal 1954 have been passed—and the Republican determination to economize has been well demonstrated.

Intruder Frightens Local Woman; Injured By Fall

GREENVILLE—A Greenville woman was in a state of hysterical shock today after having discovered a Negro man lurking in a bedroom closet of her Rock Spring Drive home.

Police said this morning they had not been able to thoroughly question Mrs. J. Bryan Brown, who discovered the intruder in her home, due to her over-excited condition, but they did determine the incident happened shortly before 10 o'clock this morning.

Police said that Mrs. Brown first noticed the signs of an intruder when she returned to her home after shopping and discovered that one drawer of the dresser in a bedroom had been rifled and a closet door slightly ajar.

In recapitulating the incident, police quoted Mrs. Brown as saying she opened the closet door and saw a Negro man standing there who lunged at her in an attempt to get away. Mrs. Brown began backing and fell against a screened window which gave way, causing her to fall on the ground outside.

In the fall, Mrs. Brown suffered injuries of the right ankle leg and arm but was able to get to a neighbor's house, J. C. Lanier, and report the incident.

Bloodhounds were immediately called out by the police in an attempt to trace the intruder. Police said the man apparently entered the home through the back door. Nothing has been reported missing.

Driver Jailed In Prolonged Chase

GREENVILLE—A wild automobile chase beginning south of Vanceboro, with highway patrolmen as the pursuers, ended in Greenville with the offender resting in jail in default of a \$200 bond set for speeding and reckless driving.

Patrolman Paul Whitley reported this morning that Gilbert P. Jones, Negro man, 20, of 410 North 13th Street, Morehead City, had been placed in the county jail on charges of speeding and reckless driving after being pursued and stopped by patrolmen. Jones was driving a car containing several other passengers and belonging to Gerald Beaton.

The chase started last night about 9 o'clock south of Vanceboro when State Highway Patrolman Pat Herrington fell in behind a speeding automobile and pursued it through Vanceboro and north on Highway 43 toward Greenville.

With Patrolman Herrington unable to stop the fast traveling car, Patrolmen Whitley and Bill Whitehurst fell in behind the car which was traveling between 95 and 100 miles per hour, according to the officers.

The two patrolmen radioed for help and a road block was set up at the underpass on Highway 43 in Greenville by two city police cars and a deputy sheriff's car. Here the chase ended with officers rushing the car as soon as it came to a stop.

upon figures offered as accurate statistics, so that the General Assembly would not be faced with a continuing situation in which the Budget Bureau, the State Board of Education, and Department of Public Instruction and the United Forces for Education came up with different figures on such matters as number of teachers, average salaries, and similar easily determined facts. Committee discussion was mainly on whether or not the United Forces for Education should be included, since it is a rather loosely formed non-governmental organization, not responsible to the General Assembly or amenable to legislative control.

PRINCIPLE—Grady Rankin and Edwin Pate contended that while the United Forces or any of its component parts should be heard when request for hearing was made, it was setting a dangerous precedent to suggest the Legislature should be bound by statistics from non-governmental agencies. Senators Kirkman, Adam Whitley and Robert Morgan expressed belief that the UF should be included. When the vote was taken a substantial majority of the committee voted to limit the list to state agencies. Later several Senators said they wanted the UF figures for comparison with official statistics. That is essentially the policy which has been followed.

Bill For Income Tax Reduction Has Heavy Committee Backing

WASHINGTON (UP)—Rep. Daniel A. Reed's plan to cut personal income taxes July 1 has the support of a large majority of the House framing House Ways and Means Committee, a membership poll disclosed today.

Only two of the 25 committee members—both Democrats—said flatly they would vote against Reed's bill if it is brought up as scheduled Feb. 16.

Seven other members—all Republicans—said they had some reservations about the proposal, particularly the timing of it.

But none of the GOP members said they would vote against it.

Reed, New York Republican who is chairman of the committee, wants to reduce personal income taxes about 11 per cent for the last half of 1953, or the equivalent of about 5 1/2 per cent for the full calendar year.

Federal income tax payers will get an 11 per cent cut effective next Jan. 1 under present law. Reed proposes to advance this relief by six months.

Speaker Joseph W. Martin Jr. (Mass.) and House Republican leader Charles A. Halleck (Ind.) have made clear their displeasure with Reed for proceeding without a green light from them. They feel that the new Republican Congress must make a record on cutting federal spending before it sets about reducing taxes.

But Reed is going ahead with his plan. He says the difference in views among high-ranking Republicans has put rank-and-file GOP members of the Ways and Means Committee on the spot.

Some are frankly worried whether they should support Reed, or whether they should try to win a delay in committee consideration of the bill. Indications are that if the bill says it will, then most of the doubtful Republican members will vote for it.

They will do so with the knowledge that Martin and Halleck won't let the tax bill get to the floor until after some of the big appropriations bills for fiscal 1954 have been passed—and the Republican determination to economize has been well demonstrated.

Intruder Frightens Local Woman; Injured By Fall

GREENVILLE—A Greenville woman was in a state of hysterical shock today after having discovered a Negro man lurking in a bedroom closet of her Rock Spring Drive home.

Police said this morning they had not been able to thoroughly question Mrs. J. Bryan Brown, who discovered the intruder in her home, due to her over-excited condition, but they did determine the incident happened shortly before 10 o'clock this morning.

Police said that Mrs. Brown first noticed the signs of an intruder when she returned to her home after shopping and discovered that one drawer of the dresser in a bedroom had been rifled and a closet door slightly ajar.

In recapitulating the incident, police quoted Mrs. Brown as saying she opened the closet door and saw a Negro man standing there who lunged at her in an attempt to get away. Mrs. Brown began backing and fell against a screened window which gave way, causing her to fall on the ground outside.

In the fall, Mrs. Brown suffered injuries of the right ankle leg and arm but was able to get to a neighbor's house, J. C. Lanier, and report the incident.

Bloodhounds were immediately called out by the police in an attempt to trace the intruder. Police said the man apparently entered the home through the back door. Nothing has been reported missing.

Driver Jailed In Prolonged Chase

GREENVILLE—A wild automobile chase beginning south of Vanceboro, with highway patrolmen as the pursuers, ended in Greenville with the offender resting in jail in default of a \$200 bond set for speeding and reckless driving.

Patrolman Paul Whitley reported this morning that Gilbert P. Jones, Negro man, 20, of 410 North 13th Street, Morehead City, had been placed in the county jail on charges of speeding and reckless driving after being pursued and stopped by patrolmen. Jones was driving a car containing several other passengers and belonging to Gerald Beaton.

The chase started last night about 9 o'clock south of Vanceboro when State Highway Patrolman Pat Herrington fell in behind a speeding automobile and pursued it through Vanceboro and north on Highway 43 toward Greenville.

With Patrolman Herrington unable to stop the fast traveling car, Patrolmen Whitley and Bill Whitehurst fell in behind the car which was traveling between 95 and 100 miles per hour, according to the officers.

The two patrolmen radioed for help and a road block was set up at the underpass on Highway 43 in Greenville by two city police cars and a deputy sheriff's car. Here the chase ended with officers rushing the car as soon as it came to a stop.
