Gen. Clark Sees No Reason For Great Hopes Or Pessimism

Cautious Attitude Advised

By RUTHERFORD POATS United Press Staff Correspondent TOKYO (AP)—Gen. Mark Clark warned today the United Nations must not expect too much or too little from the Communist offer to resume truce negotiations in Korea.

"I never know what their motives are. I am usually in utter amazement," Clark said at a news conference in Seoul. "The U. N. Far East commander recalled that he has been dealing with the Reds for a long time. He added: 'I never know what their motives are. I am usually in utter amazement.'"

"We are making all preparations and will be ready to go. We don't want to do anything to hold up the negotiations." Today's 30-minute meeting was held to discuss the location of Red prisoners of war camps, which would have to be known before an exchange of prisoners could be made.

Molotov Pledges Assistance To Invoke Chinese Plan

Russia Endorses Korea Truce Offer

By EDDY GILMORE MOSCOW (AP)—Foreign Minister Y. M. Molotov pledged Soviet assistance today in trying to bring about an armistice in Korea on the basis of proposals by Chou En-lai, the Chinese premier.

Molotov's statement was the first official Soviet comment on the latest Korean developments. It appeared in the form of a Foreign Ministry announcement issued through the official Soviet news agency Tass and broadcast by Moscow Radio.

Democratic Republic have stated that they agree to the proposal for the exchange of sick and wounded prisoners of war, and as before express readiness to reach agreement on the immediate settlement of the entire question and thereby ending the war in Korea.

Molotov said that the Chinese proposal on repatriation "gives an opportunity to solve justly the question of the repatriation of war prisoners and removes the remaining barriers to realization of an armistice in Korea."

East And West Agree On Lie's Successor

UN Secretaryship Filled

UNITED NATIONS, N. Y. (AP)—U. N. delegates today viewed the East-West agreement on a new U. N. secretary general and Communist Chinese proposals to settle the Korean prisoners-of-war question as major steps in the Soviet Union's new anti-Stalin peace offensive.

The surprise East-West agreement came on the heels of Red China's broadcast offer two days ago to settle the major issue standing in the way of a Korean armistice. That proposal had immediately captured top attention at the U. N.

Members—the U. S., Britain, France, the Soviet Union and Nationalist China. Each agreed not to use his veto if the Swede won the seven Council votes necessary for his selection.

Teen-Age Marine Confesses To Wanton Slayings

Calmly Admits 5 Murders

DUBUQUE, Ia. (AP)—A teen-age Marine, described as "clean-cut and gentlemanly," calmly admitted five wanton murders in four days and then begged police to free his "dirty blonde" girl friend.

But the love-struck girl sobbed "I want the same punishment as he gets." Pvt. Fred E. McManus, 18, of Valley Stream, N. Y., was captured Tuesday night and signed a confession to the slayings of a Rochester, N. Y., man Friday, the double killing of an Illinois couple Saturday and another double murder at Spring Valley, Minn., early Monday.

McManus, one day AWOL, was arrested in a stolen car four miles north of Dubuque. With him was Diane Marie Wegeland, the foster daughter of a Somerville, N. Y., couple, and a middle-aged hitchhiker.

Experts See No Reason For Fear Of Peace

Study Wall Street 'Jitters'

NEW YORK (AP)—Economists were cautious today in diagnosing the bad case of jitters on Wall Street. Rumors that a truce may be signed soon in Korea sent stock prices tumbling in a wave of selling Monday and Tuesday. It was obvious many market operators feared that peace in Korea would mean a serious letdown in the nation's economy.

Stock market experts do not agree, however, that American businessmen need to be afraid of peace. The market flurry this week was reminiscent of the jitters which hit the trading boards 33 months and five days ago—when war broke out in Korea.

Wall Street experts have been advising against promiscuous selling of stocks. Some predict a rapid recovery in the market, but they are reticent about guessing when it will occur. Meantime, they admit that selling psychology is a difficult thing to cope with.

Women In The Church

Greater freedom of trade between the United States and other nations of the world are necessary for the "establishing of world economic health" and for the achievement of world peace, says a committee of United Church Women. The U.C.W.'s national Christian world relations committee believes that U. S. foreign trade policy should include these principles if our nation is to cooperate fully in the International Trade Organization: elimination of discriminatory trade regulations; reduction of tariff barriers; renewal of reciprocal trade agreements with reconsideration of "peril" and "escape" clauses; and simplification of customs regulations.

The Woman's Division of Christian Service—an arm of the Board of Missions of the Methodist Church—has issued a call for at least one hundred young women ("of good health, of Christian character and purpose, with a year's experience after college graduation") to volunteer for missionary service. They would be trained by the Board if accepted. The areas of service are Burma, Sumatra, Sarawak (Borneo), Malaya, and the Philippines. The need is for teachers of religious education, music, English, home economics, agriculture, physical education, and many high school subjects; supervisors of elementary schools, persons skilled in group singing, recreation, and club work; nurses, public health teachers, deaconesses, assistants to pastors. Persons interested may write to the Department of Missionary Personnel, 150 Fifth Avenue, New York 11, N. Y.

Irresponsible attacks on U. S. public schools, carried out in an atmosphere of "fear and hysteria" are denounced by Miss Esther Stamatis, director of Christian Social Relations for United Church Women. Attacks on public schools "strike at the heart of freedom and democracy," she recently told leaders of U.C.W., but added that she "welcomed honest and constructive criticism, discussed democratically and thoughtfully." Miss Stamatis heads a study and project on juvenile delinquency which will be carried out by church women's groups during the year.

Press Association Demands Repeal Of Secrecy Measure

RALEIGH (UP) — The General Assembly's "secrecy" law brought a demand from the board of directors of the North Carolina Press Association here yesterday for a repeal of the law and a public hearing on it before the Assembly.

The group, representing some 200 newspapers, adopted a resolution condemning the legislature's action in passing a measure last Thursday to allow its Joint Appropriations Committee and subcommittees to hold closed sessions.

The resolution said the action "is a dangerous precedent" which infringes on "the right of the people to know how their public affairs are managed."

The resolution was adopted after a spirited debate attended by newspaper editors, publishers and reporters from all over the state.

Two of the publishers, Josh Horne of the Rocky Mount Telegram and Thomas L. Robertson of the Charlotte News, proposed that representatives of the press and the legislature meet to seek a solution to the closed-door action. This proposal was defeated.

Horne agreed that the principle of open sessions should be preserved "as much as possible." He told the group that executive sessions can be desirable, but with passage of the law the legislature "now holds all the aces."

"It's not a question of who's got the aces, but a question of who's right," said C. A. (Pete) McKnight, editor of the Charlotte News.

Robertson said the legislature may have made a stronger case to the public than the press supposes and that representatives from both groups should "sit down and talk this thing out."

Association Director Eric Rodgers of Scotland Neck also said he believed executive sessions can be useful and that "liberty of the press should not become license of the press."

The resolution adopted by the group took into account the "annoying quest of reporters in their role as the people's information representatives."

However, it said this "annoyance" is a "necessary part of the Democratic process" and we submit that this annoyance is a small price indeed to pay for our political and other freedoms — freedoms that can live only where there is full freedom of the mind.

The group asked that the Assembly repeal its "hasty action" and commended reporters who refused to leave secret sessions of the appropriations subcommittee when ordered out.

"The truth is," the resolution said, "that the General Assembly, in its haste and determination to slap down Capitol reporters, really slapped down the people of North Carolina."

Consultants Will Assist In Promoting X-Ray Survey

A trio of public health publicity consultants, State Board of Health personnel, arrived here yesterday to begin promotional and educational work for the coming community-wide Chest X-Ray Survey.

Arriving yesterday were Flay W. Sellers, Iris Turlington, and Paul Johnson, who will remain in the county through May to assist the Pitt health department and community organizations.

The consultants will work through existing civic organizations in the county, churches, schools, extension services, and other groups in promoting the mass chest x-ray survey in Pitt County which will begin April 25 and run through June 18.

The trio will work in all areas of the county, making arrangements for the visit of the mobile x-ray units. The schedule for visits of the units has not yet been completed but will be announced upon completion. At present, the consultants have an office in the offices of the local health department.

The Pitt County Chest X-ray Survey will be made available to all citizens 15 years of age and older, by the Pitt County Tuberculosis As-

sociation, the Pitt County and North Carolina Medical and Dental Societies, the local and state health departments, the county health and education boards, and many civic organizations.

ificent that the stockholders who were hastily unloading do not want war and the continued drain and strain upon American productivity.

Truce in Korea should not by any means bring about a reduction in U. S. defense preparations and expenditures. The whole fabric of national defense policy and expenditures has been designed for a possible war that may never be fought. The Korean conflict does not figure in the defense budget Government officials have been waging that war with money and armament largely intended for other purposes.

There is no reason to believe that preparations for that "possible war that may never be fought" will be relaxed any time in the foreseeable future.

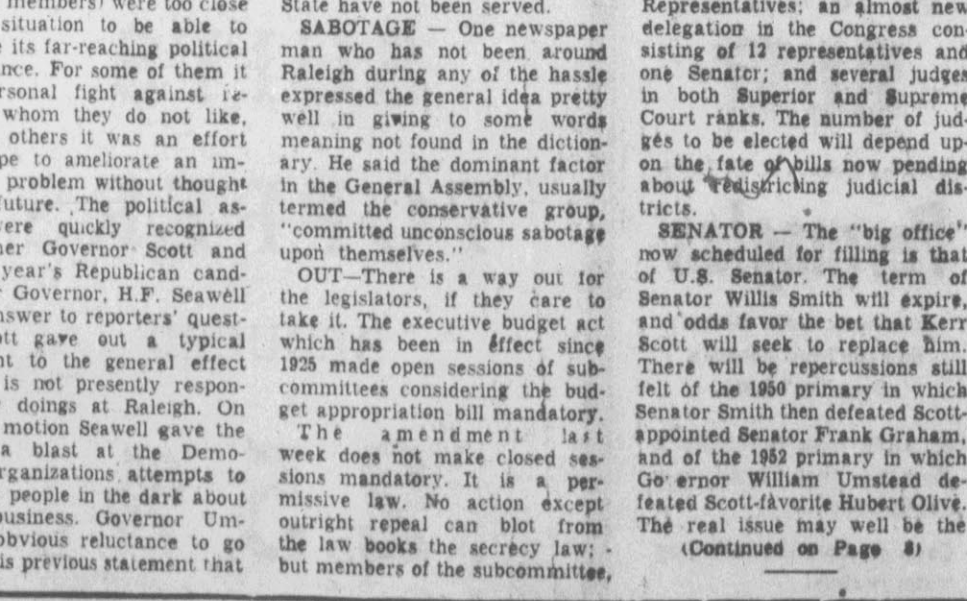
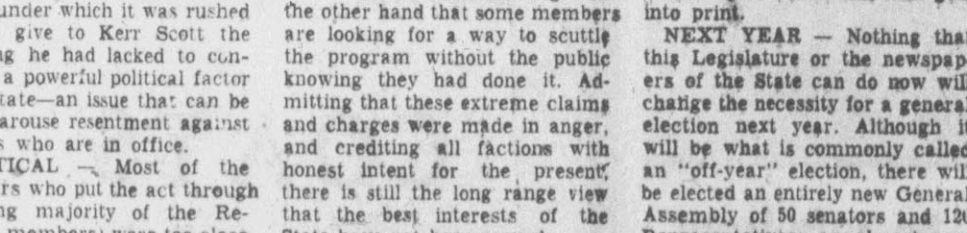
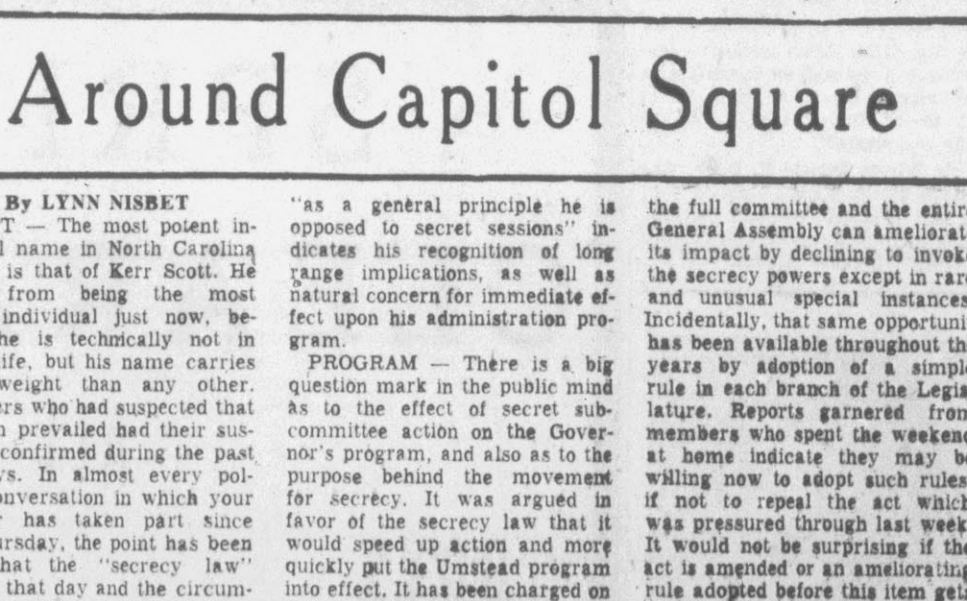
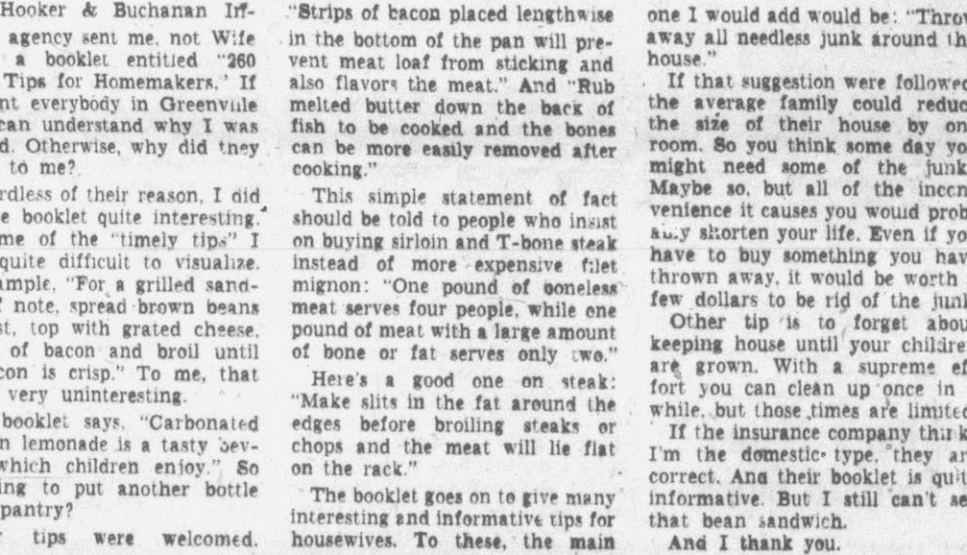
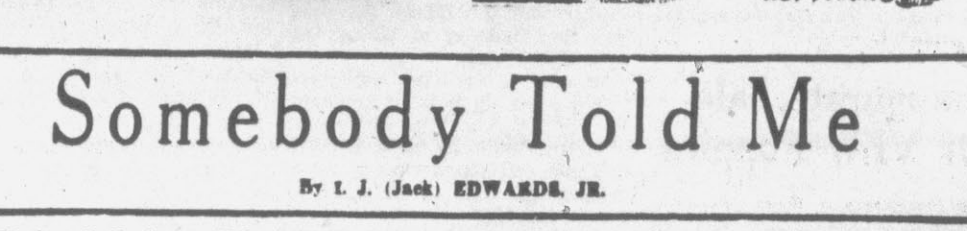
Should peace be restored in Korea, it will mean relatively little change in American defense efforts; and probably none at all. The sums now devoted to fighting the Chinese Communists will in all likelihood be devoted to the over-all defense planning.

Anyone who imagines the United States has increased its defense spending to about \$46 billions a year merely to fight in Korea is woefully misinformed. Only a fraction of this sum, roughly \$7 billion is devoted to Korea. And, of the \$104 billions voted for armaments in the past three years, only \$40 billions have been actually converted into delivered armaments. There's a long way to go.

So we find it hard to rationalize the stock market's wave of selling (and losses, too) as being due to what the Chinese regime says or does. By no means is there any sign that American policy-makers remotely suspect the Kremlin is permanently shelving its aggressive ambitions; nor have we heard satisfaction expressed with the state of the free world's military strength as compared with that of Russia.

Let us be the first to reassure Wall Street that if the stock market so strongly depends upon defense spending, there is no end in sight.

The Hooker & Buchanan Insurance agency sent me, not Wife Rachel, a booklet entitled "360 Timely Tips for Homemakers." If they sent everybody in Greenville one, I can understand why I was included. Otherwise, why did they send it to me?

Regardless of their reason, I did find the booklet quite interesting. But some of the "timely tips" I found quite difficult to visualize. For example, "For a grilled sandwich on toast, spread brown beans on toast, top with grated cheese, a slice of bacon and broil until the bacon is crisp." To me, that sounds very uninteresting.

The booklet says, "Carbonated water in lemonade is a tasty beverage which children enjoy." So I'm going to put another bottle in the pantry?

Other tips were welcomed.

"Strips of bacon placed lengthwise in the bottom of the pan will prevent meat loaf from sticking and also flavor the meat." And "Rub melted butter down the back of fish to be broiled and the bones can be more easily removed after cooking."

This simple statement of fact should be told to people who insist on buying sirloin and T-bone steak instead of more expensive filet mignon: "One pound of boneless meat serves four people, while one pound of meat with a large amount of bone or fat serves only two."

Here's a good one on steak: "Make slits in the fat around the edges, before broiling steaks or chops and the meat will lie flat on the rack."

The booklet goes on to give many interesting and informative tips for housewives. To these, the main one I would add would be: "Throw away all needless junk around the house."

If that suggestion were followed, the average family could reduce the size of their house by one room. So you think some day you might need some of the junk? Maybe so, but all of the inconvenience it causes you would probably shorten your life. Even if you have to buy something you have thrown away, it would be worth a few dollars to be rid of the junk.

Other tip is to forget about keeping house until your children are grown. With a supreme effort you can clean up once in a while, but those times are limited.

If the insurance company thinks I'm the domestic type, they are correct. And their booklet is quite informative. But I still can't see that bean sandwich.

The first 90 days of 1953 indicate that this year the average American family is on a vacation spree unequalled in the country's history. Vacation spending estimates start at \$4 billion a year and go up from there—depending on what is figured as vacation spending and who is doing the figuring.

The transportation field gets the largest piece of the tourist's dollar. During December, Pan-American Air's traffic to Puerto Rico was up 40 per cent over the previous year. Traffic to some other Caribbean areas was up 20 per cent. Travel and resort people anticipate approximately 300,000 Americans will travel to that area during the winter season compared with 250,000 in 1951-52 and less than 100,000 in 1946-47.

At the height of the winter season—the Christmas and New Year holidays—United Air Lines added some 40 flights to 206 scheduled. The New Haven Railroad used "everything that rolls" to handle its traffic and the Illinois Central ran "everything with wheels on it."

Winter resorts in the northern states and Canada are doing better than ever and business at the traditionally summer vacation spots is phenomenally strong. J.E. Farr, executive vice-president of Schenley Distributors—whose job it is to know where the liquor customers are and where they are going—estimates more than \$25,000,000 was spent for food, lodging and beverages by some 15,000,000 tourists and their families during January, February and March. During the year they will spend about \$2,345,000,000 for these items.

Winter's increasing popularity is a blessing to the vacation and resort industry because it creates business in what was once a slack season. In fact, many are taking winter holidays just to avoid crowded facilities during the warmer months.

Another reason is the trend towards two vacations, because of more leisure and paid vacations. Other factors include discounts in off seasons, pressure of business, higher earnings and savings, development of year-round attractions at resorts and the increasing popularity of winter sports.

But the trend is harder on the retailer. Keeping up with the highly mobile American consumer has never been easy, but now it's hard all year. Round, big or small, companies must have the right inventory to catch a buyer when he is in a vacation spending mood. It's not just the petroleum industry, the tire makers, the distillers and the luggage makers must know vacation trends. It's also the sunglasses salesman, the service station operator, the restaurateur, the sun-tan lotion retailer and dozens of others.

Once a business could take stock of itself and coast a bit during the cold months—but not any more.

UNION REPRESENTATION ELECTIONS RESTRICTED
 Collective bargaining contracts can now bar union representation elections for five years—at least in the automobile and farm equipment manufacturing fields.

The National Labor Relations Board unanimously ruled against such elections in cases where five-year contracts are in force.

This is the first time the NLRB has held that a contract can bar an election for more than three years. The board stated its decision was made in the interest of stable labor relations and that it did not feel employees were being unreasonably restricted in their choice of unions.

COMPANY OFFERS FIRST TV SET
 The first firm to rush to market with a three-dimensional system for television says all that is required is a \$50 mixing device on the transmitter and a \$10 viewing attachment on the receiver.

The home attachment has two peep holes with a mechanism which permit first the left eye and then the right eye to view the screen in rapid succession, according to the company (American Television Inc., 5050 N. Broadway, Chicago). Either two cameras or one with a mechanical shutter can be used at the TV studio.

NEW PRODUCTS
METAL: A low cost material—a compound of aluminum and antimony—that may compete with germanium and silicon for use in transistors and other electronic devices, has been developed at the Battelle Memorial Institute, 505 King Ave., Columbus, Ohio.

CHOCORY: An instantly soluble chicory in powder form, which is claimed to add flavor when added to soups, bouillans, sauces and prepared meats, is being marketed by American Food Laboratories, Inc., 860 Atlantic Ave., Brooklyn, N.Y.

 WASHINGTON—Be it a cake sale or a concert, wives of American officials in Thailand are finding the familiar ways for raising money for community betterment just as success abroad as back home. "It takes a good lot of organization and American woman in Bangkok who isn't doing voluntary work for some welfare project or other," Mrs. Joseph Brent, wife of the deputy chief of the Mutual Security Agency's mission, told me on a visit to Washington.

In the two and a half years the Brents have been in Bangkok she has taught English a year at the Agricultural university and a year at the School for the Blind, which required her to learn Braille. Last year she was chairman of the United Nations drive for children. The help of the Americans there was raised \$4,000 through fashion shows, bingo parties, a children's fair and a bridge tournament, she related enthusiastically, "and for the blind school, we gave a benefit dance, an American innovation happily sponsored by the King. We raised another \$2,000."

The 48-MSA ladies, organized as a group, have donated \$200 in funds they've raised through bazaars, teas and the like to each of the 14 charities and institutions in the Thailand capital, in addition to all their charitable work they keep up the rigid social program expected of them.

Mrs. Brent, a New Englander by birth, worked during the war for the U.S. Air Forces and later was an executive officer of the North Atlantic Treaty Organization set-up in the Pentagon here. She finds life in Thailand somewhat trying but is willing to undergo it to help this country's effort against Communism. "Someone else's worst," she said, "but living in Thailand is expansive, and during the past year, with increasing numbers of foreigners moving in, servants scarce, the dollar devaluing 25 per cent she found this becoming quite difficult.

"Many women have to do all their own housework under the most adverse conditions," she told me. "The temperature ranges from 84 to 97 degrees, with 97 humidity. There's no electric equipment except a fan, perhaps, and a refrigerator, which runs only a few hours a day. There's no hot water and cooking has to be done either on charcoal or gas stoves. There are no green vegetables, or fresh dairy products, and eggs cost around nine cents each."

The Brents have three children, Joseph, Jr., 24, a high school graduate who has just returned from 18 months in Korea; Robin, 21, an Oberlin graduate, just enlisted in the Army, and Ann, 20, who is with her parents.

Strength for the Day

PREPARATION
 There is no Biblical reference to any activity in which Jesus engaged on the Wednesday of what we have come to call Holy Week. It was a day of utter silence. No doubt he spent it in the home of some friend, probably in Bethany. We are not told what he did on this day.

But he knew on Wednesday that two days later he would suffer a horrible death. In addition to the physical pain would be the spiritual torture which, as the bearer of human sin, his separation from God in the last moments of his agony would bring about. Here was the terrible and awful ordeal for which he was to prepare himself.

On that Wednesday he no doubt rested and relaxed. He must have strengthened himself by reading over and over again the promises in the Old Testament regarding the final triumph in the world of God's Messiah. Above everything else, he prayed. We can be absolutely sure of that. He who poured out his soul so completely in Gethsemane on Thursday night must surely have prayed earnestly in the quiet of Bethany on Wednesday.

What does this mean to us? Well, very simply, it means this, does it not—that if Jesus the Son of God needed the help of prayer in a great crisis, you and I need it. He was apparently quiet on that day, in retirement, engrossed in a great spiritual experience which was preparing him for the ordeal of the cross. The Biblical injunction to us is, "Pray without ceasing."

Leave It To The State Department, Senator

When the international affairs of the United States get to the state, Senator Joseph McCarthy or his kind have to step in and take charge, the people, or their representatives should be the ones to authorize him to do so.

Until such time—and we surely hope our foreign affairs do not sink to that ebb—he should keep his hands out of the nation's foreign negotiations.

McCarthy probably has stolen the show in Washington so many times with his mudslinging and investigating—when he wasn't seeking a higher rank in the Marine Reserves—that he though he would make another advancement in the publicity limelight.

Fortunately for the country, McCarthy included, the State Department already had completed through proper channels an agreement with the Greek government that neither Greek nationals nor Greek ships would conduct further trade with Red China.

If each individual Senator or Congressman took it into his own hands to handle a minute phase of the nation's diplomatic program, the foreign policy of the United States would be in a mess. It is by no means void of inconsistencies or confusion as it is but if the Senators start working on individual international projects, it will be so confused no one would ever get it straightened out.

If McCarthy resolves to his usual tactics in this matter he probably will be on the warpath before too long to determine what official or faction in the White House or the State Department had the gall to steal his thunder by effecting an agreement with Greece before he did.

Apparently, in this instance, McCarthy's venture into diplomacy did no harm; but in another instance, under other circumstances, such a venture could be detrimental to the welfare of the nation.

The Reflector would much prefer that Senator McCarthy spend his time working on the problems of the Senate—too many of which now are not being solved—and leave diplomacy to the White House and the State Department until such time as the Senate is called on for help.

One would think, by Wall Street's reaction, that even the merest glimmer of hope for truce in Korea was bad news. Yet, all of us know it ain't so; just as we are con-

National Whirligig

WASHINGTON—Ambassador Charles E. Bohlen's first major mission to Moscow will be to try to arrange for the most important and fateful meeting of world statesmen since Potsdam, where the cold war involving the West and East really began.

He will seek to lay the groundwork for a conference of President Eisenhower, Prime Minister Churchill and Premier Malenkov, or their plenipotentiary delegates. Even if his preliminary movement should fail, the mere effort would clarify the murky international atmosphere. He can make no definitive plans in the domestic or foreign field without more information on the new Russian enigma.

Bohlen's task will be to ascertain whether Malenkov's recent professions of peaceful intent were sincere, or whether they were delivered only for home consumption in a shaky, restless, post-Stalin empire.

Even the latter discovery, however, the Russian-speaking American diplomat is peculiarly equipped to penetrate the sullen, devious, Muscovite psychology, would help to satisfy the doubts, the suspicions and the hopes of the Western world.

DELICATE PROBLEMS—The personal presence of Bohlen at Moscow in order to execute this assignment lay behind Eisenhower-Dulles impatience over the needless delay in Senate confirmation of his nomination. Were it not for Stalin's death and the Malenkov succession, the most important event behind the "iron curtain" since the passing of Lenin, there would be little need for a U. S. Ambassador to the Kremlin.

Such a high-level conference, however, cannot be arranged through the medium of note-writing or even transatlantic telephone talks. The various problems—the place of meeting, the protocol arrangements, agreement on an agenda—are far too delicate for distant negotiations.

MALENKOV'S POSITION—Each nation's prestige at home and abroad, as well as its future diplomatic tactics, are deeply involved. Malenkov cannot afford to show weakness lest he place his supremacy in jeopardy. Knowing the Communists' bloody record of intrigue, purges and rivalry, he cannot feel too solidly enthroned.

If Eisenhower appears too anxious, he could nullify the none-too-successful effort to build a European Defense Community. It could weaken domestic and Congressional support of huge military appropriations for Europe, Korea, Indo-China, etc. The faint prospects of long-deferred peace could make faint hearts of all.

In short, Bohlen can discover whether there is any sense in such a diplomatic showdown, on what basis the Kremlin will settle, and whether these terms can be reconciled to the West's honor and security needs.

Eisenhower is hopeful, but skeptical. However, recent dispatches from 10 Downing Street indicate that the normally pessimistic Churchill is more sanguine. These are regarded as especially significant because they were sent after the Prime Minister's talks with Marshal Tito, the Yugoslavian Communist.

WILSON'S DUAL PERSONALITY—Motor Charley? Wilson's more precise title should be Secretary of Military Production rather than Secretary of Defense. The duality of his character and personality intrigues and amuses Pentagon officers.

When Wilson discusses strictly professional military questions with his staff, he has hardly a word to say. Sensing that he is over his head in strange waters, he listens silently to their analysis of war needs, supplies, organization, strategy, possibilities. He is then a pupil.

But when they take up industrial production, expansion, costs and schedules, he becomes a different man. Then he exhibits his executive ability, his broad grasp of the subject and his intimate knowledge of details, based on dealing with thousands of General Motors suppliers and subcontractors.

He also becomes a very personality. Normally reticent, almost shy, he sparkles, dominates and educates. Since current and prospective production represents our greatest war-making asset, he seems to be the right man in the right place.

AN EXIT LONG OVERDUE (Henderson Dispatch)
 Agreement by President Eisenhower and congressional leaders to liquidate the Reconstruction Finance Corporation is a fitting move. Long ago it ceased to be an essential branch of the government. Its exit is long overdue. June 30, 1954, is the date set for the corporation to go out of business. The end of this calendar year could be a suitable time, but if fifteen months is required to close out its activities then it must remain that long. At least the agency is now definitely on the way to extinction.

The RFC was brought into existence during the last previous Republican administration. It was a device of the Hoover regime designed to rescue business from bankruptcy in early days of the depression, and in that capacity stepped into a wide breach in a great economic emergency. Twenty years of Democratic rule saw the agency supported and continued, with a lack of courage to abolish it when there was no longer any real reason for its continuance.

During nearly half of the period in which RFC functioned, credit was abundant and cheap from private sources. There was then no occasion for this competition from the government, but still it was carried on to occupy a field usually reserved for banks and other lending corporations, able and willing to make loans on a basis equal to that of this Federal bureau.

Now, after two decades, another Republican administration has come into power, and has recognized the desirability of liquidating this old lending concern. It can be dispensed with now without doing hurt to any legitimate activity, as it could have been years ago.

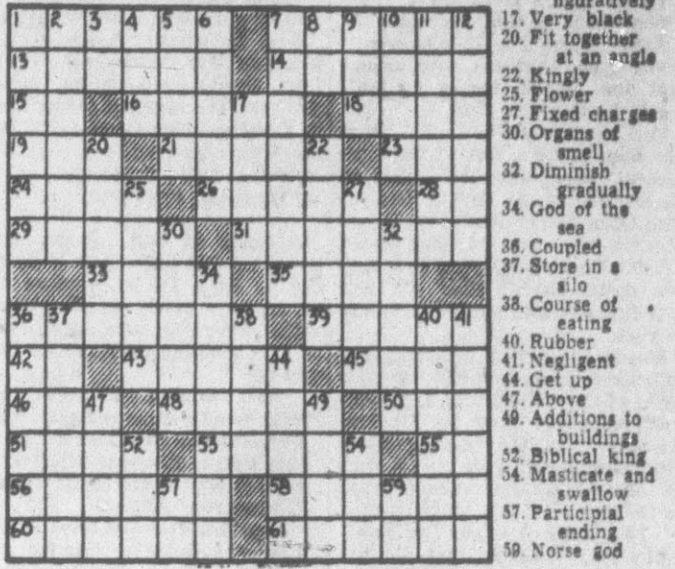

Sanderson And Cline Hit Homers For Bucs

Last 18 New Bedford Batters Retired In Outstanding Pitching Performances By Freshmen Ken Hall and Eugene Rose

The East Carolina College Pirates toyed with the New Bedford (Mass.) Textilers for three innings yesterday before turning on their power for a 13-3 victory over the touring New Englanders. The victory was the third straight for the Pirates and the second over the Textilers.

The Textilers, shutout 7-0 on a one-hit pitching job by three East Carolina pitchers Monday, took immediate steps to make sure that the same situation didn't occur a second time and almost knocked the Pirates off their perch before the game was under way for any time at all.

A two-run single in the first inning and a singleton in the third gave the visitors a 3-0 lead before the Pirates could wake up their sluggish batting power. After the wakening was completed, however, the Textilers had had it—both at the bat and in the field.

Almost lost in the avalanche of runs scored by the Pirates was a bit of outstanding pitching turned in by a pair of freshmen pitchers, Ken Hall, the second of three East Carolina pitchers, got off to a rocky start by giving up a pair of walks to the first two men he faced but he settled down immediately thereafter and retired nine men in a row.

Eugene Rose, Hall's successor, retired the last nine men in order. At no time when either of the two was on the mound did the Textilers threaten to get a hit.

While the New Englanders were searching in their bag of tricks for a base knock, the Pirates were going to work with a vengeance that they had not displayed prior to the game. They struck for two runs in the third inning, three in the fourth, two more in the sixth, two in the seventh, and four big ones in the eighth.

Sanderson Homers
The two runs in the third inning came on a long-distance homer hit by W. C. Sanderson that rolled for an inside-the-park homer. Major Hooper was on base by virtue of a single at the time the blow was struck.

The fourth inning runs were the clincher for the Pirates and came about through the inadvertent generosity of the New Bedford team. Pitcher Dick Bachand struck out the first man to face him in the frame but then his teammates started getting a little careless.

Catcher Babe Poitras started the merry-go-round, by throwing wild to first base on a dribbler by Billy Hardison and letting Hardison reach base safely. Gaither Cline interrupted the circus for a moment to rifle a legitimate single into right field but Hardison got to come home a moment later when Charlie Cherry grounded out to the second baseman. W. C. Sanderson drove home the second run when he reached first on first baseman Dick Chapman's error and Sanderson himself scored a moment later when Paul Gay banged out a three-base hit that skipped past leftfielder Jose Martinez.

Cline Homers
The sixth-inning runs were provided by Gaither Cline's big bat. The big outfield-third baseman home one of Bachand's pitches over the rightfield fence, some 310 feet from the plate. Cecil Heath was on base at the time.

A fielder's choice, a walk, a single, and some lackadaisical fielding accounted for the seventh, inning runs with Cecil Heath contributing the hit.

"It's the players, not the manager, who win pennants," he calmly observed. "And I think I have them, whether they are a year older or not."

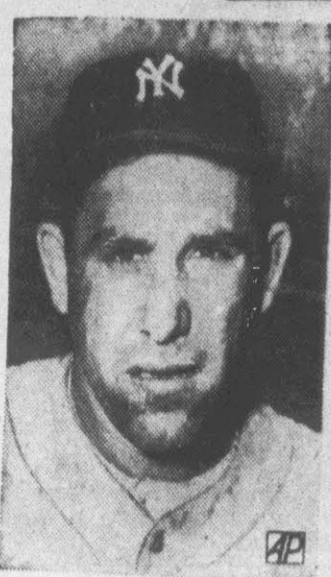

LOS ANGELES (UP)—Friends across the country carried the ball today for the late Jim Thorpe in trying to determine his final resting place, arrange funeral services and get two of his sons back from Korea in time for the services.

A family friend, C. E. Harrison, indicated services would be held here Monday or Tuesday in a cemetery chapel. Thorpe, 64, who died at nearby Lomita Saturday, will lie in state from Tuesday till the services.

Rosary will follow in a mortuary operated by David J. Mallory. Thorpe's friend for 25 years, but there was no decision as to where the legendary all-around athlete would be buried, Harrison said.

One of the big Indian's four sons, Richard, 18, arrived here from Navy duty at San Diego Tuesday, but Harrison feared two others in Korea—William, 23, and Phillip, 24—would not arrive in time. The fourth, Jackie, hadn't "been heard from." He was reported at an Oregon school.

Fine wired the proposal to the athlete's widow in California after attending a meeting of a citizens' group which told her in an accompanying telegram that Thorpe would receive a funeral merited by the "greatest athlete in the world."

Rose Bowl Pact Apparently Set

LAFAYETTE, Ind. (UP)—The Rose Bowl contract between the Big Ten and Pacific Coast Conference apparently was secure today for another four years.

The Purdue faculty Tuesday voted, 185-70, in favor of renewing the pact for another three years, extending to the game Jan. 1, 1957. The current contract calls for one more game next New Year's Day.

Shortly before the Purdue vote, it was announced that the Iowa faculty, voting nearly a month ago, had favored renewal of the agreement also.

Purdue was believed to be the sixth school in the conference to vote in favor of renewal. Earlier, Illinois and Ohio State announced they would vote for continuation of the pact.

Michigan and Indiana, though they have made no announcement of their vote, were regarded as certain to favor another renewal. Both voted for the agreement when it was first made Sept. 1, 1946, and again when it was renewed for three years on May 25, 1951.

SAN FRANCISCO (UP)—Ezzard Charles, the veteran former world heavyweight champion, enters the ring tonight a 2-1 choice to whip stocky young Rex Layne in their elimination television go before a sell-out crowd of 7,200 at Winterland.

Impressed by Charles' aggressive manner in his workouts, the railbirds think the Cincinnati Negro will win the rubber match of his series with the lad from Utah. In previous encounters, Charles won the first on a knockout in the 11th round; and Layne took the second via the decision route.

The winner has been promised a shot at Rocky Marciano's world crown—if Rocky is successful in defending it against the onslaught of the ancient Joe Walcott in their title scramble in Chicago April 11.

Both managers have predicted knockouts for their battlers. If the bout should go the route, it is believed that Charles would be the winner. He is considered a much superior boxer to Layne.

RALEIGH (UP) — The House Committee on Cities and Towns postponed action again today on a controversial statewide liquor referendum bill, but will consider it again next Wednesday.

The vote to postpone action came on a motion by Rep. Larry Moore of Wilson County, offered as a substitute for a motion by Rep. Joseph M. Hunt Jr. of Guilford to postpone consideration "indefinitely."

Committee Chairman Carroll R. Holmes of Perquimans reached the bill with the comment: "Gentlemen, we have here House Bill 454, for whatever action you wish to take."

Holmes had promised to bring up the liquor referendum measure for action today.

Hunt said, "I move we hold that bill for further study."

"Any definite time, or indefinitely," Holmes asked.

"Indefinite," said Hunt.

Rep. Joseph Warren of Caswell said, "I think it is only fair to have this committee vote on this."

To the chairman, Warren said, "I know I helped you carry armloads of telegrams that you received about this." However, Warren did not offer a substitute motion.

Moore then offered the motion to postpone a vote until next Wednesday.

The referendum measure, probably the most explosive of the current session, would call a statewide vote on an "all or nothing" state liquor policy.

If the state should vote dry, sales of liquor, beer and wine would be prohibited in all 100 counties. Otherwise, liquor, beer and wine sales would be legal in all counties of the state. North Carolina now has the local option system.

Secret Testing Of Rocket Plane

MUROC, Calif. (UP)—Government aviation experts are conducting top secret test flights with the Bell X-1A, the Air Force's new super-sonic rocket plane believed capable of streaking 1,700 miles an hour, it was reported.

The X-1A was reported to be undergoing initial flight tests at Edwards Air Force Base to accomplish what the X-1 could not do.

The X-1 was originally designed to hit 1,700 miles an hour at 80,000 feet but failed to reach that speed mark because it was necessary to use nitrogen pressure for fuel feed instead of a turbine pump.

It was reported that the X-1A can gain the needed speed by using a turbine fuel pump which provides for prolonged acceleration and consequently more speed. It reportedly can operate all four rocket tubes to full blast for 4.2 minutes. The X-1 could use its tubes only 2.5 minutes.

The present world speed record for planes is 1,238 mph, attained by test pilot Bill Bridgeman in the Douglas Skyrocket.

Bootlegger 'On Relief' Is Given Road Sentence

John (Jack) Brown, who has been receiving assistance from the County Welfare Department, elicited the sympathy of Judge Dink James in "Cit County Recorder's Court Tuesday—and a sentence on the roads for possession of non-tax paid whiskey.

County ABC officers testified that they found a lot of moonshine whiskey in a closet at Brown's home. Brown told the court "some fellow brought the liquor here and I don't know his name."

Judge James said, "I'd like to catch that fellow, because he is the same fellow who has been putting whiskey off on people around here for a long time."

"Ninety days on the roads," the judge pronounced.

"Brown, you don't seem to be doing very well on the welfare department's relief. I think it will be better if you spend some time on a prison road gang. There, you will get three meals a day, a good place to sleep, a doctor to look after your health and a lot of other comforts not provided by the Welfare Department."

"It appears to me," Judge James said in conclusion, "that being on relief is too strenuous for you and I'm going to let you try the prison camp for a while."

Brief Court Hearing Is Given Accused Slayer

LONDON (AP)—An owl-eyed clerk charged with murdering his wife and under questioning about the sex-thrill strangling of at least five other women appeared briefly in a crowded court today. He was ordered jailed for another week.

Gaunt, 55-year-old John R. H. Christie seemed nonchalant, even bored, with the eight-minute proceedings in the London magistrates' court. He made no statement.

The prisoner was guarded heavily by police and detectives. Outside the court, a crowd strained against police lines or queued for the few available public seats in the courtroom.

Housewives carrying shopping bags and holding onto children looked for better views. There was a mad rush for seats when the courtroom doors opened.

Christie stepped briskly into the dock when his name and case, No. 7, were called. He wore a gray tweed suit and horn-rimmed spectacles.

Judge Clyde Wilson granted Scotland Yard's request that Christie be "remanded"—held over—for another week. Detectives want more time to probe into his past and to grill him further about the mass "Murder House" slayings in London's drab Notting Hill district.

Christie was captured yesterday after a seven-day nationwide manhunt—Britain's most intense since the days of Jack the Ripper. He was charged formally with the slaying of his wife, Ethel.

Police said today that he had made a statement after his detention but its contents were not disclosed.

The body of Mrs. Christie, 54, was one of six female corpses so far found buried or walled up in the macabre house of murder in the drab Notting Hill district where Christie had lived since 1935. Police believe additional bones found in the garden may belong to a seventh victim.

Two of the dead women apparently met their fate as long as three years ago. Aside from Mrs. Christie only three—all known as zood-time girls in cheap haunts of the neighborhood—have been identified.

Over Four Years Passed Before Case Wound Up

WASHINGTON (UP) — Four years and two months elapsed in the slow-motion progress of influence peddler E. Meri Young from the White House executive office lobby to the end of his trial here in U. S. District Court.

Young was convicted Tuesday on four charges of perjury. He is to be sentenced April 30, barring an appeal. Unknown to him, events began closing in on Young in the winter of 1949 when Sen. J. William Fulbright, an Arkansas Democrat decided there was something smelly in the Reconstruction Finance Corp.

Fulbright obtained Senate authority to investigate, but kept proceedings under tight cover. As the investigation progressed, Fulbright discovered what he regarded as influence peddling irregularities—not much in direct violation of law, but plenty of evidence of favors given and received.

For some months Fulbright had been urging President Truman privately to shake up the RFC. The Senate was refusing to confirm the President's nominations of new directors. Fulbright and others wanted a one-man clean-up administrator on the job.

On Feb. 2, 1951, Fulbright fired directly at the White House. His subcommittee made a public report charging that political pressure and personal favoritism had influenced RFC loans. It named names. Among those accused of influencing RFC transactions were Democratic National Committee Chairman William M. Boyle Jr., presidential assistant Donald S. Dawson, and Young, all with White House connections.

Mrs. Young was a White House stenographer, envied and gossiped about by other White House women employes because she had a mink coat. Mrs. Young's became known as "mink coat No. 1" in ensuing congressional hearings. It developed that other wives had received them.

Young had various jobs, beginning with \$1,000 a year as a government messenger up to an estimated \$60,000 annually in 1950 as a loan expediter for RFC clients. White House intimates recall that Young often patrolled the lobby of the executive offices—a good place to be seen.

Dawson and Boyle denied all wrong doing. So did Young, but he got mixed up on his finances when under oath. Dawson remained at the White House but disappeared from the news after the RFC hearings. Boyle resigned the Democratic chairmanship after testifying before the Senate committee. He said he quit because of his health.

Allies Consider Warning Reds

WASHINGTON (UP)—The United Nations may link any Korean armistice with a flat warning to the Reds that a major violation of peace terms or sudden aggression elsewhere could prompt stiff Allied retaliation, informed sources reported today.

Official hints that the Allies were considering such a warning reflected the skepticism and uncertainty here regarding the motives behind the Communists' apparent interest in a Korean truce.

Authorities at the same time rejected any idea that the Allies would "retreat" from their long-standing decision against forcibly repatriating any Red prisoners who do not wish to go home. They said any armistice would have to recognize that basic principle. Allied prison camps hold 40,000 or more prisoners who have opposed repatriation.

Experts on East-West relations were cautiously optimistic that the Reds would be willing to write an honorable armistice. But they seriously doubted their recent conciliatory moves were prompted by "any real love of peace." These officials said the free world must keep its eyes open for:

1. A Communist ruse to get Allied troops out of Korea before striking again, or to transfer aggression to Indo-China, Formosa, Iran, Germany or other Communist targets. Concern over these possibilities explains the increased sentiment for a warning in advance that the Allies are alert for trickery. President Eisenhower and French Premier Rene Mayer issued a preliminary warning of this sort to Red China at the conclusion of their cold war strategy talks here last week.

2. Soft sounding Communists talk—not supported by acts—that would build pressure for defense cuts in this country and other non-Communist nations foreign aid reductions, delays in German rearmament and a new "get the boys home" movement.
