Morse Talks For 22 Hours

By WILLIAM BATES United Press Staff Correspondent WASHINGTON (UP)—Sen. Wayne Morse broke all records for Senate oratory today with a 22-hour, 26-minute speech against the tidelands oil bill which lacked just an hour and 34 minutes of running around the clock.

Despite obvious fatigue, leg cramps, and a tendency to stumble over words occasionally, he appeared fit at the end of his record-breaking. He sat down, shook hands with a few senators who walked to his desk, and a few minutes later strode jauntily from the chamber.

Other senators took turns going home to sleep or catching naps in the cloakroom; sometimes there were only a couple of them on the floor. But all through the day all through the night, and on into the sunny new day, Morse stood at his desk talking, talking, talking.

Worthington Reviews Impending Bills He Opposes

Legislature On 'Last Legs'

By JESS POINDEXTER Reflector City Editor The 1953 General Assembly of North Carolina is on its last legs. After a legislative session fraught with marked controversies and varied accomplishments, the current complement of Tar Heel lawmakers is expected to close out official State business and return to their homes the last of next week.

Prediction of adjournment "by next Thursday or Friday" was made here this morning by Sam O. Worthington of Greenville, Pitt County's senior representative to the State legislature. He said that next week's deliberations definitely should close out the session.

According to Worthington, two of the impending measures which have not received final action—he is opposed to both bills—are re-districting of judicial districts and setting up a State Milk Commission. He charged initiators of both measures with "group favoritism."

Analyst Says Good Year For Business Is Indicated

William H. Neal, senior vice-president of Wachovia Bank and Trust Company of Winston-Salem, discussed business conditions in the United States at the annual Chamber of Commerce meeting here last night.

Neal, in his analysis of current business conditions in the country, pointed out the first quarter of 1953 has surpassed the business of the first quarter of last year, and indications are this year will be equally good as the 1952 peak in business activity throughout the nation.

Neal said the 11 per cent reduction in farm prices last year could have its effect upon the buying power of farm families which make up a large part of the nation's consumers. He also declared the nation is in "no position to take the whole world on its shoulders," and said money loaned other countries for export of American goods is likely to be curtailed.

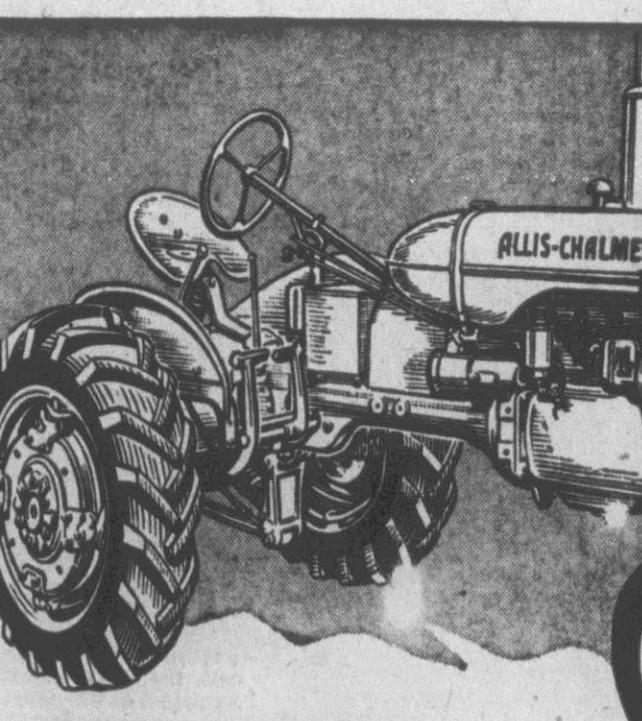

I believe that the City Manager form of government has proved very satisfactory in other cities, and that it will prove efficient and economical in Greenville. I think that the new city council should make every effort to secure the best possible man for Greenville, pay him a salary sufficient to keep him, and cooperate with him in every way in an effort to really give this form of government a fair chance.

UTILITIES

I do not believe that the City Manager form of government will prove satisfactory unless the Greenville Utilities are placed under the control of the city manager. Since utilities is the largest single department of the municipal government I feel that the greatest savings to the people of Greenville can be effected by the City Manager form of government in this department. The Greenville Utilities Commission, unique in form, a self governing unit set up by the legislative act, does not, I feel, serve the best interests of the people of Greenville.

INDUSTRY

If elected I pledge every effort possible to get more enterprises and industries for Greenville. I believe that with the proper inducement, some of the industry being established in our neighboring towns can be brought to Greenville. For years we have all realized that Greenville needs regular payrolls. So many of our workers have employment for just a few months or weeks, and spend the rest of the year seeking odd jobs, or drawing unemployment checks. In years of poor crops this lack of employment is felt acutely by all Greenville. Many Greenville people drive to neighboring towns and military installations to work each day. I would like to see people coming to Greenville to work and to live.

RECREATION

The Greenville Recreation Commission, and the director and his assistants, have done a wonderful job with very limited means. However I feel that the opportunities for recreation for children and adults in Greenville are not adequate for a city of this size. Our swimming pool continues to collect leaves and trash, our recreation building is held up for lack of funds. A large part of the recreation facilities in Greenville have been financed by private contributors, and the civic clubs of the city. I believe that Greenville citizens are entitled to better recreational facilities and that such facilities can be provided with an efficient City-Manager form of government.

fact Greenville has no swimming pool, and affords no safe place nearby for the youngsters to enjoy a refreshing dip. Such thoughts also bring to mind the lure of the treacherous Tar River and memories of countless bodies which have been dragged from beneath its muddy surface.

Some of the bodies were adults; some were children. Most of them have been of people who went to the river for a dip and were betrayed by the unpredictable waters.

Will there be more bodies pulled from the river as these warm days give way to a truly hot Pitt County summer? Surely we hope not, but one never knows.

The first really warm days are the ones which tempt youngsters most strenuously to steal away for a swim in a body of water. The temptation continues so long as the hot days are here, but after the initial consciousness of hot weather, together with the realization there is no adequate safe place to swim, the temptation loses some of its pull.

In view of these circumstances which now exist in Greenville — with the weather getting warm again and still no pool for the youngsters to use — it behooves the parents of the community to impress upon their children once more the dangers which lurk in the river; the great price one may be called upon to pay for a few minutes in the cooling water.

The community certainly can ill afford to have any of its youngsters fall victim to the waters of the Tar River. The best way to be sure none do, is to have reasonable assurance that none will be swimming or playing in the river.

National Whirligig

WASHINGTON—Is it true," inquires S. E. of Brooklyn, N. Y., "that the Eisenhower Administration has established a blackout on news at Washington? I thought the Republicans had promised to do away with secrecy in the conduct of national and international affairs. After all, their business is our business."

Although this subject might be considered as shop talk, and a matter of principal concern to news-gatherers and their editors, I am willing to take a whirl at it. I may premise my comment with the statement that it will probably be unpopular among my newspaper colleagues at Washington.

There has been a certain clamor on news, but for what seems to me as understandable reasons. The new Administration faces many difficult problems, national and international, which cannot be solved overnight. Naturally, premature revelations prejudice a solution.

IMPATIENT OF PREMATURE NEWS—The businessmen in top positions are not accustomed to announcing unfinished or half-baked plans. They remind me of a talk I once had on this question with Herbert Hoover, whose background as an engineer resembles that of the Humphrey-Wilson group. Hoover could not understand why we insisted on day-by-day accounts of planning and policy-making.

"As an engineer," he said, "I wouldn't think of calling in the press when I had a bridge only half finished or a mine half dug. Why can't you wait till the end of the job?"

Similarly, Wilson, Humphrey and their business associates think there is no news when an automobile or some other product is only half finished. They want us to wait till the job is done. They are impatient of premature news. They ask us to be more patient.

DIGGING FOR NEWS—There is no news secrecy problem, however, which hard, old-fashioned digging for facts cannot remedy. It is not necessary to wait around for an official announcement to ascertain the general direction and purpose of Eisenhower's policies. This is particularly true because so many changes can be effected by administrative decisions as well as by legislation.

By studying and analyzing the men like names to key positions in the executive branch, and by keeping a close watch on their statements and orders, it is possible to keep the public informed on what they may expect from Washington.

Finally, so long as Congress continues in its present investigative mood, there will be few secrets at the Capital.

MOVEMENT TO DISCREDIT MARSHALL—"Do I detect," asks M. F. of Leesburg, Va., "a general movement to discredit General Marshall? I have been reading quite a bit of criticism of him lately."

Answer: There has been no attempt to depreciate his achievements as Chief of Staff during World War II. But, as I recently noted, Truman's awe and admiration of the Leesburg military hero led to assignment of Marshall to tasks for which he was entirely unfit and unqualified.

Marshall knew nothing of foreign affairs and the interplay of nonmilitary forces when he was named as Special Ambassador to China and as Secretary of State. He had to take the advice of "experts" foisted on him, and their advice was invariably bad. The same applies to his decision that the Korean War would last only twelve months, which is largely responsible for current ammunition shortages.

CONGRESSMEN'S MAIL—"Are letters to members of Congress effective?" inquires Mrs. E.H.T. of Springfield, Mass. "Are they read?"

Answer: It depends on the individual member, and also the letter writer. A canny and responsible Congressman reads his mail carefully, or has it briefed for him, if it is a sensible and sincere communication. It is an excellent way of keeping in touch with constituents' sentiments and reaction. If he doesn't read intelligent mail, or even unintelligent letters, he is inviting defeat.

Selected Shorts

PERRIS, CALIF. PROGRESS: "In the strike of electrical workers against the Southern California Edison Company, the firm's president, W. C. Mullendore, vigorously exercised his Constitutional right of freedom of speech by presenting the company's side of the controversy. . . . For exercising the right of free speech, however, charges of unfair labor practices have been filed with the National Labor Relations Board against the Edison Company by the electrical workers' union. . . . Labor, no less than management, should recognize that for this Nation to remain free, Constitutional rights cannot be denied groups or individuals."

ROSEBURG, OREGON, EWS-REVIEW: "The free world can be lulled into acceptance of Russian declarations of peaceful intent, the Reds will gain time to adjust their internal position. Freed from external pressures they can devote full attention to establishing stronger holds over the Soviet sphere of influence, tightening controls, and building up aggressive strength. Naturally, we must show an interest in any peace overtures. . . . But, from the lessons of the past, we should remain fully aware of the real purpose behind Red declarations. We should intensify, rather than relax, our pressures."

Somebody Told Me

When I heard that one of Greenville's Negro doctors, Dr. H. B. Kelly, had been called into military service I wondered who would take his place. When somebody told me . . . that his sister would take over I figured that it was time to write a column about the Kellys.

Dr. V. Cecil, who is taking over H. B.'s practice, is just one link in the amazing Kelly family, originally from Georgetown, S. C. There is still another doctor, G. E. who practices in Conway, S. C. There are four other Kelly children, all of whom have college degrees. Two are teaching, one is a nurse, and the other is a contractor.

At the time H. B. was called into service (he has held a reserve commission for some years) Cecil was in Washington at Freedmen's Hospital specializing in pediatrics.

When she knew that H. B. needed someone to take over, she interrupted her training.

"When H. B. comes back," she says, "I plan to continue to specialize." In the meantime, she will doubtless get plenty of pediatric experience in Greenville that will help her in later training.

"What did H. B.'s patients think when they found out that the new Dr. Kelly would be female?" I asked Dr. Cecil Kelly.

"They were very receptive," she answered, "because most of them had been told the situation."

In addition to having the distinction of being a woman general practitioner, Dr. Kelly is quite distinctive in that she is only 26 years old. Furthermore, she finished medical school at the amazing age of 22. Afterwards, she interned for one year and has

been training in pediatrics for three years.

"How did you finish so soon?" I asked.

"Well," she said modestly, "I suppose I just started school early."

When I talked to Dr. Kelly last night she was in her second week of the task of taking over her brother's practice. She seemed quite wrapped up in the job already. "What are you doing about night calls?" I asked.

"Well," she confessed, "as yet I don't know the town too well, but I'll certainly do the best I can." You can't beat that attitude, which is no doubt what put the Kelly children where they are today. Seven children, three doctors, and all seven with college degrees is a record hard to beat!

And I thank you.

Around Capitol Square

By LYNN NISBET

POLITICAL—The . . . in next year's Democratic primary will be for the seat in the United States Senate now occupied by Senator Willis Smith. Unless there are vacancies caused by death or resignation the only other statewide nominations to be made will be for the Supreme Court places now held by Associate Justices Maurice V. Barnhill and Wallace Winborne. Only twice in the memory of most current voters has a "supreme court race" occurred.

Those races were in 1930 when a second primary was necessary to name Walter P. Stacy and in 1932 when a run-off resulted in nominating Hunt Parker.

SENATE—Ever since the 1950 primary in which Willis Smith ousted Scott-appointed Frank Graham from the Senate, Kerr Scott has been generally rated as the most likely prospective candidate against Smith for the full term beginning in January, 1955. Other potentials in that race are L. Y. (Stag) Ballentine, commissioner of agriculture and former lieutenant governor, and Harold Cooley, Congressman from the fourth district. Ballentine is a long-odds bet, but Cooley is a very likely candidate. He is almost a sure bet if by end of this year it looks like the Republicans will retain control of the Congress. If chances for Democratic control are good and Cooley seems fairly certain to get back his position as chairman of the agriculture committee, his entry in the Senate race is doubtful.

GOVERNOR—Political strategists look farther ahead than one year, so there is already considerable speculation about the contest for Governor in 1956. There are those among the in-

formed politicians who believe that former Governor Kerr Scott would rather come back to the mansion on Blount Street and the office in the southwest corner of the State Capitol than go to the United States Senate under a Republican regime. The Haw River farmer delights in breaking precedent and doing the unexpected. This corner rates him a more likely candidate for Governor in 1956 than for Senator in 1954.

WARREN—No speculation about prospective candidacies for Senator or Governor would be complete without mention of Lindsay Warren. His tenure as head of the general accounting office of the Federal government expires in 1955. It is of common knowledge that he toyed with the idea of running for Governor in 1948. During the past few weeks public speeches and his written letters to newspaper public forums. He was the featured speaker at the 1953 meeting of North Carolina Citizens Association last month and received the Distinguished Citizenship Award given by that group each year. Long time congressman from the first district before being named to his present non-fireable position in which he has saved the country many millions of dollars from virtual seclusion gives rise to rumor that he may be interested in further elective office.

BIG LIST—Prospective candidates for the Senate next year are few, but the prospective list for Governor in 1956 is rather long. Besides former Governor Scott it includes Lieutenant Governor Luther Hodges of Spray, State Senators Edwin Pate of Laurinburg and Gray Rankin of Gastonia and half a dozen other hopefuls. Gossip around capital square

has it that Hodges, Pate and Rankin are all running for the State's top office as hard as they can, consistent with their duties in the offices they now occupy.

DARK HORSES—Despite the recognized ambitions of these gentlemen there is rather general belief that one or more dark horses may get into the senatorial race next year, and that the next Governor may be somebody whose name has not heretofore been mentioned as a possibility. The record of campaigns during the past decade or more would seem to justify the prediction that neither of the top offices will go by default or that anybody will win them without opposition.

SECTIONAL—The east-west rivalry was injected in debate on the question of submitting the \$14 1/2 million "catch all" bond issue to vote of the people, along with the mental hospital and school aid bonds. The allocation formula would give East Carolina the lion's share. "All that if the bonds are issued," said Hugh Horton, speaker against Sen. Pou Bailey's amendment calling for the election, said the college Greenville is "all that Eastern North Carolina has left of state institutions; all the rest are in the west."

Horton said most of the folks are in the west and he does not want to trust his little institution to them. Buy consistently refusing to obey the constitution on restricting the General Assembly has kept a majority of its own votes in the East.

DIVISION—The age-old question of where the dividing line should be drawn bobs up again. However, the people at Elizabeth City and Fayetteville, where there

MAINTAINING DEFENSES (New Bern Sun-Journal)

The peace offensive of the Russians has been raging for some weeks now, and top American leaders are showing a healthy skepticism about it. This attitude contradicts plainly any notion that we have learned nothing from our painful dealings with the Kremlin.

President Eisenhower, Senator Taft and Senator Wiley all have publicly declared that the West dare not be lulled into lowering its guard. They show no disposition to favor more than fat-

trimming reductions in defense spending unless and until the Soviet Union puts far more on the line than it has so far in its peace moves. Our statesmen, and others in the West, too, recognize that "peace" is just another kind of combat to the Russians.

Besides believing that the new Malenkov regime may need a breather for internal purposes, western leaders feel the Kremlin may be trying to slow us down defense-wise while the Communists build up their power. This could hold for the immediate battlefield situation in Korea and Indo-China, and it could hold as

well for such things as augmenting the Russians' stockpile of atomic bombs.

It does not really matter what specific combination of purposes Moscow has, the important thing is that we do not accept their smiling overtures at face value; that we insist on maintaining our defense program and the vital machinery of the NATO and other international arrangements. The danger of weakening on this front however, is not yet at its peak. Peace maneuvers find many average citizens, especially among the nations of western Europe, all too ready to buy the whole package.

Perhaps some young Field of Kinsey could win his doctorate by probing the strata of inferiority in manufacturers' minds. If so, he is welcome to look at our files.

Hal Boyle's Column

WASHINGTON (AP)—A mild man relaxes when a belligerent man slaps picking of him for the same reason being hit on the head with a hammer feels so good when it stops.

This country and its allies in the North Atlantic Treaty Organization must decide soon whether, like the mild man, they will relax their defense plans now that the Russians are talking peace.

Sincere or not, the Kremlin's sudden mildness started about mid-March, which was just far enough ahead of some important Western decisions to have a maximum softening effect, if the West could be softened.

1. The NATO Council of Ministers, representing 14 countries, was to hold its 11th meeting in its four year history to lay plans for further military buildup in case of Russian attack. The meeting began in Paris Friday.

2. The Republicans are anxious to keep their campaign promise to cut government spending. The biggest cuts are expected in money for defense and foreign aid.

3. The French haven't yet approved the plan to let Western Europe an army that would include Germans. The French are unhappy and doubtful about the prospect of rearming any Germans, even Germans in the same army with the French.

The NATO Council is made up of the foreign, defense and finance ministers of the 14 member countries. The U.S. sent Secretaries Dulles (State), Wilson (defense), and Humphrey (Treasury) to the Paris meeting.

NATO's secretary general Lord Ismay, was asked by reporters last night if the Russian tactics had induced NATO to slacken defense preparations. He gave an emphatic "no."

The results of the three-day council meeting may show whether Ismay was a prophet. The talk, but it's the decisions they reach that will tell the tale.

When the council met 14 months ago in Lisbon it set a defense goal for 1952, 1953 and 1954. The 1952 goal has largely been met. Later, but before the Russian peace moves started, the Western Allies questioned whether they had over-reached themselves for 1953.

Originally the defense buildup was planned to be intense and quick. Now Dulles has said the U.S. would ask its allies to stretch out the program.

The ministers will decide whether they should go slower because (A) of their own financial condition or (B) the Russians suddenly seem less dangerous.

Meanwhile it was learned here this week the Eisenhower administration hoped to cut perhaps two billion dollars off the \$7,600,000,000 President Truman asked Congress to approve for foreign aid in the year starting July 1.

Some Eisenhower planners think this might be done safely because there is a backlog of about 10 billions for weapons, appropriated under Truman but not yet spent or obligated.

At the same time the administration is looking for ways to reduce military spending on this country's own armed forces. President Eisenhower said he himself will make the final decision on how much the cut should be.

What he decides might mean the difference between victory and defeat if the Russians once more

reversed themselves and attacked here or elsewhere.

His advisers may not have been influenced in the cuts that he's trying to make by the emergence of a Russian which talks of wanting peace, not war. But if the Russians had been acting tougher there probably would be no cuts.

WASHINGTON—Grace Arnock, Scottish-born researcher with the British Food Ministry, is here to make a study of food habits of the average American family.

So far, she has noted we waste more food than the British, who are conditioned to rationing.

However, she says a national survey of the diet of British families to see what wastes that only in the case of one of two nutrients, such as iron and riboflavin, does the level fall slightly below ideal requirements.

Miss Arnock's study here with a group of home economists from eight countries is sponsored by the Mutual Security Administration.

"The difference between the diet of the wealthiest and the poorest is not as great as in the prewar days," she told me, "and everybody remarks how very pretty the babies are." This is due, Miss Arnock believes to results of the "welfare food scheme" for children and expectant mothers set up by an advisory council and administered by her ministry. This provides all children up to five with plenty of vitamin C at seven cents a bottle and free cod liver oil. Milk is available at low cost. Vitamin A and D tablets are provided free to expectant mothers.

Eggs, tea and chocolate were just recently taken off rationing, but expectant mothers always had additional rations. Meat now is rationed at 25 cents worth gets roughly about 25 cents worth per week. "Meat is much cheaper than here," Miss Arnock told me. "It ranges from 25 to 40 cents per pound for the best, only cooked ham is as high as a dollar."

At one time tea was rationed in the traditional tea-drinking nation to eight ounces per person every four weeks. Now you can buy as much as you want. The average Briton usually has tea four times a day," Miss Arnock said. The majority of workers, especially in the north, have fish tea when they come home from work, with a bit of meat, ham, egg or fish, which was never rationed. Very often with this they have potatoes or some other vegetable. Where families have high tea around six o'clock, they have a spot of tea, milk, or cocoa, with a sandwich, biscuit, or cake, before going to bed.

"I think I like all your food," Miss Arnock told me. "The thing that amazes me is the amount of paper you use — Dollies, napkins, food cartons, cups, plates. I'm surprised to see turkeys out of season and buttermilk on the market. In England you seldom buy it in the shops."

Miss Arnock, a pleasant, attractive young woman with a slight Scottish burr, was born on a farm at Hoddon, near Glasgow. She loves housekeeping, makes all her own clothes, collects ceramics and goes in for Scottish country dancing.

Is This Using State Money Wisely?

For years it has been said a sharp eye must be kept for questionable legislation which always manages to pop up — and sometimes receives favorable action — during the rushed days when the General Assembly is trying to adjourn.

An example of this sort of unwise legislation — which is not in the best interest of the state as a whole — in our opinion is the bill introduced to provide additional pay from state funds for individuals who served on a jury in Pitt County nine years ago.

Rep. Bascomb Sawyer of Pasquotank introduced the bill which would pay an extra \$2 per day from state funds for jurors who served on the 75-day Meadows trial in Pitt County in 1944.

When the trial was held nine years ago the jurors who sat on the case were paid \$3 per day which was the standard juror's pay then. Now Rep. Sawyer's bill asks that these jurors be paid by the state an additional \$2 for each day they served on that jury to make their pay match the present jury rate of pay of \$5 per day.

The bill first proposed that Pitt County pay the additional \$2 per day to the Pasquotank jurors who served on the Pitt trial. When objection was voiced to Pitt County's paying the additional funds, the bill was amended to have the money come from the contingency and emergency funds and was given a favorable report by Judiciary No. 2 committee.

Legislators up in Raleigh this session have been pulling their hair out over money matters, and striving to keep the state's spending within the means of a rather questionable revenue fund. Yet the committee gives a favorable report to this kind of bill to throw away some of the state's money to one of the Representative's constituents.

Comparatively speaking the bill will cost the state relatively little money. But nevertheless, a number of such bills could eat into the state's funds to an appreciable degree.

There may be a good reason for paying the jurors extra money for their services nine years ago, but so far we haven't been able to ascertain any good reason for the payment.

On the surface, at least the bill could easily be viewed as an instrument to help some member of the legislature play politics back in his home county . . . while the people of the state provide the money for it.

The Card-Cub and Red-Braves games were rained out in the National.

School Pupils Gathered Strawberries In Project

The boys of Brookgreen School gathered their first strawberries Thursday. Previously they had gathered a few here and there but they found a large number that had ripened.

Twenty boys of the Brookgreen School started the strawberry project last fall. It has been used in a study of arithmetic, science and reading. With the aid of the farm demonstration agent they found out how to prepare the soil and they did their own plowing. They studied the right type of fertilizer to use for that particular type of soil. Reading also taught them what type of strawberry to plant. The variety which they planted is the "Massey" and is a large, delicious, solid berry.

During the winter, the plants were protected by straw the boys placed around the plants.

Since this is the first year the plants will bear, they will not harvest many berries, but next year they are planning to harvest enough berries and sell them so that the original cost of the project will be paid for and money will be left over. The boys are keeping books on the project and an accurate account of all costs, including the labor. While they have done all the labor, as a matter of bookkeeping, they have charged on the books for their labor to see whether or not strawberries can be produced at a profit.

James A. Vinci, principal of Brookgreen School, is the advisor on this project and the boys who are carrying out the project are from grades four to eight, inclusive.
