Teams representing schools throughout the nation will debate on the query: "Resolved that the Atlantic Pact Nations should form a Federal Union."

Ginger Worthington will also take part in girl's extemp and radio announcing and Brooks will participate in original oratory and radio announcing.

Miss Worthington holds the Degree of Distinction with the Greenville NFL and has filed 406 points with the NFL headquarters. She has had two years of tournament debating experience and has won 18 interscholastic debates.

Greenville students have participated in national tourneys once before with Rodney Fulcher and Harvey Bradshaw as representatives of the school.

This year's trip to the national tourney is being made possible by several civic organizations of Greenville making cash contributions to provide transportation for the debaters.

## Queen Reviews Scarlet Troops

LONDON (UP) — Queen Elizabeth, poised and confident on horseback, reviewed the brilliant scarlet troops of the guard's brigade today on her "official" birthday.

Riding slowly from Buckingham Palace past shouting throngs, the queen saluted the carriage where her mother sat with Prince Charles and Princess Anne as she rode into the Horse Guards' parade ground.

She was dressed in the scarlet tunic of the guards, with a plumed hat. Elizabeth rode the police horse "Winston," one of the eight which had drawn her coronation carriage, and the Duke of Edinburgh followed on another magnificent chestnut mount which grew frisky as the trooping of the color began.

The banner today was that of the first battalion of the Grenadier Guard whose first company was created by King Charles II.

The ceremony of trooping goes back to the 18th Century when troops were paraded preparatory to guarding a person of royal blood and the flag was carried past the soldiers as visible symbol of their duty to the sovereign.

Today was Elizabeth's "official" birthday. Her actual birthday is April 21 but strict fact has been overlooked by Britain's sovereigns for many years so the trooping can be held in the best of weather. More than 30,000 persons packed stands along the Mall which had been built for the coronation.

Miss Barbara Jean Conway of Greenville, sister of the bride, was bridesmaid and wore a lavender gown of net designed the same as the gown of the matron of honor. She also carried a bouquet like that of the matron of honor.

## Sound Business Principles In Government

It can safely be said that sound business methods are being applied to Greenville's municipal government by the new city council in preparing the budget for the 1953-54 fiscal year.

From the activities at the city hall during recent weeks, it has been apparent that the new governing board of Greenville has dug deeply — and apparently thoroughly — into the financial affairs of the city in determining what should go into the new budget.

Those closely connected with the city's work will attest to the fact that the new council has been reluctant to move a peg on any matter until it has been ascertained whether the contemplated action is strictly legal. The questionable items have been left out of the new budget which is now in the process of being prepared.

A case in point in this field is the matter of donations to worthy causes which has been a policy of the governing board of the city for a number of years. The new council, Mayor W. L. Whedbee has announced, had the attorney general contacted for an opinion on the matter of donations, and as a result, no provisions for any donations from the city budget will be found in 1953-54 budget.

The numerous conferences held with officials from other cities in North Carolina, the bulk of data collected by visits to other cities certainly bespeak of far more than a surface treatment of the affairs of city government by the new council. In the month they have been in office, the new councilmen, under the leadership of the mayor, have dug into every nook and cranny of the city affairs.

Perhaps in so doing, they have made some mistakes. Perhaps in the future other mistakes will become evident. But so far, it certainly appears that no stone is being left unturned in their attempt to give Greenville the most efficient government possible.

# 'Favors' For Henry Kaiser

WASHINGTON—The first complete recital of Henry J. Kaiser's receipt of multimillion-dollar favors from American taxpayers is about to be presented on Capitol Hill, with John Wesley Snyder, Truman's personal confidant and former Secretary of the Treasury, appearing in the role of Henry J.'s fairy godfather.

Snyder is now vice-president of Willys-Overland Motors, Inc., at a reported salary of \$100,000 a year. The merger of non-profitable K-F automobile interests with the successful Willys-Overland firm was arranged only a few weeks before Snyder quit his Treasury job—at a loss of at least \$5,000,000 to the Treasury through a balancing of the combined losses and profits for tax purposes.

ODD DISCUSSION—Although Snyder denies that he had any part in this deal, he got his present job only nine days after the inauguration of President Eisenhower. In view of Snyder's disclaimer, investigators consider it odd that Harry A. McDonald, holder of the Reconstruction Finance Corporation, thought it advisable and necessary to discuss the merger's tax implications with Secretary George M. Humphrey, Snyder's successor.

Ironically, the key figure in this Kaiser-Snyder drama is Senator John J. Williams of Delaware, who single-handedly uncovered the appalling laxity and corruption in Snyder's Bureau of Internal Revenue. Williams met Truman-Snyder opposition then, and got no assistance from GOP colleagues. Now, however, the fantastic Kaiser story is breaking all over Capitol Hill.

A MYSTERIOUS CONTRACT—The Senate Armed Services Committee has been unable to learn why the Air Force contracted for Kaiser to manufacture C-119 planes at an estimated unit cost of \$467,000 when the Fairchild Aircraft Corporation produces them for \$280,000 each.

Williams believes that, next to F.D.R., Snyder was Kaiser's principal benefactor at Washington. As a former RFC director, Federal Loan Administrator, War Mobilizer and Secretary of the Treasury, the erstwhile St. Louis banker was the key policy-maker on loans.

SALE OF WILLOW RUN TO KAISER—After en-

terprises, and in discussions of the budget for the coming fiscal year, the new councilmen have literally spent many hours burning the midnight oil. The fruits of these and other efforts on behalf of the city of Greenville by its councilmen should appear not only in the budget for the new fiscal year, but also in the course of government in years to come.

The Greenville councilmen certainly are to be congratulated for their work during the first month of their two-year term in office. If the pace is continued, it can not help but be of great benefit to the city and its local government operations.

## Still A Big Gap In Our X-Ray Survey

According to last reports, fifteen people who presumably didn't know they were "dying on their feet" have been identified by means of the county's X-ray survey.

There is no way of estimating how many other people have been saved from a similar fate through the identification of tubercular victims who may have eventually passed on their disease to them.

Quite possibly still more cases of tuberculosis will be found, other conditions, too, before the work of the survey is completed.

For all of them, the chance of a longer life span is made possible. For many others, the likelihood of contracting tuberculosis has been immeasurably reduced; and for well over 20,000 other Pitt Counts there is assurance that for the present they need not be nagged by the haunting dread of not knowing whether they have fallen prey to TB.

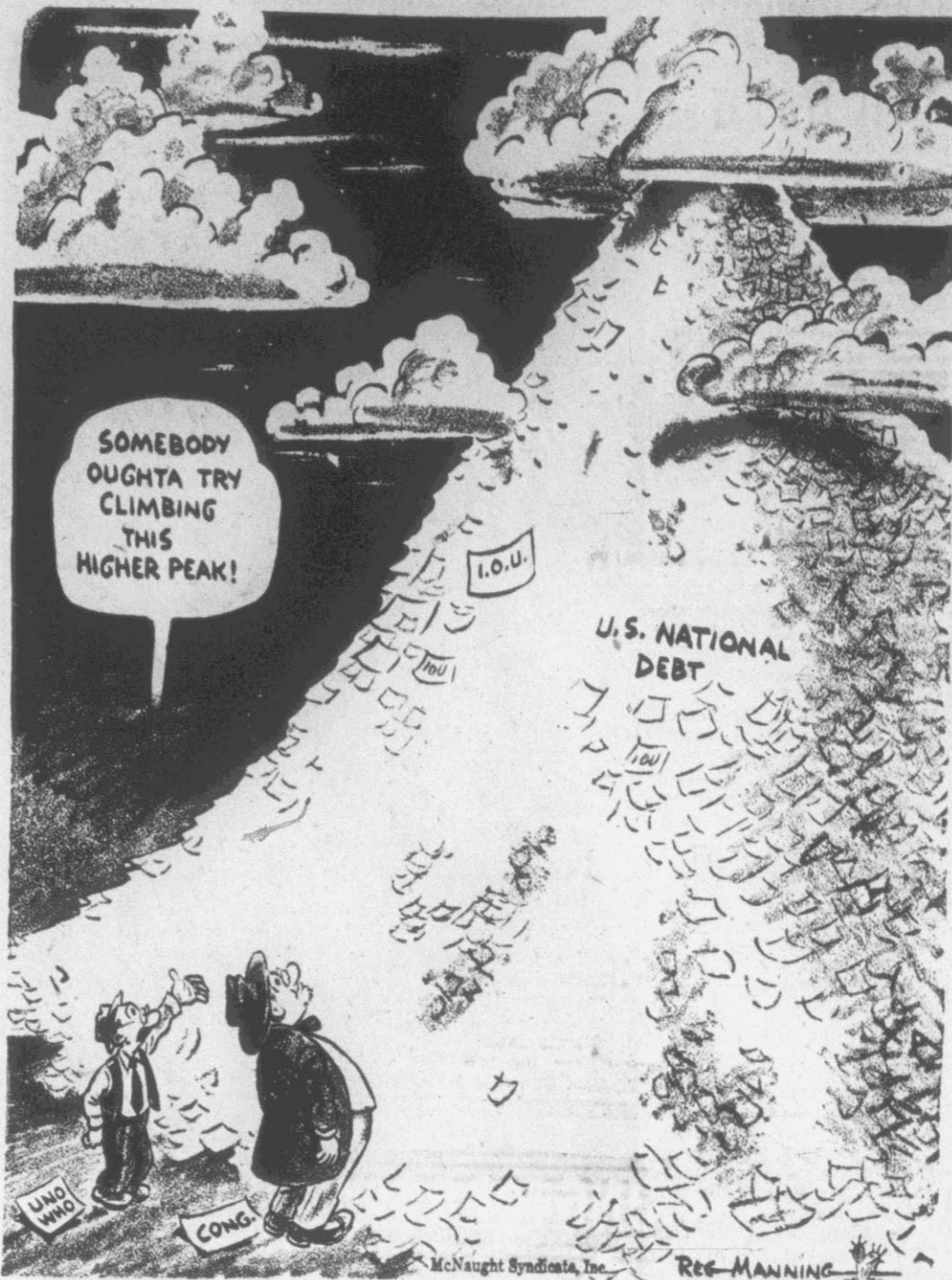
There is no guessing involved when the assumption is made that once the initial shock had passed, each of the newly-identified victims of "lung trouble" were thankful the condition was discovered. To be forewarned is to be forearmed, the saying goes, and the value of this warning far exceeds the cost of any x-ray survey for a county.

It should be a matter of deep concern to all Pitt citizens that a vast number of people will not take advantage of the free chest x-rays; particularly when it is feared that among the ranks of the absentees a greater rate of tubercular conditions exist.

The survey has already more than "paid its way" in serving thousands of our people, but there remain thousands more who will not take even this simple precaution of a free x-ray in safeguarding their own lives and the health of close associates. They may well be the people who most need this protection.

## Sleep Before Making A Decision

Many times you have heard people say "I'll sleep on that." Actually, how much good does it do? A trade publication called the Weatherlane gives an interesting report on the significance of sleeping a night before making a decision.

Perhaps you have had the experience of going to bed with your mind filled with an urgent problem and awoke up in the morning with a solution.

There is a psychological explanation of this phenomenon, which has been a matter of common knowledge for generations. The brain contains two chambers of intelligence: one is the conscious mind; the other is the subconscious mind.

The subconscious mind is a

warehouse where all experiences, ideas, facts and thoughts are stored for future use. In some people the contact between the conscious and subconscious mind is simple and direct. Such people are fortunate. They do not have to learn the same thing twice. They can profit by experience.

Others find this contact between the conscious and subconscious mind takes place most easily during hours of sleep.

George Eliot stated that in writing her novels she often encountered situations which she was absolutely unable to solve. She thought about them in the daytime and slept on them at night, until finally the solution came by a process which she could not explain.

Quite often I use this method in writing this column. Normally, it's written at night, but sometimes I decide to sleep on an idea. I would like for the experts to explain to me the result: Usually after having slept on an idea I change it and write about something else entirely.

The biggest advantage in sleeping on anything is that early in the morning the mind functions so much better than it does at night. Simple fatigue will keep you from thinking your best.

The mind is such an amazing chamber that it even works for you while you're asleep. But whether it's true or not, it's better to think that even the mind rests sometimes.

TITO IS USEFUL, BUT NOT AS PARTNER (Charlotte Observer)

The proposal of Turkey that Yugoslavia be integrated into the defense without becoming a member of NATO is a good one, because Tito can be useful to the West as long as his schism with Moscow continues.

It would not be safe, however, to make Yugoslavia a member of NATO, because we don't know when the Kremlin will make up with Tito. It can always reverse its policies at will, and all of the satellites must then fall in line. Tito is still a Communist. He

has made a few superficial concessions to popular government, but they are only superficial. He has not allowed any liberal leader to arise who could take over the government in the case of his death or removal from power.

These so-called reforms do not weaken in the least the hold that the Communist Party has on governmental affairs in the country. Hence, any successor that Tito might have would be a party man, and he might not be a believer in the kind of nationalist communism that Tito has promoted. He could very well be one who would

turn to a new alignment with Moscow and take with him all the aid we have given to Yugoslavia.

As long as Tito lives or holds to power, we can use him. About his possible successor we cannot be sure. But he has 300,000 well trained troops, which, with the Greek and Turkish armies under the military understanding among the three countries, will make a formidable force on Russia's exposed southern flank.

We could, therefore, integrate Yugoslavia into western defense, but we could not admit her to full partnership.

# Anticipated Court Appointments By The Governor

JUDGES — In addition to the twelve Superior Court special judges authorized by the recent Legislature, Governor Umstead quite likely will have the responsibility of naming at least three members of the Supreme Court and four or five regular Superior Court judges within the next two years. The anticipated vacancies will be occasioned by retirement of incumbents, under provisions of the statutes which affords two-thirds regular salary—but makes the retiring judges subject to call for duty to "hot" terms of Superior Court in emergencies when no active judge is available.

RETIREMENT — The judicial retirement act provides that any justice of the Supreme Court, or regular or special judge of the Superior Court, who has served on the bench for as many as 12 years and has reached the age of 65 may retire on that basis; and any one who has served as much as eight years and while on active duty becomes physical disabled to hold courts may retire for disability. The recent Legislature submitted to the people a constitutional amendment to be voted upon in November of next year providing for Supreme Court justices to retire and be subject only to call for relief duty on the high court in event of temporary incapacity of a regular justice.

CHIEF JUSTICE — Chief Justice William A. Devin will be 82 on July 12, and he has to his credit 40 years continuous service on the bench. He was a Superior Court Judge from 1913 to 1935, Associate Justice from 1935 to 1951, and Chief Justice since the fall of 1951. He is physically hale and hearty and mentally alert, and has given no indication of intent to retire. But—it is known that he is having a new home built at Oxford and that Mrs. Devin recently declined the

presidency of a Raleigh club of which she is a member on the ground that she expected to be away a good deal of the time.

ASSOCIATES — Associate Justices Maurice V. Barnhill and J. Wallace Winborne are also eligible for age-tenure retirement. Barnhill is 65 and has a service record of 29 years—from 1924 to 1937 on the Superior Court and from 1937 to 1953 on the Supreme Court. Winborne will be 69 on July 12 (the same day Chief Justice Devin will be 82) and has been on the high court since July 1, 1937, giving him 15 years. Devin was elected for an 8-year term as Chief Justice last November. Barnhill and Winborne come up for election next year, having served for the last 18 months of their tenure under appointment, and elected to full terms in 1935 and re-elected in 1946.

CHANCE — Chances are that the Supreme Court justices will not retire until after the 1954 November election, since action on the constitutional amendment would materially affect their subsequent status. Chief Devin is in the clear on that hazard. Associates Barnhill and Winborne must take a chance. They can offer for re-election and continue in full harness or retire at any time after the amendment is made effective, thus affording the Governor the opportunity to appoint two new associate justices; or they may elect not to run again taking a chance on the amendment being ratified, or upon assuming the status of emergency Superior Court judges. In any event, it is not much of a chance, because opinion prevails that the next Legislature will materially change the present set-up respecting special and emergency judges.

SUPERIOR — There are four regular and one special Superior Court judges eligible for retirement. They are Judges W. C. Harris, whose tenure dates back

to 1927; J. Paul Frizzelle and J.H. Clements, from 1921; Clawson Williams from 1935. Special Judge W.H.S. Burgwyn dates from 1937. Two or three other regular judges may be eligible for retirement under the disability phase of the act. In any event, prospects are that Governor Umstead will have the opportunity to appoint a larger part of the Judiciary than any Governor in modern times.

LOAD — Meantime, the backlog load of cumulative cases in both Supreme and Superior Court circles is increasing. The Supreme Court concluded arguments for the spring term some weeks ago but has more than 30 cases not decided. Friday of this week has been set as opinion day, and it is expected that more than half the cases will be disposed of then.

It is not likely that the slate will be cleared entirely. Whether the high court will adjourn for the term and leave the undecided cases until fall, or will set another opinion day could not be learned at the time this is written. The spring term of the Supreme Court begins on the first Monday in February and the fall term on the first Monday in August of each year. It is customary, but not mandatory, for the court to

reader opinions in all cases argued during the term before final adjournment.

DELAY — Slow action in the Superior Courts, for whatever reason—whether insufficient personnel, unnecessary postponement of trial, deliberate or accidental failure of witnesses to report, or what have you—contributes to delay in the handling of appeals. During the past two years there has been an abnormal number of judges failing to report for duty because of illness, thus occasioning slow down in processes all the way.

PHYSICAL — It was that situation which led one prominent lawyer to suggest to Governor

## Business Today

# Gov't Contracts

Many small businessmen fail to read and understand government contracts completely and this has led to misunderstandings, financial losses and even bankruptcies, says the Small Defense Plants Administration. The situation has prompted the SDPA to issue a bulletin alerting businessmen to the dangers.

It warns bidders that once their bid is accepted, they are bound by every provision of the contract. It applies to delivery time, marking, packing and crating as well as the quantity and quality specified. Manufacturers not only lose payment for rejected goods, but they must bear the expense of moving them from government property.

"Many manufacturers get into trouble because they fail to confirm deviations from the original specifications," the bulletin says. "Therefore, you should insist that any changes be presented to you by the contracting officer in writing."

Packaging specifications appear to be a trap for the unwary. "There may be special packaging instructions calling for a box of certain dimensions and weight, or a particular type of wrapping material, or for a certain substance to protect surfaces," the bulletin notes. "Overseas packaging may be especially elaborate and expensive. You should be sure to include all your packaging expenses in your cost figures."

It also suggests getting positive answers to these questions before bidding:

Do you fully understand the specifications?  
Have you figured your costs accurately?  
Do you understand the restrict-

ions in the contract which apply to your business?  
Have you considered the risks? Do you understand the penalties in your contract?

WE BUY WRONG KIND OF SHOES, SAYS DOCTOR  
Americans know less about buying a pair of shoes than about choosing a mate, selecting an auto or furnishing a home, Dr. Edward Gaul, Indiana dermatologist, told the American Leather Chemists Association in Cincinnati this week.

Although Americans are the best-shod people on earth, Dr. Gaul said, three out of four are afflicted with some foot ailment. Most of this could be avoided by selecting shoes of better fit and materials, he said, recommending shoes that fit snug but not cramped, with one-half to three-quarters of an inch between the big toe and the tip of the shoe.

He said roomy, all-leather oxfords with medium heels were the best shoes for women who spend most of the day pushing a baby carriage, vacuum cleaner or shopping wagon.

SALESMEN'S EXPENSES UP "PER CENT SINCE 1950"  
It costs from 21 to 25 per cent more to keep a salesman in the field than it did in 1950, Sales Management magazine declares after examining figures from 500 companies.

The average cost of maintaining a salesman in a large city is \$16.52 a day and in small cities, \$12.47. The average for executives is \$26.33 a day in large cities and \$20.76 in small.

## Final Notes On London Visit

LONDON (AP)—Last pages in a London notebook:

A queen's husband needs more of a sense of humor than does a queen—particularly if she wears the only crown in the family. The Duke of Edinburgh has this saving quality in good measure. He's a cheerful husband, and keeps his perspective in a tough role, one of the hardest that can fall to a man.

There is a high fellow to be required by law to kneel and pledge his loyalty to a woman and salute her on formal occasions afterward when he married her on his two feet and is the father of his children. It wouldn't be easy even for a modern-minded wife to have to do this for her husband, if their positions were reversed. In life it isn't customary to be required to salute the same person you kiss by choice.

But the duke is a blithe spirit in a trying job. He goes through his palace paces in a completely gracious way, but he doesn't take royal duties as much to heart as does his queen-wife. They weigh upon him less heavily.

There is a high seriousness about Elizabeth, this young woman whom millions felt looked so small and lost and lonely in great Westminster Abbey as the crown of empire was placed upon her head.

She has a developing firmness, the regal discipline exemplified by Queen Victoria and taught to Elizabeth herself as a girl by her grandmother, the late Queen Mary. She isn't as merry as her husband, and perhaps will be even less so as time bends more duties on her.

Shortly before the coronation, an Allied officer said to the duke during an inspection tour: "I suppose you are looking forward to June 2"—the coronation

day.

"No, I'm looking forward to June 3," replied the duke, smiling. His various titles—he is a field marshal as well as an admiral—provide the duke with a wide variety of "degrees" besides the coronet he wore on Coronation Day.

Once he told of putting his admiral's cocked hat on sideways, thrusting his hand into his shirt-front, and strolling about the palace as if he were Napoleon. Asked what his wife thought of this, the duke is reported to have admitted wryly:

"The queen was not amused." But the serious young queen and her handsome light-hearted duke are perhaps the "best-matched couple in British royal history."

A palace can be a mighty dull place, and a queen is lucky to have a husband around who knows how to laugh, and can brighten it with a little horse play.

The greatest moment of suspense in the coronation ceremony in the abbey came when the 69-year-old Archbishop of Canterbury started to lift the heavy St. Edward's crown and put it on the queen.

His fingers lifted, hesitated, and up came the crown safely, thus averting the greatest blunder in history. I had a nightmare feeling that if it had slipped, fallen, and rolled across the floor, the archbishop would groan aloud:

"Oh, no! Now they'll sell me to the St. Louis Browns!"

The coronation was an all-British production, and the British are still immersed in a proud glow of how well they carried it off.

"In one way this is the greatest anti-American demonstration of the century," one Englishman joked. "It proved we could get something done without help either from Washington or Hollywood."

## Scotland Awaits Royal Visit By Queen Elizabeth

EDINBURGH (UP) — All Scotland is preparing for the "little coronation" June 24 when Queen Elizabeth II will ride in procession from Holyrood House to St. Giles Cathedral — "the Westminster Abbey of the north."

The procession will be the highlight of the Queen Mother's visit here from June 23 to June 29. The British ruler has many blood links with Scotland. Her mother, the Queen Mother, is a member of the ancient Bowes-Lyon family of Glamis Castle.

For the procession from Holyrood House to St. Giles, the Queen

and the Duke of Edinburgh will ride in state in an open carriage which will be flanked by one officer and 10 archers of the Royal Company of Archers.

Preceding the royal carriage will be "the honors of Scotland"—the regalia of the Scottish kings, including crown and sword. The hereditary standard-bearer of Scotland, Viscount Duhope, will lead

the procession on horseback, and the "honors" will be in the care of the Duke of Hamilton, the Earl of Crawford and Balcarres and the Earl of Home.

21-gun Salute  
Heraldic officers of Scotland in gold-frogged tabards and other ceremonial attire will ride in a carriage preceding the "honors." Detachments of the Scots Guards,

the Royal Air Force, the Army and the Royal Navy will march with the massed bagpipers of the Scottish regiments and the massed military bands and the mounted band of the household cavalry in brilliant uniforms.

There will be many noble names in the procession to St. Giles where a national service will be celebrated.

Police expect hundreds of thousands of visitors here during the Queen's visit. They do not expect any trouble from Scottish nationalists who have blown up a post office box and made other protests against the title, Elizabeth II. They contend the first Elizabeth never ruled Scotland and the Queen should be known here simply as Queen Elizabeth.

Clark, in winning \$250 and a gold medal as the leading qualifier, moved up into the dark-horse ranks for the four-round championship proper, beginning today on the sand-trap dotted heavily-roughed Oakmont Country Club course.

The 32-year old ex-Marine, who picked up \$250 and a gold medal as the low qualifier, joined such stars as Bobby Locke, Lew Worsham, Jackie Burke, Tommy Bolt and Porky Oliver in the list of "dark horse" probabilities.

But despite his record-shattering 66 Wednesday on that tough Oakmont course, the handsome, blond-haired Clark didn't figure very strongly in the betting odds.

They still had Hogan and Snead, despite their handicaps, as the men to beat at 6 to 1.

A total of 156 qualified to join defending champion Julius Boros.

Greenville's Giants will be battling for first place when they meet Nashville in a Carolina-Virginia League contest at Guy Smith Stadium Friday night.

An all-white team, Nashville is currently a half game ahead of the Giants.

## Mangrum Tabs Open Golf Tourney 'Idiot's Delight'

OAKMONT, Pa. (UP)—Straight-talking Lloyd Mangrum, a Purple Heart hero who knows tough things when he sees them, struck straight from the shoulder today when he tabbed the U.S. Open golf championship "an idiot's delight."

The lean and dapper pro from Niles, Ill., who came battling back from the flaming battlefields of Germany to win the gloriol and storied Open at lightning-buffed Canterbury in 1946, heatedly pegged the present day tournament "a matter of sheer luck."

"There is no premium on real skill," Mangrum stormed after nearly breaking his hand in the steelwire rough at Oakmont Country Club in what he described as an unnecessary qualifying round.

"In the first place, former champions of the last 10 years or so shouldn't even have to qualify for the tournament proper," Mangrum added. "Why should we have to prove we are good enough to be in the Open and how can you call this a test of golfing skill when they try to make the greens as fast as a runaway freight train—so fast that when you hit a putt and it runs past the hole, the members sit there and laugh at you. Some fun."

Mangrum, one of the greatest shotmakers of all time, wasn't pointing the finger particularly at Oakmont Country Club where the championship officially gets underway today. But he wasn't exempting a club which jealously did everything possible to protect the sanctity of its cherished par.

## Brooklyn, Cleveland Win But Don't Gain

NEW YORK (UP)—The Dodgers and the Indians had the feeling today that they were traveling like mad on a treadmill — and not getting anywhere.

Brooklyn has won 16 out of its last 19 games and still trails Milwaukee by a full game in the National League race. Things are even tougher for Cleveland. The Indians have won seven in a row but haven't gained an inch on the Yankees, who happen to have a 13-game winning streak still intact.

Cleveland, in fact, lost ground by winning 11 out of its last 13 games and trails the Yankees by 5 1-2 games.

Things have gotten so bad with Dodger Manager Charley Dressen that he's been rooting for the Giants. He went to the Polo Grounds to scout the madcap Milwaukee boys and whooped it up all the way for New York.

"First time that's happened since 1932," said Dressen, an old Giant hater since ever since he played with them that season.

But Dressen's cheers fell on deaf ears and Milwaukee made it three in a row over the jaded Giants, 6-5, as Sid Gordon whacked a three-run homer in the eighth off ace reliever Hoyt Wilhelm.

Dressen went back to Brooklyn to direct his Dodgers to a 13-3 victory over Cincinnati in a night game while the Phils won a pair from the Cubs 9-1 and 8-5, and the Cards topped the Pirates 5-1. In the American League the Yankees stormed from behind to defeat Detroit 11-4 and Cleveland edged Washington 2-1 on Mike Garcia's four-hitter for his fifth straight win. The Athletics defeated Chicago 3-1 and the Red Sox twice topped the Browns 11-3 and 3-2 to extend a St. Louis losing streak to nine games.

Brooklyn made 13 hits including a homer by Duke Snider, triples by pinch-hitter Wayne Belardi and Carl Furillo and doubles by Jackie Robinson, Peeewe Reese and Bob Morgan, blowing the game to bits with a seven-run rally in the eighth. Preacher Roe, although belted out when Gus Bell and Bob Borkowski homered for all of Cincinnati's runs in the sixth, gained credit for his third victory.

The magic number was "10" at Philadelphia where Robin Roberts chalked up his 10th victory with a seven-hit first game triumph, and poor Warren Hacker suffered his 10th defeat for Chicago in the second game. They were the first pitchers in the majors to reach that figure — but Hacker, unfortunately, is traveling in reverse as are the tail-end Cubs. Roberts missed a shutout in the opener when Ralph Kiner homered. Earl Torgeson paced the Phils with a three-run homer, a double and single. In the second game Jim Konstanty won his fifth decision with relief help from Steve Riddick and Karl Drews. Roberts last year won his 10th game on June 28, putting him 17 days ahead of the pace which brought him 38 wins in 1952. It also was his 32nd straight complete game. Connie Ryan and Del Ennis hit first inning homers in a four run rally that put the Phils in front for good in the second game.

Old Enos Slaughter hit four singles to drive in three runs in the Cardinal victory at Pittsburgh in which a Frank Thomas homer robbed Joe Precko of a shutout. The Yankees stormed from behind to score seven runs in the sixth at Detroit as relief pitcher Johnny Sain gained his seventh victory. Joe Collins hit a two run pinch-hit in the big rally for his 1,999th major league base blow. Bob Nieman and Owen friend hit Detroit homers.

## Leo Durocher Retracts Charge Against Umpires

NEW YORK (UP)—Leo Durocher retracted his charge that the umpires were ganging up on him today and won the endorsement of Giant President Horace Stoneham — at least for the rest of the season.

Stoneham, whose quick intervention was credited with cooling off Leo, followed the retraction with a statement backing Durocher all the way. There had been reports that Stoneham had grown tired of Leo's continuous feuding with the umpires and might be ready to fire him.

"Leo's arguments with umpires have never caused me to wonder whether he should be retained as manager," Stoneham said. "Leo popped off, has retracted his charge and that's the end of the matter as far as I'm concerned."

Stoneham said nothing about next year — Leo has been rumored as Hollywood bound — but the endorsement covered the entire '53 season. Equally important was Stoneham's neat handling of the irate Durocher. For, if Stoneham had any ideas about easing Leo out, he had only to sit back in the crisis Wednesday and let Durocher talk his way out of baseball.

"I seemed determined to do just that, too, as he followed Tuesday night's bitter blast with his charge of a "double standard of judgment" and the citing of five umpires; These umpires were Frank Secory, Frank Dascoli, Larry Goetz, Al Barlick and Bill Stewart. By this time Durocher probably was only a few syllables from lifetime banishment.

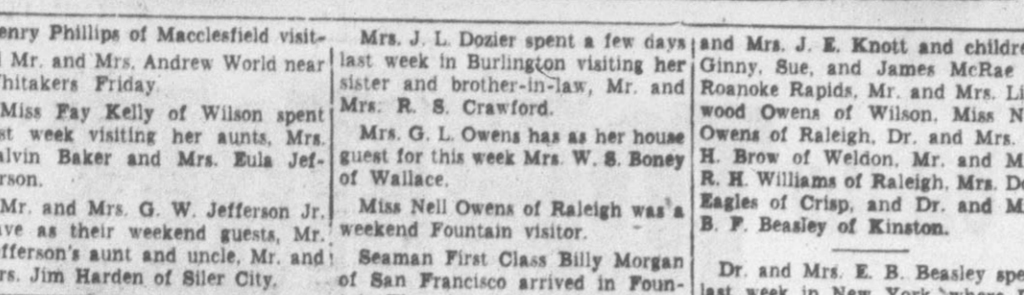

# Possible 'Aggression' By Rhee Worries Ike

 President Eisenhower has urged South Korea's President Syngman Rhee not to commit the same "crime" of aggression which the Reds were guilty three years ago and which led to our entry into the Korean war.

But the aged and single-minded Rhee so far has paid no attention. Persistently and dangerously he has proceeded to whip up South Korean emotions to continue a war which now not only could not have United Nations support but, under the U.N. charter, must have its active opposition.

The President told Rhee that "the enemy has proposed an armistice which involves a clear abandonment of the fruits of aggression."

He added that he believed "profoundly" that it should be accepted.

Thus Rhee is told that any new crime of aggression must be on his own head.

The President's message, besides its appeal to reason, was strictly in accord with Chapter I, Article I, Point 1 of the United Nations Charter. It says the purposes of the U.N. are first:

"To maintain international peace and security, and to that end: to take effective collective measures for the prevention and removal of threats to the peace and for the suppression of acts of aggression or other breaches of the peace, and to bring about by peaceful means, and in conformity with the principles of justice and international

law, adjustment or settlement of international disputes or situations which might lead to a breach of the peace."

But the emotional Rhee urges Seoul demonstrators to chants of "unification or death."

And so he invites exactly the same sort of U.N. "police action" against himself and his people as was instituted against North Korea on June 27, 1950.

Which for the United States, the United Nations and the South Koreans themselves would be a tragedy.

Critics of the United Nations would say that it failed in its greatest test and by its own failure proved that nations would use it—not for world peace—but for their own ends.

For the United States it would be a tragedy on three counts. Twenty-five thousand Americans have died in Korea during the last three years. We sponsored South Korea as a sovereign nation before the United Nations on Sept. 17, 1947, and we sponsored and built the South Korean army which now would be used against us as a Frankenstein monster to break a truce.

For South Korea, it would mean national suicide.

Maj. Gen. Choi Woung Hi, former South Korean deputy chief of staff now in the United States, says the South Korean army will follow Rhee's orders, regardless.

There is no doubt, either, that Rhee can lead the remainder of his people on to a suicidal war if

## Battle To Save Burning Vessel

FT. MYERS, Fla. (UP)—A stubborn fire still blazed today in one hold of the Swedish freighter Stegholm in the Gulf of Mexico as a skeleton crew, aided by coast guardsmen, fought to save the charred and blackened vessel.

Hose from the salvage tug cable poured water into the 6,350-ton Stegholm which caught fire about 60 miles southwest of here two days ago shortly after leaving Tampa, Fla., for Montreal, Canada.

The Coast Guard reported that the Stegholm's superstructure and engine room are gutted and the fire in No. 4 hold still burned "fiercely" although flames shooting up from the No. 3 and No. 5 holds had been brought under control.

## Pittsburgher Is Record Collector For A Lifetime

PITTSBURGH, Pa. (U.P.)—Some historian of the future is going to bless the name of Bog Dixon, Pittsburgh insurance realty and estate management expert.

The future scholar probably will find one of his most important sources of study of this era in the library of the real estate man. And the library doesn't consist of books.

The big thing to the historian will be Dixon's 10,000 sound recordings dating back for nearly a quarter of a century.

Dixon has been spending his spare time recording all important speeches made in his lifetime. Although a storage room of his home already is packed with filings cases of thousands of recordings, Dixon still records every important occasion.

**Political Records**

For instance, during the critical period leading up to World War II he recorded speeches by Mussolini, Hitler, Haile Selassie, Chamberlain and others in the thick of events. He can play back the present Duke of Windsor's famous abdication speech when he gave up the British throne for the "woman I love." He also can play major speeches of big political campaigns.

To get his recordings Dixon uses special high-fidelity radio receivers and sound equipment. He had a battery of recording equipment built into rack panels. He even has a portable unit which he uses to record programs while he watches television. To top it off, he has automatic timing equipment in his studio which can be set to turn on his rig, record a program at any hour and turn it off again.



### Private Transit Firms Lose Out

CHICAGO (U.P.)—Many cities are getting substantial revenues from privately owned public transit systems while others get little or none.

That is the conclusion of a study made by the American Municipal Association, which surveys 31 privately owned transit systems in 29 cities between 200,000 and 1,000,000 population.

In only three cities, Providence, R.I., Richmond, Va., and St. Paul, Minn., are there no traction franchises.

In St. Paul the transit company's only financial obligation is to pave that part of a street between the car tracks.

**Other Systems**  
Richmond's transit company pays a bus tax of five per cent gross revenue amounting to \$230,000 annually.

Quasi-franchise arrangements are in effect in St. Louis and Worcester, Mass. St. Louis collects more than \$1,000,000 annually from five per cent tax on motor bus receipts and taxes on street-cars.

In the other 24 cities privately owned transit systems operate under franchises. But no taxes are imposed and no revenue is derived under the franchises in Cincinnati and Toledo, O., and in Oakland, Calif.

Other cities that impose no taxes include Akron, O., and Minneapolis, Minn., where revenues are nominal.

Fifteen other cities impose taxes, and the rest have other systems for collecting revenue.

### Just The Recipe For A Good Chew

CHEYENNE, Wyo. (U.P.)—A recipe for 13 pounds of chawin' tobacco turned up recently in an old diary. Here it is:

"First select enough good tobacco (in strength according to taste) to make 10 pounds after it is stemmed; cook one pound of good dried peaches well done, strain the syrup from the peaches; melt one and a half pounds of good licorice; don't let boil—stir regularly; put in one hand full of common salt; use half gallon of water only; after it is well melted add the peach syrup to licorice and one-half pound of white sugar; after it is cool add one-half pint of whiskey or brandy.

"Let your peaches boil down very low so the syrup will be thick, not having but little over one-half gallon of dip after mixing. Now spread your tobacco very thin, sprinkle well with mixture, put more tobacco and sprinkle as before until you use all of your dip. "Now hang your tobacco on sticks and let dry scatter it well or it will mold. Let it hang until the first damp spell. It will come in case, then twist or plug and prise it, if you like, in very stout box. "Now if you will be particular and follow the direction you have 13 pounds of tobacco that will not cost you exceeding \$1.75."

### Bidault Loses In Premiership Bid

PARIS (UP)—The National Assembly rejected Georges Bidault as premier by one vote and France went into its fourth week without a government.

The assembly gave Bidault, Catholic Popular Republican leader, 313 votes against the 314 absolute majority he needed to be confirmed as head of the government. Votes against him totaled 228, with 86 abstentions.

Bidault was the fifth man named by President Vincent Auriol in his search for a new premier to replace Radical Socialist Rene Mayer, whose coalition government fell May 21.

The assembly vote left France without a leader to represent it at the Big Three Bermuda conference, scheduled for late this month. The meeting already has been postponed once because of the French crisis and another delay now may be necessary.

It was believed President Auriol might next ask ex-Premier Antoine Pinay to try to form a new cabinet.

### Millionaire And His New Bride On Honeymoon

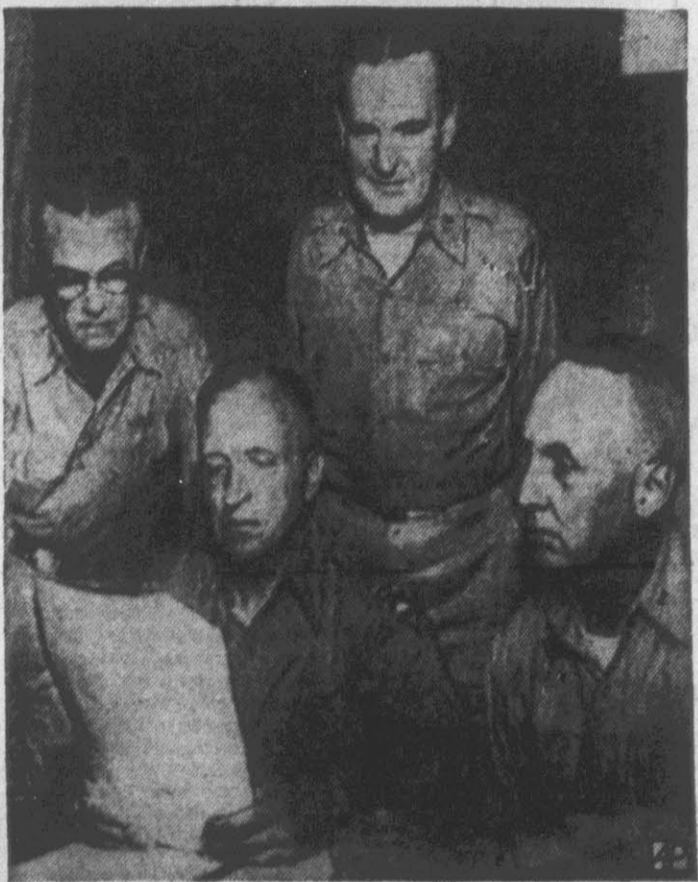

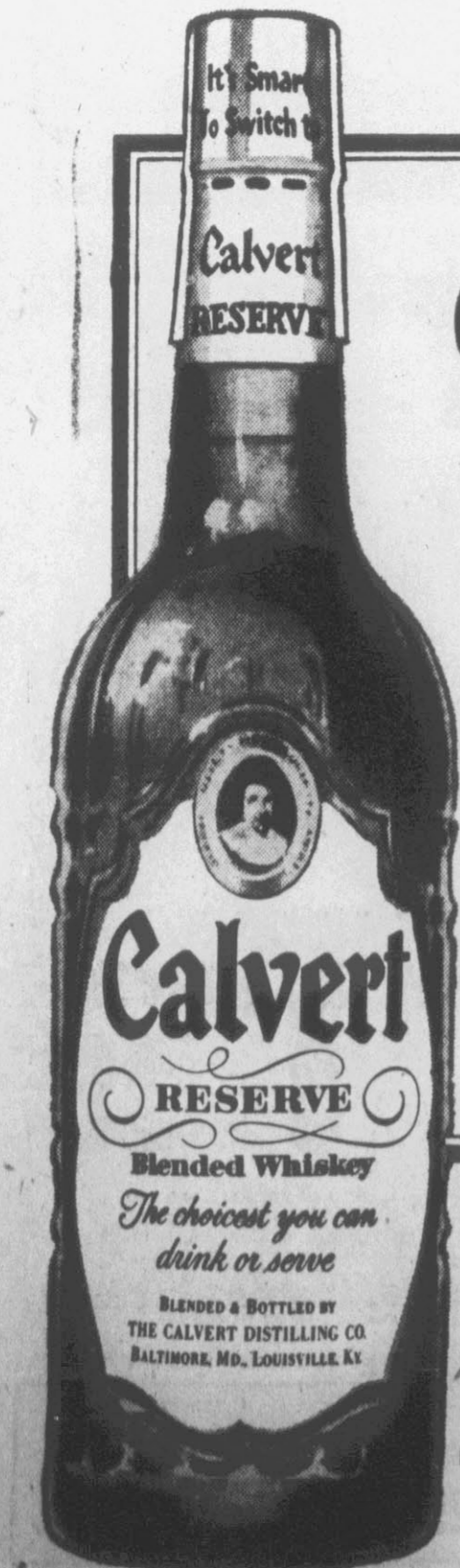

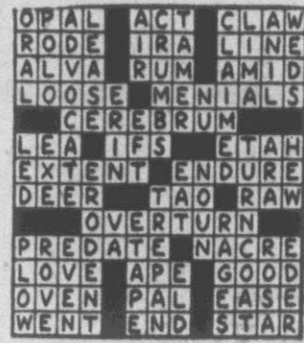

## Sen. Taft Losing Little By His Stepping Aside

WASHINGTON (UP)—First reports of Sen. Robert A. Taft's withdrawal from active leadership of the Senate Republican majority were considerably exaggerated if all the facts of his illness have been revealed.

Barring aggravation instead of improvement in his physical condition, about all the Ohio senator actually has given up is the chore of sitting in the Senate chamber during every moment of every session.

Only for lunch, and that a brief one may a majority party leader desert the floor. It is the leader who holds the Senate to the formal business to which it is committed and makes good on the private agreements which senators constantly make among themselves.

A senator, for example, desires to be absent for a couple of days, but has a special bill in which he is interested. The absentee for good reason wants to be on the floor when that bill comes up. So he tells the Senate leader he must be away and requests that any action on the bill be put over until he returns.

A Senate leader makes many such promises—and he sits in the Senate chamber through every session to make good on them. The X-ray and other treatment Taft now must take over a long period of time will prevent his constant attendance at the Senate. Whether he ever returns to active leadership will depend on the extent of his recovery.

Sen. William F. Knowland (R-Cal) will take on the irksome floor leadership chore. Taft will continue as nominal leader. He will attend the weekly White House legislative conferences, and generally continue to have just about as much influence in Congress as he has had before—assuming, that is, that his health improves.

Taft's very important role as an adviser to President Eisenhower can be, and increasingly is recent weeks has been, exercised far from the Senate floor. Taft's advice to the man who beat him out for the presidential nomination seems to be not confined to legislative matters, but includes seasoned political wisdom on ways of selling a program to Congress and the country.

If Taft gets worse instead of better, his influence will wane accordingly. As of now he has stepped down only for the remainder of this session.

Taft's misfortune is a real political break for Knowland. The young man from California—he will be 45 this month—already was chairman of the Senate Republican Policy Committee. That is high office for a senator of fewer than 10 years of seniority.
