Vietminh Assault Troops Bolstered

By LARRY ALLEN HANOI, Indochina (AP)—The Vietminh showed tens of thousands of fresh troops into attack positions around Dien Bien Phu today. The third round of the savage battle for the French Union stronghold appeared to be days or even hours away. Reliable sources said rebel Gen. Vo Nguyen Giap had rushed up at least 40,000 unbloodied regulars to bolster his badly battered force in the low hills encircling the fortified plain and along its fringes. With these reinforcements and replacements for the thousands killed by murderous French fire in the past five weeks came 5,000 or more youthful rebels just out of training camps. It appeared certain here the Vietminh in their next all-out assault would outnumber the defenders at least 6 or 8 to 1. The Communist-led reinforcements went into forward trenches to relieve units of the four divisions which have spearheaded the hard fighting around the fortress since the first Vietminh push March 13. The veterans fell back a short distance, presumably to rest up for the next anticipated massive charge. The stoutly defended French fortifications faced more critical moments today as the garrison force tried to drive out Vietminh troops entrenched on the northern section of the main Dien Bien Phu airstrip. The French, lunging at the infiltrated units with bayonets, grenades and machine guns, routed them yesterday from about half the trenches they had dug and blasted with high explosives on the pocked field. But the rebels still clung to dug-outs only 2,400 feet from the heart of the French bastion. These split the east-to-west network of defense communications on the north and posed the most serious threat to the fortified plain since the Vietminh first struck. The foothold on the airstrip was won this week after Vietminh night raiders blasted craters with nitroglycerine. Rebel troops then rushed in and furiously hacked out a system of connecting trenches. The Vietminh also kept up their steady fighting around the outskirts of the Dien Bien Phu plain today, relentlessly pushing their web of trenches and foxholes closer to the French barbed wire barricades. Giap was believed to have rounded up his reinforcements by beating the jungles throughout northern Indochina. Apparently he even drew on the regulars who have been fanning out in repeated scattered attacks against the French and their Vietnamese allies in the vital Red River delta, about 150 miles to the east. The French gave no information on the numbers of defenders they still have at Dien Bien Phu after the five weeks of pounding. The high command here said only that none of the fortress' six main defense positions had suffered any food or ammunition shortages. All supplies and reinforcements for the garrison of several thousand men must be parachuted in. The remote fortress is completely surrounded by the enemy, and constant artillery bombardment makes its two airstrips unusable, even for removal of wounded.

Says Secrecy Has Confused Planning

GREEN WASHINGTON (AP)—Secrecy on atomic weapons progress has thrown civil defense planning into confusion and hindered development of a continental defense system, the American Society of Newspaper Editors was told today. Paul Block Jr., co-publisher of the Toledo Blade, reported to some 400 editors at their annual meeting that despite recent hydrogen bomb revelations, atomic developments have outrun public information. "The public appears to be relatively farther behind informationally than ever before," said Block, the society's one-man watchdog committee on atomic information. The sensation created by Atomic Energy Commission Chairman Lewis L. Strauss with his recent description of a 17-month-old hydrogen bomb explosion, Block said, raises the question "whether the people must not be told much more soon." "Witness the confusion of the Federal Civil Defense Administra-

tion," Block said. "The potential of the H-bomb required a major change in emphasis in the teaching of this organization. "Now the watchword is 'evacuation' and the training of rescue units is pinned to the needs of rescuing other areas rather than one's own city. "And what of the many stories about a cobalt bomb—which would set off a rain of destruction by the dropping of radioactive materials many miles from the site of the explosion? "A major question of national defense policy, the editor went on, is whether more money should be spent on continental defense. "Clearly the answer to this is in the hands of the electorate," he said. "Does it have enough information on which to base a decision?" Block's message was one section of a comprehensive report by the society's Committee on Freedom of Information headed by J. Russell Wiggins, managing editor of the Washington Post and Times-

Demos Will Fight Scandal Stigma

WASHINGTON (AP)—Three Democratic members said today they will fight any effort by the Senate Banking Committee to focus on housing swindles which may have taken place in the Truman administration while glossing over more recent irregularities. Chairman Capehart (R-Ind) said there was no such intent on the part of the committee, which plans to start public hearings Monday into reports of a multimillion-dollar scandal. The three Democrats — Senators Douglas of Illinois, Lehman of New York and Maybank of South Carolina—said that so far they had noted a lack of emphasis on exorbitant fees said to have been charged home owners for repairs financed with loans insured by the Federal Housing Administration (FHA). Officials have said these irregularities have continued virtually up until the present. The other principal aspect of the investigation—also being carried on by at least three agencies of the executive branch—involves FHA-

insured loans to build big apartment houses. The section of the act which authorized these loans expired in 1950, although some projects are said to be still under construction. The Internal Revenue Service announced late yesterday that 1,149 corporations got loans to build apartment houses which cost less than the amount of the loans, with the corporations pocketing the difference. One result in many cases has been to force up rents in those projects, because the rents are tied to the size of the loan. Capehart has said buildings may have reaped a half-billion-dollar windfall under this program, designed to stimulate apartment buildings in the postwar years. He said in a separate interview the home-repair "rocket" is "equally as bad if not worse" than the apartment-project swindle and that he intended to give it a complete airing.

Utilities Show \$35,915 Net Revenue In March

The financial statement for Greenville Utilities Commission for the month of March showed a net revenue of \$35,915.54 from a gross income of \$169,946.28. A breakdown of departmental operations showed for the water department an income of \$17,238.14, expense of \$11,467.47, and a net revenue of \$5,770.67. For the gas department the income was \$18,835.05, expense was \$13,519.05 and the net profit \$5,316. For the electric department distribution in the city brought in \$96,049.55, expenses amounted to \$77,589.37, and the net profit amounted to \$20,460.19. The rural electric system showed an income of \$36,823.53, expenses of \$30,454.85, and a

net revenue of \$6,368.68. The report also showed 29 customers were added to the utility's rural electric system in March, 14 sewer taps were made in Greenville and 27 water taps were made in Greenville. A breakdown wholesale sales to other electric distribution systems showed Ayden purchased 460,800 KWH for \$5,522.24 at an average rate of \$1.20 per KWH; Grimesland purchased 147,000 KWH for \$1,930.35 at an average rate of \$1.31; Winterville purchased 97,280 KWH for \$1,469.54 at an average rate of \$1.51; and the Pitt-Greene Electric Co-op purchased 24,600 KWH for \$535.62 at an average rate of \$21.5.

Pilgrims Fill Arab Jerusalem

By WILTON WYNN JERUSALEM (AP)—Pilgrims from Western countries packed every hotel and hostel of Arab Jerusalem today to join in a Jerusalem Easter devotion no inhabitants of the Holy City observe. The special devotion is called the Way of the Cross—a procession following huge wooden crosses from the point of Jesus' trial inside the old walled city along the path he followed to Calvary and the tomb. Introduced a few hundred years ago by the Franciscan monks coming from the West, the service is always observed on Good Friday by pilgrims from abroad. Conservative oriental Christians living here regard the procession as too modern a tradition. The pilgrims assembled at the Pretorium, where Pilate condemned Christ, with each national group following a cross carried by young men. At 14 stations of the cross along the way a sermon is preached in the language of each group. Most of the procession route passes over medieval streets which have scarcely changed since the days of the Crusaders. In many places the streets are covered with stone-vaunted ceilings and lighted only by small skylights admitting the sun at intervals. Automobiles or other wheeled vehicles have never invaded them. Human porters and overloaded donkeys are the only means of transport in the semi-darkness. Franciscan fathers say the present Way of the Cross is almost identical with the route Christ followed the first Good Friday, although changes in the city make some detours necessary. The streets and buildings have changed and even the city walls have been moved, so that the sites of Calvary and the Holy Sepulchre are now inside the city instead of outside the walls, as in Biblical times. The Franciscans point out, however, that the pilgrims still see some original objects which existed on the day Christ was executed. Among these are the pavement on which he walked into the Pretorium to be condemned by Pilate, and a portion of the rock of Calvary where he was buried. Most other stations of the cross are marked only by plaques on the walls of the convents and churches, or on simple shops where the Arabs of Jerusalem carry on business as usual while the foreigners pray in the streets.

Will Not Believe Japan Lost War

HONOLULU (AP)—A Japanese farmer, indicted on a charge of violating the immigration law, says Japan won World War II "and you can't make me believe otherwise." The farmer, Kametoku Tomel, 64, was accused of refusing to file an annual alien address report and the U. S. attorney's office said he insisted that Hawaii is part of Japan. "Hawaii is a part of Japan," Tomel told a reporter yesterday. "Everything else is a pack of lies." Tomel's children, all born here and U. S. citizens, left home several years ago. They were angered and embarrassed, said the eldest son, Shigemichi Tomel. "We tried everything to explain the true situation to him," Shigemichi said. "He wouldn't believe us. I even offered him money to take a trip to Japan to see for himself but he refused, saying the time had not come to visit Japan yet." Tomel said he would believe Japan lost the war "if the Emperor sent a representative" but added: "The Emperor would not do such a thing."

Ex-Detective Is Found Guilty Of Lying Over Cash

KANSAS CITY (AP)—A federal court jury has convicted Louis Shoulters, the veteran police officer who broke the Greenlease kidnaping case, of lying about the handling of the ransom money. A half year ago Shoulters, who spent more than a quarter of a century on the St. Louis police force, was hailed as a hero after he arrested Carl Austin Hall, Hall and his partner, Mrs. Bonnie Brown Heady, were executed for kidnaping and killing 6-year-old Bobby Greenlease. Yesterday the federal jury found Shoulters guilty of lying about his handling of two money-stuffed suitcases found in Hall's room. Shoulters was charged with committing perjury in testimony early this year before a federal grand jury. He maintained the suitcases were brought into the police station 15 to 20 minutes after Hall was booked. The government said they weren't brought in until more than an hour later.

Twisters Strike

MONTGOMERY, Ala. (AP)—Tornadoes spun into two communities 100 miles apart in south and central Alabama early today, tearing up at least four buildings and damaging several others. But no one was reported injured. One twister struck in and near Wetumpka about 6 a. m., smashing two buildings there, while another storm hit two miles north of Enterprise in southeast Alabama two hours later. Two houses were "torn up" by the wind at Enterprise, the patrol said. Arthur Foster, a filling station employee said several houses were unroofed and a sawmill was "wrecked" at a lumber company in Wetumpka by the storm which struck about 6 a. m. Foster said "It must have been a little tornado from the way it hit and twisted off trees." North of Wetumpka a large chicken house was reported demolished, porches and roofs damaged on a number of houses and trees blown across the road at two places. Wetumpka is a town of 3,800 in central Alabama a few miles north of Montgomery, the capital. Enterprise has a population of 4,300.

Tito Talking Turkish Pact

ANKARA, Turkey (AP)—Yugoslavia's visiting President Tito has agreed tentatively to form an outright military alliance with Turkey, NATO's easternmost member. He plans to press Greece, another NATO neighbor in the Balkans, to join in the plan. The decision was announced last night by Yugoslav Foreign Minister Koca Popovic as a climax to his state visit here by the Communist leader who has defied Moscow and leagued his country with the West. Popovic said Greece's approval is necessary for the alliance since the three Balkan neighbors, in their pact signed Feb. 28, 1953, agreed to consult each other on military matters. In Athens a foreign ministry spokesman confirmed that military representatives are exploring the possibility of expanding the tripartite agreement into a full-fledged military pact. The spokesman added that his nation would view such a change in "a favorable light." The Athens Foreign Office said Tito is expected to visit Greece in June. The proposed alliance would go much further than the mere consultation stage in bringing together a total of about a million men under arms from the three countries guarding the eastern Mediterranean. All three receive American military aid.

French Gov't Is Satisfied With EDC Promises

PARIS (AP)—France's government said today it is entirely satisfied with President Eisenhower's assurances of U. S. support for the European Defense Community. But a Cabinet spokesman said he could not speak for the National Assembly, which demanded the assurances. The French Foreign Ministry spokesman said Premier Joseph Laniel's government considers Eisenhower's declaration fully as valid as Britain's similar pledge earlier this week to keep troops on the European continent as long as Western Europe's security is threatened. Both the British and American promises were made in an effort to calm French fears of a re-armed Germany and to expedite ratification of the EDC treaty, now bogged down in the French National Assembly.

Dulles Will Report To President

AUGUSTA, Ga. (AP)—President Eisenhower will get a personal report from Secretary of State Dulles here Monday on United States efforts to forge a Pacific defense alliance to stem the spread of communism. The President's vacation headquarters announced late yesterday that Dulles, just back from London and Paris conferences on Indochina and Southeast Asia, will fly from Washington to meet Eisenhower. The announcement came a few hours after Dulles had returned to the United States after winning British and French agreement to work toward a Pacific pact. James C. Hagerly, White House press secretary, said that Dulles—in addition to reporting on the London-Paris negotiations—will "obtain the President's guidance on the upcoming NATO conference and the Geneva conference." He will spend two or three hours with Eisenhower at the Little White House at the Augusta National Golf Club then return to Washington. He will fly Tuesday night to Paris for a meeting of North Atlantic Treaty nations then go to Geneva, Switzerland, for a Big Four foreign ministers conference starting April 26. Representatives of Communist China will sit in at the Geneva sessions, but not as participants, together with U. S., British, French and Russian officials. Dulles said on his return to this country yesterday that he was well satisfied with the outcome of his London and Paris talks aimed at creation of a 10-nation Pacific alliance similar to the North Atlantic collective security agreement. He termed the situation in Indochina and the rest of Southeast Asia disastrous, and added that the "disaster would be compounded" if Indochina were lost eventually to the Reds. Yesterday Eisenhower dispatched a message praising the kingdom of Laos in Indochina for its "inspiring defense against foreign aggression."

To Stay In Europe As Long As Dangers Continue U. S. Troops Pledged

By MARVIN L. ARROWSMITH AUGUSTA, Ga. (AP)—President Eisenhower pledged today that a "fair share" of American troops will be maintained in Europe as long as a threat to the security of the Western nations exists. In a six-point message to the prime ministers of six Western European countries, the President sought to assure French ratification of the European Defense Community (EDC) project by promising in effect that rearmament of West Germany would not be permitted to endanger France. France long has sought such formal assurances before joining in the creation of a six-nation army designed as a bulwark against any Russian aggression. The proposed EDC has been ratified by Belgium, West Germany, Luxembourg and the Netherlands. Only Italy and France have yet to act. The President also pledged continuation of efforts to provide for sharing with U. S. allies more information about the use and effects of the hydrogen bomb and atomic weapons on military and civilian personnel. In an administration statement of policy, he messaged all six nations from his vacation headquarters here that:

- 1. The United States will continue to maintain in Europe, including West Germany, such American troops "as may be necessary and appropriate to contribute its fair share of the forces needed for the joint defense of the North Atlantic area while a threat to that area exists. . . .
- 2. The United States will consult with fellow signatories to the North Atlantic Treaty and with the EDC nations "on questions of mutual concern," including the armed forces strength to be placed at the disposal of the supreme commander in Europe, Gen. Alfred M. Gruenther.
- 3. The United States will encourage the closest possible integration between EDC forces on the one hand, and U. S. and North Atlantic Treaty forces on the other.
- 4. The United States will recommend to Congress, to seek means of extending to the Atlantic community increased security by sharing in greater measure information with respect to the military utilization of new weapons and techniques for the improvement of the collective defense."

James C. Hagerly, Eisenhower's press secretary, told newsmen that that pledge means sharing of information regarding the use and effects of hydrogen bombs and atomic weapons on both military and civilian personnel. The pledge does not apply, Hagerly added, to production secrets. "In line with its policy of "full and continuing support for maintenance and the integrity and unity of EDC, the United States will regard any action from whatever quarter which threatens that integrity or unity as a threat to the security of the United States." In such event, the President said, the United States would consult with the other North Atlantic Treaty nations. That promise obviously was designed to allay French fears that a resurgence of German armed strength under EDC won't be permitted to threaten the security of France itself. It amounts to a U. S. guarantee that American troops won't be pulled out of Europe after Germany is rearmed. As in the case of the North Atlantic Treaty itself, the President's promise also applies to any aggression by Russia.

McCarthy Camp Protests Release Of Army Charges Pre-Probe Inquiry Is Asked

WASHINGTON (AP)—Sen. Mundt (R-S.D.) pushed ahead today with scheduled plans for a televised probe of the McCarthy-Army row in the face of demands from the McCarthy camp for another investigation before the public hearings get under way. Mundt acting chairman of the Senate investigations subcommittee during the inquiry, professed hope the public hearings would start next Thursday as planned despite those demands and reports the Army would be asked to rework its case. The call for a pre-investigation came from Chairman McCarthy (R-Wis.) and Roy M. Cohn, the subcommittee's regular counsel, following the release yesterday of the Army's 29-point "bill of particulars" against the senator and his aides. Cohn telegraphed from New York for "an immediate investigation" to find out who violated an earlier subcommittee decision not to make public the Army

charges until McCarthy's accusations against the Army also had been submitted and could be made public. Cohn made clear he was not referring to Sen. Symington (D-Mo.), the subcommittee member who gave out the Army list of charges. Symington said he did so because of previous "piecemeal leaks" to newsmen about the Army document. But in his call for an investigation of the matter, McCarthy said in Houston, Tex., that he was "very surprised that Symington violated the Senate rule." And he said any Pentagon officials who "leaked" parts of the report earlier should be cited for contempt. The Army report, sent to the subcommittee as a basis for its case in the public inquiry, alleged that McCarthy and his aides "sought by improper means" and by "threats" against Army people to win favored treatment of a draftee, Pvt. G. David Schine, formerly an unpaid subcommittee in-

vestigator. Except for pointing up McCarthy's reported role in the affair, the new bill of particulars was generally similar to the charges contained in the lengthier document made public in mid-March. McCarthy at that time put out countercharges that top Army officials were using Schine as a "hostage" to ward off a subcommittee probe of Army treatment of alleged Communists, and that they attempted to divert the subcommittee's attention to other branches of the armed services. Both sides denied the others' accusations, and it is this swirl of charges and countercharges that the investigations group—with McCarthy temporarily stepping aside as chairman—is trying to clear up. A further barrier to getting the probe under way on schedule came to light today with reports the new Army document itself is "too general" in some of its language to suit some subcommittee members and staff lawyers.

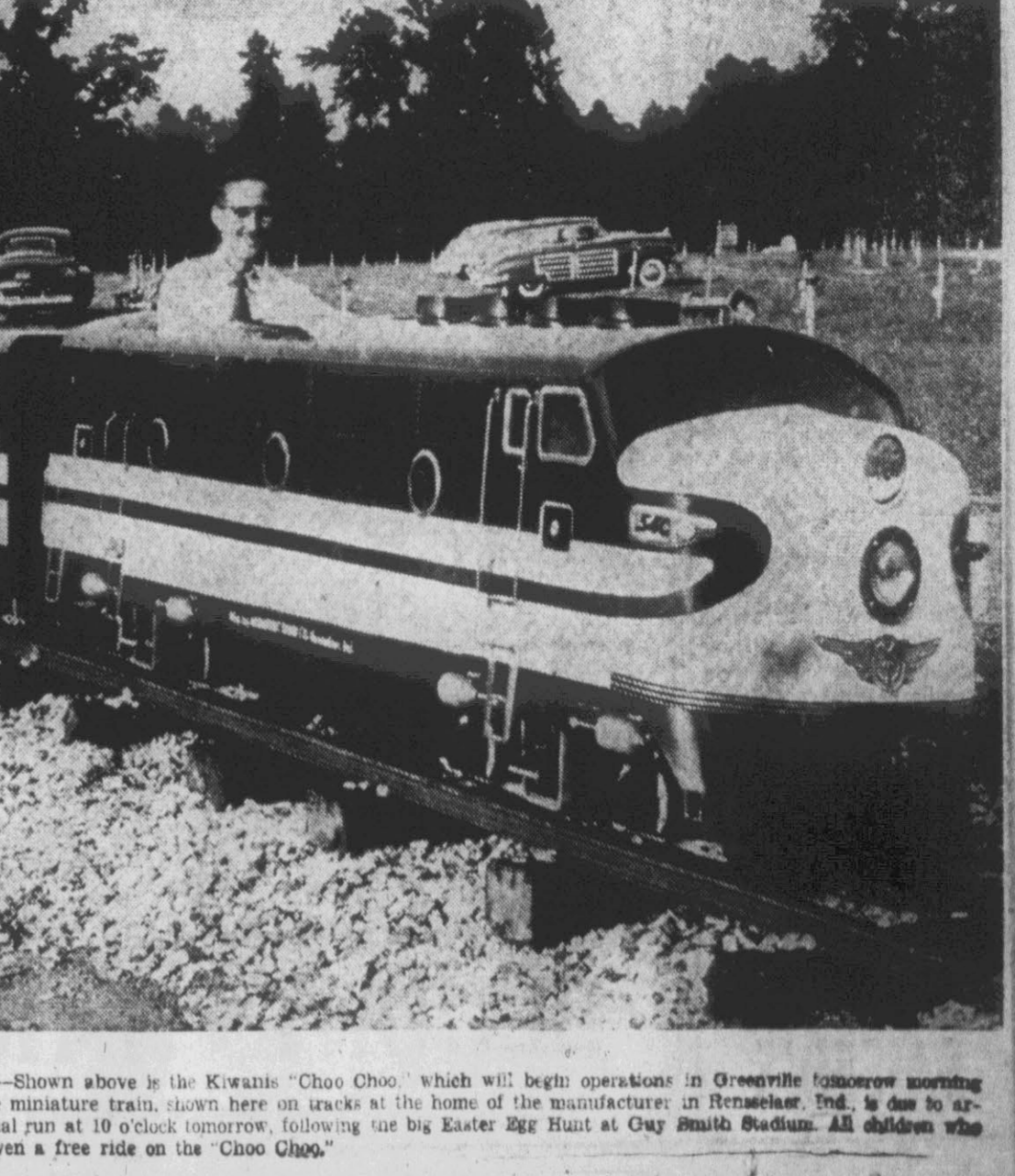
'Something' Pockmarks Windshields In Seattle Area Windshield Damage Rising

SEATTLE (AP)—Superbombs, supernatural or superstition, there was no doubt about it today, the one million people in the Puget Sound country were stirred up by the case of the pockmarked windshields. Some were even blaming H-bombs. And the mayor of this city of 500,000 was trying to stir up the President of the United States. The mayor, Allan Pomeroy apparently was among the believers that something, rather than someone, is damaging thousands of automobile windshields with an unknown substance. The mayor asked the President to "instruct appropriate federal agencies to cooperate with local authorities on an emergency basis." There are doubters, too, who

think an awful lot of people are victims of mass hysteria, suddenly conscious of something that may have happened days, weeks or months ago. "Tommyrot," exploded Dr. D. M. Ritter, assigned by the chemistry department of the University of Washington to assist authorities seeking an answer to the riddle. "There isn't anything I know of that could be causing unusual breaks in windshields," he said after examining several and residue found on the cars. "These people must be dreaming!" One thing is certain: the claims of damaged windshields are mounting into the thousands. And one thing else appears certain: no other glass objects seem to be suffering, not even side windows of cars.

The description of the damage varies from actual holes to pit marks covering every known shape. Chips, scratches, mars, pits holes, crumbling blemishes, blurs, blots and cracks. Some people even claim the damage has happened before their eyes. Law enforcement officials are convinced that some vandalism was involved in cases reported at Bellingham, some, but not all, believe the vandalism spread. Then, this week, other communities south of Bellingham said they had suffered an outbreak of the trouble. Wednesday night it broke out in Seattle. The police switchboard couldn't handle the complaints; neither could the newspapers.

Fifteen talented students of music at the college will have principal parts in the tale of Old Vienna when it is presented on the campus. A chorus made up of members of the Varsity Glee Club and the Women's Chorus of East Carolina will sing, and the East Carolina Orchestra will play.

The operetta presents the drama and pathos of the renowned composer's romance. The music is Schubert's own and was adapted for "Blossom Time" by Sigmund Romberg, composer of "The Student Prince" and other works. Frances Smith of Robersonville will play the part of Schubert's sweetheart Miti. Both Miss Smith and Mr. Murphy sang last year in the Student Government Association's production of "The Student Prince."

Carolyn Clapp of Greenville and Jeanne Pritchard of Elizabeth City will appear in "Blossom Time" as Miti's two sisters, and Ronnie Rose of Goldsboro will take the part of the father of the three girls. 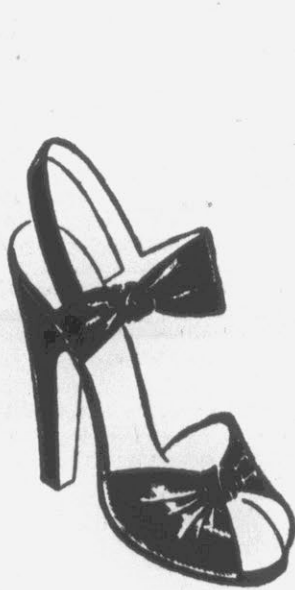

The Passion Play being produced this week by St. James Methodist Church is proving to be a deeply religious experience for those participating as well as for the audience. Many times during the play on Wednesday and Thursday nights a deep hush was over the audience. Many remained in their places during the two intermissions and some sat quietly for a few moments after the "Alleluia" by the Choir at the end of the play. There was no applause, even though no request concerning this had been made on the printed programs, and the audience talked in low tones about the play and left the auditorium quietly when the house lights were turned on.

This was because of the spirit of the members of the cast, technical crew and all connected with the production. One has noted a spirit of devotion to a great task on the part of each individual. Members of the Cast have been reverent and quiet while awaiting their cues, and the changes in scenery have been performed with the minimum of noise.

There are no small parts in this production. Each member of cast and crew feels that each particular part is of importance to the message of the play and each one has given the best in performance of even the most simple task.

Members of the Cast have read and studied the Story of Christ's Passion in the Gospels, they pray that God may speak His message through them, and each one pauses before going on the stage for a moment of silent prayer. It is not surprising that one of the Metho-

dist ministers present last night said: "The Last Supper scene was truly wonderful. I do not see how it could have been more perfect." And that members of the College faculty said: "Truly a great performance."

The initial production of the Passion Play will be long remembered, in Greenville, and throughout the state, not for the authenticity of its costumes, nor for the high quality of the performance by the actors, but for the deeply spiritual message which it has brought to all who have been privileged to witness it.

A Reasonable Basis For Tax Valuation

The yard-stick of one-third actual valuation to be used by the county as the tax valuation of property gives the people of Pitt a more concrete basis upon which to estimate how the revaluation will affect them individually.

As we understand the action taken by the County Commissioners this week, property is to be placed on the tax books at one-third its actual value as found in the revaluation program.

On the overall basis, this new yard-stick probably will make the taxable value of

real property in the county somewhat higher than under the old system which the county has been using. At the same time, however, it will be the one yard-stick which will be applied to both real and personal property in the county for tax purposes.

For the past 17 years the county has used as its basis for real property tax valuation a yard-stick of 60 per cent of the 1937 values. Obviously this medium of measuring the value of property for tax purposes has long since been antiquated even for real property. As far as personal property was concerned, it, of necessity, had to be disregarded almost altogether.

Under the thorough revaluation system used by Pitt County, the actual values on relative pieces and types of property have been arrived at as nearly as humanly possible. By using the one-third rule for arriving at the tax valuation for all property, it should eliminate inequities between different types of property, and remove inequities which have existed among similar types of property.

It is difficult to tell until the one-third rule is applied to the actual values which have been arrived at for Pitt property just how much taxable property there will be on the county's books when the program is completed. It is reasonable to assume that the tax valuation of the county under the new set-up will be higher than it has been. This will be partially due to the new method of arriving at the tax valuation of property, and also to the additional property, or more accurately appraised property listed on the county's books.

The tax valuation of one-third today's actual value seems to us a most reasonable yard-stick for the county to use in arriving at tax valuations.

Another Rathole Being Uncovered

It appears another government rathole through which millions in taxpayers money may have been poured has been uncovered. The big scandal over a portion of the government's housing program which broke last week promises to be bigger and more despicable than it already appears.

There has been a good bit of scandal in the federal government in the last few years. There were the percentage boys who were rooted out, the tax case helpers in influential places in government and a number of others. Now the process of uncovering corruption which has bred in obscurity of government bureaucracy has moved into a new agency.

No stone should be left unturned to bring to full light the conditions which have existed in the federal agency which is now under scrutiny. If the government has been fleeced through some individuals action or through their negligence, those individuals should be called upon to pay the proper penalty.

At the same time, precautions must be taken to keep activities fully out in the open in the future to repeat a recurrence of the same thing again.

Rural Fire Protection Is Making Progress

Rural fire protection in Eastern North Carolina has come a long way in recent years, but it still has a long way to go before adequate protection will be provided for many rural communities.

In Pitt County a number of individual communities have taken steps to set up their own fire protection associations with trucks operated by volunteer firemen.

In the Pactolus section now there is a movement on foot to establish such an association and for the community to issue bonds for the purchase of equipment. In other communities equipment has been purchased by individual subscription association members.

Groundwork is being laid in an attempt to effect the establishment of such an association for the rural section immediately surrounding Greenville.

Obviously reasonable fire protection for all rural areas of our section can not be achieved in a brief period of months. It took a long time to get rural electrification to the point it is today, and to bring rural telephone service to the place it now is. Yet, if the project of rural fire protection is continually pushed by people of individual communities in rural section, the day will come in the not too distant future when fire protection will be available.

It is a project which must be worked on a community basis, and those communities which are forging ahead with their projects are the ones which will enjoy the fruits of their endeavors.

Shadow Cast On Sympathies

WASHINGTON—The Eisenhower Administration's professed sympathy for private enterprise versus public (Federal or State) financing and operation of utilities and certain industries has become suspect in politico-economic circles because of its latest action with respect to the \$400,000,000 project for harnessing wasted water at Niagara Falls.

This new chapter assumes national significance for numerous reasons. In favoring New York State rather than private development of Niagara's boiling waters, Eisenhower seeks to assure a victory for Governor Thomas E. Dewey against Franklin D. Roosevelt Jr., or any other Democratic opponent next fall.

But if the White House favors public promotion here for partisan reasons, it will open the door to similar handling of many other moot developed or undeveloped natural resources—Hell's Canyon, TVA, Bonneville, the Upper Colorado Basin, Passamaquoddy, and, importantly, atomic power.

Thus, the Niagara controversy furnishes an acid test of the Republican philosophy of government on this question. It will answer the question of whether New Deal-Fair Deal policies in this field are to be perpetuated. Its importance cannot be overestimated.

PRESENTS A SHOWDOWN—The Niagara Project, which is the only vast undeveloped resource of its kind east of the Great Divide, presents a clear-cut showdown. It is a water-power affair exclusively, with no such side issues as irrigation, navigation, flood control and conservation. Five great utility firms, headed by Niagara-Mohawk, have pooled their financial and engineering strength, and are ready to build now.

In view of these factors, the House passed the Dondoro Bill for private development by an overwhelming majority last year. It rejected a Dewey measure for state promotion and a Roosevelt-Lehman proposal for another federally sponsored TVA.

Somebody Told Me

Westernized Filipino Culture

(Guest columnist for the rest of this week is Herbert White Lee, who is a former representative of the U. S. State Department and has traveled in many continents. Herb is now living in Greenville and is connected with H. A. White and Sons. Special note: Be sure to see the Passion Play this week and hear me howl like a dog. Jack Edwards.)

The Filipino's hatred of the Japanese goes deeper than the war atrocities committed. It was my impression that the average Filipino was humiliated at having been invaded by a non-Christian, purely Asiatic race. After two centuries of Spanish domination, half a century of American domination, much intermingling of blood and language, and the firm establishment of the Roman Catholic Church, the Filipino of today is culturally more akin to the European than the Asiatic. English is the language taught in all schools. (Actually, you will find many native tongues in the various islands,

but the common meeting ground is English.) Contrary to general belief, the Spanish language is not predominant. It is spoken among the Spanish families of Manila, in all of the better social clubs, occasionally in the show and sometimes over the radio; but usually those who speak Spanish also speak perfect English. It is true that most Filipino names (both family and Christian) are of Spanish origin, and practically all of the city dwellers profess to be pure Castilian or at least part Castilian. Aside from this claim to Spanish lineage, the average Filipino tries to be as American in his ways as possible. He wants American automobiles, movies, soft drinks, cigarettes and whiskey (where he can afford them); American radios, washing machines and refrigerators. When I asked if a certain article were made in the states one store owner said to me: "Meester, if it isn't state-side, we do not carry it." Every Filipino has a cousin, a

brother or an uncle who is an American citizen or who is in the states, which is not hard to believe when you consider the tremendous size of the average Filipino family. It is also true that the United States government offered American citizenship to a great number of those who worked so faithfully in the resistance movement during the war. But the most outstanding examples of American heritage are the Philippine systems of education and government. Their system of public schools was introduced by the Americans in the early 1900's, and has followed precisely the development of schools in the United States. The National Government of the Republic is modeled very closely after our own. Nor was it mere chance that the Fourth of July is their Independence Day. That was arranged by Filipino patriots, and on July 4, 1946 in the course of an elaborate ceremony the flag of the new Republic was raised over the land—the American flag, lowered simultaneously.

What Other Editors Are Thinking

CHRISTIANITY IN BUSINESS (Columbia S.C. State)
The churches of America have started a campaign to attempt to get farmers and business to apply the principles of Christianity to their mundane affairs. Starting this fall conferences in 400 communities over the nation will be held in the next year. The theme is to take the "inspiration of Sunday to the occupation of Monday."

Under a Rockefeller grant the National Council of Churches has sponsored broad research projects into "the ethics and economics of society." The findings are to fill six volumes, three of which are already published. They deal with such matters as goals of economic life, the original revolution, and social responsibility of the businessman.

For years many leaders have urged that religion be applied to daily life and increasingly in recent years we have heard the belief expressed that the hope of the world lay in this direction. The argument makes sense.

The recognized enemy of the world is communism which ignores religion both in theory and in practice. In theory the state is the supreme being. In practice the individual is without rights, his life, his work and his mind belonging to the state. Religion is considered the enemy of the state as it defects a part of the individual from the state.

It therefore follows as logical that if true religion could take

the world it would at the same time take communism—the anti-Christ.
It may be necessary, as some passages of the Bible seem to prophesy, that the anti-Christ first gain supremacy before being finally overthrown by the forces of Christianity to make a true Godly world. But since "the beast" has gained power over such a large part of the world, controlling the thought of a great portion of the populace, and influencing the thought of them, it may have reached its zenith and be ripe for the slide into permanent oblivion.

In any event, any move looking to the spread of religion in daily life is a move toward freedom of thought and the dignity of the individual and peace in the world.

Around Capitol Square

STRATEGY—The high commands of both candidates for the United States Senate have been holding conferences during the past few days—and nights—to map strategy. Proceedings of these conferences are not publicized, but the general course of activity indicate what decisions were made.

Stated in fewest possible words the attitudes of the respective organizations appear to be: The Lennon folks are trying desperately hard to get some real interest in the campaign; the Scott folks are trying just as hard to keep it quiet.

The Scott strategists reason that their candidate is well known throughout the state, and by reason of that wide acquaintance was far ahead in voting strength when the campaign opened. All they have to do to win is to hold what they've got—and the less fuss made about the situation the better for them.

The Lennon strategists concede that Scott is better known, but question the extent of his lead in votes. Their job is to get their man known and to acquaint the voters with what they consider the vulnerable points in the Scott record. To do that they must arouse real interest. To that end they have attempted to "needle" Scott into making more statements like the one at Ahoskie about the bankers supporting him and the American Trust Company offering to help out—a statement which was promptly denied by the bank.

him out on a limb. Back of the Lennon strategy is the idea if they can ever get the other man to talk he will tangle himself up. It is a paradoxical situation when the so-called conservative wants to stir up "trouble" and the labeled liberal wants to keep everything quiet.

ABSENTEES—Absentee voting in the primary is limited to military personnel. Just how many Tarheel young men and women of voting age are in uniform is not known, but there are certainly several thousand of them. Apparently they are not concerned about the primary. Up to Friday morning the requests received by Secretary of State Thad Eure for absentee ballots numbered 32.

The procedure is for the applicant to send request to the Secretary of State, who forwards it to the chairman of the board of elections in the county of the applicant's residence, who, in turn, sends it along to the precinct registrar. The application for ballot, sent to the voter to registration if not already on the precinct books.

All of this must be done in time for the registrar to mail back the requested ballots, which the voter will mark and have witnessed by a competent official and return in time to be counted on election day.

Applications are expected to speed up during the next three or four weeks, but on present showing the absentee military vote in the primary will be negligible, amounting to perhaps not more than 500 for the whole State.

AID TO HANDICAPPED—By way of Col. Gaston's (J.W. At-

kins) column in the Gastonia Gazette comes information on a novel venture in the textile capital. Mill Motor Repair, Inc., is a new firm with the avowed purpose of giving lucrative employment along with technical training to physically handicapped persons. This particular project deals with rewinding coils in electric motors and other motor repairs. The idea is susceptible to almost unlimited expansion.

Col. Gaston says "You'd probably be surprised, as I was, to learn how many physically handicapped people there are—and how alert they are mentally."

RE-ORGANIZATION—The commission to study re-organization of State Government, authorized by the last General Assembly and appointed last fall by Governor Umstead, is on the job. Information is that the members of the commission, which is chaired by Rep. William B. Rodman, were appalled at the magnitude of the job confronting them when they began the studies, and decided to limit activities to purely administrative agencies.

Several members of the staff of the Institute of Government at Chapel Hill are devoting practically full time in research to aid the commission.

The term "administrative agencies" is somewhat elastic, but is usually defined as those performing functions not directly related to any specific division of government—legislative, executive or judicial—but including some phases of all three.

Local Manufacturing

A way to develop local manufacturing has been developed and proved—by the Greater Paterson, N.J., Chamber of Commerce.

It staged an exhibition of inventions in search of manufacturers. As a consequence, two inventions are going into production, two more seem likely, and 20 more are under consideration.

The Paterson area has a large number of small manufacturing plants, many of which have curtailed activities because of the decline in defense orders. So the chamber devised the show in expectation that it would increase manufacturing and employment in the area.

It broadcast invitations to inventors to display inventions that were not yet in production. American inventors were charged a \$5 fee and foreign inventors \$10. All had to show proof that patents had been obtained or were pending. Patent brokers, foreign consulates and individual inventors submitted devices and gadgets, in model or in blueprint. They were displayed in the chamber's building.

Then manufacturers were invited. In addition to general invitations, many were specialized; auto firms were invited to send representatives to inspect certain devices for automobiles; tool manufacturers were asked to inspect new tools, and so on. Four hundred manufacturers attended, according to Charles F. Feuerbach, manager of the manufacturers' division of the chamber. Inquiries have started coming in from other cities and it looks as if there will be a lot of inventor-manufacturer shows around the country before the snow flies again.

PRICE CUT, DISTRIBUTOR PICKETS AND IS PICKETED

A distributor picketed a New York discount store that sold his brand of vacuum cleaners at a cut price, and he himself was picketed by a store employee. The store advertised \$59.95 cleaners for \$52.95. Thereupon, Dave Stern, the New York dis-

tributor, started marching in front of the place with a sign warning that cleaners purchased from unauthorized dealers did not carry factory guarantees. The store thereupon put its own sign on the door with a sandwich board announcing that the store would guarantee all cleaners and make any needed repairs in its own shop.

GOVERNMENT SEEKING POWDERED TOMATO JUICE

Now that it has developed a powdered orange juice, the Department of Agriculture is trying to devise a powdered tomato juice. Work is under way at the Western Regional Research Laboratories, Albany, Calif.

BURGLARS, PLEASE READ NO FURTHER!
A study by a lock company discloses that while most stores have elaborate lock and alarm systems to protect their front doors, many do not have adequate safeguards on rear and basement doors. Police officials are quoted by Master Lock Co., Milwaukee, as saying that stores with 500 locks on front doors and 51 locks on rear doors are considered burglar proof. They aren't so conspicuous.

KOREA DRAFTS TERMS ON WHICH IT BUYS

The Republic of Korea Office of Procurement has drawn up detailed procedure for firms wishing to sell to the Korean government. Copies of the terms and conditions can be obtained from the Office of Small Business, Foreign Operations Administration, Washington 25, D.C.

TOILETRIES REACH SECOND \$1-BILLION YEAR

Sales of perfumes, cosmetics and other toiletries topped a billion dollars for the second time last year, according to the Toilet Goods Association. Retail sales totaled \$1,020,800,000 according to the association. That's a gain of 1.6 per cent over 1952, the first billion-dollar year.

of law, along with authority to enforce these regulations, and to sit in judgment upon alleged violators. The task of establishing uniform procedure and eliminating overlapping functions among these agencies, is big enough for one study commission without venturing into the broader field of re-organizing the constitutional functions of the legislature, activities of departments directly under members of the Council of State, or the courts.

The recognized need for revision and adjustment in some of these areas more properly belongs to a constitutional convention than to a temporary legislative study commission. The total job is too big to be handled in a few months. Experience has proven that legislation based on too scanty information has contributed largely to the present confusion—and contributed very little toward solving the problems involved.

Next Biennium School Outlays Still Uncertain

RALEIGH (AP)—Gov. Umstead doesn't know how much money will be available to operate the schools during the 1955-57 biennium.

But he told reporters at his news conference yesterday, "I'm certainly not in favor of any backward step in education." He added "Of course, we've got to operate in this state on a balanced budget."

The governor's remarks were prompted by questions as to whether he is opposed to any move to freeze school appropriations at their present levels.

He said that actually he did not know what was meant by "freezing" school appropriations. Does it mean a freeze in the overall appropriation, a freeze in salary scales, or something else?

The so-called freeze talk started after a speech by Dr. Charles F. Carroll, state superintendent of public instruction, before the state PTA convention last week.

Dr. Carroll said, "Any talk about a freezing of financial support for adequate educational opportunities for North Carolina youth comes too late."

Last night, Dr. Carroll explained he had not heard of any movement to freeze school appropriations although he had heard an occasional suggestion that "perhaps no money would be available."

He said his statement before the PTA was a figure of speech carrying the "main" thought that we need more money just to stand still—and, of course, much more if we want to go ahead."

Gov. Umstead asserted, "I don't see how you can freeze school funds to show up more children continue to long up each year for the first grade."

Profits Picture Is Not At All Gloomy

SAN FRANCISCO (AP)—Profits are holding up better than many expected.

A nice handful of corporations are reporting that net earnings after taxes in the first three months of this year topped their first-quarter showing last year. This helps to offset those whose profits are feeling the pinch of the business activity slump which started almost a year ago.

Increased sales are announced by many companies—to confound the pessimists. Other corporations whose sales are off from a year ago still show earnings as good or better than last year. Some credit the death of the excess profits tax. Others report operating costs cut by use of more economical plants and equipment.

Many a corporation, however, can't join this happy throng yet. The list of those reporting sales down and profits off along with them is a lengthy one and doubt less will grow as the flood of first-quarter earnings statements approaches its crest at the start of May. But even among those are many who report profits holding up better than sales, thanks to tax changes and cost cutting.

When all first-quarter corporate returns are tabulated the results may well show profits, lower on average than a year ago—but not by as large a percentage as many once feared. The bears reasoned—when corporate earnings for the first three months of 1953 slipped by 10 per cent, on average—that a much steeper slide would take place in the early months of 1954.

Earnings statements are just starting to come in. But clues to profits are being given in greater volume by corporate chiefs report-

ing to their stockholders at annual meetings now in full swing around the country.

Du Pont is a good example of a company whose sales slid in the first quarter, as compared both to the previous year and to the final three months of 1953, but whose profits rose. The chemical giant's sales dipped 8 per cent in the first quarter and were 3 per cent below the final quarter. But its president says net earnings in the first three 1954 months should be higher than in either of the 1953 periods.

Companies reporting both sales and earnings up include Rayonier, Columbia Co., S. Regis Paper, Commercial Solvents, M. A. Hanna, Pure Oil, Elico Products and a long list of banks.

Sales off but profits about as good or better are indicated by American Tobacco, Goodyear, E. F. Goodrich, Thompson Products, Chain Belt and Farris, Davis.

Increased sales this year (with earnings yet unreported) are announced by Ford Motor Co., General Tire & Rubber Norge Division of Borg-Warner, California-Pacific Utilities and Century Electric Co. among others.

Many industries, of course, show a much less pleasing picture. But often company executives temper their reports with predictions of better days.

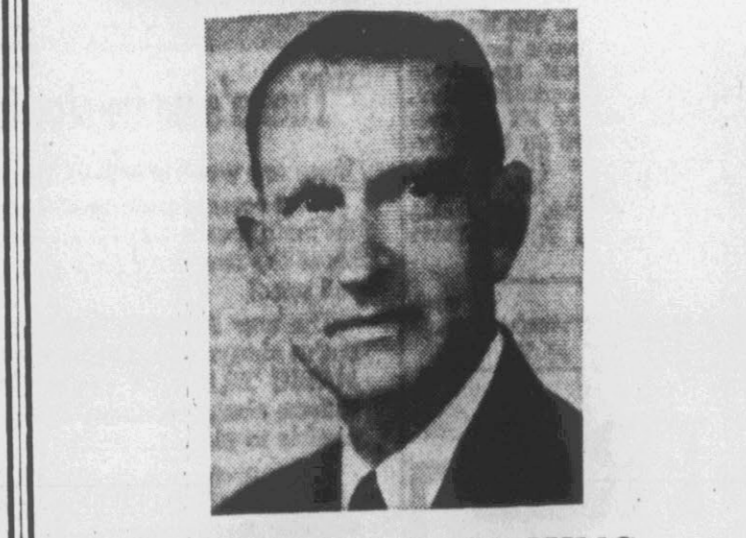

"We have two, good, solid offers—and either one of them would put each of us in the five-figure salary bracket."

"What are they?"

"I can't say. In fact, I can't even give you a hint. But there's just the slightest chance we'll stay at Rio Grande. If we don't form our own team, we'll go pro. Nothing's definite yet, but it's going to be a hard decision to make."

"Were you really in Cincinnati, or somewhere else?"

"I was in Cincinnati last night to see the Harlem Globetrotters and the College All-Stars."

"Did you talk to Saperstein (Abe Saperstein, owner of the Globetrotters)?"

"I can't say who I talked to. But you don't think I went down there for my health, do you?"

"What about that 'slight' chance you and Bevo will be back at Rio Grande next year? Are you two going to be together or not?"

"When the college dropped Bevo, they busted the biggest publicity bubble in basketball history. But if he doesn't come back, it's just as certain as the sun comin' up in the morning that I won't be back here either. Bevo'll be playing basketball somewhere next season, and you can bet your life I'll be right there on the bench. We'll be together, no matter what happens."

Manager Eddie Stanky of the St. Louis Cardinals must be wondering today whether all that pre-season pitching by his Big Three was only an early spring night's dream.

It was only a few weeks ago that Harvey Haddix, Vic Raschi and Gerry Staley were racking up goose eggs all over the lot.

But in successive starts since the regular season began Haddix and Raschi were pounded off the hill before they could even draw a deep breath. Haddix got his lumps opening day, pounded for five hits and four runs in less than three innings by the Chicago Cubs.

Raschi made his National League debut in Milwaukee yesterday and the former Yankee ace fared even worse. He was pulled in the second inning after he had been slugged for four hits and as many runs.

The Cards fought back to tie the game with a run in the eighth and three more in the ninth but Billy Bruton walked in the 11th and raced all the way home with the winning run on Danny O'Connell's single to right and Rip Russell's bobbie. The 7-6 defeat was charged to reliever Haddix, his second in two games. A record crowd of 39,963 saw southpaw Warren Spahn go all the way for Milwaukee.

Staley, the third member of the big trio, is due to make his 1953 bow in Chicago tomorrow. The only other winless club in the majors are the Chicago White Sox, who dropped their third in a row at Baltimore celebrated its first American League home opener since 1902 with a 3-1 victory before 46,354 wildly cheering fans. Bob Turley, the sophomore speedballer, permitted seven hits and struck out nine for the Orioles. Home runs by Clint Courtney and Vern Stephens sent Virgil Trucks down to defeat.

Cincinnati's hard-hitting Redlegs remained the majors' only unbeaten team, pounding out an 11-5 decision over the Cubs for their second straight. Jimmy Green-glass, who tied a record with four doubles on opening day, added a fifth two-bagger and walloped a bases-loaded home run to highlight a six-run seventh for Cincinnati.

A slim gathering of 12,498 hardy souls braved the wintry blasts at Ebbets Field and were rewarded by a 7-4 Brooklyn victory over the Pittsburgh Pirates. Three Dodger home runs all off loser Max Surkon, accounted for six runs. Andy Campanella hit his third of the season with two on Junior Gilliam hit his second and Jackie Robinson his first with a runner on base. Russ Meyer was the winner but he needed help from Jim Hughes in the eighth.

Veteran Murry Dickson got the better of a pitching duel with the New York Yankees. Three Dodger Phils blanked the Philadelphia Phillies 2-0 in a game cut to two innings because of rain. Andelli yielded only three hits but two of them were damaging drag bunts. One was made by Ted Kazanski, who took second on Antonelli's wild throw, third on a passed ball and scored on a fly in the fifth. The second was made by slugger Del Ennis, who squeezed Willie Jones home with two out in the sixth.

Four teams were tied for first place in the American League with 2-1 records. Detroit blasted Cleveland the first defeat of the season 3-2, scoring the winning run in the ninth on two walks, an infield single by Bill Tuggle and an infield out by Matt Batte. Reliever Ralph Branca was the winner and Mike Garcia the loser.

The New York Yankees joined Cleveland, Detroit and Baltimore at the top, defeating the Philadelphia Athletics 2-0 on Tom Moran's eight-hitter. Eighth-inning home runs by Hank Bauer and rookie Bill Skowron off loser Alex Kellner broke up a close hurling duel.

Catcher Sammy White drove in three runs with a home run, double and two singles in four times at a 6-1 victory over Washington. Lefty Bill Henry hurled a three-hitter.

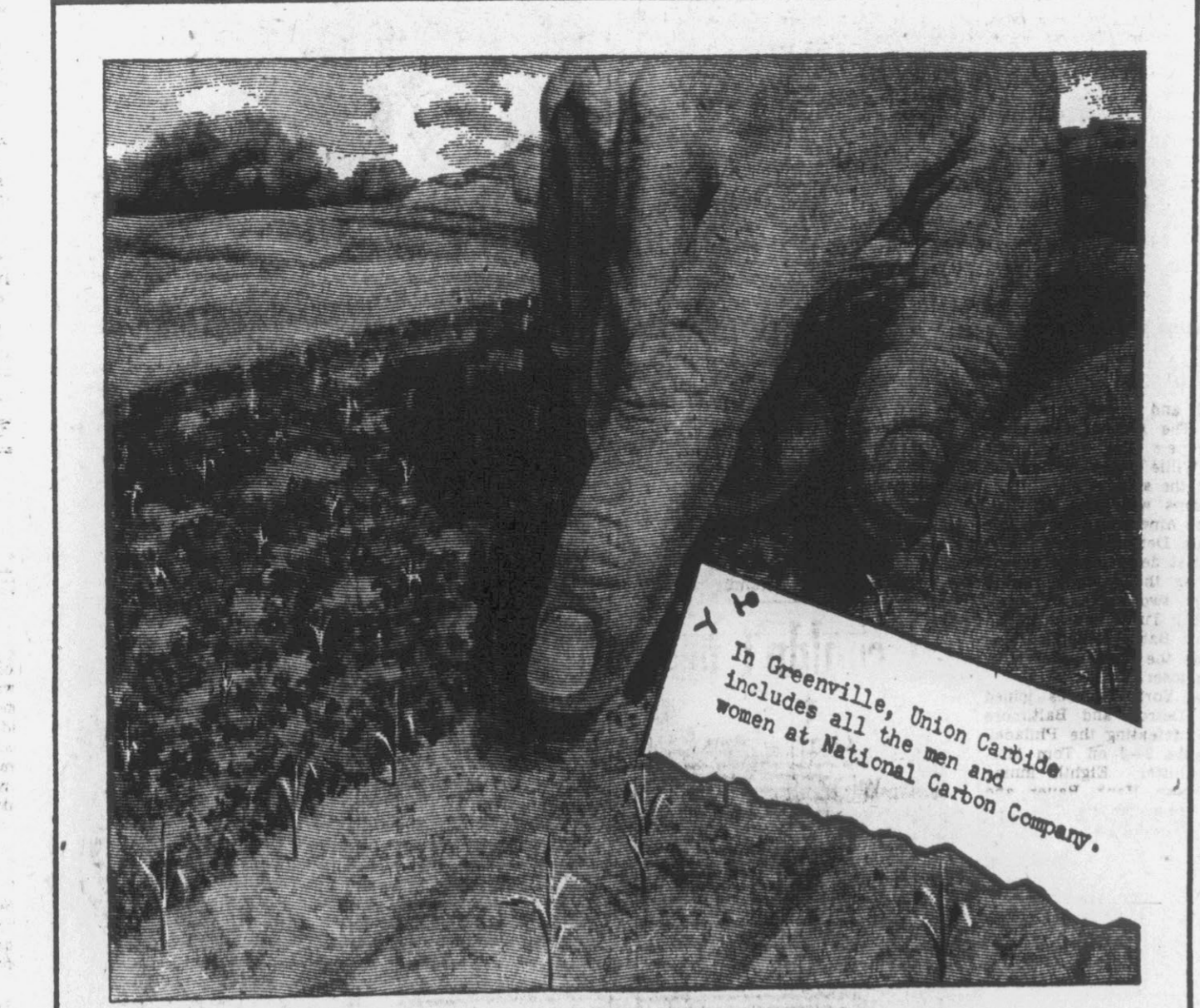

Scripture—John 19:41-42; 20-21.



On the first day of the week, Mary Magdalene went early to Jesus' tomb; she found the stone rolled away and the tomb empty.

Peter and John went home, but Mary returned to the tomb and saw two angels who asked her why she wept? Because her Lord had been taken away, she said.

In the evening of the same day, as the disciples were assembled with the doors locked because they were afraid of the Jews, Jesus stood in the midst of them, saying, "Peace be unto you, and showed them His hands and side."

Thomas, who was not present when Jesus appeared to His other disciples, doubted His resurrection, but when the Lord again appeared and Thomas saw His wounds, he too believed.

JESUS APPEARS TO MARY MAGDALENE, THEN TO HIS DISCIPLES

Scripture—John 20:1-18; 20-31.

By NEWMAN CAMPBELL. EASTER DAY, the Lord has risen. All nature rejoices at this time. The leaf buds are opening on the trees, flowers are blooming or about to bloom; birds are singing as they build their nests, and, above all, our scripture tells us that Jesus Christ rose from His tomb on such a day, centuries ago. He died for our sins, but He rose again!

The first two verses of our lesson (John 19:41-42), describe the tomb in which Jesus' body was laid. It was a new tomb in the private garden of Joseph of Arimathea, the Pharisee who was secretly a disciple of Christ's. It was sealed with a great stone and soldiers guarded it at night. Very early in the morning Mary Magdalene went to the tomb, before it was light. The first thing Mary noticed was that the stone had been rolled away; then she looked in and the tomb was empty. She ran to meet Peter and John, and told them, and

side, and the disciples were overcome to see their Lord. Now Thomas, called Didymus, was not with his brethren, and when he heard of Christ's appearance to them he said, "Except I shall see in His hands the print of the nails, and put my finger into the print of the nails, and thrust my hands into His side, I will not believe."

This disbelief is the origin of our modern saying, when a person expresses doubts, that he is a "Doubting Thomas."

Eight days after this Jesus came to them again, and this time Thomas was with them. Jesus told him to "reach hither thy finger, and behold My hands; and reach hither thy hand, and thrust it into My side; and be not faithless, but believing."

Thomas answered and said, "My Lord and my God!" Then Jesus said to Thomas, "because thou hast seen Me, thou hast believed; blessed are they that have not seen, and yet have believed."

they looked in the tomb, and then Peter went in and then John.

They saw the linen that had wrapped the Body lying there, and the napkin that had been about His head neatly folded in a place by itself, but "as yet they knew not the scripture, that He must rise again from the dead."

The two men went home, John writes, but Mary stood without the sepulchre weeping. She saw two angels in the tomb, and they asked her why she wept? She said, "Because they have taken away my Lord, and I know not where they have laid Him."

Turning away from the tomb Mary saw Jesus, but weeping, she did not know Him. He said to her, "Woman, why weepest thou? Whom seekest thou?" Thinking Him to be the gardener, she said, "Sir, if thou hast borne Him hence, tell me where thou hast laid Him, and I will take Him away."

Jesus spoke her name, "Mary," and she knew it was He and joyfully called "Master." He told her to "go to My brethren, and say unto them, I ascend unto My Father, and your Father; and to My God, and your God."

So Mary told the disciples, and that same evening, when the doors were shut where the disciples were assembled, "came Jesus and stood in their midst, and saith unto them, "Peace be unto you." He showed them His hands and

The next time the disciples saw their Lord he appeared to them at the Sea of Tiberias. Simon Peter told the others he was going fishing and they took a ship and went out, but caught no fish. In the morning Jesus stood upon the shore, but the disciples "knew not that it was Jesus."

Jesus told them where to drop their nets to find fish, and their nets became full. There was a fire on the beach, and at the Lord's bidding they brought the fish to shore and all ate.

"So when they had dined Jesus saith to Simon Peter, Simon, son of Jonas, lovest thou Me more than these? He saith unto Him, Yes, Lord; Thou knowest that I love Thee. He saith, Feed My lambs."

"He saith to him again the second time, Simon, son of Jonas, lovest thou Me? He saith unto Him, Yes, Lord, Thou knowest that I love Thee. He saith, Feed My sheep."

The third time Christ asked Peter the same question, and that grieved Peter because he thought Jesus doubted his love. A gain Jesus told him, "Feed my sheep."

Jesus' last command to His earthly brethren was "Follow thou Me." That is what we all should do, as His disciples spent their lives in doing His work, preaching His word, suffering even martyrdom before they followed Him to heaven.

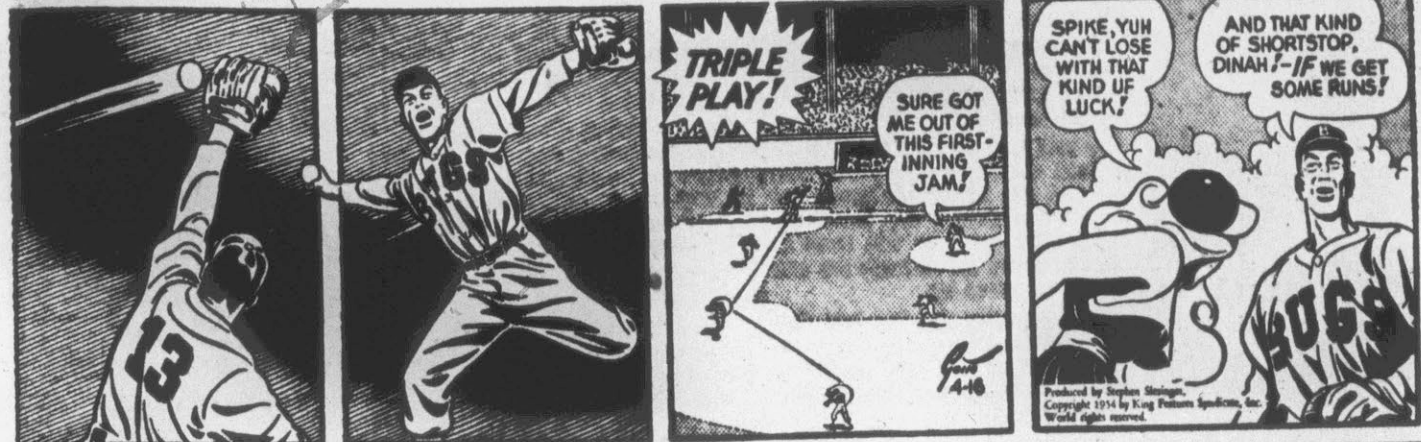
