REBELS CAPTURE DIEN BIEN PHU

Money Set For Airport Project

By BOB BOYETTE Reflector Staff Writer Airport appropriation, hearing appeal of the building code, and discussing the appointment of a local Zoning Commission highlighted the night's activities at the regular monthly meeting of the Greenville City Council last night.

W. H. Watson, who represents the City of Greenville on the East Carolina Airport Authority, came before the Council requesting that \$4,344 be appropriated for use by the Authority for purchasing options on the site for the four county-four city airport.

He explained that he could not divulge the proposed site for the airport but said, "It is advantageous to the City of Greenville."

It was voted by the Council to request the Pitt-Greenville Airport Commission to give \$2,500 to the City of Greenville and upon receipt of this amount the city would thereupon deliver a check for the balance to the East Carolina Airport Authority for use in purchasing the options.

Watson told the Council then that the Authority had a "three stage planning program." We intend to first build a runway 4,800 feet long and 150 feet wide with further extension of this runway to 8,200 feet which would make it an "Express Airport" which would take care of anything that flies today.

Appeal Of Building Code N. O. VanNortwick, Jr. of the North Side Lumber Company came before the Council asking that he be allowed to build a lumber shed with walls that were not 12 inch masonry as required by buildings in the industrial zone of Greenville.

He explained that he desired to build the lumber shed now but did not want to make it with 12 inch masonry walls. The Council explained that if they made an exception to the

rule other businesses would desire an exception. They told him to re-design the building so it would not have to conform with the building code. Councilman S. Eugene West offered to help him re-design it so it would be strictly a shed and not a building and therefore would not be required to have the thick walls.

Appointment of a Zoning Commission came before the Council at this point, but due to differences of opinions among the members action was deferred on this matter until the next meeting.

City Manager James S. Hughes was instructed to write other towns for information on their Zoning Commissions between now and the June meeting of the City Council.

Loss New City Tags At a recent meeting of the City Council a new city license tag which was to be the same size of the state tags was authorized for next year.

At last night's meeting it was brought out that the State tags next year would again be in duplicate and therefore the large tag authorized by the Council at the past meeting could not be used.

This tag authorized by the Council before would have an outline of the State of North Carolina and would be colored green and white.

It was voted last night to cancel the order for those tags and it was decided to again use the same type tag that is now being used on cars here.

Soil Tests Made City Manager James S. Hughes reported to the Council that soil tests for the two proposed pools here had been made.

He said that land at both Elm Street Park and South Greenville School had proved satisfactory for building the two pools. He added that he hoped to have a preliminary report from the architect who is designing the pools in the near future.

Human Waves Smother French Fort

By THE ASSOCIATED PRESS PARIS—Dien Bien Phu has fallen. Premier Joseph Laniel announced late today the northwest Indochina bastion "has been submerged."

A little fortress named Isabelle, site of the French Union garrison's main artillery, still was holding out three miles south of the bloodied, muddied bastion that had epitomized the Indochina war to the world for 57 days.

One of the last orders Brig. Gen. Christian de Castries, the lanky commander in chief, sent to Isabelle was to fire on his own command post when the Communist-led rebel riflemen finally cut through.

There was no immediate word as to the fate of Gen. de Castries, commander of the fallen garrison, nor that of Genevieve de Galard Terraube, a French nurse and the only woman in the besieged fort. She had been decorated for gallantry twice within the week.

Premier Laniel told the National Assembly counterattacks had been launched in a vain effort to block the rebels from making a juncture in attacks from the northeast and the southwest, but the defense efforts failed.

The government has just learned that Dien Bien Phu has been submerged after 20 hours of uninterrupted combat, Laniel said.

Laniel said: "The French reaction will be the reaction of the virility of a great nation."

He added that France will confirm its instructions to its delegates at Geneva without admitting that the fall of Dien Bien Phu can change anything.

"France will recall to its Allies that during seven years it has never quit defending alone a great region of Asia," Laniel told the Assembly.

All the deputies in the Assembly stood while Laniel announced the fall of Dien Bien Phu—except the Communists. They remained seated.

Gen. Ho Nguyen Giap's rebel siege forces, bidding for victory until when the Geneva conference started negotiations for an end to the 7-year-old war outnumbered De Castries' garrison by 4-to-1 or more.

De Castries was estimated on the eve of the showdown battle to have 14,000 men, including wounded at his command. These were Frenchmen, Foreign Legionnaires, Vietnamese and North Af-

ricans. There were about 1,000 wounded in underground bunkers of the fort. All efforts for a truce to evacuate them had failed.

The fortress, situated in a broad flat rice plain about six miles long and half that wide, was pounded by artillery and mortars during the long days of the siege.

Each new wave of infantrymen bit off a bit of the original fortress until when the attack started during the past night, a field lit by a bigger than a baseball diamond remained in which the defenders were concentrated.

Defense of the little fortress was made difficult by the fact that all the surrounding hills were held by the Vietminh and, to the surprise of the French Union forces, they were strongly supplied with artillery, for the first time in the more

than seven years that they have been fighting the French.

Beyond that, also they had anti-aircraft guns which some French and American officials insisted were manned by Chinese crews, a fact never formally established.

The end result was, however, that plans to supply the fortress with an airlift from Hanoi proved expensive and extremely difficult. Planes had to drop their supplies from a high altitude, so that much equipment fell immediately into Vietminh hands.

The Dien Bien Phu battle marked the first all-out frontal fighting that the war in Indochina has developed in its nearly eight years. The Communist-led Vietminh hold areas spotted throughout Indochina, but French Union

forces still possess the main cities, Hanoi, Saigon and Haiphong. There has been speculation that a rebel success at Dien Bien Phu would pave the way for attacks on Hanoi, 180 miles to the east.

Meanwhile the Geneva conference is ready to take up the problem of making peace in Indochina. The intensity of the Dien Bien Phu attack showed the Communists' determination to present its capture as an accomplished fact before the diplomats at Geneva.

Scores of planes supplied by the United States helped the French Union forces defend Dien Bien Phu, but no U. S. Air Force fliers participated. However, American civilian fliers employed by private concerns did participate in air drop operations, and only today two of these men were lost.

Russian Arms Mid-Air Explosion Kills U.S. Pilots

MANAGUA, Nicaragua (AP)—President Anastasio Somoza says a large cache of Russian-made arms has been found on Nicaragua's Pacific coast, and he believes they were landed by submarine.

The President displayed the arms—rifles, machineguns, hand grenades, pistols and ammunition, all in weatherproof packing—to foreign diplomats yesterday.

He told a press conference a mysterious submarine had made several visits to the isolated beach where the arms were found, between Montelimar and El Tamarindo. The spot was marked by a buoy, and the hiding place was about 300 feet inland.

Somoza termed it all "very serious business." He added he did not know whether some international organization wanted to make Nicaragua a "second Korea" or whether the cache was intended to revolutionists who staged an abortive coup early last month.

The other American killed was Wallace Abbott Buford, 28, of Ogden, Utah who narrowly escaped death 10 days ago when his plane was riddled by AA fire, which wounded the American pilot with him.

An official French command announcement said the cause of the explosion was not known but unofficial observers thought possibly it had been hit by Vietminh anti-aircraft fire.

From at least three previous missions over the embattled fortress, McGovern had returned with his big G119 riddled with machinegun and rifle bullets.

A veteran of Chennault's Flying Tigers in China, McGovern served with the 14th Air Force and was credited with shooting down four Jap planes, damaging five and possibly destroying one on the ground.

After his release from the Air Force he began flying commercial planes in China.

Call For End Of Spectacles, Clean Up Mess Demos Rap GOP Inaction

WASHINGTON (AP)—Democrats have put up a cry for the administration to be done with "circus luxuries" and "TV spectacles" and come up with action to prevent a cold war from blowing hot.

The Republican campaign slogan of 1952 "Clean Up the Mess in Washington," was thrown back at the party in power last night at a Jefferson-Jackson Democratic dinner that brought out an estimated 1,500 diners at \$100 a head—or \$150,000 for the drive to elect a Democratic Congress this fall.

Speakers told the cheering throng that Republicans have created "messes of their own" and have suffered serious "reversals" on the Indochina question.

Unlike many previous \$100-a-plate dinners by the Democrats in Washington, last night's glittering affair was generously attended by Southerners. They sat alongside old "New Dealers" and "Fair Dealers" in at least an outward show of unity.

Former President Truman, who with his family, was a featured guest, told the diners in a brief informal talk: "As leaders of the free world we must have the friendship of our allies and we can't have that if we insult them."

Sen. Lyndon B. Johnson of Texas, Senate Democratic floor leader, declared the Eisenhower administration has been "caught bluffing" in our enemies' and this country now stands in danger of being "left naked and alone in a hostile world."

Rep. Sam Rayburn of Texas, House minority leader, said the people heard a lot about a "mess" in 1952 "and you are hearing a great deal more now." He said Sen. McCarthy (R-Wis) is the "problem" of the Republicans, not the Democrats, and declared that if the principals in the McCarthy-Army scrap were Democrats, all Republicans and a majority of the newspapers would be saying:

"This is the biggest mess that Washington has ever witnessed."

Adlai E. Stevenson, the Democratic presidential candidate in 1952, sent a message predicting that the Republicans will have "considerable experience as a minority after November of 1954." He himself was not able to attend the banquet because of a kidney operation.

Dies For Killings And Beheading

COLUMBIA (AP)—Raymond Carney died in the electric chair here today for the killing of an ex-Air Force man whose attractive young date he admitted beheading.

It took six minutes and five 2,400-volt charges to bring death to the lanky 38-year-old Negro. A crowd of 58 people watched Carney die for the death of H. B. Allen, 22 of Latta and for the beheading of Betty Clair Cain, 15, of Pimlico last December at a river bank lovers' meeting place near her home.

"To the people that I caused their heart to be broken, I hope they will forgive me," Carney said in a short written statement read by a prison chaplain, after the condemned man was strapped in the chair.

Allen's father and three uncles, and two uncles of Miss Cain were among the witnesses. Carney's 20-year-old daughter, Glendora Carney, waited outside the prison to claim the body.

Japan Will Get Four Destroyers

TOKYO (AP)—Japan expects to get four destroyers from the United States under a proposed lend-lease agreement being negotiated under the recently approved mutual security pact.

McCarthy Told Watch Language

WASHINGTON (AP)—Sen. McCarthy today denounced one of the original Army charges against the McCarthy camp as "this lie" but was ordered to withdraw the word.

Ray H. Jenkins, special counsel for the Senate Investigations subcommittee, sternly told the senator his language was improper in a question to Secretary of the Army Stevens.

Chairman Mundt (R-SD) ruled McCarthy could ask whether the charge was "true or false."

The charge, originally put out by the Army but not included in the formal Army bill of specifications for the McCarthy-Army hearing, was so "upset" by Army Cohn was so "upset" by Army handling of Pvt. G. David Schine he could not attend a luncheon on Dec. 10. Cohn is general counsel to the McCarthy subcommittee.

McCarthy said Cohn had "exploded that lie" in telling about the matter on a TV program. He asked Stevens whether it was not true that Cohn did not attend the luncheon because Cohn's father was ill in New York.

The luncheon, at the Carroll Arms Hotel here, was attended by McCarthy, Francis P. Carr, chief of the McCarthy committee staff, and Stevens.

Stevens testified the charge was not "false." He insisted Carr had told him at the luncheon that Cohn was very upset about Schine.

Big Three To Propose Parleys Open Saturday Will Ask Start Indochina Peace Talk

GENEVA (AP)—The Big Three Western powers decided today to propose to the Communists that the Indochinese peace talks begin tomorrow afternoon.

The last apparent obstacle for the opening of the talks was removed when the French agreed to have the chairmanship rotate between British Foreign Secretary Anthony Eden and Soviet Foreign Minister Vyacheslav M. Molotov.

This was understood to be satisfactory to the Communists.

The Western powers agreed to have W. D. Allen, British undersecretary of state for foreign affairs, notify Soviet Deputy Foreign Minister Andrei Gromyko that the West is ready to meet tomorrow. It had been arranged several days ago that the meeting would be convened whenever the Western

delegations were ready.

Final strategy was discussed at a midday conference of Eden, French Foreign Secretary Georges Bidault and Undersecretary of State Walter Bedell Smith. French sources said Bidault planned to open the conference with a statement about the plight of the sick and wounded at beleaguered Dien Bien Phu. These sources said, however, Bidault did not want the question of a Dien Bien Phu truce to be discussed by the conference. France has taken the position that this should be discussed by the two sides on the spot and not here.

Proponents Hail Seaway Victory

CHICAGO (AP)—Proponents of the St. Lawrence seaway today hailed victory in their 20-year fight for congressional enabling legislation but tempered their rejoicing in the realization that fullest benefits are many years away.

The House yesterday approved a bill to authorize a 27-foot-deep channel in the International Rapids section of the St. Lawrence River.

Gov. G. Mennen Williams of Michigan said the action "means that the major barrier to making Great Lakes cities inland seaports will be removed."

The measure returns to the Senate, which had previously approved it, for concurrence in minor House amendments. Then it will go to President Eisenhower for signature into law. The President had advocated the seaway as a defense measure and yesterday, after the House acted, said it would also "contribute materially to the economic well-being and security" of both the United States and Canada.

Seaway proponents from the upper Great Lakes region, however, already had set a new target—supplementary all-U. S. project deepening channels into Lakes

Huron, Michigan and Superior, where navigation is now restricted to 21 feet for upbound ships and 25 feet for downbound ships.

The measure authorizing the 27-foot channel into Lakes Ontario and Erie contemplates a joint project with Canada. It would enable ocean-going ships to move inland as far as Toledo Navigation of the river where the seaway canal would be dug now is restricted to vessels of a draft of 14 feet or less.

The House's 241-158 vote for the seaway yesterday, however, evoked no official enthusiasm in Ottawa. Prime Minister Louis St. Laurent said Canada was prepared—and many believed she preferred—to go it alone. That would mean Canada would set and collect all the tolls.

St. Laurent's statement said the government has not changed its position from 1951, when Parliament authorized construction of the whole 305-million-dollar project, but he said he will discuss any "specific proposal" with the United States.

As a joint project, the U. S. share is estimated to cost 105 millions, Canada's 200 millions.

City Council Fails Appoint Zoning Commission

Greenville City Council failed to appoint a Zoning Commission at their regular monthly meeting last night.

The appointment of a Zoning Commission was one of the items of business to come before the local city government body, but due to a disagreement on whether to make the Planning Board the Zoning Commission or appoint a separate board brought the appointment to a stalemate last night.

City manager James S. Hughes said at this point that bringing in a separate board would be bringing in a group of men completely new to the present needs of Greenville. He stated that the work of the planning Board and the Zoning Commission were very close in their duties.

Councilman S. Eugene West spoke that he thought that one board was all that was needed since the actual need for action by a Zoning Commission came very seldom.

Harvey added at this point that if there was only one board he thought the membership of the Planning Board should be increased.

Councilman S. Eugene West spoke at this time and said that he thought there should be two separate boards.

Collins Made Motion After a little more discussion Councilman J. A. Collins made a motion to appoint a separate board for zoning with the board consisting of Thomas W. Rivers, Louis W. Gaylord, Jr., J. W. Griffith, S. Eugene West.

A second to this motion never came as much discussion followed.

Mayor W. L. Whebee asked the City Attorney, R. B. Lee, what his opinion on the matter was.

Lee explained that he had no voting power on the board, but that he would give his opinion. "I think," he stated, "that the work of these two boards should be closely coordinated and since the statutes say that either the Zoning Commission can be the Planning Board or a separate board, that there should be only one board—in other words give the Planning Board the Zoning power even if you want to add new members to that Board."

Mayor Whebee stated at this point that he agreed with the attorney that one board would be sufficient for both jobs and he would recommend one board with Gaylord, Griffith and West added to the Planning Board since Hughes and Rivers were already on the Planning Board.

Councilman Ruffin made a motion that West, Griffith, and Gaylord be appointed to the Planning Board and that the Planning Board be designated as the Zoning Commission.

There was no second received to this motion either.

Councilman Harvey stated he would like to see action deferred

on this matter until the city manager could write other cities to see what system is being used there.

So, action was deferred and City Manager Hughes will contact other cities and report to the Council at the next meeting.

Townsend met with the County Commissioners in March, requesting that money be included in the budget for placing of a bronze plaque in the corridor of the Court House commemorating the signing of the "Pitt County Resolves" by 88 patriots of the county.

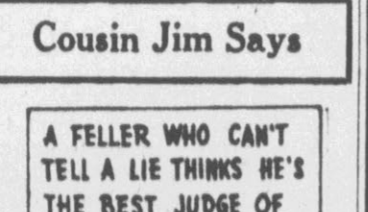

# N.C. Academy Of Science Meets At East Carolina College Today

Among those participating today in the meeting at East Carolina College of the North Carolina Academy of Science are Dr. Christine Wilton of the college faculty, chairman of local arrangements, who is shown here at work in the laboratories of the department of science; Dr. Florence L. Schaeffer of Woman's College in Greensboro, vice president; and Dr. John A. Yarborough of Meredith College, secretary.

Principal events of sessions held this morning and early this afternoon included a symposium on "Growth and Development," at which Dr. Donald B. Anderson of State College, president of the Academy, acted as chairman; a tour of the DuPont Deacon plant near Kinston; and organization of the North Carolina Collegiate Academy of Science, a newly organized group made up of undergraduate students of science in colleges and universities of North Carolina.

Speakers at the symposium this morning, all distinguished scientists of the state, were: Dr. Ernest Ball of State College; Dr. D. P. Costello of the University of North Carolina; Dr. Stanfield Rogers of the Duke University Medical School; and Dr. Victor M. Cutler Jr. of the Woman's College UNC.

Tonight at 8 o'clock in the College Theatre Dr. Anderson will deliver the Presidential Address of the fifty-first annual meeting of the Academy. His topic will be "The Structure of Plant Cell Walls."

Announcement of annual awards will also be made at tonight's meeting. Dr. Elizabeth K. Goldie-Smith of the University of North Carolina department of botany will receive the Potat Award in the Botany Section of the Academy. She was chosen for the honor on the basis of her technical paper entitled "Members of the Plasmodi Ophoraceae Occurring as Parasites of Fungi."

The recipient of the John Bewley Derricks Memorial Award in physics will also be announced at the meeting. Mary O. Ellington of the Needham-Broughton High School, Raleigh, will recognize winners of the high school essay contests sponsored by the Academy. Prizes and cash awards will be given to high school students submitting the best papers on the subjects of forestry and ornithology.

Tomorrow's events will include sectional meetings of the Academy, meetings of the North Carolina section of the American Chemical Society and of the North Carolina Psychological Association, and a luncheon for high school teachers of science and for members of the Collegiate Academy.

## Dr. Humber To Address Session

**PINEHURST** Dr. Robert Lee Humber, Greenville attorney and author of a widely known plan for a World Federation of Nations, will address the annual banquet session Tuesday night, May 18, of the North Carolina Dental Convention, which will be held at the Carolina Hotel May 16-19.

The banquet will be followed by a dance.

A 40-voice chorus composed of students in the University of North Carolina School of Dentistry, directed by Dr. Roger Sturdevant, will furnish music for the banquet.

Dr. Humber wrote his resolution endorsing a World Federation in 1940, soon after fleeing his residence in Paris just ahead of the invading German army. He presented it first to a group of friends and acquaintances and has since taken his idea to the people of the 48 states and to the people of Europe.

He is a graduate of Wake Forest College with A.B. and LL.B. degrees, received his M.A. at Harvard, and attended New College at Oxford as a Rhodes Scholar, receiving a B. Litt. degree. From Oxford he went to the University of Paris as an American Field Service Fellow for two years.

Once in a while the incident—such as the one in Ayden—comes to the attention of the press and makes headlines (large or small) in the papers. Most of the time, the helpful people of the community lend their helping hands as a matter of course, never thinking others might be interested.

It is spirit of helpfulness and kindness of which Pitt Countians can be proud.

# Power Policies Under Scrutiny

By RAY TUCKER  
WASHINGTON—President Eisenhower's record in the public versus private power controversy was reviewed realistically by the nation's top utility experts here in recent days. The leaders of the so-called "power trust" staged their annual meeting in connection with the national convention of the U. S. Chamber of Commerce, with which most of them are affiliated.

It may surprise the professional, political agitators of this issue, but the private operators were not entirely satisfied with the White House achievements. He has not tried, as Truman liberals forecast, to hand over the nation's natural resources to them. He has made no attempt to withdraw the Government from this field, or to sell TVA, Bonneville, Grand Coulee and Central Valley to the private interests. He has not opened the door to "selfish exploitation."

A FEW COMPLAINTS AGAINST IKE—As a matter of fact, the private utilitarians voiced a few complaints against Ike. Although he described TVA as "creeping socialism," the House killed amendments forcing TVA to pay taxes and liberalizing its contracts for sale of juice by cities in its area. Eisenhower made no attempt to round up Republican votes for the restrictions.

Through the Federal Power Commission, he handed the St. Lawrence project to Governor Thomas E. Dewey's New York State Power Authority. He has thrown his influence behind Dewey's demand for the right to develop Niagara River, as against the firm bid of five private companies. And utility men regard State intervention as only slightly less distasteful than Federal promotion.

Although Secretary Douglas McKay has killed the Truman-Chapman plan for Federal development of Hell's Canyon, FPC has dragged out hearings on the Idaho Power Company's petition interminably. It looks now as if any decision may be deferred until after the November elections.

In these specific contests, Ike has not shown himself too friendly to private power. He had to give

## Reminder For Those Who Haven't Registered

Last Saturday when the registration books opened, some 2,400 voters got their names on the books. Officials said that figure represented approximately 12 1/2 per cent of the voters who should be registered in Pitt.

When the registration books close Saturday, the registration will be more than half over. There will remain but six days for unregistered voters to get their names on the books to be eligible to vote in the Democratic primary May 29. Chances are the number of voters who have registered by Saturday night will represent more than half the number which will be registered for the primary.

CUERO, TEXAS, RECORD: "Americans just can't seem to remember somehow, after the shooting stops, that a strong, ready and efficient merchant marine is essential to national prosperity as well as national defense. Chairman Thor C. Tollefson (R-Wash.) of the House Committee on Merchant Marine and Fisheries, reminded the Congress the other day of some of the facts-of-life. In World War I, he said, we paid three billion dollars for ships that could have been built previously for \$40 million; and in World War II, emergency construction cost more than 14 billion, instead of the pre-war price of four billion! In each instance, of course, we would also have saved priceless time—which in this jet-bomber age means more than ever before."

NORWALK, CONN., HOUR: "Dr. Detley W. Bronk, president of the Rockefeller Institute for Medical Research, and also head of the National Academy of Sciences, asked thoughtful men to shed their fear for the future, adding, 'Weary, bewildered men covet security. . . . In other words, the explorers of today are the imaginative scientists and the reward is new worlds undreamed of by Columbus and his colleagues. Dr. Bronk's is a clarion call for courage and faith in the future.'"

thought to such political considerations as the need to re-elect Dewey and a Republican Congress next fall. ROOSEVELT - TRUMAN - ICKES PROGRAM CHECKMATED—Being politico-economic realists, however, few utility bigwigs expected Ike to sabotage the vast public power grid built up through Roosevelt-Truman years. No utility corporation is in the market for existing Federal systems, which are tied to such collateral operations as flood control, irrigation, navigation and other activities unsuited to private management.

In their summary, they credit the White House, Congress and the Courts with having checkmated the Roosevelt-Truman-Ickes program of Federalizing almost all the generating and distributing facilities now in private hands. Had that trend been continued for another four or eight years under a Democratic regime, they believe that Washington would have obtained a near-monopoly in this field.

Eisenhower, in short, has reversed the march of the public power parade. A MIGHTY FEDERAL WEAPON—Equally important, they feel that a Stevenson in the White House would have insisted on exclusive Government development of atomic power. All the traditional public power factions—Truman liberals and former aides, the CIO, the National Farmers' Union—demanded that Uncle Sam retain ownership and control of nuclear energy materials and facilities for commercial utilization.

Were this view to prevail, the United States would possess a weapon for destroying the private industry such as Roosevelt, Truman and Ickes never dreamed of in their most balmy and belligerent days. With exclusive control of all sources of nuclear and solar energy, Washington would have enjoyed life-and-death power over all industry, not merely the private utilities.

Under measures now pending before Congress, however, these on-the-horizon forces will be developed and marketed under private auspices, with strict Government supervision and regulations for safeguarding national defense needs.

## What Other Editors Are Thinking

RUSSIANS SURPRISE MR. WILSON (Rocky Mount Telegram)

American and Western military attaches serving in Moscow are reported to have been "plainly impressed" if not outright shocked over the Soviet display of jet bombers on May Day.

What startled American observers most was the Soviet Union's new, four-jet intercontinental bomber which has the capacity to carry the hydrogen bomb to American cities. One American military attaché said, "That's a whole lot of airplane."

The sight of these tremendous intercontinental bombers over Red Square confirmed the most chilling fears that the Communists had a B-52 type jet bomber. Nor was the giant new Soviet bomber the only new Russian

surprise. There were other new weapons. There was a radically new style of twin-jet medium bomber or escort, also on public display for the first time, as well as some newly modified jet fighters.

A few months ago, Secretary of Defense Charles Wilson, trying to excuse his catastrophic error in slashing over \$4 billion from the Air Force budget last year, advised the American people that the Russians wouldn't have a dropable atomic bomb or a plane that could get it here for "at least three years." Unfortunately, Secretary Wilson's wishful hasn't made it. In less than half a year, we learn that the Russians not only have dropable atomic bombs, but hydrogen bombs. Now we learn that they have an intercontinental jet bomber that can

deliver hydrogen bombs on us tonight if the Kremlin orders it.

While Mr. Wilson was busy slashing the Air Force budget and otherwise crippling the whole air defense of the United States, the Russians were busy building inter-continental bombers and other new types of jet planes.

We have said before and we say again that it is the business of the Secretary of Defense in these perilous times to be a pessimist preparing for the worst. Instead, Secretary Wilson from the very beginning has shown himself to be the most foolish type of Pollyanna, optimistically expecting nothing but the best. Such a colossal blunder in judgment raises questions as to his fitness for office. These times do not permit the luxury of many such stupid mistakes.

## Around Capitol Square

OFF-SIDE — Various reasons are given for the apparent continuing lack of interest in the senatorial campaign as it moves into the final period. Perhaps the most logical is that all of the active candidates are operating out of character. In the parlance of the football field, they are playing off-side. Carrying the gridiron simile one step farther, the penalties neutralize each other resulting in no gain and a very uninteresting game.

Continuing the football analogy: Lennor has the ball, Scott is the state of the opposing team, Wingfield is blocking for Scott, and the other candidates are wondering why they are on the field at all. Normal play under those circumstances would be for Lennor to keep his hands on the ball and his eye on the goal; for Scott to be trying to take the ball away from him and reverse the course of play. Analysis of tactics as evidenced in activities up to now indicate entirely different strategy. Let's see how it looks.

SCOTT — Because he has been an active candidate much longer and is far better known throughout the State, Kerr Scott rates first attention. The exigencies of this campaign cast him in the technical role of an outside contender, although actually he is the man against whom all the others are running. This is the first time in all his political experience he has been in that situation. Always heretofore he has been the challenging bell-ringer. His previous campaigns have been based on attacks against the propriety of official conduct if not the integrity of his entrenched opponents. He has been the one to charge misfeasance in public office, misuse

of official authority and lack of consideration for the common good.

His friends are somewhat confused and his opponents outright disgusted with his present attitude of ignoring all other candidates and his supporters and isolating himself behind an insulated wall of a code of ethics which holds that most criticism of public official conduct is mudslinging—of which he wants no part. He has not bothered to answer open charges that he used the power of the Governor's office to get extra roads for his farms; that he used appointive powers to penalize citizens for not voting the way he wanted them to vote, and that he might not have made entirely proper income tax returns.

Contrary to his usual practice of lashing out at anybody and everybody who disagreed with him, he has been so far in this campaign blithely indifferent to all his critics.

LENNON — Alton Lennon, who holds the Senate office by appointment after the death of elected Senator Willis Smith, is technically the man against whom every other candidate is running. The fact is, that from inception of the campaigning he has taken the position of opposing Scott rather than promoting his own capacity to fill the Senate seat. He is disadvantaged to some extent by reason of his middle-ground position between the conservative and the radical liberal viewpoints. The next ground does not lend itself to spectacular publicity to the same degree as do the extremes of right and left.

Usually the man who is in office and in the middle as between right and left is the one who stands pat. In the instant case Lennon is

about as much out of character as Scott.

WINGFIELD — The activities of Alvin Wingfield are more difficult to reconcile with political tradition and his demonstrated extreme rightist political philosophy. He claims to be, and his statements seem to justify the claim, much farther to the right than Lennon and a whole lot farther to the right than Kerr Scott.

Yet his whole campaign has been directed against Lennon and has had the effect of helping Scott. Privately he has said he thinks he has done Lennon "a lot of harm." Apparently his strategy is to eliminate Lennon in a first primary and then make a bid for the conservative vote in a

## Business Today

# Markets Changing

By ELMER ROESSNER  
Don't look now, but your markets have been changing in the last few years. Between April, 1950, and July, 1953, the population of the United States increased 8,496,000, according to a new estimate released by Robert W. Burgess, Census director. And every one of those 8,500,000 is a consumer and most of them are customers.

Even more significant to business planners is the fact that the changes within are groups varied considerably. The 20 through 24 years group declined 555,000, or 4.6 per cent, according to Census estimates. That doesn't mean that the early 20's are unhealthy—it just means that more persons turned 25 than turned 20. The 25 to 29 group declined, too, down 265,000 or 2.1 per cent. All other groups gained, the largest gains being in the 5 to 9 group, up 2,355,000, or 17.8 per cent, followed by the 10 to 14 group, up 1,312,000 or 11.8 per cent. The third largest gain was by the 65 and over group, up 1,130,000, or 9.3 per cent. Other gains: under 5—1,272,000, or 5.6 per cent; 15 to 19—119,000, or 1.1 per cent; 30 to 34—626,000, or 5.2 per cent; 35 to 39—165,000, or 1.5 per cent; 40 to 44—705,000, or 6.9 per cent; 45 to 49—598,000, or 6.6 per cent; 50 to 54—290,000, or 3.5 per cent; 55 to 59—366,000, or 5.0 per cent, and 60 to 64—358,000, or 5.9 per cent.

The total last July is estimated at 159,829,000. It is now close to 162,000,000. The median age—the age at which there are as many older persons as there are younger—is 30.2 years. The median for men is 29.6 and for women, 30.7. So now you know whether you are middle-aged or not—statistically.

While there are fewer people in the older brackets generally, this is not always true specifically. For instance, there are more persons 30 to 34 than there are in the 25 to 29 group, and more 25 to 29 than there are from 20 to 24.

Census has published 12 pages of figures and data on these nine-months-old statistics but still latest estimates. They are useful in

making merchandising plans. For instance, a company making a gadget for men in their 20's can calculate not only how many prospects it has now, but also how many it will have 5 and 10 years from now. For copies, send a dime to the Census Bureau, Washington 25, D.C.

TAX CUTS PRIME CORPORATE PROSPERITY  
Five hundred and seventy leading corporations earned 7 per cent more after taxes in the first quarter of this year than they did in the first 1953 quarter, according to a compilation by the National City Bank.

And the big reason why appears to be taxes—or, rather, the cut in corporate rates and the end of the excess profits levy.

The 506 corporations engaged in manufacturing reported that their receipts from sales and other sources were, in the aggregate 5 per cent less than a year ago. They did manage to reduce costs 4 per cent and that left their net before taxes 17 per cent under a year ago. Despite that, their keeping money after taxes was 7 per cent higher. "DETERGENT 'FACTORY'"

It may pay large commercial laundries to manufacture their own detergents. A Rochester manufacturer (Pfaudler Co.) designed and manufactured a small detergent factory for shipment to Iceland. It cost only \$8,000 to produce and can be operated by one man.

Unless they are buying detergents very cheaply, large users may profitably make their own at that rate and possibly pick up a few extra dollars selling the product on the local market.

STEEL'S JOB CAPACITY UP SHARPLY SINCE WAR

While the steel industry is running considerably below rated capacity these days, the potential "number of jobs is considerably greater than in 1946, the American Steel and Iron Institute declares. Employment in the industry averaged about 683,000 in 1953, compared with 575,000 in 1946, it found. This resulted from expenditures of more than \$5.6 billion in plant expansion.

## Now You Can Know Who Know

NEW YORK (AP)—There is a flip saying in this country that "it ain't what you know that counts—it's who you know."

This remark isn't as pertinent as it used to be. Civilization has become so complicated that people with specialized knowledge in any field are becoming more important. The rest of us need them as guides.

There is so much to know in the world today that the guy with the know-it-all complex is as out of touch with reality as a fossil. This is the age of the expert.

But how can the average man, seeking information about a topic, tell an expert from a braggart?

Well, the publishers of "Who's Who in America" have solved this problem. They came out today with a big volume called "Who Knows—and What."

The big Blue Book lists some 18,000 authorities on 33,000 subjects, ranging from the Aardvark to the Zuni Indians. It runs to 907 pages and cost the publishers \$200,000 and several years of research.

The publishers are hopeful the volume will prove useful to everybody who has a problem—and that means everybody. The housewife plagued with cockroaches, for example, will find listed three authorities whose advice she can seek on how to get rid of these kitchen intruders.

Anybody annoyed by a prowling Aardvark, however, will have to turn for help to Dr. Glenn L. Jepson of the Princeton Museum of Natural History. He has a monopoly on this African mammal.

Emily Post, the hardy perennial in the field of what-for-to-use-and-when, is the sole authority listed

on etiquette—and what Amy Vanderbilt will say about that I shudder to think.

The same way with raindrop erosion. Now there's a field you'd think would be crawling with experts, but Walter David Ellison of the U. S. Navy has it all to himself.

On the other hand "Who Knows—and What" names 2 specialists on horseshoes, 2 on porpoises, 9 on turtles and 11 on rabbits. It also names 8 authorities on communism—and doesn't include Sen. McCarthy, although it does mention his former aide, J.B. Matthews.

Only a baker's dozen are identified as authorities on sex, and Dr. Kinsey isn't slighted. But some of their approaches to sex don't make for very racy reading. Dr. Bernard Samuel Greenberg, to cite only one, has written on "some effects of testosterone on the sexual pigmentation and other sex characters of the cricket frog." And of course we all remember his heady study titled, "Some Relations between Territory, Social Hierarchy, and Leadership in the Green Sunfish."

A young girl looking for ways to trap a husband will find slim pickings in "Who Knows—and What." Neither bachelors nor hermits are mentioned. Nor are husbands. Presumably the experts in husband grabbing aren't talking for publication.

As a matter of dismal fact, the vast field of love isn't listed at all. How anybody could list 33,000 separate subjects without mentioning love strikes us as the greatest single feat of pure scholarship in our century.

Only men could leave out woman's favorite word.

## Worth Noting

FORMING CLEARING HOUSE ON FUND CAMPAIGNS  
Efforts are now being made to form a national organization to give businessmen information on all fund-raising campaigns, and to persuade fund-raisers to coordinate their drives. The efforts are being made by a committee appointed by the National Solicitations Conference, sponsored by the Cleveland Chamber of Commerce.

Recent exposures of the heavy fund-raising campaigns have made expenses connected with certain many businessmen wary, and while local organizations can advise them about local organizations there has been no central clearing house of information on national drives. The contemplated organization would fill that need.

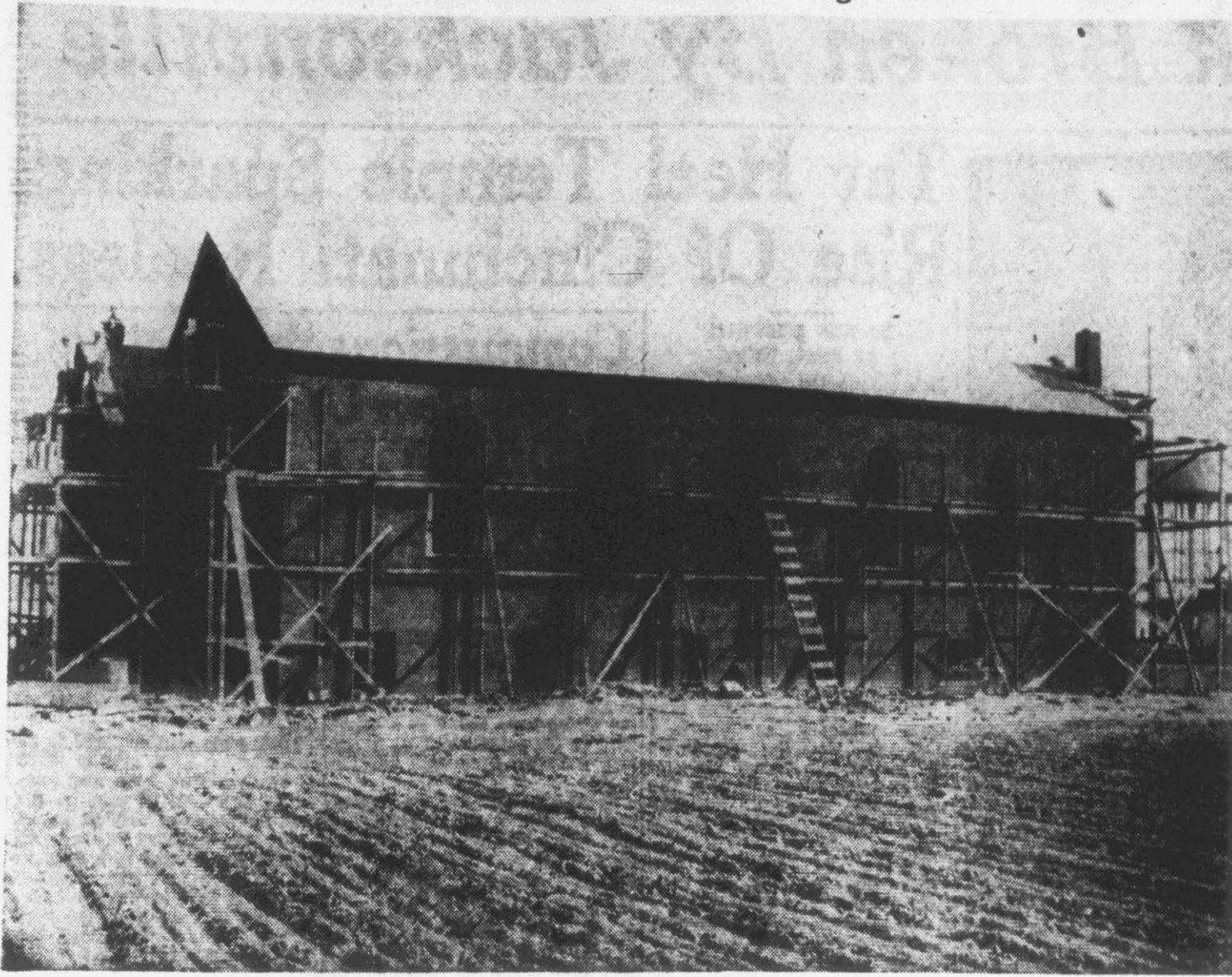

Heretofore, scientists have admitted the possibility of controlling thermonuclear power, but have generally assumed it could only be used destructively.

Hickenlooper, vice chairman of the Joint Congressional Committee on Atomic Energy, did not elaborate on his statement made in a speech yesterday before the World Affairs Council of Philadelphia.

"There is a possibility of direct production of power through controlled thermonuclear reaction," he said.

Ten boys took over a cement mixer in the rear of a building supply house and took turns at riding inside the barrel and cranking. The makeshift "ride" accommodated two customers at a time.

Scott Shuns Tax Challenge As Wingfield Flays Lennon

RALEIGH (AP)—Action on the U. S. Senate campaign front today gave appearances of rolling into high gear. The three leading candidates took aim and launched barages yesterday.

Challenger Alvin Wingfield Jr. chided Sen. Alton A. Lennon's draft record and money making ability; Lennon's headquarters again challenged W. Kerr Scott to release his income tax returns; and Scott, in his first statewide radio address, refused to be smoked out.

Scott said he would continue to refuse to be drawn into discussion of personalities, and he would not discuss "trivial matters raised as a smoke screen to hide the real issues."

Lennon, campaigning in Catawba County yesterday, flew to Washington so he could vote on proposed revisions of the Taft-Hartley Act expected to come up today.

His headquarters, however, pointing out he recently released his income tax returns for the past five years, again asked Scott to do likewise.

The former governor said over the airwaves he would welcome an investigation of his tax returns by federal or state authorities.

He said the income tax issue was "brought up to muddy the water and is irrelevant to the campaign."

Scott said he would not "dignify by discussion, trivial matters raised as a smoke screen to hide the real issues from the people of

North Carolina as they choose, at the polls, who shall be their United States senator."

He declared he was "not running against anyone. I am running for the United States Senate, in my own name, and on my own responsibility, with the assistance of thousands upon thousands of men and women, in all walks of life, from one end of North Carolina to the other."

He then reiterated what he termed the major campaign issues, among them protecting 90 per cent parity for the farmer, getting interest on federal deposit funds lying idle in banks, and strengthening the nation's bipartisan foreign policy. He concluded by pledging to "continue to fight a clean battle and (I) will not be diverted from the main issues."

Wingfield, who makes no bones of the fact he considers the Senate race between himself and Scott because he doesn't believe Lennon can defeat Scott, hit hard at Lennon again.

In a stinging radio speech which will be transcribed over many stations in coming days, he said: "There is simply too much against him (Lennon) — his lack of success as a lawyer, his draft record, his desertion of duties in Washington to campaign in North Carolina, the absurd false claims about him which his managers have made in fancy television films and newspaper ads, his pompous conceit over being an appointed senator, his inability to think and speak for himself on campaign issues and the blunders which have been made by the well-beeled political machine which is backing and running him."

Wingfield said his talk would be made over more than 20 stations. The stations are giving him the time since the FCC has ruled he is entitled to the same amount of time they had given Sen. Lennon free of charge after Lennon filed as a candidate.

This School Teacher Has Class Of Over Six Million

By BOB THOMAS HOLLYWOOD (AP)—Like many other American women, Frances Horwich is a schoolteacher. The only difference is that her class numbers 6½ million.

Dr. Horwich is the originator and sole proprietor of Ding Dong School, a Chicago TV show that delights and informs pre-school children from coast to coast every weekday.

"But we also have viewers from 7 months to 87," said Dr. Horwich who visited here for a couple of speeches. "You'd be surprised how many arthritics watch the show for exercises in using the hands. Also a number of teachers' schools and hospitals watch regularly so future teachers and internes can learn how to deal with young children."

Among most children's TV shows, Ding Dong School stands out like a rose amid thistles. While other programs parade violence and clownish antics before the young viewers, Dr. Horwich entertains and instructs her audience with gentle games and knowledge. Her efforts have earned her 29 different awards, among them Associated Press Woman of the Year in Education.

"That pleased me very much," she reflected. "My friends in education had begun to think that I had lapsed into the entertainment field."

Dr. Horwich has taught kindergarten through third grades since 1929 and has acquired degrees

from Chicago, Columbia and Northwestern (Ph.D.). As president of a national group for day nurseries she was approached by NBC for advice on a program for children from 3 to 6.

She emphasized that the show should be done by an educator, not an entertainer. Ten days later she was on the air with Ding Dong School. That was 19 months ago, and she has been on every day since.

I asked for her secret. "Perhaps it was because I had been in education so long and was not easily swept away," she observed. "I had to stand my ground on a number of things. When it first started, the men on the show didn't like the name of it. They were ashamed to say 'Ding Dong School' to their friends. I told them not to talk about it then. It was easy for children to say and it belonged."

"They also wanted more production on the show; I thought that was wrong. I also insisted on sponsor approval. They argued that they certainly wouldn't allow any beer or cigarette sponsor, but I held my ground. Recently the sales department brought forth an aspirin sponsor. I wouldn't allow it. It's up to a pediatrician to prescribe aspirin for children."

Jury Proposes Death Sentence

DOYLESTOWN, Pa. (AP)—George L. Capps, a 22-year-old Army veteran, was convicted of first-degree murder—with a death penalty recommendation—last night in the slaying of a teen-age neighbor girl.

A jury of nine men and three women deliberated less than two hours before returning the verdict. Capps had admitted shooting 15-year-old Marta Gibbons through the head but maintained he was intoxicated and temporarily insane.

The girl's frozen and partially clad body was found by the edge of a lake several miles from her home in the new community of Levittown last Jan. 25.

Capps testified he and the girl had been intimate in the rear of his automobile, with her consent. He said they later argued and he shot her. The state contended he acted in fear she would tell his wife who was expecting a baby at the time.

One Of Pair Sentenced To Die Shows No Fear

SAN FRANCISCO (AP)—Two former private detectives condemned to death for a kidnaping in which the victim was rescued and no ransom was paid faced the San Quentin gas chamber with radically different attitudes today.

Dapper, 52-year-old Harold Jackson and mild Joseph Lear, 43, were convicted late yesterday under California's Little Lindbergh Law of kidnaping Leonard Moskowitz, 36, a real estate broker, Jan. 16. They demanded \$500,000 ransom; later \$300,000.

The jury of six men and six women found that Moskowitz had suffered bodily harm in being chained and threatened with a knife before he was rescued by police after 61 hours in captivity. The jurors automatically condemned the two to death by not recommending leniency.

The verdict didn't seem to bother Jackson, a onetime sailor and an all-time adventurer who operated a wartime private guard

agency on the San Francisco waterfront.

Brought into court in handcuffs to hear the verdict late in the 33rd trial day, the convicted mastermind of the Moskowitz kidnaping cracked to his lawyer:

"Cheer up, pal, the worst is yet to come. Here's where we get that old rocking chair."

As the verdict was read, pointedly omitting any leniency recommendation which could have resulted in life imprisonment, Jackson grinned and circled his right forefinger and thumb in a symbol of triumph.

"Well, well, old rocking chair's got me," he said.

Then he laughed aloud at Lear, whose face was strained and taut.

When an identical guilty verdict was read for Lear, Lear broke into tears.

His pretty 23-year-old wife Betty who sat in the first row with his mother and father, Mr. and Mrs. James Lear of Havre, Mont., stared for a moment, then plunged her face into her hands. Both women sobbed.

Superior Judge Twain Michelsen said he would hear arguments Tuesday for a new trial before pronouncing sentence.

If a new trial is denied, defense attorneys said they would appeal. California law provides for an automatic review by the State Supreme Court of all death sentences.

Moskowitz disappeared Jan. 16 on the way to a business appointment. He testified that Jackson, on pretext of wanting to buy a home, had lured him to a rented house, where he was overpowered and imprisoned.

On Jan. 19, alert police noticed a man making a telephone call for ransom, it turned out—from a sidewalk booth. The telephoner was Lear, who led police to the kidnap house, where Moskowitz was freed.

Lear testified he was hired by Jackson as a private detective; that when he learned he was involved in a kidnaping he was afraid to break away because he feared for his life and his family's.

Jackson pleaded in court that it was all a hoax; that Moskowitz wanted to extract money from his father.

Said Moskowitz of the death verdict: "It was perfectly just. . . . They are getting what they deserve."

Elijah Challenges Baal Worship

ILLUSTRATED SUNDAY SCHOOL LESSON By Alfred J. Buescher

Scripture—1 Kings 17:1-19:18.



King Ahab of Israel, his wife and his people, worshipped Baal. Because of this the Lord God of Israel said, 'As the Lord God of Israel liveth, there shall not be dew nor rain these years, according to my word.' The Lord told Elijah to hide by the brook Cherith, to drink from the brook, and 'I have commanded the ravens to feed thee there.' Elijah obeyed the Lord, and drank from the brook and ravens brought him his food. Before rains came to Israel, Elijah told King Ahab to gather the 450 prophets of Baal, Elijah commanded the priests to build an altar to Baal, put their sacrifice on it and pray for fire to burn it. They obeyed but no fire came. Elijah built an altar to the Lord, laid the sacrifice upon it, poured water on all, and prayed God to send fire. Flames completely consumed the sacrifice, and the people cried 'The Lord, He is God!' MEMORY VERSE—1 Kings 18:21.

Elijah Challenges Baal Worship

JEROVAH'S PROPHET DEALS PAGANISM A MORTAL BLOW.

Scripture—1 Kings 17:1-19:18.

By NEWMAN CAMPBELL. ELIJAH, THE TISHBITE, is the hero of one of the most thrilling episodes of the Old Testament. The lesson is long, so we will have room only to mention briefly the things that occurred before the great drama took place on the mountaintop. King Ahab had succeeded his father, Omri, as king of Israel, and he proved one of the worst kings of all Israel's rulers. He had a wicked wife, named Jezebel, whose name even today implies that a woman to whom it is applied is evil. Elijah faced the king and told him, 'As the Lord God of Israel liveth, before whom I stand, there shall not be dew nor rain these years, but according to my word. And so it was, the earth dried, the brooks were empty of water and not even dew fell to moisten plants. There was a great famine in the land. However, God told Elijah to hide himself by the brook Cherith and He would send ravens to feed him. Elijah obeyed and the ravens did feed him, bringing meat and bread, and he drank from the

Elijah persisted in showing himself to Ahab, however, and when he met the king the monarch said: 'Art thou he that troubleth Israel?' Elijah's answer was, 'I have not troubled Israel, but thou, and thy father's house, in that ye have forsaken the command of the Lord, and thou hast followed Baalim.' Then Elijah ordered the king to call all the people together on Mt. Carmel, which he did, and Elijah asked the people, 'How long halt ye between two opinions? If the Lord be God, follow Him, but if Baal, then follow him,' but the people answered never a word. Then Elijah told the 400 prophets of Baal to build an altar, to slaughter a bullock, cut it up, arrange wood on the altar, place the bullock upon it, but light no fire, but call upon Baal to send fire to burn the sacrifice. They did as he said, and for hours they called upon Baal to send the fire, even, in their desperation, cutting themselves with knives and lancets to induce their heathen god to answer their supplications. Elijah mocked them, and built

brook until it dried up. Then God told him to go to the town of Zarephath and a widow would give him food. When Elijah appeared at the widow's home and asked for a drink of water and some bread, she said she had only a handful of meal and a little oil to feed her son and herself, and then they would die, but Elijah told her that if she would make a little cake for him the Lord had said that the meal 'shall not waste, neither shall the oil fail, until the day that the Lord sendeth rain upon the earth.' So Elijah lived with the widow and her son and they were fed, but the son was taken ill and 'there was no breath left in him.' His mother upbraided Elijah, accusing him of being the cause of the boy's death. Elijah took the child to his own room, laid him upon the bed, stretched himself upon the child three times and prayed that he might live, and the boy recovered. After three years of drought the Lord told Elijah to show himself to Ahab. Now Obadiah was governor of the king's house, and a devout man, and the king had told him to go into the land and see if there was any water left in any fountain or brook so that the horses and mules might be saved. Obadiah had hidden in caves 100 of the Lord's prophets who would have been killed by Jezebel. Meeting the prophet Elijah, Obadiah was terrified when the prophet told him that he must see the king. He thought Ahab would kill him because the king had sent everywhere to find and slay Elijah but had not found him. a like altar on the peak of Mt. Carmel, built a trench about it, laid wood upon it, the bullock upon the wood, poured water over the meat and the wood three times, filling the trench also with water. Elijah then prayed most earnestly to the God of Abraham, Isaac and Israel, saying: 'Hear me, O Lord, hear me, that this people may know that Thou art the Lord God, and that Thou hast turned their heart back again.' 'Then the fire of the Lord fell, and consumed the burnt sacrifice, and the wood, and licked up the water that was in the trench.' When the people saw this they fell on their faces and said, 'The Lord, He is the God; the Lord, He is the God!' Then Elijah called upon the people to kill all the prophets of Baal, which they did. 'Elijah said to Ahab, get thee up, eat and drink, for there is a sound of abundance of rain.' When Jezebel, the queen, was told she was so furious she vowed she would have Elijah killed, so again he fled into the wilderness, sat down under a juniper tree and pleaded, 'O Lord, take away my life; for I am not better than my fathers.' However, he did not die then. An angel of the Lord fed him for the Lord had other missions for him to fulfill. Pictures of idols that have been worshipped in various times would interest children in this lesson. Are there any idol worshippers in our own communities? What about those who make money their god? or those who make a fetish of power seeking? These, too, might be called idol worship.

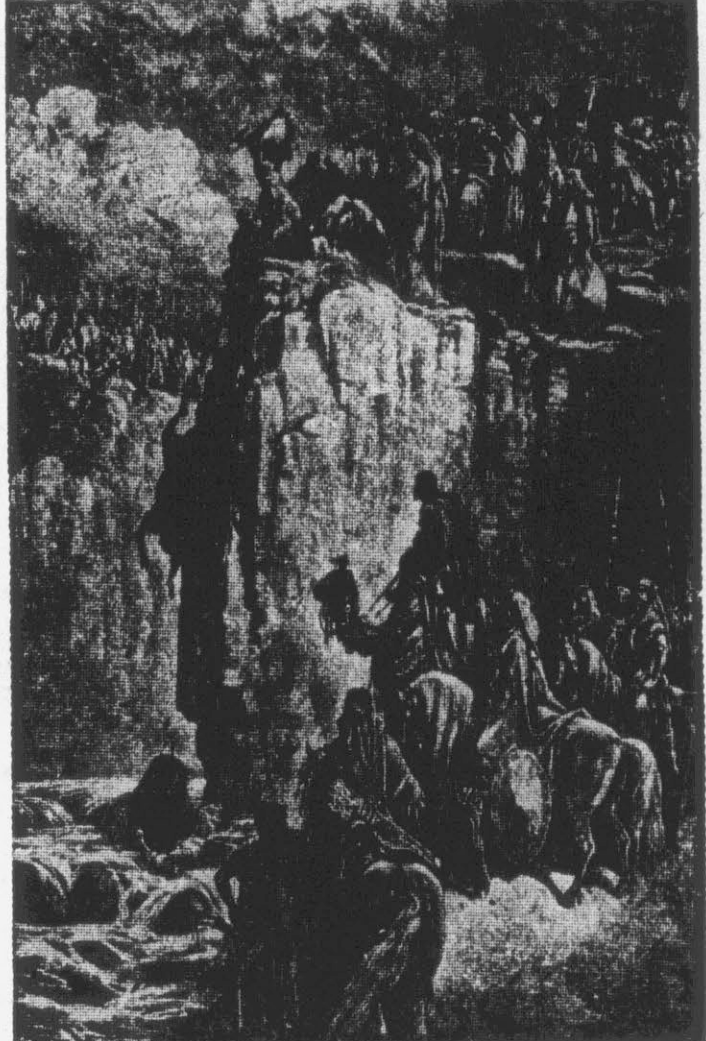

Her dream of buying antiques for her new home had simply gone out of the window. There was no money. They would have to get along with whatever the two families could spare them from their homes.

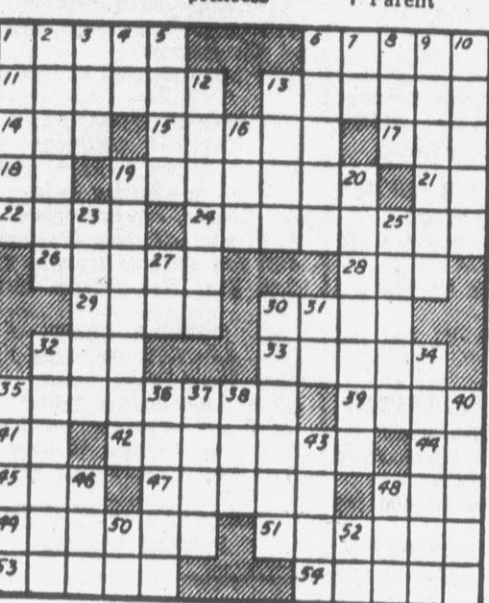
"At least," Joan thought, "our bedroom will look nice."

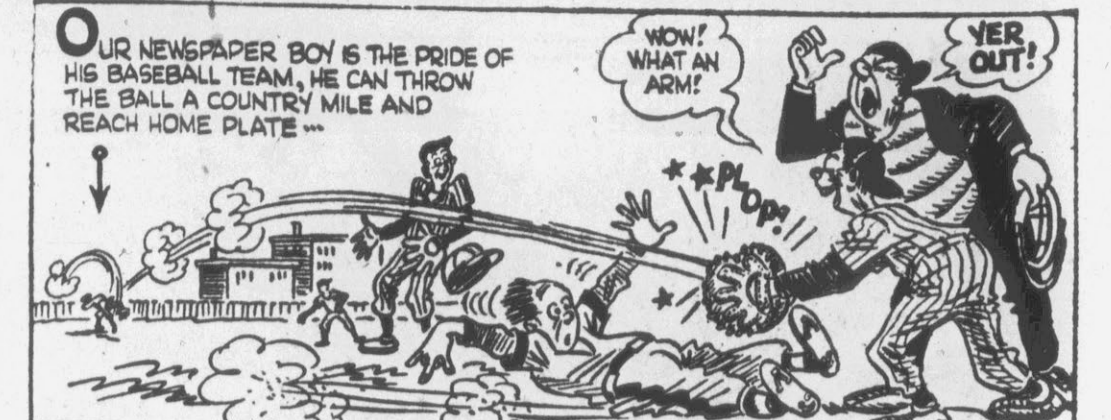

be a little harsher under fire. He seems incapable of it. He has answered questions "yes" or "no" sometimes, sometimes been roundabout and sometimes been so vague that he had to be urged to get to the point by McCarthy and Ray H. Jenkins, special counsel to the investigating subcommittee.

From the records, and the story he tells, McCarthy and his aides belted Stevens twice before he belted back.

He didn't publicly take a stand against McCarthy until, he said, the senator insulted a general. And the report in which he said McCarthy and his aides applied pressure to get special treatment for a draftee wasn't released until months after he said the pressure had been first applied.

McCarthy gives another picture of Stevens, of a man working behind the scenes to force McCarthy to give up his search for Communists in the army.

Why did Stevens delay so long in taking a stand? He says it was because of his desire to get along with McCarthy and Congress. It may be that he thought President Eisenhower wanted him to lean over backwards to get along.

The administration itself through most of its first year in office, when Stevens' troubles with McCarthy began, had set an example of trying to get along with the senator through one encounter after another.

Stevens didn't take his stand until after the White House relationship with McCarthy began to harden.

Nevertheless, and not by design but by an accident of personalities, the army may be setting McCarthy up for the old-fashioned nice-guy-tough-guy routine which police have often used.

So far McCarthy has had to deal mainly with nice-talking Stevens. But if these hearings, continue, he's going to have to tackle a couple of tough talkers who seem perfectly happy to snarl at him.

Army Counselor John G. Adams and Asst. Secretary of Defense H. Struve Hensel are principals in this case with Stevens on the Army side. McCarthy has questioned the honesty of both of them too.

He has had only a brief encounter with Adams and Hensel at this hearing so far. Hensel and McCarthy have looked at each other contemptuously throughout the hearing.

McCarthy repeatedly treated Stevens on a first-name basis, calling him "Bob." At the beginning of a brief exchange with Adams, McCarthy tried the same thing on him, calling him "John."

Adams showed he was in no mood for nice talk. He said: "The name to you, senator, is Mr. Adams."

## Sec. Stevens Is Like A Man Born Without A Snarl

By JAMES MARLOW

WASHINGTON (AP)—If you belted him on the jaw, Secretary of the Army Robert T. Stevens might hit you back. Maybe not until you'd belted him a couple of times, but it would be out of character if he called you names.

He acts like a man born without a snarl. Mild as a duck on a rock, he has sat patiently day after day while Sen. McCarthy quizzed him, tried to belittle him and questioned his honesty by urging him to be honest.

Stevens' public career may be at stake in the Senate inquiry into McCarthy's fight with army officials. And he has blinked steadily through the pounding. But he has a habit of blinking. It adds to his look of mildness.

Only a few times has he shown any heat in answering McCarthy's questions.

There may be another Stevens, one who can gasp with fury. And maybe he has made it a rule, since he's head of the Army, that in public he must be a model of self-discipline.

More likely this is the real Stevens at the Senate hearing: a man with white hair and eyeglasses, both of them always in place. One newspaper has noted he even wears the same gray suit every day.

The inquiry is now in its 12th day and he's been the same every day. He has never lost his temper, seldom showed impatience and never barked at McCarthy although a few times he's been curt.

It might seem that a man like Stevens, who has served in the Army, worked for the government and been a board member of some of the biggest corporations, might

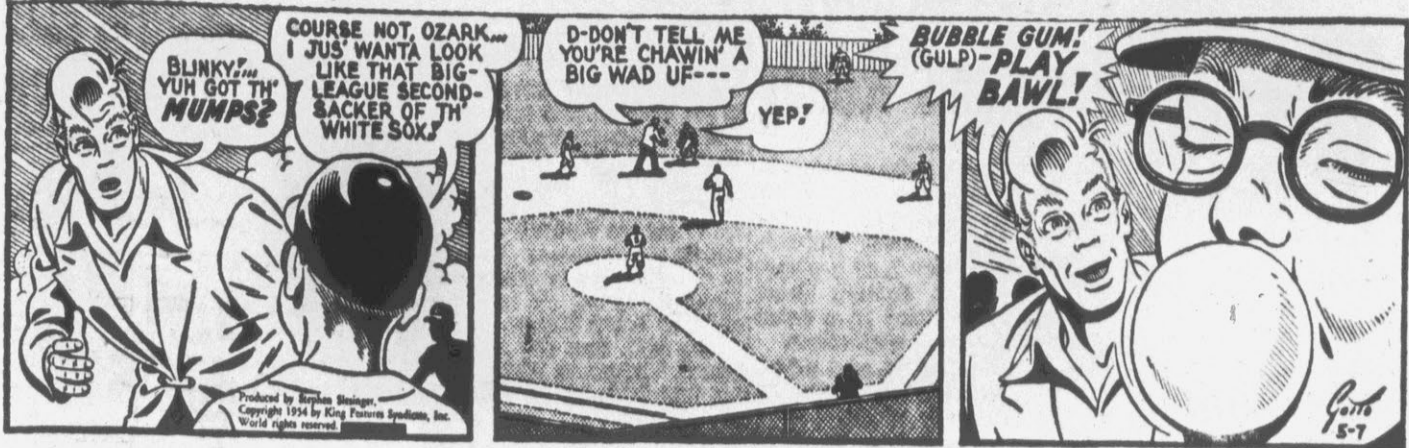

Cities Service, up 3/4 yesterday, stepped ahead briskly today on rumors of a stock split.

Mullins Mfg. gained 2 1/2 at 24 1/2 on a block of 1,500 shares. American Radiator traded a block of 9,000 shares at 18 up 1/2.

# Profits Of Top Corporations Match Those Of Year Ago

**NEW YORK** — Profits of 616 leading American corporations for the first quarter of this year ran about even with a year ago, an Associated Press compilation showed today.

Their aggregate net income was \$1,874,221,000 compared with \$1,878,826,000 in the first three months of 1953—actually a gain of a little less than three tenths of 1 percent.

Elimination of the excess profits tax last Dec. 31 played a major part in sustaining earnings and enabled some companies to show substantial gains.

The giant General Motors Corp., with a tax bill 144 million dollars lower than a year ago, gained nearly 38 million dollars in profits. E. I. du Pont de Nemours & Co. had 48 million dollars less in taxes and 17 million more in earnings. But industries and companies did not share alike. Fifty-seven railroads showed a 50 per cent decline in profits, 19 textile companies were down 84 per cent, 37 steel companies were off nearly 22 per cent, and 19 nonferrous metals companies down 16 per cent. Eight airlines reporting had an aggregate loss of more than three million dollars compared with 4 1/2 million profits a year ago.

On the other hand, seven aircraft manufacturers were 48 per cent ahead of a year ago due in large part to heavy output of military planes.

Thirty-one oil companies, receiving tax benefits under depletion allowances turned in profits nearly 17 per cent higher than in the first three months of 1953. Fifteen pulp and paper companies gained 20 per cent and 67 electric and gas utilities companies were up 7 per cent.

A gain of 9 per cent was shown by 24 food and nonalcoholic beverage companies, and eight firms making liquor or beer were down 2 per cent.

Besides General Motors and Du Pont, there were some other big gainers. General Electric Co. made 14 million dollars more than a year ago. The Bell Telephone System, consisting of American Telephone & Telegraph Co. and its 21 principal telephone subsidiaries, was up 13 million but on increased investment so that its rate of profit remained about the same.

Standard Oil Co. (New Jersey) was 20 million dollars ahead of last year. Standard of California up 10 million, Westinghouse Electric Corp. up 9 1/2 million and the Texas Co. 8 million.

Those eight corporations alone had an aggregate gain of 129 1/2 million dollars in profits over a year ago.

General motors ran counter to the trend in the automotive field among companies making financial reports. The giant Ford Motor Co., not having publicly owned stock outstanding, is not required to file reports, so its results are not known.

However, Chrysler Corp. skidded from \$24,428,740 in the first quarter of 1953 to \$7,681,053 in the latest quarter and Nash, Studebaker and Packard showed sharp declines.

The latest compilation, bolstered by reports from most of the big moneymakers of industry, compared more favorably with last year than an earlier AP tabulation two weeks ago. It covered the first 150 corporations to report, and they showed a decline of nearly 12 per cent in profits from 1953.

# Tests Point To Another H-Bomb

**TOKYO** — Two Japanese scientists said today the United States apparently exploded a fourth hydrogen bomb at Bikini between April 25 and 27.

They said their estimate was based on Geiger counter tests of rain which fell this week on widely separated areas of Japan.

Prof. Yasushi Nishiwaki of Osaka Medical University said rain which fell in Osaka, about 300 miles southwest of Tokyo, yesterday was many times more radioactive than rain tested Monday.

Nishiwaki said there was a similar sharp increase in the radioactivity of rain 12 days after the second H-bomb test March 26 and 13 days after the third test April 6.

Dr. Hironobu Watanabe of Niigata University said rain which fell in Niigata, about 100 miles north of Tokyo, Monday and Tuesday showed a sharp increase in radioactivity.

Watanabe's theory is that it takes about a week for atomic particles to reach Niigata, roughly 2,500 miles northwest of Bikini. "Therefore the new radioactivity is believed to have been caused by a fourth H-bomb test that took place in Bikini on April 26 or 27," he said.

The scientists said the rain was not dangerously radioactive.

**ROLLA, Mo.** — Rolla High School students will decide today whether to return to classes in their two-day protest of the dismissal of two teachers and resignations of two others.

School Board President Dr. Harold Fuller and Supt. Don Matthews urged them to return to classes at a public meeting last night. He promised their dispute would be brought before the next board meeting Monday night.

The board gave no reason for the dismissals.
