Hughes Sketches Deficiencies; Sum Is \$89,260 More Than Last Year \$689,510 Budget For City Is Proposed

Greenville has not had a change in business license for retail merchants in a number of years. According to records checked by the city manager the license fee has not been changed since 1931 and Hughes said, "Some city officials recall no change in 30 years."

God knows about each sin of each person and He is going to do something about your sins unless you repent declared Evangelist Eddie Martin last night to over two thousand people at the big Gospel Tent near in front Pitt County Memorial Hospital. In spite of the cool weather the largest week-day crowd of the meeting came last night.

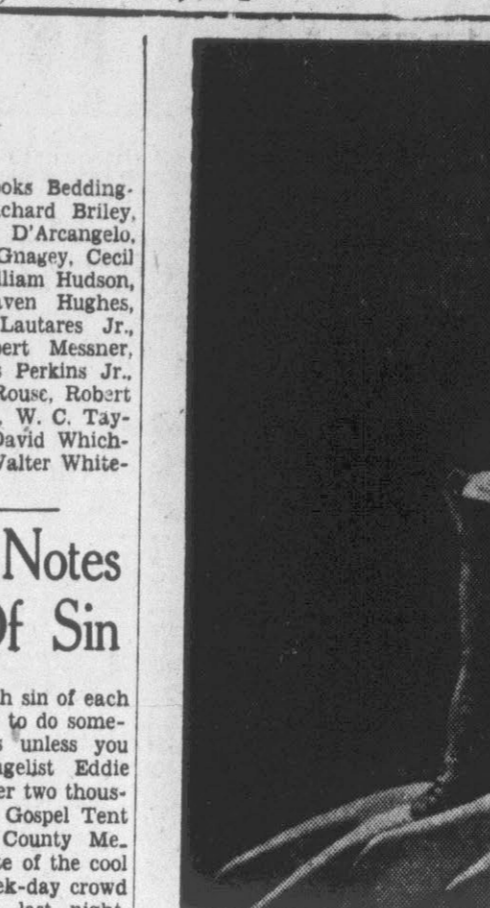
Eddie Martin's subject last night was "This Thing Called Sin." At the outset Mr. Martin read scriptural references to as many types of sin and the consequences suffered by the sinner. He brought out that man is born in sin and not a Christian; so, everyone needs a Saviour, Christ.

Instead of a hard to understand theological definition of sin he said he was going to list sins. The list included: cursing, violation of the Lord's Day, adultery, divorce, drunkenness, filthy communications out of the mouth, lying, stealing, wrong relationships in dating. Then some others which he more particularly characterized as personal sins: pride, evil eye, evil thoughts, gossip, and ill temper.

Pride, he said, would be the worst if there was a worst sin. He made it clear that there was no such thing as a little lie or a little theft because to do such things was breaking God's laws rendering one accountable to God.

Though everyone sins and sin is displeasing to God and subject to His wrath, the blood of Christ is available to cleanse even the worst sinner of his sins—to those who repent and turn to God, said Eddie Martin. He exhorted everyone to avail themselves of the saving grace, and in conclusion declared "God not only forgives sins but forgets sins."

Tonight Eddie Martin will preach on the subject "God Broke Up the Party." Tonight, Friday night, Mrs. Martin, Eddie's mother, will give her testimony. Saturday night Garland Coffield, the music director for Eddie Martin, will give his testimony. Sunday night Eddie Martin will speak on "The Unpardonable Sin." Mr. Martin says a crowd of over three thousand for Sunday night is being prepared for by putting additional benches up outside the tent in front of the pulpit.

### Stock Prices Reflecting Traders' Uncertainty

NEW YORK (AP) — Stock prices have been jumping around in the last two weeks like popcorn on a hot griddle.

Traders are trying to make up their minds whether the bull market is over or whether it's just getting its second wind—whether the expected upturn in business has already been amply reflected in the market, or whether a new upsurge of inflation is likely in coming months.

One day last week stock prices—as mirrored in stock indexes—took the sharpest drop since June of 1950 when traders were trying to guess whether the outbreak of fighting in Korea meant the third world war was starting.

One day this week some stock-price indexes had "the greatest advance of the past two years" and were reported standing "within the shadow of the highest mark since 1929."

You might remember, however, that a stock price index isn't the same thing as the market as a whole. For instance, Tuesday when the many stocks were making a sharp advance, 298 of the 1,139 stock issues traded declined. And two of them hit their lowest point so far this year, while 272 showed no change at all.

On the days when an index may be taking a spectacular drop, there will almost always be a sizable number of stocks recording price gains.

The long uphill march since last September has reflected primarily the eagerness of investors to buy

the blue chip stocks of the most prominent and prosperous corporations—the type which most stock indexes include. A sizable number of other shares on the stock exchange have shown only a small advance or none at all. Stocks of some industries have been notoriously depressed.

The advance of the blue chips and some growth company stocks over the months has been traced to several factors.

One is the belief that business will turn better this fall or next year. A second is a growing amount of idle money piling up in pension funds and insurance company safes. Investors have been seeking the blue chips to put this money to work.

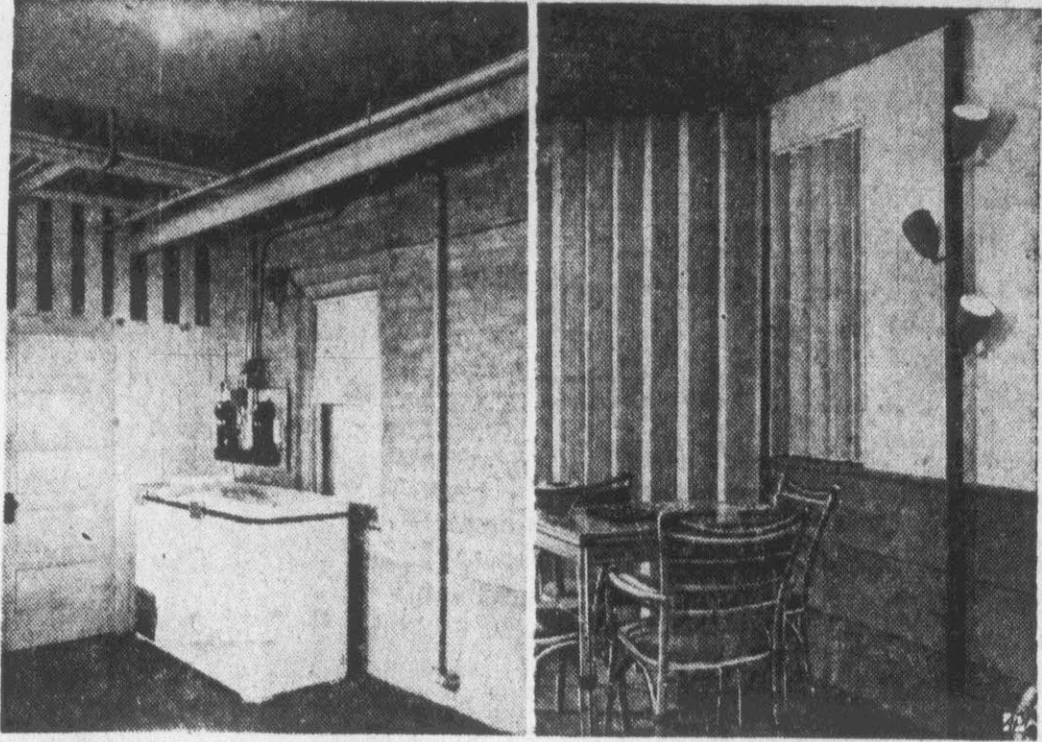
A third has been the very real chance that dividend payments will be more liberal. This chance is based on the fact that many companies, despite a decline in sales volume, have been able to show as good or better net profit after taxes this year. The end of the excess profits tax helped.

Greater productivity and economy from the use of more modern plants and new equipment have cut their costs.

And many of these companies are now winding up their long post-war expansion programs, into which they poured a large proportion of their earnings.

Stockholders feel that henceforth a bigger share of the profit pie is going to be cut in the form of dividends.

### Ideas Can Glamorize A Cellar



BEFORE AND AFTER the Gordon Taylors of Evanston, Ill. modernized their basement—these photos show some of the magic that can be achieved by modern building materials and accessories. Electric meters shown in the photo at the left are effectively concealed by a split wood screen on a ceiling track. A wainscot is formed with wide hardboard siding applied to furring strips. Above the wainscot, walls are covered with insulating wallboard planks. The exposed pipe is disguised as a smart lighting fixture.

### Brando Says Movie Return Due To Vow

By BOB THOMAS HOLLYWOOD (AP) — Marlon Brando says he is doing another film role because of a vow to his dying mother.

The actor has reported to 20th Century-Fox to portray the young Napoleon in the film version of the best seller "Desiree." He has returned in glory to the studio where his name was mud only a few months ago.

When he failed to report for shooting of "The Egyptian," the studio replaced him with Edmund Purdom. Then it sued Brando for two million dollars. The suit was canceled when Brando agreed to appear in "Desiree" opposite Jean Simmons.

Brando told me the deal came about because of his mother. He explained:

"She was very ill when the whole thing happened. She was very upset by the innuendo and sniping at me after I left the picture. She made me promise to patch up the trouble. So I agreed to do 'Desiree.'"

"She's dead now. But the deal is still on."

He gave no indication that he was any happier with his current "Egyptian." I talked to him as two makeup women were fitting a wig on his head. He gazed placidly in the mirror as they curled the phony locks into a replica of Napoleon's hair.

While making "The Wild One," he had told me he planned to work in only one more picture. This could be it.

"I'd like to do a play," he said. "Maybe I'll direct one. I've always wanted to see what it's like on the other end of the stick. After that I don't know what I'll do."

Is he interested in television?

"Nah! Are you?"

I asked him about his treatment of Napoleon, whom he much resembled in the wig. He wore a Napoleonic vest over his inevitable T-shirt, but all the buttons were buttoned. He won't stick his hand inside, he declared.

"It's too much of a cliché," he said. "The minute I stuck my hand in my vest the audience would start to snicker. Besides, this deals with earlier years when he may not have had the habit."

### Unusual Trio Pleases East Carolina Audience

### Tobacco Clinic Set Wednesday

A tobacco disease clinic will be held at the County Agent's office in the old hospital building next Wednesday from 9 a.m. to 12 noon. Assistant County Agent S.J. Weeks announced today.

Weeks said that J.C. Wells, Extension Plant Pathologist from N.C. State College will be present to make diagnosis of diseased tobacco plants which are brought in.

"Farmers who bring in diseased plants should bring several plants from the field where the trouble is present," Weeks stated. "The diseased plants should be dug up and all soil shaken from the roots, saving as much of the feeder root system as possible."

"Wrap the root system in wet paper or burlap bag and be prepared to give information as to variety, previous crop grown in field, and approximate percent of plants in the field affected," the assistant county agent advised farmers.

"This will be an excellent time for farmers to get expert diagnosis of tobacco diseases present in cases where you are not sure what the trouble might be," Weeks emphasized.

The past week has included two very important and interesting dates for the Irish. The most influential Irish poet of this century was born on June 13, eighty-nine years ago—he was William B. Yeats, first director of the famous Abbey Theatre in Dublin and, as we said, Ireland's greatest modern poet. . . . And June 16, 1904, was the day James Joyce chose to write about in "Ulysses," also about Dublin and considered by many the most significant book to come out of Ireland in many years. . . . We highly recommend the brilliant article about him in this week's New York Times, called "50 Years After Bloomsday," written by Sean O'Faolain. . . .

And quoted from what Mr. O'Faolain has said in some of his recent lectures during a tour of this country: "Students are more important than professors." (But who said they weren't—what would our professors do without them?) . . . "Faulkner is not a genius, he is just a man with too much talent." Agreed, though we wonder if there is very much difference. . . .

Among the new novels: Getting much publicity is Frances Parkinson Keyes' "The Royal Box," a lot like her others, about charming, handsome people, luxurious restaurants and lovely clothes, but with a little murder thrown in. And don't forget John Steinbeck's new one, "Sweet Thursday," described as a sequel to "Cannery Row" and like it in background and some of the characters. . . . And another with a southern setting, Emmett McDowell's "Switcheroo," which takes place in Louisville, about a young private eye who wants to live the way they do in the books he reads—also an Ace book, highly recommended for the mystery lovers. . . .

We learned with interest that Bernard DeVoto, author of "Across the Wide Missouri" and "The Year of Decision," and editor of "The Journals of Lewis and Clark," recently was awarded a medal by "The Limited Editions Club, as one of ten authors who have written books during the last quarter century which seem most likely to survive as classics. . . .

Book-Of-the-Month Club selection for July will be a new novel by Daphne du Maurier (a very good-looking woman, incidentally, judg-

ing from the photos) called "Mary Anne," about Mrs. Mary Anne Clarke, who rose from obscurity to become the favorite of the then-around 1800—Duke of York, Frederick Augustus. . . . According to the biurbs, Mary Anne has it all over such heroines as Becky Sharp, Scarlett O'Hara and Forever Amber, so maybe the Book-of-the-Month Club has something. . . .

On the local scene: We hear with regret that this is the last week that Mrs. Bess Scott, Librarian at the Sheppard Memorial, will spend with us. She goes to her new job on the North Carolina Library Commission with our best wishes — we'll miss her around here, though one consolation is that her duties will take her here occasionally, so maybe we'll be seeing her. ## 10th Anniversary Of GI Bill

WASHINGTON—Next Tuesday will mark the tenth anniversary of a unique law which is partially responsible for general national prosperity, despite three costly wars and heavy expenditures for national defense. It is the so-called GI Bill of Rights, which has provided homes, farms, business and hospitalization, vocational training, pensions and hospitalization for millions of ex-service men and women.

Although political experience refutes it, politicians still speak of and try to appeal to the "veterans' vote." But what they fail to realize is that the veterans' bloc forms a definite and solid economic unit as a result of the operation of the GI Bill of Rights. They have been enabled to stand on their own feet without benefit of politicians. In a sense, the Bill of Rights was also declaration of political independence.

It is estimated that there are now about 20,000,000 living veterans of World Wars I and II and the Korean "police action." With their families, they probably make up almost half of the nation's population. And at least 50 per cent got a new and better economic start because of the GI Bill of Rights.

CASH PAYMENTS TO VETS—Since World War I, a total of \$83 billion has been out to former servicemen and women in one form or the other by the Veterans Administration and its predecessor bodies. That sum has been handed out in cash—in pensions and disability payments, insurance benefits, educational fees, unemployment funds, hospitalization, etc.

## Civil Defense Fault Accentuated By Test

The country's civil defense program has been caught with its slips showing.

Results of the mock enemy attack of major U. S. cities this week pointed out many faults in the program. We got by with the faults in this mock defense drill, but under real attack, the shortcomings of the program shown by the test would indeed be costly.

The nation's civil defense organization has been neglected to a great extent on the local level throughout the country. Throughout its table of organization from top to bottom, there are glaring evidences of lack of planning personnel shortages, and insufficient organization.

The fact that these circumstances exist should not come as surprise to anyone. Reasons for the condition are obvious. The major portion of the nation's population has taken little if any interest in the current civil defense program. Funds for the program have been short on both the national and state levels.

It is difficult to get the people interested in a civil defense program which they hope will never have to be used. Assuming an air of complacency about the civil defense program affords the public an escape from the reality that there is a possibility the civil population of this country may some day come under attack. The American people just don't like to play war games.

The sooner the American people realize the civil defense program is a realistic rather than a fictitious part of the nation's defense, the better off we'll be.

SAVE — A number of "aged and homeless white ladies of Anson county" are assured of a comfortable home, and the "poor of Hertford county" have the benefit of several thousand dollars by reason of the exercise of a responsibility of the Attorney General Harry McMullan's office with which the public is not generally familiar.

The old English Common Law placed upon the attorney general the duty of enforcing public charitable trusts and protecting the beneficiaries. The same obligation is written into the North Carolina statutes, although presently in somewhat vague language.

The Anson and Hertford county cases serve to illustrate the importance of this function on part of the attorney general in saving thousands of dollars for the intended beneficiaries of charitable trusts.

Sketched in briefest outline the Anson situation was about this: Miss Lillie M. Bennett made a will in which she devised specific sums to kinsmen and to particular churches and schools. The residue of the sizeable estate, including the home in Wadesboro, was constituted the Lillie M. Bennett Memorial Foundation with named trustees charged with converting and maintaining the home place as a home for aged homeless white women. A nephew, Judge Clifton Clement Bennett, resident of New Jersey, was

named executor. A few weeks ago Judge Bennett as executor started proceedings in Anson county superior court to invalidate the trust, on the grounds that the homeplace was not suitable for the purpose indicated and the amount of money was inadequate to maintain the home. It happens also that Judge Bennett is the sole blood heir of the deceased Lillie M. Bennett and would get the property if the trust were invalidated. The attorney general was made a party to the action pursuant to North Carolina statutes.

The Anson county court sustained the contentions of the trustees and the attorney general and declared the trust valid. Result is the old ladies will get their home.

## What Other Editors Are Thinking

THE RIGHT TO BELIEVE (Washington Daily News)  
What so many Americans fail to realize is that a man can be a liberal and still be a good American.

Too many people condemn a man for believing this or that, especially if his views are more liberal than those of an average man. For years past on the American political scene men have been branded as socialists or communists purely because of extreme liberal views.

Senator McCarthy seems to confuse liberalism with communism. Every man who is a liberal is not necessarily a communist. In fact that a man believes in a liberal philosophy of government often reacts against him in the forum of American public opinion.

It is so unfair to stamp a man as dangerous or a communist because he holds to a liberal view. While this writer classes himself as a middle of the roader, he recognizes the right of a man to believe in whatever principles he wishes so long as those principles advocate or hold that the other man also can believe in his own principles.

We have seen men crucified in the forum of public opinion because they would disagree with those who hold to the extreme liberal view, as a newspaperman and an American he would in all sincerity and fairness recognize their right to their own beliefs.

If we for one moment try to stifle a man's right to think or believe, we have smothered the greatest American heritage of all time. America became great because men had the right of free speech, free worship, free press, and free beliefs. If we take away any of our freedoms, we have cut the very heart and core of democracy.

However, a man's right to speak and think should not take the destructive turn where he would overthrow the rights of others to do the same thing which democracy allows him. Democracy is a wonderful institution. It even protects those who advocate its overthrow. When a communist goes to trial, under the democratic system, he is assured of a fair trial, and he cannot be punished without a hearing. He often hides behind some principle of democracy to further his fight against the very system which he would overthrow.

That seems unfair, but democracy works slowly. Sometimes it is not as efficient as other forms. But it has a soul that no other form of government can boast.

## Social Security Act

About 10,000,000 more persons are about to be brought under Social Security. The House of Representatives voted 355 to 8 to extend coverage to eight groups and to increase the benefits. The Senate is almost certain to vote for the measure and President Eisenhower will sign the legislation with a flourish.

It may seem strange that the Republican Administration is extending a conception that began in Socialism and was fostered in New Dealism. But this socialistic idea is not a "creep"; it is the inevitable and inescapable consequence of two other things: inflation and high taxes.

Social Security was presented to the nation as a remedy for several ills. It was designed, we were told, to provide for the oldsters who could not find work and it was intended to persuade them to leave the labor market, thereby vacating jobs for hungry men. It had some of those effects, of course. But the reason Social Security was imperative was the devaluation of the dollar and skyrocketing of tax rates. The first cut in half the purchasing power of savings, insurance, annuities and other resources for a comfortable old age; the second works to prevent adequate accumulations for retirement.

Once the government had taken away the birthright of the people, in justice it had to provide an alternative. At the time Social Security was inaugurated, it did more than that; it provided old age subsistence for many who had no savings; nor who had any hopes of accumulating any. But, in that it applied only to part of the population, it did not right the wrong—if it was a wrong—that was done to the rest.

Extension of Social Security to many self-employed a couple of years ago helped to correct that omission, and the new legislation will correct it for millions more. The new beneficiaries include 1,300,000 farm workers, 3,600,000 farmers, 3,500,000 state and Federal workers (if they vote to get in.), 250,000 more domestic workers, 25,000 ministers and members of religious orders, 150,000 Federal civilian workers not now in pension plans, 100,000 citizens abroad, 50,000 workers on small fishing ships, and about 400,000 professions including physicians.

There are some other things being made to bring members of the Armed Services in later. Eventually, everybody in the nation will be brought under. It will be only just. TWO BIG MANUFACTURERS HELP FINANCE DEALERS These are times when manufacturers need aggressive re-

Your reporter has traveled the breadth of Iowa without being able to get an ear of corn, although the same sun grows both hog corn and Roessner-corn; he has invaded five restaurants in Smithfield, Va., before he could get an order of Smithfield ham and eggs; he has looked in vain in railroad stations in Idaho for stands selling hot baked Idaho spuds soaked in Montana butter; he has squirmed before offers of Kansas City beef in New York and New York cuts of beef in Kansas City. However, he has been able to get Pismo clams and Pismo clam chowder at Pismo Beach, Calif., to the eternal glory of the enterprise of transplanted Iowans there.

## Poor Tamara; Caught In Middle

MOSCOW (AP)—See a gal that strikes your fancy?

Well, don't get wastin' time a-curtain an' askin' her consent. Just gallop out and carry her off. If you need help, because she isn't alone, just whistle up a pack of your buddies. That's the way the hillbillies of the Soviet Union down that in the Caucasus Mountains have been doing' it for generations.

But the Communist press in Moscow says it's got to stop — the gal should be courted right and given a chance to say yes or no. Now take the case of Tamara, reports Komsomol Pravda which often criticizes what it calls primitive practices and conditions in the United States. Tamara was a teacher in the mountain village of Malka, in the Kabardinski autonomous republic. And a fine lookin' school marm she was, to.

So fine looking, in fact, one of three "brave and bold" brothers of the village fancied her for a wife. So he called a family council at which it was decided his was a wise choice.

When Tamara took a walk along a mountain path with her sister, the brothers — with two pals — rode out in a coach and carried her off. All this information came to Komsomol Pravda from Tamara's sister, who was left on the trail. Indignantly she wrote the

paper, which prodded the local prosecutor's office until he sent a representative to find what was up. According to this investigator, says Komsomol Pravda, "Tamara" reply to his inquiries was: "Well, after I was kidnaped I agreed to marry him." The prosecutor decided to take her at her word.

But here's what really happened, the paper quotes the unkidnaped sister: "Tamara was kidnaped she became afraid for the future and agreed to marry him." The paper cites the case of two other recently kidnaped brides, and says "the girls in the mountain areas live in constant fear of being kidnaped. And once they are thus forced to marry the man their life is ruined."

Of the brothers who kidnaped Tamara, it says "the committed" "hooligan" deed typical of the feudal mode of life of pre-revolutionary Kabardinski. . . . "Why is the work of the public prosecutor's office not so organized as to defend the honor of Kabardinski and its women? Why does it not punish those who violate the law — who kidnap people? And why does it not protect those who need protection?"

But the most unkind blow of all is delivered by that sister left on the path. She writes: "If my sister Tamara agreed to marry this man, I will say to everybody that she is unworthy of the principles a Komsomol member. She victimizes herself for the sake of her feudal survival."

## Educational TV Discussed At ECC Conference

That television is an increasingly popular and powerful force in education and presents both great opportunities and perplexing problems to pupils, parents, and teachers was brought out in discussions at a two-day conference on educational TV held Wednesday and Thursday of this week at East Carolina College.

Ralph L. Burgin of State College, Raleigh, program director of Station WUNC-TV, which will go on the air in the fall, acted as consultant at meetings held in the Radio Theatre of the Joyner Library at the college.

Under the direction of Dr. E. D. Johnson of East Carolina, the conference was sponsored jointly by the college and Station WNCN-TV of Greenville.

Included on the program was a tour of the local television studio, with E. B. Wall, program director there, and his staff as hosts; observation of commercial TV programs, and discussion of their educational values for the child and the general public; and a panel on "Television and the Child."

Participants in this panel were Dean Leo W. Jenkins, moderator; Mrs. Elsie Eagan, faculty member, and Harry Forbes of Greenville, pupil in the Wahl-Coates Laboratory School at the college; Mrs. J. W. Overton of Greenville, PTA president; and Frank Fuller of the East Carolina faculty.

Different points of view about TV were informally presented by this varied group and members of the audience. Emphasis was placed on problems relating to juvenile delinquency, the effects of TV on the reading habits of children, instruction encouraging discrimination on the part of the child in the choice of programs, better contacts between teachers and TV stations through advanced notices of educational programs, effects of TV on the health of children, and the question of TV and the child's homework for his classes.

## Brownell Fires Another Criticism Of Informers

BALTIMORE (AP)—Atty. Gen. Brownell said last night Sen. McCarthy's invitation to government employees to come to him with information, even information they are charged with keeping secret:

1. Threatens the classic American concept of separation of powers among Congress, the executive and the courts.

2. "Would substitute rule by an individual for government by law."

About 500 weekly newspaper editors and publishers attending the 68th annual convention of the National Editorial Assn. broke in to applaud when the attorney general declared:

"Anyone who attempts to put himself above the law, and incite government employees to turn over classified information relating to our national security, is tragically

mistaken if he believes he is helping to protect our nation's safety. "Nothing pleases the Communists more than to create division among the people on matters of national security impair constitutional government, and encourage disobedience to the law....

"I have spoken out pretty strongly against those in high places who are blind to the danger of Communist infiltration in our government. I believe it equally important to speak out against those who, regardless of motive, break down our system of government by law in an effort to investigate communism. There is no need for it."

Brownell did not mention McCarthy (R-Wis) by name. But he quoted verbatim the statement McCarthy made during the Army-McCarthy hearings that it was the duty of federal employees "to give us any information which they have."

Brownell said this "open invitation to violate the laws of the United States would substitute rule by an individual for government by law."

He went on: "Long years of experience have proved that direct control of military secrets, intelligence information and counterintelligence the executive branch.

"During all our history, the ordinary auditing powers of Congress, plus its broad powers to legislate and its broad powers to control the purse strings have sufficed to provide the necessary checks on the executive branch. That is a better system than destroying our constitutional system of separation of powers—an action which our founding fathers warned would result in tyranny."

'Dual Loyalty' Of Labor Recognized

By NORMAN WALKER WASHINGTON (AP)—Now that jobs are scarcer, are workers less willing to strike?

With strike idleness for the first four months of this year running at a postwar low, the answer appears to be yes. But to say that workers are less willing to strike doesn't mean they won't if they think the issues important. Just last month an AFL union settled a strike that had gone on for 10 months at a Norwalk, Conn., hat factory. The issue was job security.

That single walkout cost the union, a small one, nearly two million dollars in strike benefits. The workers themselves lost an estimated four million dollars in wages. Last year was a relatively peaceful one in labor relations. Strike idleness amounted to less than half what it was in 1952.

Yet it was generally overlooked that the number of strikes last year was more than 5,000—nearly a record, although the walkouts were generally small ones that didn't last very long. So far this year both the number of strikes and resulting idleness are running at the lowest point since World War II.

This seeming reluctance of workers to engage in strikes these days is probably due mainly to the business situation—a realization that employers don't have as many dollars to spend for wage increases as they once had. Recent plant surveys, however, have strongly indicated that while workers support union objectives they also sympathize with their employers' problems.

These studies show that most workers have "dual loyalty"—that is while they may be ardent union members, they also have a considerable respect and allegiance for the boss. It was said that even foremen who are supposed to represent management in small groups of workers, and union stewards, who represent the union in such worker groups, are loyal to both company and union.

This "dual loyalty" was found even in cases where individual company officers or union leaders were unpopular. Secretary of Labor James P. Mitchell, in analyzing these research findings recently, said "they have definitely disproved the Marxian philosophy of class conflict."

"As long as the company and the union do not represent conflicting forces and try to pull the worker in different directions," Mitchell said "the workers can be 'loyal' to both and well disposed toward each."

"When there is a conflict between them, however, the employe must choose which allegiance shall motivate his action in the particular situation and circumstances. He

must choose between company and union. "It is to the advantage, therefore, of employe, union, employe and public not to have any conflict so that the worker can feel a favorable and friendly identification with both his company and union."

Late last year the CIO United Auto Workers struck military airplane producing plants at the North American Aviation Co. at Columbus, Ohio, and Los Angeles. The strike, which lasted two months, was ultimately settled pretty much on the company's terms. The experience apparently didn't sit too well with some of the workers. Many quit the union.

To help hold back membership, the union has put the Columbus local under an "administrative" meaning that it is now run by the union's national headquarters. The union started an extraordinary organizing drive at North American's Los Angeles plants with initiation fees waived and a grand prize of (A) a new automobile or (B) an all-expense-paid trip for two to Hawaii, plus baggage and clothes, for its members.

Thus in these days when workers have some degree of loyalty to both, the union and the employe are handling their relationships with workers more carefully.

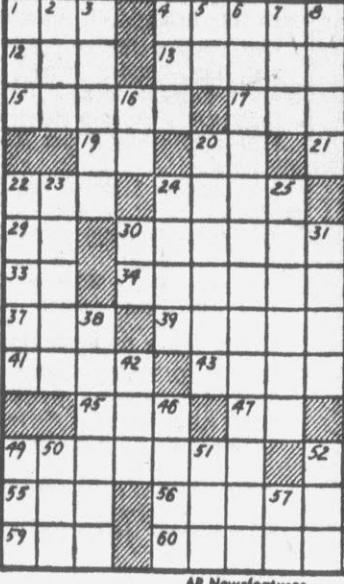
