BANDIT ROBBS VANCEBORO BANK

Utilities Accept Audit Report On Concluded Year; \$333,028 Profit

Assets Reveal Increase Of \$231,398 Over Figures For Previous Year

At a meeting last night the Greenville Utilities Commissioners accepted the audit report for the year ending June 30, 1954.

The audit, which was received by the Commissioners with full details by Auditor John C. Proctor, showed a net profit for the year of \$333,028.48.

As of June 30, 1954 the Commission showed cash account of \$159,670.46. This was a \$91,835.25 increase over June 30, 1953.

Accounts receivable totaled \$2,525.53, an increase of \$262.61 over 1953. Inventories showed \$231,864.30 compared with \$287,139.62.

Prepaid insurance totaled \$5,585. Last year there was no prepaid insurance.

Finally, the property, plant and equipment show a value of \$5,324,597.81 as compared to \$5,135,806.66 of last year.

The total assets for the fiscal year amounted to \$5,724,243.10 as compared to \$5,492,844.41. This is a \$231,398.69 increase of the 1953 figure.

Liabilities In the liability column the accounts payable totaled \$30,112.11. Last year the figure was \$38,215.95 - a decrease of \$8,103.86.

Deposits total \$81,806.74 while last year the deposits totaled \$77,332.83. Bonded indebtedness showed \$2,680,000 while last year it was \$2,778,000.

Total liabilities for the year were \$2,791,918.85 while last year it was \$2,895,546.80, a decrease of \$101,627.95.

The surplus totaled \$2,932,324.25 or \$333,028.64 more than last year. This increase of \$33,028.64 is the net profit for the year.

Profit and Loss The revenue for the year ending June 30, 1954 totaled \$1,833,417.25. This is a \$173,939.21 increase over last year.

Cost of production for the year was \$872,428.89 or \$77,749.99 more than last year. The cost of distribution totaled \$296,390.52 or \$23,178.63 more than last year.

The administrative and general cost totaled \$261,785.47. This cost decreased \$2,798.44 compared to last year.

Total expenses for the year was \$1,369,604.88. Last year the total expense was \$1,271,474.70.

Other income amounted to \$11,716.27 showing a final profit of the year of \$475,528.64. Last year the total profit was \$423,579.58 - thus an increase this year of \$51,949.06.

The turnover for the city for the fiscal year was \$142,500 as compared to \$82,604.10 for the fiscal year ending June 30, 1953.

Final net profit this year was \$333,028.64 as compared to \$340,975.48 of last year.

The electric department showed an increase of 12.33 percent in kilowatt hours sold to customers. Power was purchased from Virginia Electric and Power Company at a cost of 2.043 cents per kilowatt. This is 47 percent less than the cost of power produced at the plant, Proctor reported.

Negro Named To Diplomatic Post

ROME (AP)—Dr. Frank M. Snowden Jr., Negro professor and director of the summer school at Howard University in Washington, D. C., has been appointed cultural attaché of the U.S. Embassy in Rome.

The embassy said Snowden is the first Negro named to such a major European post.

Highway Patrol Retains Policy Of Arrest Without A Warrant

RALEIGH (AP)—Motor Vehicles Commissioner Ed Scheidt has reiterated that the State Highway Patrol will continue its policy of making arrests without warrants in motor vehicle violation cases.

Scheidt conferred yesterday with state attorneys and patrol officers. He then issued a statement which said "arrests will continue to be made as in the past."

WASHINGTON (AP)—President Eisenhower says the books are open for inspection of a controversial power contract in the TVA area. Democratic National Chairman Stephen A. Mitchell says he's glad Eisenhower is ready to disclose "the whole story behind the Dixon-Yates deal."

Mitchell's latest blast at the power contract came in a statement he issued in Chicago last night after Eisenhower had told his news conference he is astonished at Mitchell's criticism of the way the matter was handled.

The ruckus was stirred up on Monday when Mitchell—in a Chicago debate with Republican National Chairman Leonard W. Hall—

Local Mart's Tobacco Price Average Increases

Second day figures show Greenville's tobacco market increased its average over opening day by \$1.55. Yesterday, even though sales were still light, the local market paid \$43.211.31 for 79,058 pounds of tobacco. The average was \$54.66. Opening day's average was \$53.11.

Sales Supervisor W. L. Whedbee said this morning the offerings yesterday consisted of low and medium grade primings, lugs and a sprinkling of tips. He said the small volume was due to the extremely dry weather.

The supervisor reported plenty of room for sales this week. Farmville tobacco market sales supervisor Charles E. Edwards reported very light sales on that market today and that the average was \$55.06.

Fred Royster of Henderson, president of the Bright Belt Warehouse Assn., announced today that tobacco markets of the Eastern North Carolina Belt will continue sales for the remainder of this week at 60 percent of normal. Beginning Monday they will go on a full sales schedule.

So far, sales on the Eastern markets have been light and have not reached 60 percent of normal. Royster said extremely light sales on both the Eastern and South Carolina Belts was due primarily to hot weather which prevented growers from handling their leaf.

Georgia-Florida Tobacco Markets Approach Close

VALDOSTA, Ga. (AP)—Georgia-Florida tobacco markets are nearing the end of the season with prices, quality and volume at low levels.

Total sales Monday for the 11 markets still operating were 2,219,770 pounds at an average price of \$33.57 per hundred.

Sales for the entire Georgia-Florida Belt this season through Monday totaled 171,819,351 pounds at an average of \$48.38.

For the corresponding period last year, beltwide sales totaled 187,671,212 pounds for a \$51.26 average.

Five markets will close this week. Moultrie rings down the curtain for the season today, Fitzgerald and Valdosta close Thursday, and Blackshear and Hazelhurst Friday.

Roadblocks Thrown Up; Second Man Believed Accompanying Robber Lone Gunman Took \$3,000

VANCEBORO—An armed bandit today held up the Vanceboro branch of the Guaranty Bank and Trust Company and made off with more than \$3,000.

W. H. Woolard of Greenville, President of the Guaranty Bank and Trust Company said a check of the money at the Vanceboro bank indicated the robbers got approximately \$3,039. The check was completed shortly before 1 o'clock.

Woolard said the loss was fully insured. The man entered the bank, leveled a chrome plated revolver at Assistant Cashier Robert B. Whitley and Teller Mavis Simpkins and ordered them to lie on the floor. He scooped money from the drawers in two tellers cages and fled.

Only 2 Minutes Mrs. Simpkins, whose home is in Ernul, said the robber was in the bank less than two minutes.

While the robbery was taking place, Elmon Ippock, a farmer of the Vanceboro community, entered the bank and was also made to lie on the floor by the bandit.

Local, state and federal officers converged on the small Craven County town of about 600 people shortly after the robbery took place at 10:45 this morning.

FBI agents, SBI agents and local officers were investigating the robbery while patrolmen and officers from nearby counties set up roadblocks in an effort to apprehend the robber and an accomplice who were believed traveling in either a 1949 green Ford or a yellow Lincoln.

Said 'Lie Down' Whitley said he was standing at the first teller's window counting money and Mrs. Simpkins was wrapping money when the bandit flashed the revolver in his face.

"He pointed the gun in my face and said lie down," Mrs. Simpkins told a Reflector reporter. "He went up to Bob (Whitley) and told him to lie down."

He took the bag that Whitley was counting money from which had about \$130 in it. She said the bandit then scooped the money from the drawers of the two tellers windows.

"While he was here," Mrs. Simpkins said, "Mr. Ippock came in and he told him he would be with him in just a minute. As he started out the door he told Mr. Ippock to lay down and stay down."

"Got In Hurry" Ippock told the Reflector reporter he had come into the bank to deposit a check. He said the man was "getting the money when I came in and he told me to wait just a minute. The man started to the back and I thought he was going to the vault to put the money away."

Ippock said when the man got to the back of the cages he "got in a hurry" and he got around the corner of the cages, "and told me to lay down."

Ippock said the man told him three times to lie down. Ippock said he didn't move when the man first told him to lie down, but did when the man waved a revolver at him and told him "I mean business."

He said he believed he would recognize the bandit if he saw him again.

Unmasked The lone bandit was dressed in gray trousers, a gray shirt and a sport cap. He was unmasked. He was described by the two bank employees as a white man, tanned, 26 to 28 years old, about "five feet nine inches tall and weighed about 150 pounds."

Whitley said he had seen the man about 30 minutes before walking across the street in front of the bank. Mrs. Simpkins told reporters, "I

would recognize him if I saw him again. I saw him go by the bank this morning a couple of times."

She said she also saw the man once yesterday.

A. F. Whitley, cashier of the bank and brother of the assistant cashier, was visiting a physician in Washington at the time the unmasked bandit entered the bank.

Missed Money J. H. Waldrop, vice president and comptroller of the Guaranty Bank and Trust Company, said the robber took only the money in the front section of the drawers in the tellers' cages, and missed the cash which was in the back section of the drawers. Waldrop also said the bandit missed approximately \$250 which was lying on the counter.

Included in the loot was \$200 in halves.

Second Robbery It was the second time in a year that a branch of the Guaranty Bank and Trust Company has been robbed. Last summer a youth robbed the Williamston branch of the bank of \$17,000 but he and his brother were quickly apprehended and later convicted of bank robbery. The loot was recovered.

The man who robbed the Vanceboro bank today was armed with a .32 or .38 calibre "old type" revolver.

The FBI said early this afternoon it believed two men were involved in the robbery. Officers were notified to be on the lookout for a green Ford in which two men were riding, and also to be on the lookout for a yellow Lincoln in which two men were accompanied by a blonde woman.

Accomplice The second man believed involved in the robbery was described at 30 to 35 years old, five feet nine inches and weighing 160 to 165 pounds.

The Vanceboro robbery today was the sixth bank robbery this year in North Carolina. Previous holdups have occurred at Fletcher, and Bostic in the western part of the state and at Cayuse, Fremont and Carboro in the eastern part. FBI officials have obtained convictions or reported confessions in all five robberies.

S. Korea Claims Withdrawal Of U.S. Troops Set

SEOUL (AP)—South Korean National Assemblymen said tonight the United States plans to withdraw all but three U.S. divisions from Korea by the end of 1954.

There are now six U.S. divisions in Korea.

The report was made during an emergency night session of the National Assembly which voted unanimously to oppose a withdrawal.

An Army spokesman in Washington said he had heard nothing of plans for withdrawing part of the 8th Army from Korea.

Assembly Chairman Lee Ki Poong said South Korean representatives in Washington would discuss the matter with top U.S. officials tomorrow.

Foreign Relations Committee Chairman Whang Sung So said the United States plans to pull out all but two U.S. divisions and one combined division of U.S. and other U.N. troops.

An informed source said President Syngman Rhee was advised the U.S. National Security Council will make a decision "within two days."

Rhee and other ROK government officials long have demanded that three South Korean infantry divisions be formed for each U.S. division pulled out of South Korea.

Twenty South Korean divisions and seven divisions of U.S. and U.N. troops now are in South Korea.

Demonstrations against the reported withdrawal were being scheduled throughout South Korea tomorrow, official sources said.

Opposition Mounts To French Proposals EDC Leaders Gathering In Brussels

BRUSSELS, Belgium (AP)—Leaders of the six European army nations came to the Belgian capital today for crucial talks on the French demands imperiling the projected European Defense Community.

From all sides opposition mounted to French Premier Pierre Mendes-France's proposals for major revisions in the EDC treaty. But reports from Paris said Mendes-France would tell his colleagues at the foreign ministers' conference opening here tomorrow that only his new European army plan could be approved by the French National Assembly.

Many observers doubted that an acceptable formula could be worked out for the six-nation army in which a rearmend West Germany would pool her troops with those of France, Italy, Belgium, the Netherlands and Luxembourg.

U.S. officials in Washington already have expressed fears that the long-nurtured EDC plan, first proposed in October 1950 by France's then defense minister, Rene Pleven, is doomed.

So far the five other EDC nations have given evidence of nothing but opposition to the French proposals. Critics contend they rob the army plan of much of its international aspect. All argue the amendments would require new parliamentary approval by the four nations—all but Italy and France—which have ratified the pact.

The West Germans consider the proposals raise new discriminations against them.

Mendes-France was reported ready to answer the critics with the argument that even a much-modified army plan is better than no army at all, and that the EDC pact as now drafted cannot win approval in his National Assembly.

French sources said Mendes-France believes a treaty amended as he proposes would secure approval of a majority of the lower house's entire 627 members. Only this majority can override an adverse vote in the French senate, the Council of the Republic.

The Mendes-France amendments among other things, would allow any members to withdraw from EDC if a American and British troops were pulled out of Europe, limit the EDC treaty's length to that of the North Atlantic Treaty Organization, forbid the stationing of German troops on French soil and withhold final French ratification pending a new try at settlement with Russia of the German question.

NEW YORK (AP)—Four youths, who authorities said "got a kick out of seeing blood flow," have been charged with prowling Brooklyn parks at night and wantonly torturing almost anyone they found. At least two persons were slain, authorities said.

Brooklyn Dist. Atty. Edward S. Silver said yesterday the youths admitted beating and kicking a man to death, horsewhipping teenage girls and torturing a vagrant and throwing him into the East River.

Silver said the youths, ranging from 15 to 18 years of age, apparently had no reason for the crimes except the thrill they got. They "committed crimes for pleasure and hatred and got a kick out of seeing blood flow," Silver said. Two of them were charged with

murder, one with felonious assault and the fourth, because of his age, with juvenile delinquency.

The four were nabbed early yesterday after a passerby told police he had just seen four boys beat a man in Lou Sobel park. They confessed to the crimes after questioning, Silver said.

Their orgy started on Aug. 6, Silver said, when two of the gang attacked Rheinholt Ulrickson, 43, a homeless and inebriated alcoholic, beating and kicking him to insensibility. He died 12 hours later at Greenpoint Hospital.

Last Monday, Silver continued, they raided Washington park where they beat two elderly men.

Later that night they waylaid and horsewhipped two young girls. The whip was seized by police in the home of one of the youths.

Silver said that after that the

gang set upon a Negro sleeping on a bench, who had no shoes or socks on. They burned his feet with lighted cigarettes, beat him unconscious, dragged him to the East River and threw him into the water. The man, who has not been identified, apparently drowned.

Charged with homicide in the Ulrickson death were Melvin Mittman and Jerome Lieberman, both 17. Jack Koslow, 18, accused of felonious assault and Robert Trautenberg, 15, was charged with juvenile delinquency.

All but Koslow are from the Williamsburg section of Brooklyn.

Silver quoted Koslow, of Manhattan, as saying he had "an abstract hatred for bums—I despise them."

Now It's The Council's Turn Again

Now, with buck-passing possibilities apparently exhausted, we expect Greenville's City Council will let the courtesy parking plan die because no funds will be available to operate it.

The Greenville Merchants Association has announced that after Saturday it is withdrawing its financial support which has made the courtesy parking plan possible since its inception in April of last year.

No one can blame the Merchants Association for withdrawing its support. Since the Council announced it would abolish the courtesy parking plan November 1, abuses of the plan by the general public have become more and more flagrant. The Merchants Association has been loaning nickels to parkers and getting few nickels in return.

The City Council's handling of this courtesy parking matter is absurd. In our opinion, the Council has not acted in the best interest of the city as a whole; but consciously or unconsciously it has leaned toward preferential treatment for some individuals or groups at the expense of the city as a whole.

Strength for the Day

GAMBLING

Gambling is sometimes described as getting something for nothing. It is precisely the opposite. It consists in getting nothing for something.

Someone has called gambling the child of avarice and parent of prodigality. Old Ben Franklin urged his readers that as they would keep wax from fire, so should they keep youth from gambling. And the observation has often been made that the best throw one can make with dice is to throw them away.

It is inconceivable that although everyone knows that slot machines are rigged to bring their owners tremendous profit and the player consistent loss, yet people go on wasting their money, hoping that some day they will strike the jackpot. Now and again a person wins a tremendous amount of money on sweep-stake tickets, but where one wins, a million lose.

Many years ago, America's most famous gambler died after trying up what little he had in trust for a nephew, fearing lest this little would get into the boy's hands and slip through his fingers. At the end of a lifetime of gambling, the man who had won millions had lost them, for of course, he never had sense enough to stop when things were running in his favor.

For some reason or other, gambling seems to ruin character almost irreparably. Drunkards are often reformed, but gamblers seldom. This is a vice that cuts the very life out of moral character.

National Whirligig

Struggle For Airline Routes

WASHINGTON—The survival or death of President Eisenhower's program for a fair and antimonopolistic revision of American commercial aviation will be determined by the outcome of the current struggle for new routes between several competitive companies. Powerful politico-economic interests seek to outmaneuver the White House on this problem.

The two cases heading toward his desk, and which he must decide within a few weeks, involve Juan Trippe's giant Pan American World Airways, which has been charged with seeking a monopoly in international flying.

It maintains an influential lobby here, including a Cabinet member, numerous Senators, Democratic and Republican politicians, lawyers who once served in the Roosevelt-Truman households, Oswald Ryan, Civil Aeronautics Board member, has never voted against Pan Am.

WEEKS SEEKS TO AID PAN AM—The American Aviation Daily, which is the aviation industry's recognized trade journal, charges that Commerce Secretary Sinclair Weeks is trying to upset CAB and Justice Department decisions adverse to Pan Am in the famous Balboa case. Weeks also seeks to aid Pan Am's attempt to block establishment of a second, competitive American around-the-world airline.

It is the grimmest but most unwritten feud in Washington today, with Weeks defying Attorney General Herbert Brownell Jr., who has filed an anti-trust suit against Pan American and its South American subsidiary, Panagra.

The domestic controversy concerns air service between the United States and South America. The current interchange at Miami connects Eastern Airlines (Eddie Rickenbacker's outfit) and Panagra, which is owned 50 per cent by Pan Am.

CAB has twice recommended that Eastern interchange at Miami with Braniff Airways, and that National Airlines merge there with Panagra, thus providing two strong competitive services in the South American area. Pan Am flies to South America through the Caribbean.

TRANS WORLD WOULD EXTEND ROUTE — The other aviation controversy is, perhaps, even more important because it involves commercial penetration and a buildup of American influence in countries still undecided on whether they will adhere to the United States or to the Russo-Chinese communism-Japan, southeast Asia and India.

Pan American has an around-the-world monopoly at the moment. Its chief rival, Trans World Airlines, now files from New York to Bombay, India. Trans World seeks a certificate to extend its route to Tokyo, where it would join up with Northwest Airlines to provide another global American airline.

HEALTHY COMPETITION POLICY—The need for competition in this area has been emphasized in numerous State Department and White House papers. In its effort to erect an anti-Red bulwark from Japan to Siam, the U. S. needs as many contacts as possible. It needs fast and frequent air service for cargoes, businessmen and tourists.

But Thomas Wrenn, CAB examiner, who has never written a report adverse to Pan Am, dismisses or neglects these politico-economic considerations. In his report against the Trans World petition for the Tokyo extension, he takes no cognizance of diplomatic factors. He also dismisses the fact that Trans World costs are far lower than Pan Am's, according to official CAB statistics.

The CAB will soon send its recommendation on this question to Ike, with Ryan working for a ruling that will preserve Pan Am's monopoly. But it is generally believed that Eisenhower will reverse his predecessor's policies and side with Brownell in a demand for healthy competition, greater efficiency and lower costs.

RELATIVE — The relative importance of crops is noted in a table comparing the five-year periods of 1924-29, 1937-41 and 1948-52. Cotton, which represented 34.13 per cent of farm crops in the first period, dropped to 13.59 per cent in the second, and to 10.56 per cent in 1948-52 period. Meanwhile tobacco was moving up from 35.34 per cent to 53.5 per cent and 54.26 per cent. Corn moved from 2.33 per cent to 3.04 per cent and 3.32 per cent. Fruits and vegetables declined in relative importance during the 28 years covered, although some kinds of vegetables showed substantial increases.

LIVESTOCK — In 1924-29 field and garden crops represented 86.40 per cent of all farm products (including poultry and dairy) accounted for 13.60 per cent. The more rapid development in livestock particularly during the past 15 years, had changed the percentages by 1948-52 to 79.10 per cent for field crops, 20.10 per cent for livestock. Most notable increases were in poultry products and milk produced for bulk sales.

Protection Of Ideas

By ELMER ROESSNER
Contrary to popular belief, original ideas can be protected and sold even if they are not suitable for patent or copyright.

How this works is told by G. Howard Mann, of the Institute of American Inventors, in a leaflet prepared for the Small Business Administration.

Contracts are the key. First, the originator of the idea must not blab about it. Second, he should disclose details to no one without a contract providing for a review in confidence and payment if used.

Mr. Mann suggests the creator write to a company likely to be interested, offering to disclose details if an accompanying agreement is signed. He suggests this form:

"We, the undersigned, agree to receive in confidence full details about an idea for product packaging to be submitted for our consideration by Robert Roe.

"It is further understood that we assume no responsibility whatever with respect to features which can be demonstrated to be already known to us. We also agree not to divulge any details of the idea submitted without permission of Robert Roe or to make use of any feature or information of which the said Robert Roe is the originator, without payment of compensation to be fixed by negotiation with the said Robert Roe or his lawful representatives.

"There should be space for date and official company signature, and space for the inventor to sign in acceptance. There should be two copies, one for each party. The appropriate term should be substituted for "product packaging" and the name of the idea

man for "Robert Roe." Of course, if the idea can be proved to have existed before, the company is under no obligation.

A copy of the leaflet can be obtained by writing the Small Business Administration, Washington 25, D.C., and asking for "Management Aid No. 53."

Churches Strive For More Unity

EVANSTON, Ill. (AP)—Representatives of 170 million Christians today renewed their efforts to carry out Jesus Christ's prayer "that they may all be one."

Hopes for a closer union of Christ's followers were expressed before leaders of 163 denominations from 48 countries at the meeting of the World Council of Churches.

Keynote speeches on unity were made last night by clergymen of four different denominations from four different countries.

They laid the groundwork for later discussions.

Bishop Anders Nygren of the Church of Sweden recalled Christ's prayer not long before his crucifixion. The bishop said:

"Jesus prayed 'that they may all be one.'"

"One must now take that prayer seriously so Jesus shall not have prayed in vain."

He also stated:

"If we were not one in Christ we would not be assembled here. And if we were not disunited we would not be here either, for this conference is meant to be a step on the way toward overcoming this disunity."

Canon O. S. Tomkins of the Church of England mentioned differences over such things as a definition of unity, but said:

"It may be that, by every standard of human achievement, the unity of the church is an impossible task and to think of it is an idle dream. But we are not limited to human achievements. Christ has made us his own—and he is not divided."

The Rev. Georges Florovsky, New York City, of the Russian Orthodox Catholic Church said:

"The very sting of Christian tragedy is in the fact that, in the concrete setting of history, many divisions have been imposed as it were, precisely by loyalty to Christ and by a sincere zeal for the true faith."

The Rev. V. E. Devadutt, president of the Baptist Union of India, made this comment:

"A church that lives out of communion with another church is taking upon itself a dreadful responsibility for it is saying in effect to its sister church: 'You are not founded on Christ.'"

The World Council itself does not arrange mergers of denominations but it seeks to bring about the understanding that may lead to consolidations among them.

"No, this certainly has been no do-nothing Congress." But much of the work accomplished, he said, has "not been in the interests of the people."

Brokers Say The Public Entering Stock Market

By SAM DAWSON
NEW YORK (AP)—Brokers say the public is coming into the stock market now. And that makes for quicker and wider swings in stock prices.

The public reacts much more violently than do institutional investors to news or rumors that affect confidence, seem to arouse big chances for gain, or, on the contrary, seem to call for caution or retreat.

And for almost a year now the institutional investors have been one of the chief supports of the rising market. These investors handle other people's money—the growing corporate pension funds, for instance, or the growing total of savings in the form of insurance, or the big educational philanthropic or private trust funds.

They have been buying up the blue chips—the top-grade stocks with the best records of stability and the firmest foreseeable future.

As these blue chips have been salted away in the strong boxes of the big institutional investors, there have been fewer shares available for trading on the stock exchange. A flurry of demand for an issue, therefore, can send the price up faster than formerly because the supply to meet that demand is thin.

Brokers say that the recent interest in the secondary shares—the stocks priced lower than the blue chips and with more of a speculative tinge—is one evidence that the public is being drawn into the market. Another, they say, is found in some of the quick and wide swings in individual stocks due to corporate news or to rumors involving various companies.

With the public in the market, the chance of a big break is greater according to the brokers, because the public takes fright faster and dumps its holdings.

The institutional investors don't dump stocks fast.

The public also is more likely to respond to the psychological nudges that come from official proclamations of confidence, brokers say. The institutional investors who for 11 months now have been buying up stocks have shown a long-term confidence in the economy's future.

But that is quite another thing from expecting a quick boom in the next few months, based on any official assurances of future prosperity.

Ask Britain To Handle Demands

LONDON (AP)—The United States has asked Britain to take over its compensation demands against Red China for the six Americans killed and wounded in the British airliner shot down July 23 near Hainan Island, official sources said last night.

Informants said Washington has proposed that Britain lump its own compensation claims with those of the United States and present them to the Chinese Communists.

Peiping already has rejected two direct American demands for compensation, but has offered to talk over the British claims.

Dodgers Thrown For Loss By Lowly Pirates; Milwaukee String Broken

Three years ago Branch Rickey invited a group of sports writers to attend the 1954 World Series in Pittsburgh.

The only way Pittsburgh will see the 1954 World Series is by television. But the old master's amazement and fussy-checked youngsters apparently is going to have a lot to say about where the series will be played.

The last-place Pirates own today's longest winning streak in the National League—five games, including a 4-2 triumph last night over the bewildered Brooklyn Dodgers. Pittsburgh had won 9 of its last 11, the best record by a Pirate team since 1949.

The Dodgers had reason to be bewildered. This was their second loss in Forbes Field in seven starts this season. In 1952 and 1953 they lost there only twice.

Pittsburgh's streak became the longest when the Milwaukee Braves were beaten 4-1 by St. Louis, ending a nine-game string. The league-leading New York Giants beat Philadelphia 8-3 putting them two games in front of Brooklyn, 4½ ahead of the Braves.

Max Surkont, one of the pitchers Milwaukee decided it didn't need this season, beat the Dodgers on five hits. Frank Thomas drove in three of the four runs.

Johnny Antonelli, also traded away by the Braves during the winter, won his 18th game against three losses for the Giants. Bobby Hofman drove in four runs with a pair of homers and a single. Willie Mays smashed a triple and three singles in four times up, running his hitting streak to 18 games.

In the American League, the New York Yankees won their eighth in a row, 111 over Philadelphia and again failed to close the three-game gap on the Cleveland Indians, who came from behind in the last of the ninth and nipped Detroit 4-3 for their seventh straight.

Fight Tonight

CHICAGO (AP)—Gil Turner of Philadelphia, returning to his "natural" welterweight division after a disappointing fling against the middleweights, is a 3-1 favorite to beat Al Andrews of Superior, Wis., in their 10-round bout at Chicago Stadium tonight.

The match will be televised nationally by CBS at 9 p.m. EST. Champion Kid Gavilan ended a streak of 31 straight victories for then welter contender Turner two years ago and the defeat prompted the fast-swinging Philadelphia to move up a notch.

Against 160-pounders he has lost five fights and now returns to the lower division where, he says, "Gavilan is past his peak and ready to be taken."

Turner's overall record is 42 victories against 6 losses. His wins include 30 knockouts.

Andrews has won 28 bouts, lost 7 and fought 2 draws. Ranked as the No. 7 welterweight, the former soldier has gained some national TV prominence with two victories over Chuck Davey.

The Pirates are in last place in the National League but 20,102 fans turned out last night to watch them spot the Brooklyn Dodgers two runs in the first inning, then come through with a 4-2 victory for their fifth consecutive win. The crowd was the largest to watch a night home game this year.

The Pirates now have won nine of their last 11 games—tops since 1949 for them.

Dodger manager Walt Alton, somewhat sour over dropping two full games back of the pace-setting New York Giants, commented: "There's no question the Pirates are a young and hustling ball club. They've improved since I last saw them. They'll improve more."

Trabert, Seixas Unimpressive In Doubles Victory

Seed Gifts Help Foreign Farmers

MANILA, Philippines (AP)—The Filipino farmers never had seen anything like it. They took the gift radish seed from the United States and planted it.

It came up just like the Filipino radish but when they harvested the crop, the roots were red. Now to a Filipino, a radish is white.

"They thought at first they were apples. They cooked some and like them better than the white ones."

This is from one of many letters received by the Manila headquarters of "Seeds for Democracy," directed by the privately sponsored Committee for Free Asia.

"Many farmers are growing vegetables they have not known before," said Dolores L. Benavides, project director in Manila. "Some of them were wary at first. Then they start liking them and order more."

More than three million seed packages have been distributed since the project was launched in 1950 as an experiment in good will. The distribution includes pole beans, bush beans, cabbage, cauliflower, eggplant, mustard, lettuce, tomatoes, peas, squash and watermelon.

Contributions have come from the Girl Scouts 4-H clubs, the National Council of State Garden Clubs Inc., the Georgia Federation of Women's Clubs, the Junior Chamber of Commerce of Omaha, Neb., and the Buffalo Evening News.

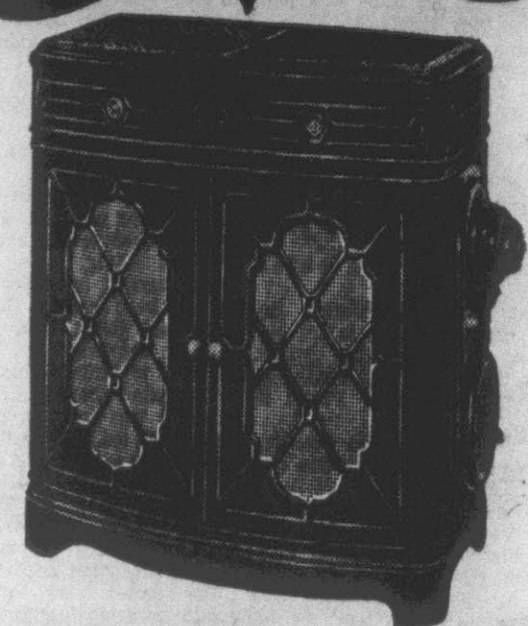

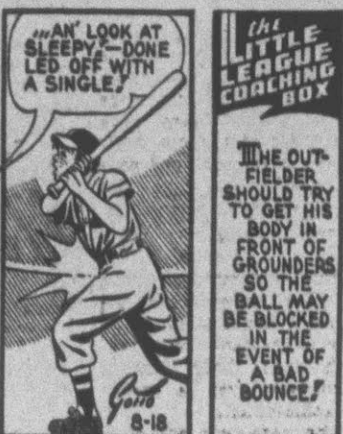
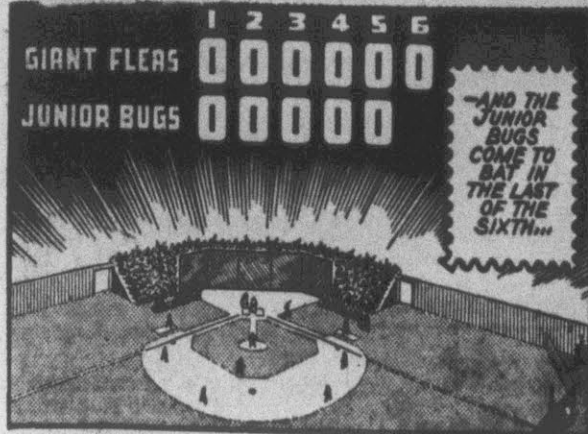

Tornado Leaves Heavy Wreckage

STALEY, N.C.—This Randolph County town of 250 was left in shambles after a tornado ripped a mile-long swath yesterday, wrecking the two major industries and leaving an estimated half million dollars damages. Nobody was hurt.

The C. M. Starley hosiery mill was demolished. The machinery, bolted to concrete floors, was left standing in the open, the walls and roof blown away. The A. C. Marley chair plant was knocked from its foundations and the roof blown in.

Mayor John Staley said, "It's a miracle that nobody was hurt, not a scratch as far as I can learn."

At least 15 homes were hit by the twister.

Emergency crews made temporary repairs, erecting tar paper roofs on damaged homes to provide shelter last night.

C. F. Teague, storekeeper, said none of his customers nor himself were hurt when the front of the store collapsed.

"The wind was blowing hard," he said, "there was a dash and the whole front of the store went out in the road."

Heavy Acreage Cuts For State

RALEIGH—Under acreage allotment restrictions for 1955, North Carolina farmers will lose 712,000 acres of land from cash crop production.

This was pointed out yesterday to agricultural administrators and department heads at North Carolina State College. They considered ways that the college could help the farmers meet the loss of the acreage and still maintain their net income.

Horace D. Godfrey, state administrative officer for agricultural conservation and stabilization said his office had not yet received instructions for carrying out the new acreage allotment program announced last month by Secretary of Agriculture Benson.

Essentially, the program stipulates that: (1) Farmers must comply with acreage allotments for all crops in order to receive price supports for any crops; and (2) farmers who have more than 10 "diverted acres" will be restricted to a "total allotment" which they cannot exceed and still receive price supports.

In 1955, the farmers will lose 262,000 acres of cotton, 13,000 of peanuts, 300,000 of corn, and 137,000 of wheat.
