TRUTH IN PREFERENCE TO FICTION

\$627,544 N. C. BUDGET ASKED Gov. Hodges Calls For Action On School Desegregation

RALEIGH (AP) — Gov. Luther Hodges today asked the General Assembly to take steps to meet the U. S. Supreme Court's decision banning racial segregation in public schools.

Following the report of a special advisory committee, the governor recommended that legislation be adopted to give local school boards "complete authority" over enrollment and assignment of children in public schools and on school buses.

In his message prepared for delivery to the General Assembly and House session, Hodges also backed the Advisory Budget Commission's recommendations on spending and taxes and outlined his program of legislation.

Major items in the program included support for a statewide liquor referendum, elimination of the absentee ballot in general elections except for military personnel, increasing judicial districts to Court judges, and reassignment of House and Senate membership in line with population changes.

Hodges said he would not recommend to the General Assembly requests for money not approved by the Advisory Budget Commission. "I recognize that many desegregation requests for increases have been denied, but I feel that the state cannot, at this time, afford to do more," he said.

Hodges followed to the letter the recommendations on segregation made by the special advisory committee appointed by Gov. Umstead. He called the report of the committee, which included both white and Negro citizens, "a unanimous document of great significance."

Hodges said the report "gives to the General Assembly and to all of North Carolina a starting point from which the state may go forward toward a solution of this problem."

Hodges commended North Carolina citizens and other elected officials, for the calmness and wisdom they have shown. "In facing the court's ruling that school segregation is unconstitutional, the committee's report, which I included in my speech, declared its opinion that 'the mixing of the races throughout the state cannot be accomplished and should not be attempted.'"

Appeals For Bipartisan Harmony In Free World's Struggle

Eisenhower Says Both Parties 'On Trial'

By MARVIN L. ARROWSMITH WASHINGTON (AP) — President Eisenhower appealed today for bipartisan harmony and told the 84th Congress "on trial" in the free world's struggle to win enduring peace and prevent an atomic "holocaust."

The President said he is hopeful the reductions can be made next year. He called for emphasis on modern air power in readying the nation for any attack, and for "reduction of forces in certain categories"—an obvious reference to the cuts planned in Army, Navy and Marine manpower.

On the domestic front, there was a formal call for hiking the 75-cent minimum wage to 90 cents an hour. That would mean a pay raise for 1,300,000 workers now covered by the minimum wage act who are earning between 75 and 90 cents an hour.

Foreign trade—A gradual reduction of "certain tariff obstacles to trade," by the United States as well as other nations, to "assure broad benefits to our own and other peoples." In a special message to Congress next Monday the chief executive will renew his call for a 15 per cent cut in American tariffs over a three-year period—a proposal shelved by the Republican-run 83rd Congress.

Foreign aid — Without any specific mention of plans to call for economic aid to free nations of Asia to help thwart the threat of Communist aggression, Eisenhower said, "There is a growing will to improve the living standards of all men." Such aid, he said, "promises us allies who are strong and self-reliant."

National defense — Eisenhower said the United States must maintain powerful military forces because "there is no present alternative." He said those forces are designed for defensive and deterrent purposes alone and "are able instantly to strike back with destructive power in response to an attack."

As for the international situation, he said that during the last year "there has been progress justifying hope, both for continuing peace and for the ultimate rule of freedom and justice in the world."

But sobering problems remain ahead and they require continued heavy spending, he said. The entire federal budget expected to run about \$4 billion dollars—to buttress the free nations against any Communist aggression, he said.

There has been no such exchange of pledges on domestic issues, but Eisenhower declared that "the strength of our country" requires teamwork on a broad scale.

With Democrats and Republicans alike casting an eye ahead to the 1956 elections, Eisenhower put it this way: "Our quest for peace and freedom necessarily presumes that we who hold positions of public trust must rise above self and section—that we must subordinate to the general good our partisan or personal pride and prejudice. Tirelessly, with united purpose, we must fortify the material and spiritual foundations of this land of freedom and of free nations throughout the world."

At this time the executive and legislative branches are under management of different political parties. This fact places both parties on trial before the American people.

In less perilous days of the past, division of governmental responsibility among our great parties has produced a paralyzing indecision. We must not let this happen in our

House Schedules Early Study Of N. C. Budget

RALEIGH (AP) — Getting a jump on the Senate, members of the House planned to begin a detailed study today of the proposed state budget for the next biennium.

House Speaker Larry Moore said yesterday he plans for the House to sit as a committee of the whole for about seven hours each day to hear reports on the state's financial picture. Appropriation and revenue bills were handed to the lawmakers today.

Moore estimated it will take two to three weeks to complete the budget study. He called on the representatives to concern themselves almost entirely with the financial study during the early days. Until the budget study is completed, one night session will be called each week to handle emergency legislation.

Rules and calendar committees were named by Moore to operate until the budget study is complete. Rep. Brantley Womble of Wake was appointed chairman of the Rules Committee and Rep. Sam O. Worthington of Pitt chairman of the calendar group.

As the House got down to business, a bill was introduced by Rep. B. I. Satterfield of Person to repeal the legislative secrecy law enacted in 1953. The Senate received a resolution to study the question.

At the request of Speaker Moore, the House postponed consideration of the bill until after the budget study is complete. Satterfield said Moore had voiced no objection to his introducing the bill but had asked that it not be considered at this time. The bill was referred to the rules committee.

N. C. Tax Boosts Required To Meet \$52 Million Gap; Tobacco On List

RALEIGH (AP) — A budget calling for state spending totaling \$637,075,544 during the next two fiscal years and tax boosts to bridge a \$52,063,004 gap between appropriations and expected revenues was presented to the General Assembly today.

The budget, prepared by Gov. Hodges and the Advisory Budget Commission, proposes a 2-cent tax on cigarettes, 1 cent on cigars and 2 cents on soft drinks, a 10 per cent increase on soft drinks, a 10 per cent increase on some sales tax exemptions, and a boost from 1 to 2 1/2 per cent on the levy on premiums of domestic insurance companies. The commission estimated they would raise \$26,031,502 a year.

The budget compared with \$608,497,522 appropriated by the last Legislature to operate state agencies during the present biennium. The commission said tax increases could be avoided only by one or more of the following alternatives: (1) a pay slash for teachers and state employees, (2) a big increase in the school teacher's job, (3) drastic increases in fees and charges at state institutions, (4) greater local support of the schools, or (5) "discontinuing services or drastically reducing them."

The budget report plus appropriations and tax bills to put it into effect were presented to the General Assembly today shortly after Gov. Hodges delivered his biennial message on the "State of the State."

City Council Defers Action On Lifting Recreation Limit

Action on removing the \$30,000 ceiling from the recreation budget was deferred by the city council last night until an opinion on the legality of the move can be obtained from the state attorney general.

That action was taken after City Attorney R. B. Lee told the council a remote possibility existed that the State Supreme Court could declare such an act without a public purpose and charge that the authorization from the legislature, city fathers could be held personally liable. Lee emphasized, however, that such a possibility is very remote.

Tyson Bilbro, chairman of the Recreation Commission, had appeared before the board on behalf of the commission to request the removal of the limit.

The recreation budget at present has reached the limit and cannot be raised until a special act is passed by the General Assembly authorizing the higher budget.

Planned Sums To N. C. Institutions

RALEIGH (AP) — The appropriations recommended by the Advisory Budget Commission to operate state institutions during the next two fiscal years follow: (In each case the first figure is the recommended appropriation for 1955-56 and the second for 1956-57):

Educational institutions: The University of North Carolina (consolidated) general administration, \$2,827,000; Institute of Fisheries Research, \$70,558 and \$70,208; State College of Agriculture and Engineering, \$3,121,559 and \$3,054,759; industrial experimental program, \$62,500; and \$62,500; the Womans College, \$1,523,887 and \$1,513,393; Experiment Station—State College, \$1,439,943 and 1,470,543; Cooperative Agricultural Extension—State College, \$2,010,811 and \$2,007,082.

City Council Defers Action On Lifting Recreation Limit

The council agreed to defer action on the matter until the February meeting when a committee which was set up some months ago will report on the city's entire insurance program.

Drainage District

After a long discussion of a proposal for the city to participate in a drainage district along the banks of the Green Mill Run which passes through the southern portion of town, the council instructed City Attorney Lee to draw up a proposed bill to be presented to the legislature during its next session.

Owners and 60 Percent of the Land Area Must Agree to the Forming of the District

It was noted that a portion of the Green Mill Run passes through college property and Mayor Wheeler appointed all members of the council to a committee which will discuss the matter with college authorities.

Prarking Lot Question

The parking lot question came in for a short discussion at last night's monthly meeting. Councilman J. A. Collins recommended the re-wording of the lease on a proposed parking lot at the corner of Washington and Fifth Streets to include a clause which would relieve the city of responsibility in the event the Supreme Court ruled that public money cannot be spent for off-street parking.

Included in the clause will be a provision that if the Supreme Court should hold off-street parking illegal, the property owners will return the money paid to the owners.

The council agreed to re-submit the lease on the property with the clause for their consideration.

## Folks Live In Town Are Doing Their Part

Far too often a government official in North Carolina points an uncomplicated finger at incorporated municipalities within the state and makes some remark about the cities and towns as distinguished from the rest of the state.

In commenting on the traffic accidents of 1954, which showed a substantial improvement over the 1953 record, Ed Sheidt, commissioner of motor vehicles, is quoted as saying: "Had the cities and towns kept pace with our rate of traffic enforcement" the toll in the state would have been less.

### Arbitrary Power Must Be Challenged

Arbitrary use of power grows by default unless someone steps forth to challenge such use of power by those in public office.

Such is the case in Pennsylvania where seven newspapermen this week were arrested for contempt of court. The newspapermen were not surprised that the court held them in contempt. They set out deliberately to challenge and test a ruling of the court which had prohibited the taking of photographs in the Westmoreland County Courthouse.

Pictures in recent years have become as much a part of reporting news and happening as the written word. In the case in question, three Westmoreland County courts had forbidden the taking of pictures in the county's courtroom, but went further to prohibit the taking of pictures in the courthouses as a whole. The newspapermen felt this was a usurpation of the power of the court and likewise an encroachment upon the people's right to know and have full information on what transpired in the courts. They made their move to challenge the arbitrary ruling of the courts.

What the final outcome of the test case will be remains to be seen. Unless the higher courts uphold the challenge of the newspapermen, however, the people of the nation are likely to see another channel of public information gradually closed from their view.

## Strength for the Day

In the 57th chapter of the Book of Isaiah occur these words: "And thus saith the high and lofty One that inhabits eternity, whose name is Holy: I will dwell in the high and holy place, with him also that is of a contrite and humble spirit, to revive the spirit of the humble, and to revive the heart of the contrite."

We must allow the events of life to accomplish in our souls what God intends them to accomplish. # Courts Cripple Spy Functions

WASHINGTON—Recent court decisions have combined to cripple the espionage system maintained and operated by the unnecessarily large colony of Russian and satellite diplomats at Washington. In fact, there are reports along diplomatic row here that numerous attaches will be recalled to Moscow, Warsaw and other Red capitals because their usefulness has ended.

The District of Columbia Appeals Court, which ranks second to the highest judicial tribunal, has upheld the McCarran Act. This statute, which was passed over former President Truman's veto, empowers the Department of Justice to cite certain organizations with high-sounding titles as Communist puppets seeking the overthrow of our government.

After such a citation the Subversive Activities Control Board holds open hearings on the D of J's indictment. In every instance, and despite a fair trial at which the defendants are represented by counsel, SACB has found against the suspects.

HOSTILE GROUPS EXPOSED—As a result of this procedure, about 40 groups that once commanded the support and sympathy of gullible Americans, have been exposed as hostile agencies. They have lost money, membership and influence. They must file periodic reports on their membership, giving the individuals' names, addresses and occupations. They must account for their finances and activities.

Every Communist Embassy here had a special section work with these organizations before they were outlawed by the D of J, the SACB and now by the court whose rulings are rarely upset on appeal to the United States Supreme Court.

These so-called diplomats and their American allies had built an effective network that furnished the Kremlin with invaluable data on economic, military and industrial trends and developments. DANGEROUS RELATIONSHIPS—That the government and judicial authorities found that these groups were outlaws and enemies in our midst it was perfectly legal for the Red representatives to contact them and connive with them. Now, although the de-

The people who live in incorporated cities and towns pay their gasoline taxes for construction and maintenance of highways, for support of the highway patrol and for traffic enforcement just as the people of rural areas do. Yet, when it comes to providing services from state funds, there is almost always someone who wants to make a distinction between the cities and towns and the rest of the state.

In addition to their proportionate share of state and county taxes, municipal residents pay additional taxes which theoretically are to provide additional services of police protection, traffic law enforcement and numerous other things. In too many instances statements by state or county officials attempt to set cities and towns apart from the rest of the state. Far too often these statements tend to charge municipal residents with the full responsibility of providing for themselves all the services they need, while at the same time they are paying approximately one-third the bill for state and county services which seem to be regarded for the exclusive benefit of rural residents.

The recurring implications that the people who live in incorporated towns have not done their part is unkind to say the least.

## Army Manpower Cuts Are Poor Economy

The Army has already begun steps designed to reduce its manpower in accordance with economy steps periodically sought by the administration. Men in high places, who should know, say the cuts will not affect strength of the nation's defenses because of new weapons development.

If financial savings were the principal goal of the armed forces this would be understandable; but such is not the case.

As we remember provisos of current defense legislation, the Selective Service Act was not only intended to build up the active armed forces but to provide a trained reserve as the ultimate bulwark against aggressors.

The buildup of trained reserves was given a particularly emphatic role as a substitute for oft-discussed Universal Military Training. . . which, though shelved is far from being a dead issue.

On paper, the idea of two years active service and training. . . coupled with six years of reserve status. . . was an economical means of getting what was needed in the way of a substantial backlog of military manpower. It suited not only present needs but filled an obvious need for the future.

No matter what sort of armed conflict the United States might become involved in, and regardless of advances in "push button" warfare, there will always be an insatiable demand for trained military manpower.

Potential, trained manpower needs of the future are going to be lost to the Army under the impact of today's cutbacks. Such a loss cannot be made up overnight.

# Unemployment Laws

In many of the 44 state legislatures that meet this year, serious consideration will be given to proposals to liberalize unemployment benefits.

There are a number of reasons for this:  
1. Many unemployed persons used up their benefits last year, even though unemployment was low compared with many years in the past. A sharper decrease in employment some time in the future, or even a period of mild unemployment continuing longer than last year's setback, might have grave results. It is expected that proposals to lengthen the time benefits will be paid will get more support than proposals to increase the amount of weekly payments.

2. John P. Mitchell, Secretary of Labor, is urging states to extend benefits. While this action has been carefully separated from the official Republican Party line it is gaining support in many parts of the Party.

3. There is the possibility that if the states do not take action Congress will. Mr. Mitchell has indicated he would request Congress to act and, with both parties wooing labor, it might readily act. In developing the Social Security program, Congress left decisions on unemployment benefits to the states. At that time a weekly payment large enough to sustain a family in a Northern industrial city would have been larger than the pay many people could get by working in some Southern fastnesses. Wage differentials are somewhat less today, but the threat of government action in setting rates can stir some states to action.

4. Union drives for larger benefits are growing stronger. Unspecified support for greater benefits is coming from corporations. Most states have laws prohibiting the payment of benefits to unemployed who are still drawing pay from an employer. Therefore, if unemployment benefits were lengthened or increased, there would be that much less reason for the

guaranteed annual wage. Some companies are quite uneasy about demands for annual wages. 6. State legislators, too, want to be re-elected.

FOREIGN COMPANIES SEEKING U.S. INVESTMENT  
The Foreign Operations Administration has compiled a new list of European firms seeking investment by Americans either in businesses abroad or in United States rights to patents and techniques.

Another fellow has been frustrated all the 18 years he's been in this business. Someday we all hope, he'll be able to start a story beginning "A human skull rolled out on the table."

Still another lady writer complains, "I'm an 'actually' and however, and on the other hand" girl myself. When will they stop cutting them out?"

But with all his tender sensibilities a writer is made durable by hope. Someday we'll all get these things out of our system. Someday I'll be able to say of a certain party, "He was never too busy to say an unkind word."

# Colleges Begin Arguing Football TV Problems

NEW YORK (AP)—Having fired a salvo at the pros for invading "college territory" with their Saturday night football telecasts, the colleges train their guns on each other today in an open discussion of the controversial television problem.

Video is the hot potato of this NCAA convention. And it's a cinch that the multiple issues won't be even half settled by the round-table talks today and by the appointment of the new 1955 TV committee Friday.

The six alternative proposals to be suggested by the outgoing 1954 TV committee and other parties boil down to a contest between another national "Game of the Week" program, with slight variations, and a series of regional, geographically distributed telecasts.

It looks as if the national card, backed by the numerically powerful 101-member Eastern College Athletic Conference will win out over the regional backers which

include the influential but numerically weak Big Ten and Pacific Coast conferences.

The blasts at the pro National Football League were touched off yesterday by Matty Bell of Southern Methodist at an NCAA round-table meeting.

Reading a report prepared by a special NCAA committee, Bell said, "It was completely unthinkable and selfish for the professionals to black out their own games but to telecast their Saturday night games into college territory."

Bell said the NFL was "discourteous" in declining to appoint a committee to meet with an NCAA committee to discuss the matter.

At the time of the NFL's refusal to meet with an NCAA committee, NFL Commissioner Bert Bell said such a meeting might be interpreted as a "conspiracy" to restrain television activity.

Although he said he didn't want to "declare war" on the pros, Matty Bell said the colleges should not permit their coaches or other athletic personnel to participate in professional sports in any way, and that college sports facilities shouldn't be made available for pro activities.

# Robinson Briefly Shines As Of Old

DETROIT (AP)—For 10 exciting seconds, it was the Sugar Ray Robinson of old—swift, sharp and deadly.

In that brief burst, the 34-year-old former middleweight champion swarmed over Joe Rindone, of Boston, and scored a knockout at 1:37 of the sixth round last night to successfully start his comeback.

As a howling crowd of 11,973 urged him on, Robinson floored the fight, confused Rindone with a flashing series of lefts and rights that made one wonder why Sugar Ray ever left the ring.

But before that, the sleek New Yorker was cautious and uncertain, showing obvious signs of his 30-month layoff. His famous one-two combination wasn't clicking although his footwork seemed as good as ever.

"I was satisfied with my showing, he said in his dressing room. "Even though my combinations weren't working, I at least had an opportunity to try them."

"I can't honestly say it was one of my better fights. It'll take time to regain the touch."

Robinson was stung into action when Rindone, who did little more than huff and puff through the first five rounds, landed a solid left and right to the head. It was his first serious gesture of the nontelevised fight.

Robinson tore after his backpedaling, 28-year-old opponent, clubbing him with six, seven, eight blows to the head and body. A roundhouse right sent Rindone crashing to the canvas.

The crowd, largest in Olympia Stadium since June 1952, went wild.

# Seixas Tabbed World's Best

MELBOURNE, Australia (AP)—Vic Seixas of Philadelphia, who with Tony Trabert beat Australia in the recent Davis Cup challenge round, was picked today as the top player in world tennis by Harry Hopman, the Australian Davis Cup captain.

Writing in the Melbourne Herald-Hopman said: "I rated Trabert a close second last year, but drop him to sixth place this year despite the fact that many I know regard him as the world's best amateur."

A year ago Hopman had Australian Lew Hoad on top, but he dropped Hoad to seventh this time.

# Alabama's 85-Foot Field Goal Will Go Down As One Of Greatest Thrills

TUSCALOOSA, Ala. (AP)—George Linn's field goal of nearly 85 feet Tuesday night against North Carolina will go down among basketball's greatest thrills.

Officials at the University of Alabama yesterday took a recap of the event, and brought Linn back to the Alabama Field House to show them exactly where he was standing. They measured the distance and said it was 84 feet, 11 inches. And now they're trying to determine if it is a record.

Tide Coach Johnny Dee said the basketball which Linn hurled is being sent to the Basketball Hall of Fame, now being established by the National Assn. of Basketball.

Coaches at Springfield, Mass. A bronze plaque will be inserted into the Alabama Field House floor, marking the spot from where Linn launched his long shot.

"How could there possibly ever be a longer shot?" Dee exclaimed. "I've seen them made from beyond the midcourt line, but never anything like that."

Linn, 20-year-old forward who sometimes plays center, is a junior from Columbus, Ohio. He's 6-4 and weighs 185 pounds.

Describing the throw later, Linn said he just leaned back and threw. He tried to repeat the peg three times yesterday. The first was over the backboard, but in line with the basket. The second was under the hoop, but in a straight line. The third bounced off the rim.

The long field goal came in the final seconds of the first half Tuesday night, with the Tide leading North Carolina 39-29. Linn took rebound off the Tar Heel backboard. Looking at the clock, he leaned backward. The ball almost touched the floor.

The Field House was almost jammed to its capacity of 4,000. They shouted, "Shoot, shoot!" Linn leaned forward and threw the ball with an easy overhand motion. It struck the Alabama backboard just above the rim, and ricocheted through the hoop as the buzzer ended the half.

There was a deathly silence in the Field House. And then pandemonium.

Alabama went on to defeat the Tar Heels 77-55.

# Parachute Baby Trout Into Ponds

CONCORD, N.H. (AP)—The Fish and Game Department has a new setup. It is "Operation Fish-drop."

Some 50,000 baby trout—measuring one to three inches—have been dropped parachute fashion into 24 remote Granite State ponds.

The Airborne fingerling fish are dropped from tanks of fresh water at an average height of 200 feet. Investigations showed nearly all the fish survived the drop.

## School District Tax Election To Be Held Feb. 12

A special election to raise taxes in the Bevoir-Falkland school district will be held February 12 in the Falkland Town Hall, county attorney W.W. Speight has announced.

The election will determine whether or not taxes will be raised ten cents on each \$100 property valuation. If approved this will bring the school tax per \$100 property valuation to 32 cents in that district.

Purpose of the supplementary tax, according to a petition submitted by the Bevoir-Falkland School District Committee, is to enable the schools to be operated "at a higher standard than that provided by State support" by employing a public school music teacher or additional vocational teachers, or both.

The petition for election was approved December 21 by the Pitt County Board of Education, and Monday by the County Board of Commissioners. It is also subject to the approval of the North Carolina State Board of Education. County Superintendent D.H. Conley said the Bevoir-Falkland district, which has a school population of 800, is following the pattern of most of the other local school areas in its efforts to expand its educational program to include a music teacher.

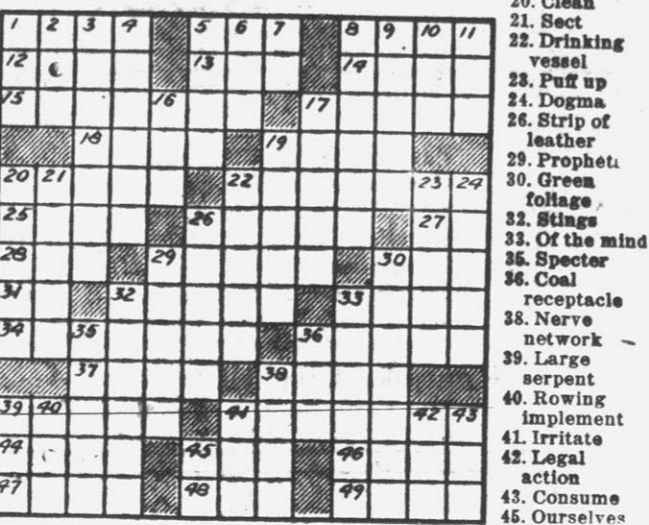
**CHAPTER TWENTY-TWO**

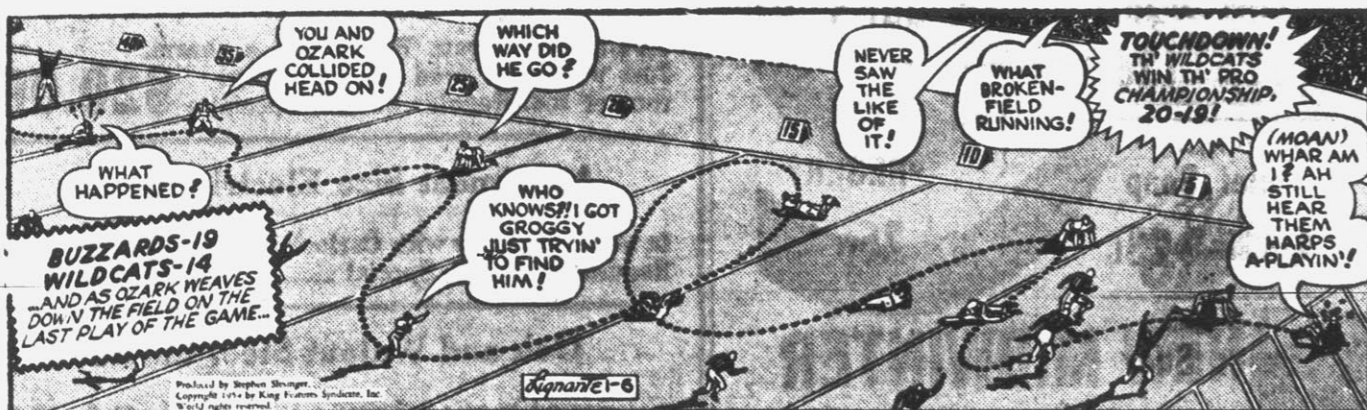

# Stock And Market Reports

**NEW YORK** — The stock market suffered two acute sinking spells today on the heels of yesterday's severe break.

The fall carried prices down between 1 and 5 points in most key divisions, and in some cases the decline extended to between 8 and 9 points. There were a few persistent plus signs, some going to between 1 and 2 points.

The abrupt fall yesterday and today followed the boost in margin requirements to 60 per cent from 50 per cent by the Federal Reserve Board.

There were two selling drives. The first came at the opening and extended on into the second hour. The deluge of selling forced the tape to fall some six minutes behind in reporting actual dealings. The Stock Exchange brought into play its emergency system of flashing prices directly from the floor to the tape to let the public know the fate of key issues immediately.

When this drive cleared, prices started up from their lows and many good gains were registered. Just before the beginning of the third hour, the selling drive started again and the tape again was swamped in reporting actual deals. Prices retraced all around, and most of the gains were quickly wiped out.

Hard hit were such key issues as Union Pacific, Standard Oil (N.J.), American Telephone, Bethlehem Steel, General Motors, Douglas Aircraft, Du Pont, Radio Corp., Eastman Kodak, and Anaconda Copper.

Also approved was the return of \$2,500 to the Airport Commission by the city. The money was advanced to the city for the East Carolina Airport Authority but it was returned when that authority was disbanded.

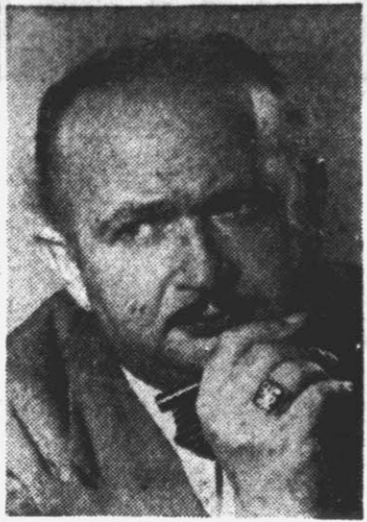
## Zurich Entertainer Will Be Club Speaker

## Four Being Held For Blasphemy

**NEW BRITAIN, Conn.** (AP)—A man who exhibited wounds in his hands and feet and claimed he was Jesus Christ was among four Polish refugees facing blasphemy charges in City Court today. All four claimed to be 2,000 years old.

Police said John Tschaplinski, 50, when arrested yesterday, was wearing a crown of thorns, causing him to bleed from the head, and wore a loin cloth made from a diaper.

A seven-foot wooden cross with four spikes and a stack of \$20 bills were found in his kitchen. Police said they had taken him into custody several weeks ago after he was found passing out \$20 bills at the New Britain General Hospital, but they released him after questioning.

Arrested with him yesterday were Mieczyslaw Majewski, 38, who was wearing a black robe and had a long beard; and two women, Antonina Suszko and Dina Karanowicz, about 30. Police said all four came here three years ago and lived in the same tenement.

They are not known to be members of any religious sect here. City Prosecutor Steven E. Perakos said the four were booked on an alleged violation of a Connecticut law which forbids persons to claim to be a deity.

## U.S. Citizen Is Held In Panama

**PANAMA** (AP)—Panama police held a 34-year-old U.S. citizen incommunicado today in connection with Sunday's slaying of President Jose Antonio Remon. They were questioning at least 70 suspects in the gang-style murder.

Police said they picked up Martin Irving Lipstein—tentatively described as a schoolteacher from New York—at the airport 24 hours after Remon and two other men were shot to death at Juan Franco race track.

Authorities said they had released another U.S. citizen, Roy Bettis, 36, a native of Waukegan, Ill., who is employed by the Canal Zone administration, but lives in Panama City. Bettis was questioned about the activities of one of his truck drivers on the night of the murder. National guard headquarters in Chiriqui province 200 miles west of here.

Arias, an arch political foe of Remon, was picked up at his plantation 300 miles west of here shortly after the slaying. Authorities later said the murder weapons were German-made Schmeisser machine guns of a type confiscated from Arias previously.

Police were tight-lipped about Lipstein, but reliable sources said tests made of his clothing showed traces of gunpowder. Informants said police became suspicious because of his unkempt appearance and his excited reaction Monday when told he could not leave Panama because outgoing flights had been canceled.

Cecil Lewis, six-month old son of Mr. and Mrs. Guy Lewis, of the Hackney's Siding community in Sautour County, died at a Washington hospital at 6:30 Wednesday afternoon.

He suffered severe burns about three hours earlier at his home when an oil stove exploded and the home burned.

Graveside services were conducted at the Clark Family Cemetery near Hackney's at three o'clock Thursday afternoon by the Rev. Warren Boyd, Holiness minister of Black Jack. Cecil Lewis spent all his like in the Hackney Siding community of Beaufort County. He is survived by his parents, Mr. and Mrs. Guy Lewis; a half-sister, Mary Elizabeth Woodard; and his grandmothers, Mrs. Ethelinda Hardy and Mrs. Annie Evans, both of the same community.
