Dulles Convinced Red China And U.S. Are Heading For Military Showdown

WASHINGTON (AP)—Secretary of State Dulles' trip to the Far East apparently convinced him the United States and Communist China are heading toward a military showdown—probably over Formosa.

Without giving details, he projected U.S. cooperation toward improving economic conditions. He urged subversion, the greatest danger in Southeast Asia, but voiced belief the threat would diminish when such countries as Viet Nam understand that their allies "have the power, and the will, to strike down an open armed aggressor."

Disclose Princess Will Wed Townsend

LONDON (AP)—Princess Margaret intends to marry 46-year-old RAF Group Capt. Peter Townsend this fall, an informant in touch with the royal family said today.
Townsend himself, a divorced man, was quoted as saying: "There can be nothing said until the time is ready or somebody else does something."
The 24-year-old princess is expected to renounce her right of succession to the throne to smooth the way for her wedding to a commoner, according to the informant, who refused to permit use of his name.
Margaret's marriage to the war hero, father of two children, would defy the Church of England's ban on the remarriage of divorced persons.
Buckingham Palace maintained its traditional silence on reports concerning the royal family's personal plans. But available information tended to corroborate the report that Margaret and Townsend are going ahead with wedding plans.
Even a princess can change her mind, however, and Townsend himself presumably could erect great obstacles to the marriage by indiscreet remarks.
There were suggestions—naturally not confirmed—that news about the royal romance is being leaked deliberately to the British press.
The aim of that apparently would be to determine how the British people react. Such publicity also would avoid the public shock which Mrs. Mary Goodman, GREEN LIGHTS advisor, will conduct a sectional meeting on "Editorials" at the New York convention. History Of Methodism In Greenville Discussed

History and reminiscences of Methodism in Greenville were shared by J. B. James, life time local Methodist whose family was identified with Methodism in Greenville in the generation before him, with the members of the Methodist Men's Club of Jarvis Memorial Methodist Church last night at their regular monthly meeting which had been postponed a week due to the Visitation Program in progress last Tuesday night. Mr. James would call the name of some former leader and tell some incidents humorous or otherwise about the person.

The first Methodist Church was organized in 1833 and met in the Masonic Hall at the corner of Pitt Street and Second Street. Mr. James said. They built their first sanctuary in what is now Cherry Hill cemetery. Next in 1890 they moved to a new sanctuary at the corner of Second Street and Greene-named St. Pauls.

Mr. James mused as he thought of St. Pauls. He recalled many saintly people. The sanctuary was one large room. Overhead at the rear was a "gallery" where the organ and the choir were located. He was the one who always pumped the old organ.

Among those who were faithful at old St. Pauls were the Hearnes, Browns, James, Miss Betty Warren, Governor Jarvis, Mr. Ed. Harris, Mr. Alf Forbes and many others. It was a minister of the church named Rev. N. M. Watson who with Mr. James Little and other local young men built a tennis court. Mr. Watson took time from his duties to play tennis and greatly impressed young Mr. James.

In 1905 the Methodists occupied their new church at the corner of Washington and Dickinson Avenue. Rightly, according to Mr. James they named it after a great man both in accomplishments and character—Governor Thomas J. Jarvis—Lieutenant Governor, Governor, Senator, Speaker of the House, ambassador to Brazil, leader and faithful member of the Methodist Church.

Soon after Mr. James was married he and his new bride were sitting in Jarvis Memorial one Sunday when the organist failed to turn up. The preacher—Rev. Hoyle—called her to preside at the console. He said he worried about her negotiating the steps to the choir loft

with her tight skirts. She made it. She served many years in many ways in the church.

The incident of the biscuits got a good laugh. It seems one Reverend John Hall "loved" biscuits. He frequented Mr. James' grandfather's home—the late J. B. Cherry—for meals. He ate so many biscuits that the young grandson proposed to count how many the preacher ate. But to save him, J. B. could not catch the preacher diminishing the supply on the plate on the table. Yet Mr. Hall ate biscuit after biscuit. The explanation was that preacher was getting them from a plate on his lap foresightedly placed there by Mr. James' grandmother.

He recalled the Moyes, Littles, Tafts, Warrens, and others. He praised contemporary leaders for their work in planning Jarvis Memorial's building program, the construction of the new education building and financing it.

Near the last, due to prodding from the floor, Mr. James mentioned his organizing a young men's class of 100 young men, his superintendency of the Sunday School with nine hundred present with Mr. Roberson as musical director and Professor H. E. Austin, secretary. In closing he exhorted everyone to make a contribution to the church from lives with spiritual values that would inspire those who come after this generation. He had attributed the outstanding position of Jarvis Memorial in Southern Methodism to the quality of the leadership who preceded the present generation many of whom from the past he named.

Have They Overlooked Something?

The creation of 11 new judicial districts in North Carolina should alleviate the backlog of court calendars, but unless something is done to eliminate the confusion caused by overlapping judicial and solicitorial districts that matter is going to become a major problem.

The new legislation increasing the number of judicial districts changed many judicial district lines, but kept the solicitorial district lines as they are presently constituted. Thus the fifth solicitorial district composed of Pitt, Greene, Carteret, Pamlico and Jones, contains counties which are parts of three distinct judicial districts. Pitt, Pamlico, Craven and Carteret will make up the third judicial district, Greene will be in another judicial district and Jones in still a different judicial district.

In mapping out the criminal terms of Superior court in each county, it will be necessary not only to take into consideration the conflicts in assignments of judges, but likewise the conflicts which may be encountered by solicitors.

Since the solicitors do not participate in civil terms of court, the confusion will be

This book by Dr. Elson privileged as he is to be close to the throbbing heart of national life, is one of the inspiring products of a man who believes in a spiritual America, and who is giving all he has to the maintenance and strengthening of the nation's spiritual life.

National Whirligig

Discords In Demo Harmony

WASHINGTON—A simmering threat to Democratic harmony in the 1956 Presidential year lies in the numerous attacks on the South's social and economic structure that have been headed by leaders of the Party's northern and liberal faction, generally known as the Lehman-Douglas-Humphrey wing. It explains why the Byrd-George leadership support so many of the major Eisenhower policies.

Although the liberals' effort to force school desegregation on the South is the most radical expression of this movement, it is only one of many mostly subtle gestures.

In the economic field, an equally serious anti-Dixie movement consists of the demand of Democrats from urban, industrial districts that the minimum hourly wage be increased from 75 cents to \$1 or \$1.25. The 90-cent proposal has been assailed by the labor unions as too low.

MOTIVATED BY POLITICS—Although northern advocates of these social and economic reforms may be credited with sincerity, it is also obvious that political needs and considerations motivate them. They seek to retain the Democrats' 30-year grip on the racial and labor vote in next year's Congressional and Presidential elections.

Without the support of these numerically powerful ballot-box groups many Democratic members of House and Senate might stand in danger next year, especially if such a seemingly popular figure as Eisenhower heads the Republican ticket. And he will! They recall that he carried every large industrial state in 1952, also rolling up a good vote in the tenement sections.

DRIVE TO UNIONIZE SOUTH'S INDUSTRIES—As soon as the AFL-CIO merger has been consummated, the combined forces will stage a drive for unionization of the South's industries. Their greatest weapon will be the promise of higher pay, based on their current Capitol Hill attempt to raise the floor wage from 75 cents to \$1 or \$1.25.

The following analysis of regional levels of industrial wage scales reveals how effective this argument may be:

confined to the criminal terms. Solicitor Robert Rouse of the fifth solicitorial district will be responsible not only for the criminal terms in the entire third district, but likewise for terms in counties which are in two other districts. Although the counties are in three different judicial districts, none of the four counties in the third judicial district can have a criminal term of court at the same time that either Jones or Greene County have a criminal term. Conversely, neither Greene nor Jones County can have a criminal term of court the same week there is a criminal term in any of the four counties which make up the third district.

Multiply that situation several times in the overlapping judicial and solicitorial districts throughout the state, and it is readily seen how confusing the matter might become. The situation should be studied thoroughly before the General Assembly adjourns so if alteration of solicitorial districts is necessary, it may be done now in conjunction with the judicial district change. Otherwise the criminal terms of Superior Court may get into a terrible jam before the 1957 legislature can cope with the problem.

Progress Program Idea Has An Appealing Side

At first glance, proposals of the Farmers Day Steering Committee to change the customary one-day fete to a County Progress Program is most appealing.

Of course, the plan is still in the tentative stage with many questions to be worked out and much more effort necessary. But, as outlined for the Pitt Home Demonstration Club County Council yesterday, the new program should result in a more widely shared and more beneficial program than enjoyed by past Farmers Day celebrations.

Basically it is a spur to community progress; with awards going for cumulative efforts toward such things as accident prevention, beautification work, health activities, fire prevention, participation in the blood bank, polio drive, Red Cross, Heart Fund and similar campaigns.

Rightfully, Farmers Day president Ben Rouse called attention to the point that the proposed program would not be for home demonstration club women alone, but for everybody.

If such a program can be worked out in a way that would offer an appreciable incentive for organizations and individuals to work for localized improvements, then Pitt County as a whole will be benefited and made a better place to live.

It would be a much less spectacular program than the usual Farmers Day event, but on the whole many more people could participate and emerge with a sum total of accomplishments for which they could take real pride.

per cent; Far West, 1.1 per cent; Middle West, 2.3 per cent; Northeast, 4.1 per cent.

For these bread-and-butter reasons, as well as for their own political nourishment, the non-southern Democrats have fallen behind the Meany-Reuther program. Higher wages below the Mason and Dixon line may prevent New England, New York and Pennsylvania factories from moving to the South. A similar consideration lies behind the demand of both Democrats and Republicans for restriction; on expansion of the Tennessee Valley Authority.

AUTHORITY TO REDUCE DARIFFS—It was the New Deal Democrats who provided the votes for House passage of the bill to extend the reciprocal tariff agreements and to give Eisenhower the authority to reduce duties by 15 per cent within three years. The proposal was favored by the great industries in their states, which enjoy a profitable overseas market for autos, industrial equipment, steel etc.

But the South, once a low-tariff region because of income from exports of raw materials, now wants protection for new and young industries. With 106 members in the House, 98 of those present from Dixie voted 48 to 54 against opening the American market to a larger inflow of foreign goods.

The southern economic system in the opinion of its Capitol Hill spokesmen, needs safeguards on both the domestic and foreign fronts, as against their northern colleagues' insistence upon hasty and immediate expansion. It appears to be an irreconcilable conflict.

POSSIBLE PRESIDENTIAL NOMINEES—Finally, Southern Democrats are not especially keen for the men now mentioned as possible Presidential nominees next year—namely, Adlai E. Stevenson, Governor Averell Harriman of New York, Governor O. Menon Williams of Michigan, Senator Estes Kefauver of Tennessee. They are far too radical to suit the Dixie conservatives, who would prefer a man of the Byrd-George-Russell or Lyndon Johnson type.

Amateur Radio Goes Mobile

Here's a look at another phase of one of the world's most fascinating hobbies: amateur radio. Any licensed amateur may operate from an automobile, airplane or boat. My recent installation is in a 1951 Buick.

Electronically, a mobile station is a challenge. At home you plug the rig into the wall. On a car you are faced with the problem (in my particular case) of taking a six-volt automobile battery and converting it to the 300 volts necessary for operating the transmitter. Likewise, 250 volts are required for the receiver, so it becomes necessary to take the same 300 volts and convert it to 250 by the push of a button, the same button which turns the transmitter on and the receiver off. Complicated? Not to the man who knows what he's doing; and I'm not talking about myself. Half of a Saturday afternoon was spent with Red Styers in Farmville, many questions were asked of Bill Smith and Roy Phelps, and Lay-

ton Clark worked with me on installation about half a day. Sunday afternoon George Valentine of Rocky Mount, also a mobile ham, dropped by for a visit. On his way back home we talked mobile to mobile until he got about 16 miles away. The late Sunday afternoon interference got us at that point.

It takes patience to operate mobile. Naturally you'll put out calls and get no answers. But when you can get results with a simple whip antenna and 30 watts you can feel like you've done something. The fixed powerful stations, up to 1000 watts, make for rough competition. Last night from my fixed station I put out a call, asking for answers from mobile stations only. In short order I talked to two—one in Los Angeles and the other in San Diego. And I thank you.

What Other Editors Are Thinking

NEED FOR SCHOOL SOCIAL REFORM
(Rocky Mount Telegram)
Although the sororities and fraternities which some of our high school students belong to, indicate some improvements with regard to their operations as a result of public criticism last year, still the system remains a blot on our school social life and cries out for drastic reform.

On the one hand some school authorities too often close their eyes to the situation and claim the problem is beyond their jurisdiction because it exists outside the schools. On the other hand, parents whose youngsters belong to these organizations too often assume they are bonafide school activities supervised by school authorities, which, of course, is not the case. We have previously voiced our objection to the undemocratic

character of high school sororities and fraternities in our public schools. Such organizations are bad enough in college, but at least students select their own colleges whereas attendance in the public schools is compulsory. Many fine young men and women in our school system are deeply hurt every year because they are not invited to join these social groups which more or less control the social life of the high school. Life in a high school is stiff enough without having to suffer the slings and arrows of snobbery so early in life as high school students.

But, all this we have said before. We are prompted now to protest anew by reliable information that some outstanding boys and girls who are invited to join sororities and fraternities and who, for their own good reasons, refuse are now being ostracized and blackballed by their schools. Because they prefer not to join sorority or fraternity, they are not permitted to attend any of the better high school dances controlled by these groups. Some girls preferring to stay out of sororities find it difficult to get dates. So it goes.

Thus we see how some students, on the one hand, want to belong, but can't; and on the other hand, how other students are being forced by the system to join against their wishes and better judgment.

When, we wonder, will the people of Rocky Mount awake to this undesirable situation in our schools and demand either the abolition of these exclusive social groups, or else a more democratic setup open to all under the supervision of school authorities.

How Will Hodges React To Pressures For Judgeships?

PUZZLED—Governor Hodges has a number of aspirants and their backers for judgeships and other high appointive office puzzled. There is no precedent to indicate the best method of approach. Every other Governor in more than 60 years has gone through some kind of campaign to obtain the nomination and election, during the course of which they made connections, if not commitments, that gave observers pretty fair knowledge as to what type of men would be appointed, and in many instances what individuals. Besides, most of the other Governors had established records of political activity and service in State government which gave further impetus to the kind of appointments to expect.

Governor Hodges came to the office by accession from Lieutenant Governor. His State governmental service had included a brief time as highway commissioner nearly 20 years ago and two years as Lieutenant Governor and president of the Senate. He made no commitments because there was no campaign, and the appointment records in making appointments were limited to naming committees in the 1953 Senate.

How will he react to pressure? Should those who want the appointments for themselves or friends "put the bee on him" early or wait for him to ask for recommendations? Would he consent, or does he expect, the applications to be accompanied by promises of political support in future campaigns, or in behalf

of his current legislative program? Does the "conservative" or the "liberal" have the better chance?

The folks who are directly interested do not know, and they are not having much success in trying to find the answers to these questions.

BIG LIST—Governor Hodges will have the opportunity, and the responsibility, for appointing a larger number of Superior Court Judges than any of his predecessors. The redistricting act provides eleven regular resident judges, and it is expected that at least two, probably four, special judges will be authorized. The regulars must be named before July 1 this year, and the special judges may be named any time before July 1, 1957. The late Governor Umstead holds the previous record for judicial appointments. He was authorized to name twelve special judges and he appointed ten. Since his death Governor Hodges has named one more, and he has the right to name another before June 30.

Unemployment Rates

Advocates of more government action to provide jobs get a rugged going-over in the March National City Bank letter. It points out that the present 5 per cent rate of unemployment is below the 1950-53 average of 7.2 per cent, and adds, "If ten war years are left out of account, the unemployment percentage for forty-four peacetime years comes out to 8.4 per cent. If the eleven years of deep depression are also eliminated, we get an average for thirty-three nondepressed years of 4.3 per cent."

Then it adds: "The height of present-day unemployment in many ways is surprising, considering the fact that Government (Federal, State and local) is making social welfare payments—from unemployment compensation and old-age pensions to soldiers' bonuses—at the incredible rate of \$14 billion a year. And this is to say nothing of severance pay, pension and benefits provided by private employers as well as savings accumulated by private employers.

Shortstop and third base are scenes of heated arguments. Two returnees from last year are finding the going rough because of determined freshmen. Ray Pennington handled the shortstop duties some in 1954 but is having a hard time out-impressing Jerry Stewart of Sanford. The latter was an All-State high school performer and played on state championship clubs two out of his last three years. He is an excellent fielder and has a strong throwing arm.

The victory sent Villanova into a second round meeting with Canisius at Philadelphia, Friday night. Another game on the same program will send LaSalle's defending champions against tonight's Columbia, Princeton Ivy League playoff winner.

Canisius advanced here last night by downing Williams 73-60, and LaSalle whipped West Virginia, 95-61, for a new tournament record score.

With ace Ronnie Mayer scoring only four points, Duke's heavy work fell to Dan Tobin, who threw in 22 and Joe Belmont who potted 20. Duke led in baskets, 25-23, but Villanova's 28 foul goals turned the tide. Bobby Schaffer, Villanova's scoring ace, had 22 points, 14 on fouls.

It was Villanova that handed ACC champion, North Carolina State two of its four losses this season.

N. C. State was ineligible for the tournament because it is on probation by the NCAA for violating rules against trying out prospective athletes. Duke, as runnerup, got the NCAA bid. N. C. State will play in the AAU tournament in Denver later this month.

Ken Loeffler, LaSalle coach, said he was glad Duke, lost, adding: "They have too many big men. Gola can handle a man and a half under the boards, but not three."

Tom Gola, LaSalle ace hit for 24 points after going scoreless for 10 minutes. He left the game with 6 1/2 minutes remaining.

West Virginia's Rod Hundley hit for 17 points, 16 in the first half. LaSalle switched into a 3-2 zone at the start of the last half and double teamed Hundley to stop him in his tracks.

Stock And Market Reports

NEW YORK (AP)—The stock market declined today, but strong resistance to the fall developed in the early afternoon.

Yesterday's market broke sharply when heavy selling hit late in the session.

The decline today was concentrated in the first hour. Prices were down between 1 and 3 points at the outside.

A recovery movement toward the end of the first hour and through the second hour brought better demand to many key issues and produced some plus signs that went to around 2 points at times.

Steels were mixed with Bethlehem under selling pressure and down between 2 and 3 points. A few steels managed to hold to small plus signs most of the time.

Aircrafts also were mixed. Boeing stood out with a good gain. The company reported annual earnings for last year equal to \$11.39 a share as against \$6.26 the previous year.

Railroads were higher with a long series of small gains shown. Motors did fairly well with General Motors higher.

Lower were oils, airlines, utilities, coppers, and chemicals.

Bar Association Endorses Bundy For Judgeship Post

The local Bar Association last night passed a resolution endorsing W. J. (Dick) Bundy for resident judge of the new third judicial district.

Frank Wooten, bar association president, said that the resolution will be presented to Gov. Hodges in the near future. Hodges will soon appoint a resident judge for the new district which is composed of Pitt, Craven, Carteret and Pamlico Counties.

The bar association president stated that a letter had been written to the governor asking for an appointment to present the resolution. Wooten and other bar association members will carry the resolution to Raleigh at that time.

Wooten noted that about 80 percent of the local bar association members were present for the regular monthly meeting last night, and that the resolution was passed by a unanimous vote of those present.

The resolution reads in part: "Whereas Pitt County, the largest County in said district, both in area and in population, has not had a Resident Judge since 1922—twenty-nine years; and whereas W. J. Bundy, a member of the Pitt County Bar, served the old Fifth Judicial District as judge for more than two terms with ability and success, and manifested by his courtesy, his fairness and devotion for said office . . . (and) that he will endow the office with honor and bring the Bench both learning and strength . . . Now be it resolved that the Pitt County Bar endorse W. J. Bundy for Resident Judge of the Third Judicial District . . . and recommend his appointment to the Governor of the State . . ."

Some 2,658 Families Suffering Flood Damage

CINCINNATI (AP)—Red Cross officials today said some 2,658 families in four states have suffered property damage by the flooding Ohio River. This includes Ohio, Kentucky, West Virginia, and Indiana.

As damages mounted downstream, the Weather Bureau predicted the river should be back in its banks in the lower portion this weekend. Many of the areas hit generally suffer damages when the river overflows.

Cincinnati braced for the flood crest today along with numerous small river towns in Ohio, Kentucky and Indiana. The crest has swept past Pennsylvania and West Virginia.

Among the hardest hit river towns was Manchester, Ohio, where the state highway patrol said 225 families fled shore homes as the crest neared the town today. Manchester is about 80 miles upstream from Cincinnati.

Sixty-four Manchester businesses suspended operations as the crest today along with numerous small river towns in Ohio, Kentucky and Indiana. The crest has swept past Pennsylvania and West Virginia.

Coastal Tryouts For Lost Colony Set For Mar. 12

MANTEO—Coastal tryouts for roles in Paul Green's symphonic drama, *The Lost Colony*, which opens in Waterside Theatre here at Fort Raleigh on July 1, for its 15th season, will be held in Manteo on Saturday, March 12, it was announced today by R.E. Jordan, general manager.

Supervisory Director Samuel Selden who has been with the show since its beginning in 1937, will be here to assist in choosing cast members, it was stated.

Later in the Spring state-wide tryouts for Lost Colony roles will be held under the direction of Selden at the Playmaker Forest Theatre in Chapel Hill. The local casting on March 12, however, will be open to not only residents of Manteo and Dare County but for any person from the counties of Northeastern Carolina and the Norfolk area, it was announced.

New Faces Likely

While several of the veteran cast members will return to play roles they have had in the show during recent years there is likely to be new actors playing some of the principal roles.

It is now believed that Robert Armstrong, who played the male lead of John Borden in previous seasons, will not be in the cast this year. In a letter to Manager Jordan from Selden, he said: "What we are going to do about John Borden, I don't know yet. You have doubtless heard by this time that he is rehearsing in Tennessee. Williams' Cat on a Hot Tin Roof which, they say, looks good and may well run through the summer."

Selden also stated that Ralph Butler will not be back in the cast this year and that Nena Williams would direct the Lost Colony Choir made up of Westminster Choir College voices.

Anne Martin of Cherokee, who starred as Eleanor Dare last season will be cast in the same role again this year.

Frank Groseclose, who played the narrating historian in the drama will return to *The Lost Colony* for its 15th season following a winter of study in England on a fellowship he won for creative work in the theatre.

Barber Is Fined For Sanitation Violation

The operator of a Grifton Barber shop was found guilty and fined here yesterday afternoon for operating his shop in an unsanitary condition.

The verdict was rendered by Judge Dink James in County Court after hearing testimony from a state barber inspector that the barber shop, which is the only one in Grifton, was in a general unsanitary condition. "For one thing, hairs, towels, dust, soap, all things of that nature, had accumulated on the workstand," the inspector testified to the court. He added that the operator of the shop, L. A. Butler, Grifton, was in a general unsanitary condition, but had consistently ignored the warnings.

Butler countered with, "he (the inspector) was more or less down on me."

The barber shop operator, commenting on the sanitary condition of his workstand, sharply contradicted the inspector, asserting that "I keep that workstand in absolute number one shape."

"He" (the inspector), concluded Butler, "was always harping about something."

The defense was conducted by W. W. Speight, attorney for Butler. Six prominent Pitt County citizens testified for the defense, stating that the barber shop was "about average" or "fair" in sanitation, and "would compare favorably with other barber shops in Greenville and Kingston." The deputy sheriff who served the

papers in the case also testified in Butler's defense.

Judge Dink James raised the question, "Is 'fair' good enough for all citizens of Grifton?" and added that "it ought to be in top grade." Judge James made the statement after hearing the defendant testify that he sometimes fell behind in some of the details of housekeeping in the middle of the day when the shop was crowded with people waiting for service.

"Fair is not a violation," the defense attorney pointed out, in rebuttal.

County Solicitor Jim Lanier pressed for a guilty verdict on the basis of testimony from the state inspector, who gave a detailed report to the court on his findings in the barber shop. The inspector also was essentially backed up in his testimony by a representative from the local health department, who accompanied the inspector on one of his inspection trips.

After finding Butler guilty of running a barber shop in an unsanitary condition on a certain date, Judge James imposed a fine of ten dollars and court costs.

French Premier Wins Test Vote

PARIS (AP)—Premier Edgar Faure's government has won its first parliamentary battle—a budget issue involving limited pay increases for government employees and retired civil servants.

The National Assembly approved the budget article 362-342 last night after Faure warned his two-week-old cabinet would resign if defeated. The Assembly turned down the same measure when it was first presented by former Premier Pierre Mendes-France.

The article calls for a yearly raise equivalent to \$35.71 for civil and military personnel, both active and retired.

Body Of Tarheel Pilot Returning

BUENOS AIRES, Argentina, (AP)—The body of Lt. John P. Moore of Lenoir, N.C., killed Jan. 22 when a helicopter crashed at Kaiman Bay 40 miles northwest of Little America, was placed aboard a cargo plane here last night to be returned to the United States.

Moore, 26, was a member of the U.S. Navy expedition to the Antarctic. The expedition reached Buenos Aires today after two months in the Antarctic.

Satellite Leader Is Under Attack

BUDAPEST, Hungary (AP)—Leaders of the Hungarian Communist party today accused Premier Imre Nagy of "rightist deviationism" and of supporting mistaken "rightist ideas" in speeches and articles.

(Western observers in Vienna said Nagy's dismissal from office appeared imminent. He had been his country's chief mouthpiece for Soviet ex-Premier Georgi Malenkov's policy of more consumer goods. His downfall had been expected since the Soviet Union and Hungary early this year returned to policies emphasizing heavy industrial production, which includes war materials.)

A statement by the Hungarian Workers (Communist) party's Central Committee, published in all Budapest newspapers, accused Nagy of encouraging elements who tried to frustrate industrialization and deny the necessity of heavy industry development.

Only by development of heavy industry, it added, could there be a development of light industry and agriculture.

The statement said the criticism of Nagy was voiced at a session of the Central Committee held March 24. The chief speaker at the meeting was the party's first secretary, Matyas Rakosi.

Prisoner Held In California Tells Of N.C. Crimes

VISALIA, Calif. (AP)—A prisoner serving time in Tulare County jail for drunk driving and an unsuccessful escape attempt has admitted participating in 77 burglaries and armed robberies in North Carolina and Virginia, Sheriff Sandy Robinson said yesterday.

The sheriff quoted the prisoner, Shelton L. Beasley, 28, as saying he was responsible for 40 burglaries and an armed robbery in North Carolina; had knowledge of 16 others committed by "his gang" in that state; pulled three burglaries and an armed robbery in Virginia; two in the District of Columbia; and that the gang performed 14 others in Virginia.

Robinson said Beasley told him the largest burglary was a \$2,000 theft of truck tires in Elizabeth City, N.C. He also described an \$80 burglary of the Newhope, N.C., post office.

The crimes, Beasley told Robinson, were committed in 1953 and 1954. Beasley came to California four months ago.
