Conviction Grows Princess To Wed Townsend Green Light For Margaret?

LONDON (U. P.)—Right or wrong, the conviction spread like a runaway forest fire through Britain today that Princess Margaret has said "Yes" to RAF Group Capt. Peter Townsend.

Dead silence continued in official quarters. No reliable informant pressed to know what went on at the meeting last night between Queen Elizabeth II's lovely 25-year-old sister and the 40-year-old British public was sure the lid of Britain.

For all anybody outside the inner circle could tell with any certainty, the princess may have said "Yes," "No," or "Let's just be friends."

But Townsend, asked after his visit whether he was happy, grinned at newsmen and said: "Yes."

With only that and the fact of the visit to go on, much of the British public was sure the lid would come off soon on a happy ending to the reported royal romance.

The general guess was there would be a public statement—any time now and no later than the opening of Parliament Oct. 25—that the princess will defy the opposition of the Church of England to wed the divorced father of two children whose ex-wife is still living.

Townsend's unheralded visit to Clarence House, London home of Margaret and Queen Mother Elizabeth near Buckingham Palace, lasted an hour and 20 minutes. So far as was known, it was the first meeting of the princess and the pilot since he was named British air attaché at Brussels more than two years ago. Before that they saw each other nearly every day for 10 years while he was a royal equerry.

Both Margaret and her mother were at Clarence House when Townsend arrived. The princess came home from Scotland yesterday morning. The Queen Mother had returned from her vacation only an hour before Townsend, wearing an ordinary business suit, drove up alone in his car along

the tree-lined mall and parked in the courtyard of St. James Palace, across a side street from Clarence House.

When Townsend emerged after the visit, he declined even to confirm that he had talked with the princess.

A running interview ensued with newsmen, with these questions and answers:

"Did you have dinner with the princess and Queen Mother Elizabeth?"

"I can say nothing."

"Did you meet Princess Margaret?"

"I can say nothing."

"Do you expect to know soon what the future holds for you?"

"I cannot say."

"You realize how excited the public are about all this?"

"You can't imagine the state I am in myself."

"Will rumors of a royal romance be cleared up by the time your leave has ended and you return to Brussels?"

"I do not know."

"Are you happy tonight?"

"Yes," he said promptly with a grin.

That last answer did it, and the reporters sprinted for telephones. In the absence of official guidance from Buckingham Palace, London's morning newspapers were reduced to guessing. For instance, Lord Beaverbrook's independent Daily Express declared that, "as a result of the visit, it is believed an announcement is imminent that the 25-year-old princess and the 40-year-old group captain are to marry."

Council Unable To Reach Agreement With Property Owners City To Ask Study Of Re-Routing

The State Highway Department will be asked to study the proposed re-routing of N.C. 48 along Boyd Ave. in an attempt to determine if another route can be used for the highway.

Councilmen took that action last night after a local attorney appeared before the city fathers to request that a plan to remove a portion of the yard of Mrs. Emily Rouse for straightening the Boyd-Dickinson Ave. intersection be discontinued.

The Highway Department had approved the re-routing of the highway which now follows Albermarle Ave. and Tenth St. provided the city lined up the intersection at Boyd and Dickinson.

City officials have been negotiating for the needed property for some time but have been unable to reach an agreement with property owners.

Albion Dunn appeared before the board on behalf of Mrs. Rouse to

register her protest to the planned move.

In order to line up the intersection the city would have to purchase a triangular portion from the front of the lot. The move would not involve moving or demolishing the house which now stands on the property.

The proposal to request re-consideration of the route was advanced by Mayor W.L. Wheelbee, who pointed out that the new route would carry the highway traffic by schools and right-of-way was insufficient for construction of sidewalks for pupils. He also pointed out that the turn off Fifth St. to Boyd Ave. is a bad turn.

Councilman Wesley Harvey did not vote on the motion. He said even if the highway is not moved to Boyd Ave. the city still has an obligation to make improvements for intercity traffic. He also said there is no other feasible route for the street.

New Junk Yard? Attorney R.O. Worthington presented a petition to the council last night from property owners in the Meadowbrook area protesting the establishment of a junk yard west of the railroad right-of-way and Greene St. Worthington said that bulldozers had already begun work on the land and they had moved earth on private property next to the railroad right-of-way.

Worthington said he understood Sam Fleming, Inc., a junk yard located on the east side of Greene St., is to move into the new area.

No action was taken by the councilmen since representatives of the junk yard were not present at last night's meeting.

Attorney Milton Williamson appeared before the council on behalf of E. Tenth St. residents who asked that the college provide ample off-street parking for students using

newly constructed Umstead Hall. Mayor Wheelbee was instructed to contact college authorities concerning the request.

Request For Light Requested by the Student Government Association at the college for a stop light at the intersection of the administration building.

The councilmen informed the student body that the proposal would be submitted to the Highway Commission for their recommendation.

Action was deferred on a proposal to place curb and guttering in front of the recreation building on Elm St. The entire street will be considered in a proposed bond issue. A special meeting for consideration of the bond issue was set for November 3.

City fathers took no action on a request by Mrs. Carrie M. Barbour that her house be moved back due to the closeness of a sidewalk which is being constructed on Elm St.

Councilmen were told by City Attorney James S. Hughes and City Manager R.B. Lee that the walk is

apparently being constructed on the street's 60-foot right-of-way.

Building Fund Councilman S. Eugene West reported that he and Councilman Harvey had located a building at Guy Smith Park which could serve the needs of the local Ground Observer Corps. That group had requested a building from the city to be used as an observation post. They will be allowed \$200 from the city for work on the building and \$100 for a telephone installation.

Councilmen also approved changes in the Virginia Power and Electric contract at the request of Leonard Bloxam, utilities superintendent; authorized the city attorney to advise to make the city an interested party to hearings concerning natural gas lines for this section; increased the Planning Board to nine members and appointed Jack Wallace, local realtor, to the board; appointed Dr. John Zasky, of East Carolina College, to the Recreation Board; limited parking on Grand Ave. from Chestnut to Dickinson to 30 minutes.

Security Council Seat Again At Stake East-West Deadlock In UN

UNITED NATIONS, N.Y. (U. P.)—The U.N. General Assembly was plunged into a new East-West deadlock today when it failed on the first ballot to settle the hotly fought contest for a Security Council seat.

Neither Communist Poland nor the Philippines, supported by the United States, received the two-thirds majority required for election. The Assembly immediately began balloting again in the hope of breaking the stalemate.

The vote was 34 for Poland and 33 for the Philippines. Thirty nine votes were required.

The voting climaxed a campaign in which the Communists asserted that failure to elect Poland would arm international cooperation and endanger the spirit of Geneva. The United States charged that Poland was not qualified for the post.

Cuba and Australia were elected

without contest to fill two other council seats.

Before the voting, both Poland and the Philippines had claimed enough votes for election.

On the second ballot, the Philippines picked up two votes, to 35, while Poland fell to 29. On the third ballot, the Philippines fell only one short of the necessary 39, while Poland decreased to 30.

Yugoslavia has insisted it would not run, but informants said it might reconsider if it were sought as a compromise choice.

Russia and Poland depicted the contest as a test of the "Geneva spirit" and warned that defeat of Poland would endanger the slowly developing East-West harmony.

The Communist states charged that by backing an Asian state, the United States breached a London pact of agreement of 1946 allocating one non-permanent council seat to Eastern Europe. The

United States says the agreement was only for 1946 not forever.

Elsewhere in the U.N.: The 60-nation Social Committee handed Secretary General Dag Hammarskjold a sharp rebuff when it scrapped his suggestion that it turn the thorny question of self-determination for subject peoples over to a temporary committee.

During the debate delegates accused Hammarskjold for interfering in any question that was being debated by a committee and accused him of exceeding his authority by making his suggestion.

In the Political Committee, Czechoslovakia said she favored an "in principle" early establishment of an international atom-for-peace agency provided it is kept open to all countries including East Germany and Red China.

Await Ruling On City's Extension

Lakewood Pines representatives appeared before the City Council last night for another round in their battle to enter the city limits and thus obtain water lines for the area located south of Greenville.

They were told to wait for a reply from state attorney general's office which would definitely establish the legality of the unusual extension of city limits that is necessary for inclusion of the area.

The residential area is located some distance from the present city limits and land in between is undeveloped. Thus to make city limits contiguous, the line would have to run down Evans St. Extension to the Lakewood Pines area where it would then surround Lakewood Pines.

City Attorney R. E. Lee said he had written a letter to the Attorney General's office and expected a reply within a few days. He said that in his opinion, however, there is no doubt of the legality of the plan.

Mayor W. L. Wheelbee said he had heard the legality of the move had been questioned by some.

"I don't like for any doubt to exist about the legality of anything we do up here," he declared.

The Lakewood Pines group has appeared before the city's Planning Board, the Utilities Commission and the City Council on numerous occasions.

City fathers annexed two new sections in to the city last night after no protests were registered at public hearings on the matter.

The new sections are: Colonial Heights Addition and Sheraton Place.

Colonial Heights Addition is located behind the present Colonial Heights and is a newly opened area.

Sheraton Place is located across the U. S. 294 bypass from the Hillside area. It, too, has only recently been opened.

Both new sub-divisions were said to have complied with the subdivision ordinance.

Eisenhower Refreshed, Cheerful In Hospital The President Is 65 Today

DENVER (U. P.)—President Eisenhower is 65 today. And he began the observance of his anniversary feeling "refreshed and cheerful."

While he still must travel cautiously the hazardous road to complete recovery from a heart attack, it is a "happy birthday" for he is getting better every day.

A 7 a.m. MST medical bulletin said:

"The President had a good night's sleep of more than eight hours. He awoke fully refreshed and cheerful. His condition continues to progress satisfactorily without complications."

His observance of the occasion is being limited because he is not allowed out of bed as yet. But the

joy of others, at home and abroad, reflected in the scores of presents and thousands of greetings piling up by the hour at the Denver White House and Fitzsimons Army Hospital.

There is, of course, a birthday cake—a gigantic one made in sections so that more than 2,000 hospital patients and the hospital staff can share. And his own section, from which he will eat a small slice at noon, is decorated with an American flag and the inscription "Happy Birthday, Ike."

The President, in a "happy mood" could look forward too to a stepped-up schedule of government business. Secretary of the Treasury Humphrey is flying in tomorrow to talk over budgetary problems. There will be a conference on defense and security Monday with Secretary of Defense Wilson and Adm. Arthur W. Radford, chairman of the Joint Chiefs of Staff.

Today, however, the only business scheduled was the celebration of an anniversary for the man whose attack of coronary thrombosis Sept. 24 sent a wave of sorrow and concern around the world.

Half Of All Graduates Can't Fill N. C. Needs

RALEIGH (U. P.)—Half of all graduates of North Carolina's colleges entered the teaching profession, they still would not fill the need for public school teachers.

This was the report given yesterday by William H. Cartwright, chairman of the Duke University department of education, at a wide conference on school problems.

More than 1,000 persons attended the meeting, a preliminary to the national White House conference on education in Washington Nov. 28-Dec. 1. A 34-member delegation named by Gov. Hodges will represent North Carolina at the national conference.

Cartwright said that at six regional meetings which preceded the state conference there was general agreement that adequate salaries would do more to alleviate the teacher shortage than anything else.

A minimum of 3,200 new teachers annually will be needed by Tar Heel public schools later this year, he reported. N. C. Hunt, director of the State Department of Public Instruction, Teacher Colleges turned out 3,040 teachers in 1953-54 but fewer than half of these were employed in the state's schools the following year, he

More financial support for schools was a need mentioned by several speakers. Gov. Hodges declared that federal aid, if made available, "will never do more than touch the problem." If it is made available, it likely will be on a matching basis, he added.

At the close of the conference, Dr. Charles F. Carroll, state superintendent of public instruction, said the time has come "when the people of North Carolina should resolve to pay the bill" for adequate education at school and college levels.

William E. Rosenstengel of the University of North Carolina said there was agreement at the regional meetings that schools are "inadequately financed in many areas." Increased enrollment will increase the financial load, he added.

The conference was told that local and state support for schools should be increased to meet money needs.

On school organization, the conference heard a report that selection of local school board members should be brought closer to the public, perhaps through elections on a nonpartisan basis.

Starving Tots Die Of Eating Garbage Scraps

NEW ORLEANS (U. P.)—Two small starving boys died, each dreamed of someday growing up to be heavyweight champion of the world, died yesterday after days of begging scraps of food from door to door and eating out of neighborhood trash cans.

Six-year-old William Baumhans Jr. died with a plea for food on his lips. "Please, may I have a ham sandwich?" he murmured to hospital attendants.

Seven-year-old Lawrence, who died 12 hours later, never regained consciousness after police removed him, frail and convulsed, from the shabby, one-room apartment where the Baumhans lived with their seven children.

The five girls, ranging in age from 1 to 9 were placed in foster homes.

Police jailed William Baumhans, a 29-year-old unemployed longshoreman and his 38-year-old wife, booking them for criminal neglect of their children.

Laboratory tests and toxicological examinations were scheduled after Dolo, the oldest girl, told police the brothers had been eating out of an empty mustard jar found under the wooden tenement. Doctors believe it was contaminated with arsenic.

Police went to the squalid room

yesterday when neighbors complained the children were out begging at all hours of the day and might be eating out of wine from discarded bottles. One woman said she couldn't sleep because of the cries of the hungry children.

"They ate in the garbage cans up and down the street," said Mrs. Evelyn Scallan, a next-door neighbor.

Offers to bury the two children poured in after Baumhans said he would have to await assistance from his father in Acadia, Tex., because a burial insurance policy had lapsed two months ago.

"I'm a sick man," he said. "I have a nerve sickness. I've been nervous since I was born."

He said he left his last job two weeks ago to seek admission to a Veterans Administration hospital.

Since then, the family lived on \$7 worth of food chits provided by nuns at a nearby convent.

Baumhans a gaunt, thin man who looks older than his 29 years, said his sons wanted to grow up to be fighters "like Rocky Marciano."

His wife, a frail woman in a soles' pink dress, tearfully insisted she had done her best for the children.

The family had applied for assistance from the Louisiana Welfare Department. Miss Lillie H. Nairne head of the New Orleans office, said the mother gave no indication that her husband was too ill to work or that their situation was an emergency. A follow-up letter went unanswered by the Baumhans.

Six-Jet Bomber Crash Kills Four

RIVERSIDE, Calif. (U. P.)—A six-jet B47 bomber powered into a hill and exploded killing four crewmen last night, shortly after it had taken off on an instrument training flight from nearby March Air Force Base.

Base commander Col. Pinkham Smith estimated the swept-wing bomber was traveling nearly 500 miles an hour when it hit.

The explosion scattered flaming wreckage over a two-mile area. Houses shook in Riverside, eight miles away, and residents flooded police with calls.

Prohibit Use Of Secular Music In Church Rites

CHICAGO (U. P.)—Starting Nov. 27 certain musical selections, including the traditional Wagner and Mendelssohn wedding marches, will be banned from churches of the Roman Catholic archdiocese of Chicago.

Also forbidden by the edict against secular music at religious ceremonies are eight versions of "Ave Maria," among them the popular Gounod and Schubert compositions.

Three English songs—"I Love You Truly," "Oh Promise Me" and "Because"—also are on the proscribed list.

Samuel Cardinal Stritch archbishop of Chicago, issued his ruling yesterday to all pastors. He stated "no deviation can or will be permitted."

The cardinal said he acted upon advice of a commission on sacred music he established a year ago to survey compositions performed in churches. It recommended that certain music be banned as "unsuitable for failing to meet the primary requisite of 'sanctity.'"

'Old Boys' At National Legion Convention Showed Plenty Zip

MIAMI Fla. (U. P.)—Drums and bagpipes are stilled and the veterans scattered but the old boys who attended the American Legion's national convention showed plenty of zip.

In the convention which ended yesterday they voted to over-whelmingly endorsed the United Nations in principle and approved U.S. membership.

They gave a thumping defeat to a ban for \$100-a-month pensions for all first World War veterans at age 65 but asked greater benefits for its veterans and dependents.

They revolted developed against Legion "brass" over a proposal for a steering committee to do planning at conventions but a new national commander and five state commanders were elected by acclamation.

Russia, China and India were given a kicking around, but the veterans asked solid military sup-

port for Nationalist China and South Korea.

Most of the delegates were World War I veterans, with a smattering of younger World War II and Korean service men. The older men dominated the floor during debates — but the new national commander, J. Addison (Add) Wagner, was born in 1914, when war clouds began to shadow the oldsters.

Wagner, an attorney of Battle Creek, Mich., is a Navy veteran of World War II. He was commissioned a Navy ensign in 1942, served aboard a rocket-firing ship in the Pacific and was wounded in a air attack at Okinawa. He recovered in time to take part in the occupation of Japan.

A Massachusetts delegate Jacob Kessler tossed in from the floor the only name in opposition to Wagner. He nominated Dwight E. McCarthy of Fitchburg, Mass., as a part of the revolt against

"brass" McCarthy received 20 Massachusetts votes. All the remaining 3,145 went to Wagner. A motion from the floor made it Wagner by acclamation.

Strong opposition to communism, and especially to any Communist activity in the United States was made the Legion's target for the next year by Wagner.

A single paragraph in a 10-page foreign relations report unanimously adopted by the convention called for refusing economic aid to India because that country "although professing neutrality, is actually giving material aid to Communist Russia."

The United States was asked to withdraw its support from the Korean armistice commission, to continue to refuse diplomatic recognition of Red China, and to use "every resource" to prevent Communist China from gaining membership in the United Nations.

Then they can be dyed with rit or used in the natural color. Molding caly makes a wonderful base into which flowers can be arranged. Silver or glass containers should never be used. Pottery, copper, wooden and straw containers are very appropriate. Dried arrangements should never be placed near a furnace or in a draft. Mrs. Hardee had many of her own arrangements at the meeting. N. C. Schools Pose Staggering Burden

1960 is little more than four years away, and school officials are telling the people of North Carolina that the school needs of the state by that date will total 377 1/2 million dollars.

If North Carolina were to meet its need for school outlays it would necessitate the spending of approximately 100 million a year for the next half decade. In spite of efforts which will be made in behalf of better schools for the state, such an outlay could hardly be realized.

During the decade which ended last July 1, North Carolina made the greatest capital outlay for school facilities it has made in any similar period in its history. Even so, during the past 10 years expenditures for the state's public school facilities amounted to approximately three-fourths of what leaders say is needed in the next four years.

From 1945 to 1955 North Carolina spent 288 million dollars on its school facilities. Of this amount \$222 million came from local school units and the remaining \$66 million came from state funds. Although the ratio of state funds to local funds for public school improvements may fluctuate somewhat in the next few years, the major part of the expenditures for new classrooms obviously must come from local school districts.

During the post-war decade many of these school units incurred as much bonded indebtedness as they could stand attempting to bring their school system up to par. Some of this indebtedness has been retired. But there are some counties which still have about all the school bond debt they can manage for several more years.

This condition will be a major factor in determining how much local money can be funnelled into more school building programs.

There is also another factor which will have a weighty

bearing on the amount of school funds which are available for capital improvements. That is the segregation question which has cast a shadow over the North Carolina school system since the Supreme Court decision.

Generally throughout the state there is the feeling that some solution to the segregation issue must be found before the state or local units launch another spending spree for school facilities. In order to spend wisely millions of dollars more for public schools, the planners must know whether to continue to build schools for use in a segregated system, or in an integrated system. Then too there is the remote possibility that state public schools as we know them today may be out of the picture altogether.

In this valley of indecision, there are many voters who are reluctant to sanction further bonded indebtedness for schools. And the voters, of course, will determine whether local bond issues for school improvements are passed or defeated.

North Carolina will continue to build new classrooms and new schools from both local and state funds throughout the next few years. Local school units will continue to pass bond issues for school outlays. Whether these bond issues will be in an amount equal to the pace of the past decade, however, remains a matter of conjecture. It is extremely doubtful that the flow of money into our public school facilities during the next five years will surpass the pace which was set during the past decade.

Undercurrents In Political Waters

UNDERCURRENTS—Beneath the placid surface of North Carolina political waters there are undercurrents that may result in turbulent waves. To change the simile, behind the gentle breezes which appear to lull the public conscience into complacency there are little whirlwinds with potential development into hurricane force.

These incipient storms have their origin in the fact that North Carolinians generally are more progressive and liberal than many of the self-appointed spokesmen on economic and political matters.

Governors Scott, Umstead and Hodges, the post-war executives, have consistently argued with budget-makers and legislators that the people want service from their government and are willing to pay for it.

One phase of the developing storm is related directly to this point of view. It is the question of racial segregation in the public schools. That issue is almost wholly economic, with only casual social implications.

The major force behind the undercurrents is largely social. It is primarily related to the question of racial segregation in the public schools, with all the implications of integration in other phases of society.

THREE WAYS—There are three distinct groups of thought in the political waters of North Carolina. The first group is in favor of full integration and to hell with consequences to tradition or the established social order.

A larger and less vocative, but perhaps more determined group, insists upon maintaining segregation even at expense of abolishing the public school system and abandoning many other social services.

The third group, believed to constitute substantial majority of the citizenship, opposes integration on principle and in practice, and will not resist it as far as possible within legal limits, but will not surrender the public school system in its entirety.

CONTROL—On statewide basis David Jordan group has the numerical strength to control the situation. In some communities it does not. The degree of local authority under terms of the 1955 act and Governor Hodges' "local option" proposal has not been determined.

The act transfers from the State to local unit boards responsibility for enrollment and assignment of pupils so as to provide for the orderly and efficient administration, effective instruction of pupils, and their health, safety and general welfare. It is assumed that gives local boards the power to integrate pupils upon finding that such action would serve the purposes set out in the statute.

The Governor has not elaborated

ed upon the local option plan, which will require legislation. Street corner opinion is the proposal would permit local boards to close the schools rather than integrate, perhaps only after a popular vote. That might result in some counties continuing to get State and local tax money for public education while others would not. Yet the people of all the counties would continue to pay sales and income taxes, whether or not they shared in the distributed benefits.

ELECTIONS—Another phase of the overall subject matter is the unpredictable participation of voters in local option elections. Even to mention that is to walk on egg shells and savors of fool rushing in where angels fear to tread. Conditions are not changed by ignoring the facts.

The historic facts are that a minority of the registered voters participate in elections and that the registered voters constitute little more than a majority of eligible registrants, particularly in precincts which have predominant Negro population. Except in a half dozen larger cities there has been no effort to obtain general registration of Negro voters.

BLOC—Election returns over the past five years will show that in Raleigh, Durham, Greensboro, Winston-Salem and Charlotte the voters are predominantly colored precincts have voted almost "en bloc".

Issues involved then were not nearly so vital to the interests of the colored voters as the question of abolishing public schools.

Local option elections on that issue might well precipitate efforts for mass registration and bloc voting. Once registered the voters will be eligible to participate in all other elections. That is one of the undercurrents which may develop into storms that would upset all calculations about outcome of primaries and elections for public officials.

SHOW-DOWN—Since no local option election or vote upon constitutional amendments can be had until authorized by legislation, and since a special session of the General Assembly presently seems very unlikely, the storm may not break until after the 1957 Legislature. There remains the possibility that many of these undercurrent issues may come to the surface in time to materially affect primary voting next May.

That is one of the reasons a number of actual and potential candidates are having headaches and nightmares. Particularly those who espouse one of the relative extreme positions. They are not sure whether it is to their advantage to sit-out the deal or call for a show-down.

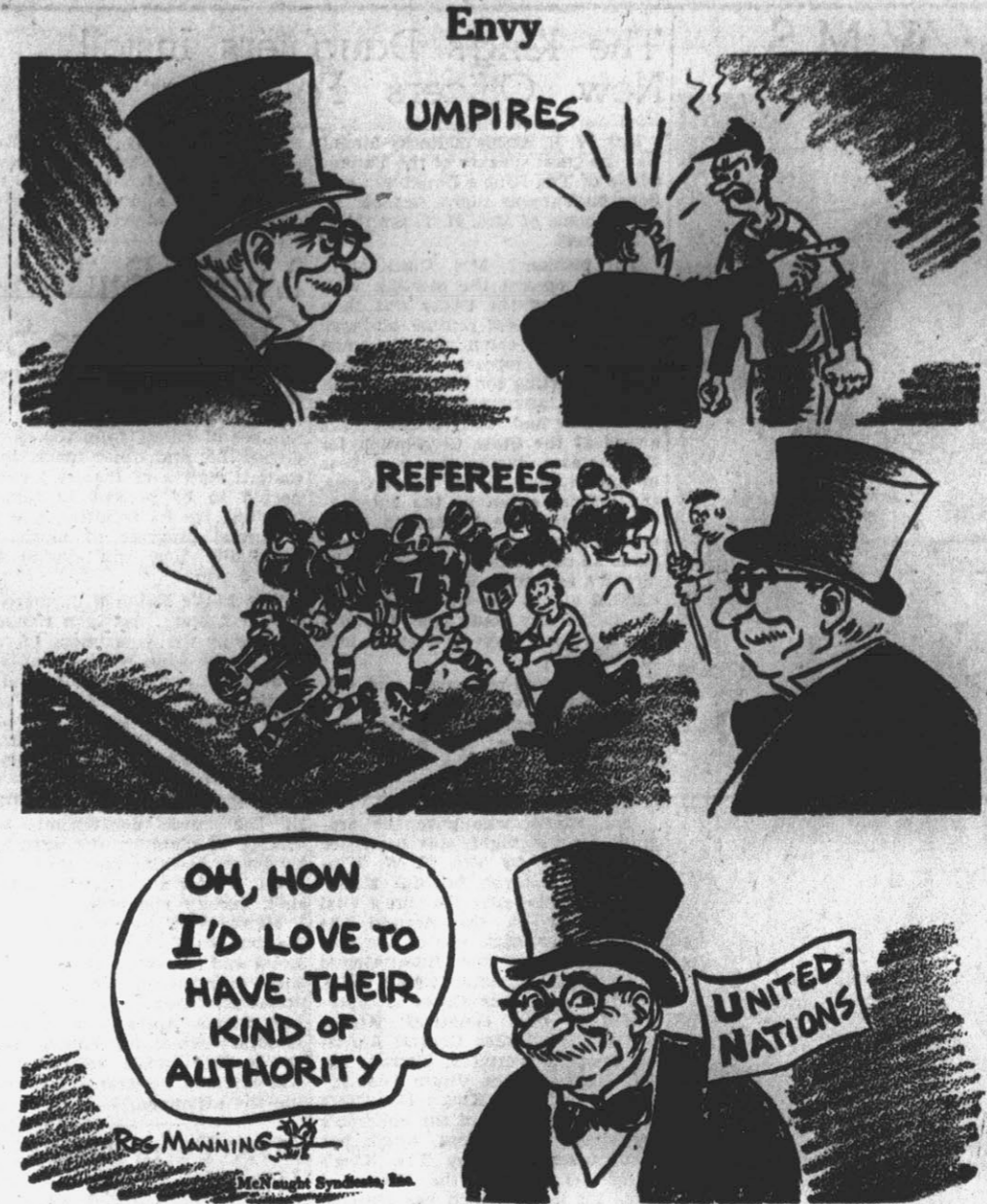

Cost Of Services Runs High

By ELMER ROESSNER

The amount Americans are willing to spend for services may be far greater than generally realized. The National Industrial Conference Board, as chronicler here yesterday, estimates the average family is spending 36 cents of every dollar for services, compared with 31 cents in 1949.

The Board bases this conclusion on a rigid definition of "services," holding them to be transactions in which no goods change hands. But the average family pays, in addition, a lot for services when goods are involved.

The average family insists on sliced bread. The cost of slicing machines, repairs, power and operation is tucked in somewhere in the price of sliced bread, and the family pays for this service.

In buying frozen foods, housewives may be buying more service than edibles. Frozen peas may have more flavor than tired old peas in a pod, but that does not alter the fact that housewives are buying a lot of pea service—and lima, potato and broccoli services.

And if the food is precooked, the amount paid for services is necessarily higher. If a frozen turkey dinner tastes better than the housewife can cook, it is because she is paying for a seasoning service, too.

The entire aerosol industry is founded on the idea that consumers will pay for service. People can whip cream or hair gel by hand or squirt on hair goo or bug-killers with an atomizer. But they are willing—nay, eager—to pay a premium to have compressible gas save a few arm and hand motions.

Whenever a guarantee is involved, buyers are paying for services as well as product. The price of a new car must include the costs of the 1,000-mile check-up and other services that go with the deal. The tags on television sets, refrigerators and other appliances must include the costs of delivery, instructions and guaranteed repairs.

A detailed analysis might show that American families are spending no 36 cents but four bits or every dollar for services—and doing it willingly. This eagerness may be worth a few minutes' meditation by businessmen eager to increase sales or expand operations.

TIGHTER CREDIT BENEFITS BANKS
About midway the Federal Reserve Banks took a major step to slow down the boom: They increased rediscount rates, thereby leading to increase the interest rate on borrowed money.

Many businessmen protested this contending that, if it was not bad for the economy, it certainly was bad for them, since it made them pay more for operating capital.

Banks also lamented that they were losing money on the depreciated value of their government securities. However, the third-quarter reports of banks, now being made public, disclose a pattern: Banks lost on sales of securities but more than made up for it in increased returns on loans at higher interest rates.

WANT LEGAL FEES?
CONGRESS—Several Congressmen pressed to be shocked because 14 Wall Street brokers and businessmen put in bills for \$1,700 expenses in answering subpoenas issued by a Senate Anti-Monopoly subcommittee. They are entitled to the money under the law and will be paid, although the committee staff made the point that businessmen usually waive fees in such cases.

Just why businessmen—even those wearing the Wall Street Street tag—should waive legal fees is not clear. But one way to encourage them might be for Congressmen to pay their own expenses on trips to Europe, limit mileage to amounts actually spent, abandon their right to frank mail and fire their relatives from the Congressional payroll.

State Highway Dept. Can't Wait Forever

Greenville's City Council for the past several months has kicked around the matter of acquiring the necessary property at the intersection of Dickinson Avenue and Boyd Avenue to eliminate the off-set at that intersection.

The matter has been discussed and re-discussed by the Council. After several months of consideration, it seems Council members should have made up their minds what the city intends to do.

It was a number of months ago that State Highway officials informed the city the Highway Commission would re-route N. C. 43 along Boyd Avenue if the off-set at the intersection is corrected. In spite of the city's delay in taking positive action, we assume the offer of the Highway officials still holds. Nevertheless the Council cannot expect the Highway Department to wait indefinitely for a reply.

Obviously the off-set at the intersection needs correction to eliminate one of the more dangerous traffic hazards of the city. It is likewise obvious that the city's traffic situation would be improved if N. C. 43 is re-routed through the city over the proposed route rather than over the streets it now follows.

It is high time the Council took concrete steps toward acquiring the needed property.

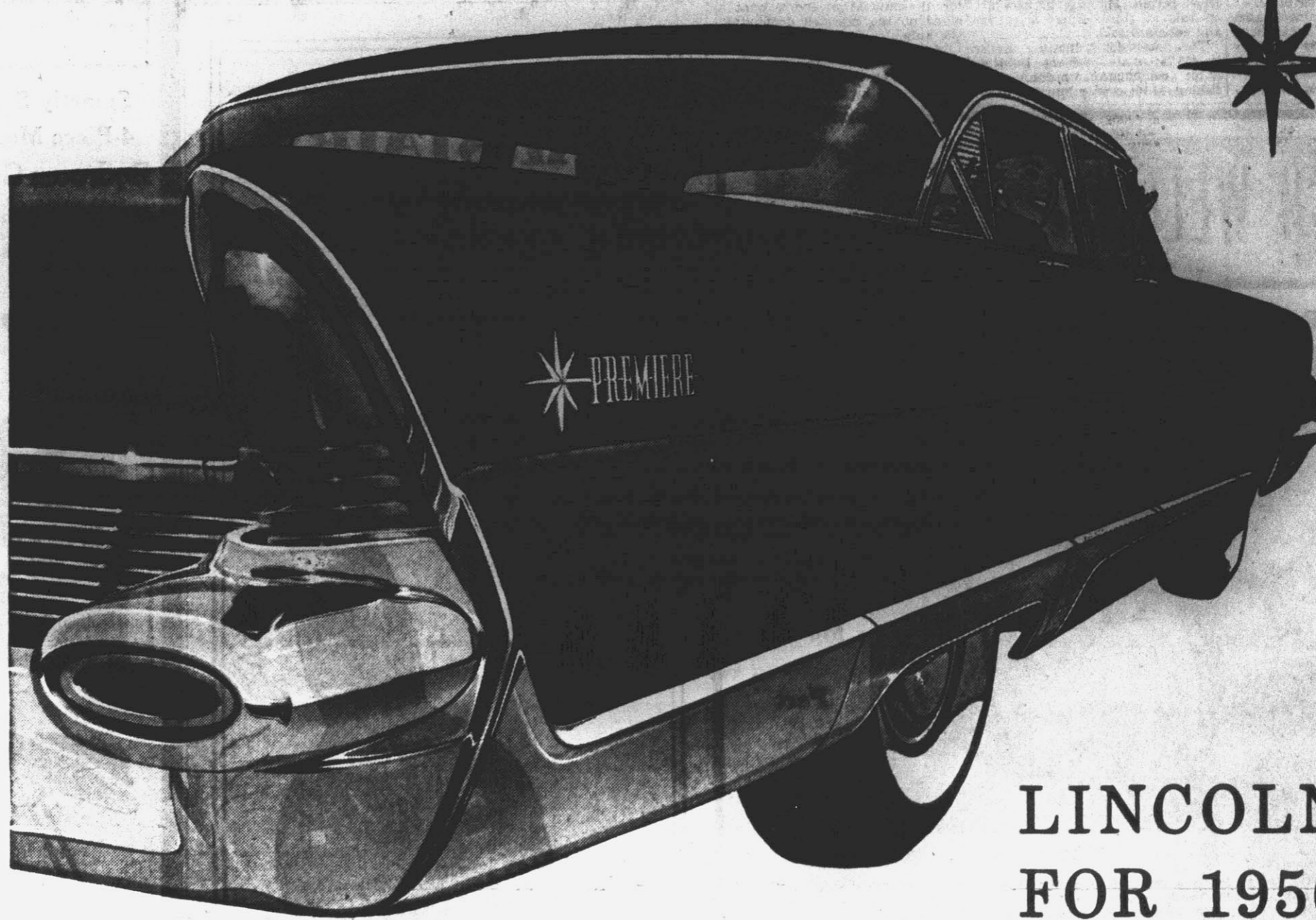

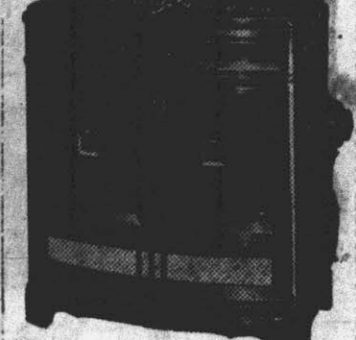

From Near And Far, Loud Tax Protest Being Heard

SALL LAKE CITY (AP)—The post card from Monroe, La., to Gov. J. Bracken Lee reads: "Two, four, six, but—Seven, eight, nine—'We don't want no hem or haw—'We're for the governor of Utah."

The Louisiana doggerel was among more than 500 letters and cards piled across the desk today of Harold W. Simpson, Lee's administrative assistant. Lee is a Republican.

Simpson said all but four letters praised Lee's statement he will not pay all his income tax next year, hoping to prod the government into a suit in which he can challenge the constitutionality of using income tax funds for foreign aid.

"These letters would surprise a lot of politicians," said Simpson. "Judging from them I believe a nationwide referendum would go against continuing foreign aid."

Utah Democrats have blasted Lee's proposal. They asked the governor to either retract or resign. Lee refused to do either. State Republicans have said "No comment."

Lee's assistant said 90 per cent of the letters came from outside Utah. Of the four opposing Lee's stand, Simpson challenged two. He said they appeared to come from the same typewriter, although different names were typed at the bottom. Both were post-marked Los Angeles.

Other letters offered to help. Several included small amounts of money to help finance Lee's battle. Lee declared last week he would withhold his income tax on a portion of his salary. "I shall put my tax in the bank here in Sall Lake City," he said. "Not a dollar of it will they get until legality of

She knew of no plans NBC had for her. She felt if she broke away completely from television she would be free to do more in other fields."

Another friend says "I think she felt the bad year she's had more than anybody realizes. I think she wanted to wipe the slate and have a clean blackboard to write on."

The past year was indeed a bad one for this slim woman who with Sid Caesar rose to the summit of TV entertainment in past seasons. After she and Caesar parted amiably she had her own show on NBC last season. Despite changes of format and great effort, the show simply didn't take. Her mother to whom she was deeply devoted, died. Shortly afterwards death also took her husband, tall and handsome Robert Burton to whom she'd been happily married for 18 years.

"Coca has had it," people in television said sympathetically. Imogene Coca has known bad times—as well as good times—in the past. Before she began hitting her stride with Caesar in television she had a decade of incredibly bad times. "My blue period," she has called it. She and her husband, who also was a singer and actor, often didn't know where the next dollar was coming from. They literally knew hunger—and eviction for not paying the rent. Once, without a nickel between them, they spent the night dosing on the hard benches of Grand Central Station.

Knowing much tragedy, she has still brought a great sense of comedy to life. There will be a lot of people cheering for her when she opens at a Las Vegas hotel in three weeks.

Tammany Boss Finds Adlai Drive

SAN FRANCISCO (AP)—A Tammany backer of New York's Gov. Averar Harriman for the Democratic presidential nomination found a burst of campaigning for Adlai Stevenson today while sounding out West Coast preferences.

Carmine DeSapio, the Tammany leader, said he was not campaigning for Harriman although he liked the governor. He said he wanted to sound out the "grass roots."

Almost simultaneously four of the five top California Democrats urged Stevenson to seek the 1956 nomination and declared. "This is the start of a movement that will sweep the West."

DeSapio also learned that a statewide campaign was being started at Los Angeles in behalf of Sen. Estes Kefauver of Tennessee.

Shortly afterwards, the Democratic chairman in Oregon declared he was a firm backer of Stevenson and contended Tammany Hall and the Republican press were trying to swing the nomination to Harriman.

Howard Morgan, the Oregon chairman, expressed himself in a letter to the Portland Oregonian, which editorially had reported a recent "organizational drift toward Harriman."

DeSapio and Harriman's press secretary Charles Van DeWander were quoted by the Oregonian as saying Morgan's opinions were "ridiculous."

California Atty. Gen. Edmond G. (Pat) Brown said, "We are in this thing until Stevenson wins or releases us." Brown is titular head of the start party in the "draft Stevenson" group with him are Paul Ziffren of Los Angeles, national committee chairman; Elizabeth Snyder of Los Angeles, chairman of the State Central Committee; and Roger Kent of San Francisco, northern chairman for the State Central Committee.

Mrs. Clara Shirsper of Berkeley, national committeewoman, said, "Until I know who the candidates will be in the California Democratic primary, I am going to remain uncommitted."

Brown said he assured DeSapio there was "excellent secondary strength" in California for Harriman.

None of the three — Harriman, Kefauver or Stevenson — has declared himself a candidate here yet.

All candidates must give their consent to appear on the California primary ballot.

Stevenson telegraphed Brown and other supporters that he was "deeply grateful . . . Support like yours will insure a great victory for our party in 1956. You will have my decision soon."

He is expected to announce his plans at a national committee meeting in Chicago Nov. 17-19.

Politicians Are Embarrassed By Huge U.S. Crop

NEW YORK (AP)—Perfect weather is bringing an embarrassment of riches.

The nation's second largest harvest is good news for the eating public—but a worry to the politicians.

And today the economists are beginning to wonder out loud how high the surpluses can be piled before they get so top-heavy as to threaten a topping of good times in general.

The Agriculture Department reports that ideal weather in September is bringing the prospects of the cotton crop by 8 per cent. The farmers are now expected to pick a crop 2 per cent higher than in 1954 in spite of government controls that cut cotton acreage by 14 per cent.

September's perfect days sent the prospects of corn higher and the crop will be well above last year's. Farmers can translate that into more meat for American tables. But livestock production is already high, and meat prices are weak in the wholesale markets.

Other crops that September smiled upon are rice, peanuts, tobacco and grain sorghums.

Although the wheat harvest is smaller than last year's, it's higher than the goal set by the government.

Total farm income this year is running behind last year and is about one-sixth below the record set in 1951.

Farmers have been putting new machines and methods into use. They get more production out of an acre of land.

And they get more output out of a farm worker. So there are fewer employed on farms now, and more rural workers seeking factory jobs. There are five million fewer workers on farms now than in 1920, although the harvests are much larger.

The Federal Reserve Board reports that "the general financial position of farmers remains relatively strong." It notes a rise in farm debts to finance production and to buy more land, but it says this debt is "fairly low in relation to current level of farm income, the large volume of liquid assets on the farm real estate."

But with the weather, boating surplus crops — and an election coming up—the political question of what to do about over-production and weakening prices seems bound to hit new heights of sound and fury in the months ahead.

Hungary To Free High Churchman

VIENNA, Austria (AP)—Hungary's Communist government says it is releasing Roman Catholic Archbishop Jozsef Groesz from prison, but it indicates he is being put under house arrest.

Radio Budapest announced last night, "Dr. Groesz will take up residence in an ecclesiastical building to be assigned to him." Such announcements from the Communists usually mean the churchman is not allowed to resume his church office and is restricted to the residence assigned him.

The broadcast said the archbishop's 15-year sentence for plotting to overthrow the Communist regime was being "interrupted" at the request of Dr. Gyula Csapek, archbishop of Eger and acting head of the Roman Catholic Church in Hungary.

The announcement added that four other imprisoned Catholic priests would be amnestied. They were identified as Dr. Misa Imre, James Horvath, Japoe Korp-n and Jozsef Bardos. Their terms were not specified.

Archbishop Groesz was Hungary's highest ranking Catholic prelate after Josef Cardinal Mindszenty was imprisoned in 1948 on a treason charge. Archbishop Groesz was sentenced in 1951 in a continuing wave of Red attacks on the church.

Last July the Communists announced they were releasing Cardinal Mindszenty from his imprisonment, but nothing definite has been heard of his whereabouts.

More than 14 million pints of blood, 7½ million for civilians and 6½ million for military use have been donated to the Red Cross since 1948.

Protest Exclusion Of Representation

RALEIGH (AP)—Catholic leaders are protesting the exclusion of parochial school representation among North Carolina delegates who will attend the White House conference on education.

The 24-member state delegation was announced at a statewide educational meeting attended by more than 1,000 persons yesterday. The conference will be held in Washington, Nov. 28-Dec. 1.

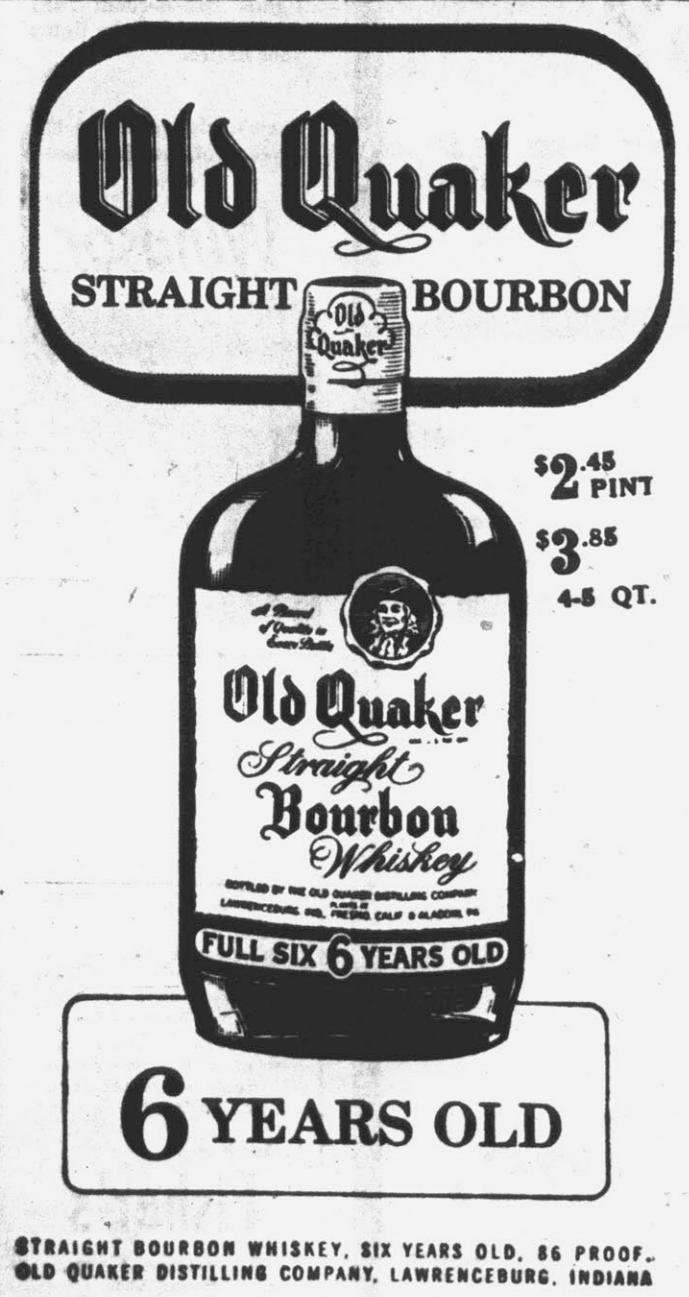

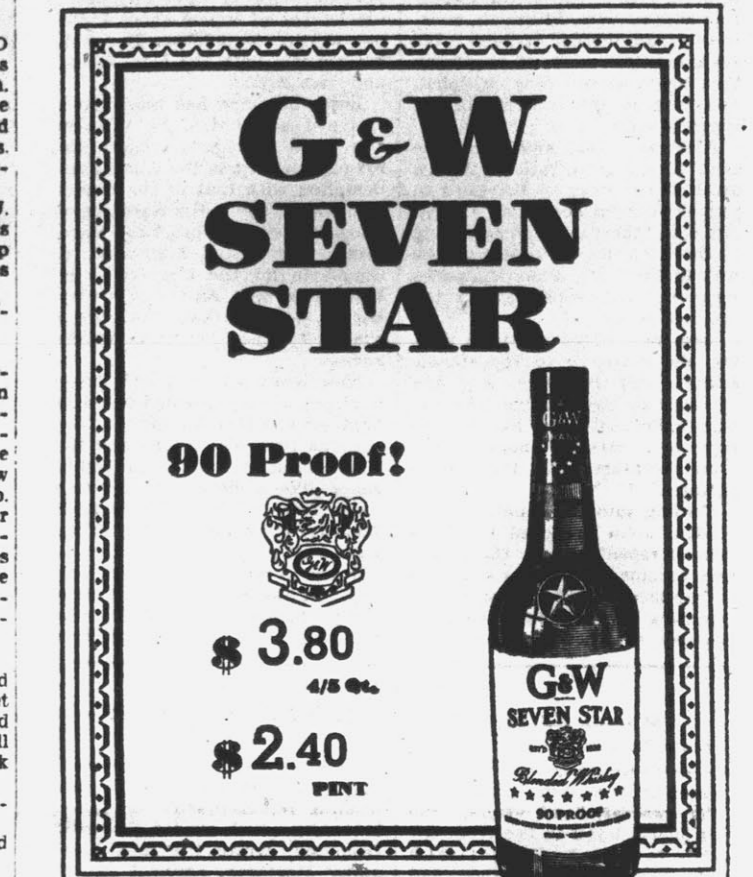

Local firemen who were called to the scene said the blaze was beyond control when they arrived. Some tobacco was believed lost in the structure.

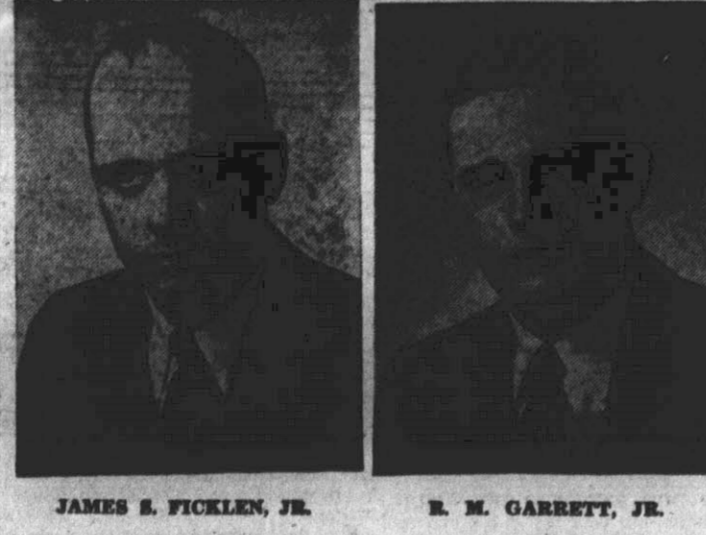

French Premier Faure In Fight For Political Life

PARIS (U) — Faced by likely defeat in the National Assembly on Algerian policies, Premier Edgar Faure postponed the showdown early today by calling for a vote of confidence in his government.

The demand keeps him in office at least until Tuesday, when the vote will be held. In the meantime, the Premier will try to work out a lifesaving maneuver such as spared his government last Sunday on the question of Morocco.

The call for a vote of confidence automatically shut off debate for 24 hours, and the deputies decided to extend the cooling-off period until Tuesday. If the government loses on a question of confidence, it resigns.

Faure's seven-month-old government has been in difficulties since the Moroccan debate. Four Gaullist ministers, in open opposition to Faure's program of conciliation of Moroccan nationalists, were forced out by the Premier, and since then Faure has lacked a dependable majority in the Assembly.

French Forces Try Close Off Morocco Border

RABAT, French Morocco (U) — Half a French division pressed an encircling movement in the embattled triangle along the Spanish-Moroccan frontier today and at the same time tried to trap a fugitive band of rebels headed that way from the Atlas Mountains.

The French in eastern Morocco are trying to close off the Spanish-Moroccan frontier, over which they say most of the recent rebel attacks have come. It is a country of mountains and plateaus, cut by gullies offering hideouts for rebels sniping at French troops.

The rebels still hold one border post, Bou Zineb. The French drive stalled just over a mile from the mountain position when a rebel patrol picked off five troops in a scuffle.

From Tizi-Ouzi, recaptured several days ago, other French troops advanced three or four miles north to occupy heights from which they can better control routes across the frontier.

To the south, along the main Casablanca-Algeria highway across North Africa, French patrols searched for a band of 125 rebels from the central Atlas section. These are believed to be seeking refuge in the Spanish-Moroccan zone after having had a part in the sack of the small French outpost of Immaouzer-Des-Marmouchas, where 11 French men, women and children were killed in a night raid Oct. 1-2.

The government announced via the official radio Maroc that the highway was closed for 125 miles to the east of Taza. Meanwhile, surrendering tribesmen in the area turned in nearly 150 guns including a few light and heavy machine-guns.

Nearly a thousand miles to the east small but widespread terrorist attacks continued in Algeria. In the region of Bone, one of Algeria's important cities, small bands swept through orchard country cutting down orange and olive trees.

Near Ouled Selim an Italian truck driver was killed. Near El Madher the brother of the local chief and another Moslem were kidnapped. Near Meriel two Moslem boys were found with their throats cut. Two others were kidnapped earlier in the week were still missing.

Neither Knowland Nor Nixon Can Win: Knight

By MORRIE LANDSBERG SACRAMENTO, Calif. (U) — Gov. Goodwin Knight was quoted yesterday as saying he didn't believe either Sen. William F. Knowland (R-Calif) or Vice President Nixon could win as the 1956 Republican presidential candidate.

The Republican governor, a strong supporter of President Eisenhower, but embroiled in a hot political fight with Nixon partisans, denied "flatly and without equivocation" that he ever questioned Knowland's electability.

He did not reply directly to a request at a news conference to confirm he had said he opposes Nixon because "I just don't think Dick can win" if President Eisenhower doesn't run.

"I'm getting a little weary of being misinterpreted in this matter," he said.

He replied "Oh no," when asked if Nixon lacked any of three prerequisites Knight enumerated for a Republican presidential nominee — integrity, stability and electability.

Charles Cleveland political editor of the Chicago Daily News, said: "The facts are that I interviewed him (Knight) and he said everything he was quoted as saying in the story."

The governor, in that interview, reiterated his plans to head California's delegation to the Republican national convention next August if Eisenhower withdraws as a candidate, even if it means a primary election battle against a Nixon slate.
