He recalls, "I was a student at Chapel Hill at the time and a group of us decided to drive to Raleigh on that Sunday afternoon especially to hear 'The Messiah.' We were in Memorial Auditorium most of the afternoon and there was no interruption at all. We didn't hear about it until the performance was concluded and we went out on the street."

# Reviewer Directs Sharp Remarks At Noisy Behavior Of Audience

Planners like to hear other pianists. So it was a genuine pleasure to have the current Concert Series open with so competent performer as Gary Graffman, and judging from the applause, the rest of the audience enjoyed the concert with equal enthusiasm. As a matter of fact, the rather small but appreciative audience came close to giving the artist something of an ovation.

Notwithstanding, it was certainly a noisy audience, and this sort of thing is not only disrespectful to the artist, but to the devoted listener, and is entirely unnecessary. Why there can be such a silence during the likes of a band performance and such disturbing unrest during a solo performance is something for which there is no immediate answer. But there is no need for seats to drop, purses to loudly snap shut, items to fall to the floor, and audible conversation to be carried on. And most important, it is completely unforgivable and utter disregard of concert etiquette for listeners to begin their exit before the house-

lights go on, or to continue their exit when the artist is obviously waiting to play an encore. A few years ago Oscar Levant gave from the same stage the counterpart of these remarks. Mr. Graffman, however, was too much the gentleman to do a repeat; but he couldn't help but be genuinely insulted by such inattentiveness. One of the possible reasons why top-name artists are not engaged for local performance is because it would be sacrilegious to subject them to such indignities. Let's not let Greenville get the reputation of some cities in which certain artists refuse to appear because of disrespectful audiences.

But now to a pleasanter subject—the terrific recital. Mr. Graffman, who was trained at Curtis Institute under the great Mme. Venigova, is one of the most consummate of the younger pianists. He has a technique which is nothing but fabulous. But above this, he is a musician to the core. He knows how to deal competently with every selection; he has insight, introspection, and a genuine understanding of what music is about. He knows how to shape a phrase and how to give it movement. His playing is clean, yet soulful; it can be restrained, or broad, big and almost symphonic, yet at no time harshly percussive, or loud for the mere sake of volume. Tone is his first consideration, form is his second, and impeccable articulation following closely by the side. Actually, in his playing, there is no separating these three.

His program which appealed at least to the trained listener, was of the heavier type, containing no less than two sonatas, plus the magnificent Wanderer Fantasy by Schubert, which is virtually a sonata in every aspect except name. A definitive reading of the G Major Sonata of Haydn opened the program. Here was Haydn as it should be played, imbued with the virility which kept it from being confused with Mozart. There was excellent contrast in dynamics, touch, and tone. There was outstanding balance between the hands; and the most minute attention to the smallest details were practically uncanny. The two Brahms Inter-

mezzi from Opus 117 which followed seemed to be woven rather than played, and as they unfolded, the innermost Brahms emerged.

Concluding the first half of the concert was the piece-de-resistance: the Wanderer Fantasy of Schubert. This magnificent work, so broad in scope and so demanding of the performer is unquestionably one of the truly great pieces in piano literature, and in the hands of so capable an artist last night's performance was certainly a memorable one. His technique and tone were flawless, and only the slightest unevenness in the left hand during a small passage of the second movement prevented the rendition from being wholly commendable.

Following intermission, another gigantic work was set forth in equally notable manner—Schumann's dramatic Sonata in G Minor. They myriad of technical and musical problems was grasped firmly, to the result that here again was playing never to be forgotten. The soulful second movement was the epitome of Schumann's romanticism: tender, pleading, but never apologetic.

Rachmaninoff's "Elegie" would have come across better had the piano been a more responsive instrument. (Mr. G. G. fman is but another of those who have found that instrument objectionable), but even with this drawback, it was at the same time a melodic and climactic rendition.

Two treacherous Liszt Caprices after Paganini closed the printed program. The first in E flat Major was a marvel of cascading scales, thunderous octaves, and sparkling dexterity, and the familiar "La Campanella" emerged in all its brilliancy.

Most pianists place the G Minor Ballade by Chopin in the main body of a recital, but Mr. Graffman chose it as his first encore. Technically and tonally, it was overwhelming. Some may feel it was a bit too heavy, but this work is not the salon-type of Chopin, but rather the concert-hall variety, and therefore the artist seems justified in giving to it the density he did. The sheer ecstasy of the G-sharp minor Prelude by Rachmaninoff was present in Mr. Graffman's hands, but it was lost to the audience because of the audible rumble of concert goers who couldn't restrain their exit or their chatter long enough to hear it.

Mr. Graffman's performance certainly sets a high-water mark for visiting pianists. Few in the past have equalled it, and few in the future will surpass it.

Not that we want to blow our own horn—but if we won't, who will—but some very nice things were said about English and the study of Literature in last Sunday's Education Section of the N. Y. Times which we would like to bring to your attention.

In a survey of 13,586 college graduates employed by the General Electric Company in both technical and non-technical jobs, there were these questions, and their answers:

1. "What areas of college study have contributed most to your present position of responsibility with the GE Company?" The big majority of the non-technicians answered that the most valuable and helpful subject was English communication, both written and spoken. The engineers listed English second only to math.

2. "What areas of college study have contributed most to your use of leisure time?" Practically all answers claimed that English literature—and literature courses in college—had contributed to the ability to relax and to develop non-business thinking.

3. "What specific areas of study would you recommend to a young high school graduate entering college who aspires to a position of business responsibility?" The four areas listed by engineers and non-engineers were science, the Humanities, social science and business. And for specific course work, most of the graduates listed English communication and expression first, followed by economics and math and engineering or business. Many comments also pointed out the need for a more balanced program in college than is usually offered, with less specialization in a major field. . . . Need we, to coin a phrase say more?

The book critics are pointing in all directions these days at their choices for the best books to give for Christmas, and we will not presume to compete with them, except to suggest two books on our desk now.

"Ride With the Sun," plugged here last week, a collection of folk tales and stories from all countries of the United Nations, put out by the U. N. Woman's Guild and available in order from your local book emporium; and "Stories to Remember," a selection of short novels and stories put together by Thomas B. Costain and John Beecroft.

Today's Review

STORIES TO REMEMBER. A selection by Thomas B. Costain and John Beecroft. Garden City, N. Y.: Doubleday & Co., 1956. 2 vols.

The Literary Guild people, who have chosen this as the December offering, might have suggested "Unforgettable Stories" as a title that would be just as appropriate. What looks like an ordinary collection of bedside sleep-inducers turns out to be, on close inspection, a first class array of the kind of literary creations that truly are of the unforgettable variety. You have here everything from ghost yarns to mysteries to love, in lengths and types to suit every taste and circumstance. There also are little known pieces by famous authors that are valuable additions to any library simply because they're hard to get in other available editions.

For example, I never came across Somerset Maugham's "Lord Montandrago" in any other anthology. In fact, I'd never seen or heard of it before. It's a real thriller, about two men who keep dreaming the same things about one another—uncanny, fascinating—and completely unforgettable. "The Story of the Late Mr. Elvisham" by H. G. Wells is another comparatively unknown story, also spooky, also unforgettable, by a very well known writer. And all of the choices aren't of the grim and grisly kind, either. There are some delightful shorts by Jessamyn West from her book "The Friendly Persuasion," about the funny side of Quaker life, there's "The Legend of Sleepy Hollow" for oldtime humor, and there's a wonderful touch of oldworld laughter in "The Pope's Mule," by Alphonse Daudet.

"Stories to Remember" actually runs an extraordinary gauntlet of top quality offerings from the works of some of the best story writers the western world has ever known. When you get, in addition to those already mentioned, people writing for you like Rudyard Kipling, O. Henry, Charles Dickens, Honore de Balzac, Edgar Allan Poe, MacKinlay Kantor, Thornton Wilder, Edith Wharton, Hans Christian Anderson and Guy de Maupassant—among others—then you really have a book that's worth

# Governor Helps Safety Program

Gov. Hodges' endorsement of the 1957 legislative program proposed by the Department of Motor Vehicles adds strength to the proposals and boosts chances of the program's favorable consideration by the General Assembly.

Heading the list of requests for a better highway safety program which North Carolina sorely needs are proposals to allow chemical tests for those accused of driving drunk, the addition of 100 new men to the Highway Patrol, and a motor vehicles inspection law. Each of these requests, if allowed by the General Assembly, will go along way toward making highways of the state safer. Each will have some opposition, but the merits of these programs far outway any disadvantages they might have.

The Highway Patrol of the state finds itself hard pressed to stretch its now limited personnel over the thousands of miles of highway in North Carolina. As a result, each patrolman has many more miles of roads than he can effectively patrol. For every speeder, careless driver and drunken driver who is apprehended by a patrolman before he is involved in an accident, there are others which are not apprehended and become part of the mounting traffic toll in the state.

With an annual increase in the number of miles of highway to be patrolled, compounded by the in-

creasing number of vehicles on the road each year, it is imperative that the number of patrolmen be increased if they are to cope with the growing problem.

In states now using chemical tests to determine whether or not a driver is intoxicated, the means has been found much more effective in coping with the drunken driving problem than other methods have been alone. If North Carolina is to have the caliber highway safety program it needs in the face of rising traffic tolls, it must incorporate wherever practical the most advanced methods available. It would be amiss for the state to pass over the chemical test program which has proved so effective in other states for coping with drunken drivers.

As for the motor vehicles inspection program, there is still a bad taste lingering from the unfortunate program the state had for two years. It will be difficult even now to convince the people of North Carolina that the new vehicles inspection program is both practical and worthwhile. Yet, it is clear that some sort of program is needed to assure insofar as possible that vehicles on the highways are mechanically safe.

Members of the General Assembly should carefully consider the new vehicles inspection program which is proposed. They should consider it in the light of the percentages of accidents in which vehicles with mechanical defects are involved. With an open minded approach to the matter, we are confident the legislators can pass a practical program which will be acceptable to the people of the state and at the same time contribute in no small measure to greater safety of North Carolina's highways.

NEW YORK (AP) — The girl who wears the pants at the Metropolitan Opera is Mildred Miller, a young singer with a double attraction. She not only is gifted with a fine mezzo-soprano voice. Nature also endowed her with a pair of trim limbs as graceful as those on most Hollywood cheesecake stars. Because she has "the most beautiful legs at the Met," pretty Miss Miller—who happens to be married to an Air Force major and is the mother of two children—gets most of the young boy roles in opera here. "I enjoy singing them," she said. "But at least once a year I like to sing a woman's part, and I tell the management, 'Please, let me show my versatility.'"

Eight years after she left high school Miss Miller was singing at the Met. In addition to 15 to 25 opera appearances, she gives 30 to 40 concerts and sings half a dozen or more times a year on radio and TV programs.

## New Dept. Would Tighten His Control

ADMINISTRATION — Creation of a new Department of Administration as recommended by the Commission on Reorganization of State Government, would serve to give the Governor more direct control over major governmental activities and policies, and at the same time relieve him of much detail minutiae which now clutter his desk. The new department would consolidate under its wing the functions performed by the relatively independent budgeting and accounting agencies, and those dealing with the purchase and disposition of property—both real and personal, as well as a new division of management analysis. The department would be headed by a Director of Administration appointed by and directly responsible to the Governor. The director in turn would name the division heads, with approval of the Governor. Instead of half a dozen agency heads reporting directly to the Governor, he would deal only with the department head who would be in effect the housekeeper for the whole State government. There are some exemptions. The collection of revenue would remain the responsibility of a separate department, and the Personnel Department would remain independent, with perhaps some slight increase in budget control. Although integrated as a division of the new department, functions of the Budget Bureau, with the Governor as Director of the Budget, and of the Advisory Commission would continue essentially as at present. The budget commission would continue preparation of the biennial operating budget, and a new division of long range planning will be charged with preparing capital investment budgets six to ten years in advance. At present there is no general budgeting of building requirements. The reorganization commission released three reports this week. One deals with Fiscal Information, another with Property Management. Recommendations in these reports tie in closely with the proposed Administration Department. The idea of a legislative comptroller, which gained large early support in last session, but failed of final approval, was vetoed. Instead, it is recommended that the budget bureau continue and expand the policy of preparing program or performance budgets for State agencies, departments, and institutions. It is further proposed that the budget bureau, whether or not it remains inde-

pendent or is brought into the new department, employ skilled personnel to conduct periodic reviews of the operation of government agencies, with a view to continuing improvement in efficiency. PROPERTY MANAGEMENT There are twelve specific recommendations in the field of property management. The total effect will be to place responsibility for establishing and maintaining an inventory of State-owned lands, the acquisition of needed real estate and the disposition of lands not needed by the state, in one agency. That agency would work closely with the long range planners and the several institutions which will use the property in determining such needs. Prospective users of buildings will be asked to make requisition in terms of space and facilities needed, rather than in terms of dollars. All State-owned lands would be put into one general pot, with the property management division given authority to allocate to the several agencies on basis of use-need. The division also would be responsible for general utilization of lands in the growing and sale of timber, in co-operation with the forestry division of the Department of Conservation and Development. CO-ORDINATION — There will be criticism of the commission's proposal to establish a new State department, rather than to abolish some existing agencies. Effectuation of the proposals will result in consolidating under one administrative chief many of the presently independent functional agencies, some of them small. Instead of every department and institution preparing its own capital budget, there will be one overall long range building program. Accounting will be concentrated, and all State-owned lands will be used for the greater benefit of all the people of the state, instead of various separate agencies engaging in competition for their own special advantage. I may be expected that certain agencies will resist the plan to deprive them of particular control over real estate. There has grown up an attitude among officials that this or that land belongs to "us" while perhaps neighboring land belongs to the State. The reorganization commission will have several other reports embodying additional recommendations for change. Implications in the three first reports released is that the new Department of Administration will be the heart of any reorganization program.

## Fresh Determination With Each December 7

Fifteen years ago today America stood stunned and almost paralyzed by the sneak attack on Pearl Harbor which, as we later learned, left Asia, the broad Pacific and our own western shores bare to any attack Japanese warlords may have chosen to make. That day is far behind us now. Out of the chaos the great American people on battlefields and in the factories, brought victory and freedom to millions of people throughout the world. It was, we thought, a war to end wars. It was a war to end tyranny and enslavement. It was a war to rid the world of its iron fisted dictators who cared nothing for the rights of men.

Today those evils still beset the world. They still threaten free people everywhere. But out of Pearl Harbor we learned a bitter lesson . . . and so did the foes of freedom. For all the tension and strife which hangs today over the world, freedom is much more secure than it was on December 7, 1941. The words Pearl Harbor and the date December 7, represent in the minds of the American people a summation of all the hardship and strife, death and grief which was paid for freedom upon the beaches of Normandy, Iwo Jima and a thousand other dots across the face of the earth. Each year it brings renewed determination that a similar disaster shall not overtake the world. Each year it brings to greater realization that freedom is not only won but preserved on the installment plan; and that the installments have no end.

## Effects Demonstrated By Just One Industry

DuPont's huge Dacron plant next door to Pitt in Lenoir County has been here for several years now and its economic importance to Pitt and other counties in addition to Lenoir is generally recognized. To Kinston, Grifton, Ayden and Greenville it has brought many new people who have made their homes in our midst and have made outstanding contributions to every phase of community life. In addition, the presence of the plant has provided new year-round jobs for hundreds upon hundreds of people who live in the area before the plant became a reality. Even with all this in mind, we were surprised at the figures recently released on the total amount spent for payroll and local purchases by the plant during the past year. The information released by Plant Manager W. E. Gladding shows the plant paid out a total of \$10,666,000 in wages and salaries to its employees and for purchases from business firms in this area. While that figure is significant in itself, its significance comes more sharply into focus when it is compared with the old standby of agricultural income upon which this entire area has depended for the most part for decades. The amount of money put into circulation in this area by this one industrial plant last year is equal to somewhere between 25 and 30 per cent of the total income from 11 principal agricultural crops produced in Pitt County. Considered in the light of farm income in Lenoir County, the payroll and local purchases of the DuPont plant are equal to almost one-half the total value of the 11 principal agricultural crops produced in Lenoir. From the figures provided by this one industry alone, it is readily seen what industry can do to supplement the income of an agricultural area, and to raise the economy for the area and all its people.

## Other Editors Are Saying . . . Missing, Maybe Permanently

No fewer than 26 mammals, the International Union for the Protection of Nature has announced in Scotland, are threatened with extinction today. The Survival Service of that group, formed to help preserve species in danger of becoming extinct, has listed their names, and a colorful array of beasts they are: The Asiatic lion, the Tasmanian wolf, the Javan one-horned rhinoceros, the Nubian wild ass are among them. So are the Przewalski wild horse, the Persian wild ass, the Caribbean and the Hawaiian monk seals, the Suleiman markhor. The Addo bush elephant is endangered, so are chinchillas, all species, and the black-footed ferret. And so on: big and little mammals are alike imperiled. It is to be hoped that the IPUN, or as it will henceforth be known, the IUCN (International Union for the Conservation of Nature and Natural Resources), will meet with success; its drive to save the vanishing mammals. What, after all, would life be without the Nubian wild ass and the Addo bush elephant? But while the gentlemen are at it, attention may well be directed to several additional vanishing species whose increasing scarcity threatens to imperil us all. 1. The Double-breasted Seesucker. We have three of these in the closet, but so few of them are seen about today that they are likely to stay there. 2. The rockribbed Constitutionalist. There hasn't been one seen in Washington in years. 3. The 400-hitting Outfielder. Utterly vanished; has left no trace whatsoever. 4. The Good Five-cent Cheroot. Always a scarce fellow; now practically non-existent. Many imitations are available, but upon closer inspection they turn out to be baleful beat known as the Ropp Hempo. 5. The Summer Rainbird. Frequently rumored on the way, but seldom shows up any more. 6. The Great Ward Heeler. Vanished amid a cloud of Good Intentions. Absence particularly noticeable when trucks take over a residential thoroughfare. 7. The Well-Red Citizen. Cannot live for long in areas containing television antennae. Increasingly scarce now. 8. The Jolly Roisterer. Disappeared in early 1920's; failed to reappear in 1928's; failed to reappear in 1938's; failed to reappear in 1948's; failed to reappear in 1956's. Disappearance believed connected with that of Great Ward Heeler.

## Geographical Battle For GOP Ranks

WASHINGTON—A geographical battle for legislative power has broken out among the Republicans in House and Senate, matching the North-South conflict among the Democrats in Congress. In the GOP ranks, however, it is a struggle between the increasingly important Far West, mainly California, and Eastern stalwarts. The surprising defeat of Representative Harris Ellsworth, Republican from Oregon, has left the coastal region without any member of the all-powerful House Rules Committee. It is this group which has the final voice on what legislative measures may be considered by the House itself, and every section feels it essential to have representation on this club within a club. With Ellsworth's departure, the only Republican spokesman for people and interests beyond the Mississippi is Representative J. Edgar Chenoweth of Colorado. But the Far Westerners point out that a man for the so-called "mountain states" cannot be expected or counted on to champion their viewpoint. HOUSE RULES COMMITTEE VACANCY The Easterners aim to fill the Ellsworth vacancy on the House Rules Committee with Representative Hugh Scott of Pennsylvania, who has many claims on the position. He formerly served on Rules, and in 1948 he was Chairman of the Republican National Committee the last time Thomas E. Dewey ran for President. He is known as a "Dewey man," pro-Eisenhower and a moderate liberal. California's entries are Representative Edgar W. Hestand and Representative James B. Utt. Besides the need for giving representation to the West, their supporters note the growing political power and importance of the West. WEST OR EAST California, for instance, may gain three additional seats in the House and in the Electoral College after the 1960 census, in view of its gains in population. Oregon and Washington may also be entitled to more places in both bodies. Representative Scott's state of Pennsylvania may lose a few votes in the House and in the electoral chamber. But Scott's advocates maintain that California has already been given all the recognition it deserves, and that the geographical balance of power has been upset. They refer, of course, to the fact that three Californians now occupy top positions—namely, Vice President Richard M. Nixon, Senate Minority Leader William F. Knowland and Chief Justice Earl Warren. There is the further fact that any one of this trio, not excepting Chief Justice Warren, may become the Republican candidate for President in 1960. CLASH INVOLVES RACIAL ISSUES The East-West clash also involves the racial issues which trouble the Democrats. California Republicans believe that they can advance their region's interests by teaming up with Southern Democrats, for both groups are generally conservative. Moreover, the Chairman and the real boss of the House Rules Committee is J. Howard Smith of Virginia, an unreconstructed De-

## Mere Ideas Are Worth Nothing

A reader writes: "I have a wonderful idea, as you can see from the enclosed description. What is it worth?"

It is worth absolutely nothing. I haven't read the description. No idea by itself is worth anything.

Remember the old stumper: "If a tree falls in the midst of a deserted forest, does it make a sound?" The answer, of course, depends on your definition of sound. If you consider sound to be waves of a certain length, then the tree makes a sound. But if you define sound as the effect of such waves on the ear, there was no sound when the tree fell.

So it is with an idea. An idea is only a set of brain waves until someone does something about it.

A START, AT LEAST  
My correspondent's idea may have some slight value because he has started to do something. He has set it down on paper and he has asked somebody—me—about it.

But to be worth more than the value of two sheets of paper and a stamp, an idea must be: 1. Crystallized.

2. Projected.

3. Merchandised.

Perhaps "crystallize" isn't the precise word. It's not broad enough. But the first step should be analysis of the idea, elimination of bugs, research to determine if it is unique and general perfection of the idea. Without this, it isn't worth much.

Protecting the idea involves getting a patent on it if patentable, copyrighting it if copyrightable, and taking other steps to prove origination. These should be taken with the aid of an attorney.

The idea is still not worth much. Real value comes with merchandising, which may involve the making of a product and selling it, or the sale or lease of the idea to others. It is only when someone says, "I'll give you yuppence for one of those" or "I'll give sixpence for the right to use that idea," that an idea has any real value.

### HOW TO MARKET AN IDEA

When an idea can be patented or copyrighted, the creator is protected and he can advertise if for sale or take other steps to bring revenue in such cases. Ideas cannot be so protected. They can still be sold.

A good first step is to slash away a roof of origin; an attorney can tell you the best way, which will vary according to the nature of the idea. A good second step is to compile a list of companies that might be interested in exploiting the idea. Then write to each one, asking if they would be interested. They will probably send you a form in which you must promise not to sue them in case they already have the idea or obtain it from another source. Show the form to your attorney before signing and if he says ok . . . send the form and the idea. Major corporations are strict honest in such cases. They won't be. They need new ideas and if their conduct is suspect they won't be offered many.

Suppose somebody is interested. What, then, is the idea worth? It's worth all you can get for it. That's probably less than you think.

Suppose you dream up a gadget that will net \$100,000 a year. Should you get two-thirds? Half? Probably very much less. You are risking time and an idea. The buyer must risk time and vast amount of money in dies, machinery, selling, advertising, rent and management. A quarter would be a fat return, a tenth probably above average.

Suppose you have an idea that will save a corporation \$100,000 a year. Shouldn't you get half? No, because the chances are that the company will stumble on or evolve a similar or even better saving in a short time. Be firm, hire a good attorney—but take what you can get.

"There is therefore no condemnation to them that are in Christ Jesus, who walk not after the flesh, but after the Spirit."

SHOWING HOW THE HOLY SPIRIT HELPS TO FREE US FROM SIN

Scripture—Romans 8.

I FEAR that this lesson is going to be a somewhat difficult one to interpret to young children. The older ones will gain much in studying Paul's words to the Romans and applying his teachings to their own personal lives.

Dr. Wilbur Smith, editor of the Sunday School Notes suggests that the teacher might tell of an experience of his, when he was taken by a friend to visit a man of wealth who lived in a house that had not been painted or repaired for years; whose garden had not been tended, fruit trees were uncared for, fine furniture was unused, beautiful books had been put away and never read, and the man himself, past 80 years of age, was living frugally though his wealth totalled \$2 million!

He had been liberal in giving to the Christian cause, but how much more good would he have done if he had made his home a comfortable place for himself to

Jesus. The example set by Christ when He was on earth will help us. Just think, "What would Jesus do?" when we are about to utter a falsehood, say something cruel about another, pick a quarrel, or do any one of the unkind things that we all do occasionally, and we will not give way to these temptations. Paul wrote to the Romans that, "There is no condemnation to them which are in Christ Jesus, who walk not after the flesh, but after the Spirit. For the law of the Spirit of life in Christ Jesus hath made me free from the law of sin and death."

True sons of God are led by the Holy Spirit. You will remember that this Spirit led Christ into the wilderness; this same Spirit led Andrew to bring his brother Simon to Jesus. If we are led by this same Holy Spirit, we too may become true sons of the Father, God, and temptations will not be allowed to make us fall into sin. "Likewise the Spirit also helpeth our infirmities; for we know

# Reorganization Commission Urges Fiscal Activities Be Centralized

RALEIGH (AP)—The Commission on Reorganization of State Government has proposed that "all new state department of administration"

Gov. Hodges released the commission's report containing the proposal at a news conference yesterday. Hodges said he was "generally in favor" of the recommendations, although "that doesn't mean I'm wedded to every word."

Creation of a department of administration would not result in substantial savings immediately, but might save in the long run by stopping "further overlapping" in functions of state agencies, he said.

The report was the first of three to be released by the reorganization commission, headed by Rep. David Clark of Lincoln.

The new department of administration would combine the present Budget Bureau and the Division of Purchase and Contract, plus some functions of the Board of Buildings and Grounds and other functions scattered over numerous agencies.

The governor would appoint the head of the department and fix his salary. Under the director would be six division heads, appointed with the governor's approval.

A division of property control and disposition would keep inventory of state buildings and land and have the duty of assigning this property to various state agencies.

The reorganization commission pointed out that the state now owns 260,000 acres of forest lands plus 10,000 acres of sparsely wooded bay lands.

## Cold Air Mass Is Over Rockies

DENVER (AP)—Anchored by its own moisture, a wall of cold moved sluggishly along the Rocky Mountains and over the plains early today.

Temperatures shrank to 25 below zero at some mountain points. Up to 15 inches of snow was reported in spots, none in others.

Two members of a Hartville, Wyo., family were killed and two others injured critically when their car struck a skidding snowplow north of Cheyenne. At Cut Bank, Mont., near the Canadian border, a motorist was rescued after being snowbound in his car for 40 hours.

Despite temperatures of 30 below, he suffered only frostbitten fingers. The weatherman promised little in the way of a warming trend today.

Although heavy at Rawlins and Laramie, Wyo., and in some mountain passes, the snow was not expected to bring much relief in the prolonged drought for the mountain states.

Hardest hit by the massive cold front was Montana. At midnight only two points in the state reported above - zero readings. Havre and Cut Bank had 25-below readings. The state capital, Helena, logged 19 below.





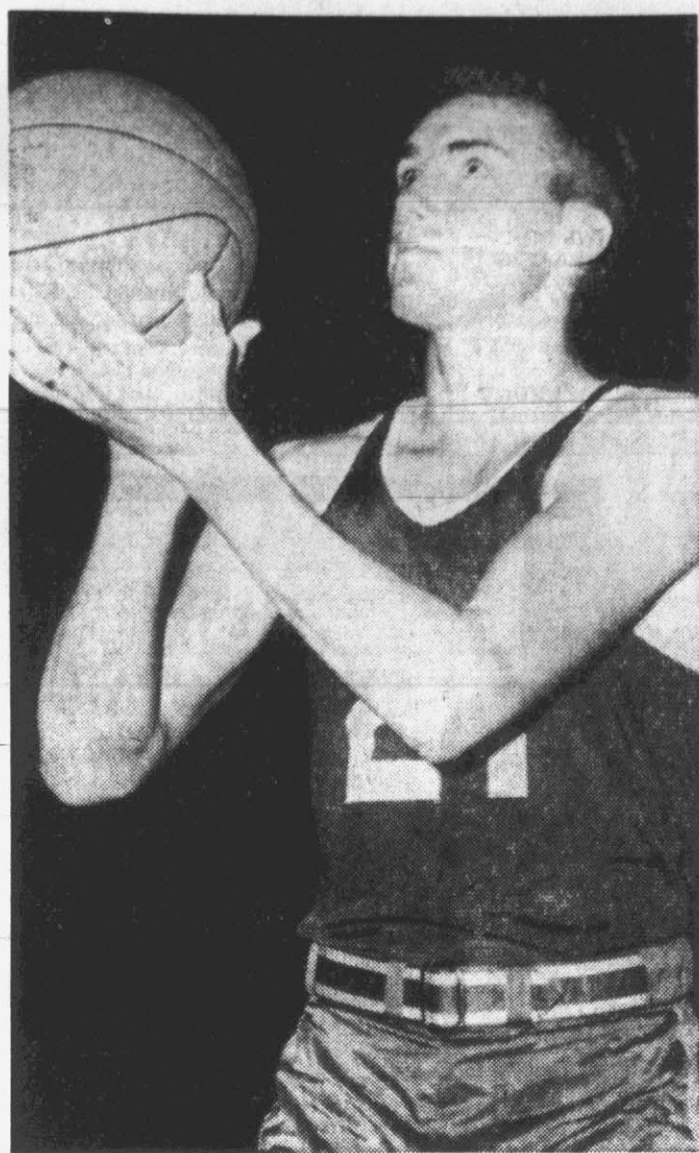

Sooners Place Two On AP All-America

By BOB HOOBING NEW YORK (AP)—Oklahoma halfback Tommy McDonald is the lone holdover on the 1956 Associated Press All-America football team announced today. Center Jerry Tubbs of the national champion Sooners is also included on the squad chosen on the recommendations of regional boards blanketing the nation and based on all college games through Dec. 1. Johnny Majors, the 162-pound tailback who led Tennessee to an unbeaten, untied season, rugged Jimmy Brown of Syracuse and Don Bosseler, Miami's wonder man, complete the backfield.

In addition to Tubbs, the line includes Ron Kramer of Michigan and Joe Walton of Pittsburgh at ends, Alex Karras of Iowa and John Witte of Oregon State at tackles with Bill Glass of Baylor and Jim Parker of Ohio State at guards. Certificates will be presented to all members of the first three teams. Great performers like Michigan State's Clarence Peaks and Southern California's Jon Arnett were withheld from consideration because of their limited half-season service. Six of the players — Kramer, Brown, Parker, Bosseler, Tubbs

and Glass — were picked in the first round of the recent professional football draft. Notre Dame's Paul Hornung, the bonus choice in the National Football League, is in the second backfield. For the second successive year, McDonald has been the chief exciter of Oklahoma's "bread and butter" play — the split-T option pitchout with Tommy capitalizing on the defense to either sweep the end or call on his pinpoint passing ability. In helping the Sooners run their victory string to 40, McDonald rushed 83 yards in 119 carries, scored 102 points, completed 8 of

12 passes for 183 yards, caught 4 scoring passes and was strong on defense. Majors completed 36 of 59 passes for 532 yards, rushed 549, averaged 43 yards punting and called signals. Brown, the light-footed 212-pounder who could run over on the sidelines with equal ease, rushed 986 yards, scored 106 points, was a top pass receiver and could throw as well. His 43 points against Colgate was a modern record against major opposition. Bosseler is rated the equal of Don Blanchard by Coach Andy

Walton, son of former Pitt tackle Frank (Tiger) Walton, hauled in six touchdown passes, including the ones which beat Syracuse, Oregon State, Duke. Witte had the stamina for 55-56 minutes a game and the skill to block and tackle Oregon State to its first Pacific Coast Conference championship since 1941. He will be opposed in the Rose Bowl by Karras who is the tower of strength for the Hawkeyes as the middle man in the defensive line. Glass averaged 16 tackles per game and blocked Baylor backs to an average gain of four yards throughout a rugged Southwest Conference campaign. Parker, at 232 pounds, had speed and agility, played 48 1/2 of a possible 540 minutes. Tubbs was consistently outstanding as a linebacker, pass defender and blocker. Against Iowa State he raced 78 yards to score on an interception.

Diver Again Has A Double Victory

By TED SMITS MELBOURNE (AP)—Mrs. Pat McCormick scored an unprecedented Olympic diving "double" tonight when she led a 1-2-3 American sweep in the platform dive after Murray Rose and Lorraine Crapp, two Australian teen-agers dominated the final night's swimming races. Mrs. McCormick, who won both the springboard and platform dive crowns at Helsinki in 1952, repeated her double victory. Mrs. Juno Stover Irwin of Glendale, Calif., was second and Paula Jean Myers, a Southern California coed from Glendora, Calif., was third. The best Uncle Sam's men and women swimmers could do was third place in the final races as

Rose took the men's 1,500-meter free style and Miss Crapp grabbed the women's 400-meter free style record time. Despite the diving sweep and the brilliant performance by Mrs. McCormick, a Lakewood, Calif., housewife and mother, the United States could make little inroad into Russia's bulking point total. The Russians already had clinched the unofficial championship with a great demonstration of strength in gymnastics and wrestling. All that remained on the Olympic program was tomorrow's final soccer games, in which Russia is a finalist, and the closing ceremonies.

While the athletes were competing before another sellout crowd of 5,500 in the Olympic pool, several members of the Hungarian team were making the fatal decision between returning to their revolution-torn homeland or seeking asylum in Australia or America. There were empty seats in the first plane as 83 Hungarians left for Milan on the first leg of their trip. Russia's lead was clipped some 13 points due to the U.S. diving sweep but it still was massive. Unofficial figures showed Russia with 712 points and the United States with 593. Russia led in gold medals 36-32.

However, Father Joyce recalled that Knute Rockne enjoyed his greatest seasons in 1929 and 1930 after his Irish had a poor year in 1928. Joseph I. O'Neill Jr., national president of the Notre Dame Alumni Assn., said that he was proud that there is "no talk of 'Let's fire the coach' and at Notre Dame we have no hanging effigy."

Light Heavies In Tonight's Bout At The Garden

NEW YORK (AP)—After watching Archie Moore's performance in his futile bid for the heavyweight title, his challengers in the light-heavyweight class have taken new heart. Two men who hope to earn a shot at Archie's 175-pound title meet tonight at Madison Square Garden in a match between Tony Anthony of New York and Gordon Wallace of Toronto. The 10-round bout will be carried on network (NBC) radio and television at 10 p.m. EST with two judges and a referee scoring by rounds. Anthony doesn't often leave matters up to the judges. He either wins or loses by a knockout. His 23-4 record for 32 fights includes 21 knockout victories. He has been stopped four times. "What'll you have?" Casson asked. "I think a whisky, thank you," Perry replied. "I feel rather poor."

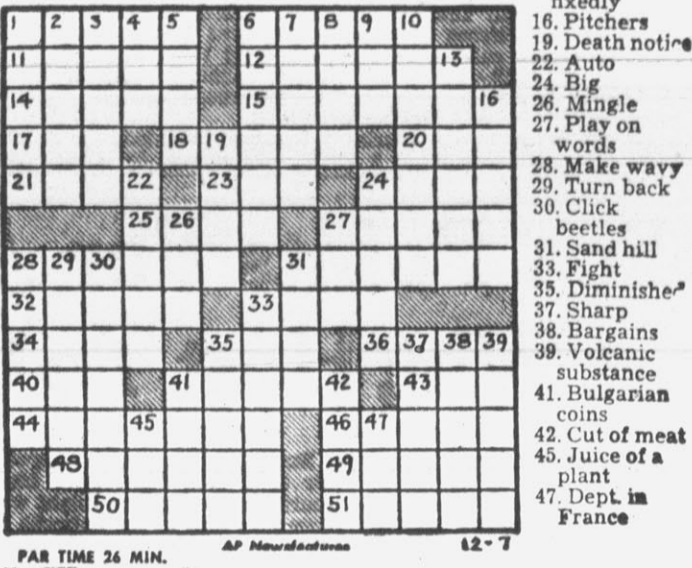

"I found out about it when I went home to our little three-room apartment," he declares. "It was the first thing I heard when I turned on the radio."

E. L. Kilpatrick, sanitarian at the Pitt County Health Department, was a 15-year-old boy in 1941 when he heard the news about the attack. "I was walking into a drug store one block from my home in Kinston. And I recall thinking they'd never get me into the Army because I was so young."

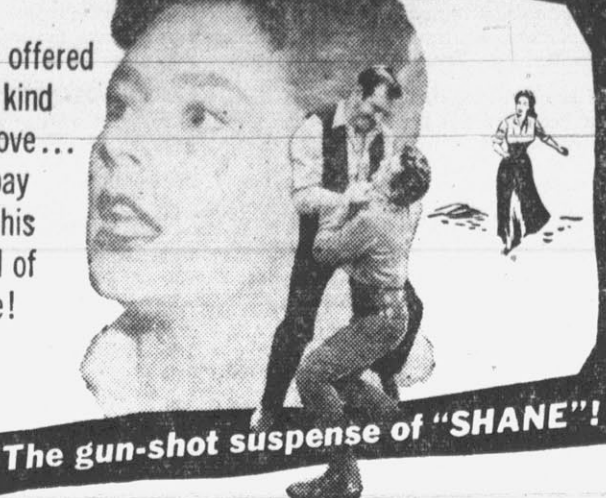
Dr. Walter C. Humbert, Pitt County Health Director was already in service when the attack

came. "I was on duty at the station hospital at Camp Livingston, La., when the news came that Sunday afternoon. I had been on active duty for 13 months and seven days as a captain and was attending surgeon at the hospital, chief medical examining officer and chief medical review board at Camp Livingston. On the day of the attack the 32nd National Guard Division from Michigan and Wisconsin was training with V Corps Artillery at Camp Livingston."

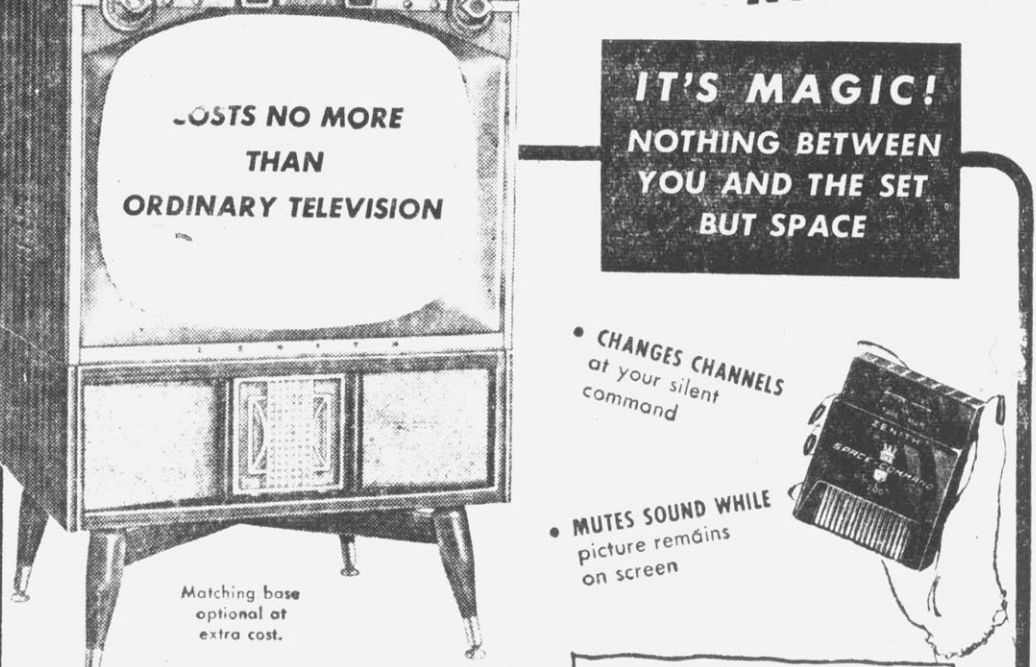

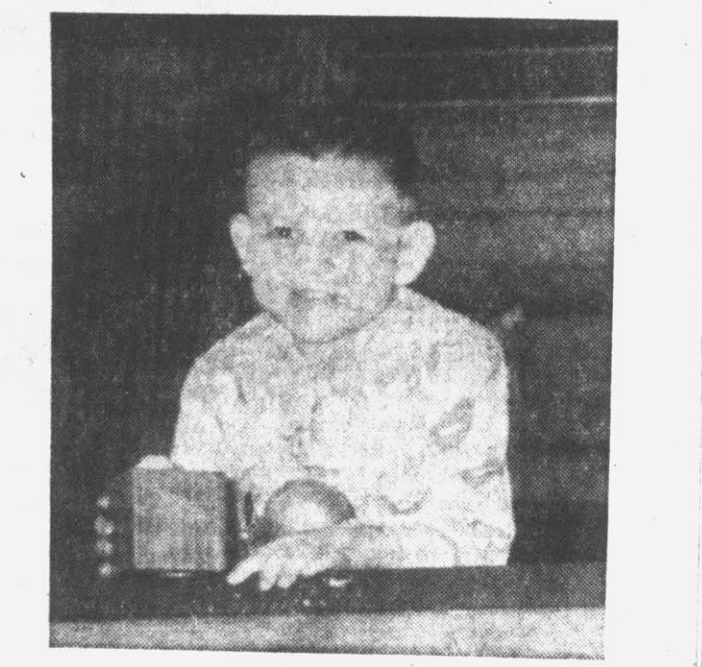
