Group Believes Pitt Is Missing Million Dollars In Social Security

Committee Will Contact Men And Women Over 65 At Tax-Listing Time

A special committee appointed by the County Board of Commissioners believes it can add \$1 million to Pitt citizens' income by contacting men and women over 65 years of age through county tax-listings for Social Security purposes.

Chairman of the committee Sam C. Winchester said that volunteer workers will be stationed at tax listing places in Greenville, Aiden and Farmville during the listing period.

Volunteers will also work at other listing places during the rush periods. At other times listers themselves will be asked to obtain the information.

Winchester said there are many persons in the county who are eligible for Social Security payments but who are not receiving them.

"We find them every day and we know there are a lot we aren't finding," he declared.

"We feel that there are enough people eligible to give the county an additional income of at least \$1 million."

Winchester pointed out that farm people were taken under Social Security only last year. A farm employee or farm operator 65 years of age or older would only have to file his income tax for 1955 and 1956 and make Social Security payments for those two years to be eligible to begin receiving an income from Social Security.

He noted that a relatively large number of persons involved will not have to pay any income tax. The Social Security tax which they pay for the two years will be based on net income. If the person is self-employed he will pay Social Security tax of 3 per cent. If he is an employee his tax will be 2 per cent of net income.

Winchester pointed out that the last 50 persons who had qualified for the payments had lost a total of \$60,000 because they had not qualified earlier.

Men and women 65 or older ought to make immediate application for Social Security benefits even while necessary forms for qualification are being processed, Winchester said.

A Social Security representative contacted at the local Employment office every Tuesday.

Serving on the committee with Winchester are Mrs. Lillie Little, K. T. Futrelle, Reginald Gray, and Harold Aldred. Also working with the committee is Mrs. Perry M. Evans of the Welfare Department.

NATO Told To Prepare For East German Revolt

PARIS (AP) — West Germany warned the North Atlantic Council today there is grave danger of East Germany following Hungary into rebellion against Moscow's domination—and NATO had better decide what to do if the revolt comes.

West German Foreign Minister Heinrich von Brentano sought the advice of the other 14 NATO partners as the foreign, defense and finance ministers of the alliance met for the second day of their annual session.

Von Brentano put this problem before the Allies: "Any revolt in East Germany would generate strong pressure among the West German public to rush some form of aid rather than stand by and see the lives of other Germans snuffed out."

Chancellor Konrad Adenauer's government would resist involvement from fear of inviting retaliation from the Russian army just across the East-West border.

The ministers met under the tightest security blackout ever seen at NATO headquarters. Delegation spokesmen, who had been ready to talk in the past, clamored up this time with two notable exceptions: the text of the opening speech by Italian Foreign Minister Gaetano Martino, chairman of the meeting, was distributed, and an extended abstract of Dulles' speech was circulated.

The rift between Britain and France and the United States over the Egyptian invasion appeared to be virtually patched as a result of private talks Dulles had with British Foreign Secretary Selwyn Lloyd and French Foreign Minister Christian Pineau before the council session got under way.

They conferred again last night. However, he warned that the matter is not settled as yet.

Subversion In East Europe Is Formally Charged U. S.

Soviet Union Lays Charge Before United Nations As Condemnation Of Kremlin Being Considered

UNITED NATIONS, N. Y. (AP) — The Soviet Union formally laid before the U. N. General Assembly today a complaint charging the United States with "subversive action" in the Soviet-dominated countries of Eastern Europe.

The move came as delegates to the 79-nation Assembly rallied behind an American-backed resolution condemning Russia for tampering in Hungarian affairs.

Specifically, the Soviet delegation proposed that the Assembly add to its agenda an item entitled: "Intervention by the United States of America in the domestic affairs of the peoples democracies and its subversive activity against those states."

Such charges had been made by the Russians in previous sessions of the Assembly and rejected as unfounded. Three more sponsors—Spain, Turkey and Colombia—threw their support behind the resolution to condemn Russia, bringing the total sponsorship to 20 countries.

The 20 sponsors met last night to discuss a companion resolution entered by India and her three closest Asian allies—Burma, Ceylon and Indonesia. The Asian proposal, this would be the actual condemnation of Russia. But U. S. Chief Delegate Henry Cabot Lodge Jr. told his cosponsors it was noteworthy in that it implied a strong rebuke.

Lodge was slated to take the floor late today to analyze the Asian proposal. It would have U. N. Secretary Dag Hammarskjold negotiate with both Hungary and Russia for withdrawal of Soviet troops from Hungary.

The Budapest regime already has ignored or rejected four previous Assembly resolutions calling for admission of U. N. observers and withdrawal of the Russian forces.

Informed sources said the 20 sponsors of the U. S. proposal agreed to drive for a quick vote on their own resolution and then to suggest a paragraph by paragraph ballot on the Indian proposal. This would leave the Assembly free to select whatever parts it wanted.

General resentment over Hungary's flouting of the Assembly took a sharp upturn after Foreign Minister Imre Horvath stalked out of the assembly yesterday, declaring "disgracefully offended" by U. N. fellow members. The anger mounted as three other Soviet satellites—Bulgaria, Albania and White Russia—chorused Moscow's claim that the United States and other Western powers had touched off the Hungarian revolt and were responsible for that country's present plight.

Putting Britain in favor of the 20-power resolution, Sir Pierson Dixon said the Assembly could not "admit that the Soviet Union has some special right to the bullying of small nations in Eastern Europe." He added he thought it was time the Assembly spelled out what it thought of the Soviet action in Hungary.

Railroads Seek Lower Rates For Leaf Shipments WASHINGTON (AP)—North Carolina railroads have asked the Interstate Commerce Commission (ICC) for permission to cut intrastate freight rates on some movement of tobacco within the state.

Cuts are necessary, the railroads said, to meet truck competition. Present intrastate rates were fixed by the ICC in 1954 to correct differences with interstate rates, making federal assent necessary.

The railroads said they want to match rates on other shipments within the state.

Farmers Discard Proposed Corn Control Program

WASHINGTON (AP)—Farmers' rejection of a new corn control program favored by Secretary of Agriculture Benson appeared today to have opened the door for a broad and politics-studded congressional review of federal farm programs.

In one of five separate crop referendums yesterday, corn growers in an designated commercial area voted in effect to stick with an old program authorized in 1938—even with its widely admitted shortcomings.

Some doubtless voted against the new Benson proposal on the basis of promises of Sen. Humphrey (D-Minn.), a sharp critic of the secretary, that he would sponsor new legislation next year to eliminate weaknesses of the old plan.

Four other referendums went as expected. Farmers voted to continue rigid federal marketing quotas on upland cotton, extra long staple cotton, rice and peanuts. The quotas are designed to help prevent production of surpluses.

Farm legislation this year produced some of the sharpest political skirmishing in Congress, with President Eisenhower vetoing one big Democratic bill.

The referendum produced 257,874 votes for the new proposal and 163,227 for the old one. This was a majority of 61.2 per cent for the new one, but a 66.7 per cent or two thirds majority was required under the law.

The rejected plan, called the soil bank case acreage program, would have allotted 51 million acres to corn farmers in the country in 1957, which presently comprises 894 million acres. Acres in 24 midwestern eastern

and southern states. The old one, referred to as the acreage allotment program, provides for apportionment of only 37,288,000 acres among the same farmers.

The new plan had been advanced because the old one, using a formula in the 1938 farm law, resulted in sharply reduced allotments and widespread overplanting and noncompliance.

The only penalty for failing to comply with allotments is loss of eligibility for price supports. Because many growers exceeded their allotments and thus became ineligible for price supports, the old program was widely regarded as ineffective in preventing overproduction and in stabilizing prices.

Benson had indicated clearly he favored the new plan, which Congress wrote into the soil bank law this year with his approval.

Their opposition was centered not on the larger allotment of the new plan, but on a provision that would have given the secretary of agriculture much greater leeway in setting price supports on corn after 1957.

Under the old plan which farmers voted to retain, corn must be supported between 75 and 90 per cent of parity. Under the new one, the rate would have ranged between 90 and 95 per cent. Parity is a standard for measuring farm prices declared to be fair to farmers in relation to their costs.

North Carolina corn growers voted 15,700 for the new corn program, 4,276 for the old program. They approved quotas of other crops by the following majorities: upland cotton 2,125 to 2,174; peanuts 7,839 to 388; rice 1 to 0.

More Violence In Poland Disclosed WARSAW (AP)—New antigovernment violence was reported in Poland today in the wake of the mob attack on the Soviet consulate at Stettin. Eighty-eight persons, many of them youths, were reported jailed for the Stettin riot.

Trybuna Ludu, official organ of the Polish United Workers (Communist) party, disclosed a crowd attacked a police building in Olecko, a town near the northern eastern city of Bialystok.

The Communist paper reported that crowds demolished municipal offices at Nowy Cieclocinek in the northern midlands.

Other demonstrators beat up a local Communist party secretary at Nieszawa, in the same district. The paper added: "More such incidents can be reported."

Poland's nationalistic Communist government, seeking to avert any repetition of the Soviet military intervention in Hungary, sped an apology to the Soviets for the attack on the Russian consulate in the suburb at Stettin (Szczecin) Monday night.

Newspapers which first played down the riots as drunken hooliganism reported that the demonstrators attacked police headquarters and the local prosecutor's office and tried to break open the jail.

These reports said the rioters were dispersed from the jail by security troops and police using tear gas.

The attack on the Soviet consulate followed two hours later. The demonstrators got inside the building and damaged furniture. The papers did not report what happened in the consulate staff.

Isolated Armed Clashes In Hungary's Massive Strike

VIENNA (AP) — A protest strike against Premier Janos Kadar's Soviet-imposed government went into its second day today in Hungary.

Word arrived in the West of many isolated clashes between striking workers and Russian soldiers. But so far there was no repetition of the bloodbath with which Soviet troops and tanks beat back the armed Hungarian revolt Nov. 4.

Kadar sent his security police and Soviet occupation troops to break up workers' demonstrations. The puppet Premier vowed that, having defeated his foes militarily, "we will also defeat them politically."

Soviet troops were reported moving to wipe out a band of guerrillas holding out in the hills north of Budapest. Informed Hungarian sources said the guerrillas were encircled but fighting to escape extinction.

The general strike, ordered to last until midnight tonight, brought industry and commerce almost to a standstill on its first day. A Yucoslav correspondent reported from Budapest that at least 80 per cent of Hungary's workers obeyed the cease work order from the outlawed Central Workers' Council. Other dispatches said the work stoppage was nearly 100 per cent effective in the provinces.

Moscow radio and Kadar's Budapest broadcasting station played down the effectiveness of the strike, called to protest the Kadar regime's dictatorial actions.

But in its next words Budapest radio pleaded for a return to normalcy.

The station quoted Kadar as saying each day of the general strike would cost the nation's economy 300 million forints (about 25 million dollars).

The broadcast said the Premier warned a workers' delegation that he would consolidate the Red Army's military victory over the Oct. 23 rebellion with complete defeat of political foes.

Despite martial law and the arrest of some labor leaders, workers stayed away from their jobs yesterday by the hundreds of thousands.

Power plants ran but most of Budapest's big factories were closed. The sound of cannon and machine-gun fire could be heard in the capital. It appeared to come from the vicinity of Gellert Hill, whose historic citadel the Red army is using as a base for tanks and artillery.

The Pitt County Grand Jury, prior to adjournment yesterday, returned true bills in 31 bills of indictment and also requested a copy of the audit of county tax records when it is completed.

F. F. Hendrix, foreman of the jury, reported to Judge Chester R. Morris that the Grand Jury had received 34 bills of indictment for consideration and found only three of them not true bills. He also told the judge that the jury heard representatives from the County Board of Commissioners, the County Auditor and the County Tax Supervisor in an investigation of recent discrepancies in the County Tax Office.

"After hearing the report of im-

proved accounting procedures which are being set up to avoid such discrepancies in the future, the Grand Jury wishes to commend the County Commissioners for the changes that have been made to improve the accounting system," the jury's report stated.

It added that no further action was taken in the matter, pending receipt of the written report from the auditing firm of D. R. Hollowell, Certified Public Accountant. The Grand Jury has requested a copy of the report after it has been delivered to the solicitor.

Concert Ushers In Yule Season

The concert by the College Singers last evening was certainly a pleasant way to usher in the Christmas Season.

It was a well-chosen program, presented with considerable finesse, and Dan Vornholt, director of the ensemble, chose his material well and grouped it cleverly. Christmas music—carols old and new, and anthems—made up the entire program. These were ingeniously arranged as "Holiday Greetings," "A Story in Carols," "Instrumental Meditations," and "Anthems in Praise and Adoration."

It would be a task to comment even briefly on each selection, but certain of them seemed to be particularly outstanding. The sprightly and spirited "Shepherds, Shake Off Your Drowsy Sleep," the Scotch carol, "The Carol of the Birds" sung by Peggy Griffin, and the immortal "Silent Night" sung in duet by Barbara Harris and Jane Fuller with string quartet accompaniment were the high-spots of the concert.

As to the ensemble itself, the blend they achieved was for the most part smooth and velvety. The fact the members are hand-picked probably contributes considerably to this fact, as well as to the uniform vibrato the group used so advantageously.

Their attacks and particularly their releases were generally precise, their vowel tones open, and their diction clean and clear without being exaggerated. The carrying-power was quite extraordinary, a fact which I'm sure was abetted by the resonant acoustics of the Music Hall Foyer.

And speaking of this room, it was the perfect place for this program, the double stairway seemingly forming a Y for "Yule" and the singers arranged in either arm of the Y, with Mr. Vornholt at the juncture.

This clever staging, the well-

chosen and well-presented program, plus the timely decorations all joined forces to make for a program that did justice to the College Singers.

All Eastern Carolina Has Problem

Realization of the economic impact tobacco acreage reductions have in their region should prod all the people of Eastern North Carolina to greater efforts in behalf of industrial develop.

The 20 per cent reduction in tobacco acreage announced for 1957 will deprive 26,000 people—mostly in the East—from their accustomed means of livelihood on the farm. What's more the acreage reduction is expected to deprive farmers of some \$50 million income next year.

What will these 26,000 people do for a living during the coming year? Will they remain in the area and be productive for themselves and their communities, or will they invest the remainder of their lives in making other areas more prosperous and more productive? To what shall the tobacco areas of the state turn to make up for the loss of income from the golden weed?

It is not our purpose to paint a gloomy picture. We are convinced, however, that Eastern North Carolina and all its people must face the reality of changing times and changing conditions. It is not the first time this section has been called to face up to an economic challenge and overcome it. Neither will it be the last. Yet the first prerequisite to coping with the situation is squarely facing it with the resolve to put forth whatever effort necessary to overcome it.

Eastern North Carolina learned many decades ago it could not depend forever on cotton, tar, pitch and turpentine for its livelihood. Gradually King Cotton relinquished its one-crop hold and tobacco came to the fore as the cash crop which formed the basis of the economy in many Eastern counties. In recent years the need for greater diversification of crops has been recognized and this movement has advanced, though not as rapidly as we would have liked to have seen.

Herter Appears Sound Choice For Key Field

Appointment of Governor Herter of Massachusetts as under Secretary of State should add strength to the State Department and its administration of this nation's foreign affairs.

The New Englander proved himself an able administrator of the affairs of his state, and even though he declined to be forced into a bid for the vice presidency on the Republican ticket this year, his capabilities have not gone unrecognized beyond party lines.

It should not come as a surprise if the appointment of Gov. Herter to the important post might be a two-fold proposition in addition to merely filling the post vacated by Herbert Hoover, Jr. President Eisenhower has picked a man to whom he can turn over foreign affairs when the time comes that John Foster Dulles steps down from his exacting post.

Although Secretary of State Dulles is not an old man by modern standards (he'll be 69 in February) the gruelling job of hopping all over the globe for four years takes its toll of any man. On top of that his recent illness may necessitate his slowing down for his own sake.

It may be that the Secretary of State is thinking of stepping down from his post before another four years elapses. If he is, it is quite possible that he will see fit to serve his post at the beginning of the President's second term of office or shortly thereafter. Assuming our suppositions are correct, that would afford an orientation period of a few months for Gov. Herter to be brought up to date on world affairs as top officials of the State Department sees them.

Crossing Signals Are Welcome Safety Steps

Erection of electric warning signals at three railroad crossings in and near Greenville go a long way toward eliminating serious traffic hazards which have existed for several years.

Warning signals have been placed at the Norfolk-Southern crossing on South Evans Street and likewise at the Norfolk-Southern crossing on the 264 bypass just east of the city limits. Warning signals also have been erected recently at the Atlantic Coast Line crossing on the 264 bypass just south of the Greenville city limits.

While these improvements by the railroad companies are most welcomed, there is still need for the railroads to provide some warning of approaching trains at other railroad crossings in the city. Even the presence of a flagman, if nothing else, at these crossings would be a help.

In a word at least, the city requires railroad companies to provide adequate warnings at crossings within the corporate limits. It is the responsibility of city officials to see that such regulations are complied with by the railroads for the safety of local citizens. It would not be amiss for city officials to carefully survey the conditions at railroad crossings within the city and take whatever action is necessary to provide adequate safety for local people.

It is evident now that something more must be had to produce income for the East. Industry must be provided; and indeed it can be provided, both the home-grown and the imported varieties.

Tobacco for years yet—perhaps decades—must continue to provide a major portion of Eastern North Carolina's income. But it can by no means be expected under these changing conditions which we now face to shoulder the portion of the load it has in past years. Provisions must be made for new sources of income.

It is not a problem which faces no one county or one community. It is not a problem to be resolved by a few people in a few communities. It is an area problem which must be faced squarely by all the people of Eastern North Carolina. It is one which can be overcome if the people as a whole give it their attention and their efforts.

Changed Concept Of Mentally Ill Shown

HOSPITALS — Two little news items coming out of the mental hospital system this week hint at a much bigger story.

The All Faiths Chapel at Dix Hill, Raleigh's State hospital, will be dedicated Sunday in exercises which also commemorate the 100th anniversary of establishment of that institution. Announcement was made of the appointment of Dr. Mintaut Viols as superintendent of the hospital for Negroes at Goldsboro.

Although the hospital at Raleigh dates back a hundred years more of the advancement in the care and treatment of the mentally ill covers only the past decade and a half. A chapel for religious and cultural services, along with recreation halls and playgrounds for patients, is one incident in the completely changed concept of mental hospital administration. This new concept led to abolition of the drab walls inside prison-like buildings which were appropriately called "insane asylums," where the ill were incarcerated and forgotten. The concept which has grown during the past 15 years has been almost as revolutionary as was the original idea conceived by the Yankee lady from Massachusetts, Dorothea Dix, who devoted most of her time to the 1850's to persuading legislatures to do something for mental patients. The asylums have become real hospitals where patients are treated and cured by modern surgery and physical therapy.

More than \$100 million spent on buildings, equipment and personnel since the end of World War II has transformed the drab asylums into cheerful surroundings. The job has not been finished, there are still weak places in the system. But North Carolina has right to be proud of its institutions at Raleigh, Morganton, Butler, Caswell and Goldsboro.

PERSONNEL — The new superintendent at Goldsboro is part of an even more interesting story. Dr. Viols is one of fifty or more medical men and women from Europe and Asia who have contributed much to the cause of mental health in North Carolina.

He was born and reared in Latvia, then a royal province of Russia and now an independent member among the Soviet republics. He came to this country in 1949, under the sponsorship of Myers Park Baptist church in Charlotte, and soon joined the hospital staff.

In his recent speech to the State Bar, Col. William T. Joyner, intimated that, whether through local school boards or court orders, some Negroes are bound to be admitted sooner or later to schools hitherto attended exclusively by white pupils.

On this the Greensboro Daily News comments: "Now Colonel Joyner, speaking emphatically as an individual and not as a member of the Advisory Committee on Education, has declared that it would be far better to have such admissions occur by board assignment rather than by court order."

When such Negro pupils are admitted we see no reason why there should be any more disturbance than there was when the first Negro students were admitted to the professional and undergraduate schools of the University of North Carolina.

If Chapel Hill can take the thing quietly, there is no reason why any other community should not behave with the same calmness, believing in any case that the heavens will not fall. The News makes this further comment: "So the door is open, at least in the thinking of one distinguished member of the Pearsall Plan Committee, to prove that while highly controversial change in North Carolina's organic law was built in part on fears, it was also wisely built in hopes. These hopes are that if white North Carolina, in the word of the late Horace Stacy of Lumberton, is willing to meet the Negro race halfway and 'eliminate the date,' then there is some prospect for continuing racial harmony in North Carolina. To preserve the racial harmony that North Carolina has enjoyed for many years, there is all the more reason for setting up of biracial committees in every community, and if needed, in the State, to keep abreast of each local situation as it develops and to keep unbroken the cooperation that will be needed in the transition period."

In that connection it is noted that Dr. James W. Murdock, general superintendent of the hospital system, is a native of Scotland, with a record of educational attainment and successful hospital administration in Scotland, England, Australia and Malaya. He came to North Carolina in 1947, joined the staff at Dix Hill from where he was transferred to Butler in 1948. After several years as superintendent at Butler he was drafted to head the whole system upon the retirement of Dr. David Young two years ago.

Not all of the doctors from other countries were able to obtain medical license in this state. Many of those who did not fully qualify rendered highly valuable service under supervision of licensed physicians. The arrangement was mutually profitable. Without them the hospitals would have been in desperate plight for psychiatrists and skilled attendants, and their placement afforded opportunity to carry on their profession in relieving suffering in the home they had chosen when forced to leave their native land.

Many of the foreign doctors were here on temporary visas and have returned home. A few have decided to make their stay permanent. PROBLEM — Secretary of State Thad Eure is up against a tough problem. The 1955 General Assembly completely rewrote the corporation laws of North Carolina. Procedure for forming corporations, filing and amending charters, and making tax reports were entirely changed.

But unlike most such revisions of statutes, the effective date of the new provisions were fixed as of July 1, 1957, more than two years after enactment.

The secretary of state's office handles corporation matters, and to comply with the new law the whole process must be revamped—and must be ready to operate on July 1. That will require five or six months, under direction of a competent officer with broad knowledge of corporation law. So far the problem is fairly simple. The officer might be difficult to find, but he can be had. Trouble is the 1957 General Assembly will have a whack at amending or further rewriting the laws. Already there is clear intimation that some powerful legislators are sharpening their axes for the bill. Amendments are certain, and drastic revision probable. So, what is needed besides somebody to set up the

To preserve the racial harmony that North Carolina has enjoyed for many years, there is all the more reason for setting up of biracial committees in every community, and if needed, in the State, to keep abreast of each local situation as it develops and to keep unbroken the cooperation that will be needed in the transition period."

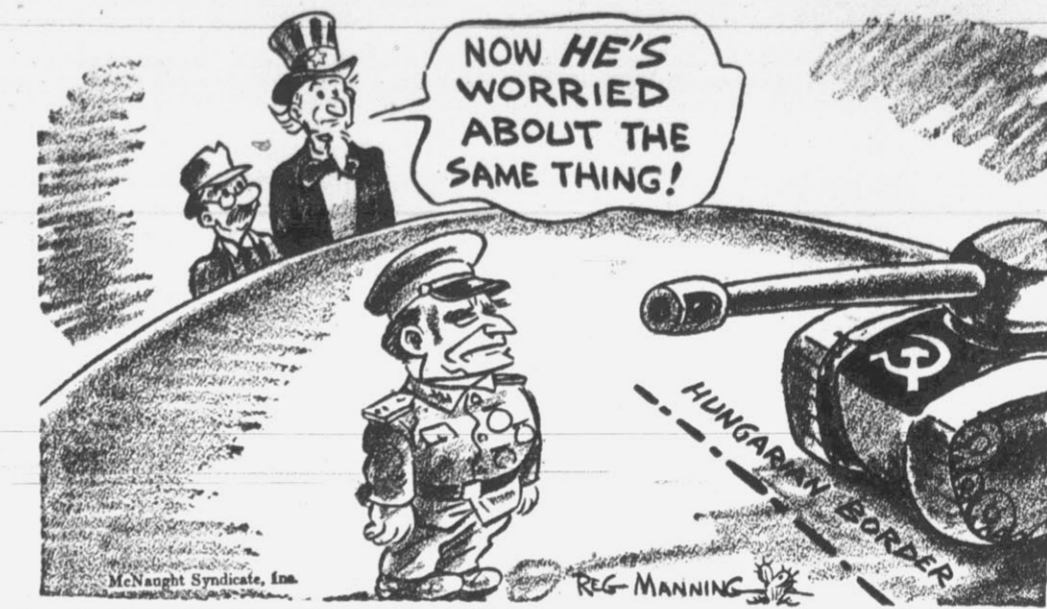

Somewhere a block or so away a cornetist tried a practice scale in the darkening evening; he muffed a note, and it evoked the thought that neighbors can be wonderfully forbearing.

An embryo musician can... and usually does... make a tortured thing out of his instrument. For an hour every day he or she works on scales and exercises and melodies to the complete discredit of instrument manufacturers. The reluctant audience can only take it with stoicism because somewhere within there is an appreciation of grim endeavor as well as an aversion to discouraging the student.

It might be that I'm looking too far backward, because as I

recall there seemed to be about one student instrumentalist every three blocks in the old neighborhood. Providence arranged, no doubt, that spacing so the chords and discords never did quite clash. In later years most of my waking hours have been away from home, and the congestion doesn't appear to be so great.

Despite their hopes, neighbors never do get to truly enjoy the musical offerings from practice sessions. The musical beginner struggles and struggles through the first phases of familiarizing himself with his instrument; then almost mastering the simpler melodies, moves on before that mastery is complete. He

keeps "graduating" to more difficult pieces and exercises, always something just beyond his grasp; while the inadvertent listener suffers in silence.

When the student finally takes up "second" parts, in which there is no melody, his practice assumes a sort of sonic horror for all within range. The only beneficiary is the perpetrator of it all... and maybe the instructor. Someday the prematurely aged parents may beam as they watch the new prodigy march with a band, or sedately play for a select little circle of friends. But few neighbors share in this joy, or the satisfaction.

The arts do exact a price.

NEW YORK (AP)—Do you want to be a changed man in 1957?

Well, now is the time to start removing your personality warts. Most people wait until New Year's Day to make their good resolutions. On that day you are likely to be hypercritical, unfair to yourself. You don't see yourself in the right perspective. You are full of self-hate. You see a thousand things wrong with you, whereas even a jury of those who really know you best probably wouldn't credit you with more than 750 character faults. So what happens? You resolve

to improve your conduct in 1,000 ways all at once. This is manifestly impossible, unless you lie down and die, which is certainly carrying self-improvement right out the window.

Unable to correct all your supposed 1,000 faults, you soon give up the struggle, saying, "What's the use?" That leaves you with the hopeless feeling you have added the 1,001st defect to the list—you're a guy who can't keep a pledge.

The reason you should make your New Year's resolutions right now is that you won't have to make so many. You have a Christmasy feeling toward the world, and are full of goodwill.

You don't see so many things about yourself that need changing, because you love yourself even as you do your neighbor. Maybe even more.

The danger here, of course is that you may be full of so much goodwill you find yourself absolutely flawless. You can't think of a single way to change yourself for the better. In this case you need the help of others. Here's what to do: Take six sheets of paper and give one each to your closest friend, your oldest enemy, your mother, your boss, your favorite bartender and your wife. On second thought, maybe you'd better give your wife a loose-leaf notebook—or a tape recorder.

Next, ask each to write down what they think are your greatest faults and how you can make a better man of yourself in 1957. This may result in your wife getting writer's cramp. An opportunity like this doesn't come her way often.

Then comes your big problem—weighing and interpreting the criticisms and suggestions. Here's how you get about it: To start with, examine the list made by your closest friend. Whatever he has written down, it is safe to assume, is what the bum is saying about you behind your back. If you don't like his list, your first resolve should be to get a new friend, one you can trust not to be so honest.

Protests Erupt Over Pentagon's Role

WASHINGTON The Pentagon's belated attempt to use Army planes to ferry Hungarian refugees to this country has delayed their evacuation from Austria and brought widespread protests.

The White House against making project. In a letter to President Eisenhower, Representative Daniel J. Flood of Pennsylvania has suggested that this assignment be turned over to the commercial airlines on the ground of economy, efficiency and minimizing the competition of government services with private industry. Based on official figures developed by the Hoover Commission and the House Appropriations Subcommittee handling the military budget, on which he is a key majority member, Flood informed the private lines can fly the refugees at \$200 a head cheaper than the Military

Air Transport Service. SIGNIFICANT SAVING OF COST On that basis of costs comparison, with 10,000 refugees being flown here by MATS, the saving in transportation costs alone would be \$2,000,000. If they were transported by the established airlines, in a compromise arrangement, however, the other 10,000 will travel on Navy transports and commercial planes.

Flood also notes that more general employment of profit-making and tax-paying lines, in preference to MATS, has been recommended by the President's own Air-Coordinating Committee, the Hoover Commission and the House Appropriations Committee. According to unannounced but authentic reports from Austria, it was the original intention of the Intergovernmental Committee for European Migration to rely on private planes. But Pentagon protests halted all movements for several days, em-

barrassing overworked Austrian authorities, and caused general confusion. No such official rivalries beset other nations' rescue and relief contributions.

OTHER OBJECTIONS TO MILITARY OPERATION Other objections to making the project a wholly military operation have been raised. It might not give the refugees, who are fleeing all the trappings of a totalitarian state—Russian soldiery and secret police—a good first impression of their new home for them to become the charges of American troops. This criticism has been sharpened by reports of Army mismanagement of the refugee reception center at Camp Kilmear, N.J. According to this viewpoint, "Operation Mercy" should be a civilian and humanitarian effort from start to finish, even granting the natural good nature and kindness of the American GI and his officers.

Three Tried To Beat Taxes

Under present income tax laws, you can't blame a man for trying. Some of the tries are indeed ingenious, but they don't always work. For example, here is the story of how three men tried in vain, as reported by Prentice-Hall:

The three formed a corporation to sell an obesity remedy and despite the fact the Post Office stopped them from using the mails to peddle the nostrum, they soon faced the problem of paying income taxes on almost \$600,000 in earned surplus and profits.

This was their try: They first interested a charity in receiving some money, not usually a difficult task. Then they created another corporation.

In three or four hours one afternoon the first corporation's treasury (which it had a right to do since it had just bought the company), redeemed two of the notes for \$400,000. Then it gave the three men seven-year contracts to manage the business.

At this point, it seemed as if the three had converted their property into capital gains—they had sold the business instead of taking profits that would be subject to personal income taxes at the deadly rate that afflicts those in upper brackets. In addition, they still controlled the business, from which they could draw \$3,600,000 more as additional notes became due, and which would be subjected only to the capital gains levy.

However, sales of the anti-fat stuff declined and the melon that was to be divided among the three men and the pet charity withered on the vine. So the three bought back all the second corporation's stock from the charity for \$5,000.

COURT LOOKS ASKANCE
The Internal Revenue Service didn't agree with the three men that they had made only a modest capital gain and took the matter to the U.S. Tax Court. The court, in effect, decided that the second company was a "thin corporation." A thin corporation is one that exists without substantial reality. It is, in fact, one court can see through.


The court arched eyebrows over the fact that the second corporation, with only \$1,000 in cash, seemed able to take over the first; the ratio of equity to debt was 1 to 3,600. It also thought the sale price was excessive. The notes and the interest paid on them, the court concluded, were really dividends, and not capital gains. (For lawyers: the case in question is Kolkey, 27 TC No. 4.)

Prentice - Hall observes: "Where a charity may currently be considering the purchase of a business... it is important for the charity to invest substantial funds of its own. Note further that, since 1950, feeder organizations such as the second corporation are not tax exempt, and charities are taxed on their unrelated business income."

STRAWS THAT SHOW HOW TRADE WINDS BLOW
Sixty-four per cent of 500 industrial purchasing agents surveyed by Purchasing magazine think business will be better next year; only 5 per cent fear a decline... More products are being stuffed in collapsible metal tubes; a record total of 798,383,648 tubes were sold by manufacturers in the first nine months of this year... Sales of illuminated plastic signs will double in 1957, predicts A. A. Szigler, whose view is probably influenced by the fact he is president of Tel-A-Sign... The proposal to sell carpets by square feet instead of by square yards has created a great hubbub in the industry. The National Retail Furniture Association has joined opponents, meanwhile several stores are testing it ahead of the January 1 effective date by advertising carpeting at square-foot prices... In the first 11 months of this year, 1,202 retail apparel and accessory stores failed an increase of 37 per cent over the same period last year, Dun & Bradstreet reports.

This temptation. To obey it will get you nowhere.

Haiti Political Strife Seen Near Showdown

MIAMI, Fla. (AP)—Terror and confusion swept Haiti today as a boiling political crisis — which the present regime says has been "aggravated by American government organizations" — headed toward a showdown.

The country is virtually paralyzed by a silent but deadly weapon, a mass sitdown, the refusal of thousands of persons to work.

Its object is to force bull-headed Gen. Paul E. Magloire to step out of the gleaming white palace in Port-au-Prince, the capital, and permit general elections for a new president.

It is cutting into the supplies of food from the countryside, closing stores, crippling transportation by starving gasoline stations.

The law courts have suspended, telephone communications are sketchy when they operate at all, and pistol-packing army officers are stationed in communications offices censoring all messages, press or personal.

Soldiers and sailors are patrolling the streets.

No Americans have been arrested so far as is known. But Paul Kennedy, correspondent of the New York Times, was hustled out of Haiti on six hours' notice without explanation.

I left Port-au-Prince last night after five days there.

The explosive situation hit a climax last week.

On Thursday, Magloire resigned as president. Under one interpretation of the constitution, his six-year term ended Dec. 6. The Haitian constitution does not permit a president to succeed himself.

Hours later, however, Magloire resumed office as "chief of state," presumably at the request of the army.

He then imprisoned the principal presidential candidates and about 49 others. He also dissolved the Senate and Legislature, and in effect suspended constitutional authority.

Magloire told this correspondent he was forced to take the measures. He said political leaders had caused a series of bombings and shootings during their campaigns, and created a situation that blocked all possibility of a legitimate general election.

One man was killed, a woman seriously injured, and a huge reservoir damaged, but not vital, by bombs.

The mass of the populace, however, apparently has refused to accept Magloire's explanation of the incidents, or his subsequent actions.

On the diplomatic level, Magloire is angling desperately for official recognition from the United States. It has not been granted.

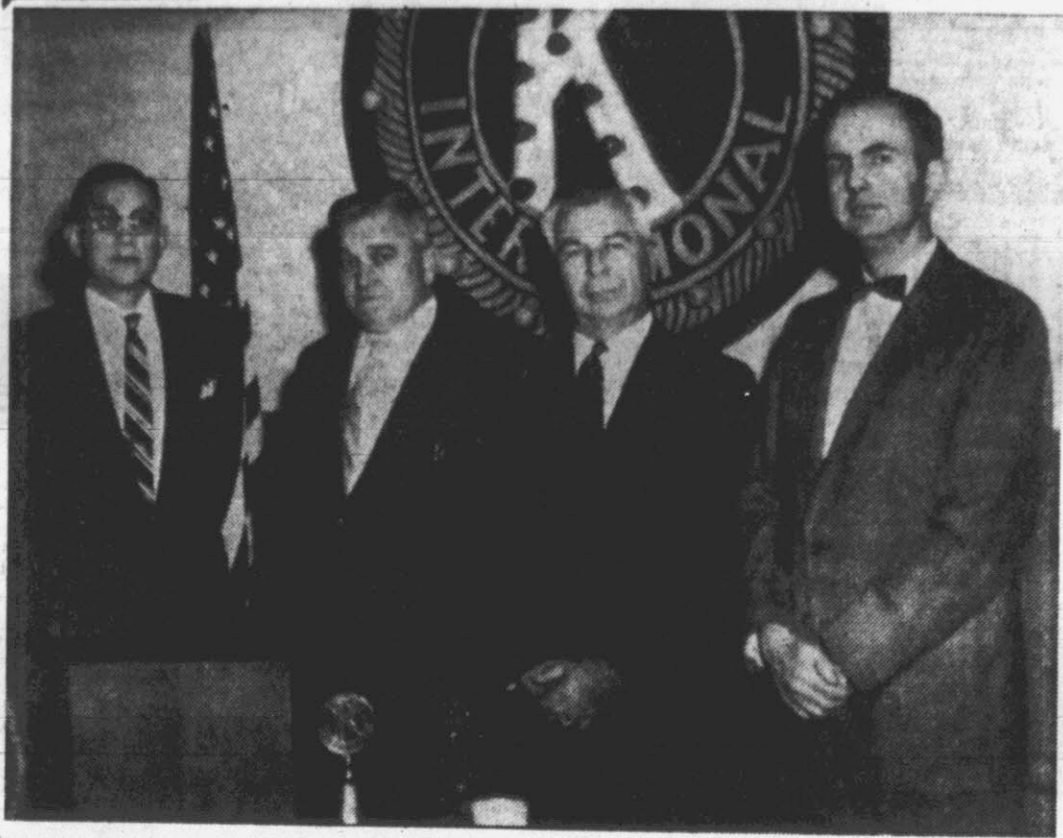

Steel Giants To Defy Protests On Merger

NEW YORK (AP)—Two of the United States' largest steel companies plan to merge despite notice by the Justice Department that it will move promptly to block the consolidation.

The Bethlehem Steel Corp., second in the industry behind U. S. Steel, and the Youngstown Sheet and Tube Co., sixth largest, announced yesterday an agreement under which Bethlehem would acquire Youngstown in exchange for Bethlehem common stock.

In Washington, Atty. Gen. Herbert Brownell immediately said the Justice Department will take prompt action in the federal courts seeking to bar the proposed merger.

Justice officials declined to say in what city the action will be brought. The two companies said they hope the government's legal action will be "speedily determined by the courts."

Bethlehem Chairman Eugene G. Grace and J. L. Mauthe, chairman of Youngstown, announced the Justice Department had formally advised them "it intends to sue to enjoin the proposed acquisition on the grounds that it would violate the antitrust laws."

The proposed merger would not affect U. S. Steel's position as largest in the industry. It would be one of the biggest in history, creating a company with assets around 2 1/2 billion dollars.

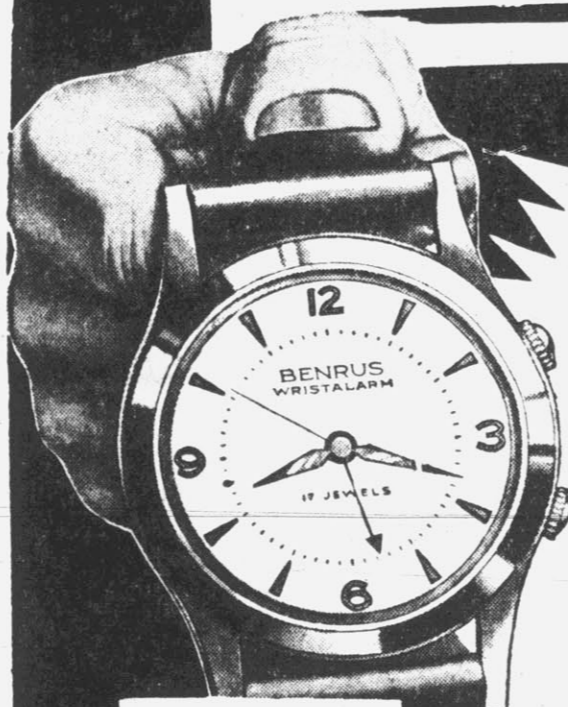

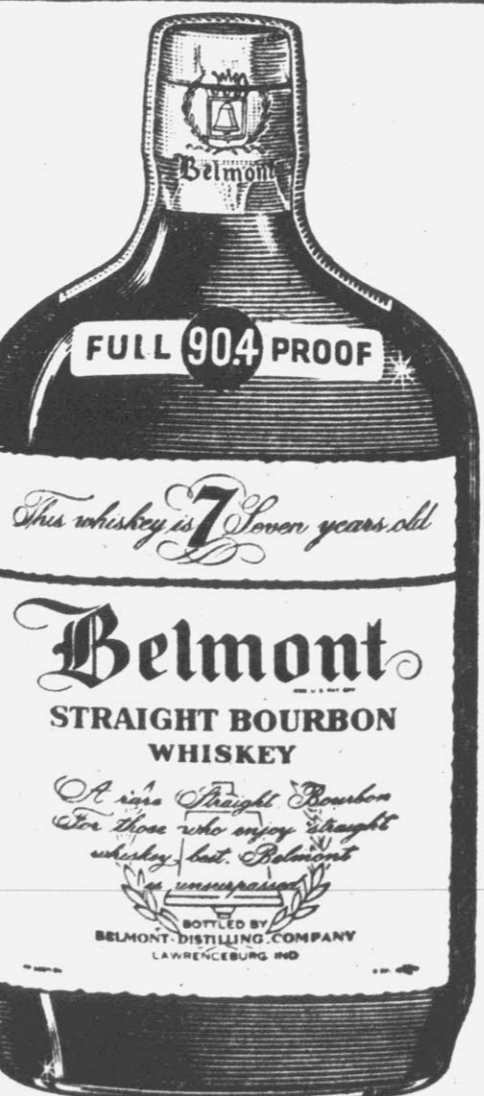

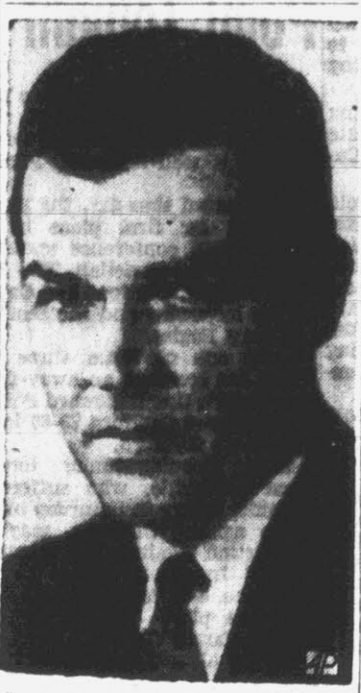

In the bewildered local peasants, in their padded cotton coats and towering fur hats, look out of place, wandering through the five newly erected department stores owned by the state, or strolling wonderingly along wide, American-looking boulevards flanked solid with half-completed buildings.

On July 15, three years to the day after construction of the motor works was begun, the first "Liberation Trucks," pride of China's five-year plan, rolled off the assembly line.

Before the end of the year, 4,000 of the six-wheeled trucks will be on Chinese highways. Eventual production, by official prediction, will be 30,000 a year.

Buses and small trucks are on the plant's drawing boards. The government has not announced when manufacture of these vehicles will start.

No passenger automobiles will be built in Changchun. Another vehicle plant is scheduled for construction under the second five-year plan (1957-62), but its location has not been disclosed.

Surrounding the No. 1 plant is a community of 113 barracks-like dormitories which house a large percentage of the 18,000 employees and their families. A self-sufficient suburb, the project includes stores, a hospital and a movie.

Chief assets to the technological and administrative staff are 500 men who were sent to study in Russian auto works while the plant was under construction.

Executives admit the plant is as much a training school as a production unit.

Pay is roughly equivalent to that in other Manchurian plants. Salaries range from 25 yuan (about \$11) a month for apprentices to 105 yuan (about \$45) for highly skilled machinists. Merit awards of 25 to 30 per cent of the monthly scale are paid to model workers, and employees with large families are subsidized.

Results of the overquick construction methods are beginning to show in cracked walls and buckling floors of the plant.

Despite immense production increases in the past three years, China is obviously still far from self-sufficient. Parked outside, the Changchun plant were a dozen American cars and a fleet of official Polish sedans for the use of the Russian technologists.

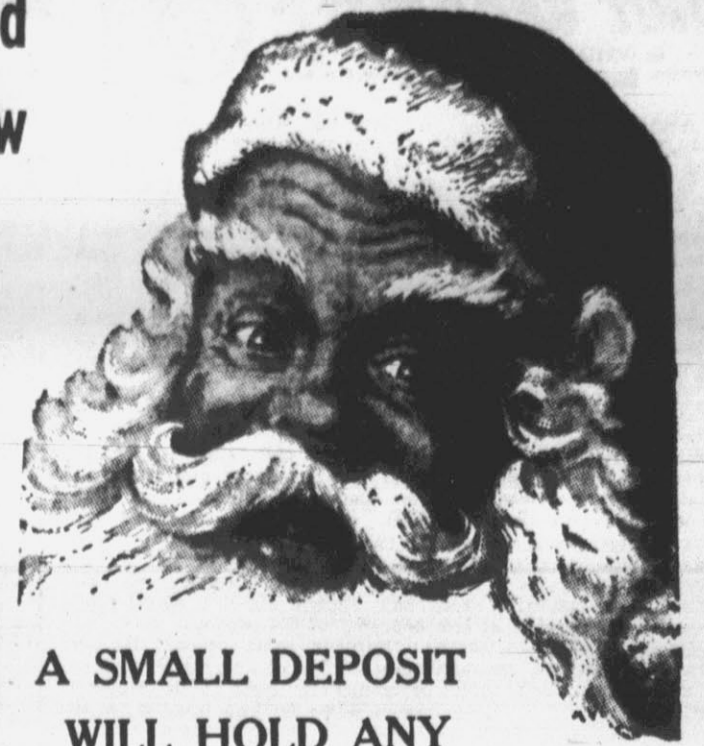

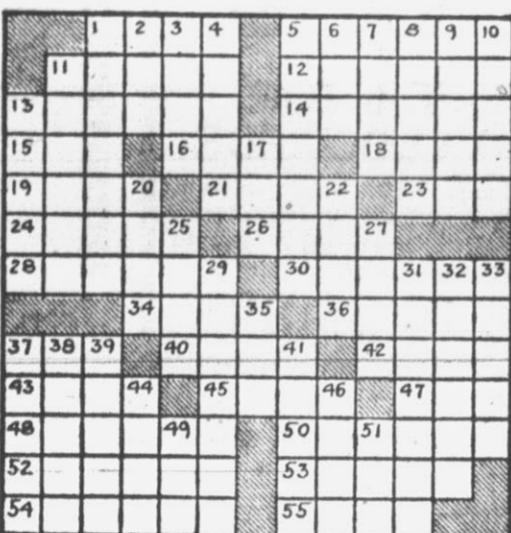

NEW YORK — Aircrafts remained ahead in an otherwise mixed and slow stock market early this afternoon.

The aircraft shares were up from fractions to a point or more. Most other pivotal stocks fluctuated from fractions to around a point but some wide movers ranged 3 or 4 points to the plus or minus side.

Generally good business news and reports of new records in production of steel and electric power were encouraging but brokers said there was still a tendency to react from last week's huge gain.

The market was irregularly higher from the start but the improving stocks were below their best late in the morning.

Youngstown converted an early loss to a small gain and then dropped more than 4. Bethlehem, down almost 3 early in the day, was traded later at a decline wavering above 2 points.

Republic and U.S. Steel kept fairly steady.

Among aircrafts, Chance Vought stepped ahead well over a point and Lockheed was about a point to the good. Boeing and Douglas Aircraft gained fractions. Glenn L. Martin sluffed off an early gain.

Allied Chemical added about 3, shoring up the averages considerably. Du Pont was down about a point. American Cyanamid was up a major fraction.

Gulf Oil improved beyond a point.
