Families Offer Rewards

Hope To Recover Bodies Of Two Fishermen Presumed Drowned

A \$500 reward has been offered for recovery or information leading to the recovery of bodies of two Pitt County fishermen missing since December 6. Friends of the families of Bonnie Lee Edwards, 43, and Coley Stanley, 33, of the Cox's Mill section are offering the reward. It was raised through contributions and first offered Thursday when \$150 was collected. Contributions since then have raised the total to \$500. The men disappeared December 6 while on a fishing trip in the Neuse River near the mouth of Adams Creek. An intensive search has been conducted since that time and Marines from the Cherry Point Marine Corps Air Station used 500 pounds of explosives Tuesday in an effort to force the bodies to the surface. The search has been expanded to include both sides of the Neuse River, which is about five miles wide at that point, and portions of the Inland Waterway in the area. Drugging operations have been halted by Craven County Sheriff C. B. Berry but Marine Corps helicopters are still making two or three sweeps over the area each day. Coast Guard boats in the area are also conducting searches during routine patrols on the river. Shrimping boats and other private craft are also participating in the search.

UN Police Fired Upon By Guerrillas; Tension High

PORT SAID, Egypt (AP)—Tension mounted in this port city today as Egyptian guerrillas attacked U.N. police force patrols and the British army cracked down on the Arab populace with tough search measures in an effort to find a kidnapped lieutenant. Three hand grenades were hurled at a jeep patrol of Norwegian members of the U.N. force and small arms fire was directed at a Swedish patrol, U.N. officials said. There were no casualties but Maj. Gen. E. L. M. Burns, the police force commander, protested strongly to Egyptian authorities in Cairo. It was the first such attack here on the U.N. soldiers. Egyptian guerrilla activity increased as the time neared for complete withdrawal of British and French forces in accord with U.N. directives. Cairo newspapers said the withdrawal would be completed today but U.N. officials said no definite time could yet be fixed. British forces also came under new guerrilla attack. One Egyptian was killed. The U.N. units wore the blue helmets of the police force but a British official said there was a possibility they might have been mistaken in the early morning darkness for British or French troops. There was speculation the guerrillas may be members of the outlawed nationalist Moslem Brotherhood trying to put Egyptian President Nasser in an embarrassing situation. Lt. Gen. Sir Hugh Stockwell, the British commander, ordered his forces to round up all Arabs, men, women and children, in a five block area for questioning in the kidnapping of Lt. Anthony Moore, Arab males 15 years or older were taken to the city sports stadium for questioning. The car in which Moorehouse was kidnapped was found abandoned in a garage in the search area. The Egyptian underground claims to have killed Moorehouse, Stockwell told newsmen: "I don't hold any great hope on this operation but I feel I must do something about it." The withdrawal continued without letup, but there still was no official word on when it would be completed. The aircraft carrier Theseus sailed for England at dawn with 1,100 British soldiers. The last shipload of Jews fled Port Said, leaving behind only two frightened families who refused to depart until their men are released from hostage. Jewish families have charged Egyptian secret police visited them after the Israeli invasion of Egypt's Sinai Peninsula and took away one member of each family. Some 330 Jews, including citizens of Egypt, France, Italy, Greece, Yugoslavia and some stateless persons, boarded a French troop ship in the harbor because of fear they would be persecuted if they remain here when the British and French leave. Delay in clearing the debris-choked Suez Canal brought mounting concern in Britain and France. The British and French have cleared a channel through the 17th and their troops occupy, but the Egyptian-held southern end remains clogged. At the United Nations in New York, there was speculation the two nations would press Secretary General Dag Hammarskjold to get the clearing job started without further delay. Egypt has accepted a U. N. offer to help clear the waterway but refuses to let work begin until all foreign troops pull out. Egyptian military sources charged the Israeli army is delaying its withdrawal from the Sinai Peninsula and trying to impose sweeping conditions, including U. N. guarantees of the security of Israel's borders.

Dulles Due Back Today To Report

HIGHTOWER WASHINGTON (AP)—Secretary of State Dulles returns from Paris today to report to President Eisenhower that progress has been made toward healing the split in the Atlantic alliance caused by the British-French attack on Egypt. Dulles was due here about 2 p.m. (EST). He was scheduled to go immediately to the White House for a meeting with the President. A State Department spokesman said yesterday he knew of no plans for Dulles to make a report to the nation. Before leaving Paris, Dulles said that his separate private talks with British Foreign Secretary Selwyn Lloyd and French Foreign Minister Christian Pineau had done much "to bury if not dissolve entirely the differences existing in our unity." Committee Urges Special Industrial Legislation For County Corporation

The special industrial committee appointed by the Pitt Commissioners last night recommended that special legislation be prepared to set up a county-wide tax supported Industrial Development Corporation for Pitt County. Action came at a meeting of the 11-man committee appointed by the Board of Commissioners. The motion for a county-wide program was made by Noel Lee of Pactivol, seconded by Floyd Harris of Greenville route four, and unanimously passed by members of the committee present at the meeting. The motion authorized Committee Chairman Leonard Bloxam to ask the Board of Commissioners to have the county attorney prepare special legislation to present to the 1957 session of the General Assembly. The legislative act would authorize a referendum for the citizens of Pitt to vote for establishment of a county-wide Industrial Development Corporation supported by a special county-wide levy not to exceed three cents per \$100 valuation. Revenue from the special levy would be used to organize and operate a county industrial development body named the Pitt County Industrial Development Corporation. The organization would be under the direction of the Board of Commissioners. The committee last night expressed the opinion the Industrial Corporation should be composed of one representative from each of the communities of the county and two representatives from the county at large. All members of the group would be appointed by the County Commissioners. It is estimated by the committee that a special three-cent tax levy would yield \$18,000 per year for the county's industrial development program based on the current tax valuation of the county. Prior to the decision calling for special legislation, the committee discussed merits of Pitt County's entering a multi-county development of creating its own industrial development program. The committee determined that the single county program would be better fitted to the needs of Pitt County. The movement for a county-wide industrial development program for Pitt County began here in October at a meeting of representatives from the several towns in Pitt County. At that time the representatives requested the County Commissioners to appoint a special committee to investigate possibilities for such a program. Last month the Commissioners appointed the 11-man committee to investigate the matter and make recommendations to the Board. Committee Chairman Leonard Bloxam said today he expects to present the recommendations of the committee to the Board of Commissioners at its January meeting. "I am highly pleased with the response from the members of this committee and the enthusiasm they have shown for this program," Bloxam commented following last night's meeting. It is the feeling of the members of the committee that something must be done in the way of industrial development to stabilize the economy in Pitt County. In addition to Bloxam, Harris and Lee, the special committee appointed by the Commissioners is composed of Major Corey Stokes of Ayden, William L. Dawes of Grifton, Bernice B. Turnage of Farmville, Mayor J. M. Horton of Fountain, Edwin E. Rawl, Jr. and David J. Whitchard of Greenville, Ward James of Winterville and W. Leslie Elks of Grimesland.

ABC Store In Grifton Guttled By Fire Friday

GRIFTON—A fire which raked the Grifton ABC Store early yesterday caused damage estimated at between \$9,000 and \$10,000. Pitt County ABC officials said today. County ABC Chairman J. W. Joyner of Farmville said the fire destroyed almost all of stock contents valued at \$9,461.47. "We were able to salvage only a small portion of the stock and very little of the inside fixtures," Joyner said. He added that the store was practically a total loss, the cash register and adding machine were destroyed and the shelving almost completely destroyed. The 4 a.m. blaze was apparently caused by a short circuit which spread from a switch box in wiring in the ceiling of the building. "We had thought at first that someone had broken into the store and tried to cover his tracks," Joyner said. "However, we found that to be not true. Nothing was tampered with and our investigation shows that the fire started in the switch box," he added. Store stock which was salvaged was recovered in poor condition. Joyner pointed out, Unbroken bottles were smoked black and all labels were burned off in the fire. Pending location in another building, the store has been temporarily located in a paint store across the street from the site of the burned-out store. The Grifton store is the fifth largest in the county's system of nine stores.

Postmen Begin Get That Weighted-Down Feeling

By JIMMY ELLIS Reflector Staff Writer Greenville's postmen are beginning to feel the additional weight of the Christmas season. Despite that, the increase in the amount of mail they're handling indicates that people aren't doing a great deal of rushing in their Christmas mailing. Postmaster J. Knott Proctor said today that mail volumes handled by his staff have picked up "25 or 30 per cent" in the past week. That, in comparison with past years, is a normal increase for this time of year and offers at least a hint that many people are waiting as long as possible before doing the bulk of their Christmas mailing. The big increase in volume is expected to come next week. To cope with the anticipated situation the Post Office will add eight or nine new men to its staff next week. Two of the new workers will be used inside the Post Office and the others will be assigned to assist regular city route carriers. One of the new "inside" men will be placed in the Post Office lobby to take mail that would otherwise be placed in regular mailing chutes. "It will help us and also help to speed the delivery of mail if postal patrons will separate their in-town and out-of-town pieces before giving them to the man in the lobby," Proctor said. "We have little tags to designate the local and out-of-town deliveries and we'll be happy to furnish them in any quantity to patrons who request them," he added. As in past years, the accent on Christmas mailing this year is "do it as early as possible." In addition, Proctor has offered patrons additional suggestions to insure the speedy delivery of regular and holiday correspondence. "If persons who rent boxes will check them several times a day and keep them cleaned out it will enable us to make sure the patron gets his mail without any delay. There are times when the boxes get so full we just can't put all the mail in them at one time. "Also, if city route patrons will place their out-going correspondence in either the Post Office lobby or in drop boxes throughout the city it will help. The carriers are so loaded down with their regular deliveries that it's an increased burden for them to pick up out-going mail at homes on their routes. Mail placed in the Post Office and in the drop boxes is always picked up according to a regular schedule which insures meeting all dispatches from Greenville," the postmaster pointed out. The manner in which mail is received and dispatched in the Post Office next week will determine whether or not deliveries will be suspended Christmas Day, Proctor added. "If people do their mailing early and we can move the load before Christmas Day we can have Christmas at home with our families. "Otherwise, we work."

Two National Magazines Call It A Day; Publication To End

NEW YORK (AP)—Collier's and the Woman's Home Companion, familiar magazines in millions of homes for more than half a century, will disappear from the American scene next month. A company official indicated that a seeming paradox—rising circulation offset by increasing publishing costs and dwindling advertising revenues—signaled the end of the two magazine giants. The 15-member Board of Directors of Crowell-Collier Publishing Co. wrote the death notice last night by voting to discontinue publication. Paul C. Smith, company president and board chairman, said the two magazines, with a combined circulation of nearly 8 1/2 million, lost more than 7 1/2 million dollars this year. He blamed it on increasing costs and declining revenue from advertisements despite a peak or near-peak circulations for both periodicals. Affected were some 2,600 employees, more than half of whom faced a jobless future in less than a month. The board's "primary duty" to the stockholders to "protect their investment" resulted in the decision, said Smith. It withdrew Crowell-Collier from the magazine field, leaving the firm with its profit-making book publishing business. Collier's, a bi-monthly general magazine with an announced circulation of 4,179,700, will cease with the Jan. 4 issue. The Companion, with a circulation of 4,238,800, ends publication with the January number. Gardner Cowles, president of Cowles Magazine, Inc., simultaneously announced an agreement under which Look magazine will take over the unexpired subscriptions of Collier's. The Crowell-Collier statement said arrangements were being made to divert the Companion's subscriptions to other publishers. The company discontinued the American magazine last August in an effort to trim its finances. The company will continue publishing Collier's Encyclopedia, a which this year sold 145,000 sets for about 25 million dollars. A company subsidiary, P. F. Collier and Sons, publishes the 51-volume Harvard Classics and the Junior Classics.

Accidental Death Ruled In Youth's Hunting Mishap

Accidental death has been ruled in the fatal shooting of Johnny Emmanuel Roach, 14, who was killed yesterday afternoon in a hunting accident. Coroner Griffin H. Rouse made the ruling after talking with young Roach's hunting companions, 12-year-old William Edward Roach, the dead youth's brother, and A. J. McLawhorn, 21. "The accident occurred when Johnny stumbled, fell and caused his 12 gauge shotgun to fire. The full load of the shell caught the youth high on the right side of his chest. The Negro boy and his two companions were hunting squirrels near Helen's Crossroads East of Ayden. According to Coroner Rouse and deputy Sheriff Ralph L. Tyson, Johnny was pulling on a vine shaking a squirrel's nest when he stumbled. There will be no inquest.

Three Freed On Bonds Yesterday

A U. S. Commissioner yesterday released three men arrested at a still site on bonds of \$200 each. Louis Eggerette, 37, and Garland Skinner, 26, both of Greenville, and Oscar Carney, 55-year-old Negro of Robersonville, Route 2, were arrested Thursday night by Pitt County ABC officers and ATU agents from New Bern. Two 300-gallon stills and 1,450 gallons of mash were destroyed at the time the arrests were made. U. S. Commissioner Matilda Turner in New Bern conducted the hearings for the three yesterday.

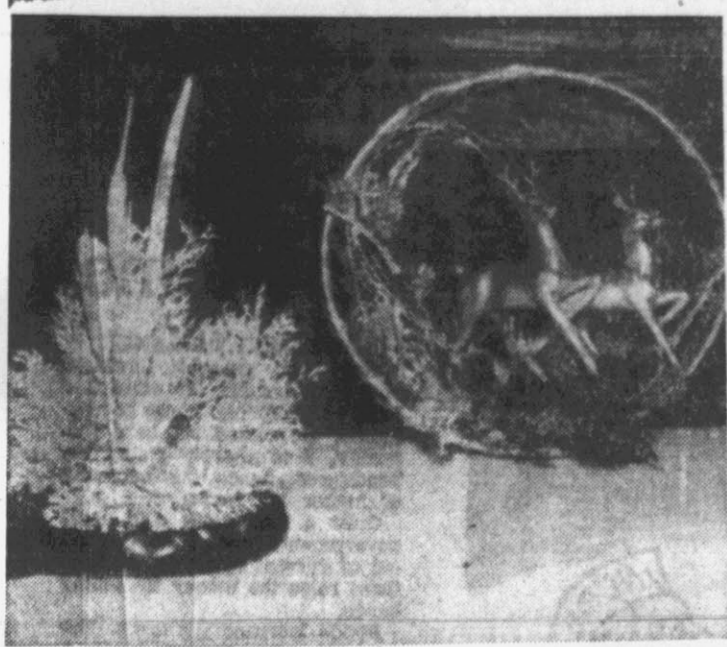

It's Time To Appraise Safety Needs

Two tragic train-vehicle accidents in two days has brought home to the people of Pitt County the need for a more critical appraisal of safety devices provided at railroad and highway intersections in this county.

The train-car collision on highway 264 near Farmville Wednesday night took the life of one man. The truck-train collision Thursday afternoon at the railroad crossing on a rural road near Grifton claimed the lives of two more men.

In both instances, the only warning devices at the crossings were the regular railroad crossing signs required by the state. In both instances these signs proved insufficient to prevent the accident which claimed three lives and shot Pitt County's highway death toll for this year to a new all-time high of 22.

The two collisions this week brought to at least six the number of people killed in vehicle-train collisions in Pitt County in little more than a year.

More prominent warning signals at both the crossings may have prevented the two most accidents.

We realize the cost of modern warning devices at railroad crossings is high. The cost of placing electrical gates or warning lights at every railroad crossing on the highways would be prohibitive. Be that as it may, it appears to us that more attention need be given in Pitt County to the erection of more adequate warning devices at railroad crossings along the highways.

It costs a number of thousands of dollars to purchase and install such devices. But how can this cost be compared with the value of a human life? Indeed, how does this cost compare with the property damage which results from vehicle-train collisions? According to Highway Patrolmen there have been three serious car-train collisions at the crossing on highway 264 near Farmville in the past two years.

As the governing board of the county, the County Commissioners should carefully appraise railroad crossings on various highways of the county, giving special attention to the degree of hazard at the crossings and the signs, signals or other warning devices provided. At the same time the Commissioners might enlist the help of the Highway and Public Works Commission which is responsible for the roads, and the Highway Patrol which is responsible for highway safety.

The shock of two fatal train-vehicle collisions in as many days and the appalling increase in Pitt County's traffic toll this year should spur prompt and serious consideration of the matters by the County Commissioners.

Give Your Postman A Really Welcome Gift

Next week is the time of year when the faithful postman finds out he has falling arches, knotty leg muscles and aching shoulders. On top of that he has headaches.

The millions of Americans who dump countless millions of Christmas cards and packages on the post office during that week can't do much to help the postman with his arches, his muscles or his shoulders. They can, if they are kind to, relieve him of some of his headaches.

Each year the post office appeals to the public to mail Christmas cards and packages early. Gradually, the idea is catching on, but so far there is no indication the postman will have an easier time that last week before Christmas.

Each year too, the post office pleads with people to take care in addressing cards and packages, writing plainly not only the name but the street address, city and zone. In spite of these pleas the number of cards which cannot be delivered because of inadequate addresses continues to pile up. Postal employees spend many unnecessary hours trying to sort mail which contains insufficient addresses from that which is properly addressed. They spend more hours trying to see that every piece of Christmas mail, regardless of how inadequate its address, reaches the addressee before that important holiday.

This year, give the postman a present he can really use during this holiday season. Help relieve his headache by taking a little more care in addressing Christmas mail.

The Tide Of Blood And Revulsion May Yet Win

A few weeks ago it appeared that the brave Hungarian people may have won their long-sought independence from Russia. Then, with the mass of Russian tanks and guns which crossed the border it looked for a few days if the Kremlin gangsters would quickly subdue Hungary and reinstate the Hungarian people in their servitude.

Now the scene has changed again. Unrest in Hungary, strikes, demonstration and the demands of an oppressed people still plague the Russian government. They have resorted to the brutality for which they denounced Stalin only a few months ago. Even so they have been unable to regain control of the situation.

Slowly but surely the Hungarian people are wearing down the murdering masters who have enslaved them for more than a decade. Slowly the rest of the world is gaining sufficient confidence in itself to come to the aid of Hungary and its people. It may take months yet, or even years, but sooner or later the blood which the Hungarian people have given in their fight for freedom will be redeemed.

Belated condemnation of Russia's action in Hungary by members of the United Nations is a step which may lead to more decisive and important steps by other nations of the world in the months ahead. It is likewise a step which will encourage not only the people of Hungary, but those of other Russian satellite states. Inadequate though it is, the move is one of importance which, like the continued efforts of the Hungarian people, will take its toll of Russia's control outside its own borders.

Unique Conference Can Clear The Air

UNIQUE — The conference arranged by Governor Hodges with members of the North Carolina delegation in the Congress and heads of State departments and institutions is something new for this state. It has been the custom for many years for the General Assembly and other official bodies to memorialize Congress to do certain things. The Congress has enacted legislation requiring cooperation on part of the State agencies, often without much first hand knowledge of the attitude of State officials or their ability to participate.

Both Senators and all twelve Representatives have accepted the Governor's invitation to luncheon at the Mansion next Tuesday and that afternoon they meet with some 30 heads of agencies, departments and institutions of the State to discuss mutual problems. Sixteen State officials whose functions require direct cooperation with the Federal government have promised to have written statements to file, and support them with three to five minutes oral presentation.

Admittedly thorough discussion will not be possible in the limited time available, and there will be temptation on part of some of the fellows to indulge in oratorical explanations of their positions. The temptation will be enhanced by presence of the press and radio reporters. Effort will be made to cover the field in a total of not more than two and a half hours. All participants will be given some work for later reading.

LIAISON — Governor Hodges' objective in seeking fuller understanding and cooperation between State and Federal governments is generally approved. Several years ago, if memory serves correctly it was during the administration of Governor Broughton, some thought was given to the plan of the State of North Carolina establishing a sort of embassy at Washington, a full time office which would maintain continuous contact with members of Congress and Federal agencies. The idea was not so much a lobbying proposition as one of closer liaison in matters requiring joint action. Sponsors of the plan argued that it would also aid the industrial development program. Despite current em-

phasis on that program, it is not new.

SPREAD — The present approach is simpler and less expensive. But some people are wondering whether Governor Hodges is spreading his personal efforts over too wide a field. Whether he can do an effective job in co-ordinating State-Federal activities without sacrificing time and energy needed for his own legislative program is questioned.

He has made complete revision of the tax structure of the State a major objective of his full administration. Modernization of fiscal policies which have loosley grown up through more than 20 years is a big enough job for any one Governor.

In addition to tax reform, Governor Hodges has fully endorsed and promised to support several governmental reorganization proposals, particularly re-amping the highway commission and divorcing prison administration from highways.

He has also through the weight of his administration behind re-apportionment of legislative representation, and the program for mechanical inspection of motor vehicles and chemical tests for intoxication of auto drivers.

CONTROVERSIAL — Every one of these matters scheduled to come before the next Legislature is highly controversial. None of them has anything like the unanimous support. Legislators who strongly favor one or more of the projects, just as violently oppose others. None can be adopted without majority vote in the General Assembly.

Other Editors Are Saying.. Strong Medicine Needed

(Rocky Mount Telegram)

On any given day in the United States, more people are slaughtered on the highways than even the Russians manage to massacre.

On any given weekend in North Carolina between ten and twenty people are torn to pieces in automobile crashes. Scores more are painfully injured and permanently crippled.

In any given year, well over 1,000 people meet sudden and violent death on North Carolina's highways.

Take a recent Tar Heel weekend, which was fairly typical.

In Winston-Salem, the mother of a 15-year-old girl was notified that her daughter, whom she thought was spending the night with another teen-age girl, had instead been killed on the Greensboro highway. The driver, a 20-year-old youth under indictment for manslaughter in another automobile accident, was also killed along with a third youth. State patrolmen said the youngsters had been drinking.

On N. C. 39, near Henderson, a lone car going too fast failed to make a curve and two young men just turned 21 perished.

On U. S. 301, in Roberson County, two Fort Bragg soldiers met a terrible death.

By the time Sunday night ended, 17 people were dead or dying from wrecks on North Carolina highways.

It happens every weekend. Governor Luther Hodges, at the last annual Governor's Traffic Safety Council, proposed appropriate medicine for the situation:

1. Re-instatement of the outdated compulsory auto-inspection law.

2. Addition of 100 new highway patrolmen.

3. Provision for blood tests for suspected drunken drivers.

4. Urged judges and juries to handle traffic violation cases "in such a way as to command the public's respect and promote law observance."

The controversial auto-inspection law should be put back in force but it should incorporate the lessons learned from the fiasco in 1948 when red tape and long lines created so much public resentment that it was thrown out altogether. States having this law can prove that it helps prevent accidents and saves lives and property loss.

And, there is no reason in the world why scientific methods should not be used to prove or disprove whether a driver is drunk. Lack of scientific testing of drunks under our present set-up means only that evidence is such that the drunk literally gets away with murder nearly every time.

The Telegram hopes the General Assembly will cooperate with the Governor in this program designed to combat highway slaughter. The last Legislature went out of its way to cripple Vehicles Commissioner Ed Scheidt by forbidding the use of unmarked cars as threat-

Notebook On Life

Still Better Than Starving

By HAL BOYLE

NEW YORK (AP) — Jack Nussbaum's mother didn't raise her boy to be a life insurance salesman.

He became one because at the time it seemed a better idea than starving. Today he thinks it's a wise mother who alerts her son early to the possibilities of financial success in the booming insurance field.

For Nussbaum feels that any young man who gets into the business now will ride the crest of a still-growing wave.

"In 1936 there was 95 billion dollars of life insurance in force," said Nussbaum, president of the National Assn. of Life Underwriters. "By 1945 it jumped to 151 billion dollars, and last year to 372 billion."

"In another ten years it should reach anywhere between 750 billion to a trillion dollars," Nussbaum's own career is an example of the success that can come to a man who stumbles into his natural vocation by chance.

He quit school at 12 in the city of his birth-Glasgow, Scotland—and took a job in his aunt's cloak factory.

"The job paid 60 cents a week, and it seemed a lot at the time," he said.

Three years later he came to America and became a clothing cutter. After serving in France during the World War I, he began saving his money and bought into a Milwaukee store specializing in high-priced men's clothes.

In 1929 there occurred a notable business recession—some even called it a crash—and Nussbaum's income dried quickly from \$10,000 a year to zero.

"I was offered a job selling insurance," he said, "and I took it very reluctantly. The first 25 weeks I earned \$19.12 an average of 75 cents a week. These were really rough times. When a man said he couldn't afford to buy insurance, he was telling the truth. But I stuck to it."

His income rose steadily. Since 1942 he has been a member of

the select "million dollar round table," made up of salesmen who sell that much insurance in a year. He earns up to \$50,000 a year but is prouder of the fact that, despite his lack of formal schooling, he is a faculty adviser at Purdue University's Institute of Life Insurance Marketing.

Nussbaum says the public has a number of misconceptions about life insurance salesmen. "You don't have to put your foot in a door to sell insurance," he said. "Women in particular are well-educated on the value of insurance, especially since we began emphasizing its living benefits rather than its death benefits."

"And you don't have to be a joiner." Nussbaum himself belongs to only two organizations—the professional organization he heads and the American Legion.

"Insurance doesn't offer as high starting salaries as some other professions," he said. "But the only limitations on how far you can go in the field are those you make yourself."

"The men who have been five years or more with one large insurance company averaged \$12,500 each last year. The top 100 salesmen in the same company averaged \$27,500."

"And nobody can push you out of your job at 65 or 70. You can write your own ticket as long as you can write a ticket. One agent in Oakland, Calif., who is 79 years old sold 47 policies last month totaling \$750,000."

Nussbaum said most people buy life insurance today for investment but often at work also is the factor of "neo-recognition." They want to be a financial success even if it's only on the day they die," he said. "They know that the first thing people will ask is, 'what shape did he leave his family in?'"

One of the great missionaries of all time was Adoniram Judson whose years of fruitful service in Burma has been set forth in several thrilling biographies. In the latest of these, The Golden Shore, by Courtney Anderson, is a quotation from the diary of Judson's wife regarding their little son Edward. The child cried out in his sleep one night and his mother found it hard to confront him. He said over and over again that he was afraid. Their Only Haven Would Be The Grave

WASHINGTON The following is typical of many pathetic letters that have been sent to U.S. Government officials on the Hungarian crisis and our failure to support the freedom fighters in a military and material way. The writers of this communication are Mr. and Mrs. E.J.R., of Lima, Ohio.

"I am Sir: We are parents of three children, and we are trying to teach them to love God, to be loyal and proud Americans, and to be honorable in everything they do.

"But when our country sits by and watches ignoramus slouches and God-fearing people so loyal to their own country and their ideals that they lay down their

lives, as are the Hungarians, and our country continues to give billions of aid and comfort to such barbarians as Tito, how do you explain this to your children?"

MILITARY INTERVENTION WOULD MEAN WAR Here is my answer, based on the official viewpoint toward the Hungarian crisis:

In the first place, actual military intervention to prevent Russian brutality would mean a global war. The first and worst sufferers would be the Hungarian people, as well as those in every satellite country. They would be the unarmed soldiers on the front line of a nuclear conflict. The refugees' only haven then

would be the grave.

BEYOND THE PALE Meanwhile, President Eisenhower is exerting the pressure of world opinion against the Khrushchev-Bulgarian regime inside and outside the United Nations. Moscow now stands condemned before the bar of justice and humanity, and has been isolated from the civilized community of mankind.

Every great advance in human history has demanded sacrifices. Civilization has marched forward across fields of blood, as witness our own annals.

This is small consolation. I realize, in the face of the cries for mercy and assistance from the streets and squares of Buda-

Debt Trouble At Home

By ELMER ROESSNER

The bond market threatens long-term trouble for state and local governments. These governments, as pointed out here yesterday, face sharply rising expenditures, hence the necessity of higher tax levies.

Only a few state and local governments finance public works out of current revenues. Most of them raise the money by selling bonds.

Bonds increase the costs. For example, when a state issues a \$1,000, 2 1/2 per cent, 40-year bond, it pays \$1,000 in interest during the 40 years and then must repay the \$1,000 principal.

Thus a \$10,000,000 structure may eventually cost \$20,000,000 — which must be collected from taxpayers or, as is sometimes the case, from toll payers or tenants.

MONEY COSTS MORE But the political subdivisions cannot now borrow money at 2 1/2 per cent interest. Even the Federal government can't these days.

In an effort to check growing inflation, the Federal Reserve increased the basic interest rate and that, in turn, has boosted all interest rates. States, highway authorities, cities and school districts must now pay 4 per cent or better if they want to sell new bonds. Thus that hypothetical structure mentioned two paragraphs back may eventually cost \$26,000,000 if built with proceeds of bonds sold in today's market.

If the threat of inflation lessens sometime in the future, the Federal Reserve may lower the basic interest rate. Such a step will reduce the costs of borrowing money and therefore the total cost of public works built with borrowings.

However, bonds sold in the present market will carry today's interest rates on to maturity. If bond rates drop to around 2 per cent in, say, the 1960's, state and local governments will still pay 4-plus per cent on bonds issued during this high-interest period.

NEEDS CRITICAL NOW

The non-Federal governments are in trouble because their needs for public works were never so great. Some things, such as monuments and ornamental street lights, can be postponed. But there is no way of postponing new schools unless we can persuade those 39,000,000 children born since the end of the war to grow up a little slower.

Trouble is cooking on another burner. In November, voters authorized the issuance of \$2,519,000,000 in new state and local bonds. In addition, many local governments have previously authorized power to borrow money. Major General John Stewart Bragdon, White House consultant, says state and local governments must increase spending from \$10 billion to \$20.4 billion a year just to catch up with current needs. Most of these billions would have to be borrowed.

COMPETITION FOR MONEY.

The pouring of \$20 billion in bonds on the market each year would surely shove interest rates higher. Even the \$2.5 billion voted this year might have a serious effect.

State and local government bonds are rich men's pets. As a rule, the interest is lower than that on industrial bonds or dividends of many stock issues, but the interest is exempt from Federal income taxes.


A highway bond paying 4 per cent will give a high-bracket investor more take-home profit than a stock paying 6 per cent. Conversely, such a bond would have little interest for a low-bracket saver.

If too great a total of state and local government bonds are poured into the market, the supply of high-bracket investment money may run out and the issuers may be forced to boost interest rates high to attract other investment money.

All these forces on bond rates also tend to increase future taxes. OFF-BEAT ITEMS

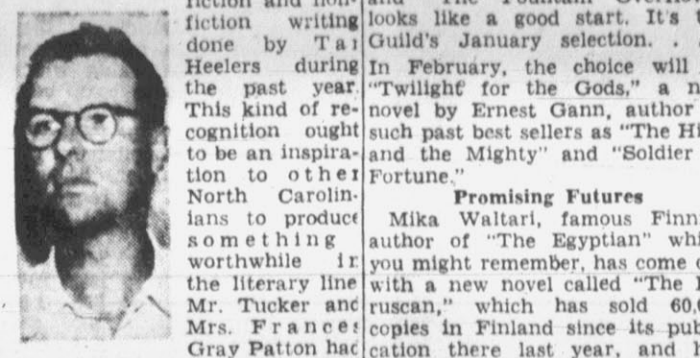

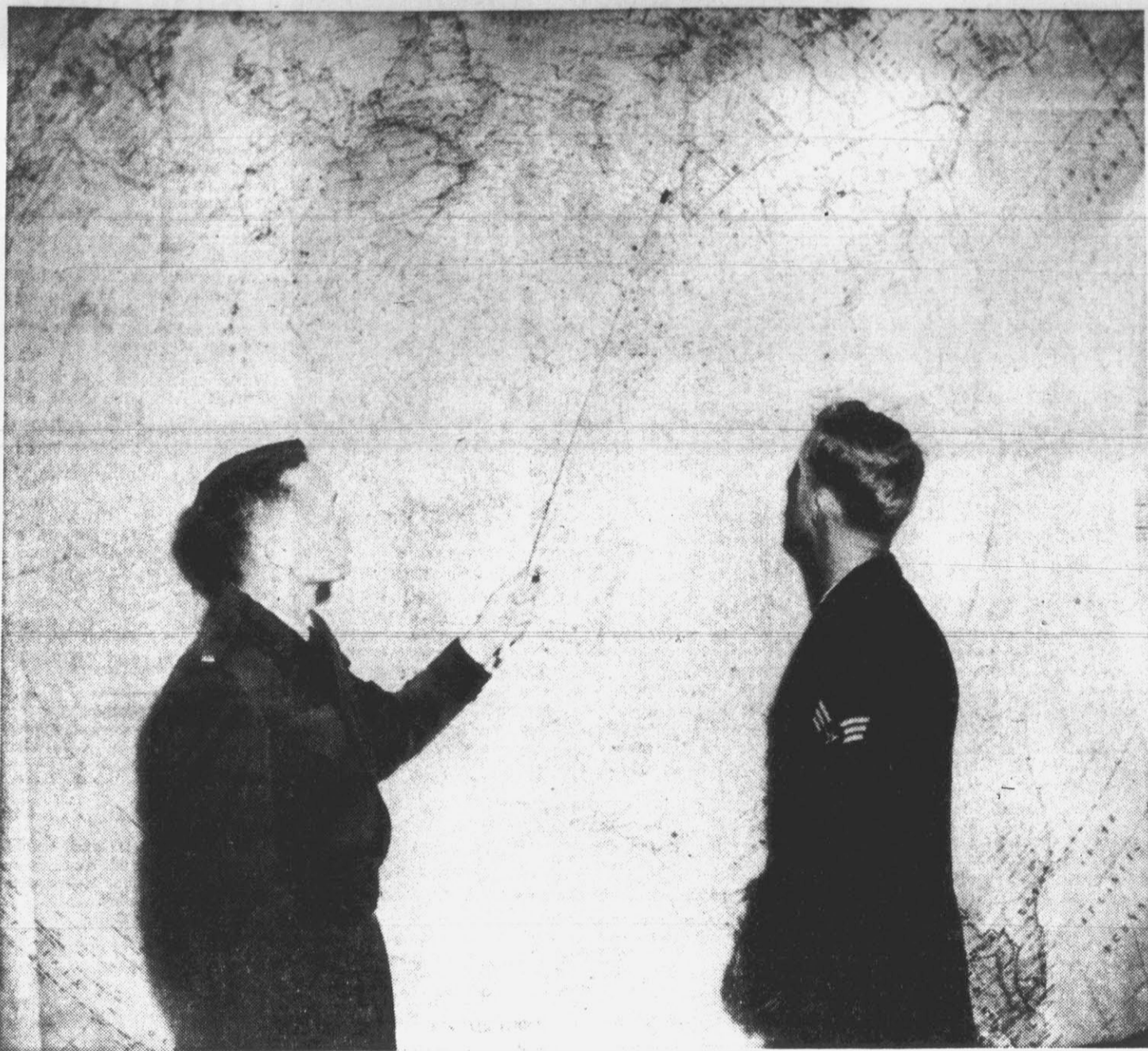

Approximately 25 members of the U.S. Air Force Reserve meet each Thursday night at 8 p.m. in the Austin building at East Carolina College.
They are members of Flight D, 9947th Air Force Reserve Squadron.
Under the command of Maj. Robert Michaels, the unit offers reserve officers in this area a specialized training course which is conducted on a pay status at Stallings Air Base in Kinston. The training covers a number of subject fields.
Officers and airmen are also able to obtain regular promotions as members of the reserve unit.

Toward Retirement
Each officer and airman must earn a total of 50 points per year in order for the year to count toward retirement. He is given a total of 15 points and he then must earn the additional 35 points to make a total of 50.
A maximum of 60 points per year can be earned toward retirement.
Points can also be earned in other ways than attendance at meetings. The reservist can earn retirement points by taking correspondence courses, attending summer camps or lectures.
In addition to the specialized

They roared back on court at the beginning of the third period and began to hit from all over. Tall, lanky center Bob Moore paced the home team with four well-executed shots from the floor and two free throws out of three attempts. The Bird lead shot up to 51-29 at the end of the period.

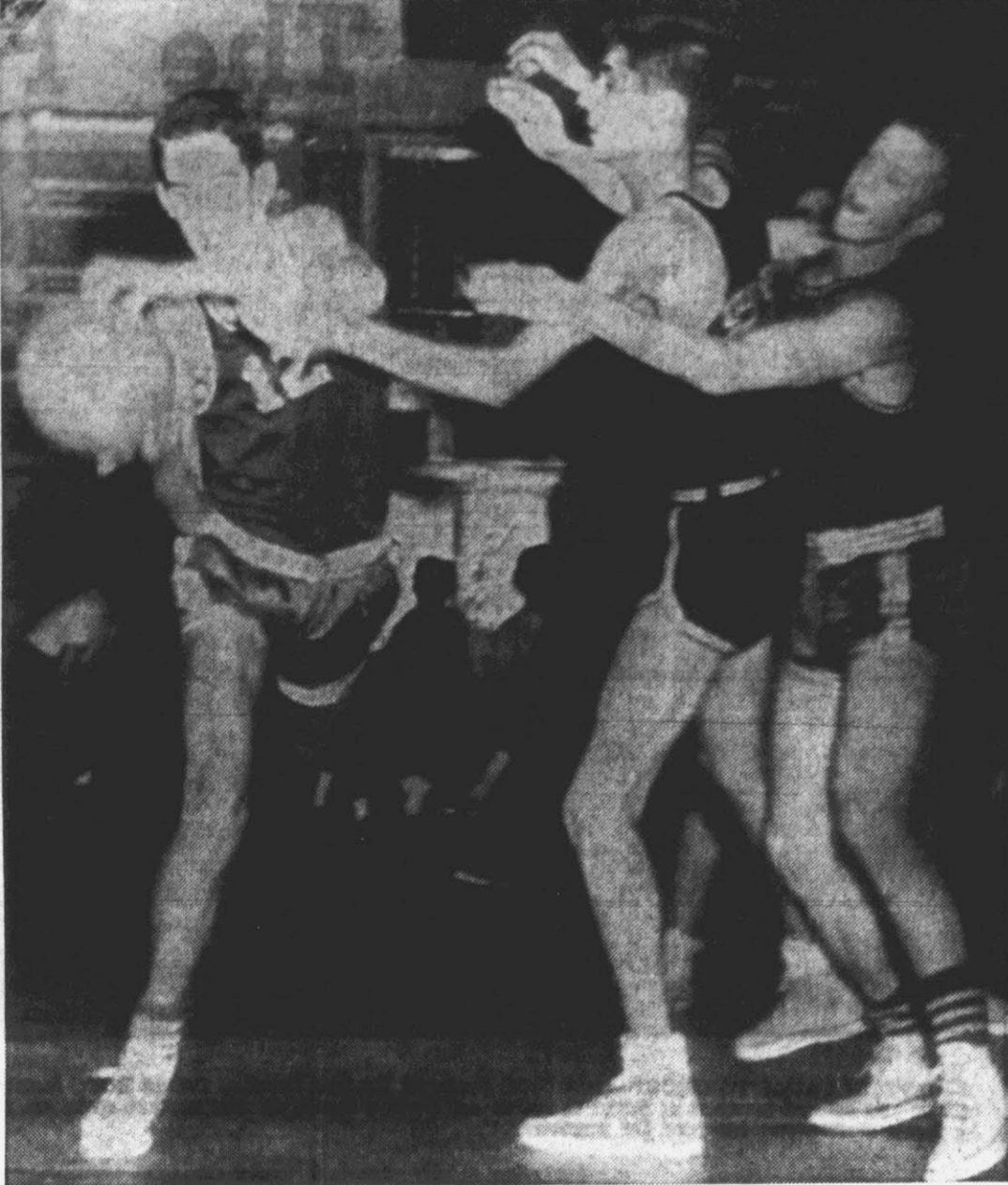
The Phants, too, played inspired ball during the third period, hitting on seven field goals and two free tosses. Substitute guard Walker Allen threw six points to pace the visitors.

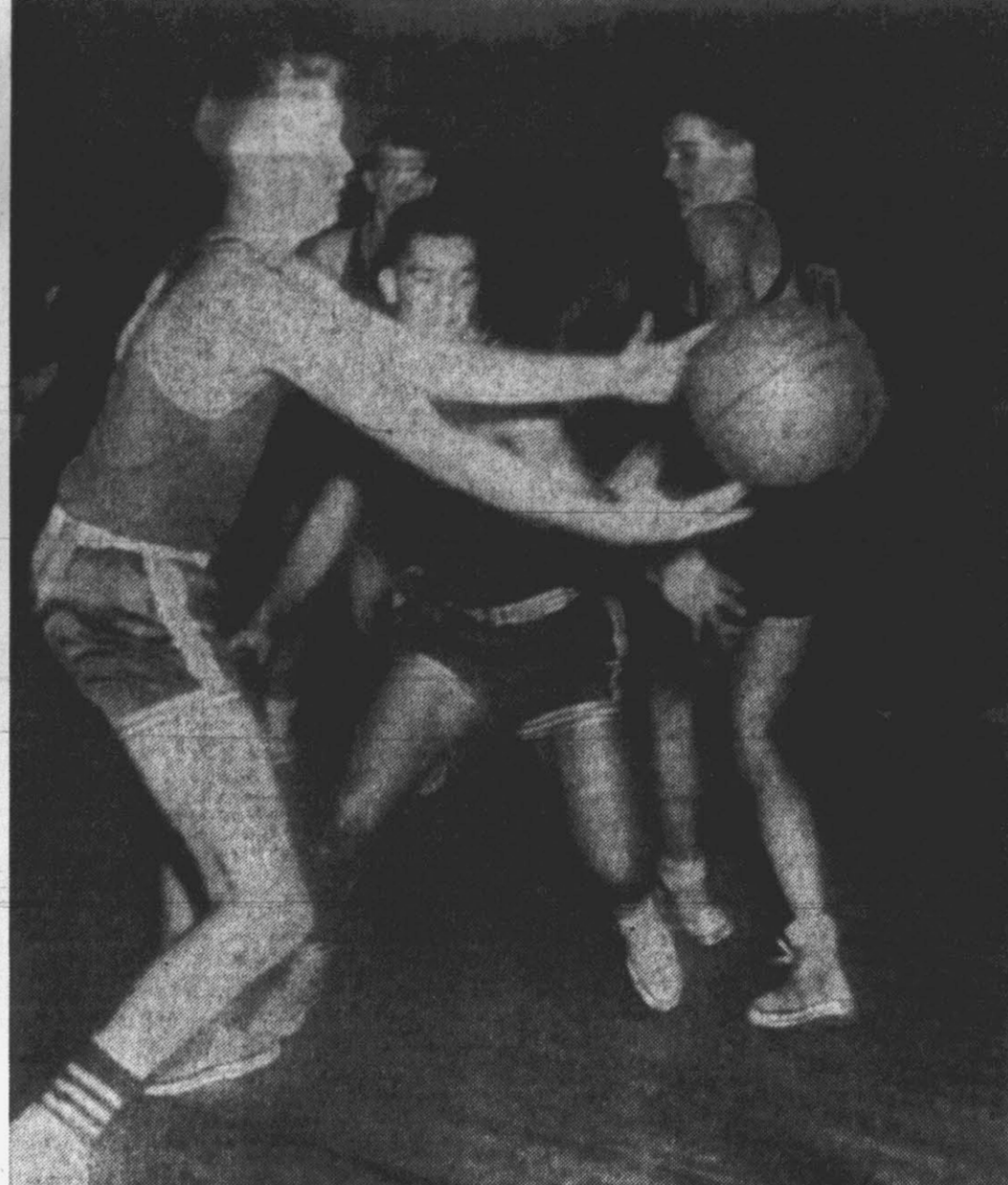

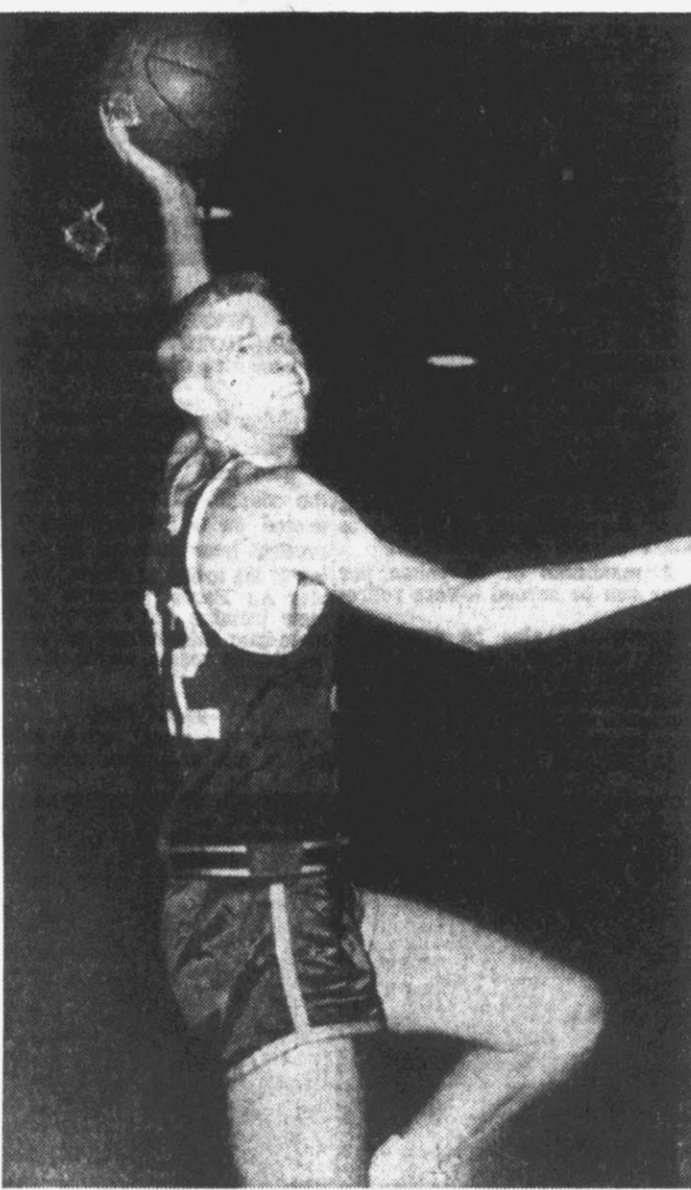

The game tonight will begin at 8:00.

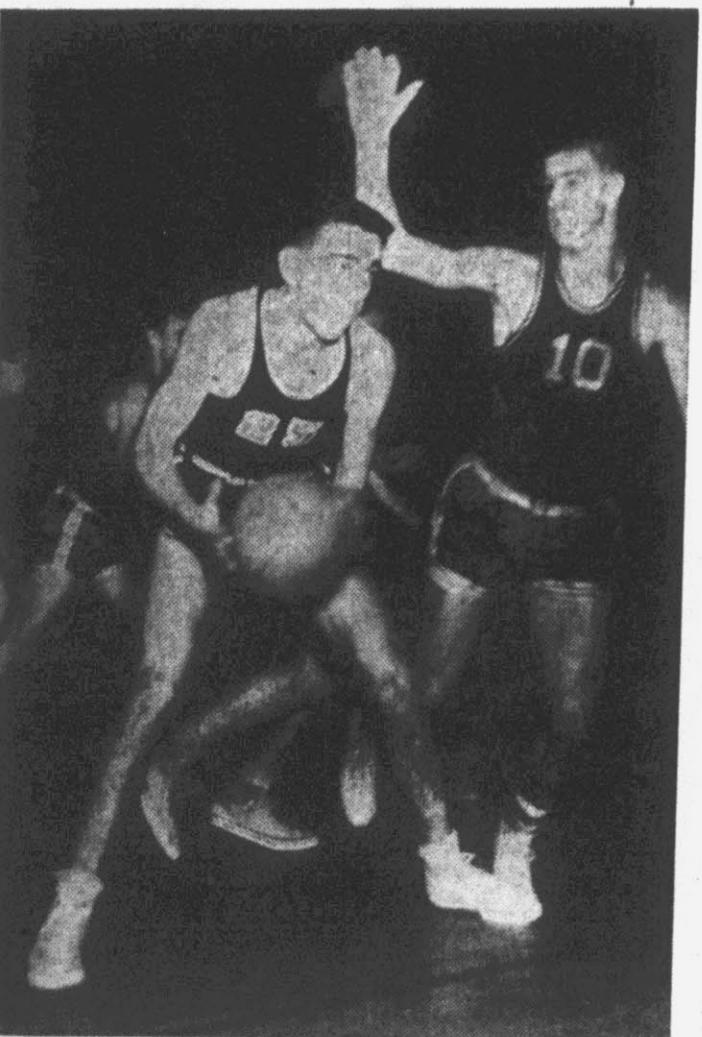
Fans Boed TV Bout In Ohio

It's been a week of surprises, but the latest may be the biggest yet—it seems the Wilt the Still isn't the only guy playing basketball for Kansas after all.

The Jayhawks, No. 1 team in the nation, didn't have much trouble winning their third of the season in a 77-63 decision over Washington at Seattle last night. Chamberlain, the 7-foot wonder, snared 30 points, but it remained for Maurice King, a husky guard, to take up the slack with 24 points.

Elsewhere, San Francisco, ranked No. 2 in this week's Associated Press poll, pushed its all-time record to 60 consecutive victories with a 67-48 job on Loyola of Chicago. But Alabama's victory string was snapped at 20 with an 83-78 defeat by still-unbeaten Duke.

Both results came in tournament play. San Francisco advanced to the finals of the Chicago Invitational and faces a "defeat that isn't" at the hands of the U.S. Olympic champions tonight. The

Olympians, who toyed around a 97-57 decision over Santa Clara, are not in the "collegiate" category and the result of tonight's game won't affect the Don's record one way or the other.

Bama, which has ruled the three previous Birmingham classics, was popped in the first round of the four-team scrap while Duke advanced to the title game tonight against also unbeaten West Virginia, which set a tournament scoring record with a 105-67 victory over inexperienced Mississippi Southern.

In another four-team, two-night tournament, Duquesne defeated C. Neve 65-52 for a championship berth in the Steel Bowl against Pitt, an 89-56 winner over Carnegie Tech.

Oklahoma A&M, beaten once in six starts, bumped off previously unbeaten Utah 73-68 and end the Utes' home court winning string at 33. Holy Cross, usually an Eastern power, lost its home court success record at 25, with a 90-74 pounding from twice-beaten Amherst.

Top Scorers In Duel Tonight

The Gamecocks apparently came into their own earlier this week when they knocked off powerful North Carolina State 75-61. The loss was the second in a row for the Wolfpack who were defeated 96-94 by Clemson in an overtime game.

The two State defeats dropped the Wolfpack down in the Atlantic Coast Conference standings and left Duke and Maryland at the top, each with two wins and no defeats. The Tar Heels are 1-0 in the conference going into tonight's game.

NASSAU, Bahamas (AP)—The Nassau International Hydroplane Regatta zoomed into its second day today with Henry (Hank) Lauterback a standout on two wins in opening dashes of the three-day event.

The Portsmouth, Va., boatman won the Governor's Trophy race yesterday, covering a 17-mile course in 14 minutes, 51 seconds at an average speed of 67.45 miles an hour.

Lauterback also gunned a 264-cubic-inch hydroplane over a five-mile course in 3:33.6 for a win in that class of competition.

F. C. Moor, Miami, Fla., won the 48-cubic-inch event of 1 1/3 miles in 5:17.9. George Fugate of Fort Lauderdale, Fla., with a time of 4:45.5, and Ed Schroeder of Niagara Falls, N.Y., 5:07.6, were twin heat winners in the 135-cubic inch division and Jack Colcock Jr., Seattle, Wash., took the 91-cubic inch race in 5:17.4.

Former Greenville Man Directs Army Program

FORT McPHERSON, Georgia—Third Army Headquarters here has announced Edwin L. Tyson, a native of Greenville, N. C., has been appointed fish and wildlife director as another step in its program of wildlife management on military reservations throughout its seven state area.

Tyson, 36-year-old former state biologist for Florida, has been selected to fill the newly-created position. He is a graduate of Duke University and received his Master's Degree from Florida State University.

In addition to his study of biology at Duke and FSU, Tyson studied game management at Washington State College.

Lt. Gen. Thomas F. Hickey, Third Army Commander, said Tyson's post became necessary because of the "tremendous potential" offered by the 600,000 acres of woodland found on the 806,000 acres of the Third Army Command, and to insure sound game management practices on military installations.

Tyson, operating from Third Army headquarters at Fort McPherston, will coordinate activities with state fish and wildlife services in the army area and advise post commanders in setting up their own programs.

He will also keep check on stream pollution, wildlife diseases and over-population of game and fish, should it occur. He is the first wildlife management specialist to assist an Army commander.

Bag and seasonal regulations on Army posts parallel those of the state in which a particular installation is located.

Tyson will visit all installations periodically in his assignment of coordinating between state and military agencies.

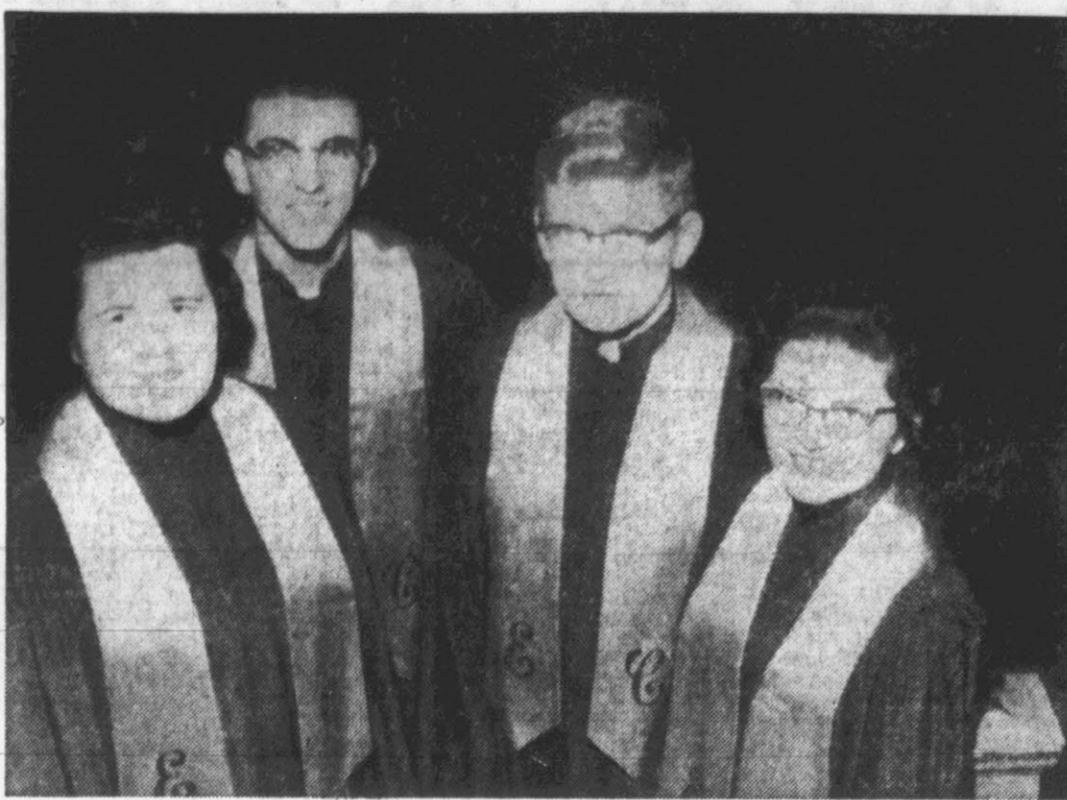
A new Army regulation dated Nov. 6 states that persons hunting or fishing on military reservations must hold an approximate license from the state in which the reservation is located.

Negro Cardinal Seen Possibility Safety Contest Staged By Stokes School Club

VATICAN CITY (AP)—The first Negro to wear a cardinal's red hat may well emerge from the next consistory to create princes of the Roman Catholic Church. And the consistory, whenever it is held, also could see an increase in the number of U.S. cardinals, now four.

Should Pope Pius XII select a Negro, it would conform with his expressed desire to keep the church's high senate body as representative as possible.

During the past 10 years the church's membership in Africa, known in missionary circles as Catholicism's "Black Flower," has increased from 12 million to more than 20 millions—outstripping the rate of worldwide growth. The church's membership today totals 472 millions.

Vatican circles believe that prelates under consideration for cardinals could well include Negro Archbishop Joseph Kiwuka of Masaka, Uganda. He is 59 years old, relatively young to be a candidate for the exalted rank.

In addition to recognizing Catholicism's growth in Africa, his choice also would contain a slightly sentimental note. Pope Pius XII, in one of his first acts, consecrated the Negro bishop in 1939 in St. Peter's Basilica.

An increase in the number of American cardinals also would recognize the growth of the church in the United States. Membership there has increased from 22,536,242 in 1942 to 33,574,000 today.
