Even years ago in October, eighty nations met in San Francisco and formed the U. N. in order to try to cool off hot spots of the world and thus avoid wars.

Orange, a warm homelike color, was used to tell how J. D. Rockefeller gave property in New York City to be used as a home for the U. N. All of this property did not cost as much as two days of war in World War II, Mrs. Starling noted.

Yellow stands for international friendship and understanding; green represents life, growth and prosperity, the speaker said.

There are twelve agencies in the U. N. working on the problem of improving conditions. As an example, she told of planes from a number of countries going into Iran to spray for locusts.

Blue stands for truth—trying to find both sides of a situation and then to remedy that situation.

Indigo is a reminder the U. N. is made up of many colors and is trying to help people all over the world to understand each other.

Mrs. Starling continued.

Violet, a timid color, represents the underprivileged parts of the world.

"Science teaches that all colors of the rainbow combined make the color white. White stands for friendship. In the U. N. Building there is a room which is used for prayers and meditation.

By joining hands, people from all over the world can come to a better understanding and make a smiling world," Mrs. Starling concluded.

Pianist Gets Ovation At Six

MUNICH, Germany (AP) — In the land of Bach, Beethoven and Brahms, a little six-year-old American girl is getting rave notices as a pianist.

Of Giordina Bender, daughter of a retired U. S. Air Force colonel, German critics have written: "She is a wonderkind (prodigy)." "She is a new starlet of the heaven of music."

"A miracle of musical memory with striking deep musical expression."

And one newspaper noted, she is a bit temperamental, refusing to perform if the piano is not to her taste.

Giordina is the daughter of former Lt. Col. and Mrs. George F. Bender, who live at nearby Diessen. He retired in Bavaria, he said, because he finds his Air Force pension goes further here.

The child was born in Ohio. Her parents have been on the move so much that they no longer have a "home town," Mrs. Bender is a sister of Frank Ricciardi, a New York opera singer who lives in Badminister, N. J. Col. Bender's family lives in Reading, Pa.

Giordina started learning to play the piano at the age of 3½. Her first teacher was her mother. Now she is under the guidance of Prof. Richard Trunk, 73, who composed a "musette for piano" as a present for his star pupil when she was six a few weeks ago.

The curly-haired little girl has performed here several times and her mother says that three more concerts are scheduled.

She plays eleven classical pieces without notes. "It's hard to imagine" one critic wrote, "how those little fingers can handle such difficult music."

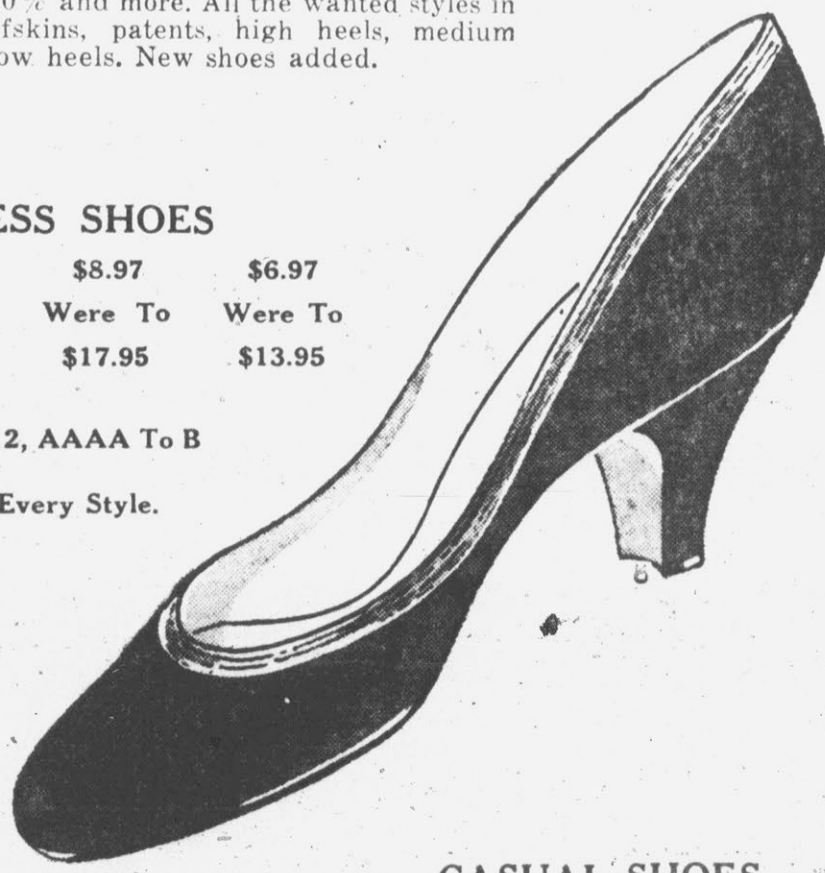

New Light On Needed Tax Revision

Remarks of Kenneth C. Towe, president of American Cyanamid Company, should impress upon North Carolinians the need for revising the state's tax structure if North Carolina is to realize its potential in industrial development.

Mr. Towe, speaking in Farmville, pointed out quite frankly that North Carolina for years has been known to industry "as one of the three or four highest tax states in the Union—especially for corporations chartered by other states." In the case of locating the new Flakeboard plant, he said, other factors "were more than adequate to overcome the adverse effect of the tax disadvantage in the governmental climate."

But . . . How many instances have there been in which advantages of industrial sites considered in North Carolina were not adequate to overcome the "tax disadvantage"? How many more industrial plants and payrolls would North Carolina have today if its tax structure had been more favorable for industry?

Of greater importance, how many companies will disregard possible plant sites in North Carolina in years to come if the state's tax structure for corporations is not changed?

Although the proposed changes in North Carolina's corporate tax structure may mean a loss in revenue of up to \$9 million annually under current conditions, this loss can be more than compensated for by new industries which will be attracted by the tax change.

The people of North Carolina must follow Gov. Hodges example by squarely recognizing and acknowledging the fact that the state's tax structure is now and for years has been "unfair" to out-of-state industries. The proposed recommendations for changing this tax structure sets forth a plan to fairly revamp this structure without offering any give-away program to industry, and without shifting an unfair tax burden to any other segment of the state's population.

If citizens of North Carolina can bring themselves to recognize these facts, the state can equip itself with a modern set of tax laws which will be an advantage in industrial development rather than the handicap which the tax structure has been in past years. And certainly there is no need to fear that the initial loss in revenue will long remain. Greater industrial expansion in the state brought about by a fair tax structure will make up initial revenue losses many times over in years to come.

North Carolina in past years has been able to attract industry not because of, but in spite of its tax structure. From this point of view it is quite obvious that the state offers industry many other advantages

which overshadow those of other states. If the state can now combine a fair tax structure for corporations with its wealth of natural resources and other advantages for industry here, it can expect to see its rate of industrial growth increase rapidly.

If North Carolina refuses to afford corporations with a fair tax program, it cannot expect to reach the industrial potential it should have.

Eden Was Right Once; How About This Time?

Historically, "Perfidious Albion" performed miracles in the field of balancing national interests with that sometimes vague quality known as international justice. Self interest usually prevailed, as it should in any government responsible for national welfare.

When war was the required answer, then war it was. When intrigue and delicate negotiations were required; that was the path to be taken. Somehow, they "muddled through". Their success rankled others.

For a very long time, Great Britain has been a keystone in the structure of the Free World. It still is.

And the resignation of Prime Minister Anthony Eden has its impact on the rest of the nations which like to think liberty and fair play are part of their characteristics.

A word about Sir Anthony. He quit a high cabinet post because of appeasement toward Hitler's Germany. Events proved him right.

It's to be assumed that the frustrating experience of Middle Eastern difficulties lie behind his late resignation. He must have believed it was time to remove the velvet glove . . . and then the outcry at home and abroad balked him. Too many voices cried for peace at any price. That price has already been proven high.

History proved him right once before. We hope he was not right this time; but there's room for wondering.

Early Plans For The J-J Dinner

DINNER — There will be a North Carolina Jefferson-Jackson dinner this year. Tickets to the dinner will be issued on basis of one for each \$50 contribution to the Democratic national committee's war chest. The date and the speaker for the occasion have not been decided upon.

Chances are the date will be later in the spring than usual, maybe either March 15, which is the anniversary of Andrew Jackson's birth, or April 13, Thomas Jefferson's birthday. However, in recent years the date of the dinner has had no relationship to any particular historic event, but has been fixed at the most convenient time.

Several reasons make a later than usual date advisable this year. Deferred meeting of the General Assembly and the inauguration of Governor Hodges set for February 7 will keep the party leaders occupied until after that time. Illness of National Committeeman Everett Jordan, who went back to Duke hospital early this week, has interfered with advance planning for the money raising dinner.

The "boys" who put up the cash for political campaigns were hit pretty hard last fall, and it was thought well to let them recover a few additional weeks to come before hitting them again. Perhaps the main reason for postponement of the dinner is the problem of obtaining a satisfactory speaker.

Specifications for the speaker are complex. He must be of national prominence in Democratic circles, and at the same time must be a non-controversial figure. He cannot be too close to Governor Hodges or to Senator Scott, but must be friendly to both. He cannot be too strong a partisan of the New Deal or the Fair Deal, and certainly no Eisenhower supporter will be acceptable.

UP-COMING—Without thinking of any particular individuals the party leaders are giving thought to choosing a speaker from the ranks of younger leaders, maybe some new governor or senator, who has not acquired severe battle scars in national campaigns but gives promise of moving to top ranks within a few years.

Experiences of the past few years and results of the last election have caused North Carolina Democrats to give more serious thought to new ideas—and to younger people to put these ideas into effect. Although the state is still safely Democratic

at all levels, inescapable fact is that the margin has been progressively narrowed at every election within the past 20 years, especially on the national ticket. It was dangerously close last time.

One ardent Democrat who is also a devotee of Sir Walter Scott quipped the other day that if the Democratic dandelion is to be saved from an unholy union with Republicans, she must be saved by some young Lochinvar out of the West. Maybe the situation isn't quite that serious. At the same time, it will not be surprising if the main speaker at the 1957 Jackson-Jefferson Dinner is a man who hasn't been too prominent political news up to now, but is likely to be featured in headlines during the next four to eight years.

While the Democratic party in North Carolina has boasted for half a century of its progressive-ism, and for most part it has been progressive, it is historically true that often progress interest to the inner circle of party leadership by young rebels. The party organization has been inclined to line up with politicians on the way out rather than adopt those on the way in. It is also true that after the young rebels take over they like the feel of power and become entrenched to the point they resent assaults of younger rebels.

Y.D.C. — All of which lends interest to the Jackson-Jefferson Dinner this year and the kind of progress that will be offered. It also focuses attention on the Young Democratic Clubs statewide meeting at Greensboro this weekend. Main feature of the program will be the Saturday night dinner followed by a dance. Principal speaker at the dinner will be Rep. Frank Thompson of New Jersey, one of the Young Democrats in the Congress.

Earlier in the afternoon there will be a general "Democratic workshop" at which there will be down to earth appraisal of why the Democrats didn't do better last November and suggestions for improving the situation in the next election.

Governor Hodges and other old line party leaders have voiced concern at the deflection of so many young voters from Democratic ranks. The regular party organization has not yet shown much active concern about reversing this trend, but the YDC folks are beginning now to make plans for holding the youngsters who voted Democratic in November and getting more of their fellows to join them in 1958 and 1960.

Less than a month ago, he decided to find his future in the United States. He was one of Hungary's Olympians who chose not to return to his native land.

Despite all these things which have made Laszlo Tabori a man to admire, I still feel a genuine sympathy for him. He's having a difficult time digesting his first taste of democracy.

Laszlo, who had been on a

tour of the United States with other Hungarian athletes, left Miami Wednesday with his coach. He isn't, happy with the treatment he has been getting. He explained his rather abrupt departure by saying, "People can't afford to give me a place like I'm used to."

He went on to say that under communism, he and other star athletes were given "the best of everything" and he can't understand why American amateurism doesn't provide the same red carpet treatment.

What Tabori, and any other person new to democracy, must understand is that democracy has become America's driving force because it makes no allow-

ance for privileged classes. It recognizes, certainly, accomplishment and unusual achievement but democracy does not set a man apart because he has done something special.

Laszlo Tabori must learn that democracy will guarantee him the privilege to be a great runner, a good carpenter or anything else he has ability to make of himself. It will recognize his worth as an individual in a great nation but it will not recognize his claim to special treatment because he has become an outstanding individual.

America has become the world's haven for millions of oppressed, discouraged and tried people. It has been understandably difficult for some of them to comprehend the intangible forces which have made America outstandingly different. They have, however and in time, come to recognize those forces and to make them a part of their lives.

I believe Laszlo Tabori can become a great American. I believe anybody with vision, intelligence and guts can become a great American.

But before Laszlo Tabori, a new American, or anybody else for that matter, can become a great American he must accept the truths proved by time and our way of life.

This is not an idle dream with me. It is something that has become a forceful part of my life. I thank God that I was born here and will not have to know the agonies Laszlo Tabori will know before it becomes a part of his life.

Other Editors Saying-- The Forgotten Refugees

(Lexington Dispatch)

WHILE the generosity of the American people is very properly stirred over the plight of thousands of Hungarians who have fled their oppressed country in search of freedom and new opportunity, they should not forget that there are many thousands of others in refugee camps in Europe who have fled from the same terror and who have only partial hope for rescue.

A religious publication of national circulation points out in its current issue that there are something like 160,000 who have fled from the Red terror now poorly housed in cheap barracks or worse quarters, principally in West Germany. These include Latvians, Estonians, Lithuanians and more largely Germans from East Germany. There are also those who have fled from western portions of old Russia, from Czechoslovakia and some other regions under Russian domination.

Almost four years ago President Eisenhower pledged that a very large number of the refugees would be brought to this country or be aided by our country in finding homes in other free nations of the West. A refugee checking program was taken out from under the State Department, which then was under fire by isolationists, and placed under the Defense Department. It became necessary to enlist personnel to go to Europe and conduct screening examinations of the refugees.

There was little time to give special training of personnel, and still less for many of them to obtain a working knowledge of German or other languages used almost exclusively by the refugees.

No doubt those who went to Europe to work in this program did as good a job as lay within their powers. They could not go into the countries from which refugees had fled to make an effective check on their records. They had to rely mainly on the stories told by the refugees themselves and by their friends in the camps.

End Of Republican-Southern Ties

WASHINGTON The gradual breakup of the postwar coalition of Republicans and Southern Democrats in the Senate assures passage of the Eisenhower Civil Rights program. In the opinion of White House advisers and GOP leaders on Capitol Hill.

Under political and presidential pressures, the alliance which plagued F.D.R. and Harry S. Truman is collapsing. It is the first specific success which Ike has gained in his professed ambition to "liberalize and humanize" the Republican Party in preparation for the 1960 election. Eisenhower has set out deliberately to refit the support of the colored and other minorities which gave him such a great majority last November.

IRONIC ASPECTS The process of the coalition's dissolution has ironic aspects. Whereas it was expected that the common interests of the West and South — natural resources, power, agriculture, tariffs, etc. — would

incline them to unite on major issues, it has been a band of political Lochinvars from the West that has lined up against Dixie.

It was Chief Justice Earl Warren of California, an Eisenhower appointee, who delivered the Supreme Court's decision against segregation in education and transportation. Now, Vice President Nixon has declared that he would hold the key provision of the Senate rule barring limitation on debate to be unconstitutional, if the opportunity were given him.

The third member of the powerful California trio—Senate Minority Leader William F. Knowland—has said that he will support a Civil Rights program, even though he voted against the liberal bloc's effort to change the rules.

Finally, 16 of the 39 Senators who voted for revision of Rule XXII, which permits unlimited debate, come from states in the Midwest and Far West. Five were Republicans, and they ad-

mittedly voted against future filibustering because of the Eisenhower-Nixon attitude.

PRESIDENT'S APPEAL WILL BE HEEDED Two other members—Neely, Democrat from West Virginia, and Wiley, Wisconsin Republican—would have voted against the South, had they been present. Their votes would have brought the anti-filibuster total to 40.

Six Republican Senators who opposed the rules change will heed President Eisenhower's appeal on behalf of his Civil Rights proposals, if he chooses to apply greater pressure than he did at the last session. Ordinarily, with the normal number of absentees, 46 Senators are enough to provide a majority.

In addition, there are about 10 Senators, Republican and Democratic, who cannot afford to oppose these measures in a showdown, even though they voted with the South in the recent test. They have too many colored voters in their states, and several

Busy Hands Recipe

NEW YORK (AP) — Amid all the suggestions on how to cure the nation's growing problem of juvenile delinquency, Dr. Laurence C. Jones offers a simple, old-fashioned prescription:

"The only solution is to keep the young people busy. Give them something worthwhile to do. Then they'll stay out of trouble."

Does this remedy sound too easy? Dr. Jones says it has worked unflinchingly with 6,000 boys and girls he has educated since 1909.

In that year Dr. Jones, a northern Negro with a college degree, \$1.65 in cash, a few clean shirts—and a lot of faith — started the Piney Woods Country Life School. The site was a clearing in the woods 22 miles southeast of Jackson, Miss. His first desk was a stump. His first class consisted of three boys who could neither read nor write. The ceiling of his open-air classroom was a cedar tree.

Today Dr. Jones, known as "The Little Professor of Piney Woods," and his "work-as-you-go" school are nationally famous. Other educators listen with respect when he says:

"The boy gangs we have now are just a result of not giving our young people enough to do.

"They have energy and have to do something — good or bad. In the old days they had chores. They don't have enough chores at home anymore to keep them occupied.

"You have to keep them busy. You can't build enough boys' clubhouses to give them all the recreation they need. It would cost too much. But there are plenty of public schools already built that stand empty at night.

"Why not keep them open in the evening and provide them with programs to keep the young people busy? It would be a big help."

At 72 Dr. Jones, his brown face a lamp of kindness, is anxious to see more common-sense understanding applied to the problem of curbing juvenile delinquency.

In nearly a half century, helped by more than 50,000 individual contributors (both white and Negro), he has built up a million-dollar endowment for his own school, which now has 500 students, a faculty of 46, and a \$250,000 plant consisting of eight buildings on 1,700 acres of farm and woodland.

For his efforts Gov. Hugh White at a testimonial meeting in 1955 acclaimed him "Mississippi's First Citizen."

To raise his annual budget of \$80,000, Dr. Jones now travels some 50,000 miles across the country, makes as many as 12 speeches a week to churches, civic clubs, educational groups. Somehow — he himself puts his faith in prayer — he always manages to raise the money he needs, and without any foundation grants.

"If you work as if everything depended on you," he said, "and pray as if everything depended on God — well, it's a hard combination to beat."

"All our students — they now come from 12 states — could be called underprivileged. If they have enough money to pay tuition, we send them home.

"About half are from broken homes, and a fourth are orphans.

"They work 3½ hours a day, and spend five hours a day studying. We teach classes from the seventh grade through junior college.

"Each student is taught not one trade but at least two — and sometimes three — so that if he can't find work at one trade he has another to fall back on.

"We've had a lot of what are called 'bad boys.' But they all fall in line. It's the spirit of the place. Once they are given something worthwhile to do, we have no trouble with them."

"We keep pretty close track of our alumni. We have no trouble getting them jobs, because people know our graduates don't mind rolling up their sleeves. Not one of our graduates, so far as we know, has ever gone to jail."

Although most of his alumni remained skilled craftsmen, others have gone on to become doctors, educators, lawyers, pharmacists and businessmen.

SKIRMISH FOR THE FUTURE

Two men now hold the fate of Civil Rights legislation in their hands.

President Eisenhower must throw himself into the fight with sincerity and determination, even going so far as to make the question a major Party issue. He did not advance this program until late in last year's session — April — and then he showed little interest in it. But the November results, when he corralled a huge Southern and colored vote, may lead him to change his tactics.

Senator James O. Eastland, segregation champion from Mississippi and Chairman of the Senate Judiciary Committee, must be prevented from pigeonholing this legislation, which passed the House by a comfortable margin last year.

As Nixon's comment indicated, and as Capitol Hill realizes, the Civil Rights question is not so much a legislative controversy as the first skirmish in the 1960 Presidential battle.

Anglo View Of U. S. Economy

If it sometimes pays to see ourselves as others see us, know that "The Economist" of London, one of the most respected economic journals in the world, says that the United States has a "service economy."

It may be right. This is how it arrives at that conclusion:

"The United States manufactures far more than any country on earth, but it is not a manufacturing nation; only about one in four members of the labor force works in a factory."

"It eats very well and exports vast quantities of farm products besides, but it is not a farming nation; only 10 per cent of the labor force is now engaged in agriculture, compared with 20 per cent as recently as 1939.

BUILDERS, BUT — "It builds more than any other country, except perhaps the Soviet Union, yet less than 5 per cent of the labor force is engaged in construction."

"Americans now earn their livings predominantly by providing services or by distributing and transporting goods. With workers at all levels of government added, these people come to half the total labor force and well over half the nonagricultural labor force."

"Consumers spend three times as much on services as they spend on all durable goods put together, including automobiles."

"It is beginning to appear that the fundamental mistake made during recent years by the pessimists . . . has been their failure to recognize the 'prosperity effect' provided by the astonishing diversity of an economy with the standard of living of America today."

The Economist observes that this diversity and emphasis on service helps to make the American economy more stable than one based on manufacturing or farming or both. It explains, "There has been a farm slump for four years, and there was a sharp manufacturing slump in 1954 and yet, in terms of total employment and income, the United States has never stopped being prosperous since the war."

"What is more, the experience of stability — plus the widespread conviction that the Government can and will act to prevent anything serious from happening to prosperity — has contributed to the amazing williness of industry to invest."

There is one flaw. The Economist holds. That is the worry that prices will go on rising in 1957. One reason for this is something not discussed much: the productivity in distribution and services. Or, as the magazine seems to be saying, the lack of rise of productivity in that area. It states:

"An American garage mechanic or bus driver or shop hand or bartender rightly insists on being paid a wage in line with the rising standards of his society. But in this type of work it is frequently impossible to do anything by capital investment to improve productivity. Therefore the price of the services provided must of necessity rise to cover the higher wage costs."

The Economist points out that wages of production workers rise roughly the same as productivity increases. When other wages rise in the same ratio, it appears that total wages rise twice as much as the rise in productivity, and only price increases can provide the money with which to pay them.

John the Baptist called on the people to repent of their sins. Many came to him confessing their sins, and were baptized by him.

When Pharisees and Sadducees came to the baptism, John chided them, asking, "Who hath warned you to flee from the wrath to come?"

After being baptized, Jesus was tempted by Satan three times, but remained sinless. He told Satan to be gone, as it was God alone He would serve.

Jesus went to Galilee and saw two brothers casting their nets. He called them and they followed Him.

CHRIST TOLD SATAN TO BEGONE, AND REMAINED THE SINLESS ONE

Scripture—Matthew 3-4.

OUR LAST lesson ended when the Holy Family returned to their homeland and settled in Nazareth. St. Matthew gives us no details of Jesus' life between the time when He returned from Egypt with His parents, and His appearance before He began His ministry after His baptism and the temptation in the wilderness.

Only Luke tells of the birth of John the Baptist and of his retirement to the wilderness where he lived a hermit's life, until his return to preach repentance of sin and the coming of Jesus Christ, as prophesied by the prophets of old.

He must have appeared an odd person in "his raiment of camel's hair, and a leathern girdle about his loins; and his meat was locusts and wild honey."

People flocked to hear him and to be baptized by him, confessing their sins. He must have received these gladly, but "when he saw many of the Pharisees and Sadducees came to his baptism he was angered, saying O generation of vipers, who hath warned you to flee from the wrath to come?"

and eat. Jesus said: "Man shall not live by bread alone, but by every word that proceedeth out of the mouth of God." The second temptation was to throw Himself from the pinnacle of the temple, trusting that God's angels would bear Him up, saving Him from harm. To this Christ said, "Thou shalt not tempt the Lord thy God."

Then Jesus was taken to the top of a very high mountain, and Satan offered to give Him all the kingdoms of the world, which were spread out before them, if Christ would worship him. What affront! Who among ordinary men would worship the devil? Even sinners would not want to pledge their allegiance to the evil one, although we have seen in our time how Adolf Hitler was virtually worshipped by thousands who performed the most cruel and dastardly deeds at his bidding.

Then Jesus said (and we can well imagine the anger with which He spoke), "Get thee hence, Satan; for it is written, Thou shalt worship the Lord thy God, and Him only shalt thou serve."

Bring forth therefore fruits meet for repentance. He also warned these men not to plead that Abraham was their father, for it would do them no good.

These groups were the two chief Jewish parties. The Pharisees were strict observers of the laws, ruthlessly denouncing anyone who did not rigidly keep all the traditions that had accumulated around the law of God through hundreds of years. The Sadducees were the theological liberals, few in number, but well educated and often wealthy.

Jesus, too, came to be baptized by John, who was reluctant at first to baptize Him, saying that he, John, should rather be baptized by Him. Jesus, being sinless, had no need to be baptized, as He had no sins to confess, but we may conjecture that He felt it would please His Father, God.

So John baptized Jesus and as He came from the water a voice from heaven, spoke: "This is My beloved Son, in whom I am well pleased."

Then was Jesus led up of the spirit into the wilderness to be tempted of the devil. After He had fasted for 40 days and nights, and was "an hungred," Satan came to Him, suggesting that He could turn the stones into bread.

Satan left Jesus then, and angels came to minister to Him. When Jesus heard that John the Baptist had been imprisoned He went to Capernaum and began to preach. Here He found four of His apostles, first Simon Peter and his brother Andrew who were casting their nets into the sea. Jesus said: "Follow Me," and at once they left their nets and followed Him.

Then Jesus saw James and John who were with their father mending nets. At the Lord's call they too left their father and followed Him, and all the rest of their lives they accompanied Him, and when He left them they carried His message to many peoples. All but John were martyred.

The teacher of the younger classes cannot do better than to discuss the temptations that they meet in their daily lives—the temptation to cheat at lessons, to be cruel or unjust to others, to help themselves when in shops without paying, etc. Tell them that when they are so tempted, they should think of Jesus and ask for His help in resisting.

The older pupils should be reminded that only by leading lives of morality and integrity can their lives be successful.

Remove Bullet Pressing Heart PHILADELPHIA (AP)—A rifle slug that lodged in a girl's heart for at least 12 days and eventually would have torn through the muscle of the organ has been removed in a successful operation, Bryn Mawr Hospital announced yesterday. Hospital officials said 9-year-old Beverly Ann Cheek of nearby Cotesville was in good condition following removal of the .22 calibre slug Wednesday by Dr. John B. Flick Jr. The child was shot accidentally by her brother, William, while the family was visiting at Lenoir, N. C., Dec. 23. The bullet struck Beverly Ann in the shoulder, ricocheted to her left jaw, then bounced into the neck behind the breastbone, entering the jugular vein. Hospital officials said prompt action by the girl's mother, Mrs. Leslie Cheek, in applying pressure to stop the flow of blood saved her. Rays taken at the Bowman Gray Medical School in Winston-Salem, N.C., showed that the slug had moved into the heart by Dec. 28. The family was advised to return to Pennsylvania for the operation. Beverly Ann walked into the hospital last Friday for preliminary tests. Doctors said the slug was being pushed against the heart wall with ever beat and eventually would have worn a hole through the muscle. Dr. Flick blocked off circulation to the heart chamber with his fingers, cut the bullet out quickly and pulled stitched thread taut to close the wound immediately.

Terps Upset Duke, UNC Now Firmly Atop Loop

Powerful North Carolina, at last clearly ahead in the Atlantic Coast Conference basketball race, plays the first of two weekend conference games tonight that should allow the Tar Heels to increase their lead.

The nationally ranked No. 2 Tar Heels play Clemson tonight and Virginia tomorrow night, both at Chapel Hill. North Carolina, 3-0 in the ACC and 12-0 over-all, is a top heavy-favorite to beat the league's two bottom teams.

Duke, which had been tied for first with the Tar Heels, dropped its first ACC contest of the year last night, losing a stunning 51-62 game to Maryland at College Park.

North Carolina State, which plays a crucial game with North Carolina in Raleigh Tuesday, took a 63-58 win over Florida State last night and Wake Forest dumped Seton Hall 64-55 in the nightcap of a Madison Square Garden double-

bill. The 51 points Duke managed against Maryland were the lowest number of points scored by a Blue Devil team since the second game of the 1955 season when Maryland beat Duke 49-47.

Maryland led at the half, and after scoring 18 points in nine minutes, the Terps were never headed. High man of the night was Maryland's John Nacinick with 17 points. He got help from Bob O'Brien and NICK DAVIS with 14. Duke's best effort came from forward Jim Newcome with 14 and Bobby Joe Harris with 12.

Wake Forest's win over Seton Hall pushed the Deacons' overall record to 11-3 for the season. The Deacons haven't played a conference game since Dec. 11 and their game against South Carolina tomorrow night will be their first chance to improve their 1-2 ACC record.

The Deacons had to come from behind 42-47 in the second half to drop Seton Hall. Center Jim Gilley and forward Jack Williams

led the assault. Gilley with 24 points was high for the night followed by Williams with 18.

Only 4,000 saw N.C. State drop Florida State in a routine game. A pair of Wolfpack guards, Lou Pucillo and John Maglio, led the scoring for the ACC team which boosted its over-all record to 8-6. Pucillo bagged 13 points and Maglio 10.

Florida State, which lost its 10th game in 11 starts, was led by Fred Twomey with 19 points.

Hot action in the North State Conference last night saw Lenoir Rhyne roll to its eighth straight victory, an 80-71 win over Western Carolina, and High Point edged Elon 83-82 on a field goal scored the other game. Guilford won its first conference game 71-58 over Appalachian.

In addition to North Carolina's clash with Clemson, Belmont Abbey's invasion of Newberry is the only other game scheduled tonight.

As usual it was Lenoir Rhyne's Raeford Wells with 33 points who led the Bears. He connected on 17 of 23 attempts from the free throw line and hit eight field goals for his total.

Walt Cornwell followed with 19 points for the winners while Bill Bowen dropped in 26 points to lead WCC. Sixty fouls were called in the game.

Jack Powell's field goal with 15 seconds remaining gave High Point its one-point win over Elon. The game left Elon with a 1-2 conference record and High Point 4-1. Dee Atkinson of the Christians was high for the night with 31 points. Powell hit 22.

Guilford's win over Appalachian was the Quakers' first conference victory of the season and their second win overall. The Quakers used only six men. Dick Qoddy, Don Henric and Bob Atlas shared Guilford's scoring honors with 17 points each but high for the night was Appalachian's Don Abernathy with 25.

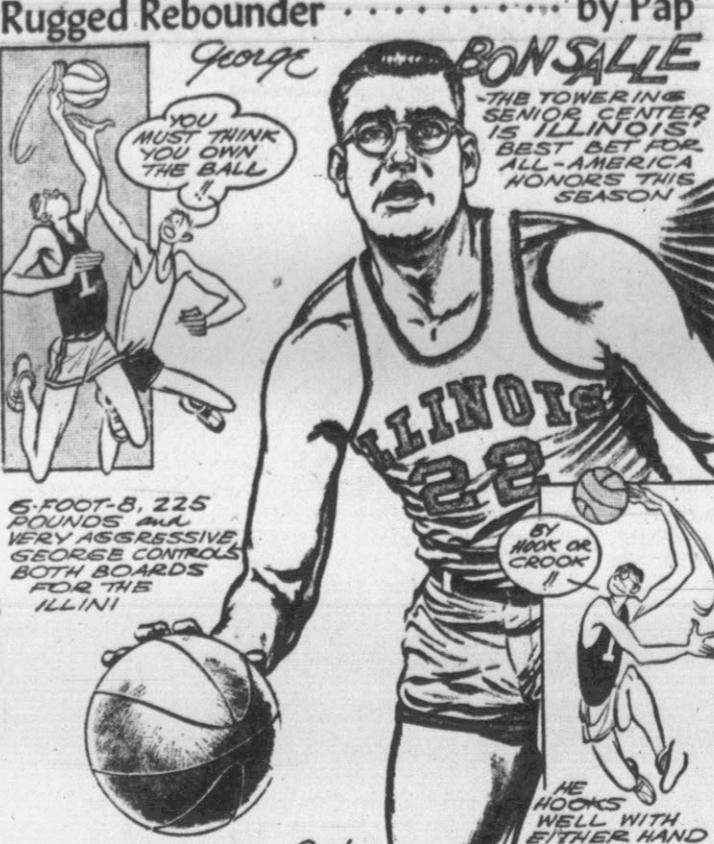

He's a vastly improved player over the early stages of last season. He hooks well from either side and is accurate from outside. His ball handling and defensive play have improved with his new-found confidence. Off the boards, Bob Salle is a strong, rugged rebounder who has developed the knack of timing his jumps properly. He's more aggressive, too, and when he throws his weight around the opposing players know they have been in a battle.

Coach Harry Combes has brought Bob Salle along carefully but has reached the point where Big George can be turned loose for a big season. If Bob Salle continues to produce as he has in early pre-conference games, the Illini are going to be awfully rough for the rest of the league to contain.

When East Carolina clashes with Elon's Fighting Christians at Elon Saturday night, both teams will have plenty to scrap for.

A tremendous battle is expected to result from the meeting of the two North State clubs—East Carolina is in the number five spot, Elon is number six, in loop standings.

Going a little deeper than just the surfaces battle between two closely-ranked conference members, it should be noted that a sharp-edge rivalry has been growing constantly between the two schools. This rivalry—though not marred by any outward signs of bitterness such as fist-fights of name-calling—is nevertheless a very deep-seated and earnest one.

Last Year Didn't Help
Over the past seasons, with East Carolina's basketball prowess growing by leaps and bounds, the Christians seem to have built up an ever-increasing resentment toward the Pirates. Last season's meetings between the two clubs didn't improve matters any.

Coach Don Mathis' boys were powerful (they finally copped the North State crown) and began the 1955-56 year with nine smashing victories against only one defeat. They lost to the semi-professional McCrary Eagles by only eight points, while winning over others by such scores as 124-70, 160-101, 104-57, 108-86, 102-81 and 100-77. They were red hot and rated to trample everything in sight.

Then they met East Carolina in the celebrated Pirate "Jinx" gym. The Christians came to Greenville determined to snap the Bucs' home-court winning streak, which was then around 40.

Don Harris, Nick Nichols, J. C. Thomas and the ECC crew humiliated the visitors with a lopsided 105-69 defeat. It was the worst beating the Champions-to-be suffered all season. It was terrible and nobody hated it worse than Mathis and his boys.

East Carolina then journeyed to Elon for the return match. The Christians were fighting mad and determined to get their revenge. They barely squeezed by the Bucs, 88-83. It was victory, but not a satisfying one.

They Want Revenge
This year, with five of their starters back and a good chance of repeating their championship drive, the Christians still want their revenge. Elon students have been outspoken in their belief in their 1956-57 team—one even went so far as to voice his disappointment that Lenoir Rhyne was the one that snapped the Pirate victory string. "We had planned to do it," he said.

Well, Elon will get its chance Saturday night on the Christian court. The game will be a big one, an important one for both clubs in North State standings. Elon, as of last reports, has posted a 1-1 conference mark and is practically untried against loop teams. They have won against the bottom team in the league and have been beaten by the top team. An Elon win Saturday night could shift the standings, putting East Carolina below the Christians—depending upon how they (Elon) have made out in their two earlier games this week. They were to have played Appalachian and High Point.

The sharp rivalry between the East and Western North Carolina teams have spilled over into football and baseball. During the past few seasons, competition in the North State loop has become stiffer and it seems that East Carolina and Elon are always battling it out for important causes.

Both Are Spoilers
Both teams have become arch-spoilers for each other. Elon was undisputed baseball champions in the North State league until the Christian baseball coach, Jim Mallory, decided to come to ECC. Since his arrival, Mallory has coasted the Pirates to a definite dominance on the conference diamonds.

In football, the two teams have battled back and forth viciously, each winning and losing hard.

But the greatest rivalry is shown on the basketball courts. Play between the two teams has become consistently rougher and both schools have taken up a policy of razzing and jeering the opposing clubs whenever at home. East Carolina fans added insult to injury last year in the humiliating 106-69 home-court victory, when they joined voices to fill Memorial gymnasium with a "Poor Elon" chorus. Elon did practically the same at Elon.

Saturday's game should be a rip-snorter, regardless of the outcome.

Books & Stuff

We've been having a very interesting correspondence with one of the outstanding literary people in our state, Charles Olson of Black Mountain, N. C. Mr. Olson is the Rector of Black Mountain College and a writer and poet of considerable accomplishments. His recent "Anecdotes of the Late War" was given an uncompromising review in this column a little while back, and we want to emphasize that this review is only one man's opinion. Mr. H. D. Rowe's, and that Mr. Olson shouldn't be judged by it alone. Mr. Rowe lists as his qualifications the simple facts that "he reads quite often; occasionally he writes."

That many other notable people think that Mr. Olson's work is good is borne out by the number of his published poems and articles. He's had poems in both "Harper's Bazaar" and the "Atlantic Monthly," as well as in such little magazines as "Ark," "Contact" and "Cliff"—both of the latter are Canadian—and in two Japanese magazines, "Shigaku" and "Cendré." Published criticism by Mr. Olson has been carried in "Partisan Review," "New Republic," "Poetry New York" and "New Mexico Quarterly." William Carlos Williams used one of Mr. Olson's essays, "Projective Verse," as a part of his "Autobiography," a National Book Award winner. We're being very brief and incomplete about Mr. Olson's accomplishments because our Editor won't allow us enough space to list them all—next week we'll try to reprint a part of his recently reviewed poem.

Grass Roots
The annual trek of the Grass Roots Opera Company is again upon us. This year's opera in English will be "The Secret Marriage," a gay Italian comedy, and it will be showing at McGinnis Auditorium on the afternoon and evening of Monday, January 21. Performances are priced at 75c for students, \$1.25 for grownups and 90c for small fry. Small fry—elementary school children—are supposed to go in the afternoon and tickets are available for them in the various schools. The grownups go at 8 p.m. and can get tickets in advance from any member of the Greenville Music Club, which sponsors this annual musical event every year—and a very wonderful and worthwhile event it is, too—er from the Music Arts Shop at Five Points, or from any of the girls who work at the Sheppard Memorial Library, where tickets will be on sale until the day of the performances.

War Books
You would think that people

would want to forget about wars, but war books are getting more and more popular all the time, despite the peaceful times—which really aren't very peaceful anyway. It's interesting to wonder about why war books are so popular in peacetime, and apparently the answer is that they are the more people like to read them. Just out is a real shocker, "Give Us This Day," by Sidney Stewart, a biographical account of the experience of an American soldier who was captured at Bataan in 1942 and held prisoner by the Japs until the Russians freed him over three years later in Manchuria. Stewart's book was first published in France in 1951, where it outsold both "The Naked and the Dead" and "From Here to Eternity"—though he had first tried to get an American publisher to buy it. Now it's back, as an American book, after being translated into several foreign languages. It first turned up in English in—of all places—England. Moral: if you want to get something published, try America last.

Today's Review
Herbert Paschal, member of the Social Studies Department at E. C. O., and a specialist in American history, contributes the following comments on a recent issue from the U. N. C. Press. **Sherman's March Through The Carolinas.** By John G. Barrett (Chapel Hill: The University of North Carolina Press, 1956) \$6.00. Propose Ending Secrecy Powers

WASHINGTON (AP)—Several members proposed today that Congress strip government agencies of some of the authority they now claim to deny nonsecurity information to the public.
Rep. Moss (D-Calif.), chairman of the House Government Information subcommittee, said legislation will be offered in both House and Senate to amend what he called a routine "housekeeping" law which has been cited by some agency officials as legal sanction for restricting information.
Moss contended executive agencies have "twisted" the intent of Congress and used their own interpretation to deny the public access to their records and files.
Identical amendments to change the law will be offered in the House by Moss and Rep. Dawson (D-Ill.) and in the Senate by Sen. Hennings (D-Mo.), Moss said. A comparable amendment will also be introduced by Rep. Hoffman (R-Mich.).
The disputed law, based on legislation going back to 1789, states that executive officials may prescribe regulations for "the custody, use and preservation" of records.
Moss said regulations adopted under that law "have become the major excuse used by the executive agencies to withhold information."
The proposed Moss-Hennings amendment would amend the law by adding this sentence: "This section does not authorize withholding information from the public or limiting the availability of records to the public."

Believes Senate Will Take Lead On School Bills

WASHINGTON (AP)—Sen. H. Alexander Smith (R-N.J.) said today he believes the Senate will take the lead in this Congress in acting on school construction legislation.
Smith, senior Republican on the Labor Committee which handles such legislation, said he understood leaders in both branches had agreed the Senate should try to handle the touchy issue first this time.
Speaker of the House Rayburn (D-Tex.) told reporters, however, he hoped that a school bill would be one of the first things acted on by the House this session.
And a Senate Democratic source predicted that the Senate, as it did last year, would wait until the House acts before passing on the proposal.
President Eisenhower, in his State of the Union message yesterday, urged that the Congress give "high priority" to a school construction bill to meet the nation's classroom shortages.
He told the lawmakers he hoped the measure would not be complicated by trying to tie provisions dealing with the "complex problems" of racial integration of schools.
Such a provision, sponsored by Rep. Powell (D-N.Y.), led to defeat of a school construction bill in the House last year.
Smith said he plans to introduce the administration's school bill in the Senate Monday. He said it would call for the same 1 1/4 billion dollars of federal allotments as the 1956 version, but that the amount would be split over four years instead of five "as in last year's bill. The new measure also is expected to contain some loan features as did the 1956 version.
Smith said it was felt that the Senate should work on the legislation first this time because it would be easier for that body to defeat any proposed integration amendment.
But he said it probably would be easier to beat such a proposal in both branches this session because "this is not an election year."

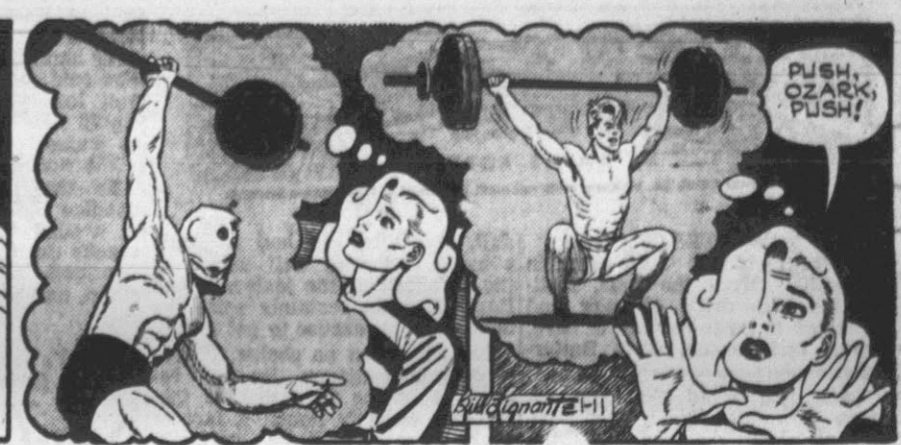

Nuclear Weapons Will Soon Be Open To All

WASHINGTON (AP)—Senators today pondered testimony that the advent of cheaper and more plentiful uranium soon will complicate the problem of bringing nuclear weapons within reach of smaller nations.
"The day is not far away when even the smaller nations will be able to engage in atomic war and increase the difficulty of outlawing the A and H bombs," Chairman Humphrey (D-Minn.) of the Senate Disarmament subcommittee told newsmen.
He and other members of the group applauded President Eisenhower's statement in his State of the Union speech yesterday broadening administration disarmament proposals to include "the outer space missile and satellite development."
Retired Army Maj. Gen. Leslie R. Groves told the subcommittee yesterday the time is coming when even the smallest nations will be able to afford to make superbombs.
Groves, who headed the agency which developed the first atomic bomb, said the usability of even very low-grade uranium ores in reduction of fissionable materials has brought the cost down.
The subcommittee decided informally yesterday to ask the Atomic Energy Commission for an opinion on the danger of fallout from tests of nuclear devices, and on whether the explosion of an H-bomb can always be detected from far away by scientific devices.
Adlai E. Stevenson, 1956 Democratic presidential candidate, raised these questions during the campaign last fall.

Royster Asserts Evidence Backs USDA Action

RALEIGH (AP)—The president of the Bright Belt Warehouse Assn. says that "overwhelming evidence supported" action of the U.S. Department of Agriculture in halving price supports on three varieties of tobacco.

Fred Royster of Henderson made the statement yesterday in commenting on charges by A. W. (Red) Bethea, Dillon County, S.C., farmer. Bethea declared that "those who fostered" the price support cutting order "were dedicated to giving a black eye" to the Coker Pedigree Seed Co. of Hartsville, which developed two of the varieties.

Royster and Carl T. Hicks of Walsenburg, chairman of the North Carolina Farm Bureau's tobacco committee, said the charges were "absolutely false."

Betha, 40, defeated twice in the race for state agriculture commissioner, asserted that if two of the grades developed by Coker, 139 or 140, had been bred by North Carolina State College "or any seed company in North Carolina, the U.S. Department of Agriculture would never have put them on the blacklist."

Royster pointed out that the other so-called undesirable variety, Dixie Bright 244, was developed by the State College experiment station.

Betha said "a small group" of men were behind the price support cutting order. Hicks and Royster were among those listed.

Royster said chemical tests showed that the three varieties "are substantially lower in nicotine content than any other variety now being grown. The tests were made by the combined research people of all flue-cured tobacco states."

He added, "Everybody had ample opportunity to be heard in connection with the action taken by the Department of Agriculture. The overwhelming evidence supported what the department did."

Hicks declared that domestic and foreign buyers of flue-cured tobacco "have fled with the U.S. Department of Agriculture tobacco section strong statements indicating that they do not want the qualities of tobacco which are produced from these three varieties."

Hicks added, "If the growers do not grow the varieties which will produce a quality in greatest demand, the tobacco program will be bankrupted."

U.S. Newcomers Get Free Meals

RALEIGH (AP)—Two Hungarian families who fled Budapest won't have to worry about food until they move into apartments being prepared for them here.

Raleigh members of the North Carolina Quality Restaurant Assn. yesterday began serving meals free to the refugees, five adults and four children, until they can start cooking for themselves.

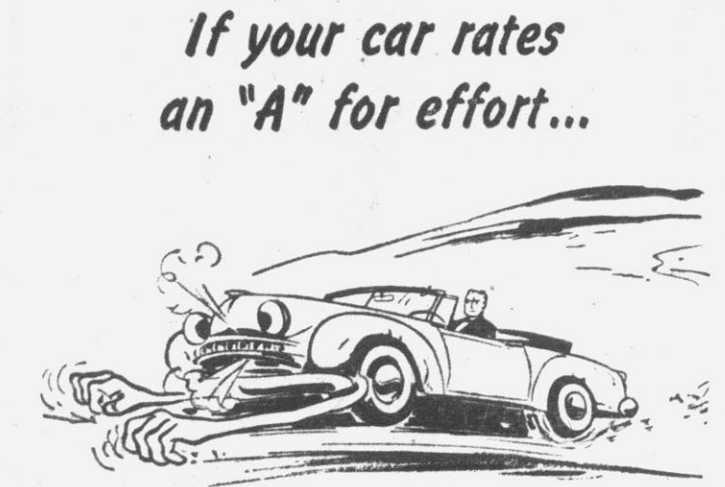

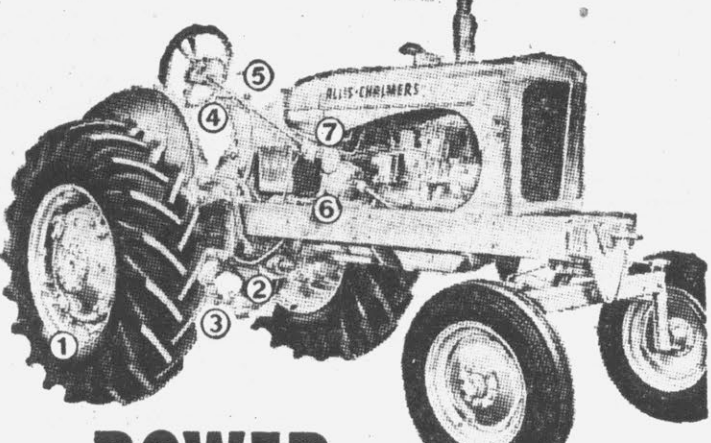

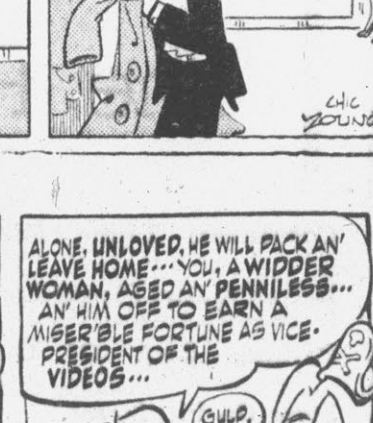
