

Egyptian Force Advances Into Area Near Gaza Strip

CAIRO (AP)—Reliable informants said today 600 to 700 Egyptian army reconnaissance and military police moved into El' Arish yesterday to take over defense of that area from the United Nations Emergency Force. El' Arish is 25 miles west of the border of the Gaza strip.

El' Arish was a vital Egyptian defense point before the Israeli attack last October. The Israelis occupied the area in early November, however, and before withdrawing demolished practically all the installations there and left the area practically isolated from the rest of Egypt. Withdrawing Israeli forces destroyed roads, telephone lines, wells and army buildings in the area.

In Gaza, an Egyptian spokesman said agreement had been reached "in principle" on the function of U.N. troops in the strip. There was no elaboration, but the indication seemed to be that UNEF would be restricted to positions along the Gaza - Israeli border.

Execution Stay Came Too Late

SAN QUENTIN, Calif. (AP)—Two minutes too late Gov. Goodwin Knight tried to grant Burton W. Abbott a stay of execution yesterday. Instead the kidnap-slayer of 14-year-old Stephanie Bryant died in the San Quentin Prison gas chamber.

The condemned man was strapped into the death chair at 11:15 a.m. The lethal pellets were dropped into a container of sulfuric acid at 11:18. Two minutes later Warden Teets answered a call from the governor's clemency secretary, Joseph Babich.

The timing raised the question whether a convicted criminal could be saved from the gas chamber after the first lethal pellet of potassium cyanide is dropped. The answer is no. You might as well try to stop the bullets from a rifle in a firing squad after the trigger is pulled.

Abbott's conviction was based on circumstantial evidence. Stephanie, daughter of Dr. and Mrs. Charles Bryant of Berkeley, Calif., vanished April 28, 1955. No one saw her abducted. No one except her assailant saw her killed. On July 15 her purse was found by Abbott's wife in the basement of the Abbott home in nearby Alameda. The girl's decomposed body was found in a shallow hillside grave near his Trinity County cabin five days later.

Economy Wave Surges Higher, Cuts Sought

WASHINGTON (AP)—An economy-in-governments wave surged higher in Congress today with fresh attacks on President Eisenhower's \$71,800,000,000 budget.

Beck Holds Up Giving Records

Teamster President Tells Probers Decision Will Be Made About Tuesday

WASHINGTON (AP)—Senate rackets investigators said today Teamsters Union President Dave Beck has told them he will delay at least until Tuesday a decision on whether he'll turn over voluntarily his personal financial records.

Beck sent a telegram to Sen. McClellan (D-Ark.), chairman of the Senate Rackets Investigating committee, saying he wanted to talk with his attorneys Tuesday night. Then, Beck told McClellan, "I will reply to your wire immediately thereafter."

McClellan yesterday sent Beck a demand for his personal records for the period 1949 through 1955 and asked for an immediate reply.

While avoiding saying so directly, McClellan had made it clear he intended to subpoena the records unless he heard from Beck within 24 hours after the request was sent yesterday afternoon.

There was no immediate word from Beck whether he would go along with the delay imposed by Beck.

A similar request for Beck's records was made nearly a month ago.

There have been allegations that union funds were used to pay some of Beck's personal expenses.

In Seattle, Beck said yesterday he hadn't received the committee's new request yet, adding: "I am not taking a position on this until I see what the committee wants and can consult with my attorneys."

Beck said that if his lawyers want him to turn over the records "I will do so in a minute." He said "that depends on whether my attorneys believe my rights are being infringed upon."

The special committee was set up to probe alleged racketeering in both labor and business. So far its hearings have dealt with an alleged plot by West Coast Teamsters officials to take over rackets in Portland, Ore.

Late in yesterday's hearing the committee produced several checks amounting to more than \$14,000 and said the Teamsters money went to Nathan W. Shefferman, Chicago labor relations consultant to employers. The committee said he once served in that capacity for Sears, Roebuck & Co.

The checks were signed in 1951 and 1952 by Beck and by Frank Brewster, chairman of the 11-state Western Conference of Teamsters.

Brewster testified that he didn't know why the money was paid. However, he said Beck used to pay Shefferman to make speeches to Teamsters Union groups as "a labor-management authority."

Rome Welcomes Touring Nixons

ROME (AP)—Vice President Nixon arrived in Rome today and spent a busy 10 minutes shaking hands with welcoming Italians who thronged in front of his hotel.

A broad smile on his face, Nixon delayed entering Rome's Grand Hotel to greet more than 1,000 spectators who blocked the street.

Italian Prime Minister Antonio Segni led a delegation of top Italian officials who welcomed Nixon at Ciampino Airport after a two-hour flight from Libya, which temporarily ended his seven-nation African goodwill tour.

During Nixon's 10-mile drive from the airport in an open car, the welcome grew increasingly enthusiastic. Some 10,000 Italians were lined up waving and applauding.

Assembly Picks Up Momentum

RALEIGH (AP)—Activity on all fronts busied the North Carolina Legislature this week, with a sweeping reorganization of the Highway Commission its major accomplishment.

The revamping bill was the first important statewide measure enacted by the 1957 General Assembly. Its passage gave Gov. Hodges the first plank in the program he has outlined to lawmakers.

These other developments enlivened the legislative scene:

1. The Joint Appropriations Committee heard money requests which ran the total asked thus far to more than 16 million dollars over the budget recommended by Gov. Hodges and the Advisory Budget Commission.

2. The Joint Finance Committee completed briefings on proposed changes in tax laws, clearing the way for public hearings to begin next week.

3. A bill to give 18-year-olds the right to vote made its way to the Senate, where it will be debated next week. The Elections Committee reported it "without prejudice," taking no stand for or against the bill.

4. Another reorganization of state government advocated by Gov. Hodges gained approval of a Senate committee and will come up on the Senate floor next week. It would combine fiscal agencies in a new department of administration.

While committees mulled over bills already introduced, legislators continued to bring forth new proposals.

Navy Blimp Ends Its Record Flight

KEY WEST, Fla. (AP)—A Navy blimp, flying longer and farther without stop than any in history, has demonstrated the capability of these roaming sentinels to warn of enemy bombers and submarines while they are still far from American targets.

The ZPG-2 landed at the Boca Chica Naval Air Station here at dark last night after being aloft 11 days and 12 minutes.

From the time the blimp left South Weymouth, Mass., until it hooked to a mooring mast here, its 14-man crew had flown it across the Atlantic, cruised above the coast of Portugal and off North Africa, then recrossed the Atlantic to Florida.

Navy officials declared the flight was never intended as a stunt or merely to set a record, but was designed to prove the ability of airships to keep on station for days at a time on patrol.

Cmdr. Ronald W. Hoel, chief of the air development unit at South Weymouth, said they kept plenty busy, with watches of 12 hours on and 12 off. When they weren't working, they played chess and read.

A nationwide audience will watch the proceedings from Hollywood and New York as outstanding performers, programs, writers and technicians are presented with the Emmy statuette, symbol of television's highest honor.

In Hollywood, Desi Arnaz, the Latin husband of "I Love Lucy," acts as master of ceremonies. Phil Silvers, "con man" extraordinary of the "Bilko" show, oversees the New York presentations.

The Academy of Television Arts and Sciences plan to present other stars including Ernie Kovacs, Jimmy Durante, Danny Thomas, Nat King Cole, Peggy Lee and Julie London.

Nominations include: Best coverage of a newsworthy event: CBS' sinking of the Andrea Doria; the national political convention by ABC and NBC; and Edward R. Murrow's report over CBS, "Year of Crisis."

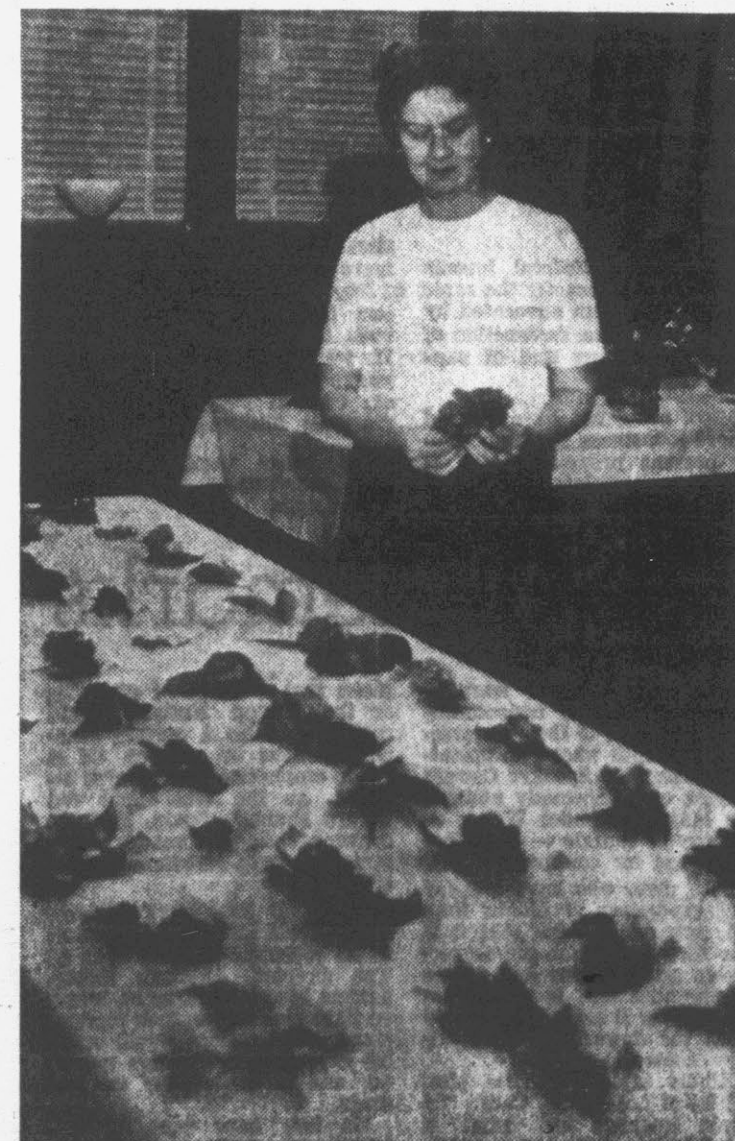

Speculation Up In Sugar Marts

Gambling on world sugar markets has become one of the exciting ventures of the day. Well—quickly, before some commodity exchange writes a nasty letter protesting that first word—let's say there has been a sharp increase in speculative interest in sugar.

The world price has been, through a series of fluctuations, hitting a new peacetime high. Fortunes have been made and lost.

There are two sugar markets. One is the world market, a free market in which sugar from all parts of the world is bought and sold.

The other is the domestic market, a dull sort of thing under government controls. American investors can buy and sell in either market.

To protect beet sugar growers in the Midwest and West, and cane growers in the South, the United States regulates imports of sugar. These regulations give the government control over the economy of sugar-producing countries. A rise in allowable imports can sweeten their prosperity, a cut could provoke revolutions.

U.S. PRICE HIGHER
As a result of controls, sugar on the domestic market fluctuates less than on the world market, but the prices average higher.

On the world market, the price rose from 3.30 cents a pound, f.o.b. Cuba, in November, to 6.35 cents in January—almost doubling in about three months. On February 6, a total of 2,598 sugar contracts changed hands on the New York Coffee and Sugar Exchange, a record for that pit.

Since then, the price has moved up and down, though within a moderate range.

The recent rise was caused by a number of factors. Drought reduced the Cuban crop for two successive years and other countries drew on their inventories.

Then this winter, although the present crop looks good, many nations started buying to build up their stocks. Britain, which bought 90,000 tons of Cuban sugar in 1955, stepped up purchases to 500,000 tons last year. Russia, which has been in and out of the world market, stepped in to buy heavily, about the same amount as Britain, according to reports. Other European and As-

It should afford better planning for the overall road program throughout North Carolina and at the same time it will give boards of county commissioners throughout the state a more important voice in planning the secondary road program in their respective counties. Through this reorganization of the Highway Commission there should evolve more closely coordinated road planning on geographical as well as the state level. The seven Commissioners will represent not only the areas from which they come; they will likewise represent all the people of the state.

Though North Carolina's highway system ranks among the best in the nation, it is apparent that the state must continue to improve its highways to meet the needs of its people. Under the new organization just written into law the Commission should be able to give more attention to the overall program of inter-state, primary and secondary highway planning, while it leaves to the governing boards of individual counties the responsibility of designating specific improvements in the secondary program.

There is obviously the need for better overall planning and greater local voice in the highway planning. Provisions of the reorganization of the Highway Commission should provide both.

Envious Eyes On Idle Money

DOG SURPLUS — There's a surplus in the dog pound fund or kennel tax account in several counties which have come under provisions of the law permitting employment of a dog warden. It seems that in addition to the regular ad valorem tax due on dogs, a number of counties provide a privilege tax for maintaining a "kennel." Money derived from this source goes into a fund out of which claims are paid for damages done by dogs to livestock or other property. There is some question whether damage to boxwood and other shrubbery is compensable under the act.

It develops that in a number of counties there is a balance left in this fund after all approved claims have been paid. The amount is not large, only a few hundred dollars having accumulated during the years. But county commissioners have cast envious eyes on that idle money. The Attorney General has ruled that it cannot be used for any other purpose. So the commissioners are backing a bill to permit diverting the balance into the general fund.

Discussion of this bill, introduced by Rep. Tim Valentine of Nash, has aroused interest in other potential "windfalls" from forgotten small balances in special funds. The annual report of the State Auditor disclosed that small balances in special fund accounts aggregate thousands of dollars.

It is known that thought is being given to a bill that would put all these idle dollars to work, with a protective clause similar to that in the escheats law assuring that any proper claimant who can prove title to the account may recapture it through due process.

HOW FAR — Just where should the line be drawn between admissibility of prima facie evidence and required proof of intent with respect to possession of property which might be used for illegal gambling?

To what extent should responsibility for illegal use of an automobile be distributed among the user, the sole owner and the holder of a mortgage, in cases where the vehicle is subject to confiscation?

In their zeal to prevent gambling, some sincere people seek to make possession of any item or equipment that might be used in gambling prima facie evidence of intent to gamble. Obviously that goes too far, because it would make illegal the possession of a coin which might be used for matching heads or tails, and certainly would outlaw a newspaper which carries stock market quotations.

A House Judiciary committee

worked for some time the other day on a bill designed to subject an automobile used in a lottery to legal confiscation. Question arose about the rights of a mortgage holder and other interested persons. A subcommittee was appointed to work out these details.

This committee action served to emphasize the diligence of the legislators for protective basic rights of all the people against the ill-advised efforts of sincere but narrow-minded persons seeking laws to effectuate their own concept of public righteousness.

In that connection it should be noted that while lawyer members of the General Assembly introduce many bills of purely technical nature and of little importance except for legal procedure, they stand as bulwarks, through membership on the Judiciary Committees, against many unintentional encroachments upon basic rights.

PEMBROKE — The littlest and the newest college supported by the State of North Carolina is also its fastest growing institution.

Pembroke State College in Robeson county was established mainly for the residents of that section, who have been legally designated as Lumbee Indians. Previous unofficial designation as Croatan, indicating belief they descended from the mixture of blood among residents of the famed Lost Colony on Roanoke Island and Indians of that area, was displeasing to the people affected. Temporary legal definition as Cherokees, also was not pleasing to them or to the real Cherokees in Oklahoma and Western North Carolina.

Several years ago the General Assembly designated the tribe as Lumbee Indians. A short time later the college was opened to white students. As late as the last regular session of the Legislature enrollment at the college was around 160, of whom large majority were day students.

Under the administration of a new President, Walter J. Gale, the college is growing and he reported to the Joint Appropriations Committee the other day an enrollment in excess of 250. He also presented an optimistic projection indicating that enrollment might increase for several years at the same rate scored during the past year.

A high ranking State official, who would talk only off the record and without direct quotes, said three years ago he was ready to recommend abandoning Pembroke as a State supported institution of higher education. Now he is enthusiastic about the potential of that college serving an area which needs such an institution for geographic reasons.

Other Editors Saying --- The Teamsters' Mr. Beck

(Richmond Times-Dispatch)

Destruction of the very records needed by the Senate probes who are investigating the teamsters' union—although older records could much more readily have been disposed of, if additional room was, in fact, desired—is one of the fishiest things yet uncorred concerning the decidedly fishy teamsters.

Another transaction with a distinctly piscatorial odor has become known through the revelation that the teamsters' union paid a mysterious \$5,000 fee to the attorney for William M. Langley, indicted district attorney of Portland, Ore.

Reginald Mikesell, secretary-treasurer of Teamsters' Council in Portland, not only can give no adequate reason for the destruction of all the union's records covering the period since mid-1954 (records from 1937 to 1954 were left intact!), but he mutters that he "can't remember" why the \$5,000 was paid to indicted Mr. Langley's lawyer.

Meanwhile Dave Beck, the teamster boss who has been dodging the Senate probe both in this country and Europe, is still reluctant to appear before the investigating committee in Washington. Beck was at one time under doctor's orders not to travel—he said—but after giving this as an excuse for refusing to testify in Washington, he was soon traveling to Miami, Nassau, Paris and Vienna. Now back in Portland—where the teamsters are alleged to have been engaged

in various types of racketeering, including gambling and prostitution, Beck leaves some doubt as to whether he will appear voluntarily before Sen. McClellan's committee. He plans to get a physical checkup and to talk with his lawyer, he says. Beck can and must be subpoenaed by the committee, if he doesn't come voluntarily. A more suspicious piece of business than his recent conduct would be hard to find.

Innocent men with nothing to hide don't normally go dodging around this country and Europe, when efforts are being made to get them on the witness stand. Neither is it customary to destroy records which are wanted by investigators. The secretary who destroyed them, on instructions from her teamster superior, is now, by a strange coincidence "some place in Asia."

The teamsters' union, with 1,400,000 members, is the biggest in the United States. It is extremely powerful by virtue of that fact, and it is also a bottleneck union. A handful of truck drivers belonging to it can shut down a plant employing thousands of dependents on trucks.

Obviously vast power is wielded by character like Beck. This is the man whom even James B. Carey, vice-president of the AFL-CIO, has termed a "disgrace" to organized labor. While we do not normally see eye to eye with Mr. Carey, he came close to the mark on this one. If, indeed, he didn't score a bulls-eye.

Ike Rebounded Too Far In Remarks

WASHINGTON — "In view of the fact that a President is not supposed to interfere in local political contests," writes G.F. of Troy, N.Y., "why did President Eisenhower endorse former National Chairman Hall for Governor of New York, if he should run for that office? I thought Ike has always taken a neutral stand in such matters."

Answer: It is true that Ike said he would be a Hall "boster," if the Long Island man seeks the Governorship next year. But it is still not certain that, in the event of a contest, the President would issue a formal commitment. However, even if he didn't, his cocktail party statement would be remembered.

AS THE STORY IS UNDERSTOOD Here is the inside story, as we understand it here: Ike was amazed at the unfavorable reaction to his press conference statement that there was no Fed-

eral job awaiting Hall on the latter's return from Florida. It appeared as if the President were ungrateful, and had adopted F.D.R.'s theory that any man, even a close friend, is "expedient." I am thinking of "Jim" Farley's relations with the late Chief Executive.

When Ike realized the position he had seemed to assume — namely, an indifference to Hall's future — he tried to make amends. From the standpoint of practical politics, he rebounded too far in Hall's direction. SENTENCE IT IS NOT ALWAYS HELPFUL to have a President in your corner, when you seek a local or state office, as the astute Hall realizes. Both people and politicians resent such interference, of having a man foisted on them from the White House. In this connection, it is noteworthy that New York's Republican leaders, including several men seek-

ing the gubernatorial nomination, were chilly or noncommittal with respect to Ike's endorsement, if such it was. Two upstarts — Assembly Speaker Oswald B. Heck of Schenectady and Senate Majority Leader Walter J. Mahoney of Buffalo — could not be reached for comment.

These men, who have had far more experience at Albany than Hall, apparently think that it is their turn to try for the Governorship after serving long terms of apprenticeship. It would not look well for Ike, if either should defeat the downstater in a primary contest. "Kindly explain," writes Mrs. W.H.S. of Los Gatos, Calif., "in simple language just what is meant by 'sanctions,' as mentioned in the newspapers with regard to Israel and Russia." Answer: In practical terms, "sanctions" amount to moral condemnation and material penalties against a nation. It could

mean that a group of countries or the United Nations would merely criticize a certain country's actions or policies. Or it would emphasize this adverse attitude, as the West once did toward Franco's Spain, by withdrawing their diplomatic representatives from the offending government.

ECONOMIC BOYCOTT "Sanctions" could include employment of an economic boycott, such as was directed, although feebly, against Mussolini after he invaded Ethiopia. Under such circumstances, the nations would prohibit exports to the nation involved, and refuse to buy its products. We now have such an embargo on military materials with respect to Russia, Red China and most of the satellites. In short, "sanctions" is reprimand, a penalty, designed to punish a nation, and persuade it to mend its manners.

Did It With \$192.32

PHOENIX, Ariz. (AP) — "It's comfortable, it's ours and it only cost us about \$190." Tom Kirley, a natural-born do-it-yourself fan, was talking about the furniture in his new home.

Three months after Tom and June Kirley moved into their house in a subdivision on Phoenix's northwest side, they had every room furnished with neat, solid furniture. They have their bills to prove they spent a total of \$192.32.

The Kirleys are quick to qualify that sum. Like most overtime apartment dwellers, they had a bed, a few lamps and other odds and ends. The house came equipped with a stove and refrigerator, and they owned a TV set and washing machine, and a \$35 jig-saw.

"And I want you to know," Kirley says proudly, "Everything in this house is just what we wanted. It's not makeshift."

The furnishings bear him out. Kirley is a sheet metal specialist at an aircraft research laboratory. He tries to spend an hour or so each day working on something new for his home.

The Kirleys picked up their tubular steel breakfast set for \$4, and recovered it with three dollars worth of plastic fabric. It looks as good as new.

The Kirleys' 4-year-old son, Mike, sleeps in an Army bunk bed that cost \$8. The other half is out in the garage until Jo Anne, the family's baby daughter, outgrows her crib.

Kirley painted the bed white and burned in Western style brands. A \$9 chest of drawers is decorated to match, with black horseshoe handles made out of scrap plywood.

The dining room table and chairs, which are made from solid oak, were found in a second-hand store for \$29. "You don't find them built like that anymore," he said. "I'll sand down the top and varnish it when I get time, and we have some gold burlap remnants for the chairs."

Their most expensive purchase was a sofa and chair for \$60. "We looked for a long time, and it was just what we wanted," Mrs. Kirley said.

The Kirleys estimate they spent from 10 to 12 weekends hunting in second-hand and bargain stores until they found all the furniture they needed to move in. UNC, California, Kentucky And Kansas Favored As Semifinalists

North Carolina, Kansas, Kentucky and California ruled heavy favorites to sweep past Syracuse, Oklahoma City, Michigan State and San Francisco tonight and move into the semifinals of the National Collegiate (NCAA) Basketball Tournament.

The four winners advanced to the semifinals and finals at Kansas City next Friday and Saturday.

For mighty North Carolina, the No. 1 team in The Associated Press poll, tonight's game against Syracuse in Philadelphia is doubly important. Not only would a victory send Frank McGuire's talented crew into the round of four, but a triumph would enable them to break the one-season winning streak record.

They tied it last night by defeating Canisius, 87-75, for their 29th straight of the season. San Francisco's great team of last season also ran up 29 in a row.

Here is tonight's complete program:

At Philadelphia—North Carolina vs. Syracuse for regional championship. Canisius vs. Lafayette in consolation.

At Lexington, Ky. — Kentucky vs. Michigan State for regional championship. Pitt vs. Notre Dame in consolation.

At Dallas — Kansas vs. Oklahoma City for regional championship. Southern Methodist vs. St. Louis in consolation.

At Corvallis, Ore. — San Francisco vs. California for regional championship. Idaho State vs. Brigham Young in consolation.

While North Carolina had no trouble once all-American Lennie Rosenbluth found the range, both Kansas and Kentucky, ranked No.

2 and 3, respectively, had their troubles.

Kansas had to go into overtime before stopping Southern Methodist, 73-65, while Kentucky couldn't pull away until the final minutes to turn back Pitt, 98-92.

Syracuse earned the dubious pleasure of going against North Carolina with a 75-71 decision over Lafayette. Oklahoma City goes against Kansas by way of a 75-66 triumph over St. Louis, while Michigan State gained the right to meet Kentucky by whipping Notre Dame, 85-83, and in the process snapping a 10-game winning streak of the Irish.

San Francisco, the defending champion which had been all but counted out of the running, sailed past Idaho State, 66-51, and California polished off Brigham Young 86-59 in the West Coast competition.

Meanwhile, the nation's other major post-season tournament, the National Invitation (NIT) opened in New York's Madison Square Garden. Utah met Memphis State in the first game. The other three games of the day-night program set on Hall against Xavier of Ohio, Dayton against St. Peter's (N.J.) and Cincinnati against St. Bonaventure.

The NCAA's Small College Tournament is all over. It ended last night in Evansville, Ind., when Wheaton vanquished Kentucky Wesleyan, 89-65. In the NIAA tournament in Kansas City, another one for the smaller colleges, Tennessee State and Southeastern Oklahoma meet for the title tonight.

Rosenbluth wound up the night's operations against Canisius with 39 points. Wilt (The Stilt) Chamberlain, wasn't far behind, pacing his Kansas mates with 36 points.

Yankee Flipper by Pap'



The all-around enthusiasm in the ranks of the Yankees over the trade that brought Bobby Shantz to New York is an honest indication of the high regard in which the tiny lefthander is held as a ballplayer. Manager Casey Stengel has long been one of Bobby's greatest admirers.

No one in the Yankee family is more pleased to see Shantz in a New York uniform than Bill McCorry, the club's traveling secretary. For almost ten years, Bill was slightly embarrassed every time the name of Bobby Shantz was mentioned. Back in 1948 Bill was scouting for the Yankees and ran into Shantz by accident while looking around in a Philadelphia suburban league. He could have signed Shantz for \$500 a month but resisted doing so because he felt that Bobby was too small for the big show. McCorry thought he knew only too well—he had failed that as a big league hurler because he lacked size.

'Mental Wages' Given Management Emphasis

John Page, personnel superintendent at the Kinston Du Pont plant, discussed "Management-Labor Relations" at the Greenville Exchange Club last night.

He said "Mental Wages are more important than real wages. Numerous surveys have been taken to determine the relative importance of real wages and, even during depression years, mental wages, such as personal recognition and fair treatment have been considered to be more important."

Page defined management as those who get things done through mental skills and labor as those who get things done through physical skills. Management and labor are both necessary to achieve the goal of running a business for profit, and there must be cooperation between them.

A part of management's job is to develop people to produce and to see that they are paid in both mental and real wages. Since people are individuals, they must be treated as such, even though every-

one has the same basic desires for recognition, to be treated fairly, to be given clear instructions as to how to do his job.

"In order to make correct decisions, management must decide what is right, not who," he said, "and when individuals are considered, then the decision is biased and may not be correct."

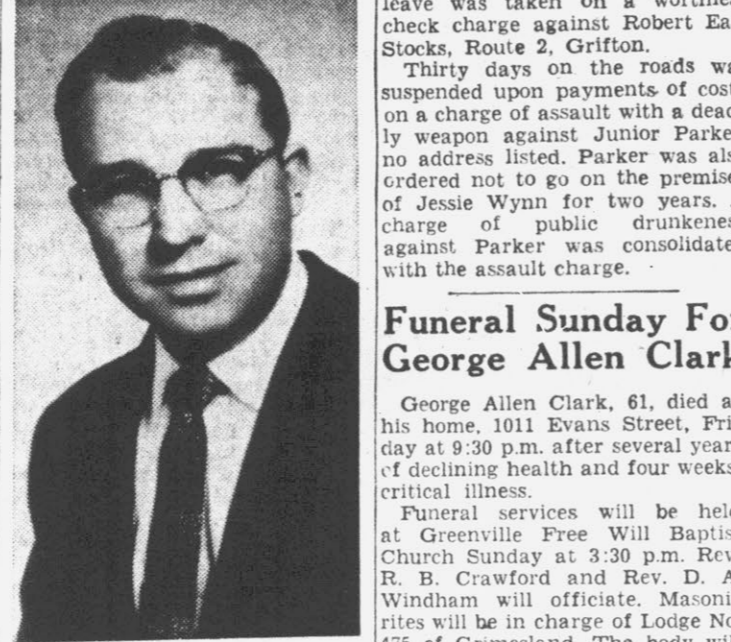

A New Radio Station Serving Us Very Soon

One day last week a high powered FM radio transmitter came to life in its new home at the Joyner Library on the East Carolina College campus.

A student technician adjusted dials on a master control board in the nearby control room.

Within a few moments the voices of Dr. Carl Adams, Dr. A.D. Frank and Miss Rosalind Roulston, all college faculty members, were on

the air for anyone in this area whose FM set happened to be tuned to 91.3 megacycles to hear.

WWWS, the Voice of East Carolina College, was on the air—even if only for a short while to test the new station's transmitting equipment.

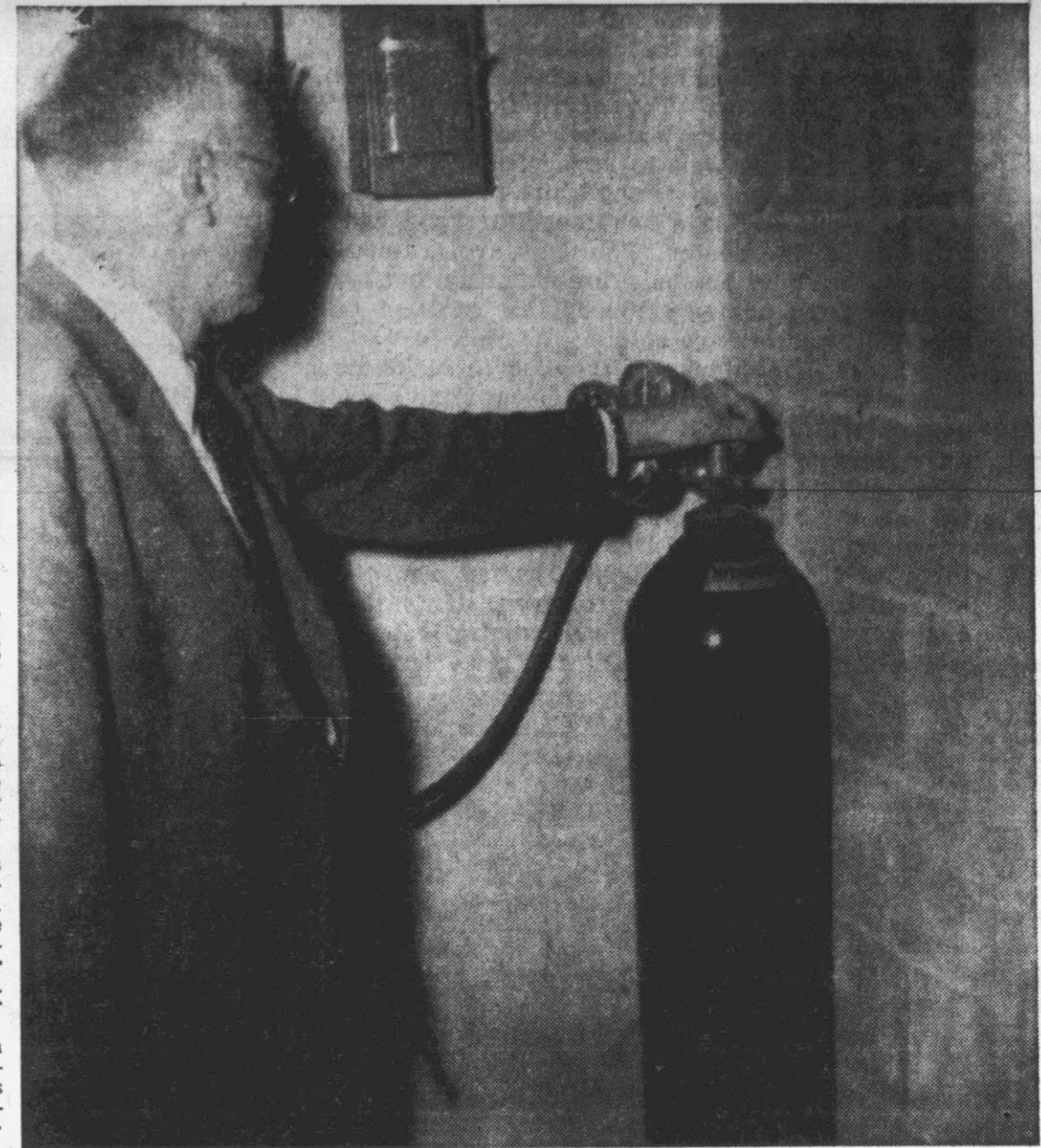
Actually the program which was being sent out by the station was not planned for live broadcast. It was being tape recorded for use by other commercial stations in this area. But for test purposes a

portion of the program was sent over the air waves.

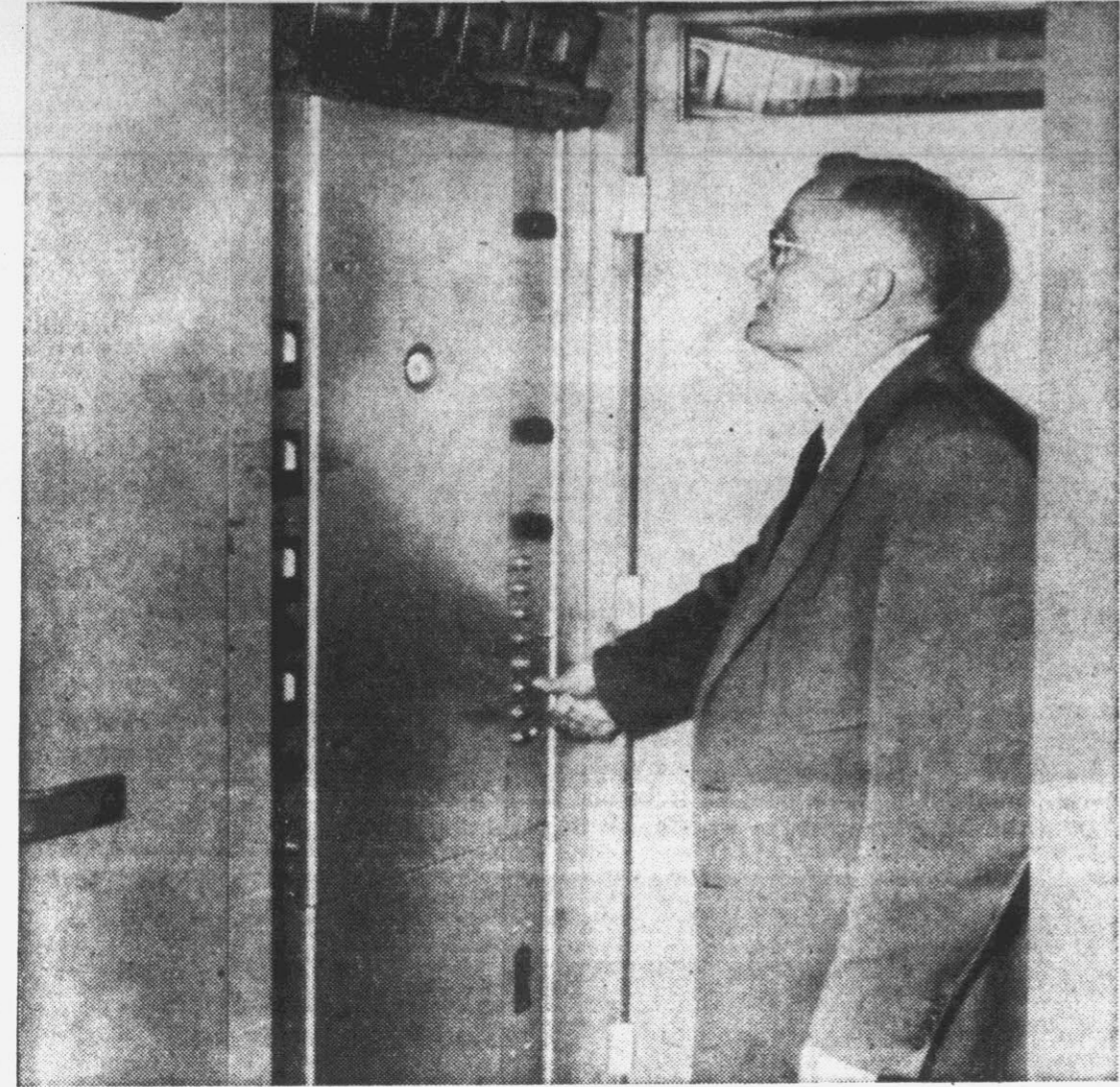
In the weeks to come there will be more and more such programs coming for the completely equipped radio studios in the library.

For, although the station has not yet officially begun broadcasting, only one major part is needed before the equipment will be ready for use.

The idea of an education FM station for East Carolina College had its beginning about a year ago

when Dr. J.D. Messick, president of the college; A. Hartwell Campbell, president of television station WNCT, and Wendell Smiley, college librarian, were discussing radio and television.

Campbell suggested that the college buy an FM station and develop it into an educational station.

The idea seemed good to Dr. Messick and a sum of money was found to purchase such a station. Smiley was delegated to find a suitable transmitter and he finally located the equipment in Norton, Va. Station WNVA was discontinuing its FM operations and wished to sell its three KW transmitter.

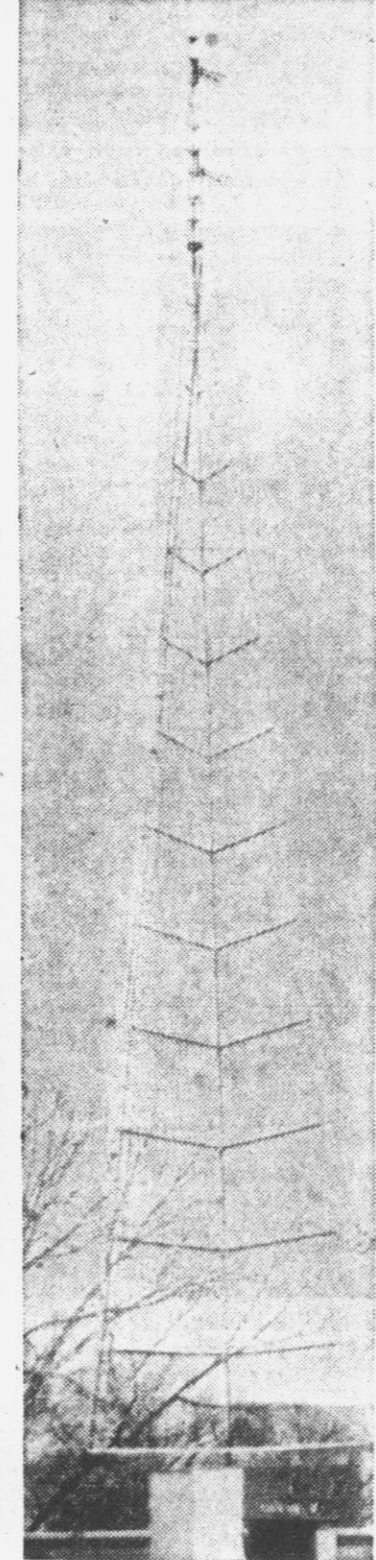
Thus the college obtained a transmitter which had been operated 27,000 hours. New, the equipment would cost about \$18,000.

A construction permit was obtained from the FCC last September and installation soon began.

Additional Section Needed

Engineers found after tests began that an additional one foot section was needed for the big tower which sits atop the library building. WNVA had operated on a frequency of 107.7 megacycles while the new WWWS frequency was to be 91.3.

The station can operate, but only at low power. The additional section has been ordered, says Dr. Smiley, and after it has been installed it is expected the station can begin operation. The top of the tower, incidentally, will be 135 feet above ground and it is hoped the

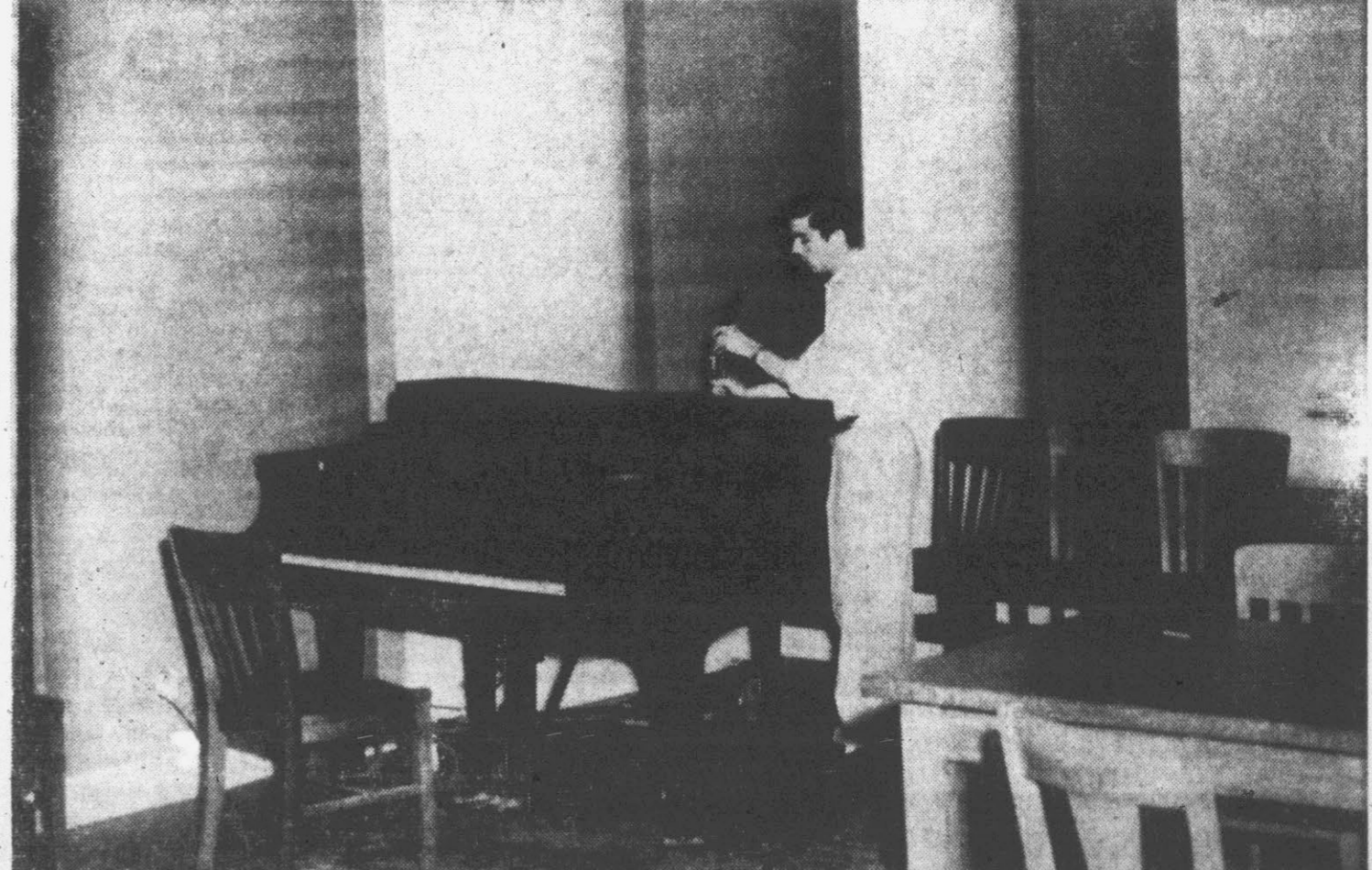

The horse and the mule have vanished from army life, but the combat-tested canine corps shows no sign of fading away. In fact, new recruits are being trained every day at Ft. Carson, Colo. It's the only army dog training center in the United States.

Some 250 dogs are being trained at Ft. Carson. All are German shepherds. The army finds they are easy to train, quick to learn and obey commands, and that they adapt themselves well to severe cold and extreme heat. They're housed in glistening white-painted kennels.

With each dog is a handler. Dogs and handlers train together at the center. The dogs are trained for sentry or scouting duty not only for the army, but for any other branch of the armed services that can use a disciplined dog. The handlers are soldier volunteers.

It takes eight weeks of training to make a sentry dog, 12 weeks for a scout. Once the training period is over, dog and man leave Ft. Carson together, bound for Okinawa or Alaska or the Philippines or perhaps an air base or missile installation in this country.

Like their handlers, the dogs were civilians before reaching the center. Their owners volunteered to sell them to the army. And like human recruits, the dogs have their 4Fs. About one of every four fails to pass the center's rigorous physical and training tests.

The training of the dogs at Ft. Carson is pictured here.
