Orgeon Mayor Arrested; Bribe, Perjury Charged

PORTLAND, Ore. (AP) — Terry Schruk, mayor of this city torn by vice accusations, was arrested last night on charges of bribery and accepting a bribe.

Dist. Atty. William Langley, a city police officer and a Portland gambler also were indicted by the Multnomah County (Portland) grand jury, which has been investigating charges of vice and corruption.

Langley, chief legal officer of the county, was accused of corruption and malfeasance for not upholding the gambling laws, of conspiring to obstruct justice by permitting gambling, and of accepting a bribe from persons "unknown." He was released on \$3,000 bail.

Both Langley and Schruk were key witnesses recently at the Portland phase of the Senate labor racketeering hearings.

Langley cited the Fifth Amendment to protect himself from possible self-incrimination when asked about charges that he had conspired with certain Teamsters Union officials and others to expand vice activities in this city of 400,000.

Schrunk denied accusations that he had accepted a bribe and he

offered to take a lie detector test. Later, though, he walked out on the test, conducted by the Service, contending that the questions put to him were a "fishing expedition."

Star witness at the hearing was Portland gambler Big Jim Elkins. His grand jury testimony, corroborated by others, is the basis for the charges against Schruk, Patrolman Richard A. Sutter and gambler Clifford O. Bennett.

Elkins said at the hearing that Bennett told him that he placed a \$500 bribe in an envelope near his club in September 1955, when Schruk, who then was sheriff, was conducting a raid. He said that Schruk had picked up the envelope.

Sutter and two other police officers said they had witnessed this. But later Sutter changed his story and said he could not be sure it was Schruk who had picked up the package. Sutter posted \$1,000 bail on his perjury indictment and was released.

Bennett also was indicted on a perjury charge in connection with the bribe accusation. His bail was set at \$3,000.

Bennett refused to testify at the Washington, D.C., hearings. But

later in a sworn affidavit published by the Oregon Journal as a copyrighted news story, Bennett said that Elkins' account of the bribe was a "frameup" to defeat Schruk's mayoralty campaign.

Schrunk, a Democrat, has steadfastly denied the bribe accusation on which he was indicted today.

No indictments against the mayor were returned by two previous grand juries that looked into the matter. It was his testimony before one of the previous grand juries that led to yesterday's perjury indictment.

Schrunk posted bond of \$2,000 after being booked in the county jail. He puffed nervously on an unlit pipe at the booking.

The indictments do not prevent him from continuing his duties as mayor.

Maximum penalty for a perjury conviction in Schruk's case is 10 years in prison, and for accepting a bribe, 15 years in prison.

AFL-CIO Suspends Beck; Order Full Inquiry Into Teamster Union

WASHINGTON (AP) — The AFL-CIO Executive Council today suspended Teamsters' President Dave Beck as an AFL-CIO officer and ordered an inquiry into the entire Teamsters' Union.

Beck's suspension as an AFL-CIO vice president and Council member is effective immediately, and until the outcome of charges being brought against him by the Executive Council.

The actions were announced by George Meany, AFL-CIO president, after a two-hour Council meeting.

Meany said Beck's suspension is effective immediately while the Council considers charges against

the Teamsters' chief based on what he termed Beck's "actions in bringing the labor movement into disrepute" and his falling to explain "the many charges against him" concerning use of Teamster Union funds before the Senate Rackets Investigating Committee.

Beck pleaded his constitutional rights, invoking the Fifth Amendment, when questioned by the senators Tuesday and Wednesday. The amendment protects a witness against being required to give evidence that might be self-incriminating.

The committee told Beck the evidence it had collected indicated

he had diverted some \$320,000 of union funds to his personal use.

The AFL-CIO Council directed that the labor organization's five-member Ethical Practices Committee investigate the Teamsters' Union "to determine whether or not the Teamsters' International Union is substantially dominated or controlled by corrupt influences."

This latter investigation — separate from the investigation of Beck — could lead to ouster of the Teamsters from the federation unless the union moves to rid itself of alleged corrupt leadership.

The Council's actions are probably the most drastic ever taken

by organized labor in America against a union leader of so high a position.

It gave substance to the AFL-CIO assertions in recent months that it is ready to work with congressional committees and other public bodies to clean every semblance of corruption from the 15-million member AFL-CIO.

Earlier this year, the Council had expelled a Philadelphia union official, Charles Naddio, and had temporarily suspended three small unions.

These unions were the Distillery Workers, Laundry Workers and Allied Industrial Workers. They were suspended until they demonstrate a clean-up of conditions in their ranks.

In addition, Meany has suspended Paul Dorfman, head of a Chicago Waste Handlers local union, pending a union trial on corruption charges.

Walter Reuther, head of the United Auto Workers, told news men as he went into the Executive Council meeting that he was confident "we will do what is necessary to protect the good name of the American labor movement."

"My interpretation of the AFL-CIO constitution—and I have competent legal opinion to support it—is that the Council has power to suspend (Beck) pending a trial," he said.

Reuther said he meant suspension both as an AFL-CIO vice president and an Executive Council member.

The Council has no authority to remove Beck as Teamsters' President but could direct his union to do so.

Reuther, asked if he would move in the Council for Beck's suspension, said reporters could "draw your own conclusions" from his previous remarks.

There were 22 Council members on hand when the session began.

Beck, himself a member of the powerful, 29-man Executive Council, fled at his home in Seattle.

He stayed there yesterday after spending two days here invoking the Fifth Amendment to avoid answering questions by Senate rackets investigators who said he converted to his personal use \$320,000 of union funds.

George Meany, AFL-CIO president, called the special council meeting Tuesday within minutes of learning that Beck had claimed the Fifth Amendment's constitutional privilege against self-incrimination.

County Tax Office Bills To Assembly

Two bills affecting the Pitt County tax office have been forwarded to the General Assembly and are expected to be introduced either today or early next week.

County Attorney W. W. Speight forwarded the bills to Representative Walter Jones and Senator Paul E. Jones after completing them yesterday. One of the bills would allow the county furnish a tax rate along with tax receipts instead of printing the rate on receipts. The other bill would discontinue the allowance of pre-payment of taxes until August 1 each year. Both bills are "local" legislation and are designed to affect only Pitt County.

Pitt County's Board of Commissioners directed Speight to prepare the bills after hearing a request from Tax Supervisor Harold Alred at a special meeting in January. Alred pointed out at the special meeting that changes are being requested because of the matter of time involved in present procedures.

As things stand now, General Statute 105-345 requires North Carolina counties to allow prepayment of tax collections in July with a two per cent discount. Alred said the procedure affects only a few tax payers and that it involves extra work in his department because final tax bills are not usually completed by July 1.

If the bill is passed, persons who pay their taxes in August will get a two per cent discount. September payments will get a one-and-one-half per cent discount, October payments a one per cent discount and November payments a one-half of one per cent discount. December and January payments will require the full amount of the tax bills.

The second bill requests an amendment to G. S. 105-324 to permit Pitt County to enclose copies of the tax rate break-down with receipts instead of printing the break-down on the receipts themselves. Present laws require that

the break-down be printed on the receipt.

The bill is being requested because the break-down is not always completed at the time orders for tax receipts are sent to printers.

Private Sale Of Edwards Bldg. Is Being Requested

A petition to conduct a private sale of the Edwards Building has been filed with Clerk of Court D. T. House, Jr.

Heirs of the estate, who turned down a public sale offer of \$30,000 by Pitt County, has requested permission to sell the office building for \$37,500. An offer of that amount has been made, according to attorney Lewis G. Cooper who is serving as commissioner for the estate. Cooper did not disclose who had made the bid of \$37,500.

The petition will remain open until April 4 before the private sale can be confirmed. If the private offer is raised before April 4, law requires that a second public sale be held with bidding to open at the level of the highest offer made.

The county has been seeking the building, located on Evans Street between the Court House and the Armory, as additional office space.

The two-story building contains facilities for about 18 offices but considerable renovation will be necessary before all of the space can be utilized.

Chairman B. Alton Gardner of the Board of Commissioners entered the county's bid of \$30,000 at a public sale on March 11. The bid, the only one offered at the public sale, was not confirmed and the sale set aside by an order signed by House.

The petition for private sale, which was filed March 25, includes reports from three freeholders who say that \$37,500 is a fair price for the property. The freeholders who filed reports are Bancroft Moseley, J. H. Harrell and Alton R. Barrett.

The property, which has a 55-foot front on Evans St. and a depth of approximately 129 feet, is listed on the Pitt County tax books as having a tax valuation of \$9,320. Tax valuations are usually listed as about one-third of actual property values, however, according to an original petition filed January 25 for sale of the building.

AWOL Marine Arrested On Auto-Stealing Charges Here

A Marine, AWOL from Cherry Point, led law enforcement officers on a "merry" chase last night from his base to Greenville, before being apprehended by local police early this morning.

Police Chief S. G. Gibbs reported this morning that the Marine has been identified as Thomas N. Tennis. According to military authorities the 17-year-old boy was on a work detail as a result of disciplinary action at the time of his escape.

He reportedly stole a 1955 automobile from Cherry Point and drove to Washington, N.C. Chief Gibbs stated that military authorities

gave chase shortly after the Marine left the base but lost him enroute.

After arriving in Washington, Tennis stopped at a service station and had gas put in the stolen car. He is said to have driven off without paying for the merchandise.

That was reported to the Washington police by the service station attendant.

Leaving Washington, he abandoned the first stolen car in the vicinity of Grimesland and took a 1953 vehicle belonging to Leo Hawkins, Negro farmer of Grimesland Rt. 1.

From Grimesland, Tennis drove on to Greenville and left Hawkins' vehicle on Elm Street. Gibbs stated

that the Marine then proceeded to steal a 1954 automobile owned by C. K. Beatty of 407 Elm Street.

Shortly after the theft, he abandoned the Beatty automobile on East 5th St. near Greenville high school.

Tennis later took a 1954 vehicle belonging to R. C. Stokes Jr. of 414 Elizabeth St. The Marine was driving this car at the time of his arrest.

According to police reports, he was stopped at the intersection of 4th and Evans Streets by two members of the police department who recognized the automobile from a description given by the owner. The arrest occurred at approximately 3:30 a.m.

In addition to the Greenville police, Chief Gibbs stated that ABC officers and members of Pitt County Sheriff's department assisted in the investigation.

The Marine, Gibbs stated, will be given a hearing here Monday morning in City Court on charges of automobile larceny.

Hold Up Action On Prisons Bill

RALEIGH (AP) — The House State Government Committee today delayed action on the bill which would separate the Prisons Department from the Highway Commission, until a question governing use of federal funds can be ironed out.

The question, raised by Reps. Roger Kiser of Scotland, Thomas Turner of Guilford and Philip R. Whitely of Wake, is whether or not federal highway aid funds would be cut or reduced if Prisons Department financing is transferred from the highway fund to the general fund and a later Legislature should decide to transfer it back.

Whitely raised the point that such a transfer might be construed by the federal government as a diversion of highway funds and therefore come under a federal law which calls for reduced federal aid to states which practice diversion.

On motion of Rep. William F. Womble of Forsyth the committee asked the attorney general to check the matter with the Federal Bureau of Public Roads.

The proposed budget calls for 17 million dollars of the highway fund to be used to support the prison system during the next biennium, with the other four million dollars to come from the general fund.

Rep. John Umstead stated he planned to move in the Appropriations Committee to transfer the four million dollars to the highway fund. However, other legislators felt there was too much doubt involved to risk passage before checking with officials in Washington.

Rep. Whitely also proposed an amendment which would have made the Prisons Department a division of the Highway Commission but responsible solely to the governor. He withdrew this, however, in lieu of the larger motion by Rep. Womble. A motion by Rep. John Kerr of Warren to report the bill favorably also was withdrawn.

Rep. Whitely warned the committee against divorcing the prisons system from the highway fund which, he said, has sufficiently taken care of prisons operations in the past. "Don't divorce ourselves from the goose that's laying the golden egg," he urged.

Pitt Bills Ready For Legislature

A bill which would empower the Board of County Commissioners to call a special election to authorize an industrial development tax and creation of an Industrial Development Commission for Pitt County has been forwarded to Representative Frank Woolen for introduction into the General Assembly.

The bill, requested by the commissioners, was completed and forwarded yesterday by County Attorney W. W. Speight. It is expected to be introduced into the General Assembly either today or early next week as "local" legislation, affecting only Pitt County.

If it is given favorable consideration by the Assembly, the bill would "authorize and empower" county commissioners to call a special election to decide whether they can levy a tax not to exceed three cents per \$100 valuation to support industrial development. If the tax is approved in the special election, the bill would also authorize commissioners to name a 12-member Industrial Development Commission to encourage industrial growth in the county.

Portions of the bill which affect the Industrial Development Commission provide that Greenville-Pactolus community, Stokes community, Ayden community, Grifton, Farmville, Fountain, Winterville, Grimesland and Falkland would provide one member each for the commission. The other two members would be at-large appointees from the county. The bill provides for appointment of all commission members by the Board of County Commissioners.

Terms of office of the members of the commission will be three years and commissioners will serve until their successors have been appointed and qualified.

The commission member who is designated treasurer will have supervision of all funds administered by the commission although the bill stipulates that "no money, property or funds of the commission shall be used directly or indirectly as a subsidy or investment in capital stock or capital assets in any business, industry or business venture."

The bill also provides for the commission to set up a bureau to encourage new business and industrial development based on either local or foreign capital.

The election which the bill calls for would be called by the Board of County Commissioners upon presentation of a petition signed by any 100 voters of Pitt County. The election would be administered under rules and regulations affecting other elections. The points mentioned in the bill include opening registration books the fourth Saturday before the election day, closing them at sunset on the second Saturday before the election and reserving the Saturday immediately prior to the election as challenge day.

Push Search For Captive Woman

TEHRAN, Iran (AP) — Iranian authorities say they believe a 35-year-old American woman kidnapped by a bandit gang may be hidden away in a desolate mountain cave.

An intensive search was pressed again today in the Tangorkheh Desert area of southeast Iran for the outlaw band that seized Mrs. Anita Carroll of Issaquah, Wash., after slaying her husband, another American and two Iranians Sunday night.

Interior Minister Assadollah Alam declared "there is more than a 60 per cent chance" that she will be found alive.

Officials based their belief that Mrs. Carroll has not been killed on the theory that she would bring a high price on the slave market.

Army men wise in the ways of the semicivilized Tangorkheh Desert tribesmen said it is likely Mrs. Carroll is being hidden by the gang until it can smuggle her to the coast and send her to Arabia or Pakistan.

Police and camel-borne troops — 1,200 strong — were pursuing the kidnappers, believed led by a notorious bandman named Dads-han. The only trail of Mrs. Carroll was a paper trail found in the desert and believed dropped by Mrs. Carroll as she was carried away.

The bodies of Mrs. Carroll's husband Kevin, 37, a Point Four development adviser for Kerman province; Brewer A. Wilson, 35, Portland, Ore., a regional specialist for the Near East Foundation; and the two Iranians were brought to Tehran by U.S. Air Force planes. They were received at Mehrabad Airport with military honors.

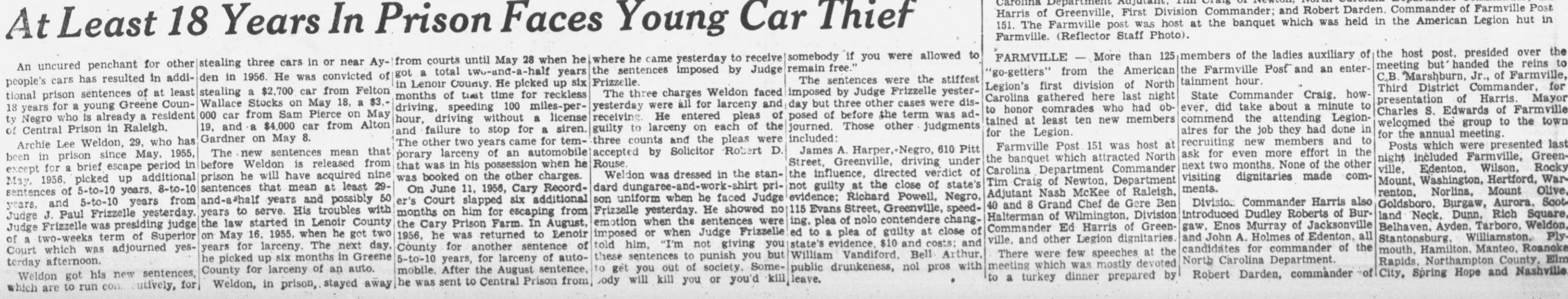

Librarians, Trustees Of District Conduct Special Meeting

A special meeting of librarians and trustees of public libraries in the Northeastern district of North Carolina was conducted at Sheppard Memorial Library yesterday morning and afternoon.

The purpose of this special meeting was to explain to the librarians and trustees the various forms to be filled out and followed, and to suggest possible types of library service that can be financed through the Library Service Bill. This bill was recently passed in the United States Congress, giving Federal aid to public libraries.

Conducting the meeting were two representatives from the staff of the North Carolina State Library, Miss Frances Gish, Field Librarian, and Miss Elaine von Oesen, Extension Librarian. Miss Gish and Miss von Oesen have been conducting special meetings throughout North Carolina since March 12.

Miss von Oesen stated, "Since a large number of libraries in Northeastern North Carolina serve rural areas, these libraries will be directly affected by the amount of appropriation made by Congress."

"If Congress approves less than five million dollars for the entire county, many of these libraries will not be able to expand services beyond those now given," the Extension Librarian added.

The bill, passed on a five-year basis only, is designed to assist in the purchase of additional books, equipment and to help supplement the salaries of needed personnel. It was disclosed that the bill does not provide for the purchase of land or building space.

Over 60 delegates representing towns throughout this area were present for the meeting that commenced yesterday morning at 10:30 and adjourned at 3:30 p.m.

It was explained that rural librarians would receive a majority of the bill's benefits. A spokesman stated that the Library Service Bill will monetarily assist in the improvement of rural library service for a five year period. After that time, it is generally felt that these established standards will be maintained in the areas served by the libraries.

During the meeting a question and answer period was conducted by the two visiting members of the State Library.

Miss Elizabeth Copeland, Sheppard Memorial Librarian, stated yesterday after the meeting, "This program will be of value in assisting rural libraries to develop and improve their services."

Stuttering May Be Caused By Tension

ALMOST ALL CHILDREN stutter a little when they are beginning to talk. Of course they learn to talk more easily, but a few don't; they may even continue to stutter up into adult life.

It is because of this possible danger that parents are often much concerned about little breaks in a young child's speech.

There is much that we do not know about stuttering. It does seem to run in families, and boys are more prone to it than girls. A child's emotional state has a lot to do with it — tense, unhappy children sometimes stutter. Occasionally a child will show that there is undue strain upon him by sucking his thumb excessively or wetting his bed or having temper tantrums, or by any one of a dozen "tension outlets." But some children stutter when things are going badly with them. It seems as though stuttering comes easier to such children — and we do not know why.

Left-Handed Child
It has been thought that making a left-handed child use his right hand may be the straw that breaks the camel's back, and start a youngster, prone to stuttering, to speech impediments. The part of the brain that controls speech is closely connected with the part that controls the hands. If the two interfere with the use of the hand, a child normally prefers, it may interfere with his speech — if he is one of those people whose speech is a little uneasy anyway.

A child prone to stutter will show the symptom when he is upset — this much we know for sure. What we don't know is why some children express their agitation by this means instead of another.

When Sammy was 4 he stuttered quite badly when his beloved grandfather died. Slowly his speech came back to normal, but he began stuttering again after the birth of his baby brother, and once again when he entered school. When Sammy begins to stutter his mother knows he is worried and upset, and she does her best to make him feel more comfortable.

Winners of the National Book Award have just been announced. The Award is made annually to the three books of fiction, non-fiction and poetry that are judged to be the "most distinguished" in their respective fields, and is sponsored by the American Book Publishers Council, American Booksellers Association and the Book Manufacturers Institute. Here are the three titles for 1956:

In fiction, "The Field of Vision," by Wright Morris.

In non-fiction, "Russia Leaves the War," by George F. Kennan.

In poetry, "Things of This World," by Richard Wilbur.

All three have at least two things in common: we haven't read any of them, and not a single one is on a current best-seller list.

We cheerfully admit that this must mean that we don't read the right books — but how about everybody else in the country?

Why haven't more people read these three "most distinguished" selections? Somebody's taste — either the National Book Award people's or the reading public's — is awry.

Speaking of the charmed list, we glanced through it and found that Daphne du Maurier's "The Scapegoat" has usurped Number One position for the first time this week, pushing "Peyton Place" down to second. This represents a steady climb for Miss du Maurier's intriguing novel about an English history professor who swapped places with a French count for awhile.

It was a recent Literary Guild choice, if you remember. . . . The May selection of the Guild, incidentally, just announced, will be "Anne Boleyn" by Evelyn Anthony — you've guessed it, about the wife of Henry VIII who was Queen Elizabeth's mother. A lot of books have been written about and around her, and we can't tell you much about this one. . . . "Birthright," the April Guild novel, is about a school teacher in a small southern town, and will be reviewed in these columns soon. . . .

Concern in the Kremlin
We've just been reading about a book called "Not By Bread Alone," by Vladimir Dudintsev, that came out in the August, September and October issues of the Soviet literary magazine, Novy Mir. It's created such a furor that the government has suppressed any further printings, and original copies of Novy Mir containing it are selling at around \$25 a set, five times the normal cost. The story is about a Russian inventor whose new machine for manufacturing pipe is rejected by bureaucrats even though it's a better machine than anything available, simply because the bureaucrats don't want to bother with it. The book doesn't sound very sensational, but it brings up several controversial points, and we feel that anything controversial in a country like Russia is a good thing for everybody, if only to get people to do some thinking by themselves, instead of letting the government do all of it for them. . . .

Gov't Has Big Stake In Tobacco

If tobacco farmers could get as much out of cigarettes and other tobacco products as the government does, folks in Pitt County and Eastern North Carolina wouldn't have to worry about the agricultural outlook or the decrease in tobacco acreage allotments.

Last year tobacco farmers received \$1,151,000,000 for their crop. During the same year federal and state governments collected \$2,185,000,000 in taxes on cigarettes and other tobacco products.

Such a situation is in itself bad enough, but to make matters worse the tax take on tobacco products was up four percent during the past year while the farmers' share of tobacco money was down six per cent. This year the government take from taxes on tobacco products is expected to go even higher while the farmers get even less than last year for their crop.

These are not new circumstances in the overall tobacco picture. For years the government has been receiving more from taxes on tobacco products than the farmer has been receiving for his year's work in producing the crop. Taxes on tobacco have brought billions of dollars into government coffers.

It should be pointed out too that unlike other of its crop price support program, tobacco has yet to cost the government a cent for surpluses. Millions of pounds of tobacco have gone to stabilization over the years, but this tobacco has been disposed of at a profit. The government has paid out millions upon millions of dollars for wheat, corn, butter and other farm crops. It has paid out nothing for tobacco which brings more than two billion dollars in taxes to the government every year.

In view of those circumstances, would it be amiss for the federal government to invest several million dollars in tobacco to help remove the staggering surpluses of leaf now on hand? Most people who are familiar with the tobacco industry agree that the major portion of tobacco now held by stabilization is not of the quality which is in greatest demand. Although it could be sold in the world market at a lower price, foreign purchasers refuse to buy it at the asking price. They can buy similar tobacco from other countries at lower prices than they can from the United States.

As long as this surplus of tobacco remains in stor-

age, it will tend to depress prices on each new crop produced by farmers. The cost of this tobacco will continue to rise because of the storage charges which must be paid for each month or year it is held.

It would cost the government several million dollars if it made up the difference between the price this surplus tobacco brought on the auction floors and the price it will bring on today's world market. Even so, such an expenditure would be wise investment by the government in stabilizing the agricultural economy in the broad tobacco region. It would also serve to help retain the foreign market for U. S. tobacco which is constantly threatened by other tobacco-producing countries which can sell their crop for considerably less than the United States can.

From its annual tax take on tobacco products, it is obvious the government has a big financial stake in this particular crop. It could afford to spend a small percent of its annual take to crue one of the major threats to a continued prosperous tobacco economy in this country.

School Science Fair Seizure Inexcusable

If ATU agents in South Carolina have to raid schoolboys' science exhibits to find stills, they should turn in their badges and let the government save the money they are getting in salaries.

The ATU agents should be made to answer for their uncalld for action in seizing the science exhibit through which a 15-year-old boy hoped to win a college scholarship. Not only did they knock the kid out of any chance he might have had at the scholarship or other prizes, they likewise degraded the respect a great many people have for law enforcement officers.

There are probably several thousand producing illegal liquor stills in South Carolina, hidden in old barns, woods and swamps. They are turning out countless gallons of illegal spirits every day. But it takes time and trouble to find them. Maybe the ATU agents in South Carolina felt the little still in the science exhibit made by a kid to demonstrate fermentation and distillation, presented a greater threat to society and to law and order. Or maybe it was just a lot easier to confiscate the kid's still, openly displayed, than to hunt for moonshiners.

In our book the rash action taken by the South Carolina ATU agents against the school science fair is inexcusable and should not be shrugged off by top officials who are in charge of the ATU enforcement program.

'Nibbling' Hits Statewide Laws

NIBBLING—Many statewide laws are undermined in effect by insidious nibbling through so-called local bills. Rep. Sam Whitehurst and Sen. Luther Hamilton got a bill through under suspension of the rules last week masked as a local bill, but which in effect authorized blocking of a main primary highway (US-70) for perhaps an hour or more.

The general statutes confer upon the highway commission the authority to permit closing roads to traffic in order to permit their use for house moving or other purpose. The special "local act" upset this policy, because the highway commission had declined to permit the road closing in this instance. When Senators discovered the effect of the bill they had passed without committee consideration—without having even been read in the House—they sought to rescind the action. Too late.

Another nibble at a statewide law was Sen. Jule McMichael's bill making it illegal for citizens of Rockingham county to petition the county commissioners to add or take off a road from the highway system, and requiring the petitioners to file their petition with the Director of Highways at Raleigh.

The bill is accorded less than one chance in a thousand to get on the law books. It strikes at the very heart of the local responsibility feature of the highway reorganization act passed a few days ago.

These are two illustrations of the numerous attempts to circumvent general laws with alleged local acts, which are "local" only in the captions of the bills.

WEEK END PRISONERS—The proposal to permit certain persons sentenced to serve time in State prison to work at regular jobs during the day and spend nights and weekends in prison is rather generally approved "in principle" by legislators.

The plan is officially known in prison jargon as "work release," the idea being that the person is theoretically in prison all the time, but released during working hours to help pay for his own prison keep, help support his family, and earn a little money that will be available when he has completed his sentence. In one sense it is an extension of the honor grade rating which permits prisoners to work outside walls and without guards, but only on State jobs.

In another sense it is a combination of the probation and parole ideas. To understand the "work release" plan it is necessary to get a clearer picture than most people have of how the probation and parole systems operate.

Probation is a judicial "unction" in the discretion of the judge of a court of competent jurisdiction a convicted offender may be put on probation instead of being sent to prison. That means he is under continuous supervision on probation officers who must report to the court any infraction or violation of the terms of probation. It is still in the discretion of the sentencing

court to determine whether the probationer shall remain out or be sent to prison.

Parole is purely an administrative function, applicable only after the offender has been sentenced and incarcerated. In fact, it is the highest honor grade for a prisoner, because he must report periodically either to the prison or, which is the usual practice, to the welfare department of his county.

COMBINATION—The "work release" plan involves both administrative and judicial functions, in a combination that is new to North Carolina. Honor grade rating and parole have been recognized ever since North Carolina was a State. Probation is more than 20 years old here, and older in other places.

What happened? The two got around a dozen calls from unemployed individuals who wished to pick up a morning's work. This brought a change in the ad. Now it asks for 50 men to DONATE an hour Monday morning for sweeping the city's Main

Street. Anyway men for the job are still needed and those willing to work for an hour beginning at 9 a. m. Monday can still call Dr. Aldridge or Boykin. Don't expect any pay though. Its all for free.

Red and orange bands now circle all Utilities poles in the city on which fire alarm boxes are located. Firemen have recently completed the job of installing the bands.

The bright bands can be seen blocks away. There's also the advantage of being able to tell there's an alarm box on the pole even though it might be located on the far side out of sight.

One Of Richest Men

NEW YORK (AP) — Multimillionaire Axel Wenner-Gren, "The Swedish Sphinx," says it is a mystery to him why he is sometimes called "the mystery man of international finance."

"If I spent all my time talking about what I was doing, I wouldn't have time left to do all the things I still want to," he said.

"I am no mystery man. I have tried to keep out of the spotlight, but sometimes you have to throw a little light on what you are attempting to do."

And in his 76th year, Wenner-Gren feels he is now embarked on the biggest project of his life. It is the opening up of a 40,000-square-mile frontier tract in British Columbia, a wilderness area of Canada almost as large as England and Wales combined.

Wenner — Gren has deposited half a million dollars with British Columbia provincial authorities as a guarantee he will build a 400-mile monorail in the area by 1960. But before then he expects to spend five million dollars to inventory its mineral, hydroelectric and timber resources.

"This is the most important thing I have ever tried," he said, "because it will mean more to more people."

His company has agreed to provide hospitals and schools in the area as it develops, and his own share of any profits have been pledged to philanthropies. His associates estimate that if the territory proves as rich in resources as they expect, more than a billion dollars of development capital will eventually be required.

Wenner-Gren, who is tanned, gray-haired and as vigorous as his Viking forbears, is often referred to as "one of the five richest men in the world."

His blue eyes twinkle in amusement when asked if it is true that he belongs in this charmed circle of wealth.

"I don't know myself," he said. "I wish I were. But as soon as I have more than I want I give it away."

Associates have estimated he has given from 25 million to 50 million dollars to various scientific and health foundations he has established here and in Sweden. He doesn't like to discuss his private philanthropies.

Wenner-Gren is an organization genius, and is now reported to have active business interests in 20 countries. He founded his fortune on vacuum cleaners and home refrigerators, but today his scores of corporations make everything from diet pills to railroad trains.

The real mystery to most people is how this "mystery man" who in 1907 was getting 15 cents an hour in a New Jersey tractor factory, became a 20th Century Croesus.

But Wenner-Gren doesn't mind disclosing his secret of how to become rich.

"All that is required to make a million dollars is hard work, self-discipline and common sense," he observed dryly.

There, the secret is yours. Now let's see how quickly you can pile up your first million. The odds are that, even though you now know the magic formula, you won't use it.

"Many people aren't independent-minded," said Wenner-Gren. "They don't want to take up the challenge of going into business for themselves."

"I do. I still supervise all my interests personally, and I feel I have at least 10 more years of business activity."

"What lies ahead? I don't see any real crisis. I can't think of anything more promising right right now than the future of the United States."

No Income Tax Help That Way

While you calculate your income tax in the next few days, you can make yourself a little more miserable by realizing that a rate range of 13 to 56 per cent could bring in as much money as the present range of 20 to 91 per cent.

To get such lower rates, taxpayers would have to give up their special allowances and miscellaneous deductions.

William Vickrey, professor of economics at Columbia University, writing in the current issue of Challenge, published by New York University explains:

"National income estimates of the Department of Commerce show personal incomes of individuals amounting altogether to \$93 billion. Only about \$125 billion of this sum is estimated to be actually subject to the individual income tax. Of the difference, \$101 billion perhaps can be accounted for by personal exemption limit and not filing returns. There remains \$77 billion which could, in theory, be made subject to the tax."

THE UNTAXED \$77 BILLION Taxing these \$77 billion could bring the rates down, as noted above. But Mr. Vickrey doubts whether it could be managed.

The present rates, he states, were enacted in wartime "largely as a means of persuading the mass of taxpayers that the burdens are being equitably distributed."

Since then, "Democratic and Republican Administrations alike have shrunk from appearing to favor the rich in their tax reduction programs."

Instead, a large number of "adaptations" have been made to minimize the high rates. A study of 1951 found that persons with incomes of over \$1,000,000 paid an effective rate of only 48 per cent — considerably less than the top rate of 91 per cent. Gently-taxed capital gains, tax-exempt bonds and other dodges (the professor's word) permit this vast, legal tax escapement.

GOVERNMENT FOOLS PEOPLE "The result is a great pretense of progressivity," Mr. Vickrey writes, "but this progress-

ivity is invalidated by the increasingly generous provision of loopholes. The unsophisticated voter is thus led to believe that the degree of progression is greater than it actually is, while in reality the incidence of the tax becomes more and more capricious, depending on whether individuals are in a position to avail themselves of the loopholes.

"The little taxpayer, too, by dint of persistent clamor, has been let in on the fascinating game of special deductions and exemptions provided, that is, that he has sufficient time, patience and persistence to ferret out all the favorable possibilities, or can pay a tax specialist to do the job for him."

Many special deductions have no equitable justification, the professor declares, adding, "Their continuation can be explained only on the theory that the taxpayer's bargain-counter psychology is being pandered to by allowing him deductions; although, of course, this is merely to offset the fact that rates are higher than they would be if a tighter rein were kept on deductions in the first place."

The professor appears to confirm a statement often made here: The tax laws make converts of us all.

British Press Cool Toward U. S.

By RAY TUCKER

WASHINGTON Although the Eisenhower-Macmillan meeting at Bermuda may have improved Anglo-American relations on the select and official level, it has not contributed to a better understanding or friendlier attitude on the part of the British people on the street. And the same observation applies to the popular feeling toward us in France.

The mass viewpoint toward the United States is fixed, not by the uncommunicative and polished communiques of top-level statesmen, so much as it is by the tone and tenor of day-to-day newspaper dispatches. The British are tremendous newspaper readers. And the reporting by representatives of Britain's most influential newspapers, liberal and conservative, anti-government and pro-Macmillan, is invariably unfriendly, disparaging and condescending.

THE EXPLANATION for the lethargy that has fallen on American politics is to be found not in Eisenhower's weakness, but in

the absence of ideas in both parties. The Democrats are more exposed and vulnerable, since they cannot hide their deficiencies behind a respected leader or the splendid facade of administrative efficiency.

There was some hope of a constructive advance when Mr. Eisenhower came before Congress in January with a new design for the Middle East; but the vision has been obscured by the intellectual fog in which Mr. Dulles moved, and by the smaller blemishes of Congressional indecision.

"The debate on the budget is prompted less by concern over its size than by controversy over functions of government of mediocrity in American politics.

"IKE BEWILDERED" If Mr. Eisenhower has gone to Bermuda as a generous and compassionate man, but also conveying the impression that he is somewhat bewildered and adrift, he is no more than an accurate reflection of American policy today—both in its strength and its mistakes.

Thus, according to these reports to the British people, and their newspapers help to mold general European opinion, our President is "bewildered and adrift," our Secretary of State moves "in a fog," and they symbolize the mediocrity and stupidity characteristic of the American people in these days of world crises.

UNION PAPER COMMENTS ON HIGH COSTS Organized labor has attributed the constant increase in the cost of living to excessive charges and profits on everyday commodities in the market. No more than management, the unions have not responded to Ike's request that they co-operate in the battle against inflation.

But Labor, the weekly newspaper of the Railway Brotherhoods, reports a current operational deficit because of the "steadily mounting costs" of wages and newprints. For the same reason, it says that a new building will cost far more than the original estimates, and construction may have to be deferred.

CHAPEL HILL, N.C.—Yale's once-high hopes of winning the National Collegiate swimming championship rested on the broad shoulders of sophomore Tim Jecko and on its record-breaking relay team today after an unexpected setback in the 1,500-meter race.

Yale led in the point totals after the opening event of the three-day NCAA meet, but the slim margin of nine points to Michigan's eight indicated it would be a real scrap instead of the expected runaway.

This turnaround came when Michigan's Fritz Myers clipped 42 seconds off his best previous time and beat Yale's favored Ray Ellison to the finish line by about a yard in the fast second heat of the 1,500. Joe Robinson of Yale took third place to give the Elis nine points, but Peter Fries picked up a sixth-place point for Michigan by finishing second to Buddy Belshe of Denver in the slower first heat.

The metric mile race, only event on the opening night's program, was run off in two heats with the placings decided on times. Belshe and Fries, relieved of the strain of trying to keep up with the faster men, both turned in surprisingly speedy performances.

But it was Myers, equalling the record for the shortened 25-yard Bowman Gray pool, who supplied the big surprise. He trailed Ellison, the Eastern champion, but stayed within striking distance until there was about a quarter of a mile to go. Then the Michigan lad took the lead only to have Ellison spurt ahead again. The were almost even coming down the next-to-last lap, but Myers went out in front by about an arm's length as the gun sounded to indicate about a lap and a half to go. Adventists To Observe Special Day Of Prayer, Fasting, Saturday

Special prayers will be offered and a day of fasting observed Saturday, by Greenville Seventh-day Adventists for Christians who are being persecuted for their religious convictions in Columbia, South America.

Pastor Lyndon De Witt of the Greenville Seventh-day Adventist church said special prayers would be offered at 1:30 o'clock worship services Saturday morning. "For fellow Christians who are passing through a very critical time."

Pastor De Witt said the special service results from an appeal by Adventist World President R. R. Figuhr, Washington, D.C., stating that in Columbia 10 Seventh-day Adventists died in 1956 because they would not recant their religious convictions.

Church members have been beaten to death, beheaded, and shot in their own backyards; homes have been destroyed, churches burned and scores imprisoned. "Figuhr's message stated, "During the summer of 1956, a total of 197 Adventists were imprisoned," he says.

The message received by the local church said that while persecution has been evident in Columbia for a number of years, "in recent months it has been increasing in severity." The message also called for prayers for Christians in other countries where religious restriction is common.

Ford was off around a point, Chrysler more than that and General Motors showed little change as the auto industry picture was one of cutbacks in production.

Coppers earlier had maintained their upside position on firmer prices for the red metal but they, too, turned spotty. Phelps Dodge held a major fractional advance while Anaconda and Kennecott erased gains.

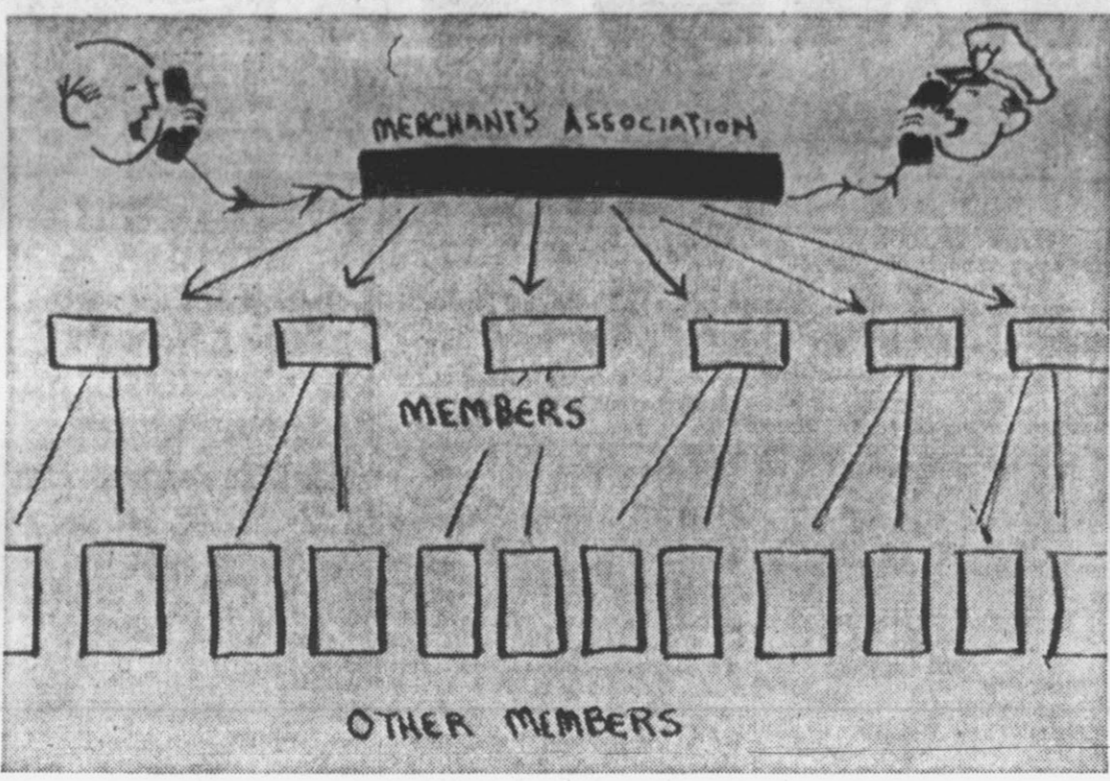
The ADA was created in 1947 to check what its founders termed a trend toward conservatism. The organization says it is nonpartisan, but so far it has supported only Democrats for president.

One of the group's first tasks today was the formulation of a new "statement of principles" setting forth ADA aims in present-day terms.

New Bad-Check Plan Ready

A big step has been taken by the Greenville Merchants Association to curb bogus check flashers in this city.

Effective Monday, business firms in Greenville will be closely watching for worthless or forged checks. As soon as a merchant discovers a questionable check he will immediately notify the Police Department or the Merchants Association.

Upon his call, the Merchants Association will promptly contact six prearranged business firms who will then call two other merchants and these two will notify two more until all merchants participating in this new system are contacted.

Charts will be mailed to the 95 participating business firms designating the two firms that are responsible to call in case a professional check flasher is discovered.

This new chain is expected to create a tight check on habitual offenders passing worthless checks in Greenville. This will not affect persons who through error write checks on the wrong bank or carelessly give an "insufficient funds" check.

Chief Gibbs of the Police Department is in full accord with this system and has offered the Greenville Merchants Association his full cooperation and that of his department.

According to Mrs. Cora Powell, secretary of the Greenville Merchants Association, "Cards were sent out to all of the members of the Greenville Merchants Association giving them an opportunity to cooperate in this new plan."

Shocking Point

A recent bulletin from the SBI reported that a long wanted check flasher was now in custody. He had given bogus checks in at least 43 North Carolina towns. His method of operation was to make small purchases at small stores, presenting checks prepared on a typewriter and checkwriter.

Here is the shocking point about this matter: The check flasher confessed to investigating officers that 90 per cent of his victims required no identification from him whatsoever. The remaining 10 per cent accepted a fictitious name printed by the check flasher gang on a metal tag and Social Security card.

Arrest Believed Solve Series Of Battery Thefts

A series of battery larceny cases here have been solved by Greenville police.

The accused man was tried in Greenville City Court this morning and found guilty on all five charges. Judge Charles H. Whedbee sentenced Burnett to two and one-half years on the roads.
