## Pitt Officials Appear In Accord On Uniform Sick Leave, Vacation

Pitt County Commissioners and their department heads appeared in accord last night on the matter of establishing uniform regulations for vacation and sick leave for all employees of the county.

Under the proposal presented by Dr. Humbert, vacation would be granted all employees of the county, including merit system and extension service personnel, on the same basis. From the date of employment through the fourth year of employment, an employee would receive five days annual vacation forever six months; a total of 10 days or the equivalent of two weeks vacation a year during the period.

Employees with five to 10 years service with the county would receive six days vacation for every six months, a total of 12 days a year. Employees with 11 to 15 years service with the county would receive seven and one-half days vacation for each six months of the year making a total of 15 days or three weeks vacation annually. Any request for more than 15 days vacation a year from employees with more than 15 years service with the county would be submitted to the Commissioners for action.

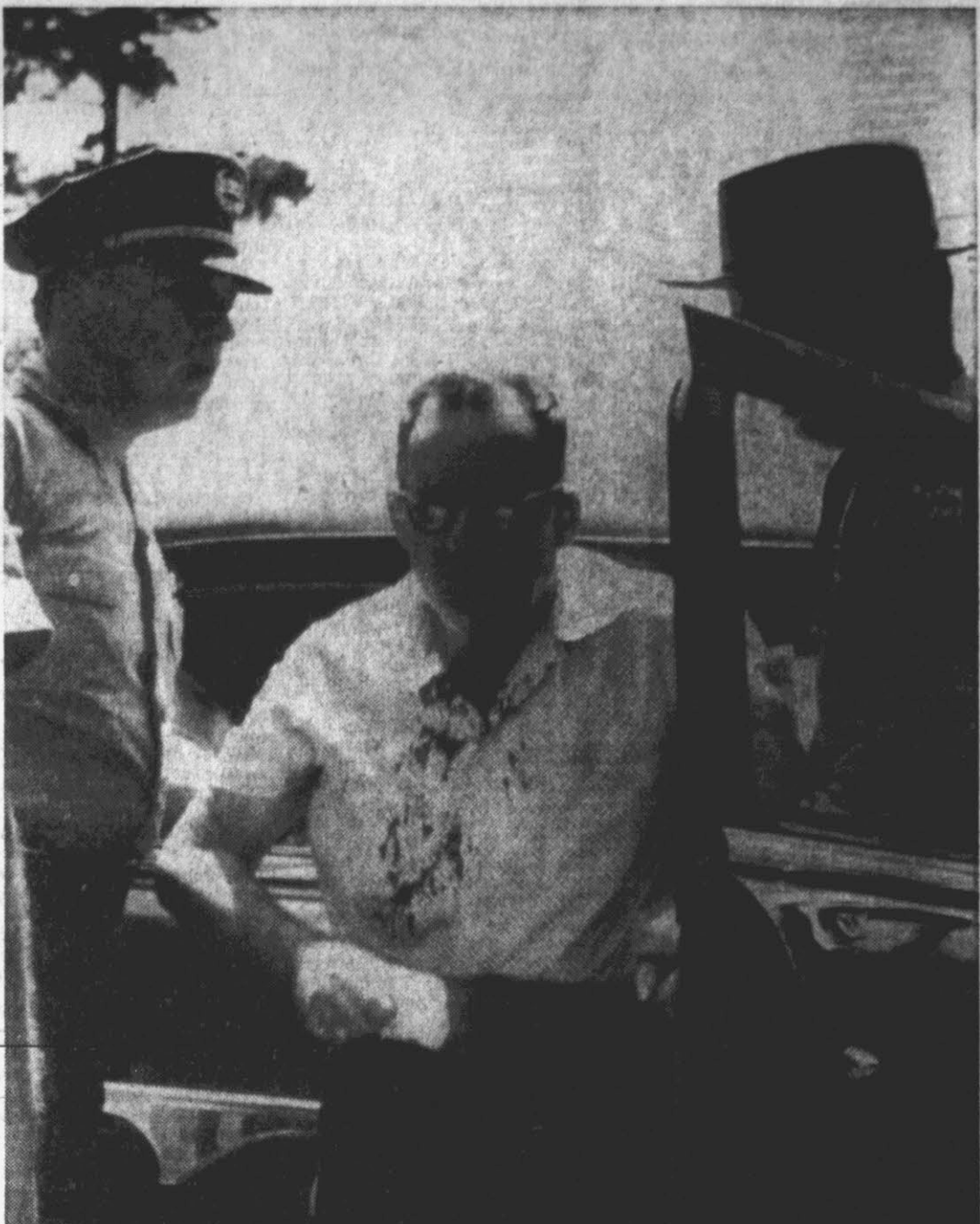
Earned vacation of employees could not be accumulated from one year to the next under the proposal.

Dr. Humbert's proposal also contained a provision that all employees be granted 12 days per year sick leave with the provision that not more than 60 days sick leave could be accumulated.

A special provision for "compassionate leave" was included in the proposal whereby a county employee would be allowed up to five days if necessary in case of death in his immediate family.

At the meeting last night the Commissioners also reviewed briefly the vacation and sick leave regulations of the merit system and extension service, and regulations established by Carteret and Orange Counties.

The Board of Commissioners informed their department heads that the matter of vacations and sick leave would be studied further by the board before definite action is taken establishing a uniform policy which will cover all county employees.

## Southerners See Civil Rights Win

WASHINGTON (AP)—Southern foes of the civil rights bill scented victory today in their efforts to erase what they called the "most vicious part" of the measure.

With supporters of the bill split over compromise moves, Sen. Russell (D-Ga.), leader of the Dixie forces, told newsmen he was "very hopeful" the Senate would adopt an amendment to strike out part 3 of the House-passed measure.

That part would authorize the attorney general to obtain federal court injunctions to protect civil rights generally. Southern senators have protested it could be used to force racial integration in schools and other public places.

Russell said he hoped for a vote no later than Tuesday, Monday if possible, on an amendment.

Sens. Anderson (D-NM) and Aiken (R-Vt.) to rip out this section of the bill.

Republican and Democratic efforts for a compromise that would remove some of the opposition to part 3 collapsed suddenly late yesterday afternoon.

Senate Republican leader Knowland of California said he had concluded no substitute could be worked out "to meet the situation and the desires of the various people with whom we have been discussing it."

He said he was prepared to let the vote come on the Anderson-Aiken amendment rather than attempt to get a vote first on an amendment or substitute softening the terms of part 3.

Like Russell, he spoke of a vote being taken either Monday or Tuesday.

With this word from Knowland, Sen. Humphrey (D-Minn.), a leader of northern Democrats backing the bill, promptly told newsmen that an amendment he had prepared to modify part 3 would not now be offered. Humphrey had said he intended to offer it with bipartisan support.

After these developments, Russell said: "I am glad the Senate is going to have an opportunity to vote up or down this part 3, the most vicious part of the bill."

Sen. Douglas (D-Ill.) said he was "very hopeful" about the outcome. He said the bill's supporters were "optimistic" about defeating the Anderson-Aiken amendment.

A more restrained view was taken by Knowland, who said "I think it will be a very close vote."

## Superior Court Trial For Three Defendants

Three Negroes, held in connection of the Fourth of July disappearance of Mattie Bell Phillips 49-year-old Negro woman, have been bound over for grand jury action.

A Coroner's Jury at last night's inquest recommended that Henry and Jake Barnhill, two brothers of Winterville and Ada Lee Jackson, alias Ada Boyd of 1717 Pitt St. be held for an upcoming term of the Pitt County Superior Court.

Early on the afternoon of the Fourth, the three left with the Phillips woman to go to a Washington, N. C. beach.

Later in the day, the three returned without the Winterville woman saying that she had gotten out of their car and "gone off with another man."

The mother of four children was not seen again until two men found her badly decomposed body on a "lover's lane" just off a rural paved road between Winterville and Ballard's Cross Roads the following Monday morning.

The Barnhills and the Jackson woman were arrested on the same day having been seen last with the woman when she was alive. Later in the week they were charged with illegally disposing of a human body.

This action came about following an autopsy performed on the body of the day it was found on the A. W. Ane farm. The autopsy failed to disclose cause of death. No visible marks of violence were found on the corpse.

When the woman did not return for several days, her 15-year-old son reported her missing to Police Chief D. C. Martin of Winterville who instigated an investigation. Chief Martin was the first witness called to the stand last night by Solicitor Robert D. Rouse who assisted Pitt Coroner Griffin H. Rouse at the inquest.

Only two other witnesses took the stand, Deputy Sheriff N. H. Byrd and Ada Lee Jackson, during the relatively noisy inquest. The City Courtroom was filled to capacity by spectators eager to learn more about the strange disappearance and subsequent discovery of the Phillips woman's body. Several times orders were issued for the verbal outbursts to be toned down in order that questions and answers might be heard.

Chief Martin told of the woman's son coming to him reporting in his mother's two day disappearance. The chief quoted the boy as saying that he had gone off with two men and a strange woman.

After learning of her disappearance, Martin contacted one of the Barnhill brothers and was told the woman had gotten out of his car and left with another man when his automobile started giving him trouble. He said he had not seen her since that time.

Both his brother and the Boyd woman told the same "story" when questioned by Martin and members of the county sheriff's Department before and after the body was found, hardly recognizable due to partial decomposition.

Johnny Streeter of Winterville Rt. 1, a relative of the deceased, identified her he said, "by a gold tooth and clothing she was last seen wearing."

She was found by Ernest J. Hooks and Jimmy Stokes. Stokes had gone to the old Smith Farm, located on a rural dirt road just off the Greenville-Winterville highway, to check on the whereabouts of the middle-aged woman. Accidentally her corpse was found on a wooded path near the field Hooks was working in at the time Stokes came by.

Deputy Sheriff Byrd was the second witness to take the stand. He related the results of the Sheriff Department's investigation following the arrest of the trio.

After picking up the Phillips woman, he related the two couples purchased a small quantity of bootleg whiskey and proceeded to park.

Jake Barnhill and the Jackson woman got out of the car and walked down the wooded path. They were said to have stayed approximately 30 minutes.

Shortly afterwards Henry Barnhill came down the path and said "Mattie Bell is dead."

The three went back to the automobile and the two men took the body out of the back seat of the vehicle, Byrd said. To this Jake Barnhill was in disagreement.

They laid the corpse on the path and left the scene, making up an alibi on their way to the dead woman's house. This story they stuck to for several days following their arrest.

Henry Barnhill told Byrd that he and the woman were in the back seat "talking" when suddenly she clutched her fists and fell back limp. He said he then called to the others to come back to the car.

After further investigation it was discovered by Byrd that Ada Jackson took a watch off the dead woman's arm and pawned it for a half-pint of whiskey. On the stand the Jackson woman denied.

## Prices Unchanged On Georgia Markets

Prices were reported unchanged on the little lower volume sagged sharply Friday at the close of the short two-day first week of auctions at the 28 Georgia-Florida flue-cured tobacco markets.

Observers said, however, they expected sales to be near capacity Monday at the start of the first full week.

Friday's volume was far below the relatively light volume of 8,921,606 pounds that moved Thursday in the first 1957 sales of cigarette tobacco. Warehouse floors were cleared before noon at Moultrie, Waycross and some of the other markets.

Waycross reported 83,772 pounds sold for \$45,552 at an average price of \$57.37. The average was 66 cents less than Thursday's \$55.03. The volume was reported the lowest since at least 1937.

The U.S. Department of Agriculture reported Thursday's belt-wide gross price average at \$53.52 a hundred pounds, up \$4.50 from last season's first day and the highest opening on record.

The USDA reported that where prices by grades changed Friday the trend was slightly downward from the opening. Auction bid averages per 100 pounds on a few representative U.S. grades were as follows:

Leaf—Fair lemon \$60, down \$2 from Thursday; fair orange 62, unchanged; low lemon 59, down 1; low orange 59, down 1.

Cutters—Low lemon 62, unchanged; low orange 62, unchanged; good orange 60, down 1; fair lemon 58, unchanged; fair orange 58, down 1.

Primings—Good lemon 56, unchanged; fair lemon 51, down 2; fair orange 48, down 1; low orange 35, down 3.

Nondescript—Best thin 25, up 1.5.

## Train Derails In Selma Yard

SELMA, N.C. (AP)—Seven cars of an Atlantic Coast Line Railway freight train were damaged here early today when the train was derailed at the freight yard. No one was injured.

Three of the cars were badly damaged and about 300 feet of track in the yard was torn up, company officials reported. Officials had no estimate of damages and were unable to give any reason for the accident.

Schedules were interrupted only momentarily and regular schedules were being met this morning. Wrecking crews hoped to clear the wreckage by late today.

Night shift crews at the Eastern Manufacturing Co., which overlooks the area where the derailment took place, said sparks flew for considerable distances at the time of the accident.

The freight was moving slowly into the freight yard when the derailment occurred.

The derailment occurred shortly after 2 a.m.

An ACL wreck crew from Rocky Mount arrived on the scene shortly before daybreak and began clearing away the wreckage and repairing tracks.

Trains were being routed on a pass track around the scene of the wreck.

The freight, estimated at more than 100 cars, was reported to have made up at Florence, S.C., and was northbound to Rocky Mount.

## Three Injured In Auto Wreck

Three people sustained personal injuries in a two-car collision at the intersection of 14th and Charles Sts. shortly afternoon today.

Injured were: an unidentified Negro couple, addresses unknown, cuts about the face and arms; Wayne Summrell; and John Jasper Arwood of 1509B Fleming St., chest injuries. None of the injuries were serious, investigating officers said.

Arwood was identified as the driver of the 1951 automobile involved in the accident with Donald McKenzie Nichols Jr. of 111 S. Sylvan Dr. Nichols was not injured.

Damage to both automobiles was estimated at \$1,250. The investigation is continuing.

## Lawyers Working On Arguments In Clinton Segregation Trial

KNOXVILLE, Tenn. (AP)—Opposing lawyers in the Clinton segregation trial were working today on final arguments to present to the all-white jury Monday morning.

Their closing statements may hold far more importance in this case than in the usual lawsuit, for two reasons.

1. Tremendous national issues are inherent in the suit.

On trial are 10 men and one woman accused of conspiring to keep Negro students out of Clinton High School last fall.

But beyond the guilt or innocence of the 11 people are the great issues of enforcing the Supreme Court ruling that public schools should be desegregated "with all possible speed," the "social revolution" in the United States, as a southern defense lawyer put it, and the possible effect of this case on future civil rights suits.

2. The defense is setting out to show that the U.S. government failed to prove its charges of conspiracy.

In a daring maneuver, the southern attorneys put only six witnesses on the stand. They say they had "40 or 50 more." But they believed the very fact that they presented so little testimony to rebut the government's witnesses will help convince the jury no case exists to convict the 10 Tennesseans and dark-haired John Kasper, northern segregationist organizer.

They said that, in their final summations, they will hammer home the point that prosecution testimony was "irrelevant and immaterial... not worth answering."

U.S. Dist. Judge Robert L. Taylor allotted to each side four hours for argument.

Attorneys for the 10 Tennesseans have three hours. J. Benjamin Simmons, Washington lawyer who represents Kasper, has one.

U.S. Dist. Atty. John C. Crawford, Jr., 50, and his assistant, "little James Meek, 67, will sum up the government's case.

Crawford's contention, in a nutshell, is this:

That Clinton was peaceful last fall, and Negro students were quietly attending high school classes — until Kasper arrived "on or about Aug. 25." Crawford said, "He came to Clinton stating his purpose or design: to prevent the integration of the school."

The government asserts that Kasper organized the conspiracy, that "overt acts" were committed to keep Negroes out of school, causing violence to flare in the small east Tennessee town.

Taylor's instruction to the jury on how to weigh the evidence probably will come Tuesday.

The trial, which began July 8, has been heard by a jury of 10 men and two women.

## Disastrous Fling At Crime Wrecks Life Of Raleighite

RALEIGH (AP)—A disastrous fling at crime has wrecked the respectable world of Worth Alexander Whitaker.

Holding a "wandering gun," he robbed a bank at Angier of \$12,392 yesterday. The stickup was followed by a chase. He was shot in the jaw and captured some 10 miles from the scene less than an hour later.

For 14 years, he was a dependable employee of a Raleigh newspaper publishing company, trusted with large sums of money. Fellow workers described the 41-year-old, bespectacled Whitaker as timid, reticent, and meek.

Money worries apparently were behind the dramatic switch in character. His wife said debts had mounted and he had borrowed money without her knowledge.

"With him, money is just like drink is with some people," she said. "Maybe this what I've said was going to happen, but I just can't believe it. It'll take time for it to sink in."

It was the third robbery since 1950 at the First Citizens Bank & Trust Co. branch at Angier, a rural Hartnett County town some 18 miles south of Raleigh.

It was timed, almost to the hour, one week after a bank at Apex, a short distance away in Wake County, was looted for \$32,000.

Alert bystanders, including Cashier Hayward Hall, foiled Whitaker's getaway with a brown satchel containing the money.

When Whitaker abandoned the robbery car in Fuquay-Varina, about 10 miles from Angier, an auto salesman, saw the man dash across the highway at a stop light on the outskirts of Fuquay-Varina. "I heard somebody yell 'Catch him,'" said Burchette. "I thought he must be a fugitive of some kind, so I took out after him."

Burchette ran after Whitaker until the chase led back to the highway where Fuquay officers were waiting.

All the while, Whitaker carried with him the money satchel and frequently waved the gun back in Burchette's direction.

Other employees of the newspapers were dumfounded. "From a personality viewpoint, he was one of the last persons working in this building who I would have thought could do that," said Editor Jonathan Daniels of The News and Observer.

Advertising Manager R. H. Carson recalled that Whitaker had carried "thousands of dollars in cash to the bank, and he's never been short a cent."

Whitaker had not worked since June 18, when he went on sick leave.

Employees of the Angier bank said the robber was "very nervous" as he flashed a gun and asked that the satchel be filled with currency. A brown felt hat was pulled down, shadowing his face.

Mrs. Hall, returning from lunch with her husband, spotted the robbery in progress through the bank's plate glass doors. While she ran to telephone officers, Hall chased after the fleeing bandit's car.

Whitaker drove the stolen car used in the robbery to Fuquay-Varina, where his own auto was parked.

Sheriff Tyson quoted witnesses as saying Haggart stepped on the toes of a girl Ward brought to Factolus Inn last night and the argument ensued.

Other officers participating in the raid were H. B. Lilley, W. M. Taylor and J. M. Ross.

Haggart was arrested about an hour later at his home between Factolus and Stokes by Deputies N.H. Byrd, Duke Andrews, Cecil Crandell and ABC Officer Jack Russell.

The officers reported no trouble in making the arrest.

Sheriff Tyson said Haggart will be charged with murder.

Coroner Griffin H. Rouse stated this morning that Ward died of a stab wound through the heart. A date for an inquest has not yet been set, Rouse said.

# Patients' Welfare First Consideration

Most North Carolinians remain baffled on the sidelines while what appears a full scale battle shapes up between the State Board of Medical Examiners and the State Hospitals Board of Control.

At stake in the battle is the issue of allowing foreign doctors to practice at state institutions. Tar Heels don't want the state's mentally ill to have "substandard" care as the president of the medical examining board says they are getting from foreign doctors who are now practicing in the state's mental institutions. On the other hand, North Carolinians do not want to see their state institutions handicapped for lack of doctors to care for the ill.

Under the examining board's decision, the licensing of foreign doctors to practice at state institutions would end next July 1. The decision, if carried out, would affect 23 doctors now on the staffs of state mental institutions, and others of the staffs of tuberculosis sanatoriums.

The examining board has taken the position that by next year the emergency under which foreign doctors have been licensed by the state from year to year would be over. In other words, the board has implied, there will be sufficient doctors who have attended schools approved by the American Medical Association to man the staffs of the state's hospitals after July 1, 1958.

Chairman John W. Umstead of the Hospitals Control Board has taken issue with that position, and has also asserted that the medical advisory group which works with the Hospitals Control Board has raised no question about the competency of foreign doctors.

While The Reflector is in no position to judge which group is right and which group is wrong in this controversy, a doctor's qualifications to practice in state institutions should not be judged solely upon his nationality. We certainly cannot accept the supposition that all foreign doctors are inferior to all American doctors.

# Sign Campaign Hitting Snags

**SIGNS** — The program advocated by Bill Sharpe of State Magazine and sponsored by the Travel Council of North Carolina for placing informational signs along the highways calling attention to places of special human or scenic interest is running into some snags. There are so many such places the number of signs required threatens to clutter the roadsides.

In addition to official signs warning of curves or danger spots ahead, legal speed zones, county lines and city limits, mile posts and directional indicators, NC and US route numbers, etc., the former highway commission authorized erection of signs in behalf of forest fire prevention, promotion of the anti-litterbug campaign and special name designation of some main thoroughfares. These "unofficial" installations were required to meet highway engineering specifications. Although paid for out of private funds, they were usually erected and maintained by highway forces in order to assure conformity.

Many people otherwise well informed about State spending have expressed surprise upon learning that the cost of painting, erecting and maintaining signs — including the white and yellow center and border lines — takes more than two million dollars a year out of the highway budget.

The proposed Travel Council informational signs would cost the State very little, but fear is voiced that their multiplicity might confuse rather than inform traffic safety hazard. There has been the public and constitute a traffic safety hazard. There has been some complaint on this score about the metal historical markers designating birthplaces of prominent citizens or the paths once taken by Indians or invading armies.

**COMMERCIAL** — There is further problem in making proper distinction between public historic and scenic spots and commercial projects operated for private profit. State and Federal regulations prohibit bill boards on highway rights of way and afford some control over installations beyond the line if they obstruct the view or constitute safety hazards.

The idea for the informational signs is sound. Undoubtedly they will contribute to the pleasure of travel and will bring money into the State treasury by furthering the program to keep visitors here a little longer and encourage them to travel more miles. The problem is not as simple as just putting up a sign where somebody thinks one should be. If attention is called to Crazy Gardens and Roan Mountain, free admission places in the National Forest domain, should there be signs also for Chimney Rock and Grandfather Mountain, private profit enterprises? If Wilmington's Greenfield Lake Park is noted, what about Airline and Orton signs on the highway? Some of these questions are more difficult to answer than determining which departed big shot is entitled to have his birthplace or grave honored by an official historic marker.

Tentative agenda of the Travel Council executive committee meeting at Nag's Head next month includes discussion of this matter. Effort will be made to get full cooperation from the highway department. The State not only has an entirely new highway commission, the whole approach to this kind of problem has been changed. Policy with respect to roadside signs has not been adopted. The new policy may be more liberal. There is also the chance that some existing signs will have to come down.

**DIVERSIFICATION** — Eastern North Carolina is not forgetting the importance of diversified agriculture in the current period of major emphasis on industrialization. On the same day this week the Greenville Reflector had an editorial commending an egg-producing campaign in neighboring Beaufort county; and the Wilmington News had one about the growing importance of beef cattle and dairying throughout SENCland (South Eastern North Carolina), especially in Bladen county.

These areas have led the state in producing commercial flowers and have been in the front line marketing berries and fresh vegetables. Industrial promoters are giving attention to small plants for processing and packaging these products and seafoods, as well as to the huge installations for paper pulp and titanium products. Continuing interest in agricultural and industrial diversification gives promise that the Southeastern corner of North Carolina can claim full recognition in the State family with significant contributions to the overall economy.

can doctors. Therefore a doctor's place of birth cannot be used as the sole basis of judging his ability as a physician. It cannot be used as the only criterion to determine whether he is medically qualified to hold a position on the staff of a state institution.

North Carolina should not permit its mentally ill to be subjected to treatment by "inferior" physicians even though mental hospitals are crowded and the need for personnel to staff the hospitals is critical. Neither should the state permit its mentally ill to be deprived of the services of qualified doctors because those doctors were born in other lands.

# Yankee Senator Views Civil Rights Effort

"Some of these people don't want a civil rights bill. They want a campaign issue for 1958 and 1960."

Those are rather strong words for a Vermont Republican particularly when he is speaking of the group of Republicans and Northern Democrats who are pushing the administration's civil rights bill now before the Senate.

It's our guess that Senator Aiken of Vermont hit the nail on the head when he made that statement yesterday after a conference with Republican and Northern Democrat leaders over the civil rights matter. It's our guess that Sen. Knowland, who jumped suddenly into the front to lead the fight for the civil rights measure figures he's stockpiling political ammunition to use in a bid for the GOP presidential nomination come 1960. There are probably others of the extremely vocal civil rights advocates who more concerned about the outcome of future elections than they are about the serious repercussions of the administration's civil rights bill will have if it is passed.

In the words of Sen. Aiken: "If they wanted a civil rights bill they could get one in three days—by the middle of next week. But some of them don't want a reasonable bill. They are not satisfied with something which could be approved. They want to go into the whole field of human relations."

Those words should open the eyes of a lot of Americans—particularly since they come from a Yankee.

# Labor Receiving Larger Shares

You often hear it said these days that labor is getting a bigger share of the economic pie. It's true.

Compared with 1939, labor's slice of the income pie has increased almost 6 per cent. Every other group except one is getting a smaller share. The single exception is the group subsisting on "transfer payments," which is governmentese for social security payments, direct relief, mustering-out pay, veterans' allowances and various other cash transfers.

Here, in percentages, is how the personal income was whacked up in 1939 and during May, the latest month for which figures are available: (1939 figures first, May 1957 figures second): Wage and Salary income — 63.9; Farm proprietorships — 5.9; 3.4; Business and professional proprietorships — 10.0; 8.9; Personal rental income — 3.2; 2.8; Dividends — 5.2; 3.8; Personal interest income — 7.9; 5.4; Transfer payments — 4.0; 6.4. (Total — 100.1, 101.9. Less social security contributions of — 0.1, 1.9.)

The wage and salary line includes more than purely labor income. It takes in salaries of corporation presidents getting half a million dollars a year and down on to the pay of some owner's nephew who does not know exactly what he is doing for it. Nevertheless, the total is largely labor and if the income of all fat cats was subtracted, the change would be less than 1 per cent.

## BIG LABOR GAIN

The figures indicate labor has increased its share of total personal income by more than 7 per cent. If all social security deductions are charged against labor income, workers as a group will still have increased their share by almost 6 per cent. Labor's gain in percentage is greater than the farmers' share in percentage; labor's gain in dollars is more than 16 times the farmers' income.

The pie today is bigger. Personal income in 1939 totaled

\$72.9 billion; in May this year it was at an annual rate of \$34.0 billion. While labor's share was rising from 63.9 per cent to 71.2 per cent, before social security deductions, its dollar total was going from \$46.6 billion up to \$242.3 billion.

The gain in dollars is not an accurate measure of the increase in the size of the pie. Inflation has affected it considerably. Inflation, however, does not affect the percentage ratios and labor's gains are unmistakable. Labor's share of the total income has been rising since 1929, but not always at a consistent rate. Labor's percentages in key years were: 1929 — 59.5; 1933 — 71.1; 1933 — 62.3; 1935 — 71.0; 1939 — 63.9; 1956 — 71.5; 1950 — 66.2; Current — 71.2.

Whether you think the increase in labor's share is good or bad will depend largely on what you do for a living. In any event, economic trends in recent years have surely shrunk the shares of the landlords, the money lenders, and the coupon clippers. In doing so, they have also cut the small businessmen, the professional men and the farmers.

You take the bowl of crushed fruit — at room temperature, mind you — not so cold from the refrigerator that you can't savor the flavor — and spoon it out on the warm shortcake. Then you take the cream pitcher — not whipped cream or (ugh!) ice cream — and pour it on so the rich scrolls curl through the ripe, red berries on the flaky crust.

In other times and countries, the disparity between upper and lower income brackets has grown until revolution followed. In our country, and largely throughout the remainder of the civilized world, advertising has maintained a constant economic and social stability.

# Skillful Parliamentary Operation

**WASHINGTON** — Veterans on Capitol Hill admit that they have rarely witnessed such a skillful parliamentary operation as Southern Senators have staged in their battle against the extreme Civil Rights Bill originally proposed by the Administration.

While their first objective is defeat or drastic modification of the measure, a secondary purpose is to present the South's viewpoint on the racial problem, as well as its difficulties, to the American people. There are psychological as well as political undertones to their strategy.

They have contended, at least until recently, that non-South media of communications have not presented their side of the controversy to their audiences and readers. Now, for the first time since the dark days of reconstruction, they have had that opportunity. Moreover, they are speaking for the New South that has emerged since World War I.

**ON HIGH PLANE** They have performed this task with remarkable restraint, relying on close legal arguments rather than on political or emotional exhibitions. There have been no ranters or demagogues such as "Cotton Tom" Heflin of Alabama, "The Man" Bilbo of Mississippi or "Kingfish" Huey Long of Louisiana.

In fact, such leaders and strategists as Senator Richard B. Russell of Georgia and Senator Samuel J. Ervin Jr. of North Carolina have routed the ablest advocates of the Civil Rights Bill. Ervin was a former Chief Justice of his state's Supreme Court, and Russell was Speaker of the Georgia General Assembly when he was only 26 years old.

The two leaders — Senator Lyndon B. Johnson of Texas and Senator William F. Knowland of California — also have used their influence to keep the debate on a high plane.

**THREATS TO CIVIL LIBERTIES OVERLOOKED** The Southern bloc has concentrated on two originally unnoticed sections of the measure which, in their opinion, offend the Americans' sense of fair play and equality before the law. Even President Eisenhower did not appreciate their threat to civil liberties as essential and fundamental as the right to vote and to attend unsegregated schools.

Even such "liberals" as Senator Joseph C. O'Mahoney of Wyoming and Senator Clinton P. Anderson of New Mexico were shaken when their attention was called to these proposals in floor debate.

The first, of course, is the provision for a juryless trial of persons alleged to have violated general and vague sections of the Civil Rights Bill. Nobody can say now what future United States prosecutors will regard as violations.

The result will be endless litigation and court delays, especially in view of the attitude of the legal staff of the National Association of Colored People.

# Civil Rights Query

**WASHINGTON (AP)** — There is an almost topsy-turvy air about the Senate fight over the civil rights bill which President Eisenhower's administration backed.

And like offstage music one question hovers over all that's being done: who gets what out of this — Negroes, the Republicans, the Democrats?

The administration put the heat on House Republicans last June to pass the bill intact, as the administration wanted it. They got behind it in big numbers.

The Republicans are conscious of the growing importance of Negro votes in the North. With passage of this bill, they could expect a show of political gratitude from Northern Negroes in the next elections.

And if the bill, as passed, had any real teeth in it and enabled more Southern Negroes to vote, the Republicans could expect benefits there, too.

The degree of Negro gratitude, however, may be in direct relation to (1) whether the bill passes and (2) whether it has teeth.

No matter what happens the Republicans can claim that Eisenhower and Sen. Knowland of California, Republican Senate leader, led the fight for it.

But when the House-passed bill got over to the Senate, the Southern Democrats began their real fight against it. Knowland felt pressure to weaken it. Together with Sen. Humphrey (D-Minn.) he proposed a softening amendment.

And Knowland has further changes in mind, although the House went down the line to pass almost exactly the kind of bill the administration asked.

But there is a complicated situation in the Senate.

There the Republicans can hardly be called all Eisenhower Republicans. But because of the circumstances — a bill backed by Eisenhower and Knowland — those who follow Eisenhower will back some kind of bill, and so will those who like Knowland.

The Democrats, North and South, have their own problem: with Southerners against it and some, if not all, Northerners for it, the Democrats have the task of preserving some kind of party unity.

Behind the scenes Sen. Lyndon Johnson of Texas, Senate Leader of the Democrats, is working to produce a compromise which Northern and Southern Democrats, and perhaps Republicans, can accept.

Johnson, whose Democrats have a majority in the Senate, is in the strange position of watching Knowland, leader of the Republican minority, put up the fight for civil rights which the Democrats had always promised.

And if the Southerners want no part of compromise, even for party unity, they face the possibility of defeat by a coalition of Republicans and Northern Democrats.

They want the whole bill killed. But this time they may figure it a victory if they can wind up with a bill that is much toned down from the kind Eisenhower requested. A weak bill would be better from their viewpoint than a tough one.

Northern Democrats who help get some kind of civil rights bill can claim some credit among Northern Negroes for their part in it.

Yet, because of the Southern opposition, Democrats as a party can hardly claim much when it was the Republicans who led the fight.

Even a watered-down bill would be a victory for the Negroes — not as much as they hoped for, but still a victory. In this century that a civil rights bill would be first time in this century that a civil rights bill passed the Senate.

Hitherto, Southern Democrats have always been able to block it. Even a weakened civil rights bill, if it helped more Negroes vote, would be an encouragement to them next year to put pressure on Republicans and Northern Democrats to pass a stiffer one, once the Southern wall had been broken.

# Milwaukee Still On Top; Bums Pull Into Second Slot

Milwaukee continued its hold on the National League lead yesterday by dropping New York, 3-1, but the big noise of the day was made by Brooklyn.

The Bums took two from Chicago, 6-3 and 5-3 in a twin bill, to move to within one game of the Braves.

And Cincinnati has quit fifth to move within one percentage point of third-place St. Louis.

The Philadelphia Phillies, meanwhile have collapsed with four defeats in a row and now are fifth again. St. Louis Cardinals have blown a three-game lead and now are third, two games behind.

The Braves made it four in a row last night, beating the New York Giants 3-1 as old-timer Andy Pafko smacked two home runs and cracked open a tie ball game with a two-run belt in the ninth. Brooklyn moved up by beating Chicago's last place Cubs twice, 6-3 in 10 innings and 5-3 for the Dodgers' first doubleheader sweep of the season. Pittsburgh routed St. Louis and the Cards' young sensation, Von McDaniel, 7-0. Cincinnati clobbered the Phillies and became winner Jack Sanford 7-2.

The American League race, already draped with crepe, showed the New York Yankees with a six-game bulge after whipping Cleveland 9-1 as Boston disposed of the second-place Chicago White Sox 5-2. Detroit defeated Washington 4-1 and Baltimore beat Kansas City 4-2.

Gene Conley won his third in a Braves finale beat ex-mate Johnson with a seven-hitter as the New York Yankees pulled out three singles after Pafko's second-inning home run until Andy parked one following a walk in the ninth. Conley is 3-4; Antonelli 9-8.

The Braves are 7-3 since the All-Star game, the Dodgers are 8-1.

Duke Snider homered in both games for the Braves last night, for seven in nine games. His 22nd tied the opener 3-all in the 10th before rookie John Roseboro bagged it with a three-run homer. Reliever Clem Labine won it for a 4-5 record after losing five in a row. The Cubs had only four hits in the opener, but three were homers—two by Lee Walls.

A pinch single by Randy Jackson broke a 3-all tie in the nightcap sixth, giving Sal Maglie a 4-2 record. Pittsburgh swung for nine hits off McDaniel, who lost his second in a row for a 4-2 record. In 5 2-3 innings as the Cards lost their seventh in the last nine. Vern Law walked none and scattered nine singles for his sixth victory. Ex-Card Bill Virdon had three, two to the Redlegs, was smacked for 11 of their 15 hits—all singles except for George Crowe's 21st home run with a man on. Joe Nuxhall won his fourth.

A bases-loaded balk by Don Mossi helped the Yankees to a 2-0 lead in the first inning, and they really put it away in a five-run seventh as Bill Skowron hit a three-run homer. Whitey Ford had a three-hit shutout for six innings, then gave up Gene Woodling's home run and left with a recurrence of his shoulder troubles.

Ted Lepio replacing the injured Billy Klaus, whacked a three-run homer and Ted Williams hit his 27th as the Red Sox beat Billy Pierce, now 13-7. Willard Nixon won it, with relief help.

Paul Foytack won his 10th, one more than he's lost, with relief help after the Tigers tagged Pete Ramos for all their runs in four innings. Frank House homered for Detroit.

The New York Giants came from behind yesterday afternoon to whip the Boston Red Sox in the final game of the Coastal Boys Little League playoff, 9-2.

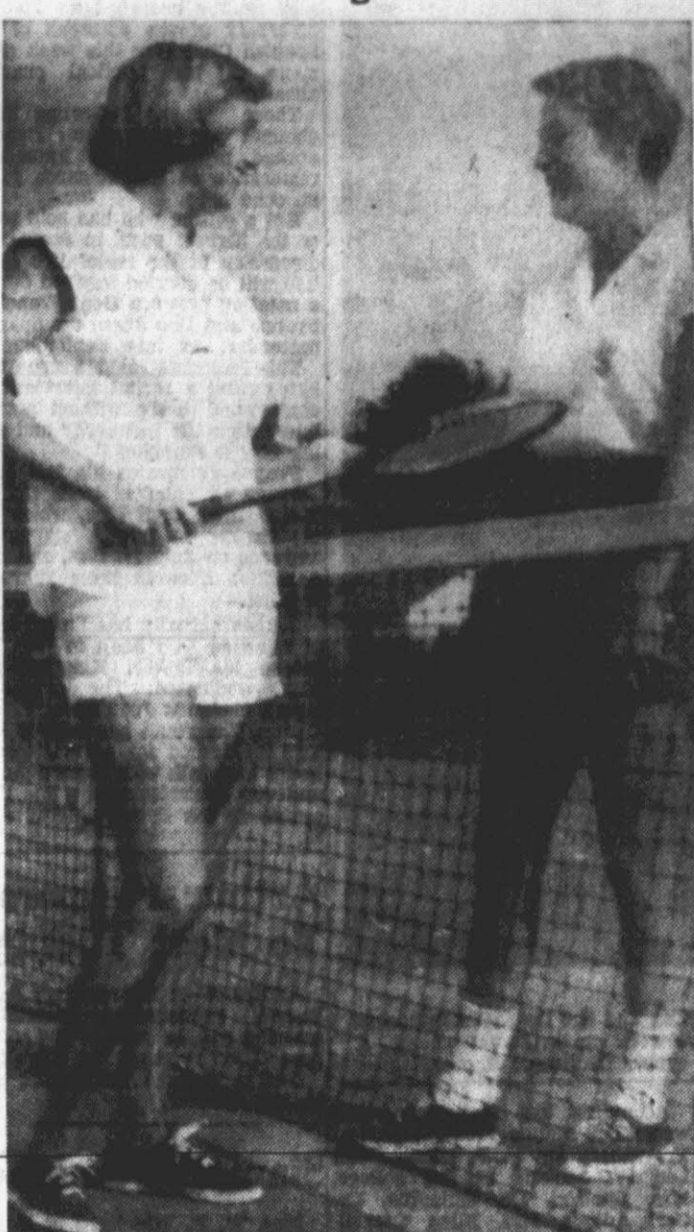
Leon Grimes hurled the Giants into the championship, with a 3-hit performance. Benny Wilson managed the club.

## Signs Of Political Changes As Spain Recalls Civil War

MADRID, Spain (AP)—The nationalist regime observed the 21st anniversary of the outbreak of the Spanish Civil War this week amid signs of big political changes ahead.

There was no indication these changes are immediate. Reports abroad predicting an immediate restoration of the monarch found no echo here.

But a source who has held some of the highest posts in Spain said discussion of the restoration question will be carried forward during a meeting between Gen. Francisco Franco and Don Juan, the Spanish pretender, in late September.

This informant said Franco told him during a recent interview, "I don't want to die without putting into action the monarchy and seeing how it functions."

Francisco celebrates his 21st anniversary as chief of state Oct. 1. The Spanish Civil War, which put his regime in power, started in Morocco on July 17, 1936, and cost a million lives in three years of fighting.

Francisco actually has no intention of allowing Don Juan to take the throne his father, King Alfonso XIII, abdicated. The generalissimo's choice is Juan's son, Prince Carlos. The youth has been in college in Madrid for several years, had a long talk with Franco July 8 and was commissioned a 2nd lieutenant in the Spanish Army July 13.

### Alleged Killer Repeats Confession For Newsmen

DELAND, Fla. (AP)—Donald J. Wedler, whose statements have revived interest in the Marilyn Sheppard slaying, repeated his recollection of events at Cleveland in early July 1954 for newsmen last night.

Wedler, 23, told essentially the same story he gave Sheriff Rodney Thursday Monday night. The prisoner, who is awaiting trial for prison escape, was the coolest of the 22 persons crowded into the sheriff's office at Volusia County jail. While others perspired, Wedler seemed dry.

On either side of Wedler were Erie Stanley Gardner, mystery writer, and Alex Gregory, lie detector expert, both representatives of the Court of Last Resort which is investigating the Sheppard case. Gardner is one of the founders of the court, organized to help persons unjustly convicted of crimes.

Gregory said after two days of lie detector tests that Wedler is telling the truth or what he believes to be the truth.

The prisoner's statement has Gov. C. William O'Neill for the result in permission from Ohio's Court of Last Resort to give lie detector tests to Dr. Samuel Sheppard in prison.

Most of the questions at the Wedler press interview were asked by Gardner. At times Gregory reassured Wedler that the sole purpose was to ascertain facts. Wedler answered naturally and appeared sincere.

He said he went to a house in Cleveland, hit a woman on the head with an iron pipe when she coughed as he was ransacking her bedroom.

Six and a half years ago Mr. and Mrs. F. F. Hendrix moved to their new home on Evans Street Extension and began transforming their wooded, over-grown lot into a well-planned lawn of beauty.

Care of their acre and a half of property is not a one man job, but as Mrs. Hendrix explains, "It is entirely a family project."

A natural pond on their property furnishes the water for their irrigation system which Hendrix and his sons, Floyd, Jr. and Jimmy, installed in 1952. This system, composed of 26 permanent sprinklers and a portable garden system, waters the entire lawn in a minimum length of time.

Their pond encircled with flowers and shade trees is a favorite spot for family picnics and young fishermen.

Since the entire family finds so much enjoyment and satisfaction working in their yard, it is not surprising that Jimmy chose home grounds beautification as his 4-H club project which won him a state award in 1953 and national recognition in 1954.

Hendrix is interested in shrubs, and mentions, "We have rooted and grown most of our shrubbery." He has a green house where the clippings are kept until they are transplanted in the shade house. Here they are kept two years before being transferred to the yard as permanent plants.

A new project is growing pine trees which will furnish the necessary winter shade for the azalea and camellia plants.

For those interested in beautifying their present lawn, Mr. and Mrs. Hendrix offer the following suggestions:

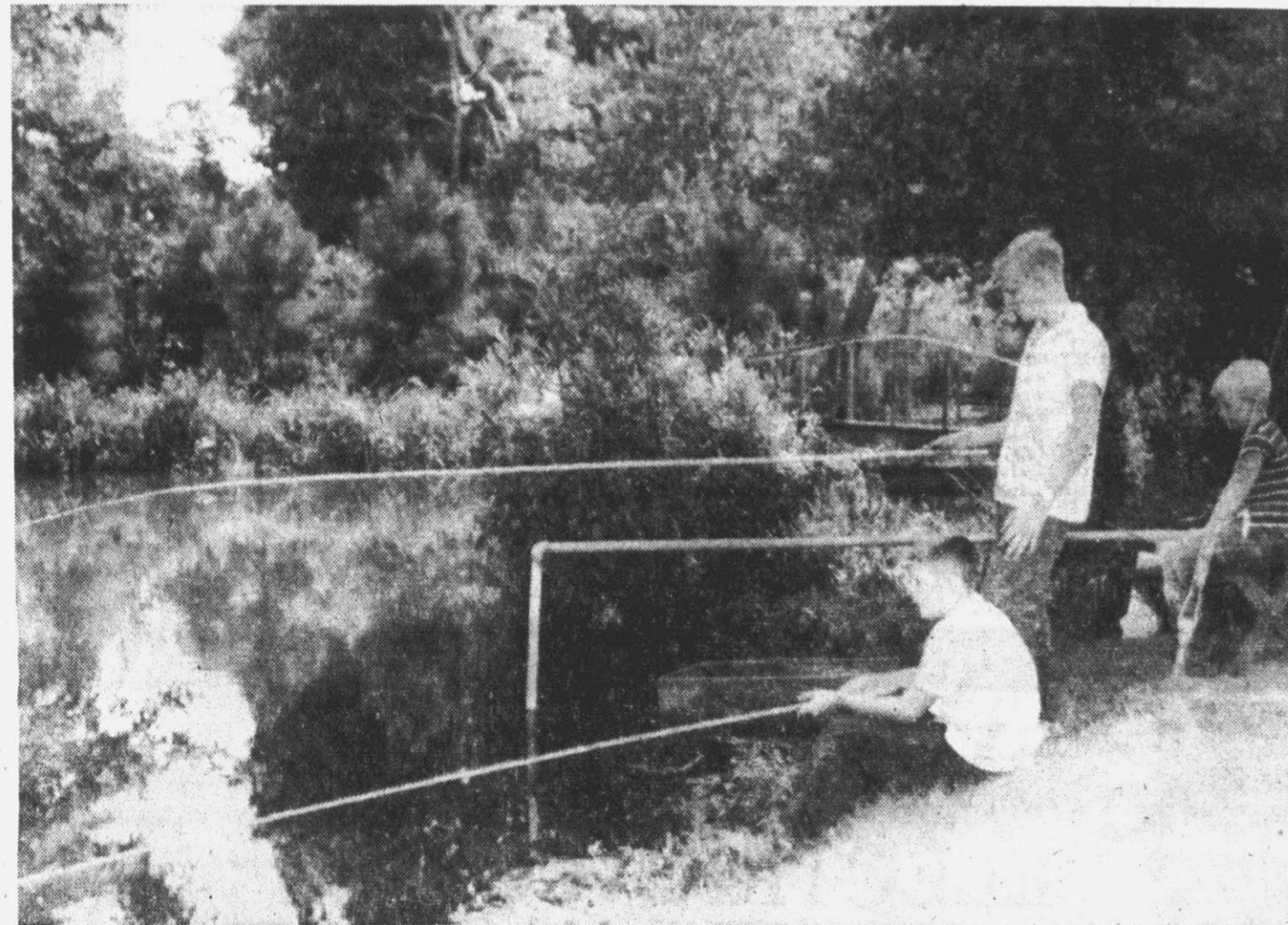
1. Water and fertilizer are absolute necessities plus a good bit of personal endurance.
2. Don't overplant . . . it is easy to start in the spring, but hard to keep going during the summer. It is better to start on a small scale until you find out how much you can take care of.
3. Limit planting to adapted shrubbery and perennials intermixed with flowers.
4. Crepe myrtle, azalea plants, camellia plants, holly, and day lilies all require little care . . . but are colorful on a lawn.

# Like Helps Son Get House Fixed

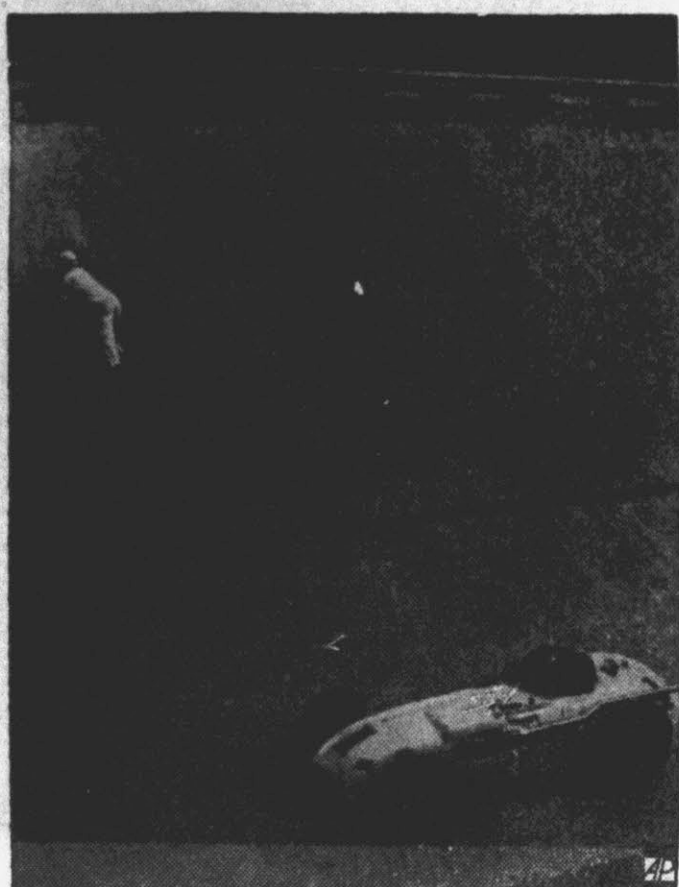
GETTYSBURG, Pa. (AP)—President Eisenhower scolded into the role of week-end country gentleman today and helped some new neighbors get settled. They are close neighbors and, in fact, close relatives—Maj. and Mrs. John Eisenhower, the President's son and daughter-in-law. They moved in last night at the neat white home they acquired from the chief executive. It's a done-over, enlarged schoolhouse in a corner of the President's 500-acre farm, about three-quarters of a mile from the Eisenhower home. John and Barbara came up from Washington late yesterday. The President flew from Washington yesterday afternoon. They brought along their young-est, Mary Jean. The other three presidential grandchildren, David, Barbara Anne and Susan were already here with their grandmother. With David at the tiller of an electric cart, the President shot a fast 18 holes of golf with Brig. Gen. Arthur Nevins, retired. Nevins, a neighbor and close friend of the president, was 66 yesterday. So he was invited over to the Eisenhowers for dinner. The President, Nevins said, had some new cooking equipment to try out. And a package of charcoal had come along from Washington, on a secret service plane.

# Government's Surplus Gone Before Announced

WASHINGTON (AP)—The \$1,645,000,000 budget surplus which Secretary of the Treasury Humphrey reported yesterday was gone before it was announced. The surplus had provided most of the money that was used to whittle down the federal debt by seven-tenths of one per cent during fiscal 1957. When the fiscal year ended June 30, the public debt stood at \$270,634,309,946. This was a \$2,190,000,000 reduction from the debt total 12 months earlier. The debt-shaving process was a continuous one. It took place throughout the year, by the cashing of U.S. savings bonds and other government securities as they fell due for redemption. In the case of most maturing securities, the government simply reborrowed by floating a new issue or by selling new savings bonds as rapidly as the old ones were paid off. But it re-borrowed a little less than it paid off — \$1,645,000,000 less, over the year. The rest of the debt reduction was achieved simply by drawing money out of the treasury's general fund balance of cash on hand. The balance on June 30 was about 950 million dollars smaller than it was on the same date a year ago. Some 545 millions of this difference had been used, along with the budget surplus, to reduce the debt. The rest went into operations of government trust funds which do not affect the federal budget figures. WORMS HOOKED RHODELL, W. Va. (AP)—Some "worm" wormed his way into Fred Barker's establishment, he told police, and made off with 20,000 of his fishing worms imported from Africa. He valued the worms at \$3,000.

# Union Jack To Be Removed From Malaya On August 31

By MURRAY FROMSON KUALA LUMPUR, Malaya (AP)—On Aug. 31 the Union Jack will be lowered here and its place taken by the flag of an independent Malaya. The day will mark the end of 133 years of British colonial rule, interrupted by the four-year Japanese occupation in World War II. Malaya as the 10th nation to join the British Commonwealth is the first constitutional monarchy to recognize Queen Elizabeth II as head of the Commonwealth. Malaya will have its own king, a Paramount Ruler to be selected Aug. 3 from among nine sultans. He will serve for a five-year period and be known as "his majesty." Actually governing falls to another member of the Malay royalty, Cambridge-educated Prince Abdul Rahman, a younger brother of the sultan of Kedah. He becomes prime minister. For the last two years he has been chief minister, a job he got when his party won the legislative election. Prince Rahman must keep harmony among Malaya's 6,300,000 people. His own Malay race numbers three million. Then follow the Chinese, with 2,300,000; Indians, Pakistanis, Ceylonese, Eurasians and Europeans. More than a half dozen tongues are spoken. He will need agility to steer a middle course and pacify extremists — discontented Chinese on one hand and Malay nationalists who want to suppress the Chinese, on the other. Responsible Malays say it is only a matter of a few years before the prolific Chinese surpass them in numbers. The Chinese for more than 100 years have dominated commerce through a combination of their own industriousness and the Malays' preoccupation with small-scale agriculture that didn't take too much effort. The Colonial British fostered the Malay attitude so they wouldn't get ideas about asserting their nationalist rights. Despite the near equality of Chinese and Malays in numbers, three out of four civil service jobs will, by law, be reserved for Malays. A knowledge of the basic Malay language has been required to qualify for citizenship. The new constitution waives this requirement for those who apply for citizenship within a year. The catchword is "apply." Only half the Chinese have applied. The rest are illiterate or ignorant of the laws. Some are in regions remote from registration offices. Those who come to register may give up in anger after a brush with Malay bureaucracy. "In short," said one Chinese businessman, "this is independence for the Malays, not the Malaysians." The Chinese have no real voice or spokesman. The Malaysian Chinese Assn. is made up largely of the rich Chinese rubber merchants and tin mine owners and they speak for themselves only. In frustration, many Chinese have looked toward the jungle and have lent support to Communist terrorists who have kept the country in war for more than nine years.

# Five Airmen Survive Blast

ATOMIC TEST SITE, Nev. (AP)—The first five men to intentionally stand under an atomic explosion shrugged their experience off today as just a breeze. "It's one of the best places to observe a blast that I can think of," said Col. Sydney Bruce, of Durango, Colo. The first air-to-air atomic rocket ever fired went off more than 15,000 feet—how much more was not disclosed—above the heads of the five Air Defense Command officers. The rocket was a low-powered weapon compared with most atomic devices, but Lt. Gen. J. H. Atkinson, commander of the defense command, said it could blast a fleet of enemy planes out of the skies. The little band of officers came out from under the explosion with their neatly pressed Khaki uniforms fresh enough for a parade ground review. They were assigned to the lonely station at ground zero to bring out a report on what might happen to people below an aerial battle fought with atomic rockets such as the one tested here yesterday. The officers had no protection whatsoever, not even the dark goggles which newsmen wore at their observation point more than 13 miles from the point of explosion.

# Cats Rerieved In Eviction Case

ENGLEWOOD, N. J. (AP)—Some 26 cats, facing eviction, won a last minute reprieve when one of them had five kittens yesterday. Mrs. Marion Westlake had been given until then to get rid of 26 of her 28 cats because the Department of Health said they were a public nuisance. In court she asked Acting Magistrate Lester Kramer for a week's extension because one of her pets had given birth to five kittens. Kramer granted the extension but Mrs. Westlake will still be allowed to keep only two of her pets.

Spanish-Type Western Coming On Television

By CHARLES MAHER HOLLYWOOD (N)—You've been warned by now, no doubt, that if you don't like Westerns you may as well have your TV picture tube converted into a sun lamp next season. Well, fellow squinters, there may be an out. If cowboys are your idea of nothing to watch, if shoot-'em-ups leave you bilious, you can skip the Westerns and watch a Spanish. 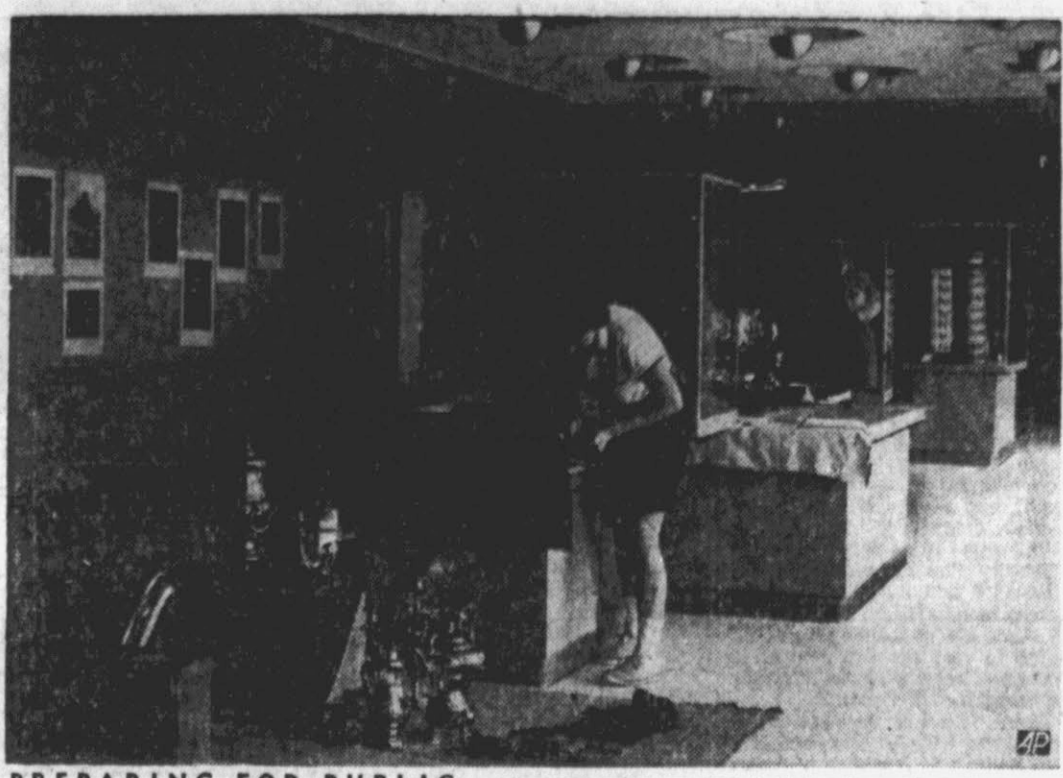

## Mixed Reaction Greet Offer To Lift News Ban

WASHINGTON (AP)—Secretary of State Dulles' offer to allow a "limited number" of American reporters to visit Red China for a trial period got a mixed reaction on Capitol Hill today.

Sen. Mansfield (D-Mont) called it "the first break in the paper curtain" and "better than no American coverage at all of Red China." He commended Dulles for proposing it, but news representatives who received the offer yesterday balked at the limitations it contained.

Mansfield expressed hope the limits would be "sufficiently large to insure a square deal for all elements of legitimate communications media."

In a separate interview, however, Sen. O'Mahoney (D-Wyo) objected to the idea of the State Department saying "who could, and who could not report."

"Under a free press a government official is not permitted to say what segments of the press should be permitted to cover the news anywhere," he said.

Sen. Aiken (R-Vt) said in another interview that neither the Red Chinese government nor the State Department should "handpick the reporters who would visit Red China."

The State Department, which controls passports, now bars all Americans from going to Communist China, which this country does not recognize.

## Belgian Congo Religious Sects Growing Despite Law

ELIZABETHTOWN, Belgium (AP)—To a casual onlooker, the old man's clothes—long white robe, sandals, red turban and shepherd's staff—might be mistaken for another form of local dress.

But people in the know recognized him immediately for what he was—a member of a new, flourishing religious sect in the Congo called Church of the Apostles.

His costume was based not on African tradition but on millions of religious images annually circulated throughout the Congo by mission priests.

From them, founders of the Church of the Apostles learned how the original apostles looked and then imitated them.

The old man in his white robe was the only one example of thousands of adherents of hundreds of religious communities now thriving in the Congo.

The fact is astonishing because no territory in Africa has more stringent legislation against religious sects.

Part of the explanation lies in the fact that up to now Christianity and colonizers have been more closely identified with each other in the Congo than anywhere else in Africa, with the exception perhaps of the Portuguese territories.

Moreover, the method of combating the sects in the Belgian Congo may have contributed to their spread. Sect leaders can be banned and their organizations dissolved by order of provincial governors. But exiled "prophets" frequently use banishment as an excuse to move to some remote corner of the country and start spreading their particular creed all over again.

Although individual sects may not be long lived—much depends on the personality of the founder—they are constantly being reborn in one form or another.

Among the oldest are Kibanguism, established 20 years ago by Simon Kibangu, and Kiawal, which has a firm hold on the eastern Congo.

Most of the religious sects in the Congo apply the Christian idea of sin and expiation to their own traditional beliefs. A disease in a village or an accident, for example, can be interpreted as the consequence of some offense a "sin" committed by a member of the community. The wrongdoer is identified by a "prophet" and is forced to expiate through various humiliations.

Whatever the name and location of the sect, they all have some basic tenets that are identical: first, they all attempt to combine Christian teachings—namely, the notion of sin—with heathen tradition. Second they all are, at present, anti-European.

## Divorced Actress Says 20 Is An Age Of Crisis

HOLLYWOOD (AP)—Merry Anders, a blonde eye-flicker, is a young actress whose marriage lasted only three months and 17 days.

That's brief, even for Hollywood. However, Hollywood had nothing to do with the break-up, she claims.

"On the contrary," she explains, "my husband was in television production. He was more apt to understand the problems of an actress."

She talks frankly on why her marriage to John Stephens broke up, not as an advice-to-the-lover expert, but in the hope that others may benefit from her mistakes.

"I was 20 and an only child," she says. "My husband was 26 and also an only child. Neither one of us was old enough to get married. We just didn't know what we were doing."

She believes that 20 is a crisis year among girls. They're still children, yet they believe that if they are not married by the time they're 21, the parade will pass them by.

"I almost got married at 17 to a high school cheerleader, but I got backed out at the last minute. I had more sense at 17 than I had at 20."

Another mistake, she feels, was

the choice of a municipal judge to perform the ceremony. "Things might have been different if we had been married in a church," she said.

Merry said she hadn't been married a week until she knew that she had made a mistake.

"Then when I did leave for good," she says, "I found out that I was two weeks pregnant when we split up." Merry now lives with her 16-month-old daughter and her mother in a San Fernando Valley home.
