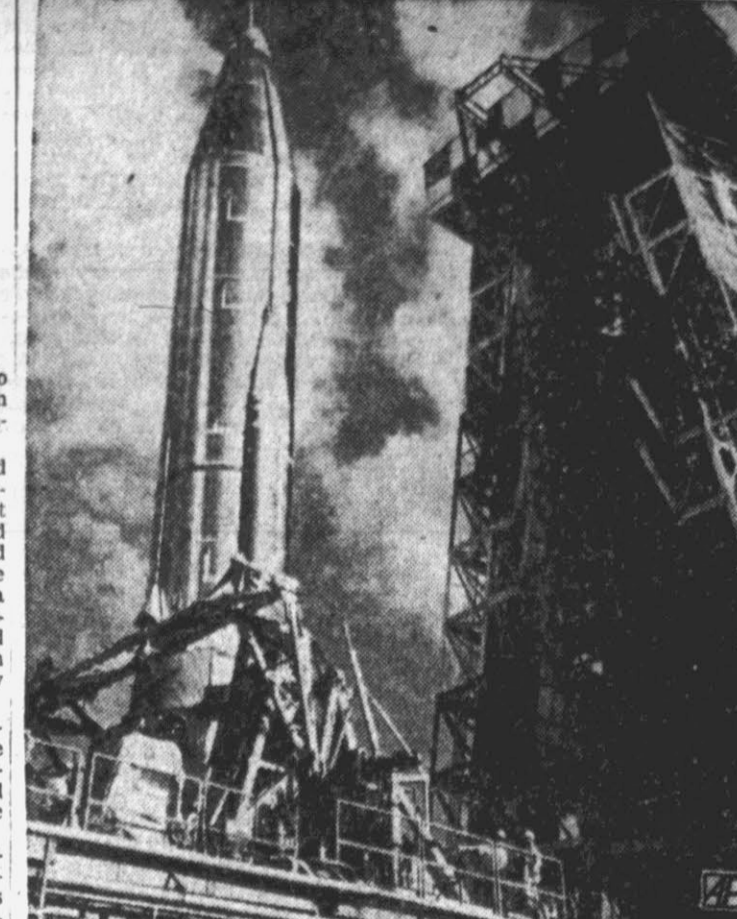

Easter Bonnet Decorates Table

French chefs have always gone in for decorating food elaborately. Americans have taken over the custom but have adapted it to their own tastes and skills.

So even if you're not a cake-decorating expert, you can prepare this amusing Easter Bonnet dessert. Two white or yellow layer cakes (made from a mix), some chocolate filling and seven-minute frosting are its foundation, and morsels of semi-sweet chocolate got the top of the cake in a polka-dot effect. The only skill necessary is forcing some of the chocolate filling through a cake-decorating tube around the base of the hat's crown, and trimming with a bow.

You will need a set of tier cake pans to bake the cake. These are widely available in dime, hardware and other stores and come four to a set. Baking the cake in the 7- and 9-inch pans achieves a perfect tailored-hat effect!

EASTER BONNET CAKE
Ingredients: 1 regular-size package white or yellow cake mix, 1 package (6 ounces) semi-sweet chocolate pieces (1 cup), 6 tablespoons condensed milk, 1 tablespoon light corn syrup, 1 tablespoon water, 1-8 teaspoon salt, 1/2 teaspoon vanilla, 1/2 recipe for seven-minute frosting or 1 package (6 1/2 ounces) seven-minute frosting mix.
Method: Have ready greased and

floured 7 by 2 1/2 inch round layer cake pan and a 9 by 1 1/2-inch layer cake pan. Prepare cake mix according to package directions. Fill each pan two-thirds full. Bake according to package directions, baking the 7-inch layer 5 to 10 minutes longer, or until sides of cake pull away from pan and cake tester inserted in center comes out clean. Cool; remove cake layers from pans. Reserve 1 tablespoon of the semi-sweet chocolate pieces. Melt remaining chocolate over hot (not boiling) water; remove from heat. Add condensed milk, corn syrup, water, salt and vanilla, beat until smooth. Cool to spreading consistency. Place 9-inch cake layer on cake stand or serving plate. Spread three-quarters of the filling on cake to 1 1/2 inches from cake edge. Top with second layer. Frost cake with seven-minute frosting. Place reserved pieces of chocolate on top of cake, point side down, in polka dot fashion. Force remaining chocolate filling through cake decorator around bottom of 7-inch layer to make hat band and bow.

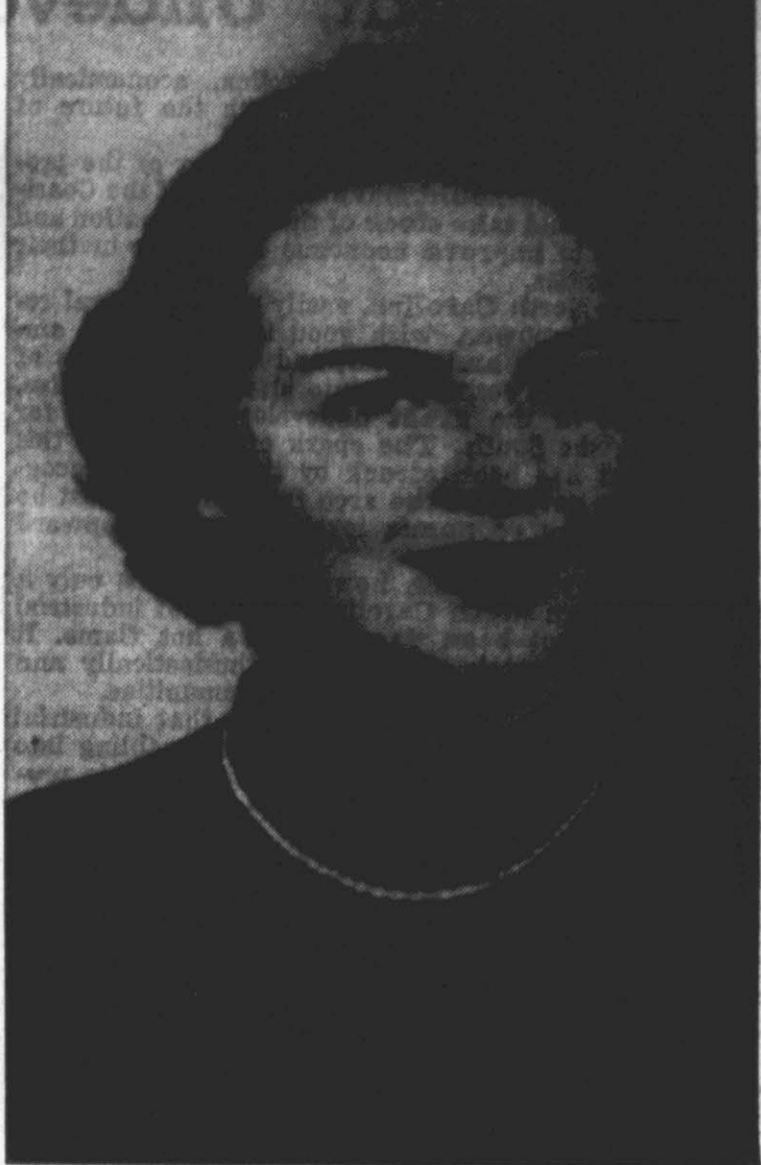

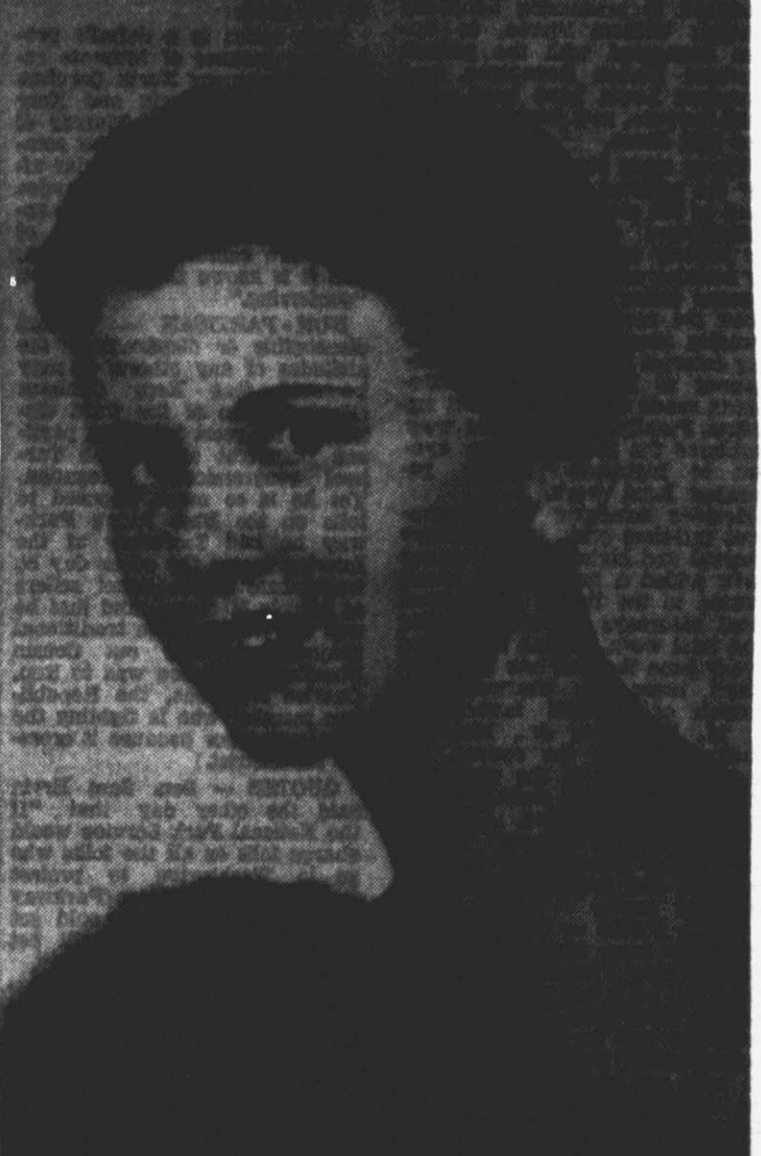

This Great, Undeveloped Frontier

"The future of North Carolina, economically speaking, is irrevocably tied up with the future of Eastern North Carolina."

That statement, coming from a leader of the progressive Piedmont should make the people of the Coastal Plain sit up and take stock of their own situation and their efforts to improve economic conditions in their own communities.

Eastern North Carolina, vastly rich in natural resources, in manpower, with good transportation, ample electric power and water, and with thousands of acres that can be converted into ideal industrial sites, remains one of the great undeveloped frontiers for industry in the South. The spark of interest for this development has been struck by the shocking recognition by the people of the area that industry must be had here if the economic level is to move upward rather than downward.

Practically speaking, however, it remains only a spark in Eastern North Carolina. The fire of industrial progress has not been fanned into a hot flame. It smolders, alternately flickering enthusiastically and almost dying entirely in individual communities.

People of the area should realize that industrial and economic development do not come ambling into a community for no particular reason. Economic pro-

Action To Meet Big Legal Load

LEGAL LOAD—The increased load of legal work imposed upon the office of the attorney general incident to highway right of way acquisition has necessitated adding two trial lawyers to the staff. Charles Barbee has already reported for duty and Andrew Jones will report April 1 after completing a stretch of naval reserve duty. Both have been practicing in Raleigh.

The highway legal section of seven lawyers is headed by Kenneth Wooten, assistant attorney general. Parks Inghour is assigned to processing accident claims; William Pierce, to duties connected with the prison system; Horton Roundtree and Harrison Lewis have been the trial lawyers, now joined by Barbee and Jones.

Three main reasons are given for the addition of two trial lawyers to the staff. First is the administrative directive to clear up rapidly as possible the heavy backlog of right of way cases—some dating back into the '20's. Then the recent Supreme Court decision requiring the State to pay interest in at least some instances of long delayed settlements made it wise to speed up action. Finally, the rights of way problems for the interstate system of highways greatly increase legal work.

Besides enlarging the permanent full-time staff, the attorney general and highway department have added a hundred or more names to the list of accredited local attorneys for special title and trial work. As has happened every time that list has been revised there are charges and denials of political favoritism. J. M. Broughton, Jr., highway chairman, says the reason for more local aid is the same as for the permanent staffers — to speed up settlements. Although attached to the attorney general's office Wooten and his associates are paid directly from highway funds.

TOLL FREE — There is better than even chance that the Blue Ridge Parkway will continue to be toll free road. It also is more than likely that it's free will be guaranteed by congressional action, at least until tolls are imposed on the other parkways administered by the National Park Service. These include the routes between Washington and Baltimore, Washington and Mt. Vernon and the Natchez Trail. At the hearing in Washington the other day Governor Hodges and the congressional delegation made much of the discrimination involved by singling out one parkway for tolls.

Secretary of the Interior Fred Seaton has ordered tolls imposed on and after June 1 this year. Rep. Harold Cooley, supported by the other lawyers in the Tarheel delegation, challenged the legal authority for charging fees and threatened court action. Meantime, bills are pending in

both branches of the Congress to outlaw tolls.

So there are three ways by which the toll-free status of the road may be maintained. Secretary Seaton can rescind his order; the courts can enjoin application of the order, or the Congress can prohibit levying the charges. These are direct approaches. There is another avenue of obtaining at least temporary relief through oblique approach. That is for the Senate appropriations committee to tack a rider on the park service allocation making it conditioned upon continued free use of the road.

Such action is a definite probability because of intimate relationship among North Carolina Senators Sam Ervin and Kerr Scott, Senator James Murray of Montana, chairman of the committee on interior and insular affairs, and Senator Carl Hayden of Arizona, chairman of the appropriations committee. All of them are against the toll idea, and it is known they have been "conferring."

NON-PARTISAN — Without discounting or disparaging the attitudes of any others, it may be said that Rep. Graham (Rep) Barden of the third district is the most intensely partisan Democrat among the Tarheel congressional delegation. Yet he is so much opposed to tolls on the Blue Ridge Parkway he told Secretary of the Interior Seaton the other day he would hate to see ticket sellers at Lincoln Memorial and that he was over-riding some traditional prejudices to help out Cousin Charlie. (Reference was to Rep. Charles R. Jones, the Republican member who is fighting the tolls with vigor because it crosses his district.)

QUOTES — Sen. Sam Ervin said the other day that "If the National Park Service would charge tolls on all the folks who go to Washington to protest fees on the Blue Ridge Parkway the Federal treasury would get about as much as it will net from the Parkway receipts."

The late Governor and Senator Cam Morrison once said that imposition of tolls on the Parkway "Will raise more hell than revenue."

Add to these easy access to library materials made possible by the Bookmobile which visits every section of the county, and one begins to get an idea of the store of books on every imaginable subject available to the people of this county just for the asking.

According to a national survey, 61 percent of Americans read no book other than the Bible during a recent year. It is our guess that in Pitt County the reading record of our people is no better than the national average. It may be considerably below the national average. Yet in our modest way we have library facilities which far surpass those of the average area this size in the country.

National Library Week ends today. But its theme "Wake Up and Read" should remain in the minds of the people of this community every week in the year.

Where Would It Come From?

One of the more popular proposals for remedying the current mood—which is boom spelled backwards—is for reduction of income taxes. The proposal most frequently heard is to reduce taxes by \$50 a person.

This would give some 60,000,000 taxpayers \$30 each. The theory is that each would dash down to the store and spend the windfall for groceries, television sets, neckties, gin, autos and so on. This would increase manufacturers' orders, therefore employment and the nasty old mood would be over.

Believe you me, young lovers, if somebody handed me \$50 I would take it and, like as not, I would dash down to the store and I spend it. So would you. But before we take those 50 skins in our damp, grubby hands, let's ask where they come from.

BLACK MAGIC OF INFLATION — The Federal budget is now close to being in balance. But if taxes are cut to give every taxpayer a \$50 tranquilizer pill, government income will be about \$3 billion less than planned out. As a matter of fact, the deficit may be even greater because current layoffs may reduce incomes, hence income taxes, more than calculated.

moderate amounts may be paid off. But whenever a surplus piles up, bureaucrats and Congressmen will be more eager to spend it than to pay off indebtedness. There will be a great amount of shuffling. Long-term borrowings will be transferred to short-term indebtedness; new names will be invented for series of loans; there will be funds, refunds and counter-funds and counter-counter-funds, but in the end the total will grow and there will be no effort to pay it off.

Interest will be paid, of course, thereby keeping Columbia an honest woman. Interest now runs about \$7 billion a year, which is more than twice the amount of the proposed tax cut and much more than the cost of any recovery scheme so far advanced. In short, if we were not paying so much interest on our national debt, we would have more than enough money to snap ourselves out of the present decline!

But in letting the national debt drift, and in increasing it every time we feel a pinch, we are lapsing into a policy of perpetual inflation.

HIDDEN TAXES — There is one thing commendable about income taxes. They look you in the eye. You know exactly how much they are taking out of your wallet, just how hard you'll be hit over the head if you resist and, if you are patient and persevering, just what happens to your money.

But you never know how much you are taxed by the process of government borrowing, which increases the amount of money without increasing things for which it may be spent. This creates inflation, which takes from the pensioners, annuitants, and savers and gives to the smart hedgers, and which increases the cost of living and impoverishes those on fixed incomes.

So if Uncle Sam kicks back \$50 of the money he has taxed from you, look at it cautiously.

Reasons For Feeling Of Panic

Old timers say that one has to go back 25 years to find such a widespread feeling of panic in Washington as there is today. Apparently there are three main reasons for this.

First is the stream of unfavorable business news. The quaking during the past few days included:

1. Unemployment in mid-February was 5.2 million as compared with 4.5 million a month earlier. The 700,000 increase was much greater than normal for this time of year — in fact it is not unusual for February to mark the beginning of a spring upturn and no amount of rationalization can make the increase other than disturbing.
2. Business plans for investment in plant and equipment have been scaled sharply downward. The peak of such investment was in the third quarter of last year. That was at an annual rate of \$37.75 billion. The amount declined slightly in the fourth quarter. In the first quarter of this year it dropped to \$35.5 billion. The latest survey reveals that the plans for this year now

"I'm going to take care of Martinez the same way—maybe quicker," Akins said minutes after he had demolished the 2-1 favorite. The odds had jumped from the 7-5 favoring Logart to the 2-1 at fight time.

Shortly after the fight ended, Dist. Atty. Frank Hogan's office said "more than a dozen" boxing figures, including matchmaker Billy Brown of the International Boxing Club, were served with subpoenas.

A spokesman for the D.A. said the subpoenas were issued for appearances as witnesses in an investigation "that has been going on for some time." He declined to elaborate.

As Wednesday's opening-season encounter with Wake Forest draws nearer, the baseball picture at East Carolina College remains much the same—a question mark.

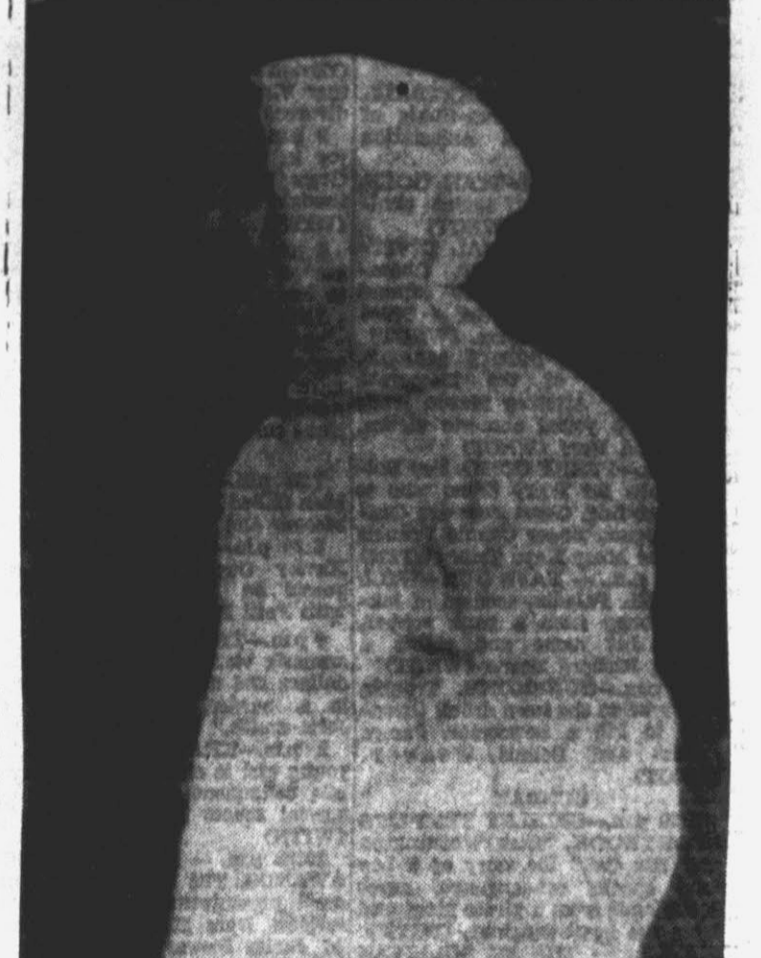

Find Arrested Woman Masqueraded As Man

RALEIGH — A dark-haired woman who had masqueraded as a man for years before employers, fellow workers and police, was held in lieu of bond here today pending trial on fraudulent check charges.

The FBI arrested Geraldine Grace Moore, 33, Thursday night and said she had been sought in the case of several years—only officers thought the accused was a man.

M. P. Chiles, special agent in charge of the Charlotte FBI office, said "We had been looking for a man for several years," but that the Moore woman's fingerprints showed her to be the suspect.

He said she had been running a small grocery store here and was wearing woman's clothing when arrested.

She was charged with violation of interstate transportation of stolen property statutes. Specifically, she is accused of "fraudulently executing" checks at a Greensboro mill where she worked as a bookkeeper, and of taking them to Greenville, S.C., and cashing them about Nov. 16, 1956.

At a hearing here yesterday she was ordered held in lieu of \$4,000 bond for trial during the June term of federal court at Greensboro.

The FBI said she was convicted and sentenced, as a woman, to 3-5 years on an embezzlement charge in Raleigh in March, 1952. She served part of the sentence at Women's Prison here and gained a parole.

She worked as a man from 1954 through 1956 at the Greensboro mill, under the FBI, under the name of John Leigh Moore Jr. It was there she allegedly made

Sign Contracts For Club Pool

The filter used will be capable of turning over the water in the pools every eight hours.

It smiles in the clouds that mean more rain for a land that has shivered in the cold of Winter's downpours.

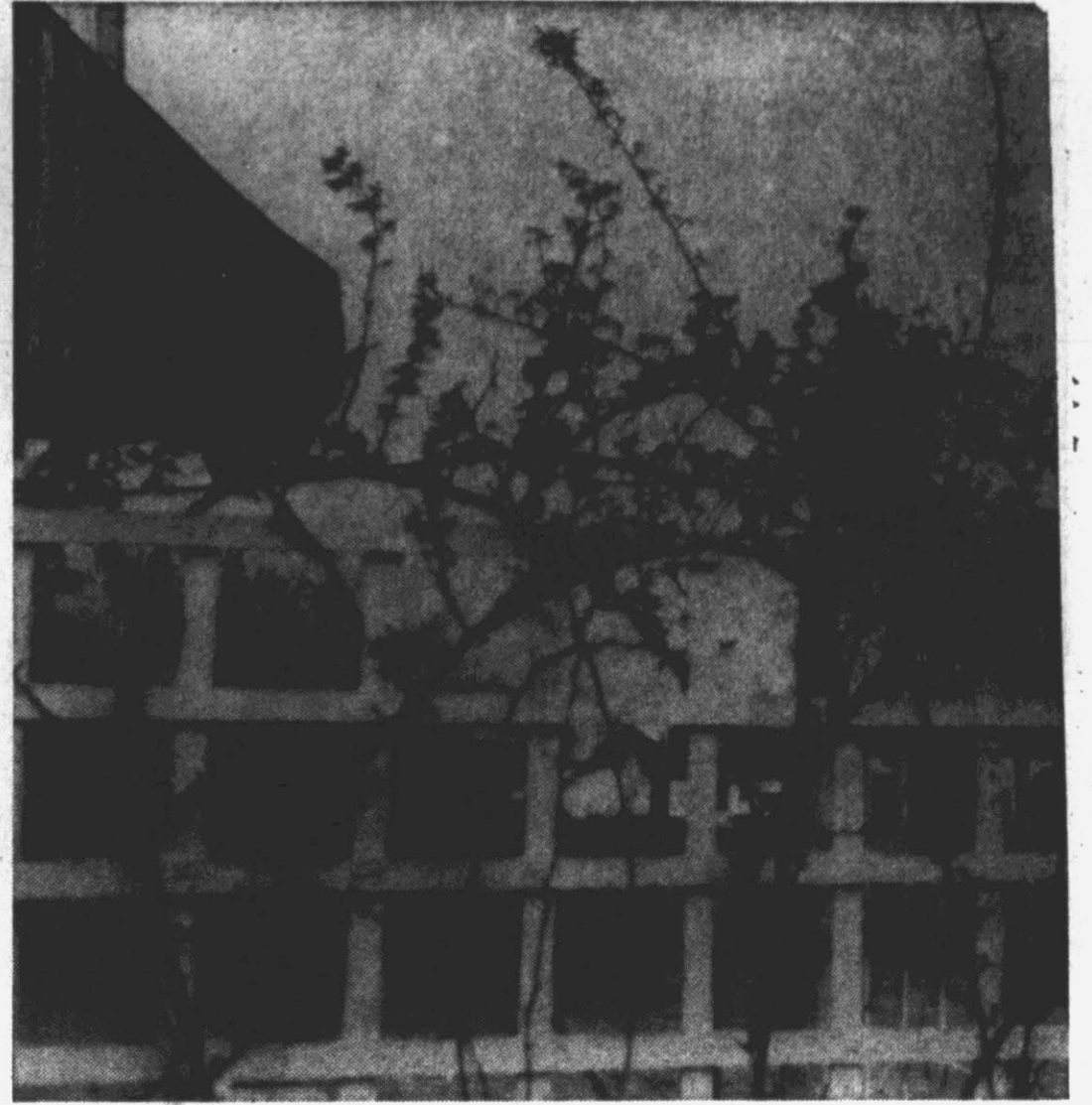

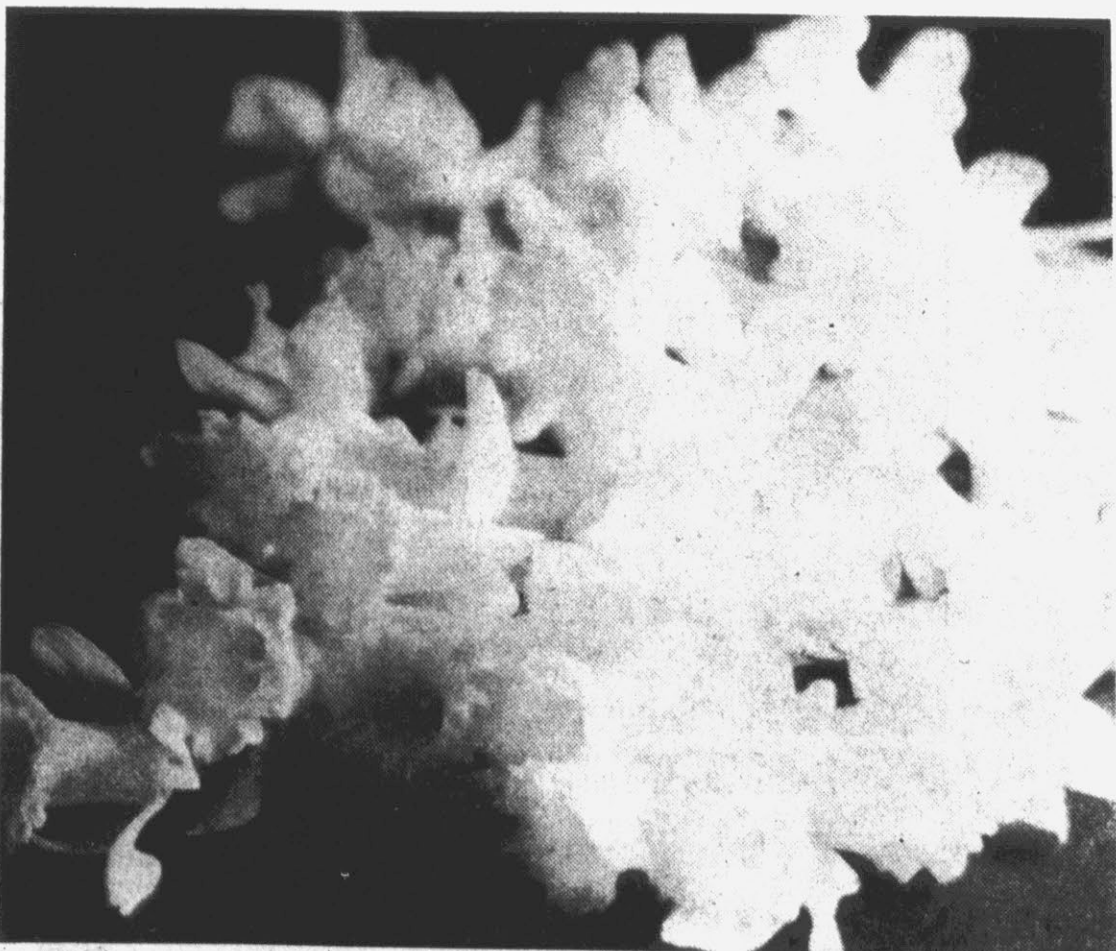

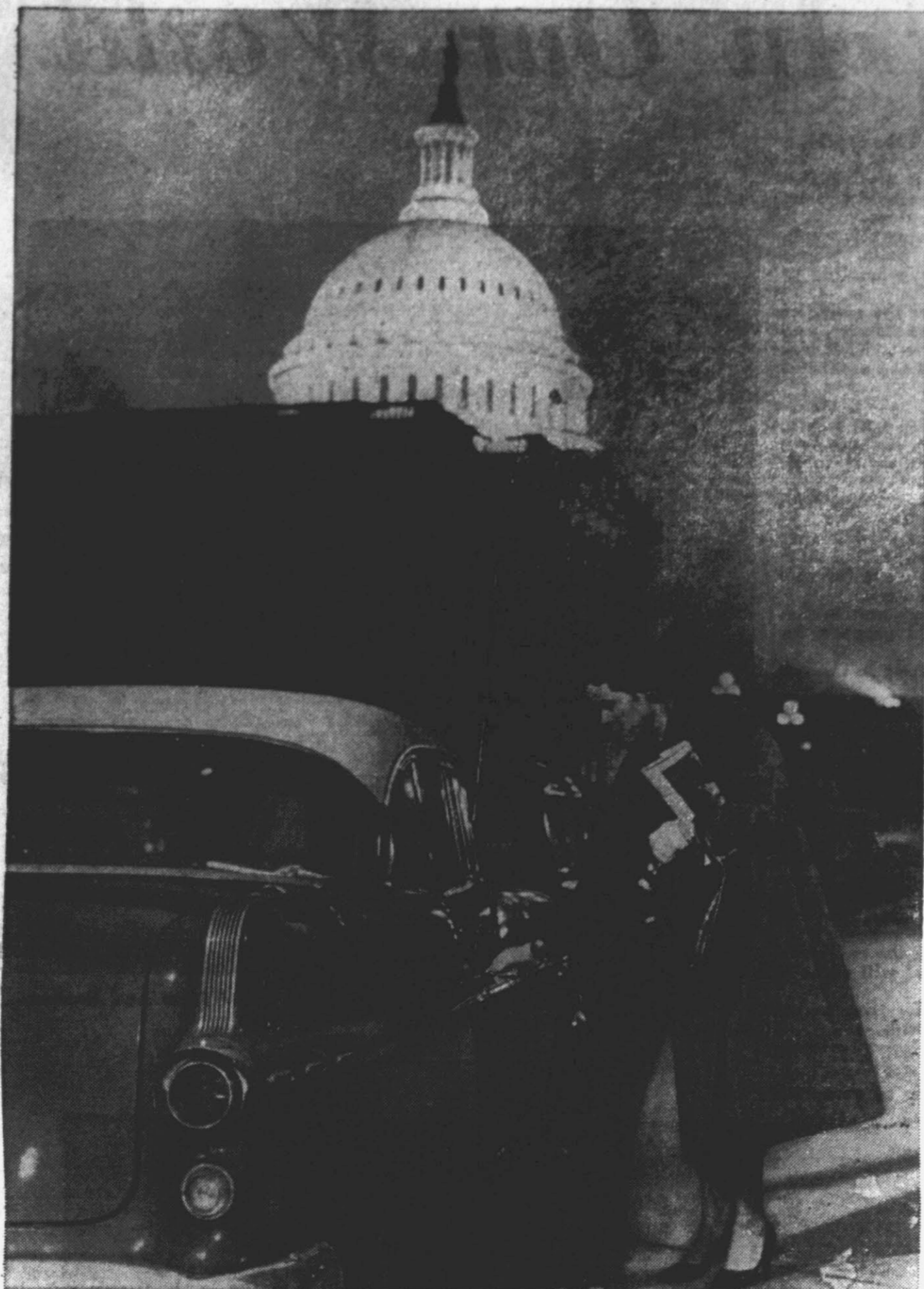

Additional Grain Storage Space Is To Be Had

Many Tar Heel farmers, when they harvest this year's grain crops, crops, will find that they could have increased their income considerably by being able to store their grain on the farm at harvest time, according to Walter Hasty, Pitt County ASC office manager.

He explained that this condition exists because of usually depressed local prices at harvest time and the requirement that farmers be able to store their grain either commercially or on the farm in order to take part in ASC's price support program.

"It's just good business for farmers to build their grain storage during this period when the storage facilities can be paid for through the increased income made possible because the farmer is in a position to hold his grain for orderly marketing and to take advantage of the ASC price support programs," Hasty declared.

He listed the following types of assistance that will be available through ASC county office in helping farmers to meet these storage needs:

Financial "loan" help is available to farmers which will provide up to 80 percent of the unrecouped cost of new bins. ASC county offices are also authorized to make loans to assist farmers in the purchase of drying equipment necessary to get their grain in condition for storage.

Under ASC's price support program for 1957, loans were made available on corn, oats, barley, rye, grain sorghums, soybeans, and wheat. Loan rates on the grains for 1957 were:

Corn, \$1.53 bushel, (complying farmers in the commercial area); oats, \$.73 bushel; barley, \$1.07 bushel; rye, \$1.35 bushel; grain sorghums, \$1.98 cwt; soybeans, \$2.04 bushel; wheat, \$2.21 bushel.
