Student Leaders Receive Rewards

Mary Ann Bryant, top-ranking student in Junior H. Rose High School's Class of 1958, was announced as winner of eight awards

last night at the class' Awards Night program in the school gymnasium.

Miss Bryant was one of 37 students singled out for awards other than those made for participation in athletics. Her awards include a Merit Scholarship, a \$2,600 Duke University scholarship, the Reader's Digest Scholarship Award for the highest average over a four-year period, the Math Award, the "Miss School Spirit" Award, an Editor's Medal for her work on the student newspaper, the high school medal for the highest academic average, and the school's scholarship plaque for placing first in the class.

Other principal award winners are Bob Bilbro, the Keech Distinguished Service Cup; Florence Norman, The Daily Reflector Scholarship; Iona Jones, the Lions Club Scholarship; Mack Roebuck, the Woolfolk Memorial Scholarship; Dick Evans, the Dixon Athletic Trophy; and Bob Howell, the Kiwanis Sportsmanship Award.

A report and pictures of the Woolfolk, Dixon and Kiwanis awards, plus other athletic awards, are being carried on today's sports page.

Bilbro, who was awarded the Keech Cup on the basis of his scholarship, leadership and activity, also received a certificate recognizing his selection as a Morehead Scholar at the University of North Carolina, the Student Co-

operative Association's President's Gavel, and the school's scholarship plaque for placing first, with Godfrey Oakley, in academic standing among male members of the class.

Oakley will have his name placed on the scholarship plaque and was also announced as winner of a \$2,600 Duke University Scholarship, the SCA's medal for service as Traffic Committee chairman and the Tau Award for leadership. Oakley, Bilbro and Miss Bryant were speakers during the program which was presided over by Class President Edward Buchanan. Principal O. E. Dowd and Superintendent J. H. Rose presented awards, and Dowd accepted the Seniors' gifts, aluminum lettering spelling out the name of the school beside the main entrance and a book to be used by succeeding classes in recording important events in each class' stay in the school.

The Daily Reflector Scholarship won by Miss Norman is a \$700 award for use at East Carolina College. The Lions Club Scholarship, presented to Iona Jones, is a \$200 award, also for use at ECC, as are seven \$100 awards presented by the Pitt County Scholarship Foundation of ECC and a \$100 award, provided by Best Jewelry Company and presented by the ECC Science Department.

Memorial Weekend Deaths Rise

Traffic 135 Drownings 45 Miscellaneous 24 Total 204

Deaths on the nation's roads soared today.

The National Safety Council reported traffic fatalities were mounting at a rate that will set a new Memorial Day holiday record, unless the climb is checked.

The council had predicted 350 motor vehicle deaths for the long weekend. The record for a three-day observance of the holiday, 369, was set in 1955.

Most of the deaths were reported one or two at a time. But early today there were two instances of six deaths each.

A station wagon and an automobile collided early today on the Cross County Parkway in Westchester County, New York. Six persons were killed.

Police at Ranger, Tex., reported seven persons had died in a truck-car collision 15 miles north of Ranger. That also occurred when the sun was just starting its ascent and the peace of a new day was on the land.

The growing list of accidents was a mixture of tragedy and irony.

A soldier at Afton, Okla., dragged three men safely from their wrecked and burning car, despite warnings from bystanders of a possible gasoline explosion.

He accidentally touched a high voltage line knocked down by the car and was electrocuted.

Seven persons were hospitalized with varying injuries in a smashing two-car collision near Hidalgo, Ill. One of the passengers was killed.

An Associated Press survey, made for comparative purposes, showed 294 persons were killed in traffic accidents in the 78-hour non-holiday period from 6 p. m. Thursday, May 15, to midnight Sunday, May 18. The current tabulation which began at the same time Thursday ends at midnight tomorrow (local time).

Taking Over As Premier Sunday

PARIS (AP)—Gen. Charles de Gaulle today clinched a wide majority in the French National Assembly for his investiture tomorrow as premier.

The Socialist Party gave its members the privilege of a free vote—and half of them swung behind the general.

This would give De Gaulle about 50 Socialist votes and bring his assembly total to less than the 400 votes he wants but well over the only certain opposition of 150 Communist deputies.

The Socialist Party who do not support De Gaulle could possibly abstain, thus beefing up his majority.

The Socialists also voted to permit their members to accept posts in De Gaulle's cabinet and several were almost certain to be given to socialist deputies.

The vote in the Socialist caucus removed the last snag to be De Gaulle's investiture. The National Assembly was called into extraordinary session tomorrow. No French premier has ever been voted into office during a Sunday session.

De Gaulle had given party leaders just five hours to make up their minds about supporting him.

The general set the deadline after a showdown meeting with leaders of all French political parties, except the Communists, which ended about noon.

He called for them to be back at 5 p. m. (11 a. m. EST) for their final answers. He is demanding from them that he get some 400 votes in the Assembly to provide an overwhelming majority against the 150 Communist votes certain to be cast in opposition.

The Socialist party still seemed to be holding the key to whether De Gaulle will legally receive from Parliament the sweeping authority he wants.

The Socialists refused to confirm that they had fallen in line behind the general. Their 97 deputies in the National Assembly scheduled another caucus before the 5 p. m. meeting.

Socialist leader Guy Mollet, emerging from the De Gaulle meeting, snapped a brusque "No comment" at all questions.

Antoine Pinay, right wing Independent, said that none of the questions posed at the meeting "revealed any political difficulties."

He said De Gaulle's responses had been clear and precise.

President Rene Coty announced as the morning began that he finally had accepted the resignation of Premier Pierre Pflimlin, clearing the way for De Gaulle. Pflimlin quit early Wednesday.

Pflimlin said after a meeting with De Gaulle and another with Coty that the general would announce his cabinet tonight and then go before an extraordinary Sunday Assembly session for approval as premier.

Political sources said De Gaulle had reassured the politicians he would bring the French civilian and military insurgents in Algeria back under the law of the republic. Paris newspapers predicted De Gaulle would fly to Algeria.

De Gaulle said it is the duty of the chief of government — by the very definition of the term — to see that the laws are obeyed by all. De Gaulle also guaranteed that he would make no move against civil liberties in France.

He expressed support for some sort of federal settlement between France and its restive African empire.

De Gaulle said he would respect the treaties which France has signed — specifically the North Atlantic Treaty Organization pact, the six-nation European Common Market and the atomic development program.

Mollet and Paul Ramadier hurried back for conferences with their colleagues. Mollet is known to be supporting De Gaulle. Ramadier apparently is acting as an arbiter between Mollet and the Socialist deputies still opposed.

In the buzzing corridors of the National Assembly where the deputies hurried although they were not in session—the names of a prospective cabinet for De Gaulle began to spread.

A De Gaulle supporter said the general intends to name an old hand as foreign minister, Catholic Popular Republican Movement Deputy Georges Bidault. The appointment of Bidault, a longtime backer of European unity, would soothe opposition to De Gaulle in those quarters which fear he will lead France down a lonely isolated road.

Jetliner 'Great' In First Flight

LONG BEACH, Calif. (AP)—"Far and away the finest first flight I ever made."

That was how the pilot felt about the maiden flight of the Douglas DC8 jetliner, capable of carrying 176 persons across the United States in 4½ hours.

The four-engine DC8 flew 2 hours and 5 minutes yesterday. It thundered off Municipal Airport here, cruised over the ocean and landed at Edwards Air Force Base, Calif.

After the flight, pilot A. G. Heimerdinger, 48, said:

"Of all the Douglas transports I have flown, the DC8 is the greatest. The plane handled so well we were able to accomplish much more than we had originally programmed."

The first DC8 represents a quarter of a billion-dollar investment over a three-year period by its manufacturer, Douglas Aircraft Co.

Douglas plans to start delivering the jetliners to airlines the middle of next year. It has 700 million dollars worth of orders from 17 airlines for 138 DC8s.

The DC8 has a top-rated speed of 600 m.p.h. It flew about 350 m.p.h. yesterday. It has a maximum range of 3,900 miles. Its wingspan is 139 feet 9 inches, length 150½ feet and tail height 42 feet.

Thomas C. Callahan, 31, of Atlanta, tired and hungry after evading officers in this coastal area, surrendered yesterday. He flagged down Dare County Deputy Sheriff Clarence Hassell while walking along highway 264 near Englehard.

Callahan was sentenced in Mecklenburg County in March to 35 years for kidnapping and robbing a Charlotte used-car salesman. He escaped last December from a Georgia prison where he was serving a life term for murder.

Callahan and another convict, Ray Baker, 28, of Covington, Ky., jumped from a prison truck during a heavy rain Monday. Callahan fled into the swamps, but a guard wounded Baker and recaptured him.

Three Prisoners Injure Own Legs

RALEIGH (AP)—The State Bureau of Investigation has been asked to prove accusations that three prisoners deliberately inflicted wounds on their legs with sledge-hammers. One prisoner suffered a broken leg.

State Prisons Director William F. Bailey said yesterday that Joseph Brewer, 25, of Easley, S. C., broke his leg in the incidents at the Ivey Bluff Prison in Caswell County during lunch hour on May 1.

Bailey said two other inmates attempted to break their legs with a sledge-hammer. They were identified as Fred Day Bowman, 47, of High Point and Frederick M. Barbour, 33, of Dunn.

A fourth prisoner, Floyd Reeves, 31, of High Point, sustained injuries, but contended his

resulted from a rock falling on his leg, Bailey said.

He added that Brewer, Barbour and Bowman had admitted they deliberately inflicted their wounds.

The prisoners head said he had asked the SBI to make an independent investigation "because of the possibilities that the offenses committed by these inmates amount to crimes and because they have by their action and asertions suggested the possibility of improprieties in the administration of the North Carolina prison system."

He added, "If this investigation uncovers evidence that a law has been violated, this evidence will be turned over to the solicitor of the district for appropriate action."

An investigation made by a prison official, Bailey said, brought out circumstantial evidence indicating that the injuries of each inmate involved in the incident were either self-inflicted or inflicted by one on the other for the purpose of avoiding work and seeking privileges not granted at a maximum security institution like Ivey Bluff.

Bailey recalled that Brewer, Bowman and Reeves were among a group of prisoners indicted in connection with the fatal stabbing of Martin Chavis at Central Prison on July 30 last year.

Bailey said Brewer refused to disclose why he broke his leg "but denied that he was motivated by a desire to bring about unfavorable publicity for Ivey Bluff Prison which he felt was the purpose behind the action of the other inmates involved."

Barbour said the main reason for attempting to break his leg was a desire to get the story to the newspapers, Bailey stated. Bowman said his motive was to get out of the rock quarry and escape punishment.

Bowman is serving 7-15 years from Randolph County for armed robbery. Brewer was sentenced from Henderson County to 6-10 years for breaking, entering and larceny. Barbour is serving 3-4 years from Sampson County for accessory before and after the fact of breaking, entering, larceny and receiving. Reeves was consecutive terms of five years sentenced from Guilford to three each for manslaughter.

Cholera Vaccine Is Being Flown Into Thailand

BANGKOK, Thailand (AP)—A U. S. Air Force mercy plane was flying from the Philippines to Bangkok today with 4,000 bottles of cholera vaccine to help curb an epidemic that already has claimed 50 lives here.

A spokesman for the U. S. International Cooperation Administration, donors of the vaccine, said another 6,000 bottles soon would be sent to Thailand. Cholera has stricken at least 400 persons in the past week.

Vaccine also has been sent by India and Australia through the World Health Organization. Health officials here predicted it would take two years to root out the disease.

A major cholera and smallpox epidemic has been raging in East Pakistan, on the other side of Burma from Thailand. Nearly 20,000 persons have died there.

Pharmacy School Building Ahead

CHAPEL HILL, N. C. (AP)—Awarding of contracts totaling more than \$850,000 for major construction work on a new University of North Carolina Pharmacy School building were announced today.

Funds amounting to \$1,500,000 were appropriated by the 1957 General Assembly for the building, scheduled to be ready by September, 1959.

Light To Moderate Vote During Morning Hours

Generally light to moderate voting this morning marked early hours of Pitt County's 1958 Democratic Primary.

Reports at noon from 17 of the county's 25 precincts showed a total of 3,386 votes cast. Most of the poll-holders, however, say they expect balloting to pick up in the afternoon hours. The polls will be open until 6:30 p.m.

At stake in today's election is the county's seat in the State Senate, the Sheriff's office, a seat on the Board of County Commissioners, a three cents tax levy for industrial development and a host of township constables' jobs.

Heaviest voting in the morning hours was in Greenville's eight precincts: Ayden, Farmville, Grifton and Winterville. At noon, Whitehurst had cast 454 votes, largest number reported from any single precinct. Farmville voters had cast 390 ballots. Greenville's sprawling seventh precinct had recorded 368 votes, and eighth precinct voters in Greenville had cast 419 ballots.

There are approximately 21,000 registered voters in the county and many veteran political observers have predicted a vote of around 10,000 in today's races.

Voting for the political office contests will be restricted to registered Democratic Party members, but Republicans are eligible to cast ballots on the special tax levy issue.

A check at noon of as many precincts as possible by The Daily Reflector's staff members brought these comments:

Ayden: Somewhat short of the number of votes cast during the 1956 general election, but expectations of heavy voting this afternoon to bring the precinct's total to about 1,100.

Winterville: The 238 votes cast were classed as "an average number." Heavier voting is expected this afternoon and the precinct may have between 600 and 700 ballots cast.

Farmville: With 390 votes cast at noon, precinct officials are looking for a total vote of more than 800. Voting, which was considered heavy this morning, is expected to be "about the same" during the afternoon.

Bethel: Voting thus far has been light, with 128 votes recorded at noon. Balloting is expected to pick up during the afternoon because of interest in the Senate and Sheriff's races.

The race for the Senate seat is between Greenville attorneys J. Henry Harrell and Robert Lee Humber. Neither has held an elective political office previously, and each is seeking the post vacated when Dr. Paul E. Jones of Farmville announced he would not seek a sixth term.

Incumbent Ruel Tyson, former Sheriff Sam A. Whitehurst and former Chieftown Constable Ben D. Forrest, Jr., are seeking the Sheriff's office. Tyson has

been Sheriff since 1942 when he succeeded J. Knott Proctor, who succeeded Whitehurst in 1938. Whitehurst had been Sheriff since 1926 when Proctor took the office.

The race for the seat on the Board of County Commissioners is between incumbent E. Alton Gardner, a former chairman of the board, and R. Guy Jackson, who was successful in a previous attempt to unseat Gardner.

The vote on the tax levy, authorized by the 1957 General Assembly, would permit the County Commissioners to establish a 17-member Industrial Development Commission, if voters approve the levy. The industrial development group would seek new and expanded industry for the county.

Today's voting, although expected to be heavy, is not expected to reach the 1956 General Election totals of more than 14,000.

Reassign Two To White Schools

CHARLOTTE (AP)—The Charlotte City School Board has assigned two Negro students to the previously all-white schools they attended this year. Another Negro student has been reassigned to a Negro school.

The rest of the city's almost 30,000 public school students were assigned yesterday along racially segregated lines.

The state's pupil assignment law gives parents 10 days in which to appeal unsatisfactory assignments.

Gustav Roberts, Negro boy who attended Central High School with white classmates, and his sister Girvaud, who attended white Piedmont Junior High, were reassigned to those schools for the 1958-59 school year.

Debra Hundley, Negro girl who attended white Alexander Graham Junior High, was reassigned to a Negro school. The junior high school's present building is being abandoned and all its pupils were reassigned.

Dorothy Counts, a fourth Negro student who broke the color barrier here last fall, dropped out of school after a week of classes because of harassment from other students.

Clear Truck Driver Of Fatality Blame

Kenneth Gordon Mace, Jr., the driver of the truck that crushed a Pitt County resident to death on May 10, has been exonerated in connection with the fatal accident.

After hearing testimony at last night's inquest into the death of James Edward Taylor, 32, of Greenville Route 5, the Coroner's Jury recommended that no criminal action be taken against Mace.

Taylor died instantly when struck by a truck heavily loaded with hogs while crossing N. C. Highway 30 at Pactolus. Pfc. Walter R. Chapman of the State Highway Patrol who investigated the accident and testified at the inquest testified the victim died as a result of head and internal injuries.

The currently popular view of the American woman is that she has two heads, breathes fire and beats her husband every morning before breakfast.

She is accused of wearing the pants in the family and wielding the whip, of driving her husband to an early grave and robbing him of his manhood.

The latest diatribe against the beleaguered American female is a grim little book called "The Decline of the American Male" by three males. It is illustrated with macabre sketches, showing helpless little men being squashed like bugs beneath the thumbs of a giant woman, lashed to a treadmill or driven into a rat race.

According to the three authors, Mr. America is in a bad way. His wife, they say, makes all the decisions of daily living, up to and including sex. She gives him an apron and makes him do the housework. She forces him to greater and greater exertions in order that she may keep up with her girl friends in mink coats, diamonds and automobiles. She won't let him go out with the boys at night, and objects when he wants to spend a few hours on the golf course in innocent play.

She ridicules him when he fails to get a raise at the office and

chastises him when he makes a mistake at home. If this is all true, we women should be pretty sick of ourselves by now.

Maybe I don't move in the right circles, but the women I know don't have two heads—or if they do, it doesn't show. They are more likely to overcoddle a husband than to horsewhip him. They worry about his colds and whether he wears his rubbers. And they hate to have him take a hand with the housework—it's always so much more trouble cleaning up after him.

When the men of my acquaintance take on household chores, it's always the dramatic ones, and in public. They love to grill a thick steak at a cookout, provided the rest of the meal has been prepared in advance, and there's a woman around to wash the dishes.

When pressed, they will mind the baby while Mom does the marketing—but don't think she won't hear about it for weeks to come.

And that growing number of American women who hold down

jobs outside the home are so worried, according to my observation, about becoming unfeminine that they redouble their efforts at cooking, housekeeping and looking glamorous after hours. Domesticity becomes something to be jealously guarded.

The authors don't offer much of a solution for the burdens of the modern man, except to suggest that he really should revolt. But they conclude: "The only trouble is, would his wife object?"

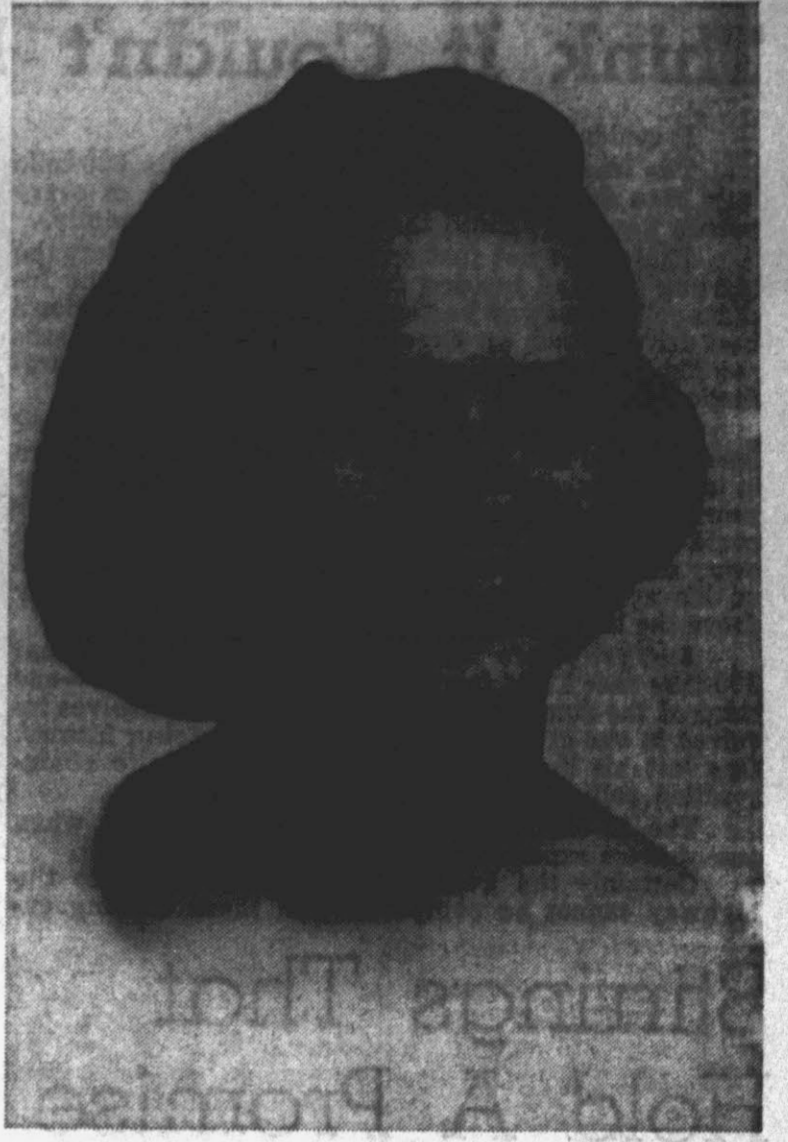

Ingredients: 1 large ripe pineapple, 1 large orange, 1 package (11 ounces) dried apricots (rinsed in hot water and drained), 4 cups sugar, 2 cups water.  
Method: Pare pineapple and slice. Quarter orange and remove any seeds. Put pineapple through fine blade of food grinder; turn into strainer to drain so you can measure. There should be 1 to 1 1/2 cups pulp and 1 to 1 1/3 cups juice; if less than that 1 cup juice, add orange juice to make that amount. Grind fine the unpeeled orange; grind apricots through coarse blade. In large kettle, mix fruit and juices, sugar and water. Stir over low heat until sugar dissolves. Cook rapidly, stirring every 5 minutes to prevent scorching, until fairly thick—20 to 30 minutes. Make 3 to 4 pints. # Think It Couldn't Happen To You?

It couldn't happen; but it did. The tragedy of yesterday's Indianapolis 500-mile auto race should burn deeply into the mind of every person who gets behind the wheel of an automobile.

These were not just ordinary drivers who left the starting line and headed for the first turn at the Indianapolis speedway yesterday. They were the nation's best drivers. Each an expert, each a man of keen senses, lightning-fast reflexes, and countless hours of professional driving.

These were men whose physical faculties had been checked and re-checked to make sure they were in top physical condition. They were men prepared by years of training for the most gruelling test any driver could face. They were men who knew and practiced every means of safety, for each knew his life depended on his actions and those of the other fellow. They drove the best vehicles money can buy.

And yet before the third turn of the 42nd annual 500-mile race 11 of the best drivers in the world—one third of the number in the race—found themselves involved in one of the worst smashups in racing history. One lost his life. Others were injured in the chain-reaction collision of high speed automobiles.

The 11-car collision, officials said, began when one of these experts lost control of his vehicle.

Certainly the average driver who takes to the highway cannot be compared with these driving ex-

perts. He is no match for their experience, their keen senses, their driving know-how. He doesn't drive on roadways on which only the best drivers are allowed. He is confronted with careless drivers as well as the safe drivers.

In the final analysis the chances of the average driver on the highway reaching his destination safely are much less than those experts who drive in the Indianapolis 500.

The tragedy at Indianapolis yesterday should prompt every motorist to review his driving habits, consider the conditions under which he drives, and take note of the hazards he faces on our highways.

It couldn't happen at Indianapolis; but it did.

# Three Symbols That Bare Finer Qualities

Materialists? Yes. Opportunists? Yes. Proud? Yes.

Americans are all those things and many more. Like yesterday . . . in the nation's capital.

There they entombed two more strangers with all the pomp and ceremony of national heroes. Nobody could even guess who these strangers were, it was enough they wore American uniforms when they died violent deaths.

There was no question about their race, their faith, their wealth, their IQ. In the long run, it never really mattered.

# Stirrings That Hold A Promise

NEGRO PUPILS — Text and statistical tables in the current issue of State School Facts. Publication of the Department of Public Instruction, give some highly interesting data on the way Negro pupils are taking advantage of educational opportunities, especially in high schools.

Total enrollment in all public schools increased from 833,615 in 1953-54 to 1,039,487 in 1956-57. During the same period total enrollment in white schools rose from 576,003 to 732,731, an increase of 27.2 per cent. Negro enrollment rose from 257,612 to 306,756, or 19.2 per cent. The difference in percentage increase may be explained by the fact that white population has increased, while there has been an actual as well as percentage decline in Negro population.

The high school picture is more significant. From 1943-44 to 1956-57 white high school enrollment went from 104,999 to 170,139, or 62 per cent. Negro high school enrollment rose from 28,651 to 60,688 an increase of 112 per cent.

Much more significant is the story of survival of first graders to high school graduation. Of each 1,000 white pupils who entered school in 1935-36 there were 229 to graduate in 1947 after completing 12 years. Of each 1,000 who entered the first grade in 1945-46 there were 419 to graduate in 1957, an increase of 83 per cent.

Out of each 1,000 Negro first graders in 1935 only 61 got high school diplomas in 1947. Of each 1,000 first graders in 1945, there were 192 to graduate in 1957 — an increase of 214 per cent.

Inescapable conclusion is that the North Carolina segregated public school system afforded equal opportunity for Negro pupils, and the Negroes have made better use of that opportunity than their white neighbors.

OPTIMISTIC — It isn't likely that Eastern North Carolina will ever erect a monument to tobacco wilt, black shank or Earsa Benson, as an Alabama community once did for the cotton boll weevil. But there are a great many people, including some of the direct victims, who see in the plight of tobacco farmers an opportunity for greater prosperity than the section has ever known.

June H. Rose, superintendent of Greenville schools, was talking about it the other day. His outstanding success as a school man is due in large part to his ability to analyze people and situations as to anticipate conditions. He is happily optimistic about the future of his section, although admitting that some of the people are unfortunately slow in adjusting their thinking to the changed economy.

Tobacco is still the backbone

of agriculture, but it is no longer the whole body of farming, he said. It is the main source of income for farmers and for business men, and perhaps will be for a long time. A crop failure or price failure will never gain mean the tragedy it did a few years ago. Industrial payrolls have supplemented and stabilized income. The most significant change, however, has been on the farm itself. Big farmers are diverting tobacco lands to pasture for beef and dairy cattle, and to bean and corn and grain for feed. Smaller operators are going in for hogs and poultry and for diversity in field produce.

Dr. Rose confessed that great prosperity is prospective rather than present. Too many people cling tenaciously to old ideas. But in the willingness of some to adopt new policies, to face up to conditions, he sees a brighter future.

ATTITUDE — This hope is based more on the attitude of the people than on their actions to date. He finds throughout the whole community a livelier spirit, more active interest in doing something, as contrasted with the apathetic acceptance of disaster that was evident when the era of easy tobacco money began to fade.

Ellis Canady of Oxford came along while your reporter and Rose were talking. He reported similar stirrings among the people of Granville county. He recalled that dominance to flue-cured tobacco in agriculture began in his section and that most of the original growers in Wake, Johnston, Wayne, Lenoir and Pitt Counties migrated from Granville, Person and Caswell.

"We started the business," he said, "and we seem more reluctant to abandon it." A large percentage of the farmers in Granville and adjacent counties are relatively small operators — family farms. Tenancy is less pronounced than in the mid-eastern area of the state. Most of the people who produced tobacco owned the land on which it was grown. They were and are an independent breed. But they also can read the handwriting on the wall and are turning more acres into corn and small grain, giving attention to cattle and poultry and to the development of small industries.

Conditions in Granville and Pitt are typical of the whole eastern half of North Carolina. It is probable that there is less ready spending money in the area now than there was three years ago. Certainly the "capital resources" are greater, because of the spirit of the people. Then they were obsessed with fear that conditions would get worse. Now they are sure they will get better. The direction of travel is indicated by the upward look as contrasted with the downward view.

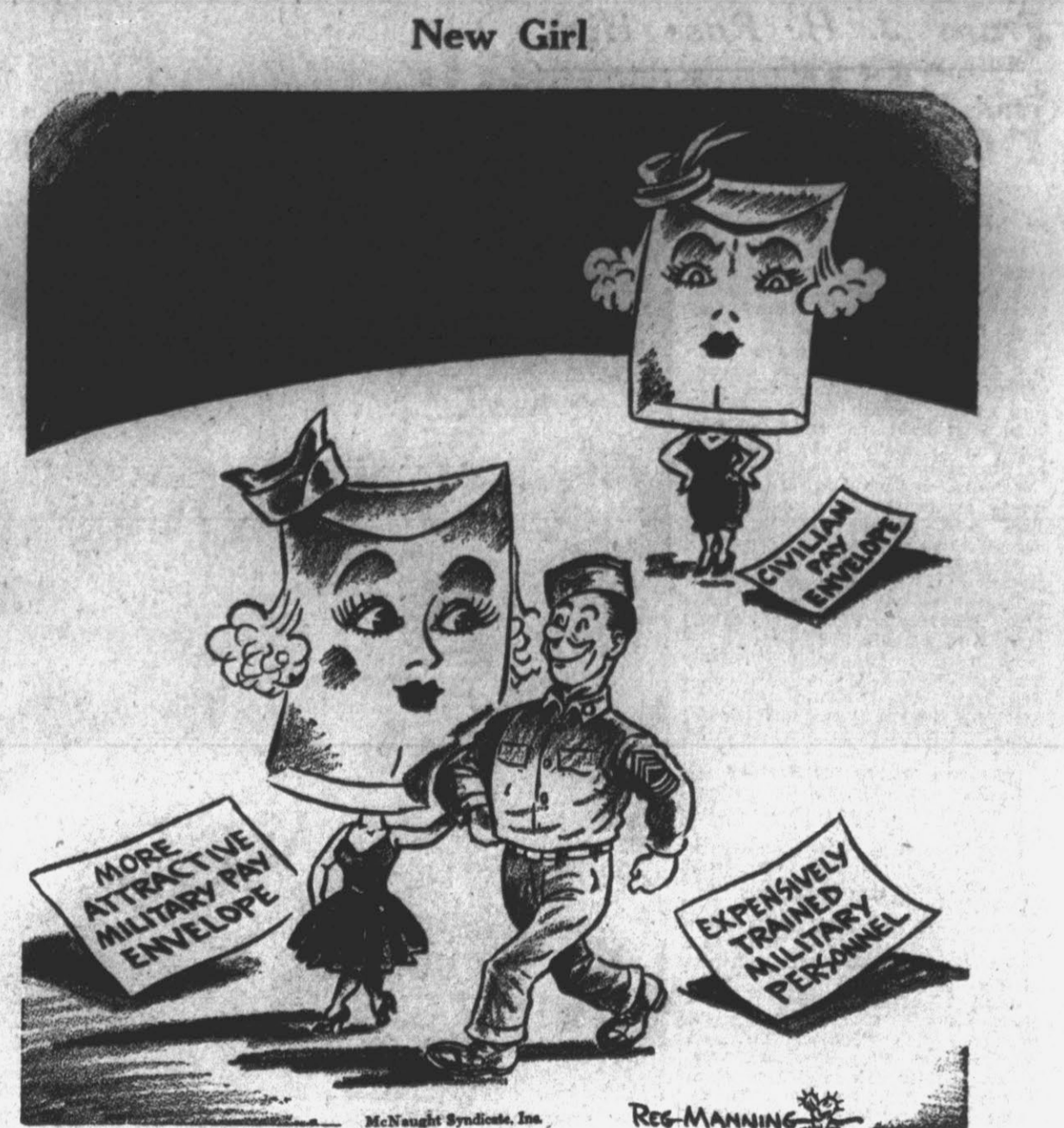

Other Editors Saying --- No Poor Boy's Champion

(Raleigh Times) Some of those who would turn all our higher education over to the State Board of Higher Education are now holding that board up as the champion which is keeping the poor boys and girls of North Carolina from having to pay too much dormitory rent.

The chief difficulty with this claim is that it is based on the erroneous idea that there is any connection between housing for married students and rents paid by single students in regular dormitories. There is no connection whatsoever between the two. The scale of rents charged for housing for married students is based on the cost of the housing for them, and on no other figure. The room rentals paid by students for dormitory space has no connection with housing provided for married students.

Actually, the Board of Higher Education made the per-unit rental for married students higher by approving only the 300 units instead of the 500 which the College had sought. For the per-unit rent is cheaper when more units are built.

That may be true. But what most surely is true is the fact that the Board also has made it impossible for a lot of North Carolina young people to find moderately priced housing when they do go to college. So, the Board actually is working against the best interests of many students by blocking such units.

The ideal solution, of course, would be for the State of North Carolina, from tax income to build the dormitories needed at State, Carolina and all the other state institutions of higher learning. Then it wouldn't be necessary for the institutions to charge the higher rents to pay for the dormitories they have to build.

But, each legislature is confronted with the task of finding more and more money for more and more needs for state services. The legislators can't do all they should do.

Until the state can build all the needed dormitories, the best way to get them is to follow the self-liquidating plan, with the necessarily higher room rentals.

## Jimmy Bryan Cops Indianapolis 500

INDIANAPOLIS (AP)—Jimmy Bryan, who now has won everything available in championship closed course auto racing, tonight will pick up a check for about \$100,000 at a 500-mile race Victory Dinner saddened by the death of Pat O'Connor.

O'Connor died in his burning car on the first lap of the Memorial Day classic yesterday after the worst start in the 47-year history of the race.

A car driven by Jerry Unser, a first-time starter from Long Beach, Calif., ran over two other cars and plunged over the retaining wall, but he escaped with a dislocated shoulder.

Of the 15 cars in the mixup, eight were knocked out of the race. Three others kept running. Four got back in the race after repairs.

Chief Steward Harlan Fenger said first reports indicated Ellisian was responsible for the wreck and Fenger recommended that the United States Auto Club take disciplinary action.

O'Connor's death was the 48th in the speedway's history, including two years of races prior to the first one in 1911.

Bryan, winner of the Monza 500 in Italy last year and the United States Auto Club champion the last two years, started in seventh position in the Belony Special driven to victory in the Memorial Day classic last year by Sam Hanks.

The husky cigar-chewing Bryan missed skidding and spinning cars by inches and found himself in first place at the end of the tragic first lap. He stayed there automatically for the 25 minutes it took to clear the track—and then there was a first-class race!

The lead changed 17 times before the Arizona cowboy pulled into the victory circle for the winner's kiss from movie star Shirley MaLaime.

George Amick, a 33-year-old speed veteran making his first 500 start, finished a little over 26 seconds behind Bryan. It was the third year Amick, from Venice, Calif., had tried to get into the race.

Johnny Boyd of Fresno, Calif., who finished 42 seconds back of Amick, was running practically hub-to-hub with Bryan late in the race. Jim Rathmann of Miami, second last year, also was coming up fast.

Amick made up almost a full lap late in the race, running a sizzling 144 miles an hour in a horizontal engine car, the Demler Special, similar to the Bryan-Hanks racer.

The winning speed, 133.791, was the second-fastest in the history of the race. Only 14 cars were running at the finish.

Bryan won \$20,850 in lap prizes—\$150 a lap for each he led. Amick won \$3,900 in lap prizes. Total winnings won't be known until tonight's Victory Dinner after the speedway counts its receipts and figures accessory companies' awards. The crowd was estimated over 150,000.

Shot putter Parry O'Brien, high jump champion Charlie Dumas and pole vaulter Bob Gutowski, all world record holders, face strong competition.

A special event is a 220-low hurdles race featuring Elias Gilbert and Fran Washington, both Winston-Salem, N. C., teachers. Gilbert bettered the world record with 22.1 seconds May 17 and it was Washington who pushed him to his mark. The pair will be opposed by NCAA champ Ance Robinson of Fresno State, a 22.2 man.

Cal Bryan Wins Ladies' Title

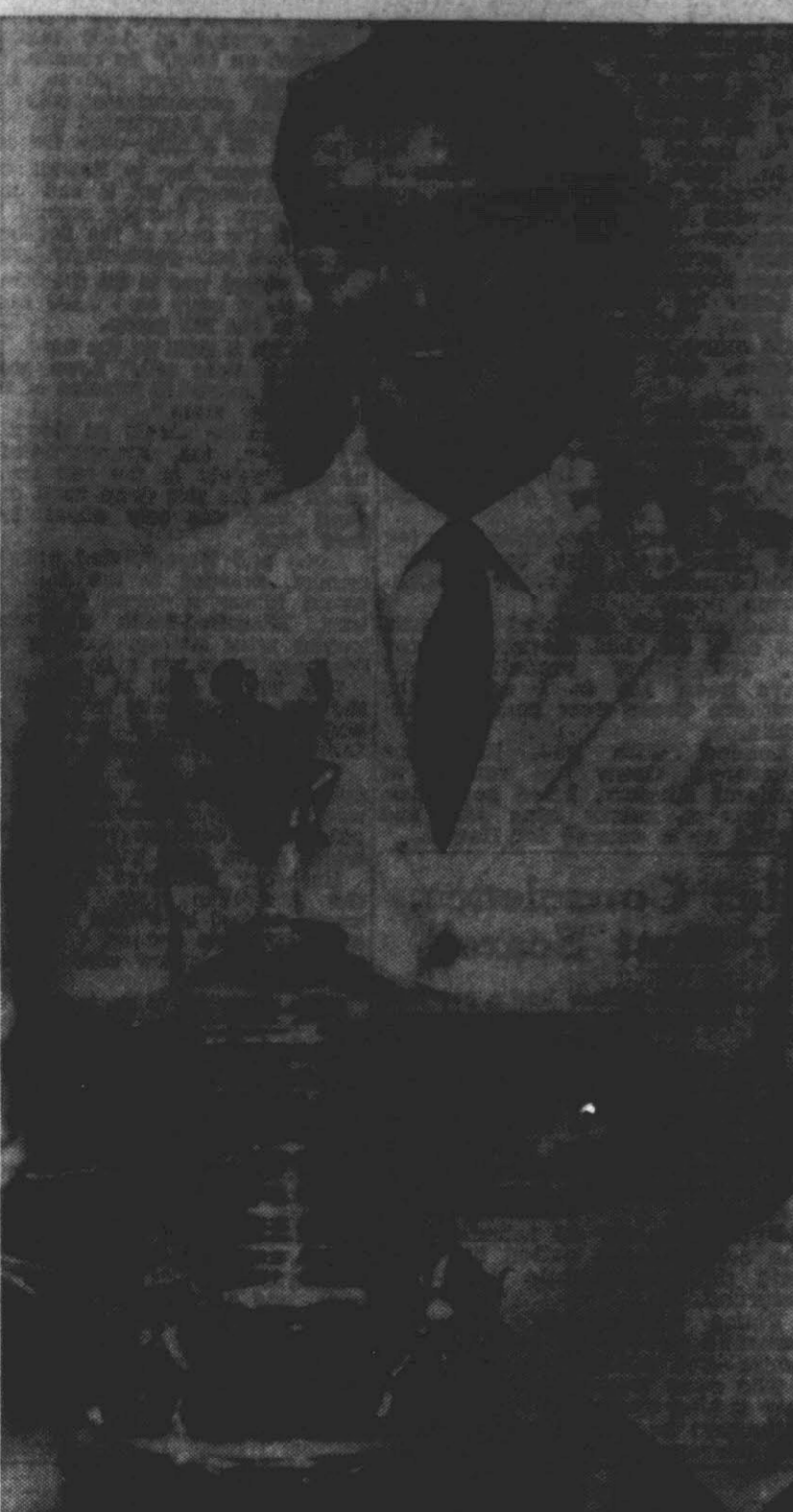
Cal Bryan won the ladies handicap golf championship yesterday afternoon at the Greenville Golf and Country Club, winning out over a field of 29 participants.

## UAW Attention Is Turned To Ford, Chrysler Issues

DETROIT (AP)—The United Auto Workers Union sought to break deadlocked negotiations with Ford and Chrysler today while completing plans for some 200,000 General Motors workers to work without a contract.

UAW members at three GM plants worked without a contract yesterday. Others will do the same in all 126 company plants Monday.

Both management and union termed the Ford and Chrysler negotiations deadlocked and each accused the other of refusing to budge.

Contracts at Ford and Chrysler expire Sunday midnight. The contract at GM expired Thursday midnight.

The industry's big three have offered to extend the old contracts two years. The UAW refused this.

The GM extension would have included built-in wage increases

totaling 16 cents an hour — a 7-cent productivity increase immediately, a 2-cent cost-of-living allowance increase immediately and a 7-cent productivity increase next year.

GM said this week that its 10,000 non-union employees would get both the immediate increases. It also said salaried personnel would get the equivalent.

The average hourly wage of auto production workers is about \$2.40. GM estimates that its production workers get an average of \$2.45 an hour.

Three GM plants at Atlanta, Ga., employing about 4,800 hourly rate workers, operated yesterday without a contract. It was the first such operation in a GM plant in 21 years.

GM set the terms for the no-contract work. Generally the terms follow the expired contract, except UAW membership no longer is a condition of employment.

The UAW has instructed local unions to establish gate patrols to demand that workers show dues receipts or membership cards. In this way it seeks to preserve an all-union shop. These patrols were not operating at Atlanta yesterday.

Walker Reuther, UAW president, asked for a Monday meeting with GM negotiators to lay the groundwork for further talks.

The International Electrical Workers Union contract covering about 18,000 workers at GM also

expired Thursday midnight. Negotiators met briefly yesterday and recessed until Monday.

Reuther made an unsuccessful last-minute bid for agreement with GM.

With only five minutes to go under the old contract, he proposed that GM's hourly rated employees be given a chance to vote secretly whether they favored the two-year extension offered by GM or the multi-point demands of the UAW.

Under the proposal, if UAW workers favored the union demands, GM would have been obliged to bargain for 30 days. At the end of that time, unresolved issues would have gone to binding arbitration.

## Proposes U.S. Drop Immunity In World Court

BILOXI, Miss. (AP)—The United States should give up its immunity from orders by the International Court of Justice to enforce effective world law, the president of the American Bar Assn. said today.

"War with Russia is as certain as tomorrow's sunrise unless a formula or mechanism can be developed to maintain peace other than through arms," said Charles S. Rhyme of Washington, D.C.

In an address prepared for the Mississippi State Bar, Rhyme said the international court "should make known its willingness to sit elsewhere than at the Hague."

"The entire court, or even a chamber of the court, should sit rather constantly at United Nations headquarters in New York... so that its advisory jurisdiction would be used more than it is now."

He asked the nation's lawyers to join "in urging removal by the United States of the present reservation which makes inapplicable to our country the compulsory jurisdiction of the International Court of Justice, to the end that we as a nation will accept the jurisdiction of that court in all international disputes."

Rhyme said international law can become the decider of disputes between nations without there being any world government and without a need to trust Russian agreements.

"This plan can capture the minds of the uncommitted peoples of the world... and leave Russia naked of friends," he said.

"Even Russia does not envision such nakedness as desirable... to launch this plan—unlike an armament agreement—we do not need her, nor do we need to trust her word."

"She can only hurt herself by her failure to cooperate."

Rhyme said there is no question peace "can only be maintained by our winning the arms race."

Even though this requires billions upon billions of dollars and a great economic drain upon our nation.

But, he said, "our task is to see to it that the time of the rule of law is a decider of international disputes before atomic annihilation overtakes us."

The girls, both Williamette students, said Crane swam toward them to give aid but that the heavy tide carried him away from the beach. The air drop followed.

# Just 36 Years Ago Today, Harry Lyons Helped Fly Pacific Ocean

PARIS HILL, Maine (AP)—In a white colonial mansion overlooking a New England churchyard, Cap'n Harry Lyons lives amid memories of his days as an ocean skipper, rum runner, pioneer flier, and village hell-raiser.

"I am what you might call a nefarious character," he grins.

At 73, Lyons can indeed look back on a career that has had its high moments — and he wouldn't give one of them back.

As Lyons would say, you can pick up his life story about the way you would a pup—just forward of the middle. It was 30 years ago today that Lyons helped make aviation history by navigating the first airplane to cross the Pacific.

The plane was the famous Southern Cross, a patched up bi-motor Fokker that somehow made it from Oakland, Calif., to Brisbane, Australia, a distance of well over 7,000 miles.

The pilot was one of the greatest airmen of his day — Sir Charles Kingsford-Smith. The other crew members were C. P. T. Ulm, a fellow Australian as copilot, and radio operator Jim Warner, an American.

Kingsford-Smith and Ulm were later killed in separate plane crashes.

Lyons, a Merchant Marine skipper, had never flown in his life when he was asked to navigate the Southern Cross. He was "on

the beach" and thinking vaguely of retiring from the sea when Kingsford-Smith entered his life in San Francisco.

The son of an admiral, Lyons was expelled from Hebron Academy for general hell-raising.

"I lasted about a year," he says, "and then the headmaster suggested that I not return the following year. I was an awful prankster—usually leading a lot of other pranksters on a merry chase around the village."

Later he went to Annapolis for a year, "bilged out" because he paid more attention to sports than studies, and then went to Dartmouth.

In 1912 he left college and went to sea under sail, for several years commanding a square-rigger. He was a lieutenant commander in the Navy during World War I.

He skippered freighters during the 1920s and also had a brief whirl running rum along the California coast.

Had anyone troubled to figure the odds on that morning of May 31, 1922, they probably would have been 100 to 1 against the Southern Cross ever reaching Australia.

Loaded with gas, the plane thundered down the runway at Oakland Airport, lifted ponderously into a misty blue sky, and picked up a course for Hawaii.

Lyons made the first official log entry: "We're happy as hell!"

"We cruised at 4,000 feet at 90 miles an hour," he recalls. "It was drafty in there and so noisy we could communicate only by writing notes. I navigated the way I would on a ship—only faster."

The 27-hour hop to Hawaii was an achievement, but it had been done before. It was the second leg that put the crew of the Southern Cross to a test—particularly Lyons.

The object was to hit the island of Suva, a coral chip 3,100 miles away in the Fiji group.

"We hit it right on the nose, but it was a close call," Lyons says. "We had maybe 20 minutes of fuel left in our tanks."

The landing should go down in history, too. Kingsford-Smith needed weight in the tail so he could set the ship down hard on a field that was only about 1,000 feet long.

Lyons and Warner, clad only in trunks, crawled to the tail. To avoid hitting a crowd of spectators, Kingsford-Smith ground-looped after landing, sending the Southern Cross into a bog.

The wheels sank in the muck, the tail shot violently into the air, and Warner hurtled through the fabric—losing his trunks en route.

The last leg of the flight—1,900 miles from Suva to Australia—would have been easy had not the patched-up Southern Cross hit the worst storm Lyons had ever seen.

But they weathered it, crossed the Australian coast, and later were mobbed by 300,000 people at a reception in Sydney, where the Southern Cross now reposes in a museum.

Lyons returned to Paris Hill and was hailed as the village cut-up who had made good. Still ahead were more years of flying (until he suffered a back injury in an automobile wreck) and a stint as a transport skipper in World War II.

Today, Lyons lives the life of a country squire with his wife Thelma at the family home, Lyonsden. He is criser in Superior Court, a deputy sheriff, a member of the South Paris water commission, and a member of the local draft board.

The Southern Cross is now a pleasant memory, and the \$2,500 he received as his share of the purse has long since gone, too.

"I spent every dime of it on riotous living," Lyons winked.

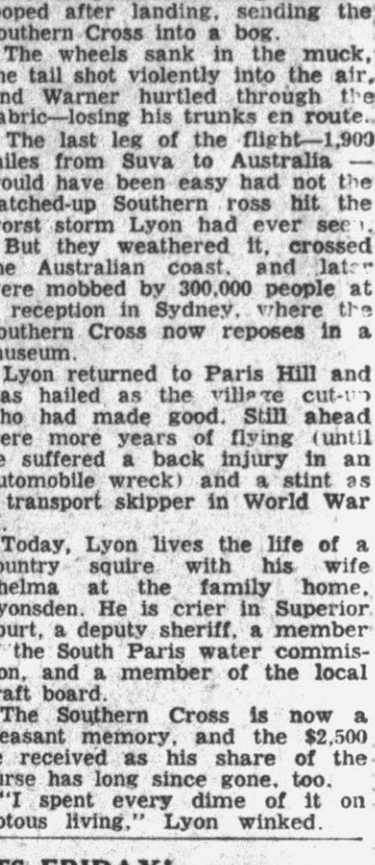

**Moscow Journey**

Speaking of Adlai Stevenson, we learn that he is scheduled to make a trip to Russia as a representative of the Authors League of the U. S., to talk about copyright agreements. Russia never signed the International Copyright Agreement and the rules over there about authors' rights to royalties and everybody else's, apparently, Mr. Stevenson is going to try to straighten out this situation for such writers from this side of the water as Mickey Spillane, John Steinbeck, Clifford Odets and Ernest Hemingway, to mention only a few. We can't resist wondering—if he doesn't succeed—if he'll write a letter to his client, saying, "I did badly—sadly, Adlai."

**Southern Arrivals**

From John F. Blair, publisher of Winston-Salem, who makes it his business to get good books about the South into print, has just come a new novel by Robert A. Bowen called "Tall in the Sights of God." Mr. Bowen is a newspaperman who divides his time between Asheville, N.C., and Moultrie, Georgia, and his book is about a family living in the mountains of western North Carolina. It will be published early next month and will be reviewed here soon, we trust. . . . Ruth Chatterton, whom many of you remember as a successful actress—she's famous for her work in movies like "Rodeo" and "Mr. Deeds Goes to Town"—now is turning her talents to fiction writing. In fact, since 1950 she's written three novels which have been favorably received. Her fourth will be coming out in June and concerns a very interesting problem—race relations in the South. The new book is titled "The Southern Wild" and is about two families, one white and one Negro—and that all we can tell you about it right now. . . .

**Today's Review**

The distinguished head of the Social Studies Department at E.C.C. reviews a recent controversial book about the War. . . . WHY THE CIVIL WAR? By Otto Eiseenschiml. Bobbs-Merrill Company, Inc., Indianapolis, 1958. (pp. 198, bibliography and index, \$3.75.)

The essence of good history writing is the use of new materials or the re-interpretation of old materials. This book falls far short on both these counts. It contains not a single reference to an unpublished source, and its two and one-half page bibliography carries only four titles bearing a publication date earlier than 1870. Its contribution to the history of the Civil War is virtually nil, in spite of the glowing build-up in the dust cover and the author's own rather stimulating questions in his one-page "Foreword."

Actually the book is another stirring of the dead ashes of the original Deep South charge that the outbreak of the Civil War in 1861 was due to Lincoln's refusal to compromise before March 4, 1861, and his failure to keep faith with the leaders of the Confederacy after his inauguration. This time, however, the president is presented in the role of "Honest Abe." Hence, the bewildering array of orders and counter-orders, public plans and secret moves in opposition, statements in conference and contradictory policies can be described as one vast plan for saving the Union.

## Youngsters Rioted In Holiday Cruise

**PENNSVILLE, N.J. (AP)**—Fired up by alcohol, youthful rioters turned a holiday cruise down the Delaware River into pandemonium yesterday. They smashed equipment aboard a crowded excursion boat and injured 15 passengers.

The crew of "The State of Pennsylvania" had to turn fire hoses on the rioters during the 3-mile trip downriver from Philadelphia.

Police do not know how the fight started.

Ten of those arrested were released. Eight others are under 18 and were charged as juveniles. They were sent to the Salem County Detention Home in nearby Woodstown to await action by juvenile authorities.

The remaining 16, ranging in age up to 22, were booked as disorderly persons, each accused of fighting with another person in a public place. A magistrate set bail at \$300 each. Parents or friends arrived during the night to bail them out one by one from the county jail in the city of Salem.

All those charged are from Philadelphia. They must be back here next Wednesday evening for a court hearing.

## Auto Industry's 1959 Models Coming Early

**DETROIT (AP)**—The auto industry's 1959 model year will end early in the third quarter. High inventories and lagging sales will bring shutdowns starting in July—perhaps sooner.

But whether new models will appear earlier than usual will depend upon the number of cars dealers have on hand when the shutdowns start.

The suspensions will be extended this year to enable retailers to liquidate outgoing models. Inventories have been reduced but they still represent nearly double a normal supply. There have been occasional sales spurts, but over all deliveries are far below those of a year ago. There is no present indication of a major upturn.

Talk of earlier closings for model changeovers has started speculation of what lies ahead for the 1959 models. Some sources predict a production boom with the start of the new model period.

There is talk of six-day factory operations overtime in most plants. But some sources say production is not likely to approach capacity levels early in the 1959 model year.

Obviously talk about overtime operations is largely wishful thinking. A thorough cleanup of outgoing models would contribute substantially to a favorable start

of 1959 car sales.

An earlier build-out of 1958 models and longer changeover shutdowns may avoid a rash of bargain sales just before the new models are introduced. Complete liquidation of outgoing models before the 1959 cars appear probably is too much to expect, but the industry is trying for it.

Most industry experts agree the engineering and styling of the 1958 models were in no way responsible for the sales lag that has harassed the industry. There is some difference of opinion as to whether the 1957 car market was oversold. But it apparently borrowed something from the present model year.

The sales pressure late in the 1957 model period was terrific. Motorists were urged to buy before 1958 models brought higher prices. There were many instances where extra \$100 reductions were offered on outgoing models if they were bought before midnight of the day preceding 1958 model introductions.

Bonuses offered dealers by the car makers made these extra reductions possible.

The auto makers are trying to avoid a repetition of the frenzied cleanup drives of 1957 and 1958.

# Two Unknowns Now Lie At Rest On Hill With Another Soldier Of Past

ARLINGTON, Va. (AP)—With pomp and pageantry ended, the Unknown warriors of World War II and Korea were at rest today on a hill overlooking the capital of the nation for which they died.

Under yesterday's warm sun, the two Unknowns—representing all the nameless dead of the most recent wars—were brought to the tomb where for almost 37 years the Unknown Soldier of World War I has slept alone.

There were marching troops, the subdued music of bands, artillery salutes and a fly-over of jets. Prayers were said and the President of the United States bestowed Medals of Honor on the two nameless Americans.

An estimated 115,000 persons lined the route of the funeral procession. Thousands more packed the amphitheater at the Arlington National Cemetery and stood in tribute as the twin bronze caskets were placed above open crypts.

But at dusk last night there was the final, lonely act of the drama that opened weeks ago when selection of the Unknowns began across the seas.

In the gloaming, the two were buried.

Only a few remained of the thousands who had thronged the cemetery during the formal services.

As the lights of Washington twinkled across the Potomac, the nine body bearers filed onto the plaza and drew to attention. Behind them stood perhaps half a hundred spectators.

The superintendent of the national cemetery and his assistants stepped forward. Each unfasted

## Governments May Go, But 'Striptiz' Stays On

ISTANBUL (AP)—Governors may come and go, but the "striptiz" goes on forever.

That is the conclusion some Turkish newspapers are drawing from the coming and going of Muztar Tarhan, ex-governor of Istanbul and arch foe of striptease.

Tarhan resigned from his job suddenly this month, without explanation. His job, as governor of Istanbul province and mayor of Istanbul, is one of the biggest political posts in Turkey.

No one has said anything official about it, but newspapers and people making the diplomatic rounds are surmising that one reason may have been that Tarhan was too strait-laced for the hand of the thriving striptease and belly dance.

Shortly after taking over his post last winter, he jumped into

the middle of a controversy by banning the striptease in night clubs as "too damaging to youth." He also insisted on night clubs closing earlier, prohibited tossing cigarette butts and matches on the street and campaigned against pin ball games—called "Uncle Sams" here—and soccer matches on week days.

All this aroused Istanbul. It likes the "striptiz." Late night clubs, cigarette butts, pinball and midweek soccer.

Ethem Yetkiner has taken over as acting governor. He quickly recalled the order against tossing butts and matches on streets but struck out vigorously against the hanging of carpets from windows.

Asked about the other measures, such as the striptease ban, he replied he couldn't say anything yet. But one shouldn't lose sight of the fact, he said, "that Istanbul is a touristic city."

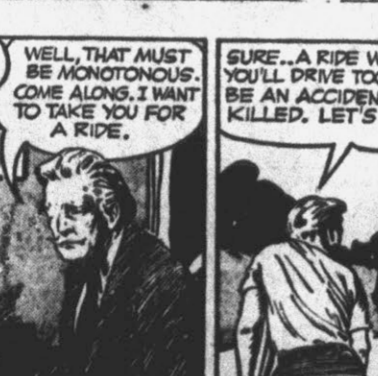

## Security Council To Meet Monday Over Clashes

UNITED NATIONS, N.Y. (AP) — The Security Council is scheduled to meet Monday on complaints by Tunisia and France that the other is responsible for recent armed clashes in Tunisia.

The meeting was called yesterday by Charles S. A. Ritchie of Canada, the outgoing Council president for May.

Tunisian delegate Mongi Slim charged Thursday that French forces in Tunisia and Algeria had conducted a armed aggression against his country. Tunisia is trying to get Paris to evacuate some 22,000 French troops from the former French protectorate.

A countercharge that Tunisia had broken an agreement on stationing the troops there was filed by French delegate Guillaume Georges-Picot. He also asked the Council to resume consideration of France's earlier charge that Tunisia is aiding the Algerian rebels.

# Soon, Russia Will Match Our SAC

LONDON (AP) — The Soviet equivalent of the American Strategic Air Command soon will be capable of mounting a major offensive with nuclear weapons of all types, Britain's Royal Air Force Flying Review said today.

The Soviet magazine said the Soviet bombing force still is smaller than SAC "but is being increased in strength and potency and is likely to provide the backbone of Russia's offensive power."

The Soviet SAC is known as the Dal'naya Aviatstia—or DA.

The Flying Review said DA is weak in long-range heavy bombers and aerial refueling tankers but every effort is being made to overcome these shortcomings.

"Next year may see parity reached with the Strategic Air Command," the article said.

DA "is one of the Kremlin's top priority weapons—despite Nikita Khrushchev's widely publicized boast that Russian ballistic missile progress has rendered the manned bomber obsolete," the Review asserted.

"Paralleling the Soviet Union's immense missile program are several manned bomber programs and there is much evidence to indicate the Kremlin planners have no intention of placing all their nuclear eggs in the ICBM basket for at least a decade ahead."

The magazine, which is published with the cooperation of Britain's Air Ministry, claimed DA attack techniques now are believed to have attained a high standard closely comparable with those of SAC.

The Flying Review said DA's strength is reliably estimated at some 1,500 medium and heavy bombers. It predicted a gradual increase in numerical strength.

It said there are between 30 and 40 DA bases, mostly in central Europe and so widely dispersed as to make simultaneous attack by SAC impossible.

"Any offensive action by DA forces is likely to comprise simultaneous sorties against U. S. Strategic Air Command bases and industrial targets in North America, the strikes being sufficiently numerous to saturate the enemy radar chain and split the opposing interceptor forces," the Flying Review said.

## Places Second To Perry Como

WASHINGTON (AP) — Among other mail, President Eisenhower recently received a letter from a 9-year-old girl.

"Dear Mr. President," she wrote, "I love you more than anyone in the whole world, except, of course, for Perry Como."

Robert K. Gray, White House secretary to the Cabinet, told about the letter yesterday in a speech to wives of Medal of Honor winners.

## Accept Denial Of 'Buzzing' Giant Airliner

SAN FRANCISCO (AP)—United Air Lines has accepted the Air Force's denial that B-47 pilot "deliberately buzzed" a UAL airliner with 62 persons aboard.

Maj. Eugene Mathis said he actually was maneuvering his big jet bomber to avoid a possible collision with the DC-7 near Salina, Kan. Thursday. He is based at Salina AFB, Salina.

In Washington, undersecretary of the Air Force Malcolm A. MacIntyre exclaimed "unfounded...an irresponsible statement" of the UAL complaint to the Civil Aeronautics Administration. The complaint was withdrawn last night.

UAL pilot M. K. Wolfe had charged on arrival here that B-47 crossed only 500 to 1,000 feet in front of his airliner. He called it "a deliberate buzz."

Sen. William P. Knowland, California Republican, one of 57 passengers, had asked the Air Force and CAA to investigate.

## General Travels By Whirly-Bird

FT. JACKSON, S.C. (AP)—Maj. Gen. N. A. Costello soon may have everything in Korea looking up.

The general, who will take command of the 7th Infantry Division in Korea, arrived on schedule to review the troops here yesterday—one day after finishing helicopter pilots' school. He landed a whirly-bird neatly beside the reviewing stand and took his place beside the other brass.

## Dog Lives Up To A Famous Name

BUENOS AIRES (AP)—A bulldog named Rer-Tin-Tin lived up to his name yesterday. He routed three robbers and saved the post office 300,000 pesos — \$750.

The holdup trio had locked up the employees of a branch post office and were trying to open the safe when Rer-Tin, the superintendent's pet, trotted in and attacked. The robbers fled but piled up their getaway car and police caught them. The post office safe contained 300,000 pesos.

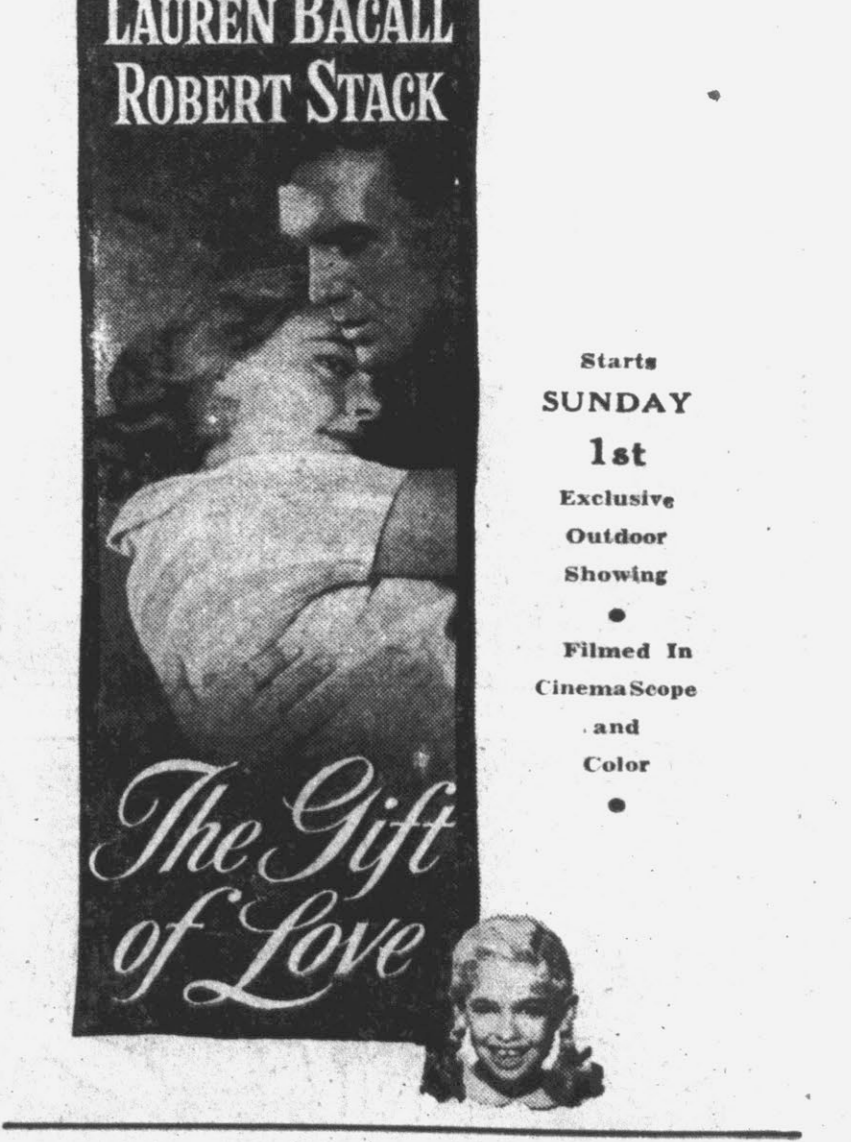
