marked Trees to Ceder Tree thence to a corner pine thence along

Road thence along the Road to the Beginning to have and to hold
the aforesaid parcel or Dividend of Land to gether with all houses
Orchards gardens woods ways & waters with all other rights
privellages proffits Commodities or advantages to the same belong-
ing or in any wise appertaining to him the said Littleberry
Futrell and his heirs forever, and further the said Levi Dolbay
do hereby agree promis & affirm to the said Littleberry Futrell
that the said Bargained Land and premise and every part
and parcel there of is Clear & free from all former & other gifts

of incombrances whatsoever and that I am Lawfully seized
