

This Indenture Made this twentyth - Day March in the year of our Lord 1800 one thousand eight hundred and Seven, Between Shadrack Futral of the County of W<sup>m</sup>ampton and State of N<sup>o</sup> Carolina of the one part and Elliott Futral and Littlebury Futral of the County and State aforesaid of the other part witnesseth, that the Said Shadrack Futral for and in Consideration of the sum of eight hundred Silver Dollars to him in hand paid by the Said Elliott and Littlebury Futral which is hereby Acknowledged and have by these presents Bargained sold and Confirmed unto the S<sup>r</sup> Elliott Futral and Littlebury Futral their Heirs and Assigns for ever A certain Tract or Dividint of Land Situate lying and Being in the County and State aforesaid Containing by Estimation, One hundred and eighty One Acres to the same more or less and Bound as follows (SWW) Beginning at a pine James Sharrods corner, then along the Said Sharrods line to a Lightwood Slump in Burritt Lapiters line then along the Said Lapiters line to a corner Red Oak then along the Said Lapiters line to a White Oak Eli Tallow's corner then S<sup>r</sup> along a line of Marked trees to a pine and two Red Oaks, in a line formerly called, loose Carters line then Mustardly Corn to a corner, then S<sup>r</sup> 65 East along the S<sup>r</sup> Carters line to a Black Gum Standing on the Side of the road in the Scotchmans Branch then up the Main Run of S<sup>r</sup> branch to the first Station, With the Appertances therunto Belonging to them the Said Elliott Futral and Littlebury Futral their Heirs and Assigns for ever To H<sup>r</sup> H<sup>r</sup> & H<sup>r</sup> Hole, the S<sup>r</sup> parcel of Land with all and Singular the Appertances therunto belonging to them the Said Elliott Futral and Littlebury Futral as aforesaid and the Said Shadrack Futral both for him self his Heirs Exec<sup>t</sup> & Covenant and agree to and With the Said Elliott and Littlebury Futral their Heirs and Assigns that he will warrant and Defend the Said Bargained Land and Premises, and every part and parcel thereof from the last Claim and Demand of all and Manner of person and Persons whatsoever free and clear of all and Manner of Incumbrances whatsoever and that the Said Shadrack Futral have in him self at the time of the Sealing and Delivering of these Presents a good and Lawfull Right to sell and Dispose of the same in fee Simple in Witness whereof I the Said Shadrack Futral have hereunto set my hand and affixed my Seal the Day and Year first above written
