1874 by and between W^m H. Hughes a spouse of the Estate and
effects of James Lurgford, Bankrupt, of the County of North-
-ampton State of North Carolina of first part and Cornelius
Lafite of the other part, witnesses: - that whereas the
said spouse after due and lawful notice did expose
at public auction before the Court here door in the town
of Jackson Northampton County N. C. to the highest bidder
for Cash the reversionary interests in a tract of land in the
Schedule of the said Bankrupt mentioned, and hereinafter
described, which said tract of land had been allotted and
set apart to said Bankrupt as a homestead, when and
