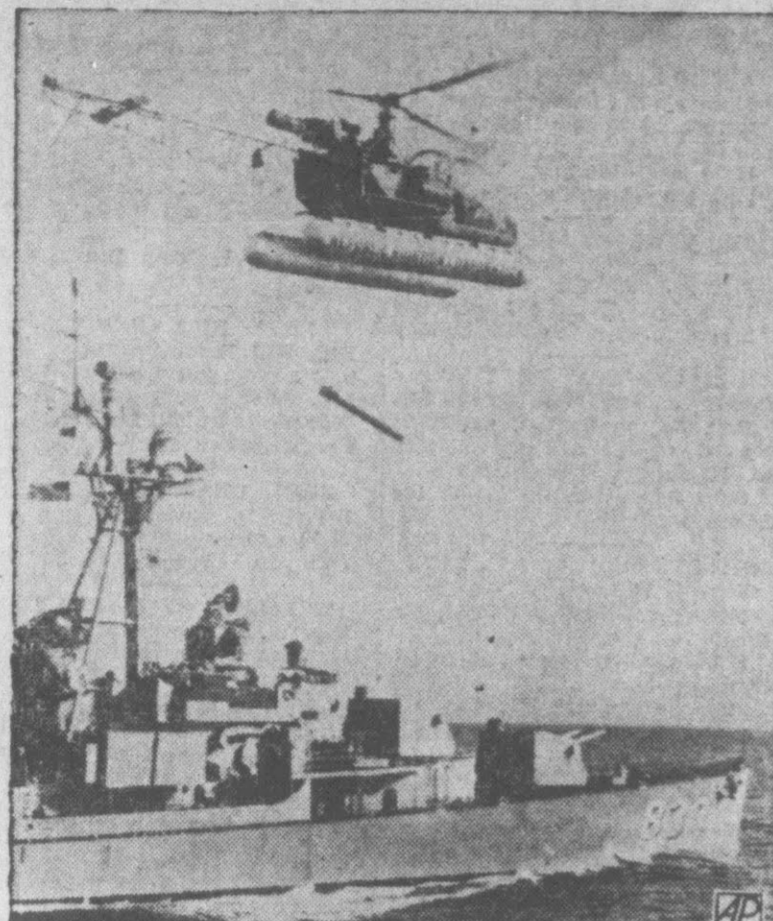

First John XXIII During Schism Era

FLORENCE, Italy (AP) — The tourists were downright puzzled. They had just come from Rome, where a vigorous Pope John XXIII rules the Vatican. Now they were in Florence looking at the tomb of Pope John XXIII.

The guide said the bewilderment on their faces.

"I'm sorry," he said. "I must explain. This is the tomb of a Pope John XXIII who died in the 15th century. He really wasn't a legitimate pope. He was an antipope, a false claimant to the papacy."

"For years I have told tourists that this is the tomb of Pope John XXIII. I never had to distinguish between him and the present pope. Now I must and I keep forgetting."

Donatello and Michelozzo, two of the greatest Italian Renaissance sculptors, have given the antipope a magnificent tomb just outside the historic cathedral of Florence.

How did a man considered a false pope get such a fine tomb? The antipope, born about 1370, was Baldassarre Cossa, son of a noble family of Naples. He was 8 when the "Great Schism" split the Roman Catholic Church. One pope, Clement VII, set up shop in Avignon, France; another, Urban VI, in Rome.

The schism continued through the reigns of Popes Boniface IX, Innocent VII and Gregory XII in Rome, while the antipope Benedict XIII succeeded Clement in Avignon.

Cossa, a youth of talent and energy, entered the service of the popes of Rome and became a cardinal at the age of 32. Seven years later he played an important part in the Council of Pisa, which sought to resolve the schism. Instead, it merely created another schismatic faction.

The council ruled that both Gregory XII at Rome and Benedict XIII in Avignon should be deposed. Then Cossa brought about the election of Alexander V.

now considered an antipope. A year later, in 1410, Alexander died and Cossa was elected Pope John XXIII by the cardinals supporting him.

The schism had political overtones and Cossa had the solid support of the rich city of Florence, which was then building itself into a rival of Rome and of France.

But Gregory in Rome and Benedict in Avignon both refused to give way to Alexander or his successor, John, and until 1415 there were three rival claimants to the papacy.

In that year, the Council of Constance brought about John's abdication. Benedict was declared deposed. Gregory resigned to help resolve the schism.

Two years later, Martin V was elected pope and the schism ended. Cossa paid homage to Martin, who returned the erstwhile Pope John XXIII to the cardinalate.

Cossa had long been a favorite of the flourishing Florentine Republic and he went to Florence to spend his last years. On his death, his magnificent tomb was ordered built by Cosimo de' Medici, a founder of the powerful ruling family of Renaissance Florence.

She Likes Cooking Specialty Is Pastries

"In order to have good results in cooking everytime, a cook must follow a recipe closely and use exactly what it calls for." This explanation came from Mrs. George Tyndall of 207 Summit Street.

Mrs. Tyndall speaks with authority because she has been cooking since grammar school. Her mother, "a real good cook," started the spark of interest which grew into a career.

Since Mrs. Tyndall enjoys working with pastries and cakes, she caters to many clubs and women's circles.

"A favorite of the Greenville club women is the individual coconut cake, especially in the winter," said this petite housewife.

This seven-blue-ribbon winner in the cooking field enjoys making a deviled-foe cake, canning string beans and beets, which are among the items which wear the ribbons.

Her culinary specialty is cake and pastry making.

The recipe for the individual coconut squares is as follows:

- Coconut Squares
- 2 1/2 cups sifted flour (all purpose)
- 3 teaspoons of baking powder
- 1 teaspoon salt
- 1 1/2 cups sugar

Sift these ingredients together and then add 1 stick of butter at room temperature, 1 cup of milk, and 2 teaspoons of vanilla. Mix the dry ingredients until they look like coarse meal. Add 2-3 cup of milk, beat until smooth, add rest of milk and 2 whole eggs, beat until looks like whipped cream.

Bake in two 9" square pans or 9" x 15" rectangular pans with the oven at 375 deg. After cake is cooled, cut in desired shapes.

- Fluffy White Icing
- 3-4 cup sugar
- 1-3 cup white syrup
- 2 egg whites
- 2 teaspoons water
- 1-4 teaspoon cream of tartar
- 1 teaspoon vanilla

Cook over boiling water for 6 to 7 minutes or until fluffy. This mixture is sufficient for icing a two-layer cake.

If squares are used sprinkle with coconut (two shredded coconuts). One coconut is used to a cake. After icing, sprinkle coconut.

"The secret of a cake is to have the butter, milk and eggs at room temperature," adds Mrs. Tyndall.

Nothing can top Southern fried chicken, fresh vegetables such as beans or peas and potato salad, is Mrs. Tyndall's belief.

She recommends serving the potato salad fresh instead of chilled, especially if onions are used in the mixture. A flavor tip for the salad is to use bell pepper which also gives color to this dish.

A meal would not be complete with refrigerator rolls, another specialty of Mrs. Tyndall's. "They are quick and easy," she notes.

- Refrigerator Rolls
- 2 cups warm water or potato water (she uses warm water)
- 2 packages of yeast
- 1/2 cup sugar
- 2 teaspoons salt
- 1 egg
- 1-4 cup soft shortening (margarine)
- 6 1/2 or 7 cups all-purpose flour (use unmixd flour)

Dissolve yeast in water in a mixing bowl, and add sugar, salt and 3 or 3 1/2 cups of the flour. Beat thoroughly for 2 minutes, add egg and shortening, and gradually beat in remaining flour, beating until smooth.

Cover with a damp cloth, place in refrigerator, and punch down occasionally. About 2 hours before baking, cut off the amount needed and return remaining dough to the refrigerator. Shape dough into rolls and place on greased baking sheet. Let rise 1 1/2 hours. Bake 12 to 15 minutes in oven pre-heated to 400 degrees. Recipe makes 4 dozen rolls.

Something Different

To add a little something different to the bread used during dinner, Mrs. Tyndall suggests this method:

Cut off a piece of dough and roll in a circle. Brush with melted butter and slice the dough in triangular spaces, starting from the center.

Then start with the wider end and roll toward the middle for each roll. At the finish you have a pinwheel design.

"The best thing about cooking, to me, is to try my wits with all kinds of recipes, because one could easily say that I am a recipe-follower," concluded Mrs. Tyndall.

Intervention Is Still Unthinkable

Much as the mass executions of Fidel Castro's new Cuban government have horrified most American people, intervention by the United States into the internal affairs of Cuba is unthinkable.

We can use our good offices in attempting to persuade Castro to follow a more lenient line in punishing those guilty of crimes before his government came to power, and to urge that fair trials are assured the accused persons. But for the United States to attempt to coerce Castro would be a grave mistake indeed.

Certainly there should be no thought in high places of sending American troops into Cuba. After all, we sat by and watched unprecedented slaughter of innocent people in Hungary under the ruthless Russian boot, and there was no mention of sending troops to help the Hungarians hold on to the freedom they won briefly.

We sent the Hungarian people nothing more helpful than words of praise and hope. We sent nothing more devastating against the Soviet oppressors than carefully phrased diplomatic notes.

How then could we justify sending American troops into tiny Cuba where even those who are calling for drastic action are convinced that the vast majority of the citizens of that country are in sympathy with the Castro regime?

An unfortunate series of circumstances has quickly brought the relationship between the United States and the new government of Cuba to a low ebb. To be sure the mass executions ordered by the Castro government are a major factor. But it must be remembered that though the United States more than a year ago

ceased to send arms to Batista, thousands of rebels and their sympathizers in Cuba were slain by American-supplied arms in the hands of Batista forces.

It should not be difficult for us to understand—if we wish to—that Castro and his followers may harbor some misgivings toward their big neighbor to the North. They genuinely fear their victory, won after more than two years of bitter fighting, may quickly be challenged again in open conflict.

Though these conditions do not justify the mass executions, to some degree at least they may account for the words Castro and others have angrily hurled at the United States.

At least Castro has openly publicized the trials and executions in contrast with the cloak of strict official censorship which shielded from the world's view reprisals taken against rebels and their sympathizers when Batista held power.

Let us be misunderstood, The Reflector reiterates its disapproval of the manner in which the Castro government has carried out the swift execution of Batista followers.

In all good conscience, we must disapprove with equal vigor any suggestion of armed intervention by this nation in the current situation in Cuba.

It was Theodore Roosevelt who counseled the American government to talk softly but carry a big stick. We have the big stick, but sounds emanating from the legislative halls of Washington suggest we have long since forgotten the first half of his advice.

An Exemplary Spirit In Community Leader

Selection of W. C. (Bill) Taylor, Jr. as Greenville's Outstanding Young Man of 1958 places that distinguished honor upon a young man who has contributed countless hours to voluntary civic service in behalf of his community, not just in 1958, but over a period of several years.

He is a young man who exemplifies the spirit of a true community leader, ready to accept positions of heavy responsibility in community affairs, and equally ready to accept yeomanly tasks which are essential to the continued progress of any community.

The list of Bill Taylor's activities in behalf of a better Greenville during the past year is far too long to be repeated here. Suffice it to say they cover almost the entire scope of community endeavors, and represent a tremendous personal sacrifice on the part of a young family man who in the past few years has begun and built his own business. But of such stuff are the true community leaders made—the willingness to make personal sacrifices when necessary in order to do what must be done for the welfare of his fellow citizens and the community which he lives.

The winner of this year's Distinguished Service Award presented by the Greenville Jaycees is most deserving of the high honor bestowed upon him in recognition for his service to his community.

To the hundreds of messages of congratulations Bill Taylor has received in the past two days, The Daily Reflector would like to add its congratulations. And we would also convey our deep and sincere appreciation for his unselfish devotion to helping make Greenville a better community in which to live.

Cuba Again Has A Dictatorship

WASHINGTON (AP) — Fidel Castro, in power in Cuba only 16 days, is already in a shouting match with the United States although his revolutionary government was given speedy diplomatic recognition by this country.

Castro's long fight against the dictatorship of Fulencio Batista reached its climax Jan. 1 when Batista fled. Castro's announced purpose in overthrowing Batista was to restore democracy to Cuba.

What he has actually imposed—at least temporarily—is another dictatorship. His government has dismissed Congress and announced it will rule by decree for 18 months, after which elections can be held.

No observer in Washington can say whether such delay is justified or not. But Castro's tactics since his victory—in approving mass execution by firing squads of Batista followers and in his violent attacks on the United States—raise questions.

Was his long fight against Batista simply that of a patriotic but emotional man who lacked the vision to plan long-range for orderly government? Or was he practical enough to do such planning?

His angry outbursts against the United States seemed prompted by American criticism of the mass executions.

He repeated charges—quickly denied by the State Department—that the United States provided arms and aid to Batista's defeated forces.

The Pipe Maestro Speaks

Why do pipe-smokers prefer their pipes to any other form of smoking?

The question came up the other day, in a casual sort of way. "Really," we asked, "why smoke a pipe?"

Don Schlenz, "Mr. Pipe" of The Daily Reflector came up with a variety of answers. "I can think of several reasons," he said, "one of them being that a pipe smoker is a bit of a poseur . . . another, that he is also smart; he also has a craving for stronger smoke than wisps of paper and light tobaccos can provide."

"He avoids the loose crumbs of tobacco that work loose from the non-filtered fags and the pipe stem gives his teeth something substantial to clamp down on. In the course of his conversation, he has tried cigars; but, in biting them, he also picks up a mouthful of tobacco."

That should have been enough of an answer, but Schlenz wasn't through.

"Why smoke a pipe? Well . . . Because pipe smokers prefer that frank, open-eyed and contemplative gaze . . . not the smoke-squinted, shifty look. It's no idle gossip that you don't find pipe-smokers among the top ten wanted by the FBI. Because of their mild dispositions, because of their native shrewdness, because they just plain look honest, they (pipe-smokers) are seldom even indicted."

Satisfied that he was far, far away from the long arm of the law and the cold walls of a prison cell, Schlenz leaned back. He re-lit his pipe, took a few puffs, cleared his throat and claimed the floor again.

"Why smoke a pipe? Because the true solace of good tobacco stands up for what he says and take his punishment whatever it might be. If he has any conscience he must feel pretty bad as Miss Torre serves in jail for defending him."

Miss Morre, instead of a man reporter, happened to be one sentenced by a New York federal to a jail term of 10 days for refusing to tell the court the source of her information for an article she had written about Judy Garland, which jarred the pride of the actress. Her newspaper, the Herald Tribune, stood behind her in the position she had taken and helped her in the court fight.

MIKOYANIK TO MISS U.S. (Greenville (Miss.) Delta Democrat-Times)

Anastas Mikoyanik, the Soviet deputy premier who arrived in the United States Sunday for a two week look-see and conferences with top officials, will miss the thing he needs most to see.

His itinerary includes New York, Washington, Philadelphia, Chicago, Detroit, Cleveland, Boston, Dallas, San Francisco and Los Angeles.

But to see how democracy and the capitalist system have developed this country, Comrade Mikoyanik should come to the small towns like Hollandale, Leland, Greenville or their counterparts in other parts of the nation.

TAILS THEY LOSE
Meanwhile, the California Supreme Court has ruled that a company who sent an agent into the state to negotiate contracts with local distributors thereby become liable to state corporation taxes.

California has a neat legal device. If you appoint a legal agent in the state, you are liable for taxes. If you don't have a legal agent, the state can get a default judgment against you, because you cannot defend yourself in court.

Florida has levied taxes on a corporation that had contracts with jobbers there, but no other operations. Georgia tried to levy taxes on an Alabama company whose salesman spent a third of his time in states and promotional work in Georgia. Minnesota taxed an Iowa company that maintained five salesmen and a secretary in Minneapolis, although orders were accepted only in Iowa, and filled from inventories there. Louisiana taxed the Brown-Foreman Distillers Corp. although the company merely shipped goods into the state and maintained promotional men who helped wholesalers.

The last three cases have been taken to the Supreme Court which will eventually spell out how far states can go in taxing corporations based elsewhere.

At present, corporations sometimes pay two and even three state taxes on the same profit or revenue, this in addition to Federal taxes.

But even more troublesome is the fact that there is no uniformity in state levies. Almost every state has its own formula, levying corporation taxes on bases of property, payroll, sales, manufacturing costs, cost of sales, shares in other corporations, accounts receivable, purchases, manufacturing costs, loans wages or interest, or combinations of two, three or more of those factors.

Bigger Gems Retire

NEW YORK (AP) — Diamonds may be a girl's best friend, but recently some of the world's most fabulous gem stones have been getting mighty chummy with governments, museums, foundations, commercial firms and businessmen whose worn interest is scarcely sentimental.

Retirement of the famed, 44-carat blue Hope diamond to a lighted niche in the Smithsonian Institution is but a signpost on the path toward a new function for historic and out-sized gems.

Whereabouts of many famed gems are unknown, but it is hard to name more than two famous diamonds which might still be considered "working stones" owned and worn by private citizens. One is the 54-carat Sancy, once property of Elizabeth I of England, and now in the tiara of Virginia-born Lady Astor. The other is the Nassak, 43-carat stone which turned up in a Hindu temple in India and now the property of Mrs. William B. Leeds, wife of a New York millionaire.

Experts know that the Soviet Union has a fabulous gem collection — but how large, and exactly what it contains is pretty much of a mystery. Certain famous stones, like the Orloff diamond, are known to be in it.

King Farouk, a gem collector, managed to take some stones with him on his speedy departure from the throne, but the Egyptian government hung on to the prize of his collection: the 125-carat Jonker.

At the time of the French Revolution, the royal treasury was robbed of many famous, important jewels. Most were never recovered, and for years this or that stone, turning up with a new cutting, has been rumored to have been originally part of the royal loot. However, the Louvre sports an impressive gem collection including notably the Regent, a 140-carat stone considered one of the finest diamonds in the world.

Great Britain, of course, has the biggest, best known and most popular collection of state jewels on earth. There are on view at the Tower of London and seen by almost half a million persons a year, included in the collection are the huge stones cut from the Cullinan, the largest diamond ever found, and the ancient Koh-i-noor.

In the less sparkling world of stones with few carats, more women than ever are wearing diamonds. One survey recently indicated that 85 per cent of all brides today sport diamond engagement rings — and that 11 per cent of all engagement rings sold are for ladies who have been married for 10 or more years.

With more and more precious stone wearers in the country, who are the ones interested in the big, famous and historic gems?

"They are a constantly changing group," said one student of gem history. "Two hundred years ago, fabulous gems were bought by the rich with the idea of giving them to their families or — more likely — to the church. A hundred years ago, they were bought by people who wanted to put them away — a hedge against disaster."

"But 50 years ago, people started buying these jewels with the idea of putting them on their wives and lady friends, to let the world know how prosperous they were. But now the idea seems to be to buy them, put them in a show case and let everybody take a look at them. It's a healthy trend — anyway, more people can see them and admire them."

State Taxes Heading For Clash

Until recent years state corporation income taxes have been applied only to corporations maintaining some permanent establishment in the state, Paul Studenski and Gerard J. Glasser write in the latest Harvard Business Review under the title, "New Threat in State Business Taxation."

"Since the end of World War II, however, several states have altered their statutes or have interpreted them to extend the application of their corporate income taxes to out-of-state corporations that neither own nor operate properties there nor maintain any permanent establishment authoritatively representing the company. . . . At the same time, quite a few states have altered their existing allocation formulas by substituting sales-by-destination or sales-by-site-of-solicitation criteria for the more conventional receipts factor, or else by modifying some other factors," they state.

Notable Drop In City Fire Losses

Fire losses for 1958 amounted to \$79,970.39, a considerable drop from the 1957 losses, Fire Chief George Gardner reported.

The chief noted that the losses for the preceding year were set at \$132,440.64. Losses last year were \$62,537.25 below 1957.

There were 70 box alarms during 1958, 37 false alarms, 233 telephone calls to fires and 74 county calls. A truck was also sent to Washington to assist in a major fire there.

The Rescue Squad's ambulance was called out 224 times last year. Thus a total of 638 calls were answered by equipment in the city's two fire stations.

Value of the structures and contents involved in fires during the year was estimated at \$1,535,528. A total of \$1,218,650 in insurance was carried on the fire-threatened property.

For December the department answered three box alarms, one false alarm, 25 telephone calls to fires, four county calls, burned off two lots, and 23 rescue calls. There were a total of 57 calls for the month.

The volunteer payroll for December was \$69 and for the fiscal year \$735.

Chief Gardner pointed out that there were no major fires during the year and as a result, losses were low.

He expressed appreciation to the press, television, radio, schools, Chamber of Commerce and the public for their efforts in furthering fire prevention during 1958.

Apartment Fire Today Causes Moderate Loss

An apartment at 904A Travis Lane received moderate damage around 10:30 this morning when fire broke out in a room of the house.

The apartment is occupied by D. Whichard and rented by Grier Rental Agency.

Firemen said no one was at home at the time fire broke out. The cot and a chair were damaged by the flames which also burned through door.

Smoke from the blaze filled the house.

Earlier this morning at 9 o'clock firemen were called to the home of E. L. Garris at 305 Ashe St. when a space heater caught fire. A small hole was burned in the floor and there was soot damage to the walls.

Late yesterday afternoon at 5:25 p.m. a truck was sent to Peoples Bakery when an oven caught fire. The blaze was extinguished with baking soda.

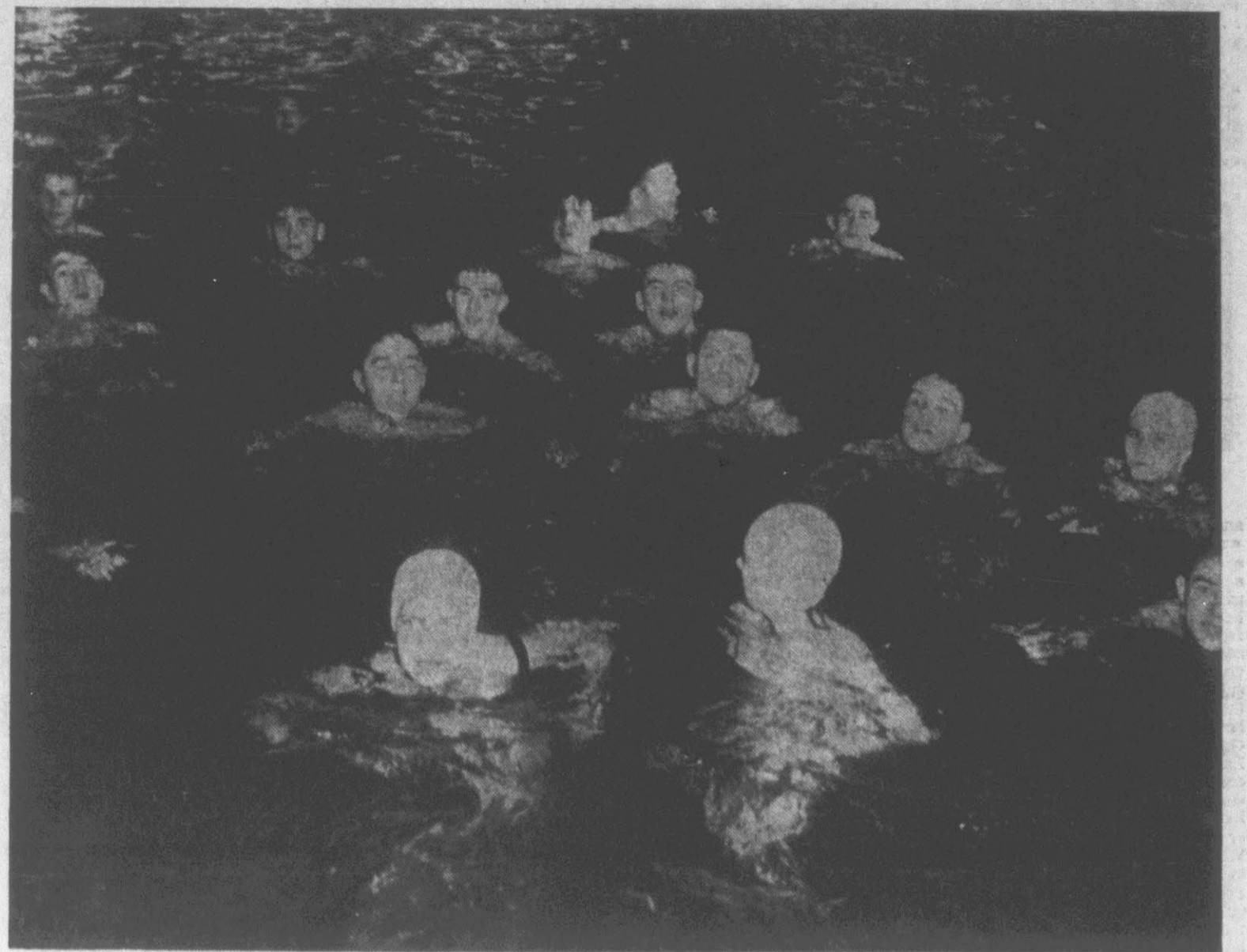

January, particularly a January such as the one Pitt County is enduring now, is not generally recognized as the year's most popular month for swimming.

Even when swimming pools are enclosed, filled with heated water and made as comfortable as possible, there is often a psychological element which keeps many swimmers out of the water. The psychological element insists that swimming is not a cold weather sport.

As a result, many swimming pools are warm weather assets and cold weather liabilities.

To a certain extent, East Carolina College's Memorial Gymnasium pool could be placed in the "cold weather liability" category. It could be put there because it's obvious that the pool isn't as crowded in the winter months as it is in the hot, muggy days of summer.

The actual extent to which ECC's pool could be called a cold weather liability is questionable, however. It's a year-round favorite with students, staff and faculty members, and others connected with the college.

As a matter of fact, there are some days in the cold weather season when a swimming enthusiast might have a little difficulty finding enough room to practice his swimming techniques.

Although it is available for use only about five full days a week, the pool is used by an esti-

mated 400 people weekly. That includes about 300 students in nine classes, members of the ECC swimming team, faculty and staff members (and their children), participants in special classes for townspeople, and other students who use the pool during periods.

According to Ray Martinez, ECC swimming coach and chairman of all pool activities, the response to availability of the pool is "very good." Every day, Monday through Thursday, it is used constantly from 7 a.m. through 5 p.m. On Mondays and Wednesdays, the hours are extended to 6 p.m. and a half-hour later than that on Tuesdays and Thursdays.

On Fridays, when the pool is closed during the morning hours for cleaning and backwashing, the pool opens at 1:30 for recreational swimming and remains open until the swimming team completes a two-hour workout at 5 p.m. It is reopened at 7 p.m. for a three-hour period available to Boy Scout groups.

On Saturdays, beginning today, the pool opens at 8:45 for two one-hour swimming classes for townspeople and remains open until 12:30 when the swimming team winds up an hour-and-a-half of practice.

The pool is not open on Sundays. Response to the pool's availability is not limited to the "we-have-to-respond" groups of students who take swimming classes. The college's swimming team, a volunteer outfit which won the 1957 national champion-

ship of the National Intercollegiate Athletics Association, has 18 members.

Faculty and staff members, and their children, "respond well" during the hours the pool is available to them, according to Martinez. In addition, he says there has been "good response" to water safety classes taught with the auspices of the Pitt County Chapter of the American Red Cross.

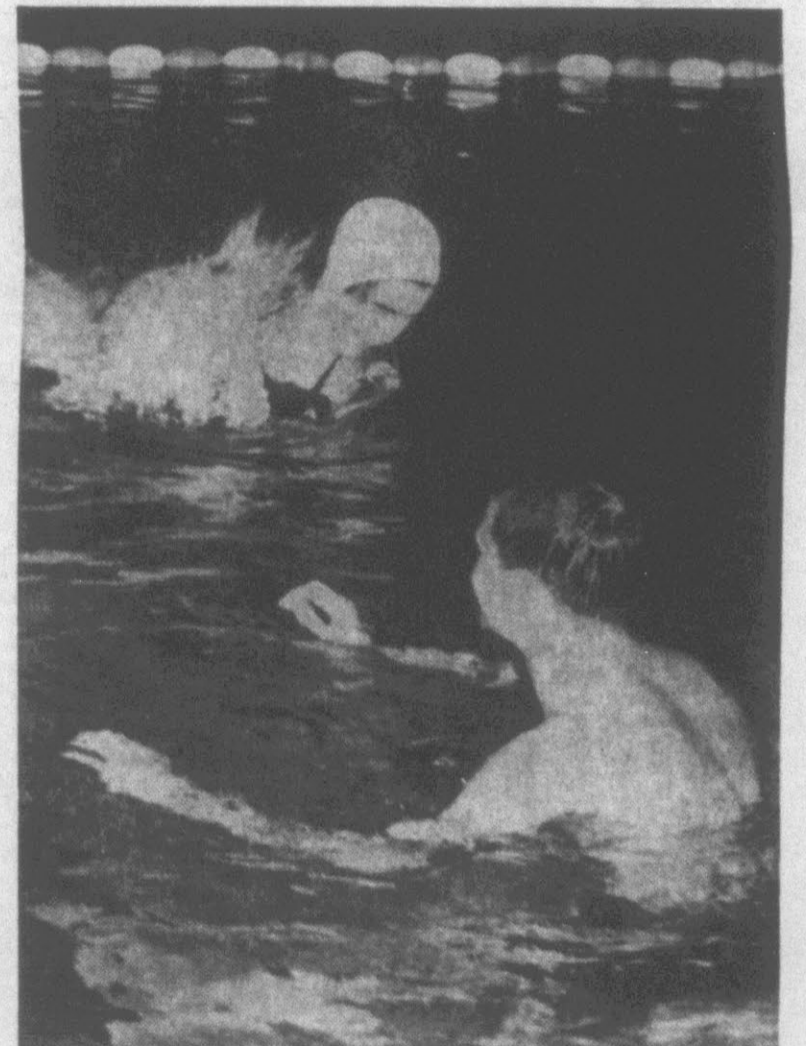
The response from students, particularly, has been so great, that plans have already been made to add intermediate swimming and water safety classes to the college curriculum next quarter. In addition, volunteer student groups, such as the "Aqua Nymphs," a precision swimming group, are growing steadily.

Martinez believes the Saturday swimming classes, such as those which opened today and which have room for additional persons, can become "outstanding."

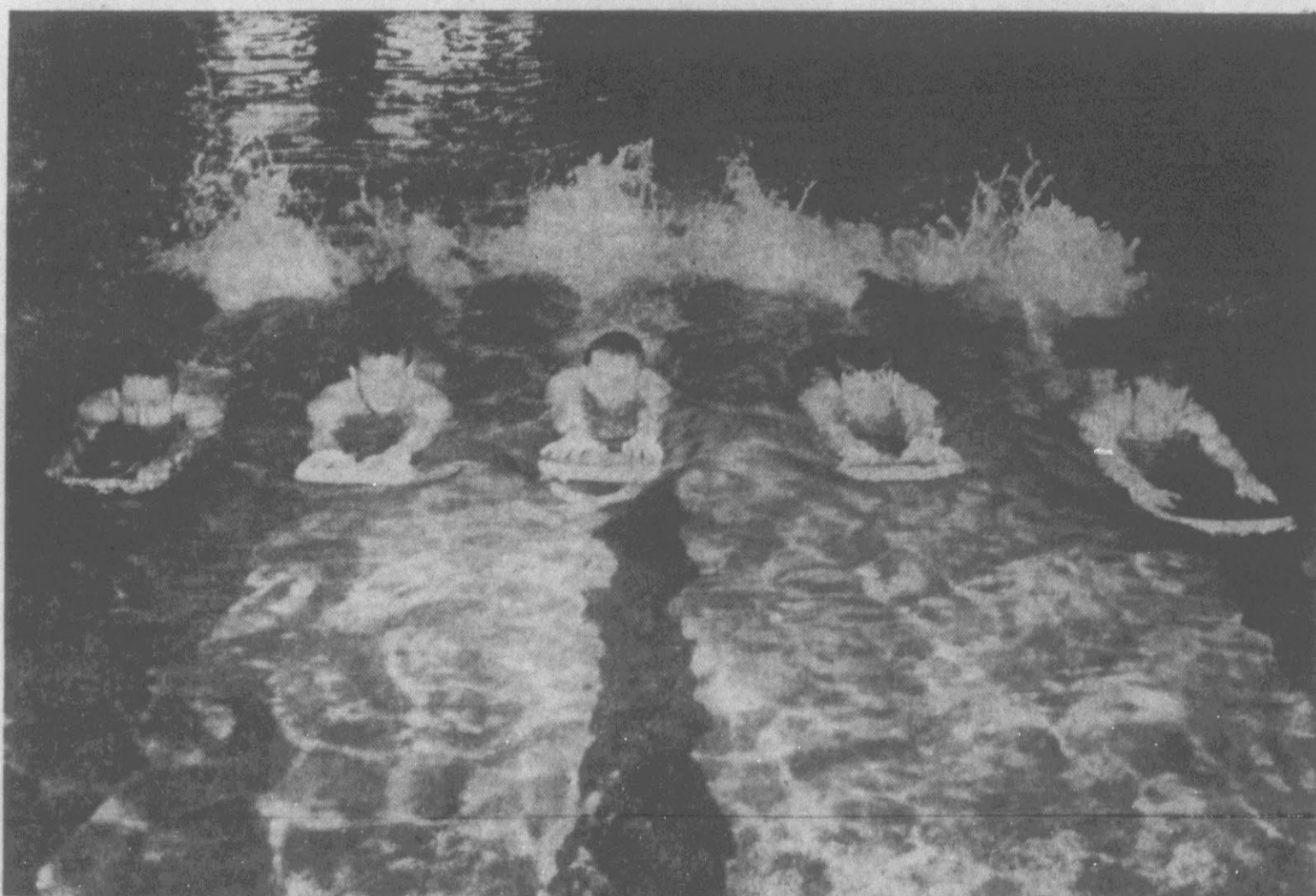
"We have," he says, "exceptional instructors who are qualified in every phase of swimming and water safety. They permit a well-rounded program of swimming and safety instruction for just about every interested person."

Most of the folks who use the pool regularly are already convinced that it's a good thing. They pay no attention to the weather outside, get the kinks out of their muscles and relax, regardless of the time of year.

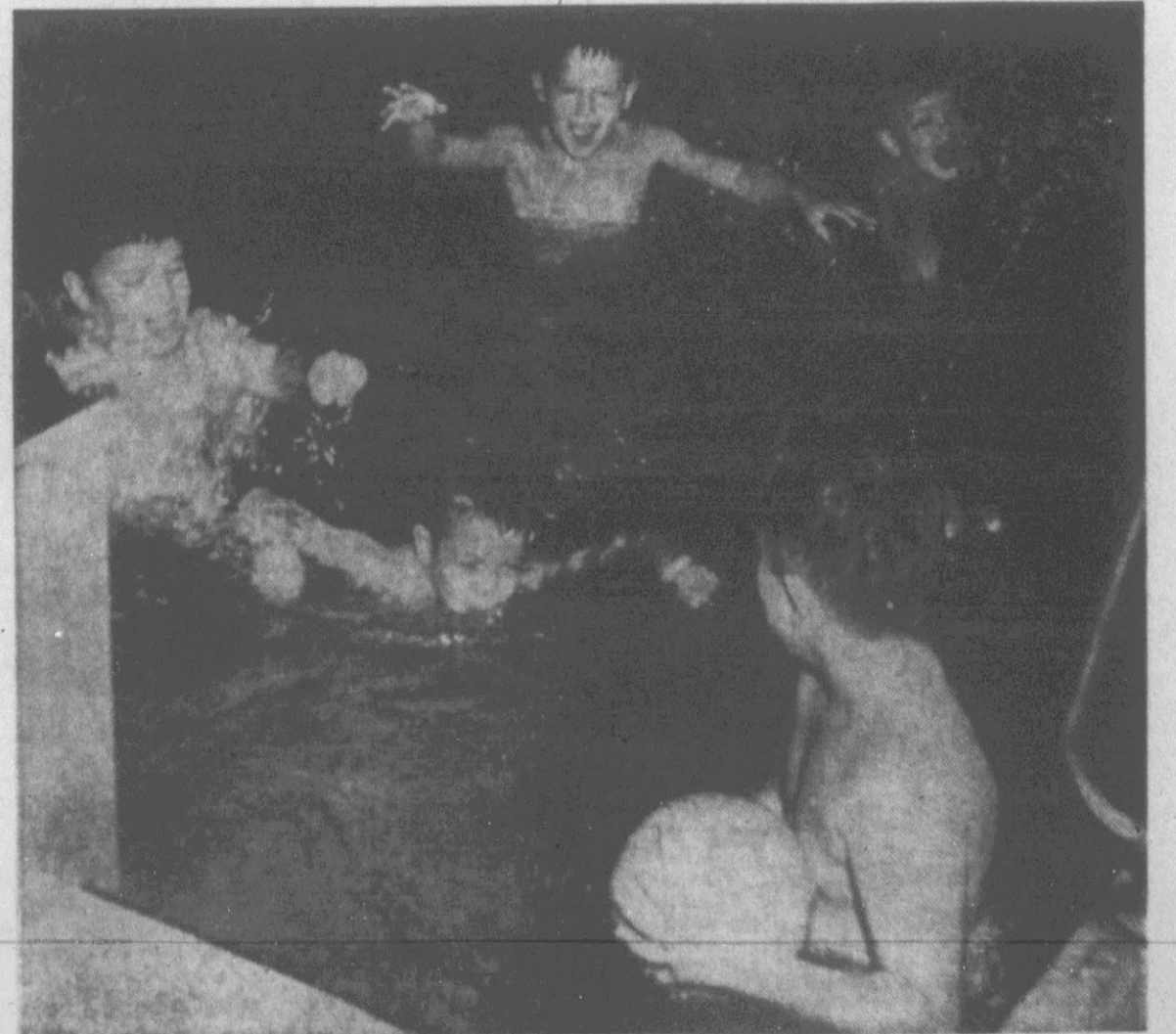

CHILDREN OF FACULTY AND STAFF MEMBERS . . . Enjoying A "Warm Weather Sport" In The Middle Of January

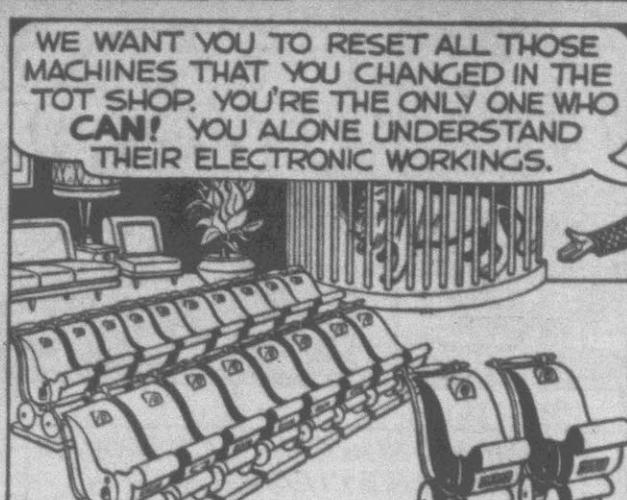
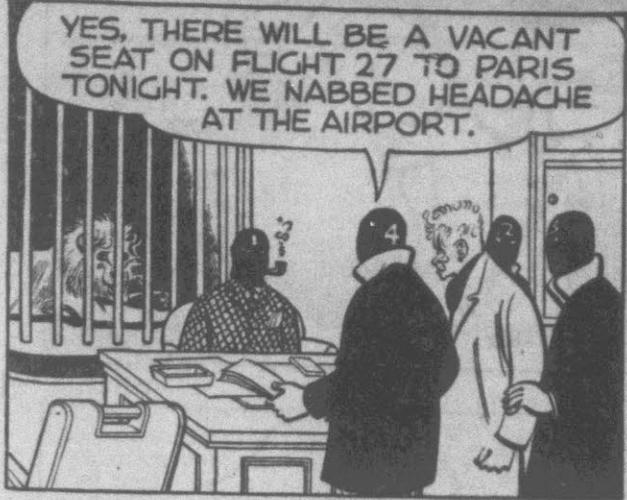

Out Of Prison To See Funeral

CHARLOTTE (AP)—The mother of seven children, sent to prison for neglecting them, will attend the funeral of one of her children today. She flew here with the help of money donated by Charlotte policemen, and will return to prison, unguarded, after the services.

The child who died was 5-year-old Jewell Ann Miller, whose father, Lonnie, is a part-time stevedore for a trucking firm. The mother, Mrs. Louise Miller, 42, was sentenced in December to six months for neglect. Officers said she likely will be released before then for good behavior. Meanwhile, the father and the children are living with his mother.

Little Jewell died Thursday after surgeons operated on her heart, trying to lengthen her life. Police Sgt. Jack Wallace told the story to men of the patrol division. They dug into their pockets for change and small bills. Their contributions bought a plane ticket and the mother, unattended, arrived here Friday. The warden said she had been a model prisoner.

The woman's other children will be at the funeral, the police, who found that none of them had clothing in suitable for the services, bought them outfits with money left over from the collection and with Salvation Army funds.

ST. AUGUSTINE, Fla. (AP)—The bells of scores of Florida Catholic churches will ring in protest Tuesday when Soviet Premier Anastas I. Mikoyan visits the state.

Gov. LeRoy Collins and Mayor Nick Nucchio of Tampa have asked that Florida be courteous to the visitors. Several persons representing several hundred Hungarian-Americans in central Florida announced they will demonstrate "in spirit" against the Soviet official.

The Rev. Louis G. Novak, pastor of the Hungarian United Church of central Florida in Lakeland, announced the silent demonstration. Suspend Four Students For Off-Campus Party

Four male students at East Carolina College have been suspended for the remainder of the Winter Quarter as a result of an off-campus party last Saturday night.

Dr. John D. Messick, president of the college, said the students were ordered dismissed after ECC's Discipline Committee found them guilty of conducting an unchaperoned party in an off-campus residence rented by the four men. About 50 persons, not all of them college students, were present at the party, according to Dr. Messick.

The four men, who were not named by Dr. Messick, have already withdrawn from school. They will be permitted to return Spring Quarter, providing they do not have automobiles, do not room together, have all campus social privileges withdrawn and conform to other provisions of probation set by the college.

Other students involved in the party, at which Dr. Messick said mixed drinks were served, are to appear Tuesday before the Discipline Committee, a student-faculty group. As a general rule, findings of the committee are not announced publicly.

Dr. Messick said the party came to the attention of college officials when other persons in the neighborhood complained to Greenville police about loud talking and laughing in the house. City police notified campus police, who, in turn, notified Dr. James H. Tucker, Dean of Men at East Carolina, and dormitory counselors.

The college personnel went to the house, with city police, and found the party in progress, Dr. Messick said. He added that no misconduct, other than drinking, was observed.

Dr. Messick said the party was not a fraternity function and the house in which it was held is not connected with any one of the college's fraternities. He also said that an effigy of Dr. Tucker, found hanging on the campus during the weekend, was not connected "in any way" with the intervention of college officials in the party.
