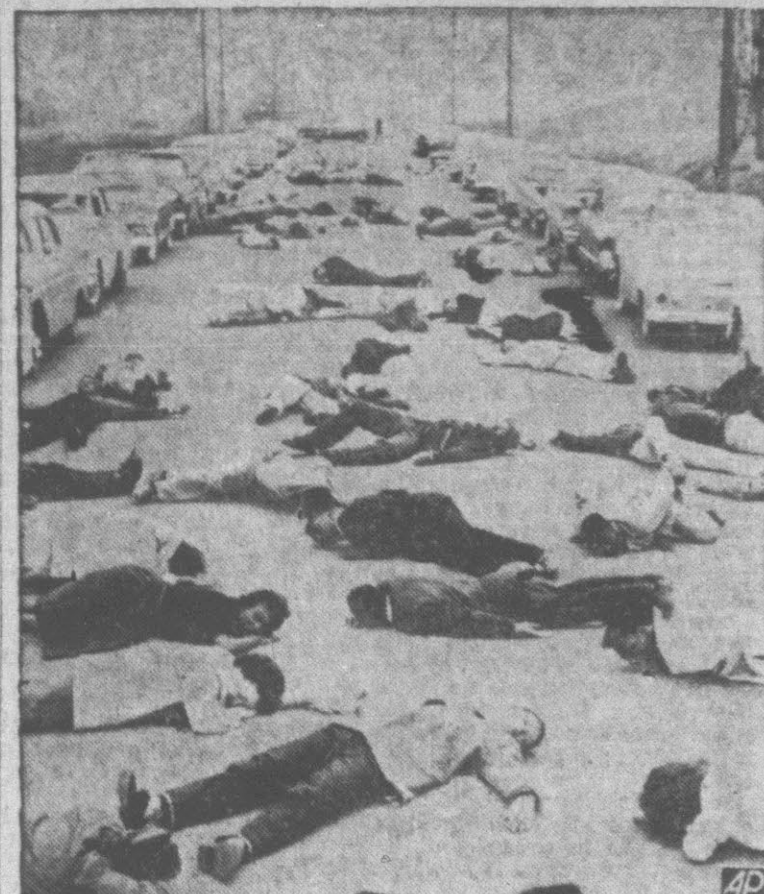

Virginia's School Segregation Plans Feel More Blows

RICHMOND, Va. (AP) — Two federal courts in separate rulings struck new blows at Virginia's crumbling anti-integration program Friday by strengthening desegregation orders for Arlington and Norfolk schools.

The U.S. 4th Circuit Court of Appeals ordered Arlington County officials to admit four Negro children to the all-white Stratford Junior High School Feb. 2 — the start of the new term.

The ruling upheld U.S. District Judge Albert V. Bryan's Sept. 2 decision that the transfer of the four students from a Negro school was denied on the basis of race.

At about the same time, a special 3-judge federal court issued a permanent injunction prohibiting state officials and Norfolk school authorities from closing any public school or grade solely because of integration while other schools are kept open on a segregated basis.

Members of the Arlington School Board said there would be no automatic switching of white pupils to avoid integrated classes if legal efforts to avoid integration prove fruitless.

The strongly worded injunction in the Norfolk case seemed to imply that City Council's announced intention to shut down all grades above the sixth, effective Feb. 1, will be declared illegal when it comes up for a hearing Monday.

Gov. J. Lindsay Almond Jr. said "The situation is very serious." He has been holding an endless series of conferences with legal aides and legislators on a new program of resistance.

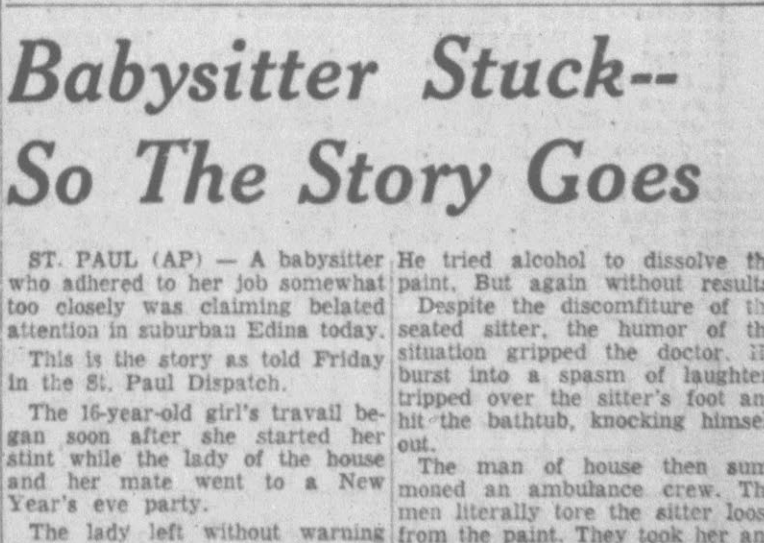

# Tiny Log Church Stands In Arctic

ANAKTUVUK, Alaska (AP)—A small log church, deep in a treeless Arctic waste, stands as a symbol of a new-found faith in God, and of the curious fulfillment of an ancient prophecy.

From earliest times, the tale was passed down through generations of the Nunamut, or inland Eskimos, that a Deliverer would come to them and he would be Ataanik, or Lord.

So when the Rev. William C. Wartes, a Presbyterian missionary, landed his single-engine float plane on the lake at Anaktuvuk Pass and introduced himself, the villagers nodded knowingly. "What took you so long?" they asked.

The Nunamut also had been told Ataanik would come when the tundra was covered with Katuk, the Eskimo word for containers. This part of the prophecy came true also.

The U.S. Navy had explored for oil in the Brooks Range. Vast expanses of tundra were dotted with 50-gallon oil drums left behind when the Navy abandoned its search for oil.

The Rev. Mr. Wartes first visited Anaktuvuk, about 300 miles southeast of Point Barrow, in 1952. On frequent flying trips he taught the villagers the lessons of the Bible. In the summer he held services outdoors; in the winter, in sod huts.

It was his dream to build a log church in the isolated little village 2,300 feet up in a saddle of the Brooks Range along the migration route of the caribou.

But the difficulties seemed almost insurmountable. The timberline was 25 miles down the John River on the south slope of the Brooks Range. Suitable stands of spruce were another 10 or 15 miles beyond.

Men were few and the logs could only be transported by dog sled when the river was frozen. Tools and equipment had to be flown in, piece by piece, from Barrow. The villagers, however, were thrilled by the thought of having a church building of their own.

Last spring, 14 village men pledged their strength and dog teams to haul the 275 logs needed for the chapel. The Rev. Mr. Wartes brought in carpentry tools and a chain saw.

Then began the laborious chore of felling trees, cutting the logs to size and packing them by dog-sled 30 or 35 miles up the frozen river. Some were so heavy it took four men to load them on the sleds.

As warm weather began to melt the snow and ice, logs had to be carried the last several hundred yards by hand. For a time, the Rev. Mr. Wartes feared the logs never would be collected by the time he had completed his Alaskan mission.

He had climbed into our sleeping bags the night before with the dogs howling and we wondered how strong they would be the next day on empty stomachs. Then came the caribou. When we awoke they were all around us. It was simple for the men to replenish completely depleted food supplies.

Finally, all the logs were gathered. Slowly through the summer the 17 1/2-by-24-foot church took shape. Handmade benches had a seating capacity of 60. A five-foot annex in the rear held a pulpit, a small organ, and the communion table.

The chapel was dedicated in September after the Rev. Mr. Wartes, his wife, and their six children had returned on furlough to Seattle.

Behind him he left 43 converts—nearly half the Nunamut band of 89—in the hands of his replacement, the Rev. John Chambers of Scotia, N.Y., and the village postmaster, Homer Mekiana, ordained a church elder last spring.

He also left behind the cozy little log church, the first ever built by Alaskan Eskimos on the treeless slopes beyond the Arctic Circle, and a symbol of a prophecy fulfilled.

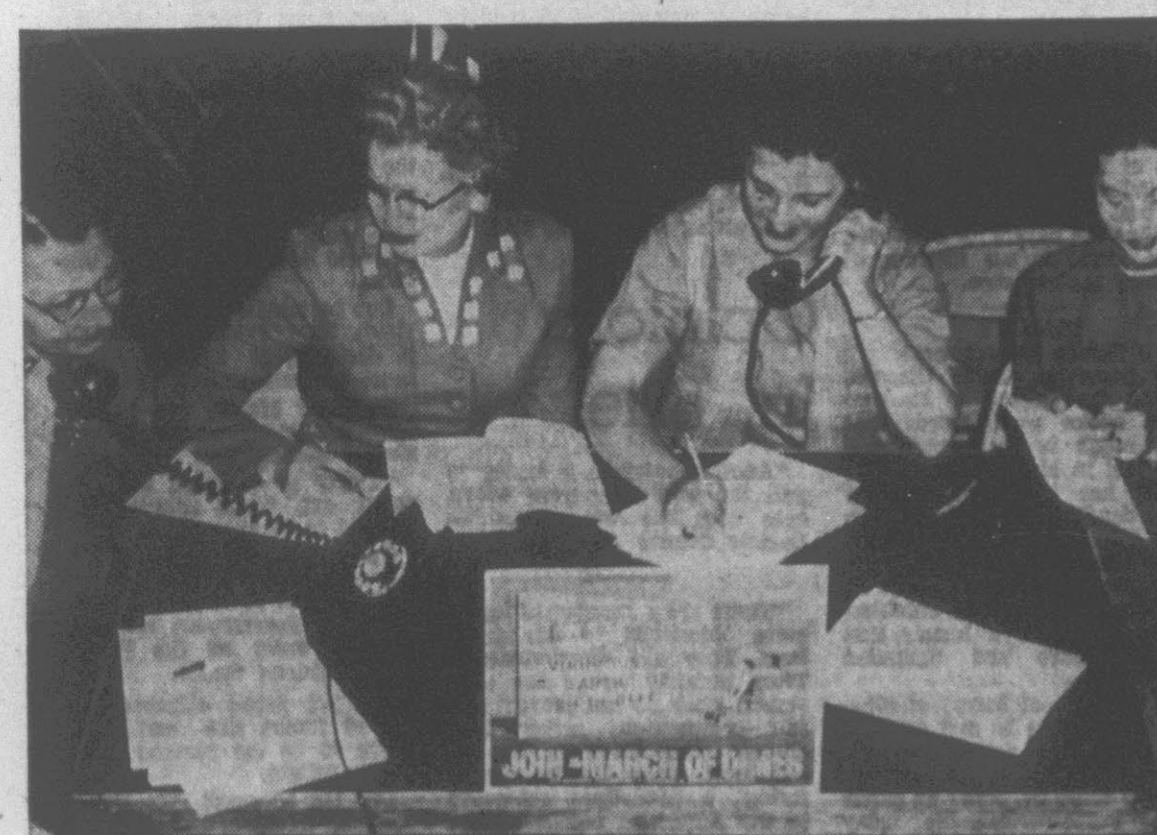

# Compromise Bid To Be Studied

Senate Majority Leader Lyndon Johnson's civil rights proposal brought surprise and adverse comments from both sides in the Senate and it has even brought a reaction from the White House.

If there is any real significance in the four-point program offered by Johnson, it lies in furthering his role as a Congressional compromiser rather than offering something genuinely constructive in the approach to the question which has brought both self-styled "liberals" and conservatives to the feet many times in the past few years.

Johnson's proposal, like all other so-called civil rights legislation, should receive the same reaction from the Southern delegation of Congress as other proposals under a similar label have received. It obviously is more political than constructive in nature. While on the surface it would do little harm, there is nothing to indicate it would do any good in the field that has been called "civil rights."

If the Southern delegation elects to acquiesce to Johnson's proposal, it can only be before the purpose of accepting the proposal as a compromise in order to prevent more radical civil rights proposals from receiving favorable consideration during this session of Congress.

Even so, Southern acceptance of the Johnson proposal would represent a retreat from the adamant stand the delegation has previously taken against unne-

sary and unwise legislation proposed under the politically potent "civil rights" label. Whether such a fight by the Southern wing of the Democratic party would be successful is a matter of conjecture. Johnson's strength and influence in Congress cannot be minimized. It may prove expedient for the Southern delegation to side with Sen. Johnson on this matter.

But before final decision is made, the Southern delegation should make every possible evaluation of its possibility of success if it decided to combat to the last ditch the Johnson proposal.

## A Rule Worth Having Is Worth Enforcing

There may be adverse reaction from various parts of North Carolina over the suspension of a total of 55 students from East Carolina College as a result of an unchaperoned party off-campus recently.

Though adverse reaction may come from parents and friends of the suspended students, as well as from the student body itself, the student-faculty discipline committee of the college had little choice but to order punishment for the breach of conduct rules laid down for students. And the college administration had no choice but to uphold the suspensions.

Had greater leniency been followed in dealing with these students for their breach of regulations, it would only have encouraged rather than discouraged similar breaking of long standing rules among the student body.

College students are going to have parties and are going to have a good time. And there is nothing wrong with that. They are entitled to good times, to parties, and to letting off steam. Yet the student conduct rules at East Carolina and other colleges provide ample latitude for such actions. It is only when conduct rules are disregarded that punishment is meted out to students. And they should expect as much.

In this particular case the infraction was over the provision that even off-campus parties should be chaperoned. And few people would argue that it is not a good rule.

If a rule is worth having, it is worth enforcing.

The discipline committee, made up of faculty and students of East Carolina College, and the administration, are to be commended rather than condemned for enforcing the rule with discipline against those who broke it. They are to be admired for not making an exception to the rule simply because an unusually large number of students were involved.

# Profit-Making And Service

**BANKS** — There are some interesting sidelights at a meeting of the State Banking Commission, the agency which licenses banks to operate and supervises their activities. Banks, like power, telephone and transportation utilities, are designed to be profit-making and also are required to render certain basic services. The regulatory commissions have obligation to see that these services are rendered. They also recognize responsibility to assure reasonable profit to investors in the enterprises.

The Banking Commission at its meeting this week had eight applications for establishment of branch banks. In each case it was obvious that the Commission was mainly concerned with service, while the petitioning bank was primarily concerned with profits. That was illustrated by the fact that when essential need for the service had been established, the final question was "Do you think this operation will be profitable?" In every instance the banker said if he didn't think it would pay off he would not be interested in it.

Seven of the applications were approved. One was denied on the grounds that while it might be profitable itself its operation probably would render unprofitable some other authorized unit.

**HOGS** — One application demonstrated a relationship between banking and hogs. (No facetiousness intended.) One item listed by Attorney Al Butler in support of his contention that Clinton needed additional banking facilities was that last year farmers of Sampson and adjacent counties were paid nine and a half million dollars for hogs sold on the market there. Larger and smaller amounts paid for other commodities such as cotton, tobacco, vegetables, etc., apparently did not impress the banking commissioners as much as that hog item.

**PAR-CLEARANCE** — The upcoming Legislature will have to face the issue of whether to require by law all banks to clear checks and drafts at face value or to permit those which desire to charge exchange fees against the recipient of the check. In legal terminology these practices are termed par and non-par.

To limited degree the issue was injected into the Speakership race several weeks ago, with Addison Hewlett generally regarded as favoring par clearance and Carl Venters favoring the non-par, or exchange, policy. Both candidates have disavowed the general alignment.

Certainty that the issue will be presented to the General Assembly was established when the State Banking Commission this week declined to adopt a resolution offered by Don Elias, vigorous champion of par clearance, but did authorize a com-

mittee to prepare a resolution to be acted upon at a special meeting, requesting an act abolishing non-par banking. Attorney General Malcolm B. Seawell is chairman of that committee, and since he is known to be an advocate of par clearance the tenor of the resolution can be safely predicted.

Advocates of the non-par practice insist that many banks could not operate without the exchange fee. Opponents concede that in many instances a charge is proper, but insist that current practice puts the cost on the wrong party. The person or firm that writes the check and employs the bank as its agent to deliver the money should pay the charge, rather than the recipient—who is entitled to receive the full amount due him.

It isn't a major issue, and has no earth-shaking implications, but in several previous sessions it has occasioned some bitter legislative fights.

**DUPLICATES** — There are only two name pairs in the membership of the Senate, meaning that only four times will the reading clerk have to designate residence of the senator on the roll call. These are Currie (Claude) of Durham and Currie (Wilbur) of Moore; and Morgan (Robert F.) of Cleveland and Morgan (Robert M.) of Harnett.

The House reading clerk will have to designate residence of members 18 times out of 120, although there are only seven pairs of identical names. These are Britt of Bladen and Britt of Robeson; Crawford of Buncombe and Crawford of Swain; Davis of Lenoir and Davis of Rutherford; Hill of Catawba and Hill of Durham; Holcombe of Madison and Holcombe of Yancey; Jones of Ashe and Jones of Pitt; Woodard of Northampton and Woodard of Wilson. Spelled differently but pronounced the same are Harris of Rowan and Harris of Wake. Sounding enough alike to require county designation are Murphy of Pender and Murphy of Halifax.

The Crawfords are brothers, while Holcombe of Madison and Holcombe of Yancey constitute an unusual father-son team. There are six family names represented by one or more members in each branch — Jordan of Buncombe (House) and Jordan of Wake (Senate); Bell of Carerette (H) and Bell of Mecklenburg (S); Whitley of Wake (H) and Whitley of Johnston (S); Thomas (H) of Johnston and Thomas (S) of Union; Lockett (H) and Lockett (S) both hail from Alexander, and Williamson (H) and Williamson (S) both live in Columbus.

The Davis family with a Senator from Forsyth and Representatives from Lenoir and Rutherford is the only one with three members in the General Assembly.

# Up Four Times And Struck Out

**WASHINGTON (AP)** — That hardy little congressional band called liberals tried to throw their weight around, found out in a hurry they were underweight, and got smacked down four times in a row.

Yet the liberals' failures can't be dismissed as something absolute. They didn't lose entirely. There are an active and vocal force, even if very often they miss achieving their goals. They make their presence felt and have an influence on events.

But those post-November election predictions, when Democrats swamped Republicans, didn't come off. Then it was thought new blood and more liberal men would be a big pain to the conservative leaders of Congress.

These were the four liberal bumps on the head:

No. 1, first target for the bloc of Democrats and Republicans bearing the liberal label was the Senate rule which made it almost impossible to break a filibuster — the talkiest Southern Democrat traditionally relied on to stop a civil rights bill. Under this rule debate couldn't be stopped unless a constitutional two-thirds of the Senate — 66 of the 98 members — voted to do it. With Sen. Paul Douglas (D-III) leading the charge, the liberals set out to change this rule.

Douglas proposed that a simple majority of the Senate — 50 of the 98 members — be enough to stop a filibuster. Sen. Lyndon Johnson of Texas, leader of the Senate Democrats, called Douglas's hand.

He let the Douglas proposal come to a vote — at a time when there was no filibuster to overcome — and the result was a staggering 67-28 against letting a majority of the Senate stop a filibuster.

Yet in the end the rule was

changed just a little. Under Johnson's guidance the Senate changed the rule to require hereafter a simple two-thirds of those present at voting time.

No. 2, a group of Senate Republican liberals tried to get one of themselves chosen leader of Senate Republicans. They wanted to keep a conservative like Sen. Everett Dirksen of Illinois from getting the job.

So all 34 of the Senate Republicans voted. The liberals were outnumbered. The majority picked Dirksen. But the liberals here, too, got a concession. One of their number, Sen. Thomas Kuchel of California, was named assistant leader.

No. 3, once again the liberal Senate Republicans made a try. This was to keep the highly conservative Sen. Barry Goldwater of Arizona from being chosen chairman of the Senate Republican Campaign Committee.

Again they lost. A majority picked Goldwater who frankly says he is so conservative that "I'm even a stronger conservative than people think I am."

No. 4, On the House side a batch of liberal Democrats and Republicans made noises about something they wanted. They wanted changes made in or about the House Rules Committee whose Democratic and Republican membership is highly conservative.

This is one of the most powerful committees in Congress and can pretty well prevent legislation from coming out for a full House vote when the members don't like it.

But this minor liberal revolt was squelched under the persuasion of Sam Rayburn, speaker of the House and boss of the Democrats. He reportedly assured the liberals, however, that he'd personally see to it that no worthwhile legislation gets buried in the Rules Committee.

They wrestled into the living room and the gun went off, the bullet smacking into the ceiling without hitting anyone.

Switzer, according to Stiltz, got possession of the gun briefly but Stiltz got it back. Switzer drew a knife and screamed, "I'm going to kill you, you s.o.b.," Stiltz said. "I took the gun away from Alfalfa and he threw the knife at me," Stiltz said. "That's when I shot him."

Switzer had been down on his luck since making the child

To avoid this irritant, exporters can get details from nearest Department of Commerce field office, or by sending a dime to the Department of Commerce, Washington 25, D.C., for "Marketing and Labeling Requirements of Canada."

Furthermore, the department managers should be in full charge of the sales personnel, and should

be responsible for the training. At present, personnel departments usually assign salespersons to sales departments and the buyer has little to say about it. Besides, she's probably off to New York lining up post-Easter specials.

WANTS FUNCTIONS DIVIDED  
If the buying and selling functions in department store organizations were clearly defined and divided so that the responsi-

bility for proper performance would be definitely fixed and the full benefits of specialization attained, the quality of selling in department stores might increase substantially.

# Other Editors Saying . . . A Matter Of Economy

(Rocky Mount Telegram)

North Carolina's highways have long ranked with the rest of the nation in quality as well as the level of maintenance. For these accomplishments we have every reason to be proud. But representatives of the state's highway construction industry claim a scientific test shows that North Carolina is spending 19 per cent more than it should on highway maintenance.

What does this mean to the average citizen if these claims are true? Well, primarily it means more tax money spent. Then there is also the question of quality of workmanship in highway maintenance. If it costs 19 per cent more to keep our roads in top condition, then obviously the extra cost is worth it. But if the same job can be done for 19 per cent less money, then obviously the tax payer is interested in seeing that this is done. There's a simple matter of economy.

Let's example the case of the highway construction representatives. Two officials of the Carolina Branch of the Associated General Contractors of America, Inc., R. W. W. Parks of Monroe and S. C. Austin of Raleigh, pointed out that "37 years with the wrong approach to road maintenance problems is long enough."

North Carolina presently performs nearly all highway maintenance with its own construction crews under the old system called "force account." Austin said the U. S. Bureau of Public Roads conducted the test on five secondary road projects in the Asheville area by comparing the

actual costs in building three projects under the competitive contract system and two projects under the force account method.

At the conclusion of the test the bureau reported that, considering all applicable cost items, it cost the state approximately 19 per cent more to do the work by force account. Now perhaps the state has a rebuttal to make in defense of its system of highway maintenance. A conclusion should never be drawn until both sides of a story is heard.

It is to be hoped that some type of industry representatives are indeed correct, then it is to the best interests of the North Carolina tax payers for a revision to be made in our methods of highway maintenance.

GALVESTON, Tex. (AP) — The delectable shrimp, which has touched off more Gulf Coast sea battles than the pirate Jean Lafitte, may be pulling a disappearing act.

Shrimp boats which pulled in 2,000 tons a day 10 years ago now settle for a daily catch of 500 tons.

Could be only that the demand is at an all-time peak, say marine scientists. More shrimp boats than ever are going searching for the evil looking but delicate tasting shellfish once considered little more than fodder for a hot tomato sauce.

The sweet, tangy shrimp tickles the palates of Americans to the run of about a pound per person annually.

Supermarket frozen food counters now carry everything from the old cocktail standby to the french fried and creole varieties.

John Mehos, president of the Shrimp Assn. of the Americas, says the industry does about \$3 million dollars worth of business a year. Shrimpers who marketed only about 50 million pounds in 1950 produced four times that much last year.

Time was when the American housewife wouldn't touch a brown shrimp and the white shrimp was the only strain thought suitable for eating. But with the frozen food era came the rise of the brown-flecked beauty and its sister shrimp, the pink — and the gradual disappearance of the white.

Now not more than 15 per cent of the industry's total catch is white and at least one scientist says Mrs. Housewife doesn't know the difference.

"Some claim they can tell but I doubt it — although I've never given taste tests," says research biologist Ed Chen of the U. S. Fish and Wildlife Service here.

Shrimpers haul in the pink chiefly off Florida's west coast and Mexico's Campeche Banks. The brown — and what whites remain — are found off the Mississippi, Louisiana, Texas and Northern Mexico coasts.

In lean seasons the shrimper strays farther from his home port in search of a payload. With demand on the increase, competition gets rougher.

Mexico lifts an irritated eyebrow at any foreign fishing boats camped off the 12-mile limit she claims. Often it has led to naval action.

A Mexican gunboat fired on a Texas shrimp boat the claimed was within her coastal waters last year, wounding its skipper. His craft was towed to a Mexican port and its shrimp confiscated.

In recent years dozens of other U. S. shrimpers also claim to have been persuaded at gun point to turn over their cargoes to Mexican authorities. Texas shrimpers raised cries of piracy on the high seas and asked for added Coast Guard protection.

Both nations agree the problem is a serious one.

Chen says government shrimp production figures go back only two years and that the drop in the size of catches could reflect only the substantial increase in the size of the fishing fleets. Shrimpers' figures, he says, are prone to lean on oldtimers' memories.

But he adds that if shrimpers claim their evasive crustacean is declining in number, there must be something to it.

Shrimper Mehos, one of Texas' largest producers, says shrimp conservation is a must.

"Thirty or 40 years ago," he points out, "crop rotation was thought to be sheer malarkey."

One bright spot, Chen says, is the discovery of new shrimp strains such as the Royal Red found by government scientists in deep water off the Florida and Louisiana coasts.

Not yet fished commercially, it's of jumbo size and could prove to be the seafood enthusiast's delight.

But big or small, the shrimp has won its spurs as a delicacy. Except, possibly, by the shrimp boat crewman. He's a man known to take a dim view of the shrimp once it's off to market.

# When A Buyer Is Not A Customer

By ELMER ROESSNER

A buyer in a department store is not a customer but a seller.

This fact bothers many people including, it seems, Robert H. Myers, associate professor of marketing at Miami University. The fact that Miami U. is at Oxford, Ohio, and not in Miami also bothers many people, but we won't go into that today.

The typical department store organization centers around the buyers, the stores' name for the department heads. A buyer is responsible for both buying and selling all his or her department's merchandise.

A buyer is constantly dashing off to markets and trade shows for fresh stock, constantly darting to the store to make sure goods are properly displayed and that salespersons are using the right approach.

Buyers often end up mad. "I'm in fact, many start that way. The buyer's job, Professor Myers states in the winter issue of New York University's Journal of Retailing, is all wrong.

"Poor retail salesmanship in department stores, to a great extent, stems from the illogical grouping of functions and a lack of clear division and definition of the selling function," he says.

**WANTS FUNCTIONS DIVIDED**  
If the buying and selling functions in department store organizations were clearly defined and divided so that the responsi-

bility for proper performance would be definitely fixed and the full benefits of specialization attained, the quality of selling in department stores might increase substantially.

If the auto industry were organized like department stores, he points out, the product engineers would do the selling.

In retailing, he says, buying should be left to specialists in purchasing; selling should be left to specialists in selling; sales specialists. The buyers, he says, should naturally work closely with the department managers, who would be in charge of sales. The buyers should also work closely with fashion co-ordinators, merchandise researchers, the comparison shoppers and the budgeting department.

Furthermore, the department managers should be in full charge of the sales personnel, and should

## Driver Education Course Is Begun

FARMVILLE — A special course in driver education began today at Farmville High School and will continue for the next 14 weeks, Principal Sam D. Bundy announced this morning.

The weekly session will include two hours of classwork on Saturday mornings and "behind-the-wheel" instruction on Saturday afternoons. Each student who completes the course will have participated in 30 hours of classwork, six hours of actual driving and 12 hours of observation as a passenger.

Twenty-four Farmville High School students, most of them sophomores, are enrolled in the course, Principal Bundy said. Classes are held in the school's Home Economics Cottage under instructors Elbert Moye and George Casby, who will also direct actual driving experiences in a special training car furnished by Davenport Motor Sales of Farmville.

The course is the first to be taught in Farmville under auspices of action by the 1957 North Carolina General Assembly which authorized an additional \$1 charge for license plates to finance the instruction. A second 15-week course is scheduled to begin in June for Farmville students.

## Oberlin College Ensemble To Play Monday Evening

The Oberlin College Wind Ensemble, appearing at East Carolina College Monday night, January 26, will give the first of two major programs of music to be presented on the campus during the week.

The Roger Wagner Choral, an internationally famous singing group, is scheduled to sing here on Thursday, January 29. Both concerts will be presented as attractions of the 1959-1960 Entertainment Series at the college.

The Oberlin College Wind Ensemble, now on a tour of five states, will play at 8 p.m. Monday in the McGinnis auditorium.

Kenneth Moore, conductor of the group, now a faculty member of the Conservatory of Music at Oberlin College in Ohio, is well known in this state. From 1950 to 1955 he taught at Davidson College, North Carolina. He has played with the Transylvania Music Camp Faculty Orchestra and the Brevard Festival Orchestra. At Oberlin he organized the wind ensemble.

Music lovers who attend Monday's recital will have an opportunity to hear some of the finest music composed for wind instruments. A special attraction will be a performance of George Frederick Handel's Water Music, played in commemoration of the 200th anniversary of the composer's death.

Other selections on Monday's program will be Mozart's Serenade No. 10 in B-flat major for 13 wind instruments; a brilliant show piece for the full ensemble, the Pasacaglia and Fugue for Band by the contemporary American composer Wallingford Riegger; and Stravinsky's Octet for Wind Instruments.

The final number will be a Divertimento for Band, opus 42, by Vincent Persichetti.

The Oberlin Wind Ensemble is made up of forty woodwind, brass, and percussion players. This instrumentation is basically that of the wind section of the symphony orchestra. The repertoire for this type of ensemble is broader than is available to the concert band, which is the usual type of wind organization.

## Orders New Fire Escapes For School At Farmville

FARMVILLE — Farmville's District School Committee has completed negotiations with a Goldsboro firm for construction and installation of additional fire escapes at Farmville High School.

The building, only two-story structures among nine buildings in the Farmville school system, has only two exits at the present time for the second floor. The new escapes, to be constructed and installed by Dewey Brothers of Goldsboro, will be placed at each end of the high school building.

Principal Sam D. Bundy said today the fire escapes will be placed at the rear of the building. They are to be counter-balanced and will connect with existing corridors.

Principal Bundy said that fire drills conducted in the school have shown that the high school building can be evacuated in approximately one minute and 40 seconds by using all existing exits.

The principal also announced that the district committee is considering installation of a fire-warning system by which an alarm can be given from points throughout the building. The new system would also tie in with a signal switch to give an alarm at the Farmville Fire Department.

## Chief Speaks At Exchange Club

At the Greenville Exchange Club last night, Greenville Fire Chief George Gardner described some of the equipment used by the Fire Department and Rescue Squad that was not acquired with tax funds and praised the citizens for providing it.

He reported that members of the Greenville Fire Department had received instructions in Raleigh about radio-active materials. The fire chief advised that whenever there is an accident with radioactive materials, call the State Highway Patrol and keep clear of the scene of the accident after rendering first aid necessary. Radio active accidents will be handled by a special team of firemen on call at all times, he added.

The chief emphasized the importance of preparing for fires and emergencies in homes, and said fire drills are a good thing to practice. He answered numerous safety questions by members.

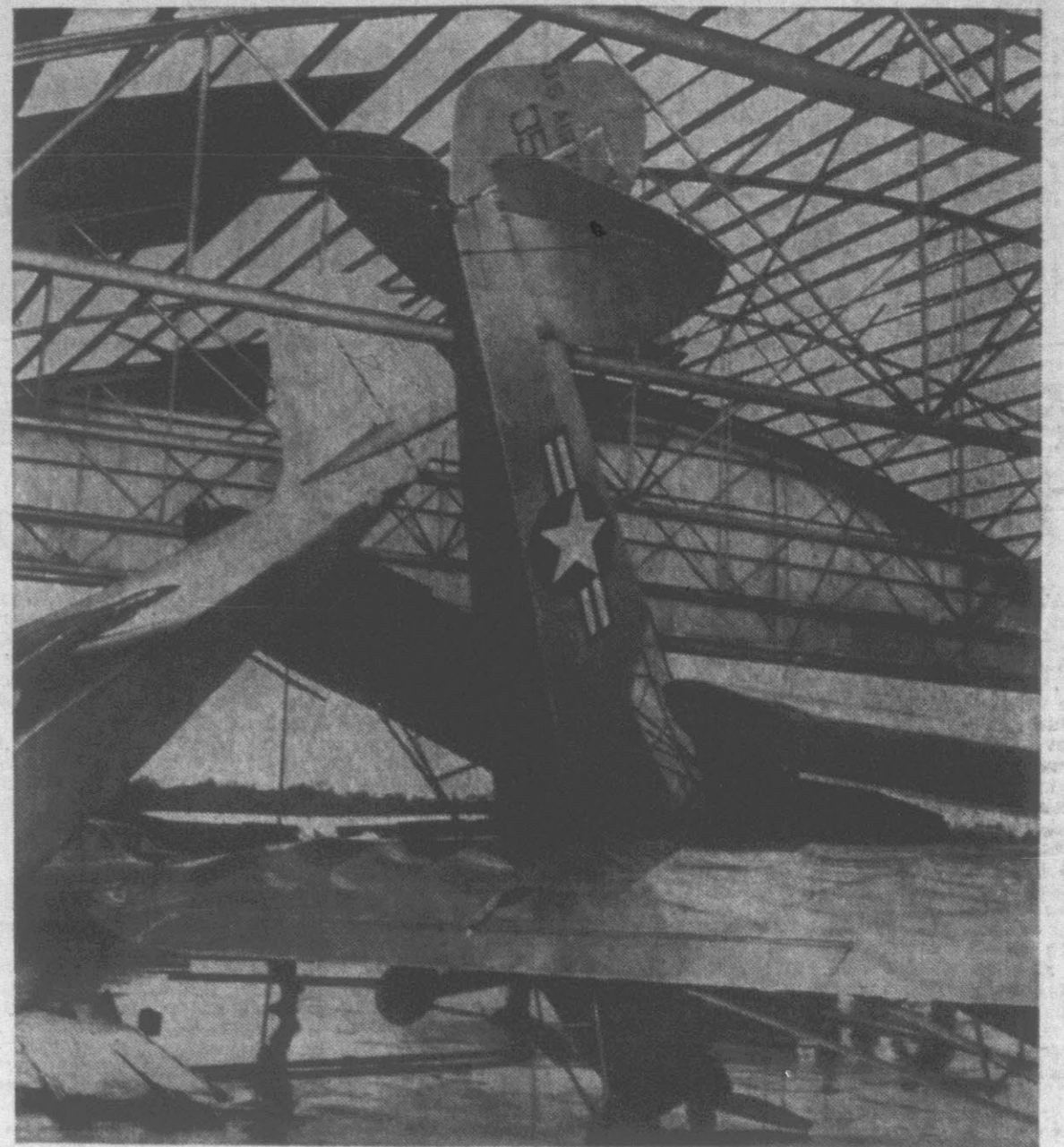

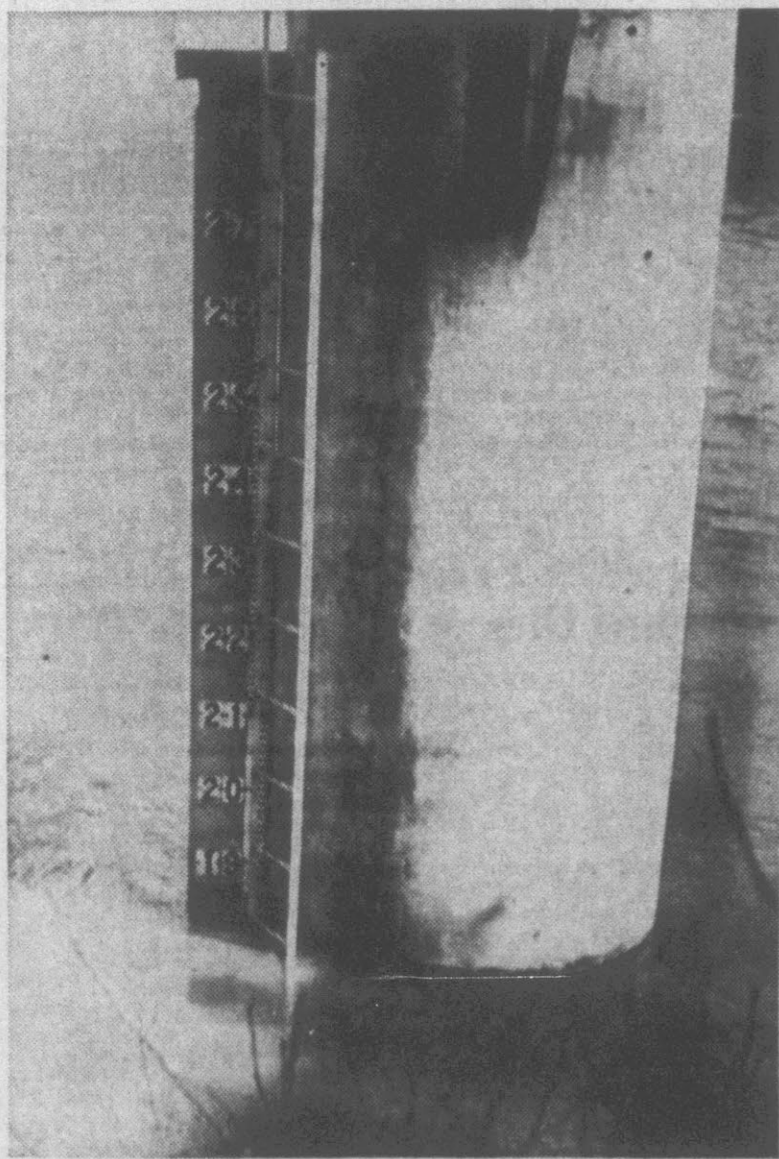
## Nothing Like Variety In The Weather

The mean annual temperature around these parts is 61 degrees, which shows nice year 'round weather, but that doesn't mean there isn't plenty of variety in Pitt County's weather.

For Pitt Countians have seen hurricanes, tornados, blizzards, floods, hail storms, heat and cold waves along with plenty of days when the weather was "just fine" outside through the years.

In other words, just about everything the weatherman can throw at mankind—with the exception of volcanic eruptions and maybe earthquakes—have come Pitt County's way. And its possible there may have been some earthquakes in this area.

Hurricanes? Everyone remembers Hazel which tore inland in October of 1954. It caused huge damages in every municipality of the county and there were few Pitt farms which did not have some loss due to the mighty winds.

Since that time hurricane has become a fearful word in eastern North Carolina and residents of the area keep a close watch on each of the tropical storms making up in the Caribbean.

And tornados have not been uncommon. A mighty one tore through the town of Bethel at the north end of the county a few years ago. A flourishing potato market, most of the town's potato houses were badly damaged by the tricky winds.

In 1957 a tornado hit Marlboro just outside Farmville causing heavy damage to buildings in that area. It also hit some farm buildings some distance from Marlboro.

There was another tornado that struck in Greenville's West End Circle which caused considerable damage to stores there.

And there have been blizzards—at least by Pitt County standards. The most recent was only last month when 12 to 15 inches of snow paralyzed the county for a day or so. A cold wave kept the snow here for longer than most folks wanted but Pitt Countians dug out and life went on as usual.

There was that big snow of March, 1927 which is still considered the heaviest snowfall in the memory of anyone alive today. One warehouse collapsed during that one and life was at a standstill for a time.

Anyone who lives along the north bank of the Tar will testify that floods are to be expected almost annually in Pitt County. With spring rains the river rises. On rare occasions such as August, 1940, flooding is so severe that the highways are submerged.

That year the Bethel highway was covered with around two feet of water and traffic was cut off over the bridge. Those wishing to journey from Bethel to Greenville or vice versa had to make the trip by way of the Falkland-Belvoir bridge which at that time had only recently been built.

Flood waters eventually recede, however, and soon the highway was re-opened to traffic.

And every summer tobacco farmers anxiously watch the skies for signs of devastating hail storms which they know can level their crop in a matter of minutes. Most summers such storms will strike some where in the county, although last summer Pitt was spared a major hail storm.

As for heat waves, anyone around July 24, 1952 can say they lived through the hottest day on record—at least for 25 years preceding 1953. The temperature for that day rose to a scorching

106 degrees.

If you consider the last two winters as extremely cold you are probably right. But you have to go back in weather bureau records to January 4, 1918 to find the coldest day. That day the thermometer registered a teeth-chattering zero.

But all-in-all Pitt County is a pretty nice place to live when it comes to weather. With its mean annual temperature of 61 degrees, the county has a daily average range of 19 degrees. The average winter range is 18 degrees and the average summer range, 20 degrees.

Normal temperatures for Spring is 60 degrees, summer, 79 degrees, fall, 63 degrees and winter, 44 degrees.

There are an average of 215 frost free days and on an average 60 per cent of the days of the year are clear. To be more specific, there are 130 clear days per year on the average, 120 partly cloudy days. Skies are totally cloudy only 115 days per year, the U.S. Weather Bureau's 25-year averages show.

Winds are mild through Pitt County with the yearly average being seven miles per hour. The average velocity ranges from August with six miles per hour to March with nine miles per hour.

The mean average rainfall is 49 inches. July is the normal wettest month with an average of 6.4 inches while November is the driest with an average of 2.4 inches.

The weather bureau lists average annual snowfall at seven inches.

The average relative humidity is Spring (April), 65 per cent; Summer, (July), 75 per cent; Autumn, (October), 70 per cent; Winter (January), 70 percent.

Heart Operation Is 'Difference' For 11-Year-Old

CHARLOTTE, N.C. (AP)—When 11-year-old Roger Stepp leaves a hospital here soon he will walk down the front steps unaided and won't gasp for breath.

Until recently doctors didn't expect him to live much longer. Just about any kind of exercise was out of the question.

A new operating technique that gives hope for all types of "blue babies" made the difference. Blue babies are so-called because the lack of sufficient oxygen in their blood, caused by congenital heart defects, gives a distinct bluish cast to their complexion.

Now Roger's heart is hooked up to only one set of blood vessels instead of two. The blood in his veins—instead of passing through the right side of his heart—goes direct to his lungs for purifying and picking up fresh oxygen.

The method was used for the first time here—and one of the first times anywhere—after five years of research at Memorial Hospital.

The operation was performed two weeks ago by a group of surgeons headed by Dr. Paul Sanger and including Drs. Frederick H. Taylor and Francis Robicsek.

Since his birth Roger had suffered from a heart condition doctors thought could not be remedied by surgery. There were two holes in the right chambers of his heart, hindering its action, that he had to remedy by a heart operation.

The solution, the doctors found by experiments with animals, was to bypass the heart and operate on the veins—detach them from the right chambers of the heart and route them directly to the lungs.

Roger used to have trouble just breathing. Now doctors say he'll put some weight on his spindly frame and eventually will lead a nearly normal life.

Prospect Of Labor Strife Biggest Cloud On Horizon

NEW YORK (AP)—One of the darkest clouds on the horizon of a generally sunny business sky today is the threat of major labor trouble.

Basic industries have wage contracts now in their final months. And both management and labor are talking even tougher than usual this time.

Management says it can't go on with big pay hikes year after year. It now cites President Eisenhower's condemnation of boosts in excess of productivity gains as a prime cause of price inflation.

Labor says that the business recovery and the quick snap back of corporate profits has put management in an excellent position to share more of sales income with the workers.

Just the threat of major strikes can upset the economy in two ways: 1. It leads companies to over-order supplies ahead of the prospective strike, running up prices and causing shortages, and then to stop ordering all together while these stocks are worked off.

2. It leads the more cautious

workers to put off buying on time such big ticket items such as cars and appliances. This spreads from those involved in the dispute to others who might be laid off for lack of materials in their own factories.

The country already has been harassed by bitter labor disputes on several airlines. It has just escaped a strike in the refineries of several oil companies. Some 100,000 oilworkers are involved in labor contracts expiring in June.

Some aircraft workers will seek new contracts in May and others in September. Cloak, suit, and skirt manufacturers have a May deadline for their negotiations with 50,000 garment makers.

But it is in June and July that the economy will face its most critical labor-management talks. Contracts with 300,000 steel workers expire in June. In that month and the next 62,000 non-ferrous workers will be involved in negotiations.

Fear of a steel strike is widespread now. Each increase in steel wages has been followed by boosts in prices, affecting a large

number of industries making consumer goods.

Both steel management and steel workers are reported ready to take tough stands and to be ready for hard battling at the conference table at least and to be preparing for a strike if there is no meeting of the minds.

The major meat packers and their 100,000 workers must hammer out a new contract in August.

A million railroad workers will see their present contracts expire in October.

Some unions, particularly some aircraft workers, will be getting automatic pay increases before their present contracts come up for renegotiation.

Other unions not involved this year in contract renewals will be getting pay raises automatically. These include auto workers, electrical workers, machinists and coal miners.

Altogether it's going to be a tense year in the labor relations field. And it's going to be pretty hard for President Eisenhower to get his wish that labor and management use more restraint in the matter of wages and prices.

Donna Gambled And Won Over Big Odds

1. Her competition was an established series, "The Millionaire," and the longtime Mr. Television, Milton Berle.

2. She came in with a comedy at a time when comedies are on the decline.

3. Virtually all the female stars who started series last season disappeared from the channels.

Reviewers found the first show mild and predicted a short history for the series.

As sometimes happens, they made the mistake of underestimating the power of a woman. The Donna Reed Show on ABC Wednesday nights has been climbing nicely in the audience polls, sometimes beating the opposition; has been picked up for a full season by the sponsor; and looks healthy for a return next year.

"I knew what we were up against," says Donna, "and I was a little scared. But I thought we might have a chance if I just played myself. Nobody else — just me."

Because of her resolve, she turned down a variety of offers to play a lady doctor, nurse, etc. She and her husband-producer, Tony Owen, spent a year and a half searching for the right vehicle for her TV debut.

"The answer came when a Screen Gems executive saw a picture of my four children, my sister, and myself on Tony's desk," she said. "There is the answer, he said. 'Have her play a wife and mother.'"

So she is. She plays a pediatrician's wife and mother of two children. The show doesn't go overboard for laughs. Proof of this is that, despite Donna's fears, there have been no complaints from critics and their families.

Donna dipped into a comedy show despite the fact that she had never played it for laughs in her movie career. She readily admitted that one of her considerations was money.

"During both our careers, Tony and I have never made anything but highly taxable money," she said. "If the show succeeds, we may be able to change all that."

Farmville Ass'n Assets Growing
