Mrs. Hoot Speaks To Club On 'Glass Models Of Flowers'

The Inter Se Book Club met Tuesday afternoon with Mrs. M. P. Hoot who presented the afternoon program at her home on East Fifth Street.

Mrs. Hoot chose as her subject "Glass Models of Flowers". Mrs. Hoot stated that it had been 17 years since she had visited the Harvard Botanical Museum in Cambridge, Mass., but that she had never forgotten the beauty of this Collection of Glass Models of Flowers on exhibit there. The Ware Collection of Glass Models of plants represents the artistic and scientific effort of two men - Leopold and Rudolph Blaschka who had their studio near Dresden in

Germany. According to Mrs. Hoot there is perhaps in no other museum in the world is there a comparable collection, for it exhibits not only consummate skill in the use of a difficult medium, glass, but is the record of the complete product of a single studio and of two artist-naturalists over a period of nearly half a century.

Mrs. Hoot gave the history of this Collection and showed some colored slides of different glass flowers taken from this Collection. A Valentine motif was used in the dining room where Mrs. William H. Taft served heart-shaped molded salad and Mrs. R. F. Thompson poured tea.

Pork Is Biggest Aid To Budget

RALEIGH — This week's food shoppers will find pork products the biggest aid to the budget, advises Mrs. Ruby P. Uzile and John W. Hagen, consumer marketing specialists for the N. C. Agricultural Extension Service.

Lower prices are appearing on pork loins, bacon, sausage and ham. Your favorite grocery store or supermarket may feature other pork cuts as "specials."

Beef prices may be slightly higher; lamb prices are steady. Poultry prices dropped slightly this past week—due to a decrease in demand. A few cents dropped from the price of eggs; with the expected steady production, the prices should hold the next two months.

Despite cold weather in the producing areas, most fresh vegetables are in moderate supply with steady prices. Hagen says that Irish potatoes, dry onions and turnips will help the homemaker to stretch the budget. Check frozen and canned vegetables to see which form offers the greatest economy.

California Naval oranges and Florida Temple oranges are available at reasonable prices. Large grapefruit continue to be a good buy. Pears are top quality fruits, but they have higher prices than the citrus fruits.

Education, Here We Come
Always in the news, controversies about education are breaking out all over again. . . . what with Adlai Stevenson's blast last week at the Schoolboard members' convention and now a book by Admiral Hyman Rickover, "Education and Freedom," just out from Dutton's. . . . Today's Review
Since next week is Boy Scout Week we're appropriately offering you comments on the founder of the Girl Scout movement in America. Our reviewer is a capable and enthusiastic Girl Scout worker herself. . . .

LADY FROM SAVANNAH. By Gladys D. Shultz and Daisy Gordon Lawrence. Philadelphia: J. B. Lippincott & Co., 1958

Juliette Gordon Low is known throughout the world as the founder of the Girl Scout organization, and the fact that her birthday is celebrated by Scouts each year is tribute to the love and esteem in which she is held, both by the girls, and by adult Scouts everywhere. But our real appreciation and understanding of this remarkable woman is incomplete until we have read the story of her life.

Daisy, as she was affectionately known by her family and friends, (Aunt Daisy to her beloved Girl Scouts) was born into the socially prominent and civically outstanding Gordon family of Savannah, Georgia. Daisy was a fun loving, high spirited girl whose way of life seemed primarily the pursuit of pleasure. Her reputation for eccentricity increased after she became nearly deaf, and she went to great lengths to hide from everyone the great handicap her deafness imposed. Her tragic and childless marriage to William Low might have embittered anyone of less sterling character than Daisy, but, although the experience colored her whole life, it did not lessen her capacity for love, honesty, or fun.

Mrs. Low returned from Europe in 1912 full of enthusiasm and plans for beginning the Girl Scout organization in America. Her friendship with Lord Robert Baden-Powell, the founder of the Boy Scouts, and her work with the Girl Guides in England, furnished the inspiration. Daisy's life took on new meaning as she devoted her time and her wealth to "her girls." For four years she supported the entire work, paying salaries, buying uniforms, paying rent on the office building, and buying all supplies. Despite her sizable personal fortune this was a hardship on her, and she sold many of her personal belongings to raise money.

The growth of the Girl Scouts was phenomenal, partly because of her untiring efforts, but also because the program was almost universally appealing to girls of all ages. Daisy tried to keep secret her ill health, and even during the last stages of her fight against cancer the Girl Scouts were uppermost in her mind. She had always loved children, was deeply disturbed by her childlessness, and was grateful to her Scouts for being the children she needed, and for giving her the purpose in life which she hungered for.

This book is a "must" on the list for every adult interested in Girl Scouting. Mrs. Low emerges as a warm, real person, and her philosophy gives the reader considerable empathy with the Girl Scout organization. It is unfortunate that the first half of the book is cluttered with so many details, but the rest of the book, particularly with the inception of the Girl Scout movement, was completely fascinating, and the kind of reading one looks forward to returning to.

Teenagers Expected Tighten Music Grip

HOLLYWOOD (AP)—A handful of years ago there were four record companies in the United States. Today there are more than 1,500.

No wonder record veterans exclaim the business has gone crazy!

Says one: "Any guy with a thousand dollars can start a record company. All he's got to do is pick up a foursome in a bar, take 'em to a recording studio, make a couple of sides, think up a name for his label, and he's in business."

Then he takes his record to a distributor in one or more of the major cities. If the distributor thinks the record might sell, he takes it on. It is sent to the local disc jockeys. If they take a shine to it, they play it over and over on the air, and the teen-agers start asking for the number in the music stores.

If this situation is repeated in city after city, the man who start-

ed with a shoestring can end up with a shoe store.

As might be expected, the established record firms are upset by this trend. They complain that distributors favor the shoestringers, who demand less royalty because they have no overhead. There are even dark hints that his are created not by teen-age demand but by greasing the palms of disc jockeys and other hit-makers.

What has the teen-age revolution done to the record business? The industry boomed from 7½ million dollars in 1939 to 400 million in 1957. Indications are that the record companies may have dropped in sales volume in 1958.

The reason is that teen-agers have virtually taken over the single-record market. Their kind of music is largely unappealing to adults, who buy the albums. For that reason, the major companies are putting more and more emphasis on the packaging of albums while the newcomers scramble to sell singles to the kids.

What about the teen-agers? Most observers believe the kids will increase their hold on pop records. Some see hope in the rising interest in Latin music and the big bands. But these are small glimmers in an otherwise dark picture for those who dislike teenage music.

Principal Sam D. Bundy announced today that information received this week confirms continuation of the association's accreditation. The school was first accredited in the 1940-1941 school year.

Bundy said the accreditation is based on examination of school facilities, school policies and philosophy, training and experience of the school staff, college records of its graduates and other items.

In connection with the accreditation study, Bundy also said that members of the high school faculty are now evaluating the school's curriculum and graduation procedures. Necessary changes or adjustments determined by the study will be made, Bundy added.

It was also stated at the meet-

ing that Pitt Memorial Hospital is within range of two major surgical supply centers and has access to any needed equipment within an hour or an hour and a half of any major disaster.

Chairman of the Safety Council Charles H. Whedbee presided over the meeting. Everett Parker was acting program Chairman.

Tar Heels Have A Clearer Picture

At the outset of the 1959 General Assembly most North Carolinians are probably more familiar with major issues which will come before the legislature than during any session in a long time.

To some degree at least, this may be attributable to fact that Gov. Hodges has been the state's chief executive during two legislative sessions already, and this will be the third under his administration. Normally a governor is in office during only two legislative sessions. The third "Hodges session" means a natural continuation of the general program advocated by the administration.

More than that, however, we believe reports by special study commissions which have been made public in recent months have focused public attention on legislative problems.

There is the matter of revamping the state's system of lower courts. The report and the committee's recommendations have been widely publicized. There are reports on the state's water resources and means of conserving and controlling them; proposals for realigning local and state financial support for public schools; recommendations on changes in the election laws; recommendations on property tax laws from the Tax Study Commission and many other such reports.

The result of all this caused people to begin thinking about legislative problems months before the General Assembly session convened. The usual number of trial balloons which were sent up immediately before the session began added emphasis to public attention already focused on legislative matters.

In many instances relatively strong support and opposition already has developed concerning certain matters which will be before the legislators for decision. This year, unlike other years, it has not been a matter

of waiting until a bill hit the hopper for citizens of the state to start talking about its merits.

All things considered, it is a healthy situation for North Carolina. It should lessen the chances for hasty consideration of many matters. It will increase public interest in what the legislature does throughout the session; and it should increase the number of suggestions on specific pieces of legislation which representatives get from the folks back home.

By all standards the current legislature has as many complex problems confronting it as any session in recent history. The fact that the people of the state already are better informed than usual on major matters which must be considered should prove an invaluable asset to the legislators in reaching wise solutions to these problems.

Virginians Displayed Laudable Self Control

Since Tuesday, integrated schools in Norfolk and other Virginia areas have been a fact. White children and a few Negroes are going to classrooms together in schools that were closed from September until they reopened on an integrated basis this week.

Even though the mere fact that the schools are integrated is significant, it is even more significant, we believe, that the actual process of integrating the schools in Virginia has come off without a single incident of violence or intimidation of any sort against Negro children who are attending the previously all-white schools.

Virginia vigorously fought integration of its schools to the last ditch with its program of massive resistance. When the laws which formed the basis of that program were struck down by both federal and state courts, integration came quickly. And it came with stern warning from Gov. Almond that Virginia would tolerate no violence or demonstrations in connection with the integration of its schools.

And as Gov. Almond predicted, integration has been carried out without incident. It has been carried out without incident because of the leadership afforded by the man who led the massive resistance program — Gov. Almond.

It is a tribute to the Old Dominion State that its people have not reacted violently in the face of a most bitter situation as did the people of some other cities. It is also a tribute to Gov. Almond and the leadership he has afforded and will continue to afford the people of Virginia.

'Mr. X' Talking Policy Changes

WASHINGTON (AP)—A sign of the changing times: George F. Kennan, the "Mr. X" of yesterday.

He's credited with being the author of policy toward the Soviet Union followed for a decade by both the Truman and Eisenhower administrations.

This is the policy of containment, of ringing the Soviet Union with military bases to prevent Soviet expansion. It's worked fairly well.

But now Kennan has other ideas. He's talking of a pullback of American forces in Europe.

Long employed by the State Department, Kennan got out after differences with Secretary of State Dulles. But his new ideas have brought him into sharp conflict with his old boss there, former Secretary of State Acheson.

In 1947, while Kennan was director of the State Department's policy containment policy in the Foreign Affairs Quarterly magazine. He wrote under the name of Mr. X. He said then:

"It is clear the main element of any United States policy toward the Soviet Union must be that of a long-term, patient but firm and vigilant containment of Russian expansive tendencies. . . .

"Russia, as opposed to the western world in general, is still by far the weaker party. . . . Soviet society may well contain deficiencies which will eventually weaken its own total potential."

While the Soviet Union hasn't expanded in the sense of acquiring new territory — since 1947, she has become stronger, not weaker as Kennan hopefully seemed to think she might.

Kennan, who later served as ambassador to Moscow before his exit after his troubles with Dulles, Wednesday gave to a

Senate disarmament subcommittee views which would indicate he thinks his 1947 policy is obsolete.

He talked of the idea of making a deal with the Russians so that both American and Soviet Troops could be pulled back from Central Europe, or at least from Germany.

The man who once talked of containing the Soviet Union, Wednesday said he hopes it would not be necessary to pull American troops entirely off the continent of Europe.

He was thinking in terms of a neutralized Germany and seemed to envision it, while neutralized, as both democratic and free from the Communist political threat.

This is not the first time Kennan has talked this way. It's pretty much a repetition of broadcasts he made in Britain last March.

Those broadcasts made Acheson so furious that he replied to Kennan with an article of his own in the Foreign Affairs magazine.

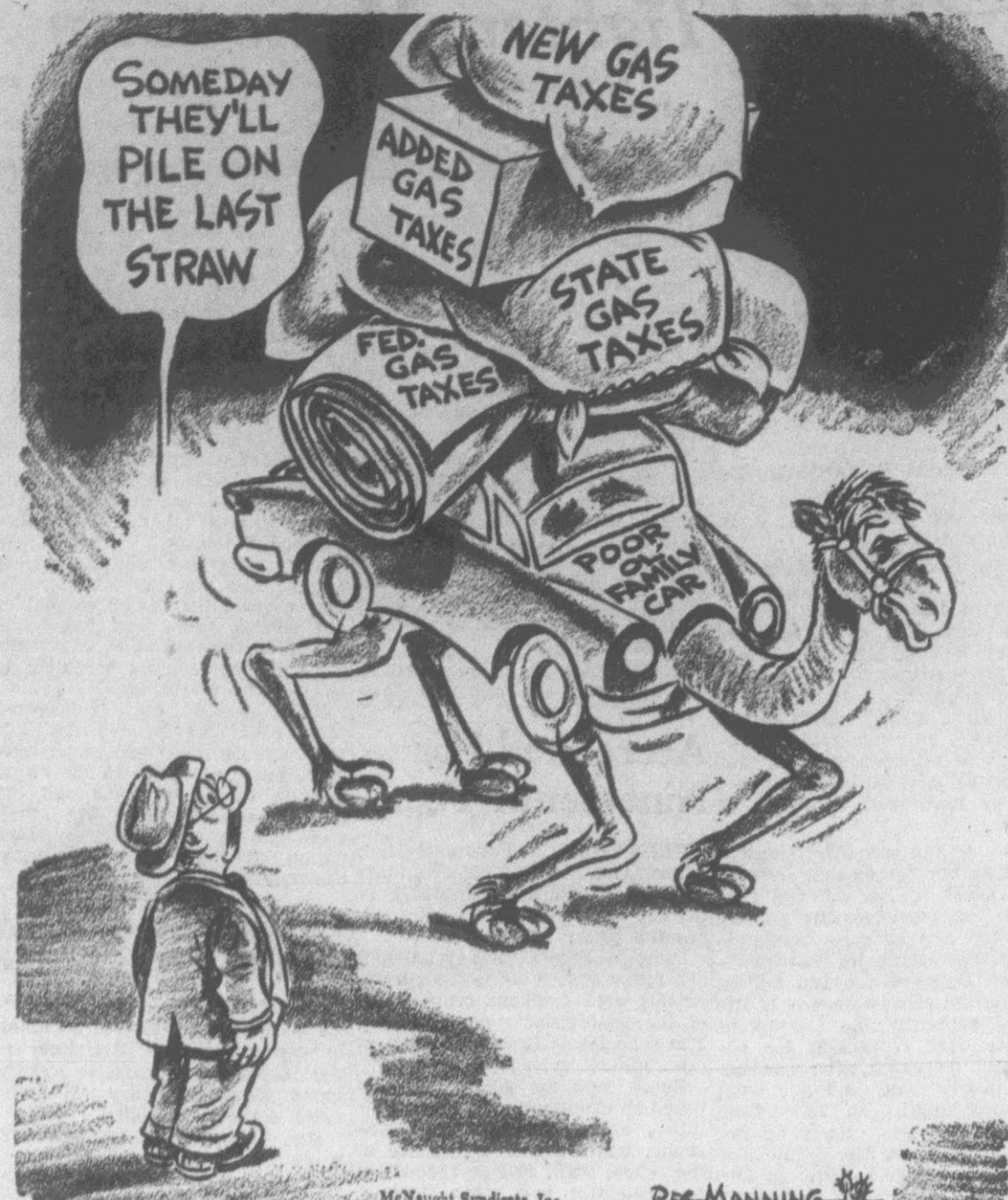
Acheson, who supports President Eisenhower's continued use of the containment policy which he himself used under the Truman administration, predicted:

Withdrawal of U.S. forces from Europe would lead ultimately to a linkup between Germany and the Soviet Union, confronting the world with a new war threat.

Acheson called the disengagement idea the "new isolationism" and stated the pullback of Soviet troops wouldn't mean much.

Yet withdrawal of Allied forces from West Berlin is what the Russians are insisting upon right now. The world is watching to see what Secretary Dulles, now in Europe, can come up with in making concessions to Moscow or standing firm.

Senator Paul H. Douglas of Illinois has introduced into the Senate an amendment to the Civil Rights Bill which the senior senator from North Carolina, Hon. Sam Ervin, Jr., says if enacted into law "it would destroy the system of government which has prevailed in the United States since the adoption of the Constitution."

The bill "proposes to place all state governments, all municipal governments and all county governments in the United States under the supervision of the Attorney General of the United States, who is to be given authority superior to that of duly elected state and local officials in all areas which can possibly be construed by usurpation or otherwise to fall within the domain covered by the 14th Amendment."

Senator Ervin further points out that this part of the law was defeated in 1957, but that the new version is even more devastating to States' Rights than the proposal made then. He declares that "It makes provision to rob the people of the states of ultimate control over their own schools and bestows this power on the Department of Health, Education and Welfare. It goes far beyond the provisions of the 14th Amendment and far beyond the so-called desegregation decision itself. Indeed it's based upon a complete misinterpretation of such decision."

Most of the mistakes we make are probably due to the fact that we come to hasty decisions. Precipitous action is almost always bad.

If you think about it for a moment, you will probably conclude that hasty judgment followed by unwise action is usually the result either of fear or weariness. We become obsessed with the idea that unless we do a certain thing we will experience financial loss, or pass up a good opportunity, or find ourselves in a continually uncomfortable situation. Therefore, we make up our mind fast — and generally to our own grief.

The other reason for precipitous action is weariness. Why

worry along with this matter any longer? Let's get it settled now and settled for good. Everybody should look searchingly at that point in his thought concerning any situation where he begins to feel that regardless of consequences he wants to be rid of the whole thing. Then, we can be almost sure, that any decision he makes will be wrong.

There is, of course, such a thing as lingering too long over consideration of a situation. But nine times out of ten, when we are wrong in making up our minds too quickly and acting precipitantly.

Watch out for signs of fear or weariness. Either of these things can lure us into making decisions which we later regret and acting in a way that will soon demonstrate its inherent folly.

Dept. Store Sales Poor Index

The distinction of registering the greatest increase in department store sales in 1958 goes to Quincy, Mass., up 16 per cent. This helped push the total gain of suburban Boston to 15 per cent.

Close behind were the Lancaster, Pa., and Tulsa, Okla., metropolitan areas, each up 12 per cent. Cambridge, Mass., also part of the suburban Boston area, and Albuquerque, N.M., showed gains of 9 per cent. Sacramento, Calif., made a gain of 8 per cent, and Columbus, Ga., gained 7 per cent. All other cities and metropolitan areas gained less than 6 per cent, or showed losses, in February Reserve figures.

Oakland, Calif., showed the greatest loss, down 12 per cent, followed by the Pompano Beach, Fla., metropolitan area, down 10 per cent.

A VARIABLE YARDSTICK However, department store sales as compiled by the Federal Reserve System are a much poorer index of business condi-

tions in a community than they were a few years ago.

The great rush of department stores to new suburban shopping centers, sometimes followed by closing downtown stores, distorts the significance of these figures.

A few new shopping centers, each with one or two department store branches, can bring about big increases in sales totals in a particular area. The general rise in prosperity may not be as great because the rise in sales has come from drawing trade from downtown areas, or from farther outlying regions.

Data on the San Francisco-Oakland metropolitan area shows how this works. Sales for the entire area were 1 per cent above a year earlier. But sales in San Francisco were down 1 per cent, and in Oakland down 12 per cent, as noted above.

The explanation lies in the great increase in shopping centers in the areas outside of those cities: in Marin, Sonoma, Napa, Solano, Contra Costa and San Mateo Counties, and the rest

of Alameda County.

GAINS BY DISTRICTS

Figures by Reserve districts are slightly more significant. The Kansas City district made the largest gain, 3 per cent. The New York, Philadelphia and San Francisco districts reported 2 per cent gains. Richmond and Atlanta districts had 1 per cent gains. The Chicago district had a 2 per cent decline and the Cleveland district. These declines were probably due to the drop in industrial payrolls in those areas. Sales in the remaining districts were even with a year ago, and the national total was up 1 per cent.

In the week ended January 24, 1959, Quincy continued its pace, recording a sales gain of 29 per cent over the same week a year ago, and the whole suburban Boston district showed a gain of 23 per cent. These were topped by the St. Joseph, Mo., metropolitan area, up 33 per cent, the Houston area, up 29 per cent, and given a close race by the Kansas City area, up 25 per

cent.

These weekly figures are even less of an index of general business conditions than the annual figures, especially at this time of the year. A spell of bad weather can shove sales down; a few springlike days can shoot them up. A newspaper strike can cut totals; a special community event can boost them.

FOREIGN MAILINGS TO ESCAPE U.S. POSTAL RATES PENALIZED

Mailed advertisements with foreign stamps and postmarks get attention and an increasing number of foreign companies are offering to print, address and mail literature at low prices in France, Spain, Mexico and other exotic places. Foreign postage to the United States is often cheaper than domestic mail.

However, if the U.S. postal authorities are convinced a foreign mailing was made to avoid paying the American rate, they can seize the mailing and assess the U.S. rate in addition to the foreign charges. If there is another good reason for mailing abroad, there are no objections.

The Sadducees belonged to the aristocratic priests of the Jewish church. The high priests at the head of the Sanhedrin were Sadducees, we are told. They did not believe in resurrection and so, to trip Christ, their enemy, they asked Him what seems to us a ridiculous question. Two Clubs May Test Closed Circuit TV Plan

NEW YORK (AP)—San Francisco and Los Angeles, major league baseball's youngest franchises, today were being viewed as testing grounds for the most significant business move in the national game since somebody first passed the hat around an open field.

That would be the televising of major league games on pay-TV as you see it. As outlined to The Associated Press Thursday by Skiatron of America, the subscription TV plan is being readied for introduction in the two Pacific Coast cities about July 1.

The move had been talked about ever since 1957 when the former New York Giants and Brooklyn Dodgers first announced they would move West.

For months Skiatron, reportedly involved greatly in the double franchise shift, maintained silence on the basis that it could not disclose information that would put it at a competitive disadvantage.

But when questioned Thursday the company said its plans had been telecast to Los Angeles and San Francisco homes by the middle of the baseball season.

Additional Skiatron plans also call for pay TV of college football games in the two West Coast cities.

The sports telecasts would be part of over-all programming which would include movies, plays, and other non-sports presentations. The cost of viewing a single game has not been set, Skiatron said, but it would be less than a fan pays at the gate.

Baseball Commissioner Ford Frick said today it is proper that pay TV should get a trial on a regional basis. But he added that he would not want to comment on its national significance to the game. He said he considers pay TV still to be a matter left to the discretion of the individual clubs.

Basil Estrich, vice president of Skiatron, said although no cable has been laid and no subscribers signed, Skiatron expects to have 100,000 subscribers receiving service at the start of what he called a long-term operation.

On the West Coast, much of reaction was skeptical.

Estrich had quick answers for statements from San Francisco city authorities, West Coast telephone line spokesmen, and others who indicated they feel Skiatron's program is too ambitious and costly to be put into operation by the

Both cities are basically served by overhead power lines, whereas in a city like New York, where virtually all lines are underground, the cost would be prohibitive.

Denies Alleged Plot Confession

HAVANA (AP)—Alan Robert Nye was reported today to have denied that he had confessed to plotting to assassinate rebel leader Fidel Castro. The 31-year-old former U.S. Navy pilot from Whiting, Ind., reportedly made his denial to U.S. Vice Consul Hugh Kessler in an interview with him Thursday. Kessler declined to confirm the report. Police headquarters also had no comment. High revolutionary police and military officials met until late Thursday night discussing Nye's case. The rebels arrested the American six-footer as he marched in their ranks in Oriente Province Dec. 26, five days before ex-president Fulgencio Batista fled and Castro's revolution triumphed. Brought to Havana after the rebel victory, he told news men Monday that he was not involved in any plot against Castro but had wanted to fight for the revolutionary cause. Police headquarters announced Thursday that Nye had confessed he had gone to eastern Cuba to kill the rebel chief and that Brig. Gen. Carlos Tabernilla, head of Batista's air force, had promised him \$100,000 if he did the deed. The police said Nye had made the statement voluntarily and had not been mistreated. He was being held on a technical charge of landing illegally in Cuba, but there was no hint of what further action would be taken against him.

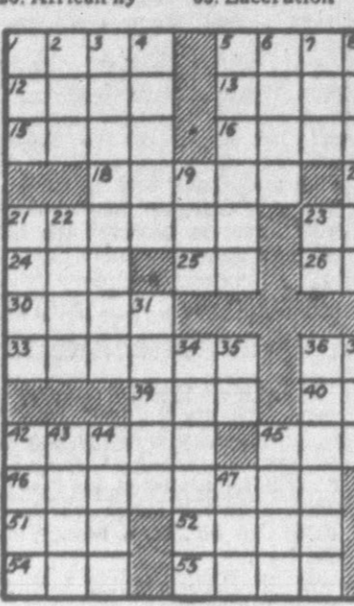

FAYETTEVILLE, N. C. (AP)—Fayetteville business men set out today to try to raise \$200,000 with which to build an industrial plant to attract a metal stamping company. J. Bernard Stein, president of Cape Fear Industries, Inc., told a called meeting of the Chamber of Commerce yesterday that the firm would move into Fayetteville provided local capital would provide a plant. He said a 110,000-square foot building was needed. Stein did not name the company but he said it operates several plants elsewhere in producing automobile parts. He added that a plant in Fayetteville would employ 300 to 500 workers. The Chamber of Commerce named a 50-member committee to solicit money from Fayetteville citizens in hopes that the \$200,000 could be raised by the deadline, set as next Wednesday.

N.C. Free Salk Vaccine Supply Is Going Fast

GREENSBORO (AP) — North Carolina's supply of free Salk polio vaccine is running out fast, almost two million children need shots and there is likely to be more polio in the state in 1959. This was the report Thursday night from Dr. Fred T. Foard of Raleigh, chief epidemiologist with the State Health Board. He spoke to a conference of State Medical Society members, health officials, National Foundation representatives and public relations men. Dr. Foard said the stocks of vaccine furnished by the U. S. Public Health Service will run out within a week. Dr. Foard said 1,900,000 children in the state need one or more polio shots, including those whom doctors are recommending for booster shots.

Mr. Rouse, son of the late George P. and Louise Jones Rouse, was born in Beaufort County, but had lived in Pitt County since he was a small boy. Enforcement Is Driving 'Heart Month' Proclaimed

OKLAHOMA CITY (AP)—"This could cause a revolution," said a would-be whisky drinker. "Why, my bootlegger said he didn't have any vodka and didn't even know when he'd get some," said a social drinker. "There ought to be a law against this," said a clubman. For 50 years folks in constitutionally dry Oklahoma haven't been bothered by the law. But suddenly it is being enforced. Oklahomaans are talking more about whisky and probably are drinking less than ever before. And they are paying more if they do drink. The reform administration of 33-year-old Gov. J. Howard Edmondson is trying to dry up the state and bring repeal to a vote. "We want to give the people a clear-cut choice between prohibition and repeal," Edmondson said. Whisky bills and a referendum proposal are before the Legislature. Joe Cannon, 33, an attorney from Muskogee, is directing the crackdown on bootleggers as public safety commissioner heading the Highway Patrol. He has staged periodic roadblocks across the state, trying to stop the flow of illegal liquor from Missouri, Kansas, Texas, and Arkansas. In the past month whisky has gone up \$1 to \$1.50 a pint, if you can find it. "I just can't serve my people," a bootlegger explained. "But one thing about it, they're not fussy anymore. I've had people beg me for Scotch that never drank Scotch in their life. It was all I had." Bourbon, the biggest seller, now goes for \$5.50 a pint in Oklahoma City.
