Panama's Invaders Surrender

Bedraggled Band Says They Were Told Panama Ruled By Dictator

PANAMA (AP)—Cuban invaders of Panama who surrendered without firing a shot arrived in the capital as captives during the night in eight heavily guarded buses.

Informed sources said Fidel Castro's Cuban Embassy may seek leniency for the small band who threw themselves on the mercy of the Panamanian courts in laying down their arms.

Hundreds of curious Panamanians silently watched the 87 prisoners — one a woman — marched into jail.

They will be questioned before the government decides what to do with them.

A source with official connections reported antigovernment forces operating near the Caribbean coastal town of Nombre de Dios where the main group of the Cuban invaders gave up Friday.

The strength of the rebels was not determined. First reports did not indicate whether they were Panamanians who have been waging hit-and-run attacks against the government for weeks or new foreign invaders.

The back of the Cuban-backed expedition was believed broken, however.

The bedraggled band of revolutionists said they came to Panama on being told the country was ruled by a dictatorship — "but we were wrong."

Panama defenses — aided by U.S. planes patrolling the coast — kept on the alert against the danger of more invasions.

Justice Minister J. D. Bazan said the government was still on the lookout for two more invasion ships which reportedly left a Cuban port. But, he said, "they may have turned back in view of the failure of the first expedition."

The surrender of the party that landed in Panama last weekend was carried out under the eyes of a fact-finding team of the 21-nation Organization of American States.

Fernando Lobo, Brazilian diplomat who headed the OAS peace mission, said he was checking into the possibility of a new invasion and so far found it to be "rumors, just rumors."

"If nothing comes of that," he said, "our mission is finished."

A Panama government said 87 invaders were captured. They are being brought to the capital after laying down their arms in Nombre de Dios, the small town on the Caribbean coast they seized after landing. Three of the revolutionists reportedly fled into the jungle rather than give up.

Lobo said the captives must face Panamanian courts and explain "what they explained to us."

Hammaraskjold Says UN Unable Play Berlin Role

COPENHAGEN, Denmark (AP)—Secretary General Dag Hammaraskjold said today practical considerations virtually bar the setting up of either a U.N. military or civilian political authority in Berlin.

He made the statement in a speech prepared for delivery in Copenhagen in which he stressed also the advantages as he saw them of holding an East-West summit conference within the framework of the U.N. Security Council.

Hammaraskjold spoke at a meeting of the Students Assn. He stopped en route to Geneva, where he will attend U.N. conference. He will be in Geneva when the foreign ministers of the

United States, Britain, France and the Soviet Union open their conference on Berlin and Germany on May 11.

He said there was no reason for him to prophesy as to whether a summit conference would be held, but he recalled that when such a meeting was discussed last year, the intention was to have it "with-in, or in intimate connection with the Security Council."

He said that should present plans develop in the same direction, it would mean that the negotiations would take place against the background of the U.N. Charter which stresses the obligation of finding a peaceful solution to international disputes.

Hammaraskjold referred to spec-

ulation that the big powers might decide to establish a "presence" in West Berlin as one means of easing East-West tension.

He commented that, while there have been no concrete proposals as to the type of presence, in his view "practical considerations alone" prevent a semimilitary arrangement, such as had been set up in Lebanon during last year's Middle East crisis.

Hammaraskjold did not spell out what he meant by "practical considerations" barring U.N. semimilitary bodies in Berlin, but it was believed that both France and West Germany oppose such a course.

He called attention to the fact that the U.N. will be host to the foreign ministers in Geneva. He

said this reflects the fact that should the foreign ministers find themselves in need of U.N. aid, "they can ask for such assistance and will get it."

He said that negotiations within the framework of the United Nations have a special advantage. "One may agree or fail to agree to a foreign ministers' meeting on a certain question, for instance," he commented. "But only with difficulty is it possible to avoid entering a reply if the same question is brought before the United Nations in the prescribed form."

"The importance of this is increased by the fact that not the parties alone, but practically all the states in the world, are represented at the negotiating table in the United Nations."

Herter Reports To President Today On 'Successful' Meeting In Paris

GETTYSBURG Pa. (AP)—Secretary of State Christian Herter flew back today from Western Europe, where he had just completed talks in Paris and promptly reported to President Eisenhower.

He arrived at the Eisenhower farm home, where the President is spending the weekend, from Washington by helicopter and landed in a pasture only a few yards from the President's front door.

He went into the house immediately to report to Eisenhower on the Western foreign ministers' plans for negotiations with Russia at Geneva on German problems.

On his arrival in Washington Herter said the Paris talks with foreign ministers of Britain,

France and West Germany were "very successful" in deciding on the Western position for the Geneva negotiations starting May 11.

"Both in spirit and in substance," he said, "we reached complete agreement on a highly important Western position."

"This should assist us greatly in making progress at Geneva if the Soviet Union demonstrates an honest desire to negotiate."

Herter was asked whether the "complete agreement" he reported at Paris had been reached because the Western foreign ministers made no attempt to settle many details.

"We settled every detail that came up," Herter said.

He was asked whether he is optimistic about the prospects for

the negotiations with the Russians at the Geneva foreign ministers meeting which will open May 11.

"If I knew what frame of mind the other fellow was in, I could answer that better," he answered.

Herter was met by Undersecretary of State Douglas Dillon, Deputy Undersecretary Robert Murphy and Deputy Undersecretary Loy Henderson his chief officials in the State Department. He said he plans to confer with former Secretary of State John Foster Dulles during the week end. Dulles is at Walter Reed Army Hospital suffering from cancer.

Herter also will report Tuesday to a closed-door session of the Senate Foreign Relations Committee.

Thursday evening he will tell

the nation by radio and television about Western plans and prospects for the Geneva Big Four foreign ministers meeting which will open May 11 and continue for possibly a month or more.

The impression among Washington officials was that Herter had done a good job in his first international conference as secretary of state. He met with the foreign ministers of Britain, France and West Germany in Paris Wednesday and Thursday.

At the end of next week Herter will fly to the Geneva meeting. This conference is due to cover the whole range of outstanding German problems, including the Soviet's demand for withdrawal of Western occupation forces from West Berlin.

Special Recognition Given 2 By Alumni Association

The East Carolina College Alumni Association presented awards today to a North Carolina teacher and author, three times a graduate of East Carolina, and to a faculty member with a record of 35 years of service to the institution. The honors were conferred at a luncheon in the North Dining Hall, an event of Alumni Day on the campus.

Mrs. Nell Wise Wechter, teacher in the Greensboro schools and author of the prize-winning juvenile novel "Taffy and the Torpedo Junction," received the annually presented Distinguished Alumni Award.

Miss Emma L. Hooper became the first recipient of the Alumni Association Recognition Award to a member of the teaching staff at East Carolina.

Miss Hooper, who joined the faculty in 1924, is a member of the Department of English. She has been associated in her work with each of East Carolina's five presidents and is known to alumni throughout the state.

For many years she has acted as advisor of the campus chapter of the Future Teachers of America, now a chapter of the Department of Future Teachers of North Carolina Education Association and the Student National Education Association. Under her leadership, the organization has several times received national recognition for outstanding work.

Since 1939 she has been a member of the Advisory Committee of the East Carolina Alumni Association. She has also served as president of the Greenville Branch of the American Association of University Women and has held important committee assignments in the local chapter of Delta Kappa Gamma, national honorary society for women teachers.

Miss Hooper was invited in 1957 to write a Golden Anniversary pageant dealing with the history of East Carolina College during its first fifty years. Her work "East Carolina's Spade" was presented on the campus May 3 and 4, 1958, before large audiences of students, faculty members, alumni, and other friends of the college.

A native of Mississippi, Miss Hooper now calls Memphis, Tenn., her home. She holds the bachelor's degree from Mississippi State College for Women and the master's degree from the University of Virginia.

Recognition of her work in education came as a result of her inspiration teaching of the American way of life. The first of two awards from Freedoms Foundation was for her small Dare County school a prize of \$750, and the second brought her national honor as recipient of the Freedoms Foundation Teachers Medal. As the outstanding Greensboro teacher for 1956, she won the Franklin McNitt Award.

She was already author of many articles for newspapers and educational journals when "Taffy of Torpedo Junction," a story of the Outer Banks of North Carolina, appeared in 1957. The book received during Culture Week in Raleigh the American Association of University Women Award for the best juvenile work written by a North Carolina author that year.

Mrs. Wechter is now preparing for publication in 1960 a second novel with a North Carolina setting, "Betsy Dowdy," a story of a young patriot during the American Revolution.

Mrs. Wechter is married to Robert W. Wechter, teacher of industrial arts in Greensboro, and also holds the bachelor's and master's degrees from the University of Virginia.

Special Session Being Talked

RALEIGH — A joint resolution may be introduced in the House and Senate requesting the Governor to call a special session of the General Assembly next fall to consider amendments to the constitution and modification of the judicial system.

The resolution has been drafted by Rep. I. C. Crawford of Bunncombe but will not be introduced, he said, "unless it appears necessary."

Crawford noted that committee work on the constitution and court proposals has progressed more rapidly the past couple of days and may require less time than was originally expected.

At the same time, he said, work of these two committees continues to be hampered by the large amount of pending legislation in other areas.

While he has not attempted to gain any sponsors thus far, Crawford said he has talked with a number of legislators and has found "right much sentiment in favor of a special session."

The resolution specifically requests that the Governor call an extra session "sometime in the fall of 1959, after Oct. 1."

The resolution notes "the magnitude and importance of the proposals and recommendations" on the constitution and courts and expresses the view that "hasty or ill-considered adoption of proposals or measures of such great significance to the people of North Carolina would be inadvisable."

Coed Kidnaped, Assaulted By Four-Man Gang

TALLAHASSEE, Fla. (AP)—A Negro coed from Florida, A.A.M. University was kidnaped and raped at gunpoint by four white men early today after a college dance.

Deputy Sheriff W. W. Slappey reported that the four men involved had been arrested a short time later with the gagged and hysterical girl still in their car.

State Atty. William Hopkins was questioning the four in Leon County Jail and announced that rape charges would be filed against all four.

Three of the men were listed as Patrick G. Scarborough, 20, a Tallahassee man reported A.W.O.L. from Ft. Fisher, N.C. Air Base; William Collinsworth 24, a telephone company lineman from Tallahassee; and David Ervin Bagley, 18, a Tallahassee high school student.

The fourth was a 16-year-old former high school student whose name was withheld.

Slappey gave an account of the case.

Two Negro couples from Florida A.&M. were parked in an automobile near the campus about 2:30 a.m. when an automobile containing the four white men pulled up alongside, he said.

At shotgun point the white men demanded that the two Negro girls get into their car. One of the Negro girls broke and ran, succeeding in getting away. The four drove off with the other girl in a wooded area several miles west of the campus. All four raped her, one of them twice, Slappey said.

The two Negro men, Thomas Butterfield and Richard Brown, both of Miami, called the sheriff's office. Slappey and a part-time deputy, Joe Cook, started out in different cars. Cook came upon the car with the four men and the Negro girl in it.

With the aid of other officers summoned to the scene by radio, he brought them to the county jail. Slappey said the four white men appeared to have been drinking heavily.

Humber Says Only World Law Can Insure Real Peace

Sen. Robert Lee Humber of Greenville addressed the Pitt County Bar Association yesterday at a luncheon celebrating Law Day, U.S.A.

Sen. Humber, lawyer and former business executive, asserted permanent world peace can only be established through the creation of an enforceable world law which would "nip evil in the bud before it becomes a public evil" in much the same manner that local, state and national law does.

Achievements of science, he said, have brought the world into a

relatively small community, and no community can expect to maintain order without law. Diplomacy which the world has used in an effort to maintain order, he declared, is enforceable only on the battlefields. But law is a rule of law enforceable in the courts.

He explained that under law an individual is held responsible for violations, but under a rule of diplomacy only a nation can be held responsible for the acts of its citizens.

The problem which faces this generation, Sen. Humber said, is

how to establish order in a world community. "Either we must banish war, or war will banish civilization. War now would be a carnival of insanity."

In addition to members of the Bar Association, representatives of the Senior Classes of each of the high schools in Pitt County were guests of the Bar Association luncheon. Harry M. Brown, president of the Bar Association, presided at the meeting, and Sen. Humber was introduced by William C. Brewer Jr., chairman of the Law Day Committee.

Perennial Issues Share Week's Activities Of N. C. Assembly

RALEIGH (AP)—A bill born out of Henderson strike legislation shared the legislative spotlight this week with such perennial issues as teacher pay and motor vehicles inspection for highway safety.

Administration forces joined in pushing along the measure to give arrest powers to National Guard troops called out to help local officers preserve law and order.

Backers described it as a step to prepare the way for Guardsmen to replace the State Highway Patrol on duty in Henderson, where a 5½-month cotton mill strike has been marked by frequent violence.

The bill moved to the brink of enactment before a group of House members stalled off final action until Monday night. Most of them did not oppose the bill, but asked to study it over the weekend.

Senators spoke their minds on pay raises for teachers and other

state employees in debating a resolution which would have directed the Appropriations Committee to put salary hikes—about 7 per cent for teachers, 3 to 4 per cent for others—in the budget.

The resolution, carrying the names of 25 of the 50 senators, was an impressive display of strength for the higher pay advocates. However, they lacked the two-thirds majority to suspend rules and pass the resolution. It was sent off to the Appropriations Committee, where a subcommittee is busy trimming spending proposals.

The House Roads Committee disposed of a measure to require mechanical inspection of motor vehicles.

Sen. Lunsford Crew of Halifax guided to Senate passage his bill designed to discourage births out of wedlock. It's now up to the House whether the measure, making it a crime for a woman to

mate children, becomes law. Minimum wage legislation, on the threshold of approval, was carried over by the Senate at the request of Sen. J. Emmett Winslow of Perquimans. The bill for a 75 cents hourly wage floor now is set for action next Wednesday.

The House already has passed the bill, and indications are the Senate will follow suit. Gov. Hodges and State Labor Commissioner Frank Crane have worked hard for its approval.

CAIRO, Egypt (AP)—A hermit monk who got rich telling fortunes and once prophesied his own murder has been found dead—murdered. The seer, Abdel Messia el Makrouky, was strangled and stabbed in the monastery where he lived near Assiut, in upper Egypt. He had been robbed of

about 35,000 pounds (\$100,000).

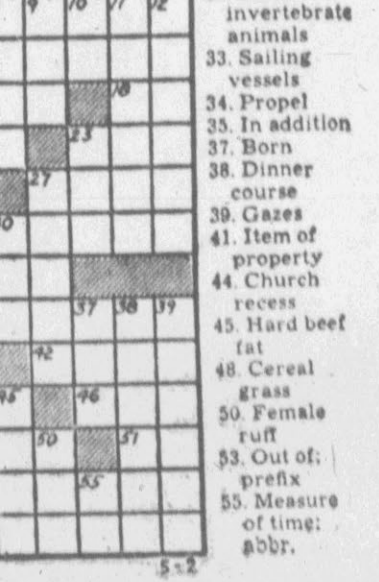
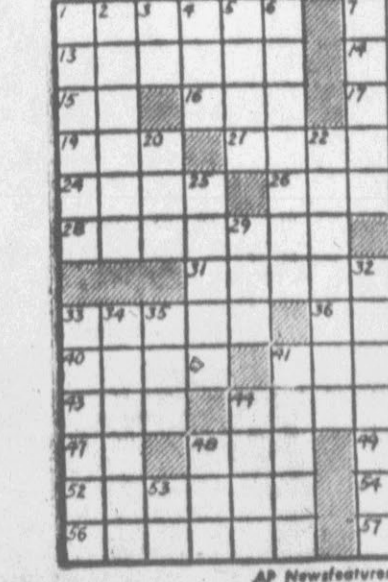

# Case Puts Diplomacy In Spotlight

Clare Booth Luce's decision to resign the post of Ambassador to Brazil even after overwhelming Senate approval of her appointment, was wise in the light of the row she has had with Sen. Morse and the adverse reaction the dispute caused in the Senate.

## No Community Can Tolerate Bomb Hoaxes

No law abiding community can tolerate such pranks as the bomb hoax on the East Carolina campus yesterday.

The outrageous prank was by no stretch of the imagination funny. It is a serious matter, taken seriously by law enforcement agencies, college officials, the 1,300 students who were attending classes in the building, and generally by the citizens of this entire community.

We trust local law enforcement agencies will leave no stone unturned in seeking out the person or persons responsible for the hoax.

In offering the \$100 reward for information leading to the arrest and conviction of the person or persons responsible for the hoax, it is the hope of The Daily Reflector that they will be brought to justice. It is also our hope that by the apprehension of the persons responsible for the hoax, other residents of this community who might be tempted to follow the warped example set by the prank will be discouraged from doing so.

The bomb hoax yesterday took college officials and law enforcement officers away from their regular duties to look for the bomb which the caller said had been placed in the building. It rendered the building useless for an hour and a half throwing some 1,300 college students out of classes for that length of time. In manhours alone—aside from the other aspects of the case—it resulted in a serious loss on the part of many people.

It is the civic responsibility of every citizen who may have some information helpful to law enforcement officers in their investigation of this crime to see that such information reaches the officers as quickly as possible. It is also the duty of citizens of this community to exert every possible influence to see that there is no recurrence of an incident such as this.

# Anyplace, Only 24 Hours Away

(Guest columnist today T. E. Pickard, Jr., Executive Vice President, Carolina Motor Club) Breakfast in New York and lunch in London—that's the menu for Tarheel business and vacation travelers in this newly arrived jet flight age.

Transportation-wise, jet flights have shrunk the world by 40 per cent.

Two International air lines—Pan American and British Overseas Airways—already have regularly scheduled jet flights across the Atlantic. American Airlines have them across the U.S., and National Airlines in flying jets from New York to Miami.

Flying time for the Pan American Jet Clippers has been reduced 48 per cent, cutting from 12 to 6½ hours the schedule between New York and London. This first American-built jet airliner, a Boeing 707, cruises at 375 miles an hour. This compares with the 353-mile-per-hour cruising speed on the DE-7C.

Among the first North Carolinians to take advantage of our "shrunken world" will be the 48 members of the Charlotte Chamber of Commerce Businessmen's Tour of Europe. These top business and industry leaders of the Charlotte area will confer with European leaders of similar business and professional interests in six countries from April 24 to May 10, strengthening the trade relations between the Charlotte area and the European countries.

No matter where an American business man or tourist may be in the world, he never will be more than 24 hours of flying time away from home.

This first Year-of-the-Jet will see an all-time record number of Americans going abroad, including an increased percentage of Tarheels.

During the last several years, North Carolinians have been obtaining more than 500 passports each year for foreign travel.

Most popular part of the world for these travelers is the Caribbean, with Europe a close second.

A notable trend is the increased number going to the South Pacific, to Hawaii in particular.

Mexico also is a favorite vacation spot for Tarheels. In fact, American tourists spent nearly \$650 million in Mexico in 1958, an increase of \$50 million over 1957.

Another mass movement of Tarheels this summer will be to our 49th state, Alaska, when a party of sportsmen will take advantage of the state's fabulous hunting and fishing in August. This jaunt is being arranged by a Charlotte newspaper.

According to a survey of 1958 travelers, people were more selective and price-conscious in planning their trips. This attitude is expected to continue this year.

As pointed out in her statement accompanying her resignation, she certainly could not expect to have the support of the Senate subcommittee on Latin American Affairs headed by Sen. Morse. In all probability, though she may have retained support of a majority of the members of the Senate, the controversy would prevent her doing the best possible job of bringing Brazil and the United States closer together in their relationships.

Mrs. Luce's resignation is an indication of the importance she attaches to the relationship between the United States and its Latin American neighbors. Had such a dispute arisen over the appointment of an ambassador to a European capital, there can be no doubt that it would have been reconsidered.

Why then should less importance be attached to our diplomatic missions to Latin American nations?

The United States for much too long as treated its closest neighbors geographically as second-rate friends in the field of diplomatic relations. We have failed to focus our attention on the needs of our neighbors as we have on other nations half-way round the world. We have failed to place the same emphasis on gaining a mutual understanding between this country and our Latin American neighbors that we have sought with other nations in Europe and Asia.

Though the Luce incident may momentarily cause some adverse reaction in Brazil and other countries to the South, it may in the long run open the eyes to the administration and Congress to the fact that the United States needs to give more diplomatic attention to the other nations of this hemisphere.

## Strike Settlement Talks Must Continue

Although settlement of the long and bitter Henderson Textile strike still appears deadlocked, efforts of mediators to bring an agreement from the dispute should be continued.

The violence in Henderson has gradually decreased in the past two weeks, but it remains evident that trouble will continue as long as the strike continues. It is also evident that Henderson, which has suffered severe economic losses because of the long and bitter strike, will continue to suffer from an economic standpoint so long as the strike continues.

To abandon efforts for settlement—even in the face of overwhelming odds that exist—would be a mistake for the parties in the dispute as well as for Henderson and North Carolina.

It may take time yet to iron out differences which block a possible settlement of one of the worst strikes in the history of the state; but for the good of all concerned, efforts toward settlement should by no means be abandoned.

## That Harmony Is No Surprise

By JAMES MARLOW WASHINGTON (AP) — There has been an unsurprising burst of harmony on both sides of the Iron Curtain.

Western diplomats in Paris Thursday, preparing to meet the Soviet-Mexican-Germany "Three Big Powers" summit, claimed full agreement among themselves on what they will talk about.

Earlier this week the Soviets and their European satellites met in Warsaw and proclaimed full agreement on their side.

The trouble with both displays of harmony:

1. The thoroughly cowed Soviet satellites could hardly do anything else but agree with whatever the Soviets want to say or demand at Geneva. So this harmony with window-dressing.

2. The Western diplomats — the foreign ministers of the United States, Britain, France and West Germany — could hardly afford not to show at least an outward sign of unity before the meeting with Gromyko.

So far the Allies have been on the defensive, but there by Khrushchev's November demands. And so far they haven't been able to think up anything to put him on the defensive. Up to now, therefore, the advantage has been all his.

Since the Geneva meeting later this month is supposed to be a preliminary and stage-setter for a summit meeting later, quite possibly both sides, while agreeing on nothing, will be on their good behavior.

A summit meeting will seem impossible if the foreign ministers at Geneva began the usual East-West program of mutual recriminations and denunciations.

## Other Editors Saying... Where Protection Aint

(Knoxville News-Sentinel) In a San Diego case just decided, the Supreme Court has widened the gap in the law which leaves the public unprotected against organized abuse.

Several unions pressured an employer to sign a union-shop contract. The employer declined on the ground that his employees were not interested and there had been no election to delegate one of the unions as bargaining agent. The unions then threw a picket line around the employer's place and put the heat on his customers and suppliers to boycott him. The California courts ordered the picketing stopped, until the employer had selected a bargaining agent, and awarded \$1000 in damages.

This action the Supreme Court has reversed. The court held the state had no power to act because the abuses of which the unions were accused are forbidden by the Taft-Hartley Law. Only the Federal Government can enforce that law. But the Government, through the National Labor Relations Board, had refused to take jurisdiction. This, said the court, didn't make any difference.

Now, we'll just leave it to the Supreme Court to say what the law is. But, as a moral proposition, doesn't this leave a lot of people in a devil of a fix? Regardless of the fine words in bodies of laws, Taft-Hartley included, a man can be harassed, pushed around, badgered and menaced out of his business. And nobody to come to his rescue. The victim will be the "small" businessman. Because the Labor Relations Board measures its jurisdiction by the size of the business and the degree it is involved in interstate commerce. The "little" fellow the politicians are always bleating about is left out in the cold — he's too little to commend the august attention of the Labor Relations Board and the court says his own state government must keep hands off.

Sometimes we think there is too much law and too little justice.

## A Card For Buying With Cash

By ELMER ROESSNER It had to happen. Now there's a card to be used when paying cash at restaurants and hotels. You get 10 per cent off the bill when you present your card.

This switch on credit cards is a project of the Rozee Bonus Card Club. Members pay \$5 a year for a card and booklet listing 2,500 restaurants and hotels across the nation. This isn't true, because out of that 7 per cent the companies must pay collection, accounting, advertising and other costs. They are probably lucky if they net 7 per cent of the 7 per cent.

They also point out that 7 per cent is a low price for collecting money these days and — this is their major appeal — people with credit cards are tempted to spend more than cash payers.

And in all sections of the country, hotels and restaurants are issuing their own credit cards. TIP: Local printers might pick up some card-printing business by soliciting hotels, motels and restaurants.

# Holiday Fun In Trailer

By BOB THOMAS LOS ANGELES (AP)—What's it like to take a vacation in a trailer?

When you're on the highway, you have the strange feeling that something is following your car closely. (Something is.) You're surprised when you can't make a quick getaway from a signal, and climbing hills is a bit of a strain. But on flat roads you scarcely remember what you're hauling.

Living in the trailer makes you claustrophobic at first. But then you become delighted at how cozy and convenient everything is.

These were conclusions of one family after a week's experiment in mobile living. It all started when another associated Press staffer, Jack Quigg, suggested we join his family on a trailer vacation. The suggestion sounded like a lark, so we tried it.

First, preparation. I pored over the California Vehicle Code to learn the laws about trailers. You can't drive faster than 45 m.p.h. You've got to have rear lights on the trailer and wide-angle side mirrors on your car.

Mobile homes of 30 feet and over cost from \$3,500 to \$9,000. But most trailers rented for vacations are 15-footers. They can sleep four comfortably, have gas stove and oven, electric lights, ice box and dining area. They are under 1,500 pounds. California state laws require special brakes and hitches above that weight. Rental in the Los Angeles area: \$25 a week.

Enough of facts, let's get on the road. I got the family car equipped with a hitch and reported to a company in Sun Valley to pick out a handsome 23-footer. Feeling the greenhorn, I asked executive Ken Dixon for driving instructions.

"Don't worry — it'll follow right along," he said casually. So I pulled out, the monster behind me. As Dixon suggested, it followed right along. I soon realized I didn't even need to make the wide, sweeping turns around corners.

At home, the parents and two daughters loaded the home-on-wheels with a hundred pounds of food, clothes, bedding, books, games, records, etc. Storage space everywhere. At last we were ready for the big adventure and set out on the Hollywood Freeway.

It's unnerving at first to cling to the right-hand lane with the old folks and trucks while the other cars go whizzing past. But you get used to it. You also learn to baby your load along, accelerating deliberately and anticipating the stops.

First stop was a trailer park near Palm Springs. We got parked — backing up isn't easy, as you may have suspected—and looked up to water, electricity and sewer. Then we began the trailer life. First impressions: Living is amazing simple — like camping out but with the comforts of civilization. Cheap, too. Park rentals averaged \$2 a night. Compare this to motel or hotel lodging, plus eating out.

2. Trailer folks are warm and friendly. But they don't intrude; there seems to be a mutual respect of privacy.

After two days in the sun, we pulled the plugs and headed south through the date palms and orange groves to Borrego Springs, a lovely, unspoiled section of desert amid rolling mountains. This was our first experience with no parking space: trailer facilities at the state park were full. So we found a privately operated park.

Carl and Olga Vogt, parents of five children, both work at other jobs to finance a swimming pool and other facilities for their trailer enterprise. We learned a trailer park is no small investment. The Vogts figure a \$1,500 bill for each installation.

Our trailer experiment was a success, a refreshing escape to the simple life. If you try it, I'd make these suggestions:

1. Don't try to cover too much ground. Pulling a trailer is more tiring than ordinary touring.

2. Make sure you'll have a place to park. Facilities are often crowded, and many parks won't take travelers, especially those with children.

3. Go with another family. It's more fun that way.

MARKETING COSTS FALLING, PROFESSOR FINDS A college professor disputes the idea that marketing costs are eating up an unduly large share of the consumer dollar.

For years, critics have said that packaging, advertising, display, and other factors in distribution have been taking bigger and bigger bites out of spending.

Not so, says Prof. Reavis Cox, of the University of Pennsylvania and president-elect of the American Marketing Association. The cost of marketing today is 47 cents of the consumer dollar, he estimated. This share, he said, has gone down, rather than up, since 1910. Mass economies made possible by mass production have helped offset increasing costs of food processing, he added.

He cites the example of scientists who hide behind statistics in justifying atomic bomb tests—the fact that only a small portion of 1% of the population will ever be affected. But this little percentage translates into 25,000 human deaths a year—many of them as yet unborn children, some in this very community, perhaps. . . . In this kind of reasoning, Cousins concludes, American education is faltering on putting out more and better scientists, we're forgetting to put out educated men, the kind of people who, ultimately, will be the only ones who can save the world. We advise you to read the article—it's very short—and weep. . . .

Compared with SOME COME RUNNING and other recent novels we could name, Lawrence's shocker is pale stuff—yet it is, according to such reputable critics as Jacques Barzun, Edmund Wilson and Archibald MacLeish, a highly artistic and moral achievement and deserves a respectable place on your bookshelves—so go and get it, 416 pp. beautifully bound, at \$6.00. . . .

Among the other candidates, two are seeking the mayor's post, being vacated by Corey Stokes, and eight are seeking seats on the town Board of Commissioners.

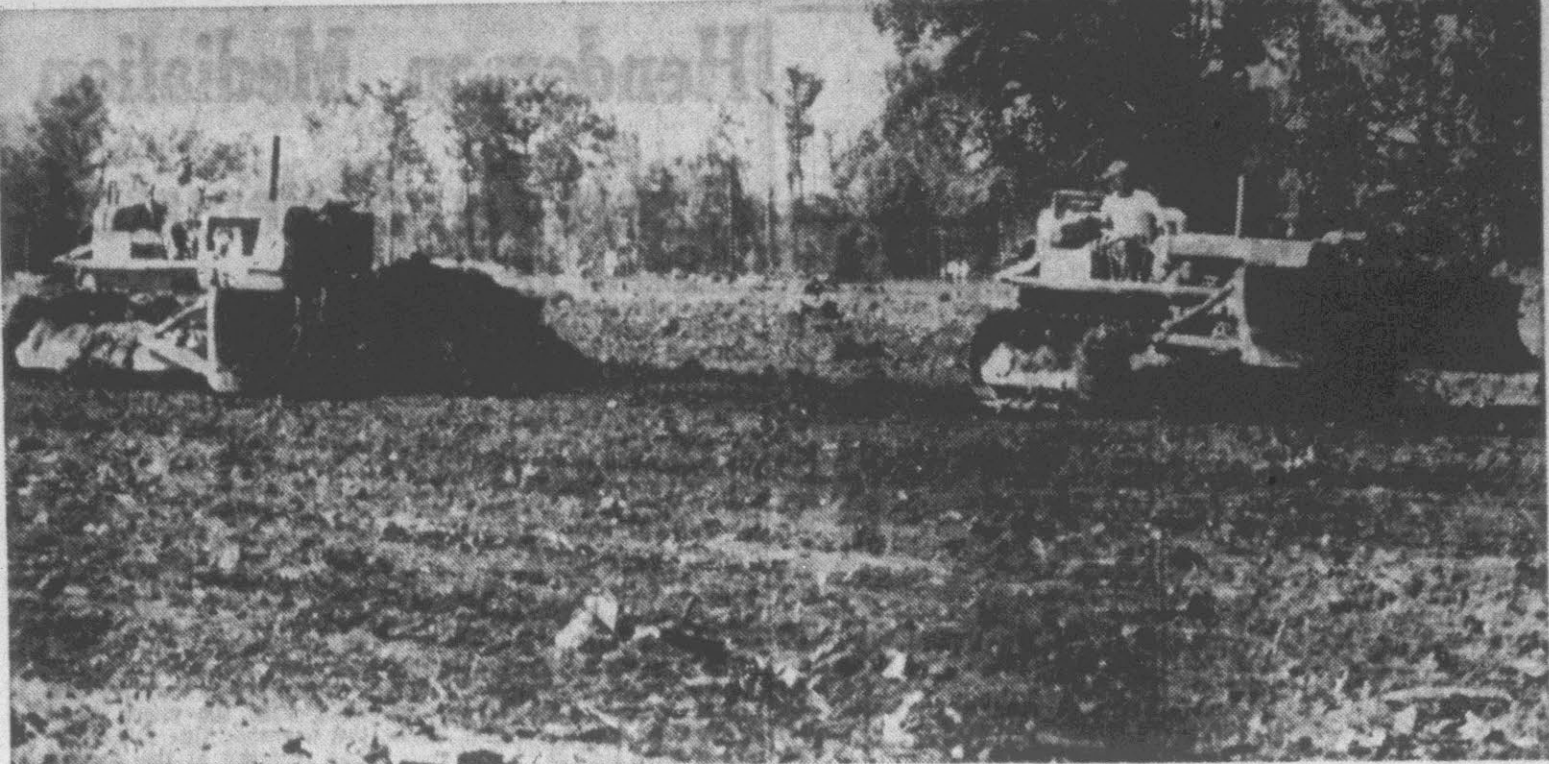
## Teacher Invited Visit School In Monterrey

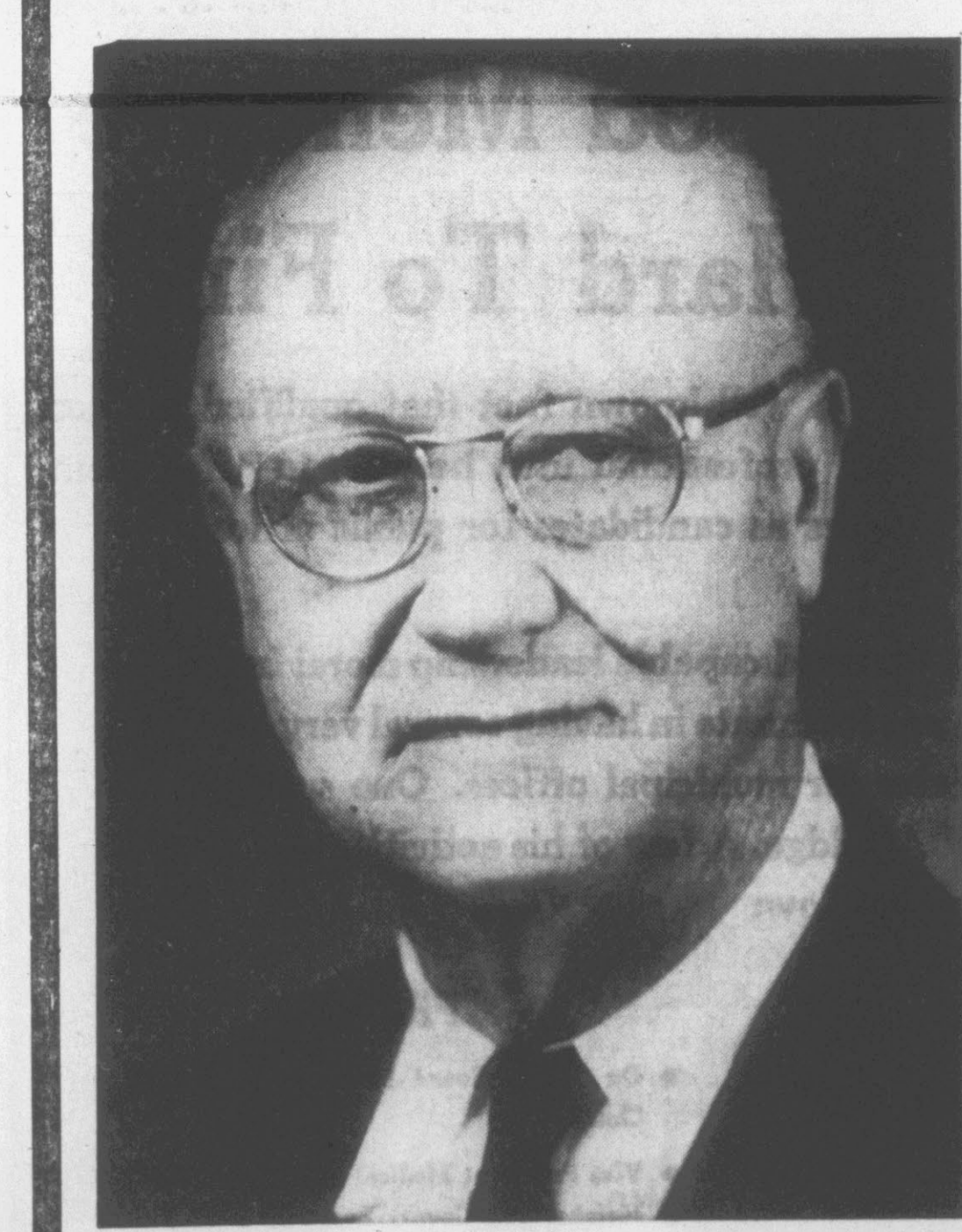

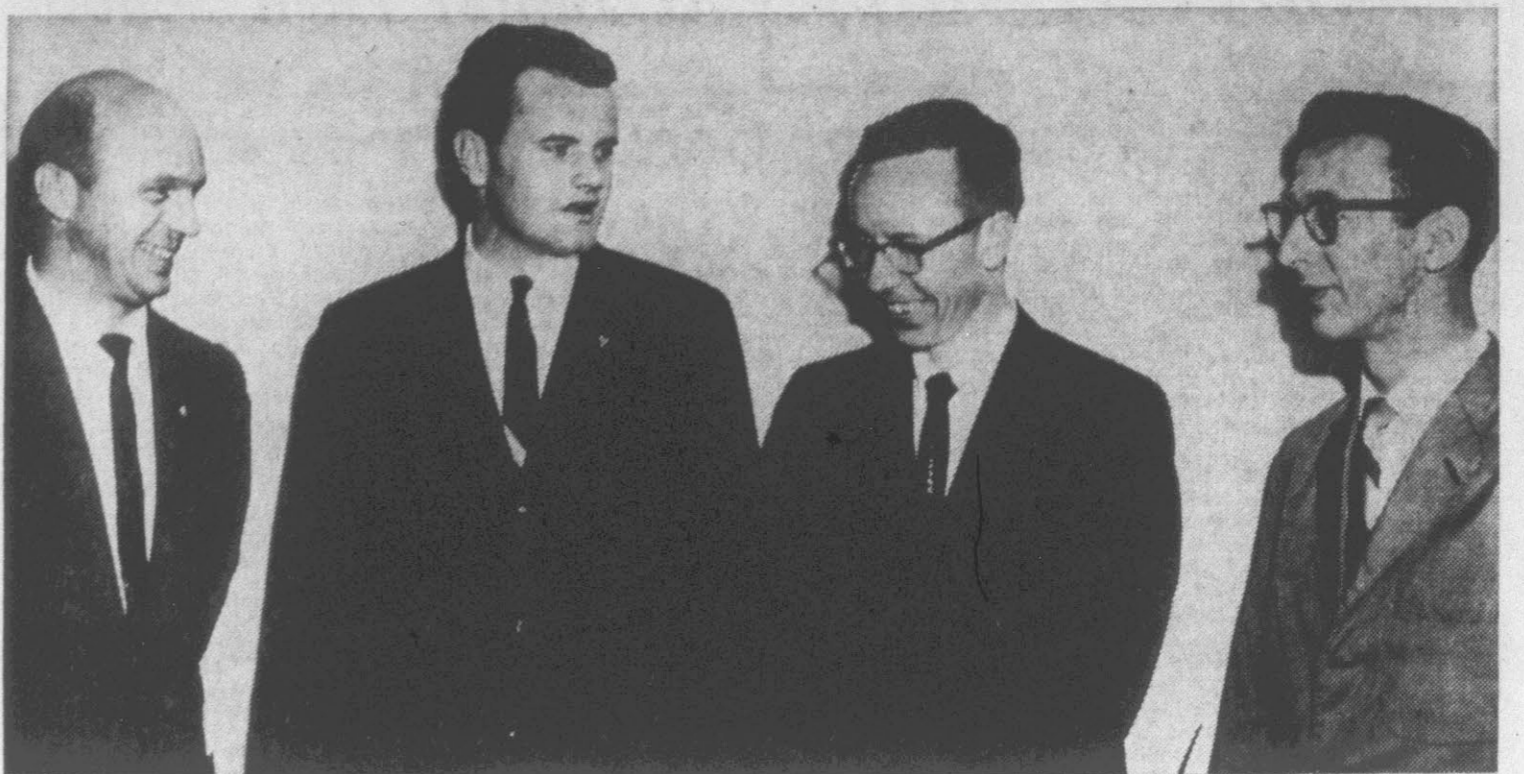

DES MOINES, Iowa (AP) — There's a sure-fire way to pick the Kentucky Derby winner.

All you need is an X-ray machine, an old broken down nag, and the imagination of a newspaper editor.

Paul Mickelson, late general news editor of The Associated Press and a crack-jack sports writer in the mid-30s, first told this story.

Back 30 or 40 years ago—no one rightly remembers—the New York racing writers weren't picking their good enough to suit editor and columnist Arthur Brisbane.

He called in Hugh Fullerton, one of the era's top baseball pen-and-inkers, and handed him the day's toughest assignment.

Fullerton was ordered to go to the race track and shoot X-ray pictures of the heart of every horse in a big upcoming race.

Fullerton naturally knew that no owner of a race horse would let an X-ray machine within a mile of the track on race day. But he was going to please his editor.

An old friend came to Fullerton's rescue. He had an old nag and they could shoot X-rays of it till the horses came home.

They shot every imaginable angle of that horse's heart. Fullerton labeled each plate with the name of a horse, and Brisbane scanned them very carefully.

Fullerton naturally knew that no owner of a race horse would let an X-ray machine within a mile of the track on race day. But he was going to please his editor.

Floyd Gets Warmup, KO's Brian In 11th

INDIANAPOLIS (AP) — Heavyweight Champion Floyd Patterson said he wanted a "warmup" and that's just about what he got in methodically chopping down Britain's Brian London in the eleventh round of their title fight.

It looked like the lithe, 24-year-old champ could pull the strings any time he wanted Friday night. Floyd pulled it at 51 seconds of the 11th with a jolting left hook to the jaw that sent the burly, 24-year-old Briton on his seat and then on his side for the full count.

Whether the New Yorker was stretching it out or fighting it out best as he could, the whole thing served to boost the spirits of Patterson's next challenger, Ingemar Johansson.

"I think I have a good chance of being the next heavyweight champion," said the handsome, undefeated Swede, Johansson, the European champion, meets Patterson at New York's Yankee Stadium, June 25.

"Patterson was taking it easy," Johansson said. "If he went out from the start and got down to business, he could have put him

out any time." For a time it appeared Patterson might blast out the 10-1 long-shot early. The fast-punching, 182½ Patserson rocked his 206-pound rival in the first two rounds and then seemed to ease up.

After that he beat a steady tattoo to the reddened body of his game, powerless foe. In the eighth he shook up London but it wasn't until the tenth that he finally floored him.

A right to the jaw dazed Brian and he stiffened for a moment. Then he slumped against the ropes until a left-right dropped him on

one knee. He was still in that position when the bell sounded at the count of five.

The end obviously was in sight and Patterson wasted no time in getting the kill. A barrage of searing body blows finished London.

London had practically no offense. Mostly he jabbed with his left and most of his shots fell short of his elusive target. Patterson slid under most of London's straight rights.

"If I didn't work on his body, I never would have got him at all," said the unmarked, undamned champion. "I noticed he was in pain from my body punching

to his right side as early as the fifth round. But he was tough and game."

Johansson is the No. 1 contender and I'll have to be better against him, I will be."

London wasn't too deeply disappointed at all. "I'm coming back to the States and learn to fight," he said, nursing a cut under his right eye.

He collected \$60,000 — that's \$4,000 more than he had earned previously in his entire career — for his first lesson in America. Patterson collected \$188,000 for his near shut-out victory. Referee Frank Sikora, imported

from Chicago for Indiana's first world boxing championship, had it 50-34 in points and 10-0 in rounds.

Judge Kelse McClure scored it 50-40 and 9-0 (one even), and Judge Marshall Baumgartner's tally showed 49-40 and 8-1. The AP card had it 50-39 in points and 9-0 in rounds with the third even.

The crowd of 10,088 and gross gate of \$122,885 in the Fairgrounds Coliseum was surprisingly good considering Indianapolis promoter Al Farb got the show from Las Vegas only two weeks ago. The coast-to-coast television (Indianapolis was blacked out) and radio fee added \$200,000.

ACC Dropping Its Regional TV Sports Program

GREENSBORO, N.C. (AP) — Regional television of football and basketball is out for the next year in Atlantic Coast Conference.

But activity in the area won't be denied the picture tube fans entirely. Less than three hours after the ACC voted at Friday's spring meeting to declare a year's regional TV moratorium, Duke and the University of North Carolina announced their football game on Thanksgiving Day would be televised nationally.

The Durham, N.C., game, originally set for Saturday, Nov. 28, was switched to Thursday, the 26th, Thanksgiving Day, when the opportunity to win a national TV billing developed.

ACC schools may schedule telecasts of their events if they do not conflict with an event at another ACC school.

After a 4 per cent assessment for the NCAA, Duke and North Carolina will split 50 per cent of the TV receipts and turn the other half over to the conference for division among other members.

Rex Enright of South Carolina, TV committee chairman, said a complete study and serious consideration of the regional TV policy will be made after a year of no telecasts.

The one-year ban was imposed after several schools had expressed alarm over lower attendance at games televised in the last two years.

In one of the most eventful and swiftest-moving meetings of its six-year history the ACC agreed on a ceiling of 140 total football and basketball scholarships, partial or full, labeled until December the basketball coaches' request to open the National Invitation Tournament at New York.

ACC teams had turned down Clemson's bid to have the football bowl receipts division formula revised to provide more financial breathing space for a school sending a team to the Gator Bowl, smallest paying of the major post-season contests.

Dates on which athletic grants-in-aid commitments are to be honored by conference members were set at May 15 for football and July 1 for basketball.

The following 1959-60 championships were awarded: Cross country, Duke, Nov. 16; swimming, Maryland, Feb. 26-27; basketball, N.C. State, March 3; wrestling, Virginia, March 4; track, North Carolina, March 12; tennis, N.C. State, May 5-7; golf, Duke, May 13-14; outdoor track, Maryland, May 13-14.
