Cargo Plane Crashes, Hits Chicago Dwellings; 7 Dead

CHICAGO (AP) — A cargo plane, returning to Midway Airport due to a fire warning, plowed into a house in rainy darkness just before dawn today and sprayed a sleeping neighborhood with fiery death.

Blocks from the southeast corner of the nation's busiest airport, a square network of runways and terminal buildings on Chicago's Southwest Side.

TWA in New York said the plane had landed in Chicago, discharged cargo and taken off again when a fire warning flashed on the instrument panel. The pilot began circling to land again when the crash occurred, TWA said.

In a flash a string of houses and apartment buildings near 634d St. and Cicero Ave. burst into flame. Firemen said 10 dwellings were set afire, some from the plane fuel, others from flames from those sprayed with gas.

Flights from all points of the compass use Midway. The rate of traffic is nearly a movement in or out every minute of the day and night.

The 116-foot-long four-engine Constellation was running behind schedule and was due in Chicago at 1:50 a.m. It left New York with a 6,576-pound cargo including an aircraft engine and other freight, 99 pounds of mail, and 106 pounds of express.

The State Patrol said the missing man was George Schaaque who was to have returned to Ellensburg from Seattle via Snoqualmie pass Sunday night.

The bodies of a man about 40 and a woman about 35 were brought to the morgue but were not identified immediately.

Played Unwilling Role In Escape

JEFFERSON, N.C. (AP) — "I didn't know they had already killed a man...that he was in that truck out there."

Her eyes were welling with tears and her voice was trembling as Mrs. Edd Sheets described her brief, unwilling role in the escape of five dangerous felons from an Ashe County prison gang.

She was alone Monday morning with her sick, 6-year-old daughter at their home about 15 road-miles north of Jefferson in the rugged Blue Ridge Mountain country.

"I had seen the convict truck go down the road. I never do rest until it's gone," said the 32-year-old mother of four daughters.

The truck carried 12 prisoners and three guards to the day's work assignment, a spot in the remote Cranberry Creek section. While en route, some of the prisoners cut a hole through the top of the wire cage.

When the vehicle stopped, five prisoners scrambled through the hole and onto guard William F. Handy as he dismounted. Handy was knocked down and disarmed. One prisoner shot work foreman Fields Absher, 55, near the heart.

Guard Judd Jones exchanged fire with the felons, but one of them held a gun muzzle against Handy's head and ordered Jones to drop his weapons.

"I didn't want to. God knows I didn't want to," Jones said. "But Handy was begging me. He was screaming: 'They'll kill me. They mean it.'"

The seven prisoners who did not participate in the escape pleaded with the felons not to kill Handy, as Jones had surrendered.

The escapees donned the guards' caps and uniforms and ordered Jones and Handy into the truck cage. The other seven prisoners loaded the mortally wounded Absher, a grandfather, into the cage also.

"I saw the prison truck come back and it stopped out front," said Mrs. Sheets. "One man got out and came to our door. He had on guard clothes and I figured he was all right."

Mrs. Sheets opened the door and the man, with aimed pistol, demanded the keys to her 1959 automobile. The five piled into the red-and-white car and fled.

Jones, Handy and the seven other prisoners rushed Absher to a hospital.

"He died before we got there," Jones said. "I don't believe he ever said a word."

The State Highway Patrol, assisted by city, county and federal officers, set up roadblocks in the northwestern section of North Carolina, trying to keep the heavily armed felons within the mountains where escape routes are few.

The five escapees and their sentences: George Brown, 29, Wilkes County, 22-26 years for attempted criminal assault, breaking and entering and highway robbery; James Waller, 35, Gibsonville, 3-5 years for auto theft; Tommy Styles, 27, Asheville, 18-25 years for robbery and larceny; John Allen Henry, 25, Miami, Fla., 10 years for armed robbery; Junior Burgess, 33, Hickory, 25-30 years as an accessory to murder.

Brown, Waller, Henry and Burgess were serving additional terms for previous escapes.

Two More Plan End Price-Fixing

RALEIGH (AP)—In the face of a thinly veiled warning from the attorney general's office, two more major oil companies today announced they are discontinuing price fixing operations under the state's fair trade law.

M. W. O'Haver, division manager for Phillips Petroleum Co., said his firm was following suit of Esso Standard Oil Co. in dropping fair trade.

Gulf Oil Co.'s district manager, F. C. Rogers, said in Charlotte that the company is removing its branded gasolines from under the state's fair trade law and is notifying all of its 2,200 branded gasoline dealers in the state of North Carolina of this action.

O'Haver said he had notified Atty. Gen. Malcolm Seawell's office of the decision. Seawell said Monday he would bring court action in a week or 10 days against oil companies still engaged in fair trading.

Seven major oil companies began fair trade operations last summer, dictating to their retailers minimum prices on gasoline. Since then there have been several abrupt swings in gas prices—up and down.

O'Haver said prices of Phillips gasoline had been restored to the levels before price drops last week—to 31.9 cents for regular and 34.9 for premium.

Of this decision to halt fair trading, O'Haver said, "We've been contemplating this for several weeks, but Gulf's price slash last week caught us by surprise. And Esso's decision to drop fair trade also was surprising."

He added, "The up-and-down price wars have been expensive."

Prices Strong

NASHVILLE, Tenn. (AP)—Tennessee tobacco growers pocketed nearly 4 million dollars as prices held strong on the opening day of the burley sales season Monday.

The State Agriculture Marketing Division said 6,046,998 pounds of burley were sold at 19 markets at an average price of \$64.61 a hundredweight. The average was 8 cents per hundred pounds less than the opening day price last year.

The burley netted growers \$3,955,394. New Tazewell had the highest average, \$67.66, on 411,104 pounds. Greenville, another East Tennessee market, was second with \$67.24.

Girl's Testimony Begins Case Against Browder

One hour and a half of testimony this morning from a 12-year-old girl began the state's case against James Henry Franklin Browder, 34, who is on trial here for rape.

Thirteen jurors had been selected—seven yesterday and six this morning before 10 o'clock—to hear the trial of the Greenville man charged with the rape of the young girl last May 6. She was 11 years old at the time of the alleged capital crime.

The girl's testimony accused Browder of the alleged act under direct examination by Solicitor Robert D. Rouse.

The defendant's wife, Myrtle Miller Browder, has been charged with assault with a deadly weapon in connection with a shotgun wound resulting in the amputation of his left leg above the knee.

Trial of Mrs. Browder's case, resulting from a shooting on May 29—about three weeks after the alleged rape—is also slated for this week's term of Pitt County Superior Court. Judge William J. Bundy of Greenville is presiding.

Local Production Credit Group Told Leaf Future Good

The tobacco situation for 1960 looks quite favorable.

This was the opinion of William Little, field representative of the North Carolina Farm Bureau who spoke to Greenville Production Credit Association stockholders here Friday.

Approximately 100 farmers from all sections of Pitt and Greene Counties attended the annual meeting.

Little said that the tobacco stocks being held by the Flue Cured Tobacco Stabilization Corporation in relation to the normal carry-over of flue cured tobacco stocks, is in the most favorable position since the Flue Cured Tobacco Stabilization Corp. was organized.

He predicted that the tobacco quotas for 1960 will be about the same as for 1959.

Little paid tribute to the Greenville Production Credit Association. He said that farmers uniting in their own behalf is necessary to this progress of agriculture.

F. L. Little, Jr., general manager, gave a report in which he cited the rapid growth of the local organization. It was pointed out by

the general manager that the capital and surplus and reserves of the local organization amounted to over \$900,000. He said that the loan volume has reached a peak in excess of 5,000,000 and that the organization is in a sound position to serve the credit needs of agriculture in this section.

Alton Gardner, chairman of the board of directors, presided over the meeting. Director Claude Grantham of Stantonsburg gave a report of the Board of Directors and the Executive Committee.

Director E. W. Fleming of Grifton gave a brief statement on the need for continuing the growth of capital.

The stockholders re-elected both Fleming and Grantham to succeed themselves as directors for three-year periods.

Greenville Production Credit Association is a locally owned corporation, extending agricultural credit on an intermediate and short-term basis to farmers of Pitt and Greene Counties. It has offices located in Greenville and Snow Hill. Other directors on the board are: Arch J. Flanagan of Farmville and W. F. Welfare, Jr. of Snow Hill.

Three Parachute, Pilot Stays In Falling Plane

RALEIGH (AP)—Three of four Army men parachuted to safety today just before their light plane crashed in Unstead State Park near the Raleigh-Durham Airport.

The pilot went down with the disabled craft and was injured. The airport's traffic control tower identified him as Capt. Brady. A report said he stumbled out of the wreckage, made his way to a farm house, and was taken to the airport.

Two of the other men in the plane were identified as 1st Lt. Paul H. Ray, 26, and the pilot, 1st Lt. Carl Ritz.

The plane was en route from Ft. Bragg to Newark, N.J., Ray said, when motor trouble developed near the Raleigh-Durham Airport. Ray, who had hitched a ride on the plane to Newark, said he was the first to jump out. Ray and another soldier had tossed a coin to see who would get a seat on the northbound plane, and Ray won.

Ray, whose home is in Moosup, Conn., said the pilot ordered the copilot and two passengers to bail out when it became apparent that the craft could not reach the airport.

Ray, a member of the 82nd Airborne Division and a veteran of many parachute jumps, said he bailed out at less than 1,000 feet. He was momentarily frightened when the chute failed to open. He pulled the rip cord a second time

and the chute blossomed out just above the trees, he said. He landed on a utility power line.

An unidentified lieutenant colonel, second to jump, landed on some telephone lines across a rural road from Ray.

Copilot Ritz landed about 100 yards away in a field. A man living nearby said he heard the plane sputter a short time before it crashed.

Ray said he immediately went to the wreck scene in a wooded area and found an unopened chute with some blood on it, and some blood on nearby leaves.

The L20 plane came to rest with its tail in the air.

Officials at the Raleigh-Durham Airport said the pilot received some bruises and scratches.

Humphrey To Tell In Early January

PHILADELPHIA (AP)—Sen. Hubert H. Humphrey (D-Minn.) said today he'll announce early in January whether he'll be a candidate for the Democratic presidential nomination and "right now it looks very encouraging."

"I'm unofficially campaigning for the nomination and officially taking a look at things, you might say," Humphrey declared in an interview.

Evacuate Thousands From Rising Washington Floods

SEATTLE, Wash. (AP)—Rescue teams continued today evacuating persons stranded by floodwaters in northwest Washington.

Thousands of acres of lowlands were under water, but there were indications some rivers were gradually receding.

The Snoqualmie River which had peaked Monday at 13 feet, dropped to 8.27 feet this morning.

The Green River was still on the rise, however, and the valley towns of Kent and Auburn, south of here, were still hard hit. Sheriff's officers and coastguardsmen were kept busy throughout the night answering calls for aid in the Green River Valley.

An Ellensburg, Wash., motorist was missing and it was believed he may have become the second fatality of the area's worst flood in 26 years.

A woman motorist was killed in a mountain pass car-truck accident Sunday night, the night the storm broke.

The State Patrol said the missing man was George Schaaque who was to have returned to Ellensburg from Seattle via Snoqualmie pass Sunday night.

A wrecked car, registered to Schaaque, was found amid mud and debris. The car was empty.

There was still no immediate relief in sight despite the lowering of some rivers. The damage to rich farmlands and homes was expected to run into millions of dollars.

Hundreds of persons have been rescued by helicopter, powerboats and amphibious craft from both the Green River Valley and the Snohomish River Valley to the north.

Some 500 Pupils Sickened By Carbon Monoxide Gas

STILLWATER, Okla. (AP)—Carbon monoxide fumes disrupted a huge choral festival and sent some 500 high school students to hospitals and first aid stations Monday night.

Many were ill with carbon monoxide poisoning. Others thought they were and had to be treated for hysteria. None was considered even seriously ill. Doctors guessed about 200 had varying degrees of monoxide poisoning.

The youngsters were part of more than 5,400 Oklahoma high school singers from 109 schools taking part in the eighth annual Thanksgiving songfest at Oklahoma State University. Another 3,000 or so persons filled Gallagher Hall to hear the massed voices.

About 200 school and charter busses were parked around the fieldhouse. About halfway through the performance many drivers started the engines to warm the busses for the trip home.

Weldon Barnes, OSU public relations officer, said the fumes apparently were drawn into the fieldhouse by air intake fans.

Hardest hit were the soprano and alto sections in the balcony at the south end. Girls out-numbered boys at hospitals and aid stations, about 10 to 1.

David Pursley, a Lawton High School sophomore, said, "I was downstairs and I turned around and looked up and saw them falling. I helped several out. I was walking around looking for some more to carry out and one girl who was seated in the balcony fell and hit the rail, then bounced toward the floor. I and two other guys caught her and took her to a room for oxygen."

The program was halted just before the final number, the Hallelujah Chorus from Handel's "Messiah."

from Gallagher Hall was orderly. But once outside many more youngsters became ill.

Ambulances, oxygen and doctors were assembled from Stillwater and communities surrounding this north central Oklahoma college of 25,000. Rescue parties formed quickly.

An unknown number of students went sent home as soon as busses could be loaded. The highway patrol said some of these became ill on the busses. Eight were hospitalized when they reached Tulsa, about 80 miles away, but none was in serious condition.

Around midnight weary instructors tackled the job of finding out who was well, who was sick and who was missing. Even then, a few became ill.

A very few were held in hospitals overnight. After treatment most were taken to college dormitories, fraternity and sorority houses and private homes for the night.

### Garden Therapist Is Speaker

Mrs. Ernest Harding, vice president of the Washington Garden Club, was guest speaker at the Greenville Garden Club meeting Friday afternoon. Her subject was "Garden Therapy."

Explaining the meaning of garden therapy, Mrs. Harding said though the term is comparatively new, the idea is "old as time itself" and has been carried on, unconsciously, for years. Its purpose is to seek out those less fortunate and help them to create something beautiful.

Garden therapy has become important in institutions, even penal institutions, as well as homes for veterans, the aged, and retarded, polio wards and tuberculosis sanitariums.

It needs "a dedicated person" to do such work, Mrs. Harding said. She herself has been chairman of Garden Therapy of the Washington Garden Club for four years. Her club has worked at the Beaufort County Nursing Home, providing materials such as pictures for scrapbooks, flowers for the making of floral arrangements or corsages, old teacups or painted tin cans and plant cuttings for fish gardens, the makings of Easter or May Day baskets, etc. "The important thing is that they do it themselves. Expenses are small, but the rewards are hundredfold," said Mrs. Harding.

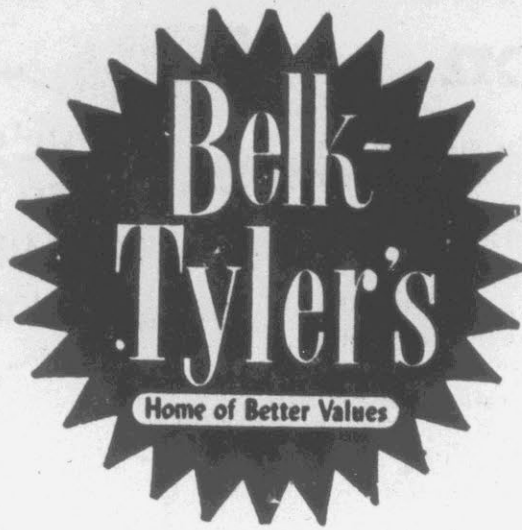

# Next Time, No Industrial Cushion

Will the steel strike be resumed after the 80-day cooling off period ends in January? If it does, will there be further steps by the government to attempt to end the strike or at least resume steel production?

Those questions have been kicked around since before the back-to-work order went out to members of the steelworkers union after the strike had idled most of the nation's steel production for 116 days. So far, no one has come up with a positive answer. The best the experts can do is speculate, and that speculation has covered a broad area of alternatives.

During the past weekend a spokesman for the steelworkers warned that the government should stockpile steel during the current production period in order to have enough on hand to take care of essential defense needs after the 80-day cooling off period. So far, according to the spokesman, there is nothing to indicate a settlement of the dispute will be reached by the time the injunction is dissolved.

The government will not be able to renew its injunction under the Taft-Hartley law after the 80-day cooling off period. Since the injunction has been in effect, there has been little from federal sources, the steel manufacturers or the union to indicate significant progress has been made toward a settlement. The latest offer by the companies was flatly rejected by union officials.

If the strike is continued in January, its effects on the nation's economy will be felt much more quickly and much more severely than was the case when steelworkers left their jobs last summer. Then there

was a huge backlog of steel put aside in anticipation of a strike. Most of that is gone now and even though steel production has been resumed thousands of workers in industries dependent on steel still have not been recalled to their jobs.

Steel production during the 80-day period will be gobbled up by users as quickly as it comes from the mills, and there will be no surplus for stockpiling. With no stockpiles, production in many industries will stop almost as soon as steel production stops. There would be no cushion to keep other industries operating for a period of time if the steel strike is resumed.

All of these things point to the fact that every effort must be made during the current cooling-off period to bring about a satisfactory settlement of the steel dispute in keeping with the public interest. Without a settlement, the country and its people will be in for another heavy blow because of the lack of steel production.

## Far-Fetched Case Of Blaming The Press

It seems far-fetched indeed that the newspapers of the nation should be blamed for the plight of cranberry producers and for the controversy which now rages over the red berries. Yet Dr. George Hiatt, head of State College's Animal Husbandry Department, would have the people of North Carolina and other states believe the whole matter should be blamed on the press.

Said Hiatt in an address to the Salisbury Kiwanis Club, "The cranberry market has been busted this year. Nobody is going to buy cranberries and all because of the freedom of the press." The speaker suggested that newspapers have overplayed the story, and by inference suggested they should have made the story—if it were reported at all—hard for readers to find.

Newspapers don't make the news. They merely report it. And they expect to be criticized from time to time for even doing that.

Had they chosen to do so, newspapers across the nation could have ignored the announcement by Secretary Flemming that some of the cranberries being offered this year were contaminated with a chemical which has caused cancer in rats. But in doing so they would not have been fulfilling their responsibility to the public. As the eyes and ears of the people, newspapers have the responsibility to report objectively the bitter as well as the sweet, the good as well as the bad in the interest of the public they serve. To do otherwise would be to disregard the tremendous responsibility which rests upon the free press in a free society.

In the case of the cranberry situation, it was something which might have affected the vast majority of the people of the United States because cranberries have become a traditional Thanksgiving food. As such it was important news that should be transmitted to the people. Moreover, it was of sufficient import for a member of the Cabinet to call specific attention of the public to it.

Though the press may be criticized for reporting the cranberry matter fully, it would be more deserving of criticism had it not reported the matter fully to the people of the nation.

## Offering Little But Personality

WASHINGTON (AP) — Cut through the smiles, handshakes and careful speeches and New York's Gov. Nelson A. Rockefeller seems to be saying of his rival, Vice President Richard M. Nixon:

"He could do it well but I could do it better."

In short, so far Rockefeller has been making a personality contest of his search for the Republican presidential nomination. He may have to keep on doing it or else try the high-minded approach.

For him the in-between tactic — political slam-bang — seems odd.

The odds against him—unless there is a change in events at home and abroad—are more than just the Vice President's head start toward the nomination.

It's no wonder that Nixon, an ambitious young man with two terms as vice president, has lined up so many Republican pros on his side. He has worked hard for them, for the party, for himself, and in his job.

Nixon, of necessity, almost has to be tongue-tied in these next few months as he tries to sew up the nomination.

Since he has been closely identified with the Eisenhower programs, policies, and performances he can't do much more than promise a continuation of them.

That seems to make good political sense right now when the country is highly prosperous and the world looks a little nearer peace than it has in years.

Nixon faces one big handicap. He'll be in the role of defender. He is hardest hitting when he can be aggressive—as he was against the Truman ad-

ministration—and not on the defensive.

But if Nixon, an important figure in the administration, is inhibited from criticizing or suggesting switches, the same limitation would seem to apply to Rockefeller.

As a faithful Republican, needing Republican support to get the nomination at next summer's convention, he can't afford to be very critical of the administration. If at all, without splitting the party.

If he wants to appeal to the independent vote, Rockefeller may even feel restrained about criticizing Democrats since he has to hope for every vote he can grab off.

Nor is Rockefeller in a good position to tee off on Nixon. Rockefeller's tearing him down to get the nomination, would be a wrecking job made to order for the Democrats if Nixon later becomes the one nominated.

But if Rockefeller can't lambast the Eisenhower administration, avoids knocking Democrats, and lays off Nixon, what claim can he have on the Republican nomination?

Through personality alone he might try to convince the Republican pros to pick him if they think Nixon couldn't win against a Democrat.

Or, he could offer new and constructive ideas to set him apart a bit from Eisenhower and Nixon but now so far that he will lose his Republican identity. That would be the high-minded, non-critical approach.

That might attract the independents, boost his standing in the polls, influence the pros. He's in a tough and delicate spot, although he has a big staff to help him get off it.

## More Business 'Going Public'

"Going public" has become a common term in business. It is so important now that the American Management Association has scheduled a five-day briefing session on "going public" at the Hotel Astor, New York, starting next January 25.

"Going public" is the offering of shares in previously closely held corporations to the public. It is a hot topic for these reasons: Many small corporations are finding it difficult to raise money for expansion. Bank rates are high. Many banks, on lending money at rates around 6 per cent, insist that part of the loan be left on deposit. If a quarter of the total must be left on deposit, the effective rate becomes 8 per cent; if a third must be left, the effective rate becomes 9 per cent.

### Advises Saving Of Cotton Crop

RALEIGH — If the crop is made, it's generally worth saving.

That's a State College cotton marketing specialist's advice to cotton farmers who are asking if their crop is really worth picking after so much rain.

The specialist, Elton Thigpen, says about 20 per cent of the cotton crop in Southeastern North Carolina is still in the field. In Northeastern North Carolina up to 35 per cent is still in the field.

"It's too late to consider production costs," Thigpen said. "A farmer must now think of how he can cut his crop loss."

Ninety-four per cent of all the cotton classed at the Raleigh Classing Office last week had a support rate of 22 cents or more a pound.

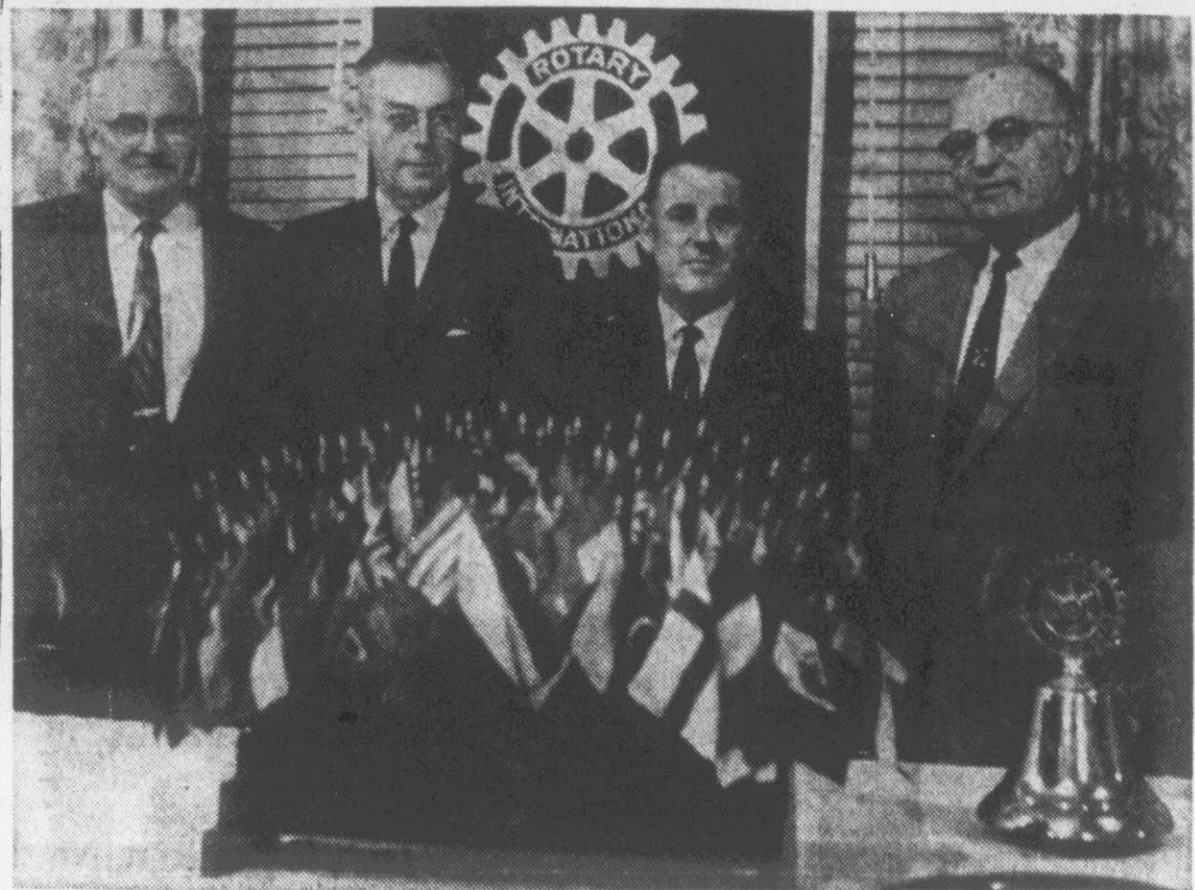
If it takes 1,600 of seed cotton to turn out a 500-pound bale, and it costs \$4 to get cotton picked, harvesting cost would be \$64 per bale. Ginning cost is not likely to exceed the seed value more than about \$5, and marketing cost should not be over \$2.

Therefore, the cost of harvesting, ginning, and selling a 500-pound bale should not exceed \$71. Most of the cotton currently being ginned is worth \$110, or more per bale.

"So if you still have cotton in the field," Thigpen concluded, "more than likely it will pay to harvest it as soon as possible."

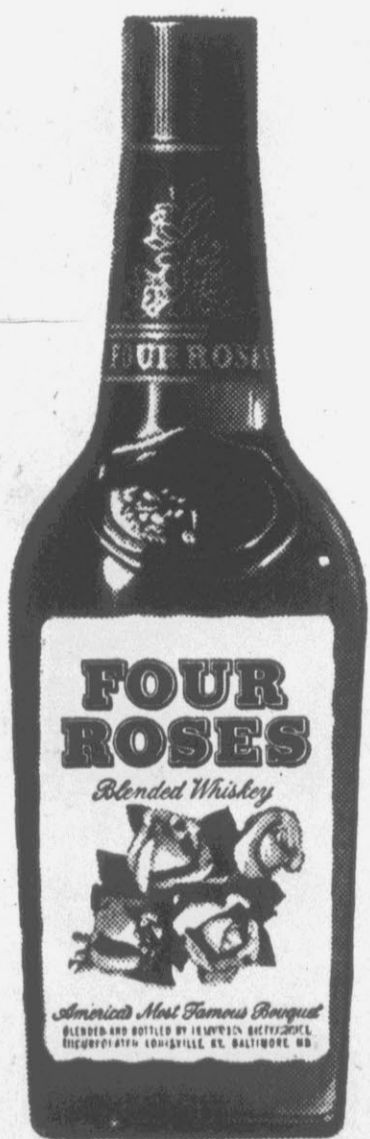

### Big Ed Plays Final

SPARTANBURG, S. C.—A blood-spattered face and a bruised hunk of mass were the trademarks of Ed Emory Saturday night as he tugged to remove the big number "48" from the final time during his college career.

East Carolina had just suffered a 20-13 defeat to Wofford but the Pirate tackle had closed out his collegiate history in glorious fashion and had claimed the praise of Wofford officials.

The Buc co-captain continued to shed his gear in silence and it was like Charles Atlas stepping out of a comic book advertisement. Almost 230 pounds were packed on this frame and it was solidly constructed into what had become one of East Carolina's greatest linemen.

### Future Is Still Question Mark

The future was full of uncertainty for this clean-cut South Carolinian who had "rather play football than eat". Pro football was still in the picture and there was also a year to enter the coaching fraternity.

Digging into the football past of Emory was like going through the attic looking for the age-old history of your ancestors. His grid history is cluttered with awards and outstanding moments mere facts alone would easily fill a columnist's column.

Growing up in the wholesome atmosphere of a typical southern home, Ed first started his football in his native town of Lancaster, South Carolina. His first actual competition came in the Midget League during his third year of school. But being a husky youngster and a little rough too, his time in this league was limited.

### Starter In Fifth Grade

Playing in a state that does not confine the number of years that a boy can play varsity ball (only four years while in high school), the blond crew-cut kid gave varsity ball a fling while in the fifth grade and became a regular halfback on the Lancaster High club. He lettered that season and is still the youngest student to ever letter at Lancaster.

The next four years he was a fixture on the club and was named second team on South Carolina's All-State club during his eighth and ninth grade in school. With college scouts already hot on his trail, Clemson was the prompting factor that sent him to Camden Prep School to finish out his education.

While at Camden, Emory served as captain for two years and was named to the All-State Prep club for two years. He was also on the All-Southern Prep (Continued on page eight)

Syracuse, the only unbeaten, untied major football power, retains the No. 1 spot in the Associated Press poll of sports writers and sportscasters for the third straight week.

The powerful Orange polished off Boston University 46-0 Saturday and now have two weeks to get ready for their regular season finale with UCLA, Dec. 5. After that Coach Ben Schwartzwalder's men move on to the Cotton Bowl in Dallas.

Syracuse's finale with UCLA now looms as an important test that should measure their real ability.

The weekly voting produced a landslide for Syracuse with 121 of 174 first place ballots. The next best was Mississippi, the No. 2 club which drew 32 firsts, although it didn't play. Mississippi still has one to go, a Nov. 28 date with off-beaten Mississippi State.

Louisiana State held third place by whipping Tulane 14-6, closing out its regular season. LSU will play in the Sugar Bowl, Jan. 1.

Eight of the top 20 have finished their regular seasons—LSU, Wisconsin, Washington, Arkansas, Illinois, Penn State, Pittsburgh and Missouri.

### Move To Curb Game Tensions

BLACKSBURG, Va. (AP)—Prosecution of overeager pranksters and a possible cessation of athletic competition between Virginia Tech and Virginia Military Institute have been threatened in an effort to lessen tension between the institutions.

The warnings were sounded and the orders posted at both schools Monday after new incidents which saw an unarmed VMI student guard assaulted on his post and an impending mass demonstration of cadets at Tech averted just when it appeared things would explode.

Officials at both institutions called for peace and order and no further pranks. They hoped to keep the tension within lawful bounds until the football teams can settle things in a sporting way in the Thanksgiving Day clash at Roanoke.

This year the old rivalry is at a peak. The annual game will settle the Southern Conference championship.

A Sunday incident, in which six Tech cadets corralled a lone VMI cadet at Lexington and held him captive at Blacksburg 90 miles away, touched off the furor.

VMI's superintendent, Maj. Gen. W. H. Milton, called in the county prosecutor for a possible legal move against the kidnapers, then held off action when Tech announced it had suspended all six for the present school quarter.

### Duke And UNC Play 'Classic' Thursday

Duke and North Carolina close their seasons Thursday, but it's not just another football game.

It's the 45th staging of one of the classic rivalries of collegiate football.

It's the contest that will determine whether each team has a losing or a break-even season.

"It's the biggest one on our schedule," says North Carolina Coach Jim Hickey, "and the one we'd want to win the most."

Each team carries a 4-5 record into the Thanksgiving Day game in Duke Stadium, but the rivalry is so traditional that the game in itself—regardless of the rest of the season—almost can determine whether it was a successful year for the participants.

The Blue Devils and the Tar Heels first played in 1888. From 1894 until 1922, the series was discontinued, but it has been annual since then. Duke has won 23 of the games, North Carolina 18 and 5 were ties. Duke won 7-6 last year.

Hickey and Duke Coach Bill Murray discussed the game in a joint news conference Monday. Each reported his team improved and in good physical condition.

Hickey said the Tar Heel improvement was in defense. Murray said the Blue Devils have improved in "general, over-all confidence."

At Wake Forest, Asst. Coach Ken Meyer in a scouting report to the Demon Deacons, said, "You can be sure we will throw the ball. But their big, strong linemen will no doubt put a lot

# D'Amato Maps Fight To Regain Manager's License

NEW YORK (AP)—A "shocked and dismayed" Cus D'Amato expects to get back his license to manage and second fighters in New York state through legal action.

If that effort doesn't meet with success, the National Boxing Assn. offers him a glimmer of hope he may be able to manage within its jurisdiction. That would give him most of the nation in which to

operate as manager of former heavyweight champion Floyd Patterson if Sweden's Ingemar Johansson will consent to meet Patterson outside New York.

"I have a legal contract for the return bout and I intend to fulfill this obligation," D'Amato said. D'Amato, whose license was revoked Monday by the New York State Athletic Commission, indicated in a statement relayed by attorney Edwin S. Schweig that his first move may be court action to upset the commission's action.

"I shall review the matter carefully with my attorneys and I believe that on appeal to the courts the drastic and unbelievable pen-

alty visited upon me will not be upheld," the white-thatched pilot declared.

The statement questioned the legal authority of the commission to revoke a license that had expired last Sept. 30, and asserted that if the commission believed he had done anything wrong it had the facts May 22, 1959, well before the Patterson-Johansson title fight, yet made no move of any kind until Oct. 26.

The wrong referred to, and on which the commission based its decision, was related to four charges, to wit: 1. failing to appear at a Sept. 14 commission hearing into alleged irregularities in the title fight promotion; 2. as

a licensed manager participating as a matchmaker and promoter in the title fight; 3. seeking to foist Harry Davidow upon Johansson as a manager, thereby attempting to control both contestants, and 4. failing to file after the fight a manager's financial report within the five days.

A fifth charge, that of consorting with Charley (Black) Antonucci, described by the commission as a gambler and an associate of bookmakers, was dismissed.

The commission ruling further clouded the already befogged heavyweight title picture as it pertains to a rematch between Patterson and Johansson.

Anthony Maceroni, NBA president, said in Providence, R.I., Monday night that his organization temporarily would uphold the ban, but that the NBA is leaving the door open for D'Amato to be heard by the association's grievance committee. Maceroni charged the New York Commission with mishandling the case. He said the charge D'Amato failed to appear Sept. 14 wasn't justified as D'Amato was out of the country, and that the commission had ample time before the June 26 fight to take action on charges of D'Amato's alleged par-

ticipation as an undercover manager and his attempt to maintain control of the title by hand-picking managers of challengers.

Patterson now has no manager anywhere in the country, and to further complicate matters Rosensohn Enterprises, Inc., which holds the return bout contract, previously had its New York license revoked.

Bill Rosensohn, still holder of one-third interest in the promoting organization, Monday had his matchmaker's license suspended for three years.

Vincent Velella, New York attorney who now heads Rosensohn Enterprises, is talking of a Miami date in March for the rematch, but Edwin Ahlquist, Johansson's advisor, doesn't go for the idea. "Velella wanted it in Florida where I understand Mr. Tony 'Fat' Salerno (a notorious gambler) has his headquarters," Ahlquist said in Goteburg, Sweden. "There will be none of that now. We still prefer New York and I think the fight can go in the beginning of June."

In Geneva, Switzerland, Johansson reiterated his desire to give Patterson the first chance at the title. The champion obviously was elated when told that commis-

er Julius Helfand had said Johansson could pick up his \$152,000 purse for the June fight at any time. The purse is being held in escrow by the New York Commission.

"We have no contract on file for a return fight," Helfand added.

## 84,633 Golfers Play In Tourney

DUNEDIN, Fla. (AP)—A total of 84,633 golfers 7,375 of them women, took part in the 1959 National Golf Day Tournament.

Harold Sargent of Atlanta, president of the Professional Golfers Assn., said today the organization had received \$90,438.75 in entry fees and contributions by those who entered the event. It was played June 6 over 1,837 golf courses throughout the nation.

The participants competed against Dow Finsterwald, professional from Tequesta, Fla., who shot a 67. Using their regular handicaps or specially devised handicap systems, 3,372 men and caddies and 752 women beat Finsterwald.

Receipts from the tournament went to the National Golf Fund Inc. for distributions to golf charities and other projects.

## 'Dollar Duel' For New Grid League

MINNEAPOLIS (AP)—Organizers of the new American Football League girded for a dollar duel with the National League today in a scramble to land the blue ribbon names of college football. The AFL chose 264 players in a day-long draft Monday, planned to select at least 400 more within

a few weeks, and then announced it is squaring away to go into operations in 1960.

From the Minneapolis-St. Paul ownership came a firm assurance that it definitely will field a team in the AFL next year despite reports that a franchise in the National is open to the Twin Cities. Left unsettled, however, was selection of the new league's commissioner. The list was reduced Monday to two, unidentified candidates, one now in the college ranks and the other connected with pro ball.

While some AFL owners discounted predictions of a full scale bidding war with the National, it seemed obvious that the entrenched NFL would not yield easily in competition for the top players it wants.

It was clear AFL owners expected the lure of wide-open job opportunities to steer a lot of talent their way.

The nation's ranking stars were plucked early. Houston chose fullback Bob White of Ohio State and halfback Dick Bass of College of Pacific after picking Louisiana State's All-America Billy Cannon in the first round.

Boston named halfback Ron Burton of Northwestern and center Max Fugler of LSU. Buffalo picked halfback Ray Jauch of Iowa and end Jim Houston of Ohio State. Two of the South's finest backs, Johnny Robinson of LSU and Tom Moore of Vanderbilt were drafted by Dallas, whose first round selection was SMU's Don Meredith, a quarterback.

Denver drew quarterback Dean Look of Michigan State, New York took halfback Ed Kovacs of Cincinnati, and Los Angeles tabbed halfback Bob Jeter of Iowa and fullback Charley Flowers of Mississippi State.

Minneapolis-St. Paul, after naming quarterback Dale Hackbart of Wisconsin in Sunday night's opening round, added Iowa end Don Norton and halfback Abner Haynes of North Texas State.

Last fall, he played a guard slot and helped ECC revive its forces from a season that had produced only one win to a respectable 6-4 mark. He was named All-Conference in the North State Conference.

This year, he served as co-captain for the Bucs and has just completed his best season. He was moved to tackle but performed brilliantly at times. He is almost assured of All-Conference once again and is a strong candidate for All-State laurels.

**LAS VEGAS, Nev. (AP)—**Nelson Eddy singing "Shortnin' Bread" instead of Candy Barr stripping to the strains of "A Pretty Girl is like a Melody," and a nearly nude chorus line ordered back into costumes.

That's a result of an official campaign to improve the moral tone of gambling casinos in this desert resort.  
Both steps were taken Monday at one hotel. Another is fighting the county commissioners' demand that it fire its headline-female impersonator T. C. Jones.

The commissioners included Jones with Miss Barr and bare bosoms in what they termed unsuitable entertainment. Jones is appearing at the New Frontier.  
Hotel show producer Bill Miller said: "How can I fire him? (Jones). What's he guilty of? He's a great entertainer and has appeared at a lot of the country's top houses."

Owner Beldon Katleman of the El Rancho Vegas originally had refused to fire Miss Barr after authorities pointed out that she is appealing a 15-year prison sentence in Texas for possession of narcotics.  
Her appeal bond was vacated while she was dancing at the hotel and she was jailed until it was re-instated. She is an ex-girl friend of Mickey Cohen, onetime Los Angeles mobster, and there were rumors he had a part in her adventures with the bondsmen.

County commissioners held a meeting Monday to figure out a legal way to get the 23-year-old blonde fired.  
They told both hotels to show cause why they shouldn't lose their gaming and liquor licenses because of what the commissioners termed objectionable floor shows. Gambling and liquor sale profits are main-stays of the hotel men.

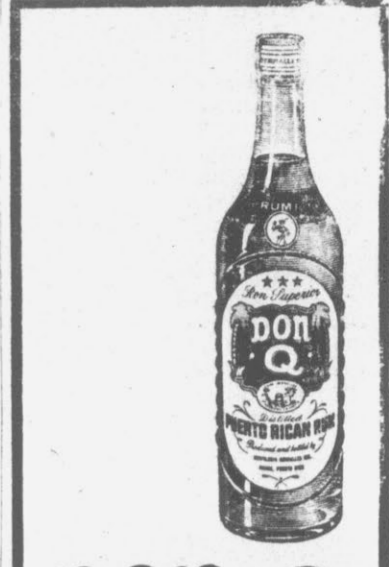
