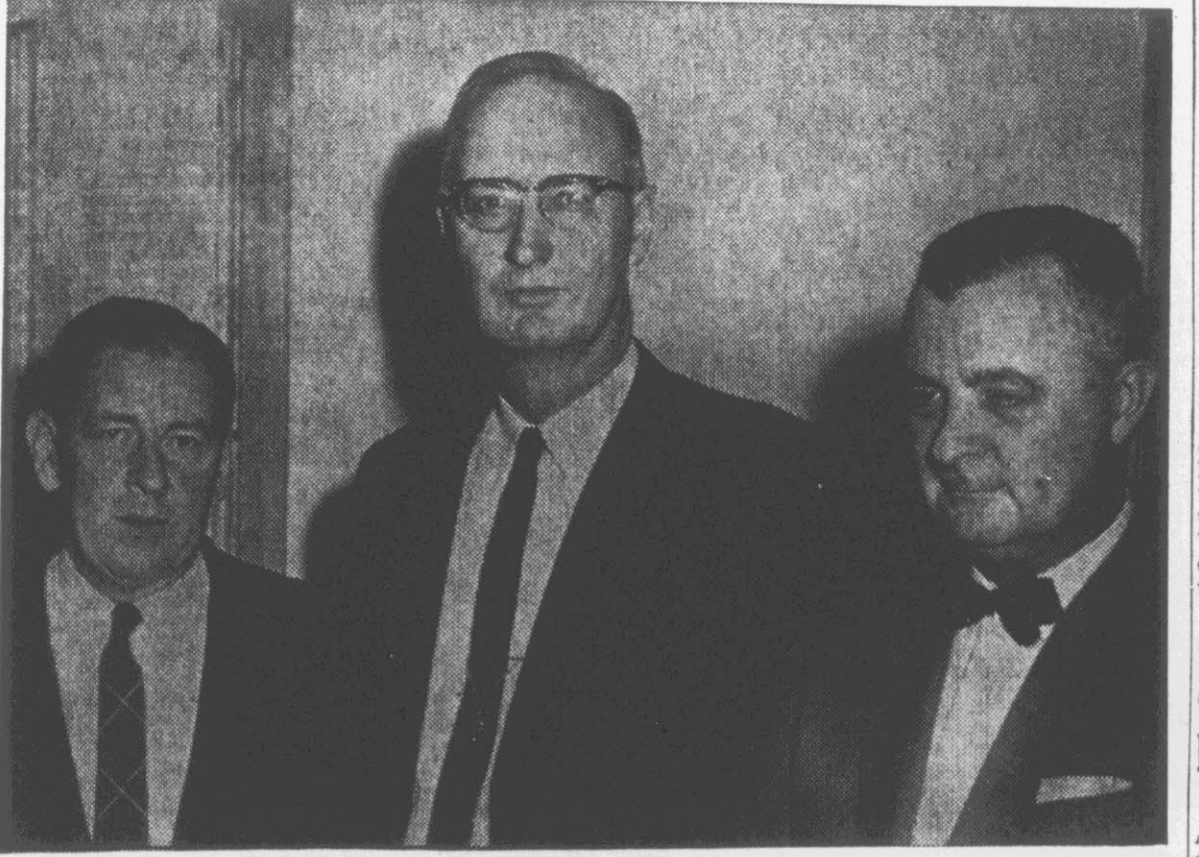

Mrs. T. M. Davis reviewed "The Recovery of Family Life" by Dr. and Mrs. Elton Trueblood, before members of the Round Table Book Club at their meeting Tuesday at the home of Mrs. R. B. Lee.

Chairman, D. H. Conley, program chairman, presented the speaker, Mrs. Davis. By way of her introduction, Mrs. Davis said being good parents, good homemakers and good wives is deeply rooted in being Christian, emphasizing that any reading we do to help strengthen our Christian lives is desirable.

Dr. Trueblood's book, "A Witness to the Value of Good Homes," clearly defines where we are and where we should be headed, the speaker said. Through five chapters, he suggests the home is being made an adjunct to other institutions, consequently "the withering way of life and the family," Mrs. Davis said.

Mrs. Trueblood in her chapters said a vocation is a "calling," and few professional women enjoy a life as exciting and satisfying as the American housewife and mother, whose job is one of service and commitment, with rich re-

wards, according to Mrs. Davis.

The sources of family strength, she said, lie in conviction and a living faith on the parents' part; in prayer as a part of living; in religious instruction and experience coupled with "a good climate" in the home; in a desire, by each one in the family unit, not to let the family down; in starting and continuing the Christian traditions; and in doing something about Bible study in the home.

The last words of the authors challenge everyone: "It is the responsibility of every reader of this book to feel this sense of vocation in trying to make his own home into a place where hristian revolution begins and to spread this idea to as many others as possible," Mrs. Davis quoted.

Presidential Trip Sure To Do Good

President Eisenhower's history making goodwill tour of 11 nations can hardly help but bring favorable reaction from many parts of the world that will strengthen the position of the United States in international affairs and likewise strengthen the unity of the free world.

A trip by an American president to Asia is long overdue and the very fact that President Eisenhower has made Asia one of the focal points of his journey should re-emphasize the fact that the United States is interested in the welfare of Asian people just as it is in the welfare of the people of Europe. In many ways the United States has tried to show this over a period of years—particularly during the period since the close of World War II—and the current trip by the President should impress that fact.

Another factor is that the President is going to see the heads of other nations rather than waiting for them to come to see him here in the United States. To some degree this may remove some of the coolness with which people in other countries have viewed the United States with all its wealth, power and plenty. The trip includes a crowded agenda of talks with heads of state and other high officials concerning a broad range of problems as well as the possibilities of a forthcoming summit conference between leaders of the free world and the communist world.

It cannot be expected that the trip by President Eisenhower will overcome all the mistakes this nation has made in its foreign policy and international rela-

tions over a period of years. Certainly it will not remove all of the misunderstandings and misconceptions about the attitudes of the United States toward a just peace and toward other nations of the world. Even so, it will afford the President an opportunity to clarify at least some of the questions in the minds of people of other nations and pave the way for better understanding and closer relationships in the future.

What transpires during the trip may well go a long way toward showing the people of other nations—that the President has said he hopes to do—that the United States is a "good partner" with other nations in the quest for a just peace.

Tobacco Stabilization Picture Is Improving

Genuine improvement in the position of the Flue-Cured Tobacco Stabilization Corporation because of the small amount of tobacco which went to the organization during this year is another factor that points to a sounder footing for tobacco producers in the years ahead.

During the 1959 selling season only 55 million pounds of leaf went to Stabilization because it failed to bring more than the support price on warehouse floors. It is a considerable improvement over 1958 when 145 million pounds of leaf was taken up by Stabilization, and hardly comparable with the 1956 season when some 320 million pounds were dumped on Stabilization.

By reducing the backlog of tobacco stocks on hand, the entire tobacco industry should find itself on a sounder basis than in recent years. Although the small amount of tobacco which went to Stabilization this year may be due in part to the short crop because of poor growing conditions, it was evident during the selling season that farmers produced a quality of tobacco this year which was more in line with the desires of the industry. It was a crop that the purchasers liked and were anxious to get.

If, in the next few years, farmers are able to continue to produce the kind of crop which meets the demands of purchasers, they will find themselves in a considerably better position. Stocks of tobacco held by Stabilization may be further reduced as a larger portion of total production goes directly to purchasers rather than into the pool of stocks held by the Stabilization Corporation.

The tobacco industry as a whole continues to face many difficult problems which must be resolved, but at least 1959 proved to be a beneficial year so far as reducing the backlog of stocks that have hung heavy over the tobacco industry in recent years.

Make The Rush Season Also A Safe Season

With the rush of the Christmas shopping season gaining momentum automotive and pedestrian traffic in the business section of Greenville and other cities and towns is getting heavier by the day.

This increase in traffic also increases the accident hazard for drivers and pedestrians alike. It is a situation which calls for greater care on the part of every person if the number of accidents and injuries is to be kept down during this busiest month of the year.

Of necessity, police officers will devote a greater portion of their time to directing traffic during the busiest portions of the day, but the officers alone cannot prevent accidents. Drivers must exercise more than the normal amount of care to observe traffic regulations in busy sections. Pedestrians must also exercise greater caution as they move from one side of the street to the other on their Christmas shopping tours.

It is the responsibility of every citizen to see that the rushed pre-Christmas season is a safe season in his community.

Unpredictables In His Mission

WASHINGTON (AP)—President Eisenhower's 11-nation journey, now underway, is a mixture of the certain, the unpredictable, and the ironic.

This much is certain, for he has said it himself: He will try to spread goodwill for this country everywhere he goes.

There are the unpredictables: What problems the various heads of government will discuss, what solutions they'll ask him for, his reaction and his health.

This is the ironic: Where he goes the Communists will probably turn out in mobs to cheer him.

At his news conference Wednesday Eisenhower looked in excellent health. But he is entering upon a rugged mission for a 69-year-old man who in the past four years has had a heart attack, an intestinal operation and a slight stroke.

He said his doctors think he can stand up all right. He knows there will be some fatigue. What he can't tell is how he will react to the various kinds of food put in front of him. And he'll have to attend a lot of ceremonial dinners.

No other President has ever embarked upon an expedition like this. But the country seems to be taking it calmly and, apparently, without any excited expectations.

That's natural enough. After these years of the cold war the lesson has sunk in that changes for the better come slowly. No one is expecting miracles, not even Eisenhower.

If the President had taken this trip early in the summer—before Premier Nikita Khrushchev's visit here and while the Kremlin was still acting tough—Communists everywhere would probably have tried to ruin any reception for Eisenhower.

Certain of these were ridiculously mistaken in the case of this young salesman. The Almighty often seems to take delight in sending his geniuses and prize-winners into the world disguised.

Teamsters May Re-Elect Jonas

JONAS—Jimmy Hoffa's teamster union may be responsible for the re-election of Republican Congressman Charles Raper Jonas in the 10th district. That, at least, is the opinion of some very astute Democratic politicians who naturally would like to see Jonas replaced by a good Democrat.

The reasoning goes like this: Jonas is known to have given serious thought to the idea of retiring at end of the current term. He has many times expressed the wish to get back to his law practice and to have more time with his family. Young David Clark gave him the hardest fight of his career last year, and was expected to be the Democratic nominee again next year—with another hard-fought general election campaign in the offing. Jonas' close friends say he was beginning to wonder if it was worth the effort and strain.

Then the teamsters union came out with a blast against Jonas, saying he had to be defeated for re-election because of his votes in Congress—which big labor officials did not like. Dave Clark was quick to disavow any desire for teamster endorsement. Clark might not win in the Democratic primary, and some other candidate might accept that kind of labor support. What it would be worth in that district is problematic. But the damage had been done to Democratic prospects.

Jonas is not the kind of man to run from a fight. The threat of big labor to defeat him may have been just what it took to assure his staying in the race—and making all-out effort to win.

"We had better than an even chance with Clark or any other good candidate to beat Jonas," said one Democratic leader. "And I think we could win easily over any other Republican. But it looks now like Jimmy Hoffa might have re-elected Jonas."

LOST COLONY—Before the meeting of the Roanoke Island Historical Association this week someone quipped that "the fate of the Lost Colony drama is as much a mystery as what happened to the colony itself more than 360 years ago." After the meeting another person observed that "if the members of the first colony had shown as much stubborn determination to hold on as the sponsors of the historic drama are now showing they wouldn't have gotten lost in the first place."

From inception of the drama in 1937 there has been question at end of each season whether it could operate the next year. It has operated every year except three war years when dim-out on the coast was more responsible for suspension than lack of money.

Folk Remedies, Anyone?

Remember that contest All State Insurance Co. was running to turn up home remedies in North Carolina?

We received several of them from the company the other day.

The letter said all of them were received from this area.

Here they are, although we'd hardly recommend them for general use.

Take three eggs laid the same day and place them without breaking the shell, in a small china bowl. Pour in enough vinegar to cover them and wait four - five days for the shell to be dissolved. Then break the residue skin and remove them (the skins). Blend the egg yolks thoroughly with present vinegar and dilute to one-half pint with vinegar. Add one-half pint of natural honey and mix well. Shake well before using each time. Take three teaspoons daily.

For Asthma
For Sprains
Take some dirt/dabber (mud wasp) nest and vinegar and

make into a poultice. Wrap poultice around sprain to prevent swelling and to remove fever.

Thrash (Babies)
Take powdered alum, natural honey, and borax and make in to a syrup. Mop babies' mouth after each feeding.

Dysentery
Take bark from root of a Shumash bush and boil for 5-10 minutes to make a tea. Drink a reasonable amount to cure — rid of dysentery.

So there they are—grand old Eastern Carolina remedies. Again let's make it clear that we don't recommend 'em. In fact just reading them makes us want to call an honest-to-goodness physician.

Other Editors Saying No. 2 Job Important

(Henderson Dispatch)

Far too little consideration has been given in the past by both political parties to selecting their candidates for vice-president. Usually more importance has been attached to the pulling power geographically of the running mate for the presidential nominee than to the actual fitness of the vice-president for the big job should he be called upon to take over the reins of government in event of the death or incapacitation of the president.

Death of President Roosevelt in 1945 placed new emphasis on the qualifications of the vice-president. Two serious illnesses of President Eisenhower have only served to emphasize the issue anew.

Few chief executives have died in office across the years. But it is well to remember that death is no respecter of persons. It strikes at the high and the low and the rich and poor alike, and no one ever can say when that may be.

The 20,000-mile trip half way around the world by Eisenhower this month poses the problem again. Never before has any President undertaken so hazardous a journey. Every possible precaution will be taken to protect him, both in flight and in the stops he will make. All Americans will hope and pray for the safety of the President as well as the success of his mission. But the trip is fraught with danger, despite all the potential good that may result.

So that when the Democrats and Republicans assemble next summer to name their national tickets, they ought to put up a man for vice-president who

is fully as qualified to be President as the man specifically chosen for that office. If geography fits into the picture, well and good. But certainly the qualifications of the candidate far outweigh that element in the appeal to voters, and the actual welfare of the country.

Vice-President Nixon has had more training and experience than perhaps any man in that office who has ever preceded him. He has been entrusted with greater responsibility and has been kept familiar with developments more intimately than any other. Even that, however, does not assure his nomination, nor his election if nominated by his party next year. But it does stress the necessity of pressing into service men who are thoroughly qualified to be President if they should be called upon to assume those duties.

Prospective nominees for president leave much to be desired in most instances. There is vast room for making a selection than merely an individual's burning desire to occupy the White House, or even his vengeful prowess. A rabble rouser could corral a sizable backlog of support, but who wants a president whose only, or at least chief, ability is that of swaying the public? It may be true that such things have happened in the past, but that helps matters not at all other than in gaining control of government and the power to distribute patronage.

The conventions next summer have their work cut out for them in advance. They should be mindful always of their duty to the country, which transcends even party considerations, regardless of party.

Threat Of Steel Strike Renewal

The threat of renewal of the steel strike hangs over the economy. When the 80-day cooling-off period ends, the strike may return in all its depressing fury. Business is perking now, heated by Christmas sales. But long range plans are difficult to make; few corporations dare to make commitments for new plants or new production lines far ahead if they aren't sure there will be steel—or if there is, how much it will cost.

Strikes are hampering other industries, and they are brewing in still more. Employment, now rising, will soon start turning down again. The midwinter seasonal dip may be accelerated by fresh walkouts.

Inflation is fomenting labor unrest. Administration spokesmen say inflation has been checked. But the cost of living continues to rise, by the government's own figures as well as your wife's reckonings.

TROUBLES ABROAD

American losses in Cuba are running higher into the millions.

We have yet to find a way to deal with Fidel Castro and his bearded ones. We don't like the company he keeps. But the barrage of criticism, the veiled threats to wreck the Cuban economy by cutting its sugar quota and wishful thinking in a loud sort of way seem to be pushing him into arms of Communist associates.

Most of these antagonisms flourish in private business; the State Department seems trying to be discreet. But it still has not found a way to deal with the revolutionists' American investments are losing lands and establishments. Even worse, American industry is losing part of its market.

Ineptness is losing the friendship of the Philippines. Twice in a lifetime thousands of American lives have been lost and billions in American property sent to free the Filipinos; today hatred for Americans is being whipped up. A cornerstone of our Pacific defense ring may crumble because neither the State Department, the Pentagon nor our

Congressmen found ways to handle the problem. Our trade with the Philippines is endangered.

TROUBLES BREW

We have messed up things in Panama. Sure, we have a valid lease. Sure, the Panama Administration will keep its word. But natives are jealous of the life we provide for employees in the Zone. They resent the Zone residents' attitude toward Panamanians. They dislike some of our high officials. Difficulties here can't hurt American industry much. Only Zone residents can afford to buy many of our products.

Peace still prevails in Guatemala, but the leftists are making common cause with the anti-Yanquis. Trouble may break out and again democracy may lose the country.

South of the Canal, the situation seems to be worsening. There have been some anti-American demonstrations in Venezuela, Brazil and Argentina. For the most part, Communist and anti-Yanqui activities seem contained.

But they may break through.

Office Party Answer

NEW YORK (AP)—The executives of many companies are worried about whether to have an office Christmas party this year.

They are afraid that if they don't hold a cheery staff get-together they will offend their employees. They also are afraid that if they do allow a holiday shindig the affair will get out of hand.

Horace McGrubb, chairman of the giant Acme Tiddlywinks Co., is one corporation head who doesn't have to worry about the party problem.

He solved it a week ago with a letter.

"With the approach of the holiday season, the question again has been raised whether the Acme Tiddlywinks Co. should have an office Christmas party. In the spirit of true industrial democracy which has always animated our firm, the management has decided this is an issue that should be resolved by employee vote," he wrote.

"The management is prepared to sponsor an office Christmas party on its premises the afternoon before Christmas, or, if the employees so decide, they can instead simply take the afternoon off.

"If an office Christmas party is held, the management naturally will shoulder all expenses. Wives will be invited, of course, as we regard them as essential partners in the operation of the Acme Tiddlywinks Co.

"A plentiful supply of refreshments, consisting of apple juice and sandwiches, will be supplied, courtesy of the management.

"A tentative program for the party has been drawn up. It will consist of the following:

"A short history of the Acme Tiddlywinks Co. to be given by Miss Winifred Myopia, head of our research department.

"A brief speech by President Horace McGrubb explaining why, because of the intense competition in the tiddlywinks industry, the firm will be unable to declare a Christmas bonus this year.

"There will follow an hour of parlor charades and a number of contests, including the three-legged potato sack race. This should provide a lot of fun for all.

"The party will conclude with an hour of gross Christmas carol singing, led by Mrs. Horace McGrubb, a gifted soprano who gave up a promising concert career to wed the head of the firm."

The letter was posted on the bulletin board.

Fifteen minutes later a spokesman entered the McGrubb's office and said:

"Sir, the employees have decided by a vote of 312-0 that they'd rather not have an office Christmas party this year."

And the Lord said unto him, Arise, and go into the street which is called Straight, and enquire in the house of Judas for one called Saul, of Tarsus: for, behold, he prayeth, and hath seen in a vision a man named Ananias coming in, and putting his hand on him, that he might receive his sight."—Acts 9:10-12.

"Then Ananias answered, Lord, I have heard by many of this man, how much evil he

this he that destroyed them which called on this Name in Jerusalem, and came hither for that intent, that he might bring them bound unto the chief priests?"—Acts 9:19-21.

"Then had the churches rest throughout all Judaea and Galilee, and Samaria, and were edified; and walking in the fear of the Holy Ghost, were multiplied."—Acts 9:31.

Thus Paul, feared and disliked by the disciples at first, became their greatest preacher of the Gospel.

Probably most of us have had the experience of knowing some person whom we were inclined to dislike and distrust, only to find that he or she was a fine person who became a close friend.

Love is a wonderful thing. Impress on the classes of all ages that a friendly attitude toward our acquaintances and even strangers or so-called "enemies," is Christ's way to live, and practice it always.

 Not now and for a couple of years. The Kremlin is pushing the peace theme vigorously since the Eisenhower - Khrushchev meeting and the "spirit of Camp David" is still floating around over the earth.

2. Khrushchev, who got along well with Eisenhower, wants a summit meeting. Any Communist demonstrations against the President might spoil the relationship and wreck chances for the summit.

If Eisenhower has any bad or embarrassing moments on this trip it will probably dampen his new enthusiasm for personal visits.

One thing may work to his great disadvantage. After making the rounds in Southern Europe, Northern Africa and Western Asia, Eisenhower will settle down several days in Paris for pre-summit talks with Western Allied leaders.

They will be discussing the position they should take next year in a summit conference with Khrushchev, particularly how they'll answer his demands that the Allies get their troops

Sports Scope

Good football backs seem to come and go at East Carolina College but it may be quite awhile before another Pirate ball carrier lives up to the feats and standards accomplished by James Speight during his four years as an East Carolina regular.

Speight has just recently closed out his brilliant career as a local athlete and he has been a recipient of a parcel of honors. Yet, one cherished and deserving title has always seemed to by-pass him.

Secret smiles throughout the state have been releasing their All-State selections but once again they have left off the name of James Speight—a boy that is classified as ECC's "greatest all-around halfback."

Going left off the honor roll of stars after a fine senior year was probably a little disheartening to the Greenville native but his trunk is already full of more honors than a four-star general could reap in twenty years.

His Fame Not Unusual

The stardom reached by Speight was nothing unusual to local fans for he was a talented youngster in his high school grid days. Being a local boy, he has always been the big favorite among ECC purists.

Speight was an exceptional athlete with more skill in football than an Einstein in the field of mathematics. He was the type of athlete that was "naturally" in shape. At times in practice, it looked as if he might be holding back but with the ball in his left arm—a habit that he had—he always left would-be tacklers sprawled on the ground.

When gametime rolled around, you could be assured that Speight would buckle his dancing shoes and become a Houdini in football gear. They say that good athletes never have bad nights and we can't recall a bad night for the boy that ran like a bull.

His senior year was his best by all means. He had a winning attitude that was sincere and his rigid training pace was an example for younger members of the squad. He realized that it was his last year and he made the best of it.

Never a real good blocker and tackler prior to this season, he learned the ropes to this trade and ranked as one of the most improved men on the club because of this. He shook running mate, Glenn Bass, loose often and little more could have been asked from his defensive play.

Had Pick Of College

While a high school star, he gained almost every recognition possible—from All-Conference to All-State. Starting as a guard with his bull-like 94 pounds, Speight started playing ball young and by his freshman year in high school, he worked into a regular's slot.

He went to the Shrine Bowl and East-West game during his senior year and played a starting halfback beside Wray Carlton, former star at Duke.

He had his pick of almost any college in the Carolina's but he chose to stay around home and East Carolina—a choice that he has never regretted. "I don't feel that I could have been happier at any other college and know that I couldn't have worked under another coach as fine and devoted to the game as Coach Boone (Jack)," notes Speight.

Leaves Rushing Record Behind

James Speight has hung up his cleats at East Carolina and next year will be a transition year—moving from the Speight era to another era. Behind him, he leaves a rushing mark that may never be touched and a name that will always be ranked with the All-Time greats.

Since his freshman year, Speight has been building a rushing mark that may long stand as an East Carolina record. He carried the ball only 38 times that first year but picked up 306 yards, averaging 8.1 yards per try.

His sophomore year saw him cop All-Conference and NAIA honors with another outstanding year although the Bucs won only one game.

'Best Back' In EC History

Billed as a Little All-American candidate his junior year, Speight saw the fates turn against him when an opening game injury sidelined him for over (continued on page eight)

Billy Cannon Heads AP All-American

By WILL GRIMSLEY Associated Press Sports Writer NEW YORK (AP)—Billy Cannon, Louisiana State's explosive halfback, is a repeater and unbeaten Syracuse is the only team with two representatives on The Associated Press 1959 All-America football team.

The team, representing every section of the country, is announced today after thorough sifting of the recommendations of 12 regional boards of newsmen.

Cannon, winner of the Heisman Trophy and top pick of the pros, leads a backfield unit which includes his Sugar Bowl opponent, Charley Flowers of Mississippi; versatile Jim Motley of Arkansas and Bob Schloredt, the one-eyed quarterback who guided Washington into the Rose Bowl.

Syracuse, the nation's No. 1 team, provided a pair of the huskies for the line—Fred Mautino, 191-pound, pass-spraying end, and Roger Davis, 220-pound guard whose alert blocking featured the Orange-men's rugged defense.

Opposite Mautino at end is Marlin McKeever, one of the ferocious twins from Southern California, and the other guard is Bill Burwell of Illinois, a former fullback. The tackles are Don Floyd of Texas Christian and Dan Lanphear of Wisconsin. The center is Georgia Tech's Maxie Baughan.

Cannon, 23 and father of three, has been the chief offensive weapon of an LSU team which has lost only one game in two years. Shotputter, weightlifter and a 9.5-second sprinter, he was the team's "climax" man — always coming through in the big moments.

A highlight was his 89-yard punt return in the final minutes of the touchdown which pulled out a 7-3 victory over Mississippi. He gained 538 yards rushing and returned punts, kickoffs and intercepted passes for an additional 54 yards. He averaged 40.3 yards on his punts.

Schloredt, who lost sight of his left eye in a childhood accident, is another all-around performer, equally effective on offense and defense. Acclaimed the best pass defender in the Far West, he also passed for 733 yards and five touchdowns, ran for 225 yards and scored 54 points.

Speed and deception are the trademarks of Flowers, a pre-law student whose shifty, stutter

style of running enabled him to rack 773 yards on the ground. He also distinguished himself as pass catcher, blocker, line backer and quick-kick specialist.

Motley, who once thought he might have to forego football because of recurring dizzy spells, instead left the dizziness to his opponents. He carried the ball 93 times for 519 yards, returned kicks for 171, scored five times and also starred as passer and receiver.

Terps Edge GW In First Game

By THE ASSOCIATED PRESS Maryland and South Carolina opened their basketball seasons with success against non-conference foes Thursday night, leaving only one Atlantic Coast Conference team, North Carolina, awaiting its debut.

Maryland, fired by Jerry Becht's push shot which gave the Terps the lead with a minute and a half to go, defeated George Washington of the Southern Conference 64-57.

South Carolina, opening against Erskine, claimed a 67-50 victory over the small college rival from South Carolina.

No games are scheduled for the ACC tonight, North Carolina, which had a 12-2 ACC record last season (20-5 overall), will open against South Carolina, 2-12 in the league last year, in a televised game Saturday afternoon.

Becht's goal, from past the foul circle, gave Maryland a 59-57 lead over the George Washington team, after a nip-and-tuck battle throughout the second half. The Terps led it with 5 more points.

Maryland's big scorers were 6-8 Charley McNeil and 6-8 Al Bunge, two of the conference's stars last season. McNeil scored 21 points, Bunge 22.

Quarterback Ralph Zehring finished second in the passing department and third in total offense. The Buc signal-caller accounted for more yards passing than any other passer but was short in total number of completions. He also led the loop in touchdown passes with nine.

Glenn Bass was the number two scorer in the conference with 86 points. Lee Farmer of Lenoir Rhyne finished at the top with 110 points.

In team statistics, East Carolina finished first in pass defense and offense. Their average of 119.6 was tops in the passing department and foes were able to pick up an average of only 72.0 per contest via the airways.

ECC finished second in total offense behind Lenoir Rhyne.

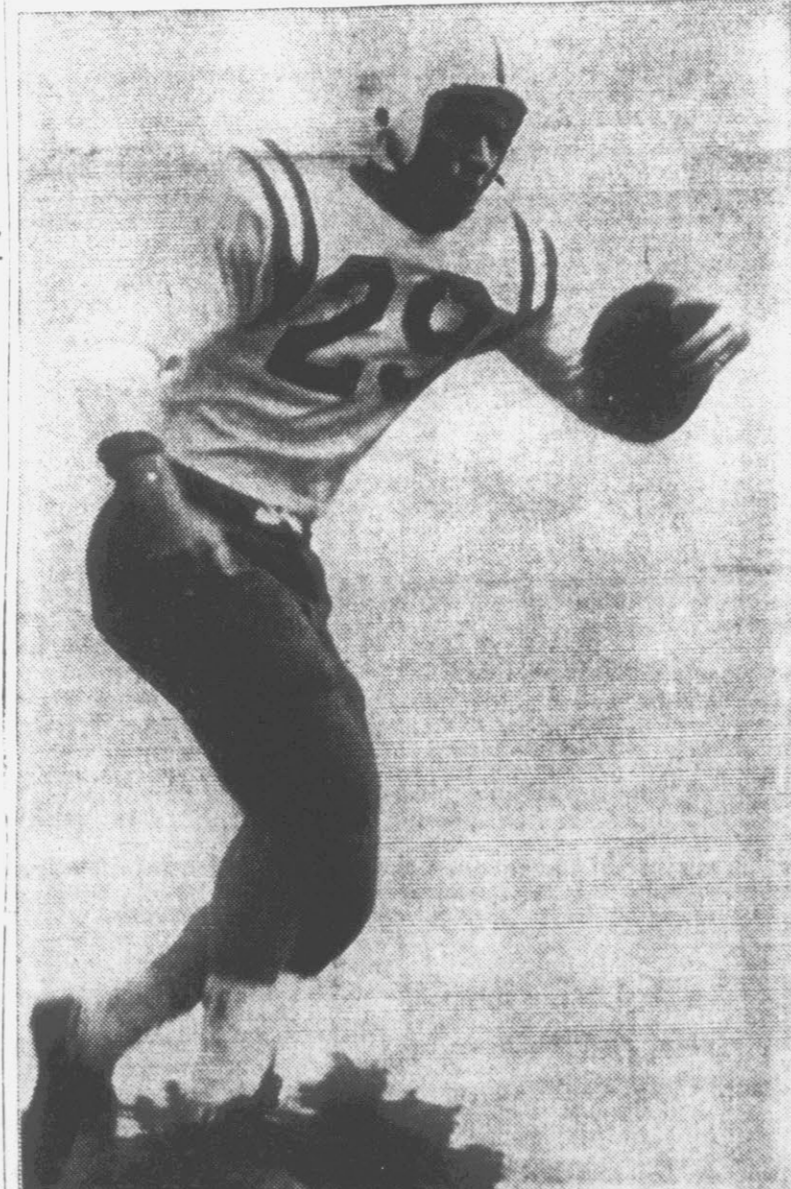

Ohio State keyed its attack to Lucas, who had scored 16 points in his debut, and this time he tossed in 34 in as the Buckeyes routed Memphis State 94-55.

Halberstadt, scored 28 points and kept the VMI Keydets in the game until the last few seconds before they yielded to William and Mary 79-78. Hadnot made only nine Providence points in an 81-59 decision over Springfield but he hauled in 16 rebounds. Davidson's Bussell (a mere six footer) was top scorer against Tennessee with 18 points but between them Test and Martin accounted for 28 as the Vols breezed to a 102-68 victory.

In some other noteworthy games Carnegie Tech and Slippery Rock played two overtime periods before Tech won 119-116. St. Francis (Pa.) beat St. Vincent 93-60. Maryland's finishing rally brought a 64-57 victory over George Washington. Georgia Tech beat Furman 91-63. Tulane won over Louisiana College 90-72. Miami (Fla.) defeated Jacksonville 106-98. Baseball In Civil War For New Talent

ST. PETERSBURG, Fla. (AP)—Baseball is trying to rescue itself from an expensive civil war for new talent. Alarmed by the high bidding in the bonus market, the owners are attempting to get things in focus.

The first-year player draft, re-adopted Thursday by the minor leagues is being hailed by many as a sound step in the direction of economy. Of course, it must be ratified by the major leagues next week in Miami Beach.

"The idea is to save us from ourselves," said Fresno Thompson vice-president of the Los Angeles Dodgers who proposed the new modified version of the draft. "We are trying to stop ridiculous spending."

"I regard this as a piece of constructive legislation," said Lee Mae Phail, general manager of the Baltimore Orioles. Both the Orioles and Dodgers are high bidders in the bonus race.

To the average fan this talk about first-year draft, bonus rule and waivers is confusing book language. The technicalities would baffle a lawyer. But the legislation could have far-reaching effects.

Let's try to explain by example. John Doe is a high school boy with many scouts camping at his door on graduation night. The bidding soars past \$50,000 and finally he is signed for \$100,000. The big league team that is putting up the money knows he isn't ready so he actually is signed to a minor league contract.

After one year in the minors, the big league team must make up its mind. Either it brings him up to the major league roster or it leaves him in the minors, where he can be picked up for \$15,000 by another big league team.

Since Villanova athletic Director Frank Reagan started the seasonal changeover by firing himself as head coach in mid-October, no fewer than 14 college coaching positions have been vacated for various reasons. Most of them still are open.

A few coaches quit for reasons of their own, usually because better jobs were available. Others "resigned" with obvious reluctance and some merely were told their expiring contracts wouldn't be renewed.

In the last class is the most mystifying move of all. Penny cropping Steve Sebo just after he had won the Ivy League Championship.

It turned out the decision to yield to alumni pressure had been made before the season started. But Penn didn't let out the news until John Steigman, the Rutgers head coach, had been hired as Sebo's replacement and John Bateman, line coach under Sebo, had taken the Rutgers job.

The result ought to make Sebo a candidate for the head coaching job at Illinois, where coaches so far have had security. Ray Elliot, who retired at the end of the 1959 season to become assistant athletic director, was only the second Illini coach in 47 years.

Nov. 18: Perry Moss, Florida State, resigned to become coach and general manager of the pro Montreal Alouettes.

Nov. 24: Eugene (Bo) Sherman, George Washington, resigned for what he said were "purely personal reasons."

Nov. 25: Clark Jarnigan, West Texas State, was fired.

Nov. 30: Chalmer (Woody) Woodward, Wichita, resigned after rejecting one-year contract.

Dec. 2: Bob Woodward, Florida, was asked to resign "in the best interests of the institution."

Dec. 2: Harry Larche, Toledo, quit after a 2-7-1 season.

Dec. 3: Mike Holovak, Boston College, resigned by request after a 5-4 season.

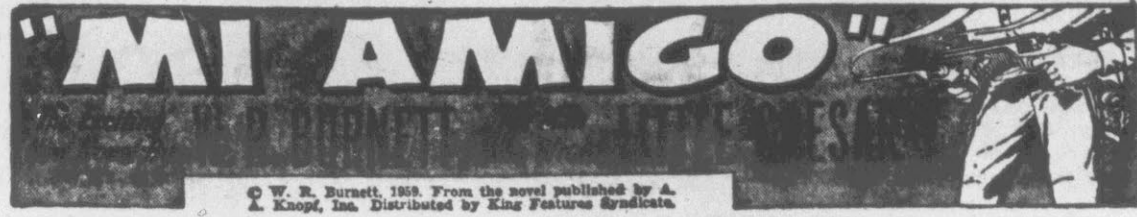

Peanut Acreage Allotments Set

All peanut farmers in Pitt County who grew peanuts in one or more of the past 3 years are now receiving notices listing their 1960 farm peanut acreage allotment. Walter A. Hasty of the County Agricultural Stabilization and Conservation Committee has announced.

The notices now being mailed give farmers plenty of time to make plans before they cast their ballots in the peanut quota referendum to be held December 15, Hasty said.

Acreage allotments to peanut farmers are based upon the National Peanut Marketing Quota of 930,000 tons proclaimed by Secretary Benson October 6, 1959 for the 1960 crop. The national acreage allotment was announced at 1,610,000 acres.

This national acreage allotment has been apportioned among the states on the basis of their share of the 1959 National Peanut Allotment.

The State's allotment was apportioned to farms growing peanuts in any of the past three years with consideration for previous allotments; abnormal conditions affecting acreage; land, labor, and equipment; crop rotations; and soil and other physical factors affecting the production of peanuts.

The farm marketing quota for the farm is the actual production of the farm allotment. Whether marketing quotas go into effect in 1960 will depend on the outcome of the referendum to be held December 15. All farmers who were entitled to share in 1959 crop peanuts planted for harvest as nuts on a farm on which more than one acre of peanuts was planted are eligible to vote.

"We went on living together for the year he was in the Army. Everything was the same, except that Ali had to hide on the balcony whenever the doorbell rang. When he got out of the army, we were married again."

"My son, Chris Rubin, hated living in Turkey. He had been back here with relatives, but I decided to return and give him some kind of home."

Miss Bruce lives here with Chris, 18, and sees her husband seldom.

Stock And Market Reports

NEW YORK (AP)—The stock market held a decidedly narrow upside edge early this afternoon.

Narrow changes were the order of the day as the market seemed to be having trouble in shaking off an irregular pattern. Steels and motors swung over to the plus side with mostly fractional gains, but observers noted many small losses on the list as a whole. Aircrafts were weak.

Rails mostly were lower, erasing some of their recent gains, while the oil group also turned mixed. Electronics had a brief spurt of popularity early in the session, then settled back.

A few specialties managed gains of a point and more, notably Hertz, Revlon and Fruehauf Trailer. Hertz was off Thursday while brokers thought Revlon's rise could be traced to a normal technical recovery after the beating the issue took during the TV quiz hearings.

Claim Break-Up Of Abortion Mill

NEW YORK (AP)—The district attorney's office announced today the breakup of a \$6,000-a-week abortion mill catering to college girls and entertainers.

Three men were arrested Thursday night at medical offices in midtown Manhattan.

The raid led by Asst. Dist. Atty. Lawrence Rowe, followed a two-month investigation.

The raiders said they found, in the office of Leopold Geel, a woman who had just undergone an illegal operation.

Geel, 53, who allegedly used the name Dr. Roy Gilbert, was described as having a British medical license but as not having obtained a New York license since coming to the United States last April.

In another office, the raiding party found Jan John Aldon, 65, and his cousin, Daniel Zaiberg, 65. A patient, accompanied by her boy friend, was in the waiting room, detectives said.

The district attorney's office said Zaiberg, preparing to leave for a world cruise in February, had been breaking in the other two men to take over the alleged abortion mill during his absence.

Charges against the men alleged that the mill handled an average of 10 abortions a week at \$600 each, with women patients coming from New England, Virginia and Washington, D. C., as well as New York.

The three were charged with committing abortion, which is a felony.

Low Quality Schools Laid To Poor Citizen Support

RALEIGH (AP)—An eastern North Carolina editor today blamed low quality schools on low quality support from parents and citizens.

Henry Belk, Goldsboro News-Tribune editor, emphasized the importance of improved education to the state's future. His speech was prepared for delivery to the 59th annual meeting of the North Carolina Literary and Historical Assn.

The session, which opened the fourth and busiest day of culture week, was devoted to an observance of the 100th anniversary of the birth of Charles B. Aycock, the state's educational governor. Dr. David J. Rose of Goldsboro, Aycock Memorial Commission chairman, presided.

Belk said the quality of high school instruction and of public schools generally reflects the demands and attitudes of school patrons.

"Create an attitude and atmosphere which requires high standards, which frowns on hasty or shoddy class work, and the level of accomplishment in the schools is raised," he explained.

Every Parent-Teacher Assn. in the state, he asserted, should have as one of its most important committees one charged with seeing that the talented child shall go on to college, even if the community has to finance it.

Belk also proposed steps to meet increasing college enrollment, including bus transportation for more day students, extension of evening classes, more extension activities, and community colleges in new sections.

Mrs. Belk read the speech for her husband, whose sight is impaired after an illness.

The morning session was followed by a subscription luncheon for Literary and Historical Association members.

The afternoon schedule included annual meetings of the North Carolina Folklore Society, the North Carolina Poetry Society, and the Executive Committee of the North Carolina Symphony Society.

Culture Week, a series of annual meetings by cultural organizations, will be climaxed at tonight's meeting of the Literary and Historical Assn.
