

President Calls On Ai To Join In War On Famine

NEW DELHI (AP) — President Eisenhower today called upon all nations to wage together a "generously noble war" against hunger and famine, the scourges of India and much of this part of the world.

The President, making three speeches in the course of a busy day, continued to be the center of almost worshipful masses of people.

"Men right now possess knowledge and resources for a successful worldwide war against hunger — the sort of war that dignifies and exalts human beings," he declared in opening the dramatic American pavilion at New Delhi's World Agricultural Fair.

In two earlier speeches he: 1. Called for an expansion of the universal recognition of world law as a sound basis of peace.

2. Declared summit conferences of the big powers have less enduring influence for peace than exchanges of students and people-to-people contacts.

A surging, colorful crowd of 10,000 Indians jammed the enclosed field at the fair to hear the President term India a mighty influence for world peace and pledge American help toward solving this nation's critical food shortages.

Crowds numbering hundreds of thousands lined the route to the fair grounds, cheering Eisenhower as he passed by with Indian President Rajendra Prasad in an open horse-drawn coach under a red and gold umbrella.

At the ceremonies ended, the sun was sinking and colored lights playing on the stand gave a brilliant glow to Indian dancers in ornate costumes performing before the President.

Eisenhower was praised by Prime Minister Nehru as a great man and a great president. "You have found yourself in the hearts of my millions," Nehru declared.

Eisenhower said India and the United States are working together to solve India's food problem. "Whatever strengthens India strengthens us, a sister republic dedicated to peace," he said.

Eisenhower cited the "Four-F" theme of the American exhibit at the 14-nation fair — food, family, friendship and freedom.

"Into these four words are compressed the daily needs, high purposes, deep feelings and ageless aspirations that unite Indians and Americans under one banner—the banner of human dignity," the President declared.

Eisenhower pledged that America will continue cooperating with India to achieve a world free of hunger in which families can live full, prosperous lives and in which friendship replaces fear and suspicion.

"We see in modern agriculture the most effective instrument for a better life among all men," he said.

Not Certain

CHICAGO (AP)—The American Medical Assn. Journal says there is insufficient evidence "to warrant the assumption" that cigarette smoking is the major factor in the increase in lung cancer.

A Journal editorial Thursday questioned conclusions in a report by Dr. Leroy E. Burney, surgeon general of the U. S. Public Health Service, carried in the Journal two weeks ago.

Dr. Burney's report listed smoking as the main factor in the increase of lung cancer and concluded that heavy smokers were more prone to the disease.

"A number of authorities who have examined the same evidence cited by Dr. Burney do not agree with his conclusions. Although the studies reveal a relationship between cigarette smoking and cancer that seems more than coincidental, they do not explain why, even when smoking patterns are the same, case rates are higher among men than among women and among urban than among rural populations," the editorial said.

NATO Military Chiefs Warn Of Policies' Trend

PARIS (AP)—The highest military officers of the North Atlantic alliance have concluded that the present trend of Allied military policies will lead to dangerous weakness unless checked immediately.

Authoritative sources said this was the conclusion of the military committee of the North Atlantic Treaty Organization (NATO), which ended its annual review Thursday.

In the meeting, the chairman of the U. S. joint chiefs of staff, Gen. Nathan Twining, dropped a diplomatic bombshell by placing his finger squarely on France as the major offender. By implication he charged that French President Charles de Gaulle is the man responsible.

The speech was greeted by raised eyebrows and shocked looks in the corridors of the Palais de Chaillot, where the committee met in secret session.

The military committee is composed of the top service chiefs of all 15 NATO nations except Iceland, which has no armed forces. Its findings will be considered next week when the foreign and defense ministers of the nations meet here for their annual review and policy session. They also will be taken up at the Western summit talks which will bring President Eisenhower to Paris Dec. 18.

Twining's speech was viewed as a ground breaker for U. S. Secretary of State Christian A. Herter at next week's session. Should Herter press this line, the meeting is likely to be one of the stormiest since the founding of NATO 11 years ago.

"We will all have to remind ourselves that under this system of law one will sometimes lose as well as win. But nations can endure and accept an adverse decision rendered by competent and impartial tribunals. If armed conflict is avoided, everyone wins."

Eisenhower recommended the stepped-up student exchanges with the observation that all of us recognize the ease with which young people absorb new ideas and new insight.

"I propose to you that while governments discuss the meeting of a few at the summit, universities consider the massive interchange of mutual understanding and learn together."

Blizzard Fading Away In Sweden

STOCKHOLM, Sweden (AP) — The worst blizzards in living memory fade away in south and central Sweden today.

Gale force winds dropped to a stiff breeze. The snowfall ended over most of the seriously affected areas.

But off the Swedish northeast coast high winds continued. The salvage ship Titan with a crew of seven was reported still missing and believed sunk. It had been sailing to assist another ship, the Birka.

Hundreds of persons were treated for broken limbs or other storm injuries.

Reputed Ringleader Of Ivy Bluff Escape Is Captured In Virginia

MARTINSVILLE, Va. (AP) — Police captured the reputed ringleader of the mass escape from North Carolina's Ivy Bluff prison early today when his auto, traveling 110 m.p.h., smashed into a bridge.

Charles W. (Yank) Stewart, 52, battered but not seriously hurt in the accident, said he was driving to Raleigh, N.C., on a mission to expose brutality in North Carolina's penal system.

The arrest of the Wilmington, N.C., convict left at large only six of the 20 men who overpowered guards Tuesday, seized control of Ivy Bluff, North Carolina's Alcatraz, and fled in stolen cars with a small arsenal of weapons.

Nine escapees have been caught in Virginia. The U.S. attorney's office in Roanoke said today at least five of them will not be returned to North Carolina.

"These men have committed several very serious federal offenses for which the State of North Carolina cannot prosecute," the statement said. "We do not feel justified in releasing these men."

without charging them with the offenses committed in Virginia."

Those in federal custody are James W. Strickland, 34, Columbia, S.C.; William Vaughn, 39, Halifax County, Va.; Douglas Anderson, 24, Atlanta; James Edward Christy, 26, Concord, N.C.; and Ralph Byers, Winston-Salem, N.C.

Yank Stewart was identified positively by State Police Sgt. J. H. Barnes after first giving the name of Woodrow Stewart. One of the escapees still at large is Woodrow Stewart, 38, of Boone, N.C.

He was driving south on U.S. 220 at the northern edge of Martinsville when Martinsville Officer Roy Emerson decided to check on the car because it bore city tags from Roanoke, where a car had been reported stolen.

When he pulled up and ordered the car to stop, Emerson said, the vehicle roared away. Emerson pursued the car through Martinsville and was joined by state and Henry County police. Stewart jumped from the car

after it crashed through the bridge and ran. He was captured by State Trooper J. E. Peverall and Henry County officer L. D. Witt. Barnes said Stewart was armed with a .38 cal. revolver.

He was taken under heavy guard to Martinsville General Hospital, where attendants said he was not seriously hurt. He later was transferred to the Henry County jail here.

Yank Stewart was serving 25 years for armed robbery and store breaking and recently was recaptured after staging a daring break over the walls of the state prison in Raleigh, N.C.

Besides the two being sought in the Lynchburg - Roanoke area, three of those still at large were believed to be in the Arlington, Va. area where a stolen car was left and another vehicle taken.

State police said the car Yank Stewart was driving had been reported stolen Thursday night in Roanoke. Officers believe Stewart was accompanied to the Roanoke area by two other escapees. He was alone in the car, however,

at the time of his apprehension. Stewart crawled from the vehicle after it crashed through the bridge and managed to elude officers for half an hour by hiding near an abandoned canal at the Martinsville hydroelectric plant.

About eight officers flushed him out with searchlights and he surrendered without a struggle. He was being atop concrete wall behind some business when he was spotted.

Stewart told police he never had the sub-machine gun which vanished from the prison with the escapees. He said also he had not seen any of his fellow escapees since a few minutes after the break, but officers were inclined not to believe him.

He was quiet and somewhat sulky as he was led into the maximum security cell at the county jail here. He was overheard to say he "didn't give a damn if they give me 500 years."

Stewart told police he was headed back to Raleigh when he was apprehended. Asked if he had planned to give himself up, Stewart

shrugged and said he had given the idea some thought.

The convict had stopped and eaten at a restaurant about five miles north of Martinsville a short while before he ran into trouble. A waitress at the restaurant became suspicious and telephoned Henry County police after he left. Before they could act on the tip, however, Martinsville police had tried to stop Stewart and triggered the chase that led to his capture.

Several of those taken into custody prior to Stewart said the break was triggered because of brutality at Ivy Bluff, a prison camp for hard cases.

The men at large are believed to be carrying a sub-machine gun, rifles and pistols taken from the camp arsenal during the daring break.

Even as the search widened, Dist. Solicitor Charles M. Neaves said at Yanceyville, N.C., a grand jury investigation of the Ivy Bluff camp will be conducted. W. M. Lilly, a prison department field assistant, was named to investigate the camp for his department.

Unemployment Rises But, Jobholders Set Record

WASHINGTON (AP)—Unemployment declined by over a million in November to 65,640,000. Unemployment rose nearly 400,000 to 3,900,000.

The employment decline was somewhat greater than seasonal, but still represented a record number of Americans in jobs for the month of November.

The rise in unemployment was only a bit more than half of what was seasonally expected. Even so, it was the second highest

idle total for a November since before World War II. The postwar record for November is the 3,833,000 unemployed in 1958.

In making public the job report today, Seymour Weisberg, deputy assistant secretary of labor, said that if only seasonal economic influences occur between now and early next year, unemployment will probably rise to about 4 1/2 million in January or February.

This would be about half a million to one million less than the

unemployment figures for January and February in the recession year of 1958.

The November job data was collected only a few days after the steel strike was ended in early November by a Taft-Hartley law injunction.

The figures reflected a sizable return of steelworkers to their jobs, but a considerable dent in the employment total because of over 600,000 layoffs due to steel shortages.

Also November brings a seasonal decline in outdoor work such as construction and agriculture.

The report said a smaller number than usual of women and teenagers entered the labor force during November, looking for pre-Christmas work. Weisberg said he had no immediate explanation for this.

But he said it helped reduce the seasonally adjusted rate of unemployment to 5.6 per cent in November. The ratio of idle to the labor force was 6 per cent in October.

The factory work week, which generally shows little change between October and November, declined by nearly a half-hour to 39.9 hours, due largely to cutbacks because of the steel strike.

Average factory worker hourly earnings rose by 2 cents over the month to \$2.23, reflecting in part the return to work of higher paid steelworkers.

N.C. Poultry Is Termed 'Safe'

RALEIGH (AP)—State Agriculture Department officials say no hormone-contaminated poultry has been produced in North Carolina, the nation's second largest poultry producing state.

They made this clear Thursday after Secretary of Welfare Arthur S. Flemming announced that the operation was to get hormone-treated poultry off the market.

State Agriculture Commissioner L. Y. Ballentine and U.S. Sen. B. Everett Jordan assailed Flemming for failing to point out in his statement that North Carolina law forbids the use of stilbestrol in poultry feed. Stilbestrol, a hormone used in fattening poultry, is suspected of causing cancer.

Flemming noted that hormone-treated poultry comprises only about 1 per cent of the national poultry production.

Jordan declared Flemming "failed to point out where the contaminated birds were produced and processed. This is not keeping faith with the poultry producers and processors in North Carolina—none of whom are using this hormone."

Ballentine also criticized Flemming for failing to note that North Carolina law prohibits the use of hormones in poultry feed.

Gov't Cautions Against Hormone

WASHINGTON (AP)—The government, using a don't-get-excited approach, has announced a ban on sales of poultry fattened with a hormone which can cause cancer.

The hormone is called diethylstilbestrol, or stilbestrol. Its use in fattening poultry is being discontinued, and birds already grown with its use are being voluntarily taken off the market, it was announced.

But with last month's cranberry scare still echoing, officials gave these added assurances to housewives about stilbestrol-treated poultry.

"If you have a chicken in the refrigerator, feel safe to use it if the skin, liver and kidneys are discarded. No residue of the synthetic hormone has been found in the white or dark meat."

Secretary of Welfare Arthur S. Flemming told a news conference Thursday of the voluntary program.

He said authorized manufacturers of stilbestrol for use in poultry have agreed to suspend its sale immediately. The poultry and retail food industries have been asked to arrange for an immediate halt to the sale of stilbestrol-treated birds.

Flemming said he had talked with retail food and poultry representatives and was confident they would suspend such sales.

The hormone has been used in only about 1 per cent of the poultry grown in the United States—mostly in birds sold in the New York City and Los Angeles markets.

Flemming said stilbestrol induces cancer in test animals when it is fed to them over comparatively long periods of time.

Only minute residues of the hormone have been found in the skins, livers and kidneys of market poultry, he added.

Triumphal Tour Strengthens Ike

NEW DELHI, India (AP) — President Eisenhower's triumphal tour of Asia powerfully strengthens his voice for the East-West summit conference with Premier Nikita Khrushchev.

Eisenhower can sit down at the conference table backed by the cheers of millions of Asians who regard him as a symbol of peace with freedom.

Khrushchev will be facing a man who is proving to be his superior in appealing to Asia's teeming, underfed masses as a champion of their aspirations.

The hysterical, sometimes worshipful, reception in Turkey, Pakistan, Afghanistan and India also may stimulate Eisenhower to exert more leadership at the Western summit session, opening in Paris Dec. 19, which begins shaping the West's negotiating position.

The diplomatic showdown with Khrushchev comes later, perhaps in April.

The frenzied reception by 1 1/2 million Indians Wednesday stands out as a high point in the first week of Eisenhower's unprecedented goodwill trip.

Eisenhower and his top aides have been flabbergasted by the crowds which seemed to grow bigger and more deliriously enthusiastic at each stop.

Even before setting out, Eisenhower said he felt it his duty to make the tour because his name meant something in these areas and it might help in the quest for an enduring peace. The President was understating.

Castro Regime Holding Miami Newspaperman

HAVANA (AP)—Fidel Castro's regime today arrested but later released a British newspaperman. Still held was reporter James Buchanan of the Miami Herald, seized on charges that he was aiding Frank Austin Young, an American sentenced by a Castro military court.

The British correspondent is Ian Aitken, representing Lord Beaverbrook's newspapers. He was seized after returning from an investigation of Young's escape from jail in Pinar del Rio.

On his release, Aitken said he had been asked if he knew a man named Buchanan. His questioners apparently were referring to the Miami reporter.

Agents who arrested Buchanan said he was entering the hotel room in which they recaptured Young Thursday.

A U.S. Embassy representative said he understood officials planned to take Buchanan before a Havana judge and charge him with having been Young's accomplice, on the ground he tried to help a fugitive.

Young, a 38-year-old pilot-adventurer from Miami, was sentenced to 30 years in prison Tuesday in Pinar del Rio for conspiring against Castro's government. He escaped Wednesday and made his way to Havana, but his freedom lasted less than 48 hours.

Desperado Claims A Mission To Tell Of Brutal Prison

MARTINSVILLE, Va. (AP) — The convict caller was a mastermind of the Ivy Bluff prison break said today he was on a mission to expose brutality in North Carolina prisons when his auto crashed and he was recaptured.

"I'd rather be dead than go back," Charles W. (Yank) Stewart, 52, battered and obviously in pain, told reporters.

"I was going to Raleigh," the moustachioed convict said, "with the hope I could talk to Gov. (Luther) Hodges about the way they are treating their prisoners. Somebody has to tell him."

Stewart, chased by a Martinsville police officer, approached a bridge going about 95 m.p.h.

"I saw what was going to happen and I saw there was no other car coming," he added. "So I said to myself, 'If I'm going to crack up, I'd do it right.' So I slammed down on it and when the car hit the bridge I was going 110 m.p.h."

Asked if he wanted to die, Stewart said:

"Now I wouldn't deliberately set out to kill myself, but I'd rather be dead than go back."

Speaking from behind the bars of a maximum security cell, Stewart said he and 19 other hardened criminals broke out of Ivy Bluff.

North Carolina's Alcatraz Tuesday because of mistreatment there and because "the North Carolina prison director is a sadist."

He said he had no desire to harm anyone during his flight from the prison and the long hours he was eluding law officers.

Asked if he would have shot the pursuing police early today if his gun hadn't fallen out of his car when it was wrecked, Stewart replied:

"Shoot them? No, I wouldn't have shot them. I didn't want to shoot them. If I had wanted to kill them, I would have stopped the car and when they walked up I would have shot them."

Stewart, who stands 5 feet, 10 1/2 inches tall and weighs 175 pounds, said he was a lone wolf since he and the other prisoners seized the prison camp, took some weapons and fled in stolen cars.

He admitted being in the Roanoke, Va., area, where other escapees were captured Thursday. "But I wasn't with them," he said. "I haven't seen any of the others since we left."

Bought A Town For \$311,000

DESOTO, Kan. (AP) — A man bought a town Thursday for \$311,000.

Sunflower Village hasn't been in use since the staff of a nearby ordinance works was reduced. But it has 174 homes and 11 other buildings, including a 500-seat theater and a school.

It was bought by Louis H. Enley who owns Quick Way Homes, Inc. of Lawton, Okla. He was one of eight bidders in the auction conducted by the government's General Service Administration.

Report Williams Critically Ailing

HOUSTON, Tex. (AP) — The condition of Civil War veteran Walter Williams was termed critical Thursday by his doctor.

It was the first time the 177-year-old veteran's condition had been called critical.

Williams has been under an oxygen tent since Sunday when he became ill of pneumonia for the fourth time since June.

NEW YORK (AP) — Subway change agent Clyde Vincent, 37, was found shot to death in his booth Thursday night. Police believe he defied a bandit's demand for money. The cash box was intact.

Postmaster Reminds Proper Procedure Helps Hasten Mail

The proper addressing of mail, giving the correct street and house number or post office box number is very essential in the handling of mail during the Christmas season, according to Greenville Postmaster J. Knott Proctor.

Placing the stamp in the upper right-hand corner is important as is the placing of the return address in the upper left-hand corner on first class mail, Proctor added.

One of the best ways to help mail carriers during the Christmas rush is for box-owners, or in the case of post office boxes, box-renters, to keep their boxes clean. That is, to pick up the mail often and keep the box in order, so that when mail is posted it can be placed in the box with no difficulty.

Postal authorities noted that, though Christmas cards, if unsealed with no written message, can be sent for three cents, they will not be returned if undeliverable. The Post Office recommends sending Christmas cards first class mail with a return address so they may be returned to the sender if not delivered.

Christmas cards, whether sealed or unsealed, sent to Canada or Mexico requires four-cents postage.

Parcel post should be packed, wrapped, and tied securely with cord which will not break.

One of the greatest helps in speeding up mail service, according to Proctor, is the separating of mail for local and out-of-town delivery. The post office will have a man in the lobby near Christmas

sorting the mail but, Proctor added, the service will be much faster if the sender will, when bringing mail to the post office, divide the mail into two bundles and mark them, "All For Out of Town Delivery" or "All for Local Delivery."

Proctor also requested that people not give the mail carriers large bundles of mail and Christmas cards to be mailed. This only weighs the carrier down and it may be several hours before the carrier returns to the Post Office. The mail should be brought to the post office or dropped in one of the mail boxes located at different corners in town.

For sure delivery, mail early. If possible, Christmas mail for local delivery should be mailed by December 16, he said.

The essential steps in financial planning are simple:

1. Estimate the income expected. Be conservative in this estimate and stay on the safe side. This will be easy for salaried and regularly employed persons and more difficult for seasonal workers and farmers, but not too difficult if estimating is done enterprise by enterprise, number of things to sell (cattle, hogs, chickens, etc.).
2. Estimate expenditures for the year, payments on debts, and savings you need to set aside for future years. Be liberal in these estimates and you will not be disappointed.
3. Balance the plan. If you are normal, the estimated expenditures and savings requirements will exceed the estimated income, so you will need to go over your figures and cut where it hurts the least. But with care and thought when it brings a realization that more important items will not be sacrificed for lesser needs.

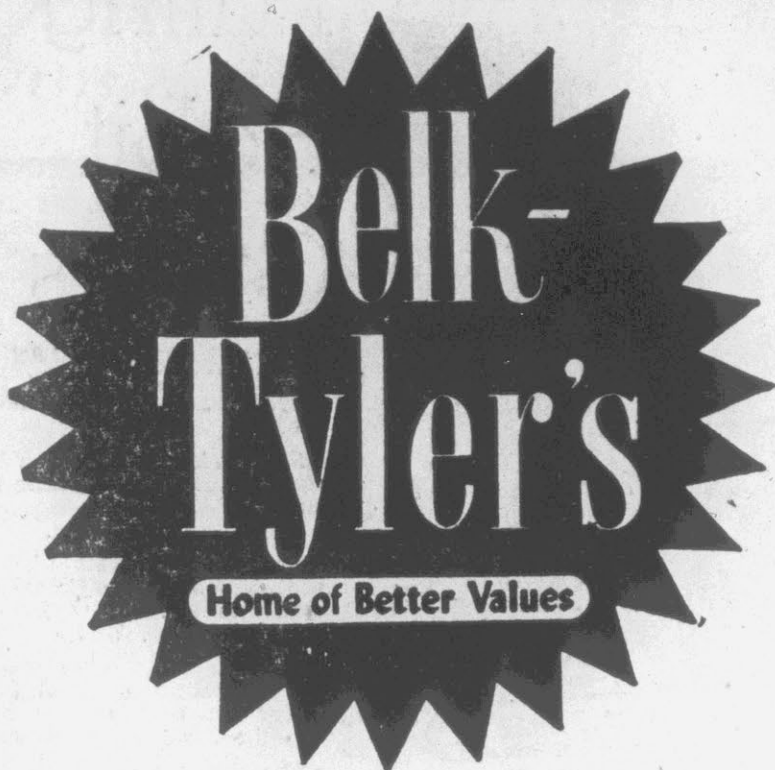

The 30-day trial period proved successful, bringing sufficient response and support from readers and advertisers to warrant continued publication of a daily newspaper in Greenville. Over the years that response from the people of Pitt County has continued and the patronage has made possible the continued expansion and improvement of the newspaper in an effort to give better service to the people of this county day by day and year by year.

Without the support of the people of Greenville and Pitt County, continued publication of The Daily Reflector for more than 65 years now would have been impossible. Those charged with the responsibility of publishing the newspaper over the years have been keenly aware of the public trust of providing the people of Pitt County with the best possible home newspaper, and it has been and will continue to be the purpose of The Daily Reflector to fulfill its important obligation to the people of this county.

Over the years The Daily Reflector has shared the good times and bad times that have come to the people of Pitt County. Day by day it has chronicled the happenings in Pitt County and reported them to its people, seeking always to be straightforward and objective in its news reporting. Also it has sought to provide its readers with the stimulus of a strong editorial page.

To err is human, and over the years The Daily Reflector and those men and women who have made up its staff have made their share of errors. In spite of these errors, however, it has never lost sight of its goal and its responsibility of providing a greater service to the people of Pitt County.

For the faithful and constant support of the people of Pitt County which has made possible the continued publication of The Daily Reflector for more than 65 years now, we shall be forever grateful. In the future as in the past it will be the purpose of this newspaper to better serve the people of this county and to measure up to the highest standards of journalism as it seeks to discharge its responsibility to the people.

Kept Open The Doors Of Communication

Renewal of agreements whereby varied cultural and scientific exchanges between the United States and the Soviet Union will be continued for another two years will prove a distinct advantage in keeping the doors of communication open between peoples of the two nations and should work in favor of the United States.

In the past two years in which such exchanges have been taking place some 1,500 people from each nation have visited the other. Although these visits probably have had little impact upon the basic beliefs of the people of either nation, they have at least provided a medium for freer exchange of information than previously existed. And there can be no doubt that this has worked in favor of the United States.

The American exhibit in Moscow last summer, for example, attracted some three million Russian visitors who were obviously impressed by the vast display of scientific exhibits and consumer goods available to the American people. If afforded many Soviet citizens an opportunity to gain an impression of the United States and its people entirely different from that which would have ever been possible through government-controlled communication systems of the kind visited the Russian exhibit in New York, but the United States held a decided edge in this exchange.

It is true that Soviet citizens who came to the United States under the cultural and scientific exchange program were for the most part much better trained propagandists than their American counterparts who visited the Soviet Union. Even so, it is extremely unlikely that the impact they made upon the American people was nearly so profound as the impact made by American delegations upon rank and file citizens in the Soviet Union.

Aside from the matter of who "won" or "lost" by the exchange of students, athletes, scientists, technicians, artists and others, it is apparent that to some degree at least the reciprocal visits have led to a better atmosphere of understanding between the major powers of East and West.

The United States should have nothing to fear—and indeed a great deal to gain—from the continuation of the exchanges in 1960 and 1961.

Sen. Johnson Is Not Impulsive

WASHINGTON (AP) — Sen. Lyndon B. Johnson seems to be doing what he has done in the Senate for years: Avoiding sticking his neck out until he counts the house.

There's nothing impulsive about this 51-year-old Texan, leader of the Senate Democrats, whose native state has started a boom to get him the 1960 Democratic presidential nomination.

Johnson says he isn't seeking the nomination. All he wants is re-election to the Senate in 1960, he says, but if the Democratic convention were to pick him "I would look at it."

Some political observers, taking it for granted Johnson would like to be president, seem puzzled because he hasn't imitated other would-be Democratic candidates, particularly from the Senate.

They've been beating the bushes across the nation, looking for support. Not Johnson. Except for one speech in Philadelphia and some speeches this week in the Midwest, he has confined himself to Texas. But there he has made an astonishing number of speeches. He has stayed away from big Democratic centers like New York and Chicago. That's understandable, if he really wants the nomination:

He has two strikes against him, starting out. First, he's a Southerner, and it's been a long time since a Democratic convention wanted a Southern candidate. Second, among Northern liberals, or some of the, Johnson is considered a conservative. View this against the way he runs the Senate. He never dashes in, waving a bill, yelling:

"Come on, boys, let's see how we do on this one." Just the contrary.

He does his homework. Before he ever lets a bill loose on the floor he checks thoroughly to find out what its chances are. Then, when he does let it loose, he knows pretty thoroughly what the vote will be.

Before the Democratic convention next summer there may be some changed thinking about him among northern liberals—that is, if he puts on next year the kind of performance that would attract them.

For instance, if he gets through a meaningful civil rights bill and some other social legislation. He has already indicated he intends to get some kind of civil rights bill on the books next year before convention.

Then it might be possible—if the other candidates knock one another out and there's a deadlock—that the convention would turn to Johnson as a compromise.

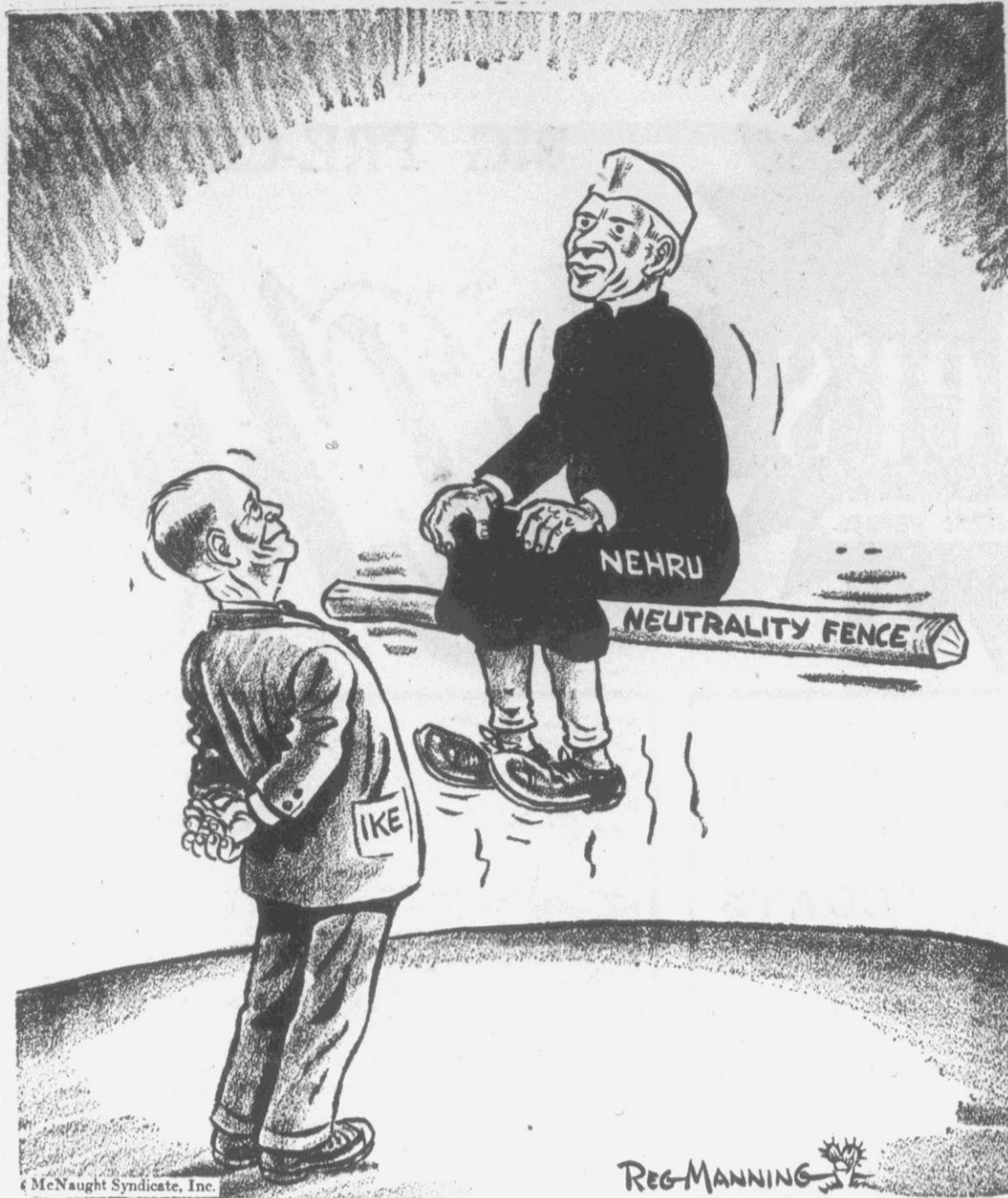
The boom for Johnson started last May when the Texas legislature put through a Johnson-for-president bill. But it really got moving Oct. 17.

That day Johnson's fellow-Texas and mentor, Speaker Sam Rayburn of the House, announced he was starting a drive to get Johnson the presidential nomination. Johnson-for-president clubs sprang up all over Texas.

And just recently Johnson got ardent support in Kentucky. There former Sen. Earle Clements quit his job as Democratic senatorial campaign director to boost Johnson's presidential chances and try to swing Kentucky's 31 convention votes behind him.

Central offices for state and national campaigns to back Johnson for president were set up in Austin, Tex., last month with a full-time staff manning the headquarters. Johnson is in an enviable position for a politician: If he misses out on the presidential nomination, he's still a cinch to be re-elected to the Senate from Texas.

Another physical phenomenon came to light yesterday during a brief visit to Farmville.

While talking with Mayor Charles Edwards about one thing and another, we could hear the loud bangings and boisterous comments of a jailed drunk downstairs.

"How long's he been in there?" I wanted to know. "A couple of hours," replied the mayor. Then he added, "You shoulda seen one we had in here the other day. . . he was really keen."

"What do you mean," I asked. After explaining the general design of the building, he exclaimed, "You know, drunks can see better than anybody else."

Well, I'd always heard the opposite and wondered what had prompted the mayor's statement.

You see, the jail in Farmville is situated in the back of the Town Hall. In order to get to the cells, you go inside through the building's front door. Down the hall about 35 or 40 feet, you make a sharp left turn. Then back to the right and you're next to the small cell-block.

Actually, there's no way possible for a person (under normal circumstances) to see the front door from the little barred rooms in the back.

I asked the mayor "how come" he'd said drunks could see better than anybody.

He explained that, the other day, they picked up a real

bolsterous one and put him behind bars for a little cooling-off period.

This particular one had been "most violent-seeming" but, as usual, had been ignored as much as possible after being deposited in jail.

The mayor continued: "After he'd been in there a while and began to realize where he was, he apparently began to think."

"He musta decided he better begin some type of diplomatic relations with the town's officials."

"That don't mean he could see better because he was drunk," I insisted. "I was just getting to that," said the mayor. "You see, with no doors in that hall, anybody can hear from one end of the building to the other."

He continued, "After this bird had dwelt with his deepening thoughts for a time and decided to attempt to make amends for his error, he heard the front door open for someone to enter."

"He had no earthly way of knowing who had opened that door, but in a steady, unwavering voice that floated around the corners to the front of the hall, he called: 'Mr. Edwards, come in here a moment, I want to talk to you.'"

Seeing I was believing, I guess.

Other Editors Saying Lab Studies Hold Future

(Goldsboro News-Argus)

Laboratory studies of core samples now under way will determine that future of drilling for oil in Eastern North Carolina. The sample were taken from drilling of seven wells in the Lake Mattamuskeet area which ended in September.

If the oil geologists find from the lab studies that there is sufficient evidence of oil bearing formation to warrant deeper drillings, the search will be resumed.

And back of this search is a moving human story. J.E. Fitzpatrick, veteran oil expert, got from the Department of Conservation and Development a contract to search for oil on state lands in Eastern North Carolina.

Before he could begin operations, he died. Fitz-Patrick had as closest friends some of the retired officers of the nation's largest oil companies.

To protect the rights of the widow of their friend, these oil veterans formed the Coastal Plains Oil Company and carried on after the plan which Fitz-Patrick had made.

The firm made Winston-Salem its North Carolina headquarters with a well known Forsyth law firm as representative and agent.

Before the 2-year deadline specified in the Fitz-Patrick contract had been reached Coastal had drilled seven wells totaling a little more than 13,000 feet in depth. The agreement had specified that the searchers must drill at least 12,000 feet in that time to keep their contract in force.

J.L. McCord is president of Coastal. His home address is

Miami. He is the former president and director of Commonwealth Oil and has 35 years of experience in the oil business.

Others in the Coastal Plains Company are: Joseph Snyder of Jackson, Miss., chairman of the board of directors, Douglas D. Clocker of Karnack, Texas, Gordon Graves of New York City, and Elton M. Hyder, Jr., of Fort Worth, Texas.

Coastal has two more years in which to drill another 12,000 feet. If the lab studies of samples taken from the seven holes on the western half of Lake Mattamuskeet are promising, more and deeper wells will be drilled.

Deepest hole put down in the Mattamuskeet study from April to September was 2,905 feet.

The seven wells sunk at Mattamuskeet brought on 11 the total holes sunk in oil search in the last six months. That is more wells than had ever been drilled before in a search which has been carried on in fits and spurts for more than a score of years.

In Hoffman forest Bryant T. Seay, Houston, Texas, drilled two holes northeast of Jacksonville. At 1300 feet, approximately, the drills hit "basement" rock. There were no oil rock evidences, reports said, in the "basement" which the drills hit.

Two other wells were drilled by the American Mining and Development Company of New York City. One was in Bladen County, near Kelly, and went down to 700 feet before it hit hard rock. The other was in the edge of Beiler County, seven miles north of Acme and bottomed at 695 feet.

As a matter of fact, that is just about all we do get to eat these days. Everything else in the refrigerator, freezer and pantry goes into the bottomless stomach of Brenn, 14.

No longer is it a problem of getting him to eat. It's how to finance his appetite.

From the four bowls of cereal in the morning—while I'm fixing his breakfast—to his final bedtime snack at night he methodically munches his way through the day.

On school days there is a slight letup for a few hours. That, fortunately, gives me time to run to the grocery for fresh loads of eatables. But during the weekends he lives a true hand-to-mouth existence.

Between meals he commutes from his room to the kitchen for apples, bread and butter, pretzels, bananas, peanuts, ice cream bars, cheese and anything else loose.

Brenn is studying, and practicing, nutrition in a high school science class. For homework he had to list everything he ate during a day and compare this with a guide listing the seven basic foods.

It required a considerable feat of memory for the two of us to tote up his own score. Finally it was completed. Brenn compared figures a moment and exclaimed:

"Hey, mom, you know what? I don't eat as much as I'm supposed to!"

Strength For Today

IMPORTANT—BUT NOT COMPLETE

People often remark that the Golden Rule is enough of a religion for them. They will just keep the Golden Rule and let the details of theology "go by the board."

This, to indulge in understatement, is a superficial appraisal of the significance of religious truth. There is no requirement of Scripture quite so hard to live up to as the Golden Rule. In fact, it can be said with confidence that no one except Jesus himself ever lived up to the moral requirements of this Rule.

The Bible is, above everything else, divine revelation. It tells us things about God and his purposes which we could not possibly find out by our own most diligent searching. This revelation—often scoffed at as a sort of fancy type of theology—is basic to religious thought and action. The person who thinks he can substitute the Golden Rule for what he terms "mere theology" is making a great mistake.

C.S. Lewis has become one of the great religious writers of this generation. He once believed that rationalism and attention to the ethical aspects of Christianity were sufficient. But he learned differently, and out of a great experience have come his great statements of Christian faith. C.W. Lewis' writings reflect the complete gospel—not just the Golden Rule, important though the Golden Rule undoubtedly is.

FTC Guide Raises New Problems

The Federal Trade Commission's new four-point guide designed to gain merchants' support in its fight against bait advertising and switch selling may create as many problems as it solves.

"Bait advertising" is the advertising of goods which the seller has no intention of selling. It is intended only to get prospective buyers into a store where the selling of one product after the prospect has been lured in by an offer of another.

Sharp retailers may, for instance, advertise a vacuum cleaner at a low price (bait advertising) and, when customers come in, tell them the advertised model is no good and offer another higher priced brand (switch selling).

NEW RULES

The four points are: 1. Don't offer the product for sale when the offer is not bona fide. 2. Don't misrepresent a product in an advertisement with

the intention of later switching customers to other goods by disclosing the truth about the advertised product.

3. Don't discourage the purchase of advertised merchandise as part of a scheme to sell something else.

4. Don't, after the sale of the advertised product, attempt to unsell it, then switch the customer to a higher priced item.

Those are sound rules and, on the surface, they seem properly qualified. The phrases "when the offer is not bona fide," "with the intention of later switching" and "as part of a scheme" make it clear that these regulations apply only to retail shenanigans.

TAINT HONEST PRACTICES
But the rules are so broad that under very common circumstances they might cause misunderstanding of the practices of honest merchants.

Here are instances based on real cases: A housewife, responding to an

ad, went to a store to buy a small, low-powered vacuum cleaner at less than \$25. The salesman learned that she had a large house and should have a heavy-duty cleaner.

Of course, he would not be violating FTC suggestions to explain the difference. But if he did, wouldn't the customer be inclined to suspect his motives and cry copper to the FTC?

In another case, a couple shopped for a refrigerator. They liked one with a 15-degree freezer compartment. The salesman learned they planned to keep seafood and fresh meats a long time, which requires a zero-degree compartment. If he even suggested it, wouldn't it look like the old switcheroo—especially if the couple had been reading about the FTC guide?

There are even broader applications. From time to time, every store advertises certain specials in limited supply. This is usually frankly stated in the advertising. "The first ten get

these fur coats!" "Only 68 suits at this price!" and "One of a kind sale!" are common adlines.

There's no "intention of later switching." But isn't the merchant vulnerable to accusations that he's using bait advertising, and that he is practicing the switch? It would seem so.

Few merchants and no shoppers want the bait and the switch. But all would want rules drawn that would not make the honest merchant suspect.

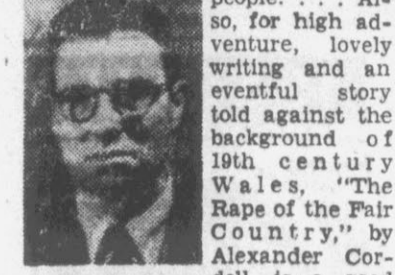

Any kind of jewelry is all right for Christmas—just so it's pearls. That's the word from the jewelry industry, whose members say they've never seen a season when pearls of all kinds, shapes and sizes, big and little, real and fake, have been in such demand.

Perhaps it's because this is a season when femininity and elegance have reached an all-time high—and pearls always have been favorites with great ladies, starting with Cleopatra, who not only wore them but is said to have swallowed them.

For Christmas giving and wearing, pearls are appearing in new shapes, finishes and colors, in new combinations and dramatic designs. Colored pearls are important in the holiday picture, ranging from fabulous cultured or oriental black pearls to costume pearls in tones of sable, smoke, jade, sapphire, burgundy, amber

and gold. Often two or more shades of a color are blended for an effect of color gradation that is subtle and effective.

There are new finishes for costume pearls that would astonish an oyster. They range from a simulated cultured pearl finish to a dazzling white. Some pearls have a dull metallic gleam, and others a silky sheen.

As to sizes, you may choose anything from tiny seed pearls in multiple strands to jumbo pearls the size of marbles. There are many shapes, also—round, oval or flat. Necklaces run the full gamut, from choker collars to long ropes. Sometimes pearls are paired with other gems or with gold or silver for a new look. Sparkling cut crystal combines with pearls with dramatic effect, as to jade, turquoise, emeralds or rubies, real or simulated.

Eels, Lasagne Holiday Treats For Italians

ROME (AP)—Eels for Christmas dinner? Don't be shocked. Italians eat them and love them. On New Year's day Italians stow away as many lentils as they can. They believe the more lentils they eat the more money they'll make the coming year.

Green lasagne with a red tomato sauce is a delicious pasta dish most Italians like to eat on Christmas day.

Here are two Italian holiday recipes:

Lentil Soup: Wash 1 lb. lentils. Place in pot with 3 quarts of cold water. Cook over medium flame 1 1/2 hours or until lentils are soft. Add salt and pepper. Melt 2 tbs. butter in separate saucepan. Add 2 tbs. olive oil. Sauté 1 chopped onion for about 5 minutes or until soft and slightly brown.

When lentils are done strain lentils and liquid through sieve or colander. Add onion and oil mixture. Stir. This produces a thick soup. Keep warm over low flame. Serve hot with parmesan cheese sprinkled over top.

Green Lasagne: Make a mound of 3 cups of flour on a large pastry board. Scoop out a well in mound. Place 1/2 lb. cooked, drained and strained spinach, 2 eggs and 1-4 teaspoon salt in well and work into the flour. Knead for 20 minutes, adding a little more flour if necessary. Divide kneaded dough into two parts and roll each part paper thin. Stretch dough on clean towels to dry for 1 hour. Fold each sheet. Cut across dough with sharp knife. Make ribbons 3-4 inch wide. Shake ribbons loose. Cook in boiling salted water 1/2 hour or less to taste. Drain. About 3 cups of tomato or meat sauce, 6 tablespoons grated parmesan cheese and 1/2 cup butter is needed.

In large casserole place a layer of lasagne, cover with sauce and continue layers. Sprinkle with parmesan cheese and dot with butter. Bake in moderate oven 3-4 hour. Sprinkle with additional parmesan before serving. Serves four.

GOOD DRESSING

Undiluted evaporated milk, vinegar and a goodly portion of sugar (plus salt and pepper) make an unusually good dressing for coleslaw.

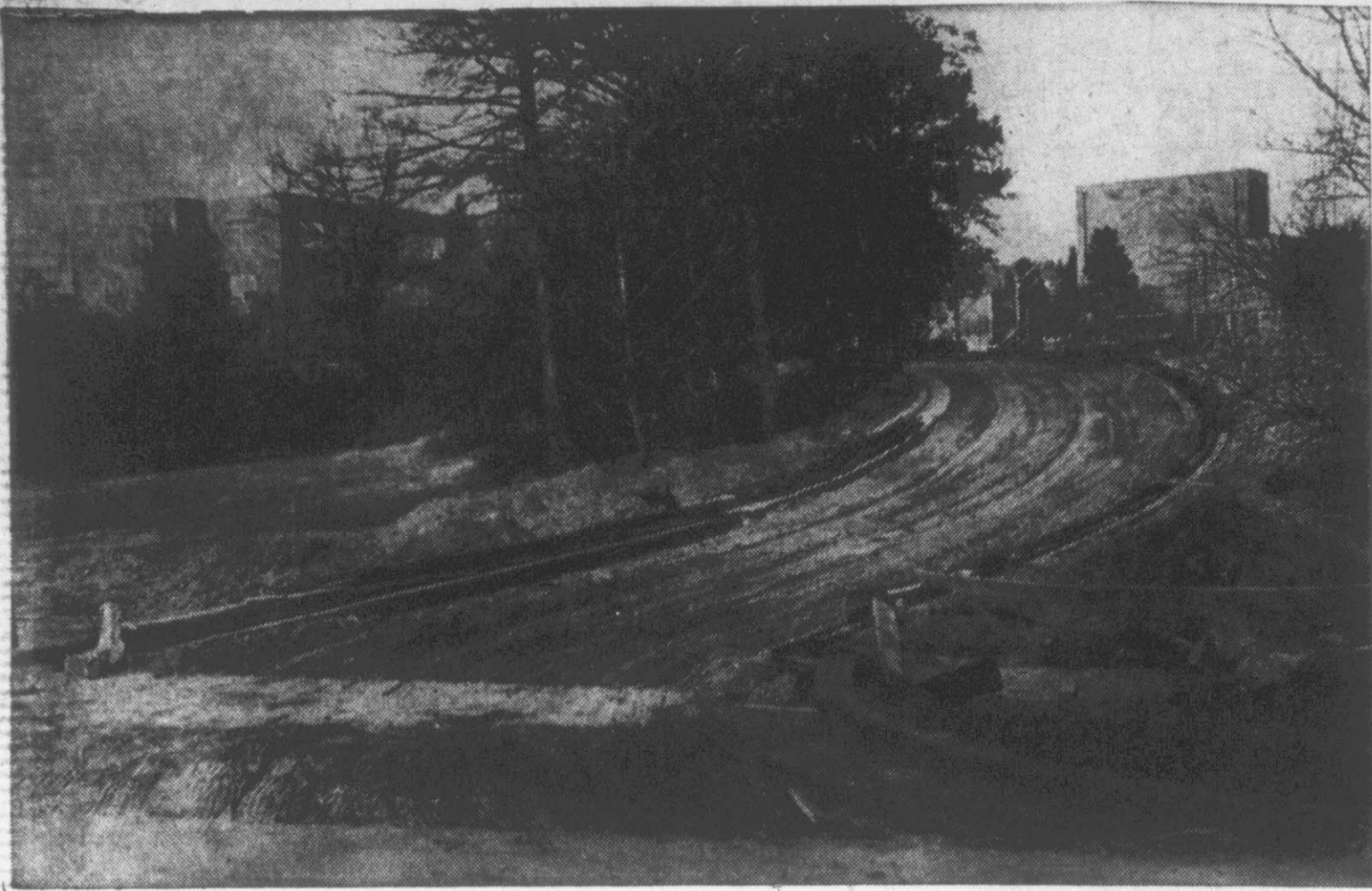

Visit To Famed Taj Mahal Included In Pres. Eisenhower's Visit To India

AGRA, India (AP)—On a warm day in October more than 150 special buses fanned out along the 120-mile highway from Delhi to this ancient city. Hundreds of automobiles jostled for highway space with bullock carts and pedestrians. Special airline flights from Delhi buzzed overhead. Trains from the capital were jammed with more passengers.
By the time the full moon had risen above Agra's banyan trees, most of the passengers who came by bus, automobile, plane, train, bullock cart and foot had assembled in one throng.
Before them, soft in the moonlight, stood a building massive and yet so delicate that poets have called it a dream in marble. It was the Taj Mahal, a monument which annually delights more eyes and stirs more sighs than any building in India.
The impact of the Taj Mahal upon viewers is so great that an Englishman who stumbled across it more than 50 years ago declared the sight alone was worth a trip to India. Thousands of tourists have since confirmed his judgment, and next Sunday President Eisenhower will join those who have journeyed to Agra for a sight of this monument to a 300-year-old love story. Prime Minister Nehru is expected to be his guide.
The building the President will see stands on a square marble parapet, raised 12 feet above a spacious garden of reflecting pools and flowering shrubs. Its frame is 186 feet on each side. The walls rise more than 100 feet and are capped by a dome which soars to 210 feet. Pencil slim minarets rise delicately at each corner of the parapet.
The structure is of pure white marble, inlaid with wreaths, scrolls and frets of bloodstones, agates and jasper. Thousands of verses from the Koran are graven into the walls in black stone.
How did one of the world's poorest countries come to have a monument which some experts believe cost more than 50 million dollars even though built more than 300 years ago?
Some critics say the answer lies in the overwhelming self esteem and ostentation of the Moghul emperors who ruled India nearly 200 years. But they are a minority. To most Indians the Taj Mahal is a monument to a great love story.
"Taj Mahal," in Urdu, means "crown of the palace." This was one of the titles of Mumtaz Mahal, wife of Shah Jahan, who ruled India 1627-1656. Shah Jahan married Mumtaz when she was only 14, and the fierce emperor never took another wife. The beauty of Mumtaz and the love in which she was held became legend in her lifetime. She died at the birth of her 14th child, at the age of 31.
One year later, in 1632, Shah Jahan began work on a memorial to endure for all time. When it was finished, 17 years later, the remains of Mumtaz were interred in the center of the parapet on which the building rests. The equivalent of "God" was inscribed in 1,000 ways on her jeweled encrusted crypt and 600 holy men were sent daily to the monument to recite prayers for her soul.
The prayers did not continue long. Six years after the monument was finished, Shah Jahan's son, Aurangzeb, revolted and seized power. Shah Jahan was imprisoned until his death in 1666.

Aurangzeb halted work on the "Black Taj" which Shah Jahan had planned to build as his own mausoleum, directly across the Jumna River from the Taj Mahal. Shah Jahan was buried beside Mumtaz, and Aurangzeb shifted his capital to Delhi.
After Aurangzeb's death in 1707 the Moghul Empire fell apart and a succession of conquerors moved in to sack Agra and the Taj Mahal. Diamonds were pried from the crypts. Precious stones were scraped from the walls. Silver gates that guarded the monument were hauled away.
By the time British Viceroy Lord Canning stumbled across the Taj in 1758 the building was overgrown with weeds and badly in need of repair. Lord Canning considered wrecking the building but found the kind of demolition necessary to preserve the marble would cost far more than the mar-

ble would bring. Again the Taj Mahal was left to the weeds and dust.
In 1903 another viceroy, Lord Curzon, saw the Taj Mahal by moonlight—just as did more than 200,000 persons on a single night 56 years later. Enchanted, Lord Curzon ordered the building restored and personally spent more than two years searching for a suitable lamp to replace one which had been stolen from above Mumtaz' crypt.
The monument has since been faithfully maintained, first by the British administration and now by the government of independent India. Its fame has spread so far and brought in so many tourists that government officials say that the long run the building may bring in even more money than Shah Jahan spent when he set out to document his love for Mumtaz more than three centuries ago.

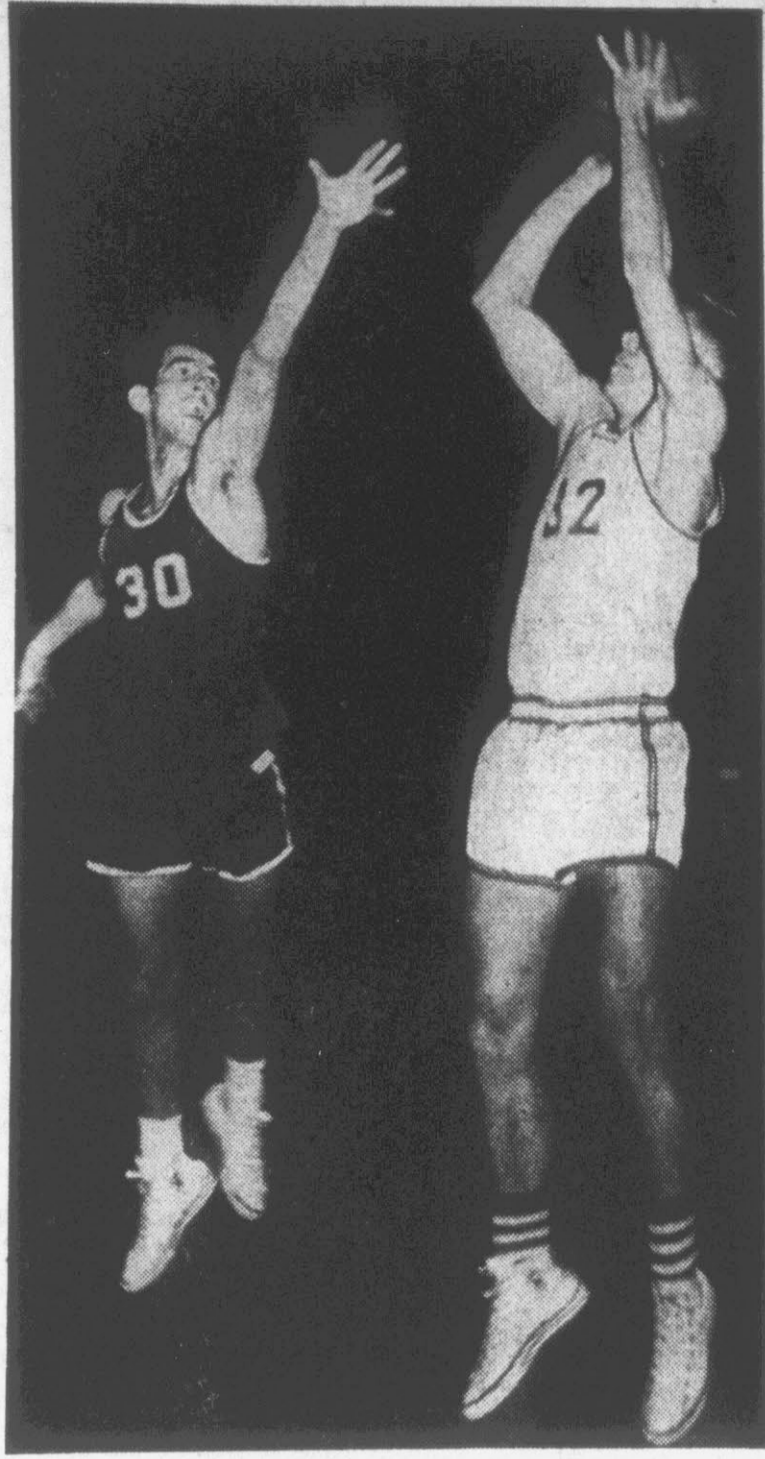

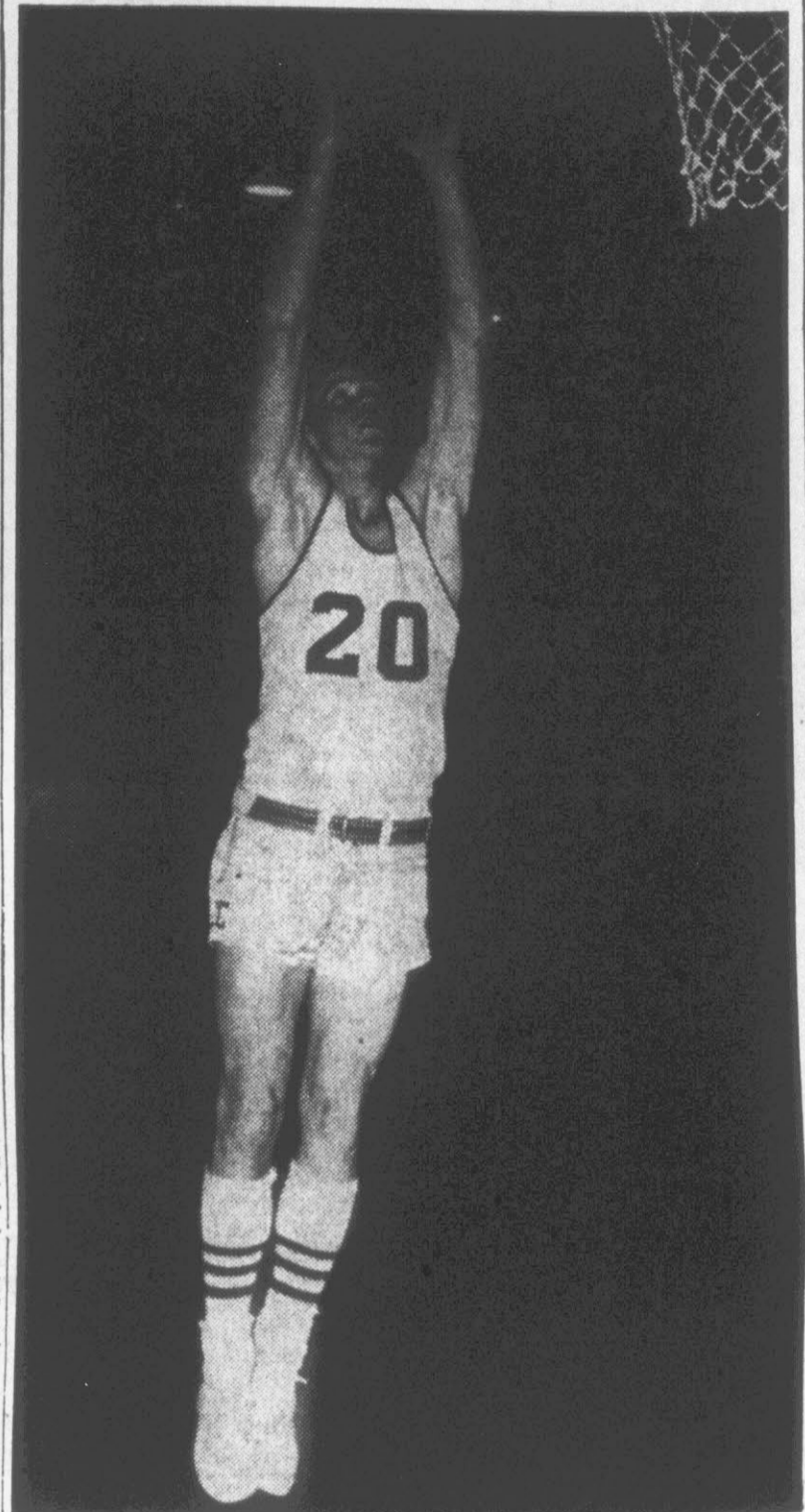

 LOS ANGELES (AP) — A favored Baltimore Colt football team arrives in town today, determined to whip the Los Angeles Rams Saturday and escape any possible playoff for the Western Division title of the National Football League.

The defending Colts are picked by as much as 12 points to inflict the 10th defeat of the season on the Rams in the final game for each in the regular NFL season.

The struggle, with some 60,000 expected in Memorial Coliseum, will be televised nationally by the Columbia Broadcasting System, with this area for 150 miles blacked out.

The Colts, with an 8-3 record can gain clear title if they win. But if they lose—and the San Francisco 49ers win over Green Bay and the Chicago Bears take Detroit—there will be a three-way tie for the division crown.

The Colts take the field with their usual troops.

That means the Rams will have to contend with quarterback Johnny Unitas, halfback Lenny Moore, fullback Alan Ameche and such dangerous pass-catchers as Ray Berry and Jim Mutscheller.

They will also encounter one of pro football's most formidable defensive platoons, notable Gino Marchetti, Big Daddy Lipscomb, Art Donovan, Don Joyce, Milt Davis, Don Shinnick and others.

The Rams have absentees due to injuries. Their offensive unit will have Billy Wade at quarterback, with Joe Marconi replacing Ollie Matson as the starting fullback.

Jon Arnett and Jim Phillips go at halfback, with Del Shofner and Leon Clarke on the flanks.

Len Richter again will be pressed into dual duty as offensive center and part-time linebacker, with rookie John Guzlik spelling him at the latter position.

Famed Fighter Is Found Dead

 NEW YORK (AP)—Tony Canzoneri, whose falling fists carried him from a bootblack's box on the sidewalks of New Orleans to boxing's hall of fame, no longer will hold court on his beloved Broadway.

The great little gladiator who won the featherweight, lightweight and junior welterweight was found dead Thursday in a \$21-a-week midtown hotel room. Medical authorities said the 51-year-old scrapper apparently had died of natural causes two days ago.

When Canzoneri failed to show for two days at the Broadway restaurant which paid him for the use of his name, a friend, Norman Schwartz, checked the hotel. The ex-champion was found dead lying across a bed, clad in his underwear.

The word quickly spread up and down Broadway.

In front of the restaurant, where Tony held court each night for those who remembered back to the exciting days in the 1920s and early 1930s, many of his friends clustered. They talked in almost hush tones of the man with the big smile who won 140 fights, lost 24 and drew in 11 and then, after his retirement in 1939, joined comedian Joey Adams in a successful night club act.

Purses were not always big in his days, but Canzoneri earned more than \$500,000 with his fists. He met all the top fighters of his time—Johnny Dundee, Benny Bass, Kid Chocolate, Bud Taylor, Lou Ambers, Busby Graham, Joe Sabgo, Sammy Mandell, Al Singer, Jackie (Kid) Berg, Stan Loayza, Billy Petrolia, Wes Ramey, Baby Arizmendi, Barney Ross and Jimmy McLarin.

The fight Canzoneri liked most to talk about was the second of three with Berg for the junior welter crown.

"All you had to do with Berg was move back one step and then let the right go up," said Tony. "I only did one day's road work for the fight because I knew I didn't have to move. I was hitting him too high at first with the right. Then in the third he stepped back and I let go. It landed right and the fight was over."

Ohio State Spills Former Unbeaten Louisville Five

 If Big Jerry Lucas wasn't enough to make Ohio State look tough, Larry Siegfried now has come along to keep the Bucks unbeaten in major college basketball.

With the 6-8 Lucas scoring 30 points under the boards and Siegfried, 6-4, popping in 22 points from the outside, Ohio State won its fifth in a row Thursday night, spilling previously unbeaten St. Louis 81-74 on the Billikens' home court.

While Lucas dueled with the Bills' 6-10 Bob Nordmann under the boards, Siegfried, who had been averaging less than 13 points a game, hit six of seven shots as the Bucks built a six-point bulge at the half, 44-38. The Billikens, who had overcome 13 and 4-point deficits while defeating St. John's (N.Y.) and Kansas State in their last two games, three times led by one before Nordmann fouled out midway in the second half.

Georgia Tech stretched its two-season winning streak to 12 games with its fifth victory of the campaign, a 70-64 road success over South Carolina. Unbeaten Utah State won its fourth, 71-66 at Iowa State after trailing the previously undefeated Cyclones by one at the half.

Miami of Florida, which had won 10 in a row in a streak carried over from last season, was handed its first loss in five games

this season, 84-77 at Centenary. Western Kentucky (3-0) jarred Seton Hall's hopes for a big comeback, 78-69.

Al Ellison, 6-4, led Western Kentucky with 36 points, counting seven in a row to kill Seton Hall's last bid with 6 minutes to go. Dave Debuschere scored 24 and Ray Albee 20 as Detroit wallopped Iowa 85-67 in the other half of the Madison Square Garden doubleheader in New York.

Loyola of the South handed Louisiana State its first loss 66-65 in overtime. Wake Forest, beaten only by Ohio State wallopped Davidson 90-55. Louisville, a loser only to Georgia Tech, beat Eastern Kentucky 75-67.

DePaul beat Bowling Green, Bill Depp, 6-7, scored 12 of his 20 points in the last 6 minutes as touring Vanderbilt beat Rice 82-72. Virginia Military beat Hampton-Sydney 108-96.

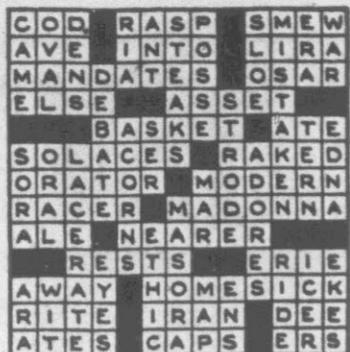

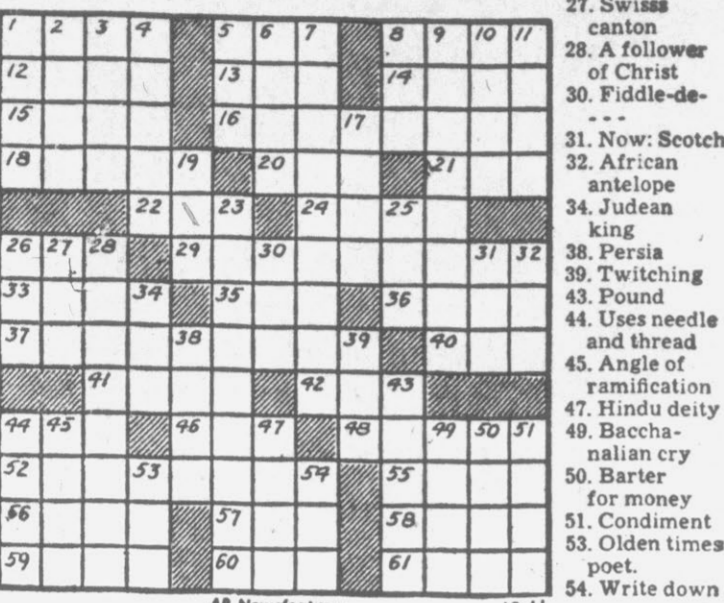

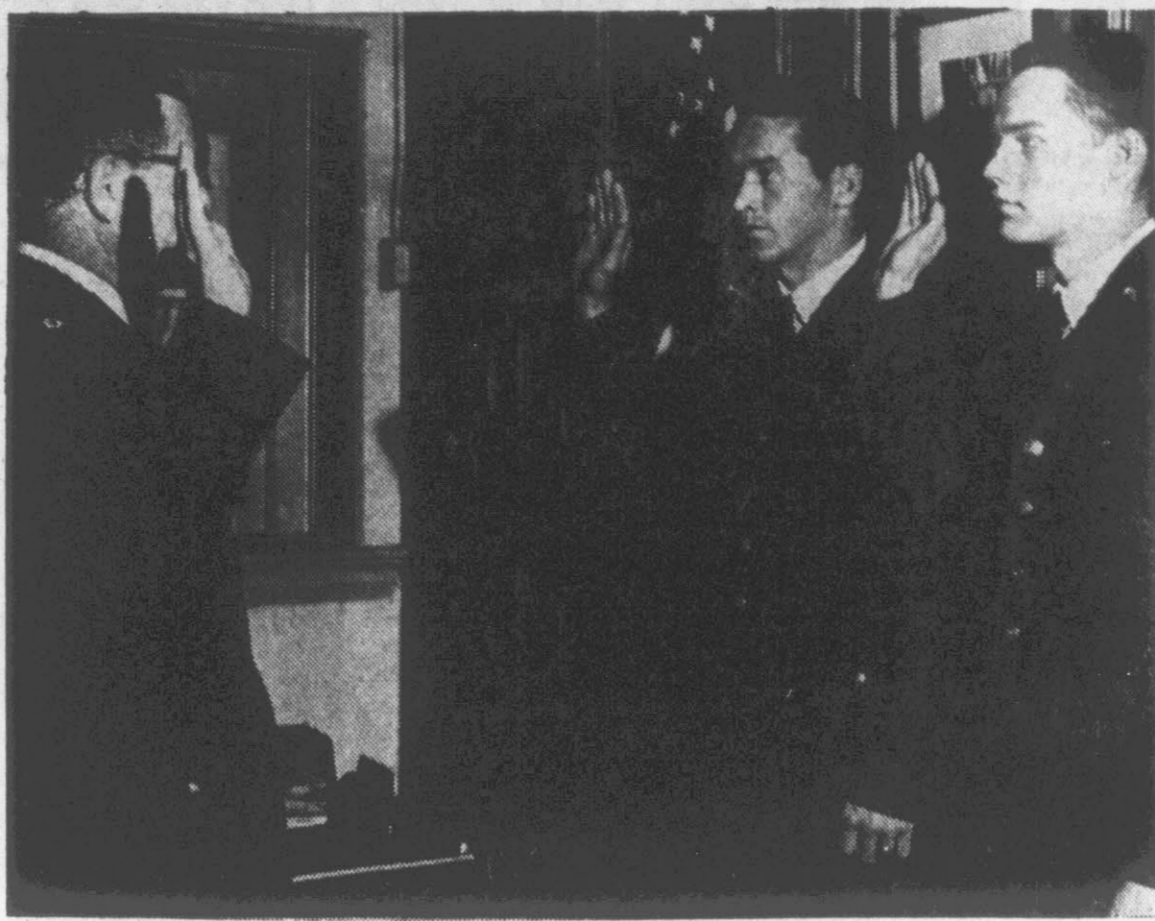

Sidetrack Steel Talks For Aluminum Parleys

WASHINGTON (AP)—Steel labor talks have been sidetracked temporarily to let union negotiators try for an aluminum industry agreement. A contract there could influence the steel situation.

The government called off Thursday the steel talks it has been sponsoring. Director Joseph F. Finnegan of the Federal Mediation and Conciliation Service said the bargaining wasn't making any progress despite stepped-up efforts after President Eisenhower's latest appeal.

No time was fixed for their resumption. Asked whether it would be a matter of days or weeks, Finnegan replied "it won't be a matter of weeks, I'm sure."

Finnegan noted the Steelworkers Union recently concluded a labor peace pact with major can manufacturers, and are negotiating with the top aluminum producers — Alcoa, Reynolds and Kaiser.

Lt. Meachum, who held the cadet rank of major in the East Carolina Air Force ROTC served as squadron commander and staff executive officer in the college detachment. He expects to enter pilot training in March.

Lt. Speight, also a cadet major, acted as flight commander and squadron commander in the East Carolina detachment. He is now doing graduate work at East Carolina and plans to go on active duty next summer.

Lt. Julian, cadet captain and commander of the Drum and Bugle Corps in the East Carolina AF ROTC detachment, expects to go into navigation training after the first of the year.

Several of the islands have eagle nests, always located in the tops of high trees. The eagles are seen frequently by commercial fishermen, trollers and excursionists but it is difficult to get close enough to them to get a picture.

Centenarian Isn't 'Hurrying' His End

NEW YORK (AP)—"I'm going to die someday," quips Dr. John Wesley Carr, often called the grand old man of American education, "but I'm not hurrying things."

And to prove his point, Dr. Carr will celebrate his 100th birthday Sunday.

Dr. Carr spent 87 years in American schoolrooms as a student, teacher, principal, college dean and president and historian. He helped establish and became the first president of Murray State College in Murray, Ky., serving from 1923 to 1953.

Now retired, he lives here with a grandson.

Dr. Carr remembers the quaint names of the rural Indiana of his youth.

"I was born on Goose Creek, brought up on Black Ankle, learned to swim in Fuss Creek, went to school at Hard Scabble and tried to go with a girl in Snake Hollow," he says.

Dr. Carr's father was a farmer and "poor as church mice," he recalls. "Father and I only had one good hat between us, so only one of us could go to church on Sunday."

He first entered a classroom in 1866 when he was 7. The Civil War had just ended and President Andrew Johnson was in the White house.

When he was 17 he started teaching at another one-room school in a neighboring county. While he never dated the girl in Snake Hollow, he did meet and later marry one of his students.

They had one daughter and three sons. One son, Harry, is alive. He is a New York insurance man. Dr. Carr's wife Rachel died in 1927.

Dr. Carr received only \$1.25 a day for a five-month term in his first teaching job. But he lived to teach.

"I think he would have taught for nothing," his son says.

Dr. Carr got his bachelor's degree at Indiana University in 1885. He later took graduate studies at Columbia University here and in 1913 got his doctorate in philosophy. He served in schools in Indiana, Ohio, New Jersey and Philadelphia. He also was high school supervisor for Kentucky.

An interviewer asked: "To what do you owe your longevity, doctor?"

"I really don't know," he answered.

"Do you drink?" "Not yet."

"Do you smoke?" "Not yet."

"Is that the reason you've lived to be 100?" "I wouldn't be at all surprised," he said, grinning broadly.

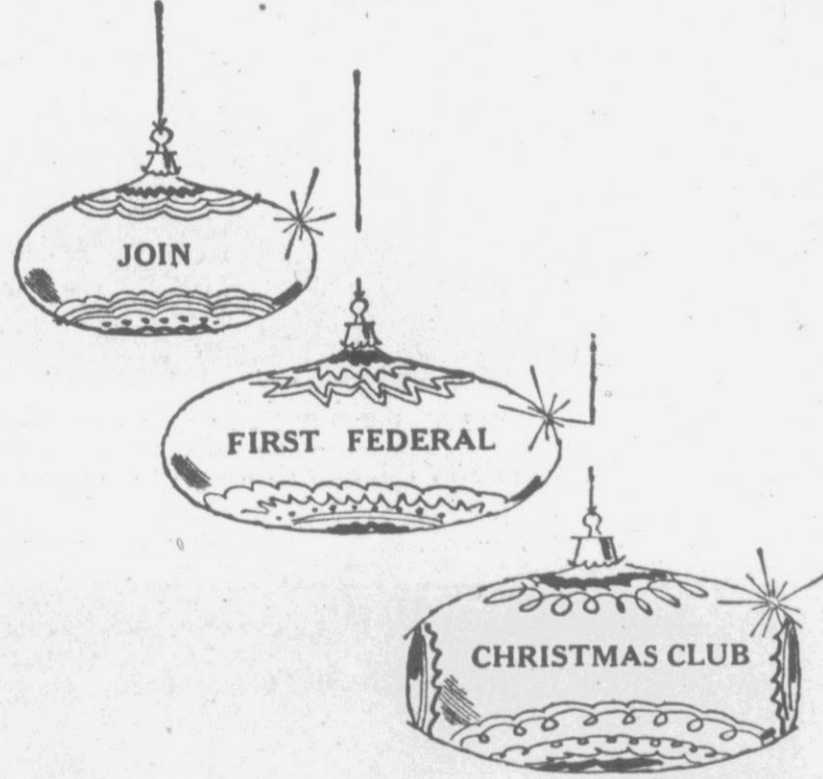
'Surrendered' To A Roving Tank

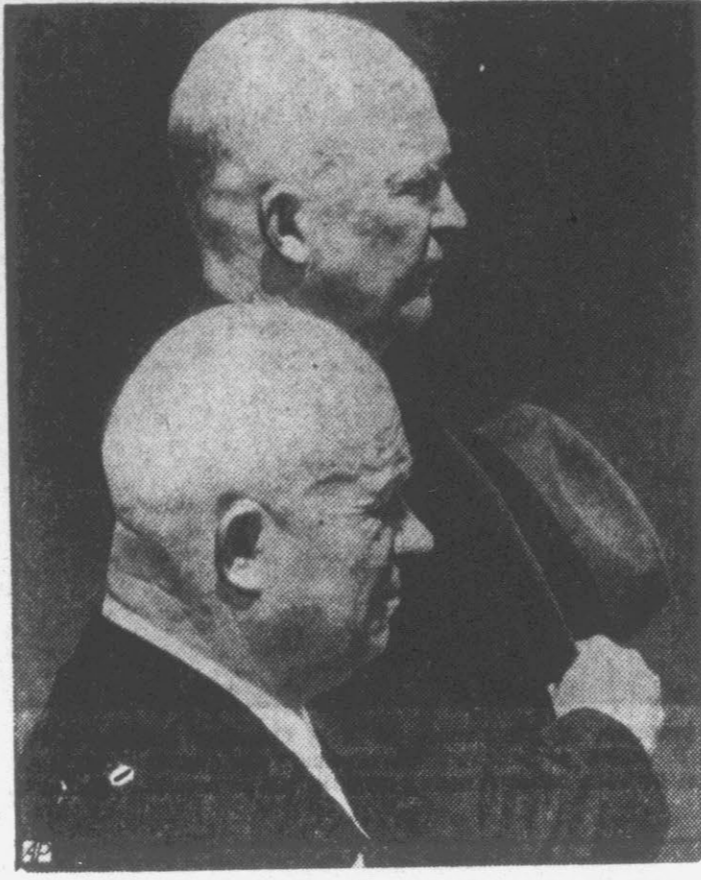

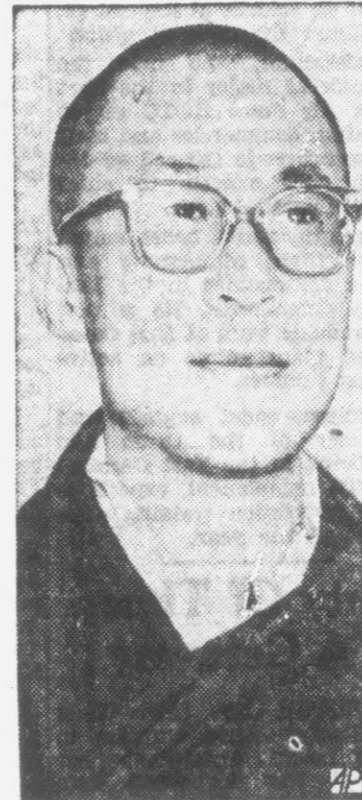

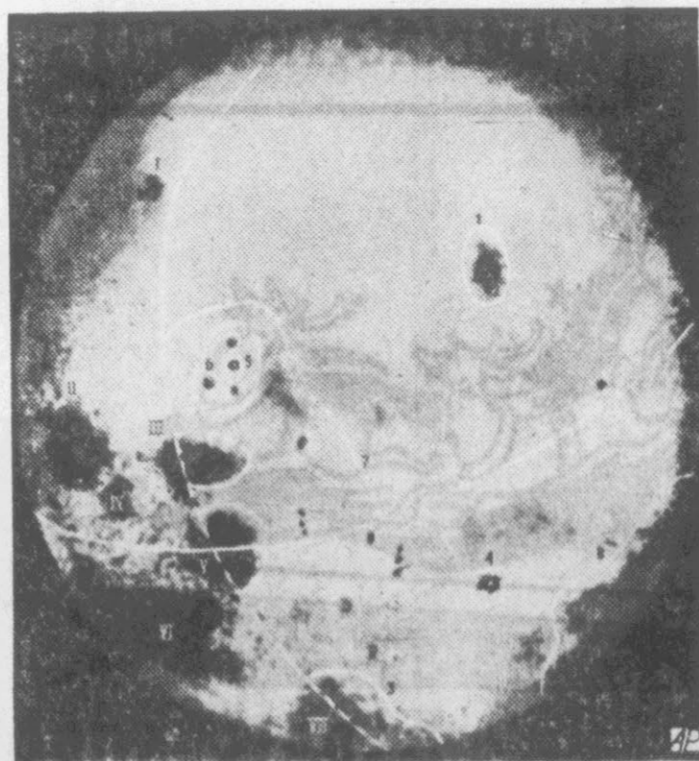

Acts Like Candidate' But Denies Role

EDITOR'S NOTE: This is the season when presidential hopefuls beat the bushes and prowl the prairies, talking, watching, counting, wishing. Associated Press political writers have been traveling with potential candidates, taking a close-up look at the men who could wind up in the White House. Here Arthur Edson, 15 years an observer of the Washington scene, reports on three eventful days in the life of a man who insists he isn't a candidate, Sen. Lyndon B. Johnson.

MARSHALLTOWN, Iowa (AP)—Of all the coy presidential aspirants who flit around the land, none is harder to figure than he tall, ambitious, hard driving Texan, Sen. Lyndon B. Johnson.

Johnson acts like a candidate. He hustles from spot to spot, in his own twin-engine, six seater plane, like a candidate. His words are the words of a candidate. He even smiles good like a candidate should. But publicly and privately Johnson will assure you that he's no candidate. Since he's making no effort to win the Democratic presi-

dential nomination, he says, he hasn't a chance.

Johnson's own explanation of what he's up to seems true enough. He's the Democratic leader in the Senate, responsible for legislating for all the people. He should see what's happening outside of Texas, and he often does when Congress isn't in session. But as you watch and listen and wonder, a few impressions fall into place.

No man is more skilled at counting the political house than Lyndon Johnson. He's such a shrewd and careful political leader that even Republicans in the Senate sometimes speak of him in awe and in envy.

Johnson is proud that the lights in his office burn late as he and his staff check and recheck on how other senators plan to vote. "We're busy with our homework," Johnson says. But Johnson doesn't have to stay

up late at night to discover this fact of political life: Since the Civil War, the door of the White House has been locked tight against all Southerners.

Johnson knows it, and Johnson resents it. His resentment shows up in such comments as this one made while he was speaking up for additional civil rights legislation. "We must purge ourselves of all bigotry, whether it's against a majority or a minority, whether it's against a class or a section." Here Johnson paused significantly. "And I'd like to emphasize 'section.'"

Johnson probably will go to the national nominating convention next summer with a good lineup of Southern votes, as well as others he will pick up in the Mountain and Western states. The convention should be a hum-dinger.

If it should come to an unpropo-

sitive stalemate, a man of great persuasive powers, who knows when to move and when to lie low, might make great progress.

A hundred-year tradition might be broken, and then Lyndon Johnson could stride as a full-fledged candidate up the path that leads toward the White House.

But now it's foolish to butto ne's head against a tightly locked door if his great friend and teacher, Speaker Sam Rayburn, wants to start Johnson - for - president clubs all over Texas, why not humor him? And there's no harm traveling about meeting the folks, is there?

It turns out a lot of folks are curious about Lyndon. He had overflow crowds wherever he spoke in Iowa and Kansas. Here, in a Republican stronghold, he drew 350 to a dinner in the Talcott Hotel. It was the largest Democratic turnout here in history.

When speaking to service clubs, Johnson takes the high road, with a few cleverly constructed detours.

He speaks of the great need for responsible leadership in this country. Then he mentions how, as majority leader, he never opposes anything merely because it's proposed by a Republican president.

"If this proposal is good for America," he will say, "it's good for the Democratic Party."

Only a dullard could fail to understand here that before them is a shining example of responsible leadership. At these meetings he refers to President Eisenhower often and kindly.

But at political meetings Johnson can become almost as free-wheeling as Harry S. Truman. True, he remains pleasant in his attitude toward Eisenhower, but now he may get in a few jabs.

He will be talking about the Soviet Union's Nikita S. Khrushchev, how forceful he is, how determined. "I didn't see a man who

needed a siesta in the afternoon," he will say.

This is a not too gentle reminder that Eisenhower sometimes sleeps during the day, and the impression left on the audience is that Johnson, who had a heart attack of his own in 1955, will never be caught napping.

Here in the farm belt Johnson naturally hits hard at the farm policies of Secretary of Agriculture Ezra Taft Benson. But he also blames the administration for high interest rates, for a lag in missiles, for what he calls the disrepair of our foreign alliances.

"The Republican party," he says, "has already settled for second place in the world."

In nearly all of his speeches Johnson slips in a sentence that comes out about like this: "Let's keep our eyes on the stars—and do the possible."

It's too early to say what's possible or impossible. But no matter what he says, you can bet that Lyndon Johnson has his eyes on the political stars shining so temptingly over the White House.

The overall problem ahead is made more urgent by the fact that the labor force is growing and will grow even faster in a few years.

Swan Promptly Left His 'Cleo'

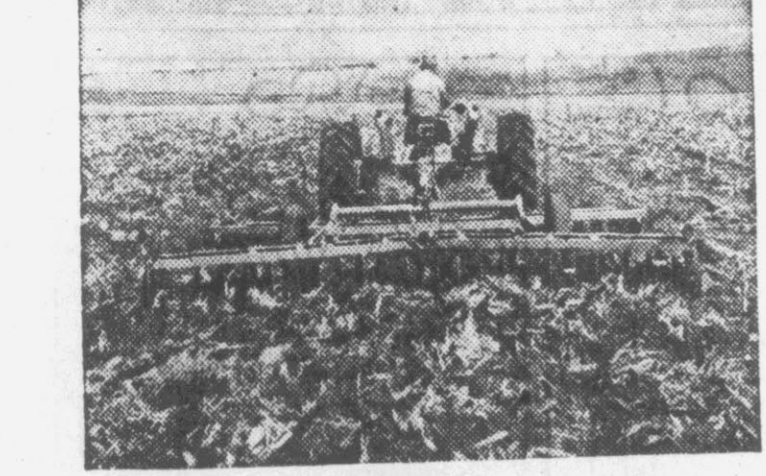

More Money To Spend For Christmas; Sales Booming

NEW YORK (AP)—People have more money to spend and they're spending it for Christmas.

That's the report today from almost every section of the country as merchants ring up sales which they expect will be the biggest for any Yule season in history.

An Associated Press survey of 24 major cities produced predictions of gains ranging from 2 to 15 per cent over record 1958.

"It's going to be a crackerjack of a Christmas," was the report from San Francisco. "Department store sales are really rolling" Cleveland reports.

"This will be our biggest year," says Raleigh, N.C., merchants. "Exceptionally good," report New York's biggest stores.

Merchants say the steel strike has had little effect generally on Christmas buying. Store owners attribute the avalanche of buying to these factors: People earned more and saved more in 1959; prices are unchanged to only slightly higher than a year ago; credit is easier. Credit cards spurred buying in

Los Angeles. "At least the woman of the house thinks she has more money," said a department store official.

Shoppers are snapping up high-priced luxury items. "The big price tag doesn't scare them anymore. They are more concerned with fashion and quality," says a St. Louis merchant.

Miami, Fla., reported a strong demand for furs and \$40 sweaters. An Indianapolis store had to reorder \$100 suede jackets. In a North Carolina city, \$25 electric can openers are going good. Marshall Field & Co. of Chicago expects to sell several \$2,000 assemble-it-yourself summer houses styled like a pagoda temple.

High-priced stereo and hi-fi sets are in general demand. Shoppers are showing a practical side, too. "If you have a good bargain and they realize it, they grab the stuff like hotcakes," says a women's apparel shop owner in

Kansas City. The hot item in toys this year is a 36-inch doll that can be dressed in a 3-year-old girl's clothes. For boys the big attractions are space age toys such as missile sets and scientific laboratory kits.

Fads haven't been as strong as in some years. But highly colored and decorated spats for girls are brisk in Detroit; red vests and gold shirts are sharp in Chicago. Two cities ran into strikes which crimped shopping activity to some extent. In Portland, Ore., a strike against two newspapers caused them to publish combined issues with limited advertising. Merchants reported advertised items sold well but that others did not.

Besides, adds the Rev. Dr. Moss, there is no record of Preacher Strawbridge even being in America as early as 1753.

Mechanization Is Still For Future On Soviet State, Collective Farms

Mechanization on Soviet state and collective farms is still far behind the stage we consider necessary in the United States.

Much hand work is required on a Soviet farm, work that would almost always be done by machine in this country. Like consumer goods, farm machinery is scarce in the Soviet Union.

Some of the farm machinery I saw during my recent trip to the Soviet Union fairly well built, but much larger than necessary for the job it was intended to do. For example, a crawler-type tractor would be used to pull a 3 or 4-bottom plow when it could just as

well have been pulling a 6. I visited a tractor factory and a combine factory. In both, working conditions were extremely poor. There were few if any safety devices. The lighting was poor, and many of the machine tools obsolete. Many of the foundry machines being used in the Soviet Union today were made in the United States.

On the farms, mechanization appears to be about half complete. Here is a fairly typical rundown of the machinery available on a 15,750-acre collective farm, where 1,850 families — 7,400 people — lived.

Mechanization included 24 tractors, 56 trucks and 2 cars. To help with the field work, 350 horses and 35 oxen were also being used. Plows, discs and planters completed the mechanization.

A great deal of the field work is still being done by hand by both men and women. Harvesting of potatoes was in full swing during my visit and much of this was done with an ordinary hand fork. Much of the sugar beet harvesting is also done by hand.

Expect Industry Outlays To Rise

WASHINGTON (AP)—The government expects industry spending on new plants and equipment to continue its slow rise early next year.

Present spending for such purposes—a major indicator of business trends—is estimated at about \$4 billion dollars yearly. That figure is smaller than had been forecast earlier, indicating the steel strike and other factors have caused a cutback in some planned projects.

The Commerce Department and the Securities and Exchange Commission said Wednesday an industrial survey indicated the annual rate is expected to increase about 500 million dollars in the first quarter of 1960.

This year's outlays, estimated at \$2.4 billion dollars, are about 7 per cent above 1958.

There is a tremendous contrast between the machinery on display at the Moscow and Kiev agricultural exhibits and what you actually see on a farm in many instances. The machinery on display is brightly painted, often very similar to U.S. machines but usually much larger. A complete line of farm machinery is shown.

On the farms, much of this equipment is not in evidence. It appeared to me that the machinery on exhibition was there for two reasons. First, to show foreign visitors Soviet mechanization. And second, to show the Soviet citizens what will be available in the future.

I am sure the average American tourist visiting only these exhibits, and not getting out on farms, would be impressed with the variety of machinery available. Out on the farms, however, it is another story.

Mechanization of farmstead chores is barely beginning on the farms I visited. I did see some milking machines, but I also saw a great many women milking by hand. I saw dairy barn gutter cleaners, but I also saw the gutter dumped from a gutter cleaner onto a flat-bed wagon. From there it is hauled to the fields and pitched off the wagon by hand. I never saw a refrigeration unit used for milk cooling.

Feeding of livestock is almost always done by hand. There ap-

parently are no augers, elevators, or blowers used to lighten the feeding chore. The one impressive mechanized feed mill I saw was a complete pelleting operation. It compared favorably with similar installations in this country.

The shortage of farm machinery is probably another result of Soviet concentration on other fields. Heavy industry, large hydroelectric dams, missile plants, and so forth are considered more important at present. Therefore, increased manufacture of farm machinery will have to wait until some future date.

Although it appeared to me that mechanization on Soviet farms was far behind that in the United States, there is apparently much more of it than just a few years ago. And it will be interesting to watch Soviet progress in the next few years. The abolition of the machine tractor stations in 1958 is having a profound effect on Soviet farm mechanization. Now, the farms themselves own the machinery and are responsible for its use and repair.

As in so many other areas the Soviets could, I am sure, make tremendous strides in farm mechanization should they suddenly decide to concentrate on this area. Whether they would or could take such a step is another question.

Sees A Use For Smoke Signals

SAN FRANCISCO (AP)—James A. Rork, Arizona employment service director, suggests Indian smoke signals as the answer should nuclear attack wipe out all modern communications.

Rork made the proposal at an emergency manpower conference of civil defense officials Wednesday.

"In Arizona we use smoke signals to reach Hopi Indian fire-fighters in an emergency," he said. "We burn old automobile tires to make good black smoke."

Warn Of Fraud In Mail Orders

WASHINGTON (AP)—The Post Office Department cautioned buyers today that some mail order advertisements are fraudulent.

"Christmas season is one time of year when certain unscrupulous operators of mail order businesses trade on the good faith of Americans," Postmaster General Arthur E. Summerfield said in a statement.
