Georgia House Votes 'Tagging' Outside Tobacco At Warehouses

State Senate Awaits Fight; Carolina Leaf Said Crowding Local Product

ATLANTA (AP) — Fight is expected in the State Senate over a bill calling for different labels on imported and Georgia-grown tobacco sold in Georgia warehouses.

The Agriculture Committee approved the House-passed measure following a two-hour public hearing Tuesday. But a compromise amendment was made to the proposal and tobacco growers indicated they would not go along with the change.

As introduced by Reps. William Lanier and Dorsey Matthews, the bill called for different colored tags on each pile of tobacco as it was lined up to be sold in the warehouse — white tickets on Georgia Type 14 and blue on tobacco from the Carolinas or Virginia.

The amendment would make all of the tickets white but would have the different tobacco types stamped on them. Lanier told the farmers and warehousemen who crowded the senate chamber that the bill was introduced because too much Carolina tobacco is crowding Georgia tobacco off markets in this state and there is confusion among buyers who expect to get Georgia's better-type tobacco.

Ask Hearing On Airliner Crash

WILMINGTON, N.C. (AP) — A public hearing here in late March will be recommended to the Civil Aeronautics Board in the investigation of the Jan. 6 crash of a National Airlines plane. Thirty-four persons died in the crash at near-by Bolivia.

Rose High Senior Is Morehead Finalist

James Clark Brewer, son of Mr. and Mrs. James W. Brewer of 1001 Colonial Avenue, Greenville, has been named a finalist for the Morehead Scholarship competition at the University of North Carolina.

A senior at J. H. Rose High School, Clark is president of the high school student body, an honor student and a member of the varsity basketball team. He has been invited to Chapel Hill for an interview with the central scholarship committee as a part of the procedure for final selections of Morehead scholars. Clark was nominated for a Morehead Scholarship by the Pitt County committee along with four other Rose High seniors, and recently was recommended for further consideration by the district scholarship committee.

President Says Missile Record Quite Gratifying

WASHINGTON (AP)—President Eisenhower today called America's missile development record quite gratifying. He rejected proposals for an around-the-clock bomber alert.

At a news conference, the President sided vigorously with Secretary of Defense Thomas S. Gates Jr. and Gen. Nathan F. Twining, chairman of the Joint Chiefs of Staff, in their differences with Gen. Thomas S. Power, head of the Strategic Air Command.

Eisenhower rejected Power's call for a continuous airborne bomber alert, and also the general's contention that the United States faces the danger of having its retaliatory striking force knocked out by Soviet missiles.

Eisenhower seemed to be a bit irritated when talking of Power's differences with Gates and the joint chiefs. Too many of these generals have all sorts of ideas, he said. The President warmly praised Gates and Twining and added that he has complete trust in both.

Eisenhower said further he believes he spent enough time in the military to know what he is talking about—and not to be disturbed by what he termed the parochial viewpoints of those who say the bosses know nothing about it.

A reporter asked whether Eisenhower feels there is a basic danger of defeatism developing among the American people. He replied there is none in his soul, he would say that. The news conference dealt also with these matters:

POLITICS — Eisenhower spoke warmly once more of Vice President Richard M. Nixon, but again withheld specific endorsement of Nixon for the Republican presidential nomination. However, the President added he wanted to make it perfectly clear that he is not dissatisfied with, as he put it, the individual who looks as though he has the nomination.

That was a clear allusion to Nixon, now regarded as a shoo-in for the GOP standard. A reporter told Eisenhower that some California Republicans seemed to be rather surprised that he had made no mention of Nixon in his political speech in Los Angeles a week ago.

The newsmen asked whether Eisenhower intended to stand by his announced policy of endorsing no one for the nomination prior to the party's July convention, even though Nixon apparently will have no opposition. Eisenhower said the outcome now does appear to be academic, but he went on to say that actually there are a number of Republicans—big men, he called them—who could be considered for the nomination.

In view of that, he said, he has followed what he believes to be the correct course of endorsing no individual. As for making no mention of Nixon in his Los Angeles talk, Eisenhower recalled that he has praised Nixon in the past. He said he is sure Nixon is not unaware of his sentiments about him.

Also in the political field, Eisenhower was asked whether he is concerned about the possibility the Republican party needs more vigor and more crusaders. With a smile, Eisenhower replied he has no doubt the party needs more recruits. He said he would like to see the party tell its story more fully, more eloquently and more often.

Kinston Bank Holdup Charged To Veteran Cherry Point Marine

Mixed Reaction In Random Poll On Bank Merger

By PATRICIA MOORE Reflector Staff Writer Some people think the Guaranty-Wachovia Bank merger proposal, approved by directors of the two banks, will be a good thing.

Some think the merger represents a loss to the community since Guaranty Bank and Trust Co., which ranks seventh in size among the banks of North Carolina, is a local bank.

And some are wondering just what the merged bank would be named here. The Daily Reflector conducted a random man-on-the-street poll to find out what public opinion is concerning the merger.

Pete Oglesby of 304 Elizabeth St., said he would be frank, when asked for his opinion of The Daily Reflector in an opinion poll.

DR. JOHN WOOTEN posed to the merger because I have a lot of pride in the fact that we have one of the largest banks in North Carolina whose home office is in Greenville.

With Guaranty as an independent local bank, he said, Greenville was more of a financial center for the branch banks.

"While it represents a financial gain to the stockholders, I think it represents a loss of prestige for the community," he said, however, he was sure the merger had been studied carefully by the bank officials and that their opinion "is worth more than mine."

C. E. Fleming, operator of a local laundrette, said he believed the merger would be a good thing. "It makes a larger bank," Wachovia is 41st in size in the nation.

"When Guaranty goes with the largest bank in the state, there'll be more lending power," he compared Wachovia's assets of over \$658 million with Guaranty's resources in excess of \$48 million.

But Fleming wondered, like a lot of other people, what the proposed merged bank would be named here. A spokesman said it would be named the Wachovia Bank.

A lifelong resident of Pitt County, Mrs. S. H. Crandell, said she believes the proposed merger is a good thing for the eastern part of the state. She said she had always patronized the Guaranty Bank and Trust Co., and had been satisfied with their service. But still, she considered the proposal beneficial to the section.

R. Frank Moseley said, "I don't see where it could do any harm. I think it would be beneficial to all concerned."

KINSTON, N.C. (AP)—A veteran Marine sergeant, who has won five Good Conduct medals, was charged today with the \$4,701 robbery of a Kinston bank.

Acting M.Sgt. Melvin Lee Nash, 33, an aviation ordnance instructor at the Cherry Point Marine Air Station, was placed under \$25,000 bond for trial in federal court April 18 at New Bern.

At a preliminary hearing before U.S. Commissioner W. J. Thomas here, a bank customer identified Nash as the man who entered and robbed the Parkway branch of Commercial National Bank last Wednesday, wearing a stocking over his face.

"How can you positively identify me?" Nash asked the customer, Miss Sarah Beth Hearn.

"By your profile, hair and full features," she replied. The FBI, which announced Nash's arrest shortly after midnight, said \$3,778 in one, five and ten-dollar bills had been found on the Cherry Point base. The FBI said it was not found in Nash's living quarters, but would not elaborate further.

At the end of the 15-minute hearing in an anteroom at a hospital, where Commissioner Thomas is a pneumonia patient, Nash remarked:

"Up until last night I had given everything voluntarily (to questioning officers). Now this young lady and coincidence has got me where I don't know where I am. I don't understand how she could identify me through a mask."

To a reporter's questions about whether Nash was guilty or innocent and whether he had been in trouble before, the 16-year Marine veteran replied, "No comment."

Nash was arrested at the Cherry Point base, 56 miles from here, and brought to Kinston for questioning. After the hearing he was taken to jail in Wilson.

Nash is a son of Mrs. Minnie B. Nash of Oklahoma City, Okla., and he lives on the Cherry Point base with his wife, Anne. The FBI said he was born in Wilson, Okla.

W. Wade Bromwell, special agent in charge of the FBI's Charleston office, announced the arrest. He also praised the fine help given by other law authorities.

An armed, masked bandit entered the bank shortly after it opened last Wednesday and made off with \$4,701. The FBI did not say how much, if any, of the loot was recovered.

The fact-paced stickup occurred about 9:25 a.m. The bandit, brandishing a .45 caliber automatic, ordered tellers to stuff folding money into a brown paper bag. He had a stocking tightly-pulled over his face.

The branch bank's manager, Al Owens, and three women were ordered to the rear of the bank and told to lie on the floor. When they heard a door shut, the police were called.

He fled toward downtown Kinston in a stolen 1959 model white Ford, police reported. Left behind was between \$10,000 and \$15,000 in the teller's cages.

It was North Carolina's first bank robbery of the year.

Find Man Inside Local Bakery

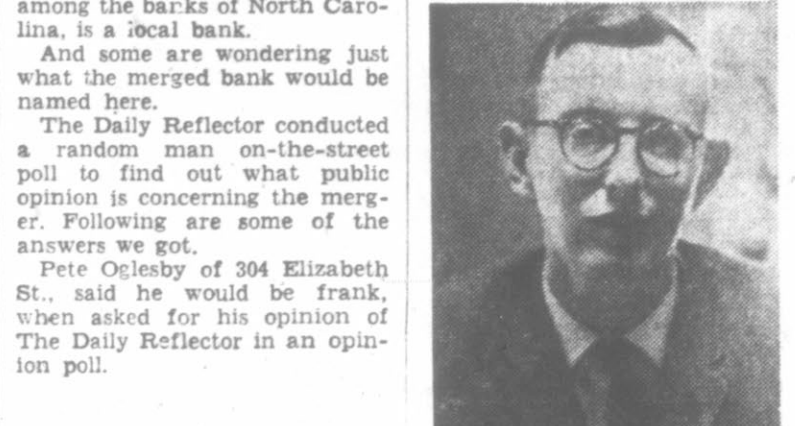

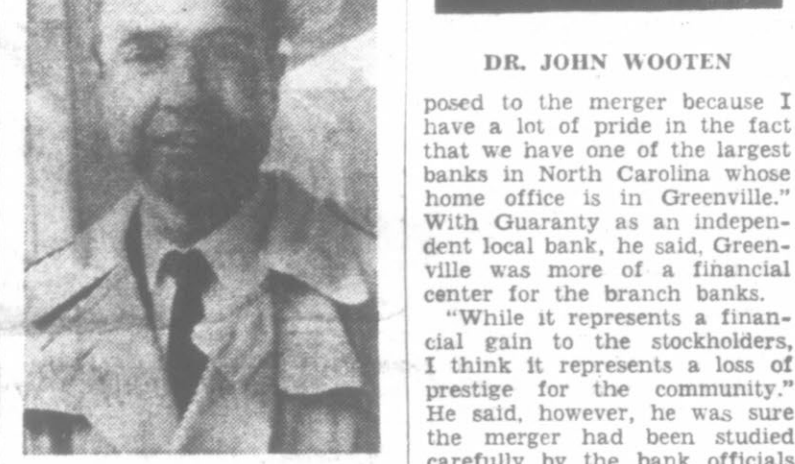

Officers set damage to the truck at \$600 while damage to the 1956 model car, reportedly a total loss, was estimated to be \$1,000.

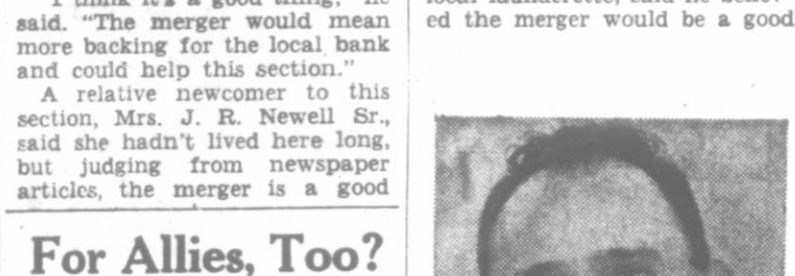
Investigation of the wreck is incomplete, police reported.

Son Of Former Slave Elected Union President

NEW YORK (AP) — A 62-year-old son of a one-time North Carolina slave has taken office as president of a 12,500-member union of municipal employes here.

He is William Lewis, born in a two-room frame house in Battleboro, N.C. His father, Ned, was a slave until he was 21 and became a postbellum sharecropper and carpenter.

Lewis took office Tuesday as head of Local 237, City Employees Union of the International Brotherhood of Teamsters. He was elected by the executive board of the integrated local on Monday night for three years to fill a vacancy.

Lewis' salary as president will be at least equal to the \$10,000 a year he received as a union trustee and head of the hospital employees division. He had worked for a number of years as a practical nurse and attendant in city hospitals.

Meat And Potatoes With A Fancy Twist

Husbands and children are notorious for being meat-and-potatoes people, but that doesn't mean they won't welcome interesting presentations of these favorite foods.

A big success at our house is to take frankfurters and mashed potatoes and give them a new look. There's method to our madness because the franks can be stuffed with the potatoes ahead of dinnertime and then popped into the oven at the last minute.

You can of course prepare your own potatoes for the dish, but when you are short of time or energy you may wish to use the instant flaked potatoes that come in two foil envelopes in a 5 1/2-ounce package. In this particular recipe we've added cheese to the instant potatoes, but here are other flavoring suggestions.

POTATO-STUFFED FRANKFURTERS

Ingredients: 1 envelope (from a 5 1/2-ounce package) instant flaked potatoes, 1-4 cup grated sharp cheddar cheese (loosely packed), 8 frankfurters, paprika.

Method: Make up potatoes according to package directions, then mix in cheese. Slit each frankfurter lengthwise but not through bottom; fill with potato mixture. Place on ungreased baking sheet; sprinkle with paprika. Bake in moderate (350 degrees) oven 15 minutes or until hot through. For an extra garnish heat a frankfurter in simmering water and slice crosswise; tuck slices into potato stuffing when

SPINACH WITH CHEESE SAUCE

Ingredients: 1 package (10 ounces) frozen leaf spinach, 1/2 teaspoon salt, 2 tablespoons butter, 1 tablespoon flour, 1 cup milk, 1/2 cup coarsely grated cheddar cheese.

Method: Cook spinach using the amount of water called for on the package and the 1/2 teaspoon salt; drain; chop slightly. Melt butter in saucepan over low heat; stir in flour; add milk; cook and stir constantly until thickened. Add cheese; remove from heat; stir vigorously until cheese melts. Add drained slightly-chopped spinach; reheat briefly but do not boil.

HAM SALAD PLATE

Ingredients: 1 container (8 ounces cream-style cottage cheese (small or large curd), 1 tablespoon grated orange rind, 4 large ripe pears, romaine or watercress or other salad greens, sliced cold baked ham, French dressing.

Method: Mix cottage cheese and orange rind. Pare pears; cut in half; remove stem structure; arrange on greens. Fill pear cavities with cottage cheese. Add baked ham to plates. Serve with French dressing. Makes 4 servings. Note: Other additions such as silvered dates, chopped pecans or toasted filberts, may be added.

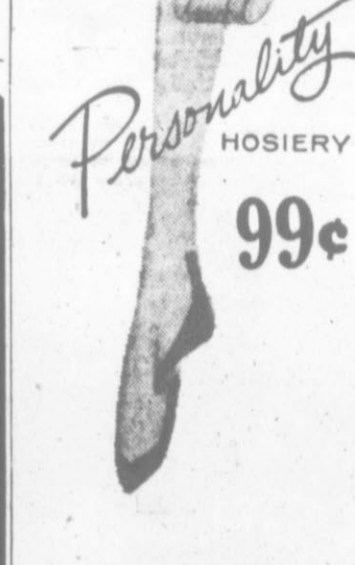

Outwardly Placid Principal Slays 2 And Self

HARTFORD CITY, Ind. (AP)—School Principal Leonard O. Redden, outwardly a placid man, is dead—driven by inner anguish to kill two women teachers and then himself. Redden kept his private fears hidden behind a quiet smile until Tuesday. Then, before their fifth-grade pupils, he killed Harriet Robson, 52, and Minnie McFerrin, 62. Finally, in the woods where he used to hunt, he fired his shotgun into his own chest.

ers and friends of the principal in this neat little northern Indiana town couldn't conceive of Leonard Redden's doing such a monstrous thing. A few recalled he had been irritable lately and quick to take offense. But he remained outwardly calm in chance meetings and had the same gentle smile. They didn't know Redden had been growing increasingly depressed since last spring. He was convinced Miss Robson herself was spreading rumors linking them romantically. "Of course there was nothing to this idea," said the principal's wife. "But he couldn't throw it off. He chose to believe it, and he couldn't be convinced it wasn't true."

Tuesday morning Redden arose and watched his wife drive off to consult the family doctor. Then he bought some more shells for his 12-gauge shotgun, tidied up his desk and drove to the school. Rapidly he strode into the first-floor classroom of Miss Robson. The 21 children stared at the shotgun. "They aren't going to hang me," the principal shouted. He fired a single shot, killing Miss Robson with a blast in the chest. "All the kids thought it was a joke until we saw the blood," said Richard Monroe, 11. "Miss Robson was very nice to us. She didn't give us much homework."

Some of the pupils screamed. Others were too shocked to make a sound. Waving the frantic youngsters back into the classroom with his gun, Redden climbed a concrete ramp to the classroom of Mrs. Minnie McFerrin, 62. "Don't shoot me," she pleaded. Redden killed her with a shot in the face. Blood splattered over a piano and on textbooks lying on nearby desks. A janitor ran up, saw the prin-

incipal with the gun and threw a crowbar at him. It missed, and Redden made for the floor. En route he pointed the shotgun at a male teacher and another janitor, but he drove off without firing another shot. Word of the killings spread quickly among the town's 7,250 residents. Parents dragged children indoors as all schools were dismissed. Police mounted guard over teachers, at the school, at Redden's home, the doctor's office, road intersections—everywhere a crazed man with a loaded shotgun might take a notion to go. About four hours later a farmer spotted the principal's car, mired down in a thicket seven miles southwest of town. Several schoolbooks lay in the rear seat, and a few report cards were still neatly attached to a clipboard. Shortly before dusk, officers found Redden. Redden, who had changed his conservative business suit for worn hunting clothes, lay as if asleep near a pile of felled trees. The shotgun was cradled in his arms, and three cigarette butts showed he had sat there for some time. The end of Leonard O. Redden—a kindly and quiet man.

SANTA MONICA, Calif. (AP)—Actor Anthony Quinn has sued actor Yul Brynner and two film corporations for \$1,150,000. In a complaint filed Tuesday, Quinn alleged breach of an oral agreement. He said he and Brynner were to buy a literary property, "The Magnificent Seven," for a movie. Instead, Quinn claims, Brynner bought the literary rights through Alcona International Corp. Quinn sued Brynner and Alcona for \$500,000 each. He asked \$150,000 from United Artists Corp. for loss of his services as an actor in the proposed production. Rome was founded in 754 B.C. Defense Secretary Predictable Target; Soon Ran Into Attacks

WASHINGTON (AP) — In the two months he has been secretary of defense, Thomas S. Gates Jr. has become the center of a political storm. How much of the storm is generated by politics in a presidential election year and how much represents genuine concern over the administration's defense policies is hard to determine. Gates was a predictable target for Democratic critics when he went before House and Senate committees to defend President Eisenhower's 41-billion-dollar defense budget for the fiscal year that starts July 1. At first Gates appeared to be doing a good selling job. After he and Gen. Nathan F. Twining, chairman of the Joint Chiefs of Staff, described the defense picture to the House Defense Appropriations Subcommittee, Chairman George Mahon (D-Tex) exclaimed: "This is the most enthusiastic and rosy and reassuring presentation that we have ever had."

He said intelligence estimates of Soviet strength now are based on "what we believe he (Russia) probably will do, not what he is capable of doing." To Symington, this represented juggling U.S. intelligence reports to give a more favorable picture. Gates and President Eisenhower have heatedly denied any juggling. The president sprang to Gates' defense at a news conference. He said Gates was "a very splendid civil servant" and his remark on intelligence was "subject to misinterpretation." Gates himself told another House committee "we have never been relying on what their intentions will be in reference to specific actions." He repeated again and again his conviction that U.S. defense presents no "deterrent gap"—no lack of strength to retaliate—when viewed as a whole. Gates brings to his tough job a background of wealth, Navy combat service in World War II, and experience as secretary of the Navy. He has a reputation for firmness and efficiency. Born April 10, 1906 in Germantown, Pa., Gates comes from a family of Philadelphia investment bankers. In World War II he was decorated for combat duty in the Mediterranean and the Pacific and finished the war as a captain. He was called to Washington in 1953 to be undersecretary of the

Navy, and in 1957 moved up to the secretaryship. He had resigned and was preparing to return to his life as a Philadelphia banker last year when Deputy Undersecretary of Defense Donald Quarles died. Quarles had been slated to become secretary of defense upon the long-predicted resignation of Neil H. McElroy. Another experienced man was needed to take McElroy's place and Gates was persuaded to stay. "I couldn't think of any reason not to do it," Gates said at the time, "except that I didn't want to, and that wasn't good enough." Gates is tall, slender and impressive in appearance. He customarily introduces himself by striking forward and saying "I'm Tom Gates." The present squabble over defense needs recalls something Gates said in an interview last fall: "I would never be part of any budget that I believed inadequate," he said firmly. "I'd quit." Gates is married to the former Millicent Ann Brengle. They met at Northeast Harbor, Maine, where the Gates family spent summer vacations and where Gates still returns, "it being a sort of religion in our family." The Gateses have three daughters and five grandchildren. An only son, Thomas S. Gates III, was killed in a fire at a Canadian ski lodge several years ago while he was a student at Harvard.

Pay \$50,125 In Local Taxes

Local managers of Carolina Telephone and Telegraph Company, one of Pitt County's major taxpayers, handed tax collectors in the county checks totaling \$50,125.79 last Friday. The total amount paid into Pitt's collection offices was the company's 1959 ad valorem tax bill for its property in Pitt County and these municipalities: Ayden, Bethel, Farmville, Fountain, Greenville, Grifton, Grimesland, and Winterville. Presenting the checks were Manager Frank Harrington at Ayden, Greenville, Grimesland, and Winterville; Manager E. T. Meeks at Bethel; Manager R. L. Spivey at Farmville and Fountain; and Commercial Manager C. G. Fields at Grifton. Taxes on the company's property in these towns or cities in the county are part of the more than \$750,000 in 1959 city and county taxes paid by the company, an increase of about six percent over last year. In addition to these local taxes, Carolina Tel. and Tel. also paid 1959 taxes to the state and federal governments, which brought its total tax bill to more than \$6,151,000. Also, the company collected and remitted to the federal government during the year more than \$2 million in excise taxes on its services.

Nixon Quietly Preparing His Own Farm Program

WASHINGTON (AP) — Vice President Richard M. Nixon is quietly getting ready to draft his own farm program for his expected campaign as the Republican presidential nominee. President Eisenhower plans to send to Congress this week a wide-ranging program constructed on the recommendations of Secretary of Agriculture Ezra Taft Benson. While Nixon was consulted on broad policies, he had almost no hand in refining these proposals. However, he is certain to support them in line with his established policy of publicly backing all of the administration's suggestions to Congress. Nixon is well aware that Democrats intend to make a major issue in the election campaign of crop surpluses, declining prices and dwindling farm income. Democrats who now blame all of these on Benson's policies suspect the new program will be considerably less than satisfactory to them. Anticipating a battle in Congress, Nixon is preparing to draft some proposals of his own. He will air them in later speeches, possibly before the Republican convention platform committee goes into action. To get a cross-section of agricultural opinion, Nixon has been conferring quietly with a number of leaders in this field. If this is regarded in some quarters as an effort by Nixon to draw away from Benson as a possible political liability, Democrats

made it clear they intend to have a great deal to say about any such move. Sen. Hubert H. Humphrey (D-Minn), a candidate for his party's top nomination, said in an interview Democrats "aren't going to let Vice President Nixon wiggle out of any responsibility for the administration's farm program." "Mr. Nixon has to take the responsibility for the Benson program and its failures," Humphrey said. "Mr. Benson has many faults but we can rely on his word that the vice president is one of the architects of the administration's bumbling, fumbling program." Sen. Stuart Symington (D-Mo), who is available for his party's presidential nomination, already has accused Nixon of "trying to avoid his proper responsibility for the farm depression we now face." Symington said he hopes Eisenhower submits a complete program "so that we will know what he wants." "I give you my word, as a member of the Agriculture Committee who has heard Benson testify for years, I still don't know what this administration wants," he said.

Did Well Except For One Thing

SEATTLE Wash. (AP) — Marie Carter took her driver's license test Tuesday and did just fine except for one thing. When the patrolman told her to park the car she drove it through the wall of the patrol office. State patrol examiner David Pieterick said Mrs. Carter, 47, stepped on the gas pedal instead of the brake. Neither she nor Pieterick was injured but the car knocked a hole six by four feet in a concrete wall. She didn't get the license.

College Refuses Federal Gifts

CLAREMONT, Calif. (AP) — Tiny Claremont College isn't going to accept federal gifts. Not that the school — 340 men students—couldn't use the money. It's just that the board of trustees "believes in free enterprise in education." When a private college accepts government gifts, the trustees declared Tuesday, "it lets down its guard and invites interference to the pursuit of free inquiry and untrammeled scholarship."

Might Act To Consolidate Books

It is an old saying in political circles of North Carolina that the peoples' interest in politics doesn't start rising until sap starts rising in the trees in spring.

Well, spring is still a few months away, and the first elections of the year are more distant than that. But before the year is over, folk hereabouts will be much interested in political matters.

Unfortunately, some of them who thought they were properly registered to vote in the Democratic primary, or perhaps later in the general election, will find their names are not on the books and therefore they will be ineligible to cast a ballot.

For several years now it has been evident that Greenville should work out some solution to the confusion which arises over voting places in the city each time an election is held.

The root of the problem is that one set of registration books and one set of polling places is used for purely city elections and another set of registration books and another set of polling places is used in county, state and national elections.

In elections in which only city matters are decided Greenville citizens cast their ballots either at the main fire station or at the courthouse.

Seawell Points To Past Efforts

By LYNN NISBETH COURTS — In his speech to the Junior Chamber of Commerce at Leaksville the other night Attorney General Malcolm Seawell reviewed the long history of efforts at improvement of the courts.

Without detracting from the splendid work done by the N.C. Bar Association committee headed by Sen. Spencer Bell, which promoted the court improvement bills in the Legislature, Seawell reminded his young audience that none of the ideas suggested were original or new with that committee.

He cited record of efforts from 1906 until now to obtain a better method of jury selection by non-political commissions. As far back as 1914 there were proposals for less than unanimous verdict in civil cases—another feature of the 1959 program.

Perhaps a more serious problem is in the inferior courts, below the superior court level—justice of peace and recorder setups. That, too, is an old and continuing menace.

A Greenville resident must be registered on the city's voting books to be eligible to cast a ballot in a city election and on the county's books to be eligible to cast a vote in party primaries of the general election.

It is too late now to rearrange the voting systems before the Democratic primary in May, but before another election year rolls around, some positive effort should be made to eliminate the necessity of separate registration books and separate polling places for city elections and other elections for Greenville residents.

Sizeable Bootlegging Business Is Indicated

The year-end report of Pitt County ABC officers, whose job it is to stop if possible the illegal liquor traffic, points to the fact that bootlegging is still a business of considerable size.

According to the report, a total of 175 persons were convicted in Pitt last year in connection with the illegal liquor business. More than \$16,000 in fines were collected by the courts in the cases, and 15 automobiles were confiscated in connection with liquor law violations.

Perhaps of equal significance is the fact that Pitt's ABC officers last year destroyed 54 stills, an average of slightly better than one each week. It's a good guess there were considerably more than that number of stills in operation in the county at some time during the year, for it is highly improbable that the officers were able to discover and destroy them all.

Pitt, unlike some other counties in this section of the state, has never gained the reputation of being a big center of bootlegging. But when records for one year reflect as much activity in the illegal liquor field as do Pitt's ABC records for 1959, there can be no question about the fact that bootlegging remains a big business in North Carolina.

Restraint Has Served Us Well

NEW YORK (AP) — Every year my life insurance agent sends me a congratulatory post card on my birthday.

This month I figure he ought to splurge a bit and send a "get well" telegram. For it marks the starting of my 50th year, a landmark a man passes only once in his life.

Technically, I will be only 49, but I can see 50 on the rim of the horizon, and already I am getting those who-said-50-was-nifty blues.

Years ago my birthdays were kind of fun. They gave me an excuse to go around and collect kisses from all the pretty girls in the office.

His 40th birthday is a major disaster in any man's life. He doesn't fall for that Pollyanna guff that life begins at 40. He knows better. Middle age hits him with the impact of an on-rushing locomotive.

"When does the fun begin?" he asks plaintively, and feels in his heart that for him the fun of living is mainly past.

Women of 25 and 30 seem giddy and immature to you. Women of 40 and 45 are endowed with a new and mellow charm. You give up the idea that when you awake tomorrow you'll feel as good as you did 20 years ago.

You quit writing letters of advice to your congressman, and decide to let him stew in his own juice.

You no longer have to listen to your wife, because you know everything she says by heart—and, if she challenges you, you can play any of her verbal records back from memory.

You don't fight so hard against gathering fat, lost causes, and life itself. You are content to realize that one life isn't long enough to change the wide world.

Life isn't as exciting as it once was, but it is far more comfortable.

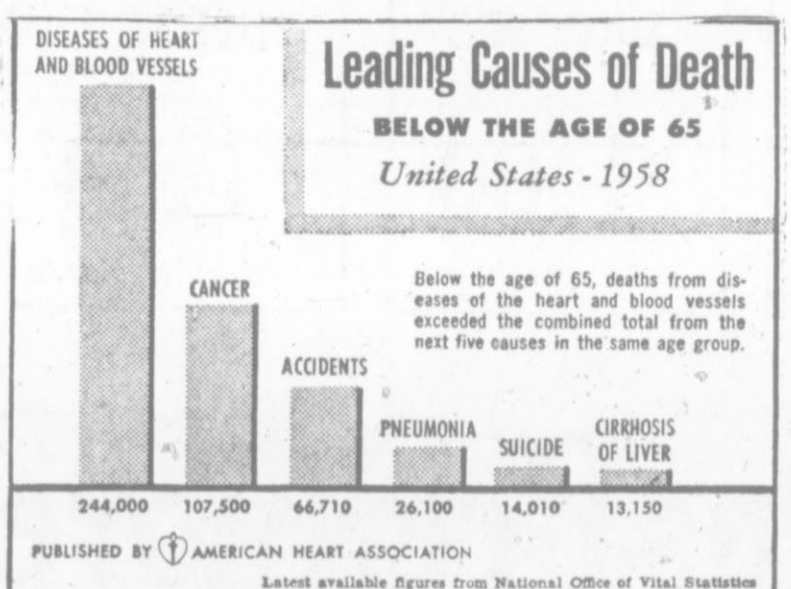

Jockeying In Air Freight Rates

By ELMER ROESSNER

If you send goods by air freight across the Atlantic, from now until April 1 you will be paying higher rates than you would pay if there were not an organization called the International Air Transport Association.

In fact, you have been paying higher rates for some time now. The association—spelled IATA and called the Eye-Ata in Trade circles—is an organization of international air lines. Every time it has been referred to here as a cartel or trust, I get pained letters from its representatives.

In Honolulu last fall, at one of the lushest conventions on record, IATA agreed on lower rates on specific commodities shipped across the Atlantic.

The cartel wasn't giving anything away. The rise in competition between trans-Atlantic lines and the introduction of jets,

with larger and faster payloads, is making it imperative for trans-Atlantic airlines to increase cargo. One way to do it is to lower rates, making it economical to ship more classes of goods by air.

APRIL FOOLS' DAY The cartel set the effective date of these cuts on April 1. If the gasoline companies of America got together and agreed on a new low rate on April 1, the public would scream. The idea of a group of corporations getting together to fix prices, and the plan to make a uniform reduction at some later date, would infuriate the public. But this open air deal passed almost unnoticed.

Then Pan American, a member of IATA, proposed to the Civil Aeronautics Board that it begin charging the new low rates on last January 1. The CAB had extended the old rates until March 31, 1960—quite convenient

for the IATA members—gut Pan Am said that because of the coming change, an "open rate situation" existed and that any airline could charge anything it wanted under those circumstances.

EFFECTIVENESS OF INERTIA Nothing happened—on the record, at least. Behind the scenes, other airlines accused Pan Am of double-crossing them and threatened reprisals. The CAB looked off into space, waiting for nothing to happen, and nothing did.

Pan Am, for its own reasons, did not press its application; CAB, for its own reasons, took no action. January passed, and the old rates are in effect, on Pan Am and on all other lines who hold membership in the cartel.

Meanwhile, you have been paying higher rates on the specific commodities for many

NEW YORK (AP)—The off again - on - again, maybe - so-maybe-Ingemar Johansson-Floyd Patterson return bout for the world heavyweight championship was practically a reality today.

Not quite, though. But it appeared that most of the major stumbling blocks had been cleared and that the new promoters, Feature Sports, Inc., merely had to sit out the required waiting period for a license to stage the bout.

Johansson, who lifted the crown from Patterson last year, and his adviser, Edwin Ahlqvist, headed home for Sweden in a happy frame of mind Tuesday night.

"I'm confident the contract will be signed when I return to the U.S. later this month," beamed Johansson.

"I talked to the Feature Sports people and the contract is in the process of being written. Everything looks fine for the fight in June."

While Ingo settles some European business matters, the wheels are grinding this side of the Atlantic to license Feature Sports, headed by Roy Cohn, former counsel for the late Sen. McCarthy's investigating committee.

"It generally takes four to five weeks to complete," he said. "We now are in the third week."

While the promotional side is practically cleared up, there still is no definite site for the bout. Ingo is on record as wanting it in New York. But Los Angeles, Milwaukee, Chicago, Dallas and Philadelphia all are bidding for it.

As for Ingo's much-publicized \$153,000 he still has coming to him from the first fight last June, he left empty-handed. But he is going to come back armed with all records and expense accounts for tax purposes and figures that as soon as the new contract is signed, he'll get the swag.

Eddie Mathews Signs Braves' Pact-\$50,000

MILWAUKEE (AP)—Eddie Mathews, the home run king of the major leagues, signed his 1960 contract with the Milwaukee Braves Tuesday. He'll receive an estimated \$50,000.

Old Pro 'Tiger' Jones Favored Against Greaves

By CHARLES CHAMBERLAIN Associated Press Sports Writer CHICAGO (AP)—Old pro Tiger Jones returns to the scene of his greatest ring triumph tonight as an 8-5 choice over Wilf Greaves, 24-year-old Canadian middleweight champion.

Five years ago, Tiger took on Sugar Ray Robinson as a 7-1 underdog at Chicago Stadium and handed the Harlem dandy, who was snuffing the comeback trail, one of his worst 10-round beatings. This launched Jones into a career as one of the most durable TV fight performers in the business.

He will be making his 37th appearance on television (10 p. m. Eastern Standard Time ABC) against Greaves, whom he defeated in a hard-fought scrap at Washington, D. C., in 1956.

Jones, 36, a slam-bang stalker, whose combinations are sharp but lack knockout power, has been bidding his time of late. In his last start, June 26, he defeated Victor Zalazar. Last year he lost to Paul Pender, who recently lifted Robinson's bottled version of the middleweight crown, and dropped a decision to Joe Giambra.

All he has is a 48-26-4 record and only 12 knockouts. Greaves is a crisp puncher and numbers 17 kayoes among 30 victories in 42 bouts since turning pro under the guidance of the late Jake Mintz in 1955. After a fight-a-month campaign, capped by his loss to Jones, Greaves hardened up against such contenders as Halo Scottichini, Gene Fullmer and Spider Webb.

Greaves, now under contract to Detroit sportsman C. W. Smith, has won his last three starts. He retained his Canadian title in Calgary, Oct. 15, by stopping Leroy Plamond in four rounds. He defeated Phil Meyer, Dec. 18, in Madison Square Garden and kayoed Eddie Bell in three at Philadelphia, Jan. 14.

Apps' Football Coach Resigns After A Month

BOONE, N.C. (AP)—Pat Preston has resigned as head football coach at Appalachian State Teachers College here after only a month on the job.

The International Ski Federation (FIS) ruled out skiers of both countries because they were not members of that organization. Previously the International Skating Union had denied Olympic participation for skaters from Nationalist China for the same reason.

The FIS and ISU set the regulations for Olympic participation.

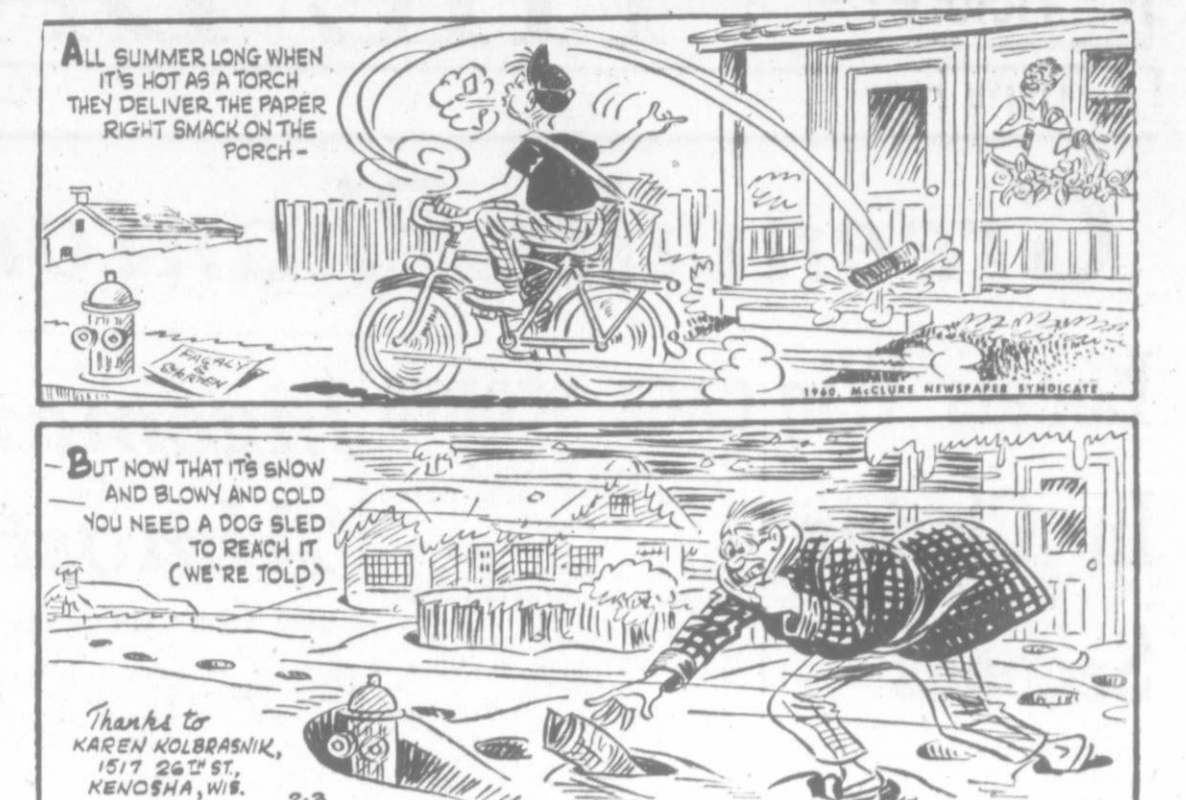

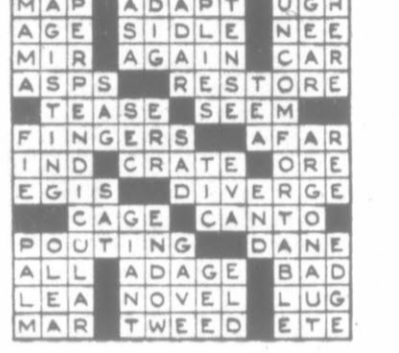

See Victory In Lamprey Fight

OTTAWA (AP)—Canadian and U.S. scientists feel confident they are winning their battle against the sea lamprey that has been killing off the trout in Lake Superior.

For four years the scientists have been teaming up in a crash program to exterminate Lake Superior's lamprey colony and preserve the trout's last refuge in the five Great Lakes.

Using underwater electric shocks and a powerful spawning ground poison, they have killed millions of the ugly bloodsuckers and now appear to have the upper hand. Ontario, Michigan, Wisconsin and Minnesota are cooperating in the restocking of the lake with hatchery-reared trout yearlings, about 700,000 of them last year.

The scientists of the Great Lakes Fisheries Commission plan this year to use their techniques in Lakes Huron and Michigan, where huge trout colonies were

wiped out several years ago. They will also try them out in Georgian Bay, where the lampreys have virtually finished the trout population.

The lamprey, a primitive, eel-like fish, has been in the St. Lawrence River and Lake Ontario for centuries. Measuring 1 to 2 feet, it kills by fastening itself to a fish by the pointed teeth lining its circular mouth.

The opening of the Welland Canal in 1829 enabled the fast-swimming killers to bypass Niagara Falls. Because they prefer cold water, it took them 100 years to migrate across warm, shallow Lake Erie.

They were first spotted in Lake Huron in 1932. Within 12 years they had reduced the lake's annual trout catch from six million pounds to virtually nothing. They moved into Lake Michigan and by 1953 had wiped out a commercial trout fishery which had yielded 5½ million pounds a year. They have cut Lake Superior's trout catch from 4,700,000 pounds in 1950 to 1,500,000 last year.

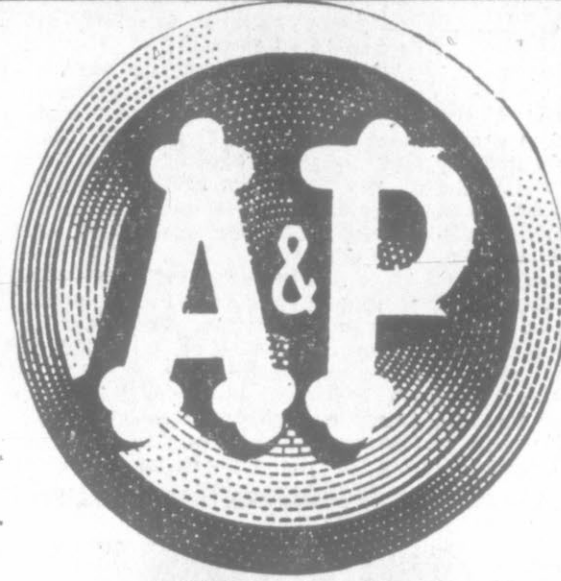

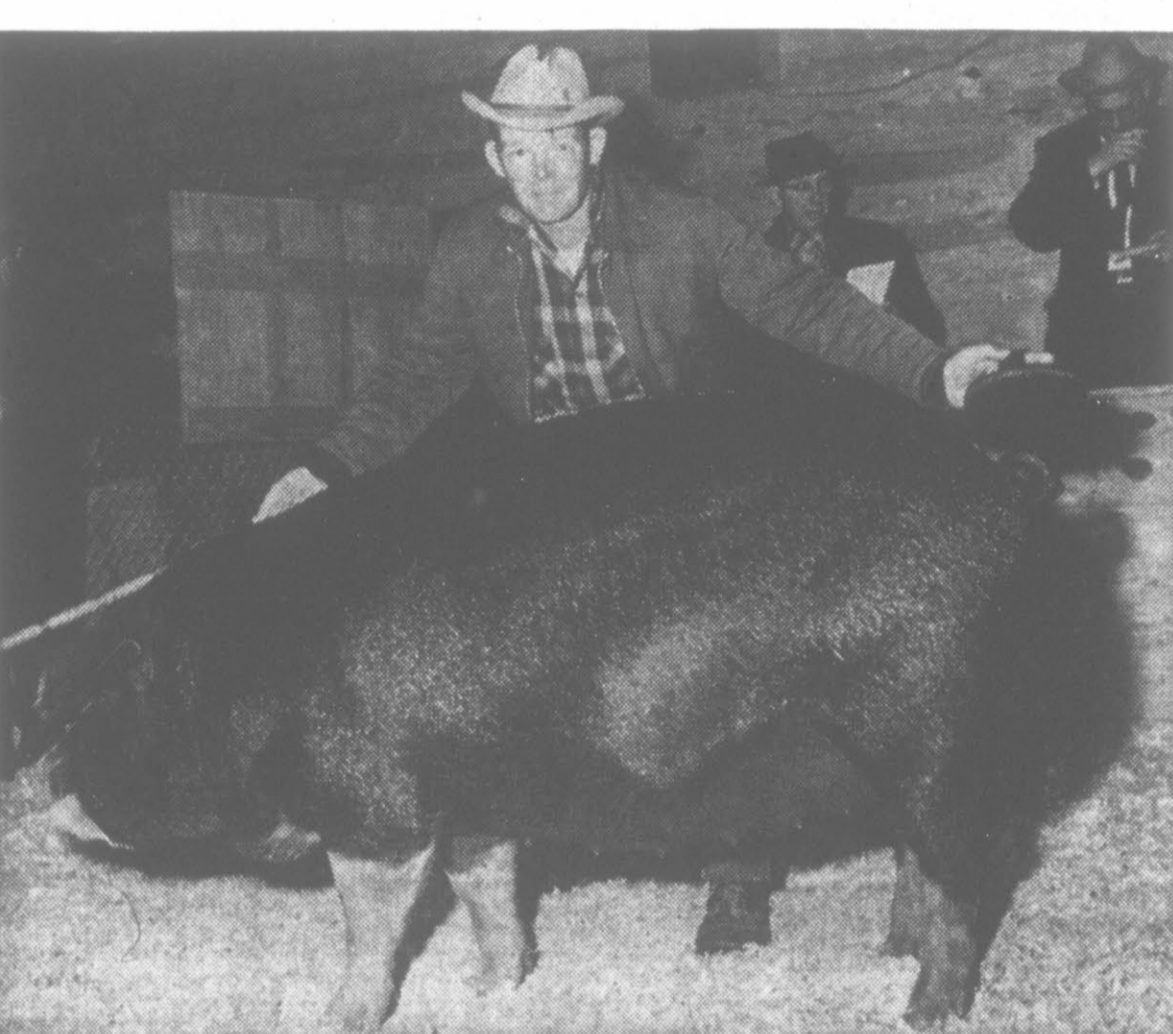

NEW YORK (AP)—The stock market recovery ran into profit taking early this afternoon and prices turned irregularly lower. The rebound from the steep January decline flourished for most of the first hour of trading and then prices began to slip below their best.
