United Fund Directors To Undertake New Program For Meeting 1960 Goals

Directors of Pitt County's United Fund in each of Pitt County's townships will undertake a program to raise additional funds in an effort to meet the United Fund goal for the 1960 fiscal year.

The action was taken by the board of directors of the organization at a special meeting last night in which it was reported that the United Fund campaign which began last fall is still considerably short of its goal.

Pledges to the United Fund so far, the report said, total \$66,297.97. The Pitt County United Fund, when it began its fund-raising campaign last fall, sought a goal of \$107,222.05. It means that so far the United Fund has raised only slightly more than 61 per cent of its budget for the current year.

Directors of the United Fund and representatives of participating organizations in the Fund met last night to determine what move should be taken by the United Fund. Discussion indicated it was the consensus of those present that the campaign should be intensified and continued in an effort to contact those who were not called on by solicitors in the initial campaign last fall.

The directors determined that representatives of the United Fund in each township of the county should handle the subsequent campaign in their respective townships.

Argentine Navy Expects Capture Mystery Sub Crippled In Fight

By BRIAN BELL. BUENOS AIRES, Argentina (AP) — Argentine warships have crippled a mystery submarine hiding in a southern Argentine gulf and capture of the sub is imminent, Navy Secretary Gaston Clement announced Thursday night.

Government authorities claimed the underwater intruder was successfully trapped after a 12 days of hide and seek near the Argentine naval base at the head of Golfo Nuevo, 650 miles southwest of Buenos Aires.

President Arturo Frondizi met with military chiefs at government house Thursday night. Sen. Alfredo Turano, president of the congressional defense committee, emerged from the meeting and announced in a radio broadcast that "the Argentine public can be sure that the intruding submarine exists."

Argentine authorities have been silent on the likely identity of the submarine. Both the United States and Britain said none of their submarines are operating in the area.

training duty reported spotting the latest submarine Jan. 30 in the Golfo Nuevo. The warships sealed off the narrow mouth of the gulf, to prevent the submarine from escaping into the Atlantic. Additional ships were rushed to the scene.

Argentine claims the entire gulf—a 20-by-40-square-mile body of water opening into the South Atlantic—has been territorial water.

It is too early to determine whether the two men will be permanently attached to the VOA staff when the radio stations begin actual operations.

Khushchev Says Soviet Union Is Strongest Power

NEW DELHI, India (AP)—Soviet Premier Nikita Khrushchev declared today that the Soviet Union is the strongest military power in the world but does not wish to take advantage of her superiority.

Gardening Today

An event, long past, slumbers until some thought stirs it. Then like a piece of rare old silver, that awakens to a touch, it glows, and memory brings it back.

This night, 46 years ago, it was snowing. The wind played a weird chant of winter—its many hands strutting against the icy whips of the trees. The snow, dancing to the tune of the wind, twisted and whirled. What lights there were threw out their feeble effort to conquer the dark. What they could not do, the white blanket accomplished. But the wind and snow did not own the night—others had plans.

On the campus of the young training school would take place an event that was as far removed from this wintry scene as the sun of summer. Soon, there would unfold a pageant that would cause the gods of twig and leaf (if there be such) to lean forward, precariously, on their thrones. What would soon take place is found in "The Training School Quarterly," April, May, June, 1914, of the East Carolina Teachers College.

"The class of 1914, following the precedent of the class of 1913," were all set to plant a tree. "They selected the magnolia as a representative of the Southern tree. This was one of the coldest nights of the entire winter but nothing daunted the ardor of the class. All dressed in white (under long coats) and wearing the purple class tie, the class marched out gaily singing the class song.

"The thirty-eight hilarious girls, shivering and with chattering teeth, were followed by the brave faculty, acting as sponsors. The

wind and snow gave zest to the whole—adding to the ghostly effect. The girls skipped around the little tree, continuing the class song, which each member shoveled dirt on the tree with the historic spade of the training school.

"Miss Mary Weston returned to President Wright the spade which had been used in breaking of the ground and other tree plantings. Miss Luella Lancaster recited a little fable, full of the spirit of the occasion. President Wright accepted the tree in his most happy manner. He assured the class that they would always be linked to the school."

Their out-of-season chore done, these hardy folks soon sought the more comfortable indoors. As this was in the days before penicillin, the whole affair smacked of bravado.

"When the next morning dawned, the sturdy tree seemed to look with surprise for the first time over the school campus covered with ice and snow." This seems to be a reasonable assumption—for it indeed was a surprising event.

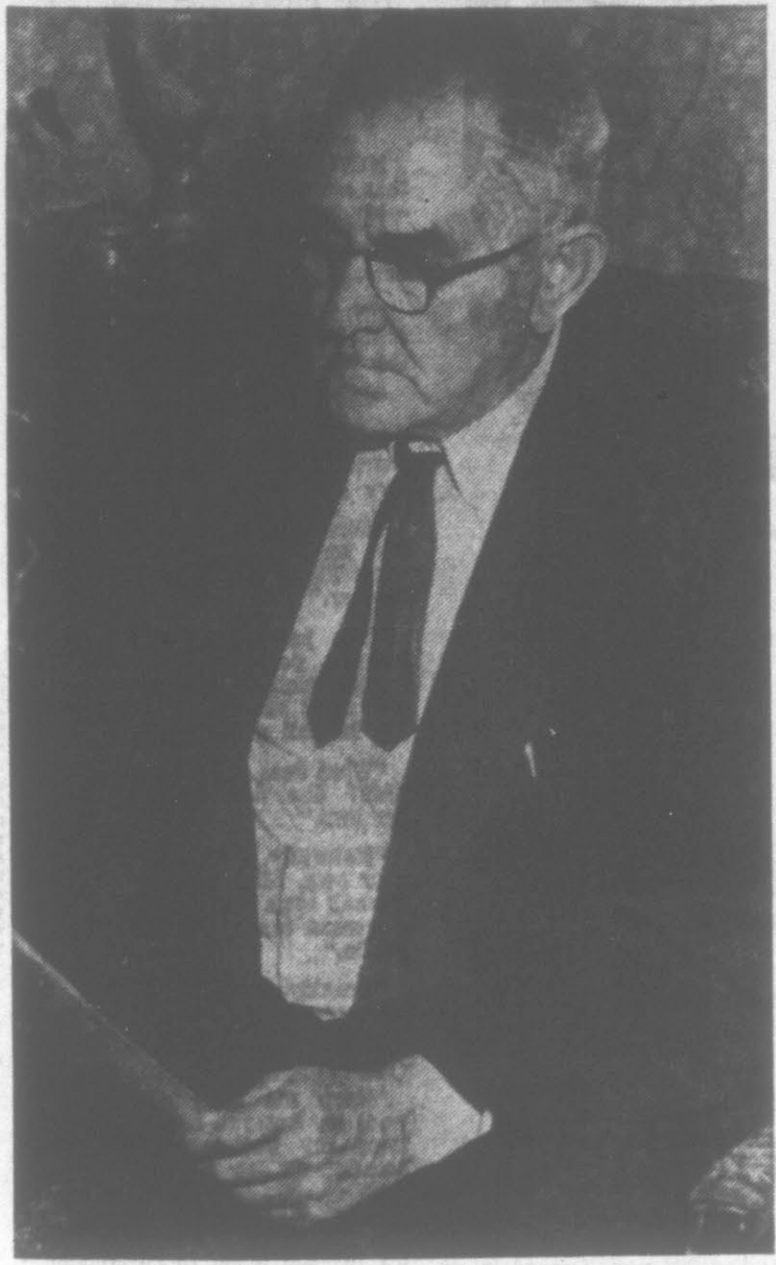

For Former Police Chief Of Farmville, New Life Begins

FARMVILLE—Less than two weeks ago, a 41-year veteran police officer quietly removed his badge, stepped out from behind his desk for the last time, and almost reluctantly made his way to his home on E. Wilson St.

At the age of 67, L. T. Lucas, Farmville's police chief for a quarter-century, retired from his post Feb. 1 to begin a new and different type of existence—a quiet life at home.

Lucas came here Dec. 1, 1934 after serving nearly 17 years on the Wilson Police Department to join two other local officers. The following summer, he assumed his position as chief of the Farmville force.

He began his career as a policeman in his hometown, Lucama in Wilson County, at the age of 18 in 1911. He joined the Wilson Department in March of 1918 before being drafted for military service in May. World War I was raging, but ended before Lucas could be shipped overseas, and he returned to Wilson and the police force there May 1, 1919.

While living in Wilson, Lucas met Miss Selma Gaylord of Roper and the two were married in December, 1930.

The veteran lawman remembers there were no police cars here when he arrived. "We furnished our own transportation until 1946 when we got our first patrol car," he says.

Operating from the office now occupied by the town's water and lights department, the Farmville police had a trio of "safe jobs" to cope with, Lucas remembers, soon after he came here. One at Turnage and Company and a pair at B. and W. Chevrolet Company required the department's most diligent work during Lucas' first years here. "We solved them all, though," the old chief remembers.

The chief built his home here in 1939 and is "thankful we paid for it by the time I had to retire." He, his wife, and a daughter live at his home at 801 E. Wilson St. here. Another daughter is married and lives near Greenville.

Lucas watched the department grow to seven officers, including himself, and move its headquarters into the section of the Town Hall formerly used to house a fire truck. The new police station, remodeled as the town's new fire station was being erected, was occupied in the fall of 1958.

Asked what he plans for the future, the retired chief thinks he'll begin to look for a job after "a month or so." "We still have to make ends meet, you know," he declares.

"I don't think I really wanted to quit," says Lucas, "but, then, 41 years is a long time. I guess the town needs a new man."

The retired chief is in line now for monetary benefits from the retirement fund for policemen in addition to Social Security payments. He has been succeeded by Walter M. Thomas of Greenville.

"Thomas, I think, is a good man," says Lucas. "If he has the town behind him, he'll make us a good chief."

Skies Clear And Cold Moves In

Skies cleared and temperatures dropped in the Midwest today as road crews continued clearing snow-covered roads and highways in the wake of winter's worst snowstorm.

Many small towns remained isolated from the storm, which dumped foot-high falls of snow from the Great Plains to Michigan. Travel on some highways in Wisconsin and northwestern Illinois was slowed by stalled cars and snow drifts.

No heavy snowfalls were indicated during the day in most of the country.

However, a snow belt stretching 400 miles was reported in Texas. Only other wet spots were in the central Rockies, which reported snow flurries, and in south central Texas, hit by showers. Skies were clear in the southwest but cloudiness was reported in most other sections of the country.

It was below zero again today in northern Midwest areas, with -11 at Grand Forks, N.D., one of the lowest readings.

Colder weather moved into the Atlantic Coast states after Thursday's unseasonably high temperatures. The mercury climbed to 66 in Newark, N.J., a record for Feb. 11, as was the 57 in Windsor Locks, Conn. It was 66 in Baltimore and 56 in Boston. New York's mild 60-plus readings were marred by wind gusts up to 60 m.p.h.

Policemen Rebel At Big Donation

BALTIMORE, Md. (AP) — City policemen have rebelled at the custom of giving retiring high brass a \$1,000 gift.

Police Commissioner James M. Hepron announced Thursday the five-year old practice would be discontinued.

It wasn't anything personal against Inspector William E. Taylor, for whom police officials planned a retirement gift. But many patrolmen asked why they should be contributing from their \$5,000 a year salary to an inspector retiring on \$6,500 a year. Clerks, who also were expected to kick in, make only \$3,300.

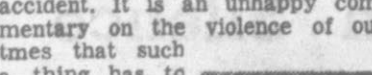

Books & Stuff

We're lardy in our expression of deep regrets—along with the rest of the literary world—at the sudden, needless and untimely death of Albert Camus, France's greatest contemporary writer who was killed a few weeks back in an auto accident. It is an unhappy commentary on the times that such a thing has to happen to such a person as Camus, who, though he already has contributed much to the world of literature and the arts—he won the Nobel Prize for Literature three years ago, at 43—was only on the threshold of his fame.

Many of you have read English translations of his best known books—THE STRANGER, THE PLAGUE, THE FALL, THE REBEL and THE MYTH OF SISYPHUS. His latest play, CALIGULA, is scheduled for production soon in New York. Camus was great because of his artistic talents and also because of his attitude toward life and the influence he wielded among writers both here and in Europe. He was perhaps the most highly respected literary figure on either side of the Atlantic, with the possible exception of T. S. Eliot.

On the positive side he could merely affirm the need for sincerity and understanding, a belief in the golden mean, the reality of the brotherhood of man. . . . There are few voices left like Camus' powerful and artistic one, and we join the world in expressing sorrow that his had to be stilled so much too early. . . ."

INVITATION TO A BEHEADING, by Vladimir Nabokov, New York: G.P. Putnam's Sons, 1959.

In Berlin in 1935 Vladimir Nabokov, refugee from a dehumanized Russia and shocked witness to the dehumanization of Germany, wrote INVITATION TO A BEHEADING. Only now has it been translated (by the author and his son) into English. It would be wrong, however, to dismiss this novel as an inconsequential youthful effort published in English at this time only to capitalize on the success of PNIN and LOLITA, those stern but affectionate appraisals respectively of the American academic community and of the totalitarian political regime.

So Nabokov's twenty-five-year-old novel is timely, providing a terrifying picture of the world of 1960, "a world which seems not a bad example of amateur craftsmanship, but is in reality calamity, horror, madness, error."

The protagonist, waiting in a prison where almost nothing is rational, has been sentenced to die but cannot learn the day on which he is to be executed. (In these respects he is just like the rest of us.) The crime with which he is charged is "gnostical turpitude, the depravity of knowing, and what he knows is that man is superior to the state (and to his machines), that humanity is unconditionally sacred."

By the use of the surrealist technique, Nabokov presents the prison administration and society outside the prison as wildly fantastic, though not more so, to pick random examples, than college football or advertising on television or our attempts to deal with the farm surplus.

Alive, the protagonist is frustrated by the engulfing mass of socially approved idiocy. Field Is Narrowing Down To Two

One-by-one prospective gubernatorial candidates have bowed out of the 1960 campaign picture leaving the field to the two avowed candidates, John Larkins of Trenton and Terry Sanford of Fayetteville.

Only two other prospective candidates still stand in the wings: Highway Commission Chairman J. Melville Broughton, Jr., and Sen. Arthur Kirkman, the only Piedmonter prominently mentioned as a gubernatorial possibility this year.

Even though Broughton and Kirkman are still to be heard from officially, it appears a good guess that neither of them will follow the plunge taken by Sanford and Larkins. There has been no state-wide evidence of enthusiasm for Kirkman even though a Piedmont candidate might normally be expected to have a good chance against two Easterners. The fact that Kirkman is not already in the race adds to the speculation that in the final analysis he will not be a candidate.

As for Broughton, his interest in seeking the governor's office this year apparently was rekindled when State Treasurer Edwin Gill announced he would not be a candidate. As a top political appointee of Gov. Hodges, Broughton would be obligated in a gubernatorial campaign to defend at least to some degree the administration program. And there is already ample indication that portions of the Hodges' program will become issues in the campaign.

In addition to being bound to defend the Hodges' administration, Broughton might normally expect support for his candidacy from the administration. To offset this, however, there are the repeated assertions by Gov. Hodges that he does not intend to take part in the campaign, plus reports that at least some administration support may be leaning toward the candidacy of John Larkins.

These factors may tend to discourage rather than encourage a gubernatorial bid by Broughton this year. With Addison Hewlett, Beverly Lake and Edwin

Gill all having removed themselves from the governor's race this year, it is likely that the two remaining prospective candidates will follow suit, leaving the battle to Sanford and Larkins.

A Time For Inciters To Maintain Silence

North Carolinians can be thankful the recent wave of "sitdown protests" against segregated eating practices have not become incidents of name-calling and violence.

There is always the danger of such things getting out of hand, causing great damage to that aura of harmony in which Tar Heels take pride.

Too, should the relatively gentle pressures now taking place generate heat, the resultant furor could bring in a host of unsolicited advisors and distort the whole picture of what has been taking place.

After all, the right to orderly protest has been pretty well established by now. It is when orderly processes go out the window and anarchy-in-miniature takes over that society acts for its own preservation.

The present demonstrations by Negro college students have been marked by a spirit of quiet persistence and self-discipline. Their level-headed approach is nevertheless hazardous to themselves and their cause. For it is all too possible that others may be tempted—people with less self-control and of violent natures—to take part in the demonstrations or attempt to follow the students' example.

We must also face the possibility of unruly and violent protests against the demonstrations by people whose primary interest should be the conduct of their own affairs.

The students involved are playing a hazardous game in which just a little bit of indiscretion can put the situation out of hand.

The demonstrators are confronted not only by determined opposition, but by custom and by the established concept that a private business may serve whom and how it pleases.

Given time, the whole situation could work itself out with no one getting hurt.

Students do have to study, and businesses do have to tend to business.

We on the sidelines are naturally concerned over the inherent possibilities in the situation; but it is better by far that calmness prevail and let the excitors and inciters be silent.

Today's Contest Is A Big Reality

WASHINGTON (AP)—What's the "Spirit of Camp David"?

It's a pretty phrase. Been floating around ever since last fall when President Eisenhower had Premier Nikita Khrushchev up to his Maryland camp and they seemed to get along all right.

Back in 1955, in the summer, Eisenhower met with Khrushchev and other Soviets at a summit conference in Geneva. Pretty soon the "Spirit of Geneva" was floating around, at least in this country.

If it meant anything, it seemed to mean some kind of new international quietude. The then Secretary of State John Foster Dulles said after the meeting a "new spirit does, indeed, prevail."

He even expressed the belief the situation was ripe for solution of the problem of unifying Communist East Germany and West Germany, which was in the Western camp.

Dulles was so carried away by what could not have been—judging from what followed—any more than Soviet cordiality and even jollity at Geneva.

Whatever the new spirit was, it didn't last long. Dulles went back to Geneva for a foreign ministers meeting with the Soviets in October. They got nowhere. And Dulles came away disillusioned. Pretty soon he was saying the cold war was on again.

Fifteen months ago Khrushchev began a campaign to force the West to get its troops out of West Berlin. It was really in an effort to get some understanding with him that Eisenhower invited him over here.

Khrushchev didn't back down on wanting the troops out. But he didn't, when he talked to Eisenhower, set a deadline. Since then some people, forgetting the Geneva summit, have been talking about the "Spirit of Camp David."

Since then the Soviets have

been a little tough in different directions and suddenly we began to hear the "Spirit of Camp David" was dead. Eisenhower at his Feb. 3 news conference tried to bring this spirit back to earth. He deprecated the phrase: "Spirit of Camp David. He said his talks with Khrushchev there were held in a friendly atmosphere. That, he said, is all the Spirit of Camp David amounted to."

Last Monday Secretary of State Christian A. Herter wouldn't go any further than saying he thought the Soviet attitude was tougher since the Camp David meeting. This kind of business—the Soviets getting tougher?—will probably go on from now until Eisenhower meets with Khrushchev at the next summit meeting in May.

The one reality which seemed most clearly to underlie the Soviet performance at Geneva and Camp David actually seemed to be this:

They haven't given anything away and they're not likely to. They don't seem anxious for war since it could ruin them, no matter whom they also ruined. They're determined communism will take over the world. They'll push here and push there, gently or hard, depending on how much they think they can get away with.

At Paris they may make some concessions but if they do it will be at the price of the time being, at least, they seem some particular advantage to the Soviet Union in doing so.

If they don't eventually go to war to take over the world, they'll try to take it by propaganda, foreign aid and any peaceful device they can think of.

This contest with communism isn't likely to stop. It will probably get more intense, even without shooting, as the Soviets develop even more military power and start catching up with us economically.

Other Editors Saying A Mole Hill Tax

(Washington Daily News)
There are many momentous problems facing America today. Peace in the world offers a real challenge to our civilization.

National defense, nuclear energy problems, unemployment, the national debt, crop supports, the budget, and countless other major propositions face our Congress.

Yet, the United States Senate, in the midst of the fact that it faces so many weighty problems, spends time debating the proposition of abolishing the poll tax payment as a prerequisite to voting in federal elections.

Today in America only five states still require the payment of the poll tax before a citizen can vote. They are Alabama, Arkansas, Mississippi, Texas, and Virginia.

In none of these five states does the poll tax amount to any considerable sum in taxes. In no state does it apply to one race only. Members of both races are affected equally.

We do not believe that a person ought to have his right to vote based on the payment of a poll tax. It was abolished long ago in North Carolina. And yet the determination of who is eligible to vote is a matter for each state to decide.

We much prefer that abolishment of poll tax payment as a prerequisite to voting come in the form of a constitutional amendment rather than by a simple act of Congress.

Regardless of how we look at this proposition, very few people in America will be affected.

The idea is not one of general concern socially, but rather one of concern only from the civil rights standpoint. And coming at a time when Congress ought to be spending its time trying to solve some of our major problems, it causes many people to wonder just how far some senators are willing to go in their effort to think about being elected rather than in thinking in terms of first things first.

This is an election year, and those senators who cry so loud about racial discrimination will leave no stone unturned in their effort to capture a few votes.

The poll tax in America today is not a major issue. Any legislation in this direction can be aimed at only five states—all in the South.

With two-thirds of the Senate concurring, the matter now goes to the House of Representatives where two-thirds of that body must approve the proposed amendment. Then three-fourths of the state legislatures must approve it before it finally can become part of our constitution.

Many state legislatures which have abolished the poll tax as a requirement for voting will not look with favor on any such constitutional amendment because they recognize the right of every state to fix its own election laws.

Spending so much time today on this poll tax matter is but a case of senators making a mountain issue out of a mole hill tax.

Big Business In Conventions

A convention of convention planners is planned.

It is to be at the International Convention Planning Exposition at Las Vegas, from November 28 through December 1, this year.

This points up two facts: that the number of conventions, expositions and other shows in the United States is vast, and that putting on shows for big business has become a big business itself.

In 1957, a total of 20,000 national, regional and state conventions attracted 10,105,000 delegates. They spent \$1,198,554,050, according to the International Association of Convention Bureaus.

This year, the total number of conventions may be close to 25,000 with spending just under \$2 billion.

Sales Meetings magazine estimates that industrial companies are spending about 5 per cent of their advertising budgets for shows and displays, almost all connected with conventions and other trade meetings.

NOT ALL A TAX DODGE
Corporation and income tax laws do nothing to discourage

conventions. Unless there are untoward circumstances, the costs of conventions and trade shows are fully deductible as business expenses. Sending executives to conventions is often a way of giving them paid vacations free of taxes. A journey to a convention may be more attractive to an executive than a salary increase, which would go largely to the government.

However, there are more important reasons for sending top men to conventions: to search out possible customers, to find and evaluate new suppliers; to gather information on new products; to learn about new technological methods; to find out what competitors are doing; to build prospect lists; to get company information over to people who can benefit; to renew contacts and friendships with old customers; to gain publicity for the company itself; to sell, sell, sell.

PROFITS TO THE COMMUNITY
Because show and convention delegates spend money, cities and resorts like them. The Chicago Convention Bureau estimates delegates spend \$200,000,000 a year for food, drink, lodgings travel and fun there; New York estimates its second larg-

est source of income if from visitors, a large part of whom visit the city in connection with conventions. New York's \$1 billion revenue from visitors is second only to its income from the garment industry.

Most large cities of the nation and many smaller ones—including Las Vegas, have built or planned convention and exhibition halls, and have bureaus seeking new conventions.

But despite all cities can do, there is still a lot of work. Convention management has become a highly specialized profession. Convention organizers and promoters must arrange to have display space; arrange sales of space to exhibitors; arrange attention-getting events; provide entertainment; make sure all visitors, have a place to sleep; get the show publicized; make sure delegates and others show up; arrange concessions, and so on endlessly.

In this infinite detail are also such things as providing models to pose for photographs at exhibits, arranging badges and making sure the color is offensive to no delegate, making arrangements so that the one big-shot delegate has an attractive cocktail companion and

that another has transportation to church; settling union disputes; taking care of the plastering (that is, getting passes to police, firemen and other people who might become both exasperated and getting a few lost delegates gawk to their hotel rooms.)

Some associations arrange their own conventions but many rely on professional convention-staging businesses.

It's easy to see that convention planning has become a big industry, and why convention planners will be eager to swap ideas with others in the field. They will also be eager to see exhibits of new folding chairs, new registration systems and new ways to put up exhibits in a hurry.

Offer 16 Rules To Safeguard Beliefs

By MILTON BESSER UNITED NATIONS, N.Y. (AP) — The United Nations has come up with a set of 16 rules or basic principles for safeguarding man's right to be a believer or non-believer in religion. They could be the basis for an international treaty designed to protect such rights. The principles were drafted by Arcot Krishnaswami, a scholarly Indian lawmaker, after more than three years of study authorized by a 14-member U.N. subcommittee on prevention of discrimination and protection of minorities. They were examined exhaustively at a three-weeks session of the subcommittee just concluded here and put in final form for eventual consideration by the U.N. General Assembly.

It is the subcommittee's hope that the rules can serve as a set of guiding principles for governments before a agreement is reached on an international treaty. One rule says parents or legal guardians shall have the prior right to decide upon the religion or belief in which their child should be raised. In the case of a child who has been deprived of its parents, their expressed or presumed wish should be taken into account, but with the best interests of the child the guiding principle. Another rule says no one should be compelled to receive religious or atheistic instruction contrary to his conviction, or in the case of children, contrary to the wishes of their parents or guardians. The rules call for taking due account of each religion or belief in respect to holidays or days of rest. They say that in countries where conscientious objection to military service is recognized, exemptions should be granted in a way that will ensure that no adverse distinction based on religion or belief may result. Members of the subcommittee served as experts and not as policy - making representatives. But the debate reflected policies of their individual homelands at times. Mrs. Z. V. Mironova, the Soviet expert, objected at one point that the rules can serve as a set of sufficient attention to discrimination against atheists. Justice Philip Halpern of Buffalo, N.Y., the U.S. expert, declared the Soviet Union bars teaching of religion in private educational institutions, and he sought safeguards against such practices. In addition to the United States and the Soviet Union, the experts came from the United Arab Republic, Lebanon, Uruguay, Britain, Philippines, France, Poland, India, Austria, Sudan, Finland and Chile.

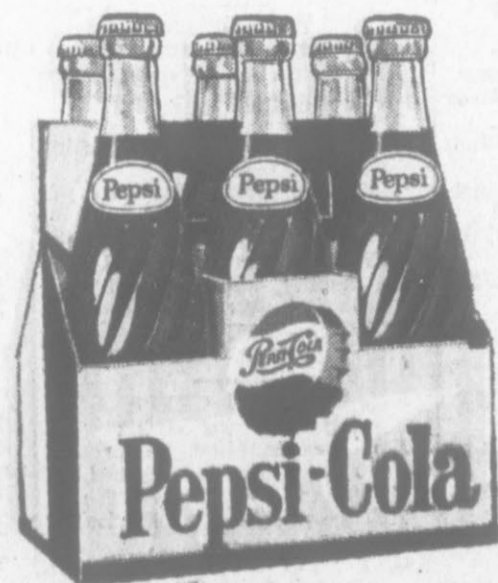

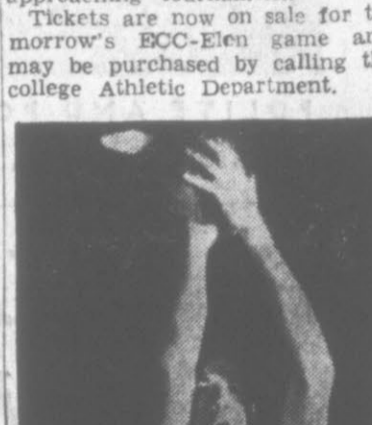

Campaign Hats Going Into Ring

Campaigning, hats in the ring and official filings continue to keep North Carolina politicians busy.
Roy A. Taylor of Black Mountain paid his \$450 filing fee Thursday, officially making him a candidate for the Democratic primary May 23 for the unexpired term of the late Rep. David Hall, who represented the 12th District in Congress, and also for the regular term.
Heinz Rollman, Waynesville shoe manufacturer, also has announced he will seek the seat as a Republican.
At Goldsboro Dr. David J. Rose, 63, announced he will seek the Democratic nomination for the congressional seat being vacated by veteran Rep. Graham Barden (D-NC).
Rose, completing his third term in the State Senate, is the fifth candidate to announce for the Third District Democratic nomination.
Campaigning was done in Asheville Thursday night by gubernatorial candidate John D. Larkins and David McConnell of Charlotte, candidate for lieutenant governor.

Jack Paar Walks Out On 'Tonight' Show; Quitting Over TV Censorship

NEW YORK (AP)—Jack Paar, simmering over a censored anecdote on his Wednesday night NBC television show, bolted over emotionally Thursday night and walked off the program. He said he was leaving the show.
The show was being taped before an audience in an NBC studio when Paar commented about "an idiot" cutting him off the air for about five minutes Wednesday evening, said "there must be a better way of making a living," and stalked off-stage.
"I believe I was let down by this network at a time when I could have used their help," said Paar.
Paar's final gesture before leaving was to shake hands with Hugh Downs, announcer on the coast-to-coast "The Jack Paar Show."
The studio audience was stunned. Some spectators, thinking it was part of the program, broke into applause, others shouted protests against Paar's departure.
Paar's outburst took place nearly three hours before the show went on the air. It is customary to tape the program in advance.
The one hour and 45-minute show went on at 11:15 p.m. Eastern Standard Time, exactly as taped and including Paar's leaving. As soon as Paar's blowing up occurred, 18 minutes after the program started, NBC said its telephone switchboard "lighted up like a Christmas tree."
Some hours before the program, Paar had criticized NBC for deleting a story dealing with a mix-up over the letters "W.C.," widely used in Europe as an abbreviation for water closet. The anecdote, in the form of a letter, in-

terpreted "W.C." as meaning a wayside chapel.
Paar told his audience Thursday night that he heard the anecdote from the uncle of a 14-year-old girl who, in turn, had heard it from a woman teacher. Paar said it was the uncle who showed him the copy of the story, that he thought it funny and "very innocent."
The story concerns an English couple seeking to rent a cottage. They told a real estate agent they wanted a "W. C." The agent, not understanding the initials, asked a local priest, who said the letters stood for wayside chapel.
"And you know," Paar told the audience, the agent "writes back that it's in the woods and you can only go there Thursdays and Sundays and it's nine miles from the cottage."
A network official said NBC's department of standards and practices felt the story was in bad taste because it involved double meanings. In a formal statement, after Paar's walkout, NBC said: "It is NBC's hope that Jack Paar will reconsider his action and return to the program."
Paar could not be reached concerning his future with the show. Downs, who took over as master of ceremonies on Thursday night's show, said Paar does not do this for effect. Downs said, "I would like to think that it's not final, that he will be back."
A commercial then followed, and Paar said he always had opposed use of risqué material and that he did not regard the anecdote in that light. The deletion of the story, Paar said, "leaves a terrible impression in some of your minds." He said he was told by NBC to pass off the censorship "as a joke," but he just could not.
"NBC is a little confused as to which clown cut that out last night; they're not sure who did it, but the damage has been done," was another of Paar's parting shots.
Paar said he never welcomed controversy, even though he has been involved in it. Addressing himself to Downs, he said seconds before he walked out:
"Now I've made a decision about what I'm going to do. I'm leaving the 'Tonight' show. There must be a better way of making a living than this...
"I like the National Broadcasting Company; they've been swell to me, and I've been pretty wonderful to them. I look over a show with 60 stations. There's now 158."
For various reasons Paar has been at odds with some personalities, including newspaper columnist Walter Winchell, Dorothy Kilgallen, Jack O'Brian, Nick Kenny and George Sokolsky.
In his farewell speech, Paar said:
"...I have been attacked and will be attacked, it's going to go on forever now. You might as well know it, by the Hearst press... because it starts in the television columns and then it spreads to the Dorothy Kilgallen column, and finally on the editorial page...
"I am opposed to purposely plotted risqué material. I am more vehemently opposed to yellow journalism...
"Miss Kilgallen, O'Brian and Sokolsky write for the New York Journal-American and the Hearst Newspapers. Winchell and Kenny write for the New York Daily Mirror, a Hearst paper, and their columns are syndicated.
"There was no immediate comment from the Hearst newspapers.
"Paar took over his show about three years ago from Steve Allen, who conducted it as "The Tonight Show." Paar renegotiated his contract with NBC last summer, and it now extends to the fall of 1962. His exact salary is not known, but estimates place it in the upper pay brackets of the entertainment industry.

Slip Of Lips Reveals Small Atomic Blast 'Kills' ICBM

WASHINGTON (AP)—A three-star general's apparent slip of the tongue has disclosed that a small atomic explosion can be used to neutralize thermonuclear warheads on ballistic missiles.
Involved in the process is the principle of neutron flux, but the details of the technique are classified top secret. Even after it was mentioned publicly, research officers declined to say anything about it.
Lt. Gen. Arthur G. Trudeau, the Army's chief of research, made the disclosure Thursday during a movie-news conference on development of the antimissile missile, Nike-Zeus.
At this same movie-with-questions conference, the Army also exhibited a one minute film clip showing the first known interception of a ballistic missile by a guided missile.
The film showed a Hawk anti-aircraft missile, which carried a conventional high explosive warhead, shooting down a short-range bombardment rocket called the Honest John. The test was made Jan. 29 over White Sands, N.M. They collided at a combined impact speed of about 2,000 miles an hour.
Since the script with the Nike-Zeus film carefully refrained from saying a direct hit was necessary

to destroy the warhead of an incoming missile, Trudeau was asked if this didn't imply a means had been found to render the warhead harmless.
Trudeau's answer was "yes," the warhead could be neutralized through the employment of the neutron flux principle.
He added that an explosion of the Zeus's atomic warhead was involved in the process and offered the opinion that it would be better to have "a small explosion a hundred miles over Hartford, Conn., than a large explosion in New York City."
Officials declined to give any further information on the neutron flux, but its general principles have frequently been discussed.
In an atomic explosion, used to trigger a thermonuclear explosion there is an abrupt and staggering release of neutrons which bump into each other, setting up a chain reaction. This reaction releases an enormous amount of heat and energy.
To use the flux principle, some means must be found to dampen, or decrease, the release of neutrons in the enemy's warhead.
How this is done through the explosion of a small atomic bomb in the Nike-Zeus is, of course, still a top secret. There was no indi-

cation whether it has been proved by any tests.
From various Army sources, however, came some additional information on the Nike-Zeus plans:
1. A second attempt to intercept a ballistic missile with a guided missile probably will be made this summer, employing the Zeus against the 500-mile range Redstone.
2. The Army has so increased the power of its Zeus radar—and thus its range—that one Army source said it could be "compared to reading by a 40-watt light and a 200-watt light."
3. The Army is planning to contract for between 15 and 45 of the 1,500-mile range Jupiters for use in interception tests of the Zeus. The first such tests will take place probably in mid-1961.

Cites Failure On Absentee Ballots

ASHEVILLE (AP)—W. E. Cobb of Morganton, North Carolina Republican chairman, says state courts have failed to "rectify the evils of the absentee ballot system."
Speaking at a Lincoln Day rally here Thursday of 12th District Republicans, Cobb said state courts "are so dedicated to the preservation of one-party rule in this state that no amount of proof has been sufficient to rectify the evils."
"Fortunately, public opinion and the press have become aware of the evils of the situation and now, at last, we see in sight fair elections in North Carolina—except in Madison County."
Cobb made his remarks in introducing I. Lee Potter, special assistant to National GOP Chairman Thurston B. Morton, Potter was the featured speaker in place of Secretary of the Interior Fred A. Seaton, who had the flu.
Potter predicted that Vice President Richard Nixon will have no trouble capturing the GOP presidential nomination. He predicted Nixon will carry North Carolina and gain support in other parts of the South.
Potter also brought with him a statement from Seaton concerning the Bryson City - Fontana Road Swain County officials have requested a congressional investigation into the National Park Service because the road has not been built.
Seaton's statement said he is giving the matter "his personal attention with the idea of re-appraising a situation which is unsatisfactory to residents of the area as well as the department."

Retail Sales Advance Despite Stock Fall-Off

NEW YORK (AP)—People may have lost some of their enthusiasm for buying stocks, but their spending in the nation's retail stores continues to rise.
Yet like the stock market, retail sales have their daily ups and downs. And the big storm that has just swept from coast to coast doubtless cut deeply into daily take of the stores where the storm was at its height.
Over-all, strength of retail sales comforts the economists who worry about the psychological effect of the drop in stock prices.
In January, when the stock market was having its roughest time, retail sales advanced more than seasonally. The Department of Commerce says the total topped 67 billion dollars, up 2 percent over the same month last year, and a similar percentage over December, the traditional month for heavy spending.
Consumer buying trends are closely watched in Wall Street as in Main Street.
Auto sales just now are getting particular attention. There have been reports that sales haven't increased as much as Detroit first hoped. The stock market took that to foretell less demand for steel later on.
But the Commerce Department figures show a two-million-dollar rise in January from December—when, to be sure, the new models were in short supply because of the steel strike. January sales were put at close to three billion dollars.
Installment debt has been ris-

ing. Merchants and finance company officials say this reflects a growing confidence on the part of the consumer to meet the payments. He seems much surer of good times ahead than do the traders on the Stock Exchange.
Tight money seems to have had few casualties yet at the retail level. Merchants say that customers show little interest in any rise in time-payment carry charges.
So the consumer is still carrying the economy along. The opinions of those who buy and sell stocks don't seem to have affected him much as yet.

Four Men Admit They Dynamited Ten Trucks

PORTLAND, Ore. (AP)—Eleven days after a series of blasts ripped 10 trucks used by struck Portland newspapers, police had statements admitting the act from four of seven persons in custody.
Sheriff Francis Lambert said four young men admitted setting off the two blasts and Gerald Couzens, one of them, said Stereotypers Union official paid them \$400 for the two jobs.
Couzens, 20, was quoted by an arresting detective as saying L. S. McDonald, a member of the Stereotypers Union negotiating committee, paid them after the 10 trucks were dynamited. McDonald was quoted by detectives in on the arrest as saying he did not make the pay off.
Lambert said others in custody in addition to Couzens and McDonald are three Snyder brothers—Charles, 23; William, 18; and Eddy, 24—and the wives of Charles and Eddy. Charles and his wife live in Boring, Ore., and the rest in Portland.
The sheriff said none except McDonald is a member of any of the unions involved in the strike against the Oregonian and Oregon Journal.
The strike began Nov. 10 when the stereotypers walked out and other union members observed picket lines. The newspapers have published jointly in the Oregonian plant since the strike started.
Deputies said bail for McDonald was set at \$30,000 and that for each of the other six at \$10,000. Lambert said no formal charges were filed against any, but he said each of the men will be charged today with malicious bombing.
Couzens told deputies he and Bill

Snyder dynamited four trucks at the Oregon Film Service in Portland. Couzens also said another man whose name he could not remember drove the car for them.
Eddy and Charles Snyder, deputies said, formed the team that dynamited six trucks at the Wyome Transfer Co. in Oregon City. Chief deputy Ard Pratt said the wives of both men accompanied them.
Lambert said a man who feared for the lives of his wife, his children and himself came forward with the information that led to the arrests after Lambert assured the man his name would not be revealed. The sheriff said police teams made the arrests after that.
"I didn't really need the money," said Couzens, a slender, blond-haired youth. "I didn't know who was right or wrong in the strike either. I guess I did it for the money."
Eddy Snyder told Deputy Dist. Atty. Glenn Guerts of lighting four dynamite fuses with a butane lighter while sitting in a small car. He said the lighter then went out and they struggled to light two more with matches as the other four fuses burned.
Charles Snyder said he and his brothers learned to use dynamite blowing up stumps on their father's farm near Boring, Ore.
When the strike began the issues involved the method of hiring substitutes for men who laid off, whether the foreman should be voted to the union and the number of men to man a new plate casting machine the Oregonian said it planned to order. Numerous negotiating sessions failed to produce a settlement in the strike.

Concert Band Is On Annual Tour

The East Carolina College Concert Band, now making its seventh annual spring tour, will appear Feb. 10-14 in a series of eight concerts in North and South Carolina. Programs are scheduled in Hartsville, Bishopville, Sumter, Columbia and Camden in South Carolina and in Hamlet, Lumberton, and Raleigh in North Carolina.
The ensemble is made up of approximately 70 student instrumentalists carefully selected because of their musicianship and their skill as performers. The organization is sponsored by the college department of music.
Herbert L. Carter of the East Carolina music department is director of the concert band and also of the marching band of the college. After joining the East Carolina staff in 1946, he organized and began rehearsals with the two groups and has developed them into bands which have received high praise from the public and the press.
During the tour, programs include the Chester Overture by William Schuman, Elsa's Procession to the Cathedral from Wagner's Lohengrin, the Procession of Nobles from Rimsky-Korsakov's Mlada; other works by outstanding composers and arrangers of band literature; and a number of light popular selections.
Soloists with the band on tour are Steven Clements of Raleigh, timpanist, and Gayle Eaker of Drexel, trumpeter.

Big Sacrifices Said Necessary

BELLEVILLE, Ill. (AP)—Dr. Werner Von Braun says Americans must sacrifice on an unprecedented scale to meet the Communist menace.
Dr. Von Braun, German born scientist who developed the V-2 rocket of World War II, spoke to some 1,300 persons in this southwest Illinois community. He is director of the development operations division, Army Ballistic Missile Agency.
Dr. Von Braun said "what we are about to discover and resolve is whether a nation which rates its home run sluggers and its fullbacks above its scientist and philosophers can meet the total competition of aggressive communism and still preserve its way of life."
He said he disagrees with "alarmists who cry that we have lost our position as a first-rate power." But he added "I would suggest that we brace ourselves for other Soviet firsts in the new field of astronautics. It will require several years of concentrated effort to come abreast, and even longer to pull ahead."

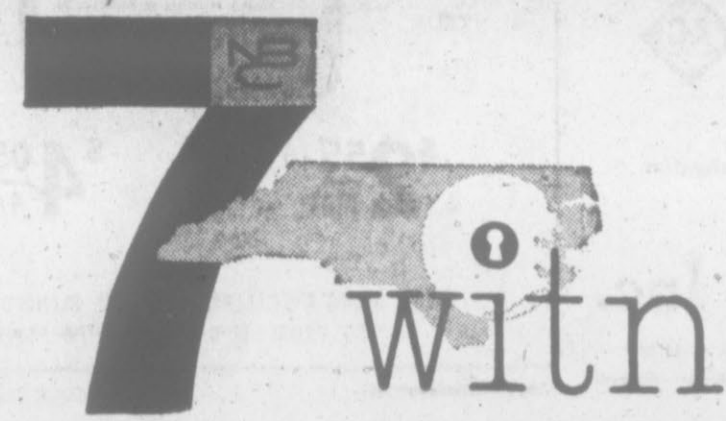

Time For A 'Break' In Case Of A Missing Man

GOLDEN, Colo. (AP) — Sheriff Art Wermuth says the time is near for a big break in the strange disappearance of Adolph Coors III, 44, wealthy brewer who may have been kidnaped.

Wermuth and Coors' 76-year-old father, Adolph Coors II, say they believe the missing man is being held by kidnapers.

If there have been ransom demands, the family and officers are keeping them secret. The elder Coors hurried back from a Hawaiian sojourn with the announced purpose of negotiating with kidnapers. "It is just a matter now of waiting for an offer," he said.

"The crucial time in past cases of kidnaping is 36 hours to 4 1/2 days after the abduction is made," Wermuth said.

Coors disappeared Tuesday morning on the way from his home in the mountain foothills to the family brewery at Golden, 12 miles west of Denver.

His station wagon, small bloodstains on the upholstery, was found near a wooden bridge on a country road. There were bloodstains on one of the wooden railings. Coors' cap and eye glasses were nearby.

Wermuth is the only official giving out any information to newsmen. FBI agents have maintained silence although they entered the case a few hours after Coors' disappearance.

Given Licenses For Solicitation

Licenses have been granted to 21 organizations to conduct fund-raising campaigns through public solicitations for the support of their programs, including the East Carolina Teacher's College Educational Foundation.

Licenses were granted during the month of January by the State Board of Public Welfare, Dr. Eileen Winston, commissioner, announced recently.

Twenty of the licenses were granted to organizations which formerly held licenses for solicitation periods.

The total amount which these 21 organizations will seek from the public during the year in North Carolina is approximately \$2,052,634.

Nixon Aides Watch Thaw In Nelson Rockefeller's Attitude

WASHINGTON (AP) — Vice President Richard M. Nixon's associates took a "watchful waiting" attitude today toward signs of a thaw in his relationships with New York Gov. Nelson A. Rockefeller.

Rockefeller's praise in a Buffalo, N.Y., speech Tuesday night of Nixon's admission to Republicans not to stand smugly on their record was recorded as encouraging in the Nixon camp.

But the vice president's followers do not regard this as anything like positive proof that Rockefeller intends to give to Nixon enthusiastic support. They regard such support as little short of imperative in November as the Republican presidential nominee.

There has been no direct communication between the two Republican leaders since Rockefeller bowed out Dec. 23 as a possible rival of Nixon for the nomination. At that time, Rockefeller conferred with Nixon on the telephone.

Rockefeller chilled the Nixon adherents when he made no mention of the vice president in a speech here last month as a part of the "Dinner with Ike" Repub-

can rallies. In his Buffalo talk, however, Rockefeller said Nixon had made a "clear and forthright statement" at the Chicago "Dinner with Ike." He cited Nixon's declaration that Republicans must not be so smug about what they had accomplished that they would "fail to meet the new challenges of the future."

Nixon's supporters had the alternative of reading this in two ways: either Rockefeller was egging the vice president on toward a more liberal position the governor could support, or he was indicating that he was beginning to be inclined toward backing a man who was talking Rockefeller's own language.

In behalf of the latter thesis, some Nixon associates said Rockefeller was much more glowing at Buffalo in his praise of the Eisen-

hower administration record than he had been when he was trying to determine whether he should become a presidential candidate.

This led to hope among Nixon's backers that Rockefeller might decide to go all out for Nixon's objectives as well as for Eisenhower's accomplishments.

But the frosty fact remained that Nixon had no personal assurance or indication of Rockefeller's intentions.

Contacts maintained with Rockefeller's associates by Leonard W. Hall and Robert Finch have yielded little on this score. Hall, former national GOP chairman, is Nixon's convention delegate representative. Finch, a Nixon assistant, is his chief political troubleshooter.

So Nixon still is in the dark as to what will happen in New York.

Will Sell Hotel For \$14 Million

NEW YORK (AP)—The opulent St. Regis hotel, a 5th Avenue landmark for 55 years, will be sold for more than 14 million dollars to the Zecendorf Hotels Corp. and Serge Obolensky, New York hotel executive. Obolensky is a brother-in-law of the late Vincent Astor, the former owner.

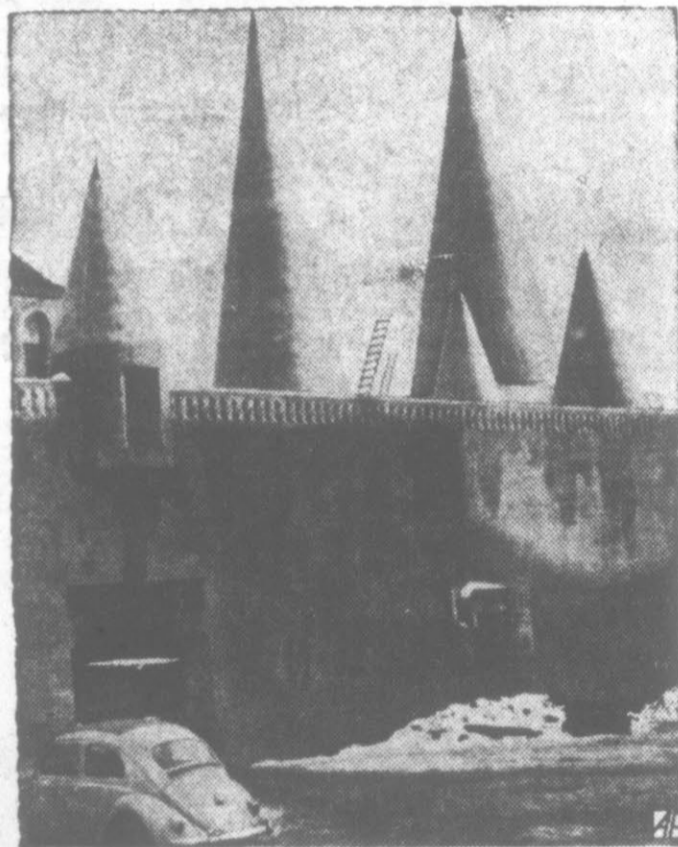
The 20-story, 600-room hotel at 55th st. will change hands in about three months, it was announced Thursday.

The raid on the Moose lodge was one of several in North Carolina following publication of a list of clubs and persons who purchased federal gambling stamps.

Chief of Police Martin Ware searched three Kings Mountain clubs today, but reported he found no slot machines.

In nearby Shelby, the police chief and the sheriff of Cleveland County held a strategy meeting but said they felt raids would produce little since club operators have had time to dispose of machines since publication of the list.

The Internal Revenue records at Greensboro showed that the Scotland Overseas Service Club Inc (VFW Post 2008) paid \$500 license fees for two slot machines and the Cole - Stutts VFW Post 6814 paid \$250 license for one slot machine.

Officers said they searched the two clubs without finding any machines.

At Whiteville, officers reported the Whiteville Country Club agreed to surrender its slot machine on Friday.

Police raided the Moose Lodge at Thomasville on Tuesday and charged Paul B. Harris, 41, governor of the lodge, and Lodge Manager William O. Rice, 41, with illegal possession and operation of gambling devices. Both were released under \$2,000 bond each for trial in Recorder's Court Feb. 25.

GREENSBORO—Though state law outlaws slot machines, organizations of North Carolina have paid federal taxes on 79 slot machines. This includes a machine belonging to BPOE Lodge 1645 in Greensboro.

A check of the records of the Internal Revenue offices here disclosed that most of the machines belong to fraternal orders, veterans' organizations and country clubs.

The federal tax is \$250 a year for each machine, and the taxes were paid for the current fiscal year, which will end next June 30.

The federal levy is a tax, not a license to operate the machines, according to Roland H. Nash Jr., assistant state director of the I. R. S.

New License Office Is Busy

FARMVILLE — With sales already tripled expectations, Farmville's new branch office for the sale of N. C. State motor vehicle license plates has enjoyed a "highly successful" season, according to Mrs. Darius White, office manager.

Through yesterday's sales, the local office had sold approximately 2,500 license plates for a total of \$52,000, Mrs. White said.

The office here, opened in October, has sold at least three times as many state tags as had been estimated would pass over the counter, Mrs. White said.

She attributed "more than half" the sales to Greene County citizens, pointing out that county has no branch office and many residents formerly going to Kinston or Wilson came to Farmville this year. Mrs. White felt the local office has drawn very little of the Greenville office's business except from Farmville area residents.

Midnight Monday is the deadline for motorists to discard 1959 plates and apply the new tags.

The local office at the Western Auto Associate store, however, will remain open on a year-round basis, according to the manager. Mrs. White pointed out the facilities here, Branch Office No. 82, include necessary equipment for title transfers, weight classifications, and other transactions that warrant a full-time office in Farmville.

Stem Invasion Of Rabid Dogs

EL CENTRO, Calif. (AP)—An invasion of Imperial County by rabid dogs has been stemmed after five months of terror and tears.

Anywhere from 3,000 to 7,000 dogs—wild ones and pets alike—were shot during the rabies epidemic. At least 135 persons have received anti-rabies treatment.

The diseased dogs began straying across the open U. S.-Mexican border into this rich farming area last fall.

A quarantine covering a 350-square-mile area was not ordered until Dec. 12 but since then all dogs on the loose have been shot on sight.

It has been more than two weeks since a rabid dog was discovered and the county health officer says if the area gets through February without another case, the quarantine will be lifted March 1.

Across the border in Mexicali, capital of Baja California, the epidemic is still raging. In the past week, 13 rabid dogs have been shot, and 26 persons are under treatment. Some reports say possibly hundreds of dogs have been killed in Mexico with poison pellets.

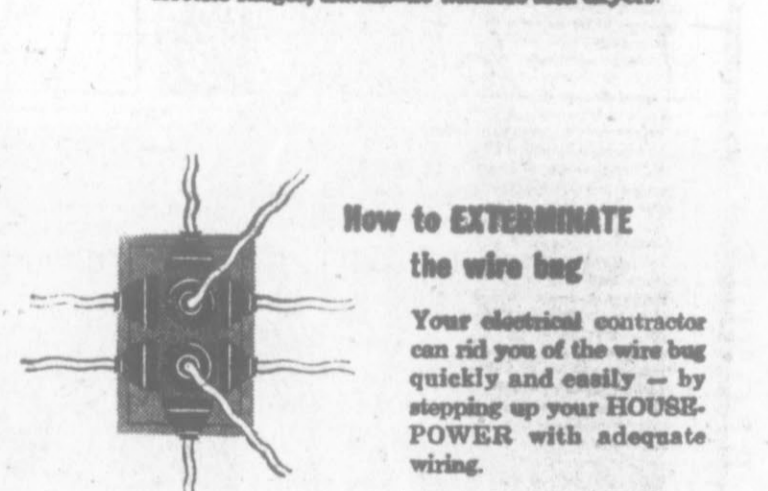
