

Few Obstacles To Negro Voters' Registration Reported In N. C.

RALEIGH, N. C. (AP) — The North Carolina Advisory Committee on Civil Rights reports that "while there may be some places in the state where obstacles are put in the path of Negro registration, in most counties this is not so."

"This can and should be done within the framework of the present laws of North Carolina." The employment practices report dealt only with the National Guard. "As of June 30, 1959, 11,345 white persons were members of the North Carolina National Guard," the committee said.

Negroes that they were discriminated against in voter registration by the manner in which the state's literacy test was applied. Ten of the complaints came from Halifax County, six from Northampton and one from Greene.

Gardening Today

Take a ride through the city streets or out into the country side or just look outside your window-spring is opening her book. Color is stirring in the cherry tops and a faint touch of fire tinges the apple. Forsythia, quince, spirea, and saucer magnolia speak a silent showy welcome to this new untried season. Jonquils, hyacinths, and tulips call out through the warming air.

Thrill spills over the stone wall like pink cascade and the flowering peach is having its moment. The red bud is beginning to blush and the dogwood buds can no longer contain themselves.

Through the streets of the city, the signs of spring are seen. The color, the fragrance, and busy people who are readying their gardens and grounds, is more proof than any date on the calendar.

Lawn mowers spin and sputter, spitting out the chewed grass and their whirling blades sweeten and cloud the air with grass juices and gasoline fumes. And the gardener trimming the grass along his sidewalk will rise with aching knees and a touch of vertigo. Then feel across his back all of his accumulated years. The spade bites into the willing yielding soil as the garden er ready an area to contribute to the larger picture of beauty.

Happy at his release from winter, he goes about his work with a zest that amazes even himself.

It is spring again with both its beauty and blemishes—time of the tulip, crocus, jonquil, high noon of the camellia; and a little distant yet of the azalea, the rose, and of others yet not awake.

Tufts of the wild onion spot the lawn along with the unwelcome gold coins of the dandelion, and wayward contrary bunches of other weeds. Is this a caprice or blindness of nature—who knows? These strange unwanted guests, having their own ideas of beauty, try to blend their little flowers and leaves into the picture of the accepted things.

This is the gladtime season of the year. One moment of spring will banish from the mind all the dull frosty times of winter.

And if you walk along the banks of the river, you might hear one blast of the chilly wind calling out to inquire the path the snow has taken. But the answer will die out into the echo of the breeze, bringing to your ears the sound of the woodpecker tapping on the sycamore, birds at song, the hum of insects.

It is a sleepy sound pulling at the moss that hangs down like gray beards from the trees. The trees, standing like Druids, look down into the brown liquid street of the river. And across the banks the woods are coming alive with the blue smoke of spring.

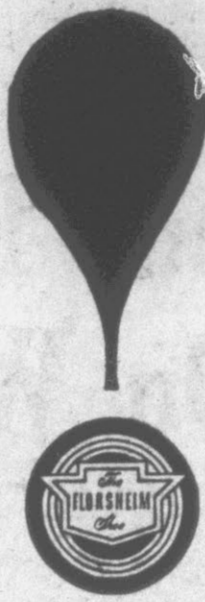

Visits School For Trainable Children

Allen Cohen, consulting psychologist in the State Department of Public Instruction, yesterday visited the School for Trainable Children here "compares very well with other ones in the state." He said there had been "very definite improvement in the progress of the children, largely due to the teachers." Cohen said that cooperation between the local schools and the parents was "very good." He added that it is only

"where you have that kind of cooperation that such programs have success."

Cohen observed classes at the school Friday morning and conferred with the instructors themselves yesterday afternoon. His visit to the school was for inspection and observation, as well as to confer with teachers on helping to improve the program further. He works with the teachers in advising new techniques and materials.

When Cohen returns to Raleigh, he will make a report concerning

his observations. On Thursday night, Cohen spoke to parents of the school children about state programs similar to this one, and trends in the program. He said there is a need for more funds to support "a growing program." The State of North Carolina appropriates about half the funds and the United Fund here contributes additional funds.

The School for Trainable Children, located behind Junius Rose High School, focuses its program in three major areas: self care,

economic usefulness and social adjustment. As well as giving children of limited ability a chance to adjust socially with other children, the program offers training in arts, crafts, safety, simple reading, word recognition and simple arithmetic.

The School for Trainable Children has been in operation here for three years and now has 20 students. There are two classes here, making 84 classes in all of North Carolina, Cohen said. "We are increasing in number every year. We added 14 this past year." Cohen added that trainable

schools had been a state-supported program since 1957, when the legislature first appropriated funds. Programs vary from place to place, since there is great variation among the children, even here in Greenville and Pitt County, Cohen said.

Mrs. Ellen Carroll, supervisor in the Greenville City Schools, accompanied Cohen on his visit to the School for Trainable Children. Principal of the school is Mrs. M. E. Cavendish. Mrs. Joe E. Brown is a teacher, and assisted them are Mrs. J. Thurman Hale and Mrs. Helen T. Semons.

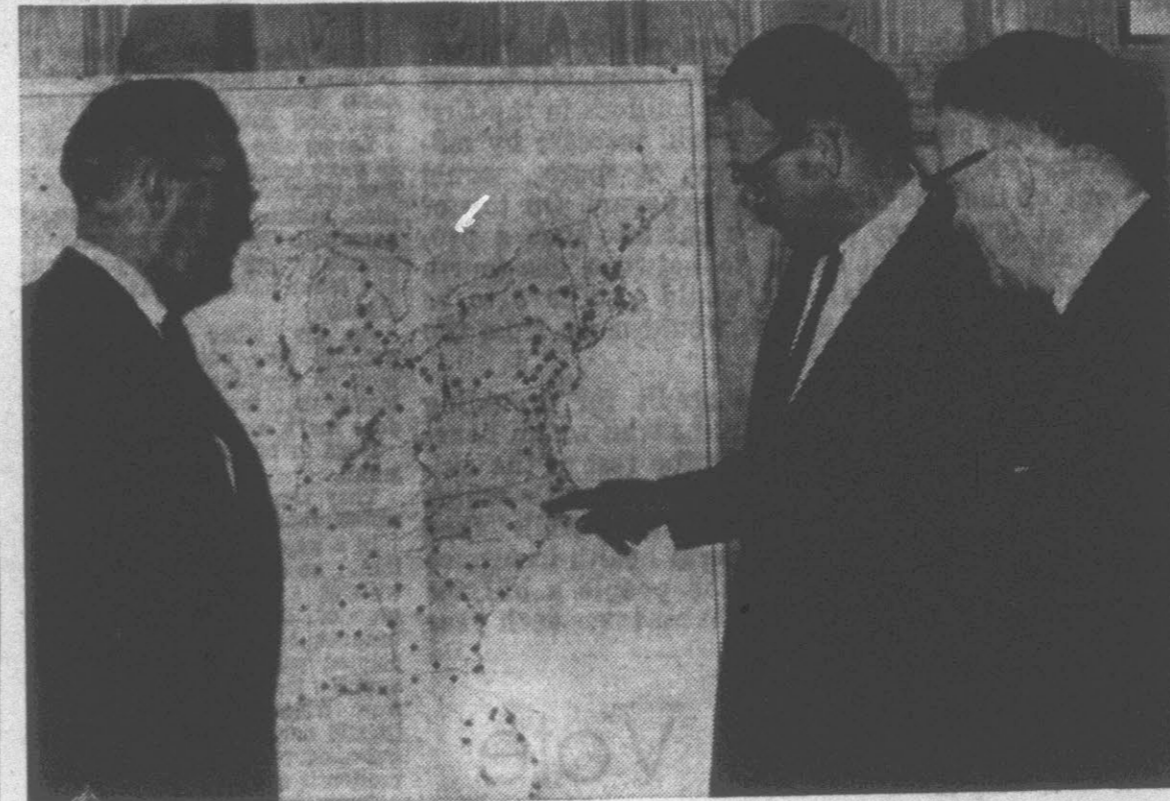

Public Awareness Of CD Said Vital

"One of the biggest jobs in Civil Defense is the education of the public," according to Russell C. Nicholson, Assistant State Civil Defense Director. Nicholson spoke to the Pitt County Safety Council at their meeting yesterday in an effort to give the group a better understanding of how civil defense affects the safety of the public.

According to Nicholson, "We will never have an adequate civil defense system until the people are sold on it and want to do something about it." He explained that civil defense is simply government at all levels being prepared to function under emergency conditions, which, he added, "is a tremendous task". If the government can function, it will "save lives and enable us to get our production back . . . so we can win."

As organized, the government heads appoint directors to head up the emergency program with the federal Civil Defense Agency coordinating the activities throughout the nation, providing matching funds with which local groups can purchase equipment and providing research and development. Nicholson pointed out the dangers involved with nuclear weapons and said, "We must do everything in our power to prevent their use . . . but do every-

thing to stay alive if it does come. He noted that being inside a house will give some protection from the fallout resulting from an atomic blast "but the only sure protection will be a fallout shelter."

J. H. Rose, local Civil Defense Director introduced Nicholson to the group.

Luther Moore, who presided over the meeting yesterday reported that Voluntary Vehicle Safety Check Lanes will be operated in Greenville for two days and in Ayden, Farmville, and Bethel for one day. No date has been set as yet but it is expected to be next month.

Autonomy Issue Has Been Injected

The matter of greater autonomy for local governments throughout the state that has been injected into the gubernatorial campaign is an issue which should not be shelved and forgotten after the campaign is over.

Whatever the method used to accomplish this worthy goal, county and municipal governments in North Carolina should be given greater autonomy in handling their own affairs than now exists. It is utterly ridiculous that county and city governments have to look to the legislature every two years to handle matters that could better be handled by the locally elected governing boards of cities and counties.

From the legislative standpoint it is ridiculous that more than half the bills introduced and handled during a session should pertain to only one county or city. By tradition, the legislators from each county determine whether the proposals for local legislation pertaining to their respective counties is approved or rejected. So far as local legislation is concerned, it is not a matter of consideration of the proposal by the entire General Assembly, but rather consideration by one or two legislators.

In far too many instances, the local government finds itself unable to do what it should for the county or city because too many matters that should be decided by the local governing board are, by law, decided by legislative action. When the legislature is not in session important matters to individual local governments are often long delayed because local officials do not have authority to make final decisions which are required to resolve local problems.

Certainly the elected officials of local governments should have the authority to determine the policies of their own governments, and they should have the authority to carry out programs to meet the needs of their people so long as these programs do not conflict with individual rights, the best interest of the state or other local governments.

There is no good reason for local governments in North Carolina being as dependent as they are on the legislature for final decisions on purely local matters. The present method of operation which requires local governments to await legislative approval for literally hundreds of decisions has long outlived its usefulness . . . if indeed, it ever was in the best interest of the local government.

North Carolina's cities and counties should be given more autonomy in handling their own affairs. The legislature should be relieved of the responsibility of acting on hundreds of purely local bills every session.

In the best interest of local governments and in the best interest of the state, it is a problem that should be resolved by the legislature next year.

Big Give-Away Part Of Election Strategy

The "big give-away" always seems to be a part of the election-year strategy in Congress as the major political parties and members themselves prepare to tell the voters what has been done for them before they go to the polls.

In this national election year, the trend in Congress appears to be to provide another major federal outlay in the form of health insurance for older citizens.

Last week the House Ways and Means Committee turned down the Forand bill which would have provided federal-financed health insurance for retired persons. This week Republican members of Congress have come up with another proposal for a state-federal program to provide similar health insurance at the cost of the taxpayers.

Such a program, of course, would have a great appeal to many voters that will go to the polls in November. The politicians in their campaigning could point to another example of what they had "given" the people of the country. That would be fine for the politicians.

But what about all this that would be "given away"? This new GOP proposal is estimated to cost the federal government some \$480 millions in the first year, and once begun, the cost would increase by millions every year. And that money, of course, would come out of the pockets of the taxpayers. On top of the federal funds that would be put into such a program, state funds amounting to between one-fourth to two-thirds of the total cost would also have to be put into the program. That too, would come from the pockets of taxpayers.

The politicians could take credit for providing the program for the group of citizens who would benefit by it, but in reality it would be the rest of the citizens who would be providing the funds with which to operate the program. The officials, while they would be giving the people a federal health insurance program, would also be giving the people a bill for hundreds of millions of dollars in extra taxes each year to pay for the program.

Wisconsin Vote Proved Nothing

WASHINGTON (AP) — The Wisconsin primary was a mish-mash.

It proved nothing. Yet all three entries, no matter how they finished, said they felt encouraged. That ought to set some kind of record for American politics.

Take Sen. John F. Kennedy (D-Mass.), who ran first in the state's Democratic presidential primary with more than 478,000 votes.

He was described as elated although he had been favored to win and could have done better. Sen. Hubert H. Humphrey (D-Minn.), his rival in the Democratic contest, got about 372,000 votes, or more than 106,000 less than Kennedy.

But he was encouraged because he hadn't done worse.

Vice President Richard M. Nixon, unopposed in the Republican presidential primary part of the election, got only 341,000 votes. Nixon interpreted his third-place vote as "surprisingly large."

He went even further and told Republicans around the country to look for a Republican victory in the presidential election in Wisconsin in November.

Then guess what Paul M. Butler, chairman of the Democratic National Committee said. He said Wisconsin would go Democratic in November.

And his opposite number, Sen. Thurston B. Morton, chairman of the GOP National Committee, said the vote for Nixon was the greatest vote ever given an unopposed candidate in the Wisconsin primary.

What does it all add up to? Nixon might have done much better if he had gone into Wisconsin to campaign for himself. But he didn't and it was the Democratic contest which got the attention.

Under other conditions in the same state—with just one Democratic entry who, like Nixon, didn't campaign—Nixon might have done far better.

Actually the Kennedy-Humphrey race was more a personal popularity contest than a choice between the different ideas the two men stand for. They stand for pretty much the same ideas.

Perhaps Kennedy would have won the way he did in Wisconsin even if he had been a Protestant and maybe the anti-Catholic sentiment that showed itself against Al Smith in 1928 has died out in this country.

And a heavy vote against Kennedy in Protestant West Virginia might not prove any anti-Catholic sentiment at all but something unrelated.

For instance: West Virginia is not a prosperous state and the people there might feel a closer kinship to Humphrey, a relatively poor man, than to the young millionaire, Kennedy.

What the Wisconsin vote he got means for Humphrey is hard to say. Perhaps, since he got a good turnout in many rural districts, the nation's farmers are fed up with the Eisenhower administration's farm policies.

Or it could mean only that the farmers felt Humphrey talked language better than Kennedy, since he comes from next-door Minnesota.

Books About Them

All of a sudden, there has been a deluge of biographies of Presidential hopefuls. There have been at least four hard-cover books on Richard Nixon alone, none of them portraying the man as a human being because no one can be either so perfect or so unsuited.

Apparently, each candidate for the Presidency finds it necessary to prove that he has done great things, that he has a common touch, that he is superior in brain-power but is not snobbish about it. Little is said to establish that impermissible described as character.

In the old days, before I.B.M. machines did our thinking, bankers lent money on character rather than on pledges. Pawnbrokers insisted on pledges and that differentiated one from the other. Character to a banker meant that the borrower possessed a quality of personality, an ethic, a morality which was so perfectly geared that even if he failed in the venture, he would somehow pay his debts. In fact, the man of character had such standing that a banker might, in those distant days, put good money after bad.

Curiously, character as a word started out to mean something else altogether. It was originally an instrument for grading. In China, it is an English word for ideographs which are the symbolized figures they use for words. This second use also came down into English back in the 15th Century when character meant a distinctive mark, a stamp. The word then went through many developments, mostly figurative, until today, it means really that which marks off one person from another.

When a word has so many different and confusing meanings, it is probably true that when one speaks the word, character, he has a different portrait to convey than his listener receives, but this all understood: If one says that a man possesses character, it is a favorable remark. He is marked out as a decent person who is to be trusted.

Presidential candidates require not only character but reputation. That is something altogether different. Reputation means the estimate or esteem in which a person is held.

A person may have a good or a bad reputation. For instance, President Eisenhower had a good reputation when he ran for President and still has one but Al Capone never had a good reputation. No man is likely to be nominated for the Presidency unless his reputation at the moment is good. What his reputation will be when the history of the period is written, no one knows. Men who were outstanding while they lived sometimes receive only a footnote in history or are not even noted.

Various candidates' biographies are campaign literature. They are designed to depict an individual as possessing a superior reputation for wonderful achievement and for noble aspirations. The reading is generally for juveniles, for truly few men are worthy of biographical study until many decades after they have been laid to rest. Then their deeds and their character may be studied objectively. Finally, a biography must be written by one who has no interest, vested or hopeful, in the career of the subject. For instance, some of the various Nixon biographers sound as though they hope that when Nixon shall have achieved his ambition, he will deign to remember the biographer.

Politicians never remember their benefactors. It is unethical. Politicians are pragmatists. They do what is necessary. They associate with those who can at the moment promote them. It is wiser to serve God than a politician; one is not likely to suffer heart-aches. Socrates in his last moments said:

" . . . And the difference between him (the partisan) and me at the present moment is merely this—that whereas he seeks to convince his hearers that what he says is true, I am rather seeking to convince myself; to convince my hearers is a secondary matter with me. . . ."

But Socrates was no politician it is sufficient to know that (Continued on Page 6)

Civil Service Pay Boost Talked

A pay rise for Federal civil service workers, including postal employees, is a strong possibility.

Not much is being said about it in Washington. The Republican Administration has publicly opposed a general rise. Nevertheless, a quiet campaign is being organized, and when the proposal comes before Congress it may be passed smoothly, with a minimum of opposition. And unless the increase is startlingly excessive, President Eisenhower is expected to approve it.

The reasons for expecting passage are these:

1. Federal employees outside civil service, who are paid rates of pay prevailing in their communities, have been getting steady increases since the last civil service boost in 1958.

2. Workers in private industry have been steadily increasing since then, making it constantly more difficult for the government to recruit employees.

3. This is an election year

and few Congressmen want to go on record against such a pay rise. The 2,000,000-plus Federal employees control more than 4,000,000 votes—a bloc not to be nose-thumbed in an election year.

4. Such a pay increase will increase the spending power of government employees, providing an added dash of prosperity to the already prosperous economy. A pay rise might increase the Republicans' chances in November.

MAY BE RETROACTIVE
This added dash may be even more important if the pay rise is made retroactive to January 1, 1960. There's ample precedent for this: the 1958 increase, was made retroactive to January 1, 1958. The retroactive bit was paid on July 1, pouring about \$300,000,000 into the economy. The 1958 rise was 10 per cent, but since it is believed that the President will not consent to a rise of more than 7 per cent this year, the windfall will be less.

There will be other consequences:

1. The Federal rise will exert a slight upward push on other wages. Private industry will have to top government salaries to win personnel with desired skills.

2. The rise will have special consequences in state and local civil services, first, because they and the Federal service are intensely competitive in seeking career-minded employees and, second, because Federal service standards are often followed by states and subdivisions.

3. Federal employees will again be better prospects for sales; many businesses will soon be re-activating civil service mailing lists and special civil service discount offers.

INFLATIONARY ASPECT
The expected rise will not be seriously inflationary of itself; rather, it is just a small whorl in the broad pattern of inflation. It is inflationary only to the extent that the increase in pay is greater than the increase in productivity. Where productivity has been increased around

7 per cent, the increase will be non-inflationary.

The increase probably will not cause any immediate increase in tax rates but, of course, it must eventually be figured in taxes. This will be especially true after the increase is spread to state and local civil service.

Total Federal state and local wage and salary payments are now running around \$47 billion a year. An average rise of only 6 per cent would mean \$2.8 billion a year, which would come out of your wallet.

TEXAS TOWERS PART OF UNITED STATES
The Internal Revenue Service considers "Texas Towers," off-shore defense installations, as part of the United States even though some are located 150 miles off the coast. It turned down the request of a manufacturer who wanted to sell pianos to men on the towers without the Federal tax. The IRS held that the towers are neither a foreign country nor a "possession" of the United States. (Rev. Rul. 60-107.)

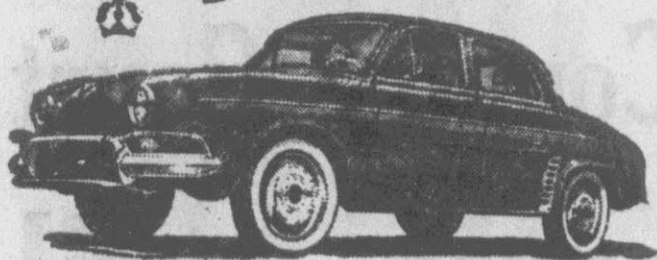

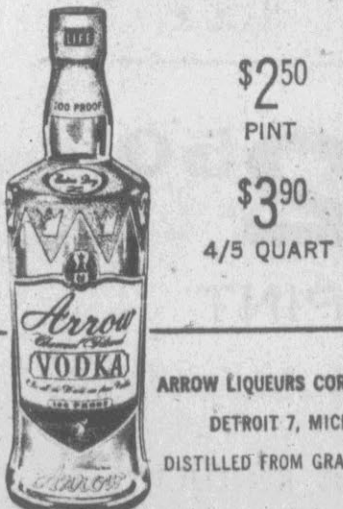

Watchers throughout the country must have been amazed to see Snead, one of the all-time greats, four-putt the 16th hole. He had an easy wedge shot and then three putted the 18th to lose, one down.

Snead said he felt compelled to waste these shots after discovering on the 12th hole that he had 15 clubs in his bags, violating the 14-club rule. This calls for immediate disqualification under the rules.

AUGUSTA, Ga. (AP) — Arnold Palmer, a husky young Pennsylvanian, today is right where the oddsmakers said he should be — leading the pack into the second round of the 24th Masters golf tournament.

The former Wake Forest College star, hottest item on the tour this year, shows no signs of cooling off. Three days after being bedbound with flu, Palmer fashioned a nifty 5-under-par 67 in Thursday's opening round and grabbed a two-stroke lead.

Some golfers are superstitious and feel it is bad luck to be pegged the pretournament favorite.

"I try not to let that bother me," said the Ligonier, Pa., professional who won the 1958 Masters.

Three of Palmer's contemporaries and one oldtimer fired 69s. Veteran Claude Harmon of Mamaroneck, N.Y., who won the 1948 Masters, was bracketed there with Fred Hawkins of El Paso, Tex., Dow Finsterwald of Tequesta, Fla., and Jay Hebert of Lafayette, La.

Amateur Bud Taylor, a dentist

from Pomona, Calif., joined Britisher Harry Weetman and tour regular Don January of Denver, Colo., in the 70 column.

Others in the 11-man par-busting brigade were British amateur champion Deane Beman of Bethesda, Md., and pros Gene Littler of Singing Hills, Calif., and Bill Casper Jr., reigning U.S. Open champion from Apple Valley, Calif. They had 71s. Par for the rolling 6,850-yard Augusta National course is 36-36-72.

Among those well off the pace were Sam Snead and Ben Hogan, both with 73s, and Jack Nicklaus, the young national amateur champion from Columbus, Ohio, who started with a 75.

Even more spectacular than Palmer's fine pace-setting round was the blowup by his No. 1 rival in pre-tourney figuring, Ken Venturi of Palo Alto, Calif.

Venturi, whose final round 80 cost him the Masters title in 1956 when he was an amateur, shot the front nine in a record-tying 31. But he plummeted to earth with a thud on the back nine, finishing with a 42 for a 73.

After today's second round, the field of 83 will be trimmed to the 40 low scorers, plus ties.

Alou, square name Maico, is on the roster of the Rio Grande Valley Giants in the Texas League and probably will be sent down. But only Kirkland among the Giants' regular outfielders bats left-handed, and an injury to, or slump by, Kirkland could give Matty a break.

Matty's second consecutive homer Thursday capped a three-run seventh that made a winner of Giant starter Mike McCormick. Both were off Tom Brewer.

Mincher batted in five runs with a two-run blast off A's starter John Tsitouris and a three-run shot off Bob Trowbridge. Allison also homered for the Senators.

Hawks Even Series With 105-102 Win

ST. LOUIS, Mo. (AP) — "They're going to get the winner's share even if they lose Saturday," owner Ben Kerner says of his St. Louis Hawks. "This is the greatest display of guts I've ever seen."

For the fourth time in two weeks, the Hawks rallied to win with their backs to the wall Thursday night, squaring pro basketball's world series at 3-3 with a 105-102 victory over Boston's defending champs.

"They have (Larry) Foust out of action with an injury after playing on an injured heel, (Bob) Pettit with an injured back and Jack McMahon and Dugie Martin out of the entire series," Kerner said. "Yet they keep coming back."

The winning team in the National Basketball Assn. title series gets \$17,000 from the league treasury, the loser \$11,000. Including their winnings for their regular season finish and for the division playoffs, the Celtics can win as much as \$36,000, the Hawks \$34,000 in prize money—because Boston had the best regular season record.

If the Hawks lose, Kerner will have to pay the \$6,000 difference out of his own pocket. But he says it'll be worth it.

The Celtics were quiet but confident they can win the title game on their home court.

"The worm will turn in Boston," said Tom Heinsohn.

"We're going to be all right, you'll see," said Frank Ramsey, Boston Coach Red Auerbach lashed out against Bob Burnes, sports editor of the St. Louis Globe-Democrat, who devoted most of his daily column to a discussion of Auerbach's court-side antics, closing with a suggestion that the officials make Red sit down throughout the game.

"He (Burnes) is a bush league

rabble-rousing cheer leader trying to get the fans stirred up," Auerbach fumed.

Burnes said "That is one of the nicest compliments I've ever had."

Kerner declared that Auerbach, dean of NBA coaches, "is a bush-league if we win 10,000 games. The only time he sat down was when he led by 26 points."

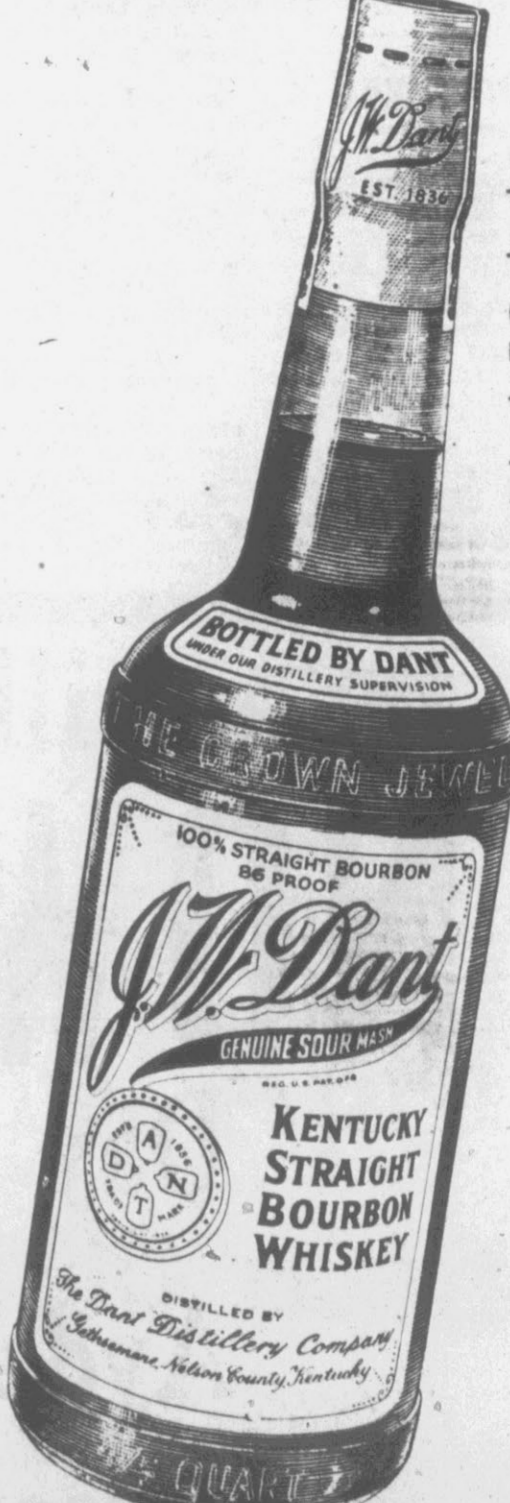

It was characteristic of the control the Hon. The time was just before two o'clock in the morning.

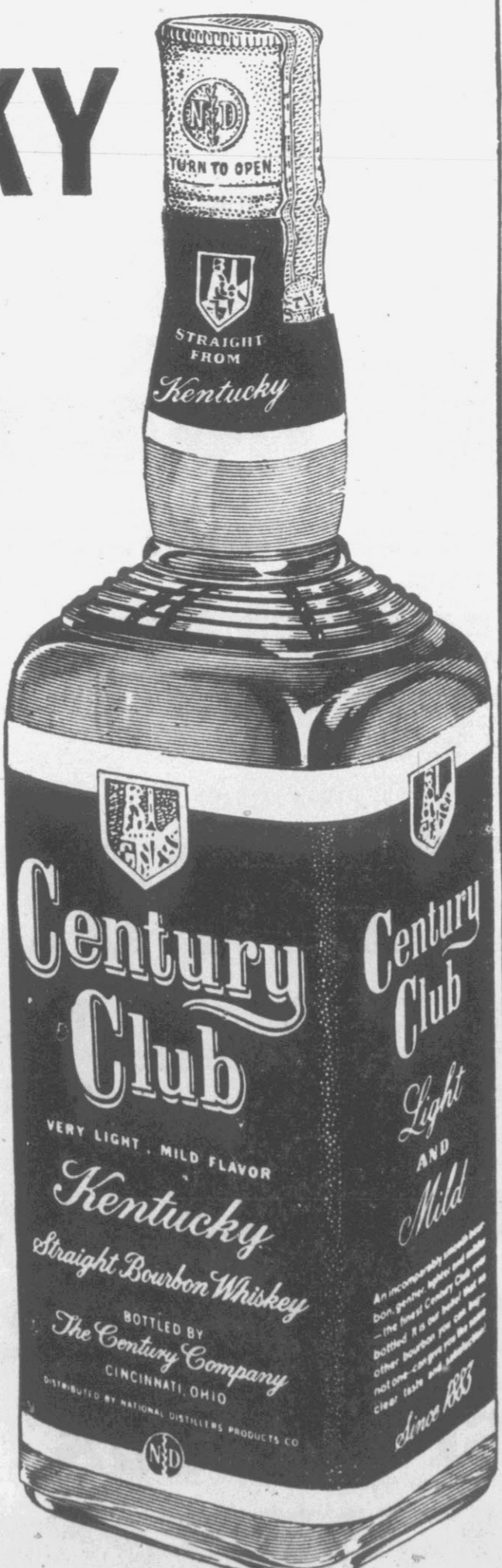

Youngstown Sheet, continuing its decline on news of production cutbacks, fell more than a point. Similar losses were taken by U.S. Steel and Jones & Laughlin. Lukens gained about a point.

Chrysler, down about a point was the worst of the motors. A 2-point gain by Pfizer paced the drug group.

Eastman Kodak climbed more than a point. Union Carbide lost close to a point.

The Dow Jones industrial average at noon was off 1.06 at 627.97. The Associated Press average of 60 stocks at noon was off .21 to 216.80 with the industrials down .60, the rails down .30 and the utilities down .20.

Corporate bonds were narrowly mixed. Governments were unchanged to a bit lower.
