Rhee's Political Foes Call Again For New Elections

SEOUL, Korea (AP) — President Syngman Rhee's political foes, unopposed by the resignation of his cabinet in the face of near revolution, today renewed their demands for new presidential elections.

With at least 1,000 persons shot during the riots, the known death toll stood at 147. Hundreds more were still in critical condition in hospitals or in their homes.

Rhee's liberal party running mate, Rhee, running unopposed for his fourth term after the death of the Democratic party candidate, piled up the biggest vote of his career in the election.

The election was the principal issue behind the uprisings. The Democrats have charged Rhee's Liberals with rigging the voting and widespread ballot box stuffing to insure a Liberal in power should the aged president not live out his term.

Propeller May Have Slain Four In Mid-Air Collision

HICKORY, N.C. (AP)—The four occupants of a private plane—victims of a collision with an airliner—may have been chopped to death by a propeller of the airliner.

The four occupants of the private plane may have been dead before they hit the earth, victims of the airliner's propeller.

"It looks as if the prop just chewed up the plane. All of the occupants suffered deep head cuts," said W. Stanley Moore, deputy coroner of Burke County.

The left propeller of the airliner sliced into the private plane, chopping and mangling the smaller aircraft.

The airliner, with 40 persons aboard, landed safely, the private plane crashed, killing all aboard — three Michigan furniture company officials and the company pilot.

Return Those Gasoline Taxes: Jones

ELIZABETH CITY — Congressional candidate Walter B. Jones last night called for federal aid to the states for secondary road and bridge improvement and construction.

Speaking to a crowd of nearly 700 that jammed the Camden Yacht Club area here, Jones raised the question: "Why cannot the federal government return to the

states gasoline tax money for the paving of rural secondary roads and the building of much-needed bridges."

He pointed out Congress has "for some years returned to the states gasoline tax money to be used for the construction of primary roads and super highways," and added, "for, after all, each live, are paying federal gasoline taxes and I know from experi-

ence that the state of North Carolina cannot financially do all that should be done in this area without this assistance."

Jones indicated all persons paying the federal gasoline tax should be able to expect equal benefits from the collected revenue.

Before his address he told newsmen Congress can "cut down on some of its wasteful defense and foreign aid spend-

ing" and divert some of that revenue to improvement of "domestic problems."

The 47-year-old Farmville resident raised more questions before his audience that frequently interrupted him with rounds of cheers and applause. He asked, "Is our district so much different than those which surround us and have federal projects which add to the economy of the sec-

tion?"

Kennedy Denies Role Of 'Catholic Candidate'

WASHINGTON (AP) — Sen. John F. Kennedy (D-Mass.) said today "bigotry is too great" to permit the election of a Catholic as president "then we ought to know it."

In a vigorous denial that he is "a Catholic candidate for president," Kennedy called on the nation's editors to keep matters of religion in perspective in the campaign for the Democratic presidential nomination.

"I do not speak for the Catholic Church on issues of public policy—and no one in that Church speaks for me," Kennedy said in a speech prepared for a luncheon session of the American Society of Newspaper Editors.

Kennedy complained about the attention given to his religion in news coverage of the Wisconsin primary, in which the defeated

Mrs. Robert Humber Speaks On Ceramics

Mrs. Robert Lee Humber of Greenville delivered a lecture on ceramics at a meeting of the Greenville Branch of the American Association of University Women in the parlor of Planagan Building on Tuesday. Mrs. C. A. Bowen, chairman of the Arts Committee, introduced the speaker. Mrs. Humber illustrated her lecture by showing pieces of pottery she had made while she was taking a course in Raleigh during her husband's term in the State Senate. Mrs. Humber told of further development by the Greeks and Romans, and mentioned the translucent ware called porcelain, which came from China. Too Much Hesitation Could Cost

The continent of Africa, gripped in the transition from colonial territory to an array of independent nations poses one of the great problems to the world today and one of the great challenges that faces the free world.

Though the world's news spotlight has centered on the racial troubles in the Union of South Africa in recent months, this is but one of the nations that makes up the continent. It is probably the most advanced nation of the continent from the standpoint of economy, transportation, schools and government.

Throughout Africa independent nations are being created with the rapidity perhaps achieved at no other moment in history in a single section of the globe. The nations which for generations have held Africa in colonial status are rapidly relinquishing their control of the territories and leaving to the natives—unskilled in self government—the huge problem of setting up governments of their own.

If the problem of forming new self-governing nations were alone not enough, most of these emerging independent states are relatively underdeveloped. Great masses of their people are illiterate. Potential natural resources which could be tapped will require billions of dollars which the new nations do not have and can only hope to get by loans from the better developed nations of the world.

Whether these new nations of Africa ally themselves with the Communist nations or with the free world probably will depend on which side puts forth the greatest effort to help them at this important moment in history.

Already the communists have made important in-

roads as the new nations of Africa emerge in their new independent status. Much of the free world, more dubious of the surging nationalism which has engulfed the continent, are skeptical of investing in the development of the new nations for fear their investments suddenly might be swallowed up by dictatorships or in revolutions. And while the free world ponders the problem of the emerging Africa, communism is taking advantage of the opportunity afforded by initiative.

If the nations of the West hope to have the new independent states of Africa on their side in the ideological conflict, they must develop a positive and far-reaching program to help these new nations in their time of need. If the West chooses to sit back and watch the development of these nations without participating in it, the West will see Africa's emerging states move into the Soviet orbit.

City Director Joins In A Guessing Game

Those who are still interested in guessing what Greenville's population will be according to the 1960 census might get a helpful hint from the new city directory being issued this week.

The 1960 city directory sets the local population at 20,650 compared with the official census figure of 10 years ago which gave the city 16,724.

As in most other cities, there is a wide range of guesses as to what the official 1960 census will show population-wise for Greenville. Most of the estimates range from about 19,500 to as high as 22,000 to 23,000 people. Whether the city directory's figure of 20,650 is high, low, or about right remains to be seen.

It is interesting to note, however, that the city directory for 1949-1950, issued shortly before the official 1950 census figures were available, gave the city's population as 17,475, some 750 more than the official census figure showed for that year. It is also interesting to note that the 1941-42 city directory gave the "Greater Greenville" population as 14,791, some 2,000 more than the official census for 1940 showed for the city.

If a similar difference between the city directory population figure and the official figure prevails this year, it would mean that Greenville might not have reached a population of 20,000 or more. On the other hand, the city directory population figure for this year might be low rather than high.

This year, we understand, the official census figures for Greenville are to include the on-campus student population at East Carolina College which would add several thousand to the number indicated by the city directory.

In any event, the city directory population figure for Greenville is not official, so if it is disappointingly low, it shouldn't be of too much concern to city officials. The figure that really counts is the census figure which will be available a few months from now. Only then will we know for the official record how much Greenville has grown in population in the past 10 years.

Candidates Up For Comparison

WASHINGTON (AP) — The scheduled debate between Sens. John P. Kennedy and Hubert H. Humphrey in the West Virginia presidential primary should, in a sense, be a kind of beauty contest. But not quite.

The two senators are like a pair of salesmen from the same company the Democratic party, with the same label on their suits (liberal), asking the customers to make a choice.

There isn't much to choose between their ideas on the kind of administration they say the country needs. They're pretty much the same. The choice to some extent would have to revolve more around personality than programs.

But the loser in the May 10 West Virginia primary will probably blame his loss on more than the way he parts his hair. The two men tramped through Wisconsin where Kennedy trimmed Humphrey but refused a challenge to debate him. Kennedy explains he thought "it would be harmful to the party and candidates."

Perhaps a much more persuasive factor in his thinking then was the belief he could wallop Humphrey without going through a debate. The polls at the time indicated he was out in front. He won by more than 100,000 votes.

In West Virginia—where Kennedy seems to have tougher going than in Wisconsin—he says he accepted the second Humphrey debate challenge because of the attacks on him.

The two men's views, because

they are rather similar, may not be an important factor in swaying West Virginia voters. But the sight of the two men in action and close up will provide a chance to weigh their presidential looks.

But even if the primary results force one of the other to give up his presidential hopes, the loser is apt to place the blame on something besides the debate.

Kennedy as a loser might feel, for instance, that his Catholicism, which didn't keep him from winning in Wisconsin where 30 per cent of the people are Catholic, was what killed him in West Virginia where the Catholics are only 5 per cent.

Or, he might explain a defeat by reasoning he was ganged-up by reason he was ganged-up on—that the backers of three other presidential hopefuls—Adlai E. Stevenson and Sens. Stuart Symington and Lyndon B. Johnson—teamed up to help Humphrey win in order to keep Kennedy out of the race altogether.

This would have to be based on a theory that Humphrey has no chance at the Democratic convention to get the nomination and that Kennedy, unless stopped soon might be unstoppable.

Humphrey, who knows that there seems to be a general opinion he can't get the nomination, would have to think closer to home to explain a defeat for him since neither the Catholic vote nor a gang-up would figure in his downfall.

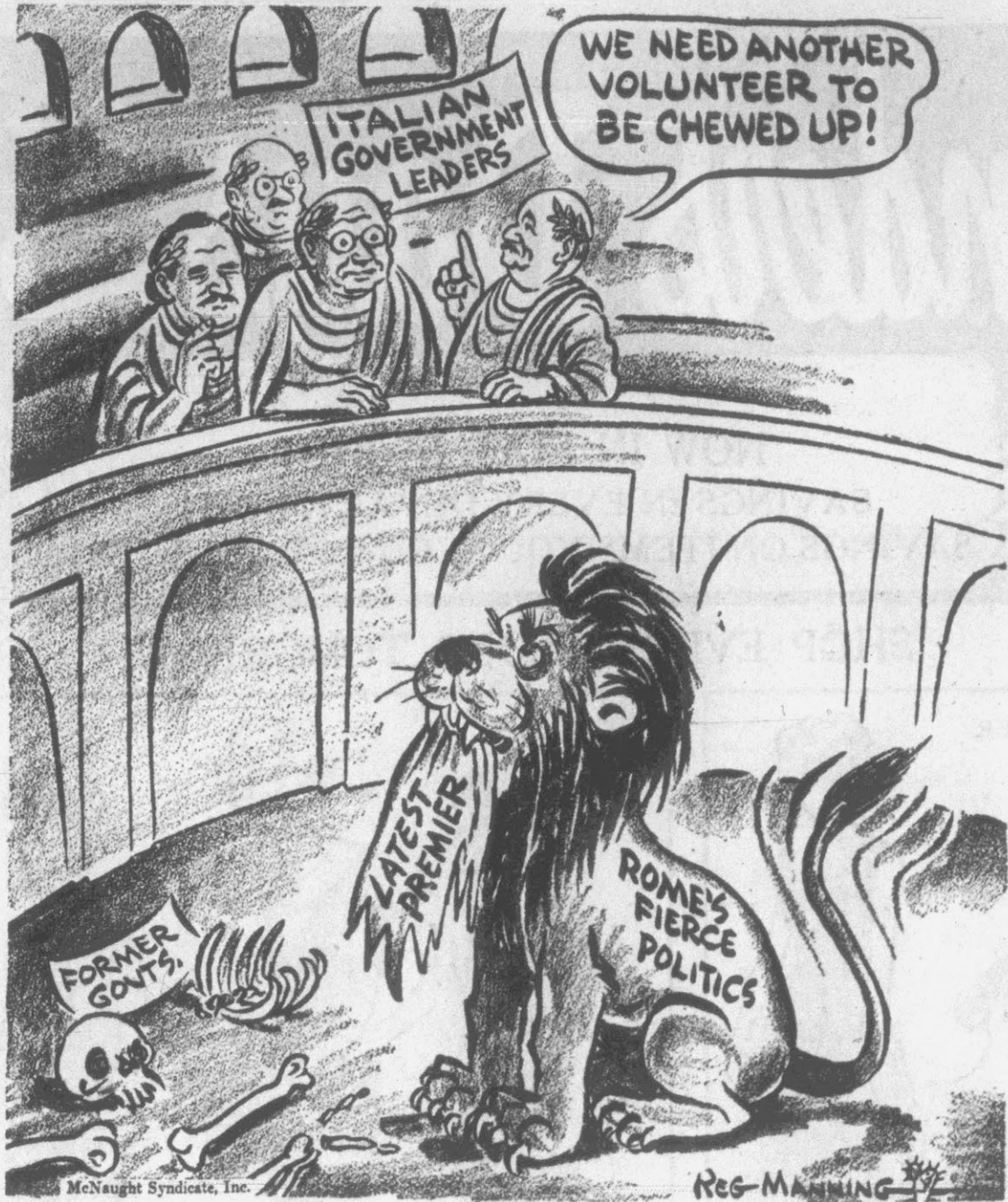

Learning What It Takes

(Henderson Dispatch)

Nearly everybody by now has been through the ordeal of filing and making payments on Federal and State income tax returns. What an experience that is—year after year, after year. There is no end to it, and the worst part of it is that the levy rise every season.

We confess to ignorance, stupidity or whatever it is, but these things are to us like a Chinese puzzle. The Internal Revenue Service now and then talks of a more simplified form, but instead of being that it becomes more and more complicated. When the company auditor or finished and handed over the personal reports, it was necessary to call on him to indicate where the signatures had to be attached and indicate the specific item that represented the amount of tax due. There's nothing simplified about that; or if we are just plain dumb, so be it.

No one likes to pay taxes. Such payments are, of course, essential for the support of government—at all levels. By the process, every one has a part in democracy. The trouble is that the procedure is becoming altogether too burdensome.

At no point is there the prospect of anything but increases—Federal, State, county and city. Those who do the spending are constantly demanding more of the citizen's substance for them to use. Some of this is pure politics, and a catering to

the hand-out element of the people who are looking for government to do something for them instead of doing it for themselves. . . . There is a feeling abroad that the upper crust will foot the bill. That group chips in its full proportion, but let no one forget that the rest of us are likewise paying through the nose.

We think it is time for a rebellion on the part of citizens against ceaseless tax increases. Those in authority ought to be told that it is a question of this far and no farther. Until they can be convinced to that extent the custom of hiking levies and outlays every year will not be checked.

It has been said, and may readily be accepted as reality, that the average individual works two days of every six-day week for government before he can have anything for himself. That is the open road toward ultimate confiscation and universal dependence upon government. Its eventual goal is communism, or at least socialism, a system under which the individual is reduced to slavery to the state. Even by running at full speed he cannot even so much as stand still.

Payment of taxes serves to bring home these hard facts to every one. That is the story and the effect of the Ides of March and the fifteenth of April. We are learning and are constantly reminded of the burdens imposed by ceaseless increases.

Castro Funds Used?

On April 6, an advertisement appeared in "The New York Times" announcing the organization of a "Fair Play for Cuba Committee." This was to have been expected because there are always committees about everything and there are always "America Lasters." It was also not surprising that this committee could immediately afford to spend \$5,000 for an advertisement in "The New York Times." I suggested that if the money came from the Cuban government, those who signed it were unregistered foreign agents which is an offense; if the signers paid for it themselves out of their own pockets, then it is a just expression of opinion to which everyone is entitled.

The co-chairmen of this committee were announced to be Waldo Frank and Carleton Beals and one was entitled to believe that these writers organized it and were responsible for it. However, into my hands came a letter from Carleton Beals to Robert B. Taber of the Columbia Broadcasting System, who was apparently organizing the "Fair Play for Cuba Committee." It was Taber who invited Beals to become a co-chairman of this committee. Beals's letter is dated April 5 and may, the Post Office being what it is, not have reached Taber in time. Also in a postscript, Beals asks Taber to show him the proposed advertisement as it is to be run. From this, it is to be inferred that Taber was the mechanic of this "Fair Play for Cuba Committee." Beals did not see the advertisement until it appeared in print.

Beals's letter to Taber is most interesting, particularly a paragraph which has his permission to reproduce here-

"Two things I would have to be reassured about: (1) That no Communist is part of the committee or is asked to become a sponsor. This would blow the whole thing out of the water; (2) That funds are from voluntary contributions and that no money is derived from the Cuban government or their representatives, either directly or indirectly."

Of course, as the advertisement was published one day after Beals addressed his letter to Taber, the former could not have received a reply from the latter. However, I telephoned to Carleton Beals on April 13 and he had not by that date received such an assurance as he requested. In fact, such an assurance could not have been given until certain persons took steps to erase their life history from the record.

As for the funds coming from Cuba, the precise date on that subject cannot be found except under oath by some authority possessing the power of subpoena. My belief is that those who signed this advertisement would prefer to list the contributors to its payment in order to visit the suspicion that it came from Castro. Men have a right to be suspicious, and wise men, if they have nothing to hide, make full disclosure of the facts. Certainly those public offices which deal with such matters know who paid for the advertisement and where the cash came from.

I must confess that I do not know who Robert B. Taber is, but the Beals letter to him shows that there was an organizing committee, that Beals did not attend any of its sessions and that Beals wanted to know what was being done and that therefore he wrote to Taber as the man who could tell him.

What is the importance of all this? Well, there is much anti-Castro agitation in this country; there is a pro-Castro propaganda. Those opposed to Castro do not represent a foreign power; they represent an American reaction to a revolutionary government which imperils the United States.

Those who favor Castro may be honest men and women who conscientiously believe that it is to the best interest of the United States that a govern-

Sunday-Closing Fight Shapes Up

Sunday-closing fights are breaking out all over the country. They are heading toward the U. S. Supreme Court; some are already on the docket.

The Sunday-closing dispute is bitter because it involves religion and civil rights as well as the human desire to make a buck.

Outside every metropolitan area new stores and shopping centers are opening on Sundays. Sunday drivers, who used to spin into the country to show their children what a cow looks like, now tool out to show them what a bargain looks like.

These highway shopping centers have great advantages over city stores. They pay no city taxes; they hire local workers at far less than they would have to pay city clerks. Insurance rates and police graft are usually less than in cities. Ground rents are less. So they can undersell city stores and markets.

THE CRITICAL DAY
However, to prosper they must sell on weekends because many of their customers can't drive out on other days.

On the other hand, city stores would probably lose Monday if they opened on Sundays. So they protest against this "unfair competition"—and quote scripture to prove that there should be one day of rest a week.

At the same time, many devout church people should have a day of rest and they have joined the demands that Sunday selling be made illegal by state law. It is illegal by local ordinance in many cities because downtown merchants and religious groups have persuaded city authorities to make Sundays no-sale day, except for certain items, such as drugs—and gasoline with which to drive to outlying open markets.

In most states there are organizations now trying to get legislatures to strengthen old laws or enact new ones prohibiting Sunday sales in all areas.

OPPOSITION STRONG
At the same time, those favoring Sunday sales are fighting back in both cities and states.

At the same time, those opposing to compulsory Sunday closing

are fighting back in both cities and states.

In cities, opposition to enforced closing centers around religious groups who do not observe Sunday as a holy day; Jews, Seventh Day Adventists, Mohammedans and others. They argue that since they close on their own holy day, they are at a disadvantage if they are forced to shut on Sunday too.

Outside of cities, those opposed include these religious groups and owners of businesses that profit by Sunday operations.

In and out of cities, the opposition to Sunday closing is often supported by civil rights organizations. In some instances, the opposition also has the open secret support of a number of businesses now usually allowed to operate on Sundays, such as drugstores, movies, service stations, restaurants and places of amusement. They fear that if the Sunday-closing movement becomes widespread, it may eventually be extended to their operations.

There is still another group that often gives cautious support

to opponents of Sunday closing. It consists of county, small town and rural officials. Sunday openings outside of cities provide employment for voters and the stores built for Sunday sales increase the taxable property within their reach.

Thus the Supreme Court will have to decide between religious faiths, between cities and rural areas, and between those who want civil rights broadened and those who don't.

The questions include: Should a man be forced to close his store on another religionist's holiday? If so, shouldn't the other religionist be forced to close on his? Has a man a constitutional right to do business any time he sees fit? Must a merchant conform to local custom? Should rural areas be free to compete with downtown shopping centers in their own way? Should highly taxed city merchants be protected from lightly taxed competition across city lines?

Supreme Court action may stir up almost as much controversy as the segregation problem.

Gardening Today

By JOHN G. DUNCAN

Plants that do double duty in the garden should be used more by the gardener. A double duty plant can best be described as one that does more than fill space, please the eye, or just fill ordinary garden needs.

Plants that offer something for the table as well as the vase should find a useful spot in your garden.

A hedge of blueberries is both attractive and the fruits you get have many uses. Such a hedge planted between your vegetable garden and the ornamental area on your place should give something to both areas. A few trees such as plum, peach, or apple planted on either side of hedge will give you a mass of color in the spring, and fall or summer fruit.

A ground cover of strawberries under the trees will give you a picture that offers much color and a host of white flowers riding on a sea of green. The flowers will soon become red berries floating in your cereal bowl.

If you plan such a picture, use the dwarf fruit trees and get the best types of strawberry plants you can. Red Rich is a good variety of overbearing strawberries.

Grapes on the backyard fence do a good job of hiding and providing Concord, Niagara, Catawba, and James should make a good group to combine together.

You can make your vegetable garden a part of—not an outsider—to your home grounds. Vegetables are plants that can be listed as double duty also. Colorful foliage (beets, rhubarb, etc.) with a variety of leaf and fruit offered by others can make your garden attractive.

Raspberries also make a good hedge or screen and fill a fruit need. Black kinds do better than

red ones in light soils. When you set these plants out, cut them back close to the ground.

Herbs planted in flue tile can be dotted around your garden. This method of planting them gives them a sort of individual identity and keeps them from running all over the place.

Use your garden space so as to get the most from each plant. To the age old saying "to everything there is a season," can be added to everything there is a reason—both beauty and bounty.

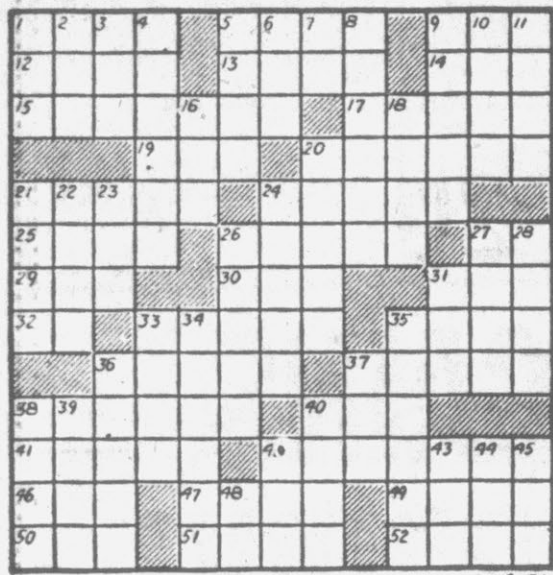
Crossword Puzzle

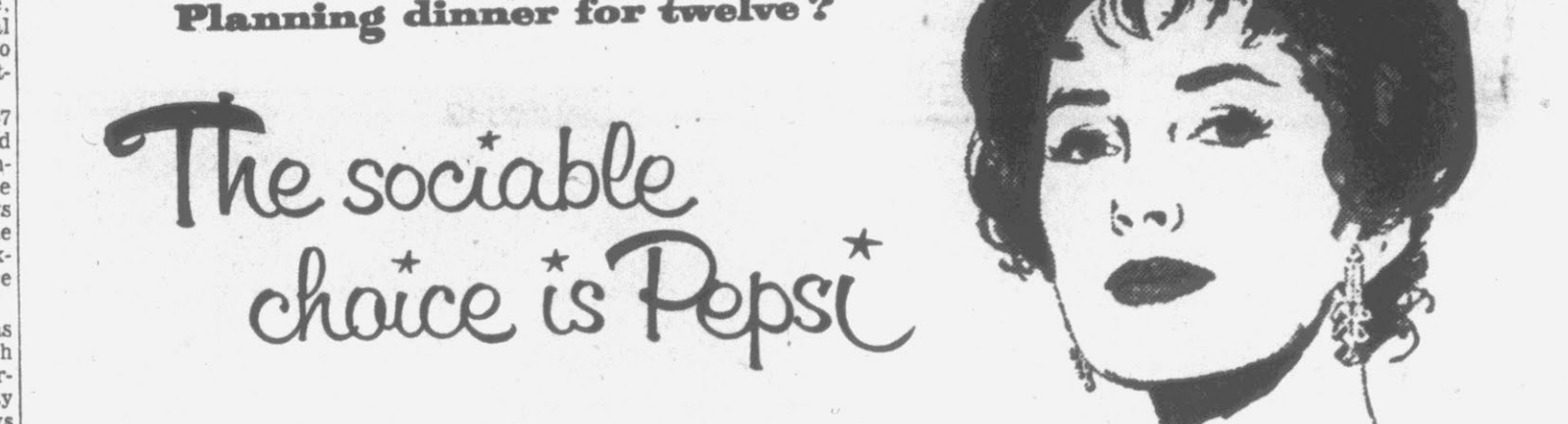

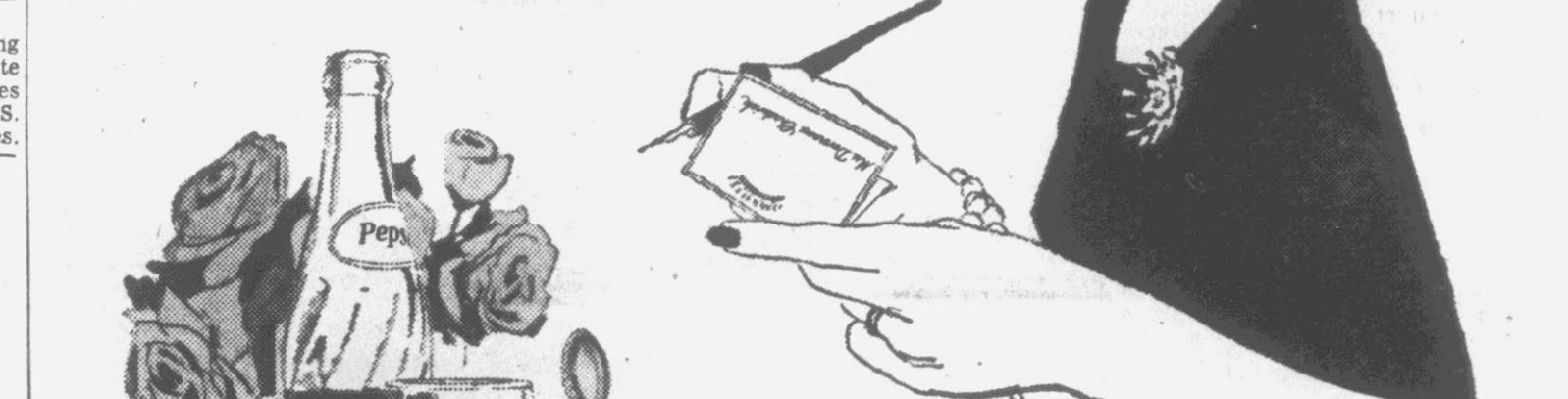

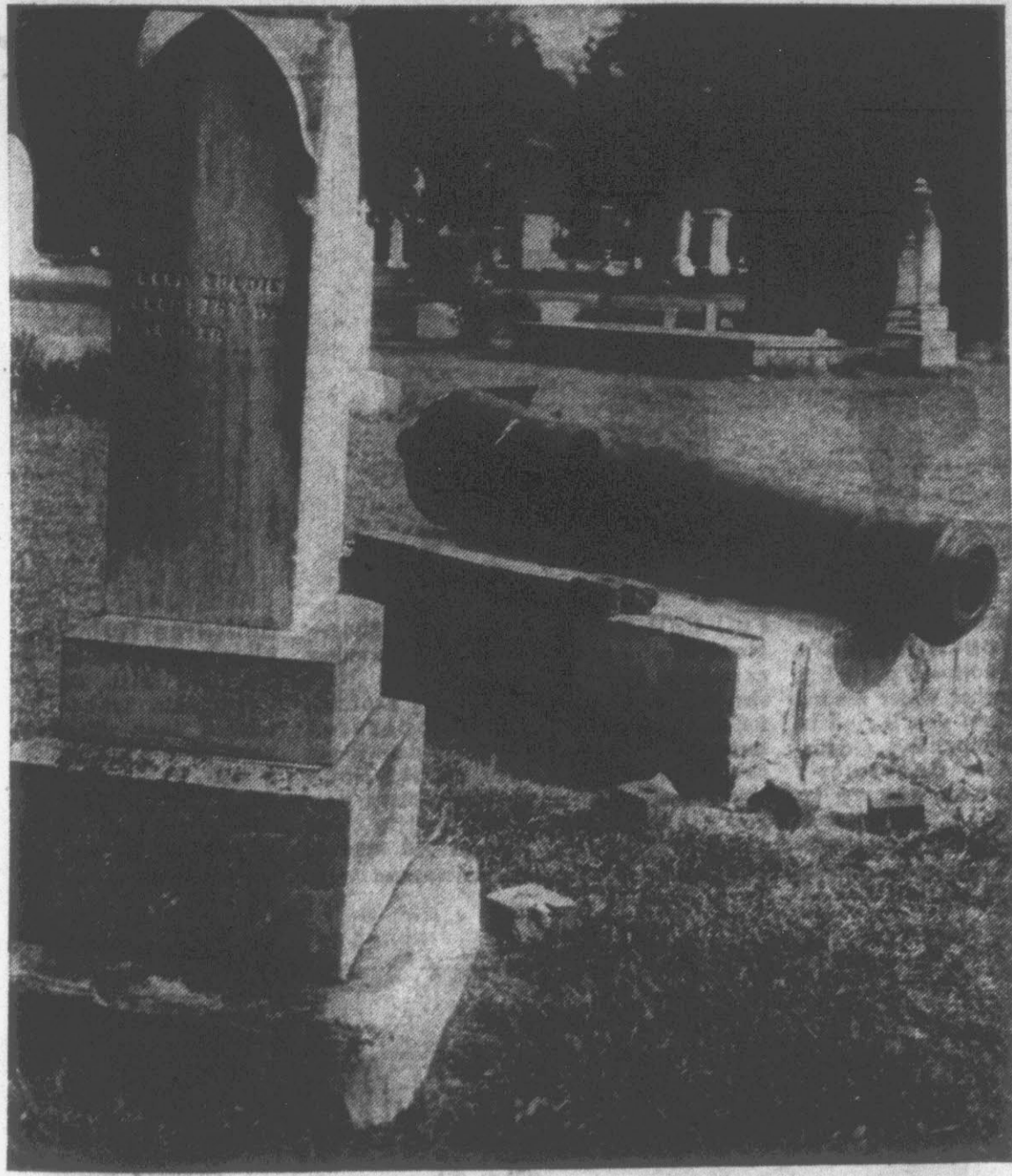

Cemetery Sometimes Has Old Cannon Balls

Cherry Hill Cemetery is the possessor of a Confederate Memorial to the dead, a Civil War cannon and the stand which holds the cannon.

Once it also was the proud possessor of 25 or 30 Civil War cannon balls, which were mounted upon the concrete stand that bears the cannon.

Over the years, the cannon balls have held an irresistible charm for the living, who have carted them off, one by one, and in groups, to places known and some unknown.

Cecil Jones, Greenville cemetery superintendent, said the cannon balls had been disappearing for years. He and his crew, searching for them, usually found the cannon balls, put them back on the stand, and when they disappeared again, went through the same process.

Jones said the culprits usually rolled the cannon balls (unusually heavy) down the hill behind old Cherry Hill Cemetery, where they often landed in a ditch. About six months ago, all the cannon balls were missing, which was getting to be a standard procedure to Jones.

He and his men searched the cemetery over, and found about a dozen in the ditch behind the graveyard, near the light plant. They took the cannon balls back to their resting place with the companion cannon.

And then, three or four months ago, all the cannon balls were discovered missing again and haven't been seen since. Jones has been cemetery superintendent for 18 or 19 years, and he said the cannon balls had been there ever since he had. Up until now.

Mrs. J.L. Fleming, a past president of the United Daughters of the Confederacy, can vouch for the disappearing and reappearing cannon balls. Through the years, she said, one by one the cannon balls, part of the Memorial to the Confederate dead, have been found missing.

Every year, on the 10th of May,

Mrs. Fleming said the United Daughters of the Confederacy had placed flowers upon the cannon balls. Last year on the annual day, the markers were all missing, so the ceremony didn't take place.

It might be that somehow, the cannon balls will turn up again. There is a rumor one is safe in a vault at the city police department, rescued from some would-be late night bowlers.

There is a strong possibility that some cannon balls found recently in the Tar River off the end of N. Library Street were a part of the missing Civil War cannon balls. They weren't corroded with rust, as they would have been if there for sometime.

And there is a clearing on the bank, from which someone, tired of captivated Civil War cannon balls, which once were with their companions in the cemetery, might have sent them to a watery grave. There is another possibility that has been mentioned: that the cannon balls have been confiscated and sold as scrap.

Perhaps in some future years, Pitt County will receive back its missing cannon balls, relics of a war 100 years ago, and Cecil Jones will take care of them and the United Daughters of the Confederacy can place flowers upon them.

Opera Theatre Receives Gift

A. J. Fletcher of Raleigh, president of TV station WRAL and founder and president of the Grass Roots Opera Company, has made a financial gift to the department of music at East Carolina College which will be used for summer work conducted by the Opera Theatre of the college, Director Earl Beach of the department has announced.

Fletcher's gift will make possible the production of an opera during the first term of the summer session. Auditions will be conducted and casting completed before the end of the spring quarter, Mr. Beach stated.

Paul Hickfang, faculty member of the department of music, will act as musical director of the opera to be presented this summer. In 1957 he founded the Opera Theatre at East Carolina and has directed the group since that time. He has studied opera in this country and on a Fulbright grant in Germany. A baritone, he was soloist with the N. C. Symphony Orchestra in 1958-1959.

This summer's opera will be the fourth production by the Opera Theatre. In 1957 the group presented Pergolesi's La Serva Padrona and scenes from Smetana's The Bartered Bride; in 1958, a full-length production of the Smetana Opera; and this spring Gian-Carlo Menotti's "The Medium." These operas have been highly praised by audiences and by the press.

Newsmen Held Overnight By Cuban Secret Police

MIAMI, Fla. (AP)—Cuban secret police accused two U. S. newsmen of counterrevolutionary activities, the Americans said on their arrival by airplane Wednesday night.

Richard Bate of Cocoa Beach, Fla., and Mario Biasetti of Boston, Columbia Broadcasting System reporter and cameraman respectively, said they would recheck film they had dispatched several days ago before discussing a recent controversial interview with Cuban Prime Minister Fidel Castro.

Bates said earlier he had interviewed Castro, who in response to a question, had stated a talk with President Eisenhower or Secretary of State Christian A. Herter "might improve relations between the two countries."

Cuban intelligence officers took the two Americans from their hotel room Tuesday and detained them overnight. Biasetti said police told them they wanted the two to identify a man they met on an airplane flight several days before en route from Camaguey to Havana.

They were held overnight without food and given glasses of milk Wednesday morning. Biasetti said youthful questioners wearing pistols in waistbands of their civilian clothes told him to keep his mouth shut when he asked for food.

The CBS men were refused an opportunity to speak to the intelligence chief or to call the U. S. Embassy, they said.

Wednesday they were taken by back routes in spending automobiles with two armed escorts to Havana airport, Biasetti said. Another car with their baggage followed.

Guns saluted the monarch's anniversary. The Royal Navy fired salutes at sea and flags flew on all public buildings. But the official celebration of the Queen's birthday comes in June, when there is a better chance for good weather.

PARIS (AP) — More police are needed to make Paris safe for foreign tourists, the tabloid Paris-Jour suggested today. The paper reported there were 30 hold-ups and burglaries in the capital the past four weeks.

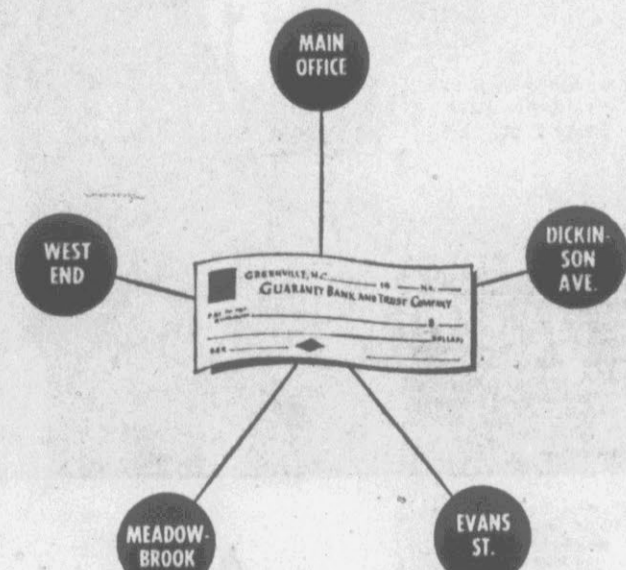

Another rendezvous in that Chowan County town produced

more Jones followers and a police escort through Hertford, a district that led the caravan as it moved toward Hertford.

With sirens screaming and horns blaring the string of vehicles numbered 13—six of them adorned with huge "Jones-For-Congress" signs, the remaining seven brandishing posters and bumper stickers.

Another police escort led the noisy parade through Hertford, where more cars joined in, and toward the destination—Elizabeth City.

As nearly 20 cars approached Elizabeth City (more police cars were waiting. Again the red lights and sirens led the procession that suddenly grew larger as cars after car fell in line.

To a downtown hotel the caravan

went. Spokesmen said an interested bystander on one of the city's streets was Herbert Bonner.

More cars joined the string as it wound its way through Elizabeth City and over the Pasquotank River to the Camden Yacht Club and a free fish fry.

Nobody seemed to know just how the caravan got started. "It must have been one of those spontaneous things," somebody said.

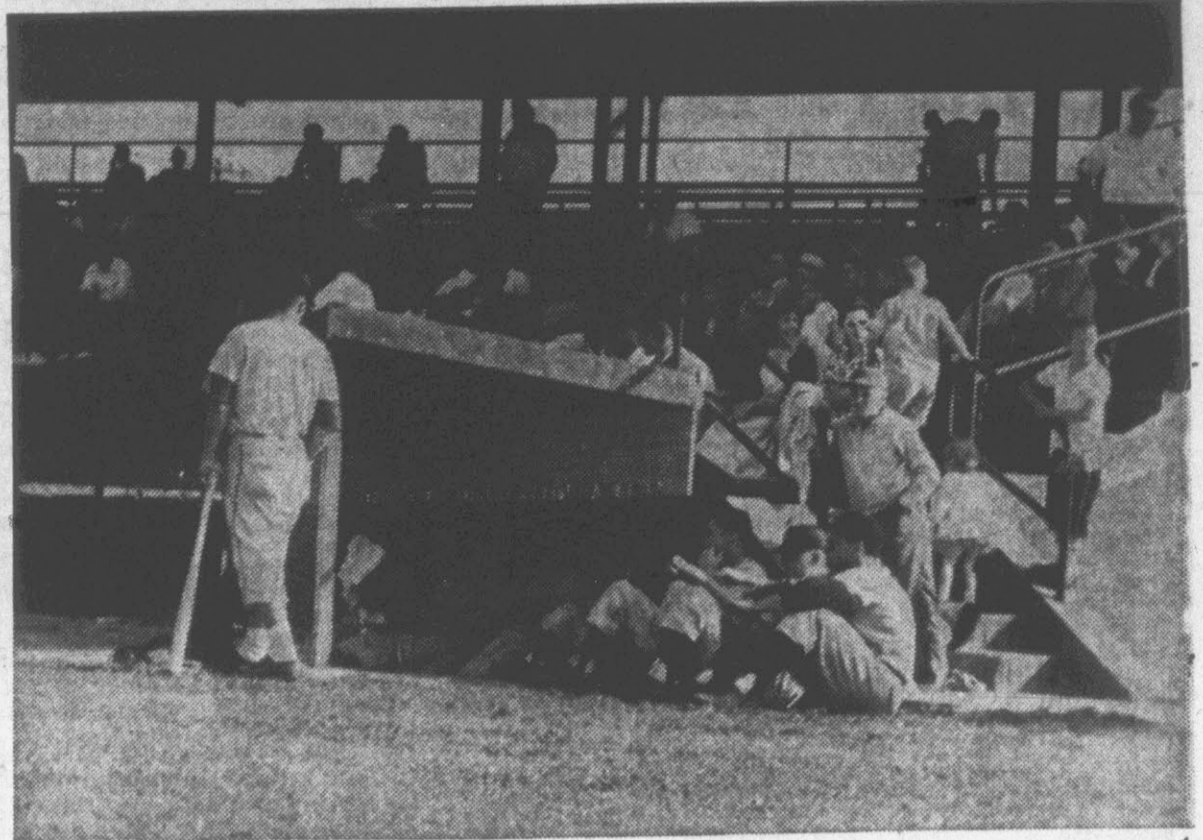

Fullmer Remains Champ As Title Fight Is Draw

BOZEMAN, Mont. (AP)—Champion Gene Fullmer's NBA middleweight crown still rested on his scarred and bruised brow today after tiling dangerously in a slug-fest and butting duel with challenger Joey Giardello.

The officials ruled the wild, 15-round brawl Wednesday night a draw.

Giardello, a 3-to-1 underdog, chanted afterward "I'm the champion, I'm the champion!"

Fullmer ignored Joey's claim and said he'd never again fight the Philadelphia veteran who missed by a hair's breadth in his first title shot after 12 years in the ring.

"He doesn't deserve a rematch because of the way he butted me in the fourth round," Fullmer said. His manager, Marv Jensen, echoed the champion's stand.

"Sure, I butted him," Giardello said afterward in his dressing room, "but I only did it after he butted me."

Giardello's head-knocking followed Referee Harry Kessler's warning in the third round against butting.

Kessler, a St. Louis official, scored it 144-142 for Giardello. Judge Ray Evans of Butte, Mont.,

gave it to the champion 145-142. Judge Billy McFarland of Missoula, Mont., called it even at 145-145. The AP scored it 144-144 and even in rounds.

More than 12,000 fans who paid in excess of \$10,000 crowded into the Montana State College field house for the nationally televised bout.

Fullmer, who just made the 160-pound weight limit, collected all the \$100,000 television receipts. Giardello, 158½, received \$25,000 plus \$5,000 expenses.

Confusion reigned at ringside for several minutes after the split votes of the referee and judges were announced. The status of Fullmer's crown remained uncertain until Sonny O'Day, chairman of the Montana Athletic Commission, told the crowd: "The decision has to be a draw. Fullmer retains his crown."

The action was fast and furious in the early rounds of the bout. By the fourth, blood streamed down the face of both fighters. Giardello peppered away with jabs around Fullmer's head while the champion countered with a relentless body tattoo which made Joey wince half a dozen times. Although both suffered heavy jolts throughout the battle, there were no knockdowns.

Sam Snead Becomes Controversial Figure

NEW ORLEANS (AP)—Sam Snead, a quiet-spoken golfer for most of his 48 years, today is emerging as golf's most controversial figure.

The president of the Starmount Forest Country Club in Greensboro, N.C., yesterday said the Professional Golfers Assn. should censure Snead for his recent actions.

Edward Benjamin, here for the Greater New Orleans Open, told the Times-Picayune in an interview, Snead is a "mental heavyweight who has developed a contempt for his fellow players."

Snead's been "too much in the limelight," Benjamin said. He said Snead ought to stay away from future Greensboro tournaments.

Benjamin's retort came after Snead called the Starmount course "lousy" after his \$2,800 victory in the Greensboro tourney.

Snead told the gallery you deserve more than you're getting. He suggested Benjamin do something about it.

Earlier, Snead was in another controversy when he said he threw a nationally televised match with Mason Rudolph because he found he had too many clubs in his bag.

Benjamin, who has a home and business interests here, said "it seems odd that if the course was in such bad shape that he (Snead) would break a course record that stood for 22 years."

He said Snead's criticism was an affront to the Starmount course. Benjamin said snow blanketed the course until March 31 and "I feel it was remarkable we even had a tournament."

Benjamin said other golfers complained about Snead's actions during play in the Greensboro tourney.

Thorne Wood, the first round leader, told him Snead would put and walk off the green with a

gallery trailing before other golfers could putt out, Benjamin said.

Wood said it hurt his concentration and cost him six strokes, Benjamin related.

Benjamin continued: "While Gary Player was trying to lineup a putt on the final green Sunday, Snead started taking golf balls out of his pocket and tossing them across the green to his caddy. Then, as Player addressed his ball, Snead threw some clubs across the green."

Sawyer Wasn't Prof Of '48 Whiz Kids

PHILADELPHIA (AP)—Why did Eddie Sawyer waste through spring training, handle the club in one regular season game and then toss in the towel as manager of the Philadelphia Phillies?

Friday will be a week since Sawyer's dramatic exit and the announcement of Gene Mauch as his successor. Instead of becoming a forgotten issue the mystery has deepened. Local sports circles still are battling about the whys and wherefores.

Sawyer still won't talk.

Club owner Bob Carpenter and General Manager John Quinn consider the matter a closed book.

The detectives in this case — reporters — have taken to interviewing each other. The writers who covered the club in spring training were particular targets for questioners.

The general opinion seemed to be that Sawyer was an entirely different personality from the man

who came to the Phillies in 1948, and helped develop the team which won a National League pennant in 1950.

During his first term, Sawyer was known as the kindly professor who had a wonderful way with kids. It was said that the manager cajoled, kidded, and hand-rode the young team known as the Whiz Kids to the flag. He made them believe they could win and they did.

But something happened. They fell apart, never were the same team again.

Sawyer, in a desperate effort to bring the club around, discarded his kindly approach and got tough. It didn't work and 2½ years after he managed a pennant winner, he was fired or quit as he always has contended.

In the middle of the 1958 season the Phillies amazed Philadelphia baseball followers by bringing back Sawyer. The Phillies now a last-place team. Sawyer sat quietly in the dugout through the rest of the season, and suffered through an ignominious campaign in 1959.

In the early months after the season, however, Sawyer talked like the professor of old. He had a lot of promising kids coming up from the farms. He spoke of the Phillies of the future. But somewhere along the line he suddenly lost his enthusiasm.

Tobacco Budget Director Involved In Problems Of His Own

By S. J. WEEKS,
Pitt County Tobacco Agent

It appears at the present that there are enough plants up to set the tobacco crop-provided good management is exercised to take care of and grow the plants that are now on the beds. However, it is realized that the completion of transplanting will be later than usual this year.

In dry windy weather it is advisable to water the beds (about one-fourth inch) every day or two until the plants are well established. After this two or three times a week in dry weather to keep the plants growing. Watering the beds before and after pulling the plants will reduce injury to the plants as they are pulled and to make the plants that are left straighten up and grow faster.

It is very important that a good insect and disease control program be followed.

On beds that have not received top dressing as yet, an application of three to five pounds of nitrate of soda per 100 square yards would be beneficial. The use of excessive nitrogen may cause the plants to be too tender at transplanting time.

Some farmers may desire to secure plants from other areas. Insofar as possible avoid moving plants from the witchweed areas. The following counties are listed as having witchweed on one or more farms: Bladen, Brunswick, Johnston, Lenoir, Columbus, Cumberland, Duplin, Harnett, Hoke, Pender, Richmond, Robeson, Sampson, Scotland in North Carolina and Marlboro, Dillon, Marion, Oree, Florence, Darlington in South Carolina.

It is my understanding that a plant pest control representative is stationed at the County Agricultural Agent's Office building in the above counties except that in Columbus County the representative is located at Chadburn. The plant pest control representative in the counties listed can make inspection and issue permits where appropriate. The kind of washing required in the quarantine regulation would damage the plants and would not guarantee freedom from witchweed.

Insofar as possible, do not secure plants from witchweed infested counties. If you do secure plants from any of these counties be sure to contact the plant pest control representative before moving plants from the farm.

WASHINGTON (AP) — Maurice H. Stans, director of the federal budget, is wrestling with a financial problem of his own.

He agreed last September to let the tax-exempt Stans Foundation guarantee a \$450,000 loan which enabled John J. Dalton Jr., a Washington businessman, to gain control of the Guaranty Bank & Trust Co., Chicago.

The loan has since been labeled delinquent and the foundation may inherit control of the bank.

This was the bank used by former Illinois State Auditor Orville Hodge in embezzling some 2½ million dollars in state funds in 1956.

Hodge, a Republican, is serving a 12-15 year prison term. The bank's former president, Edward Hintz, is in prison for aiding in the theft.

Aides say Stans is determined to avoid having the foundation assume control of the bank. The budget director is believed sensitive to the possibility this might create a conflict of interest. In his official position, Stans must intial all banking legislation recommended by the Eisenhower administration.

Chairman A. Willis Robertson (D-Va.) of the Senate Banking Committee, said he has discussed the matter with Stans and has been assured Stans could not profit from the operations of the bank or the foundation.

"If I am informed correctly," Robertson said, "There's no conflict of interest whatever."

The loan guarantee, first reported last week by the Chicago Daily News, grew out of an acquaintance between Stans and Dalton, a fellow skeet shooter. Dalton is president of Dalton Finance, Inc., which operates six small loan offices in Washington and Baltimore.

Last July, Dalton arranged to buy 16,685 shares — a 62 per cent interest — of Guaranty stock for \$750,825 from Joseph and Philmore Leemon of Detroit.

To help swing the deal, Dalton Finance sought a \$450,000 loan from the National Boulevard Bank of Chicago. At John Dalton's request Stans agreed to have the Stans Foundation guarantee the loan. In return, the foundation received 25,000 shares of Dalton Finance common stock.

In February, Dalton Finance was tardy in making an interest payment on the loan and National Boulevard decided to foreclose.

Dalton originally had until Wednesday night to arrange additional financing which would make it unnecessary for the foundation to back up its guarantee. But sources in Chicago said an extension apparently has been granted. They said Stans personally handled negotiations in behalf of the foundation.

National Boulevard could require the foundation to pay off the loan plus accrued interest.

Stans was head of the big Chicago accounting firm of Alexander Grant & Co. before joining the Eisenhower administration in 1955.

Not Even Bing In Her Choir Loft

AIKEN, S.C. (AP) — A well-dressed, middle aged man appeared in the choir loft of St. Mary's Roman Catholic Church here and asked the nun directing the children's choir if he might join in singing the offertory hymn.

"I'm very sorry," she said politely but firmly, "only choir members are permitted in the loft. You'll have to go downstairs."

After mass the rejected vocalist, who has been visiting the area, joined the pastor, whom he had met previously. They chatted over the strictness of the choir director.

"Someday I'd like to audition you, Sister," a smiling Bing Crosby said as he left the church.

The incident occurred week before last when Crosby, a golf fan, was visiting friends in Aiken during the Masters tournament in nearby Augusta, Ga.

CHARLOTTE (AP) — Newly appointed justices of the peace in Mecklenburg County will be required to attend a special school to prepare them for their new posts.

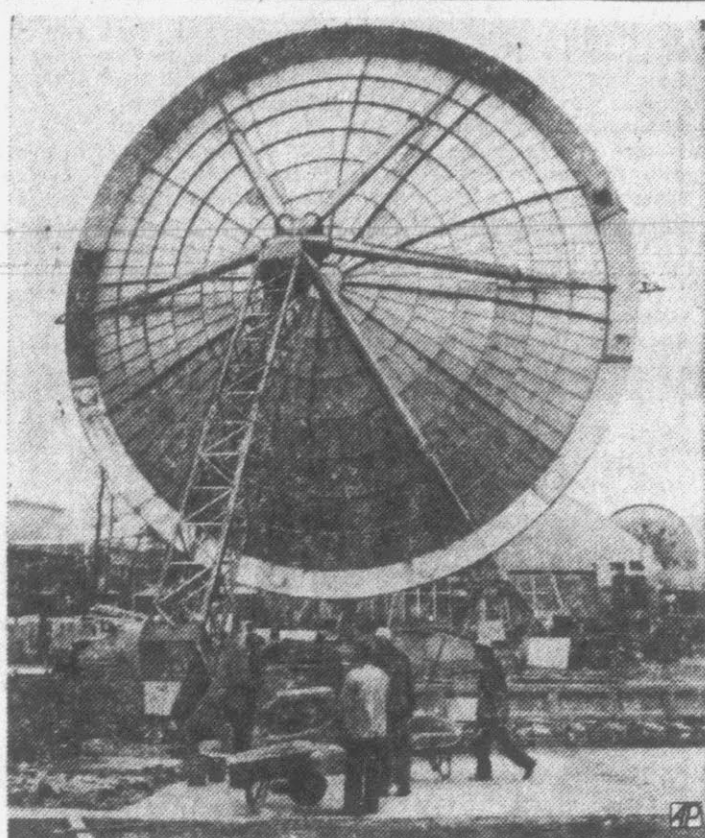
Under a resolution passed by county commissioners March 7, the justices will be appointed and paid a salary instead of being elected and collecting fees.

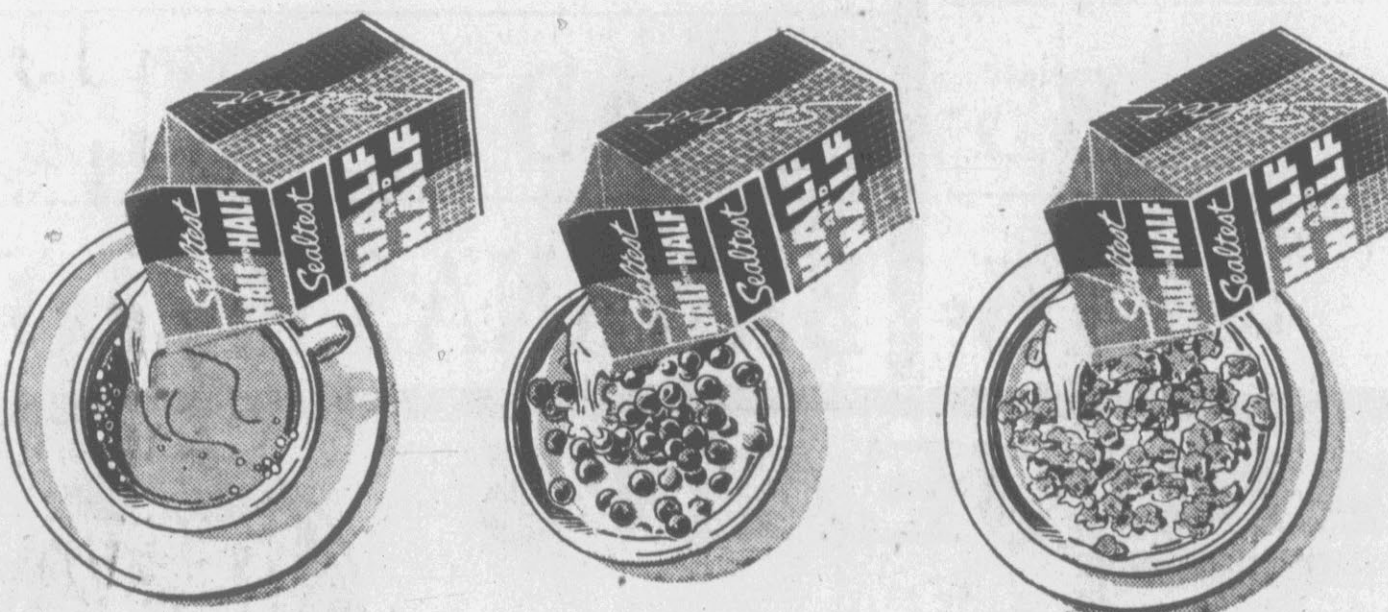

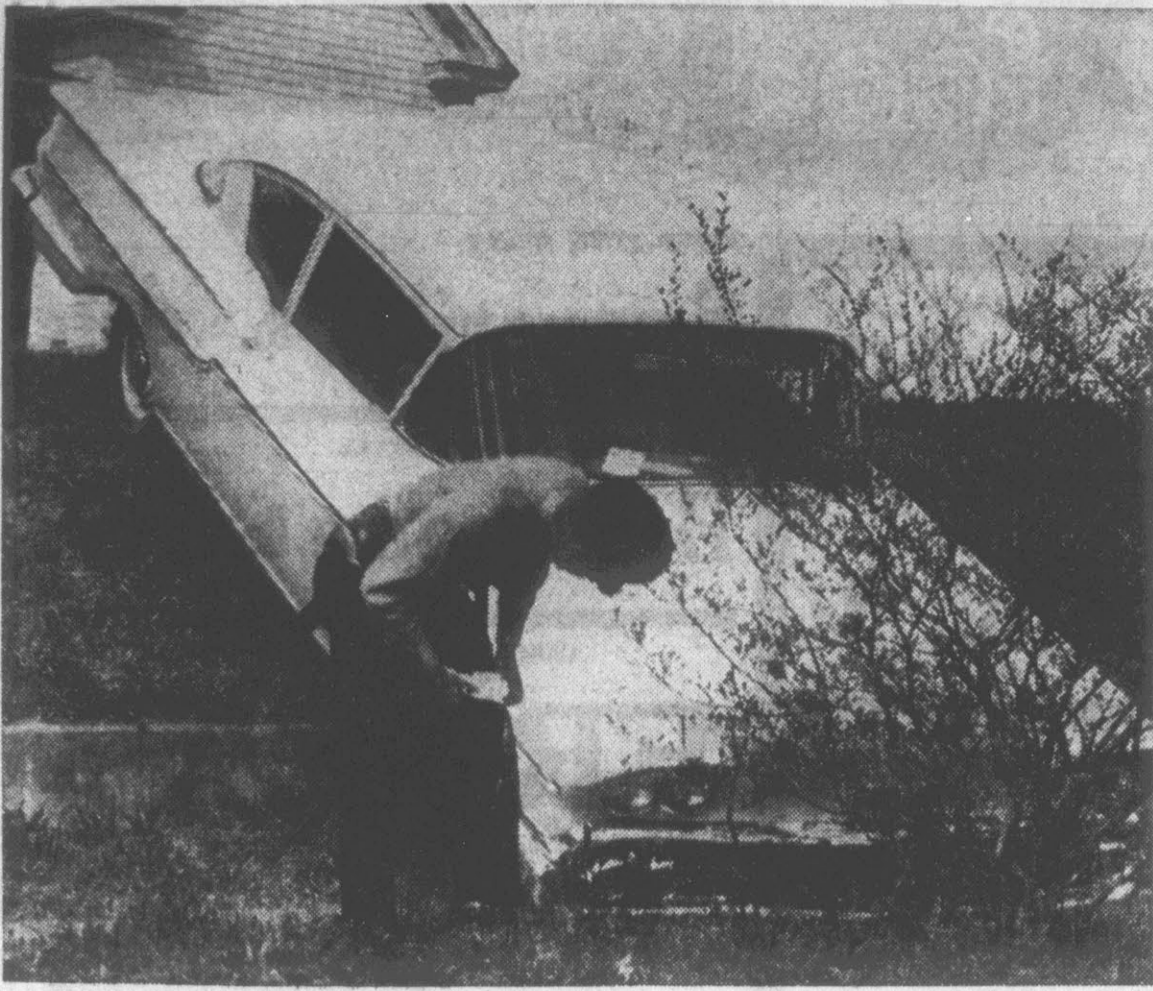

Kennedy Tackles Religious Issue In Political Day

HUNTINGTON, W. Va. (AP)— Sen. John F. Kennedy (D-Mass.) left West Virginia today after some "gloves off" campaigning against those who would make his Roman Catholic religion a factor in the state's May 10 presidential primary.

In his latest swipe Wednesday night, he said he would be "just as free to carry out the duties (of president) as anyone in West Virginia," a heavily Protestant state.

Kennedy concluded his three-day swing with a day-long whistle-stop tour across southern West Virginia, where Catholics are few among the miners and factory workers.

His bus tour included towns along the way from Beckley to Huntington, many of which are located in the depressed coal fields.

At every stop, he took the initiative in bringing up the religious issue, insisting his faith would not hamper him in living up to the president's oath of office.

He also hammered away at the state's unemployment problems and depressed economic conditions, which he said resulted from "eight years of indifference and lack of faith" by the Eisenhower administration.

At a final reception Wednesday night, Kennedy replied to criticism of the Democratic campaign leveled by Harold E. Neely, a candidate for the Republican nomination for governor.

Neely said the two senators are making West Virginia appear to be a state of "poverty-stricken indigents and religious fanatics." "I can assure you of one thing," Kennedy said. "The next president of the United States is going to know about the problems of West Virginia."

Food Situation Discussed

The Pitt County Health Department, with the cooperation of the Negro Farm and Home Demonstration offices and PTA groups, have sponsored programs in two Negro county schools this week in an effort to show farm families how they can help improve their food situation.

Spokesmen for the health department said they have been concerned over the lack of food available to Negro farm families in the county this year and attribute an increase in respiratory diseases and other ailments this year partly to improper or insufficient food.

They pointed out that by not eating the right kind of food or not having enough food breaks down the body's resistance to diseases. A program, held at the Had-

docks Crossroads School Tuesday night and at the Simpson School last night, were both part of a program designed to help the farmers help themselves.

The programs first showed the people the importance of a balanced diet and told what foods were essential, then went on to show the group how they could raise the needed food in their own garden at less cost.

In addition to showing the group how to plant a garden, members of the panel which conducted the meeting told how chickens and hogs could be raised and compared the cost of raising the products to the cost of buying them in a store.

The group was also told how they could can and freeze the food so it would be available next win-

ter. Door prizes were given at both meetings and consisted of chickens, garden seed and other things that could be used in preparing and raising food.

Those taking part in the programs included Mrs. Louise Shafer, Pitt County Public Health Nurse II; Mrs. Joanne Suggs, Nutritionist with the North Carolina State Board of Health; Mrs. Amelia Capehart, Negro Home Demonstration Agent in Pitt County; and James Goode, Pitt Negro Farm Agent.

Truman declined to comment on Tracy's performance, except to say:

"It was a wonderful show. I enjoyed it immensely. Everyone was fine."

Truman invited stars Melvyn Douglas, Frank Lovejoy, Tracy and the rest of the cast to visit the Truman Memorial Library at Independence, Mo. He said he would personally conduct them "on the special \$2 tour—for nothing."

Rockefeller Agrees Lack Of GOP Rivalry Hurts

WELLSBORO, Pa. (AP)—New York's Gov. Nelson A. Rockefeller agrees with Pennsylvania political leaders that lack of contention for the GOP presidential nomination is costing the party voter interest.

He told newsmen in the northern Pennsylvania community Wednesday that from the standpoint of interest it would have been better for the party if he had sought the nomination in opposition to Vice President Richard M. Nixon.

But he promptly added he is "standing four-square" on his Dec. 26 decision not to seek the nomination. He did not elaborate. Rockefeller came to Pennsylvania to support the candidacy of his Dartmouth College roommate Herman T. Schneebeli for Congress. Schneebeli is seeking the 17th District seat left vacant by the death last December of Rep. Alvin R. Bush, a longtime GOP leader.

Schneebeli, 51-year-old auto dealer, is opposed by Dean R. Fisher, 36, a Democrat. Both are from Williamsport. Rockefeller insisted that his appearance to aid Schneebeli's campaign in no way marked any effort on his part for Republican convention support. He also issued a flat "no chance" when asked about the possibility he would be a vice presidential candidate. The New York governor ex-

plained he is not interested in the branch. He noted that the vice president's principal duty is pre-ference in government has al-ways been in the executive legislative arm of governmen-

Carlos Montoya is a completely fantastic performer. How one man with but two hands of five fingers each plus a guitar with a mere six strings can produce such a variety of sounds is almost unbelievable. The right hand which is basically the plucking hand, evidenced some of the most dextrous finger-work conceivable. Not only did it pluck and strum in conventional fashion but in an endless variety of styles, producing every kind of a tone from a sharp pointed pizzicato to a rich singing one. But even more astonishing to me was his left hand which not only effected the pitch changes, but did its share of the soft bell-toned plucking. The agility of this hand was particularly startling during the many scale and arpeggio passages he executed with such precision. At times, one hand or the other, or a combination of both would produce sounds which were basically percussive and rhythmic, with only the vaguest pitch relationship.

There was of course a degree of sameness about the program, for after all it was all of the Flamenco variety (the same as if a pianist had played a whole program of French Clavecin music). Yet it was worth noting the subtle, but nonetheless evident, variety of styles achieved with the one general category. Perhaps the most unique number of the program was the one called "Saeta", composition in march style, with the drum sounds so cleverly done. The melodic line played singly and sometimes in octaves often sounded not unlike the harpsichord under the artist's deft fingers.

There is no question about it, Mr. Montoya is truly an artist in his own right. The audience seemed to sense this, too, for he held the large assemblage at complete and rapt attention throughout the program. This in itself was surprising, for it was not the kind of program which one would expect to offer general appeal. Yet the audience recognized the performer's artistry and his sure-fingered command of the instrument, and listened accordingly.

He has to co-sign all checks, check the records of each department, prepare a budget estimate for the Board of Commissioners, and look after all investments of county funds and see that the

budget is properly administered. Praising his four office workers, Gray said they are a "good efficient staff. . . hard workers who do not mind working. It is a pleasure working with them."

Married to the former Helen Barnhill of Greenville, he has two children, a boy seven and a girl four.

A member of the Moose and Lions clubs, Gray is a Mason and is currently president of the North Carolina Association of County Accountants. Most of the spare time is devoted to gardening but he also likes to fish and hunt.

Chester Bowles Selected Head Platform - Writing

LOS ANGELES (AP) — New England's Chester Bowles' selection as platform committee chairman at the Democratic National Convention was viewed today as a move to nail a strong civil rights plank into the party's 1960 platform.

Bowles, a longtime leader of the party's liberal wing, was named Wednesday to head the important job of overseeing what issues the Democrats will stress in the fall campaign.

Civil rights also cast its shadow on the credentials committee, which decides which delegates shall be seated at the convention in Los Angeles next July.

Named chairman for the third straight convention was Utah's Calvin W. Rawlings, a tireless party worker with a reputation for talking opposing factions into agreement.

Selected for the newly-created post of co-chairman was Camille F. Gravel, a moderate Southerner whose liberal views on civil rights have made him a favorite target of the segregationist element in his native Louisiana.

Gravel has said he feels segregation is morally wrong, but that it would be socially and economically disastrous to impose integration on the South by force at this time.

Democratic National Chairman Paul Butler announced the appointments at a press conference. "I would be less than fair if I said civil rights wouldn't be the major problem at the convention," he said. "I am hopeful that the delegates will find a substantial area of agreement on this and other problems without resorting to indignity and indecency."

Democratic presidential hopefuls hailed the appointment of Bowles, congressman and ex-governor of Connecticut and former ambassador to India.

Massachusetts' John F. Kennedy, campaigning in West Virginia, said he feels Bowles—who is Kennedy's foreign policy advisor—will clarify the party's position on civil rights. Kennedy said Bowles' selection means the party's civil rights platform "will be more effective."

Minnesota's Hubert H. Humphrey and Missouri's Stuart Symington, in Washington, also approved appointment of Bowles.

Humphrey said, "A splendid choice" and added, "Bowles knows the issues."

"I think he is a fine choice," said Symington.

Humphrey and Symington advocate strong civil rights laws.

The convention's arrangements committee also named House Speaker Sam Rayburn, longtime chairman of Democratic conventions, honorary chairman; Rep. Clarence Cannon of Missouri parliamentarian; and Phillip B. Pearlman of Maryland vice chairman of the platform committee.

A series of four programs to be presented by the department of music in the McGinnis auditorium will begin with a concerto program by talented students of music and the East Carolina Orchestra May 8 at 3 p.m. Piano recitals by Emily Vinson of Ayrville May 9, Larry Griffin of Burlington May 10, and Joseph Purcell of Raleigh May 11 are all scheduled for 8 p.m.

The East Carolina Concert Band, in a program May 12 at 8 p.m. in the Wright auditorium, will feature the premiere performance of an original work by James Parnell of the college music department. Other selections will emphasize the familiar and the popular in band music.

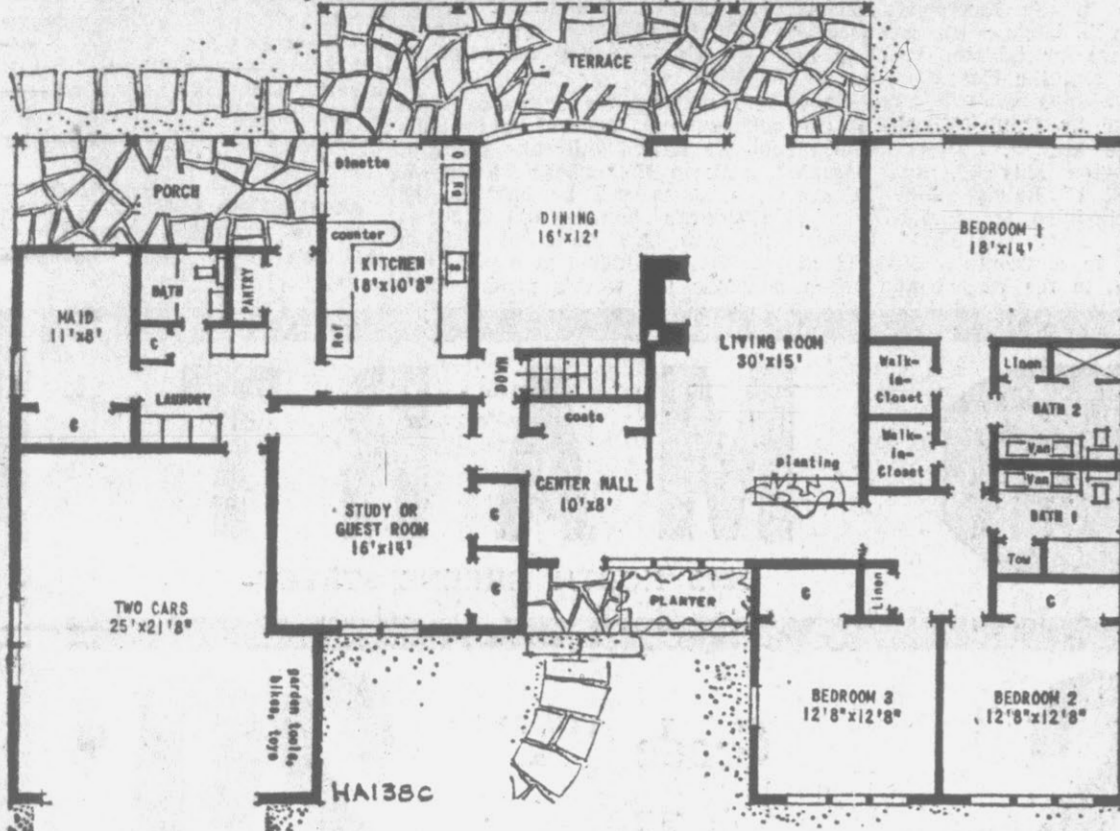
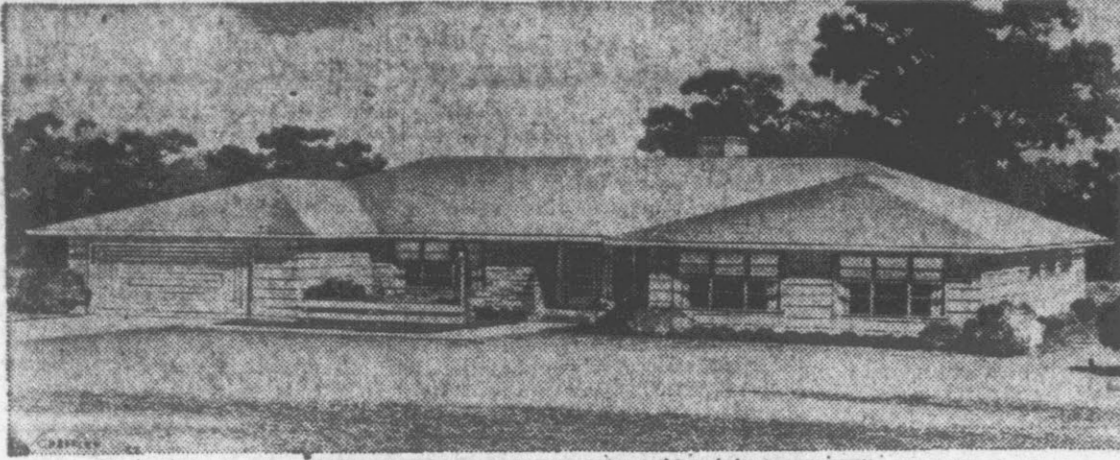

ON THE HOUSE

There may be times when you feel that home builders give you pretty much what they want in new houses. But the truth is that discussions, conferences and conventions are going on all the time in an effort to discover what will please you, the potential buyer.

This search for an accurate picture of your housing desires is, of course, based on sound business principles. If the builders give you what you want, within practical reason, you will be more inclined to put your money on the line.

In looking over various building publications, most of which do not reach the general public, it is interesting to learn some of the facts uncovered and discussed at these national, regional, state and local sessions.

The builders, for instance, have figured out that, on the average, a family wishing to buy a new house looks at 14 model houses before it makes a selection. Hence the constant competitive necessity to make certain that the model house is shown at its best, which explains why so much care is given to the furnishings.

No matter how many modern conveniences a house has, no matter how well it is constructed, and no matter what its price, it always presents a better appearance when it is furnished. The buyer may not be able to afford the kind of furnishings on display, but at least he gets a clearer idea of what effects can be achieved within the structural limits of the house.

The buyer appears to be getting increasingly interested in the matter of privacy. He is paying more attention these days to such things as fences, separate bedrooms for each child, two bathrooms and, in some cases,

living rooms that are on the side and rear of the house. Every so often a builder finds that a house otherwise acceptable is being turned down because it has a living room, with a picture window, at the front of the house.

One thing remains constant in any surveys of the needs of prospective purchasers of new homes: the insistence on plenty of closets. People not only want more closets, they want them larger. This is true even when the houses have attics and basements where there is considerable additional storage space. The closets are needed for everyday use without the necessity of climbing stairs.

Perhaps you'll be interested in knowing what one building association president considers a poor salesman. He's a fellow who fails to point up the size of the room, the size of the plot, the location of shopping areas, and the nearness to schools and houses of worship. He's also the fellow who doesn't know how much it will cost to heat the house or the cost of transportation. In fact, says this gentleman, such a salesman isn't a salesman at all. He's just an order-taker.

Switch To Daylight Saving Slated Sunday Morning

About 50 per cent of the nation's timepieces will be pushed ahead one hour at 2 a.m. Sunday with the annual switch to Daylight Saving Time promising to stir up no less confusion than it has in past years.

Most of the estimated 91 million Americans who will avail themselves of an extra hour of daylight through the summer will return to Standard Time at the end of October.

Some areas, however, will turn their clocks back near the end of September, while at least a couple plan to remain on Daylight Time for the balance of the year.

The nation's two newest states—Hawaii and Alaska—will continue on Standard Time through the summer.

The knotty problems arise for those thousands of persons who reside in one area of a state which observes a different time than a nearby area where they work or attend school.

Residents of Texas, Kansas, Colorado, New Mexico, Arizona, Utah and Oklahoma need not worry about any time mixups because those states operate on Standard

Time the year round. But even in these states, it's doubtful that many persons will go untouched by the time change if they watch television, make long distance telephone calls or travel extensively.

The eastern two-fifths of Indiana, including Indianapolis and Fort Wayne, will face no problems with the advent of D.S.T. Residents there observed Daylight Time all winter by unofficial agreement contrary to state law.

Central Kentucky residents were on Central Daylight Saving Time year-round for several years, until a recent Interstate Commerce Commission order put the area in the Eastern Standard Time zone.

This left the clocks the same as on Central Daylight Saving Time. Among those states where plans call for an incomplete swing to Daylight Time by local option are Ohio, Virginia, Pennsylvania, Iowa, West Virginia and Missouri.

All of Florida, except Eglin Air Force Base will remain on Standard Time. Washington and Oregon will continue to observe mandatory Standard

Time. Among the states where Daylight Saving Time will be observed without exception are California, Wisconsin, Minnesota, New Hampshire, Vermont, Massachusetts, Maine, Illinois, New Jersey, and Rhode Island, Washington, D.C. also will operate on Daylight Time.

A recent survey by a national watch manufacturing firm showed that the percentage of communities switching to Daylight Time rose from 37 per cent in 1948 to 50.7 this year.
