Sanford Ready If Run-Off Is Called

RALEIGH (AP)—The big question for today: Will there be a state-wide runoff primary June 25?

Terry Sanford, Fayetteville attorney generally conceded to be the front runner during the campaign for the Democratic nomination for governor, pled up a big vote in Saturday's record-breaking Democratic primary. But he couldn't close the door on Dr. I. Beverly Lake, whose major campaign pledge was to fight integration—even North Carolina's token variety—with every weapon at the governor's command.

Sanford said that on Saturday night he had asked his county managers to start working on the assumption that there will be a runoff.

State law says a runoff may be requested and get a second primary when no majority exists in the first primary. Lake has until June 13 to make a formal request.

With only a few small precincts unreported the unofficial tally in the four-way governor primary gave Sanford 257,936 to Lake's 175,110. Former Atty. Gen. Malcolm Seawell polled 99,540 and Democratic national committee man John Larkins had 98,028.

Larkins and Seawell, like Sanford, urged continuing the state's approach to limited desegregation.

Sanford got 41 per cent of the vote, and Lake 27 1/2 per cent.

Lake's big problem is this: Should Sanford be able to hold his first primary support and if the voters turn out June 25 in such vast numbers, Lake would have to take at least 72 per cent of the Seawell-Larkins vote to beat Sanford.

Should Lake decide to try it, North Carolinians doubtless will be subjected to one of the most vigorous campaigns since 1960.

U.S. Sen. B. Everett Jordan, whom Gov. Hodges appointed two years ago following Kerr Scott's death, was nominated to a full six-year term. Unofficial returns gave Jordan 311,958 to 191,523 for his chief rival in the four-way race, Wilmington attorney Addison Hewlett.

A record primary vote of more than 630,000 was cast.

Although trailing Sanford by more than 80,000 votes, Lake's first reaction was to call for a second primary June 25, but this was subject to a second hard look at the returns.

Lake called his campaign leaders into conference in Raleigh Sunday afternoon and then scheduled a news conference late this afternoon, probably to make known his decision.

State Sen. C. V. Henkel also was studying returns to see if he wants another chance to overtake State Rep. H. Cloyd Philpott in the race for the Democratic nomination for lieutenant governor.

Henkel nixed out David McConnell, Charlotte attorney, for second place and a chance for a runoff. Henkel was almost 60,000 votes behind Philpott. Henkel indicated Lake's decision may have a bearing on his own.

A runoff appeared definite for the Third District congressional nomination and another is possible in the Twelfth District.

Three incumbent congressmen, Herbert Bonner, Ralph J. Scott and Hugh Q. Alexander, won handily.

U.S. Sen. B. Everett Jordan won renomination in a runaway from State House Speaker Addison Hewlett, 311,958 to 191,523. Two political unknowns trailed far behind.

In the three-way race for lieutenant governor, Philpott polled 230,703, Henkel 173,123 and McConnell 163,242. The winner of this race will face David Bailey of Graham, who won the Republican nomination in a three-man contest, in the general election.

Insurance Commissioner Charles F. Gold and Associate Justice Clifton L. Moore of the State Supreme Court both won Democratic nominations easily. Gold's general election opponent apparently will be J. E. Cameron of Kinston, who was in front in the race for the Republican nomination.

A total of 12,513 Pitt County voters went to the polls Saturday.

Beverly Lake polled 5,328 votes and carried 14 of Pitt's precincts to lead the county's gubernatorial voting while state-wide leader Terry Sanford garnered 4,727 with winning totals in 11 precincts. Malcolm Seawell and John Larkins failed to carry any of the county's precincts but tallied 555 and 1,891 votes, respectively.

In the major Pitt race, pitting Sen. Robert Lee Humber against Robert D. Wheeler of Gritton,

Humber carried 17 of the county's 25 precincts to win renomination by 1,600 votes. Bruce Strickland of Arthur defeated Stencil Dilda of Fountain by more than 2 to 1 in the race for the Pitt District III county commission seat.

Sanford topped six of Greenville's eight precincts along with Ayden and Gritton. Lake carried Bethel, Farmville, Grimesland, Grimesland No. 1, and all three Chicod precincts.

Strickland succeeded Woodrow Wooten of Falkland as the third district's commission representative nominee by carrying 21 of

the county's precincts. Dilda topped boxes in Farmville, Fountain, Falkland, and Winterville.

The Arthur farmer polled a total 7,608 in the county compared with 3,782 for Dilda.

Sen. Humber out-pointed Wheeler by 6,887 to 5,292. The Greenville resident carried each Greenville precinct with the exception of Greenville No. 5 which Wheeler took by 21 votes. Wheeler was out front in Carolina, Chicod No. 2, Grimesland No. 2, Gritton, Swift Creek, and Bethel. Winterville cast 403 votes for each candidate.

Constables

In four constable races, three

incumbents retained their positions as township nominees.

In Ayden, Joel Wingate defeated challenger W. S. Hamilton by an overwhelming vote, 920 to 208. Joe E. Joyner collected a 5 to 1 majority over Mack Bunting for his renomination as Greenville Township's nominee for constable. Joyner carried every precinct by wide margins to pile up 3,799 ballots compared with 751 for Bunting.

In a much closer constable race in Pactolus Township, Clarence Harris Jr. grabbed a slight majority to succeed himself as that township's constable. Harris polled 184 votes as compared with 117 for Johnny Lee Brown and 59 for Marvin L. Bullock.

S. Elijah Heath polled 229 votes in the Grimesland Township constable race to win the first pri-

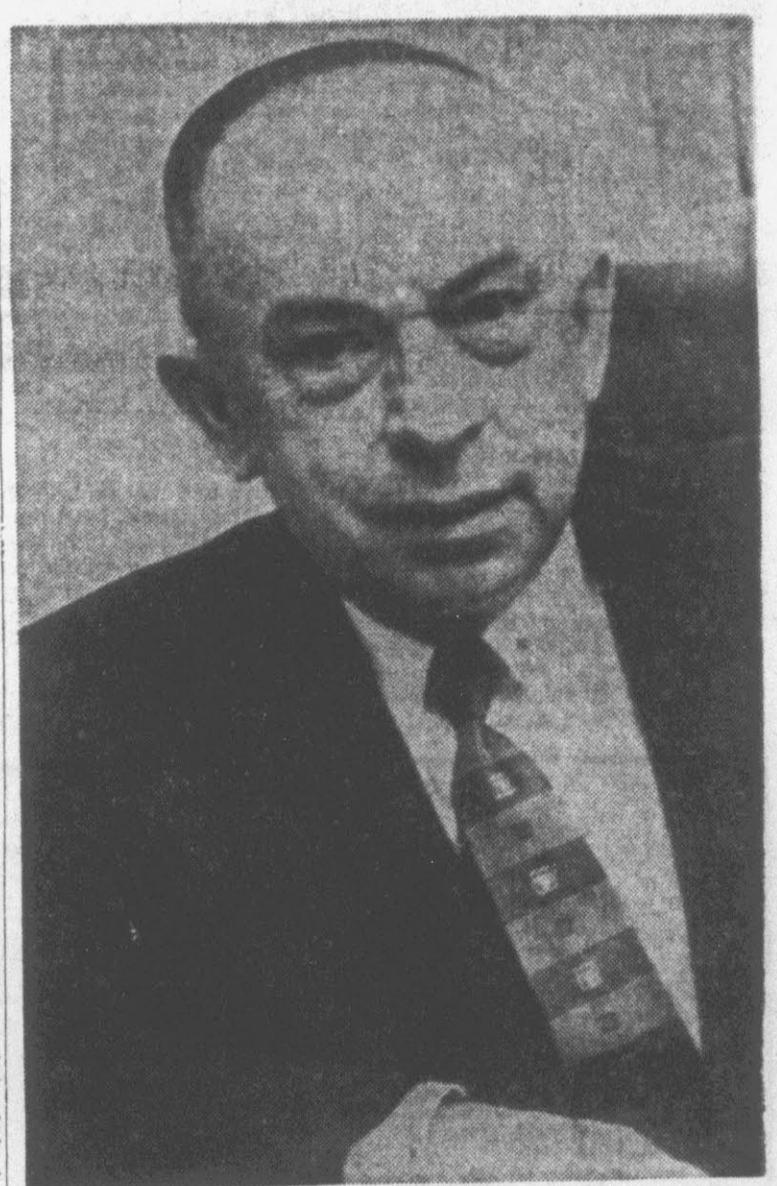

The county's 25 precincts gave Jones 7,324 votes to Bonner's 5,223.

The brightest spot of all for the Jones forces was their candidate's own box in Farmville. There Jones received 1,526 votes compared to Bonner's 139.

However Bonner was able to carry ten of Pitt County's 25 boxes. The Bonner boxes were: Car-

olina, Chicod 1, Chicod 2, Chicod 3, Falkland, Gritton, Grimesland 1, Pactolus, Swift Creek and Winterville.

Over the district Jones could claim only two counties besides Pitt. They were Chowan where Jones received 985 votes to Bonner's 797 and Perquimans where the Jones vote was 1,014 to Bonner's 759.

Bonner's home county, Beaufort, went heavily in his favor giving him 4,744 votes to Jones' 1,405. Two Beaufort County boxes went in Jones' favor, however. They were Gilliard which gave Jones 31 and Bonner 14 and Woodards Pond where Jones received 42 to Bonner's 29.

Bonner's voting box at Washington Park gave the congressman 494 votes to Jones' 127.

This primary was the third time Bonner had been challenged during his 20 years in Congress. Both times previously it was Pitt County men who had tried to unseat him. Bonner defeated Marvin K. Blount in 1942 and Robert Lee Humber in 1946. Both are Greenville men.

Warehouses In Mebane Burned

MEBANE, N. C. (AP)—Two tobacco warehouses were destroyed by fire here early today. The fire for a time threatened the entire business section.

The blaze finally was brought under control by Mebane Volunteer Firemen and firemen and equipment from at least nine other nearby towns.

Policeman James McLeod said he discovered the fire shortly after 2 a.m. He said it started in the Piedmont Warehouse.

"I thought the whole town was on fire," McLeod said.

Planters warehouse started burning. Both were destroyed. The Farmers Seed Service, adjacent to Piedmont Warehouse, was gutted and several other buildings were damaged.

Planters Warehouse was being used for storage by a mattress manufacturing company. What was stored in the Piedmont Warehouse was not learned.

The fire knocked out power lines in this Alamance County town of 2,500, and the community was without electricity for a time. Emergency generators were brought in to restore service.

Local 4-H Girl May Be Scholarship Winner

RALEIGH—A local 4-H Club girl who really knows her way around the home may be the luck winner of a \$400 Montgomery Ward college scholarship this year.

The young homemaker must be enrolled in the 4-H Home Economics program, have satisfactorily completed at least three years of club work, and be over 14 years old before she can compete for this honor.

Work in the home economics project includes cooking, food preservation, sewing, meal planning, housekeeping, buying and budgets. Developing exhibits, displays and demonstrations are among the stated objectives of this genuinely useful project directed by the N. C. Agricultural Extension Service.

Last year, Jane Blakely, daughter of Mr. and Mrs. Stewart Blakely of Ellerbe, won the trip to Chicago as state winner in the home economics program. Jane had been in 4-H for six years and had completed 49 projects. She was county champion in dairy foods for four years and presented 57 dairy foods demonstrations. She also participated in the Richmond County 4-H dress revue for five years.

The national judging is done on the member's 4-H record book which is compiled during her club career. The comprehensive report contains not only highlights of the home economics projects and other 4-H achievement, but also evidence of leadership, community service, scholastic standing, and personal recommendations from 4-H Club leaders.

Work qualifications are high and competition keen since only 50 states and Puerto Rico where 4-H Clubs are well established. Besides the scholarships, a trip to the National 4-H Club Congress in Chicago is waiting for the highest ranking member in the state.

Seeds planted years ago came into harvest recently. Miss Ruth Current, who was home agent in Iredell, but is now assistant director of the N. C. Agricultural Extension Service, taught clothing construction, thrift, and fashion consciousness to Mrs. Fred Miller, who was a Tomato Club girl in Iredell County.

In 1950 the home agent helped Mrs. Miller with plans for a Fabric Shop. Her past experiences helped her in developing her business. Mrs. Nancy Myers, home economics agent, says Mrs. Miller now employs several Home Demonstration members in her shop.

Landscaping Project Although the landscaping is not perfect yet, the Gordova Elementary School yard has come a long way since the 4-H clubs took landscaping as a project three years ago. Grass is growing on the previously barren front yard. The shrubbery is neatly trimmed since the 4-Hers learned to prune shrubbery in 1959.

Mrs. Martha B. Adams, assistant home economics agent in Richmond County, says the school children are proud of their work and are careful to walk only on the walks so the grass will continue to grow.

Northampton Dress Revue Ranging in style from tot's playwear to adult church wear, 79 entries were judged in the Northampton County Home Demonstration dress revue. This year the program was held at night as a family event and nearly 300 persons attended.

Miss Carol Winston, home economics agent, reports that all of

Mrs. Linwood Ward's family participated in the revue including her husband. The theme of the revue was "A Hat Full of Fashions."

Use of Miniature Furniture Neighbors of Mrs. Thurman DeBruhl, Trenton, R. I., may think she is playing doll house again if they walk in and see her living room floor covered with a scale board and small house furniture. Keep Important Papers In Safe Deposit Box

RALEIGH—Ever find yourself needing a sales slip, cancelled check or other record you have failed to keep.

Miss Mamie Whisnant, home management specialist for the N. C. Agricultural Extension Service, says that families should provide for permanent keeping of the following: the marriage certificate, birth certificates, investment records, wills, real estate deeds and papers, military service records, and other valuable papers. These papers may be kept in a safe deposit box.

An inventory of farm and household goods should be kept on a temporary basis. Cancelled checks should be kept for about five years for the purpose of income tax deductions. Also keep checks for insurance, payment of debt, and any checks which you might need to confirm a date of purchase or price paid for such things as home equipment or furnishings.

Miss Whisnant says that families would profit by planning a place where everyone can put receipts or spending records before they are recorded. It may be a spindle or box, on a table, on a shelf, in a drawer, or a hook on the wall. It is always wise to keep deposit slips until they appear on the bank statement and to keep sales slips until the product has proved satisfactory or outlives its guarantee.

"Keep your record book up to date," says Miss Whisnant. "Plan a regular time to enter records daily or weekly. Don't let them go too long. Do not become discouraged and quit until you've really given accounts a fair try."

Flood Toll

MANILA (AP)—The toll from weekend flash floods reached 166 dead and 90 missing today as the waters receded in Manila's sprawling metropolitan area, uncovering bodies in the mud and silt.

Navy frogmen explored still swollen streams in search of victims of the torrents of water Saturday which followed heavy southwest monsoon rains pulled into the capital area by Pacific storm Lucille.

Mass graves were dug in squatter areas along river beds where the floods swept away hundreds of flimsy shacks. Most of the dead were children or old people trapped in the shacks and shanties. Others were electrocuted by wires ripped loose by the monsoon's wind and rain.

About 5,000 persons were left homeless, the Defense Department said. An official said property losses had reached two million dollars and were still climbing.

The Weather Bureau reported a new tropical storm 420 miles east of the northern tip of Luzon Island.

Shot Threatening Father In Back

ALAMO, Tenn. (AP)—A 13-year-old girl killed her father with a 22 rifle when he threatened her mother with a hammer, said Sheriff J. W. McCoy.

James K. Parker, 23, a farmer, was shot in the back Sunday. McCoy said no charges were placed against the girl, Peggy Parker, pending investigation.

Mrs. Parker told officers her husband had threatened to kill her. McCoy said the girl told him she snatched up the rifle and pulled the trigger, then ran out of the house with her mother.

Candidate Irked By Stop Signs

MEMPHIS, Tenn. (AP)—Sheriff M. A. Hinds, up for re-election, says the wise guys converting stop signs into "Stop Hinds" signs had better cease or they will face charges.

The sheriff spent part of Sunday afternoon peeling his campaign stickers off stop signs along several major streets.

The stickers have "Hinds" printed on them in glowing orange letters. They are supposed to be glued onto auto bumpers, but many have been wadding up under the "stop" on the traffic signs.

Defeated in Democratic primary fights were incumbent representatives R. Bruce Eicheridge of Dare, Carroll R. Holmes of Perquimans, Frank Everett of Martin, Phil Whitley of Wake, Marcellus Buchanan of Jackson, Tom Herbert of Clay, Charles R. Crawford of Swain, J. Tolliver Davis of Rutherford, Fred Hoscombe of Madison, Willis Murphrey of Halifax and Carl Venters of Onslow.

The toll was the result of Democratic primary fights for 71 House seats. There were 23 Democratic campaigns for State Senate posts. Republicans contended for nominations for two House and two Senate seats.

Also President Harold Yochum of Capital (Ohio) University speaks at Lenoir Rhyne to 187 seniors, Chairman L. T. McLendon of the Board of Higher Education at Pembroke to 60, Edwin L. Jones of Charlotte at Pfeiffer to 132; Woman's College Chancellor Gordon Blackwell at Queens to 89, and UNESCO official Dr. Matta Akrawi at Meredith to 128.

Rev. King Still Faces Indictment

MONTGOMERY, Ala. (AP)—A Negro integration leader was free today of a perjury charge in connection with his 1956 Alabama income tax returns but still faced an indictment involving a similar charge on his 1955 returns.

Circuit Solicitor William F. Theiford, who prosecuted the case against the Rev. Martin Luther King Jr., declined to say what disposition would be made of the second indictment.

King was acquitted Saturday by a jury of white men in the city where he led a successful Negro bus boycott several years ago. Atty. Gen. MacDonald Gallion said the verdict "shows without question that even Martin Luther King Jr. can get a fair trial in Alabama."

King now is associate pastor of the Ebenezer Baptist church in Atlanta. He told the congregation Sunday he was grateful to the white jurors who acquitted him. The Rev. W. J. Powell, vice president of the Montgomery Improvement Assn. formerly headed by King, termed the verdict "one of the finest things that could have happened to our community."

Brief Talk For Commencement

NASHVILLE, Tenn. (AP)—Chancellor Harvie Branscomb delivered what may have been the shortest Commencement address in the history of Vanderbilt University.

Branscomb spoke less than five minutes Sunday, then quit, saying, "This occasion is dedicated to the graduates. This evening belongs to them."

Degrees were conferred on 896 graduates.

Kennedy Strengthens His Unofficial Convention Lead With 'Reserves'

WASHINGTON (AP)—Sen. John F. Kennedy (D-Mass.) apparently has backed up his unofficial lead in first-ballot convention votes with gains in reserve strength for later ballots.

The last week of political developments made only minor changes in the first-ballot strength of the major aspirants for the Democratic presidential nomination. Kennedy held his lead with an unofficial count of 334 1/2 votes on the first tally of the 761 required for nomination.

But Kennedy appeared today to have fair to good support on future ballots among the favorite, son and large uncommitted delegations. Such reserve strength is essential to victory in a multiple race.

Associated Press polls over the weekend showed Kennedy far in the lead for Iowa's 26 convention votes after a courtesy vote or two for Gov. Herschel C. Loveless, the favorite son.

Kennedy also reversed a previous poll and gained a margin over Sen. Stuart Symington of Missouri in second-choice votes in the 21-vote Kansas delegation, now pledged to Gov. George Doering on the first ballot.

The Massachusetts senator also has shown reserve strength in the favorite-son states of Michigan, New Jersey and California, and

the big 114-vote uncommitted New York delegation yet to be named. But he appears to be running behind Sen. Lyndon B. Johnson of Texas for second-choice support in Florida, where Sen. George Smathers (D-Fla.) has 29 votes sewed up on the opening ballot.

Last week brought the unofficial first-ballot vote standings to read: Kennedy 334 1/2, Johnson 116 1/2, Symington 62 1/2, Sen. Hubert H. Humphrey of Minnesota 51 1/2, Adlai E. Stevenson 18, others 17 1/2, and uncommitted 32 1/2, for a total of 1,084 votes out of a convention total of 1,521.

Here briefly is the outlook in favorite son and uncommitted states for future ballots if a bandwagon move fails to declare a winner with one call of the roll:

New York (114 votes) — The delegation, yet to be named, will be uncommitted. Carmine G. DeSapio, Tammany Hall leader and national committeeman, said May 15 that Kennedy has "substantial support" in the delegation and that substantial means more than a majority.

Illinois (69) — Mayor Richard J. Daley of Chicago will control the bulk of this uncommitted delegation. He has been reported leaning toward Kennedy.

California (81) — The delegation to be elected June 7 will be pledged to Gov. Edmund G. Brown on the first ballot. Brown is uncommitted so far on his choice, but said Sunday that Kennedy and Stevenson are close rivals for public support among California Democrats.

Pennsylvania (81) — Delegation uncommitted and Gov. David Lawrence so far is neutral. Kennedy leads in a first-ballot poll with 17 1/2 votes with a few scattered for Stevenson, Symington and Lawrence.

Michigan (51) — Delegation is committed to favorite-son Gov. G. Mennen Williams until released by him. A poll on second choices showed: Kennedy 10, Stevenson 4, Symington 3, Rep. Chester Bowles of Connecticut 1, uncommitted 33.

Iowa (26) — Delegation named Saturday was instructed for Gov. Loveless, favorite son, but a second-choice poll gave: Kennedy 18 1/2, Symington 3 1/2, Stevenson 1, uncommitted 3.

Kansas (21) — Pledged to Gov. Doering. A new poll showed these second-choice results: Kennedy 7 1/2, Symington 5, Johnson 1 1/2, uncommitted 7.

New Jersey (41) — Delegation pledged to favorite-son Gov. Robert B. Meyner on the first ballot. A partial poll for second choices showed: Kennedy 8, Meyner 3, Symington 1 1/2, rest undecided.

Florida (29) — Delegation pledged to Sen. Smathers, favorite son, on first ballot. Smathers says delegation thereafter would move to Johnson, with Kennedy and Symington also coming in for some votes.

Visitors Gawk At Capitol Work

WASHINGTON (AP) — Probably the most gawked-at workmen in the country right now are those fixing up the U.S. Capitol.

Swarms of visitors—around 18,000 a day—come to see the Capitol sights and stay to become sidewalk superintendents of a fascinating construction job.

The tricky task of hoisting and setting the 18-ton marble columns adorning the front of the Capitol holds an audience far more rapt than do the congressmen inside.

The tiny figures of painters spreadeagled on the lofty dome catch the eye quicker than the time-stained statue of Freedom standing serenely above them.

Do these craftsmen feel the tug of tradition, the glow of pride? "Nuts," growls a burly painter, wiping sweat and paint from his face after a day on the sunbaked dome. "This is the louiest job I ever had."

"The crummiest," agrees a paint-spattered colleague.

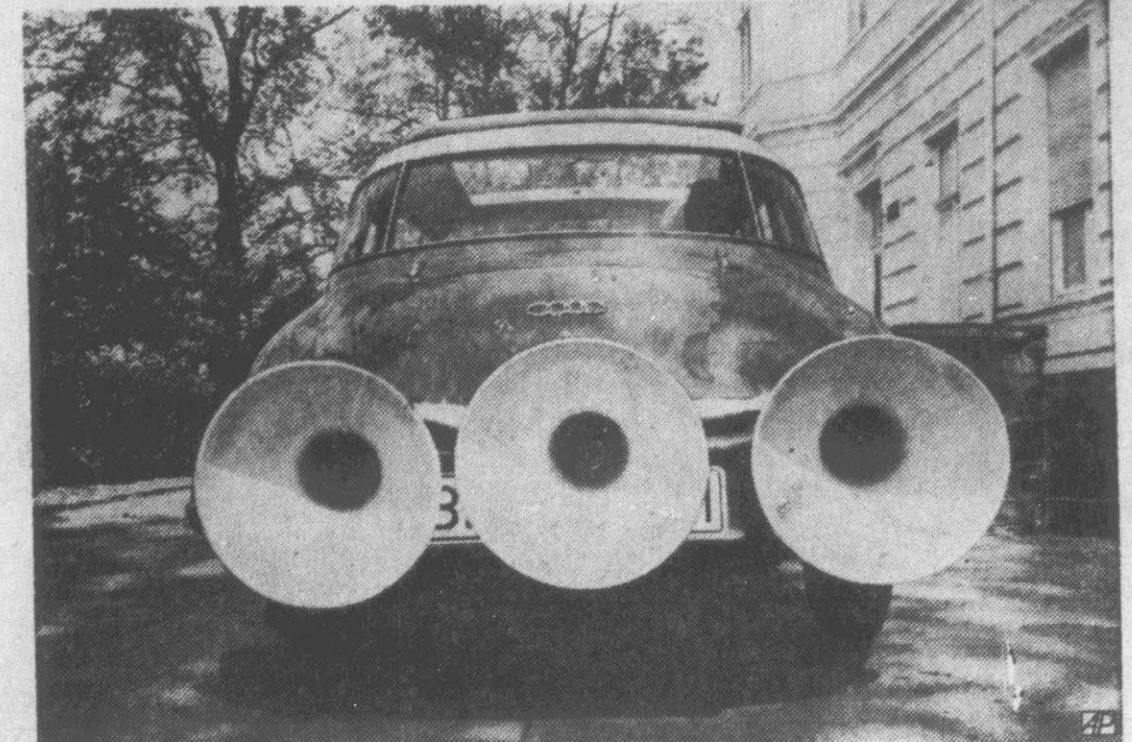
As any handyman knows, it is getting the old paint off that makes a painting job tough. These men are taking off the accumulated paint of 100 years—27 layers in all.

"It's just another job," shrugs a bricklayer.

But spare, weatherbeaten Martin Grieve, superintendent of the 10-million-dollar face-lifting job, sees the long shadows of history on the bustling scene.

He had to follow 100-year-old pencil sketches to remove the three-ton bronze doors from the main entrance. Even older paintings and drawings were used to redesign columns and decorate them exactly like the old.

Parents 'Convinced' TV Isn't Affecting Children

NEW YORK (AP) — Parents with children under 11 are overwhelmingly convinced their young ones have never been affected adversely by television, says a research firm which specializes in TV program ratings.

Pulse, in what it calls a "special qualitative sampling" of 433 households, found that 80.3 per cent regarded TV as harmless to their children. Only 19.7 per cent who reported that young children were upset by it, blamed old horror movies like "Frankenstein" and "Dracula," but also leveled a finger at certain Westerns, cartoons, mystery shows and the Three Stooges.

It probably takes more than 433 families to make a national case of it. But the study found that specific programs which parents urged their little ones to tune in were the Shirley Temple Story Book, "Father Knows Best," Leonard Bernstein's musical programs, "Twentieth Century," the American Heritage series, Telephone Hour, "Men Into Space," Wagon Train, John Gunther's "High Road," Dick Clark's "American Bandstand," and the Danny Thomas Show.

The firm made a companion study about family guidance of children's reading. They found parents forbidding—in overwhelming numbers—the reading of comic books and, in lesser number, horror stories. But they approved children's classics, fairy stories, animal tales and certain children's magazines.

Widow Of Theodore Roosevelt, Jr. Dies

OYSTER BAY, N.Y. (AP) — Mrs. Theodore Roosevelt Jr., 70, died at her home Sunday night. She was the daughter of President Theodore Roosevelt. She died at her home Sunday night. She was the widow of Brig. Gen. Theodore Roosevelt III, who died during World War II.

Mrs. Roosevelt, the former Eleanor B. Alexander, died of natural causes. She had maintained residence a quarter mile from Sagamore Hill, the family home of the 26th president, which is now a national shrine.

She was prominent in relief and social work and as an author and lecturer.

She was an assistant director of leave areas for American troops in France in World War I and received a citation from Gen. John J. Pershing for her work.

When her husband went to Puerto Rico in the late 1920s to serve as governor of the island, she established a needlework program for native women to help bring them a living wage.

She was an organizer of the first American Women's Committee for China Relief in 1937 and a director of the American Red Cross Club in England in 1942.

During World War II she turned her efforts to recruiting for the Women's Army Corps.

Stormed School For Report Card

Mrs. Stowell retreated into the arms of her husband, Donald, the physical education teacher. So, said Supt. Frazier Small, Mrs. Kidwell stormed into his desk to sweep the articles on his desk to the floor and "began whacking me over the head with her purse."

Kidwell merely stood by, muttering "I'm a taxpayer" over and over.

Mrs. Kidwell left, report card in hand.

She said if school authorities wanted the overdue book they could come to her house and get it.

Both Kidwells were charged with disturbing the peace.

Police Say Mother Of Three Hired Man To Slay Her Husband

ST. LOUIS (AP) — Police say a 26-year-old mother of three has admitted hiring a man to kill her husband so she could marry her lover, an 18-year-old clerk. All three have been charged in warrants with first degree murder.

Under arrest were Doris Angele, 26, William J. Mullane, the youth involved, and David L. Thompson, 29, a shoe worker, who admitted that for \$215 he stabbed to death Gene O. Dix, 26, whom police described as a gambler.

All three have signed statements describing the plot.

Thompson said he talked with Mrs. Dix six months ago and she told him that she wanted her husband killed because he "treated her bad and run off from keeping the kids." He said she asked if he would kill Dix and he jokingly replied, "Sure."

Later they again discussed it and she offered him \$500. He said that wasn't enough, that he'd do it "for a couple of thousand."

Thompson said they then worked out an elaborate plan, even timing a movie to which Mrs. Dix planned to lure her husband.

Thompson said he waited near the back door of the Dix home for the couple to return from the movie. He drank often out of a bottle of vodka.

He couldn't find a .22 caliber pistol that was to be waiting for him under the back steps, but Mullane gave it to him.

"Just as Gene reached the door, I shoved the bottle in my belt. I pointed the gun at him and I think I said 'Hold it!'"

Thompson said Dix got into Dix's car and Dix began driving. During the ride, Thompson said, Dix asked, "Who put the finger on me?" Thompson wouldn't say. "Was it one of my friends?" Dix asked and Thompson replied, "Yes you might call it that."

Thompson said they stopped at a side street and "he was getting kind of nervous. I made him move over and I drive. When we stopped at another street, he got panicky and tried to jump out of the car. I guess that's when I stabbed him. He cursed me and started running."

The slaying occurred the night of April 5. After Dix was stabbed he staggered into a restaurant, gasping that he had been stabbed by a man who was wearing a moustache. He died on the way to City Hospital.

Thompson said he thought he tried to shoot Dix but the gun wouldn't fire.

He said Mrs. Dix gave him \$135 as a downpayment the afternoon of the killing and Mullane later gave him \$200 more.

Mullane said he had been working in a confectionery run by Mrs. Dix for about eight months and had been romantically involved with her for about one month before the slaying.

President Adds 2 Stops In Tour

GETTYSBURG, Pa. (AP) — Visits to the Philippines and Formosa are being added to the route for President Eisenhower's Far Eastern tour next month, administration sources report.

Those visits are expected to precede stops to Japan and Korea which the White House announced some time ago for June 19-23. At that time various Asian area countries had urgently renewed standing invitations that Eisenhower visit them.

Eisenhower is expected to stop en route to the Far East at Anchorage, Alaska.

In Washington, White House Press Secretary James C. Hagerly said he could make no official comment today about the reported expansion of the trip but added he will have an announcement Tuesday about Eisenhower's travel plans.

The two additions were made possible by Soviet Premier Nikita Khrushchev's withdrawal of an earlier invitation to Eisenhower to visit the Soviet Union.

Government sources who asked not to be named said Eisenhower now is expected to arrive in the Philippines June 14 and go from there to Taipei, the Nationalist capital on the island of Formosa.

Japanese protesting the ratification of a new U.S.-Japanese security treaty have demonstrated, urging cancellation of the visit to Japan, and the leftwing Japan Teachers' Union adopted such a resolution Sunday.

The Japan Socialist party last week asked U.S. Ambassador Douglas MacArthur II to cancel Eisenhower's visit, but MacArthur said the request had a propaganda motive.

The Japanese government notified this country last Friday that its invitation to Eisenhower still stands.

Syngman Rhee Avoids Visitors In Honolulu

HONOLULU (AP) — Tight-lipped Syngman Rhee stayed in seclusion today while South Korean officials castigated the deposed leader for leaving his homeland.

The 85-year-old former president and his Austrian-born wife moved into the beach home of Wilbur Choy, a close friend and prominent Honolulu architect. They declined all requests for interviews.

The Rhees arrived from Seoul Sunday after a sudden and secret departure.

In the South Korean capital, the Acting President Huh Chung to explain why Rhee was allowed to leave.

A former assemblyman declared Rhee escaped to avoid criticism "for his misrule of the past 12 years."

The Hapdong news agency said 1,500 university students demonstrated in Taegu, South Korea's third largest city, to back their demands that Rhee be summoned home immediately and the Huh government resign.

Rhee in a brief airport interview said he would go back but gave no dates.

Rhee left Korea as the vice minister of finance, Kim Yong Kap, told the Assembly 20 million dollars in foreign exchange had been improperly appropriated by Rhee while he was president.

Both Rhee and his wife called the accusation fantastic. Rhee said, "That's the first I heard of it."

There was speculation Rhee wanted to be out of his country during the next two months when South Korea's constitution will be revised.

Rhee stepped down April 26 in the wake of a series of demonstrations and violence in which several hundred persons were killed or injured.

As for returning home, Mrs. Rhee said, "our dogs were left behind and they are waiting for us."

The Rhees brought six suitcases in their chartered four-engine plane. They cleared customs in 20 minutes. Their luggage was not opened.

The Rhees were met by C. C. Oh, Korean consul general, and B. Y. Choy, president of Dong Ji Hoi, a Korean association founded by Rhee years ago. Choy said he invited the couple here for a rest.

Rhee spent 25 years in Hawaii working for Korean independence from Japan. His pleas for independence finally became a part of United States objectives for a peaceful settlement in Asia after World War II.

"I started reeling it in. When it was about three feet away, I saw it was my boy."

The youth was Robert Eugene Jenner, 11.

The title contenders halved the twelfth hole as both dropped long putts but Clark went ahead again on the thirteenth hole with a birdie. A 15-foot putt by Farley was just inches short and he had a par five.

Starting to bear down, Farley pulled even on the fourteenth hole with a par four. After being far to the right from the tee, Clark made a good recovery and was on the green in two. His chance of holding the lead was destroyed when he three-putted.

Farley went ahead with a par three on the short fifteenth hole. Clark's tee shot went in the woods on the left and his third shot hit the pin and rolled past.

The match was tied again on the sixteenth hole when Clark took a par four and Farley, after a good third shot out of the trap, went past the hole with his putt. He finished with a bogey.

The turning point and clincher came on the seventeenth hole.

Charles Rogers pitched a three-hit shutout and also slammed a 2-run homer in the second inning to lead his Greenville Tobacco Company teammates to a 5-0 victory over the Moose, Saturday afternoon.

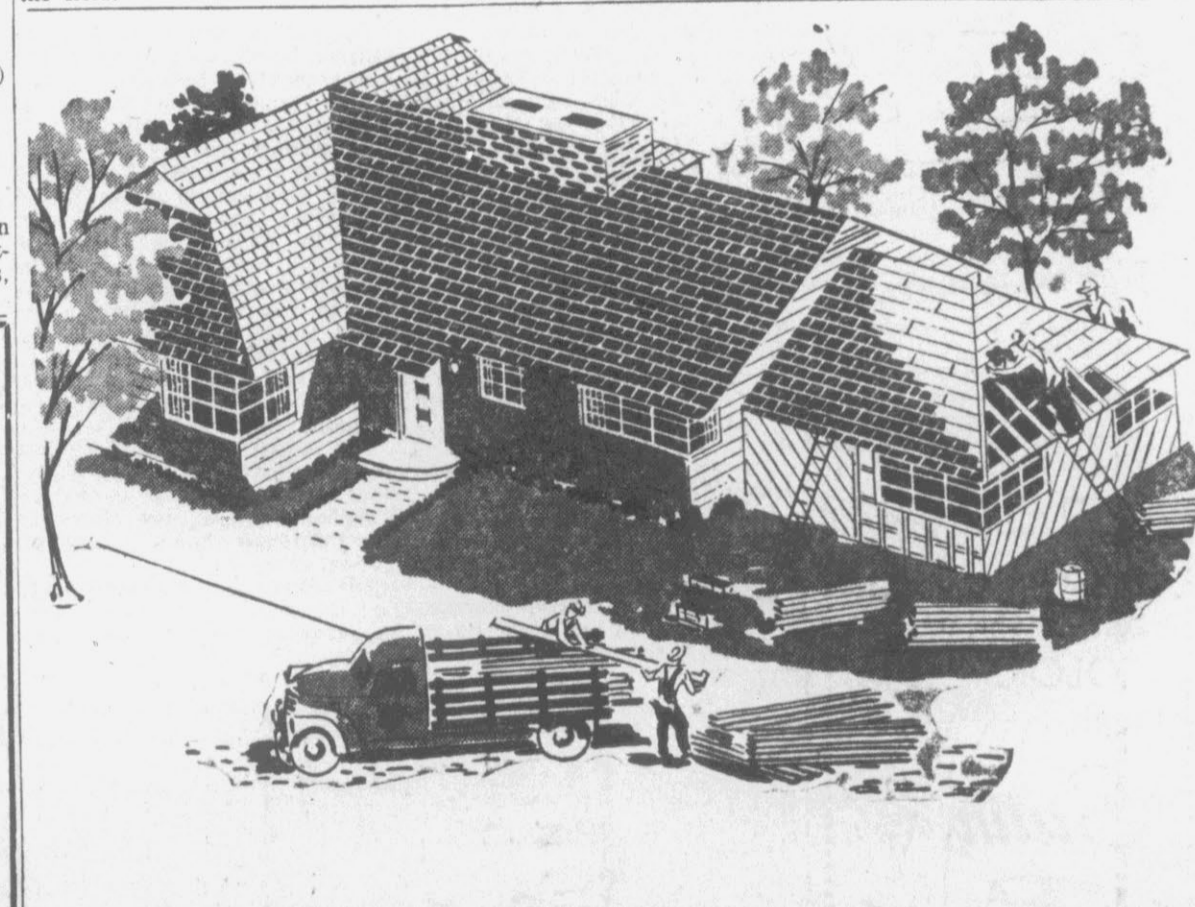

Undersea Object Is Ancient Wreck

KEY WEST, Fla. (AP)—The U.S. submarine Tirante was cruising along peacefully a week ago when its sonar operator picked up a mysterious contact.

An unidentified object was lying under about 430 feet of water in the Straits of Florida. It was only about 24 miles southeast of the U.S. naval base at Key West—in waters identified on charts as a submarine operating area.

Six antisubmarine warfare ships were sent to the scene. Divers descended. Last Friday information about the operation began to spread.

Rumors flew. Could it be a Soviet submarine? Sonar apparatus which bounces sound impulses off solid targets could only indicate the object's location. Divers were needed to make positive identification. The Navy said divers were hampered by the extreme depth and could only stay down a few minutes.

Sunday the investigation ended. Rear Adm. Lloyd Mustin, commander of the Key West naval base, said pictures taken by an underwater camera showed definitely that all the hubbub was caused by a coral-encrusted wreck—which probably has been resting on the ocean's floor for years.

Both Lowes pleaded innocent. Both were released on \$500 bond and ordered to appear for hearings June 8.

As the Lowes left the courtroom, police were arresting a man for drunken driving. His name: Lowe.

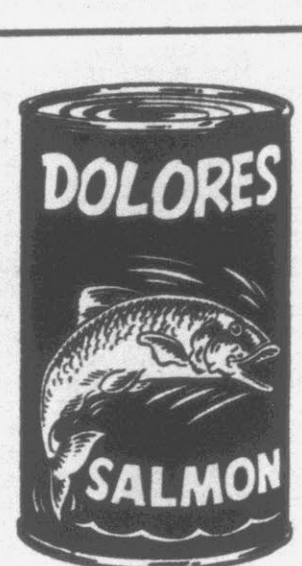

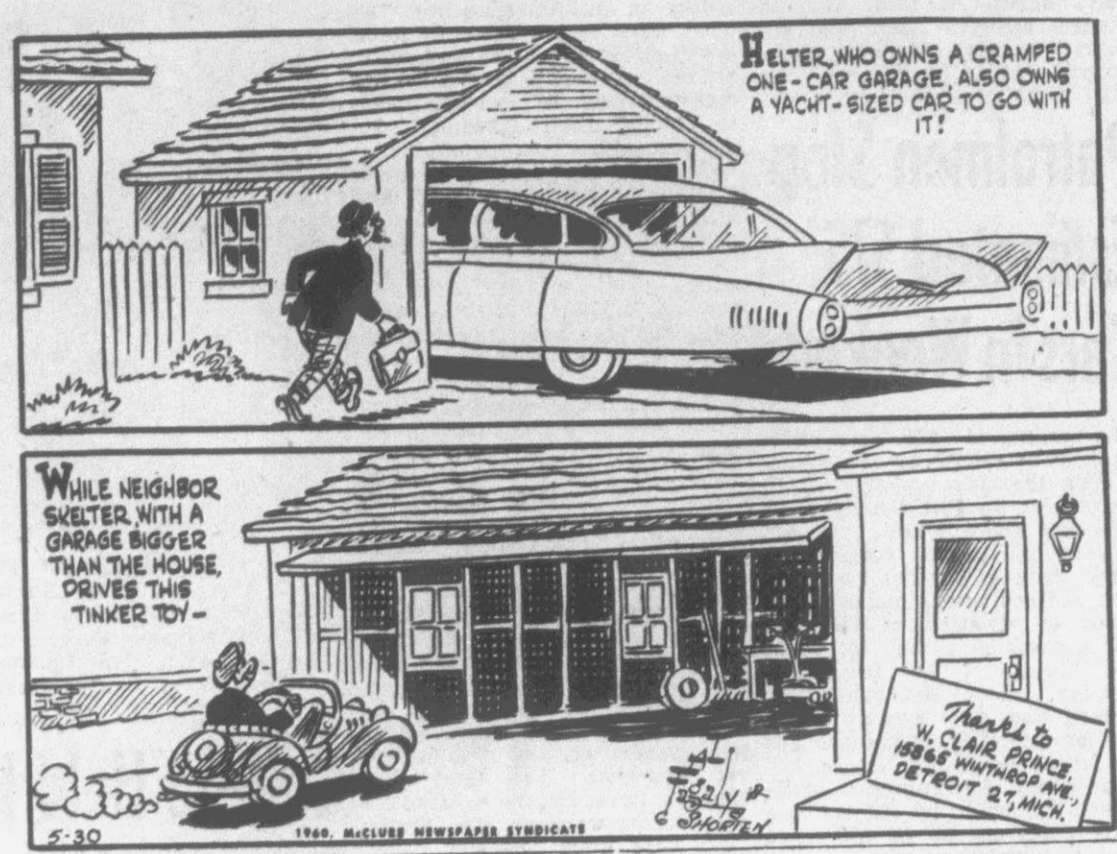

Missile Strikes Ordered If Russian Air 'Violated'

MOSCOW (AP) — Defense Minister Rodion Malinovsky declared today he has ordered Soviet rocket forces to strike at a takeoff base of any foreign plane violating Soviet airspace.

Marshal Malinovsky told a conference of Communist labor "shock workers" that this was a "lawful decision" because the foreign plane "might be armed with a hydrogen bomb."

Premier Nikita Khrushchev and other top leaders heard Malinovsky deliver his hard-hitting speech which he described as "not a threat, but a warning" to other countries. It was obviously aimed at allies of the United States in which are based such American aircraft as the U2 spy plane shot

down deep in Soviet territory May 1.

The Soviet defense minister said Soviet rockets could hit a target higher than any airplane could fly.

Malinovsky said the Soviet army had "everything needed to strike a retaliatory blow at a satellite and at a leader no matter behind which ocean they were hiding."

Apparently he was referring to allies of the United States and to the United States itself, and to the Soviet Union's intercontinental ballistic missiles capable of reaching the North American continent.

Malinovsky said the United States was by no means a coun-

Must Glorify Men Of Peace, Asserts Jenkins

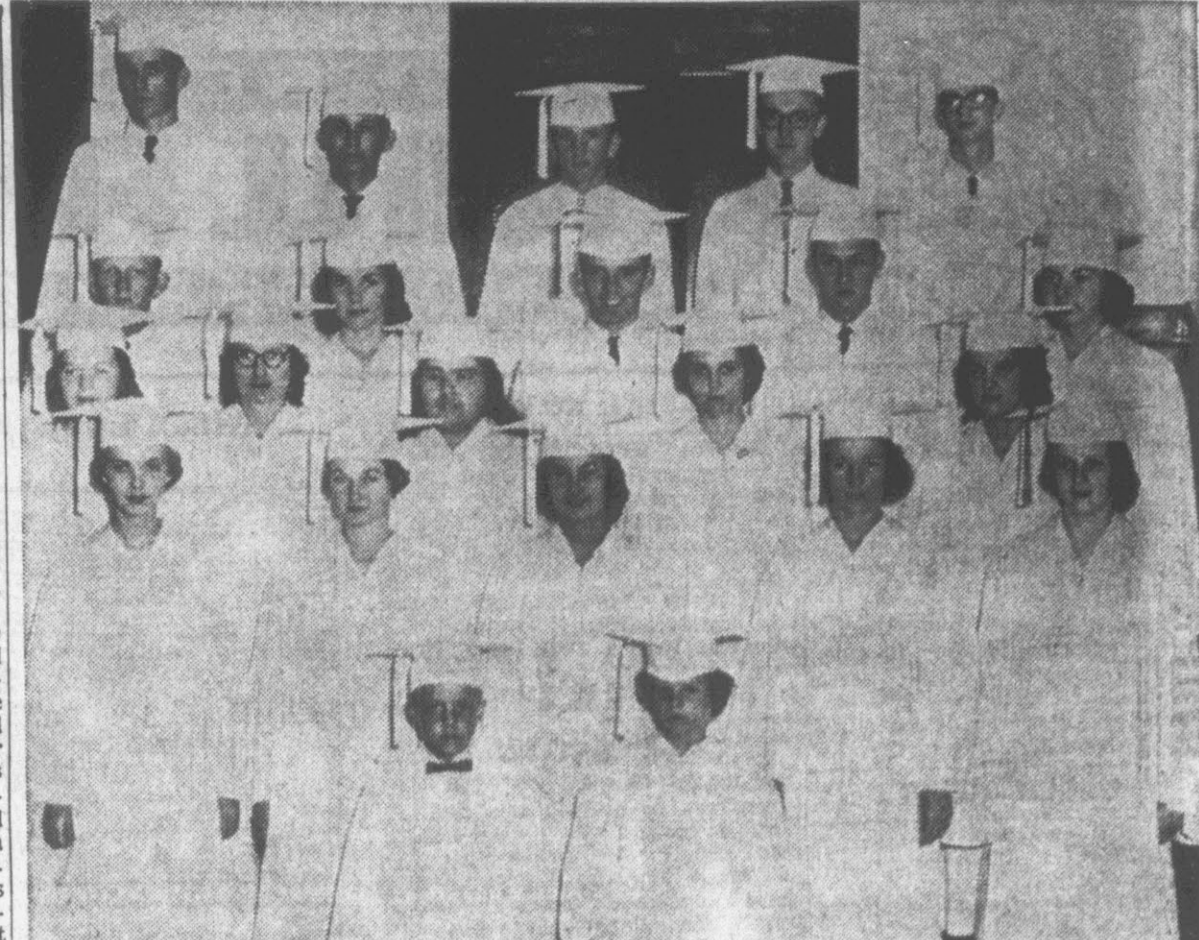
Dr. Leo W. Jenkins told Memorial Day observers yesterday that there is never a victory in war; both sides suffer.

Dr. Jenkins, president of East Carolina College, said further that "There is a struggle today for men's minds, he said, and this struggle resolves itself into five giants; namely, Peiping radio, Moscow radio, United Arab Republic radio, British Broadcasting Corporation and the Voice of America."

These include, Jenkins said, the fabulous America, representative government, a land of opportunity, the dignity of man and a religiously oriented nation.

Watched Wife Fall 3,500 Feet To Death

ELSINORE, Calif. (AP)—"She's dead, Van's dead," a bewildered husband mumbled. With his three children he had watched his wife plummet 3,500 feet in a parachute death dive.

Vanda Pfeiffer, 32, was killed Sunday on her first free jump as a skydiver, a hobby she had shared with her engineer husband, William, for about a year.

Skydiving is a relatively new sport that has quite a following at this small Southern California airstrip. Divers soar free like birds, sometimes for thousands of feet, before opening their parachutes.

Mrs. Pfeiffer apparently was frozen by fear when she leaped from a light plane circling the picturesque hills and airfield.

Arms folded tight across her chest, she dropped like a wounded dove as her husband, the children and about 100 spectators on the ground watched in horrified fascination.

"I watched her all the way down," said Dan Barrett, 33, who jumped from the plane a moment

after Mrs. Pfeiffer. "She made no effort to pull the ripcord."

"We were expecting her to pull," said Barrett's non-jumping wife, Deena, who stood with Pfeiffer and the children, Chuck, 12; Peggy, 10, and Roger, 9.

Mrs. Pfeiffer plunged closer to the ground the only sound was "Oh, no! Oh, my God, no! from a woman in the crowd."

The attractive housewife's body slammed into the earth and bounced into the air.

Pfeiffer started toward his wife's crumpled body. He was intercepted by friends and bundled with the children into a car.

"She's dead, she's dead," he kept repeating.

Pfeiffer himself had made his first free jump just an hour before.

His wife had made several jumps with a static line—a wire hooked to the plane that opens the parachute. This was her first dive without one.

The Pfeiffers have been living with the Barretts in nearby Anaheim, a suburb of Los Angeles.

many there. Incumbent Levi Wilson was second with 193 markers, and Billy Garris placed third with 48.

Heath's total is six votes shy of a majority and Wilson could ask for a run-off. County Board of Elections Chairman D. S. Spain said today he has not heard from Wilson.

Vote Disappointing

The total vote of 12,513 in the congressional balloting was not as high as had been predicted. Prognosticators had foreseen a total vote ranging between 13,000 and 16,000 for Saturday, since the gubernatorial and congressional races had aroused "intense interest."

Interest in the two races was indicated by total voting as nearly equal. Pitt voters cast a dozen less votes for gubernatorial choices than for congressional preferences. The next highest vote total resulted from the Fumber-Wheeler race. Those voted totaled 12,179.

The U. S. Senate race claimed the fourth highest total at 11,494. Other totals were: lieutenant governor—11,439; county commissioner—11,390; insurance commissioner—10,710; and associate Supreme Court justice—10,384.

For U. S. Senator, Pitt voters chose Sen. B. Everett Jordan over Addison Hewlett by slightly less than 1,000 votes—5,813 to 4,894. Cloyd Philpott was Pitt's choice for lieutenant governor by over 1,000 votes. Philpott polled 5,096 votes as compared with 4,026 for C. V. Henkel and 2,327 for David McConnell.

Charles Gold was Pitt's choice for commissioner of insurance, piling up an 8,191 total to 2,519 for John Frederick.

The widest victory margin in Pitt went to Clifton Moore for Supreme Court associate justice. Moore tallied 8,379 to 2,005 for challenger William J. Cocks.

Sunday, three drivers were cited to court for improper equipment and no operators license at a checking station on the Stanlonsburg Road West of Greenville. That check point was operated for two hours, patrolmen said, and checked an estimated 100 vehicles.

One hundred cars were checked at a point on U.S. 264 Sunday and three drivers were charged with having faulty equipment while one driver was arrested for having no operators license.

An operator may renew a license 60 days prior to the expiration of the license by taking a written test given by a License Examiner. A vision test is also given at the time of renewal of the license, Jenkins pointed out.

Traffic deaths mounted rapidly today as the Memorial Day weekend moved into the going home period for motorists, and safety officials warned that the toll might hit a record high.

"Unless there is decided improvement in driver behavior for the remainder of the holiday, we may be headed for a Memorial Day record," a National Safety Council spokesman said.

The toll climbed at a rate exceeding the same holiday period in 1958 when 371 persons died in traffic accidents and a record for the 78-hour holiday was set.

"There is plenty of time to prevent this by the simple expedient of stepping up our care to meet the traffic," the NSC spokesman added.

Counting of accident deaths began at 6 p.m. local time Friday and ends at midnight tonight—a total of 78 hours.

The Council estimated 375 persons would die in traffic accidents during the current three-day weekend.

A single crash east of Cambridge, Ohio, claimed six lives early today. All of the unidentified dead — believed to be Air Force personnel—were occupants of a car which collided with a tractor-trailer. The car bore California license plates.
