Closely Check Road With Bad Wreck Record

Six drivers were charged with law violations and 58 other vehicles checked during the first two days of a selective and saturation program on 10 miles of Pitt County Road which has the worst accident record for the year.

The section, from the intersection of N. C. 11 and U. S. 264 bypass north to the intersection of N. C. 11 and N. C. 903, has been assigned to one patrolman who patrols that 10 mile strip for his entire eight hour duty period, in an effort to prevent accidents and law violations.

Enforcers noted that a total of 13 accidents have been reported on the road so far this year with one resulting in the death of a Tarboro woman just last week.

The special patrol will continue through the weekend, officials noted. The six law violators included stop sign violations, failure to yield the right of way charges, failure to give proper signals and one drunken driver.

Explaining Trinity Concept Is Problem

NEW YORK (AP) — Most of Christendom celebrates its greatest mystery Sunday.

It's Trinity Sunday, or the Feast of the Holy Trinity — or, as it might be called "God's Feast Day" since, in Christian belief the Trinity is God as three persons and one substance.

The concept of the Trinity is a difficult one to grasp and it presents a knotty problem to missionaries in Africa or illiterate farmers in Asia.

What do you say when a prospective convert asks: "How can three be one?" And you'd better have an answer that makes sense to him because the Trinity is one of the central doctrines of Christianity.

One missionary would begin by telling him it's a mystery," says the Rev. Albert J. Nevins of the Roman Catholic Maryknoll Fathers, famed for their missionary work in the Far East.

"A mystery is truth that has to be revealed. It can't be reasoned. We'd use the example of St. Augustine, who was walking along the seashore when he saw a youngster dumping seawater into a hole.

"What are you doing?" he asked. "I'm trying to drain the ocean," said the youngster. "The ocean can't be drained any more than a mystery can be fully understood."

Maryknollers make use of symbolism to explain the Trinity. "We teach the God-family relationship," says Father Nevins. "There is your mother. There is your father. And there is you. Three persons. Yet you are all one family."

"There are three sides to one triangle, too. "And, of course, there is the famous story of St. Patrick teaching the Trinity to the Druids on Easter through the use of the shamrock."

"We don't try to explain the Trinity until after the person has accepted Christ," says the Rev. John Underwood, a Presbyterian missionary in Korea.

"We've found that those who have not accepted Christ are not ready for the deeper truths of Christianity. "When those who believe in Christ have questions, these questions are normally answered from the truths of Christian theology."

"We might answer a question on the Trinity like this: "The Christian scriptures are clear from first to last in their insistence that God is one and that there is no other God but He. "At the same time, the scriptures refer to God the Father, to Jesus Christ as God the Son and to the Holy Spirit as being God. "These three are clearly distinguished as being distinct Persons, not manifestations or facets of each other.

"This presents a dilemma which has been met by the Christian Church through the recognition of a paradox. "God is one. There are in the Godhead three persons, the Father, Son and Holy Spirit, equal in substance, power and glory. "This paradox is called the Trinity.

"It meets the test of scripture and has been concerned in the experience of the entire Church of Christ whether Roman, Protestant or Orthodox."

Every Effort To Intimidate U. S.

The violent demonstration near Tokyo against James Hagerty, President Eisenhower's press secretary, is bound to cause another Washington evaluation of the proposed trip by the President to Japan next week.

Obviously, the demonstration against Hagerty was another attempt by extreme leftist groups to intimidate the present Japanese government as well as the President of the United States in the hope of causing a change in the President's plans.

There can be no question that the President will be placing himself in a position of some danger by going ahead with his trip to Japan. There is, however, considerable speculation that when the President arrives in Japan he will not be confronted with as violent demonstrations as those so far staged by the leftists groups in seeking to prevent the visit. He will be the guest of the government and a guest of the Emperor and he will be accorded much greater police protection than that given Hagerty. It is also possible that the flame of violence which has been displayed in previous demonstrations will not burn so brightly when President Eisenhower arrives.

It is important that the President of the United States not take unnecessary personal risks because of the important position he holds in this nation and among the nations of the free world.

On the other hand, it is important that the government of Japan be kept in power. It is important that the prestige of the United States and the free world not be shattered by communist-inspired attempts to prevent the President from visiting a free world nation to which he has been invited.

A Beginning For Road Overlooks

OVERLOOKS—The campaign (?) to have the National Parks Service provide elevated ramps or overlooks along the Hatteras Seashore road is bearing some fruit. Information is that one or two such overlooks have been built just south of the Pea Island Game Refuge area, and others are planned. These places are a great help, but do not quite meet the need, because they require driving some distance from the regular highway. The idea for overlooks along the coastal roads is spreading. A group of easterners is working on petitions to the highway commission to afford drive-outs to the water edge to make more accessible small boat launching points and fishing areas, along many of the state roads which parallel the coast.

LINGO—Every trade and profession has a language peculiar to itself. Some of the most picturesque expressions were developed in the old days of sailing ships, steam railroading, and hand-composition print shop.

A choice example comes from J.M. White, head man in the North Carolina Railroad Association, and sometimes called "Mr. Railroad." Jim has been railroading nearly all his life and can talk the lingo of the roundhouse as fluently as the language of bankers and legislators.

Few modern railroaders would understand this: "The jam buster gave a green eye, and the rattler's hogger rapped the sack as he headed up the tangent on a ball of fire." Appetite Is Whetted By The River Traffic

A tug boat and a barge on the Tar River in Pitt County this week whetted our appetite to see cargo moving on the river again as it did in years past.

The tug and its empty barge were headed for Tarboro where the barge would be used in a construction project. There was no cargo. There would be no subsequent trips. It was just a stray that somehow found its way into the stream that many years ago was an artery of transportation for Pitt County and points farther inland.

Such craft as the tug and the barge are rare indeed on the Tar these days. But it was not always so. In the hey-day of the river boat, the Tar had its share that carried passengers and freight to points all along the river. In more recent years—until World War II came along—the Pitt-Greenville Port Terminal was a point of call for frequent inland waterway freighters.

Since then, the only boats on the river have been those of fishermen and boat enthusiasts. As a transportation artery, the Tar is no longer important. Efforts to restore cargo traffic on the river have failed time and again. Sand bars and snags have gradually crept into the old channel at places, and the Tar has become a latent artery, waiting to be re-opened to take its place in the growing economy of the area.

For Pitt County the river affords a valuable natural resource, and it still has its potential as a transportation artery if only the right combination can be hit upon to bring about its development.

The tug boat and the barge brought memories of times that were, and provided a lift to the dying hopes that someday perhaps, the river will be used again for transportation.

Neither Proves Really Precise

WASHINGTON (AP) — Twice in a row, with no one in sight likely to take the Republican nomination away from him, Vice President Richard M. Nixon got jabbed with a red-hot needle. Both times he stayed quiet 24 hours.

Both times this happened to be just long enough to let the Republican leaders in Congress rush to his defense against the needles — as they did — before he did any talking.

The first time it was Harold Stassen who jabbed him, just when Nixon seemed to have the Republican vice presidential nomination sewed up in 1956. Now it's New York's Gov. Nelson Rockefeller, just when Nixon seems to have the presidential nomination cinched, although Rockefeller would like to get it.

Rockefeller said it was about time Nixon started saying precisely where he stands on the big issues. Nixon replied that he not only has talked on them but has been more precise than Rockefeller.

The fact is: Neither has been completely precise at all. Few seekers of political office ever are.

It was only July 23, just a few weeks before the 1956 Republican convention, that Stassen started his dump-Nixon campaign, arguing Nixon would lose the party vote in Stassen's Massachusetts for the vice presidential nomination.

Republicans in Congress, with visions of Stassen splitting the party, rallied around Nixon. Herter didn't have a chance. In fact, he said he not only didn't want the nomination but would nominate Nixon himself.

Nixon came out of silence then. He didn't waste any time on Stassen. He just praised Herter. But he reacted far more energetically to Rockefeller.

Rockefeller, who got out of the Republican presidential race last December and jumped back in May, fired his blast at Nixon on Wednesday. The Republicans in Congress closed ranks around Nixon.

Then Nixon went to New Jersey Thursday and at a news conference said he had talked on the issues and had been more precise than Rockefeller. He challenged the governor to a "discussion in depth," perhaps before television cameras. Rockefeller said Nixon "doesn't need me to interrogate him on television."

What follows is a run-down on

the positions Rockefeller took on the issues in his Wednesday attack against Nixon and the vice president's statements in the past on those same problems.

National Defense: Rockefeller says defense is not good enough, suggests spending 3 1/2 billion dollars more right away. Nixon says defenses are just fine but this country must spend whatever it costs to retain its strength.

Other Editors Saying... No Anonymity

As might have been expected, more anonymous leaflets, aimed at influencing the Governor's race in the June 25 Democratic primary runoff, have bobbed up. They are being investigated by the SBI, whose director, Walter Anderson, has appealed to Tar Heel citizens to turn over to his office any such campaign materials which they may receive.

Frankly the SBI doesn't know whether the leaflets, which it already has are illegal or not, but it is studying them and will depend upon the attorney general's office for rulings as to illegality.

There is plenty of room for full and free discussion of the issues as the two candidates and their supporters see them without getting into vituperation, racial bitterness and animosity or smear attacks which smack of what we had hoped was a thoroughly discredited McCarthyism.

The Daily News receives numerous anonymous communications. They are never published, as someone, assuming that these communications are not libelous, must first of all assume responsibility; they must be signed, with name and address

dually established. With us anonymous communications find a ready wastebasket. A person who does not have the courage to sign what he or she writes, isn't a person to worry about.

There is a difference, however, when such communications, derogatory to any candidate, are circulated in political campaigns. North Carolina wisely has a statute which makes such circulation illegal. Emphasis that such a law is on the books and that the SBI is prepared to look into every anonymous circular or pamphlet should prove a strong deterrent, for those who do not have a sense of decency but do fear the law. It will be difficult to trace down such illegal material, but there is always the possibility that some offender will be spotted and feel the full effect of the law.

Choosing a Governor in North Carolina is earnest, serious business. It should be done in fairness and reason by people who, regardless of the victor, are going to have to live and labor together. In the whole process of reasoning together, vituperation and venom, always to be deployed, cannot be allowed under the cloak of anonymity. The right to face one's accuser is as fundamental as any single component of democracy.

Three Study Nikita

Three Hearst newsmen, William Randolph Hearst, Jr., Frank Coniff and Bob Condone, have written a book on their experiences with Khrushchev. The Hearst team spent considerable time with him during the first visit Joseph Kingsbury Smith went along. It was an experiment in journalism, sending a team instead of an individual. It was also an experiment in interviewing. Khrushchev was apparently so anxious to win American good will that he gave these men all the time they needed and spoke freely. It now appears in a book, "Ask Me Anything."

Not one of the team was an expert on Russian affairs, spoke Russian or had any particular relationship to the Communist movement. Their work, therefore, represents an objectivity not too usual in reporting on these subjects. That they came out so well is not as surprising as it may seem, for these men are competent reporters. Also, they are not accustomed to stuffy writing. Perhaps the Hearst style of journalism is not the ideal of the pundits of the schools of journalism, but what appears in print can be read with understanding. And so it is with this book. Take these paragraphs:

"Khrushchev's first purge is credited with being a direct cause of the suicide in November, 1932, of Nadyezhda Alliyeva, Stalin's wife. She took her life in protest against what her husband, through Khrushchev, was doing to old associates. Her death helped Khrushchev's career. It permitted Stalin to legalize his long relationship with Rose Kaganovich, sister of Khrushchev's patron. As Kaganovich rose, Khrushchev was pulled along. He began to be written to the top of the hierarchy, even to the informal fetes which the new Mrs. Stalin gave at their dacha outside Moscow. A French governess of the Stalin children wrote later: 'Among other regular guests was a Ukrainian secretary of a committee at Moscow. He danced well, sometimes alone, sometimes with his hostess. He was a good singer and also liked telling anecdotes which made even Stalin laugh. On one occasion, too, he brought with him his little boy who played with Basil, the son of Stalin.'"

This is the sort of personal relationship that makes history. As Westbrook Pegler put it, "If you want to know what a man thinks, look at the other head on the pillow."

We read of new names and some of them have no trails in our historic memory. For instance, who is Mrs. Furtseva, the only woman on the Presidium? How did she emerge so swiftly and reach such a high place in government? The authors say:

"Furtseva first met the dynamic little man from the Ukraine in 1937, when she was studying chemistry at Moscow's Lomonosov Institute. She is said to have become, not long after, the protegee of Nikolai Bulganin when he was party boss of the Moscow district. Bulganin appointed her propaganda chief in his branch.

"During World War II, she quickly rose to become Secretary of the ration, or 'distriet.' She also managed to get a part-time job in charge of political agitation in the armed services, which permitted her to continue her association with Nikita Khrushchev."

Child labor provisions of the Federal law apply to all employees engaged in interstate commerce or in the production of goods for interstate commerce. There has been a tendency of courts to broaden the definition of interstate commerce. To be safe, employers should check with the nearest office of the U.S. Department of Labor as to their status.

Federal law prohibits the employment of children under 14 for work other than agricultural, outside of school hours; theatrical; newspaper delivery, or for a parent.

Children between 14 and 16 may work in office and sales jobs between 7 a.m. and 7 p.m. when school is not in session, but not for more than eight hours in a day or 40 hours in a week. Those between 16 and 18 may hold factory jobs if they are not hazardous, again check with the nearest U.S. Department of Labor office.

State laws usually regulate employers not covered by Federal laws, although some states apply their laws to all businesses. State laws are often more strict than Federal.

These laws vary considerably as to minimum working ages and hours of employment. Hazardous occupations are generally barred to those under 18; night work is generally prohibited. Agricultural and domestic work, or working for parents, is generally exempt.

Under the laws of 19 states, Prentice - Hall's Information points out, if an illegally employed minor is injured while working, the injured minor is usually entitled to double the ordinary award and the employer, not his insurer, usually must pay it.

There are two paramount precautions:

1. Insist that every prospective employee not obviously in his or her twenties submit an age certificate. Most states require minors to submit such certificates. Enforce the rule: "No certificate, no job."

2. Learn exactly how both Federal and State child labor laws affect your business. Federal and State agencies are usually helpful. Company lawyers can usually furnish advice. In organized plants, union officials will frequently be able to supply current data.

Jurges Ousted As Red Sox Manager

BOSTON (AP) — "It's best for all," Billy Jurges, 58, said after being ousted as manager of the slump-ridden Boston Red Sox.

"I'm going to get back into baseball, but I don't know where yet. I'm free to do anything I want," Jurges said from his home in Arlington, Va., Friday after being notified he had been fired.

No successor was named. Veteran coach Del Baker — who took over the club on a temporary basis three days ago when doctors ordered Jurges to take a complete rest — will remain as the interim manager, the Red Sox said.

The Red Sox' unconditional release of Jurges marked a complete turn-around of policy. The one-time shortstop great was given three votes of confidence when the Red Sox hit the skids and plunged to the American League cellar.

The latest was May 31 when owner Tom Yawkey made a rare personal appearance before the Boston press, defending Jurges and chiding reporters.

There was a touch of it in the telegram Yawkey sent Jurges notifying him of his dismissal.

"I am truly sorry the way the situation developed," Yawkey said. "Good luck and good health."

Jurges, ninth manager in Yawkey's 28-year reign as the Red Sox owner, replaced Mike Higgins July 4 last season. He inherited an eighth-place club and brought them to fifth.

This season the Red Sox started well, then plunged to the bottom. Jurges came in for press criticism and for weeks there was speculation he was on the way out. Then he was ordered, by doctors, to take a rest.

Over the two seasons, he had a 59-63 record with the Red Sox.

"There's a lot to be done in Boston," Jurges said, "and the new fellow must have a free hand. Maybe he can do better than I did. Mr. Yawkey was very nice about it all. They have a job to do and I have a job to do."

The prepared release, handed to reporters minutes before the Boston-Chicago game Friday night, said Jurges would be paid in full for the rest of the season and that "Baker will continue to act as interim manager."

Baker, 68, repeated earlier statements that he is not interested in managing on a permanent basis.

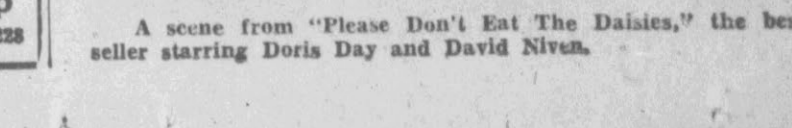

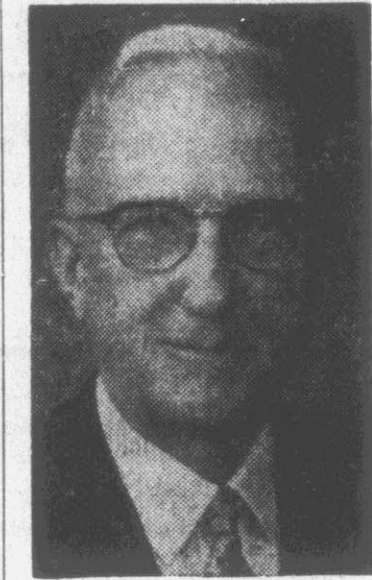

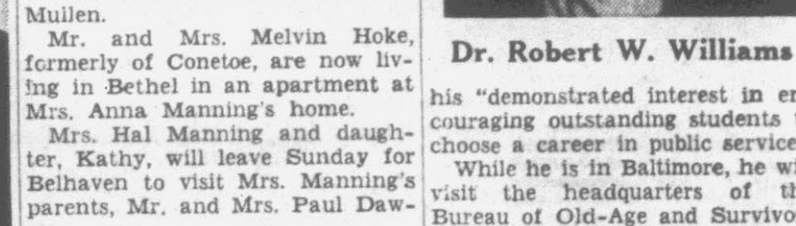

Wall Of Water Menaces City

VALDIVIA, Chile (AP)—There is more courage shown than fear in this shattered city as it awaits threatened inundation by a wall of water.

The crest of icy water would hit the city within four hours if three landslide dams fail to hold back the rising waters of Lake Rihnuve, 45 miles north of here.

The earthen dams were formed during the earthquake that rocked the area May 22. Landslides crashed down the valley sides and blocked the San Pedro River, normal outlet of the big lake, a mile wide, 12 miles long and several hundred feet deep in spots.

Officials say about 25,000 persons have been evacuated from this city, which once had a population of 100,000, and more are leaving. They are mostly women and children.

Engineers and crews of workers are digging canals and ditches in an effort to divert some of the water from the lake to relieve pressure on the dams. Sound trucks are patrolling the city streets urging residents to get out.

Ever since Valdivia was hit by earthquakes and tidal waves it has been cut off from the outside world by land Chilean warships, lying at anchor at the nearby seaport of Corral, wait to take off other refugees if the dams burst.

Work Stoppage By Airline Pilots

MIAMI, Fla. (AP)—Eastern Airlines pilots staged a work stoppage today and at least seven flights were canceled when crews failed to show up.

The airlines called the strike unlawful. A union official said the walkout was not authorized.

The strike hit flights at Miami and Detroit at midnight. All Eastern traffic out of Detroit was halted.

At Miami, two flights to Detroit and Chicago, scheduled to leave shortly before midnight, were the first to be canceled. Three Chicago flights were scratched by 1:30 a.m. EST.

An airlines spokesman said the stoppage came as a complete surprise.

Another spokesman in Detroit said captains and pilots informed the company they were calling a temporary work stoppage.

The striking pilots gave no explanation for the walkout, but unionized pilots of Eastern and other lines object to a Federal Aviation Agency ruling that FAA inspectors be given the third seat in jet airplane cockpits.

Capt. Edmund P. Rordam, regional vice president of the Airlines Pilots Assn., said the union had not authorized a strike. He said he was surprised at the action.

In a statement released here and in New York, the company assailed the strike as illegal.

Henkel Decides Against Run-Off

STATESVILLE, N.C. (AP)—Former State Sen. C. V. Henkel of Irrell today officially quit the race for lieutenant governor.

Henkel, who lives in Turnersburg, said he will not ask for a run-off election against Lexington's H. Cloyd Philpot.

Diesel Giants Still Go Through

The wail of the passenger train whistle is no longer heard in Greenville as it was in years gone by.

The last of the passenger trains—the old steam locomotive kind—was taken off here shortly after World War II. They were the victims of the automobile age.

But passenger service is not ended on the steel ribbon railroad tracks. For in neighboring Rocky Mount the modern diesel powered streamlined passenger trains still roar through. They are on their way to the plush resorts of Florida or back to the business world of New York and points north.

The diesel giants roar down Rocky Mount's main street, their bells ringing and big front lights winking. Theirs is the right-of-way as white striped gates drop to guard street crossings protecting the puny automobile.

With a great hissing the long trains grind to a halt at the long loading platforms. Only in this modern day the hiss does not come from steam engines, but, rather from the air brakes.

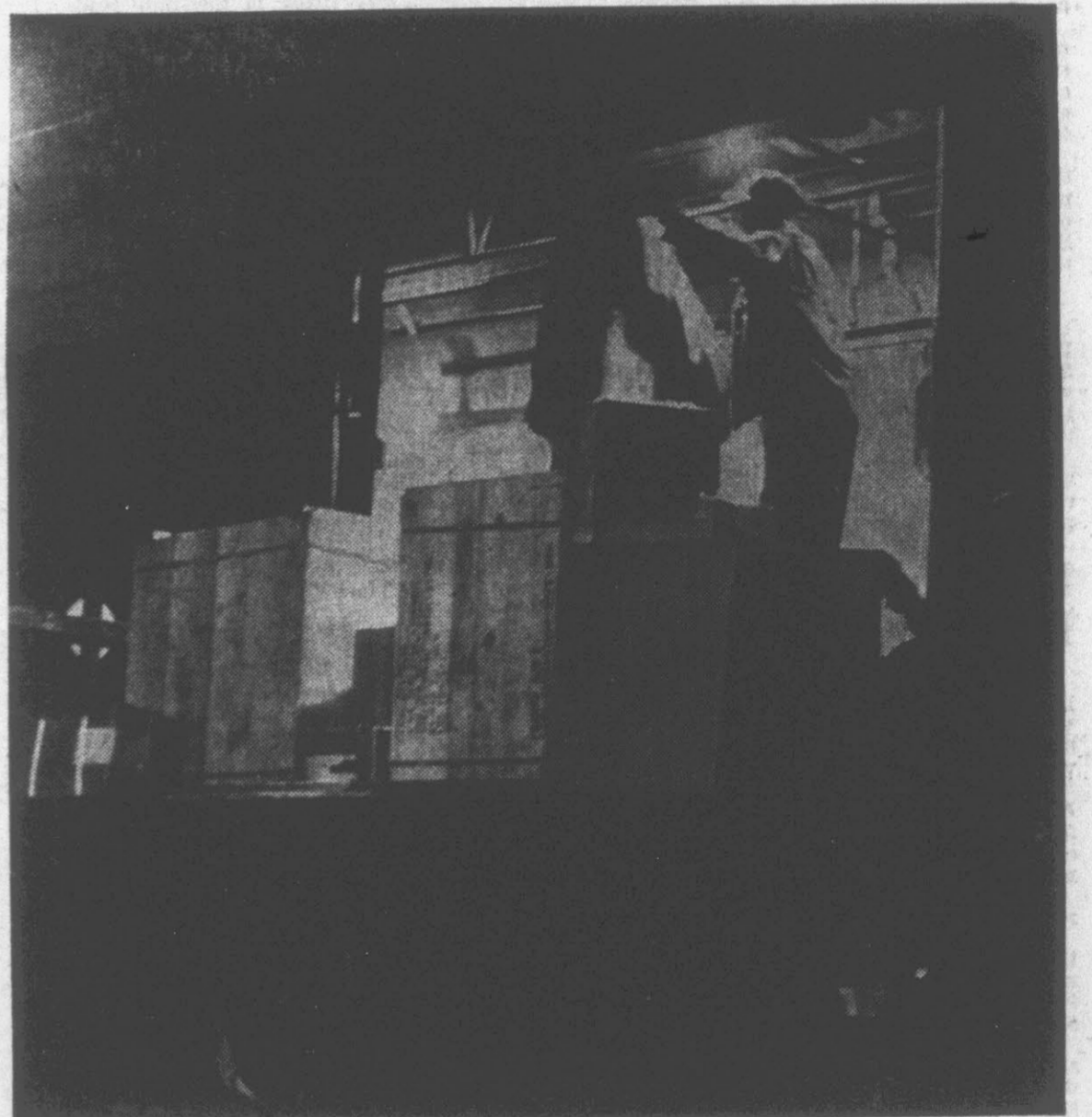
A uniformed porter assists some passengers off the train and others on. In the baggage car parcels are quickly loaded on and others taken off.

The long platform is left bare in the night, the space broken only by an occasional baggage cart.



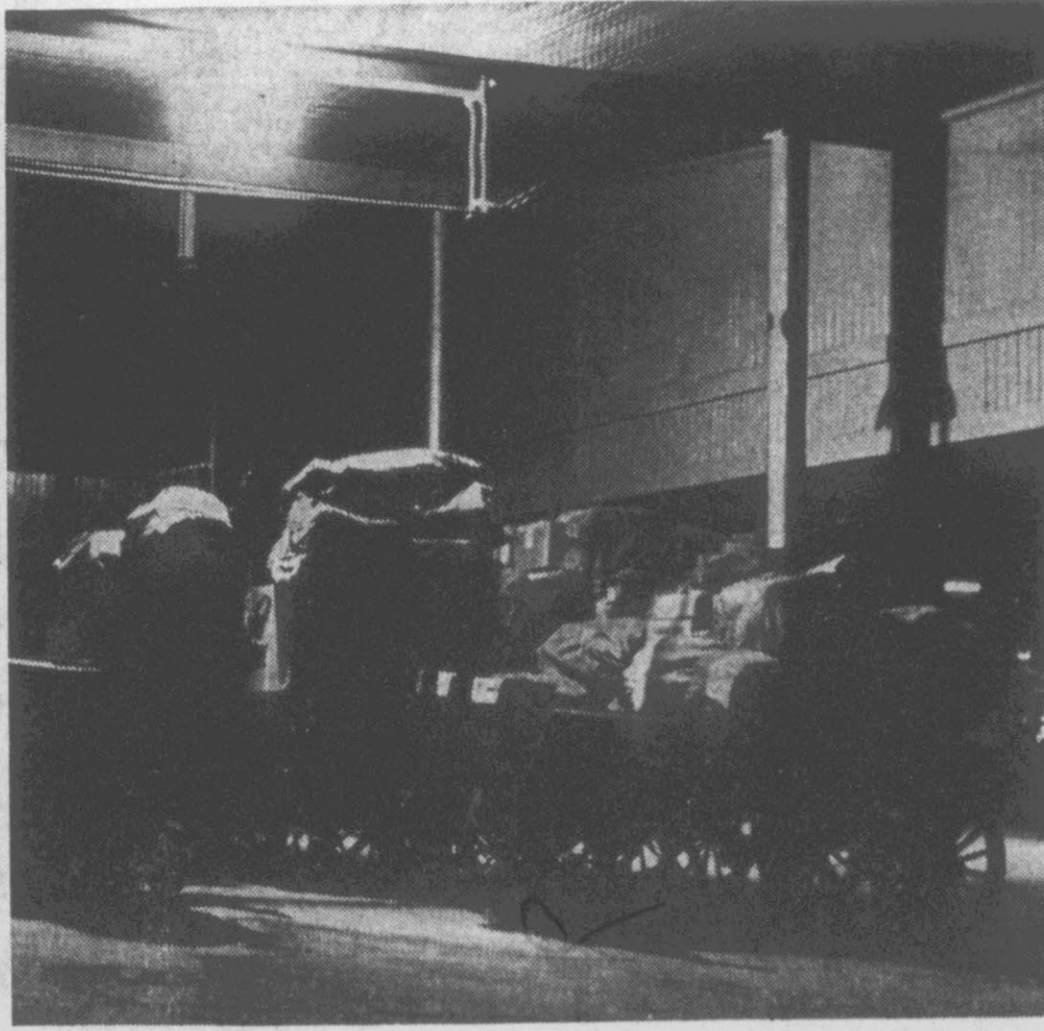
QUICK LOADING . . . as passengers board train crews do a quick job of loading.

Parents Come To Expect 'Wonders' From Reading Laboratory, Clinic

On Monday, 31 mothers will bring their children to East Carolina College, hoping that the Reading Laboratory and Clinic directed by Dr. Keith Holmes will work a wonder.

These 31 students were accepted from 100 applications from throughout the state. They will receive individual attention during a six-week program for their specific reading difficulties.

But the student himself, who may range from elementary to high school age, must want to come to school. The children, all normal and healthy, have in common a recognized difficulty in reading.

Mrs. Marvin Mewborn of Grimesland has a 12-year-old son who can memorize a page of spelling and make 100 on a test. But if he has to write a summary of his reading, he has difficulty spelling words—Mrs. Mewborn says her son missed phonics.

Mrs. Clarence Overby of New Bern has a daughter in the fourth grade who can read aloud with ease; but when she finishes, the daughter doesn't understand what she has read.

Mrs. A. W. Smith of Farmville has an 8-year-old son who is very slow in his reading. His difficulty would have held him back in school "except for this clinic," Mrs. Smith said. She hopes training and help will advance her son to the third grade level this fall.

Mrs. W. W. Shaw of Greenville has a 7-year-old son who does well in arithmetic, but when it comes to reading, he has trouble. He was held back in the second grade because of his reading.

Dr. Holmes of the Education Dept., and author of several publications, said that the attention and remedies offered in the reading clinic "sometimes save the students so that they can graduate from high school and college and have far more success in the future."

This difficulty in reading, which is so noticeable to the teacher and the parent, may be even more noticeable to the student. Children are sensitive.

The difficulty, Dr. Holmes says, may destroy an interest in further education. "The child feels handicapped, and inferior and I am afraid it has a psychological effect on his future."

It is not exaggerating to say that acceptance into the reading program may change the course of a child's life. The parents who bring their children feel this more than the child.

Interviews This Week
This week, interviews were held by Dr. Holmes, Mrs. Edna Earl Baker, supervisor of Pitt County Schools, the parent and the child.

The most important element of the interview is the child's desire to attend the reading clinic.

In one case, a young man acknowledged his difficulty in reading and realized the reading program could help him overcome

MACON, Ga. (AP)—Three Atlanta residents bagged a deer with their small foreign car but didn't get a chance to enjoy any venison.

H. T. Wood and Mr. and Mrs. A. T. Savage, told authorities a full-grown buck jumped in front of their car north of here Friday night.

his difficulty. He wanted help, but he was not so sure he wanted to attend the clinic.

In a "long shot," Dr. Holmes left the decision up to the student. He told the boy to call by Sunday if he wanted to begin school on Monday.

It was less than 30 minutes later that the young man made up his mind and returned in person to give his affirmative decision. One young lady made up her mind because she liked Dr. Holmes.

In the case of Mrs. Overby's daughter, the mother had heard of the reading clinic through a friend, whose daughter attended. At the end of this school year, the school principal said the student "had progressed three years in reading ability."

Mrs. Overby said her daughter

may have missed sounds early in school. The daughter herself wants to come to the clinic "to help me in school because I'm not doing very well."

Both Mrs. Overby's daughter and Mrs. Smith's son passed their school work, but Mrs. Overby asked that her daughter be held back in the second grade because of reading. Mrs. Smith's son would have been held back except for the clinic.

Mrs. Mewborn's son was held back in the fifth grade, though he is now in the seventh grade. By missing the "rules" for spelling, her son has had difficulty since in reading.

Individual Attention
Twenty-nine teachers have been selected and are being trained to teach the children. Some are graduate students, and some are teachers who are attending East Carolina College during the summer to renew teaching certificates.

With the training they receive this summer, these teachers may be able to improve the reading program in their own schools, Dr. Holmes says. They can serve as tutors in their own communities.

Mrs. Baker is serving for the eighth year of the program on a voluntary basis. She administers all the tests and does "paper work."

Fred Leadbetter, who has worked previously with Dr. Holmes, will serve as his assistant this summer. The program, sponsored by the Dept. of Education of East Carolina College, has the best teaching staff in its history, Dr. Holmes said. "There are four men teachers participating this year."

Teachers Attitude
Two car wrecks fatal for child

SHERIDAN, Wyo., (AP)—The death of Pamela Jean Cole, 3, of Bountiful, Utah, after she was involved in two traffic accidents in two days will be the subject of a coroner's investigation next week.

Coroner Jack Rhodes said it had not been learned which accident was responsible for her death Friday. An autopsy showed a ruptured liver to be her only severe injury.

The child appeared to be uninjured when a car driven by her mother, Mrs. Burton A. Cole, went out of control and overturned Wednesday north of Sheridan.

Pamela was run over by a car the next day while playing in the parking lot of a Sheridan hotel. She was taken to a hospital but appeared to be in good condition until she died unexpectedly.

Betty Thomas, graduate student from Pittsboro, will serve as a teacher this summer in the reading clinic. She became interested in the clinic as a result of Dr. Holmes' classes. Her interest in teaching is based on an interest in children and their reading problems.

Hilda Owens of Fountain, who will be a student teacher next fall at the Junior High School here, feels that this program will be of vital help to her work with remedial children next year.

"I think that reading is one of the basic problems. If the child can read, he can go on to other things," she said.

The program has reached such scope that teachers have come from as far as Florida to be trained and the students have come from out-of-state. This year, however all students are from North Carolina, Dr. Holmes said.

Based on previous experience in years past and the good that has been done for other children, the 31 months have reason to hope this clinic will diagnose, then help remedy, their children's reading problems.

Late in 1960 results of this program will be published.

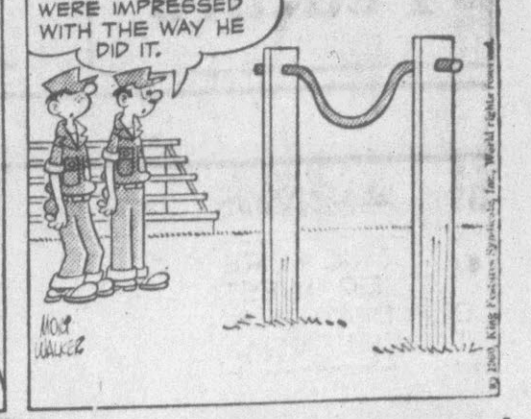

Atlas Guidance System Tested

CAPE CANAVERAL, Fla. (AP)—A block-busting Atlas rumbled 5,000 miles down the Atlantic missile range today in a successful first test of the missile's new inertial guidance system.

The Air Force reported the guidance performed as promised—re-entry body into an intended impact area off the South Atlantic island of Ascension.

The big rocket was launched despite a machinists' strike which has hampered Convair operations here for five days. Convair, which makes the Atlas, used several supervisory personnel in positions normally manned by union workers.

Other unions have joined machinists in refusing to do work for the company here.

Pouring a stream of red-orange flame from its powerful engines, the 85-foot plant rose smoothly from its pad, arched high in the sky and sped down range at speeds expected to reach 16,000 miles an hour.

The Air Force considered this test of the inertial (built-in) guidance a key one in moving the Atlas nearer the ultimate, quick-retaliation role for which it is designed.

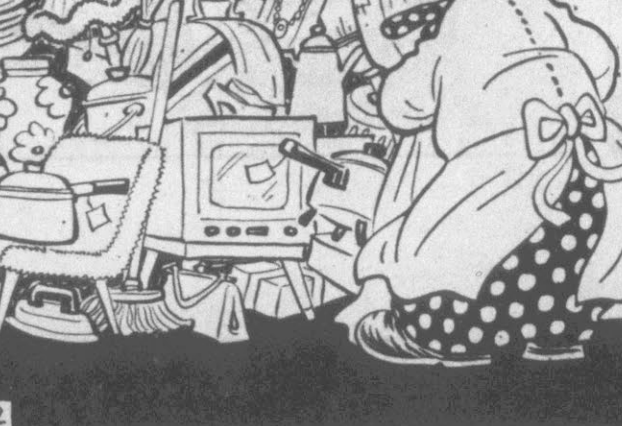

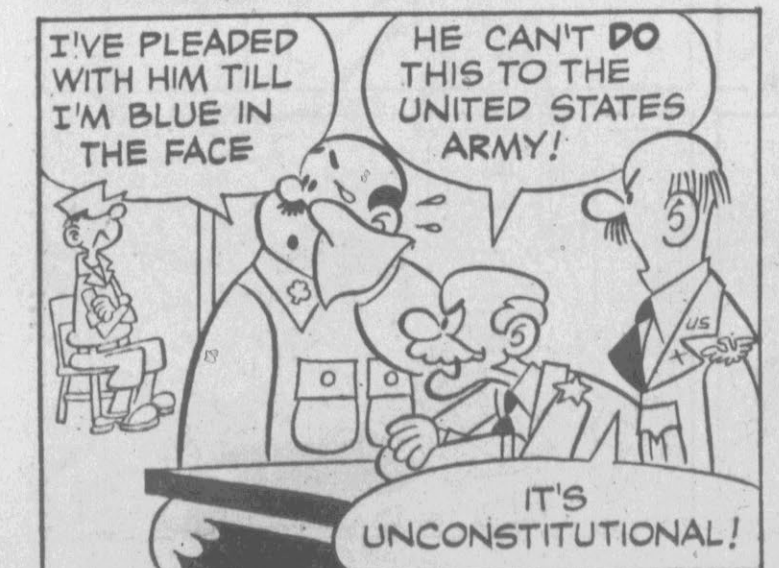
