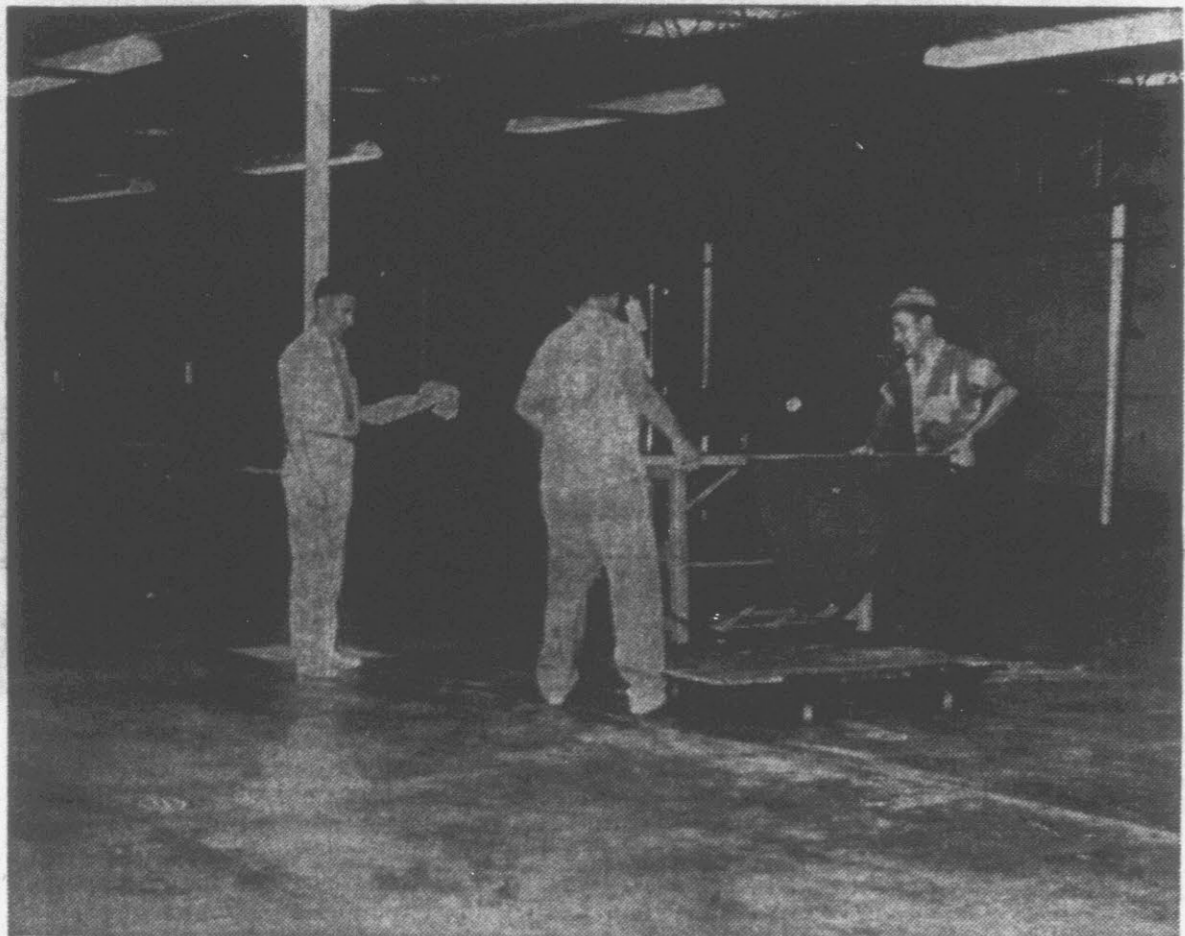


Plant Moving Into A New Home

Plant Is Moving In New Quarters

GRIFTON—The Grifton Clothing Co. yesterday began the week-end-long task of moving its entire operation into a new quarter-million dollar industrial plant.

When the production day ended at 4:30 p.m., a pair of large vans and organized working crews began loading 50 sewing machines, tons of finished garments, and more tons of material and equipment into the trucks for the half-mile journey to the 50,000-square-foot plant on the south side of E. Queen Street here.

# Wants Churches To Stay In The Cities

DALLAS, Tex. (AP) — Should downtown churches move to the suburbs to get away from the blight of housing and cold business buildings?  
No, says the Rev. Dr. W. A. Criswell, pastor of the biggest Baptist church in Texas.  
In fact, the Rev. Dr. Criswell's First Baptist Church of Dallas is sinking its roots even more deeply into the area around Ervan and San Jacinto streets in the shadows of skyscrapers.  
And it sends buses into nearby low-income districts to bring more underprivileged people to church.  
The emphasis is on youngsters. The church has become a haven for boys whose bare feet show through tattered shoes and girls who stare wide-eyed at the church's beautiful paneled walls.  
First Baptist is worth about 10 million dollars, which makes it one of the wealthiest churches in the nation.  
Recently, it paid a million dollars for a building across the

street to add to its extensive facilities, which include a gymnasium, bowling alleys and a skating rink.  
The work among the underprivileged is supervised by First Baptist's Good Shepherd Department, which has its own minister — the Rev. Johnny Barrett — and its own staff.  
But much of the day-to-day work is done by members of the church.  
Junior deacons, among them some of the wealthiest men in Dallas, drive the buses that pick up the children and their parents.  
The Rev. Dr. Criswell believes that churches have a clear duty to serve downtown areas.  
"Pressed against the downtown heart of any city is a large area of declining properties that are rented to the poor," he says. "The downtown church has a God-given commission to minister to these people."  
In ministering to them, First Baptist wins many as members.  
But quite a few prefer to stay with the Good Shepherd Department, who ministers to crowds of 500 or more with an assist from a corps of 70 Sunday School workers.  
The Good Shepherd Department began several years ago when C. F. Burch, then a new member of the church, dedicated himself to service in the underprivileged areas.  
With four other men, Burch brought boys and girls to the church basement where they were fed and taught Bible lessons.  
Now the department has its own building, minister and three large buses.

# Entertaining? What Are You Serving?

(Editor's Note: The recipes used in the article below have been compiled from the Associated Press Food Editor.)

Now and for the next few months the bride is the center of attraction. Friends and relatives are busy planning and preparing bridal showers, luncheons, afternoon teas, and other pre-nuptial events.

With these perennial parties popping up, the first question comes to mind is what to serve? Authorities on pre-nuptial etiquette say that refreshments for this festivity—whether it is a luncheon or supper, afternoon or evening snack—should be light.

For luncheon or supper the hostess should consider serving soup, sandwiches, dessert and a beverage; for the afternoon or evening snack affair omit the soup.

If the day is cool and you want to serve a hot soup you might use the excellent shrimp or oyster varieties. For a cold soup you'll find vichyssoise (available in the can) and the Spanish gazpacho (made at home) extremely popular.

Fresh strawberries with angel-food or individual indented sponge cakes and ice cream always make an easy-to-prepare dessert.

### Sandwich Variety Important

It is important to have at least one filling for your sandwiches which is a variety—such as tuna—that practically everyone likes.

The tuna filling should be savory but smooth so it will make trim and easy to manage sandwiches. To decorate the tray attractively, carrot rolls with sprigs of water-cress in each, radish roses and olives can be used.

### Eight Sandwich Cuts

There are eight ways in which you might cut sandwiches to vary them attractively. For sandwiches, trim crusts from standard-size thinly sliced bread, fill and cut as follows:

Four equal-sided triangles: from two corners cut on the diagonal to opposite corner.

Three rectangular strips: cut lengthwise into thirds.

Eight small triangles: same as number 1; cut each of the four triangles in half from point to center of opposite side.

Six squares: same as number 2; cut each of the three rectangular strips in half crosswise.

Six long squares: same as number 2; cut each of the three rectangular strips in half lengthwise.

Four squares: from center of two sides cut to opposite center side.

Two triangles and one pointed strip: cut on the diagonal into thirds.

Two triangles and two "house-shaped" pieces: same as number 7; cut the center pointed strip in half crosswise.

### Party Luncheon Loaf

This sandwich loaf to be served at a buffet luncheon or afternoon tea can be decorated imaginatively and will influence cooks.

You might like to welcome the guests with a basil-flavored consomme and crisp crackers.

For every five half-cupful servings, use one can (10½ ounces) of condensed consomme and one soup can full of water.

Knife-sliced three large fresh basil leaves, add to the soup, and simmer for 10 minutes or until there is a pronounced herb flavor.

Strain the consomme and, if you like, add a tablespoon or two of dry sherry. Serve in small pretty cups.

Dessert on this menu can be a combination of fresh fruit and thin crisp cookies.

### Loaf Recipe

Ingredients: 1 loaf unsliced white bread, butter, pimiento-nut filling, curried egg filling, stuffed olives, deviled ham filling, 1 package (8 ounces) cream cheese.

Method: Trim crusts from bread; slice loaf lengthwise into 4 layers. Spread each layer with softened butter. Spread bottom layer with pimiento-nut filling; top with second bread layer and spread with egg filling. Arrange row of stuffed olives down center of this layer; place next layer on top and spread with ham filling. Top with remaining bread layer, buttered-side down. Wrap loaf firmly in aluminum foil or waxed paper. Chill.

Unwrap and "frost" with cream cheese, moistened with milk or mayonnaise; chill until serving time. Use canned mushroom slices, crisp greens, cucumber wheels or other garnishes to make loaf pretty.

Pimiento-Nut Filling: Mix 1-3 cup chopped nuts (almonds or pecans or walnuts) and 2 diced pimientos with one 3-ounce package of softened cream cheese. Add 2 tablespoons mayonnaise and salt and pepper to taste.

Curried Egg Filling: Chop 4 hard-cooked eggs and add mayonnaise to moisten. Season with ½ teaspoon each salt and curry powder and a dash of pepper.

Deviled Ham Filling: Blend one 4½-ounce can deviled ham with a little mayonnaise; season with prepared mustard and dash of pepper.

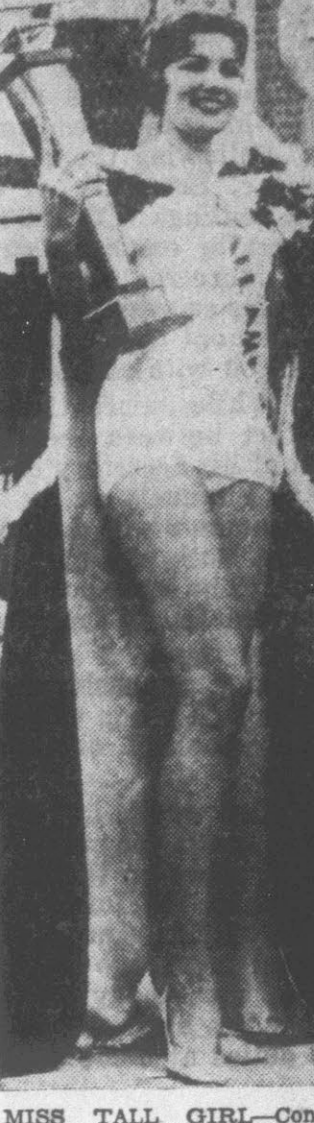

# New Burden For Heads Of State

The growing question of whether international affairs of the modern world can best be handled through traditional diplomatic channels or by top leaders of nations at frequent summit meetings is one which requires increasing attention.

Following the blow-up of the Paris summit conference, Secretary of State Herter announced that U.S. dealings with international matters would revert to greater emphasis on the regular diplomatic channels. More recently President Eisenhower has said he feels his successor will be required to follow his course of frequent trips to other countries, and probably will be faced with attending summit conferences.

While unintentional, there appears to be a basic conflict between the statement of the President and that of his Secretary of State. Either the regular diplomatic channels or the top level conference between governments will dominate international affairs in the future. Both will play a part in international negotiations, to be sure, but sooner or later, one mode will be subordinated to the other.

On the basis of past experience, it appears that a greater emphasis will be placed on the face-to-face meeting of heads of governments to iron out international problems, or at least set the stage for their solution.

The world, in recent years, has become a relatively small community of nations. In many respects it has taken on the attributes of a neighborhood rather than the former vast concept of the globe in terms of time and distance. National capitals which several years ago were days or even weeks apart in travel time today are a relatively few hours apart. While the head of a nation was not expected to leave his duties at home for a month or several months to

visit heads of other nations around the world, today representatives of governments may gather in any part of the globe on a day's notice and back in their respective capitals a day or two later.

As technological advancements draw the world into a tighter group of nations in terms of time, friendships will require greater support in terms of personal contacts and across-the-table discussions of common problems. The increasing exchange of visits by officials and citizens of various nations will require a more frequent exchange of visits by the heads of state.

Such a development will thrust a greater burden for the implementation of international policies as well as for the formation of policies on the heads of state.

Traditional channels of diplomacy will continue to be important, but the conference of the heads of state will play an increasingly important role in international affairs.

While most citizens recognize the fact that many trips by members of Congress are essential to carrying out the business of the government, it is not surprising that lavish living, bar bills and lack of record-keeping on these tax-paid expenses have brought about a certain amount of resentment. As the peoples' closest contact with the federal government, members of the House of Representatives are looked to for keeping government waste of tax dollars at a minimum. They are looked to for setting by example economy measures which will be followed throughout the government in spending tax dollars.

Such being the case, it is essential that members of the House keep accurate records of the tax money they spend for congressional trips. It is also essential that they spend only a reasonable amount. The money, after all, belongs not to the Congressmen personally, but to the taxpayers just as much so as any other government money. Not only will the new regulations encourage greater economy in this particular category of expenditure, they will also afford greater protection for the individual congressman whose record of expenses may be questioned at some future date.

# Next 4 Years In N. C. At Stake

PARTY CONTROL — Whether or not it is true, as some have insisted, that "the future of North Carolina rides on the next four years certainly is at stake."

Pursuant to requirements of the Plan of Organization of the Democratic Party in North Carolina, the 110 delegates to the national convention have been called to meet in Raleigh on Monday, June 27, to select a chairman of the delegation and to nominate a man and a woman for membership on the national committee. It is a foregone conclusion that Governor Luther Hodges will be named as chairman of the delegation.

Very little has been said about who might be nominated for the national committee posts. Incumbents John D. Larkins, Jr. and Mrs. B.B. Everett both have indicated desire to be relieved of their duties. That desire was expressed before results of the recent primary made it of little consequence.

Wishes of Senators Sam Ervin and Everett Jordan will be considered, but traditionally the recommendations of the Governor-nominate will have more influence. Membership on the national committee will carry more prestige with a Democratic administration in the White House, which seems very likely next year, but still is of less importance within the state than chairmanship of the State Democratic Committee.

That position will be filled at a later meeting of the State Executive Committee to be called by incumbent Chairman Woodrow Jones, probably in late July or early August. The Plan of Organization requires the chairman to call a meeting "as soon as practical" after the state convention. Because of the primaries and the national convention the earliest practical date would be after July 25th.

CHAIRMAN — The chairman is the official director of the General election campaign. The committee technically elects him. Actually he is appointed by the Governor. Custom for many years has been for the successful candidate for Governor to name his primary manager as state chairman. If Terry Sanford wins in Saturday's primary, the next State chairman is almost sure to be Bert Bennett of Winston-Salem. If Lake wins, the chairman most likely will be Robert E. Morgan of Lillington.

Prospects for vice chairman, who will be a woman, gets into

the realm of pure speculation. Many women have been active in both Sanford and Lake camps, but none has been sufficiently outstanding to indicate assurance of selection for the second highest place in the party organization, the position now held by Mrs. Mary Laurens (J.T.) Richardson.

All of these positions are part-time, non-salaried jobs. The Democratic Party in North Carolina pays some expenses for its officers when engaged on party business, but pays no per diem or salary.

The party maintains headquarters offices in Raleigh with a paid secretariat. Authorization was granted several years ago for employment of a full-time field man as an assistant to the chairman, Everett Jordan. John Larkins and Woodrow Jones, in successive chairmanship positions have not seen fit to effectuate that provision. Sentiment in favor of it is building up, and the next chairman may put it into effect. Many Democrats feel a permanent full-time man would make collections easier, assure larger attendance at party meetings, and maintain better spirit among the voters.

HODGES — There had been intimations of probable rivalry between Governor Hodges and the nominee of Saturday's primary for control of the delegation to the National Convention. The Governor told newsmen at his latest conference with them that while he naturally is interested in what the delegates do at their Monday sessions, his "interests" will have to be handled by friends. He will not be there.

Immediately after voting at Leaksville Saturday morning, he takes off by air for the National Governors Conference in Montana—which begins Sunday.

Asked if his interest included obtaining the post of National Committeeman he said it did not. Nobody has talked to him about it, and if they had he still would not be interested. He reiterated his support of Lyndon Johnson for the presidential nomination but believes the chances of any Democrat have been greatly enhanced by recent developments and continuing ineptness of the Republican administration.

He read and distributed a typed statement urging every citizen of North Carolina to vote, but flatly refused to discuss the second primary situation any further.

# Out Of Step On Political Issue

WASHINGTON (AP) — Former President Truman is away out of step with the presidential candidates of his own Democratic party.

Just a few days ago Truman made a plea for bipartisanship in foreign policy. He said he'd fuss with President Eisenhower "on local affairs but on foreign affairs people ought to back him up."

But before and after he said it the Democratic candidates were already lacing into Eisenhower's handling of foreign affairs, making it clear that they consider foreign policy a major issue in the 1960 campaign.

The one candidate who'd be happy if all Democrats shared Truman's view is Vice President Richard M. Nixon who, since he was so much a part of the Eisenhower administration, will have to defend it from attack.

There's Sen. Lyndon Johnson of Texas, majority leader of the Senate Democrats. Until recently he was playing the role of the great pacifier and spreading oil on troubled waters. He tried to quiet Senate criticism of foreign policy after the U2 plane incident.

But Sen. John F. Kennedy of Massachusetts, the Democrats' front-runner for the nomination, wouldn't listen and went along merrily blasting Eisenhower's handling of foreign affairs. Johnson either because he changed his mind or thought he'd better get moving if he hoped to stop Kennedy, began booming the foreign policy issue himself. Now he's calling the Eisenhower foreign policy a policy of "drift" and is accusing the administration of a "depressing lack of new ideas."

On June 14 Kennedy not only went after the Eisenhower foreign policy but produced a detailed foreign program of his own.

He said the real issue of foreign policy is: "The lack of long-range preparation, the lack of policy planning, the lack of a coherent and purposeful national strategy backed by strength... As a substitute for policy, Mr. Eisenhower has tried smiling at the Russians; our State Department has tried frowning on them; and Mr. Nixon has tried both. None has succeeded."

The story of Helen Keller's life should be one of real inspiration to those who must overcome handicaps.

For she started life with no way to communicate with others beyond her sense of touch.

From then on Miss Keller devoted her life to helping other handicapped persons.

In 1915 she helped raise funds for the American Foundation for Overseas Blind. In 1919 she appeared in the Hollywood made film "Deliverance."

In 1921 the War Relief Fund was reorganized as the American Braille Press for War and Civilian Blind and Miss Keller became staff consultant.

She made her first European tour in 1931 and was decorated by King Alexander of Yugoslavia. She traveled to Japan in 1937 on the peaking tour in behalf of the blind. She met Katharine Cornell in 1939 and they became close friends.

In 1945 the American Braille Press was reorganized as the American Foundation for Overseas Blind and Miss Keller became counselor on International Relations.

She toured Europe in 1946, Japan in 1948, Africa, and the Middle East in 1951 and Central and South America in 1953. June, 1954 she received the Alumnae Achievement Award from Radcliffe College. That same year "The Unconquered" her film biography, produced by Nancy Hamilton and narrated by Katharine Cornell received the Academy Award for the best documentary film of the year.

local boards to accept Federal directives and supervision.

Already, local boards are pretty well under the thumb of State school authorities. An example of this came to light in Henderson only this week. The city board approved plans for a building at Henderson Institute, but it has to go to Raleigh for approval there before a single dollar can be spent, even though the dollars are provided locally. Under Federal aid that directive will either be transferred to or shared by Washington, and between the two, local authority will become no more than a puppet or a stooge of outside planners.

This is wrong because it both kills local incentive and transfers decisions to the professionals, who will bring up the young people in the ideologies that sort of spirit is already noticeable in some instances, where students, as a result of what they have been taught, are hostile to free enterprise and the basic principles of the American way of life.

# Other Editors Saying... Regimenting Minds

Advocates of Federal aid to education have won the first round of their long struggle to gain control of the public schools. The House and Senate have passed separate bills which would permit the central planners to get a foot in the door. The rest will come later, and local school authorities will trelk along with the idea, if indeed they do not lend it all the aid possible in the hope of profiting thereby.

When the bureaucrats in Washington subsidize the schools, they will ultimately regiment the minds of the children, rendering them incapable of maintaining an economic system like ours, which is based upon competition and free consumer choice.

Once Uncle Sam takes a seat on the local school board, all assurances that he will be a mere onlooker had as well be forgotten. He just doesn't operate that way, as the regimented farmers can go convincingly testify. Once control passes from the local school boards to State and Federal authorities, all incentive on the part of the home town officials will pass, and the Washington hierarchy will move in. Bureaucrats will determine the curriculum, fix salaries and dictate innumerable other details. This new system then would be free to shape young minds in the way the planners direct. It would be the death knell of the free market economy.

Subsidy for teacher salaries would pave the way for certification of teachers, standardization of courses and teaching methods, and injecting the socialist and communist ideology as desired.

With professional educators and a well-entrenched educational bureaucracy in the saddle through Federal funds, every school board would be compelled to knuckle under to Washington. Federal bait money would be used to coerce all

local boards to accept Federal directives and supervision.

Already, local boards are pretty well under the thumb of State school authorities. An example of this came to light in Henderson only this week. The city board approved plans for a building at Henderson Institute, but it has to go to Raleigh for approval there before a single dollar can be spent, even though the dollars are provided locally. Under Federal aid that directive will either be transferred to or shared by Washington, and between the two, local authority will become no more than a puppet or a stooge of outside planners.

## Was Johansson Under Hypnosis?

An interesting story on the Johansson-Patterson fight came in over the wire this week but due to the heavy run of copy and limited amount of space, it was pushed off the sports page.

It quoted a leading expert on hypnosis who said Ingemar Johansson "could very possibly have been in a hypnotic state" during the title bout with Floyd Patterson.

"Johansson's reactions seemed subnormal throughout. He appeared dazed in the ring and later when I saw him in the dressing room," says Dr. Ralph Slater, president of the International Academy of Hypnotism.

"As Johansson came into the ring I noticed that he stumbled slightly," continues Dr. Slater. "Then he smiled almost all the way through the fight. "Also for one in Johansson's excellent condition, he was on the canvas for an unusually long time after being knocked out. This could have been the result of a post hypnotic suggestion."

There were rumors Ingo was hypnotized by his personal physician, Dr. Gusta Carlsson, before knocking out Patterson in the first match last June.

"The form of hypnosis Johansson received Monday night could have been very mild," says Slater. "Maybe they underestimated Patterson this time. In their first fight, Johansson may have been put in a somnambulist, very deep state and this could have had a violent reaction and made him a tiger in the ring."

"Hypnotism can do several things to a fighter. It can give him more confidence, make him immune to pain and speed his senses considerably. It can work the other way too if given in a milder form."

If hypnosis has been employed in the fight game, it is another vice that could continue to help tear down the boxing game which has already lost so much popularity due to fixed fights and underworld control.

## Palmer, Snead Hold Canada Cup Leadership

PORTSMOUTH, Ireland (AP)—A grim individual rivalry between Arnold Palmer and Sam Snead could well fire the United States to its first team victory in the Canada Cup golf tournament since 1956.

Even Irish fans have noticed that Snead is going all out to beat Palmer, reigning U. S. and Masters champion, in the race for the individual title and Arnold is just as anxious to outshine Sam.

The rivalry inside the American team could give the Yanks their first victory since Ben Hogan and Snead paired in a Canada Cup team triumph four years ago.

This is the way the two Americans have been scoring since the tournament started two days ago: On the first day Palmer shot a 69 and Snead a 71. Friday Sam rallied with a 68 and Palmer took 71.

This was enough to give the Americans a three-stroke lead over Ireland going into today's third round. Palmer and Snead have a combined score of 279 after 36 holes. The Irish have a team score of 282. South Africa is third with 284 followed by Australia with 286.

Snead is 48, winner of more than 100 tournaments, and a legendary figure in the game. Palmer is 30, and moving in on Snead as a world favorite.

## Ferrari Picked In Sports Car Race

LE MANS, France (AP)—The toughest sports car race in the world—the 24-hours of Le Mans—started today amid a talkfest of controversy.

But nothing dampened the spirits of upwards of 200,000 racing fans who already have turned this normally sleepy city into a carnival revel.

## John Thomas Tops Height Scales Again

BAKERSFIELD, Calif. (AP)—John Thomas, a young man with spring in his toes and summer on his mind, today has a new claim to lay before the high tribunal of high jumping.

The long, lean teen-ager from Boston University cleared 7 feet, 2 inches at the National AAU Championships Friday night, becoming the first jumper in history to scale that height outdoors.

But the summer is just beginning for the handsome, 19-year-old Negro, who will enter what he calls "the big one" next week and an even bigger one at the Rome Olympics in August.

Next week's show is the U.S. Olympic tryout final at Palo Alto, and Thomas' chances of qualifying are just about unqualified.

The AAU meet, a generally unspectacular affair except for the towering leap by Thomas, winds up this evening. Sprinter Ray Norton, of Santa Clara, who won the 100-meter final Friday night, is performing near his peak and could steal much of the show with a victory tonight in the 200.

Thomas took three shots at 7-2. He appeared to make it on the second, but the bar came down moments after he did. The judge said Thomas made it, but AAU trackand field Chairman Pincus Sober overruled him.

Thomas wouldn't say he cleared the standard easily on his third try. "But I didn't just make it over either," he said.

Sober, the first man to reach Thomas after the successful jump, said: "There's no question about it this time."

"I just had to make it," Thomas said later.

"The second time," he said, "I cleared it and the wind knocked it off. I felt bad for a minute."

Thomas, who has gone 7-2 1/2 indoors, said the last jump took so much out of him that he didn't feel like trying for anything above 7-2.

Asked how high he figures he can go in the next few years, Thomas responded elusively: "I can keep going up until I miss."

John's jump was a full inch better than the recognized world record, set by Russia's Yuri Stepanov in 1927, and a quarter of an inch better than Thomas' previously pending outdoor record. His indoor mark cannot be recognized.

The only other man to come really close to world record Friday night was hammer-thrower Hal Connolly. Connolly had a sore back—so sore he pulled out before the finals—but in one of the heats he heaved the ball and chain 224 feet, 4 1/2 inches—just 1 1/2 inches short of the world record he set here two years ago.

## Thomas Is Low Amateur As Al Smith Posts Win

NEW BERN, N.C. (AP)—Al Smith of Danville, Va., deadlocked with Hal Kneece of Greenville, S.C. for two rounds in the Carolinas Open golf tournament, finally broke the tie Friday with a birdie putt on their fifth extra hole and won the championship.

The two were tied at the end of Thursday's second round with 136 totals. After Friday's final round each had 208. They halved four extra holes in a sudden death playoff.

Then on the fifth hole Kneece put his second shot into a bunker, took two to get out and putted short. LOS ANGELES (AP)—The tax man is after two dozen Hollywood stars, film executives and sports figures — seeking payment of more than \$400,000 in federal income taxes.

Liens were slapped against the entertainers and celebrities Friday by Robert A. Riddell, district director of the Internal Revenue Service.

High man on the list was comedian Bud Abbott. Riddell said Abbott owes the government \$124,531, and said there are separate liens of \$41,468 against both Abbott and his wife, Jenny Mae.

Among other whopping liens were those for \$30,918 against Sammy Davis Jr.; \$25,736 against his musician father; \$23,028 against comedienne Carol Channing; \$21,074 against director George Marshall and \$18,000 against director Edward Dmytryk.

Riddell said the liens represented either disputes between the government and the parties over tax owed, or taxes which the individuals were unable to pay.

Among sports figures caught by Riddell's liens was former heavyweight champion Joe Louis. A weight \$16,416 was fined against his former welterweight contender Art Aragon was hit for \$4,389.

Writers also came in for Riddell's attention. He filed a lien for \$5,035 against W. R. Burnett and one for \$7,348 against William Saroyan.

He was removing it himself, using a screw driver, when the weapon discharged. The barrel was pointed at his chest. The bullet pierced his chest. Jackson said death was almost instantaneous.

Coroner Bill McLean ruled it a case of accidental death.

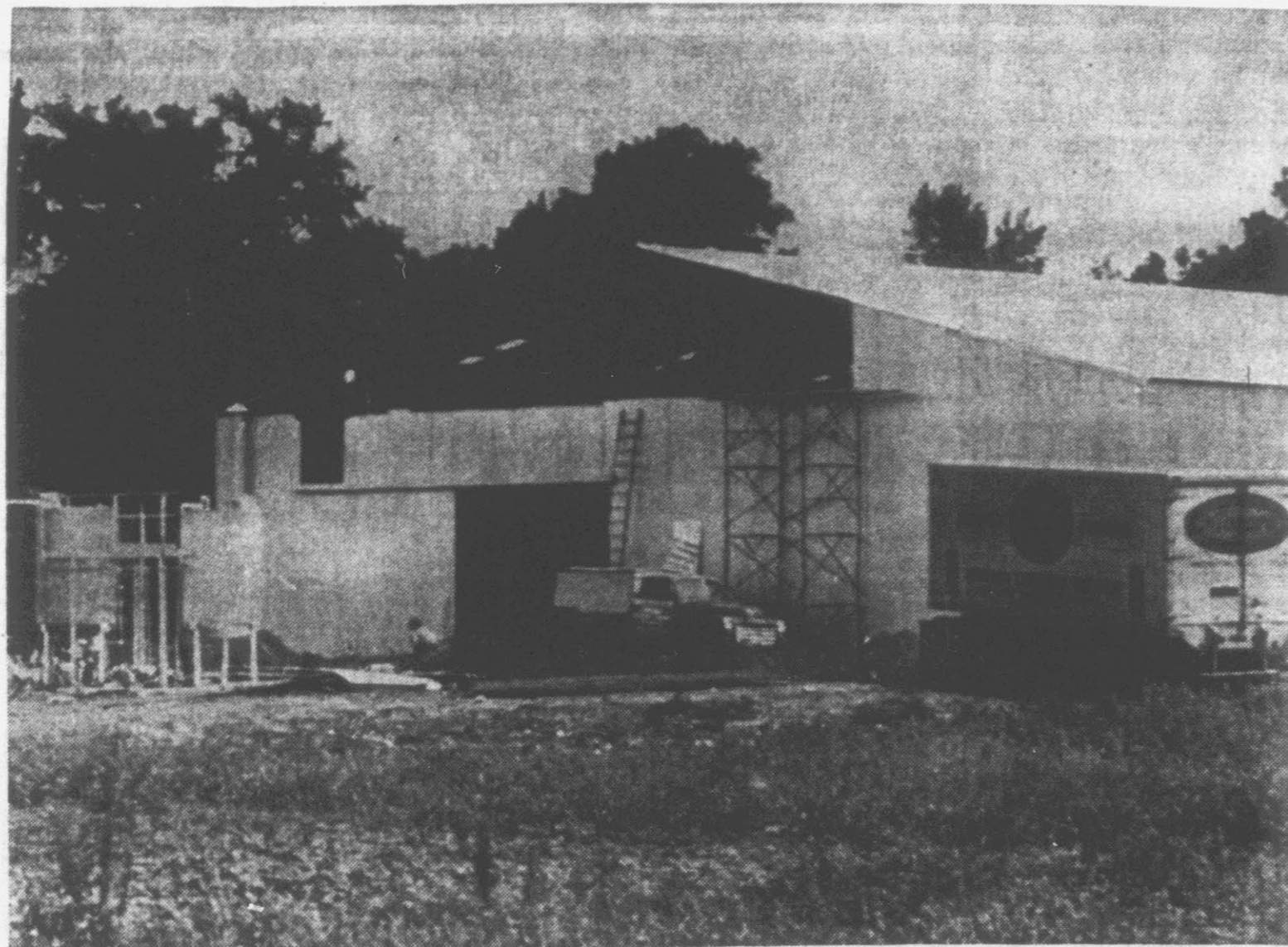

AYDEN—Within the limits of the town of Ayden—which may be called a small town of 3,096 population—there is a beehive of business activity. The Free Will Baptist Press publishes all the literature for the denomination, which goes out to some 41 states, including Alaska and Hawaii. The Smith Lumber Yard has a claim to the unique: they manufacture bed slats. There are few lumber yards in this state that manufacture bed

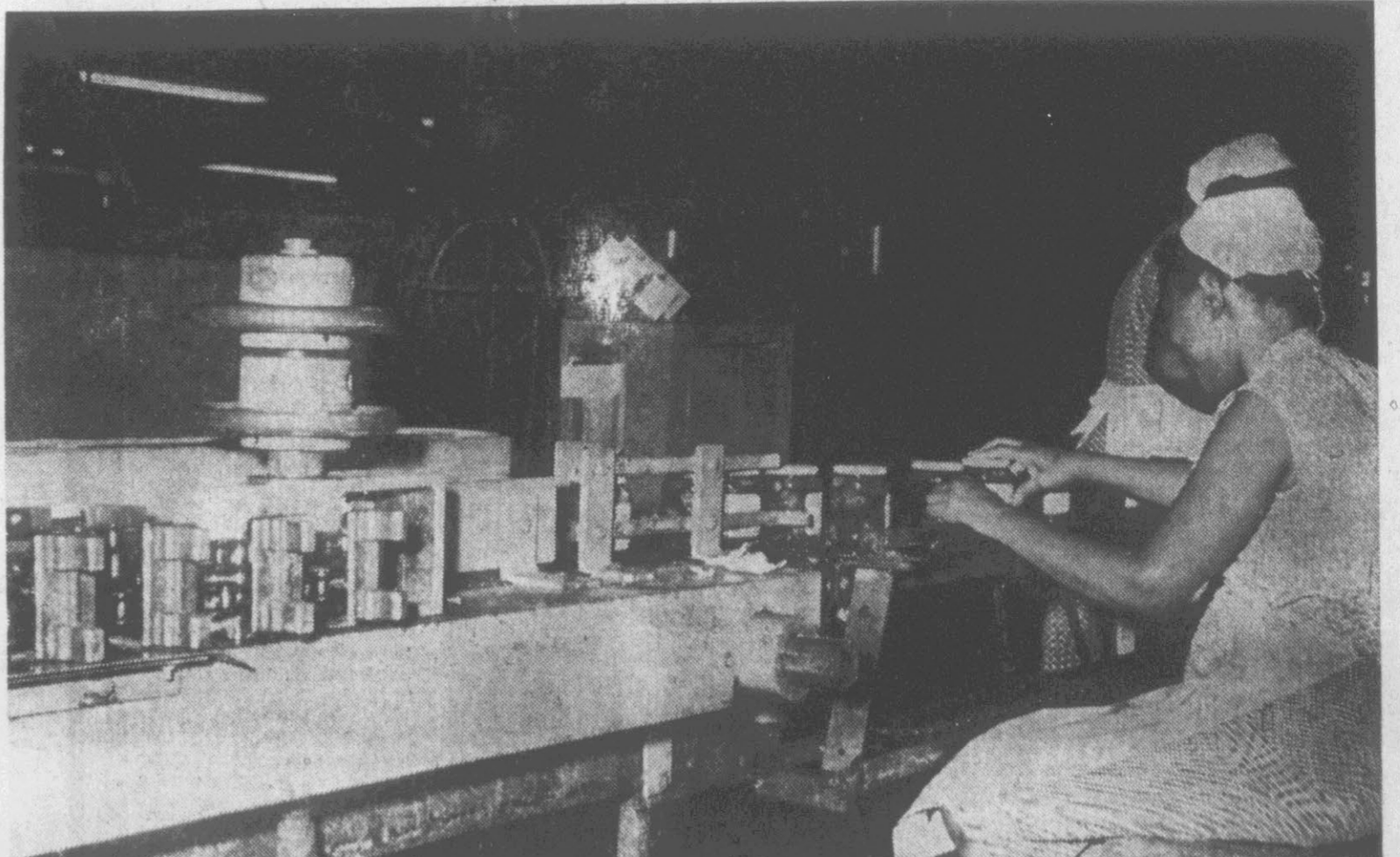

slats, and yet, where there is a bed, there must be bed slats. Tyndall - Boyd - Stroud Co., Inc., wholesale merchants, are pioneers in the Ayden area and are the only wholesalers of their type in Ayden.

A new, modern pesticide plant has just begun operations here, called the Niagara Chemical Division plant. The new unit will produce a wide range of pesticides to meet needs of farmers not only in this area, but all over the Carolina, southern Virginia, eastern portions of Maryland and Delaware. Lutz and Schramm pickle plant, whose pickles are distributed to other states, is a subsidiary to Beatrice Foods Co. They make sweet, sour, dill, and fresh packed, or the kosher dill, pickles.

The trucking business, though under no one big name, plays an important part in Ayden's economy. Numerous independent truckers who are located in Ayden contribute substantially to the income of the town. Ayden, a busy town, has assets to boast that belong to the city itself, such as a perfectly florid municipal water system, Town Manager Cleveland Paylor says. It consists of four deep wells, with a 300,000 gallon-tank included in the system.

The town offices themselves have been enlarged and remodeled this year, providing new and modern space for the mayor, town manager, and a meeting room for the town aldermen and others.

A Jaycee Park has been provided on the outskirts of town, going toward Greenville, by the Ayden Jaycees. There are numerous other industries which also contribute to the welfare and the economic success of the town.

### Free Will Baptist Press

The Free Will Baptist Press, which serves the Free Will Baptist denomination in publishing supplies as well as other churches and local interests, is the widest in scope, perhaps, of any business in eastern North

### Carolina.

The background of the Free Will Baptist Church was written here many years ago, when the first church was organized in this area, J.O. Fort, manager-editor says. Though the original publishing place was located in several different towns, it came to Ayden in 1895 and has remained within the town limits since.

Among publications for the Free Will Baptist denomination are: Sunday School literature for all age groups and the teachers' quarterly for all age groups; books, pamphlets and other promotional literature for the entire denomination; weekly religious magazine called "The Free Will Baptist," the youth paper, called the "Youth Banner;" minutes for conference conventions throughout the denomination.

In addition, the Free Will Baptist Press does commercial job printing, Fort said, and does any publicity matters for any church group. Its religious book store serves the denomination, also, and is the only religious book store east of Raleigh in the state. It also publishes the literature for the Negro Free Will Baptists of the nation, whose office is Winter Haven, Fla. There is a large mail order business through catalogues, Fort said.

A unusual feature of this particular firm is that it is the sole publisher of church literature of the North Carolina Prison System, a contract held for about a year and a half.

In monetary terms, the volume of business may be measured in terms of the \$8,000 paid for postage per year; or by the fact that already this year, the firm has exceeded \$250,000 in business.

But the Free Will Baptist Press is a non-profit corporation, governed by a board of directors elected by the stockholders annually.

### Smith Lumber Yard

The Smith Lumber Yard, owned and managed now by Robert Paul Smith, was found-

ed by C.E. Edwards years ago in Ayden.

Smith says he knows of only two lumber yards throughout the state which now manufacture bed slats in addition to the other wood products. "The furniture people make beds but do not furnish slats," Smith says.

His firm furnished the slats to furniture stores from Durham to Edenton, within a 100-mile radius of Ayden. But flooring, base boards, and all other building materials of wood are manufactured here, too.

The lumber yard has been situated on the same location for 35 years. This year, there was such demand for the bed slats that Smith sold completely out.

### Pioneer Merchants

The Tyndall - Boyd - Stroud Co., Inc., had its start in 1919 in Ayden, with members of the present Stroud family in the business. Today, O.C. Stroud and Walter Stroud, brothers, are owners and managers, with equal rank, in the same business.

This wholesale merchant's firm was a pioneer in the wholesale business in the Ayden area, and still is the only firm of its type in Ayden.

Among items handled by the Strouds are wholesale groceries, building materials and farm supplies. They handle about 4,000 different items in sizes, such as roofing materials from Pennsylvania, flour from Michigan and rice from as far as Arkansas. A warehouse of about 15,000 feet of floor space takes care of the items, the Strouds said.

Covering a radius of about 45 miles of Ayden, the merchandise goes to Pitt, Greene, Jones, Lenoir, Craven, Beaufort, Martin and Edgecombe Counties, among others.

### Pickle Plant

The smell of fresh pickles permeates the air on the outskirts of Ayden's business and residential district, along highway 11.

All kinds of pickles are manu-

factured at the Lutz and Schramm Pickle Plant, the sweet, sour, dill, and also fresh packed, which is the kosher dill.

The pickles are made from cucumbers which are sold in seed form to farmers mostly in a 30-mile radius of the factory, in Craven, Lenoir, Martin and Pitt. The seeds are furnished by Lutz and Schramm, thus the manufacturers control the size, shape and color of the cucumber.

Lutz and Schramm pickles are represented in 26 different states and are shipped to North Carolina, Virginia, Florida, Georgia, South Carolina and Tennessee points, where they are received by the wholesaler who distributes them to stores. The balance of the states are serviced from the Pittsburg, Pa. main office and warehouse space.

Lutz and Schramm, a division of Beatrice Foods Co., regularly employs about 80 people. During the special green pickle season, however, employment jumps to 185. Lutz and Schramm is the only pickle plant of the Beatrice Foods Co.

### Niagara Chemical

A newcomer to the Ayden area, the Niagara Chemical Division has just completed its plant, which will produce a wide range of modern pesticides.

They will be used by growers in the Carolinas and also in Southern Virginia and the eastern portions of Maryland and Delaware.

The plant contains both dust mixing and liquid formulating facilities, which will be used in producing materials designed to control insects, weeds and crop diseases.

The plant, with an area of about 10,000 square feet, is located just off N.C. Highway 11 near the tracks of the Atlantic Coast Line Railroad.

Sales offices will also be located within the plant to serve this area. Niagara Chemical Division is a division of Food Machinery and Chemical Corporation.

### Wants Talks To Include Peiping

WASHINGTON (AP) — Sen. Hubert H. Humphrey (D-Minn.) has suggested to President Eisenhower that he seek to bring Red China into disarmament negotiations at Geneva.

"It would be foolhardy for the United States to enter into any substantial disarmament agreement without the inclusion of Communist China," Humphrey said. He spoke in the Senate Friday and also made public a letter to Eisenhower in which he outlined a new first-stage disarmament plan.

In addition to bringing Red China into the talks, Humphrey advocated prohibition of production of long-range bombers, under effective inspection and control. This, he said, would "halt production of one of the major means by which nuclear bombs can be delivered."

Soviet Premier Nikita Khrushchev has said several times that the Soviet Union will produce no more bombers and will rely entirely on intercontinental rockets as the means of delivering bombs. The United States, with its Strategic Air Command, still relies heavily on manned bombers for retaliatory punch.

Other points in Humphrey's disarmament suggestion included stationing of international inspection teams at all military bases, Soviet or Western, and a joint study with the Soviets of methods to halt production of fissionable material for nuclear weapons.

### Bethel Youth Is Chosen To Join In Science Study

BOONE — Sammy Dewar of Bethel High School, Bethel, has been selected to participate in the National Science Foundation's summer science training program at Appalachian State Teachers College July 18-August 19.

Fifty high-ability high schoolers were selected to attend the program from hundreds of applicants from Southern states. Dewar will be in the junior division of ninth and tenth graders who will work in physical sciences. Eleventh and twelfth graders will work in the biological sciences. Each course carries one unit of high school credit.

The cost, formerly borne by the National Science Foundation in its entirety, this year will be paid one-half by the Foundation and one-half by the student. This amounts to a \$70 grant per student.

Those selected for the program underwent a screening process based on character, personality, class rank, recommendations from science teacher, guidance counselor, principal and an additional teacher, aptitude and achievement tests, interviews and statement of future science interest beyond high school.

### Built A 50-Foot Ketch, Back At His Hillside Home

HOLLYWOOD (AP) — Remember the story about the guy who built the boat in his basement? Well, Vernon Armstrong didn't use a basement. He used a hollow in the hills, high above the Hollywood Freeway, and he's having better luck.

His boat is a 50-foot ketch, which weighs 12 tons and is expected to sail better than it rolls. It is rolling slowly toward Los Angeles harbor, mounted on a trailer and towed by a boat-moving firm.

Neighbors gathered to cheer Friday as the towering sailboat, named the Xcopade, began to move ponderously from its private boatyard near Armstrong's hillside home. It was slow work, but successful.

Armstrong, a motorcycle officer, says he and his family will sail the Xcopade to Hawaii when he retires in two years.

### New Bridge Off To A Bad Start

HOUGHTON, Mich. (AP)—The new Portage Lake lift bridge got off to a poor start Friday. It didn't lift in time.

The siege began three weeks ago. A part of the swarm took up residence between the inside and the outside wall of the breakfast nook.

"Bees scare me to death," said Vaughan, "but I managed to plug up the hole."

Then his troubles really began. The bees buzzed up a storm.

"It wasn't until about a day later that I realized what I had done. I had sealed the queen bee and about half the colony in my wall. The rest of the colony is on the loose, and they want in—bad."

Whenever the Vaughans make noise the bees attack the house. That's not the half of it. They keep a watch on the doors and "they smack up against the windows and get up and do it again," said Vaughan.

Experts tell him just to be patient and wait for the bees to die.

"I've been patient—I've waited three weeks," he sighed as the grass grew high around the house. "I want to mow my lawn, pick my apricots and spray my orchard."

### Might Replace The Lightships

SAN FRANCISCO (AP) — A combination light tower and helicopter platform is being considered to replace the lightships and pilot boats that greet incoming ships 10 miles outside of San Francisco Bay.

The plan was tested Friday morning when Capt. J. H. Sever was carried to the President Cleveland from San Francisco by helicopter.

The management firm of Chase, Ward and Gardner is studying the project under the State Board of Pilot Commissioners. The light tower would be similar to offshore oil rigs in the Gulf of Mexico.

Lex Ross has to talk with a gun aimed at him, as "Secret Mission to Bangkok" continues here tomorrow.

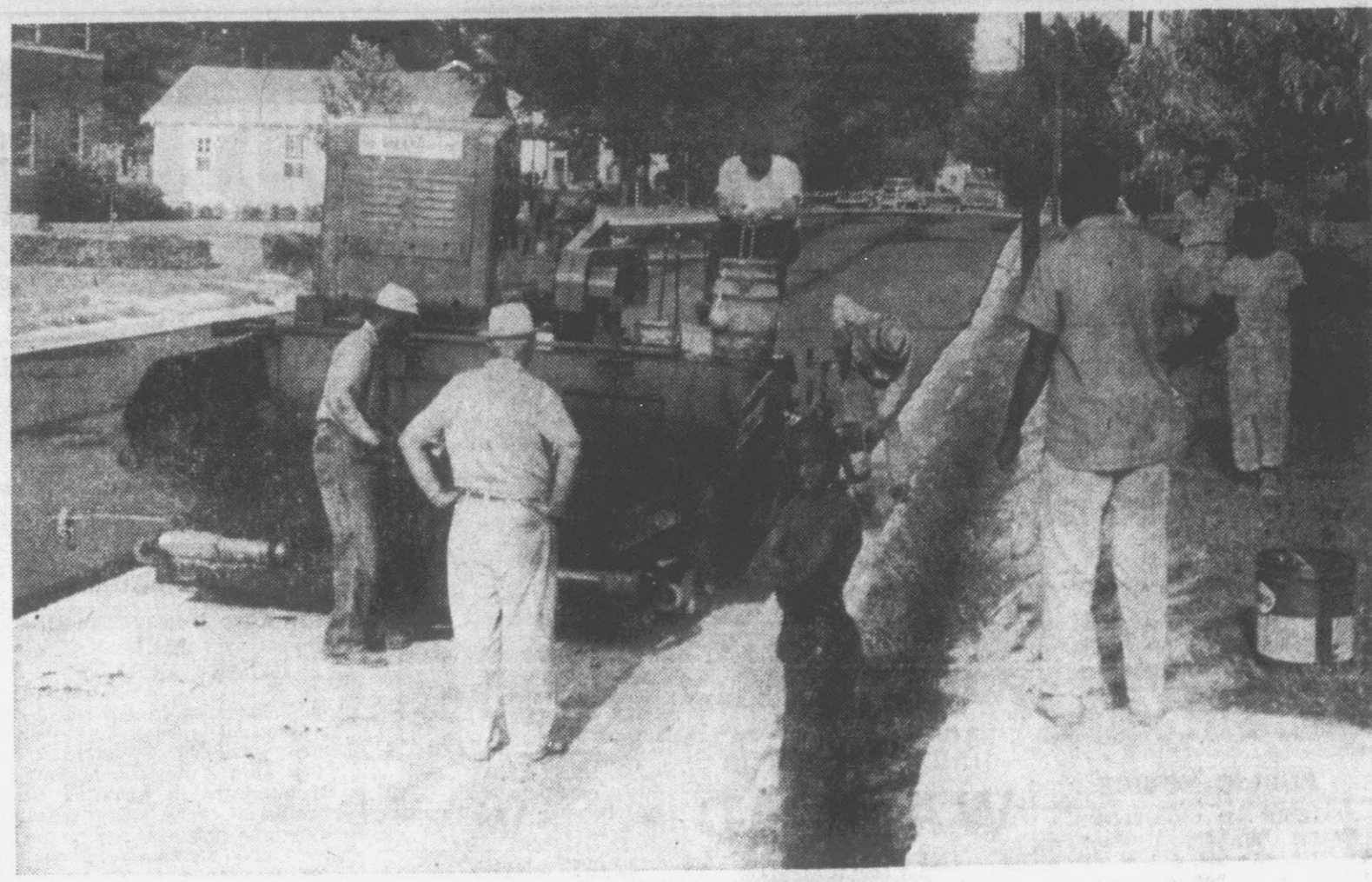
## Local Delegation Planning Attend July Convention

# Books & Stuff

Still up here in the north country, we enjoyed going to Commencement at Harvard a few days back. Both Jack Kennedy and Nelson Rockefeller were there—but not for political reasons, so they said. Kennedy was back for his 20th reunion—he was in the class of 1940—and Rockefeller was there to see his son graduate. Both potential presidential candidates mixed with the multitude of Harvardmen milling around in the famous "Yard" drinking beer and munching sandwiches—supplied free to all Harvard alumni who came back for the big day. . . .

At the Alumni Association meeting, with about 15,000 old boys in attendance, we heard Honorary degree winners Paul-Henri Spaak, Secretary-General of NATO, and Robert Menzies, Prime Minister of Australia, give stirring speeches for international unity and peace. The Association president also recalled how Harvard boys used to pay their tuition back in the 1600's when the college was just getting started—with pigs, casks of cider, and anything else that was handy. Quite a contrast to the several thousand dollars that a Harvard education—or any education—costs these days. . . .

Historical Note

Doing some research on 19th century literature in the Harvard Library, we came across an item of what we thought was considerable local interest. For several years along in the 1860's a magazine called LAND WE LOVE was being issued in Charlotte, N. C. Reviewed in the May, 1866, issue was a novel called "Nameless," by Fanny Murdaugh Downing, and A PLACE FOR MY HEAD, by

published in Raleigh. Probably none of you has ever heard of "Nameless" and we certainly haven't, but we thought the reviewer's comments had quite a bit of zest. He—or she—was glad that the tale ended well, even though it wasn't very true to life. "Now in these days of lawlessness," the review continues, "when robbery is protected and wickedness rampant, we are glad to see crime meet its deserved reward in the pages of a romance, if it meet it nowhere else."—A commentary on how things were in Tarheelia back in 1866.

The reviewer concludes that he's also happy about the "sound moralizing" of the book, because there's nothing in it which a prudent parent would wish his child not to see—something you can't say about many novels these days. He concludes with his regrets about the sloppy "getting up" of the edition, and hopes that publishing houses in the South will try to imitate those in the North in the care and attention they give to printing their books—which we think they have been doing for a long time now. . . .

More from the South

Speaking of southern publishers, we've just received the notices from Chapel Hill of their plans for fall publication out of the UNC Press. Featured for September is "THE SOUTHERNER AS AMERICAN," edited by Charles G. Sellers Jr. It's written by nine outstanding Southerners who try to prove that there isn't any difference after all between being a Southerner and being an American—something most of us will agree on. The book should contribute to a better national understanding of southern problems, which certainly is needed, especially up here in the north country.

Today's Review

WILLIAM HOFFMAN, 406 pp. Garden City, New York: Doubleday & Co. 1960

Timely, significant and beautifully written are three overworked words, but they assume fresh meaning when applied to this novel.

It is essentially a character study of Angus McCloud of McCloud, Va. He is a lawyer, the last of an aristocratic family. As the book opens he seems sunk in traditional southern apathy. The town stirs in response to new forces, changing patterns of race relations and northern industry, and Angus comes alive as a man. He attempts to meet each challenge with the weapons of his ancestors, honesty, integrity and fair play.

Most of the book seems to repeat William Faulkner's thesis: the poor white, the dirt farmer from the hills shall inherit the earth. Yet toward the end of the novel, one self-confessed opportunist says to Angus: "You're the one I fear, Mr. McCloud—I fear you because you care, really care."

William Hoffman does not attempt to solve the South's problems. He does state the problems honestly and gives us a graphic account of one honest man's struggle. The book is a restrained, moving picture of what is happening all over the South today. The thoughtful reader will catch uncomfortable glimpses of what we may expect tomorrow.
