Kennedy Takes Personal Charge Of Demo Machinery

LOS ANGELES (AP)—Sen. John F. Kennedy took personal command of the Democratic party machinery today after bluntly laying down the blueprint for a fighting campaign to carry America beyond the "New Frontier" into a space age he said demands "a new generation of leadership."

Morton, Republican chairman, said Kennedy's card cutting reference "was prompted by the fact that he has been playing with his own stacked deck at the Democratic convention."

He said the times demand "innovation, innovation, imagination, decision." "For courage—not complacency—is our need today, leadership not salesmanship," he said.

With the rolls still incomplete, the committee roster showed 41 changes in membership. Many of the departing members had been forced out in state committee voting when they declined to come out publicly for Kennedy in advance of the convention.

Kennedy Already Setting High Legislative Hurdles For Next Senate Session

LOS ANGELES (AP)—Sen. John F. Kennedy, in winning the Democratic presidential nomination here this week, set himself some high hurdles for the Senate session opening Aug. 8.

Kennedy already was intimately involved with two of the biggest measures awaiting Senate consideration—a broadening of the minimum wage law and enactment of a medical care program for the aged.

Kasper Freed

NASHVILLE, Tenn. (AP)—John Kasper is out of the workhouse and says it was worse than anything since 14th Century Spain.

It's a lot worse than the federal correctional institute in Tallahassee, Fla., he added, when released Friday.

The New Jersey-born race agitator spent six months in the workhouse for inciting to riot during school desegregation here in September, 1957. He served two terms in the federal institute for contempt of court during Clinton, Tenn., desegregation in 1956.

Kasper appeared thin. He said he missed a few meals after he was hit in the face by a guard. Warden L. D. Morrow said Kasper went on a hunger strike recently so he would look undernourished.

LOS ANGELES (AP)—Dixie take Southern voters for granted even with Johnson on the ticket. Before Sen. John F. Kennedy, the newly-chosen presidential nominee, picked the Senate majority leader for the No. 2 place on the ticket, several of the Southern governors were vocally pessimistic about the outcome of the election in the South.

Methodists Select Four New Bishops

LAKE JUNALUSKA, N.C. (AP)—Delegates to the Southeastern Jurisdictional Conference of the Methodist Church met here today to consider assignments for four new bishops elected Friday after two days of balloting.

Indications were that one of the new bishops elected Friday after Charleston, S.C., would be assigned the newly created South Carolina episcopal area with headquarters in Columbia.

The other bishops—elect, who will be consecrated Sunday night, are Dr. Paul Hardin Jr., Birmingham, Ala.; Dr. Walter C. Gum, Norfolk, Va.; and Dr. James W. Henley, Nashville, Tenn.

Members of the committee on episcopacy planned a 3:30 p.m. meeting and a conference with bishops of the jurisdiction to make recommendations on assignments.

Some reshuffling of the episcopal area boundaries could occur as a result of the creation of the new episcopal area of South Carolina which has been attached to the Charlotte area.

The conference, attended by some 2,000 Methodists, ends Sunday with the consecration ceremony.

The Southeastern Jurisdiction embraces Alabama, Kentucky, Mississippi, Tennessee, Georgia, Florida, Virginia, the Carolinas and Cuba.

Speaking to delegates Friday night, the white president of a Negro college called for a "repositioning of men" as a means of solving racial problems.

The speaker, Dr. Clayton Calhoun of Paine College, Augusta, Ga., said he was using the word "repositioning" because he wanted to avoid words "that make scare headlines."

He told fellow Southern Methodists there can be no communication between the races "when the

white man stands at the top of the stairs and the colored man at the bottom with his hat in his hand, both smiling, both fooling each other a little, but themselves not a little bit.

"If there is any efficacy in our religious teaching, any influence in our democracy, there must be a repositioning of men."

In other Friday night business, the conference adopted "the one per cent plan" for ministerial education. The program calls for each church in the jurisdiction to make voluntary contributions of one per cent of its operating budget to a fund for educating ministerial students.

Half of the fund will be divided between Candler School of Theology at Emory University and Duke University on the basis of the number of ministerial students enrolled. The remainder will be used for scholarships or grants-in-aid.

The jurisdiction also honored the Guntown-Satellite Circuit of Mississippi as the "Circuit of the Quadrennial." The award for general progress from 1956 to 1960 was received by the Rev. W. F. Appleby of Guntown.

Gas Explosion Sets Off Blaze

FORT DEVENS, Mass. (AP)—Six buildings—four barracks, a mess hall and an administrative unit—were heavily damaged by fire Friday after an explosion of a propane gas tank truck.

Two soldiers were hospitalized with burns. They are Pfc. Jimmy Jennings of Duncan, Okla., and SP 4 Paul L. Lawson of Gibbstown, N.J. A spokesman said their condition was not critical.

Twenty others were treated at the dispensary for minor burns. Six of these were relieved of duty temporarily.

The civilian propane truck, owned by the Ampropane Propane Gas Co. of Norwich, Conn., and a 2½ ton army truck were damaged by flames.

An investigating board will seek the cause of the blast.

# U.S. Ranch House Amazes British

LONDON (AP)—Something new to be seen in England is an American ranch house.

British who visit it at a big exhibition here have been conditioned by many Westerns, so they are surprised to observe there are no coiled lariats hanging from a spike on the porch.

Visitors are also learning that air conditioning and electric dishwashers have become standard equipment on the prairie, and that a sputtering barbecue dinner may be made indoors.

It is a full-scale, one-story, six-room house erected inside London's vast Olympia exhibition hall. The strange house from overseas is, so to speak, a guest of a lot of British houses also set up in an Ideal Home show.

There is, in this surprising New World house, an electric organ, in case any cowboy is talented musically, some British viewers suggest. There's also something which is appreciated in moist Britain—a mud room with plenty of hot running water where the young rascals of the family have to clean up before stepping to the tidy living room.

The house was brought to the London show by the National Assn. of the Home Builders of the U. S. A. Cooperating with the association are the National Housing Center of Washington, D. C., the National Design Center of New York, and numerous manufacturers.

Many thousands are tramping through the rooms, pressing buttons in the kitchen, and marveling at the door which is for the exclusive use of the dog. He can get from an outside dog house to the inside without yelping to attract attention.

The house is of wooden construction, roofed with asphalt shingles. Compressed wood panels, Roman brick and glass figures in the exterior decorations. There are a carpet, an entrance porch and a paved, enclosed terrace.

Inside, walls are plastered and

paneled in wood. Sliding plastic screens may cover windows. The room is an open plan, to give an impression of spaciousness. There are three bedrooms and two and a half bathrooms, a large living room and, well to one side, the dining space. But lively youngsters can make a shambles of a living room, so there is also a "family room" where behavior need not be so decorous.

The family room is the headquarters of the television, the organ and the record player. By manipulating a control panel radio programs and music may be piped into any room.

The kitchen surprises the British housewife the most. It is

strategically situated, so that Mother has a pretty good view of the whole interior. There is an area for informal family eating.

But that stove! It's a stainless steel island in the center of the room. Walk all around it freely, but not to go to the oven. That's built into a wall. There is no end of cabinets.

There are food mixers, juicers, grinders, refrigeration which controls temperatures from deep-freeze to cool, dishwashing machine and waste disposer.

At one side of the electric stove which is an island is a grate which takes charcoal, where the barbecue dinner is made. Electrical apparatus purifies the air and powerful exhausts, two of them, expel the smells.

The whole thing, from carpet to mud room, would cost about \$17,000 in an American suburb, the sponsors estimate.

The great majority of British housewives visiting the ranch house is most favorably impressed.

"That yummy shower, and that whizz of a washing machine right between the baths where it belongs!" is a typical comment.

But, while it may fit into the American scene, the total ranch house, as displayed here, is not for Britain, many conclude sadly.

Carl T. Mitnick of the National Assn. of Home Builders, and Norman E. Ginsberg of the National Design Center, who were here to open the exhibition, got tired of

## Weekend Menus

Combine pantryshelf ingredients for new flavor for soup.

**HEARTY QUICK ASPARAGUS SOUP**  
Ingredients: 1 can (10 3-4 ounces) condensed cream of vegetable soup, 1 jar (1 1/2 ounces) all-green asparagus, 1 tablespoon onion soup mix (from an envelope).

Method: Turn condensed cream of vegetable soup (undiluted) into a medium-sized saucepan. Add liquid from asparagus to soup can; fill can with water; slowly stir or whisk into vegetable soup. Heat slowly, stirring occasionally. When almost hot add asparagus stalks (cut into 1-inch lengths); save asparagus tips for salad. Stir in onion soup mix just as it comes from envelope, making sure you add a good portion of the small pieces of dry onion as well as some of the fine solids. Continue heating until very hot; the onion should stay crisp. Makes 4 servings.

# Long-Range Planning Still Needed

United States foreign policy, while it is framed by the party in power at the moment, should be a truly non-partisan approach to the problem of international relations and means of improving the security of the United States.

In the past decade, under both Democratic and Republican administrations, the United States and the free world have seen an alarming broadening of the influence of communism and the Soviet Union in international affairs. During the great portion of this time, the United States has found itself in a defensive position in international affairs, its prestige fluctuating with specific incidents around the world.

Certainly there is reason to question the course that has been followed in U. S. foreign policy in recent years. Ground has been gained in some areas of the world, but in others the United States has seen friendships grow cool, if indeed they have not been lost altogether.

What is needed, it seems to us, is a more carefully planned long-range international policy which will be followed by this nation as it occupies its position in an increasingly smaller world of nations. It is a problem which demands the best minds of the nation in international affairs, whether they be Democrat or Republican.

The problem of international relations of this nation is not so much a problem of either political party as it is a problem of the nation; one which must be coped with before it is too late.

Whether the foreign policies of the United States will be changed when a new president takes office in January is a question that is of concern to the people of this nation, just as it is to our allies and to our enemies. And it is a question to which no one, at this moment, knows the answer. Such a situation spawns a feeling of uncertainty at home, a feeling of insecurity among our allies, and a feeling of indifference and perhaps fear among the nations not yet

# Good Reports By Institutions

UNIQUE — The advisory budget commission got gratifying reports from two State institutions, each of which is unique in its field. The fact that both are small as compared with most operations supported by tax moneys, in whole or in part, does not detract from significance of the important service they are rendering to some of the unfortunate citizens of North Carolina.

Neither the rehabilitation center for the blind, operated by Butner by the State Commission for the Blind, nor the Cerebral Palsy Hospital at Durham asked for any money for capital improvements—two cases among the institutions which during the first two days of the current budget tour had filed requests for some \$25 million.

The two institutions with widely diverse purposes, have something more in common than failure to ask for capital improvements. Of the approximate million and a quarter dollars value placed on physical installation, less than half of it came directly from public tax funds.

BLIND — The rehabilitation or pre-conditioning center for the blind was authorized by legislative act in 1945, which carried an appropriation of \$15,000 — contingent upon the Lions Clubs raising a like amount. The Lions came through and operations began in an old NYA building at Greenville in late 1945. Three years later, when that site was needed for a public school building, the operation was moved to old army barracks on the recently acquired Camp Butner property. Around 1950 the Commission for the Blind acquired title to 24 acres of Butner land and built the first unit of the present center, which was occupied in 1952.

Since then additions have been made to the buildings and equipment by State appropriations, gifts from Lions Clubs and the Association of the Blind. The Garden Clubs of North Carolina have provided a "fragrance garden" in which plantings are of flowers that have pleasing odors as well as bright colors. The flower beds are elevated so that blind persons can feel and smell them with little effort.

The main purpose of this center is to provide training courses for newly blinded adults to help them adjust to their new situations. The first problem is psychological adjustment. Next step is to teach the blind persons to travel — how to get from one place to another, from bedroom to dining room to a walk down the street. Then come training courses in typing, woodworking, machine operations, etc.

It is fascinating and almost unbelievable to see how quickly the newly blinded can acquire self confidence and efficiency. The center has present capacity for 64 "students" — 16 white men, 16 white women, and a like number of colored. Plans are in the making to increase this capacity. When the increased enrollment is reached the State allocation of about \$80,000 a year and Federal aid grants of more than twice that amount also will have to be raised. Budget folks doubt any better use can be made of tax moneys.

Henry Wood, director of the Commission for the Blind, told the budgeters that the North Carolina system of checking and tabulating adult blind persons is recognized as one of the best in the nation and is being used as a pattern by other states.

C.P. — The cerebral palsy hospital at Durham, established in 1945, was the first in the nation, and still believed the only independent State institution dedicated to the sole or major purpose of caring for cerebral palsy (spastic) victims. It is located on a 10-acre tract of land, donated to the State by Duke University. With rated capacity of 40 patients, the roll has ranged from 35 to 50. There were 35 "residents" when the budget commission visited it this week. Half a dozen or so of these patients are not spastic, because the 1957 General Assembly authorized acceptance of non-spastics when facilities were available.

Some of the patients have very high intelligence rating, but most of them have IQ of less than 100, as well as having some physical handicap. Dr. Lennox Baker, medical director of this institution and chief of the orthopedic section at Duke Hospital, says that if the cerebral palsy hospital can get a youngster who cannot walk trained to get around and take care of his personal needs, it will save the State untold numbers of dollars in custodial care of the person throughout his life.

Just as we make long-range plans for military preparedness, long range-plans for economic prosperity and long-range plans for social and welfare needs of our own people, it is vital to the future security of this nation and our allies that greater emphasis be placed on long-range planning in our program of international relations.

LOS ANGELES (AP) — The Democratic ticket of Sen. John F. Kennedy for president and Sen. Lyndon B. Johnson for vice president frisks a couple of kinds of fish, political and personal.

For years Johnson, 51, has shown signs of aching for the presidential nomination. Therefore, seeing it go this week to Kennedy, eight years his junior, must have been a shattering blow.

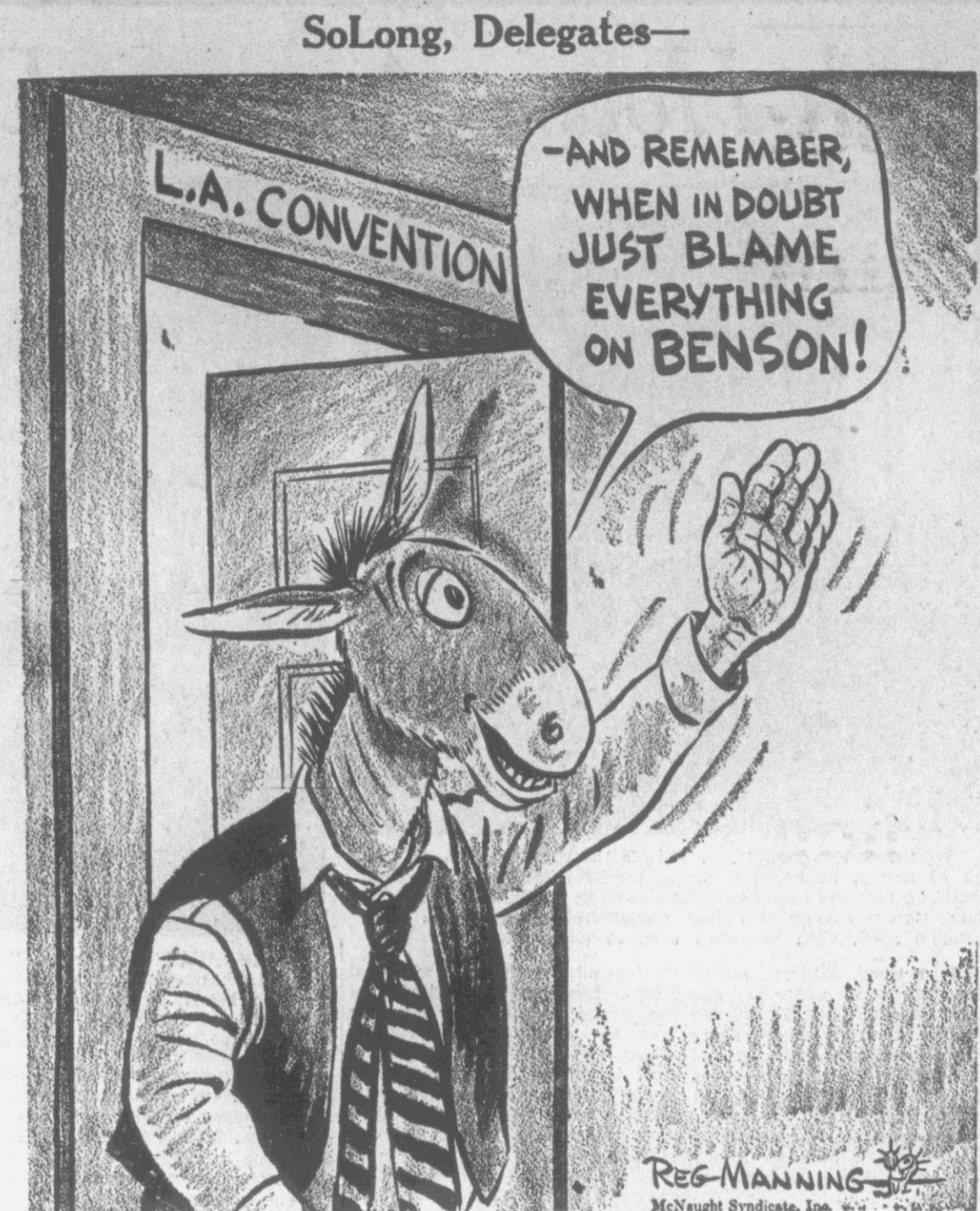
The fact that Johnson, at Kennedy's request, would accept the No. 2 spot on the ticket looks bewildering at first glance. It makes sense when you lift the lid of this strange political pot and look inside.

Johnson, as Senate leader of the Democrats, for years has had one of the most important and powerful jobs in the country. What he wanted was the most powerful job of all, the presidency.

Comparing with either one of them, the vice presidency is a shadowy situation. A vice president traditionally simply presides over the Senate, votes only to break tie votes on the floor, and runs errands for the president.

Johnson, whose Senate term is up this year, without question could be re-elected by Texas and retain his Senate leadership. He still is expected to run for the Senate as well as the vice presidency.

But this happens to be a touchy year in the national political scene. The South, as it showed at the Democratic convention, was restive and balky over the very liberal civil rights platform plan shoved down its throat by the rest of the convention delegates.

North Carolina's designated spot was directly beneath the podium allowing the 74 delegates, alternates, and company to hear every resounding whack of the special wagon-tongue gavel.

Pitt's delegates were in complete agreement that the Kennedy-Johnson ticket was the most desirable that could have been formulated at the convention. The fact that Kennedy was victorious on the first ballot by such a wide margin was sufficient to convince most delegates (Continued on page six)

er set of delegates.

Health Service reports a new record total of illegitimate births. The 1958 totals—it takes a year to get the figures together—show an increase of 7,000 legally declared bastards over the previous year. Nationally, more than 20 per cent of non-white births were registered as illegitimate. Among white, the national figure was two per cent.

This area can cringe at an illegitimacy rate among Negroes far in excess of the national rate. While the percentage of births to unwed white mothers wavers at two per cent or below, the rate among colored climbs steadily.

During the first six months of this year, for example, 33 per cent of Negro births in Rocky Mount were illegitimate. Last year, the figure was 27 per cent. From January through June in Pitt County, an appalling 39 per cent of colored babies were declared bastards.

In Edgecombe, where about 51 per cent of the population is Negro, the rate was a shocking 35 per cent the first half of this year and 30 per cent last year. In Nash in 1958, the illegitimacy rate among Negroes was 22 per cent.

What can be done? Authorities see closer church ties, improved standards of living, better education and race leadership as prerequisites to greater acceptance of social and moral responsibilities. But how to bring about these recommendations is the riddle inside the enigma.

The great tragedy is that while the problem results from illegitimacy on the part of unworthy parents and not their children, it remains for the innocent offspring to pay the price demanded by society.

The welfare departments pay more and more each year to unwed mothers is indeed an alarming sidelight—but human failure is the pathetic crux of the matter.

# Future Sec. Of State

Nearly as important as the President will be the next Secretary of State. Upon his shoulders will fall the responsibility of finding an honorable road to dealing with the Soviet world. He will need to be knowledgeable, experienced, a competent administrator, capable of controlling his deskmen and also fighting off the opinionated Senators who seek to force upon the world their private views. This means that we shall have to have a man whom the nation respects.

If Richard Nixon is elected, it depends upon who runs for Vice President as to who the Secretary of State will be. The favorite for both the Vice Presidency and the Secretaryship of State is Henry Cabot Lodge. If Lodge runs as Vice President, he will, of course, not be appointed Secretary of State. In those circumstances, a strong effort will be made to divorce Thomas E. Dewey from an extremely lucrative law practice. Dewey could be relied upon not to be beguiled by the Kremlin. He would, however, not be as acceptable to Congress as Lodge would be.

In the event that neither Dewey nor Lodge should be available, Senator Styles Bridges may be asked to serve in this position. Before Governor Nelson Rockefeller became so obstreperous, his name was heard as a possibility but it is heard no more. The present incumbent, Christian Herter, would not be considered.

Should the Democrats be elected, it is likely that Chester Bowles, Adlai Stevenson, or Senator Fulbright might be considered. It would be most logical for the Democrats to restore Dean Acheson to that position as his current views seem to be the most sound expressed by anyone in the Democratic Party. He adds to knowledge and experience wisdom which such a man as Adlai Stevenson does not seem to possess. In fact, the mere suggestion of making Adlai Stevenson Secretary of State frightens those who still hope to preserve the United States as a nation.

The difference between Stevenson and Acheson is that the former seems to learn nothing either by experience or from knowledge. Having adopted a doctrinaire position sometime before 1952, he cannot change no matter what the course of events does to his assumptions. He has no sense of timing. No matter what harm it may do to the United States, he utters words and assumes positions which can only give aid and comfort to the enemy. As a former State Department employee, he knows all about the spying that is done by Soviet Russia and for that matter, the spying that we do. His innocent demeanor about the U-2 was an absurdity. Whom did he think he was kidding?

Unfortunately when men are so ambitious that they believe their own publicity, they can do the nation as a whole great mischief. There can be little doubt that public statements by Stevenson and other Democrats encourage Khrushchev, who cannot understand our form of government, to believe that it would be to his advantage not to continue negotiations with President Eisenhower, knowing that he will cease to be President in January.

Such a speech as Paul Butler delivered on the opening night of the Democratic Convention must have pleased Khrushchev. It gave one the feeling that Khrushchev was calling the shots and writing the platitudes. The danger is that Khrushchev will believe that this country is really sharply divided and that a large part of the American people are antagonistic to President Eisenhower that they are favorably disposed to the Kremlin. Surely a speech such as Paul Butler's will give courage to Castro and other Kremlin allies in Latin America.

Senator Frank Church's speech was not much better in those sections which dealt with foreign policy. (Continued on page six)

Colavito's tie-breaking homer triggered a six-run third inning for Detroit as the Tigers rapped New York 8-4 Friday night and tagged the Yankees with a four-game losing string for the first time this season.

It was Rocky's fourth home run in three games and chopped New York's lead to 1 1/2 games over second place Cleveland. The Indians beat Washington 4-0 as Jim Ferry won his 10th with a four-hitter.

Robinson became the first AL player to hit for the cycle—home

# Eight Records Smashed In Trials For Women Games

ABILENE, Tex. (AP) — Broad jumper Willye B. White, weight star Earlene Brown and flet Wilma Rudolph got the women's Olympic trials off and winging Friday night.

In eight of the nine events in which preliminaries were held, all Olympic records were smashed. Miss White, a little girl from Chicago, set an American record in the broad jump with her best leap in six years of competing—20 feet 4 1/2 inches.

The world's record for women is 20 feet 10 inches.

Mrs. Brown, the huge Los Angeles shot putter and discus thrower, led both of these events, even shading Olga Connally, the former Czechoslovakia Olympian from Chicago, set an American discus champion. Mrs. Brown

heaved the shot 48 feet 8 1/4 inches, almost two feet over her own Olympic trials record. She threw the discus 156 feet 6 inches, to better her Olympic trial standard of 145 feet 4 1/2 inches.

Miss Rudolph, a Tennessee State star, got little competition in the 100-meter and 200-meter dashes. Miss Rudolph, who last world's record of 22.9 in the 200 meters, was far ahead in her qualifying heat in a time of 24.2, which bettered the Olympics week at Corpus Christi, set a trials record by two tenths of a second. She led the 100-meter qualifying with 11.7, which was five-tenths of a second under the trials record.

LONDON (AP)—Promoter Jack Kramer is chasing around Europe with check book poised, and amateur tennis is in a nervous dither. The court brass doesn't know where the hard cash will strike next.

The past week, the Californian moved into Barcelona and plucked off Spain's No. 1 player, Andres Gimeno.

Thursday Kramer was in Paris. Today, he is in London. Sunday he will be in Bastad, Sweden, where the Swedes play France to see who meets Italy in the final of the European zone Davis Cup competition.

"I'll try to sign the best player of the series," Kramer said. "It may be Pierre Darmon of France or it may be Ulf Schmidt of Sweden."

Now that the world amateur tennis bigwigs have voted down open tournaments, Kramer has indicated he no longer feels bound to soft-peddle his professional operations.

He has announced that all amateur players are now fair game and he hopes to sign a new batch of performers for his world stage—with particular accents on Europeans.

Kramer is not interested in any more Australians at present. He is anxious to sign two Americans—Barry MacKay and Earl Bucholz Jr.—but he won't raid Uncle Sam's cupboard until after the Davis Cup campaign.

"I'd never do anything to hurt America's chances in the Davis Cup," the onetime world champion said. "But when Barry and Earl are ready, I'll sign them."

This may happen in January. Kramer said he isn't interested in Neale Fraser, the Wimbledon champion, and was only slightly interested in Rod Laver, the flashy but unpredictable Wimbledon runner-up.

Kramer said he considered Europe the new frontier for professional tennis.

En route to Bastad, Kramer arranged to talk to Denmark's Kurt Nielsen in Copenhagen. Nielsen is pro bait.

Also high on the promoter's list of pro prospects is Nicola Pietrangeli, the gifted Italian ace who led his country into the European Davis Cup finals this week over Britain.

# Research Officials Inspect Tobacco Program In Pitt

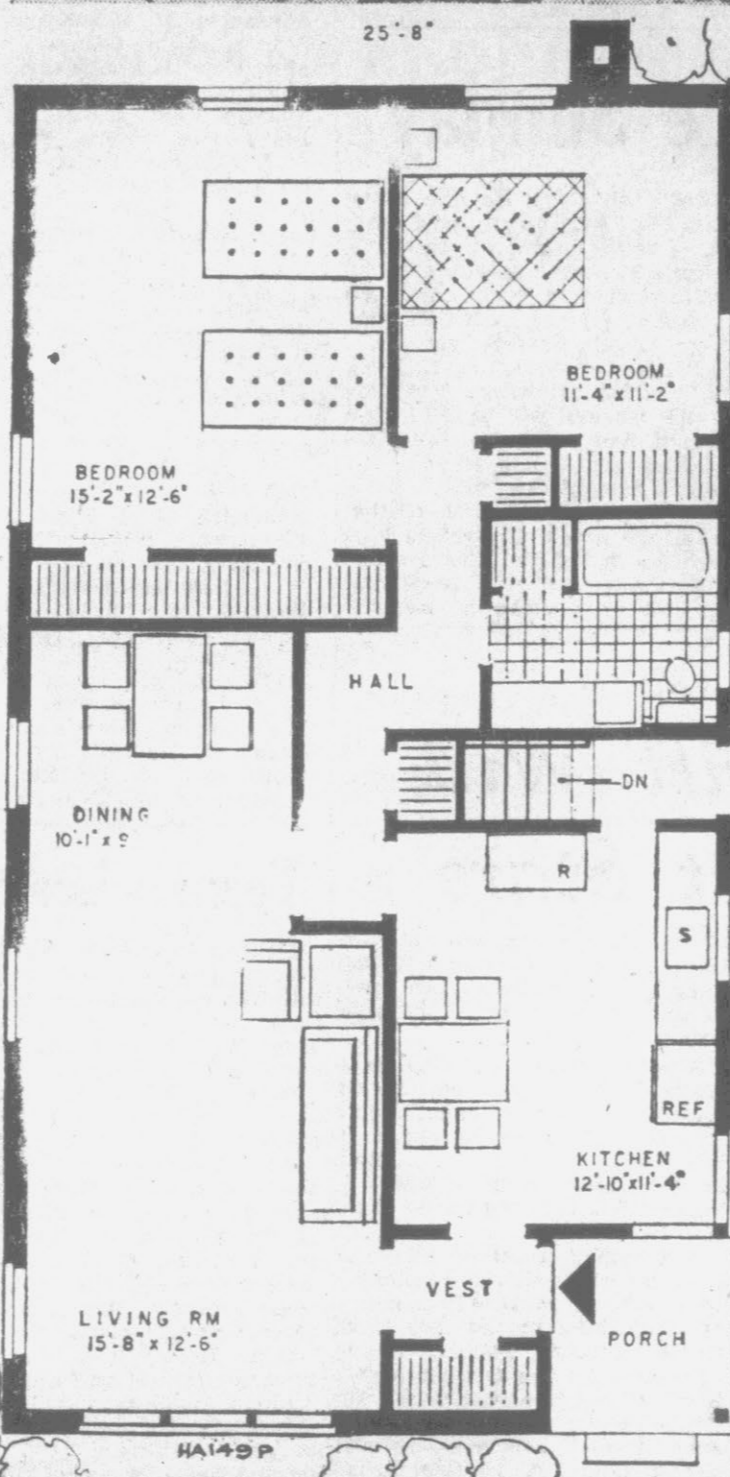

# Editors Urged To Link School And Community

Insulation board falls under the general dry-wall category of wall-board and is sometimes referred to as fiberboard. But no matter what its designation, insulation board has a porous surface and must be sealed before it is painted. If this is not done, there will be an uneven absorption of the paint, giving an unattractive mottled appearance to the surface.

In some types of insulation board, the paint absorption is so great that a single coat of sealer will not do the job. The sealer must dry to a uniform surface before it is safe to apply the paint. Once it is certain that the sealer has been effective, any regular wall paint—latex, oil or enamel—can be applied with good results.

Semi-gloss and gloss enamels are recommended in bathrooms and kitchens where extra scrubability is desired. Flat topcoats are recommended for walls and ceilings.

As in all other painting jobs, the surface of the insulation must be clean before any coating is applied. Oil and grease can be removed with an odorless paint thinner.

Insulation board used on exteriors should be painted the same way as any outdoor surface. The first step is to apply a house paint primer as soon as the board is erected, at a rate of not more than 450 square feet per gallon. As soon as the prime coat is dry, it should be followed by two topcoats of standard house paint. If brick or stone is lower on the wall, a non-chalking paint should be used to avoid staining the masonry.

Sometimes insulation board is impregnated with asphalt to give it better moisture resistance. While this type is usually sold by request and therefore not the kind you usually get, it is wise to check with your dealer. Asphalt-impregnated boards must be sealed with a special sealer designed for this purpose or with water emulsion paint or shellac. Two coats usually are necessary. If this is not done, there may be "bleeding" which will show up as brown stains.

When an acoustic type of insulation board is applied to ceilings, it is best not to paint it until absolutely necessary. When painting does become necessary, the paint should be applied lightly and carefully so as not to block the openings in the tile, since these openings absorb sound. In order not to get too much paint on the tiles, use a spray gun set so that only a minimum thickness of paint is applied.

# Claims Charges Due Controversy

Recent illegal practice charges against Ridgeway's Opticians, Inc., sprang from an extended controversy between North Carolina opticians and optometrists, Herbert L. Ridgeway Jr. claimed Thursday.

Head of the firm charged with violation of the state's optometry license laws and false newspaper advertising, Ridgeway said "there is no question that my firm was singled out" for civil action as a test case.

"It all boils down," he said, "to two different professions having an argument."

And the argument, said Ridgeway, revolves around this: "The optometrists don't like the opticians to advertise because they don't. And the optometrists also feel we are getting into their field."

The argument moved into the public eye Wednesday when the State Optometry Board filed a civil action in Wake County Superior Court charging the Ridgeway firm.

An order is sought by the action which would "permanently and perpetually" restrain Ridgeway's from engaging in the practice of optometry in the state.

Ridgeway, who has been secretary-treasurer of the State Board of Opticians for the past nine years, said the action is directed against all opticians in North Carolina—"not just my company."

The optical firm operates a branch office on Evans Street in Greenville. Other branches are in Raleigh, Charlotte and Greensboro.

# Quite A Show For 60,000 Democrats

LOS ANGELES (AP)—Some 60,000 people went out to see the Democrats wind up their national convention Friday night in a king-size baseball field noted for its "Chinese" homers.

They saw quite a show.

They saw enough movie stars almost derailed by what looked like an Indian uprising.

They saw the Democrats rake the Republicans on land and in the air and for while it seemed the Republicans were counter-attacking from the sky.

They saw enough movie stars and marching bands and motorcycle cops riding in formation (to the "Dagnett" theme music) to remake "Ben Hur" in modern dress.

And, of course, they saw the nominee, Jack Kennedy, make his big acceptance speech and they saw the losers praising him as though he had been their choice all the time.

Sen. Stuart Symington even went so far as to explain why Kennedy beat Symington and Stevenson and Lyndon B. Johnson for the top spot.

"How did he do it?" Symington said. "He did it because he has just a little more courage, stamina, wisdom and character than the rest of us."

Kennedy also got high praise from Johnson, his running mate, who apparently is convinced that Kennedy matured enough in the last two days to be president.

Early in the proceedings, sky-writing planes puffed propaganda over the Coliseum—"stop waste" and "cut debt"—which was a pretty expensive way of starting to economize.

Several speakers were bothered by helicopters overhead. Convention Chairman LeRoy Collins turned his anti-aircraft fire on them.

"Just like the Republicans, they just whirl round and round without getting anywhere," he said.

But it was Stevenson who had the roughest time getting off the ground. Just as he was about to start his speech introducing Kennedy, he looked into the setting sun and there out of the West came a high school band and a score of Indian-costumed youngsters parading with a big American flag.

It was the kind of goof-up we used to associated with the Dodgers—not the Los Angeles version but the old, old Brooklyn Dodgers when the Bums used to end up with three runners on second and outfielders were getting knocked the head by fly balls.

The band came onto the field, drums going full blast. Stevenson turned in bewilderment and asked Gov. Collins what was going on. He didn't know either. The band kept coming.

They marched through the infield. Convention officials ran out to stop them. But the band kept rolling way out into the outfield. It took a horde of frenzied officials finally to end the march and keep the eager paraders from drumming their way right up into Stevenson's lap.

What were they doing there? A man with a Stevenson button, they said, had asked them to put on a Stevenson demonstration.

The kids were just too late for the 1960 convention and a mile early for the 1964 convention.

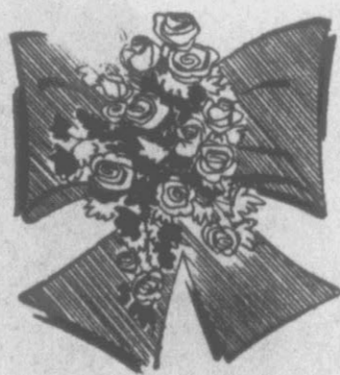

Might Of First A-Bomb Amazed Young Scientist

By IKE FLORES LOS ALAMOS, N.M. (AP)—"My God, it must have blown bigger than we planned." That was the first thought of the young scientist who triggered the first atomic bomb in the hazy dawn of the New Mexico desert 15 years ago today. Fifteen years after the historic event, Dr. Joseph (Joe) McKibben is a physics group leader at this one-time hush-hush laboratory city which gave birth to The Bomb. But on June 16, 1945, McKibben was one of three scientists who made up the "arming party" for the first nuclear weapon. He triggered the electronic relay system which set off the bomb and gave a small group of scientists and military brass its first inkling of what was to come.

Suspended 31 Beer Permits

Cell-Mate Spills Beans; Mute Is A 'Chatterbox'

CHARLOTTE, N.C. (AP) — At his arrest several weeks ago, through a lower court trial and conviction for a misdemeanor and at his appeal hearing, Joseph Wray attracted sympathy as a deaf-mute. Mecklenburg Superior Court Judge W. Jack Hooks considerably ordered that the Charlotte defendant be given a record of the evidence against him, to study in his jail cell, and permitted him to cross-examine witnesses by written notes. But Friday a cell-mate spilled the beans: At night, Wray was a regular chatterbox. "Is this true?" Judge Hooks demanded. "Yes, sir," Wray admitted sheepishly. "I started on this deaf and dumb kick when I was arrested, and I couldn't see any way to get off of it." He had appealed a suspended 60-day sentence. He got an active two-year sentence.

Something For An Old Veteran

BALTIMORE Md. (AP) — Veterans groups have tried from time to time to do something special for Charlie Creek of Annapolis, one of Maryland's senior war veterans. The shy old Indian fighter is 106. Finally, persistent members of American Legion Post 141 planned him down to something he wanted. "I'd like a new bed," said Charlie, "and — can it be a bed that has a crank?" "You mean a hospital bed?" he was asked. "I don't know hospital beds," Charlie replied. "I've never been in one." Charlie's present bed is supported by four wooden boxes. At the American Legion Convention here next Friday, Charlie will get his new bed — crank and all.

Death Sentence For Second Youth

HOUSTON, Tex. (AP) — A second Negro youth drew the death penalty Friday for the sex slaying of a white boy. Dist. Judge Edmund Duggan sentenced Adrian Johnson, 18, to die Aug. 17 in the electric chair. Johnson and six other Negro boys were charged in the slaying a year ago of William Merrill Bodenheimer, 12, whose body was found in an old ice box near his home. Police said the boy had been subjected to repeated sexual abuse. A death sentence for Joe Edward Smith, 18, in the case is on appeal. The other five boys are juveniles. Four are in state custody and the fifth has been released to his parents.

Local Woman's Mother Dies In N. J.

Mrs. Margaret Doane Vanderlock, 80, mother of Mrs. M. V. Crenshaw of Greenville, died July 6 in Passaic, N. J. She was the widow of Dr. Cornelius Vanderlock, former head of the medical staff of Passaic General Hospital. Mrs. Vanderlock was born in Hebron, Conn., a direct descendant of Dr. John Sumner, a Methodist circuit rider of the late 1700s, and of William Sumner of Oxfordshire, England, who settled in Watertown, Mass. in 1636. Survivors include three daughters, Mrs. Crenshaw of Greenville, Mrs. Oscar Seldon of Passaic, and Mrs. Raymond MacHutta of Saddlebrook, N.J.; two grandsons, Richard Seldon of Belvedere, N.J. and William Crenshaw of Greenville.

A workshop on the graduate level has been added to the camp curriculum this year. A lawn concert scheduled for Sunday, July 24 at 4 p.m., will be followed by a picnic supper and vespers. The gala concert in Wright auditorium on Saturday, July 30, features majorettes and drum majors at 1:30 p.m., and bands, choirs and orchestra at 2:30 p.m. Three bands will be organized at different levels under the direction of Herbert L. Carter, director of ECC bands; Edward D. Benson, Asheville city schools music supervisor; and Spencer Mims of Charlotte's Myers Park high school, and the orchestra will be conducted by Donald Hayes, also of the college faculty. East Carolina College faculty members on the music camp staff include Gordon Johnson, camp choir; Dr. Robert Carter, piano; Lewis Danfelt, reeds; Dr. W. Edmund Durham, theory; James Parnell, brasses; Thomas E. Mims, arts and crafts; Dr. N. M. Jorgensen, director of health and physical education, recreation. Understanding, Unsympathetic

ASHEVILLE (AP) — A North Carolinian who is assistant managing editor of the New York Times says the North understands the South's racial problems—but doesn't necessarily sympathize with them. Communications between the two regions concerning racial matters have not broken down, Clifton Daniel said in a news conference. He was here to address the 88th annual meeting of the North Carolina Press Assn. Friday night. Daniel, whose parents live in Zebulon, N.C., and who is the son-in-law of former President Truman, touched a variety of topics. He predicted victory for the Kennedy-Johnson Democratic presidential ticket in November and said that Europeans generally would welcome Kennedy's nomination. Speaking to the NCPA, Daniel discussed at length the wrecking of the summit meeting in Paris. And he offered three or four possible explanations for Soviet Premier Khrushchev's action. Among them were pressure from Red China and the U2 plane incident. "I also incline to the notion," Daniel continued, "that Khrushchev was genuinely disappointed in President Eisenhower. The Russians apparently were convinced that the President was a man of peace. For nearly five years Soviet propaganda presented President Eisenhower in that light." A business meeting today occupies delegates to the press convention. The Eiffel Tower in Paris weighs 10,000 tons. King Edward VII of England opened it when he was still Prince of Wales.

Draft Rockefeller Office Is Opened

PHILADELPHIA (AP) — The Pennsylvania Draft Rockefeller Committee opened headquarters in Philadelphia Friday — minus much money but with hopes. Edward L. Howard, of Doylestown, co-chairman, said the committee has less than \$1,000 to try to attract support for Gov. Nelson A. Rockefeller of New York as the Republican presidential nominee. Howard said there are 576 Rockefeller-for-President clubs in Pennsylvania. He defined a club as "a person who says he can get five other people together to distribute Rockefeller literature." 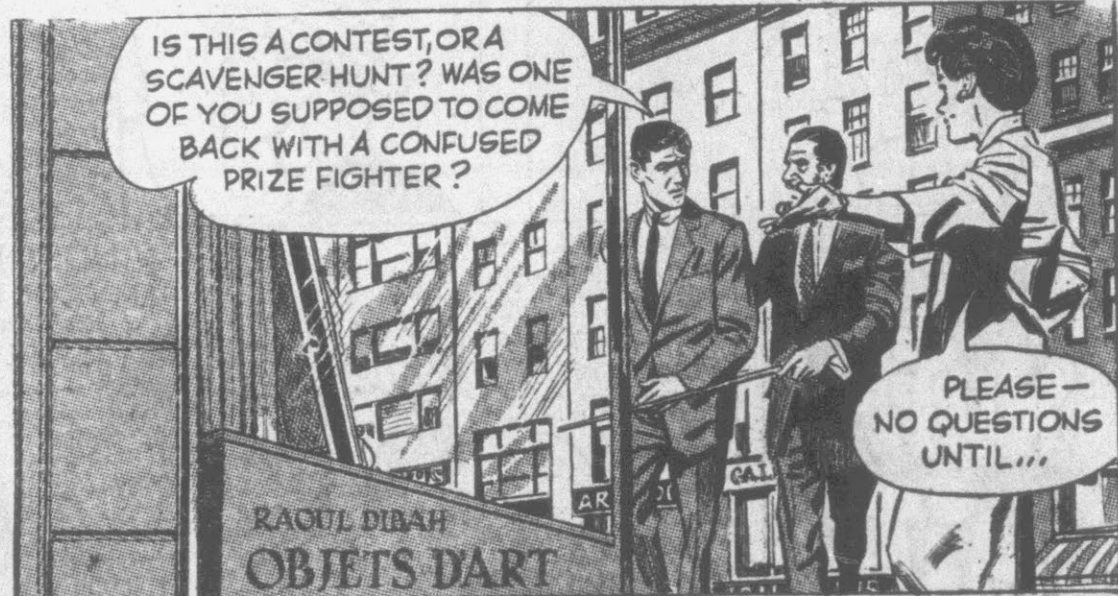

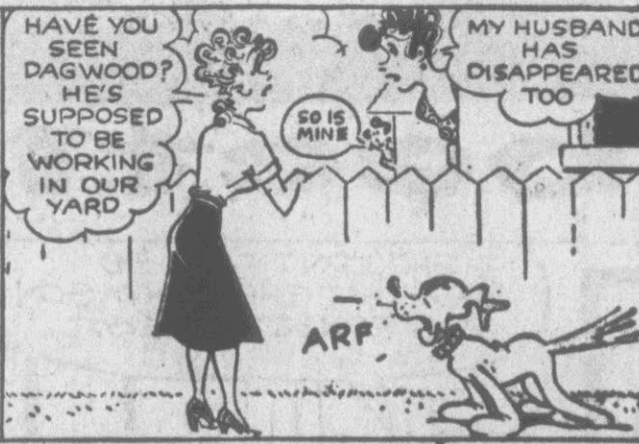

Approximately \$25,000 will be spent in renovations and repairs in the Greenville City Schools during the summer months. J. H. Rose, superintendent, has announced.

Elmhurst School will undergo some of the most extensive work, and two classrooms will be made from one at Third Street School, though workmen are on duty at all the schools.

At Elmhurst School, Rose said drain lines were being installed in the courts which were also being filled in with dirt. Rooms at the school are being painted as well as the toilets.

A new classroom is being constructed on the south end of the building by glassing in the wide porch at the end of the auditorium, Rose said. This will be a first grade room. In addition, large electric lines to the kitchen are being installed to take care of additional load.

**Third Street**  
 At Third Street School, two classrooms will be made out of one, Rose said. Each room will be about 40 feet long. In other work at this school, workmen will repair asphalt tile on the floor where needed, black-top the drive, repair all needed plumbing and repair about half the classrooms.

**Junior High**  
 The Junior High School is also in for some extensive work. The roof of the building will be repaired and in some cases there will be patching, tearing up sections. Plaster will be patched and about half the interior of the building will be painted.

Water lines to the cafeteria will be repaired, in addition. Locks which are worn out on classroom doors will be replaced, Rose said.

Other repairs will be concentrated at Agnes Fullilove, J. H. Rose High School, Fleming Street and South Greenville schools.

The entire building interior of Agnes Fullilove will be repainted. All toilets will be repaired and moved to a larger classroom.

Two new classrooms will be made in a temporary building on the J. H. Rose High School grounds. In addition, the boilers in the temporary buildings will be repaired and toilets will be repainted and repaired.

In the Fleming Street School, retaining walls will be installed. New drainage pipes will be installed around the building and the front grounds will be reshaped, Rose said.

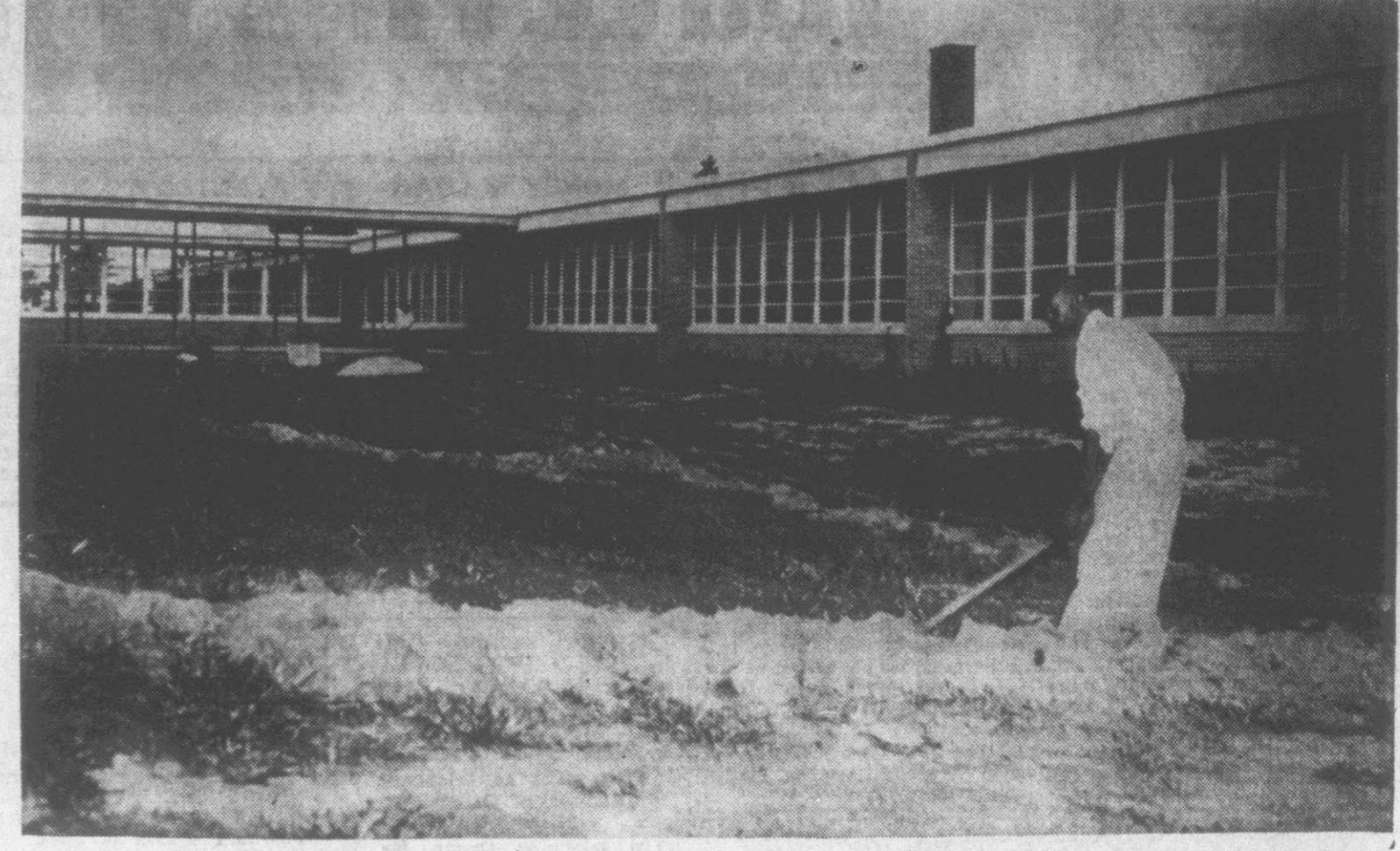
Low places will be filled with dirt. Inside the school, Rose said the ceiling in several of the classrooms will be replastered and repainted.

South Greenville School will be repaired where classrooms need it. Retaining walls will also be built and dirt will be filled in where needed. Some catch basins will be repaired and doors will be repaired, Rose said.

**Wahl-Coates**  
 Repairs in the Wahl-Coates School will be done by the State of North Carolina, Rose said.

In addition to the repairs already mentioned, broken window lights will be replaced for all the schools, and windows will be washed, floors will be cleaned and waxed. All burned out light bulbs will be replaced.

Rose said this work will keep the entire Greenville City Schools crew working all summer. Besides the regular crew, additional men are employed to help with the summer program. Rose said the janitors employed in the city schools have been trained to work as maintenance men.

C. J. Moye, superintendent of buildings, is in charge of the work program, which now has about 16 men under its charge.

Other schools repairs will continue while the schools are in session, Rose said.

He added that the administration building will undergo painting, as well as the city school classrooms.

NEWPORT BEACH, Calif. (AP) — A vacationing psychiatrist left a swordfish dinner and talked down a would-be suicide swinging and yelling atop a 10-story structure Friday night.

At Renneker's request police turned down spotlights playing on the man teetering more than 100 feet from the ground.

Some in the crowd shouted "jump jump!"

Dr. Renneker delivered the clincher.

"You're ruining my dinner, you know that," he said.
