

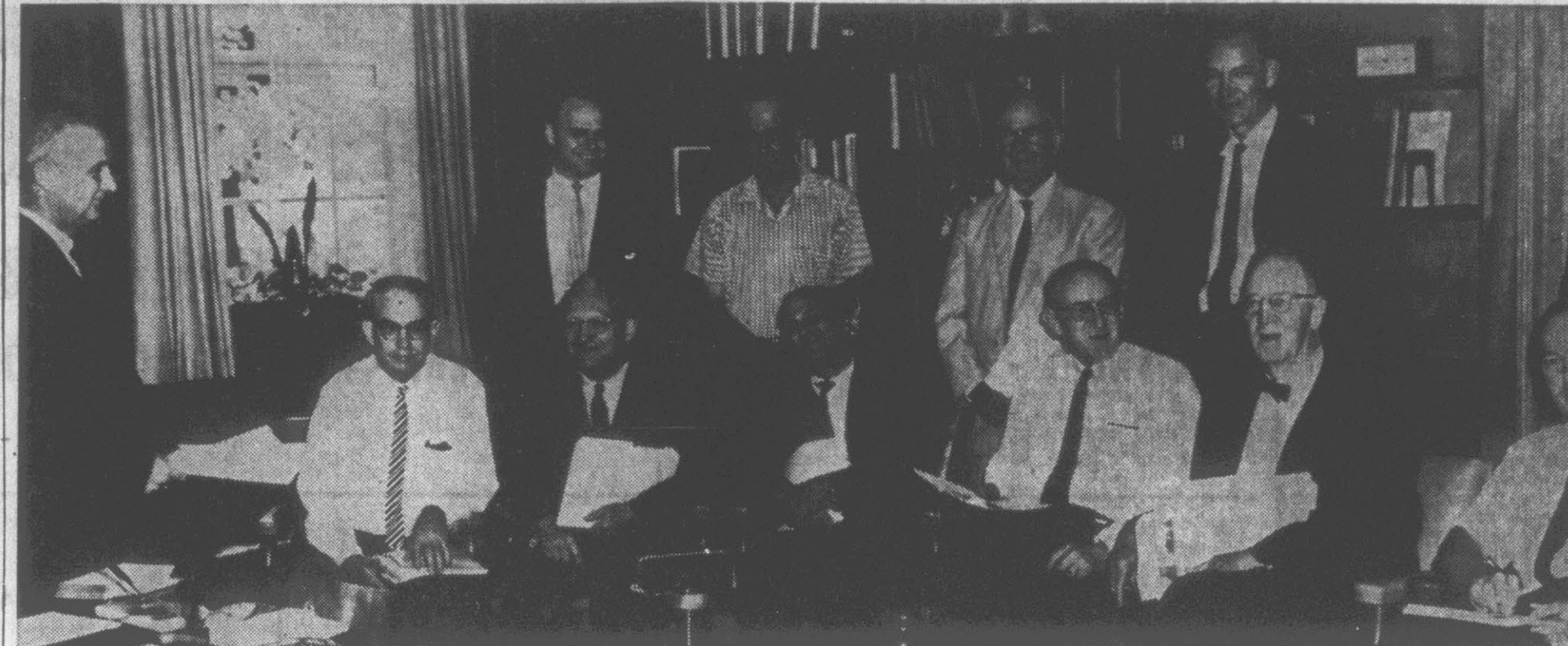
Small Nations Challenge Russia To Prove Charge Of Air Space Violation

ECC Budget Requests Laid Before Commission; Needs Of Growth Cited

By HENRY HOWARD Reflector Staff Writer Budget requests totaling \$7,835,500 for permanent improvements at East Carolina College for the 1961-63 biennium were laid before the State Advisory Budget Commission Monday afternoon at its visit to the College.

Dr. Leo W. Jenkins, ECC president, told the budget commission members that this budget request is in keeping with the needs of the growing college, citing figures from the office of Dr. John H. Horne, registrar, showing current applications for admission running more than 45 per cent ahead of the same date a year ago.

Lumumba Urges Ousting Belgians

UNITED NATIONS, N. Y. (AP)—Congo's Premier Patrice Lumumba says U.N. Secretary-General Dag Hammarskjold has promised him to "spare no effort" to get Belgian troops out of the Congo.

Lumumba called again on Belgium to pull her troops entirely out of the Congo, claiming the Belgians had "violated and destroyed" the friendship treaty under which they retained two bases in their former African colony.

### Designers' Fashions In Paris Show

 PARIS (AP)—A slim semi-fitted line, with skirts just below the knee, was shown by Jacques Griffe this morning in the curtain-raiser for the Paris fall and winter fashion openings.

New notes were bag-backed suit jackets and bag skirts, bloused out above the knee and seamed in again at a slightly longer hemline. Waistlines were more or less left where the designer found them. Modestly high day necklines went with the warm, sensible look for winter fashions.

A brown and red coat began the parade. These turned out to be Griffe's favored colors. Black and oyster white came next in popularity, followed by black-purple, olive and honey beige.

Some suits were buttoned from the neck to hem, and often the buttons ran down one side.

The new bag skirts have a harem look — with a difference. Even some coats are in the Cinderella pumpkin shape.

Warm tweeds, thick furry woolens, lace printed velvets, heavy silk crepes and moires, and even a fuzzy wool lace made up the range of winter materials. Coats had shawl collars or stand-up rounded cuff collars, often in fur. Fur borders and hems trimmed many suits and coats.

There were high covered cloches and feather duster hats to go with everything, and gold veil bird cages for evening.

The black crepe dress, beloved by most women, showed up in dozens of versions, all of them deceptively simple.

PARIS (AP)—A cylinder silhouette, frankly feminine and flattering, was Pierre Balmain's line today on the second day of the Paris fashion openings.

Zippered-up tube coats that fit like a glove and tightly belted waistlines gave many Balmain creations a lug-me-light line. His skirts stopped at the top of the calf—a little longer than last season.

Unlike the designers who opened Monday, Balmain scorned bias cuts. But he shared a tendency to bands of fur edging, back-buttoned jackets, high helmet hats, kangaroo or cowl draping, and sober colors.

A big laugh and a big hand greeted a mannequin wearing a big cap collar and a cascade hat of long-haired Mongolian sheep fur, and carrying an exactly matching poodle.

The Eastern influence continued in suit jackets cut like tunics with split side seams and high choker collars.

Balmain retained his fondness for melting beige tones, this time handsomely combined with brown. Peacock blue was a new color, but black blanketed the scene, appearing in black velvet suits and dresses, black and silver lame, black crepe and waffle taffeta.

Monkey fur hats and trimmings and wide fox hems and muffs were nostalgic of old family albums.

 Method: In a medium-sized saucepan heat to boiling 2 cups water. Mix corn meal and salt with remaining 1 cup cold water; stirring constantly, pour into the boiling water. Cook until thickened, stirring often. Cover; continue cooking over low heat about 10 minutes. Add cheddar cheese; stir until melted. Pour into baking dish (about 10 by 6 by 1 inch) that has been rinsed in cold water; chill. Spread chilled corn meal with soft butter; cut in squares; sprinkle with Parmesan. Place, slightly apart, on broiling pan; trol slowly until heated through and top is a light golden brown. Makes 6 servings.

Guest Editorial

Long Development In The C-of-C

Editor's Note: The following guest editorial was prepared by WILLARD T. KYZER, Manager of the Greenville Chamber of Commerce.

Someone has said, "Some form of organization apparently is beneficial to all living things. The purposes vary with the forms of life, but man with his ability to reason has frequently found it to his advantage to become a part of a group to secure benefits which may be enjoyed only through a combination of individuals working together for a common purpose."

Evidence of that purpose is found in the first known Chamber of Commerce which was organized in the 15th Century at Marseilles, France. It was closely affiliated with government, and was operated as an association of merchants to promote and protect their business.

The Chamber of Commerce of the state of New York, one of the world's oldest and America's first, was founded in 1768 and was followed in 1773 by an organization in Charleston, South Carolina. These with others formed in a number of other important cities, although organized independently of government, were exclusively Trade Bodies operated for the promotion and protection of Commerce.

This type prevailed until the beginning of the 20th Century, when changes in the social and economic order required a revision of the functions of a Chamber of Commerce. Businessmen saw that in the long run the successful business is one in which both the buyer and seller derive benefits. Successful Chambers of

Commerce became known as those which considered the interests of the community as well as that of business, resulting in activities programs designed to promote the growth of the entire community along commercial, industrial, and civic lines.

To handle the enlarged scope of activities resulting from the change to a community development organization, the corporation type of organization was developed providing for greater delegation of authority and more ability to pool the community's resources of men and money for worthwhile activities.

This change resulted in some mistakes, including the belief by some citizens that anything that affected the community should be handled by the Chamber of Commerce. Another mistake was the conversion of some Chambers into mere booster organizations, emphasizing growth regardless of economic principles. Then there were Chambers of Commerce that failed to realize that the membership includes all business and professional types and that each is in the organization not exclusively for direct benefits, but also for what they can provide in thought and energy, for the advancement of the entire community.

From these firsts with the changes that occurred along the way, has emerged the present day Chamber of Commerce defined as,—

"A voluntary organization of public spirited citizens banded together to do those things which promote and protect their community, which can be done more effectively by an organized group than by the same number working as individuals."

The modern Chamber of Commerce of today takes into consideration the welfare of the community as a whole. Its main objective is to assist in making the community a better place in which to live and work. The degree of success which it attains is limited by the number of its citizens who participate with their judgement, energy, and financial support.

In working toward its objective, the modern Chamber of Commerce develops a program of activities from projects proposed by the membership, that when realized contributed toward making the community a better place in which to live and work. In small and medium size communities program activities are assigned to appropriate project committees dealing with Agriculture, Civic Affairs, Commerce and Trade, Industry, Public Relations, Legislation, Transportation and Communications. For committee service, members are appointed on those of their choice and others are selected for their knowledge of the work to be done and interest in the possible accomplishments. In large communities, committees may be replaced by departments, with a trained staff member in charge of each.

Urban and rural areas are dependent upon each other, so agricultural activities approved by Federal and State Agricultural agencies are undertaken to help better the economic position of the farmer. These include encouragement of diversification of crops, better market practices, the use of better seed, and support of Boys and Girls Club work, fat stock shows and sales, and in campaigns of farmer organizations working for improvement of agriculture.

Chambers of Commerce of the future will in general closely resemble the present day organization, however with changing development patterns in the making, they will be buying the services of research specialists to assist on special projects.

The chief objective of the future will still be to do all possible to assist in making the area served, a "better place in which to live and work." It will continue to be a voluntary membership organization, with public spirited business and professional men providing the judgement, enthusiasm, energy, work and financing, needed to carry out its program.

Its successes will still be limited by the lack of active support of a group of business and professional citizens, who are willing to accept the tangible benefits resulting from efforts of those who by their thoughts, work, and money, back their desires for progress by "pitching in" to get the job done, for they believe that,—

"As long as there is a difference between what a town could be, and what it really is—there is a need for an active Chamber of Commerce."

Mixed Blessing In Nixon's Trip

CHICAGO (AP) — Vice President Richard M. Nixon's sudden and secret journey to New York's Gov. Nelson A. Rockefeller—just three days before the Republican convention opened here—was a mixed blessing.

The two men reached what they called an agreement but it turned out to be an agreement with big holes in it. It looked like a shrewd political maneuver at first. But it may prove to have been a tactical error.

It seemed at first that Rockefeller had put Nixon in his pocket or that Nixon had the governor in his pocket. But now that isn't clear, either.

It got the governor off Nixon's back, at least temporarily, but it angered some Republicans. And Democrats in the upcoming presidential campaign will probably try to wrap the whole business around Nixon's neck.

Rockefeller, for months critical of Nixon and the Eisenhower administration, only last week here in Chicago indicated he might continue his criticism if the Republican platform's promises fell short of his desires.

This was gruesome news for Nixon, almost certain to be the Republican presidential nominee, since he will probably have to carry New York if he hopes to win the November election.

The vision of a disgruntled Rockefeller, sitting on his hands during the campaign instead of trying to carry New York for the Republican ticket, spelled peril for Nixon. Late Friday Nixon tried to straighten things out.

He flew secretly from Washington to New York apparently without consulting President Eisenhower or even his closest aides here in Chicago—to see the governor. Rockefeller had complained re-

peatedly that Nixon wasn't taking either a clear enough or strong enough stand on some issues. Nixon therefore had had many weeks to reach an understanding with Rockefeller.

Why he waited to do so until almost the last minute before the convention is still a mystery. The obvious answer seems to be he felt he badly needed Rockefeller's support or was afraid the governor's continued criticism might hurt him.

In the end Rockefeller issued what both men call an agreement on "basic positions." But as Nixon later disclosed in a news conference there were some major gaps in that agreement which didn't show up in the next.

For example: while the agreement calls for strong defense efforts, Rockefeller feels the government should be spending immediately an additional \$1.5 billion dollars. Nixon didn't agree on that.

The agreement doesn't mention any money item. Neither does the defense plank approved Sunday by the party platform committee which has been working here a week.

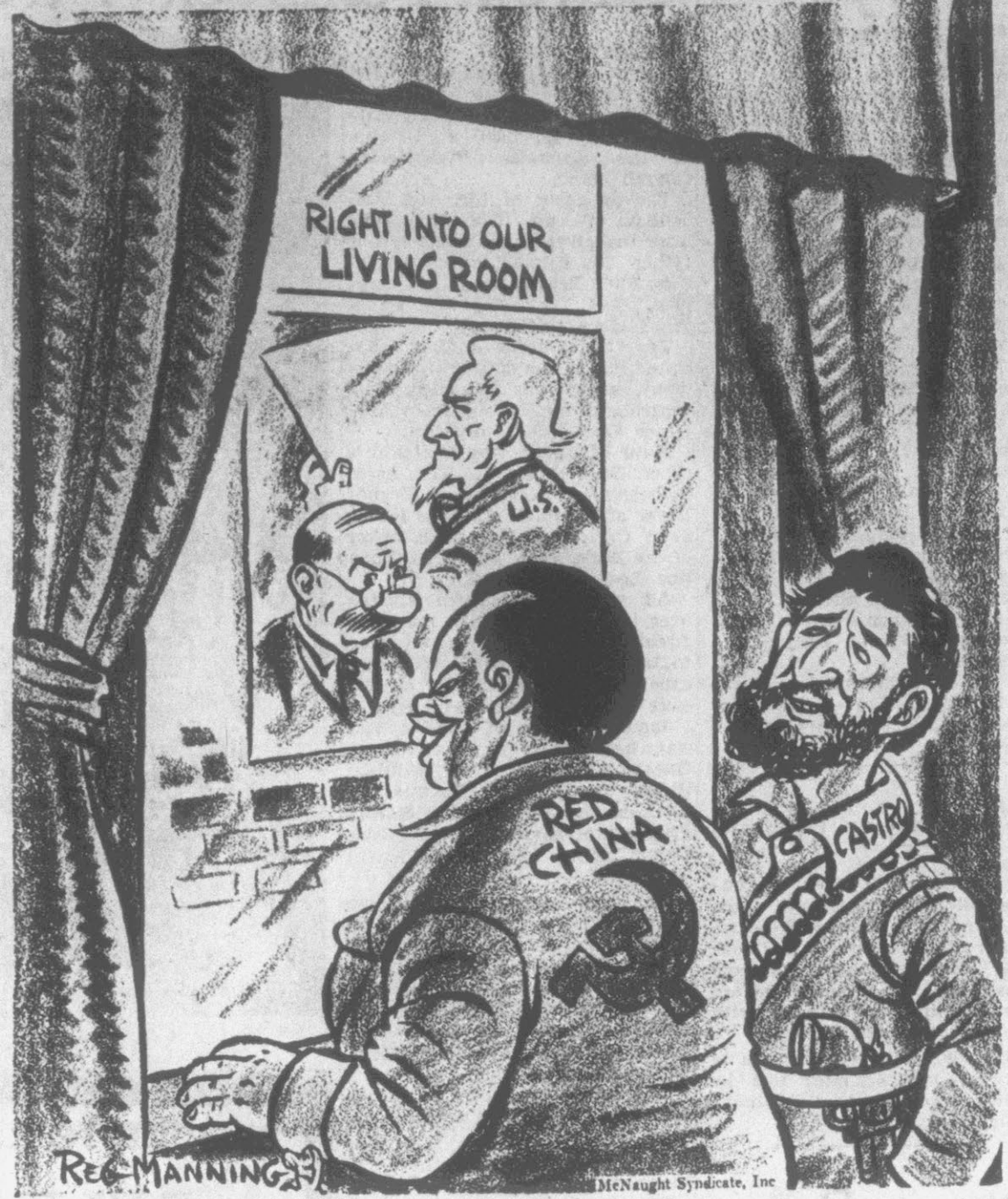
Rockefeller thinks major strikes should be settled by compulsory arbitration. Nixon does not agree. Neither did the platform committee in the labor plank it sanded and polished and presented to the public.

The sharp edge seemed to be removed from Rockefeller's attitude toward the platform—at least it appeared that way from his appearance Sunday—so the Nixonites may feel the vice president captured the governor.

But the very fact Nixon made what his critics may call a pilgrimage to the New York may be interpreted as meaning the governor captured him and made him bow, to some extent, to Rockefeller's platform demands.

Strong Or Soft Policy?

One of the conflicts within both the Republican and Democratic parties is whether this country should have a strong or a soft foreign policy. The Eisenhower Administration, when John Foster Dulles was Secretary of State, pursued a strong, independent foreign policy based on the assumption that the United States cannot be sacrificed to serve the purposes of any European or Asiatic nation. Dulles was duly attacked by all the foreign agencies which exist in this country to brain-wash the American people. Under the joint operation of our policy by President Eisenhower and Christian Herter, we have beyond doubt grown soft. The operation of our policy toward Cuba has been absurd. The Democrats will take full advantage of that.

However, more Democrats than Republicans favor the soft policy. If Adlai Stevenson is to have a voice in the formulation of the Kennedy foreign policy, it is bound to be a soft one because Stevenson has often proclaimed that as his position. What can the Democrats say to soften their own platform regarding Red China where Americans are still incarcerated?

For instance, it is the policy of Red China to imprison American Catholic priests. A Red Chinese Catholic Church has come into existence which does not recognize the authority of the Pope or the Vatican. It must be pointed out that there have been Roman Catholics among the Chinese people for at least five centuries and that the most recent Catholic to be imprisoned is Bishop James Edward Walsh, an American, who is accused of being a spy for the United States.

We have no way of dealing with Red China. The recognition of that country by the United States for any purpose would imperil the lives of Americans still in prison there for no other reason than that they are Americans.

The principle of the inviolability of American life and property has always been upheld by both parties until Woodrow Wilson's Administration when we went soft. The Republican Party has never had a soft foreign policy until after the death of John Foster Dulles in the Eisenhower Administration. This is the record and Richard Nixon could win or lose on that record.

In a difficult campaign, the swing will be on three factors: personality, issues and the course of events. So far as personality is concerned, both men are strong and young. Those who do not like Nixon can never say why. They have heard something or been told something. Likes and dislikes are not to be analyzed. There are those who would not vote for John Kennedy if he were the Angel Gabriel and there are others who feel that way about Nixon. The bigots will be out in full force against Kennedy because they fear the Pope; on the other hand, there are so-called Liberals who never forgot that it was Nixon who found the "Pumpkin Papers" which did Alger Hiss in.

As for issues, there are those who are keen students of problems and there are others who live all their lives without giving a thought to anything but their own small lives and their own small environments. Not everybody is interested in why the Congolese are so offbeat. (Continued on page 5)

Congress will soon be back on the job. And according to Jack Kennedy the Democratic nominee for President, it has much work to do, in order to set a record for campaign material. He says an upped minimum wage, medical care, and enlarged social security base are must legislation.

It appears that the demand for vote getting will out weight statesmanship. There is also talk of increased appropriations for defense. For it should be remembered that Congress passes the laws.

Now congress is to be asked to put this fund, that is paid by you and me, further in the red. For more and more people are drawing from the fund yearly. And this is certainly to increase. The plan to cover medical expenses will have to raise the social security taxes and steeply. Everyone wants to take care of the indigent aged and sick. But the plan is not just for them.

Here is an example of how social security can work. It is not based entirely on what you have but what you earn. You can inherit any amount of money and continue to get the income from it. But you can only work and earn so much.

Here is an example. One woman inherited a quarter of a million dollars, not many years ago. She was a clever person, and for this she certainly should not be blamed. She worked only the necessary quarters and then stopped to add social security to her income. And it is said that each monthly check approximates all the contributions she made.

Now under the present proposal the medical bill will also be paid by the social security taxpayers.

What we are saying is that Congress, regardless of the need for a record, should not railroad through an ill-considered medical bill that will put an even bigger mortgage on our future.

This is just one of the pieces of vote getting "record" legislation that will be passed in the next Congress. Read, think and let your congressmen know that you want a sensible and practical government. For the taxes will be there from president to president.

# Seek Avoid 'Rubber Stamp' Platform

## Several Hundred Youths In Racial Clash; 18 Arrested

GREENVILLE, S.C. — (AP) — Several hundred whites and Negroes carrying weapons ranging from a pistol to brass knuckles to a .45-caliber shot gun clashed near two white drive-in restaurants last night. City police arrested 18 persons, mostly teenagers.

Outside the city at another white drive-in two miles west of Greenville another crowd of about 100 whites and Negroes were dispersed by four patrol cars and eight deputies from the Greenville County sheriff's office. No arrests were made.

This was the second night of racial disturbances in this western South Carolina city. On Sunday police said a brief scuffle involving about 200 whites and Negroes broke out among a teen-age group near a drive-in restaurant.

Capt. G. O. Bramlette of Greenville City Police said that lunch counter demonstrations at two downtown variety stores here last Thursday probably triggered the incidents. At that time a crowd of 500 whites and Negroes milled about after Negroes left sit-ins at the S. H. Kress store and the W. T. Grant store. Some punches were exchanged between the two groups, and three white youths were arrested and charged with disorderly conduct.

Of the 18 persons arrested last night, one was a white man, about 40, who carried a pistol in the melee. A set of brass knuckles was taken from another participant and a slingshot from still another.

Police said some of those in the crowd also carried knives, which Capt. Bramlette described as being not "illegal" knives. He said an illegal knife was one with a blade over three inches in length.

The crowd, broken up into several groups, gathered in the vicinity of two drive-in restaurants. Some whites and Negroes began throwing rocks at each other, police said.

A Negro man fired a pistol through the windshield of a car belonging to a white man. The Negro escaped before police could arrest him. The white man was not injured.

Police said most of those arrested would be charged with disorderly conduct. They included 10 Negroes and 8 whites. Two of the 18 were under 16 years of age.

At the peak of the incidents city police had 12 patrol cars rushing about the city.

CHICAGO (AP)—The rebellious Republican Platform Committee, anxious to avoid a rubber stamp label, clearly needed convincing by Vice President Richard M. Nixon today if it is to meet his demand for a stronger civil rights plank.

Nixon was displeased with the tentative plank adopted by the committee early Monday. He met individually Monday with a procession of committee members and—probably more important—with key delegates in a position to influence the members.

Should Nixon fail in his efforts, the politically unpleasant prospect was a noisy floor fight on the issue at the GOP National Convention Wednesday.

Nixon postponed meetings with 29 state delegations to wrestle with the civil rights problem. His first hours in Chicago were devoted to little else.

Sen. Hugh Scott of Pennsylvania, a member of the platform committee, expressed the view that the overnight efforts of Nixon and his aides would win the battle—which became clearly drawn only after Nixon and New York Gov. Nelson A. Rockefeller agreed on a 14-point platform position.

Scott said the committee's action in postponing a final decision until today was favorable to advocates of a stronger rights plank than the committee originally endorsed.

Joseph F. Carlino, speaker of the New York General Assembly and chairman of the platform subcommittee that wrestled with the civil rights question, took the same view.

Carlino told newsmen he hoped that by today "the atmosphere will be such that a motion to reconsider will be appropriate."

On the other hand, Thomas Staggs Jr. of Louisiana said "We have enough votes to defeat" any move to strengthen the adopted plank.

The Southerner evidently was counting on committee anxiety to resist what he called "any attempt to dictate by Mr. Rockefeller or by any other source outside the committee."

Rockefeller himself commented, "We've got the language, but have we got the votes?"

The plank approved by the platform committee was a cut-and-paste job, assembled from a number of tentative drafts put forth by both liberals and moderates.

Compared with playing baseball, acting's a snap.

Say I'm batting .300, which is pretty good for me. That's pretty good hitting. But in acting I have to be batting 1,000. This is possible because if I misplay a scene or strike out on a speech, they re-shoot it. Simple, no?

As a rookie I learned early about the expendability of a player who doesn't consistently post a good batting average.

I always had my heart set on

playing first base for the Dodgers. But Gil Hodges, with 32 home runs under his belt that year had it sewed up. This, combined with my nemesis, Manager Burt Shotton's violent disapproval of my clowning and brashness, made me expendable. I was sold to the Chicago Cubs.

The Cubs farmed me out to the Los Angeles Angels. I eventually went through the revolving door, returning to the Cubs and back to the Angels again. That's when one of my Los Angeles fans, MGM casting director Billy Gray offered me a part in a motion picture.

Believe it or not, the thought of acting held no terror for me. That first part—playing a state trooper in "Pat and Mike"—paid me \$500 for three days' work. This, I thought, was a great racket. So, during the subsequent off-season I got some more little jobs which paid anywhere from \$100 to \$750 a week.

All told, during that off-season, I earned over \$11,000 for my movie work. It sure didn't take a genius to figure this was better than the \$6,200 I was getting playing first base for 6½ months.

That's when (in 1952) I quit baseball to become a full-time actor.

I still had a lot to learn about acting. But it was my baseball background that did the trick for me when I got the big break.

When I came up to the test for the Lucas McCain leading role in ABC-TV's "The Rifleman," more than 40 actors had already been tested and turned down. The McCain role called for the actor to be able to handle a rifle as easily and as skillfully as a twirler does his baton. The producers used a unique device to test each candidate's potential on this score. As each actor walked through a door, a rifle was thrown at him. You can imagine the reactions and results—some dropped it, some were clobbered.

Luckily, my good baseball reflexes came to the rescue when it was my turn at bat, so to speak; it was more like a bat boy tossing me a bat. Casually, I snatched the rifle in the air. This impressed the producers—and eventually they offered me the part.

Now, with some degree of a steady job in one place, for the first time my wife Betty and four young sons have been able to settle down. As a pro baseball player we were kept on the go most of the time, living in places where major and minor league teams had ball parks. Now, we're living comfortably in the San Fernando Valley near Los Angeles.

## Rollman Protest In Clerk's Hands

WASHINGTON (AP) — Claims by Republican Heinz Rollman of Waynesville, N.C., in a recent special congressional election in North Carolina will be handed in the "usual manner."

That was the word here Monday from House Clerk Ralph R. Roberts. He said he could do nothing about a request from Rollman that the U.S. House look into the conduct of Rep. Harold C. Cooley (D-NC).

Rollman has charged that Cooley misrepresented the facts when Ray A. Taylor (D-NC) was sworn in July 2—three days before Taylor's special June 25 election victory was officially certified. Taylor was sworn in after Cooley told the House his election was not being contested.

However, Rollman, a shoe manufacturer, claims he notified Taylor on July 5 he was contesting the victory. Rollman argues the election was not official because it was called on only 19 days notice.

Rollman, who will oppose Taylor for the North Carolina 12th District seat in November, had his name stricken from the ballot for the special election to select a successor for the rest of the term of the late Rep. David Hall, also a Democrat.

The Rollman-Taylor dispute will be turned over to the House Administration Committee for a decision. This will come after Taylor files an answer to Rollman's claims—which must come within 30 days after July 5. Then both sides have 90 days to take testimony and deliver it to Roberts, who in turn passes it to the committee.

They only wonder why Mary Ann shacked up with that no good guy. Such people vote for faces, for what they say, for what they believe about people. Some will vote for Kennedy because they hate golf; others will vote for Nixon because they hate golf; others will vote for me because they don't like millionaires.

But the course of events is something very different. Khrushchev, Castro and such people are going to have much to do with this election. They can and will take steps which will vitally affect public opinion in this country because Americans get sore easily and quickly and sometimes because they don't know why and don't care why. These sudden explosions between now and November will affect the election.

For instance, a statement like this by Nikita Khrushchev will mean much:

"The United States is a very rich country, and some American leaders believe that our economy will not advance if they do not want to trade, we this is an obvious delusion. If they do not want to trade, we shall wait... they will trade with us because they have no other way out. We can wait until this happens. Wait even for 100 years..."

## Faubus' Bid In Hands Of Voters

LITTLE ROCK, Ark. (AP) — Gov. Orval E. Faubus' bid to become Arkansas' first four-term governor today rested with the voters in the Democratic primary.

Faubus, central figure in Little Rock's 1957 integration controversy, confidently predicted a record 400,000 voters would nominate him over four avowed segregationist opponents.

The other candidates forecast 360,000 to 375,000 votes and predicted Faubus would be forced into an Aug. 9 runoff. No incumbent governor has ever survived a second primary.

In 1958, a record 383,000 voters gave Faubus a third term by a 2½ to 1 majority.

Opposing Faubus are Atty.-Gen. Bruce Bennett, a leader in the anti-integration movement; Joe C. Hardin, planter-businessman; H. E. Williams, Baptist preacher and small college president; and Hal Millsap Jr., a grocer and oilman.

Sen. Barry Goldwater of Arizona, a friend of Nixon but also a representative of the Republican extreme right, called Nixon's trip a "surrender" and a sellout to the "Republican left."

Some members of the platform committee showed anger at the idea that Nixon and Rockefeller between them should draw up an agreement which, in effect, could be taken as a demand on the committee to conform.

Some of this committee resentment bubbled out when its subcommittee on civil rights refused to go nearly so far as Nixon and Rockefeller agreed the party should go on this issue.

In the 1944 campaign Republicans made capital of a report that President Roosevelt left selection of his vice presidential running mate up to a labor leader, Sidney Hillman, by saying "clear it with Sidney."

This year it wouldn't be surprising if the Democrats try to turn this phrase around by jibing at Nixon that before he could start his campaign he had to "clear it with Rocky."

Club Pros Stand Slim Chance In PGA Tourneys

AKRON, Ohio (AP)—The bigger the Professional Golfers Assn. championship grows, and it has pushed into the big three of American pro golf, the smaller it is likely to become in interest to the fellow it used to be designed for—the club professional. That seemed to be the trend today as the nation's top players and teachers headed for their homes and stops on golf's continuing circuit after Jay Hebert's nerve-numbing victory in the 1960 PGA tournament. Of the top 60 finishers in the final standing, only a handful were club pros. It has been that way for three years now since the PGA was changed from a match play event on generally easy "pool tables" to medal play on a course like this 7,165-yard, par 35-35-70 Firestone Country Club monster that played as tough as a site of the National Open. Only the regular members of golf's tutoring group have a chance on courses like these. At the start of last week, 90 per cent of the touring pros claimed Firestone was too tough for all but a few of their number. That Hebert wasn't one of those mentioned as capable enough really shouldn't matter. What does matter is that of the top 60 in a field that originally numbered 184, the best performances by club pros were 72-hole totals of 296 by old-timer Henry Picard of Cleveland, Shelley Mayfield of Jericho, N.Y., and Bob Harris of Winnetka, Ill. That's an average of 74 per round and 15 strokes off the 281 that won for Hebert and his blazing finish in Sunday's final round. For a time, John O'Donnell, 46, teaching pro at a public links course in Baltimore, stuck close to the leaders. But he couldn't break 80 in the last two rounds and finished way back at 305. "If you get any money away from these touring players in a medal play tournament, you just have to be lucky," O'Donnell said. Used to be that a club pro would sneak in now and then and grab the PGA title. But in the three years since it went from match play to medal play, the champions have been all tourists—Dow Finsterwald, Bob Rosburg and now Hebert.

Piersall Discussion Called Off By Tribe

By DON WEISS NEW YORK (AP)—The Jimmy Piersall controversy has calmed down — on the surface — but remains explosive underneath. Troubled peace has descended on the Indians. A scheduled meeting today between the Cleveland players and Manager Joe Gordon to discuss the perplexing Piersall problem was called off late Monday night but it's no guarantee that another won't be called. Player representative Harvey Kuenn, after a talk with Piersall, said there was no longer any necessity to have a meeting. Piersall, at first greatly distressed to learn that the players planned to hold a meeting concerning him, voiced pleasure over the decision. "Piersall convinced me that his talk with President Joe Cronin had given him a new outlook," said Kuenn. "Jim promised me that he would mend his ways and his teammates are going to give him a chance to prove it. We're very glad we didn't have to have the meeting." On the surface, everybody is happy. But the resentment apparently lingers on. The latest Piersall episode began Monday afternoon when Kuenn disclosed he had requested a meeting between the Cleveland players and Gordon to discuss what should be done about Piersall because of his numerous wrangles with the umpires. Jimmy's latest squabble, which resulted in his sixth ejection, last Saturday, resulted in a summons to Boston Monday. He received a fatherly talk from Cronin and was fined \$100. It wasn't until he arrived in New York that he learned of the proposed meeting. "What have I done now?" was his first reaction. "I felt like I had jumped out of the frying pan into the fire," said the 30-year-old star center fielder. "I had just told Mr. Cronin that I was wrong and I promised him I would cut out the horse play and concentrate on baseball. Then I come to New York and see where they were going to have a meeting about me. I don't mind telling you I was terribly disturbed." "I asked Harvey, who is a friend of mine, what it was all about," said Piersall. "He told me the players felt I was making them nervous with my actions on the field and they wanted to talk the situation over with the manager." The cheers that greeted each fresh set of figures on the blackboard became louder.

By eight-thirty the District Attorney's lead had increased to two-thirds thousand. In the contagious carnival atmosphere men and women were laughing, shouting and embracing strangers. Someone started chanting, "We want Dan. The chant became a roar. At nine a new excitement swept the crowd. The candidate was going to put in an appearance!

Herald's City Room as Callahan and his party entered, was a scene of bedlam. Television equipment and technicians seemed to be everywhere. Phil Stimson was in shirt sleeves conducting a running television commentary on trends and interviewing a stream of minor candidates who waited just out of camera range for their chance at the free television time. Seeing the District Attorney enter, Stimson signaled to him frantically. Callahan limped over the bo interviewed.

"Mrs. Callahan," Stimson said dead-pan to the camera, "how do you feel?"

"Phil, I feel very humble."

"How do you size up the returns?"

"Well, they justify my faith. This is the people justify my faith. We tried to carry the badge for basic principles to the people, and it looks as if they got our message." Callahan hesitated. "Of course, the election isn't over yet."

"Supposing you become Governor. Do you intend to run for the Senate at the end of your term?"

"I just want to be a good Governor. That's my only ambition now."

"Would you say that this primary has been unusually bitter?"

"We Democrats always do our scrapping in the open. I think it's a healthy sign. A sign of vigor, honesty. As for me, I'm not mad at anybody."

"Who do you pick to win the race for Lieutenant Governor?"

"Phil, I've been paying so much attention to my own race, I haven't been watching the others. But they're both good men. The Democratic party can be proud to have either one on the ticket."

Stimson received a station-break signal from the engineer. "Well, Mr. Callahan, it was wonderful having you with us. It was wonderful, Phil. Wonderful!"

A few minutes later Callahan and his party, along with approximately twenty other people, were in Keenan's private office, and the room was quickly divided into two camps. In one camp were those congratulating the publisher who was hoarsely and happily expounding on the secrets of winning elections. In the other camp were those congratulating the District Attorney.

At Simon headquarters the tempo of the festivities increased. The Senator, making his first appearance of the evening before his supporters, received an ovation. Interviewed by a television reporter, he said with a wink, "It's still too early to detect a trend. An election's never over until the last vote is counted." As he left the room he ran a gauntlet of well-wishers who had kept their admiration to themselves until the late returns began to come in. It also included a number of men who had been converted so suddenly that they had either lacked the time or else forgotten to remove their Callahan buttons. Now it was Simon all the way.

Dan Callahan, sweating profusely, limped into Simon headquarters. A hush fell across the room as he worked his way through the crowd to confront the Senator. The two tense, exhausted men eyed each other warily. Then Callahan grinned. "Alex, you rascal, how do you do it?"

Simon relaxed. "With mirrors and moon-dust." He cut a caper for the benefit of his admirers. "Plus plenty of yogurt and Vitamin C."

A television reporter interjected, "Mr. Callahan, could we have a few words for the people at home?"

The District Attorney smiled into the camera. "Alex, I congratulate you. You're still the Champ. I know! I've taken your knockout punch. But we both fought hard, we brought the issues out in the open, nothing was covered up, and we let the voters decide. I bow to their decision. To all my supporters, I say, thank you, thank you from the bottom of my heart. We did our best, and that's all anyone can do. We know it's hard to lose. In spite of all our feuding, we're still Democrats and we want the best man to win in November. And we're going to see that he does. Alex, we're with you all the way. We're going to the bridge with you."

# Hoover Repeats 'Farewell' Speech

**CHICAGO (AP)**—All the chairman could get out was, "Ladies and gentlemen, I present to you one of the greatest humanitarian..."

The ladies and gentlemen knew who was coming. They roared, stamped, clapped and marched. Here he was again, the ancient Republican, and again he was saying this would be the last time. "Unless some miracle comes to me from the good Lord, this is finally it," Herbert Hoover told GOP conventioners who seem to like him more as the years go by.

Certainly hoping he was mistaken, the Grand Old Man of the GOP had announced in 1948, 1952 and 1956 that those were his farewell conventions. He repeated the announcement Monday night.

"No" shouted the people who jumped him every four years. Saluting their first chance to make noise in Chicago's festooned convention hall, they relished this kind of talking back to father.

Hoover smiled his peculiar smile. His tight lips curled down, his eyes twinkled.

Hoover is the Republicans' Harry Lauder. That Scot singer was forever making farewell tours. This was Hoover's eighth convention tour. And Republicans who love the sight of the once rejected leader, now a living portrait of white-haired patriarch, were out to see him again.

Hoover's voice is thinner than before and less clear. He talked of a moral slump in the land he once served as president.

He spoke against the hum of a crowd half listening and half wandering. There was appropriate applause. But there were those in the flock who were not so worshipful of his words to hear them out.

That's not really offensive, in the ways of political conventions. Hoover, 85, knows the ways of conventions.

"Age has skill," he was told by a young man who heads the Young Republican National Federation. He presented Hoover the national convention medal.

They cheered again in the hall, and they prompted the man who has been living out the memory of a great depression, the man who now speaks of moral slump, to recall: "I, too, was once a young Republican."

## Nearly 8-Inch Rainfall For City

**ORLANDO, Fla. (AP)**—A severe thunder and rain storm dumped 7.95 inches of rain on Orlando between 3 and 5 p.m. Monday. Streets were flooded, traffic was snarled and homes in various sections were flooded.

Some families were evacuated in low spots and a number of lakes overflowed. Orlando has approximately 50 lakes within its corporate limits. Electrical power was off for about an hour.

The rain stopped shortly after 6 o'clock. The Weather Bureau said the total deluge measured 8.19 inches.

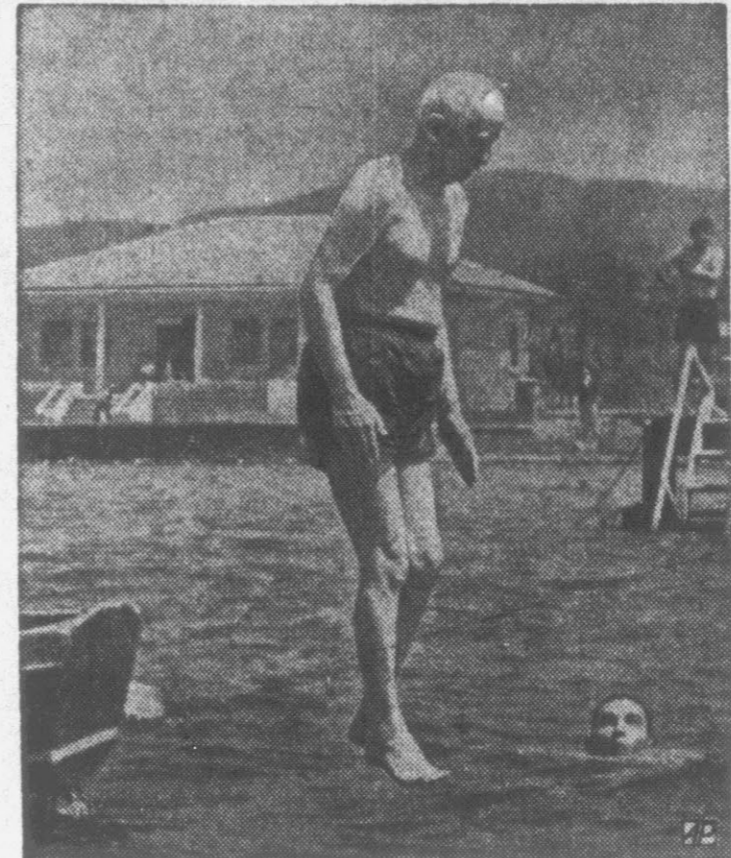
Exchange Club Entertains Boys

Gov. Hodges Reminds 4-H Clubbers Of Real Competition By Russians

RALEIGH (AP)—Gov. Hodges today reminded 4-H Club members of the real competition they face in their Soviet Union counterparts in the Soviet Union were embarked on a mission to overtake the United States in every field of endeavor. "The threat is real," the governor warned, "and we are not a nation of people that can be satisfied with second place." Hodges addressed about 1,400 youngsters and their leaders during annual 4-H Club week at Raleigh's Reynolds Coliseum. Hodges said of the Soviet youth, "He is convinced that we have become obsessed with our so-called 'good life' and could not meet his challenge even if we wanted to." "He has, I think, grossly underestimated the American people, and especially the young people of this nation, but at the same time, he poses a challenge that we cannot afford to disregard."

Whether the Soviet Union wins, Hodges said, is up to that country's youngsters. "The final decision will be made by you young people and by others like you throughout America," he said, "and it is a personal decision that each of you will have to make yourself. The will to win, the courage and dedication that will be needed to preserve and enhance our free way of life, must come from within. No one can make you apply yourself as the Russian youngsters do." Speaking for the nation's adults in their attitudes toward youth, Hodges said, "if we are overly critical, if we demand too much, if we appear a little desperate in our efforts to prepare you for what the future holds, it is because we are, perhaps, more interested in young people today than we have ever been before." He urged the 4-H members to take greater interest in governmental affairs at all levels. "Do not listen to those who tell you that there is something evil or dishonest about politics," Hodges commented. "In this nation, politics and government are one and the same—and it is only when supposedly good citizens shirk their duty and do not take part in government that corruption enters the picture."

At noon the Dow Jones industrial average was up 9.56 at 611.24.

# Southern Baptists Found In 49 States

By KATHRYN JOHNSON

ATLANTA (AP)—A marble polisher in Tampa, Fla., lost his job and moved to his wife's native town of Rochester, N.Y., to find work.

The couple's Tampa pastor, finding that Rochester had no Southern Baptist church, wrote the Baptist Mission Board. An area missionary was called, which led in short order to the establishment of a mission and, ultimately, a Southern Baptist church.

Thirty-five Southern Baptist members of a bomber wing, transferred from Roswell, N.M., to Portsmouth, N.H. found themselves without a church. They made contact with an area missionary and soon had themselves a place of worship.

The process is being repeated with variations hundreds of times in the pioneer areas of the Southern Baptist Church.

In 1941, Southern Baptists started a movement called Pioneer Missions, operated by the Home Mission Board, with headquarters in Atlanta. At that time there were Southern Baptist churches in 15 states. Today there are churches or missions in every state except Hawaii.

"A mission is a characteristic beginning of a Southern Baptist church," says Dr. A. B. Cash, pioneer director of the Home Mission Board.

"The word 'mission' has to do with the early stages of development of a church in an area where there's a need for one."

"The board gives direction and leadership as well as financial help by supplementing the salary of a pastor and helping to obtain property for a permanent building.

"The area missionary is leading the expansion in pioneer fields," adds Cash. "His primary function is to start new work."

Walter Knight, editor of Home Missions, a Baptist publication, says most area missionaries are young, well-educated and usually former pastors.

"The area missionary makes surveys and meets groups in early stages," he says. "He is more of a superintendent, not a pastor, and frequently makes contacts with groups who have been meeting at home."

"In the case of the Rochester couple, ads were run in newspapers, other prospects for membership found, and Sunday services started with about 10 persons. Later, the mission expanded into a church and a pastor was called."

The area missionary might be called a modern-day circuit rider using the latest methods of communication. He keeps up with changes in leadership techniques, organization, and promotional methods.

He used the camera, the projector, the mimeograph machine, newspaper ads, TV and radio and the phone to stay in touch with large areas. He covers more territory in a month than his 19th century prototype did in a year.

A pastoral missionary works in a dual capacity. He serves a mission or church as pastor and agrees that after the first year he will lead in the establishment of one new mission each year.

Usually the work is more rapid than one year. Ohio had set a five-year goal that was reached in two years. The work there has grown from 19 churches in 1952 to 191 churches and 64 missions today.

The area missionary, says Knight, sees beyond struggling churches and tiny missions to big churches and new state conventions.

The geographic term of the Southern Baptists is misleading. It is a denomination whose membership now totals nearly 10 million.

For many years the expansion was westward as Baptists moved toward the Pacific and still wanted churches "like those back home." More recently the movement has been to the cities of the North.

In 1956 the Southern Baptist Convention, composed of messengers or delegates from 3,200 churches, adopted a program that had as its goal the establishment of 30,000 preaching points by 1964. Approximately 10,000 have already been established.

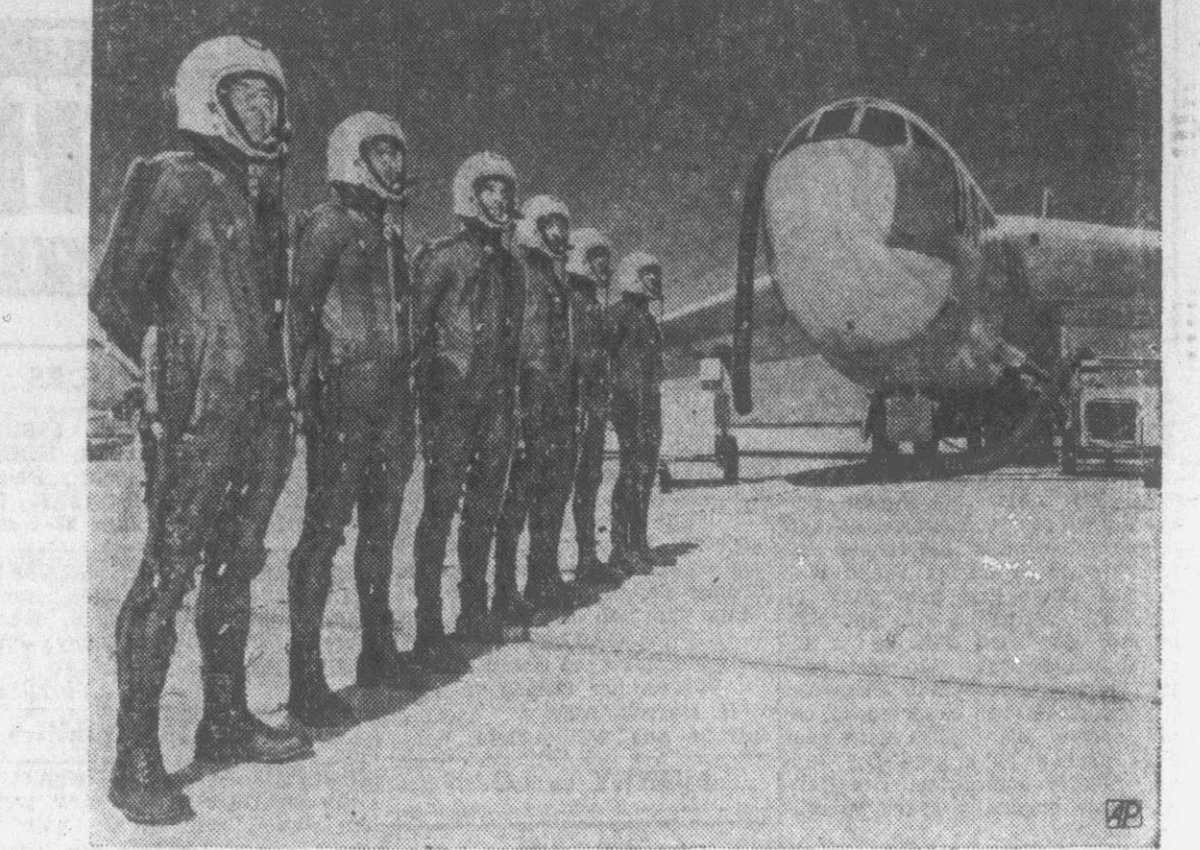
