Presume 2 Are Behind Red Curtain

Missing Intelligence Specialists Said Not In Possession Of Secrets

WASHINGTON (AP) — Two American intelligence specialists were presumed by the Pentagon today to have gone behind the Iron Curtain.

The two are Bernon F. Mitchell, 31, and William H. Martin, 29, employed since 1957 as mathematical analysts at the National Security Agency at nearby Ft. Meade, Md.

NSA is a supersecret defense unit which intercepts radio signals and works on communications intelligence 24 hours a day. Mathematics is one tool used for breaking secret codes.

The Defense Department broke silence late Friday on the whereabouts of Mitchell and Martin, who mysteriously disappeared June 24.

An official statement said it "must be assumed that there is a likelihood" that the two "have gone behind the Iron Curtain."

It added that an investigation indicated "information in their possession if revealed could be in no way prejudicial to the security of U.S. communications" and neither man had "access to classified information about American weapons or defense plans."

A Pentagon spokesman declined to say whether the pair had other information of value to the Reds, such as on U.S. code-breaking techniques and on NSA operations.

Nor would he say what Communist country they might have gone to or by what means.

The statement said the two had worked in limited areas of communications statistical work.

The department confirmed earlier reports that Mitchell and Martin had been traced to Mexico City and then to Havana.

In Eureka, Calif., Mitchell's father said "I certainly don't believe" the Pentagon's assumption that his son had slipped away to Red territory.

Emery F. Mitchell, a Eureka attorney, said "I'll never believe it unless Bernon told me so himself, and I have been with him long enough to know that he was in sound mind."

Martin's father, an Ellensburg, Wash., meat packing executive, said "We are deeply grieved over the information we have and we can't understand it. We hope there is some other explanation."

John Martin said he knew of no ideological bent that could explain his son's disappearance. He said his son was "just a good plain American."

U. S. government sources expressed belief that Havana, under the Castro regime, has been increasingly replacing Mexico City as a center for Communist operations in this hemisphere. Lack of cooperation from Castro officials has made it tougher for U.S. agents to track down Americans there.

Washington's investigation got under way after the two bachelors, friends of longstanding, failed to return from leave on schedule. Mitchell was due back July 11, Martin July 18, from vacations which began June 23.

The two told friends they planned to go on a leisurely motor trip during their vacation, visiting Martin's parents in Ellensburg and Mitchell's family in Eureka.

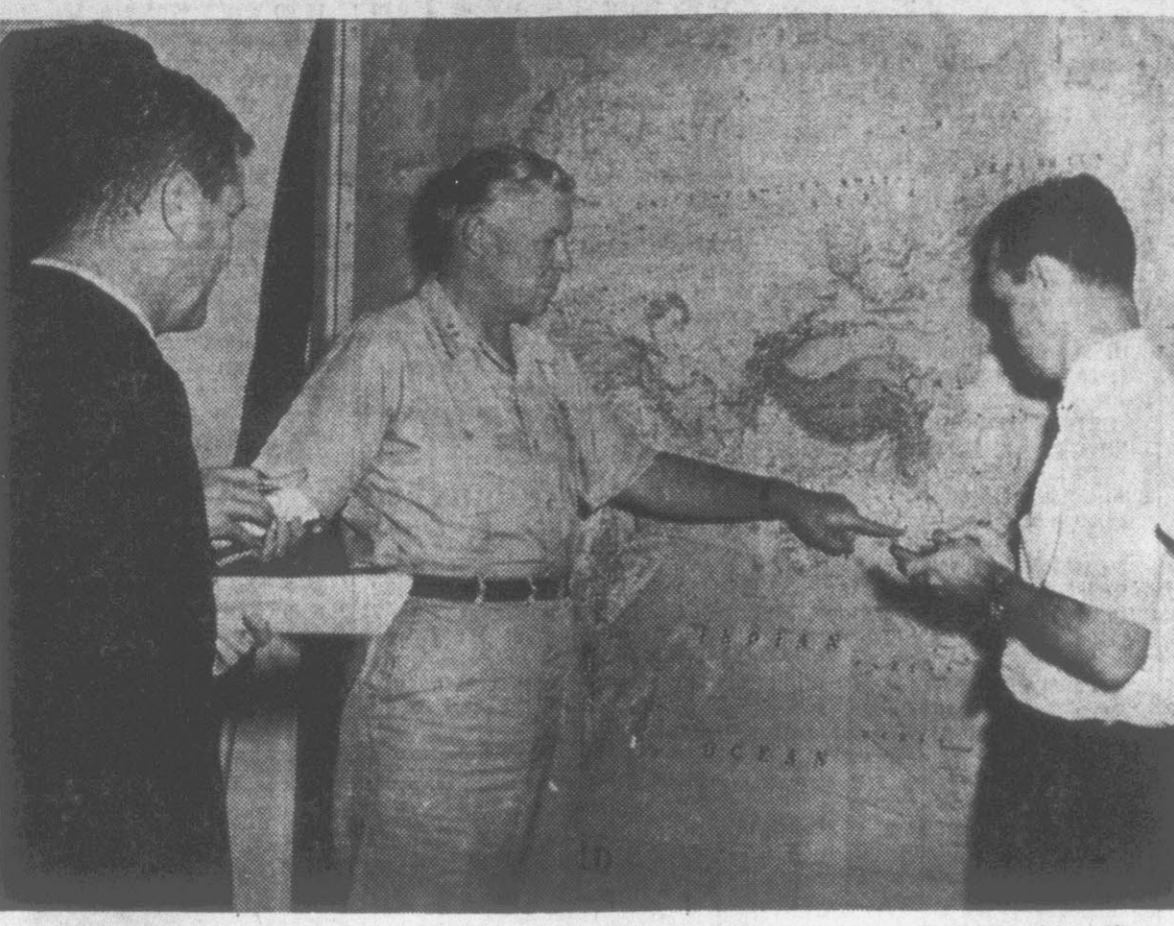
Instead, they took a commercial flight to Mexico City June 25. After a short stay there, they flew on to Havana. The families said they had neither seen nor heard from their sons for some time.

Last December the two had also gone to Mexico and Cuba, likewise without telling NSA. This was a violation of NSA regulations requiring employees to give prior notice before traveling outside this country.

The men had been buddies in the Navy, where both served four years as communications technicians.

Each joined NSA in 1957. Mitchell after graduating from Stanford University and Martin after graduating from the University of Washington. Both were middle-rank specialists at NSA in the \$3,500-a-year salary range.

UN Disarmament Group To Meet Aug. 15 As Planned

UNITED NATIONS, N.Y. (AP) — The 82-nation disarmament commission is expected to meet on Aug. 15 or shortly thereafter despite boycott threats by the Soviet Union and other Communist nations.

This was the prospect today after the United States suggested that the most constructive step the commission could take would be to call for a resumption of the deadlocked East-West disarmament negotiations.

In a letter obviously intended to quiet fears of neutral nations that the commission meeting would only heighten existing East-West tension, U.S. Ambassador Henry Cabot Lodge told the commission chairman:

"It is not the intention of the United States at this meeting to request the Disarmament Commission to make decisions regarding specific measures of disarmament."

"We believe that the most constructive outcome of the disarmament commission meeting would be a resolution which registers the common desire for prompt resumption of negotiations."

Lodge, the Republican nominee for vice president, plans to resign his post as chief U.N. delegate after taking part in the disarmament proceedings.

Mexican Ambassador Luis Padilla Nervo, the commission chairman, is receiving replies to a letter asking members of the commission how they felt about a meeting on Aug. 15.

Lodge said the United States "is fully in accord with the proposal that the Disarmament Commission should meet on or about Aug. 15."

President Eisenhower had proposed originally that the commission meet on Aug. 5.

Soviet Premier Nikita Khrushchev objected. He said disarmament should be taken up by the 82-nation U.N. General Assembly, which opens on Sept. 20. He suggested that the heads of governments be invited.

The United States reaction to any world summit conference on disarmament was cool.

Nixon Concludes 11,384-Mile Trip

WASHINGTON (AP) — Vice president Richard M. Nixon returned today from an 11,384-mile campaign tour that he marked down as "very pleasing."

The trip in a four-engined commercial airliner took the Republican nominee to Hawaii, where he was the first presidential candidate ever to campaign actively for votes in the newest U.S. state.

On the way back he traveled off the regular course to campaign Friday night in Seattle, where he told newsmen that "the prestige of the presidency could be brought to bear" to help end civil rights controversies.

There are no authoritative figures on the length of previous campaign tours. But Nixon's 11,384 miles between Tuesday and Saturday mornings apparently is the longest ever made in such a short period. He told reporters traveling with him he was pleased with his results.

The tour took Nixon's party to Nevada, California, various islands in the Hawaiian group and Washington State. He plans later to hit every state in the union in his drive for votes in November.

Only a small group—mostly members of families of those in the Nixon party—were on hand to meet Nixon's plane when it landed at National Airport on an overcast morning.

Nixon greeted the group informally, shook hands with some, then told newsmen he was going home to go to bed and rest after the long tour. With the exception of a possible meeting with his staff, he had no appointments or appearances scheduled for the weekend.

He put major emphasis on civil rights in his visit Friday night to Seattle, where he said that he would take the initiative in such matters if elected president.

Girls Rebel At Army Curfew

MANORBIER, Wales (AP) — Twenty-one girls of the Women's Royal Army Corps rebelled today against an 11 p. m. curfew. They say it's interfering with their romantic life.

The leader of the revolt, Pvt. Elizabeth McConachie, 17, said "We felt we were being treated like children and that we were not being trusted. A lot of the girls' boy friends were displeased at having to bring them back so early. It was very frustrating."

The WRACS staged a midnight demonstration on the camp parade square. They refused to move until an army patrol — all men — was sent out to herd them into the camp jailhouse.

The rebels won the first round. The army promised to investigate their complaints and released them without even a bad conduct mark.

Vanceboro Man Killed By Car

VANCEBORO, N.C. (AP) — A 64-year-old Vanceboro man was struck and killed by a car one mile south of here Friday night.

The victim was Clyde Jackson, State Highway Patrolman P. M. Herring said that Jackson walked onto the highway and was hit by a car driven by Joseph Eugene Thomas of Ernul.

Will Take Soil Samples In Rare Disease Study

GRIFTON — A pair of medical students will gather soil samples in this vicinity next week in connection with a follow-up study of a rare disease which occurred here in 1954.

The disease, North American blastomycosis, is infectious but not contagious. There have been no cases recorded here since December of 1954. Previous studies indicate the disease is caused by a fungus, but so far the fungus has not been located.

The students, Wade Weems of Waynesboro, Va., and N. S. Craven of Lexington, N.C., will be working in conjunction with Dr. Georgia V. Mills, Pitt County health director. Their work is sponsored by the Duke University Medical School, where they are students through the Hanes Fellowships.

Dr. Ernest Chick of Duke University is their director.

It is suspected that the fungus causing the disease was located in the soil during the 1954 outbreak, and that people became infected by breathing in dust from the soil. Weems and Craven said that this summer, conditions seemed "ideal" to sample the soil, as climatic and soil conditions are believed similar to what they were in 1954.

However, they emphasized that no further outbreak of blastomycosis is anticipated.

First Outbreak

The mystery of this rare disease has never been solved, though there have been scattered cases in eastern North Carolina over a period of 25 years, the stu-

Dag Proposes UN Assure Katanga Role Is Impartial

UNITED NATIONS, N.Y. (AP) — Dag Hammarskjold proposed today that the U.N. Security Council assure dissident Katanga Province that U.N. forces have no intention of taking sides in the Congo's internal conflict.

The U.N. secretary-general declared that such action by the council might well open the door to a speedy settlement of the issue posed by refusal of Katanga Province to admit U.N. forces.

He made the statement in a report to the 11-nation council released here before his arrival from the Congo.

At Hammarskjold's request, the Council has been called into urgent session Sunday night on the Congo crisis.

Hammarskjold put an 11-page report before the council detailing his efforts to carry out previous council resolutions calling for a speedy withdrawal of Belgian troops from the entire Congo.

He included the latest word from his chief troubleshooter, Dr. Ralph J. Bunche, that U.N. military units could have entered Katanga only by force.

Hammarskjold said it is now clear that the objectives of the resolution cannot be achieved by the use of U.N. force, "as its mandate has been defined." He added:

"If the council, as it is assumed, wishes to maintain its objectives, the council must, therefore, either change the character of the force, which appears to me to be impossible, both for constitutional reasons and in view of the commitments to the contributing governments, or otherwise resort to other methods which would enable me to carry through the implementation of its resolutions without going beyond my instructions as regards the force."

He said the problem for those resisting U.N. forces in Katanga is whether U.N. participation and control of security would submit the province against its wishes to the rule of Premier Patrice Lumumba's central government.

Hammarskjold said this is a political problem to which the United Nations "obviously cannot be a party. Nor would the entry of the U.N. forces in Katanga mean any taking of sides in the conflict to which I have just referred."

Then, suggesting a possible course of action to the council, he said: "The Security Council may wish to clarify its views on the matter and to lay down such rules for the U.N. operation as would serve to separate effectively questions of a peaceful and democratic development in the constitutional field from any questions relating to the presence of the U.N. force."

The council has called twice for speedy Belgian withdrawal, but any action which would condemn Belgium or seek to deal too harshly with her was certain to arouse opposition from other Western nations, particularly France.

There was speculation France might veto any resolution it considered too harsh on Belgium.

Hammarskjold made plain he felt he does not have enough authority under pending resolutions to risk bloodshed by trying to force entry into Katanga.

"Such an initiative by the U.N. force is against the principles established by the Security Council for the operation of the force and against conditions on which various contributing countries have agreed to send units to the force," he said in Leopoldville.

Tshombe was hailed in Katanga where both whites and his African supporters agreed he had won the first round in his bout with the U.N.

Three Congolese Officials Planning Be At Security Council Showdown

LEOPOLDVILLE, the Congo (AP) — Three Congolese ministers decided today to follow Secretary-General Dag Hammarskjold to New York for Sunday night's U.N. Security Council showdown on dissident Katanga Province.

On the way they plan to confer with Premier Patrice Lumumba, now touring west African countries. He may abandon his trip, turn around, and return to New York for the council session.

The decision to send the ministers to New York was reached at an emergency Cabinet meeting after Hammarskjold had scrapped plans to send U.N. troops into Katanga, the rich province which has declared its independence from the Congo.

Hammarskjold's top troubleshooter in the Congo, Undersecretary Ralph J. Bunche, warned after a visit to Katanga that sending U.N. troops to the province might provoke bloodshed.

The Congo ministers going to New York are Foreign Minister Justin Bomboko, Deputy Premier Rene Mwambe, and Thomas Kanza, the Congo's minister-delegate to the United Nations.

Although leaders of Lumumba's government have been pressing the U.N. to bring Katanga under control of U.N. troops, their reaction to Hammarskjold's backdown on Katanga was mild.

This indicated they prefer to go along with a U.N. solution of the problem rather than risk Soviet intervention—threatened by Lumumba—to restore order.

The view in both diplomatic and government circles is that the spotlight now has turned on Belgium, and pressure will be on Brussels to comply with earlier Security Council resolutions calling for withdrawal of Belgian troops from the entire Congo, including Katanga.

Without Belgian support, Premier Moise Tshombe's Katanga regime probably would collapse quickly.

In his capital of Elisabethville, Tshombe issued a statement saying: "I rejoice to see that Dr. Ralph J. Bunche and, through him, the U.N. have taken cognizance of the Katanga people's resolution not to accept anarchy and chaos."

In propping up Tshombe and frustrating the U.N. effort to restore order in the Congo, Belgium has taken the risk of making the Congo an important issue in the cold war.

The Soviet Union is eager to get a foothold here, either by providing massive technical assistance to the tottering central government or sending Communist troops into the Congo operation.

Hammarskjold has scrupulously observed the terms of the U.N. resolution and speedily accumulated a force of predominantly African troops. This force now is in a position to guarantee order or very near it. Only the intransigence of Tshombe bars the way.

Bunche became convinced of the danger after conferring in Elisabethville with Katanga Premier Moise Tshombe who vowed he would use force to keep out U.N. troops.

Hammarskjold's decision not to enter Katanga and replace Belgian troops now patrolling the province came amid ominous rumblings from two quarters.

The Soviet Union drummed out a warning that if the U.N. fails to get all Belgian troops out of the Congo, forces should be sent in from other countries "which would be ready to contribute."

And ministers of the Central Congo government talked loudly of "sending our troops to Katanga" if the U.N. keeps stalling.

Observers said Hammarskjold's backdown on Katanga might have averted bloodshed, but they predicted it might spell trouble for the United Nations on several counts.

"We are back where we started," said one U.N. diplomat gloomily. "Anything may happen now."

U.N. officials grimly awaited reaction of the Congolese government which has insisted the new republic's No. 1 problem is to keep copper-rich Katanga in the fold.

They recalled a warning by Congo Premier Patrice Lumumba that his government would consider radical measures if Belgian troops are not out of his country by the time he returns Monday.

U.S. Soldier Has 'Disappeared'

HEIDELBERG, Germany (AP) — An American soldier assigned to an intelligence unit in West Germany has disappeared. Earlier the East Germans announced a man with the same name had defected to the Communists.

Army headquarters here said Spec. 5 Vladimír Sloboda has been missing from an intelligence unit at Frankfurt since Aug. 3. The Polish-born soldier, who has no home address in the United States, was a linguist and clerk "and had only very limited access to any security information," the Army said.

In Frankfurt, Sloboda's wife Lillian, a British subject, said her husband had "lost a lot of money gambling."

Neues Deutschland, the official party newspaper of East Germany, reported this morning that a man named Sloboda had defected to the Communists. The paper said he was a secret intelligence agent for the United States.

It quoted him as saying he "no longer wanted to share the guilt of the criminal activity of the American secret service against the (East) German Democratic Republic and other countries of the Socialist camp."

An Army spokesman here said Sloboda has been a U.S. citizen since 1958 and had left his wife and three children behind in Frankfurt. The spokesman also said no documents were missing.

Neues Deutschland reported Sloboda said he had asked temporary permission to stay in East Germany. Another Communist paper, Berliner Zeitung, said he intended to go on to the Soviet Union and ask political asylum there.

In Frankfurt, Mrs. Sloboda said: "I don't know what to think. He left for work Tuesday and just never came back. He never talked about going over to the Communists."

Contradictions In Soviet Spy Charge

SALT LAKE CITY, Utah (AP) — An American exchange student says the Soviet newspaper Trud is making contradictory charges when it labels him a spy on one hand and accuses him of "making strong, anti-Soviet statements" on the other.

"Spies don't draw attention to themselves for saying what they think," said Edwin B. Morrell, 31, father of three children, at his home here.

"Spies are very cooperative and do nothing to irritate the government of the country they are visiting."

The Moscow trade union newspaper, in a lengthy story Friday, said Morrell was expelled from the Soviet Union for espionage. Morrell said he was expelled right enough, but the Soviet Ministry of High Education told him it was on recommendation of his Soviet advisor, for not fulfilling his study plan.

Trud's story said Morrell "acted in a provocative way. He spoke bitterly of everything Soviet. He laughed insultingly about our life."

He constantly tried to penetrate trade union organizations of military plants so as to fulfill his intelligence mission."

Morrell said he attended Moscow State University for 10 months, intending to write a doctoral thesis on his political and legal study of Soviet trade unions.

"To the best of my ability," said Morrell "I approached this study in an objective manner." He said none of the charges Trud mentioned were brought up when he was ordered out of the Soviet Union and he was denied chance to answer the study charges.

Trud—citing Morrell to bolster its claims that many tourists, students and delegates to Moscow meetings are actually spies—added that Morrell was expelled from Czechoslovakia as a spy 10 years ago.

Morrell said he served a mission in Czechoslovakia in 1948-49, for the Church of Jesus Christ of Latter-Day Saints, and left with his fellow missionaries when the Communist regime there closed the mission.

State Chairman For United Campaigns To Speak Tuesday

Irwin Belk of Charlotte, recently appointed state campaign chairman for the North Carolina United Community Campaigns, will address a regional meeting of United campaign leaders here Tuesday.

Edward Kronsberg, president of Carolina United, announced Belk's appointment today.

Belk, president of Belk Enterprises, Inc., will address two other regional meetings. One will be held in Burlington Aug. 11 and the second in Asheville Aug. 12.

A native of Charlotte, Belk is a graduate of the University of North Carolina and a veteran of World War II, serving overseas for two years with the Eighth Air Force.

In addition to his duties as president of Belk Enterprises, Belk is an officer and director in a host of other business and industrial concerns in North Carolina. He has been very active in the civic life of the community, serving as a board member of the United Community Services of Charlotte, the Florence Crittenton Home and the Charlotte Workshop for the Blind, Charlotte Chamber of Commerce, Merchants Association and the Carolinas' Carrousel.

He is a member of the Board of Trustees of the University of North Carolina and the Presbyterian Consolidated College in Lenoirville. Belk also is a member of the North Carolina House of Representatives from Mecklenburg County.

\$129,109 Worth Of New Building

Doing Their Bit In Combatting Cancer

DEVON, Pa. (AP) — In a cramped little laboratory that was once a bathroom, a small band of physically afflicted nuns are doing their bit in the fight on cancer.

The nuns, members of the Roman Catholic Congregation of Jesus Crucified, pore over microscopes examining specimen slides for the presence of uterine cancer.

The specimen slides are brought to the convent each week by Dr. Edward Rehak, chief pathologist at St. Agnes Hospital in Baltimore. He takes back the finished work and the nuns' reports.

Dr. Rehak supplied the first inspiration for the project while casting about for some productive activity that would also have a therapeutic value for the nuns themselves.

They suffer from such illnesses as polio, heart disease, rheumatism, arthritis, osteomyelitis and tuberculosis.

Mother Marie Landri, prioress of Regina Mundi Priory, gave her approval and the laboratory was set up in the bathroom of what was once a doctor's mansion.

The lab, headed by Japanese-born Mother Marie Aimee, examines about 50 slides a week on

its present schedule. It hopes to reach 100 a week before long.

Doctors say the laboratory detects what have been spotted between five and 10 unsuspected cancer cases out of every 1,000 specimen slides they have examined.

Eight of the 30 nuns in the community now do the laboratory work. They are trained by Mother Marie Aimee, who prepared herself by taking a course at Temple University Medical Center in Philadelphia.

A number of other nuns would like to take up the work. But training takes time and the facilities and space are limited.

The Congregation of Jesus Crucified was founded in France in 1930. Regina Mundi, the order's only priory in the United States, was founded in 1955 with six nuns from France.

It was organized for the benefit of the physically handicapped. Women between the ages of 20 and 30 are eligible to join, unless their illness is mental, nervous or contagious.

Mother Marie Aimee, who speaks fluent French, English and Japanese, was a hospital patient for 17 years in Tokyo. Her ambition is to open a laboratory in Japan because "many there want to join (but) it takes time to open a house."

Jacqueline And Pat Know Their Fashions

Meet The Deb — Has Dream Gown

America is going to be more fashion conscious this fall, and all because of politics.

As Democratic Sen. John F. Kennedy campaigns for the presidency, part of the spotlight will fall on his green-eyed, brunette wife, Jacqueline.

Although 30-year-old Mrs. Kennedy is expecting their second child around election time and doesn't plan to hit the election-carrying trail, she can't escape public notice.

What she wears and how she wears it are important news to the country's women. They know that if she becomes First Lady, the White House will welcome its most fashionable occupant since the elegant Dolly Madison.

Mrs. Kennedy, as Jacqueline Bouvier, daughter of a New York financier, was born to wealth and position. But that doesn't always insure good taste.

Her instinctive chic, intellectualized by good schooling in this country and France, and underscored by contact with high society, has made her the American darling of the Paris haute couture.

Slender as a model, yet delicately muscular, Mrs. Kennedy brings out the best in the American and Parisian avant garde designers she refers.

Givenchy, Balenciaga, Gres, Cardin are her favorite French couturiers. She orders mostly from sketches, but when she has time to fly over for fittings she is as exactly enthusiastic as a little girl in a store full of dolls.

Among her pet American designers are pacesetters Norell and Galanos.

Knowledgeable about fashion and with a mind of her own, Mrs. Kennedy is a potential style leader. She prefers simple clothes — superbly tailored suits, uncluttered sleeveless dresses — which she wears with carefully selected accessories.

Saleswomen in Fifth Avenue stores in New York report she is "very up-to-the-minute; has vigorous taste; loves color; knows what she wants when she comes into the store."

She has a firm affection for the basic black dress, but likes pinks, reds, yellows, grays.

In sports clothes she wears everything from jodhpurs and bulky sweaters to skintight slacks.

While high fashion couturiers may love her, millinery designers may not be so enthusiastic. Her bouffant hairdo doesn't take naturally to hats, and when she does wear one, it's a small, tastefully innocuous piece of millinery.

WASHINGTON (AP)—Mrs. Pat Nixon, Republican candidate for First Lady, is most often described by the fashion-conscious as "quietly chic and always well groomed."

She says she dresses on a budget, and haunts bargain sales for clothing for herself and her two daughters, aged 12 and 15. She's often seen shopping in Washington stores, and she sometimes uses local dress makers.

Her fashion choices have been called "in good taste, subdued and suit her well-groomed outlook on life." She knows fabrics because she studied fashion merchandising in school.

The willowy wife of Vice President Richard Nixon is a perfect size 10; she's 5 feet 5, and weighs 117 pounds. She wears a lot of beige and brown, and the colors go well with her light auburn hair and brown eyes.

Pat Nixon isn't label-conscious. When she does buy designer clothes, all the names are American, like Elizabeth Arden, Pauline Trigere, Fira Benenson and Jane Derby. She has very few things custom made.

Her inaugural gown in 1957 was a lustrous, ice-blue satin with bodice embroidered in pearls and crystals. It was, she said, "the only one I tried on." She got it at Elizabeth Arden's in New York City. It was blue, because her husband likes that shade.

Among her favorite costumes are the dress and jacket, a skirt with width (because she has to move about so much), and silk prints.

She favors small floral hats.

Pat Nixon has learned to live out of suitcases on trips with her husband. For the 1959 Russian trip, she fitted her wardrobe into two suitcases and a hatbox.

For a 16-day swing during the 1956 campaign her wardrobe included four suits, eight hats and three pairs of shoes.

"I like to mix them up with different accessories like blouses," she told male reporters who commented on her pert and chic look through the grueling trip.

She once disclosed that she kept a record of what she wears on various trips "so I won't come back two years later in the same outfit."

During a 1958 press conference in London, she said: "I think a woman should be neat and well groomed and not over-dressed. She should not be extravagant. When I want a suit, I just rush in and buy it."

Joday's Women

It's high time American women stopped being intimidated by European fashion moguls and stood on their own beautifully shod two feet.

It's high time to end the longstanding legend that anything is good, just so long as it's imported.

It's time American designers ended the myth of Paris supremacy and dared to wear their own laurels with pride.

The fact is American fashions, manners and way of life are setting the pace for the whole world, says Leonard Fischer, a young fashion designer who cut his teeth in New York's Seventh Avenue and now is trying to help the Italian ready-to-wear business get on its feet. Back for a breather after designing his first line of foreign fashions for a wholesale dress manufacturer in Turin, Italy, Fischer observes:

"European girls all want to look like Americans. They want to dress the same way, use the same kind of makeup, have the same kind of jobs and develop the same carefree poise. They see American tourists all over Europe these days, in always greater numbers, and they're determined to achieve the American look."

"They see our beautifully dressed and groomed American women sightseeing around Italy and France, and they admire everything about them. One of the greatest desires is to have access to the same kind of smart, well-fitting and moderate-priced clothes that Americans take as a matter of course."

Fischer started his new Italian assignment under a large handicap. There is no standard sizing for Italian ready-to-wear, he explains, so his first chore was to try to set up such a standard, using American methods.

Up to now there has been practically no ready-to-wear business in Italy, says Fischer, and the business is relatively new in France. European women are accustomed to buying couture clothes if they can afford it and either making their own or hiring a dressmaker if they can't.

"There's a new generation of career girls in Italy; however," he says, "these are the ones who want the luxury of buying ready-made clothes. And they are the ones who will be our best customers. They earn salaries comparable to those in America, they have their own jobs and apartments in the cities, and they want to live like Americans."

Reaction Evidence

The growing enthusiasm for economic development efforts in Pitt County was evidenced this week by the unanimous reaction among representative leaders of the county that Pitt's Development Commission must be continued.

On the heels of the suggestion by former Commission consultant L. A. Weston that the Development Commission be abolished, spokesmen for various community groups of the county made it plain they feel the Development Commission must continue if the county is to realize its economic potential. In their statements concerning the matter they left no doubt that they feel the county must continue its program, and that without the program the development efforts of individual communities will be much less effective.

This reaction points up the cooperative spirit which now prevails in Pitt toward economic development of the county as a whole. It is evidence of the fact that the communities of the county want to pull together toward the common goal of better economic conditions for the county as a whole and for all the citizens of the county.

Such a spirit of unity is a vital factor in the future progress of Pitt. It is essential that the county put forth a unified effort to attract new industries and to take advantage of the potential the county has. It is indeed gratifying to note that when a proposal was made to abolish the Development Commission a united

voice from all parts of the county was sounded to keep the Commission and allow it to continue its work which is so necessary to the well-being of all of Pitt.

Through such a spirit of unity Pitt County can accomplish more in the way of economic development in the years ahead than even the most optimistic of us dare dream of.

The Development Commission, which already has begun the job of seeking a new economic consultant for the county, should continue this effort with all reasonable speed. It is important that the Development Commission fill the post as soon as possible in order that the economic development work of the county may continue without interruption. At the same time it is essential that the county seek out and get the best qualified person available to it for this important post upon which rests a substantial responsibility for future successes in developing new industrial payrolls in this county.

Tobacco Plants Move Into Production Again

The past week has seen Pitt County's largest seasonal industry begin its operations for 1960 as some 600 people were added to the payrolls of local tobacco processing plants.

In the next few weeks as the tobacco season moves into full swing in Pitt County, the number of persons employed in tobacco processing plants in Greenville and Farmville will approach the 2,000 figure with several hundred others finding jobs in tobacco warehouses, transportation and other businesses closely associated with the county's tobacco industry.

As the new jobs have opened up in the past week—and as others open up as the season reaches its peak—new payrolls represented by these jobs will pump many thousands of dollars a week into the economy of this county.

Quite often local citizens speak of the tobacco economy of Pitt in terms of agriculture only, which is only a part of the overall picture. From the sale of tobacco in Pitt this year will flow millions of dollars. From the industrial jobs which are a part of the overall tobacco industry here more millions are added to the total income represented by this important phase of the local economy.

Although the peak employment by tobacco processing plants in this county lasts for only a few months out of each year, the boost which they afford the economy of Pitt County cannot be underestimated. They afford employment to literally hundreds who for the most part are without employment in other periods of the year. They afford payrolls which are important not only to individuals of the community as a means of livelihood, but to the county as a whole from the economic standpoint.

The importance of tobacco processing plants to the economic life of Pitt County is sometimes overlooked at other times in the year, but at this season, it makes its presence felt in vital terms.

Sweeping Plan For Dispersal

WASHINGTON (AP)—If you notice a sleek bomber parked at your hometown airport, it's a token of the times—a part of a sweeping program to disperse the weapons with which to strike back in the event of a sudden attack.

A few days ago the Strategic Air Command started sending individual bombers to commercial airports, deploying them temporarily from their regular airbases to train the crews in this new procedure. This is an extension of SAC's program of building more military airfields to scatter its bombers and reduce concentrated targets for enemy missiles and planes.

The dispersal program is not confined to the Air Force. The Navy which learned a hard lesson at Pearl Harbor now keeps a large segment of its fleet either at sea or in widely separated ports.

The Army's strategic dispersal problem is more difficult. But it has revamped completely its battlefield plans to avoid concentrated targets for atomic fire against troops in action.

While airplanes can be distributed easily to scattered points, land-based missiles present dispersal difficulties. The fixed launching bases for transoceanic rockets, of course, can't be moved about. And their present and planned locations are known at home and abroad.

One solution is to "harden" the launchers, put them in holes reinforced to withstand anything short of a direct hit by an enemy nuclear missile or bomb. A second solution is coming along. When the Air Force's Minuteman ICBM missile is

ready, two launching techniques will be used. The solid-fuel rocket can be fired from a hardened site or from railroad cars which will move from spot to spot, constantly shifting launch positions.

The Navy claims it has the best of all solutions in its Polaris submarine system. The sea service's argument is that not only does the system of launching ballistic missiles from submarines confound enemy defenses and vastly reduce the danger of destruction of the launching base, but it provides this added feature:

If missile bases aren't located in the United States, the reason for all-out nuclear attack on the United States is reduced.

Adm. Arleigh Burke, chief of naval operations, says the Navy's strategy will be to move the missile-firing subs about under the escort of nuclear powered antisubmarine submarines.

The danger of a swift strike by the Soviet Union was important when only bombers, which need long hours to make intercontinental flight, posed the major menace. Today the enemy's arsenal has missiles designed to reach targets in half an hour.

The nation's master plan for meeting massive attack goes beyond disposal of weapons. The government has its own dispersal program, including movement of key personnel to undisclosed or protected sites.

There also is the "continuity of government" program, establishing the line of succession in event of death of top officials. This has military significance. By law, the President is the only official who could order use of nuclear weapons.

Collectors Are Classified

Along with population explosions, the atom age, the aspirin age, coca-holics and beatniks, there seems to be in the air an inclination on the part of the Homo sapiens to collect things other than those mentioned.

Namely, THINGS. Things including anything—from little glass objects and coffee spoons to beautiful paintings or rare books.

There are psychologists now discovering why certain people collect certain things and why lots of people collect things in general.

Some of the population collect to reminisce of childhood; some out of snobbism, these psychologists say. To touch greatness, to escape the everyday self. To repossess the past, history, some person.

And, it has been said that in times of insecurity, as sociologists say we live in now, people collect to grasp at some robot, something firm. That's what they say.

But, the collecto-maniacs are now divided into classes, like everything else we know. The aristocrats are those who engage in the collection of books and art works by undiscovered talents. This is what Russell Lynes says, and he's well known in writing circles; he also says the "new aristocracy" is based on how one spends spare time.

Anyway, the next level, the Upper Bourgeois, buy tasteful art and artifacts. Below them come the Lower Bourgeois who incline toward autographed photographs. And, finally, we get to the mass of population—those of the peasant class who collect credit cards.

Probably they are the most independent and practical, for credit cards can take one a long way! Of course, those in the aristocrat class are gamblers because, other than pure enjoyment of collecting, they may or may not be investing in something substantial which will have a lasting value.

Probably those in the Upper Bourgeois class are good investors and we'll bet they have some credit cards, too. The lower Bourgeois? Well, if you like autographed photographs.

This was a new classification to us. There are classifications of personalities by colors, match your color personality with one that blends, and you have a good friend or happy husband or wife. Or classify your mental tastes and become one of the intelligensia, a beatnik, or a moron, among other things.

One can see why this is the age of the psychologist and the psychiatrist. We know a lot of peasants. Of their joint responsibilities as well as their mutual interests. If the free enterprise system is to survive over the long pull, both of its segments must find a basis for co-operative endeavor and collaboration.

This assumes concrete meaning in the field of wage negotiations. One approach would be for both to sit down together before the actual start of negotiations and review the overall situation of the nation's economy as well as that of the particular industry or enterprise involved. But should enter negotiations with a clear understanding of what the cold, hard facts are with respect to the effects any changes in their relationships would have not only upon the parties to the negotiations but upon their mutual and shared interests as well.

Above all, it must be recognized that there is a third party involved in the negotiations. That is the consumer, for whom management and labor both work in the final analysis. And unless the rights, needs and interests of this third party are taken into account and respected, price and wage controls exercised through the instrumentality of government are almost a certainty eventually. One way or another the consumer is going to demand that his voice be heard and his interests served.

A few Congressmen have said that it was a mistake not to finish the current legislative program before the conventions. If they had, Congressmen could have gone directly from conventions to their home districts, and legislation reinforcing the platforms could have gone over to the new Congress next year.

But many more see the wisdom of what has happened. On the return to the Capitol, each party will introduce legislation carrying out its platform. As noted above, little if anything will happen.

But Congressmen can return to their precincts and say, "Our program was introduced; it is still pending." This may satisfy constituents and make it easier to forget the platform in 1961. But little legislation will pass.

Order Despite Ideals

Richard C. Lee, the Mayor of New Haven, who was undoubtedly elected to maintain law and order, to keep the streets clean and to prevent riots and mayhem, has come up with the brilliant idea that those who are unhappy about conditions in this unfriendly world, particularly minorities, should "sit-out." This man means that the minorities should sit out on the streets, blocking traffic, so that all would know that a demonstration is being held by any group that regards itself as a minority.

But what about the majority of decent, hard-working citizens who are attending to their own affairs? What about the grocer whose doorway is blocked by the sinner-out? What about the worker who is driving in a car to his or her place of work? What about the doctor or the ambulance or, for that matter, the funeral procession?

Apparently, the Mayor of New Haven is preaching total abstinence from law and order. It is a concept of non-resistance which Leo Tolstoy and later Gandhi advocated as a means of enforcing their views.

But non-resistance can be a means of destruction which needs to be dealt with a fire hose or some other means of safeguarding the peaceful majority against the obstreperous minority. Too much, these days, do the politicians, particularly of large, heterogeneous citizens tend to ignore the rights of the law-abiding, the decent, the respectable, in the interest of a few exhibitionists who declare themselves to be a minority and therefore demand special privileges.

The right to petition for the redress of grievances is guaranteed in the Constitution which also guarantees a republican form of government and the latter cannot exist without majority rule. In a city like New York, for example, the politicians calculate their control of men in terms of minorities. What percentage will they get of the Negro vote or the Jewish or Italian vote? It used to be that they were concerned themselves with the German vote but the Germans switched from sauerkraut to Liberty Cabbage and have become so thoroughly assimilated that they are now part of the majority.

Thus the process of assimilation moves along. Minorities become part of the majority. The Negro is barred from assimilation by the distinction in color although more and more, on New York streets, one sees mixed black and white couples.

New Haven's Mayor was surely not concerned about his own city where these problems are not very intense. But imagine what would happen if anyone were fool enough to take his advice in New York and picked Fifth Avenue or Times Square as the place to experiment with a sit-out. Probably a few hundred persons would be killed to start with. How many would be squashed, it cannot be estimated.

The Mayor apparently does not concern himself with the consequences of his ideas. This is so true of so many bright young men who come up with ideas—sharp, smart concepts that sound so good when first spoken and that bring misery to so many people. It is like those older men and women, of all sorts of shapes and sizes who see youth dress in shorts and short-shorts and shirts sticking out of their trousers and who wear no neckties and no jackets. So they say, "Let's be young! Let's dress like the kids!" So they do that and disgrace the kids. One needs youth to wear a tieless shirt. It just does not become an older person. It looks wrong. It feels wrong. It gives the impression of carelessness. What is perfect on a girl with slender legs and tender hips is a horror on a woman whose gams resemble the legs of a baby elephant and whose figure seems to have been settled by age.

Enough! It is all part of the New Haven Mayor's idea—say it is right because it is, for the moment, popular. Say that anything is right. The other day I

Major Leagues' Expansion Plans Already Hit Snag

NEW YORK (AP) — The proposed major league baseball expansion plan already has run into a snag and Los Angeles Dodgers owner Walter O'Malley today loomed as the key man in the snarl is to be untangled.

Dan Topping, co-owner of the New York Yankees, said Friday he would fight the expansion move unless an American League club is placed in Los Angeles.

"New York is the crux of the National League expansion plan," thundered Topping, "and Los Angeles emphatically must figure in the coast-to-coast realignment on our side."

This puts things pretty much up to O'Malley. He said he was surprised at Topping's statement and would have no comment.

But his feelings on the matter are no secret. O'Malley does not want an American League team in Los Angeles until his new park is built in Chavez Ravine. That would be in 1962. He thinks he has spent a lot of money to build up a following in Los Angeles and sees no reason why another club should ride his coattails.

When the new park is built, O'Malley will be perfectly happy to have an American League team in Los Angeles, not only to build up a rivalry, but to pay its way as a tenant in the new park.

While no mention of Los Angeles was made following the expansion announcement earlier in the week, it is known that the American League has been eager to get a team there.

Topping also criticized the idea of a new stadium in New York, pointing out that the Yanks would be willing to have the new stadium at the Yankee Stadium. However, he said, he would oppose the new stadium merely as a stopgap while waiting for the new arena to be built.

The Continental League franchises include New York, Minneapolis-St. Paul, Houston, Fort Worth, Atlanta, Denver, Toronto, and Buffalo. The majors have not announced which four cities they will absorb.

Lane Draws First Blood In Managerial Exchange

Cleveland General Manager Frank Lane has drawn first blood in his recent unprecedented managerial exchange with President Bill DeWitt of the Detroit Tigers.

Making his managerial debut with the Indians following the swap that brought him from Detroit for Joe Gordon, Jimmy Dykes masterminded his new charges to a 4-3 victory over the Baltimore Orioles Friday night.

At the same time, Gordon, in his first game at the helm of the Tigers, saw his team go down to a 4-2 defeat by the Boston Red Sox.

On first game evidence, it looks like the 63-year-old Dykes hasn't lost his touch. In explaining his reason for acquiring Dykes, Lane said:

"Jimmy has had the happy faculty of lifting up each new club he's acquired. He did it with Cincinnati in 1958 and with Detroit last year. Maybe he'll do it with us this year."

The Indians employed a seldom-used weapon — the bunt squeeze — to bring home the winning run. It happened in the seventh inning with the score tied at 3-3. Red Wilson, who had opened with a double, was on third following pitcher Jim Perry's sacrifice. Johnny Temple laid down a neat bunt and Wilson, running with the pitch, scored the deciding run as pitcher Chuck Estrada had only a play at first base.

Despite the victory, the fourth place Indians still trailed front-running New York by six games. The Yankees increased their lead to 2½ games over second place Chicago by defeating Kansas City 4-3. The White Sox were soundly thrashed by Washington 6-1.

Pittsburgh opened up a four-game bulge in the National League, shutting out San Francisco 1-0. Milwaukee regained second place from St. Louis, walloping the Chicago Cubs 10-2 while Cincinnati was blanking the Cardinals 3-0. Rain washed out the game in Philadelphia between Los Angeles and the Phillies.

Cleveland's close victory over Baltimore made Perry, the Indians' ace right-hander, the biggest winner in the American League with 13 triumphs. Estrada, the loser, now has an 11-7 record.

Outfielder Harvey Kuenn, who worked for Dykes in Detroit last

year, helped his old manager along with a two-run homer. It was the first time the Indians had won two straight since July 15. They had lost 18 of their previous 26.

A two-run homer by Roger Maris, his 33rd of the season, won for the Yankees but they had to snuff off the Athletics, trailing 4-1, the A's routed relief pitchers Luis Arroyo and Bob Turley with two runs and had the tying and winning runs on base with two out. Norm Shantz took over and got Norm Eshelman to fly deep to Maris on the first pitch.

A four-run Red Sox outburst in the seventh inning spoiled Gordon's managerial debut with the Tigers. Shortstop Don Buddin tripled home two runs in the rally that wiped out a 2-0 Detroit lead and hung the 10th defeat of the season upon Frank Lary. Ike DeLock won his sixth game in relief.

The Senators battered Buck Shaw off the mound with a rousing explosion in the first inning and went on to inflict the fifth straight defeat upon the American League defending champions. After retiring the first two batters, Shaw (10-9) walked two batters, then clipped for singles by Faye Throneberry, Bill Gardner and Jim Lemon. Pete Lary won his seventh with a four-hitter.

To D'Amato, No Agreements Yet

STOCKHOLM (AP)—Cus D'Amato, manager of world heavyweight champion Floyd Patterson, said today that as far as he is concerned there is no agreement on a site and date for the third Patterson-Ingemar Johansson title fight.

Promoter Bill Fuzazy has said the fight will be on Nov. 1 in Los Angeles.

"It is the rule for the promoter to talk to both fighters — and the champion first — on these matters, but as I understand it Fuzazy has talked only to Johansson," said D'Amato.

He added that he had talked to Patterson just before leaving home and that Floyd had made no statements on his preference for any particular site and date.

D'Amato is here for talks with either Johansson or his adviser, Edwin Ahlquist. Johansson and Ahlquist made no bones about their annoyance at the way D'Amato handled the first fight in which the handsome Swede won the title. As a result, D'Amato was stripped of his manager's license by the New York State Athletic Commission.

Asked if he considers himself on good terms with Ahlquist now, D'Amato replied: "I think so, but sometimes I wonder."

D'Amato also took pains to deny that Patterson would like the fight postponed to next year because of income tax complications.

"We do not have the same tax problem as Johansson," said D'Amato. "Floyd and I are not in the same bracket any more, so we do not have any reason to balk on that account."

"When I left home, Floyd was in such good shape that he could step into the ring for the title fight with three weeks work."

Patterson arrives here next week for an 11-day tour of Sweden. D'Amato said the tour was arranged because of the tremendous amount of fan mail Floyd received from here.

Johansson won't be around. He will be in Geneva training for the third bout.

Lt. John Cronin said Friday that his office receives a half dozen tips a year.

What does Cronin think happened? "I have an open mind," he said, "and I can't make any conclusions, but the case follows a pattern of voluntary absence. I could be wrong."

The Hollywood craft unions have been bitterly declaiming the continued shift of movie productions abroad. Their latest strategy is an attack on what they call runaway stars.

Top target is William Holden, who reportedly will not make a film in the United States because it would endanger the tax advantage of his official Switzerland residence. The craft unions are affiliated with I.A.T.S.E., which also includes the nation's theater projectionists, and there have been threats of a boycott of the wandering actors.

Rock just finished a film in Mexico. He is leaving next week for another in Italy. Early next year, he will make a movie in Java.

Thus Hollywood's No. 1 box office star will be making pictures elsewhere for more than a year. Actually, it will be more than two years, since he was long idle after "Pillow Talk."

"But I'm not making pictures out of the country because of taxes," Hudson said. "My residence is still Lido Isle, California."

Hudson added: "I don't blame the actors who prefer to live and work abroad to make more money. It's the tax structure that's to blame."

"I can buy a business associate a Cadillac and that's deductible. But if I buy my mother a dress, that's not deductible. There's something wrong with the system."

SUMMER WORK FOR COLLEGE STUDENTS

With summer drawing swiftly to a close, and the fall term of college advancing rapidly, college students throughout the nation are packing their bags, readying themselves for the trip back to school after spending the summer months in work of numerous kinds.

Summer jobs for college students are of great benefit to the student in many ways. Perhaps it will be an experience in responsibility, or perhaps it is a means by which a student finances his education for another year. It is more probable, however, that the greater percentage of college students work during the summer in order to gain practical experience in their particular field of study.

Beaches and Camps Draw Many

Although a great number of students work in beach and mountain resorts as concession stand operators, waiters and waitresses, and numerous other types of employment primarily it is the trend during the summer months of many to spend the summer acting as water safety personnel.

East Carolina College furnishes a great number of the water safety personnel for the state's resort spots, summer camps, and other areas where water is the principal enjoyment of people. Ray Martinez, coach of EC's swimming team and a member of the college's Physical Education Department, in speaking of this role played by the college, says that he has "continual demands from camps looking for Water Safety directors."

According to Martinez, several of the members of the Pirate swimming team are working in such places as Camp Sea Gull, Virginia Beach, Atlantic Beach, and other areas where the services of water safety workers are needed.

The principal requirement for this sort of work, says Martinez, is either the Red Cross Water Safety Instructor's certificate, or the YMCA Leader Examiner certificate. Miss Nell Stallings of the ECC Physical Education de-

partment is the only person who teaches the Water Safety Instructor's course in Eastern North Carolina. This course has now become a part of the curriculum at EC, and according to Martinez, it is open also to the public.

As far as the benefits gained by students who work in the field of water safety during the summer is concerned, Martinez says, "It is a wonderful way to pick up experience for future work plus the fact that it is a good way to pick up extra money, and it is a good life to lead in the summer." Martinez also noted that places employing water safety workers desire primarily those who are qualified to teach aspects of water safety.

Counties Hire Students For Summer Work

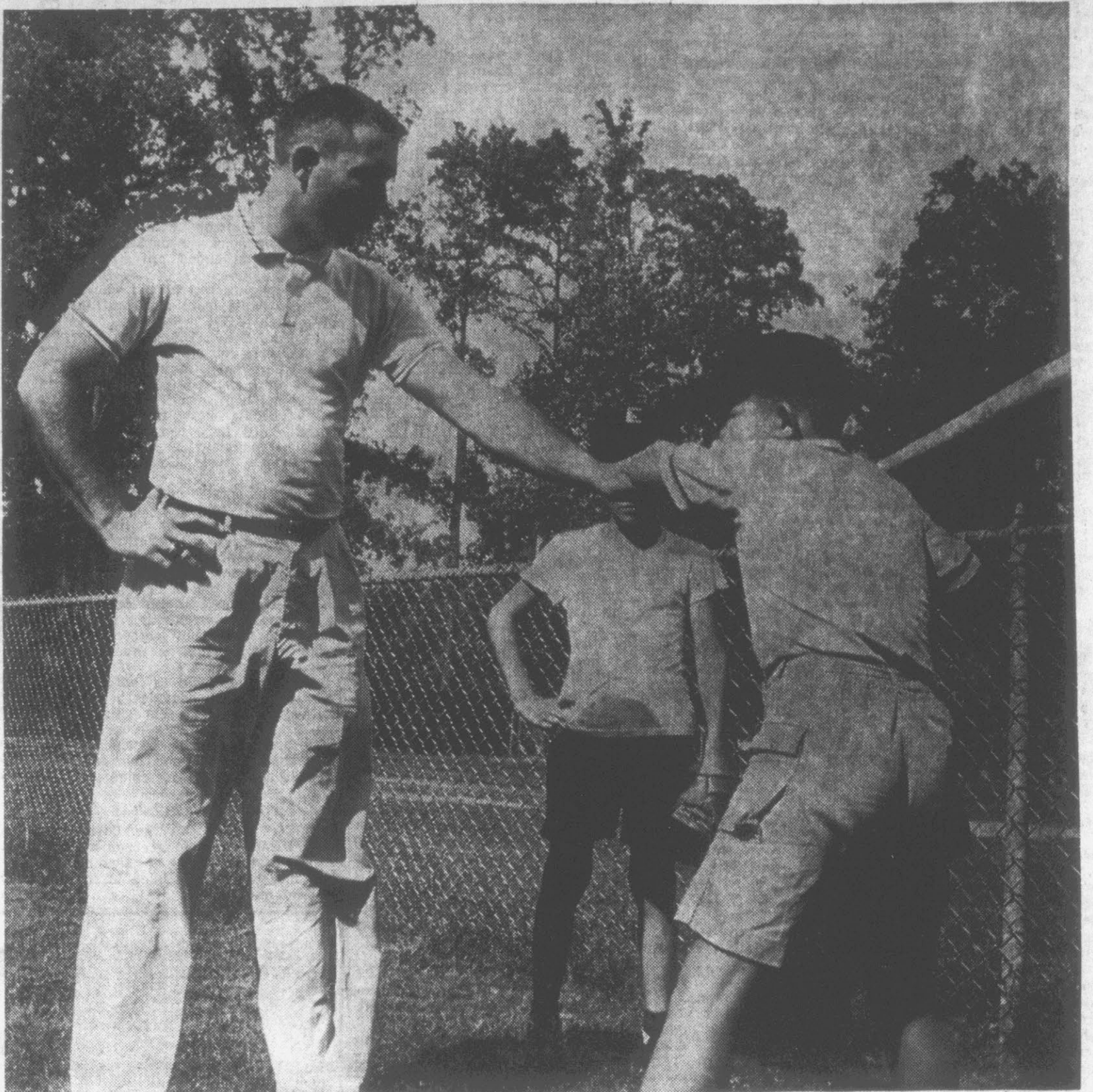
Although beaches, camps and resorts draw many students during the summer months, another big area of student employment is with the county ASC offices which hire a large force to work for a short time each summer as field reporters, measuring land.

Wayne L. Wang, Pitt County ASC Office Manager, reports that this summer, the county office had 65 field reporters, 40 of whom were college students. Wang also added that about ten girls, who are college students, worked in the office while the measuring work was in progress.

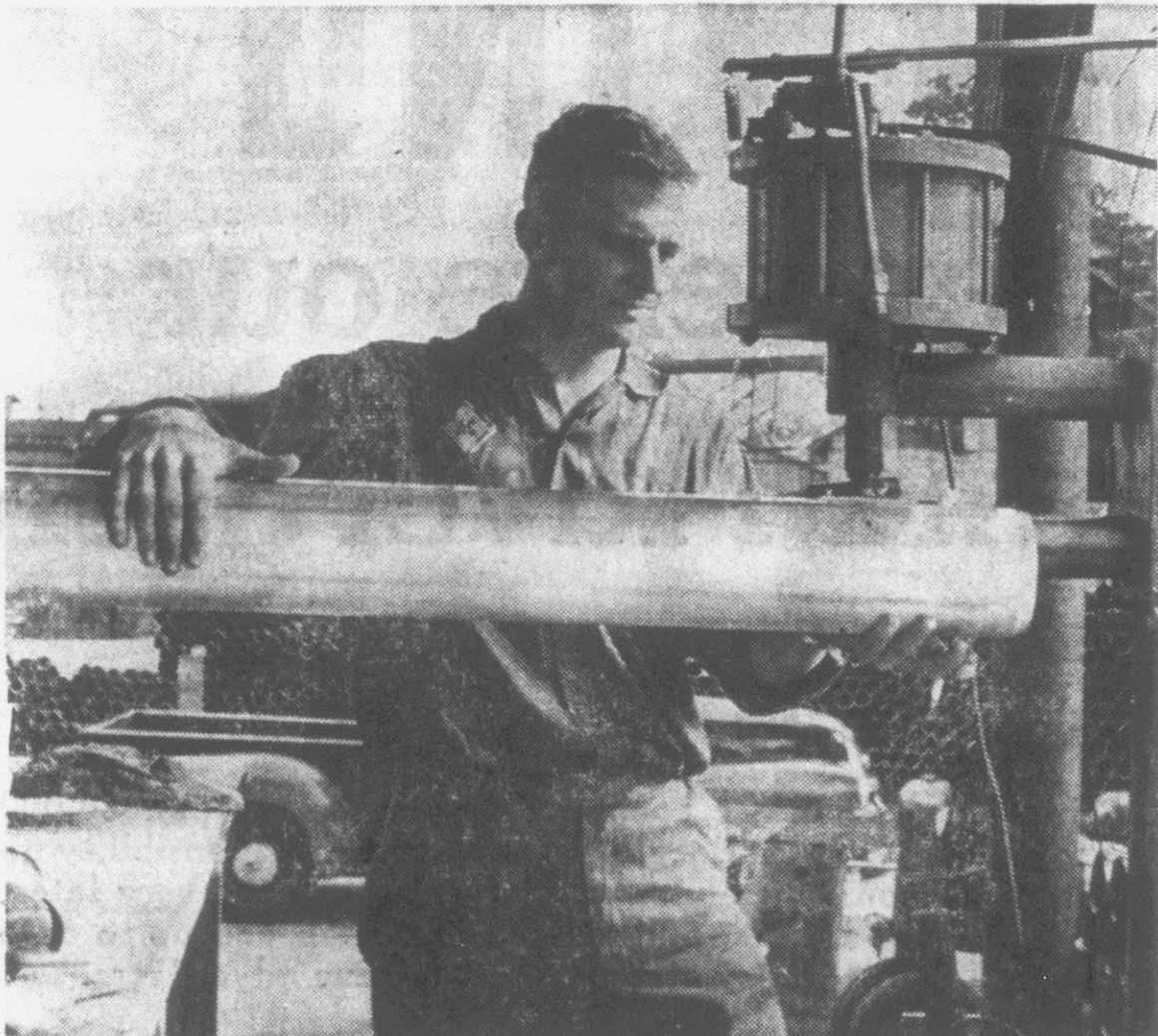
Why do the ASC offices hire student help? Wang says, "It is a quick source of a lot of boys, and it requires people who can learn many details and procedures in a short time."

Many of the students have been working with the local ASC office for several years. According to Wang, usually the college workers begin in their freshman or sophomore years, and work until they complete their education.

Thus we see that the life of a college student during the summer is not one primarily of fun and carefree excitement, but it can be classified in many different ways. As waitresses, waiters, construction workers, lifeguards, and the nation's youth works during the summer, and the life as looked upon by many is enviable.

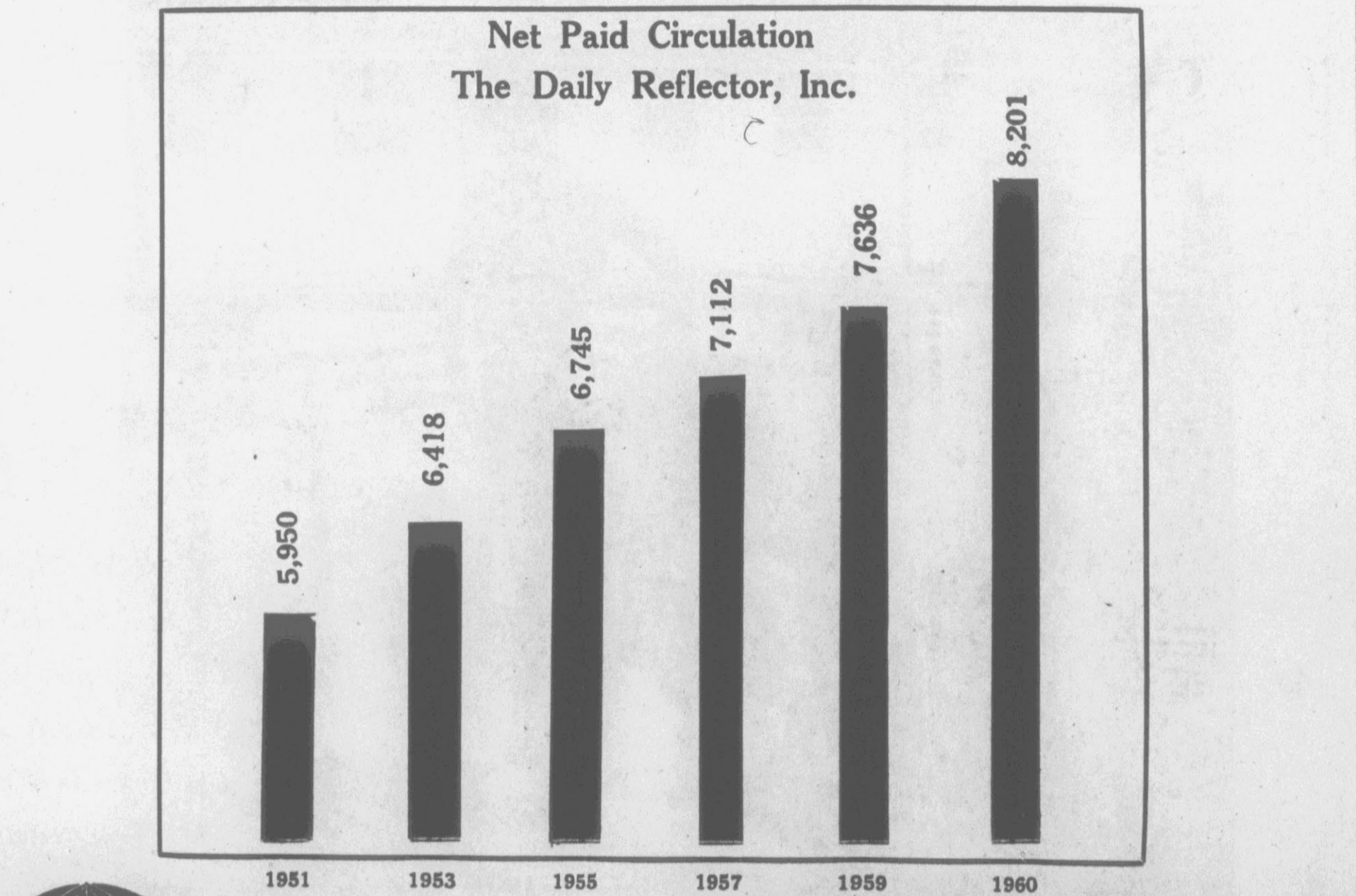

A-Bomb Ban Pleas Underline Anniversary Of Hiroshima

 TOKYO (AP)—Japan observed today the 15th anniversary of the dropping of the atomic bomb on Hiroshima with pleas for banning nuclear weapons.
 Crown Prince Akihito attended and delivered a message at a government-approved memorial service in Hiroshima. Some 30,000 persons attended the rally in Peace Park.
 In Tokyo, the Communist-dominated World Conference Against Atomic and Hydrogen Bombs opened a four-day conference at Tokyo Metropolitan Gymnasium militantly denouncing the United States and its allies as the "force of war."
 About 100 police scuffled briefly with 50 extreme rightists who demonstrated against the Red-inspired conference. One policeman was injured and three club-swinging demonstrators were arrested.
 Prime Minister Hayato Ikeda sent a message to the Hiroshima rally expressed regret that despite

Japan's repeated appeals there still was no halt in the manufacture, stockpiling and testing of nuclear weapons.
 "We must in the future appeal with even greater earnestness to the world to ban nuclear weapons," Ikeda said. "I hope that everyone of you will work for the achievement of eternal peace with renewed determination."
 "Walk for peace" marchers, organized by the leftist Japan Council against Atomic and Hydrogen Bombs, arrived Friday in Tokyo from five directions.
 The marchers claimed to have covered 6,000 miles. They included a man who said he had walked three months coming from a small island south of Japan.
 Police said the ranks of marchers who demonstrated past the Defense Agency had swollen to 4,500. At night an anti-nuclear rally of 5,000 was held at Hibuya Park.
 In Hiroshima the memorial ceremonies were held in Peace Park where a roofless gutted

building stands exactly as it was after the explosion as a symbol of the Hiroshima tragedy.
 Hiroshima city fathers were reported considering tearing it down on request from survivors of the blast who complained that the building reminded them of the horror of Aug. 6, 1949.
 Hiroshima Governor Hiro Ohara and Mayor Shinzo Hamai placed a list of 155 persons considered to have died in 1959 from the after effects of the atom bomb in the Peace Memorial Hall.
 The crown prince in a brief address expressed sympathy for the dead and said "We fervently pray for peace in the world so that this will never happen again."
 The prince laid a wreath at the foot of the Peace Memorial, the bell of peace was rung, sirens sounded, 1,000 doves released and the crowd observed a minute's silence.
 In New York City, the National Committee for a Sane Nuclear Policy, Inc., maintained a "peace vigil" in the United Nations Plaza.
 Five men and a woman carrying disarmament placards started the vigil Friday. The group planned to keep it up in two-hour shifts through noon Sunday.
 It was part of a series of meetings and minor demonstrations planned in the New York City area for the day.

Prisoner Badly Burned In Cell

RALEIGH (AP)—A Negro prisoner remained in serious condition today from burns suffered when a white inmate threw lighter fluid into his cell and ignited his clothing.
 Samuel Avon, 25, of Raleigh was badly burned about the face, chest and legs. Asst. Prison Director Robert Allen said Avon was set afire by William T. Phelps, 22, of Portsmouth, Va.
 The two short-term prisoners, outpatients at Central Prison, had become involved in an argument earlier this week, Allen said.
 Phelps, serving six months for escape in Franklin County, has been at Central Prison for some time for treatment of a stomach ulcer. Avon was being treated for a gunshot wound received before he entered prison. He is serving 12 months for larceny of an auto.
 Allen said that Avon, who was brought to Central Prison July 27 from Edgecombe County, had been helping feed other outpatients who are kept in cells near the prison hospital.
 The prison official said Phelps was let out of his cell Friday afternoon to get a haircut. Instead, he went to Avon's cell. Avon was dozing on his bunk. Allen said Phelps hurled lighter fluid through the bars. Avon awoke and another dash of fluid hit him, then a lighted match was quickly thrown on his clothes and he was turned into a torch.

Full Retraction, Apology Asked

GREENSBORO (AP)—The Knights of Columbus wants the 16th Street Baptist Church here to print and distribute to its members apologies for circulating a fictitious oath that has dogged the Catholic fraternal order almost 50 years.
 William Gallagher of Greensboro, an official of the order, declared unacceptable Friday a statement offered to the Knights by the church in reaction to their apology demand.
 Neither Gallagher nor J. Donald Smith, chairman of the Baptist church's board of deacons, would say what was in the statement. But Gallagher indicated it fell short of the retraction and apology demanded.
 "We expect," Gallagher said, "a complete and unequivocal (sic) retraction and apology printed and distributed in the same manner as the bogus oath statement." He would not say whether the Knights might follow through on their suggestions of a criminal libel suit against the church, if no suitable apology is made.

 No date was set for a hearing. The warden said the order was instituted three months ago to effect a neater appearance because some prisoners were going in for all shapes and sizes of mustaches and beards.
