

## Congo Is Rapidly Swinging To Leftist Dictatorship

LEOPOLDVILLE, the Congo (AP)—Opposition to Premier Patrice Lumumba's swing toward leftist dictatorship mounted today as he pressed his campaign to stamp out rebellion in the eastern Congo.

As U. N. officials counted nearly 300 dead in Kasai Province fighting, reports reached here that the Soviet Union had stepped up its aid to Lumumba by providing him cargo planes.

Some of the 10 Soviet Ili4 planes that arrived in Stanleyville have been repainted with the words "Congo Republic" on their sides, these reports said. Stanleyville, capital of Oriental Province in the northeast, is Lumumba's chief

base of operations in the eastern Congo. About 100 Soviet trucks already are in the interior.

At last report Lumumba's Congolese army was locked in a see-saw battle with tribal supporters of Kasai secessionist leader Albert Kalonji. The fighting was centered around Bakwanga, capital of Kalonji's so-called "mineral state."

Here in the Senate, which meets with far less than full membership, angry opposition members demanded that Lumumba cancel all the decrees restricting fundamental freedoms. They warned against dictatorship.

They even drew some support from Sen. S. Romandeke, a gov-

ernment senator who urged the government not to issue decrees without consulting Parliament. While criticizing the opposition's cries of "communism and dictatorship," Romandeke said Lumumba should not close opposition newspapers but impose censorship instead.

The senators complained they did not even have copies of Lumumba's decrees closing newspapers and clamping rigid controls on political meetings and demonstrations.

The opposition fight in the Senate was led by Sen. Syrylle Adoula, a member of the Puna-National Unity party—whose province which has declared its in-

dependence and allied itself with Kalonji's "mineral state."

An army spokesman from secessionist Katanga province said Lumumba's troops also were poised 20 miles from the Katanga border in Kivu province to the north.

"This could be a greater threat to Katanga than any action and troop movements taking place in the Kasai province right now," the spokesman said.

Some Congolese troops were reported deserting and joining Kalonji's secessionists. This appeared to be the case in Bakwanga, the spokesman said, and also at Pupa where a platoon of Congo troops had defected.

U.N. forces have steered clear of the Congo fighting, but a Moroccan unit was forced to fire on a menacing group of armed civilians in Moerbeke near the army base of Thysville in Leopoldville province Friday.

Diplomats feared the U.N. Command could no longer restore order in the chaotic new Republic unless Lumumba's forces were somehow disarmed. This was seen as highly unlikely since the fiery premier is determined to use troops to quell opposition in rebellious Katanga and Kasai provinces.

These observers noted that Lumumba was heaving straight to the line that usually leads to a

Communist-style dictatorship. His regime has been suppressing newspapers, banning political meetings and using troops and police to arrest political opposition. Soviet advisors have also been pouring into the Congo in recent weeks.

A consignment of 10 Ilyushin-14 Soviet planes has arrived in the country and 100 Soviet trucks capable of transporting troops already are in the interior.

Members of the Central Parliament meantime questioned Lumumba's authority to arrest Jean Bolikango, president of the opposition Puna party.

Lumumba, who has not hesitated to jail political opponents,

ordered Bolikango picked up along with Second Vice President Victor Dondo. A Congo government spokesman said a group of Puna supporters had been arrested for plotting to assassinate Lumumba and President Joseph Kasavubu.

"Lumumba has no regard for the constitution or the law," one of his opponents said. "He is liable to do anything to strengthen his almost dictatorial position."

If the legality of Bolikango's arrest is formally challenged, Lumumba may argue that the constitution prepared for independence June 30 is not yet in force because Parliament has not approved it.

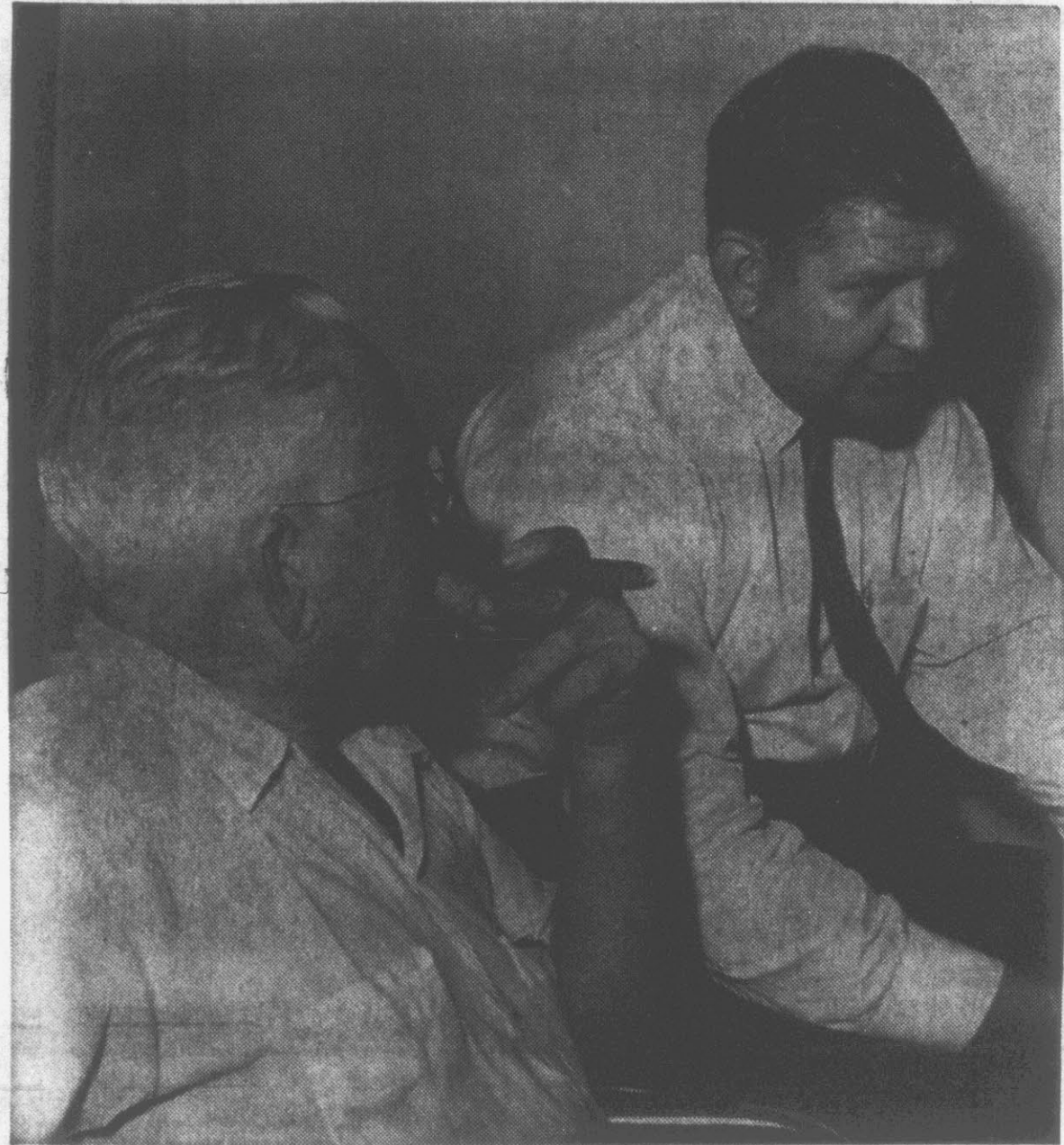

## Sanford Expects Largest Kennedy Audience Here

"We're expecting Greenville to have the largest crowd in the state to greet Sen. John Kennedy when he comes to North Carolina on September 17."

That was the comment of Terry Sanford, Democratic nominee for governor, when he was asked here yesterday what sort of reception he expected Kennedy to receive on his visit to Greenville.

Sanford came to Greenville by plane yesterday afternoon to address the faculty of East Carolina College last night. During the afternoon he spent some two hours discussing with County Chairman John G. Clark and other Democratic leaders plans for Kennedy's visit here.

The gubernatorial nominee also confirmed earlier reports that Sen. Kennedy will hold his only formal news conference of the day in Greenville. The exact time of the news conference and where it will be held here has not been determined.

Sanford said tentative plans call for Kennedy to arrive in Greenville between 9 and 9:30 a.m. on Saturday. He is expected to remain here for one and one-half to two hours before taking off on the second leg of his 700-mile one-day tour of North Carolina.

Sanford said he expects to come to Greenville from Fayetteville that morning and be here when Kennedy arrives. He will accom-

pany the Democratic presidential nominee across the state on his whirlwind tour which ends with a rally in Raleigh Saturday night.

The gubernatorial nominee said 100 or more newsmen are expected to be traveling with Kennedy on his swing through North Carolina. The State Democratic Headquarters has arranged for a chartered plane to carry Tar Heel newsmen on the swing with Kennedy through North Carolina. Newspapers, TV and radio stations whose news representatives make the swing will pay the cost of the special plane. In addition there probably will be a plane for out-of-state newsmen who normally tour with the presidential nominee.

The only real problem facing the national Democratic ticket in North Carolina, Sanford said yesterday, "is the fact that Sen. Kennedy was born into the Catholic Church. However, I cannot believe the people of North Carolina will decide the issue on the basis of church membership, particularly in the light of his (Kennedy's) clear and positive statements on the matter."

"The religious issue is the only thing they (the Republicans) have in this campaign. Everything else about Kennedy is positive. The religious issue is all they've got and that is not enough."

Sanford added that the religious issue may be more an obstacle to Kennedy in the Eastern part of

the state than in the Piedmont and the West. He said in the Piedmont and Western sections the Democrats have to be more united because of the opposition they face from the Republican organization.

The Democratic nominee for governor said he had just returned from a tour of 17 Western counties, and found the Democratic ticket "in excellent shape."

Clark, who is in charge of local arrangements for the Kennedy visit to Greenville, has called a meeting of Democratic chairmen from all Eastern Carolina counties for 3 o'clock tomorrow afternoon in Greenville. Members of the Pitt Democratic executive committee will also attend the meeting to outline plans for Kennedy's visit here. Clark was in Raleigh today, accompanied by other local Democratic leaders, to discuss with officials in the state Democratic headquarters plans for Kennedy's visit.

In addition to Kennedy's news conference and address at the ECC stadium, efforts are being made to arrange a motorcade through Greenville from the airport to the college campus. "We want as many people as possible on the streets of Greenville when Sen. Kennedy arrives here," Clark commented.

Detailed plans for the nominee's tour of North Carolina are expected to be announced early next week.

## 'New Frontier' In Education Cited

"The new frontiers of a changing world become the new frontiers of the world of education," Terry Sanford, Democratic nominee for the governorship of North Carolina, said in an address to staff members of East Carolina College last night.

He stressed quality in education as the new frontier which the people of North Carolina and of the nation must conquer. "We seek excellence," he said. "We seek full opportunity for every child."

Sanford addressed a group of approximately 500 people at a dinner given by the Faculty Wives Club in the North Dining Hall for faculty and staff members, their wives and husbands, and other guests. President Leo W. Jenkins of the college introduced the speaker.

In a brief glance backward through national history, Sanford outlined the various educational frontiers which have presented challenges to the people of this country. In North Carolina, he said, under the leadership of Aycock and others, the state "had the vision to put its faith in education."

For the last 60 years, he said, this faith has "led North Carolina to the forefront of the Southern states." The fight, he declared, was hard, "as opening new frontiers anywhere will always be a hard fight."

North Carolina today, he con-

tinued, has an "unprecedented opportunity for what might be called an educational breakthrough." The people of the state, he challenged, must not be satisfied "until we have done all that we can do to make sure to none the opportunities in education which we offer our children."

He voiced the faith that North Carolinians "have the vision to do the job."

Quality in education is the goal, he explained, but the concept is hard to define. "The free, inquisitive, wide ranging mind . . . is the way for man to advance, indeed the way for him to survive," he continued. Quality in education will be defined by teachers, he said, in a thousand ways in thousands of lives.

Praising East Carolina College for its contributions to education in the state, especially in the training of teachers, he said, "The Spirit of East Carolina College is strengthening the lives and the contributions of people of this section, therefore, in turn, in all of North Carolina."

Addressing college faculty members, Sanford said that quality in education comes from teaching. "As we seek the goal of excellence," he stated, "the place to start is here."

In America, he said in conclusion, the future "depends on what you do here, and the hope of the free world depends on quality and excellence in education."

### Boy Is Sent To Training School

David Yelton Rough, 13, taken into custody on charges of bank larceny Monday night received a hearing before Pitt County Juvenile Court Judge D.T. House and given an indeterminate sentence to the East Carolina Correctional Training School in Rocky Mount, Wednesday.

According to officials, the youth was taken into custody Monday night, two hours after the theft was reported. They noted that the youth entered the Dickinson Ave. Branch of the Wachovia Bank and Trust Company and, when a teller left his cage, "saw a bunch of old bills and took them." About \$96 in cash was recovered along with several items the boy had purchased with the remainder of the money.

Officials, who noted that there was no definite sentence, said the boy would probably serve at least one year. They added that in cases of this kind, the average stay at the school ranges from a year to 18 months.

They noted that in sending the boy to the school, both the bank larceny and the fact that he admitted other offenses were taken into consideration. The fact that the youth's father was unable to control him was also noted.

Officers who investigated the case pointed out that the boys' father had sent him to the Eastern Carolina Training School for Boys for one year in an attempt to help his son when the youth would not attend public school. They added that the father was not aware of the boys' activities.

## Castro Planning Ties To Peiping

HAVANA (AP) — Smashing the Western Hemisphere's united front against Red China, Fidel Castro announced Friday night that Cuba will establish diplomatic ties with the Peiping regime.

The bearded prime minister broke the news at a rally of hundreds of thousands of cheering followers. He climaxed his fiery speech by dramatically tearing up the Cuba-U.S. mutual defense treaty of 1952 and throwing away the pieces.

Bristling with defiance, Castro declared his revolutionary regime was breaking with the Nationalist Chinese government and switching ties, making Cuba the first nation in the Americas to recognize Communist China.

"From this moment we end our relations with the regime of Chiang Kai-shek," he proclaimed to the cheering crowd massed for a so-called assembly of the Cuban people.

Castro hailed the peoples assembly as a mark of pure Cuban democracy and challenged other Latin American republics to hold similar rallies.

He accused the United States of trying to isolate the Soviet Union and Red China from the Western Hemisphere and served notice his government would establish diplomatic relations with all Communist countries.

The Havana crowd, privately

## Kennedy Outlines Theme Of Action

SAN FRANCISCO (AP) — Sen. John F. Kennedy said today the balance of world power is shifting and the nation must "start moving again" under a new Democratic president.

In what he called the "official beginning" of his campaign in the home state of his opponent, Vice President Richard M. Nixon, the Democratic nominee assailed President Eisenhower and what he called the "stand-still philosophy" of the Republicans.

"A do-nothing party will not do," he said in a speech prepared for an airport rally. "Four more years of a Republican president blocking action by a Democratic Congress will not do."

"What we need—what we seek—what this campaign is intended to bring is action instead of drift—leadership, not salesmanship—and dedication, in place of mediocrity."

Kennedy flew to California after campaigning in New England Friday. At Portland, Maine, he got a rousing reception from homecoming crowds on a downtown street.

Police had to help him push his way through a broadcasting studio for a TV news conference, and Kennedy remarked "We're hopeful of Maine in November."

He went to Portland by way of Boston in his home state of Massachusetts and Manchester, N.H. At each stop he told his audiences New England's economic problems could be solved by a Democratic president.

By jet he sped to this bay city after a brief rest in Washington. And from here he will fly to Alaska for a swift round of campaign talks in the 49th state. He plans to speak at the State Fair in Palmer and Anchorage tonight.

After a breakfast news conference he'll take off again for Detroit. At San Francisco, Kennedy said his "new frontier" campaign does

not promise any easy solutions for American problems.

"For these are harsh times," he said. "The future will not be easier. Our burdens will not lessen. Our enemies will not weaken. But I cannot believe that history will say of our time: 'They were the greatest, richest, strongest nation on earth—but they stood still too long.'"

"I believe that history will mark this as a turning-point in the life of our nation and in the pursuit of peace. I believe that with your help—with your efforts, joining the efforts of millions like you all over America—we can make this a time of greatness."

Kennedy said the theme of his campaign is going to be action—"action at home to keep pace with our growing needs, to help the unfortunate, to build a still greater nation—and action abroad to match the rise in Communist power, to meet the turbulent revolutions reshaping our globe."

He blamed what he called parliamentary obstruction and the threat of vetoes for failure to get his program approved in the summer session of Congress that ended Thursday.

"Until a Democrat is in the White House," he said, "the Republicans can block action on an adequate minimum wage. They can water down medical care for the aged. They can play politics with civil rights. They can block action on a decent housing bill and a good school bill. But they cannot block the American people on Nov. 8."

Kennedy likened the Eisenhower years to a vacation time in which he said the people wanted to relax and to get away from it all. But he said times have changed since 1952 and the nation must get back on its toes.

"If this nation is to reassert the initiative in foreign affairs, it must be presidential initiative," he said. "If we are to rebuild our prestige in the eyes of the world, it must be presidential prestige. And if we are to regain progressive leadership on our domestic problems, it must be presidential leadership."

## Boards OK Sentinel Life, Allied Security Merger

Officials of Sentinel Life Insurance Company of Greenville and Allied Security Insurance Company of Spartanburg, S.C., today announced plans to merge the two companies, subject to approval of the companies' stockholders.

The proposed merger was unanimously approved by the board of directors of the two companies this week.

The joint announcement of the two companies said the merger proposal agreed upon calls for the issuance of two and two-thirds shares of Allied Security stock in exchange for each outstanding share of Sentinel stock.

Stockholders of each of the companies will meet within the next 30 days to consider the merger proposal. After stockholders approval, the merger will be subject to confirmation by the insurance commissioners of North Carolina and South Carolina.

Sentinel Life, organized in Greenville in 1956, has approximately 750 stockholders, most of them in Eastern North Carolina. Allied Security Insurance Company, which has its executive offices and headquarters in Charlotte, has some 3,200 stockholders in North Carolina, South Carolina and Tennessee.

A. Hartwell Campbell of Greenville, president of Sentinel, said today, "We are extremely pleased to be able to join forces with Allied Security which we believe will bring new benefits to our agency force, our stockholders and the insuring public. The future growth and appreciation of both companies will be accelerated as a result of this merger."

The proposed new company would operate under the name of Allied Security Insurance Com-

pany, and following the merger would have insurance in force in excess of \$70,000,000 with assets in excess of \$3,000,000. It will have more than 500 active agents.

Campbell will become chairman of the board of the new company when the merger is consummated. In addition to Campbell, Bancroft F. Moseley of Greenville, secretary of Sentinel, and W. W. Speight of Greenville, general counsel of Sentinel, will also become members of Allied Security's board of directors.

Charles Honig of Charlotte will continue as president and chief executive officer of Allied Security, the announcement said. Gordon Lynch of Greenville, vice president of Sentinel, will become vice president and state agent for North Carolina operations of Allied Security.

The present Sentinel Life home office in Greenville will become the state headquarters of the new company in North Carolina. The announcement said all present personnel of Sentinel Life are being encouraged to continue their employment with the new company following the merger.

M. C. Stevenson of Charlotte will continue in his present position as executive vice president of Allied Security in charge of agencies.

Allied Security Insurance Company now operates in North Carolina, South Carolina and Tennessee, and is in the process of moving into its new executive offices on Independence Blvd. in Charlotte.

Notices of approval of the merger proposal by the board of directors were mailed today to stockholders of Sentinel. The date

for the stockholders meeting at which the merger proposal will be considered has not been announced.

Allied Security as presently constituted is the result of the merger of three separate insurance companies in June of 1958. At that time Family Security Life Insurance Company of Spartanburg, Allied Life Insurance Company of Charlotte and Tennessee Life and Service Insurance Company of Knoxville merged under the name of Allied Security Insurance Company.

The merger gave the new company more than \$40,000,000 of insurance in force and assets of more than \$2,000,000. Since that time its insurance in force has grown to more than \$55,000,000.

# Basic Study Topic

All sorts of new places and new names appear in the events of the day and as it is impossible to understand what is going on without a working knowledge of geography, I looked around for a good one. Back when I went to school, geography was a separate subject and we had to study it, drawing maps, tracing them in with variegated crayons, putting in the place names, so that one had an idea where a place was and what kind of people lived there and what they did for a living and how one thing related to another.

Nowadays, it appears, geography is all mixed up with other subjects and is part of the social sciences which is a mixed up subject, not meaning the same thing as two social scientists. So it was a bit difficult to find the kind of book I wanted which would educate me about places and peoples.

So, I bought a geography from the Superintendent of Documents, Washington, D. C. This is a volume prepared by the Air Force for its ROTC, "Military Aspects of World Political Geography," and it is a mighty good book and very helpful, indeed.

Nations are multiplying like flies and soon the United Nations will have as many members as the United States Senate has legislators. And if each one wants to make a speech on each subject that comes up, the General Assembly will exist under a permanent filibuster. To understand what is going on, a person requires a re-reading of history and geography. This is particularly true concerning the new nations of Africa, a continent about which most of us know nothing. Yet Africa has been in the news, as it were, for more centuries than the Americas.

The peoples of Africa are mostly various shades of black although not all of them go by the generic term, Negroes. For instance, Hannibal's armies that marched on Rome during the Punic Wars (218-201 B.C.) were led by a dark-skinned Semitic people called the Carthaginians who were descendants of the Phoenicians who were probably the Philistines, mentioned in the Bible as being sometimes the friends and most often the enemies of the Hebrews when Saul, David, Solomon and their descendants ruled over Israel. These people intermarried undoubtedly with the Hamitic peoples of whom the present Ethiopians are the best examples. These do not regard themselves as Negroes. The Bantus in the news today, however, are Negroes.

As the Portuguese, Spaniards, Dutch, French and British have been invading and settling in various parts of Africa since the 15th century, and as the Romans, Vandals, and other European conquerors came there even earlier, to say nothing of the Turks, Arabs and other Moslem conquerors, the peoples of many parts of Africa are of very mixed origin.

In fact, as one reads geography, the question must arise as to why peoples look so different. Why are some of one color and others of another? Is it the sun? Is it the food they eat? Is it the natural environment? The Bible has a simple explanation in the story of Noah's sons, but that does not give us an inkling into the varieties of human beings that are found upon the face of the Earth. What makes a Lumumba rise above a mass of illiterate almost savage men and women? Is it education? Does schooling change personality to that extent? From what part of Africa did Adam Clayton Powell's ancestors come or Alexandre Dumas' or Ralph Bunche's?

There is so much to know and life is so short that one hardly gets started before his days are numbered. Well, I am just beginning to study Africa to try to understand what it contains. I recall that when I first heard of China and the Chinese, it was quite simple: China had no snow; the Chinese ate rice; the Chinese were all short and thin, etc., etc. Then I lived in China and discovered that everything, but everything, I had heard about that country was false. I soon learned that China was like any other place and that latitude and longitude affected the lives of people, that snow

For the Democrats under the leadership of its presidential and vice presidential nominees, the session brought no major legislation such as a new minimum wage law and a broad medical care program for the aged. These, of course, were major programs that Sen. John Kennedy called for when he returned from Los Angeles with the Democratic nomination.

The minimum wage bill proposed by Sen. Kennedy was passed by the Senate, but failed to become law when House and Senate conferees were unable to reach a satisfactory compromise between the two minimum wage bills passed by their respective bodies. Kennedy's proposal for medical care for the aged was defeated on a roll-call vote in the Senate itself.

For the Republicans and its presidential candidate Vice President Nixon, the post-convention session afforded no triumphs either. The medical care proposal Nixon had advocated was also voted down in the Senate, and his endorsement of a minimum wage bill suffered the same rejection as that of Sen. Kennedy.

All-in-all, the post-convention session brought only routine accomplishments pertaining primarily to regular appropriations.

As the candidates hit the campaign trail, there-

## Greater Power Than Realized

STATE GOVERNMENT—The Institute of Government at Chapel Hill has just released a compendium on the selection of officers in North Carolina's State government set up. Prepared by John L. Sanders, assistant director of the Institute, the publication deals with the manner of selection of members of the legislative, executive and judicial branches of State government, and several hundred local officials required by the constitution or the statutes to be appointed by the Governor. It sets out in every instance how the officers are chosen, whether by election or appointment, how they can be removed from office, and the basis upon which their compensation is fixed.

Casual study of the book suggests two primary conclusions. First is that in North Carolina more State and local officials are elected by the people in popular voting than in most other states. Next, and somewhat in contrast, is that the Governor of North Carolina has responsibility for appointing more officials than the people elect—and has the right to remove from office for cause a number of the elected officers.

For every statement about selection, qualification or removal of officers, Sanders cites constitutional or general statutes authority. While there is no instance of direct conflict, there are numerous cases where a primary provision is qualified or modified by collateral acts of the General Assembly. The net effect of all such provisions is to give to the Governor of North Carolina greater power than most citizens realize.

BUDGET CONTROL — In his ex-officio capacity as director of the budget the Governor has authority to name two of the six members of the Advisory Budget Commission—the group that to great extent determines the amount of taxes to be levied and the manner in which tax moneys collected by the State shall be spent for operating the agencies, departments and institutions. But the Governor has the power to reduce appropriations made by the General Assembly if revenue is not sufficient to meet them.

What is not so generally understood is that the Governor also has authority to remove from office any administrative head of any agency, department or institution (except constitutional elective officers who can be removed only by impeachment), who refuses to comply with provisions of the executive budget act or overspends allocations from voted bond issues for specific purposes. That means the Governor has the power, and

the implied obligation, to remove the president of the Consolidated University, the superintendent of mental hospitals, and any other non-elective official, if in his opinion that officer has not complied with budgetary requirements of the law.

VETO? — Governor Hodges and others have made much of the fact that the Governor of North Carolina does not have the constitutional power of veto over legislative acts—the only State in the union where that authority is lacking.

The actual power given to the Governor of North Carolina by statute, explicit and implied, for control over fiscal policies before and after legislative enactment, and his authority for removing recalcitrant administrators, makes the question of constitutional veto almost moot.

COMPOSITE — The Sanders-Institute of Government compilation is rated a highly valuable contribution in aid of the studies being made by the Commission for Reorganization of State Government. It might well be that some offices now elective should be switched to the executive appointment class. Certainly there are a number of appointed positions, municipal and local, with which the Governor of North Carolina should not be bothered.

Why should the Governor of North Carolina be required to select members of the governing bodies of Long Beach and Surf City, the judges of recorder courts in Siler City, Thomasville, et als et cetera? What justification is there for popular election of a Commissioner of Insurance and executive appointment of a commissioner or revenue?

FACTUAL — John Sanders, in his report for the Institute of Government, makes no comment or suggestion about changing existing policy with respect to election and appointment of officials and members of governing bodies of State department. His factual statistical presentation of existing methods of selection of officers suggests the need for statutory, perhaps constitutional, modernization and correlation of the divided authority which has grown up through the years among the varied segments of the legislative and judicial branches of State government. Undoubtedly there has been encroachments by each of these basic authorities upon prerogatives of the others. And, although the Legislature is supreme under original constitutional mandate, the fact is that by delegation of powers by numerous legislative acts through the years, the executive division, headed by the Governor, is the presently controlling force in State government.

fore, the post-convention session will be held up as an example of what happens when progressive measures are blocked by dissenting factions in the Congress. The Democrats will put the blame on the Republicans for the session having accomplished very little, and the Republicans will declare that Sen. Kennedy's leadership was rejected by his own party members who control Congress.

Regardless of the approaches that are made to the session during the campaign, it is fairly clear that the session was steeped with political considerations on both sides. Under such circumstances little could be accomplished in a short time, and the members of Congress were unwilling, because of campaign considerations, to let the session drag out into the period after Labor Day when the vote-seeking machinery had to move into high gear.

The post-convention session, as we see it, contributed nothing of consequence to the legislative program accomplished by the 86th Congress, and neither did the Democrats or Republicans emerge from the session with a decisive advantage it could use during the forthcoming campaign.

## If You Can't Beat 'em, Join 'em; Old Saying

The Battle of Benson may go down in Tar Heel history to be remembered along with the Battle of Bentonsville, the Battle of Kings Mountain, the Battle of Guilford Court House and others fought from one end of North Carolina to the other a century or more ago.

Future historians will point to the Battle of Benson as the decisive encounter fought between the military might of the nation to conserve its appropriations, and the determination of the stout citizens of Benson that the faithful mule and the hard-working farmer should be honored.

Though the Johnston County folk of Benson did not exact terms of unconditional surrender from the brass at Fort Bragg, historians will readily agree that the running battle ended with the capitulation of the airborne might of the Army.

Appropriations or no appropriations, budgets or no budgets, tax money or not, a contingent from the military would march in honor of the mule and the farmer on a bright September day down the streets of Benson.

We may be sure that the top military strategists of the United States will in the future study the victorious tactics used by the town of Benson to win the battle. The combination of a frontal publicity attack by Benson citizens upon Fort Bragg, coupled with the pincer movement via Washington, will not soon be forgotten. It will become a lesson in embarrassment instilled among the high brass of the Pentagon and imprinted in the minds of those who in the future command military bases throughout the country.

The lesson is simple: When in North Carolina the request is made to join in honoring the mule and the farmer, do not hesitate. Join ranks to pay homage or suffer the embarrassment of being surrounded, cut off from reinforcements, and subjected to a humiliating defeat.

## Nikita Grabbed Limelight Again

WASHINGTON (AP) — Premier Nikita Khrushchev, the fantastic Russian who seems to be grudge any other human being the limelight very long, has suddenly grabbed it back again. He is now doing his best to knock the presidential campaign off the world's front pages—and may interfere in it—and could even wind up at dinner in the White House with President Eisenhower whom he belittled and insulted.

Look at what he set in motion Thursday night with the Moscow announcement he and the heads of all the Iron Curtain Communist nations except Red China will go to New York for the United Nations meeting opening Sept. 20.

1. This invasion will occur in the midst of the presidential campaign.

2. With Khrushchev going, Cuba's Fidel Castro may go to the U.N. too.

3. Since Khrushchev will use the U.N. as a world forum for Communist propaganda, President Eisenhower will almost certainly have to go to New York to make a major reply.

4. If Eisenhower goes, British Prime Minister Harold Macmillan may also go. Likewise, French President Charles de Gaulle.

5. This sets the stage for the possibility of a super-summit conference, although Khrushchev wrecked the summit meeting with Eisenhower last May and said another would be useless until there was a new president.

6. Such a summit meeting in New York would first require some evidence of good will on

both sides. Instead, it's possible the U.N. sessions will turn into an international shouting match, and an ugly one at that.

7. If there are no explosions, Eisenhower might invite Khrushchev to Washington. The President at his Aug. 10 news conference didn't foreclose the possibility. He said he'd invite the Russian if he thought it useful.

The major item before the U.N. is disarmament. The Communists have already indicated they want to discuss more than that. The discussions could go on for weeks.

Meanwhile, who's going to notice the presidential campaign, particularly since Vice President Richard M. Nixon and Sen. John F. Kennedy by that time will probably be repeating what they had said before?

Khrushchev could create a sensation if he asked to meet the presidential candidates in public and got into a wrangle with them or showed a preference between them.

The real purpose of his visit may be that it is simply timed to get maximum publicity—to follow some new and spectacular Soviet achievement in space.

But there are other possibilities.

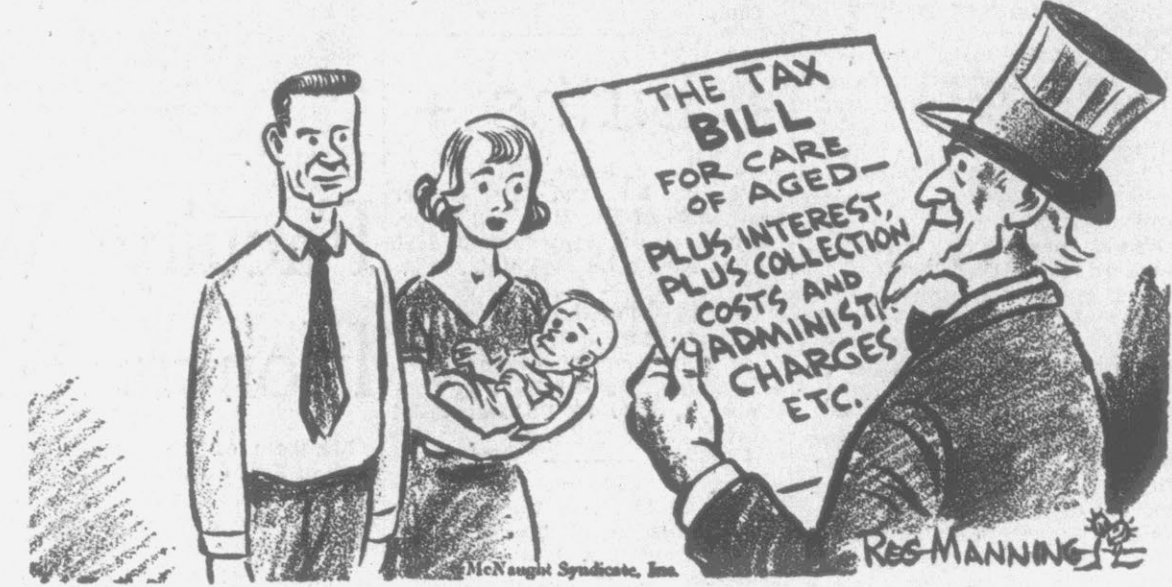
1. That he has such contempt for the United States, it de-lights him to barge in just at a time when this country thought it was to be free of foreign crisis for a while and could concentrate on the presidential race.

2. Or, that it is part of Kremlin psychology to keep the world confused and in turmoil by sudden, unpredictable performances which make the Soviets look like well-wishers and the West like

The White House Conference on Children and Youth was held in Washington last spring; March 27 to April 2, to be exact. In attendance were 7,500 delegates, 1,400 of them between 16 and 21 years.

# Casey Warns Yanks Of Birds And He's Right

"This is a good ball club, and if you men do not know it now, you're likely to find it out by Sunday.

These quotes belong to Casey Stengel. This note of warning was part of a speech made by the New York Manager to his Yankee players before Friday night's game in Baltimore.

Casey was right about the Orioles, and his players don't wait to wait until Sunday. They saw first hand just how good those Orioles are. With a crowd of 44,518 roaring approvingly, Paul Richards' Baby Birds won the opener of the vital three-game series, 5-0, extending their winning streak to five straight.

"I can see why they're up there in the race," Stengel told his players. "Their pitchers pitch four and five hitters."

The Ol' Perfessor miscalculated slightly. Mill Pappas, Baltimore's 21-year-old flame thrower, allowed the Yankees only three hits—all singles—and permitted only one runner to reach second.

"That infield of theirs does well," preached Casey. "They have good speed and you can't execute the way you want to because they keep you from getting men on base."

# U.S. Shaping Up In Gold Medal Out-Put, Win Six

ROME (AP)—The United States sent all of its entries speeding into the second round of the men's 110-meter hurdles and 400-meter run, and qualified two of its three entries in the women's discus today as the Olympic Games entered their seventh full day of competition.

While Uncle Sam's athletes continued their determined comeback bid in track and field, where they collected three gold medals Friday, his rowers were set in five of the day's seven finals on the blue waters of Lake Albano.

Navy's eight-oar crew faced the biggest challenge, after battling back through the repechages (second-chance heats) to make the finals in a quest for the ninth consecutive U.S. gold medal in that event.

Willie May, the chunky Chicagoan who three times was Big Ten champion at Indiana, led the high hurdle qualifiers in the elimination heats with a time of 14 seconds flat. Defending champion Lee Calhoun, Gary, Ind., and Hayes Jones, Pontiac, Mich., also breezed into the second round. All were heat winners.

Jack Yerman, Woodland, Calif.; Earl Young, San Fernando, Calif.; and Otis Davis, Los Angeles, just as easily moved into the second round of the 400 meters.

In the women's discus, defending champion Olga Connolly (see Santa Monica, Calif., and Mrs. Earlene Brown of Los Angeles, Florida's bronze medal winner in the shot put, qualified for Monday's final on their second tosses. But Pamela Kurrell of San Francisco failed to reach the qualifying distance of 154 feet, 2½ inches.

All three Russian entries, including shot put champion Tamara Press, qualified for the discus, which was won by Mrs. Connolly at Melbourne in 1956 when she was Olga Pitkovata of Czechoslovakia.

It was right after those Melbourne games that she married Harold Connolly, who defends his hammer gold medal this after-noon.

While there were 14 final events on the day's program, the track and field interest was on the men's 200-meter dash, where Ray Norton of Oakland, Calif., led a Yankee trio into the semis, which preceded this afternoon's finals.

It was Norton who felt the full frustration of the U.S. failure on black Thursday, when Germany's Armin Hary cracked America's monopoly in the 100-meter dash, and world record holder John Thomas was upset in the high jump.

Norton finished dead last in the century final.

Another top attraction on the day's program is the semifinal round run-in between the United States and Russia in basketball. This will be the first meeting between the two teams, who already have qualified for the final round.

A bristling battle for team honors between the Americans and Russians plus scandals in the wrestling and boxing fired the 1960 Olympic Games to a new pitch on Friday.

U.S. track and field and swimming stars pulled Uncle Sam up to 240 team points in the unofficial race.

The Russians, deep in long distance running, gymnastics, and other sports Americans find unimportant, were having a hard time keeping their lead. They had 269½ points and the margin was now only the equivalent of one gold, one silver and one bronze medal, with an odd half point thrown in.

In the medal race the Soviets had 15 golds, five silvers and nine bronzes. The Americans had 13 golds, 11 silvers and nine bronzes. Surprising Germany was an uncontented third with 150 points based on five golds, 12 silvers and five bronzes.

Individual performances were overshadowed by a storm in the wrestling section where the Russians dominate.

There were charges that a Bulgarian threw his match to a Russian. Yugoslavias, affected by the outcome, complained all the way from Belgrade, that Russia and Bulgaria had engaged in an "overt fix" which cost the Yugoslavs a gold medal.

In boxing, the Italians fired half the 30 referees and judges of all nationalities after numerous complaints including one that gave a decision to a Russian over a British fighter.

In swimming, Bob Webster won the platform diving, edging out teammate Gary Tobian.

The American women's 400-meter medley relay team set a world record of 4:14.1 for its gold medal and Mike Troy, Indianapolis, Indiana butterfly wizard, broke his own world mark with a 2:12.8 triumph in the 200 meter finals.

During the day the American forces racked up three gold medals in swimming and three in track and field. The Russians picked up only two track gold medals, the women's shot put and the men's 20,000 meter walk.

In the great Olympic stadium, the American track and field team put on an impressive display.

Ralph Boston, who cracked Jesse Owens' 1936 broad jump mark twice before this year, did it again in winning the men's broad jump. He leaped 26-7¼, as against Owens' 26-5½.

Bo Robertson, Fort Lee, Va., grabbed the silver with another record breaking 26-7¼.

Glen Davis, world record holder of the 400 meter hurdles, proved his right to it by capturing the event just a fraction short of his record. And in this event, the Americans had it one-two-three with Cliff Cushman second and Dick Howard third.

Meanwhile, the unbeaten U.S. basketball stars coasted toward what now looks like a certain triumph they way they are playing. They overwhelmed Uruguay, 108-50, for their fifth in a row as a warmup for their Saturday night game against Russia.

## Highway Patrol Conducts Weekend Safety Drive

The North Carolina State Highway Patrol in Pitt County is conducting an all-out campaign to prevent accidents on Pitt roads and highways over this Labor Day weekend.

According to Patrol Cpl. J.T. Jenkins of Greenville, Pitt's patrolmen will be working 24-hours a day over the holiday, which started last night at 6 p.m. and will officially end at 12 midnight Monday.

Jenkins urged Pitt's motorists to drive with caution "everywhere you go" over the holiday period in a sincere effort to prevent traffic accidents. The lawman noted that one person died in Pitt County last year during the Labor Day period.

He added that five accidents were investigated by patrolmen in Pitt during the period and an estimated \$1,050 damage resulted from the mishaps.

In addition to officers patrolling the highways in the county round the clock, three saturation patrols have been set up. The officers who are assigned to the sectors of highway will patrol the roads for their entire duty period and will stop at least one car each 15 minutes, and make a routine license and equipment check of the car and driver if no other violation is observed. A special session of the North Carolina Annual Conference of Methodists will be held here next Friday to review plans for the proposed \$600,000 Methodist conference headquarters building in Raleigh, which raised controversy at the Annual Conference in June.

A special committee, voting 20 to 3, has approved previous plans to erect a building spacious enough to provide space for rental to agencies outside the church. A reporting committee which includes Reynolds May of Greenville will present the report of a special committee which met in July in Raleigh.

Plans for the proposed building, to be built on six acres of land adjoining the Methodist Home for Children in Raleigh, drew fire from some Methodists at the Annual Conference held in Rocky Mount in June, who objected to a proposal that the structure be paid for with rent from other agencies which would use the building. Rev. H. M. McLamb, pastor of Jarvis Memorial Church here and a member of the study committee, said some Methodists have objected to the church's entering business, in competition with its members, by renting to agencies outside the church.

A suggestion that a motel and restaurant be built on the Methodist property was proposed and

defeated between conferences. However, one member of the headquarters building committee, Rev. Graham S. Eubank, Raleigh district superintendent, said he resigned as a member of the committee last February in protest over the motel and restaurant issues.

About half of the 1,000 conference delegates are expected to attend the 10:30 a.m. meeting at Jarvis Memorial Church, Rev. Mr. McLamb has said. Bishop Paul N. Garber of Richmond, Va., will preside at the meeting. Sam Underwood, church lay leader, will help with the local arrangements.

The North Carolina Annual Conference of Methodists set up a headquarters building committee two years ago to make plans for the new building. The land was given by the Methodist Home for Children.

The reporting committee, which includes May, Bill Price, chairman, C.D. Barclift and T.B. Hough, will move that the special session of the Annual Conference direct the building committee to proceed with the construction con-

tracts and the financial arrangements as may be necessary and appropriate to effect completion of the conference headquarters building. This committee was responsible for drawing up the report of a special committee which met in July to review and study the plans after controversy arose at Annual Conference in June.

**Building Plans**  
Preliminary plans call for a building which would house all the offices of the various boards, commissions, and agencies of the conference.

Consideration would be given to future expansion, so that expansion would be accomplished with a minimum amount of renovation due to the use of a modular ceiling system and dry wall partition construction. All walls, except those around the toilet areas, could be moved. The rental wing of the building also has been planned for maximum flexibility.

The building would consist of two levels, according to an architect's drawings.

Also a delegate to the special session will be the Rev. C. F. Hirsch, pastor of St. James Methodist Church here. Mrs. W. H. Taft, women's leader in Jarvis Memorial Church, will assist in the planning.

Whedbee said a heavier sprinkling of better quality tobacco may appear during next week's four sales days.

## Highway Fund's Collections Lag

**RALEIGH (AP)** — Tax dollars poured into North Carolina's general fund at a healthy rate last month, but collections for the highway fund continued to lag.

Revenue Commissioner James S. Currie said in a report to Gov. Hodges today that August general fund collections of \$28,431,543 represented a gain of about \$10 1/2 million over the same month last year.

The highway fund took in \$9,281,967, a decline from August, 1959, of \$475,479.

For the first two months of the new fiscal year, Currie said the general fund has taken in \$50,327,760, which is a gain of \$15,356,060. Highway fund collections have amounted to \$18,965,742, which Currie said is almost identical with the figure for the same period last year.

Currie noted that even discounting withholding, however, the general fund posted a gain of 14.19 per cent for the month of August, and 8.97 per cent for the July-August period.

Greenville firemen were called to 1904 Chestnut St. at 9 a.m. today when a car belonging to the Salvation Army backfired and caught fire.

Fire officers who responded to the alarm said the fire was out when they arrived. They added the blaze burned several wires under the hood of the car and smoked up the vehicle.

## Ex-Police Chief Is Tax Collector

**AYDEN** — H. V. Chandler, former police chief of Ayden, has accepted a position with the town of Snow Hill as tax collector as of September 13 and will become police chief there about January 1, when the present chief retires.

His plans were revealed this week.

Chandler left the Ayden police department as chief August 9 after the Town Board recommended a meeting that the Town Manager, Cleveland Paylor, ask for Chandler's immediate resignation. The action followed dissatisfaction over Chandler in some segments of the population, which had gone on for several years.

## Remind Health Cards Required

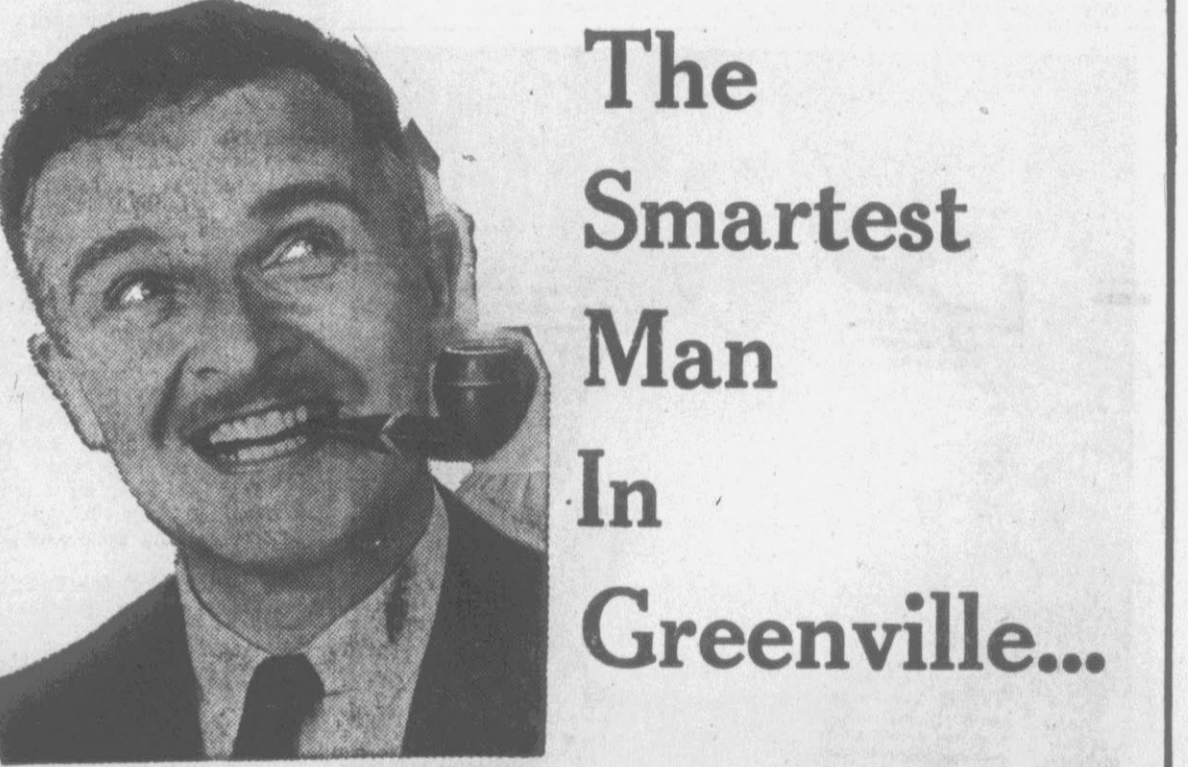

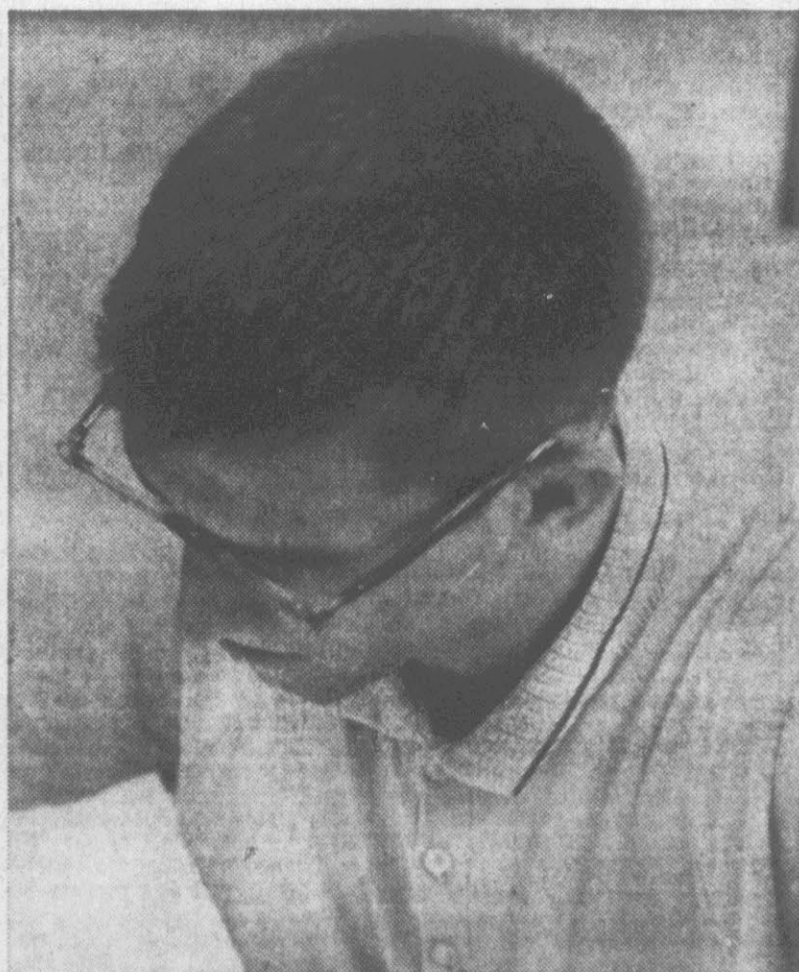
**RESTING PLACE . . .** Wright building steps, familiar to those who have attended ECC, are discovered by freshmen.

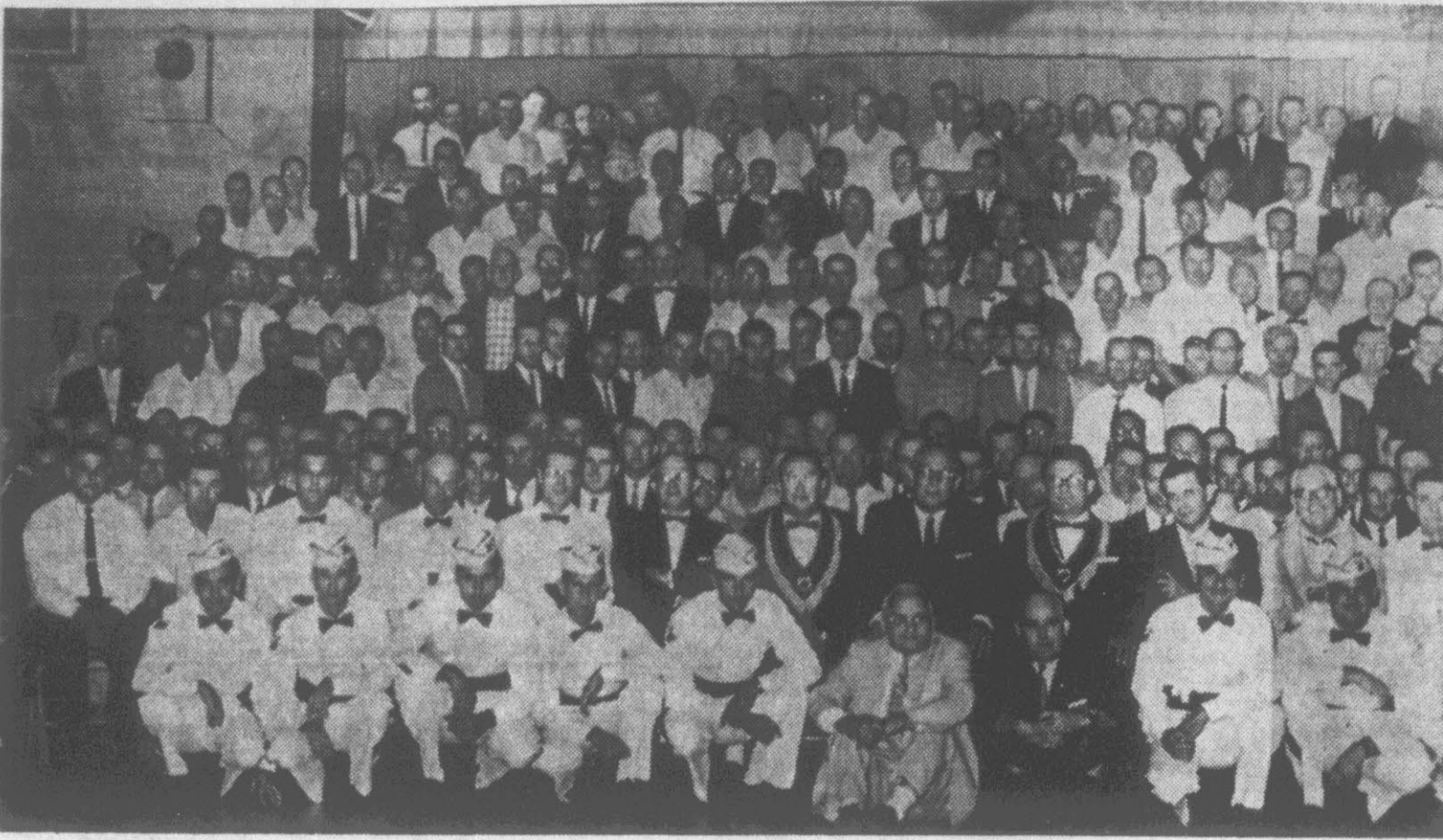

## Renovated Cafeteria At College Is Ready For Use

Renovation of the North Cafeteria at East Carolina College has been completed; and the dining hall, oldest on the campus, will be put to use this weekend for the 1960-1961 term.

Work began last winter on this building project and has been in progress since then. The entire interior has been rebuilt, and air-conditioning installed. Basic wood construction has been replaced with fireproof materials. Total cost amounted to \$130,000.

A new entrance on the west side of the building, with the already existing east entrance, provides for formation of cafeteria lines at each end of the dining hall. A lobby and rest rooms have been added just inside the west entrance.

The interior has a new acoustical ceiling and a terrazzo floor. Square fluorescent lights over the dining area and bear-shaped hanging lamps over the service counters light the building.

Walls based with wood paneling are of white plaster.

Equipment includes two units of stainless steel cafeteria counters and tables of wood with matching upholstered chairs.

The North Cafeteria adjoins the kitchen which also serve both the South and the New South cafeterias.

## Dove Season To Begin Sept. 10

Teel emphasized that the Mourning Dove season is divided in two periods, the first running from September 10 to October 15 while the second shooting period will begin December 12 and run through January 14.

Bag limit for the doves is 12 with the possession limit set at 24. Shooting hours for dove begin at 12 Noon and ends at sunset each day. Teel noted.

Rail (Marsh Hen) and Gallinule season will run for 70 consecutive days. Teel noted. The season started September 1 and will run through November 9. Shooting hours will be from sunrise to sunset each day and the bag limit is 15. Possession limit for Rail and Gallinule is 30.

Teel said migratory game birds may be taken on or over standing crops (including aquatics), flooded standing crops, flooded harvested crop lands, grain crops properly shocked on the field where grown or grains found scattered solely as a result of normal agricultural planting or harvesting.

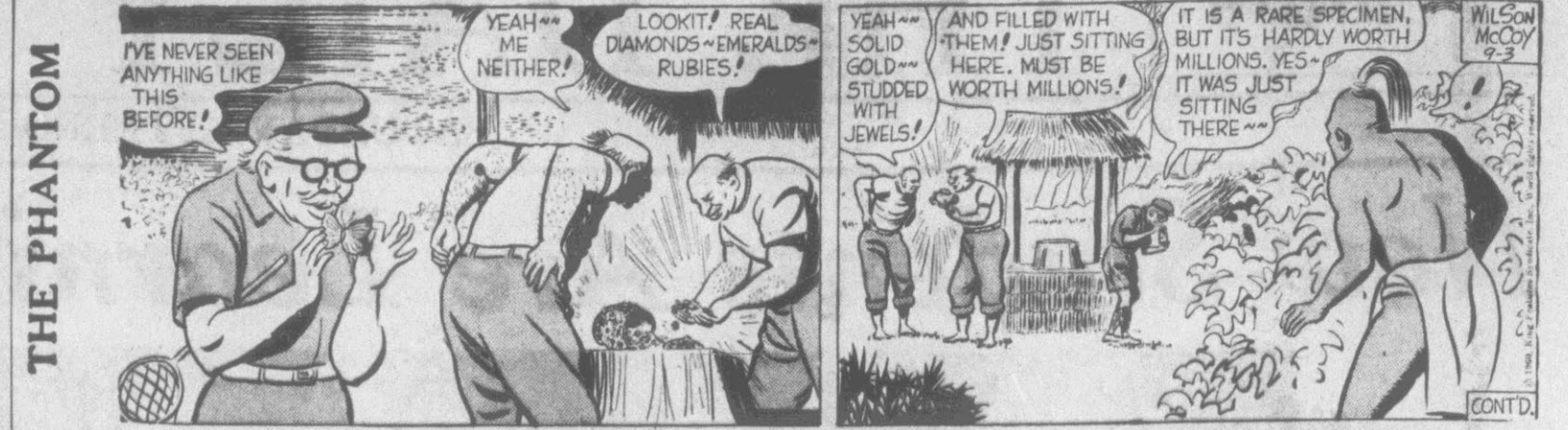

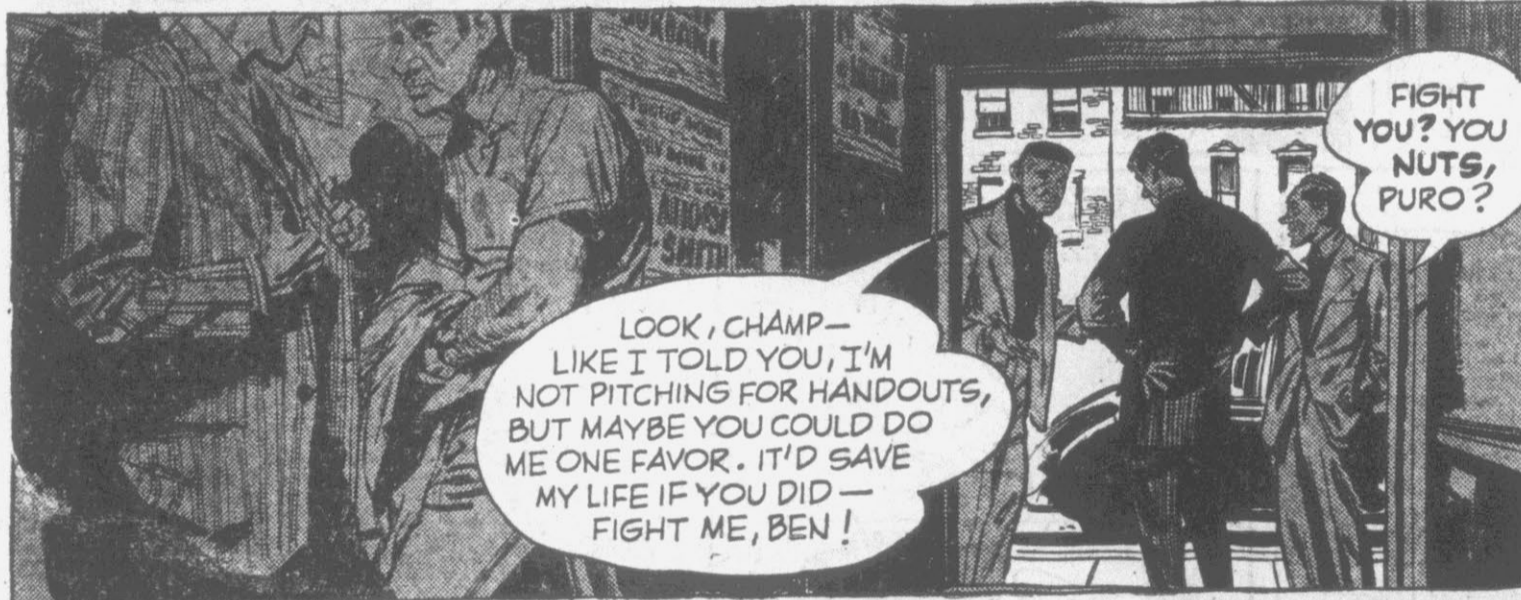

## FBI Chief Cites Poor Road Safety Program

WASHINGTON (AP)—Carnage on the highways during the Labor Day weekend offers stark testimony to the inadequacy of the nation's safety program, FBI Director J. Edgar Hoover said today.

He decried soft punishments for drunk or reckless drivers and asked why anyone should feel compassion for them.

Hoover said in an article in the FBI law enforcement bulletin that in some states drunk driving is classified as a simple misdemeanor, involving a light penalty and no suspension of the driving privilege.

"It would appear just as logical," he added, "to free a crazed man who had been firing a gun on a crowded street and return his weapon to him."

"Two of the greatest dangers on our roads are the drunken and reckless drivers. Why should anyone feel compassion for them? Their actions show as much disregard for law and order as do the acts of a burglar who follows a carefully laid plan to steal in the night. Also, in many instances, they are a far greater threat to human safety."
