All Over But The Voting, To Hodges

Governor Confident Democrats Will Win In State, Across Nation

RALEIGH (AP)—It's all over but the voting as far as Gov. Hodges is concerned. He says he has no doubts the Democrats will win in both the nation and the state next month.

The governor told his weekly news conference Thursday he was concerned, however, about the number of Tar Heels who go to the polls. He continued to urge a heavy turnout.

"I'm not the least bit concerned about how it's going in the state or even in the nation," he said when asked how he felt the Democrats were doing.

He said the party made its push after Democratic presidential nominee John Kennedy's appearance in the state and the first televised debate between Kennedy and Republican Richard Nixon.

Hodges bristled when he discussed recently announced cotton allotments for 1961. He said the Republican administration went "the limit in playing politics with the economy."

Nothing that California's allotment was increased 14.8 per cent and North Carolina's only 7.2 per cent, Hodges said perhaps the administration was using a formula based on electoral votes.

Hodges said he accepted a challenge with Hawaii over which state can produce the biggest voter turnout. He said he expected to lose. The first Hawaii election as a state drew 92.9 per cent of its registered voters. North Carolina turned out 64.7 per cent of its electorate in 1956.

"We'll have a big vote," Hodges said, "but we're not likely to be in the running against Hawaii."

Joint Meeting Is Quietly Held

Pitt County's commissioners and members of the Pitt Board of Health met in a joint informal session here last night to discuss "problems at the health department."

According to J. Vance Perkins, chairman of both county bodies, "nothing concrete" developed at the discussion session.

Four of the five commissioners attended, he said. B. Alton Gardner of Ayden was out of town.

Perkins said the meeting, held in the Community Room of the Wachovia Bank building, was unofficial. No action was taken, he said.

He called the meeting a "ret-tog" as the two boards could talk things over informally. "In addition to the commissioners and board members, Perkins said, some "lay people" attended.

'Election By Extortion' Is GOP Chairman's Charge

MORGANTON, N.C. (AP)—The head of the Republican party in North Carolina today accused the Democrats of attempting to win "election by extortion."

But, William E. Cobb of Morganton, Republican state chairman, said he had asked no police agency to investigate his charges, and admitted that the "case" he cited was just another "for instance" of an earlier campaign issue concerning a letter written to some state employees.

Cobb issued a statement asserting that the Democrats conducted a meeting of 45 highway employees in Mecklenburg County on Sept. 12 and demanded funds for Terry Sanford's gubernatorial campaign. Cobb said the employees also were directed to attach Democratic stickers to their personal vehicles.

ICC Authorizes Railroad Hike Freight Rates

WASHINGTON (AP)—The Interstate Commerce Commission today authorized the nation's railroads to hike their basic freight rates effective next Monday, Oct. 24.

However, the commission temporarily suspended proposals for various increases in special rail service charges pending further investigation.

The railroads gave public notice of the proposed increases in late September, on a basis designed to yield \$147 million additional revenue annually.

In approving the major part of these proposals, the commission made no immediate estimate of what yield will be involved to help the industry meet increased operating costs estimated to amount to \$600 million since the last general rate increase in 1958.

Basically, the higher rates, which will go into effect Sunday midnight, will involve an advance of half a cent on rates of 65 cents per 100 pounds or under, and an increase of a cent in rates above 65 cents.

However, the ICC directed the industry to submit for examination lesser increases in combination rates, in which more than one form of transportation is involved.

Also, the ICC suspended any increase on fresh fruits or vegetables and on petroleum coke.

Private Firm Asking For Its Own Satellite System

WASHINGTON (AP)—American Telephone & Telegraph Co. today asked authority to put up a space satellite as the first station in a proposed international communications system. It said it wished to do this within a year.

The first station, the company said, would provide experimental transmission of telephone calls, television and other types of communication between the United States, the United Kingdom and Europe.

This would be the first satellite launched under private, as distinguished from government, auspices and the first commercial application of satellites.

Henry T. Killingsworth, AT&T vice president in charge of long distance service, said: "We believe the commercial application of satellite communications is a job for private enterprise. This new project is still another indication of our readiness to take on that job and pay our own way."

In applying to the Federal Communications Commission for the necessary authorities, AT&T said it is now prepared to contract for the launching of the satellite and to proceed with construction of ground transmission and receiving stations.

The company made no immediate estimate of the total costs involved.

However, company officials said that after the satellites are "in production" it is estimated each will cost about \$1 million to put into space. The contemplated eventual system would require a number of satellites.

The company said it expects to work closely with the National Aeronautics and Space Administration on the project. NASA's authority is broad enough so that it could contract to launch the satellite.

Cuban Counting On Black Market

HAVANA (AP)—Cuba's economic czar said Thursday night the U.S. embargo on most exports to Cuba will not seriously harm the island nation partly because black marketers in the United States will defy it.

But National Bank President Ernesto Guevara conceded that Cuba faces difficulties. He said the nation "must have confidence in the solidarity of the nations that have offered to stand by us, extending economic aid and even volunteers, rockets—an obvious reference to Soviet Russia and the Communist bloc.

Guevara spoke on a two-hour TV program before leaving today with eight other officials on a trade-building trip to the Soviet Union, Red China, Czechoslovakia, North Korea and East Germany.

Black marketers in the United States have worked against Washington's trade bans in the past, and they will evade this one, Guevara declared.

Guevara said that "there is a serious threat" of what he called U.S.-financed invasion in the near future from Guatemala. "I believe they'll come," he

said, "but I also believe they will never get out."

The U.S. embargo on all shipments to Cuba except medical supplies and food forces Cuba to look for purchases in new markets where American influence is not felt, Guevara said. He warned that the new customers for Cuban sugar, the island's chief export crop, are not going to pay the premium price the United States paid when much of the Cuban sugar industry was American-owned.

But with a faint smile, he said the United States may have some difficulty in getting all the sugar it wants now that it has cut off Cuba's sugar quota.

One of Guevara's chief purposes is to sell Cuba's entire 1960-61 sugar crop to the Communists.

U.S. Production Sees Decline In Third Quarter

WASHINGTON (AP)—The estimated rate of the nation's total output of goods and services declined during the third quarter from the record high set in the preceding three months.

The annual rate of \$503 billion for the July-September period was \$2 billion below the \$505 billion rate for the April-June quarter but \$2.15 billion higher than that for the third quarter last year, when business was affected by a steel strike.

The figures, announced Thursday by the Joint Congressional Economic Committee, were based on reports and estimates from the Commerce Department and the President's Council of Economic Advisers.

The announcement brought from George Meany, president of the AFL-CIO, a prompt demand for "immediate counter-recession" action by the federal government.

Meany said in a statement that the figures provided confirmation of what he called "the third recession since the Eisenhower administration took office less than eight years ago." He said it has been developing since February, with no government action to head it off.

Consumer spending and private investments dropped slightly from the second to the third quarter, but increased government outlays offset most of that decline. Savings, at the rate of \$29 billion, increased \$4.3 billion over the preceding three months.

Kennedy Urges A Fifth Debate In Special Message

NEW YORK (AP)—Sen. John F. Kennedy today challenged Vice President Richard M. Nixon to declare during their television debate tonight that he is willing to meet Kennedy again before a nationwide TV audience.

The Democratic presidential candidate wired his Republican opponent:

"Only in this way will the American people be able to evaluate the arguments and issues which are raised in the closing days of the campaign."

Kennedy told Nixon, who has consistently said no to a fifth TV debate, "in fact I believe that more than five debates would be helpful if the record were to be corrected properly."

"If you should relent in your opposition to further debates—and I invite you to so state in tonight's debate—I hope your representatives can contact mine to work out one or more dates at the earliest opportunity."

Kennedy sent the telegram to Nixon as his staff happily seized on a windfall assist from a Republican senator in preparing for tonight's debate, the last scheduled under existing arrangements.

Meantime, Mrs. Diorella LaGuardia, widow of the former New York mayor, issued a statement in support of Kennedy for president. Her husband was a Republican who often got Democratic backing.

Sen. Jacob K. Javits of New York conceded Thursday that "no matter what anyone says," U.S. prestige in the world has declined.

It would be silly to contend otherwise, the senator said in a campaign discussion with Mrs. Franklin D. Roosevelt. Javits is considered a member of the Republican party liberal wing.

The reaction of Kennedy's staff left no doubt that the Democratic candidate will use Javits' statement to the full in his television and radio meeting tonight with Nixon.

The debate goes on the air at 9 p.m. Eastern Standard Time from the American Broadcasting Co.'s TV center on West 66th street. It also will be broadcast and televised by NBC and CBS, and broadcast by the Mutual Radio network.

In the Carolinas, television stations will telecast the debate at 10 p.m. (EST), an hour later than it actually transpires.

Representatives of both presidential candidates finally agreed Thursday to limit tonight's debate to one hour. There had been talk of making the program two hours, with the final 60 minutes devoted to answering questions from viewers by telephone.

The issue of an extended program grew out of a proposal by Kennedy, the Democratic nominee, to hold a fifth debate as close as possible to the Nov. 8 election. Nixon, the Republican candidate, turned Kennedy's proposal down and suggested instead that the fourth debate be extended to two hours.

However, Thursday night Herbert G. Klein, Nixon's press secretary, said "the door is slightly open" to a fifth debate. But other Nixon aides have said it would be difficult to revise campaign tour plans for the closing weeks and work in another debate.

While campaigning here Thursday, Kennedy, needing Nixon on the question of a fifth debate, said: "It is an interesting fact that he is willing to debate with a mimeograph machine that permits only one side, but is unwilling to make his answers and charges in direct TV confrontation with 70 million people watching."

It will be Nixon's first telecast from the New York ABC studio, Kennedy appeared there last week when he debated Nixon, who was in a California studio.

Each candidate will have his own small, two-room cottage in the studio to ensure privacy before they go on the air. The cottages are equipped with desks, lamps, sofas, easy chairs, telephones, and wall-to-wall carpeting.

On the foot-high broadcast stage each man will be provided with a podium and stool.

They will face a panel of four radio-TV newscasters: John Edwards of ABC, Walter Cronkite of CBS, Frank Signer of Mutual, and John Chancellor of NBC.

Howe of ABC will be moderator. There will be no "live" audience except for three news photographers and three reporters.

Rally Support For 'Food For Peace'

UNITED NATIONS, N.Y. (AP)—The United States moved today to muster U.N. support for two far-ranging American programs to help the world's underdeveloped areas.

The U.S. delegation circulated a draft to U.N. members containing points it believes should be embodied in any resolution dealing with President Eisenhower's aid for Africa program when it comes up for debate in the political committee.

The United States also sought solid backing for Eisenhower's "Food for Peace" plan after winning priority for committee debate on the proposal the Soviets called a political trick to influence the U.S. presidential election.

The tentative resolution on Africa follows closely the proposal Eisenhower broached before the U.N. General Assembly in his address Sept. 22.

The draft asked the assembly to: 1. Request Secretary-General Dag Hammarskjold to assist the new African states in the study of a regional security pact.

2. Call on all nations to refrain from intervening directly or indirectly in the internal affairs of the new nations.

3. Call on all states to refrain from triggering disputes between the new African nations.

4. Urge the U.N. Educational, Scientific and Cultural Organization to increase its assistance to African educational programs.

The African question is slated for debate when the political committee finishes its disarmament debate.

The United States won the first round in the fight to put over Eisenhower's "Food for Peace" plan Thursday night. The 99-nation economic committee voted over Soviet bloc objections to head its agenda with the U.S. proposal, which would have the United Nations act as broker in the transfer of surplus food to the world's hungry millions. The vote was 36-12 with 27 abstentions.

The Soviet Union's P.M. Chruschev told the committee he was not told to the problems of the hungry, but he said he saw no point in giving priority to a plan he charged was a bid to sway the farm vote in the United States.

PROTEST MARCH

HOLBAEK, Denmark (AP)—Some 2,000 demonstrators from seven countries started a 40-mile march to Copenhagen today to warn the government against allowing atomic weapons on Danish soil.

Economists Say U.S. Now Entering Mild Recession

By STERLING F. GREEN

NOT SPRINGS, Va. (AP)—Industry economists today advised the government's Business Advisory Council that the country is entering a mild and probably brief business recession.

The report predicted the decline would cut into total production not more than about 2 per cent and would end by mid-1961. The study was made especially for the Economic Council of the President's Council on Economic Policy.

The council itself—led by the heads of scores of the country's biggest corporations—would agree with the findings of its own panel of professional economists was a question to be decided later today.

The council was scheduled to discuss the business outlook at the opening session of its fall meeting here. Newsmen were barred as usual from the BAC meetings.

Some government economists are known to agree with the private experts. Others hold that a further period of "high plateau" can be expected, with no significant gains or losses from the present near-record level of prosperity. However, it was known that Secretary of the Treasury Robert E. Anderson was prepared to tell the council that the country already has passed through its "ad-

justment" and that business can be expected to pick up.

Aides of Anderson said he has not altered the views he voiced to the International Monetary Fund last month—that a summer sag resulted from curtailment of business outlays for inventories; that inventories now have been cut to workable levels; that resumed buying can now be expected; and that both the near-term and long-term outlooks are good.

But recession talk was stimulated by Thursday's announcement in Washington that the rate of total national output skidded by \$2 billion in the third quarter from the record \$505-billion rate of the spring quarter.

This followed a series of official reports, issued over the past fortnight, which disclosed that industrial production, retail sales, housing activity, wage and salary income, and other key indicators declined in September.

If the BAC's professional economists are right, the over-all production rate may drop below the 500 billion mark before the economy resumes its upward drive.

The \$2-billion dip in the third quarter is a drop of less than one-half of 1 per cent. The 2-per cent decline predicted by BAC economists would represent a loss of about \$10 billion in the dollar value of all goods and services produced. The official figure bore out An-

der's thesis in at least one respect: The decline was primarily the result of a halt in industry's accumulation of inventories.

However, official sources said that virtually none of the economists on BAC's professional panel saw any particular segment of the economy which can be expected to provide a powerful lift in the next several months.

Beer Can Home Gets Rejection

EVERGLADES, Fla. (AP)—Something new in buildings—construction of a home with beer cans—has been rejected under a zoning law.

"They were stacking up beer cans and plastering them over with concrete for walls—I couldn't approve that," said Collier County Engineer Harmon Turner.

He didn't identify the builder or location of the structure.

Lodge Says U. S. Prestige Is High

MINNEAPOLIS, Minn. (AP)—Republican vice-presidential nominee Henry Cabot Lodge said Thursday night the question of U.S. prestige has been confused with a belief that powerful nations such as the United States can be loved.

"A nation as great and powerful as the United States cannot be loved," Lodge said in a nationally televised address. "But it can be respected."

And no nation has higher prestige than ours because people respect it, Lodge said.

As for U.S. military strength, the former ambassador to the United Nations said there is no question the United States is the strongest military power on earth—and the Soviets know it.

Lodge called the United Nations the cornerstone of American foreign policy. Moral standards, the basis for pinning our hopes on the United Nations, also are the basis for keeping Red China out, Lodge said.

Lodge said the first U.S. veto in the Security Council would be justified to prevent Red China's admission.

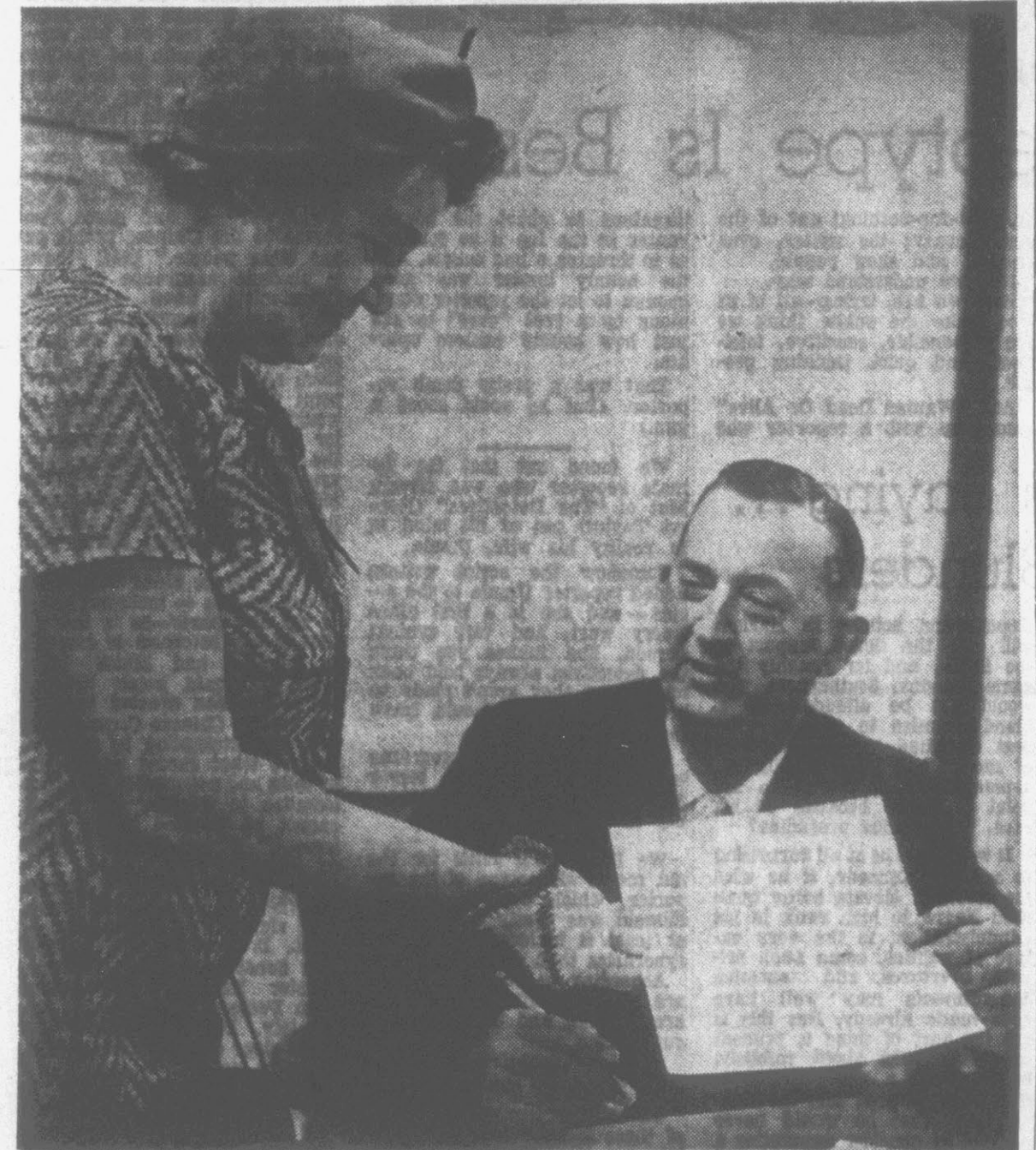

Groundbreaking 'Chain Reaction'

BRIGHAM CITY, Utah (AP)—A chain reaction out of the missile age marked ceremonies at which Thiokol Chemical Corp. broke ground for a new rocket operations center building near here.

Embargo Action Is Late In Coming

Stiff economic sanctions taken this week by the Eisenhower administration against Castro's Cuba have been urged from many sources since earlier this year when Castro began to take over millions of dollars worth of American property in his country.

The timing of the severe embargo orders, however, smacks of a domestic political move by the Republican administration as well as a move to enforce U.S. foreign policies with respect to the Castro regime.

The attitude of the Eisenhower administration toward Castro and Cuba has become one of the hot issues in these final weeks of the national political campaign. Democratic Presidential Nominee Kennedy has severely criticized the administration for the emergence of Cuba as a communist stronghold just 90 miles from the U.S. mainland.

Certainly the embargo orders issued this week by the administration represent the most severe steps yet taken by the U.S. government against the Castro rule in Cuba. It is a step many people feel should have been taken not this week, but months ago when Castro began his confiscation of large American holdings in Cuba.

If not for political considerations with respect to the forthcoming election, why did the administration choose this particular moment to take these economic steps against Cuba?

Actually, We'll Elect Electors

ELECTORS — It is estimated that some 70 million people will "vote" for a President and Vice President of the United States on November 8. About a million and a half of these votes will be cast in North Carolina.

Actually, only 537 persons in the entire United States can cast legal votes for the President and Vice President. Fourteen of these will be cast in North Carolina, and on December 19, not November 8. Either Democrats Kennedy and Johnson or Republicans Nixon and Lodge will get all the 14 states votes. There is no way the electoral vote can be split here.

That is because of the peculiar provisions governing the election of presidential electors. The original constitution of the United States provided for the election of 1812 citizens voted for each member in the Congress. With two senators and 12 representatives North Carolina has 14 electoral votes. From beginning of the nation through the election of 1931 citizens voted for presidential electors by name, just as they did for a governor or other officer. The electors were morally, but not legally, bound to support the candidates nominated by the party which had elected them.

The Legislature of 1933 enacted a law providing for the printing of the names of nominees for President and Vice President on the ballots, while names of electors are filed with the secretary of state. "A vote for such candidates shall be a vote for the electors of the party by which such candidates were named and whose names have been filed with the secretary of state."

UNIQUE — It is a sort of crazy arrangement. The citizen marks the ballot for one or two persons and that has the effect of electing 14 others — whose names are not even listed, and who are the only persons empowered to cast a legal vote for President and Vice President of the United States.

The presidential electors have unique status in one other respect. They are the only constitutional elective officers in North Carolina who do not have to be nominated in a primary. When the primary was established in 1915 the act required that all candidates for elective office be nominated by that process. Prior to that time they had been nominated in party conventions. The powers that were overlooked the fact that presidential electors are constitutional elective officers, and they continued to be nominated in convention through the election of 1948. The 1951 Legislature legalized the practice of convention nomination.

CERTIFICATION — When the State board of elections has canvassed the vote and certified the winner among presidential candidates, the secretary of state notifies the Governor that the electors of that party which are on file in his office have been duly elected. Thereupon the Governor "warns each of them to attend at the capitol in the City of Raleigh at noon on the first Monday after the second Wednesday in December next after his election, at which time the said electors shall meet, and then and there give their votes on behalf of the State of North Carolina for President and Vice President of the United States."

The constitution of the United States sets out procedure for sending results of the electoral voting to the president of the Senate and other details of completing the election.

WHO WILL VOTE? — Only two slates of electors have been filed this year, regular Democratic and regular Republican. Write-in votes for President cannot be effectively counted. Which set of electors will meet in Raleigh on December 19 will be determined by the popular vote cast on November 8.

If Republican candidates Nixon and Lodge get a majority of the popular vote the following 14 men will cast the State's vote for them: A. I. Ferree of Asheville and Ray Jennings of Taylorsville, electors at large; and district electors from congressional districts one through twelve as follows — J. D. Carr of Plymouth; John F. Mewborne of Kinston; A. L. Wilson of Newport; Henry White of Henderson; L. C. Hamrick of Winston-Salem; North D. Henderson of Greensboro; Robert Barefoot of Wilmington; Claude Hicks of Mocksville; Emery C. McCall of Lenoir; R. P. Majors of Charlotte; Paul S. Smith of Tryon; and J. Marvin Giance of Asheville.

If the majority popular vote goes for Democrats Kennedy and Johnson, twelve men and two women will cast the North Carolina vote for them. At large: W. Frank Taylor of Goldsboro and D. Hiden Ramsey of Asheville; district electors — Edgar Gurganus of Williamson; Olin Reed of Kinston; Dr. John D. Robinson, Sr. of Wallace; Daniel L. Bell of Pittsboro; E. T. Pullen of Winston-Salem; O. A. Kirkman of High Point; R. M. Kermion of Wilmington; Miss Edith Marsh of Monroe; Mrs. Stella Anderson of West Jefferson; Charles M. Walton of Morganton; John M. Akers of Gastonia; and Robert R. Livingston of Hendersonville.

The successful electors will get \$10 a day and 5 cents a mile for attending the meeting. If any one fails, without good excuse, he will forfeit to the State the sum of \$500 to be collected by the attorney general in the superior court of Wake county.

Why were these steps not taken months ago when Castro began to take over American property?

If there were no domestic political considerations why was not the move postponed for another few weeks until after the American voters had gone to the polls to indicate their choice of the next president of the United States?

Did Kennedy's criticism of the administration in the current campaign have anything to do with the administration's decision to take economic action against Cuba at this particular time?

These questions should be in the minds of the American voters, for the embargo orders appear certain to bring a further deterioration in relations between this country and Cuba in the immediate future.

We have no quarrel with these economic steps against Cuba taken by the Eisenhower administration. Indeed, we support them wholeheartedly. The timing, however, suggests to us that the administration in taking these measures now may have been thinking in terms of domestic politics as much as they were of basic foreign policy of this nation.

Another Opportunity To Check Registration

For those Pitt County citizens who have not checked to make sure they are properly registered for the coming national election, Saturday will be another opportunity.

Registrars of each of the 25 precincts in Pitt County will be at their respective polling places Saturday beginning at 9 a.m. for the purpose of registering voters.

It requires only a few minutes of an individual's time to make sure that he is properly registered. Furthermore, a check with the registrar at the polling place during the registration period will clear up any doubt in the prospective voter's mind about whether he is properly registered in order to be eligible to vote in the forthcoming election.

In this national election year it is important that citizens make sure they are properly registered so they can discharge their citizenship responsibility of participating in the election of the top officials of the nation. And in this election year in which a "close" election is predicted, individual votes are of utmost importance. The greater the number of people who participate in the voting on November 8, the better it will be for the nation and its people.

We urge each citizen of Pitt County to take time Saturday to check at the polling place in precinct in which he lives either to register or to make sure that he already is registered properly.

Most conscientious citizens will want to participate in the November election; but only those who are properly registered before the registration period closes will be eligible to do so.

A Bad Year For The Old Pros

WASHINGTON (AP) — When the Yankees sacked Casey Stengel, it just went to show this has been a bad year all around for the old pros.

Take politics. None of the men around Vice President Richard M. Nixon and Sen. John F. Kennedy is a political sentimentalist. But almost all are young.

The oldtimers in both parties have been shoved into the background.

Two of the biggest old pros still loose in the land, former President Truman and Speaker of the House Sam Rayburn, tried to sidetrack Kennedy's bid for the Democratic presidential nomination.

He ran right over them. Nixon didn't have to demolish any Republican giants to get what he wanted. He spent seven years as vice president sewing up the Republican presidential nomination long before he ever got to the convention.

Neither Nixon nor Kennedy, of course, is a political chicken. Even though they're both in their 40s, each has been in Congress 14 years and each knows his way around in campaigns. They've been in some rough spots before this.

The closest thing to an old-time pro in either camp is Leonard Hall, Nixon's campaign manager, a former Republican national chairman who was in Congress for years and has been mixed up in politics since back in the 1920s when he was

sheriff of Nassau County, N.Y. But Hall is staying pretty much out of sight, doing a lot of his work by telephone.

Further up front is 35-year-old Robert Finch, a lawyer who's been in California politics for years, ran twice unsuccessfully for Congress, and has the title of campaign director for Nixon. Kennedy didn't go hunting among the professionals, old or young, for his campaign manager. He picked his younger brother, Robert, who had been attorney for the Senate's rackets committee.

When he was with the committee the younger Kennedy brought in an old family friend, Phillip Kenneth O'Donnell, 36, a former Harvard football player and war veteran, as his top aide.

The Kennedys took O'Donnell along for the campaign. He's the senator's chief trouble-shooter now.

As his chief assistant Kennedy has 32-year-old Theodore C. Sorenson, who will probably be White House chief of staff if Kennedy wins.

Another old Kennedy family friend—Lawrence F. O'Brien, 43-year-old lawyer and public relations man—is in charge of organizing the Democrats around the country. He did pretty well for Kennedy in his primary fights this year.

So, with the exception of Hall and Truman, who is making some campaign speeches for Kennedy, there is hardly a political Stengel in sight.

"Wanted Dead Or Alive" last night presented the worst yet. It seems as if somebody always is complaining about the stereotype TV makes out of the Indian—always bad and bloodthirsty, good-for-nothing; out of the art, crazy; the writer, even crazier; and show people. Now we understand why. Here we are, trying—all of us—to make the public think we are responsible, sensitive, intelligent and quick thinking people. And "Wanted Dead Or Alive" comes up with a reporter who

threatens to shoot the bounty hunter in the leg if he continues to threaten a bad outlaw. And the bounty hunter was good enough to let the reporter come along on a real "case" to see just how bounty hunters operate. That was a pretty dumb reporter. (But he could shoot a gun.)

Other Editors Saying ... Mr. Lodge Blunders

(Richmond News Leader)

When the presidential campaign began, it was widely reported that Ambassador Henry Cabot Lodge had become Mr. Nixon's greatest asset. Today the melancholy fact is that Mr. Lodge has become Mr. Nixon's greatest liability. In his blundering "pledge" or "prediction" or "guess" that Mr. Nixon, if elected, would "name a Negro to the Cabinet," Ambassador Lodge has demonstrated total political ineptitude.

We are not so much concerned with the merits of this pledge, or prediction or guess. If some highly qualified Negro should emerge on the national scene, eminently fitted to serve as Secretary of Commerce, or Labor, or Welfare, or the Interior, the Republic would survive. No such highly qualified Negro is in sight, so the point seems rather academic. If Mr. Lodge had in mind only the appointment of Ralph Bunche as Ambassador to the United Nations, few responsible Southerners would raise much objection; in the world as it must be lived in for the next few years, the appointment of Mr. Bunche might be an excellent move for either candidate.

It is the sheer stupidity of Mr. Lodge's action from a political standpoint that sets the head to aching. This pledge, or prediction, or guess will not gain the Republican ticket a single Negro vote. In the eyes of Negro leaders, it is as greivous an offense to honor a Negro because he is a Negro as it is to deny him an honor because of his race. Either way, it is "racism."

When Adam Clayton Powell some months ago demanded that the proportion of Negro police be raised in New York, members of his own race were the first to denounce him. They do not want a color line recognized; they want it wiped out.

The blunder that profits the

Republicans nothing in Harlem will cost the ticket support in the South, and for roughly the same reasons. Southerners who would not be offended by a bland promise to appoint "the best qualified man, regardless of race," will be rightfully appalled by a pledge to appoint a Negro because of his race. What price prejudice?

It would not be at all surprising to see Mr. Kennedy, if he wins the election, elevate some qualified Negro to high rank in his administration. In the very nature of politics, some such private overtures and tentative commitments may well have been made already. But this is not the sort of thing a prudent candidate talks about publicly. Publicly, all a prudent candidate says is what Mr. Kennedy has said—that he would never promise to consider appointing a Negro as a Negro; he would promise only to consider appointing a Negro as a Negro.

That such a pledge is pious hypocrisy, no student of the nature of politics, some such private overtures and tentative commitments are made for reasons of race and religion, wholly apart from individual merits, and everybody knows it. Any President, naming his Cabinet or making judicial appointments, operates with the same judicious nicety that brings a rabbi, a priest, and a Protestant minister to a ground-breaking ceremony in Richmond.

Mr. Lodge now has his foot so thoroughly jammed in his mouth that no recantation or clarification is likely to be understood. But if the ambassador can hustle back to the same psalm-singing ground so handsomely occupied by Mr. Kennedy, he would be well advised to go it. This newspaper of course is standing by its commitment to help him. Considering the help he is getting from his gabby friend, Mr. Nixon needs somebody to stand behind him.

We found out that the female reporter who was driving Mat of "The Detectives" (Robert Taylor) out of his mind is in reality his wife, Ursula.

Somehow the script writers added reporter Ursula to the series — and she is a first class worry wart, and very cynical person. She makes you think the detectives always hold back on a story they aren't ready to break which she should have for her paper.

According to the programs we've watched, she's a terror and probably is very discouraging to would-be reporters.

We think we'll settle for the old movie stereotype of the reporter, which everyone always thought was pretty terrible, but at least it included more idiosyncrasies than pure distortions. According to the movies, we are dashing, caffeine crazy cigarette fiends and we always get our story.

And we always put "30" at the ends of our stories. To defend ourselves, not all of those in this little fourth estate (we were important enough to add after the nobles, clergy, commoners . . .) smoke and occasionally one finds one who refrains from the practice of gulping coffee down between stories.

Personally, we never used "30" to end a story except a couple of times in journalism school. Then we learned the real art was to make a scribble mark that remotely resembles a number sign.

Policy As To Islands

COPYRIGHT, 1960, KING FEATURES SYNDICATE, INC. Senator John Kennedy has an excellent memory and quotes widely. Also in the Third Debate, he came well-stocked with all sorts of documents. He quoted Republicans but not Democrats. He said nothing of the attitude of President Truman on the subject of Matsu and Quemoy. President Truman is out campaigning for Senator Kennedy and has told anybody who votes for Nixon to go to hell, which shocked not a few Baptists who avoid such language as a matter of religious preference, of course. President Truman employs the language of his preference, and has a time doing it.

President Eisenhower in September 1958 had said that the United States would take over the Red Chinese invasion of Matsu and Quemoy; that the United States would defend the principle that aggressive force must be repelled. This has been American policy throughout the controversy over these islands both in the Truman and Eisenhower Administrations. In fact, it is the essence of what has come to be known as the Truman Doctrine of Containment.

Harry Truman on September 14, 1958, in a newspaper article, said: "The probing tactics of the Chinese Communists over Quemoy and Matsu are part of a reckless campaign to determine whether they can get full support of the Kremlin and whether we will stand up to their use of force to take over Quemoy, Matsu and Formosa (Taiwan)." The mission of American forces in the area was purely defensive—"to prevent any mad adventure which could set off a 3d world war" — and posed "no threat to the Chinese people or any other people." Until "there is absolute assurance that the Communists have abandoned their aim of territorial expansion, I cannot see that we have any other choice but to meet them and thwart them at every point where it is necessary. It would be folly and dangerous for us to abandon Formosa to the Communists as long as they are aggression-minded. Formosa could be the launching point for Communist assaults on the Philippines, Korea and Japan."

"I do not go along with some of our leaders — including some of my own party — as to the extent of our interests or concern in Quemoy and Matsu. They miss the main point: This is not a situation created by anyone but the Chinese Communists, who are attempting by force to achieve what should be decided by talks and negotiations. . . . The situation in Quemoy and Matsu cannot be isolated into a local issue. . . ." (Quoted from "Facts on File.")

This is an altogether correct statement of the case. The facts are right; the evaluation is right. It is with this position that Senator Kennedy quarrels. Senator Kennedy also quotes John Foster Dulles but not accurately. Dulles's position was made clear on September 4, 1958, when he said: "(2) The United States is bound by treaty to help to defend Taiwan from armed attack, and the President is authorized by joint resolution of Congress to employ the armed forces of the United States for the securing and protecting of related positions such as Quemoy and Matsu."

"(3) Any attempt on the part of the Chinese Communists to seize these positions or any of them would be a crude violation of the principles upon which world order is based, namely, that no country should use armed force to seize new territory."

It is not understandable why Senator Kennedy picks this particular moment in world affairs to telegraph his punches to the Red Chinese. They will unquestionably take every advantage of such a situation. Unless Senator Kennedy states his case conservatively, there is real danger that should Senator Kennedy become President, the Chinese Communists will take immediate action on Matsu and Quemoy, just as after Dean Acheson stated that we would not defend Korea, the Chinese Communists marched on Korea. 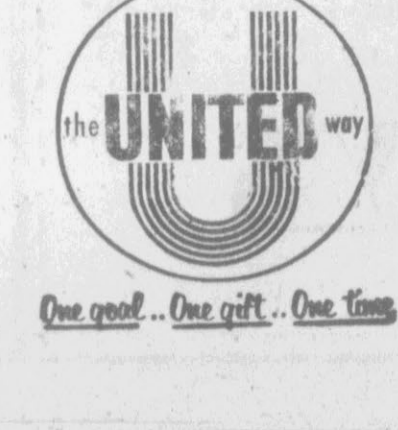
Strength For Today

LEARNING TO READ
Are you worried over the fact that modern educational methods very often bring children to the teen age without being able to read properly or to spell? Most of us are. The flurry of retail promotion this Christmas season is likely to be one of the greatest ever. Retail sales are not gaining; as the striped-pants economists would say, they are moving sideways. Specifically, total retail sales in September were about 17,844,000, about 1 per cent under the August total but about 1 per cent above September, 1959. Department store sales in the four weeks ended October 8 were 1 per cent above the comparable 1959 figure, about half the average gain so far this year. Boys, that's sideways!

Under these conditions, the American retailer, one of the most ingenious businessmen in the world, can be counted upon to work gimmicks and stunts to the limit, since the last two months offer the richest opportunities to register gains for the year. LOOK AROUND YOU! You may have noticed the start of these in your own shopping area—new kinds of sales, extra trading stamps, contests,

drawings, premiums and shows.

Many merchants will be dipping into "The Backbone of Retailing," by Jane Cahill, published earlier this year by Fairchild. It's \$6.50 for 99 pages which, although not a record, is way up there. However, 48 of the pages are a compilation of successful promotional ideas used by other retailers, and one swipe may be worth the price of the book to a retailer.

Typical of the ideas are these: A California store owner bought 5,000 silver jingle bells for \$25 and tied one on each Christmas gift package.

When a customer has not charged a purchase in a month, a Minnesota store sends a bill inscribed: "You do not owe us a penny. We wish you did." A Wisconsin store holds a "magic quarter" sale twice a year. A customer buying one sale item can buy another for a quarter.

A Michigan store gave customers \$1,000 worth of play money with each \$1 purchase, and then auctioned a number of special items for bids in the

puts names in paper. A Virginia store prints the names of 100 customers in a newspaper advertisement each week. Each person listed is entitled to a 10 per cent discount on all purchases in the following week.

A Pennsylvania store mounts wheels of fortunes near cash registers during special sales. Each wheel has numbers ranging from 10 to 50. After a customer makes a purchase, she spins the wheel and the number coming up shows the discount she gets.

An Iowa store claims to be the first to give 5 per cent of its gross receipts to churches named by the customers.

Ardmore, Pa., merchants put 60 \$1 bills in circulation, then printed the serial numbers in newspaper ads, offering \$100 for one, \$50 for another, \$25 for two more, \$10 for four others and \$5 each for the rest. A New Jersey store put on a "dog show" offering slow moving merchandise at special low

prices. "Dogs" that were not sold by the end of the sale were given away with each \$25 purchase. One customer got a \$150 designer original free.

There are many more ideas. And in the next two months you will see everyone of them outdone by even more ingenious schemes by imaginative merchants.

The public may confuse "love" and "dove," thinks the Trade Mark Trial and Appeal Board of the Patent Office.

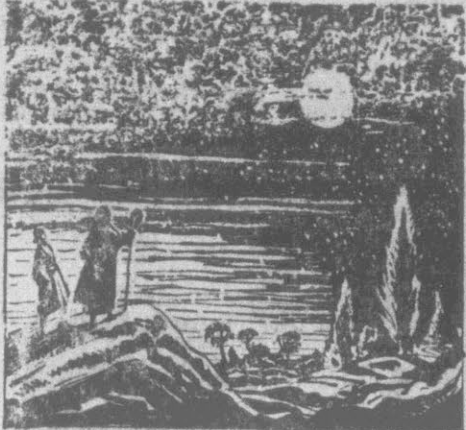

Pirate Treasure Hunt Continues Tomorrow Night

You might say the people down in Newberry, S. C. don't carry much respect for East Carolina College football. "Oh, it's just another one of Lenoir Rhyne's patsies", quips the average man on the street.
Even Einstein missed occasionally with a hypothesis and Coach Jack Boone's boys, the East Carolina Pirates, consider themselves in a position to destroy the Newberry formula and revolutionize the Indian's attitude.
To put it briefly, undefeated East Carolina tacksles stubborn Newberry in College Stadium tomorrow night. Starting time for the expected rock-and-sock hair-raiser is 8:00.
Reason for little concern by Newberry fans has been three one-sided football games all going in favor of Coach Harvey Kirkland's Indians.
Beating the war drums and racing with a certain "beat", Newberry shocked East Carolina in 1957, 20-7. Each year since it has been a little worse.
In 1958, the Indians danced to the tune of 28-6 and last fall it was 34-7. Heaven forbid a continuation of the trend.
Since engaging East Carolina, Newberry has

always drifted into this game with a record unsatisfactory to the school janitor. This fall it's no different. They have a 2-3 mark.
Yet, Kirkland is noted for molding a winning squad and few years since he came there in 1952 has he been below a 500 mark. And the early season competition isn't the type to sneer.
To date, Newberry holds a 34-8 win over Troy and a 42-6 bashing of Catawba. They have fallen to mighty Lenoir Rhyne (34-12), arch-rival Wofford (14-13), and The Citadel (19-0) of the Southern Conference.
Newberry gifted with one of the finest backfields in North and South Carolina, comes into the game as a slight favorite over 20th ranked East Carolina (among small colleges).
Richard Seastrunk is a name that rings a bell to ECC footballers as Thomas Jefferson does to the social study major.
The bullish fullback, with legs that churn like a machine, scored three touchdowns last fall and knifed ECC's line for 102 yards rushing.
He is joined by Jimmy Lowder, who can run a close foot race with Glenn Bass and Sonny Baysinger, Carl Harris and Bill Deter. It is a backfield blessed with speed, power, and talent.

The Indian line is made up of not-so-weak second unit men of 1959. Kirkland suffered a loss in his front forces last fall but after five games, no glaring weakness is present.
East Carolina may be conformed to rationalize that Newberry's line can't be as brutal as Western Carolina's. But the backfield may be a little more explosive.
Forced to the unfamiliar role of a conservative relying on defense, Coach Jack Boone may retaliate this week like the retreating general receiving a cargo load of replacements.
Boone has his backfield aces ready to sail . . . and sail they may. While Glenn Bass is the boy worrying most of ECC's opposition, Sonny Baysinger has been having a field day.
Little Sonny, who racks with the power of Thor's hammer, has joined "reserve delux" half-back Mac Thacker in claiming backfield hero honors in the past two tests. Both are ready for the pasture tomorrow night.
Bass, the senior speedster, is expected to be recovered from his ailment of the past two weeks. Tommy Matthews is also back for full-time duty if needed.
Billy Strickland and David Rogers may divide fullback honors tomorrow. Nick Hilgert,

the pride of Elizabeth City since Mike McCee bowed from the college ranks, has been shooed with an injury for the major part of practice this week.
Little need be said for East Carolina's line. They have dished out touchdowns about as hesitantly as a three-year-old departing with his last two toys.
Clayton Phland, a tackle, and Chuck Gordon, center, can write their own ticket to post-season honors. Wayne Davis, a guard, could also come up with more than newspaper clippings with more team success.
Henry Kwiatkowski, Vernon Davis, Bob Gregson also figure in the "last word" of the interior linemen. Bobby Bumgardner and Jones Lockerman have more than lived up to expectations on the ends.
Quarterback was an early season worry but this seems to be improving. Bert Stafford, always a running threat, is gaining confidence and soph Dan Rouse has picked up some needed experience.
Word of the pronosticators say stick with Newberry. On paper, the Bucs have a 50-50 chance. But only time and the bounce of the ball will tell the tale.

Another big football weekend is in store for residents of the Pitt County and Greenville area, featuring four unbeaten teams.
Greenville's Phantoms travel to New Bern tonight for an important battle with an undefeated Bruin team. The locals, led by halfback Alan McArthur, will be out to gain their sixth win against a lone Northeastern Conference loss. Game time is set for 8 p.m.
Ayden, leader of the Coastal Conference with a perfect 7-0 record, hosts seventh place Contention tonight on the Ayden field. Heavy favorites over the visitors, Ayden will look to the explosive running of fullback Dennis Mills for their offensive attack. The 170 pounder has established himself as one of the better backs in the conference.
The Rams of Robersonville will furnish the competition for another unbeaten eleven, Beaufort High. The Rams will be out to be the first team to push across the Sea Dog goal line which hasn't been done by any of Beaufort's opponents so far this season. Leading the host of swift Ram backs is Tommy Ward, a combination runner-passer tailback in Coach Bob Lee's single wing offense.
Eppes High goes after its seventh straight win without a defeat when the Bulldogs host Darden High School of Wilson. It will be the locals' homecoming game, and a large crowd is expected.
Another homecoming battle shows Farmville welcoming its alumni as the Red Devils tangle with last place Vanceboro. The Red Devils, along with the crowning of the homecoming queen, will also be out to crown Vanceboro with its sixth straight Coastal Conference defeat.
In a Saturday night battle, undefeated East Carolina goes after its sixth consecutive win, hosting a strong Newberry club from South Carolina. The visiting Indians have locked horns with the Pirates on three occasions and have come out on top each time. Coach Jack Boone of EC has his Bucs fired up to remedy a repeat performance by the visitors. The Pirates are enjoying the top spot in the North State Conference standings at present with a 4-0 conference mark.

Unstable Tigers Seek Manager

DETROIT (AP) — A return to stability instead of continued upheavals is the Detroit Tigers' aim now that their front office rift has been settled with the departure of Bill DeWitt as president. DeWitt resigned Thursday in an anticipated move and new owner John E. Fetzer established himself in a one-man command. The departing president spurned Fetzer's offer to become assistant to the president.
Fetzer promised to end the changes that have brought a rotation of Tiger presidents, general managers and field bosses since 1952. The new Tiger president — fourth in five years — said he wants to halt the "new-manager-every-year policy" that has turned the once-stable Detroit franchise into a "who's running us now?" outfit.
Whoever Fetzer selects to pilot the 1961 Tigers will be the eighth manager in 10 seasons. He has appointed the former general manager, Rick Ferrell, as his emissary to screen prospective pilots.
The Tiger managerial job was vacated when Joe Gordon quit Oct. 2 to become pilot at Kansas City. Gordon had held the job only two months, coming from Cleveland in the DeWitt-engineered managerial deal for Jimmie Dykes.
Gordon's sudden departure after signing a Detroit contract for 1961 caught DeWitt unaware. The ex-manager blamed DeWitt with "front office interference," the same charge made by Dykes after he left Detroit.
The resignation of Gordon put DeWitt on the hot seat. His fate apparently was sealed last week when Fetzer purchased additional stock to gain control.
It cost the Tiger owners a healthy sum to heal their front office wounds. DeWitt had completed just less than a year on a three-year contract that paid him \$50,000 annually. The club said an "amicable settlement" had been reached with DeWitt.
But reports persisted that DeWitt received at least one year's pay and possibly the entire \$100,000 due in his contract.

The dippy-doodle college football season hits the halfway point Friday with Iowa and Mississippi the nation's two top teams, wondering if Lady Luck will continue to smile upon them.

The same thing is probably running through the minds of the other unbeaten teams including five in the latest Associated Press top ten after the beating "form" has taken so far.

The Big Ten, with Iowa (3-0) at the top, and 4-0 overall, continues to lead the "who's it gonna be this time" parade. The Hawks meet 10th ranked Purdue while Minnesota, ranked sixth with a 4-0 mark and a 2-0 conference record takes on Michigan in the Big Ten Little Brown Jug game.

Then ninth ranked Ohio State, victor of Purdue last week, meets Wisconsin, which fell in the final minute to the Hawkeys.

Mississippi (5-0) goes into the Southwest Conference to play Arkansas (4-1) in a match of power vs. speed. Ole Miss is a 10-point favorite to beat the Razorbacks, who upset Texas 24-23 last week.

Third-ranked Syracuse tries to get back the prestige it frittered away in winning its first four when it meets winless West Virginia.

More Passing Is Sought By Turf Spectators

A frequent criticism of college football is that the teams should open up their offense and pass more—as the professional teams do—and make the game more interesting for the customers.

The Atlantic Coast Conference's answer to this will be seen in Winston-Salem, N.C., Saturday night when Wake Forest faces Maryland.

If the spectators want passing, they'll get it. Each team has a top-notch passer. It'll be Wake Forest's Norman Sneed against Maryland's Dale Betty. Both have been singled out for All-American mention by the regional Associated Press board.

Last week, Betty directed the Terps to a 19-17 upset of Clemson, hitting 12 of 16 passes for 151 yards and two touchdowns.

Sneed tossed a 15-yard touchdown pass with a little more than two minutes left to play to lead the Deacons to a 13-12 victory over North Carolina. He was off target for most of the game, however, and completed only 3 of 13 passes. However, his touchdown strike gave him a conference record, a career total of 20 touchdowns.

Wake Forest is fourth in the ACC standings with a 1-1 record, and is 1-3 over-all. Maryland has a 1-2 conference record and is 2-3 in all games.

Three ACC games are scheduled this weekend, and two non-conference clashes are on tap. League-leading Duke, 3-0 in the ACC and 3-1 over-all, entertains Clemson (2-1 and 3-1); North Carolina (0-2 and 1-3) plays at South Carolina (0-1 and 0-3); Virginia (0-2 and 0-4) takes on Virginia Tech of the Southern Conference at Roanoke, Va., and North Carolina State (3-1 and 4-1) has a non-conference engagement with Mississippi Southern at Hattiesburg, Miss., Saturday night.

A year ago, Houk rejected an offer to manage the Kansas City Athletics. The job went to Bob Elliott, who was dismissed at the end of the past season when the club finished last.

During the past World Series, when the Detroit Tigers expressed an interest in him after Joe Gordon suddenly quit the club, Houk said: "I'm willing to listen to any

offer. After all, I'm getting older and I've got to look ahead. I've got a family to think about."

Houk's family consists of his wife, Bette; daughter, Donna 18; and two sons, Dick 17 and Bobby 11. A native of Lawrence, Kan., he now makes his home in Saddle River, N.J.

Another Honor For 'Thumper'

NEW YORK (AP) — Ted Williams, who bowed out of baseball this season after an illustrious career, had another accolade added to his imposing list today. He was named the American League comeback player of the year for 1960.

Williams was a decisive choice in the annual Associated Press poll of baseball writers. The Boston Red Sox outfielder received 96 of the 182 ballots cast. Runner-up was Roy Sievers of the Chicago White Sox with 34 votes.

Tempestuous Ted, who broke into the majors in 1939 and served two stints in the armed forces, finished with a flourish at the age of 42. In his final at bat on Sept. 28 he bade baseball farewell with the 521st home run of his career.

Beaten by shoulder and neck pains, Williams' average plummeted to .254 last year. He had only 272 official at bats and produced just 10 home runs. This past season Williams batted .316 and hit 29 homers in 310 official trips.


In 1959 with the Senators Sievers batted .242, hit 21 homers and drove in 49 runs. This past season traded to Chicago Roy took over the regular first base job from Ted Kluszewski and hit .295. He accounted for 28 home runs and 93 RBI.

Al Smith of the White Sox ranked third in the comeback voting and drew 22 ballots. A .237 hitter in 1959, he had a .315 average this past season — second highest in the American League.

Arabs Protest Aerial Dogfight

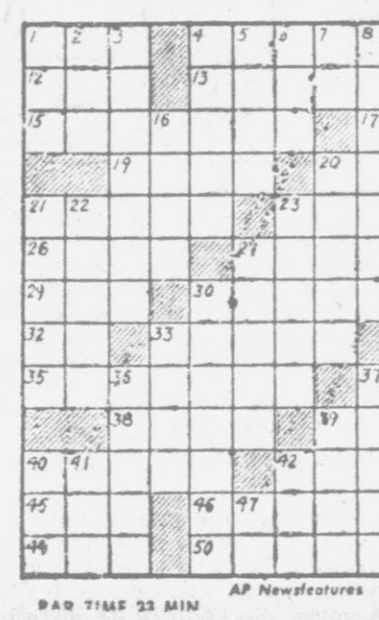

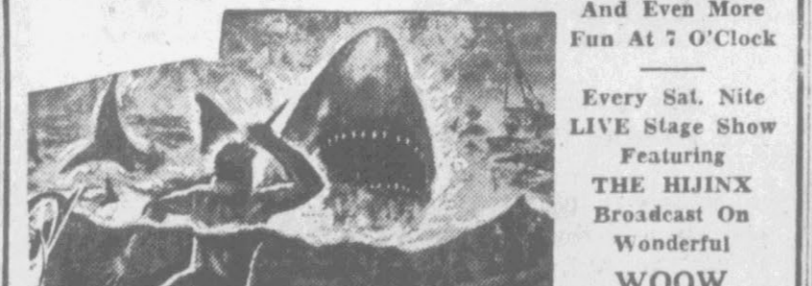

Farmers May Be Eligible For Emergency Loans

Pitt County farmers who suffered losses due to Hurricane "Donna" may be eligible for Production Emergency loans at three per cent interest, Ben H. White, supervisor of the Pitt Farmers Home Administration, announced today.

White said loans may be made for the purchase of feed, seed, fertilizer, replacement of equipment and livestock for other essential farm and home operation expenses, and for the replacement or repair of buildings, fences and drainage on farms hit by Donna's savage blast.

The supervisor pointed out, however, "loans may not be made for refinancing existing debts or to compensate farmers for other losses."
