### Juvenile Delinquency Talk Is Given To Pickwick Book Club

Juvenile Delinquency in North Carolina was the topic spoken on by James Harvey Ward, Jr. at the Tuesday meeting of the Pickwick Book Club. Mrs. Ward was club hostess at her home in Columbia.

Ward, teacher at the East Carolina Training School for boys, stated that although the juvenile delinquency problem had risen 50 percent in the nation in the past five to 10 years the overall percentage in North Carolina was considerably less.

There are six training schools in North Carolina with approximate-

ly 1,315 students. These schools accept boys under 18 who are mentally and physically capable of benefiting from the program. The required time of training for each boy is at least 12 months depending on behavior. The schools are run on an honor system and a new enrollee has been explained so, he will understand what will be expected of him.

The training school in Rocky Mount operates a large farm and affords other various opportunities for work skills through the dairy, industrial arts and maintenance shops. Mr. Ward distributed pictures showing the school and grounds.

The main causes of delinquency, according to Mr. Ward, are a poor family situation, low income, and low mentality. In closing Mr. Ward stressed the importance of a good family life by reading 12 rules for parents compiled by experts.

Mrs. Harry Allen, President welcomed Mrs. Hal Waddell, guest, and conducted a short business meeting. Mrs. Ward then served Russian tea, lemon cake and nuts.

After the distribution of books, the meeting was adjourned.

# Renewing The Development Effort

It is time for Eastern North Carolina to renew its effort to establish some sort of overall development organization to tie together more closely the efforts of various county and community groups working for economic development of the area.

A few years ago at the suggestion of the Department of Conservation and Development an effort in this direction was made in Eastern North Carolina. There were a few meetings at which representatives of a number of counties tried to effect an organization. In time, however, the meetings ceased and the efforts were dropped.

Since then the number of community and county development groups of the area have increased. They have likewise broadened their viewpoints in many respects and have learned more about this major problem of creating new jobs and boosting the economy of their respective areas.

From the standpoint of the section as a whole, however, there is much that can be done in the way of economic progress that is not now practical for one community or one county alone. Particularly in the field of agriculture efforts to establish markets for new crops often depend on more production of a particular crop than can practically be expected in the vicinity around one community or in an entire county for that matter. If several counties were brought together in such an undertaking it might prove practical.

This is just one example of the kind of work that might be undertaken on an area or regional basis.

Benefits would be derived from the discussion of mutual problems by community and county development groups. Each could learn to do a better job by exchanging ideas with the other, and collectively the group probably could boost the overall effort that is being put forth in Eastern Carolina toward economic development.

It is true that as individual communities and counties of the section make economic progress the section as a whole progresses. It is also true that progress of the section as a whole is reflected in the progress of the individual communities and counties.

The development effort in the Eastern section of the state has reached the point, we believe, where closer cooperation and coordination between various development groups can enhance the efforts of all. It would be in the interest of the area as a whole, as well as in the interest of the counties and communities individually, to try again to effect a sectional organization of development groups.

## Neither Offer A Fresh Idea

WASHINGTON (AP)—For one hour last night the presidential candidates debated foreign policy on TV with neither producing a new idea on the No. 1 foreign policy problem: How to deal with Soviet Premier Khrushchev.

They argued on who's tough, what each said or didn't say about Quemoy and Matsu, how to cope with Fidel Castro, aid for backward countries, and the need for big defense. They even talked about a summit meeting with the Russians.

America's basic policy in handling international communism has been big defense, military alliances, and aid for countries which need and accept it to keep them out of communism.

That was the Truman policy from the start of the Korean War. It has been the Eisenhower policy every since. In all their discussions Vice President Richard M. Nixon and Sen. John F. Kennedy have made no basic addition to it.

What they are really arguing is not some new policy, but which of them can handle the old one better. What they have said so far in essence is: More of the same but bigger.

They have been discussing details of the basic policy although in the end the way those details are handled—for instance, the size and excellence of our defense—may mean the difference between survival and submission.

Therefore, what the voters have to decide is which of these two men, Nixon or Kennedy, can be trusted to carry out the already established policy better by new or better programs to enforce it or enlarge it.

So last night the candidates on TV were doing a selling job, each offering the same product in different wrappings.

The Nixon-Kennedy disputes on foreign policy are in a sense an

echo in reverse of the 1952 presidential race between Dwight D. Eisenhower and Adlai Stevenson. But the very echo shows how acute the problem has become.

Eisenhower then, as Kennedy is urging now, called for building up American retaliatory strength.

And Stevenson was saying stronger measures were needed to protect American cities from growing Soviet airpower.

That was only eight years ago yet in that time the peril of the contest with Communism, and almost its very nature, have increased so enormously that it is almost as if the world had moved ahead from bows and arrows to cannon.

American and Soviet airpower—bombers—was the thing to worry about then for both nations.

In the intervening eight years airplanes have slid into the background and the giants are talking about the power of their intercontinental missiles.

## Other Editors Saying . . . Drunk Tests Would Help

(The Raleigh Times)

Those little "filler" paragraphs in the newspapers present information on the widest possible range of subjects. One in the paper this week was:

"Michigan is the 33rd state to legalize blood tests for drunken driving."

That's good news for the people of Michigan who want safer highways. It means that people who are arrested in Michigan for drunken driving will be given blood tests which will show in an impartial and scientific manner whether they were drunk or whether they weren't.

If they weren't drunk, the test will protect them. If they were drunk, the test will make it possible to convict them, punish them, and thus warn others that they'd better not drink and then drive.

North Carolina needs a law providing for such a test. It has needed such a law for a long, long time, and there is no real reason why we shouldn't have had such a law. State Motor Vehicle Department experts have asked the legislature to enact it. So have Raleigh Police Department officials. So have other safety experts. Just why the legislature has refused to pass it isn't clear to a lot of people who remember that at times good safety legislation has drawn the fire of some lawyers in the legislature.

A real drunk driving test would serve the cause of overall respect for our courts, as well as serving the cause of highway safety. Under our present drunk driving laws, the public has to see case after case

in which people charged with drunken driving are acquitted because it is impossible to prove beyond the law's reasonable doubt that they actually were drunk.

In many such cases, it would seem certain that the judge was sure in his own mind that the defendant was actually drunk, just as the police officers testified. Yet, that judge had had to hear sworn testimony from the defendant and from the defendant's friends that he wasn't drunk. Maybe that was honest opinion for the defense, and maybe it was just plain perjury, but it was said under oath and there would be no way for the judge to prove that it was perjury.

On the other hand, if there were a scientific test for drunken driving, the judge would have the result of that test before him. The defendant could testify until he was blue in the face that he wasn't drunk, and yet the test results would be there to contradict his testimony. His friends could perjure themselves to their hearts' content, and yet the test would be there.

The fact that the courts can't now convict many plainly guilty drunken drivers because of these conflicts in "opinion" testimony has lessened public respect for the courts, without the courts being able to do anything about it.

A drunken driving test would give the courts a break, as well as serving the cause of highway safety.

The next legislature should enact such a law.

Monday is United Nations Day. Every citizen should be mindful during the special day of what the UN means to America and the world.

# Shaking Up The Dept.

COPYRIGHT, 1960, King FEATURES SYNDICATE, INC. The State Department obviously needs reorganization. Its system of indirect policy-making at low levels has resulted in too many significant errors, particularly as regards China, Indonesia, Cuba, and the Congo.

The lower levels consist of deskmen who are presumed to be experts and they probably are expert. In a word, they are technicians. The essential difference between a technician and a guiding personality is that the latter adds to technical knowledge, experience, wisdom, imagination, flair.

Those who represent the State Department to the public and to Congress, that is, the Secretary of State and the Under Secretaries, are often not as technically informed as the assistant secretaries and the deskmen, but they are responsible for policy. When policy is made at the lower levels, the decisions are bound to be troublesome because they are often not correlated with other policies of government and sometimes represent the private and biased views of immature deskmen.

Many competent men have, at various times, suggested a reorganization of the State Department. The most serious effort to be made in recent years was when Herbert Hoover, Jr., was Under Secretary, but he found himself in difficulties because of civil service arrangements which amount to tenure. This makes it very difficult to get rid of useless, incompetent or even disturbing personnel.

Former Governor Averell Harriman has now come up with an interesting suggestion. He would give status to the men in charge of the regional divisions. Let me put it in his words:

"I propose that the status of the men in charge of the five regional divisions of the State Department be elevated to attract men of outstanding position and experience. The title might be 'Secretary for Africa,' for example. These Secretaries for the five regions plus the Ambassador to the United Nations and the Under Secretaries should become the Senior Cabinet of the Secretary of State.

The success of this proposal would depend on the stature of the first group of men who were selected for these Secretaryships. They should be men with the capacity and qualifications of the Secretaryship of State itself. After all, our problems in each of the five areas today are greater than the entire problems which a Secretary of State faced just a generation ago."

This is a workable suggestion if a President can find the right men to serve. My special experience is with the Far East. The last man to look after Far Eastern affairs in the State Department was Dr. Stanley Hornbeck who left the Department in 1944. Since then, with the exception of Walter Robertson, only technicians have served.

Most of the confusion over Far Eastern policy has developed because no one in the State Department for decades recognized the East of Asia as a whole. The weakness in Harriman's proposal is his division by continents. Asia, for instance, politically is not one but several areas, and to put a man of stature over the technicians in each area would be very sound. It would not only strengthen the Department, it would help the President in formulating and presenting policy.

Harriman says: "The Secretary for Africa should visit each country during the course of the year and represent the President to the governments as a Special Ambassador. He would see to it that the problems arising in each country got top level attention."

Woolrow Wilson used Colonel House for this very purpose. Franklin D. Roosevelt made Norman Davis a roving ambassador. But a roving ambassador does not have the status that a "Secretary for Europe" would have. Henry Cabot Lodge, as our Ambassador to the United Nations, elevated that post to exactly the position that Governor Harriman has in mind. He went even further; he sat in

B. A. presidential candidates are proposing to solve our surplus grain problem by sending more abroad.

Essentially that must be the ultimate solution. Under our present fantastic farm program, farmers keep on producing greater and greater quantities of grain. There aren't warehouses enough in many sections of the country.

This year, estimated production of bread grains is 3.4 billion bushels, almost 250,000,000 bushels above last year.

Americans can use only a part of it. Even if enough were turned into bread to feed the pangs of the 175,000,000 Americans who go to bed hungry every night, there would be a whopping amount left over. And we have a choice of exporting it or letting it rot. So exporting it seems like an excellent idea.

WORLD'S SECOND BIGGEST CROP But there are few places to export it to, and other countries

have their eyes on these places.

The world's crop of wheat and other short year will be about 291,000,000 short tons, according to preliminary estimates of the U.S. Foreign Agricultural Service.

While this is a per cent below the all-time high record of 1958, it is still larger than the 1959 crop.

The figures are preliminary, because nations in the Southern Hemisphere have only recently completed seeding and definite prospects cannot be determined until December.

Not all nations share this year's increase. The wheat harvest over much of Europe remained the quality of grain in many countries. High moisture and sprouting makes much of the grain suitable only for animal consumption.

Italy and Spain are on an import basis, and the poor crop in France means a smaller surplus to export. But West Germany and Britain report larger crops than last year.

Russia's wheat crop is larger than in 1959, but considerably less than the record 1958 crop, the government agency reports without the use of a U-2. "Acreage is the smallest since 1955, mainly because of the heavy winterkill. Sizeable areas of winter wheat were replanted to other grains and this loss of winter wheat acreage more than offset a reported expansion of the spring wheat acreage," reports the Foreign Agricultural Service.

Soviet rye production is also reported less than last year. Asia's wheat production is said to be ahead of last year, with the harvests in mainland China and in Turkey, India and Pakistan report harvests as big as last year, and Japan's estimate of 56 billion bushels is a near record. African wheat production is about level with 1959.

South American wheat, still in the sprouting stage, may be a little less than last year, but Australia expects a larger crop.

When, then will the victorious politicians export our sur-

plus? Some of the few countries that do not grow their own bread grains. Some to such countries as India where even bumper crops are not enough. And the rest?

We'll probably store it in warehouses until it rots, with both the cost of storing and the loss by rotting coming out of your taxes, Buster.

NEW BERN — To the home fans it was a whooper of an upset, but the Greenville Phantoms took their 13-7 victory over previously unbeaten New Bern in stride last night, keeping an alert eye toward the conference title.

Greenville mustered only two serious scoring drives but collected the pay-off on each while squelching all of New Bern's scoring threats with the exception of one. And there were questions as to how legitimate

Coach Bud Phillips, who was a little disturbed over several inopportune penalties called against his club, summed it up as another "team effort." When pinpointed to name individuals, Phillips pointed the figure toward Larry Roberts, his aggressive tackle, and Skip Wright, an end who comes through with the big plays.

It was hard to single out the backfield standout, McArthur, headed for post-season honors, scoring the final touchdown and passing for the first. Wayne Sumrell came up with the needed yardage for first downs and his 40 yard run in the third period brought the Phantoms out of the hole.

John Adams scored the first touchdown and helped set up the second. Erskine Duff's passing was also a factor in the contest, leading to the first score.

Greenville jumped in hot water early when gambling on their 38, a fourth down plunge

by Sumrell failed, giving New Bern ball possession.

Ronald Wallace and Cliffie Rowe knifed the center of Greenville's line in big slices, moving to the Phantoms' nine. A 16 yard off-tackle sweep by Rowe was the big ground-gainer in the drive.

On the nine, the Phantoms took a deep breath, buckled their belts and issued yardage like it was K-Rations.

Greenville held and gained ball control on its six. Sumrell, Adams, and McArthur combined to pick up a couple of first downs but a Duff pass was intercepted by Norman Swindell on the Phant 39. This time, the Bruins could thrust no further than the 33.

Late in the second period, Greenville opened up with its aerial attack, setting up its first touchdown.

McArthur opened the attack with an 18 yard run and it was the fleet junior who closed out the march on a seven yard scoring pass to running mate John Adams.

Sandwiched between McArthur's offensive outbursts were a couple of ground consuming passes by Erskine Duff to Layne Jorgensen. The first one covered 31 yards and the second was good for 19 more.

When Adams grabbed McArthur's low pitch and Larry Roberts booted the point, it was only 1:17 left on the scoreboard clock in the first half.

Rowe took charge of the Bruins' single-wing command and directed a 60 yard sashay through the airwaves. With the assist of two questionable 15-yard penalties, New Bern was able to gain a 7-7 halftime tie.

Rowe climaxed the drive with a 13 yard pass to Harry MacDonald. Wallace plunged for the point, Greenville had one opportunity for a pass interception on the drive, but instead it was batted away, hoping time would run out.

The third quarter was a nip and tuck affair although New Bern was in striking distance often.

Following the kickoff, the Bruins marched to the Greenville five but with Wallace injured on the series of downs, the New Bern attack stalled.

Sumrell broke loose for a 40 yard run on what Phillips described as the key play of the game. McArthur cracked for 10 more yards but the drive ended when a 15 yard penalty was called. McArthur punted to the New Bern four.

Greenville received its first break in the contest when Erskine Duff intercepted a Rowe pass on the New Bern 29 with 6:25 left in the contest.

McArthur hit his right side of the line for one yard and then skirted left end on a double reverse for 28 yards and the game winning touchdown.

On Roberts' try for the extra point, the snap from center was high, with the conversion being no good.

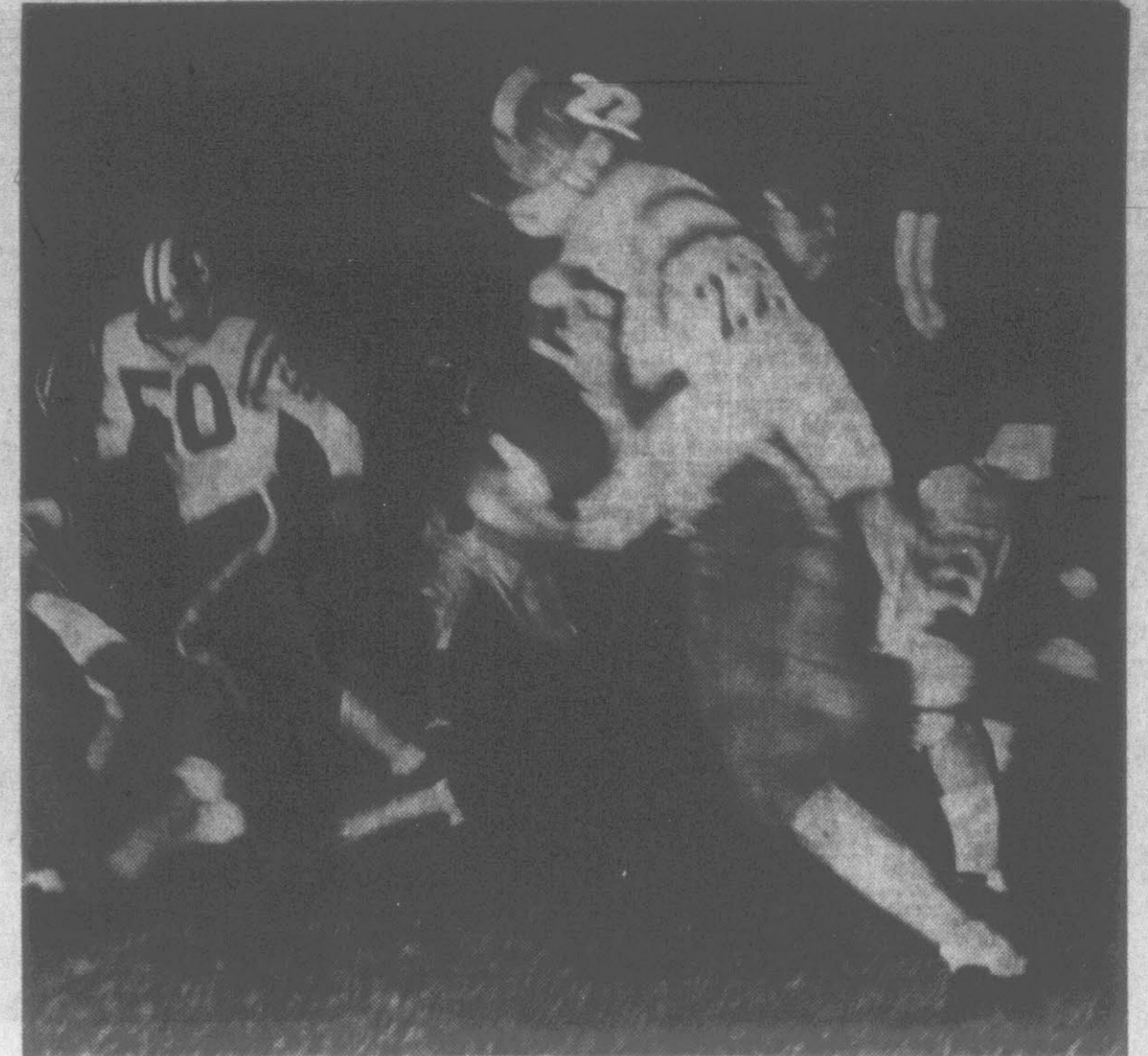
New Bern stormed back for one more last bid on the passing arm of Rowe. Running to his right and passing across field, Rowe found MacDonald open and fired a 43 yard toss.

With the ball on the Phant 18, New Bern again failed to move the ball, with three passes failing incomplete, and Greenville took over.

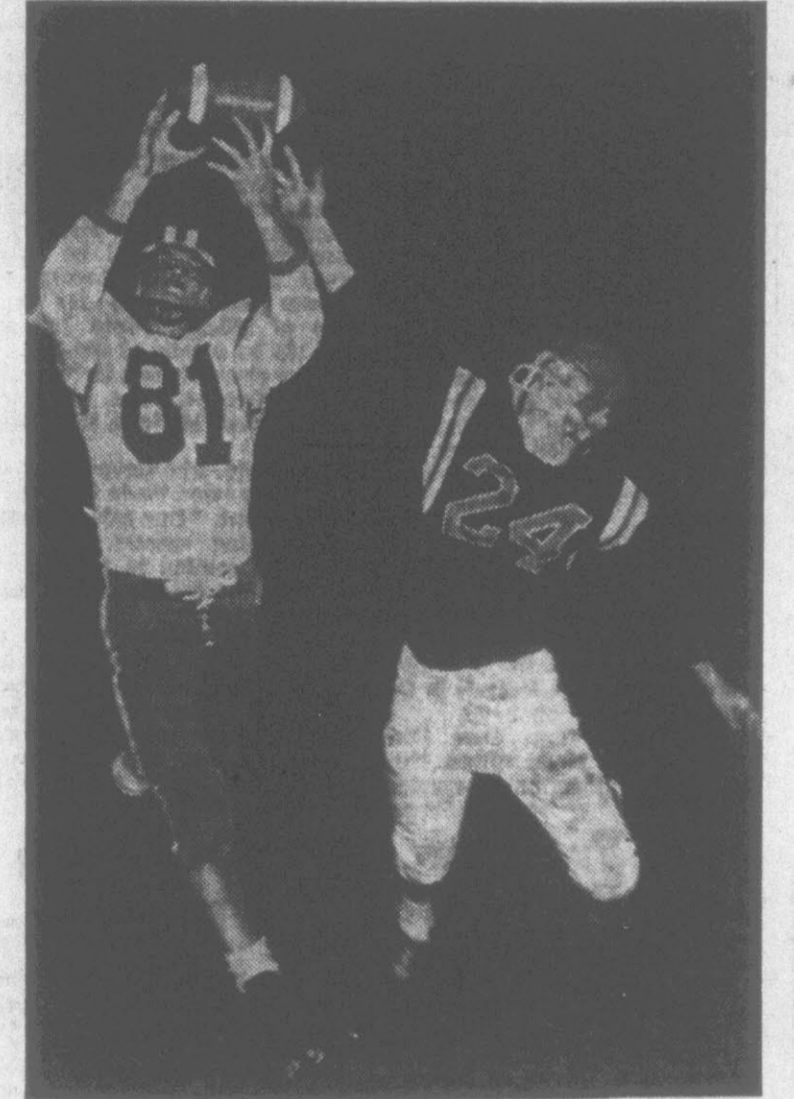
The Phants were able to pick up a couple of first downs and ran out the clock in the final two minutes of play.

The locals scored on their first two plays from scrimmage to give the visitors a sour welcome, but at the same time the returning alumni something to shout about.

Vanceboro took the opening kickoff and were held dead in their tracks at their own 15 yard line. A blocked punt by tackle Mitchell Cannon gave Farmville the ball at that point and on the first play halfback Danny Dilda skirted his end for the necessary yardage and six points. point failed.

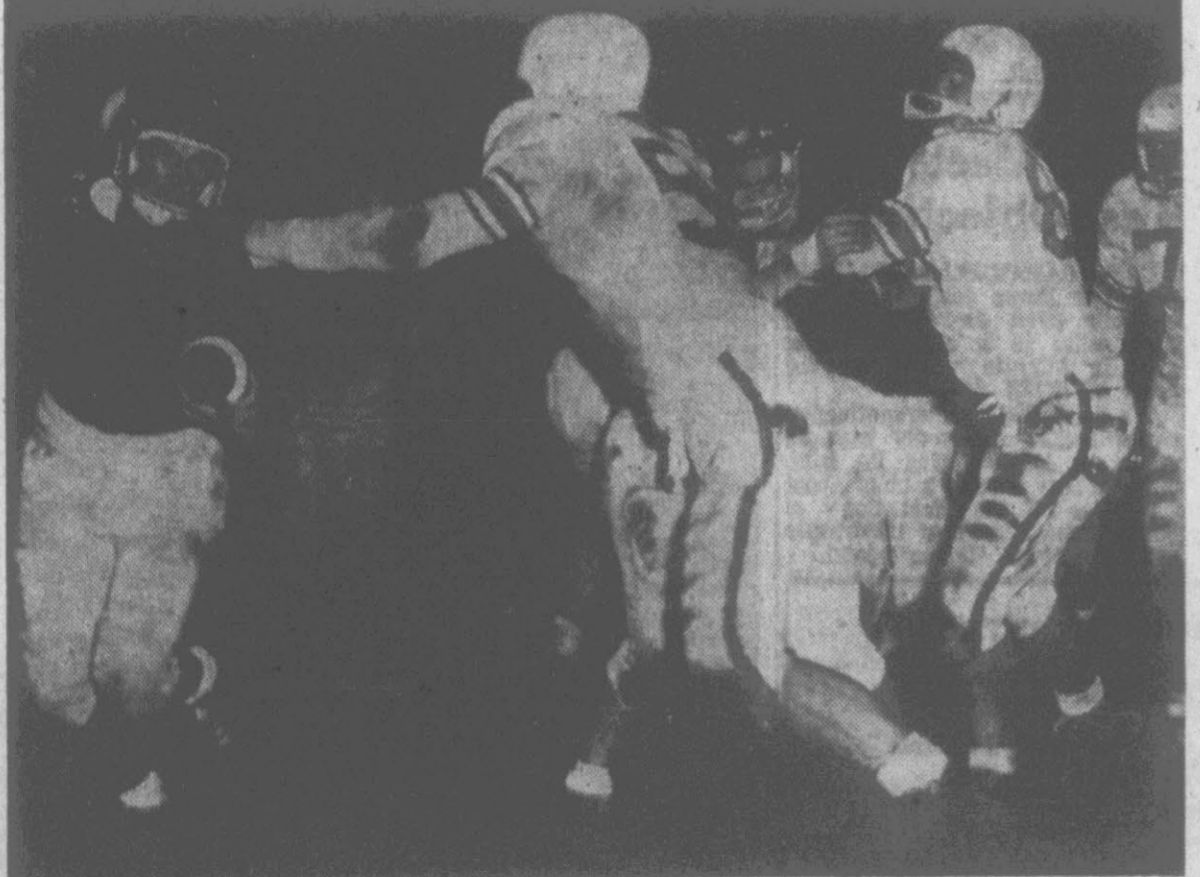

## Bishops' Letter Inspires Protests In Puerto Rico

SAN JUAN, Puerto Rico (AP)—A political storm raged in this U.S. commonwealth today over a pastoral letter by three Roman Catholic bishops telling members of their church not to vote for Gov. Luis Munoz Marin's popular Democratic party in the election Nov. 8.

Munoz Marin, a Catholic seeking reelection on this predominantly Catholic island, declared the bishops' letter an "incredible and unjust intervention in political liberties of Puerto Rican citizens."

The independent newspaper San Juan Star said the bishops have "gravely transgressed against the Catholic Church." It urged that Pope John XXIII transfer them from the island and replace them with "representatives of catholicism who recognize the indispensability of the principle of separation of church and state."

Twenty teachers from the University of Puerto Rico picketed the Roman Catholic Cathedral Friday night with signs protesting the letter. One sign said, "would Kennedy follow his bishop?"

Through his press secretary, Sen. John F. Kennedy, Democratic candidate for president and a Roman Catholic, issued a statement in New York that he "considers it wholly improper" for churchmen of any faith to tell members of their church how to vote.

Puerto Rico's Popular Democratic party which got 65 per cent of the popular vote in 1956 is not affiliated with the mainland Democratic party, which is campaigning for statehood, has connections with the mainland Republican party but Puerto Ricans do not have a vote for president of the United States.

The newly formed Christian Action party, which has been criticized by Munoz Marin as an effort to mix religion and politics, presumably would be the beneficiary of any votes swayed by the pastoral letter.

As published in the independent newspaper El Mundo, the letter declared: "It is our obligation to prohibit Catholics from giving their votes to a party that accepts as its own the morality of 'the regime of liberty' negating Christian morals."

It attacked two laws pushed through by the popular Democrats permitting the teaching of birth control and allowing sterilization to deal with the island's over-population problem. The letter also assailed public tolerance of common-law marriages, and protested defeat of a bill in the legislature to give school children time off for religious instruction.

It was signed by Archbishop James P. Davis of San Juan, Bishop James E. McNamus of Ponce, and Luis Aponte Martinez, titular bishop of Laredo.

El Mundo said the letter was to be read in churches next Sunday.

Archbishop Davis told reporters he thought the letter was non-political. Asked if the church would penalize Catholics who disregarded the letter, he said, "No, it is a matter between a Catholic and his conscience."

## Godfrey Porter Funeral Sunday

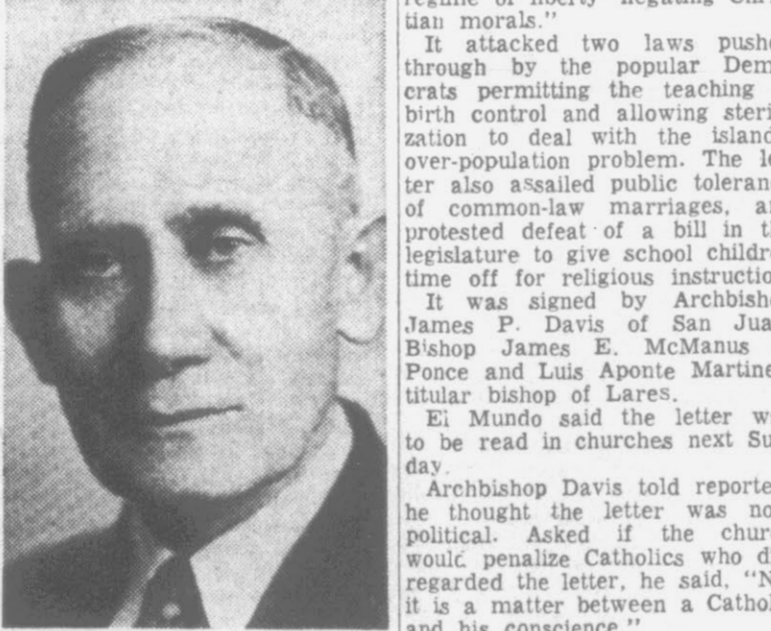

Another son, Dr. Martin Luther King Jr., is among 41 persons held in jail on charges of violating Georgia's 1960 antirape law. The minister and others in the group have indicated they will not attempt to post bond.

## Advices Against Power Politics

WATERBURY, Conn. (AP)—The Rev. Dr. Edwin H. Tuller, general secretary of the 1.6 million-member American Baptist Convention, has urged Baptists "not to venture into the field of power politics."

He told the Connecticut Baptist Convention Friday night it would be improper for Baptist ministers to "use their pulpits as political platforms."

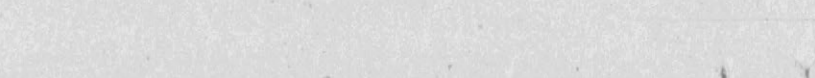

# Women Playing An Increasingly Greater Role In Political Whirl

Since the days that Susan Brownell Anthony campaigned for the first woman suffrage in this country, women have raced forward in increasing numbers to the polls every year.

The first National Woman Suffrage Association, organized by Miss Anthony, came into being in 1869, almost one hundred years ago.

At that time, of course, there were no women voters in the United States.

And now, any politician will tell you that over 50 percent of the registered voters in this country are women. In the last election, over 50 percent of the votes were cast by women. One authority says women voters potentially outnumber men

voters by five million.

In these years of dominantly female population and female voting power, the woman wields a strong voice in government. Banded together, the women can decide the fate of this nation, the outcome of this 1960 election year.

They no longer are sitting at home, content to take voting orders, from their husbands. Women are thinking.

Mrs. J. B. Spilman of Greenville, Democratic vice chairman in Pitt County for 10 years, state vice chairman one year and first woman ever named assistant manager of a gubernatorial campaign, says "Women are beginning to realize their potential in this election and are using it."

She and Mrs. Pierce Sumrell of Ayden, State Democratic executive committee member and precinct vice chairman in Ayden for 10 years, agree that women have more time than men to study and read material, to better acquaint themselves with political events and issues.

Activity on the female election in the current political campaign, on the local, state and national levels, is at an all-time high in Greenville and Pitt County.

The women are manning the political headquarters.

For the first time, a Republican headquarters has opened here in Greenville. About 18 women have volunteered to do office work, assisted by a bevy of young Republicans at the college.

Some of these women have entered political activity for the first time.

The same holds true for women in the Democratic party. Though the veterans are working harder than ever, the new recruits are equally as enthusiastic, also assisted by young Democrats organized at East Carolina College.

All agree that women are interested, more active in this campaign than ever before.

### Why?

Mrs. Virginia Garris says she has been more active this fall because of a desire for a two-party system.

Mrs. Robert Hunt is more active because "I feel very strongly about the future of the country for my children, one of whom will be able to vote in

the next four years."

Mrs. Donna Tabar, co-chairman of Citizens for Gavin, and Mrs. Garris agreed that by having a two-party system everywhere, a better candidate will come to the front. These are some of the comments from women working in the Republican headquarters.

Mrs. Spilman said that women are definitely more active, partially because of the high degree of organization—especially for women—in the Democratic primaries in North Carolina. Women were organized in every county, she noted. Women have served at teas, parties and receptions for Democrats, not just here but across the nation.

Of course, women have done these things before (as in the Frank Graham campaign) but to a greater extent this year.

The candidates' wives themselves have participated in their husbands' campaigns, which has naturally stimulated women all over the country to come out, Mrs. Spilman said.

There are other reasons for increased women's interest this year. Mrs. Sumrell agrees with other women that women are thinking, and thinking of the future of this country and the world.

Mrs. Lee Folger is more active this year, though she's always taken an interest in politics, because "so much is at stake, our foreign policy, our status as a nation." She noted that women have never felt so much was at stake before—thus, the women feel they can't afford to take a back seat. They must act.

Miss Joyce Steinbeck illustrated that women are thinking when she indicated one area which has stimulated her interest is money. One party repre-

sents loose money, one tight money, she says. To her, tight money represents a more conservative economy.

### Personalities or Issues

Personalities or issues? Research is proving that American people tend to vote for a personality.

Women this year say that might be years ago, but this year the issues take precedence over all.

Miss Janice Hardison, alternate delegate to the Democratic Convention in Los Angeles, says the personality of the candidate prompts women's interest, but once attracted, the issues become the important thing.

Dr. Kathleen Stokes, who works with Young Democrats at East Carolina College, says it is issues that are bringing women to the front this year. Safety of the country, foreign policy, prestige—"Women are looking for a leader," she says.

Mrs. Folger says women are more informed, and consequently more interested. But they are informed because the candidates have informed them this year. She and Dr. Stokes, both Democrats, pointed out that in previous Adlai Stevenson campaigns, Stevenson and his ideas "were above the level of many people."

Not this year. The candidates have come forth, and at no time has the American public, and the woman, been better informed.

### What About Age?

Age has been a popular topic as far as candidates are concerned this election time. What about as far as voting factors are concerned?

Women say there are more of all ages interested and active

in this campaign. Mrs. Sarah Allen says all ages are interested, with increasing interest from college students, even those who can't vote yet. Mrs. Ida Clark, a grandmother, is interested.

Mrs. Spilman says the older people are more interested because of experience, and younger people seem to be gathering enthusiasm from parents and friends.

Dr. Kathleen Stokes says interest among Y.D.C. members is at a height. Mrs. Old Day Bisette, in charge of the local Democratic headquarters, says the young Democrats seem to be the most enthusiastic.

### What They Can Do

As Miss Hardison has said, women do much of the "leg work" in political campaigning.

They are urging citizens to register at the precinct level, to vote, to read, study, listen and think about issues. They are knocking on doors, telephoning to reach these ends.

Many women's clubs have public affairs committees which discuss voting, registration, and have speakers which inform them of issues and events, and the subject of politics. Women organize receptions, teas.

They participate in fund raising office work, typing letters, distribution of party literature.

Women, Mrs. Nancy Monroe says have more time to spend doing these things than men.

And their biggest job, the Democratic women say, is to get John F. Kennedy and Terry Sanford elected.

Their biggest job, the Republican women say, is to get Richard Nixon and Robert Gavin elected.

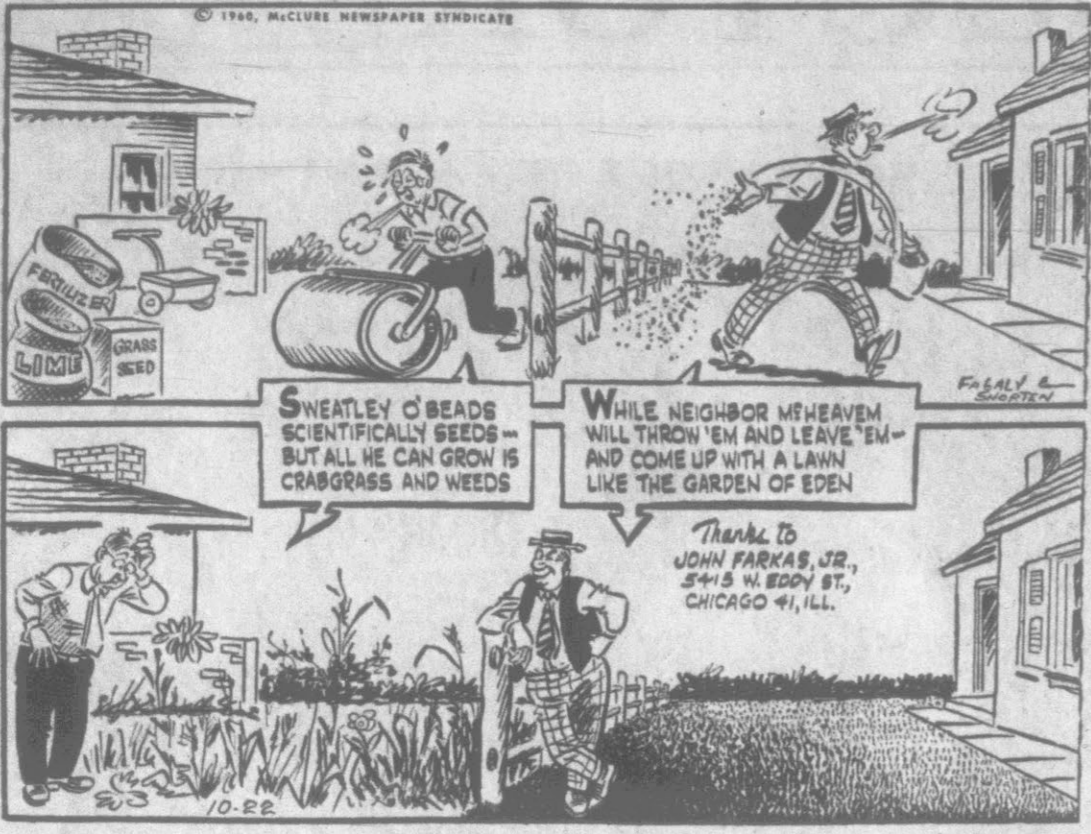

For Walter and Lionel loved their place and the lovely old things in it and their hearts didn't really want to sell. "But we have wanted to retire for years," Lawrence said. "Now we've done it." Krupshaw, jubilant over the buy, announced "This is one of the finest collections I have ever bought. In fact, it's almost unique." He will ship the cargo of 17,000 pieces back to the United States. 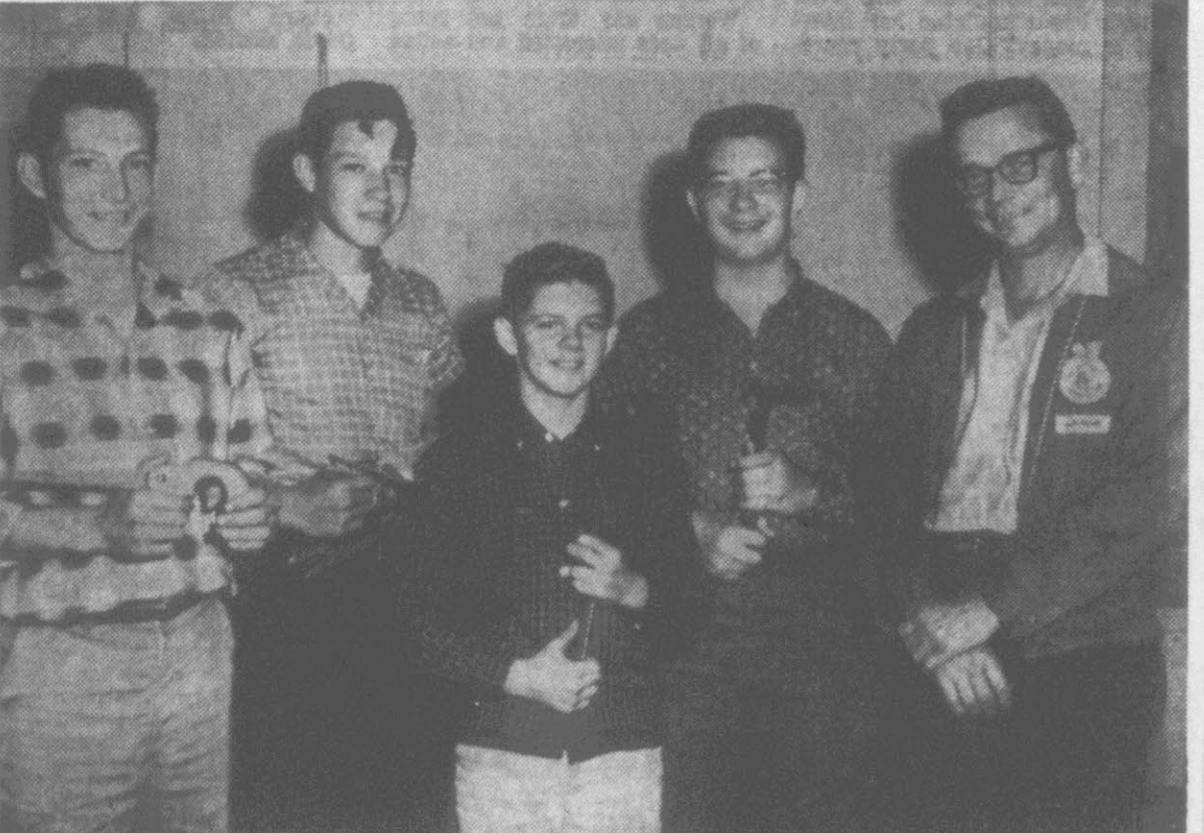

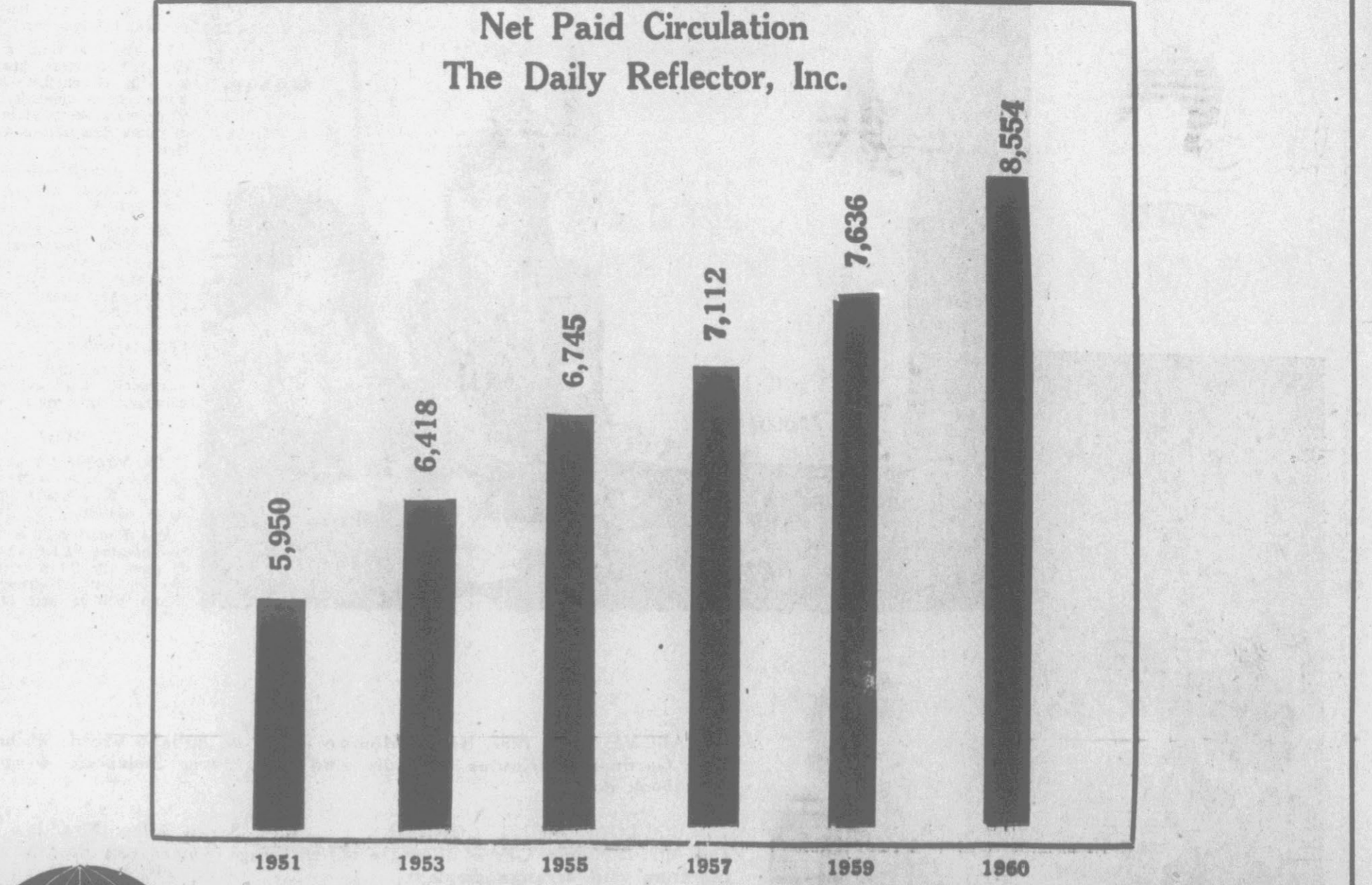

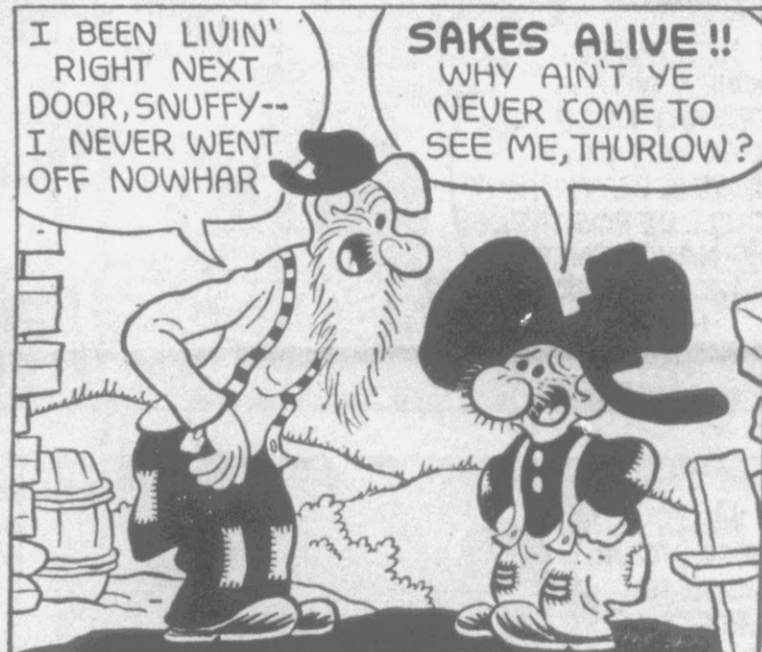
