Kennedy Confidence Seen In His Final New York Bid

NEW YORK (AP) — Sen. John F. Kennedy, looking increasingly confident, brought his hard-driving campaign to New York again today in a final bid for that state's 45 electoral votes. Kennedy himself was still cautious — publicly — about the outcome of next Tuesday's presidential election. "In the last three days, we've been in eight states, all of which are regarded as close," he told reporters. He listed California, Arizona, New Mexico, Texas, Oklahoma, Virginia, Ohio and Illinois. "I felt the tide there moving in our direction," he said. "And from all reports, our position has improved in the last seven days." The Democratic presidential candidate has consistently said the election looked close. But huge and thunderous enthusiastic receptions Friday in Virginia, Ohio and Chicago obviously lifted his hopes. Kennedy's last big foray in New York City and the heavily populated surrounding areas followed a similar sweep by Vice President Richard M. Nixon last Wednesday. Kennedy chose this strategic battleground as the spot to bid for enlisting what he called the "Republican rescue squad."

He referred primarily to President Eisenhower's appearance in New York, along with other top GOP leaders and candidates. Kennedy drew laughs and applause when he said, "We are not electing a committee as president of the United States." He likened the Republicans to circus elephants. "Each one grabs the tail of the one in front of him," he said, "and that's how they pull themselves around. But now, Mr. Nixon is running by himself." Leaving Chicago, Kennedy told correspondents on his airplane that he felt his arguments on "economic issues are hitting harder."

How many hundreds of thousands of people marched, ran and simply lined the rain-swept streets will never be known. Capt. James McMahon, chief of detectives, estimated the horde at a million and a half. The figure appeared greatly exaggerated, but in any case, it was a great show. The explosion of rockets and fireworks signaled the start of Kennedy's slow ride up Michigan Avenue. Elaborate floats representing Democratic wards and labor unions preceded his car. The bands played, banners and placards waved, thousands of people wearing straw sailor hats with "Kennedy" husbands marched, police barriers were knocked down, and Chicago had a high old time. There was even an echo of the old days of politicking—the pink torchlight.

Several times excited admirers bopped Kennedy on the head with placards. Earlier, in Toledo, Ohio, a tomato hit the windshield of his car. He had an infected hand, scratched and swollen to twice its normal size from shaking too many hands. Chicago Stadium, with a capacity of 26,000, was filled to overflowing for Kennedy's last speech in Illinois. It was nationally televised. Every time he paused for breath, the thousands cheered, no matter what he said. His speech was a kind of review of his whole campaign. He said he had tried to tell the truth, "whether the truth was pleasant or not."

Khrushchev Squelches Rumors

Soviet Premier Appears At Moscow Airport To Greet Red Chinese

MOSCOW (AP) — Premier Khrushchev headed the welcoming party at Vnukovo Airport today to greet Chinese Communist leader Liu Shao-chi, arriving to celebrate the 43rd anniversary of the Bolshevik Revolution next week. It was the Soviet Premier's first public appearance in about 10 days. His appearance cut the ground from under wild rumors in the West that he had been deposed. These rumors never gained any credence among Western diplomats in Moscow. Soviet officials had merely laughed off the rumors which spread from Vienna Friday. (In Bonn, Vienna, New York and elsewhere Russian agencies had termed the rumors nonsense.)

The first formal greeting at the airport was extended to Liu by Soviet President Leonid Brezhnev. The presence of Khrushchev, Brezhnev and most of the Communist party Presidium underlined the importance the Russians give to this symbolic demonstration of unity by the world's two biggest Communist parties. Liu is the formal head of the Chinese Communist state and Peiping's leading ideologist after Mao Tse-tung. Janos Kadar, the Hungarian party leader, and President Antonin Novotny of Czechoslovakia were among the first to arrive. Also en route is a delegation of 15 Cuban workers.

Western diplomats expect complete agreement on the question of peaceful coexistence will be announced. They also express belief the Communist leaders will reach agreement on apportioning aid to underdeveloped nations among themselves. The Soviet-Chinese ideological quarrel involves a dispute in which Peiping contends that war with the capitalist world is inevitable. Khrushchev says it is not and predicts communism can win in a struggle of "peaceful coexistence."

The Communist summit session formally opens Wednesday — the day after the American elections. Informal talks will be going on all through the holiday celebrations ending Tuesday.

Nixon Touring In Home State

EN ROUTE WITH NIXON (AP) — Vice President Richard M. Nixon, battling for the 32 electoral votes of his home state of California, today accused Sen. John F. Kennedy of talking "synthetic bunk" on financing of the Democratic program. Nixon, Republican candidate for the presidency, arrived in the central California community of Fresno Friday night, got a tumultuous welcome from a police-estimated crowd of 15,000 which surged out of control at times, and arranged a busy day in the state. Traveling by plane and automobile, the vice president booked campaign speeches in San Jose, Hayward, Oakland and Van Nuys today, and was to move on to Los Angeles for a coast-to-coast television address tonight. Nixon put out a statement contending once again that programs advocated by Kennedy, Democratic nominee for U. S. House, would add \$15 billion a year to federal spending. Nixon said Kennedy, in Norfolk, Va., Friday pledged that he would adhere to sound fiscal policy if elected. "He can't have it both ways," the vice president declared. "He can't go to Virginia and be sensible for one hour of one day of one week, and then during the rest of the time espouse his platform of free spending, cheap money doctrines. "America is a big place but not so big that such tactics go undiscovered."

Polls, Surveys To Suit Everyone

WASHINGTON (AP) — Americans with a presidential preference could find a poll to suit their tastes today, whether their choice was Richard M. Nixon or John F. Kennedy. Professional polls, newspaper polls, college campus polls and miscellaneous other straw vote polls showed various results even though the election itself is only three days away. Pollster Elmo Roper headed into the final pre-election weekend with a conclusion: "There's not a clear lead by either candidate." Roper's latest figures, from an Oct. 24 nationwide pulsetaking, showed 46 per cent for Republican Nixon, 44.5 per cent for Democrat Kennedy and 9.4 per cent undecided. But a closer analysis of the undecided vote gave this revised picture: Kennedy 48.5 per cent, Nixon 47.5 per cent, undecided 4 per cent. "The 4 per cent undecided could make an electoral college landslide either way," Roper added. Kennedy boosters could take cheer from George Gallup's report this week of "a dramatic shift" toward the Democratic slate in the campaign home-stretch. Gallup said his latest nationwide poll, tabulated from Oct. 20-26 interviews, indicated that of those likely to vote and showing a preference, 53 per cent picked Kennedy and 47 per cent Nixon. Surveys published by three national magazines this week found Kennedy ahead. Time magazine's correspondents figured Kennedy was leading in states with 306 electoral votes, Nixon in states with 149. Needed to win: 269. Newsweek said 50 top Washington correspondents predicted Kennedy would win compared with 16 forecasting a Nixon victory. It said political experts in 50 states estimated Kennedy would get 278 electoral votes, Nixon 159, and 100 votes could go either way. U.S. News and World Report rated Kennedy ahead in states with 282 votes, Nixon ahead in states with 205 votes and 50 votes doubtful. Nixon backers could take heart from a poll of the nation's newspaper editors and publishers conducted by Publishers' Auxiliary, a weekly trade newspaper which announced results Nov. 3 from nearly 4,000 of the 10,703 ballots sent to newspaper executives. Publishers' Auxiliary said weekly newspaper editors and publishers figure Nixon will win in what "could be called a near landslide" with 416 electoral votes against 115 for Kennedy. Among executives of daily newspapers, it said, Nixon was picked as the victor by a somewhat smaller margin — 350 electoral votes compared with 147 for Kennedy. The American Society of Newspaper Editors published a poll of its members, taken before Oct. 29, which produced a majority opinion that Nixon will win 314 electoral votes, Kennedy 209.

First Aid Team Competes Today For Top Honors

PHILADELPHIA — Greenville's state award winning rescue squad first aid team will compete for international honors here this afternoon beginning at 3:30. The Greenville team, which won the state title at Burlington, will be trying for one of the five places in the competition here. As a result of this afternoon's competition the winners will be announced at a banquet tonight. This will conclude the three-day meeting of the International Rescue Squad and First Aid Association. Members of the Greenville team are Claude Christopher, captain; Dawson Nethercutt, Tony Brannon and Stuart Savage. Harold Ross is alternate. Rescue Squad captain Jimmy Smith III and Neil Eggleston arrived in Philadelphia today to join the others. Squad spokesmen said this morning the team had received 17 telegrams from Greenville organizations and individuals wishing them well. Jim Johnson of Morganton, N. C., president of the North Carolina State Association of Rescue Squads, was elected second vice president of the international association. Approximately 450 people had registered for the convention and officials are expecting the final registration figure to be 500 to 525. MILANO, Tex. (AP) — Recording star Johnny Horton, 35, was killed early today in a two-car head-on collision on a railroad overpass in this central Texas town. Horton was driving a car, state police said, in which Tilman Franks, his manager, and Gerald D. Tumlison were riding. All were residents of Shreveport, La. Both Franks and Tumlison were injured, along with the driver of the second car, James Evans Davis, 19, Brady, Tex. All were taken to a hospital at nearby Cameron, Tex. Horton was dead on arrival at the Cameron Hospital and his body was taken to the Marek-Burns Funeral Home in Cameron. State police said that none of the injured was believed in serious condition. Horton was a former star of the national radio program Louisiana Hayride originating on station KWKH Shreveport. Horton skyrocketed to fame with his recording of "The Battle of New Orleans," written by his manager. His wife, Billie Jean, is the widow of Hank Williams, another famous West Texas singer who died of a heart attack in 1953. Mrs. Horton resides in Shreveport.

Mother, Daughter Killed; Five Injured In Collision

CHOCOWINITY — A mother and her infant daughter were killed and five persons injured Friday afternoon in a truck-car collision on U.S. Highway 17, south of Chocowinity, sources at the Washington Daily News said today. The dead were identified as Mrs. Carolyn Jones Jackson, 23, and her infant daughter, Lydia Grey Jackson. They died enroute to the hospital. The injured were Lonnie J. Jackson, 31, husband of Mrs. Jackson; and their other children, Gary Jackson, 2; Wanda Jackson, 3; and Bennie Jackson, 4. William Curtis Clark, 40, driver of the truck, was also injured. According to a report today from Beaufort County Hospital, all five of the injured were in fair condition.

Investigating Patrolman Ray Bland of Washington said the Jackson family was enroute from their home in Columbus County to Virginia when the collision with a tractor-trailer truck, being driven south on U.S. 17 by Clark, occurred. Clark, in attempting to pass another vehicle, swerved to the shoulder of the road and into the path of the oncoming Chevrolet being driven by Jackson. The injured were rushed to the hospital for treatment. Jackson also went onto the shoulder of the road in an attempt to avoid the accident, the Daily News said. Clark, a driver for the Woodrow Everett Truck Line, a Washington, N.C., firm, is being charged with reckless driving and manslaughter, Bland reported.

Propaganda Film Activity Claimed

WASHINGTON (AP) — The Navy said Friday it had received reports from Guantanamo Bay that Soviet photographers have been staging anti-American pictures on Cuban territory not far from the big U.S. naval base. The reports said the Soviets had dressed Cuban men in U.S. Navy uniforms and photographed them beating Cuban women and children. This propaganda activity, according to the report, took place near Guantanamo City, about 20 miles north of the U.S. base.

Incendiary Bombs Found At School

HOUSTON, Tex. (AP) — Six homemade incendiary bombs were found Friday in shrubbery on the grounds of St. Patrick's Parochial School. The Jones Elementary Public School also was evacuated of 610 students after an 11-year-old boy was arrested there by police. The boy told police he had planned to burn the Catholic school "because a boy there said he was going to beat me up."

School Lunchroom Managers, Workers At Session

Mrs. Sabrie Reid, area supervisor for the school lunch program, conducted a program on the school lunchroom program held here this week for managers and workers in Pitt County school lunchrooms. The main item of discussion was presentation of the type-A lunch includes a half pint of milk, two ounces of protein-rich food, three-fourths cup of fruit and vegetable and one portion of bread. Two teaspoons of butter or fortified margarine are also included. This type-A lunch is the basis upon which the federal government reimburses the lunchroom program for every plate lunch

served. It must be a type-A lunch every day. The half-pint of milk that is given free or sold is also reimbursable. These two items, the special milk and the type-A plate lunch bring into Pitt County (Greenville is not included in this estimate) approximately \$60,000 per year. All schools in the county operate under the National School Lunch Program and the Special Milk Program, which reimburses the schools approximately \$32,000 per year. The \$30,000 in U.S.D.A. commodities are distributed for use also. All county schools were represented at the meeting by manag-

ers and workers. D.H. Conley, Pitt County superintendent of schools, welcomed the group and briefly discussed the importance of the school lunch program. Arthur Alford, supervisor in the county schools, added that students in the county schools "are very fortunate in that they receive well balanced, well prepared and tasty meals each day." 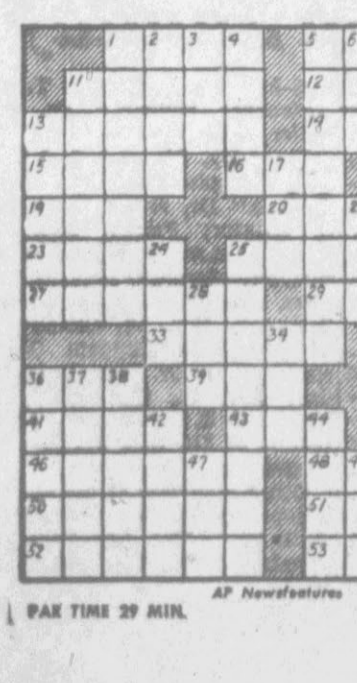

Long Hard Year On Political Front

There remain only a couple of more days before the 1960 political campaign ends, and for the people of North Carolina, it will be a political year long remembered.

More than any other year in recent Tar Heel history 1960 has literally been "filled" with politics. It was back in January when the candidates for governor began in earnest their maneuvering for post position in the big race. Before warm spring days brought buds to bare tree limbs, candidates for state offices and for local and district offices throughout North Carolina were off and running.

Before the end of May, North Carolina had seen its hottest state-wide primary campaigns in many a year. Politics had become almost the only topic of conversation in the drug stores, on the street corners, in country stores and living rooms. Television programs were shifted around to the extent that politicians were running a close second to cowboys on the home screens.

After the May first primary there was no let-up, for there followed the run-off between Terry Sanford and Dr. I. Beverly Lake for the Democratic nomination for governor. And this two-man race overshadowed all the other races that had taken place in the second primary.

Hardly had Tar Heels caught their breath from the second primary when the national parties convened to name their candidates for the presidency; and the nominees were off and running hard without waiting for the usual Labor Day signal to begin campaigning.

1,500,000 - Vote Count Possible

FORECAST — Despite all the polls and predictions which have served to confuse rather than enlighten the public during the past few weeks, your reporter has had numerous requests for an estimate on the total vote to be cast in North Carolina next Tuesday — and how it will be distributed.

So — Here goes: there will be a record turnout of voters. That is indicated by the increased new registration in almost every county. Biggest vote to date was the 1,215,000 cast in 1952. The 1960 total will exceed that by at least 10 percent, and will be not less than 1,350,000. A million and a half count will not be surprising.

There will be less difference in total votes for President and for Governor than usual, and less discrepancy in the margin of winners, although more votes will be cast for President than for Governor. Also and somewhat paradoxically, there will be more regional uniformity in preferential voting; which is another way of saying that all over the State the votes for President and Governor will run closer together. Majorities for Nixon and Lodge in the West will be smaller than the majorities rolled up here for Eisenhower four years ago; and the majorities for Kennedy and Johnson in the East will be less than given to Stevenson in 1956.

Democrat Sanford for Governor may get a smaller majority in the West than did Hodges in 1956. Almost certainly he will get a smaller margin in the east. As your reporter analyzes this prospect, the majority for Sanford may be reduced to not more than half the 385,000 given to Hodges four years ago. But — the majority for Kennedy may more than double the 15,000 given to Stevenson in 1956.

REASONING — Reasoning based on these estimates admittedly is not very logical. Fact is, there hasn't been much logic or reason in this campaign. Personal, political and religious prejudice has clouded the logical consideration of issues to such degree it is difficult to appraise. In too many instances the Republicans are running against the Pope of Rome and the Democrats are running against the Hoovercarts of three decades ago. Neither has any logical basis as an issue, but appeals to emotion and prejudice do influence votes; and such appeals are more effective in the final days of the campaign.

NECK OUT — Yielding to the numerous requests for a prediction, your reporter sticks out his neck for this forecast:

The Democratic national slate, headed by Kennedy and Johnson,

will win in North Carolina with a margin of 25,000 to 50,000 votes — two or three times the Democratic margin in 1956. Sanford will be elected Governor, along with all other Democratic candidates on the state ticket, by majorities ranging from 100,000 upwards — smallest margin since 1928, but still enough.

The total vote in North Carolina will be in the range of 1,385,000. Every Democratic candidate on the State ticket will be elected, but there will be more Republican members of the 1961 General Assembly than in any Legislature since 1928 — and some of them may come from counties which have not had Republican representatives in this century.

That's the way it looks from here as of now. The final two or three days can upset these predictions. Campaigning goes on until six o'clock Tuesday, November 8.

REGISTRATION — Reports from all over the state indicate unusually heavy registration for the election next week. Most estimates put the total number of eligible voters at slightly above two million. In counties where the party strength is fairly equal extra effort was made to get every potential voter on the books. In these counties, too, very close attention is being given to rounding up absentee ballots.

Randolph county is a good illustration. There are between 35,000 and 36,000 voters registered out of a population of 61,000. A week before election day a few more than 700 absentee ballots had been distributed. Party leaders expect a total vote of more than 25,000. The vote in 1952 was 21,400 and in 1956 it was 21,578. Majority of the registrants are listed as Democrats, but the Republican national margin has been heavy in the past two elections. When the incumbent Democratic sheriff was first elected his margin was 108 over his Republican opponent — and in that year there were 180 Democratic absentee votes.

In Gaston county the Democratic leaders are predicting a total vote of around 45,000, which compares with 34,000 four years ago and 37,000 in 1952. Absentees are not likely to be influential in the State and county races, but might make the difference for President.

More attention is being given to absentees in the East than usual. In previous elections Democratic majorities have been so big a dozen or two absentee votes were not worth the effort to get them. Now there are several points where every vote counts big, whether cast in person or by mail.

first time in several decades a serious bid by a Republican candidate for the governor's office. Both the Republican and Democratic parties have waged vigorous campaigns for their candidates down the line, giving the general election in the state this year much more attention than has been normal.

With it all, however, there has been a greater interest on the part of individual citizens in politics, candidates and government than has been the case in a long time. And that in itself will make for better government at every level in the future.

On Tuesday, Let Every Citizen Cast His Vote

Tuesday will be a big day for Democrats Republicans, Independents. It will be an important day for all those Americans who claim affiliation with major political parties and for those who adhere to no political party affiliation.

It will be the day when Americans go to the polls in what is hoped to be unprecedented numbers to elect the next president of the United States and other officials at all levels of government.

It will be the day on which members of a Democratic nation exercise their greatest responsibility as citizens by expressing through the secret ballot their personal choice of candidates for high and low places in government. Those who go to the polls on Tuesday and vote their convictions may enjoy the satisfaction that they have discharged a personal responsibility to themselves, to their fellow citizens and to their government.

Those who purposely stay away from the polls on election day will not be exercising their voice in the affairs of government where it counts most. They will not be upholding their duties as citizens.

In this nation, which above all others takes pride in the right of the individual citizen to participate in the election of officials, the percentage of registered voters who actually cast ballots is less than in any other democratic nation in the world. Certainly such a situation is not building upon the foundation of democracy as it should.

It is our hope that every citizen will make a sincere effort to cast his ballot in the important national election Tuesday. Every citizen not only has the right to participate in the election; he likewise has the duty to participate with his fellow citizens in selecting the officials who will be charged with the responsibility of our government in the critical years immediately ahead.

Eisenhower Has Own Technique

WASHINGTON (AP) — President Eisenhower's tactics against Sen. John F. Kennedy vary in his campaign effort to help Vice President Richard M. Nixon win the presidency.

He has played it cool, and he has played it hot. Cool is more in the line of this master politician who now may be making the final political effort of his life.

Last Friday night in Philadelphia he scaled Kennedy a bit, although without mentioning his name. In his Wednesday night speech in New York Eisenhower used a cool feather duster.

The former had a touch of the campaign he himself made against Adlai Stevenson in 1952. The latter was like his campaign against Stevenson in 1956.

That cool technique — which really means don't be too harsh on the man — has worked extremely well for Eisenhower throughout his presidency. Still, it is questionable whether this is the right technique to help Nixon now.

What may be needed from Eisenhower at this time — if he is going to swing any votes when polls are saying Kennedy is ahead — is a slashing, direct attack on the senator. The Nixon camp reportedly would prefer that.

In Philadelphia, in statements which could be considered aimed at Kennedy without naming him, Eisenhower spoke against "arrogance," "rashness" and "irresponsibility." None of this was in his New York speech. He made only one allusion to Kennedy — his contention that American prestige has dwindled.

If a successful politician can be described as a man who knows how to stay highly popular while getting himself re-elected, then Eisenhower is one of the master politicians of the 20th century.

The proof is his overwhelming victories, without any previous role in politics, in 1952

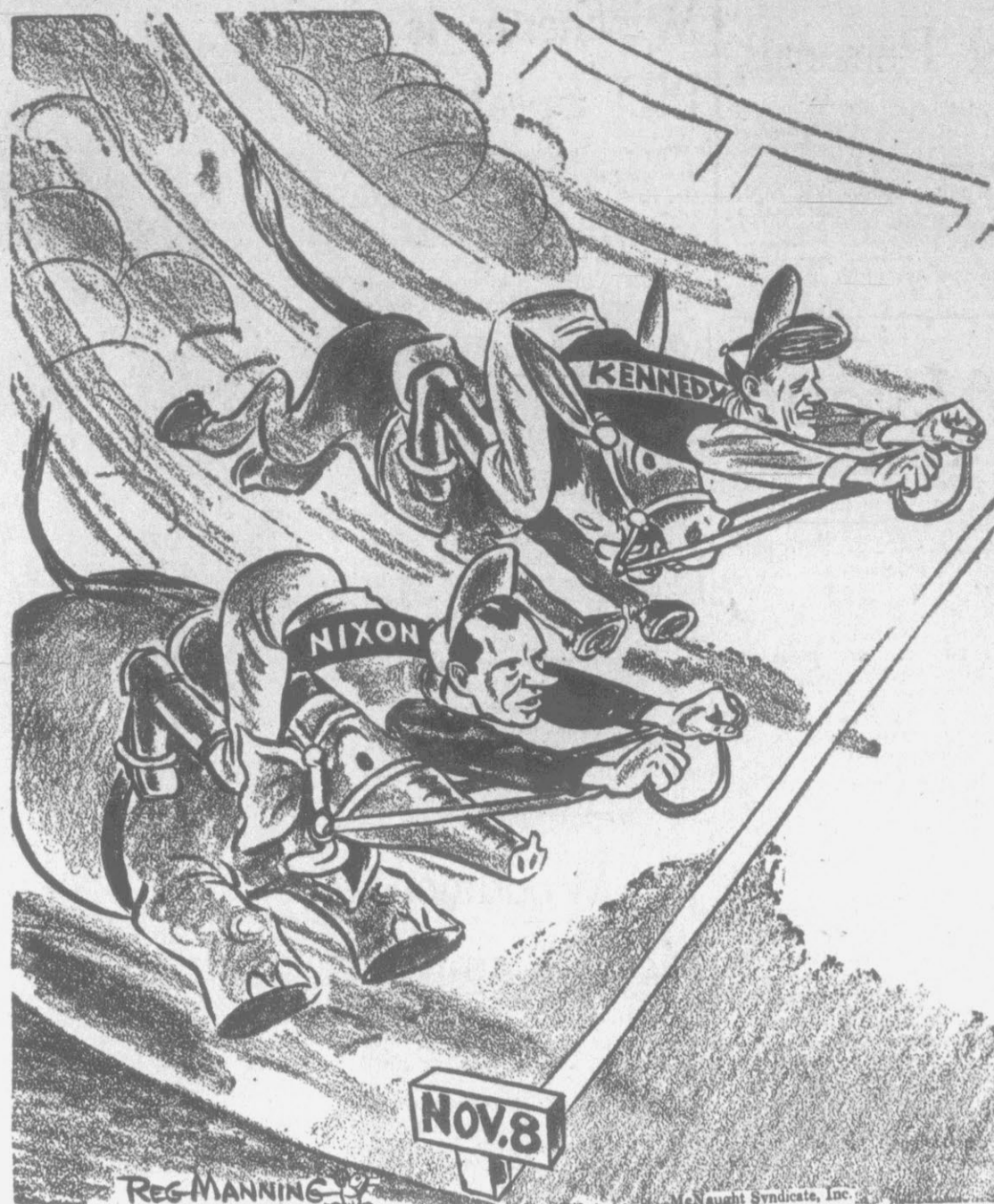
TO THE EDITOR:

I won't pretend the past fourteen years have been like four-

teen minutes, but they sure have gone by with a rush. It was quite a jolt when an outside source casually mentioned "My, you have an anniversary coming up! Your fourteenth, isn't it?"

Well, the surprise in this was

due to my Missus and I having chucked up our thirteenth anniversary just recently; and the twelfth, eleventh (and so on) seemed in retrospect to have come perilously close to one another. Several times I have been tempted to say something about anniversaries should be at the very least one year apart; but what with one thing and another this little reminder got lost in the rush.

But it is a fact, and the calendar bears me out, fourteen years ago was an important day in my young life. It was a day highlighting one of the wisest moves (for which I claim credit) that I have seen my fortune to make before, or since.

The years that have since elapsed would have been filled with 365 long days, instead of hours, if it hadn't been for a November day so well recalled. Hey, babe... Do you read me loud and clear?

For Aelouraphiles (cat enthusiasts) the coming week is a big one. It is Cat Week — International.

You aren't impressed? Well, the American Feline Society, Inc. figures the American cat population runs about 21 million; and that the count has held steady for the last two decades.

Of that 21 million cats, this same society holds that half of them are owner - fed, owner-housed and owner-cared for.

Personal experience with felines (one at a time) has proven rather pleasant. As anybody who has lived around a cat will tell you, each has a personality as distinctive as individual people.

But as much as their qualities may be admired, they seem to lack something when considered en masse.

The most famous of cats are fictional: "Dick Whittington's Cat", in which Dick Whittington became the mayor of Londontown (and not the cat); and H. Allen Smith's redoubtable "Rhubarb" in which the scene - stealer proved to be a baseball team.

If it was left to cats there would be no Cat Week? International. I suspect they'd rather be left alone.

Always It's A Big One

Admiral Ben Moreel, Chairman of the Board of Trustees of Americans for Constitutional Action, issued a mimeograph broadside to the effect:

"The approaching election is without question the most crucial in the history of our Republic — and the most momentous for the rest of the world."

This sentence I have heard or seen all my life since I was a small boy when Mary Hanna chose William McKinley to defeat William Jennings Bryan. Each time, it is the most important, the most momentous, the most significant election for one reason or another. However, the Republic manages to survive the indiscretions of its citizens.

Those who wrote the American Constitution put real power in the Congress and therefore in the people. If Congress functions as it should, we can survive such a President as Chester Arthur or Warren Harding or even such a one as Woodrow Wilson or Franklin D. Roosevelt. The very strong Presidents, such as Andrew Jackson and Abraham Lincoln, managed to dominate Congress, for one reason or another, and a weak President, like Dwight D. Eisenhower, became dependent upon an antagonistic Congress which cooperated fully for the country's sake — but always we managed to survive our worst errors or best judgments.

My point is that as long as an informed people is alert, government cannot destroy the country. Admiral Moreel's statement contains this:

"I stand with those who believe that the great conflict of our age is between Individualism to determine whether the individual, as a child of God, endowed by Him with certain inalienable rights, will be permitted to strive for a life in peaceful devotion to his God and in love of his neighbor; or, alternatively, whether his life is to be subordinated to the 'will of the majority,' a majority not guided by eternal and absolute laws of right and wrong, but solely by political and social practices fashionable at the time — a majority whose rule is actually dictated by a minority skilled at political manipulation."

I do not understand what this means. Does Admiral Moreel favor a dictatorship or an absolute monarchy or government by an elite? The "majority" is in the nature of a free society, although it is true that Hitler was chosen by a majority and so was Mussolini.

What is the alternative to a majority? It could only be a minority. How does one decide which minority is to be placed in office? Would it have been preferable to make Thomas E. Dewey President because he was defeated by Harry Truman? Are we to choose the man who is defeated rather than the man who is elected? Or shall we have a President elected only by those who understand "eternal and absolute laws of right and wrong"? Perhaps we might have an Electoral College consisting of bishops, rabbis and Christian Science readers to pick a President or we might have a Senate of university presidents to do that job!

Admiral Moreel's real objection to the majority is that it is manipulated by a minority. The word, "manipulated," is ill-chosen. It is true that men follow leaders. That is in the nature of things. Sometimes a leader is a great orator or a brilliant military leader or a noble politician. But human beings do have a way of hitching their wagon to a star and we are not all stars.

The quality of leadership is rare. It is noted in small boys who manage, for better or for worse, to be followed by other small boys. Not all men can be taken at their own valuation. Some men like to lead but others will not follow them. They become disillusioned and frustrated, because while they know the best way to do things, nobody agrees on who is the one who should do them. Trotsky was an example of this — extremely competent, efficient, knowledgeable man who knew precisely what should be done and when he got the chance, he did everything perfectly. But others preferred not to have him about: Stalin, not worthy of Trotsky's toe, called the better

Banks Provide In-Plant Service

By ELMER ROESSNER

About 100 banks are providing in-plant services in 2,000 establishments with 500,000 employees, according to "Report on Credit Unions and In-Plant Banking Services." "It is fairly safe to predict that the acceptance of bank plans will grow rapidly," it adds.

The rise of bank branch offices in offices and factories is a serious threat to credit unions. This is significant because many of the credit unions are sponsored by unions. When employees swing from credit unions to plant branch banks, unions may lose face, if not an economic hold on members.

However, banks have not yet won the battle. "Report, Etc." says that savings and loan associations are way ahead; credit unions are second and banks are last in plant offices.

WHY BANKS WILL EXPAND
There are a number of reasons why banks are forging ahead.

1. Banks are tending to bring services almost to customers' doorstep. In most states, branches are springing up in shopping centers, new apartment developments — everywhere there are people with money. Extension to plants is logical — and to be expected by customers.

2. Banks offer more services than credit unions or savings societies. They offer checking services, quick small loans, real estate loans, large-size loans.

3. Employers favor banks. Banks can offer services to the plant in which they are located: quick cash in emergency, payroll handling, quick answers to financial questions.

4. Credit unions, as "Reports, Etc." says, have left a vacuum. There are only 10,000 credit unions in the 50,000 plants with 100 or more employees.

Furthermore, as "Reports, Etc." points out, "banks and finance companies are active on the legislative front." While credit unions, banks and other lending organizations get together in opposition to consumer credit, the rest tend to gang up against credit unions in other issues.

And the newsletter adds: "Credit unions are a maverick of the financial system. They aren't financial institutions pure and simple, and they aren't a religion. They operate under laws which differ from those under which their competitors operate. They have opened up a new area of thrift and loans their competitors have missed for a long time."

"The competitors have discovered this area with a bang. They are moving into it. They will try to give better service than credit unions and they will try to cut down credit union operating privileges."

It looks as if the credit unions

need a program for survival quickly.

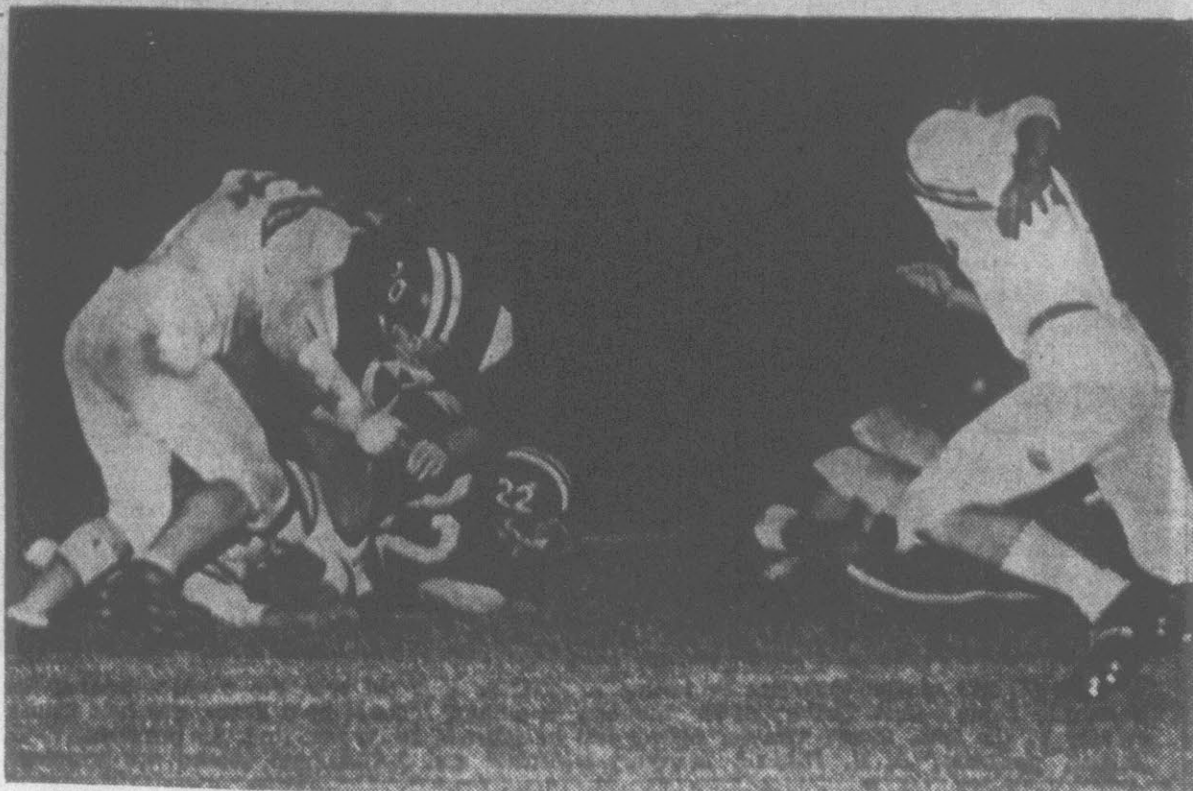

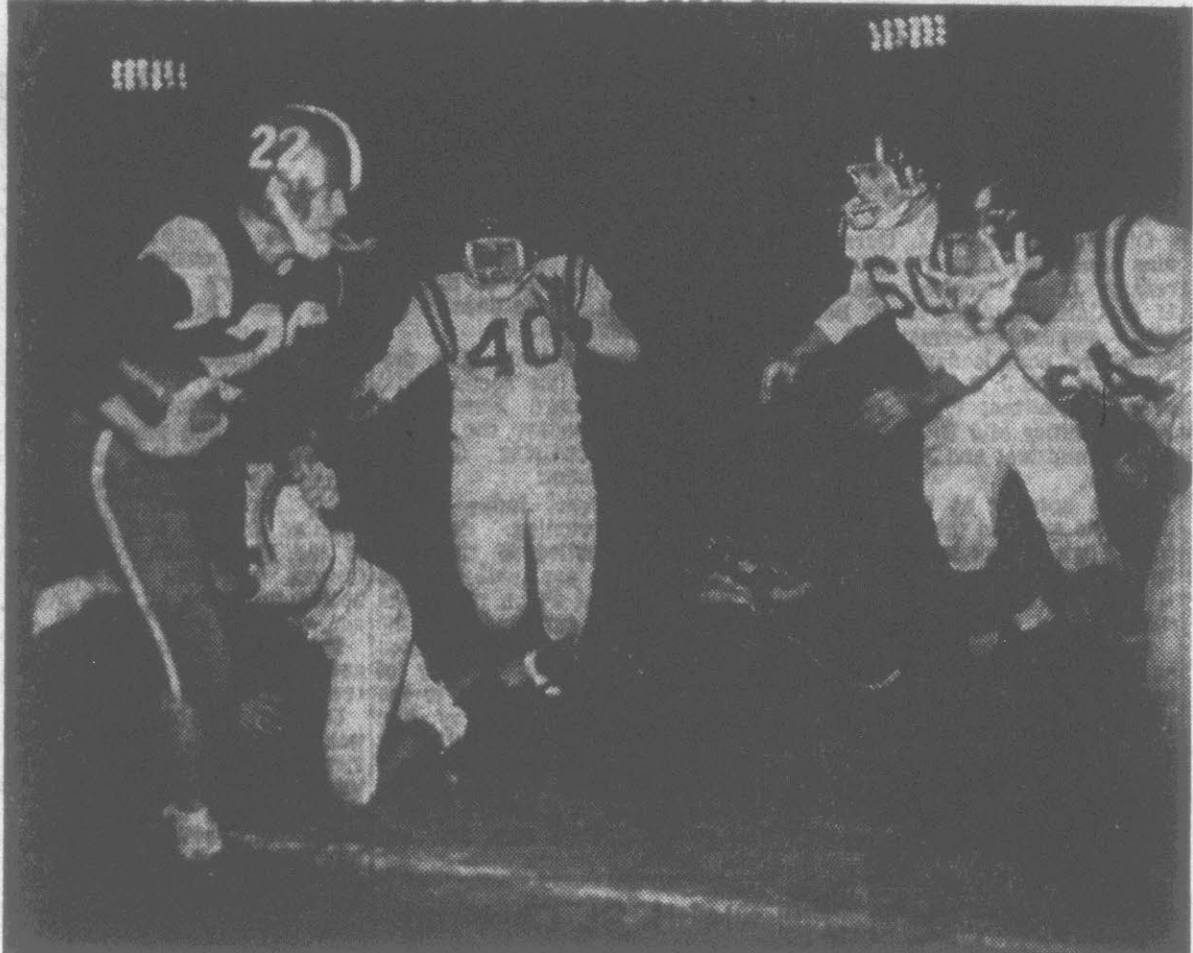

AL Draft Rosters Are Being Frozen

LOS ANGELES (AP)—American League draft rosters as of Monday are being frozen until the player draft Dec. 1.

Baseball Commissioner Ford Frick is taking the step, he told newsmen today, to guard against irregularities.

"If a club has 40 players it cannot draft any," said Frick. "Whereas a club with only 38 would be eligible to draft two. We'll put on a similar freeze in the National League when it expands to Houston and New York in 1962."

Frick said his action is being taken after discussions with Joe Cronin, president of the American League, and Warren Giles, who heads the National.

The freeze will have no effect on inter-league trading, which starts Nov. 21 and ends Dec. 11.

Hank Greenberg, who heads the American League's syndicate for a Los Angeles franchise, recently expressed disappointment over Frick's recommendation that the new Los Angeles and Washington clubs be allowed to draft two minor leaguers each after the present 16 major league teams have taken their turns.

The commissioner said he conferred with the Washington and Los Angeles clubs of the American League lucky to get any draft.

"According to the rules, a team must operate one year before getting draft privileges," said Frick. "They will not be allowed to

Adlai Stevenson, Democratic nominee for president in 1952 and 1956 also came into Eastern Carolina.

And in Greenville a Kennedy-Johnson - Sanford Democratic headquarters popped up across the street from the Republicans.

Of course, Democratic gubernatorial nominee, Terry Sanford has been here many times during the campaign. His most recent visit being Tuesday afternoon.

All-in-all it has been an interestin presidential campaign for this section where folks usually just sit back and watch the rest of the nation slug it out.



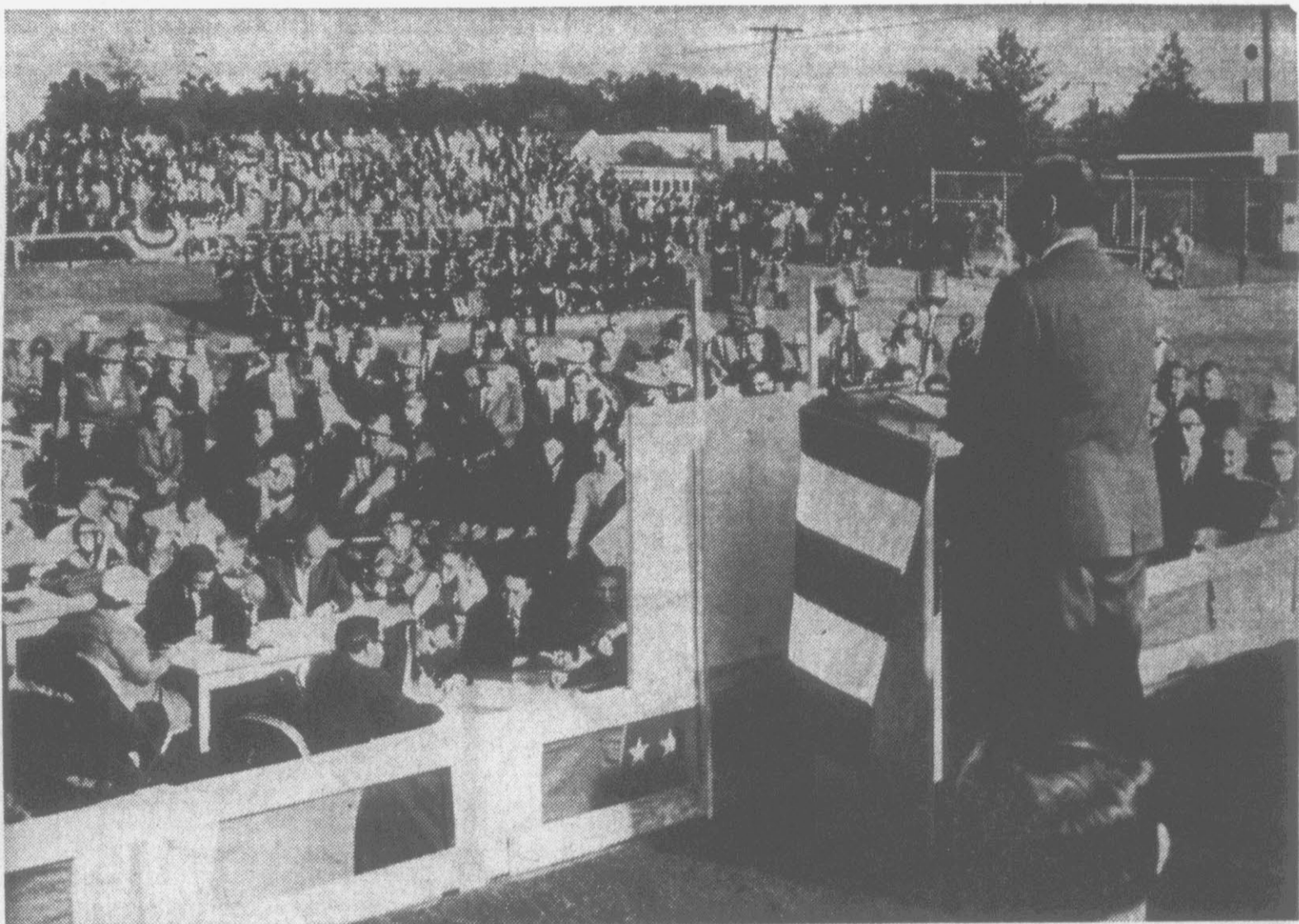
HISTORY MADE . . . Sen. Kennedy was first presidential candidate ever to visit Greenville.



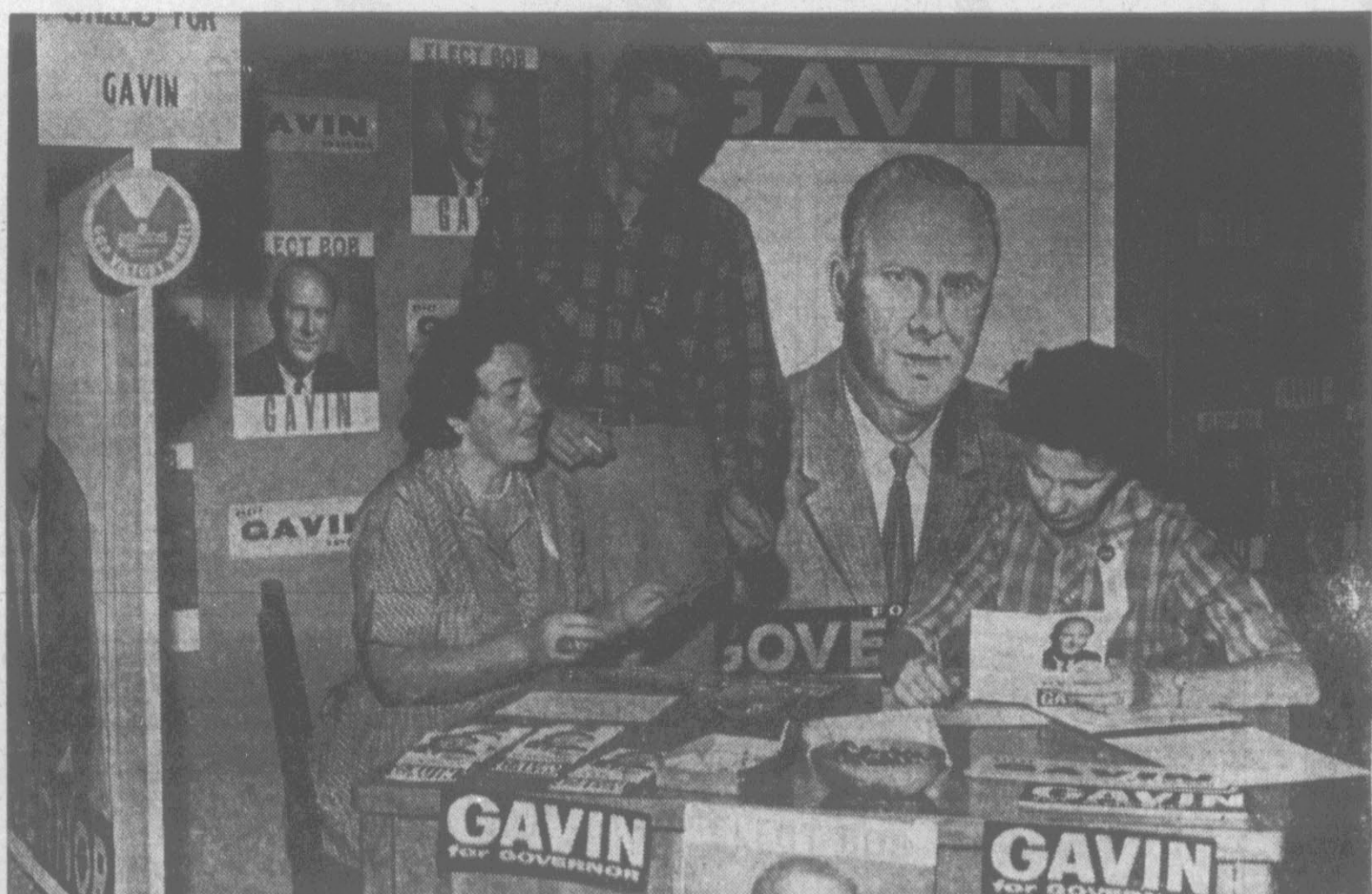
TRUMAN CAME TO EASTERN CAROLINA . . . shown here with Rep. Cooley, Terry Sanford and Gov. Hodges.

STEVENSON IN EAST . . . Adlai Stevenson, twice defeated for president, stumped for Kennedy in Eastern Carolina.

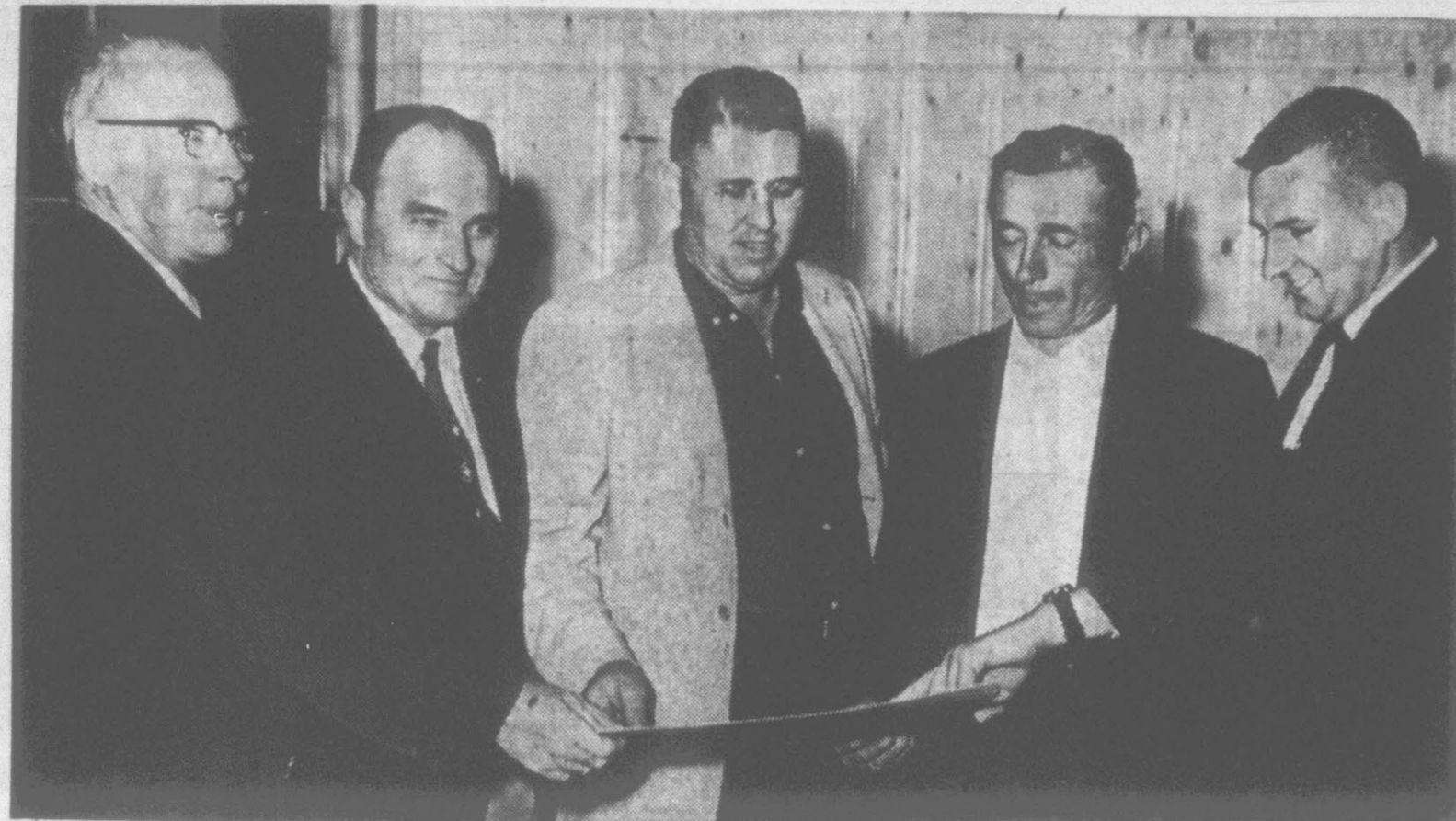


NIXON GAVIN HEADQUARTERS . . . in Proctor Hotel, first Republican headquarters here in many years

Appointed to the committee were: Johnny Hardee, Chairman; Lenwood Edwards, Roland Brison, Elbert Mills and Jimmy Ed-

wards. A previously appointed survey and truck committee will still function.

A survey will be made shortly of the area to be served and cost of equipment and cost of coverage per person. Each property owner in the five mile area of Simpson, which is not planning to be served by either the newly organized Eastern Pines Community Fire Department and the proposed Grimesland Rural Fire Department, will be asked to join.

Thus Simpson, which has been the scene of several bad fires over the past year becomes the seventh community in Pitt County in the past year to announce plans for a rural community fire department. Other departments now operating are: Stokes, Staton House, Grimesland, and planned departments at Pactolus, Greenville, Eastern Pines.

It was discussed by the group to obtain a decision from Civilian Defense office in Raleigh on a surplus piece of equipment which the community now has in regards to title and insurance coverage. Since some confusion exists the general opinion was that another truck be purchased and equipment obtained locally be mounted on

the truck placing a fire truck in service shortly if the title and insurance coverage cleared.

Hardee told the Rurians "You and only you the men in this room can provide the one vital thing which this community now needs. Fire Protection. You have none. If this community building or the homes of any of you would catch on fire tonight, there would be no one to come to your assistance. You must help yourself."

It was also cited by Hardee the strides which other counties have made in setting up county wide fire protection plans, organizing new departments and obtaining county assistance for organized departments.

"Once we have Pitt County completely covered by rural community fire departments as you will form here, then we can ask for and receive help from the County Commissioners as other counties have, but not until then," He cited, Wayne, Nash, Wilson and Greene counties as examples of what can be carried out on a county wide level once individual communities have set up their departments.

Hardee used a series of slides in color made of various rural

fires to illustrate the need for a community fire department and also showing what effective fire fighting a community fire department can offer to the area that it serves.

Last week, the Eastern Pines Community began the ground work for an Eastern Pines Community Fire Department and plans are in the making for a rural fire department at Grimesland which will provide much needed protection in the Eastern sections of the county.

WINTERVILLE — Democratic candidates John F. Kennedy, Lyndon B. Johnson and Terry Sanford won an overwhelming victory in a student vote Tuesday at Winterville High School here.

Republican candidates Richard Nixon, Henry Cabot Lodge, and Robert Gavin polled 33, 36, and 32 votes, respectively, in the student body voting.

Winterville High's teacher, voting separately, gave Kennedy 14 votes; Johnson 14; Sanford, 13; Nixon, 2; Lodge, 2; and Gavin, 2. The school's government class, sponsor of the election, cast a separate ballot that also went to Kennedy, Johnson, and Sanford, but by a lesser margin. Class members gave Kennedy 13 votes;

Johnson, 14; Sanford, 11; Nixon, 3; Lodge, 2; and Gavin, 5. Accompanying each qualifying vote in the government class was a list of three reasons for the vote for a particular candidate.

The student body's vote was cast during the study hall periods of each respective students. Troy Jackson is the government class teacher.
