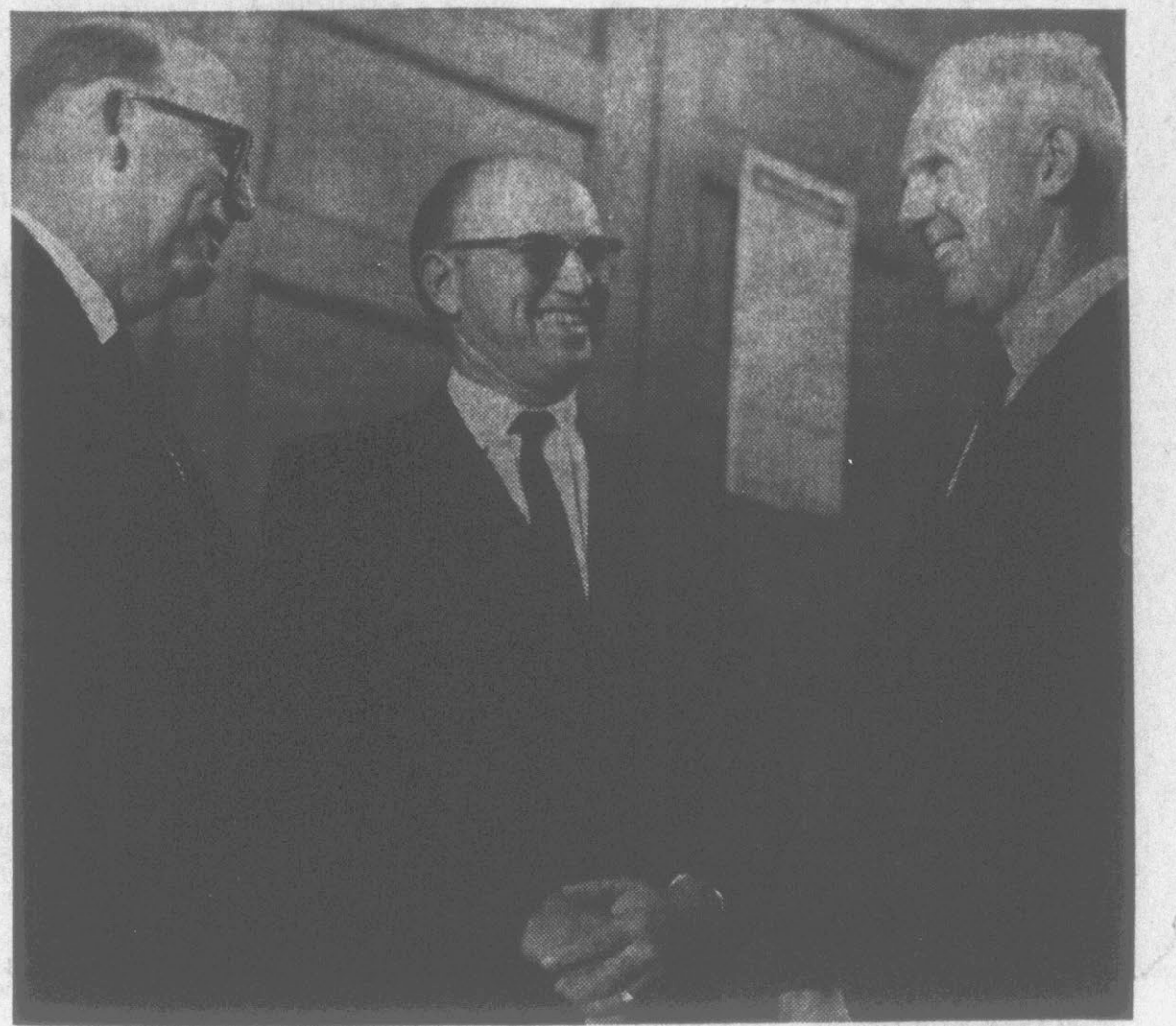

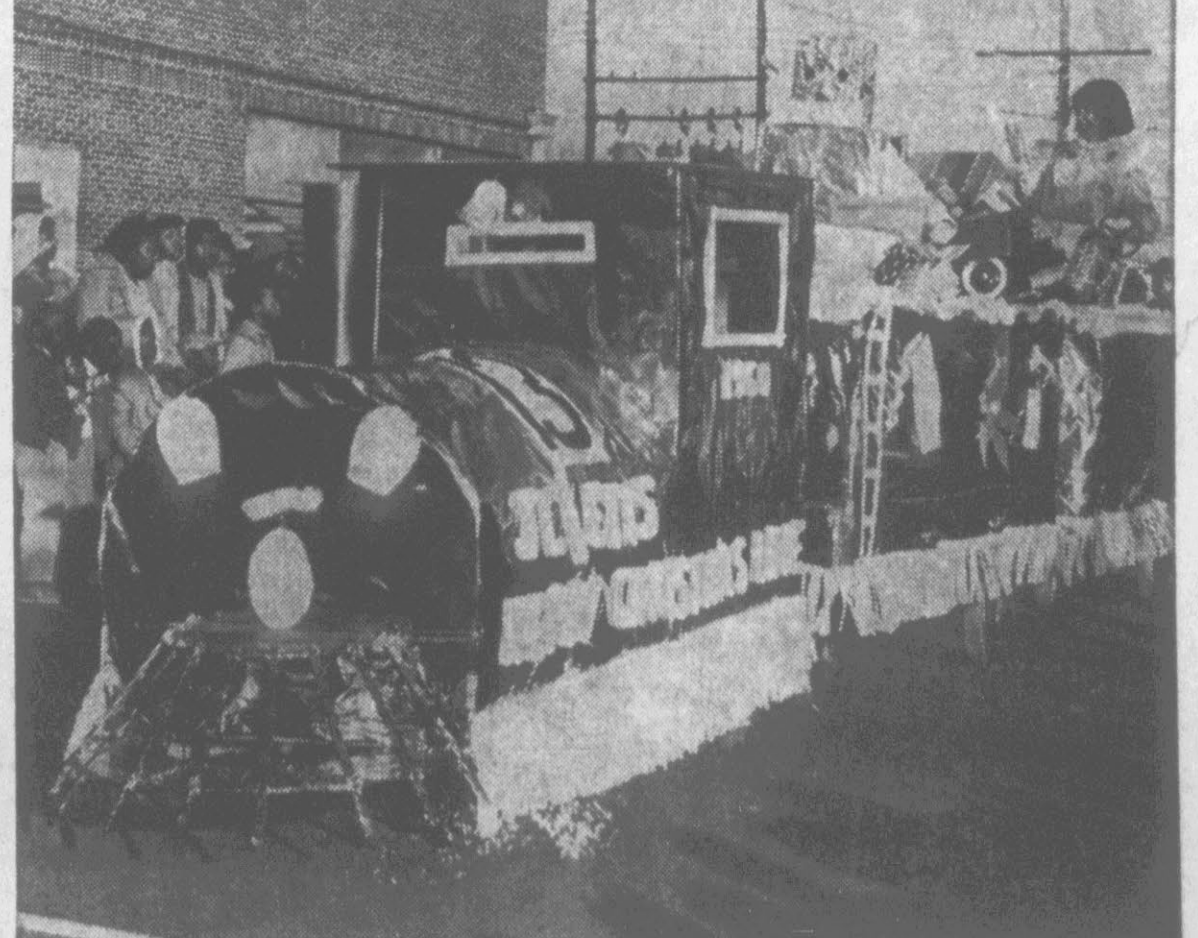

RALEIGH—Numerous stores are featuring beef this weekend at special prices.

Mrs. Ruby P. Uzzle, consumer marketing specialist for the N.C. Agricultural Extension Service, says good buys will include round, sirloin, T-bone, Porterhouse and cube steaks, roasts and ground beef.

Pork supplies have increased with better prices on many cuts—hams, picnic shoulders, pork chops and bacon. Canned hams remain about the same price.

Most poultry products remain economical buys. Fryers will be featured at many markets during the weekend. Turkeys continue in heavy supply and should hold at steady prices through December. Eggs hold their price levels with Grade A mediums advancing again.

Apple supplies continue big with volume comparing favorably

with last year. Supplies of Florida oranges are increasing. There is more fruit maturing and color is improving due to recent good weather. Good quality white and pink grapefruit supplies are plentiful. Look for special buys in bagged fruit of 5 to 10 pound lots. Other fruits available include grapes, pears, bananas, and dried fruits.

Weekend shoppers will find good offerings of cabbage, winter greens, and sweet potatoes. On the good buy list are onions, Irish potatoes, sweet potatoes, carrots, and squash. Lettuce and celery are better priced due to increased supplies reaching market.

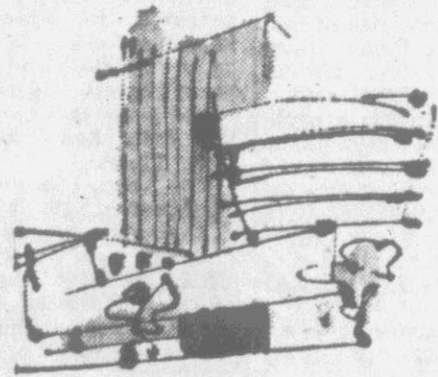

Dr. Riddick was a member of the Ayden Methodist Church and at one time served on the board of Stewards. He was a charter member of Ayden Rotary Club, former member of the board of directors of the First National Bank of Ayden.

Kennedy Made An Excellent Choice

The appointment of Gov. Hodges as Secretary of Commerce in the Kennedy Cabinet reflects again the excellent choice of the president-elect in securing the best available talent for specialized top jobs in his administration.

Gov. Hodges' brilliant record in the fields of industry and government bespeak his outstanding qualifications for the post to which Kennedy has appointed him.

While the appointment of Hodges as Secretary of Commerce did not come as a surprise, there would have been bitter disappointment in North Carolina—and elsewhere we would guess—if the president-elect had passed over Hodges in filling this important Cabinet post.

During the seven years he has served as governor of North Carolina, Luther H. Hodges has demonstrated unusual ability in administering the affairs of the state. Particularly he has demonstrated his capacity for leading the state to new and higher economic plateaus through developing the state's capacity for industry. To the affairs of government he has applied the objective business viewpoint that has resulted in greater efficiency in our state government's operation. To one

of the major problems of the state—that of low per capita income and the lack of opportunities for employment in manufacturing—he formulated and carried out a positive, farsighted program that has brought phenomenal results during his administration and which will continue to enhance North Carolina's economy in the years to come.

Gov. Hodges, from his background, understands the problems of business and industry, and at the same time he understands the problems of areas which find themselves without sufficient economic momentum to adequately provide for its people. He has demonstrated vividly his ability to approach and analyze these problems and to formulate a realistic and positive program to overcome such problems. This ability which Gov. Hodges will carry to his post as Secretary of Commerce will prove a distinct asset to the Kennedy administration and to the nation in the years ahead.

From North Carolina's standpoint, the fact that Gov. Hodges holds an important post in the national administration will be a distinct advantage. It places Gov. Hodges in a position which he will be able to continue to be of important service to his own state while he serves the nation in one of its top appointive offices.

Instead of retiring from public life when his term as governor expires next January, Gov. Hodges' unusual talents will continue to work in a still higher position for the betterment of the nation as well as for the betterment of his own state.

The appointment of Gov. Hodges as Secretary of Commerce is another recognition of his abilities and achievement which reflects credit not only upon the man himself, but upon North Carolina as well.

Complaints Get Some Attention

MAIL BOX — the most interesting experience of a newspaper man is his daily visit to the mail box or to the pile of mail which someone has deposited on his desk. Despite long schooling against being surprised at anything the mail man might bring, there is almost always an exhilarating surprise—and one of the chief surprises is when the mail contains nothing of unusual interest.

There are a dozen or more newspapers. All of them of monotonous similar format, and many identical headlines—and yet each with an individuality challenging comparison with all the other sheets. There are the handouts from public relations men in government and private industry, extolling the virtues of particular brands of merchandise or political ideology; and certainly one or more requests for charitable donations. Hasty pawing through the pile sometimes discovers that highly appreciated personal letter—wished for but not quite expected that particular day.

When the handouts are checked and generally consigned to the wastebasket, the donation requests handled in like manner; the personal letters read and enjoyed; the newspapers pushed aside for review later—along with the "please remit" suggestions—then attention is given to the "gripe" letters, mostly anonymous.

Some of these are original complaints from people who have been overcharged on water or tax bills, or unjustly (?) arrested for traffic violations, or otherwise discriminated against by law enforcement officers. Some of them merely enclose clippings of letters to the editor or newspaper comment about the incidents. And most of them convey the suggestion that there ought to be a law against enforcing laws already on the books.

In his capacity as newspaper man and as president of the Travel Council of North Carolina your reporter gets a great many letters complaining about the treatment of folks traveling in the state.

CONSIDERATION — Many of these "gripes" are so obviously absurd they are consigned to the wastebasket forthwith. Some indicate need for investigation. Like the complaints of out of state motorists that they had been suckered into gambling games. Result of these complaints was that two or three "joins" were padlocked for the protection of other visitors.

Then there was the gripe by an out of state woman motorist that she had been singled out of a line of fast moving traffic,

arrested for speeding by a highway patrolman, and discourteously treated in a local court. That same word came word that a North Carolina citizen was thoroughly disgusted with the unsanitary conditions in a roadside restaurant and demanded that the "A" grade card be removed.

Originals of these complaints went to responsible State agencies, and they investigated. It was mere coincidence that reports of these investigations also came to your reporter's desk on the same day about a week later.

The speeding lady was not stopped by a State highway patrolman but by a local city traffic cop. Evidence is she was clearly violating the law, and that she shared responsibility for discourtesy with the officers.

The complaint about roadside restaurant was re-checked by the State Health Department sanitarian, not just as routine checking but actually looking for trouble. He found less than perfect conditions but came up with a score of 91—and a new "A" grade card for display.

HELPFUL — The moral, if any, in these little stories is that complaints and gripes about mistreatment of travelers along North Carolina's highways are helpful, and aid in bringing about remedial action for bad conditions, if they are found to exist.

In most instances the responsible agencies are appreciative of the tips which disclose unsavory practices. The alleged victims of discrimination and malpractice are no more anxious than State officials to eliminate cause for complaint.

Quite naturally the law enforcement officers, the careful and courteous business people who serve travelers, and the positions who are seeking to promote travel business, do not like the complaints. Unfortunately, they are forced to admit that some of the gripes are justified. The big job is to remove any cause for honest complaint, by running down—sometimes at great effort and expense—every one of the gripes, to determine if it has factual basis.

North Carolina has an enviable record for courtesy and efficiency in law enforcement. The record is not perfect. And that reminds of the first time your reporter was ever in an airplane. He flew from Charlotte to Raleigh with Roy Rowe of Burgaw some 20 years or more ago, in a two-seat plane. On the instrument board had been attached a little brass plaque with these words: "Almost right ain't good enough."

Twin Factors In Business Trend

By RALPH ROBEY

Two items are crucial in the determination of the business trend. These are inventories and business investment in plant and equipment. They may move together, or in opposite directions. This means that they may augment each other, or tend to offset each other. There is only one phase of their importance.

On inventories the only figures we have are historical. That is they refer to what already has happened. Of course predictions may be made, but they are fraught with danger. And errors in such predictions may be enormous, because changes in inventories may amount to twenty billion dollars a year. In the first quarter of this year, for example, inventories accumulated at an annual rate of over \$1 billion. Since then there has been a continuous decline, and no one can know how much longer this drop will last.

Such a movement of inventories has a direct effect upon gross national product. It also has a curtailing influence upon production, employment, consumption, and almost every other segment of our economic system. This has been perhaps the most important single factor in our business trend this year.

On business investment in plant and equipment we have historical figures, but we also have predictions that have proved to be amazingly accurate. There are two sets of such figures. One is official, the other is private. The official series is compiled by the Department of Commerce and the Securities and Exchange Commission from data submitted by various individual companies. The private series is that of McGraw-Hill and is based upon replies to a questionnaire. The two differ in both coverage and details, but the totals always are relatively close.

The latest government survey was based upon reports made in late July and August. The projections were carried only to the end of this year. They show the same total—\$36.9 billion—for both the third and fourth quarters.

The McGraw-Hill survey has just been published. It covers the rest of this year and also 1961. The figures are both surprising and encouraging. They show an anticipated decline for next year of only 3 per cent, to

\$35 billion. This 3 per cent applies both to manufacturing alone, and for all business together.

The largest drop in proposed manufacturing investment is textiles—21 per cent. The largest increase is electrical machinery—10 per cent. In the non-manufacturing field railroads lead the list in declines—24 per cent, and electric and gas utilities plan the greatest increase—4 per cent.

The projection is surprising for several reasons: the widespread talk of a recession over most of 1961; the unused capacity at industries, which in some instances amounts to between 40 and 50 per cent; the marked squeeze on profits in almost every field; and the difficulty, or impossibility, of raising prices.

All of these considerations, one would assume, should curtail business investment in plant and equipment—curtail it by much more than a mere 3 per cent. Obviously other factors are even more important in the minds of business management. Among these probably the most significant are the desire to increase efficiency by more modern machinery, the introduction of new products, the knowledge that business can not simply stand still, and a genuinely optimistic long-term confidence in the future of our economic system.

If the McGraw-Hill projections prove true, business investment in plant and equipment will be at least a sustaining source throughout 1961.

Stealing His Stuff

Bobby Kennedy Qualifies

When it was suggested that Robert F. Kennedy might be appointed Attorney General, there was hardly any objection on the grounds of nepotism. After all, the younger Kennedy had made his own career first as the counsel for the Democrats on the McCarthy Committee and more recently as chief counsel of the Senate Select Committee on Improper Activities in the Labor or Management Field. Better known as the McClellan Com-

mittee, it exposed labor union corruption in several areas and showed the combination of unions and management in some rackets.

The Kennedys, John, who was a member of the McClellan Committee, and Robert, its chief counsel, were accused of safeguarding Walter Reuther but when Reuther finally appeared for a hearing, the Republican members of the committee either lacked the material or the courage to proceed against him. If a man writes a book, it is often possible to discern his qualifications. I therefore sat me down a week-end to read Robert Kennedy's "The Enemy Within," to discover what Robert Kennedy would do were he appointed Attorney General. I knew that when James P. McGranery, President Truman's Attorney General, finished his term, he left behind him a large number of incomplete cases of racketeers in many fields, including labor and small business, for his successor to process. It is possible that had all these cases been adequately processed, Alapachin would not have taken place.

In fact, Robert Kennedy makes the point in his book that in a number of instances, "The lack of action by the Department of Justice is disappointing. It has lost some of the cases through incompetence." Senator McClellan, who was a witness in the perjury trial of James Cross, president of the Bakers Union, made no secret of the fact that he was highly critical of the way the Government attorneys presented that case.

In the case against James Hoffa for wiretapping, Kennedy had arranged for one of its assistants, Carmine Bellino, to give the prosecuting attorney a detailed chronology of Hoffa's whereabouts for every day over a period of about three months in 1953. So the chief witness for the prosecution said that he had met Hoffa in Detroit on July 10, 1953. Bellino's memo showed that on that date Hoffa was in Seattle, Washington. I quote now from Robert Kennedy:

"... And much to the embarrassment of the prosecutor, Hoffa was able to bring in documentary evidence as well as witnesses to prove it. "Afterward, I asked the U. S. Attorney why, with the help of Bellino's memo, he had not been able to get his dates and places straight. He made the astounding admission that he had not read Bellino's memo."

Kennedy cites other similar cases of incompetence, ineptitude or perhaps worse. He says: "Furthermore, many of the cases that we sent to the Justice Department for possible prosecution lay dormant for ten months, a year, and sometimes even longer."

A man who has had this kind of experience with the Attorney General's office is likely, if appointed to the job, to clean up that agency of government which traditionally is a favor-giving outlet for an Administration.

The Department of Justice has several functions, not the least important of which is the speedy prosecution of malefactors on an utterly impartial basis. The advertisement (Continued on page 5)

Cuban Trade Views

BABSON DISCUSSES CUBA By ROGER BABSON

BABSON PARK, MASS.—The Cuban situation has reached a point where it is affecting certain investments. Therefore, I feel that my readers are due an impartial summary of the situation. I have always watched Cuba critically as it is so close to Florida, where I have spent over thirty winters.

INFLUENCE OF THE CATHOLIC CHURCH

I feel that the Cuban situation will come out satisfactorily due to the influence of the Catholic Church. The Cuban people, with their Spanish blood, are emotional and enjoy political and physical fights. They, however, are deeply Roman Catholic in faith. Hence, there is a church safeguard which does not exist in Russia or in many of her satellites.

The Communist Government in Russia has been brutal to the Christian church, due largely to its inheritance of the former Czarist domination which controlled and worked through the orthodox Church. The situation in Cuba, therefore, is entirely different from the situation in Russia and its satellites.

IMPORTANCE OF MARKETABILITY

Cuba is rich in soil, rainfall, sunshine, and warm temperatures. It could be the garden-spot of the Americas; but it has been cursed by wretched and unjust government. Castro thinks it necessary only to nationalize the farms, businesses, banks, and the few manufacturing establishments; he seems to give no thought to marketing. Cuba's wonderful productive conditions are of no use if her products cannot be marketed. Cuba's natural market is the United States (which Castro is abusing and doing his best to alienate). This same trading principle is true for the countries of Central America, and even South America; they have the land but lack the marketing facilities for their fruits, and even minerals, including oil.

This is another reason why I feel investors should have the larger proportion of their common stocks in marketing—rather in farming, mining, or manufacturing—propositions. Whatever the future may bring as to the ownership of land or the production of crops or the extraction of minerals and oil, there should always be a field for companies engaged in the marketing of these products. This applies to the big concerns such as Sears Roebuck, Montgomery Ward, etc.; but especially to the large variety chains, with their stores in all fifty states of the Union. Even in case of World War III, these great marketing organizations might emerge through the best of all concerns.

LENGTH OF THE CASTRO REGIME


When Castro, at thirty-two years of age, conquered Batista and his gang, I thought he was a wonderful fellow. As long as he stuck to military warfare, he fared well; but since he has tackled economic problems, he is ruining the country. How long he can last, even with Russia's blessing, no one knows. It seems he is destined to be assassinated by someone whose family he has ruined.

On the other hand, investors should realize that the whole world is passing through a leveling process wherein those who have not are gradually taking away from those who have. In Russia and her satellite countries, this has been done by ruthless stealing of property. In China, goodwill is expropriated, but Mao has sometimes made payment, on his own terms, for actual property taken. Great Britain has experimented with nationalization, and payment has been made for the coal mines, steel companies, railroads, and public utilities that were taken over.

In these United States, the labor leaders have the same goals, but they work through strikes and unfair demands. In all countries, investors are being attacked either by heavy taxation or by guerrilla warfare such as is taking place in Africa. Hence, we investors in the U.S. should be especially on the watch. With only 6 per cent of the people of this world, we have (Continued on page five)

Tourists Face Curb On Spending

One of the first actions of the new Congress to dam the drain of gold will be legislation to reduce the duty-free merchandise American travelers may bring home.

This provision was enacted when the United States was trying to restore the war-wrecked economies of foreign nations. Now some of their economies are healthier than ours.

Travelers bring back almost \$1 billion worth of duty-free goods each year. In addition, they are allowed to send gifts costing no more than \$10 duty-free. By sending series of gifts of themselves, such as monthly parcels of handmade Japanese silk shirts, they swell the total.

become a liability on the U.S. gold supply.

Cutting duty-free imports will not only save gold but will also please many American voting blocs. Retailers, wholesalers and importers are complaining that travelers' imports are hurting their business. For instance, it's difficult to sell a \$350 duty-free German camera to a prospect if his Uncle Louie can bring it back from Berlin duty-free for \$230. Dealers in watches, jewelry, spirits, textiles, garments, handicraft and other valuables are losing money in this foreign competition.

Furthermore, almost no foreign country allows American merchants to sell so much duty-free merchandise to their nationals.

The arguments are almost unanswerable, the new Congress will act fast.

TEXTILE OFF-BEAT Here are other predictions in business: Textile dip: Sales rose during the first nine months of this

year, partly because of forward buying. Now many companies are living on inventory, orders are down and backlogs thin. Prices will continue weak.

Clothing bargains: Too much Indian summer has slowed buying of winter clothing in many sections of the country. Retailers, forced to move stocks, will soon be offering good clothes at deeper cut prices, earlier than before. Shrewd shoppers will find great bargains.

Deeper gas cuts: Seasonal gasoline cuts take place at this time of year, but the coming cuts will be deeper than in recent years. Gasoline stocks are high.

Even deeper fuel oil cuts: Fuel oil holdings are even higher than normal because of the mild fall. Most dealers are holding prices up, in hope that sudden cold snaps will relieve their inventories. But where winters continue mild, fuel oil prices will be sharply shaved.

ufacturers will sponsor Pencils Week starting Feb. 27. Anybody using a ball point that week is an old meanie.

Sunday's Orchestral Concert Proves Satisfying Experience

Sunday afternoon a large and appreciative audience gathered in Wright Auditorium for the 1960-61 debut of the East Carolina College Orchestra under the able direction of Donald H. Hayes. Throughout the concert the orchestra proved once again that it can present commendable performances of music of all styles.

The program opened with a rather cautious rendition of the First Movement of Brahms' Second Symphony. Mr. Hayes and the members of the orchestra placed great emphasis upon the lyrical qualities of this music, but, in so doing, the rhythmic and dramatic elements seemed to be somewhat lax. Many professional musicians contend that the music of

Brahms is among the most difficult to perform correctly; however, the ECC Orchestra presented a satisfactory account of this masterpiece.

After a sensitive performance of excerpts from Handel's "Water Music," the group turned to a contemporary American work—in their reviewer's estimation the highlight of the concert. John Barnes Chance, a young Texas-born composer who is a "composer in residence" at Greensboro this year, conducted the orchestra in a stirring presentation of his Symphony. It is the policy of the ECC Orchestra to champion the works of our American composers, and the Entertainment Series is to be congratulated for its efforts in bringing these composers to our campus to conduct their own compositions. The Chance symphony reminded this listener of Shostakovich and Prokofiev; but it contained much original material in the true American idiom. This number is characterized by good melodic content, contemporary scoring devices, and a strong rhythmic drive. It will be interesting to follow Mr. Chance's future development as a composer.

Following the intermission, Mr. Hayes returned to lead his forces in an authentic account of the "Emperor Waltz" of Johann Strauss.

To close this successful concert,

the orchestra—complete with solo speakers and a speaking chorus—performed the "Declaration Suite" by the American composer Morton Gould. Mr. Gould is noted for his excellent arrangements and colorful orchestration. Although this work does not appear to be one of his better compositions, it does contain some rather exciting passages. It is a difficult piece, and it requires the utmost in performing skill by all concerned.

In summary, this initial orchestral concert of the 1960-61 academic year proved to be a very satisfying experience. There were, of course, occasional intonation difficulties, some faulty entrances, and problems of balance (some due to the acoustics of the auditorium); but, these were overshadowed by many notable examples of fine musicianship. Mention should be made of the outstanding work by the trombone section. However, it was the combined effort by the entire orchestra and its conductors which produced this interesting program.

There was one disturbing factor during the concert: audience noise. There were many late arrivals, and the resulting noise and confusion made it almost impossible to enjoy the soft portions of the Brahms and Handel compositions. Perhaps as the concert season progresses, our concert etiquette will show improvement.

ministration of the Federal Courts lies within the jurisdiction of this Department. The President makes judicial appointments on the recommendation of the Attorney General. Too often, this is a patronage-ridden agency and Federal judges who were who were once regarded as sacrosanct have not, in recent years, been regarded so favorably.

The FBI, the Federal Bureau of Investigation, is not an independent agency of government. It is a department of the Department of Justice. J. Edgar Hoover has, in his own person established such a prestige that Attorneys General and even Presidents come and go but Hoover stays on and the FBI remains free from departmental interference. Nevertheless, it needs to be said that if an Attorney General desired to abuse the FBI, he could do it. Hoover would, of course, resign under such circumstances. Only the bandits would benefit.

To summarize, were John F. Kennedy not President, there could be no objection to his brother, Robert, being appointed Attorney General. His career would justify it. Therefore there can, in justice, be no objection now.

Most Democrats In House Favor January 4 Caucus

RALEIGH (AP)—A poll shows that a majority of the 105 Democratic members of the House of Representatives favor holding a caucus here Jan. 4 to nominate a speaker and other elected House officials.

The caucus would be held the day before Gov.-elect Terry Sanford and other state officials are inaugurated.

Reps. H. Clifton Blue of Moore and Herbert W. Hardy of Greene conducted the poll. Blue said that up through Saturday they had heard from 70 House Democrats, 65 of whom favored the Jan. 4 caucus. Three were against it, one was undecided and one said "anytime" suited him.

In their letter to the Democratic House members, Blue and Hardy said Rep. Joe M. Hunt Jr. of Guilford, unopposed candidate for speaker, concurs in the idea to hold the caucus.

Blue and Hardy added the caucus "in no way would necessitate a special session of the General Assembly, or any additional expense upon the state in any way. The expense of the trip would, of course, be borne by the individ-

ual members."

They added, "we think it would be mighty nice" for Hunt to be nominated speaker by the House Democrats at the time Sanford is taking over as governor, and H. Cloyd Philpott assumes the lieutenant governorship. Hunt's formal election to the speakership would come at the official opening of the General Assembly in February.

Chaplain Tindall was awarded the "Four Chaplains Award" in 1953 and the Air Force Commendation Ribbon in 1959.

Favorable Reaction To Protestant Reunion

SAN FRANCISCO (AP)—Leading churchmen today registered a somewhat bezzled but firmly favorable reaction to a proposal for a wide reunion among American Protestants.

The plan, said Methodist Bishop John Wesley Lord, of Boston, "is as shocking as it is Christian."

"It overcomes with stark simplicity many of the problems that have perplexed the separate communions over the years."

The plan, at the outset, would embrace the Episcopal, United Presbyterian, Methodist and United Church of Christ with other

denominations subsequently invited to join. The provocative formula was offered Sunday by a top-ranking Presbyterian, the Rev. Dr. Eugene Carson Blake, of Philadelphia, shortly before the start of the National Council of Churches.

More than 3,000 representatives of 33 Protestant and Orthodox denominations with 40 million members joined Sunday night in the stirring opening services.

Although not formally a part of their program, the proposal generated keen interest among delegates.

"It is the opening of a very significant move," said the Rt. Rev. Arthur C. Lichtenberer, of New York, presiding bishop of the Episcopal Church.

"Out of this might come a plan that would be acceptable to all the people involved," he added. "It is a good approach. I hope it will lead to a reunion of the church."

He, like others, however, emphasized it will take time, and careful examination.

Dr. Blake, in a sermon at Grace Episcopal Cathedral, detailed steps for combining creeds. He urged churches with the more informal, non-ritualistic churches into a body "both reformed and catholic."

Episcopal Bishop James A. Pike, of California, called the plan the "most sound and inspiring" ever offered in this country.

The plan is patterned on the precedent-shattering establishment of the United Church of South India in 1947, uniting Presbyterians, Methodists, Episcopalians and Congregationalists.

Dr. Blake proposed specifically a merger of these four groups in the United States. He included the United Church of Christ, a presently evolving union of Congregationalists and the Evangelical and Reformed Church.

Altogether, the combined body would have more than 20 million members. Other churches accepting the principles, Dr. Blake said, would also be invited to join, with the ultimate aim of reuniting "the whole of Christ's church."

The Rev. Dr. James E. Wagner, of Philadelphia, and the Rev. Dr. Fred Hoskins, of New York, co-presidents of the newly created United Church of Christ, voiced "great interest and appreciation" for the plan.

They said they felt sure that if the Episcopal and United Presbyterian conventions next year issue calls for such a union as proposed by Dr. Blake, it will receive "careful and thoughtful consideration."

However, they expressed hope that the plan would not be limited to the four bodies named even at the start, since their own merger already was planning unity negotiations with the Disciples of Christ Church.

The proposed reunion would include a joint consecration service, in which all clergy took part, so as to bring them into the apostolic succession—a heritage valued by the Episcopal and other catholic-rooted churches.

This is a line of authority considered handed down from the apostles. The plan also would provide for

"truly democratic government," with congregations free to name their own pastors, and "a wide diversity of theological formulations of the faith and a wide diversity of worship and liturgy."

Other measures would incorporate distinctive features of both Catholic and reformed types of Protestant churches, Dr. Blake said. He said he used the word, "catholic," as it applied to age-old Christian concepts and practices.

"The reunited church," he said, "must have visible and historical continuity with the churches of all ages before and after the Reformation."

He estimated it would take at least 10 years to effect the union, if the designated denominations act on it favorably. He suggested as a possible name: "The Reformed and Catholic Church in the United States of America."

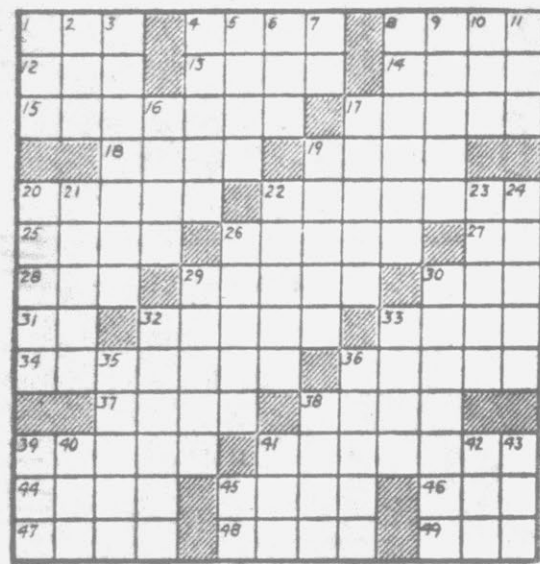

Eatherly was acquitted of burglarizing two Texas post offices after pleading innocent by reason of insanity. A grocery store robbery charge at Dallas against him was dropped after he was committed to the VA hospital here last year.

A psychiatrist testified at his trial on the burglary charges in 1957 that Eatherly had a guilt complex and said he felt responsible for killing 100,000 persons at Hiroshima.

Terrorists Fire At Cafe Dancers

PARIS (AP)—Two gunmen, believed to be Algerian terrorists, opened fire on dancing couples in a crowded cafe Sunday night, killing two persons and wounding six.

Police said the gunmen may have picked the wrong cafe for the attack. All the victims were Europeans and the cafe owner said he had no Algerians among his clientele.

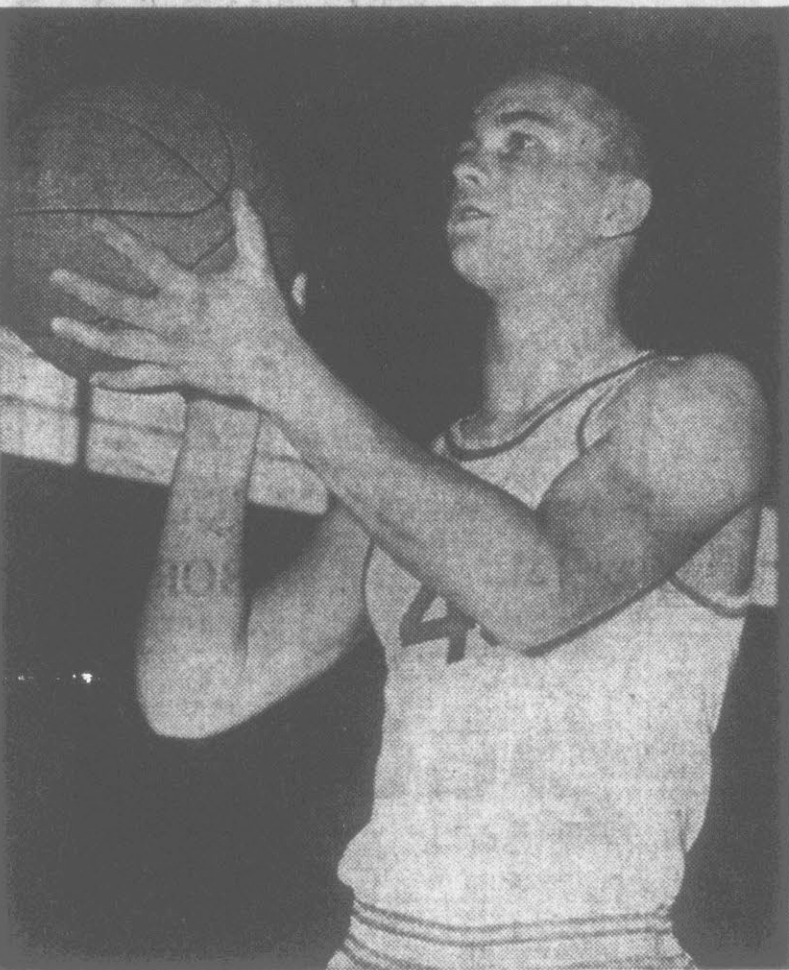

Kansas State, with games Friday and Saturday night in Los Angeles against UCLA and Southern Cal, respectively, had to fight before subduing Texas A&M 69-64.

Kansas plays St. John's in part of a doubleheader Friday night in New York's Madison Square Garden. The Redmen beat Army 69-49 Saturday. The Jayhawks also meet Texas Tech tonight after an opening 86-69 victory over Northwestern.

Utah State showed it may be ready to take over for Utah in the Skyline after beating NYU in the final six seconds 67-65. But Utah State has three more games on the road, meeting Detroit tonight, Nebraska Wednesday and South Dakota State Friday.

Utah's dreams of grandeur really went crashing Saturday Saturday night in a 59-56 loss to Stanford after being upset last Thursday by Loyola of Los Angeles. Villanova, after a victory, came back to earth when Buffalo pulled a 63-62 upset.

ECC Blossoms Late To Win 80-63

East Carolina's basketball team kept its fireworks bundled for some thirty-two minutes here Saturday night but skyrocketed to an 80-63 North State victory over Catawba with a fusillade in the final eight minutes of action.

The Bucs, who gained a high rating in pre-season speculation, disappointed a full-house Memorial Gymnasium following, estimated at 2,800, for the larger portion of the home opener but finished in a blaze of glory that brought the lackadaisical crowd to life, sending them home with victory on the tip of their tongues.

Catawba, the defending conference champions and listed among the tail-end clubs this season, had an upset within their grasp for most of the contest, outscraping and outthust-

ing the Pirates from the outset. Thanks to the shooting of Cotton Clayton, who scored 12 points in the first half, East Carolina was able to stick with the Indians in the first half.

Faced by Jimmy Dew, a newcomer, and Roger Snow, Catawba employed a deliberate style of attack that produced dividends in the first half and kept East Carolina, as well as its fans, frustrated.

After East Carolina moved out front 2-0, Catawba shot into the lead and at several times held a point spread as large as five points.

A spurt midway the first half saw East Carolina score three straight buckets and jump into a 17-16 lead. Danny Bowen making the field goal that pushed EC ahead.

Lacy West and Clayton bagged away with a couple of two-pointers and East Carolina look-

ed ready to move, leading 22-18. Two field goals by reserve Tom Childress rallied Catawba into a 30-27 lead. Don Smith dropped a bucket just before the halftime buzzer, cutting the lead to 30-29.

Action didn't change early in the second half. Catawba holding to its bulldoggish lead most of the time. The scrappy Indians led by four points on several occasions and moved ahead 47-41 with 10 minutes remaining.

A couple of fast breaks, Clayton leading the charge, moved East Carolina to within one point, 47-46. With eight minutes remaining, Bill Otte dumped a two-pointer to tie it at 51-51 and Clayton followed with a jump shot, giving East Carolina a 53-51 lead.

The final seven minutes were clear sailing for East Carolina who won its third conference

game in as many attempts. ECC's only defeat has been to non-conference The Citadel.

Clayton and junior Charlie Lewis led the late barrage of baskets. It was also the same duo that came up with several ball thefts in the final minutes of play to enable East Carolina to win by a comfortable margin.

Clayton, the sophomore ace, led the scoring with 28 points. It was high for an East Carolina player this season. Don Smith followed with 16 points and Charlie Lewis finished with 15.

Jimmy Dow was top man for the losers with 15 points and Tom Childress supplied 12. Roger Snow also cracked double figures with 10 points.

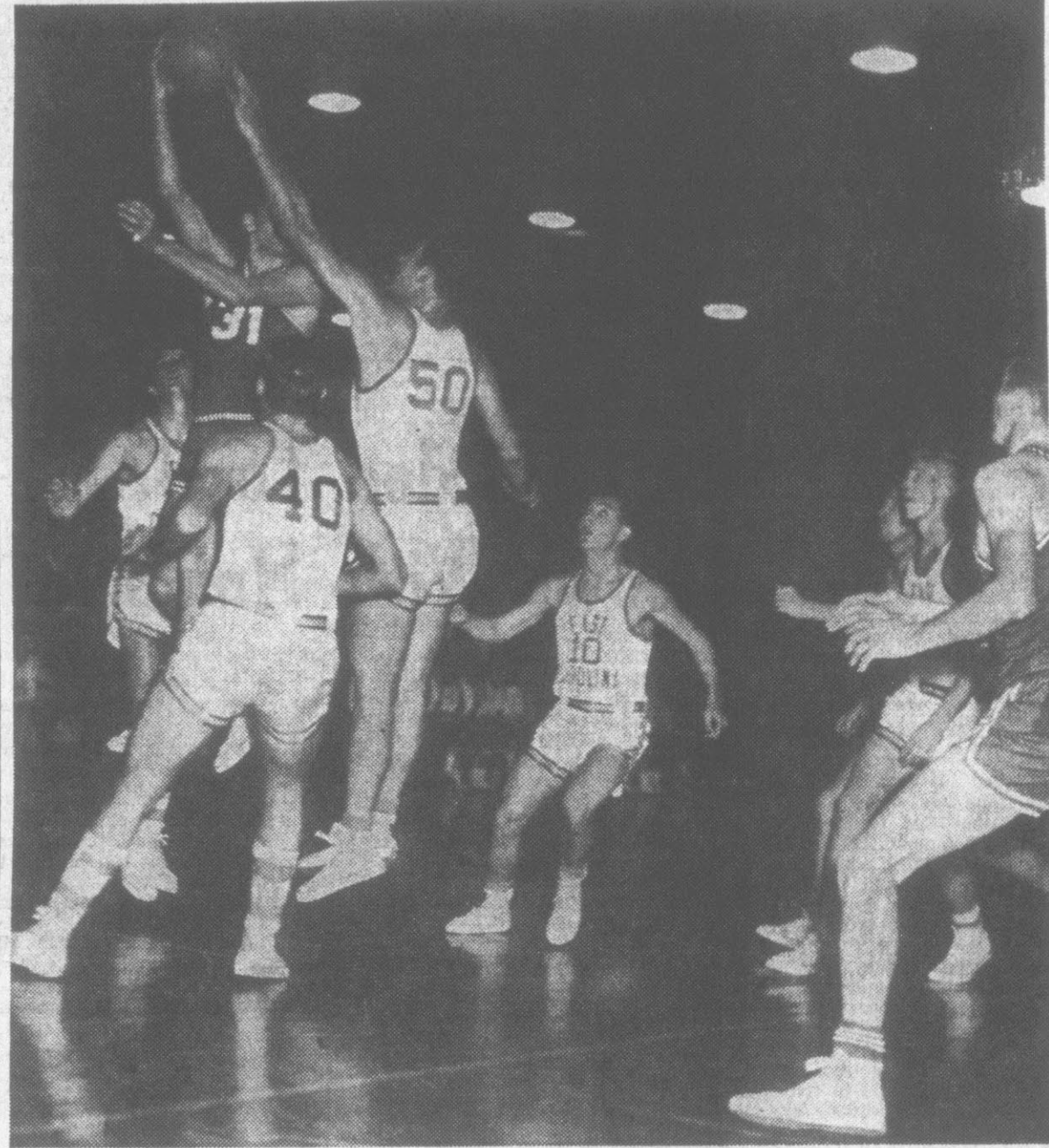

Eagles Clinch NFL Title, 'Skins Lose

The National Football League championship game will match Philadelphia's streaking Eagles against Baltimore or Green Bay or San Francisco or Chicago or Detroit.

That was the situation today, with only two weeks left in the regular season.

The Eagles clinched their first Eastern Conference title since 1949 by whipping the St. Louis Cardinals 29-6 Sunday for their ninth consecutive triumph.

The Baltimore Colts, seeking to gain a playoff berth for an unprecedented third consecutive time, were beaten by the Detroit Lions 20-15 when Earl Morrall con-

nected with Jim Gibbons for a 65-yard touchdown pass on the last play of the game.

The loss dropped Baltimore into a three-way tie for first place in the Western Division with Green Bay and San Francisco, all with 6-4 records, while Chicago (5-4-1) and Detroit (5-5) remained solidly in contention.

The Packers, getting a 23-point performance from Paul Hornung that gave him 152 for the campaign and broke Don Hutson's 18-year-old one-season scoring record, walloped the Bears 41-13. The 49ers moved into position by blasting Los Angeles 23-7 before a

crowd of 77,254.

The Cleveland Browns grabbed the runner-up spot in the East with a 27-16 victory over Washington while winless Dallas tied the New York Giants 31-31.

Norm Van Brocklin, a 34-year-old veteran who was a rookie with Los Angeles when Philadelphia last captured the Eastern championship, passed for two touchdowns and Bobby Walston kicked a pair of field goals for the Eagles (9-1). Van Brocklin hit Pete Retzlaff with a 22-yarder, then pitched a 25-yarder to Tom McDonald after the Cards (5-5-1) had scored on Mal Hammack's

two-yard plunge in the third period.

The Colts scored what appeared to be the winning touchdown with 14 seconds left when Johnny Unitas, who had previously unleashed an 80-yard TD heave to Lenhy Moore, fired a 34-yard scoring aerial to the fleet halfback for a 15-13 lead. But Morrall, on the bench for the first three periods, completed a 17-point fourth-quarter surge for Detroit by whipping the clincher to Gibbons following the kickoff.

Hornung carried the Packers to their overwhelming triumph against the Bears by scoring

twice on a 10-yard run and a 17-yard pass from Bart Starr, kicking two field goals and five conversions while eclipsing the NFL scoring record set by Green Bay's Hutson in 1942. Chicago's touchdowns came on a 19-yard Ed Brown to Willie Dewveall pass and a 20-yard toss from Zeke Bratkowski to Jim Dooley.

The 49ers, using the double wing offense that proved effective in last week's triumph over Baltimore, built a commanding 10-0 halftime lead over Los Angeles (3-6-1) on a 10-yard scoring jaunt by C. R. Roberts and the first of three field goals by Tommy Davis

A 65-yard TD strike from John Brodie to Clyde Conner rounded out San Francisco's scoring before the Rams rallied on Frank Ryan's two-yard sneak.

Milt Plum had his first pass intercepted on his 196th aerial this season, but his three touchdown flips brought the Browns (6-3-1) from behind twice against the cellar-dwelling Redskins (1-7-2).

Eddie LeBaron's nine yard touchdown toss to Bill Howton in the final period gave the Cowboys their tie with the Giants (5-3-2) after L. G. Dupre scored three TDs, two on LeBaron passes, to keep Dallas within range.

Fullmer Looking For Bout With Ageless Archie

LOS ANGELES (AP) — NBA middleweight champion Gene Fullmer set his sights on 'Ol Archie Moore's version of the light-heavyweight title after turning back Sugar Ray Robinson's gallant bid to recapture the 160-round crown for the sixth time.

Robinson, described by his manager as heartbroken over Saturday night's draw with Fullmer, was considering hanging up his gloves.

"I've always wanted to try Moore on for size and now it looks as if I'll get my chance," said Fullmer.

Moore said, "After all, Fullmer should like to fight me. He'd be getting a shot at a really old man."

Moore, Fullmer and Fullmer's manager, Mervyn Jensen, met at a party after the Utah billy goat's battle with Robinson and tentatively agreed to terms.

Matchmaker George Parnasus, who staged the Fullmer-Robinson rubber match, left today for San Diego to finalize the deal with Moore, who insists on the champion's share of the gate.

Parnasus said he hopes to stage the Fullmer-Moore battle if plans work out, in April outdoors in Memorial Coliseum.

For their savage war Saturday, Fullmer took 40 per cent and Robinson 20 per cent of the gross rate of \$122,584 plus \$100,000 for television.

Fullmer, relying on bull-like rushes to wear down Robinson, guarded his jaw with his gloves as if he had a jowlful of jewels. Robinson tried to steal the jewels with some nifty combinations. Several times he shook the charging champion and in the savage 11th round he popped Fullmer with two right hand leads that would have knocked the head off a marble statue. But Fullmer merely blinked and flurried back.

The referee scored the fight for Robinson 11 to 4 under California's scoring system that gives the winner of a round one or more points up to five and the loser none. However, one judge voted for Fullmer 9-5 and the other judge called it a draw, 8-8.

American Loop Given Go Signal To Move To LA

ST. LOUIS, Mo. (AP) — The American League has been given the green light to go to Los Angeles next year.

The big if is that the league's 10th club must play its home games in the Rose Bowl in Pasadena.

That is the stipulation Dodger owner Walter O'Malley and National League President Warren Giles gave to a committee to present to the American League at today's meeting.

A counter proposal that would allow the new Los Angeles club to play its home games either in the Coliseum or in Wrigley Field was rejected by O'Malley.

"We thought enough of the Rose Bowl to survey it so I don't think there is any reason why they shouldn't give it some consideration," said O'Malley.

A committee of club representatives met in the commissioner's

suite late Sunday night in an 11th-hour attempt to reconcile differences between the two leagues and pave the way for the American League's expansion to 10 clubs in 1961. Giles and Joe Cronin, president of the American League, attended the special conference.

A member of the committee, weary after the four-hour session that lasted into the early morning hours, told the Associated Press:

"The proposition has been made. Now it is up to the American League and the group selected to operate the franchise."

Cronin and Giles appeared optimistic.

"I'm confident that something will be worked out," said Giles. "It may not make everybody happy, but it won't be a fight."

The Rose Bowl is a football stadium that seats 100,000. It is about 15 miles from Chavez Ravine, where O'Malley is building

a stadium for his Dodgers. The park is expected to be completed sometime in 1962. The Dodgers now use the Coliseum.

The American League is not completely happy with O'Malley's compromise proposal. Some owners feel the Rose Bowl is not suitable for major league baseball.

Four groups are bidding for the franchise. The successful one will be a group that includes Gene Autry and Bobby Reynolds, former Stanford tackle. Kenyon Brown, Los Angeles TV executive who formerly headed the group, will play a major role in the new operation.

The American League has asked O'Malley to meet with Autry and Reynolds today. The Dodger owner indicated he would.

"The type of organization with which I will have to compete is more important than the money involved (compensation)," O'Malley said. "This group (Autry's) is not objectionable."

Some American Leaguers still held out hope that the National League might go along with the 9-team proposal and an inter-league schedule.

"I wouldn't bet on it," said one. "but I know that O'Malley has been picking up votes here and there. I don't think he has enough, however."

There was a report that the American League, at its meeting, will approve the sale of the Kansas City club to a group of Kansas Citizens. The sale has not been announced.

South Carolina Wins Via Air

CHARLOTTE (AP)—The story of South Carolina's 19-3 Shrine Bowl football victory here Saturday was written in the air for all the 23,000 spectators to see.

Coach John McKissick's Palmetto forces scored on passes three times and five times they intercepted tosses by the North Carolina team that was supposed to hold the advantage in the passing department.

A pair of quarterbacks and two ends combined for the scoring plays that gave South Carolina its eighth victory in the 24-game series against 12 North Carolina triumphs and four ties.

It was the first time since 1944 that North Carolina had failed to score a touchdown and only once (27-7 in 1954) has a Tar Heel team been more thoroughly trimmed.

As McKissick, Summerville High School coach, summed it up, "My boys didn't let mistakes and breaks get them down, but just kept coming. We kept getting better all the time."

The game started ominously for South Carolina, with three first-period fumbles. One led to the lone Tar Heel tally, a field goal from the 25-yard line by Elkin end Steve Holloway.

But after that the Palmetto forces took charge and won handsomely. They scored in each of the first three periods.

Quarterback Jim Tom Oliver of Orangeburg threw two touchdown passes and another quarterback, Jerry Priestley of North Augusta, tossed one.

Walter Goldman of Greenwood caught two of them, one for 5 yards and another for 10. Goldman, not on the original squad list announced three weeks ago, was an added starter. He joined the team a week ago at the start of practice.

The third touchdown came on a 84-yard pass play, Oliver to Alton Buddin, end from Greenville, who ran the last 27 yards after the catch.

Priestley was voted the award as the outstanding back by a special Shrine committee. He completed four of his six passes for 47 yards and a touchdown and ran 8 times for 21 yards.

Tommy Brawley, 219-pound tackle from Mooresville, was voted the top lineman.

South Carolina rolled up a total of 307 yards against 147 and had a 17-8 edge in first downs. Five lost fumbles slowed the Palmetto attack, but they made up for those lapses with five interceptions, two by John Johnson of Winnsboro.

The top ball carriers were Billy Ward of Columbia, 49 yards in 13 carries; Mike Derrick of West Columbia, 41 in 11; and Gene Isenhour of Hickory, 41 in 13.

New Orleans School Boycott Weakens A Bit More Today

NEW ORLEANS (AP)—The boycott of an integrated elementary school weakened a bit more today with 15 to 17 white pupils turning out for classes.

They showed up at the William Frantz School where one Negro girl is enrolled in the first grade. The previous high white attendance, since the school was integrated by federal court order, was the 10 who went to classes Friday. There are 500 enrolled.

Jeers and taunts from women demonstrators greeted the white children and the Negro girl met a chorus of boos when she arrived.

"You're as black as they are," shouted one woman at the white children.

"Nigger lover," yelled another.

At McDonogh No. 19, the other school integrated on Nov. 14, only the three Negro girls in the first grade entered the building today. Its enrollment was 500.

However, police patrols at the school were enlarged amid reports that white pupils would break the McDonogh boycott today.

The Louisiana Legislature gave quick approval Sunday to a bill providing state aid for pupils who prefer to attend private schools. The legislature, despite a federal court order not to interfere with the operation of New Orleans schools, is bent on preserving segregation.

Moving quickly to meet the expected demand for private schools, volunteer workmen rushed repairs Sunday on a building in suburban Arabi to be used for some of the white students for the two schools.

C. E. Vetter, businessman, said so many workers showed up at the building that some had to be turned away. Registration at the private school was scheduled today and Tuesday. Classes were expected to start Wednesday.

A Methodist minister who has ignored screaming, cursing white women to accompany his daughter, Pamela, 6, and other white children to the Frantz School, was jeered again Sunday by a small group as he conducted services at two churches.

Four women walked out of services conducted by the Rev. Lloyd A. Foreman at the Church of the Redeemer. One told an usher "He's a nigger lover."

The minister conducted services later in the morning at St. Mark's Methodist church. A man standing outside the building was led away by companions after he shouted, "I'll challenge that louse, the rat."

Foreman did not mention the school demonstrations in his sermons. At the evening service he pleaded for guidance for state and city officials in "these days of crisis."

In addition to providing an alternate school system the legislature approved resolutions designed to prevent banks from handing over school funds to the New Orleans School Board.

Predict Record Output After Brief Recession

WASHINGTON (AP)—National production should reach record levels next year despite higher unemployment and a brief recession early in the year, a U.S. Chamber of Commerce economist predicts.

Dr. Emerson P. Schmidt, the chamber's director of economic research, said the brief slowdown should bring a drop of 5 to 10 billion dollars in the annual production rate during the setback.

Schmidt made his predictions Sunday to a chamber business outlook conference despite cautiously optimistic reports from the auto, steel, banking and building industries.

He said he expected a recovery in the second half of next year to send total output of goods and services to a record rate of \$515 to \$520 billion a year from now. For the first nine months of this year, the production rate was \$503.5 billion a year.

Peiping Accepts Guidance Of Moscow Leaders

MOSCOW (AP)—Communist China's president today put a stamp of approval on the peaceful coexistence policy of the Soviet Union as it apparently has been ratified by the Communist summit conference which ended last week.

In a goodbye speech at Leningrad, before continuing his tour of the Soviet Union, President Liu Shao Chi made a confession of faith in Soviet leadership.

"The great Soviet Union," he said, "has always been and is today a powerful bastion of world peace. The initiative of the Soviet government and its proposals aimed at easing international discord and peaceful co-existence between countries with differing social systems have the sympathy and support of all peace-loving nations and peoples."

He said further that the recent summit conference, "resulted in a still further strengthening of the cohesion of the entire Communist movement and in a still further strengthening of the solidarity between the Communist party of China and the Communist party of the Soviet Union, between the People's Republic of China and the Soviet Union."

(Moscow radio broadcast Liu's speech but this dispatch was delayed in passing through censors).

Pravda, the Soviet Communist party newspaper, published a long editorial a week ago in which it stated that peaceful coexistence as interpreted by Premier Khrushchev is the correct interpretation.

Coming as it did near the end of the conference, after more than two weeks of debate, it sounded as if the Soviets had laid down the law as they saw it.

The speech by Liu Shao Chi was his way of saying that the man who pays the piper calls the tune. In his speech, he made it abundantly clear by pointing out that China's industrial and technical advances were heavily dependent on Soviet production.

"You manufacture for our country a great amount of intricate equipment," he said, "make available to us a great amount of designing, documentation, send us skilled specialists, train for our country a great number of technical specialists."

"All this is part of the tremendous assistance rendered by the Soviet government and the Soviet people to our country's social construction."

Peiping Accepts Guidance Of Moscow Leaders

MOSCOW (AP)—Communist China's president today put a stamp of approval on the peaceful coexistence policy of the Soviet Union as it apparently has been ratified by the Communist summit conference which ended last week.

In a goodbye speech at Leningrad, before continuing his tour of the Soviet Union, President Liu Shao Chi made a confession of faith in Soviet leadership.

"The great Soviet Union," he said, "has always been and is today a powerful bastion of world peace. The initiative of the Soviet government and its proposals aimed at easing international discord and peaceful co-existence between countries with differing social systems have the sympathy and support of all peace-loving nations and peoples."

He said further that the recent summit conference, "resulted in a still further strengthening of the cohesion of the entire Communist movement and in a still further strengthening of the solidarity between the Communist party of China and the Communist party of the Soviet Union, between the People's Republic of China and the Soviet Union."

(Moscow radio broadcast Liu's speech but this dispatch was delayed in passing through censors).

Pravda, the Soviet Communist party newspaper, published a long editorial a week ago in which it stated that peaceful coexistence as interpreted by Premier Khrushchev is the correct interpretation.

Coming as it did near the end of the conference, after more than two weeks of debate, it sounded as if the Soviets had laid down the law as they saw it.

The speech by Liu Shao Chi was his way of saying that the man who pays the piper calls the tune. In his speech, he made it abundantly clear by pointing out that China's industrial and technical advances were heavily dependent on Soviet production.

"You manufacture for our country a great amount of intricate equipment," he said, "make available to us a great amount of designing, documentation, send us skilled specialists, train for our country a great number of technical specialists."

"All this is part of the tremendous assistance rendered by the Soviet government and the Soviet people to our country's social construction."
