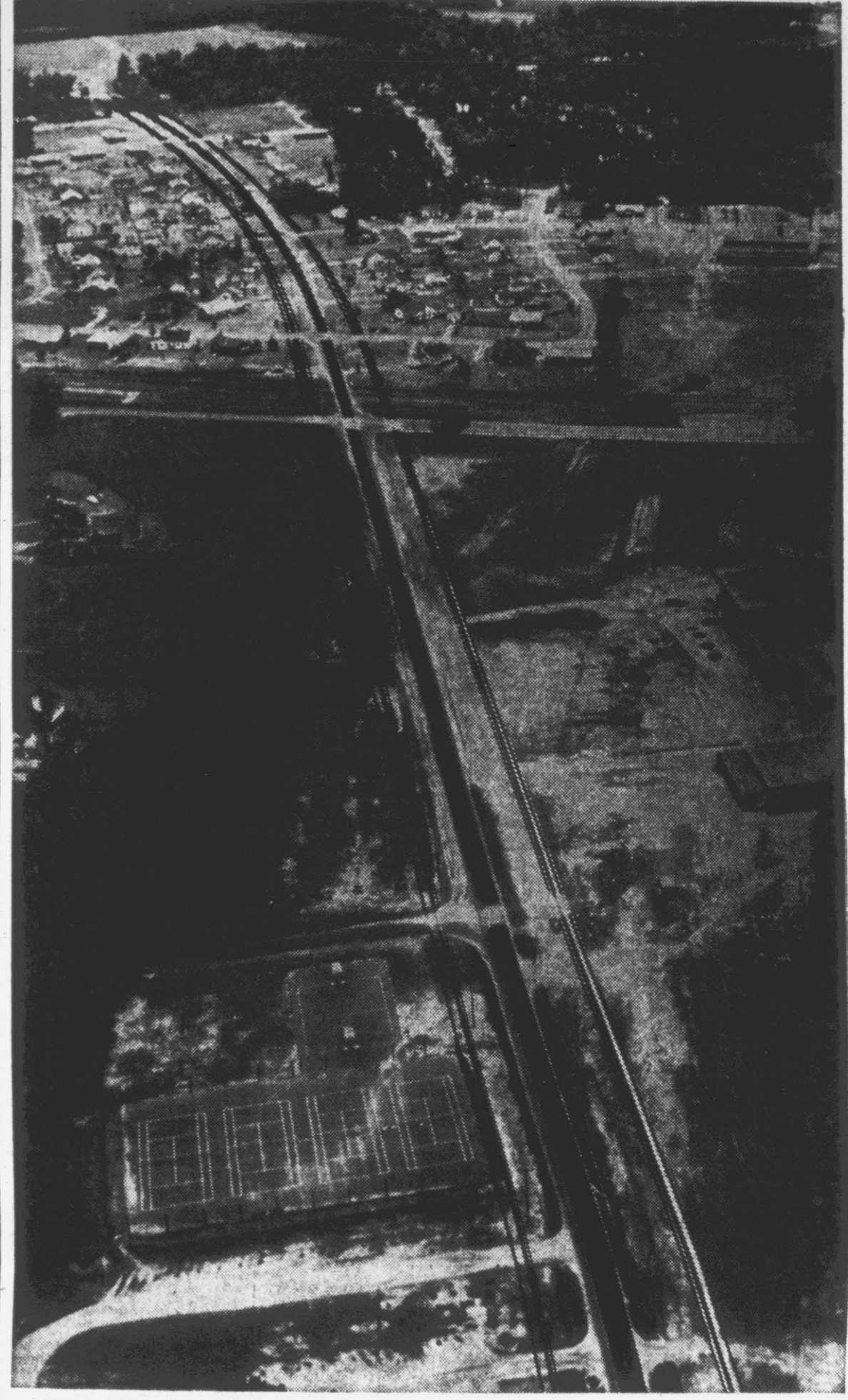

LEOPOLDVILLE, the Congo (AP)—Congolese sources claimed today the U. N. commander has met one of their chief conditions for allowing U. N. soldiers to return to their supply port.

UNITED NATIONS, N.Y. (AP)—African delegates to the U. N. General Assembly pressed today for immediate debate on the Congo as the big powers remained deadlocked over whether to take up cold war issues at the Assembly session.

A unique flower show, featuring arrangements corresponding to the forms and colors characteristics of famous artists in 11 categories, will be held Tuesday at the Greenville Art Center.

The show will be open to all six garden clubs of Greenville and will feature two divisions, the first including 11 sections captioned by different artists, and the second division with classes featuring stone, wood, found objects and sculpture.

Lakewood Pines Garden Club, headed by Mrs. H. R. Billica as president, and Mrs. R. P. Heller as show chairman, will sponsor the event. Theme of the event will be "Still Life Uncaptured," and it will be open to the public from 1 until 5 p.m. Tuesday. Entry time is 9:30 a.m. on Tuesday, and judging, by a secret panel, will be completed by one o'clock.

The form and color of each arrangement entered will correspond to the use of form and color, which is characteristic of the specific artist.

Description

Following is a description of each of the 11 artists, and a resume of what is expected from participants in individual categories:

Section One begins with the artist Hilaire Germain Edgar Degas (1834-1917) a French painter whose works greatly influenced modern painting. Although he worked with the Impressionists, his style was his own. His ballet dancers and bathers, now represented in almost all modern museums, have great beauty of line, symmetrical balance and often a delicate charm of color. The two classes under Degas call for arrangements with emphasis on pastel colored flowers.

Section Two is captioned Dali. The art movement known as Surrealism is best exemplified by Salvador Dali (1904-). Individual details in his paintings are shown with careful and precise realism, but things and qualities are combined in ways which never occur in actual life. In this way the artist gains the total effect of dreamlike unreality. Distortion, or altering the natural shapes, colors, and proportions of things, is practiced as a matter of course. The two classes under Dali should feature fantasy, weird psychological effects, exploring the dream world.

Section Three Claude Monet (1840-1926), French painter of landscapes, who was one of the leaders of the Impressionist group of French painters. Monet's paintings were based on his theory that no object has a definite fixed color, but is colored by the way the light strikes it at a particular moment. Monet also had a certain way to paint bright colors. He did not paint an object violet by mixing blue and red together on his palette. Instead, he placed little touches of red and blue side by side on the canvas. This artist suggests the three classes stressing monochromatic color, analogous color and textures.

Section Four is Raphael (1483-1520), who was one of the greatest painters and architects of the Italian Renaissance. Some critics consider Raphael's "Sistine Madonna" to be the world's greatest painting. Raphael's art expressed the serenity, grace and order of the Italian Renaissance. Famous for his Madonna and religious paintings, the two classes suggested by Raphael will be an Easter arrangement featuring a Madonna and a mass arrangement appropriate for church.

Section Five is Vincent Van Gogh (1853-1890), a Dutch painter. His pictures in intense, daring colors became well known after his death. He was influenced somewhat by the French Impressionists, but his art is fundamentally different from theirs. It is highly emotional and closely related to expressionism. This section of the show will stress color and texture.

Section Six is Henri Matisse (1869-1953), a French artist and a leader of the Modern school of

painting. His colorful, rhythmic and poster-like pictures have earned him the name of the foremost decorative painter of his time. His paintings, simple in design and rich in color, are highly decorative and do not pretend to be true to life. The important part of his art is what modern artists call "form" or "plastic design," a quality which seems to be made up of rhythmic outlines, melodious colors, rich play of textures and the arrangement of objects. The show scheduled calls for a line-mass Hogarth arrangement and a parabolic arrangement stressing brilliant color.

Section Seven is Grandma Moses (1860-) is an American primitive painter. Her paintings, which today hang in many museums, picture country scenes in gay colors. This section will depict arrangements with a primitive or Early American charm.

Section Eight is titled Rembrandt. His full name was Rembrandt Harmens van Rijn, but he is known best by his first name. The greatest of all Dutch painters, his work showed great range of imagination, for he was equally great in painting religious scenes, portraits, scenes of everyday life and landscapes. Rembrandt's colors had a deep glow, and the masterly blending of light and dark and visible and the invisible, which seemed to make forms come out of the dark background, gave his paintings depth and intensity. The deep, warm browns and reds of Rembrandt's painting suggested the deep, warm browns and reds of dried materials used for arrangements.

Section Nine is Winslow Homer (1836-1910), an American painter who became famous for his pictures of the ocean and fishermen. Shells, sand, driftwood and dried plant materials will be used in these arrangements and composition.

Section Ten is headed by Audubon. Noted for his nature studies this class calls for birds as accessories to the floral arrangements.

Section Eleven has Japanese artist Kano Sanraku for the heading. The arrangements in this section will show a Japanese influence.

Washington, it seems, is in a state of minor turmoil over the question of a suitable memorial for FDR.

A commission headed by Francis Biddle has come forward with an elaborate plan for erecting a monument composed of colossal plaques in a landscaped setting in West Potomac Park. A Different Memorial

Now, however, Representative Charles Bennett of Florida has suggested the creation of a Franklin D. Roosevelt Institute on the same site. This Institute would be primarily a graduate school for political science, and its purpose would be to train highly selected individuals for government service.

Meanwhile, Mr. Roosevelt's own wishes in this matter, which he entrusted to Justice Frankfurter in 1941, have been pushed aside. All that he said he wanted was a small slab placed in the green triangle in front of the Archives Building and inscribed "In memory of Franklin D. Roosevelt."

The whole story of the late President's request is told by Frankfurter in a brief article in the current Atlantic, which also contains a letter from Biddle justifying his decision to ignore it.

Gerald Johnson There is also Gerald Johnson's proposal, already referred to in this column, that the whole thing be forgotten until Roosevelt's place in history is more fully defined.

Speaking of Johnson, this tough old ex-Tarheel has just come out with another book, "The Man Who Feels Left Behind." It is in favor of the television western. This is what one would expect because Johnson is not only tough, but able to think, and to write what he thinks in clear terms—a rare combination any time.

Start Of The Decline Of TV Westerns Indicated

There is one important sign: So far the three television networks have announced a total of 21 new shows which they plan to put on their fall schedules. Not one is a western.

However, the interest in action stories, mostly police and adventure tales, apparently is stronger than ever: 12 have been announced.

Emphasis Is Put On Rural Roads

RALEIGH—A plea to legislators for improvement of rural roads in North Carolina was sounded at a House Committee meeting by Merrill Evans, Chairman of the Highway Commission.

"We hope you will give us some relief on the rural road problem in North Carolina—it is pathetic," implored the Highway Commission head, as he spoke to members of the House Roads and Highway Safety Committee.

Explaining that he had no specific request at present, but that he wanted to take every opportunity to acquaint members of the General Assembly with the pressing needs of the state regarding improvement of rural roads in the state, Evans continued:

"The Highway Commission is a servant of the General Assembly; we can only spend the money that you appropriate."

The chairman of the Highway Commission told the representatives that "it isn't pleasant to have to deny requests," and that his office is continually receiving calls and complaints about conditions of rural roads.

"We lack money to keep rural roads even where they are now," he declared.

Evans concluded his plea for more legislative attention to rural roads in North Carolina by requesting the Assembly's help in both building and maintaining these secondary roads.

Blind Teacher Can Fill Role

KETTERING, Ohio (AP) — Although he lost his sight in 1956 and can distinguish only shapes and dark and light, David Rayburn teaches blind students at Fairmont High School, coaches the golf team and heads the visual education department.

Student assistants help Rayburn with much of his work and friends record his books and lab manuals on tape. His golf team has lost only three matches in five years.

Would Do Well To Consider Future

The questions of school district lines in Pitt County, the bonded indebtedness of the various district, and possible future consolidation of schools are closely interrelated.

Each has a direct bearing on the other. Since the question of altering a few of the district lines in the county already has arisen, this appears an appropriate time for the Pitt Board of Education to delve into these questions from the standpoint of long-range planning for future development of the school system of the county.

Already there is an overlapping of the Greenville corporate limits into the Winterville school district which appears to require the attention of school officials. The Board of Education is in the process of con-

sidering division of the Athur School District between the Winterville and Farmville districts since there is no longer a school in operation in the Athur District.

Since these matters already have come to the fore and require attention of the Board of Education, there might be considerable benefit in the Board's considering now future possibilities that may develop.

The matter of further consolidation, particularly on the high school level, is certain to become a matter of increasing importance for the county in the years ahead. Throughout the state the move has been toward high schools with larger enrollment than many of those in Pitt in order to provide a broader curriculum for students. A number of high schools, because of their small size, find it impossible to offer certain desirable courses because of their limited number of students who desire certain courses.

The creation of larger high schools through reasonable consolidation offers at least one opportunity to provide better educational advantages to many students who now are enrolled in some of the smaller high schools.

Any program of consolidation of existing high schools in the county would of necessity have to be a long range program that would require considerable study and planning. It would involve not only the question of consolidation itself, but likewise district lines, bonded indebtedness of individual school districts and other complex problems as well.

Since the Board of Education has to take up the matter of some district lines now, it would appear advantageous for the county if the board would at the same time project some of the possible alterations over the county as a whole in connection with a long-range program for further development of the county's school system.

1964 Candidate Not Yet Evolved

1964 — Tradition decrees that the next Governor of North Carolina shall come from the western part of the state. But tradition does not fix the exact line where the west begins. Long established custom also has been for the politicians to begin grooming prospective candidates for Governor and other high offices three to eight years before the time they will enter the nomination primaries.

There is further tradition or custom, since North Carolina for many years has been a one-party (Democratic) state, the candidates for Governor must represent either the conservative or the liberal viewpoint of the party. When the chips were down, North Carolina voters generally have chosen middle-road-ers, with slight favor for liberals. In 1936 when choice was among extreme liberal Ralph McDonald, extreme conservative Sandy Graham and middle-road Clyde Hoye, the voters chose Hoye. In 1948 with extreme liberal Mayne Albright and very conservative Charles Johnson and middle roader, leading to the liberal view, Kerr Scott the voters chose Scott. In 1960 when the showdown came between conservative Beverly Lake and liberal Terry Sanford the voters chose Sanford.

The advance — planning politicians already are working on the 1964 campaign. They are weighing the advantages of Woodrow Jones of Rutherford, former congressman and former Democratic State chairman, and Basil Whitener of Gaston, incumbent congressman of the 11th district, former YDC State president, as banner carriers for the conservative element. Cloyd Philpott of Davidson, incumbent Lieutenant Governor, appears to be the choice of the middle-road group. Who will represent the extreme liberal element has not been determined. He may evolve out of the current legislative session.

TOO EARLY — Many astute political observers believe it is too early to start movements for or against any candidates in 1964. It is believed that developments in the 1961 and 1963 General Assemblies, and the trend of economic conditions which depends to considerable degree on attitude and actions of the Kennedy national administration, will have controlling influence on the 1964 voting.

There is precedent both for and against the advantage of an early start in the build-up for a governor's race. Ralph McDonald moved in back in 1936 to displace several candidates who had been working on the campaign for years, but he lost to Clyde Hoye—who had been on the make for years. However, he ran ahead of Sandy Graham, another long range planner. In 1948 Charlie Johnson, who had been regarded as certain candidate for at least 12 years — with betting odds favoring his nomination — lost to Kerr Scott, a relative newcomer in the field.

Last year John Larkins, who had long been regarded as a potential trailed a four-way

ticket and Beverly Lake, mentioned only for a couple of years in advance, got into a second primary with Terry Sanford, who had been running for at least a decade.

The advantage of early grooming is obvious. People generally do not want to vote for candidates they have never heard about. The disadvantages also are obvious. The early birds sometimes run into positive alignments and commitments which later prove very embarrassing, but which they cannot shake.

Looks now like the 1964 field is as wide open as ever a race has been so far in advance. And that reminds of the wisecrack by a political observer the other day. Recalling the criticism of Kennedy because of his Catholic faith last fall, and the trouble he is having now with his own churchmen about Federal aid to Parochial schools, this politician said he reckoned the Democrats would have to get an ardent Protestant candidate for President in 1964 in order to assure the Catholics of equal rights.

TWO-TIMERS — A couple of coastal legislators were observed in close conference the other day. Your reporter walked up and facetiously asked "who is trying to two-time you now." We've learned better than that, responded one of the men. For many years we spent so much time and energy trying to two-time each other on the coast, the upstate fellows who stood together made monkeys out of us. Now we're getting together and can present a solid front.

Actually, the man was bragging a little bit. There is still a lot of jealousy and conflict of local interests resulting in waste of energy for overall area development. But there can be no doubt that there is more cooperation among the communities along the coast, the communities in the mountains, and the big centers in mid-state, for both regional and overall state development than there has ever been before.

There are many problems shared by people in the Nags Head area, the Morehead City and Wilmington sectors which up state people cannot fully appreciate. The folks around Boone and residents of the Sapphire country west of Asheville have both diverse and common interests. Happy Valley and the Land of the Sky have more in common than they used to realize. Despite controversy and rivalry among chambers of commerce at Greensboro and High Point and Winston-Salem, Charlotte and Gastonia and Hickory, it is surprising how much they have in common.

The semi-facetious quip by the coastal legislator that the Easterners are getting together to "two-time" the upstaters, serves mainly to emphasize that to greater degree than ever before the general regional areas of North Carolina are working together to promote their local interests, and the welfare of the whole state.

Pitt County would not be facing up to reality if it did not recognize the fact that there remains only a remote possibility at this moment that it will retain two House seats after this session of the legislature.

The reapportionment bill that would take House seats away from Pitt, Johnston, Buncombe and Cabarrus Counties and give additional seats to Onslow, Mecklenburg, Alamance and Cumberland already has passed two readings in the House. The third reading was delayed until next Tuesday in order to give Rep. Frank Wooten of Pitt and Rep. Roy C. Coates of Johnston time to submit a new reapportionment measure.

Even if the Wooten-Coates measure can be submitted officially by Tuesday, the intervening period leaves little time for them to rally sufficient support for their measure to stave off final House approval of the reapportionment measure that already has been approved on two of the required three readings.

It should be further pointed out that the present measure causes four counties to lose representation in the House and four to gain. The other 92 counties will retain their present status, and therefore they might not be as vitally concerned over reapportionment as the eight which will be directly affected. Another factor is that reapportionment under the Kemp bill would not disturb the relative East-West strength in the House. Two counties in the east would lose seats and two would gain; two counties in the west would lose seats and two would gain.

The Wooten-Coates proposal would be much more involved, advocating increasing House membership from the present 120 to 150. Under the plan each county would be guaranteed one representative and the remaining 50 seats would be allocated to counties on the basis of population. Tentatively the plan would likewise provide for freezing the present Senatorial districts on their current basis. The proposal has merit, but it likewise has a number of built-in handicaps so far as obtaining legislative endorsement is concerned. And, as we pointed out earlier, time is a factor that now works against this alternate proposal for reapportioning the House.

Kennedy Image Being Developed

WASHINGTON (AP) — On TV screens around the country President Kennedy's news conferences look quick and simple. They're quick. But they are not simple.

He's now had six meetings the press, enough to show at least this much: He follows a deliberate pattern which he established himself; and his technique, much more subtle, is still developing.

This is the pattern: From the very beginning Kennedy—who won election by a squeak, has used his news conferences to get across an impression of himself as a man in motion.

Example: The series of announcements he makes at the start of each conference. Wednesday there were eight, ranging from plans for a White House reception to orders he has given to relieve hardship among Indian and Eskimo children. All could have been announced by his press secretary, Pierre Salinger.

By doing this himself Kennedy stays in the public eye as a very busy President. He is, indeed, busy as his various programs and messages testify. The news conference announcements, even though many are of secondary importance, add to the total impression.

His technique — he handles himself easily, fluidly, and fluently. He's relaxed. He's relaxed because he's doing his homework, knows what he's talking about, took the trouble to inform himself before confronting questioners. Two hallmarks of President

Eisenhower's news conferences were vagueness and generalities. This was particularly true in his early White House days. Kennedy at most times is specific. Eisenhower, because of his lifetime in the Army, didn't know government details well when he took office. Kennedy has an advantage here: Because of his 14 years in Congress, he knows government pretty much inside out.

A good example of Kennedy's specific knowledge was in his statements Wednesday on federal aid to education. But his technique began to show a change Wednesday. The best example, again, was on federal aid to education.

While Eisenhower rambled, Kennedy usually has been direct and terse. Wednesday he was for the most part direct but less terse. He not only explained his thinking on federal aid at great length, but did it repeatedly.

It looks like a deliberate, planned effort to educate the public, through press and radio, on the problem as he sees it. That, while federal aid to public schools is needed, similar aid to parochial schools hits constitutional blocks.

This change in technique—long explanation which took up a lot of time — gave newsmen less chance to ask varied questions and cover more ground. The result, from a news standpoint, was pretty dull.

That ought to give Kennedy something to chew on. He can defeat his purpose — educating the public on his viewpoint — by long explanations, he winds up diminishing public interest in what he has to say.

So--Hal Boyle Dropped In

One of the distinguished personages of the newspaper world stopped in Greenville last week. That was Hal Boyle.

Regular Reflector readers will remember that by-line; we've carried Boyle's work, off and on, for almost as long as I've been with the paper about 15 years. . . . and probably longer than that. The reason for such an assumption is that he made a name for himself as an Associated Press correspondent in World War II; and I can't imagine past Reflector editors ignoring stories that were to earn Boyle a Pulitzer Prize in 1945.

It may be said in passing that this writer read some of the wartime correspondent's stories, and they are remembered as close-up glimpses of men meeting their greatest crises. . . . as seen with the eyes of love.

In this Hal was much like that faded contemporary, Ernie Pyle. Ernie was another Pulitzer Prize-winner (1944). Some of our elders may recall Ernie Pyle marched and hitchhiked through the North African and ETO campaigns. When the fighting stopped in Europe he hid himself to the Pacific where

others of his beloved GIs were still in action. Ernie died, with some of his favorite people, on the frontlines. But back to Hal Boyle.

The occasion of his visit to eastern North Carolina was a speech before the Co-C of Washington (N.C.). Inasmuch as The Reflector is a member of the Associated Press family, we regretted an informal visit, too. Regrettably, no deathless prose marked the occasion.

I remember saying something about "I'm proud to shake the hand of a man who can write four or five columns a week". And he grinned and volunteered it could be pretty hard, sometimes. Our city editor offered the visitor a re-write job; but this was rebuffed with a reminder that this was a vacation.

Such scintillating conversation doesn't do justice to Boyle. A man of medium height, inclined to having a paunch, a receding hairline, a broad grin, mild of voice and manner, he bears the stamp of introspection. There was that about him (or it might have been an impression gained from his writings) that he is sympathetic to the human race. . . . a high-

flown way of saying he loves people but shies away from conceding he is one of them. He is a born observer. Our brief encounter left the thought he would find it difficult to say or write an unkind thing about another.

Boyle was coaxed, urged or pushed into continuing as a columnist after World War II. His work will not spark revolutions nor provide readers with a keyhole perspective of the great and would-be famous people. It does serve to remind that "all the world's a stage".

I can tell, as well as if I'd been standing at his elbow, when columns are born with the sweating of blood. . . . and those occasions when the lamp of inspiration simply would not burn.

Well, I may wash my hand-shaking hand next month, if my wife lets me put it off that long. Imagine, shaking the hand of a man who writes four or five columns a week! How close can you get to the immortals?

Youth On The March

I stood before nearly 4,000 young people and beheld a new generation emerging to its own leadership. It was a mass meeting called in New York City by the Young Americans for Freedom, a youth organization, mainly by colleges and universities, which calls itself conservative and is not fearful of the consequences. Youth, at any rate in this organization, which now claims about 100 affiliated organizations on college campuses, rejects so-called liberalism as the frozen response of the 1930's to conditions then immediate. In the 1960's, these young people reject the New Deal, the Fair Deal, even the New Frontier as fogeyish. They prefer patriotism, national pride, capitalism to the compromises which the Rooseveltian philosophers tried to make with the driving force of Marxism.

These young people reject such compromises because they do not fear Russia; they only fear the prospect of compromise with Russia. Murray Kempton, a liberal writer once young, refers to the young Americans for Freedom as "children" which, of course, they are—as most of us are children of our forebears. I recall when I used to refer to Kempton as young but never as a child. Back in those days, articulate youth was divided among those who were Communists; those who adopted a middle-of-the-road liberalism which they could never define but which gave them a feeling of goodness; those who were opportunistic and hopped on the successful band-wagon of success, Democratic liberalism. And, of course, there was the vast majority who cared very little one way or the other and hoped that they would get fringe benefits as well as a wife before they joined the Army. It was, in some ways, a furious mood, but not more so than is usual among young people.

The Communists were the most active and the best organized. They knocked off conservatives by smearing them pitilessly; they absorbed liberals of flat or blackmail, which never served best. They infiltrated both the Republican and Democratic parties, as they did everything else, including business. They were imaginative and intellectually impressive. For about 10 years, they had a wonderful time. Then came the Rosenberg Case and the noise that McCarthy made and the weak-of-heart deserted the Communists.

The liberals were frozen in the postures they had adopted — growing no more, spreading out no more, creating no more — taking advantage of what they had accumulated like a miser counting last year's gains, but gaining nothing more. The Young Americans for Freedom represent not a reaction to the dead hand of 1930 liberalism. It is an affirmative statement of an altogether new generation and it will live or die not because of what oldsters have to say about it, but because of how its own generation responds to its enthusiasm and excitement. The old very rarely are willing to recognize that they have reared sons and grandsons not to obey them but to take over. Only too often, the older ones look upon the self-expression of youth as an infringement.

National Population Implosion

By ELMER ROESSNER

POPULATION BLASTS BLOWING PEOPLE FROM FARMS TO CITIES

A population implosion is swirling long-range planners and economists more than a population explosion.

The figure of speech is derived from nuclear weapons. The first atomic weapons produced explosions which blew outward; the more advanced types, by imploding toward the core of the bombs, created much more power.

In previous sharp increases in the world's population, the effects were usually explosive. Crowded conditions in Europe, in relation to productivity of the time, sent excess populations to new frontiers—to the Americas, to Africa, to Australia and to other far corners of the world.

Now growth is inward. "More land" was the cry that sent waves after waves of immigrants to less populated countries. But today rising tides of popu-

lation are not flowing out into uncharted seas; they are flowing back into the heavily populated parts of the world.

In Manhattan, the population remains static because most residential land is occupied and new office and industrial structures are reducing it by the minute. But the New York metropolitan area is swelling with new immigrants from less concentrated areas of the world. There are hundreds of thousands of immigrants from largely agrarian Puerto Rico; there are tens of thousands more Negroes from smaller cities and rural regions of the South; there are more thousands of fair-skinned young people from rural and small-town America, and there are still a few people coming in from Europe.

They pour into Manhattan but, as they attain economic status, they spread into other boroughs. IN OTHER STATES

This is not peculiar to New York. Into California, the nation's fastest-growing state, mil-

lions pour not into the rich valleys and mountains that made the state famous, but into the Los Angeles and San Francisco metropolitan areas. In the Midwest, farm populations decline, but Chicago, St. Louis, Detroit and other metropolises swell.

Around the world, the same phenomenon exists. Tokyo, London, Berlin and the cities of India are swelling. Population is being drawn from small towns as well as agricultural areas.

Rome, which for years has refused citizenship to migrants from the provinces, is now being forced to grant Roman citizenship to 300,000 provincials, who will now be entitled to votes, lawful employment and relief.

The population may grow larger than it was in the days of the Caesars.

Why? There is no single reason. The changing farm economy, in which small family farms make little to no profit while the massive, mechanized, government-subsidized "spreads" make millions, is one cause. The de-

or to accomplish something, but the chance is all that we are given. To get something, we must get something. The opportunity we must provide ourselves, and here is where we fall down.

Opportunity often means sacrifice if we are to take advantage of it. An acquaintance of mine who for years had wanted his own business passed up chance after chance because he was afraid to give up the secure job he held. Finally he took the plunge; he resigned from his job, invested his savings in a project of his own, and was successful. Opportunity had knocked often, but to no avail until he answered the knock.

Opportunities are many; people who seize them are few. Where do you stand?

And there are thousands of other causes, which compel more and more people to cower together in the slums of the cities of the world rather than face self-dependence on the barren hills of rural places.

And perhaps there is a psychological born of fear of atomic bombs, which makes people want to huddle together. (Recent researches indicate that fishes survive better in schools than as independents.)

But whatever the causes, the trend is with us today and for the next ten thousand morrows. Your plans in business, whether in manufacturing or distribution, may best take this long-term trend into consideration.

Nostalgia And Good Spirits Marked Truman Anniversary Observation

WASHINGTON (AP)—Former President Harry S. Truman Thursday night observed an anniversary and the occasion was awash with nostalgia and good spirits.

President Kennedy popped in to help celebrate the 20th anniversary of the creation of the Senate War Investigating Committee, which served as Truman's springboard to national prominence.

The dinner party was arranged by Charles Patrick Clark, who served as counsel for that long ago committee Truman headed. Many of Washington's most prominent faces—old and new, Republican and Democrat—beamed at the former president around the banquet table.

Visibly moved by many tributes, Truman who is 76 told them: "I'm going to do what I can (for the country), but I haven't much left."

Atty. Gen. Robert F. Kennedy, the President's brother, arrived early to get Truman's autograph on a picture made at the Truman's Library at Independence, Mo.

Just before the guests sat down for dinner—they included Vice President Lyndon B. Johnson, Chief Justice Earl Warren and Speaker Sam Rayburn—President Kennedy bustled in.

Kennedy, his blue striped shirt hardly in keeping with the black-tie affair, did a lot of hand-shaking, and hurried off into an adjoining room to greet a dinner for Democratic party fund raisers.

Kennedy told this group he will attend a May 27 fund raising ball to be given in honor of his 44th birthday.

He didn't mind, Kennedy said, that his birthday is really May 29. "Of course," the President said, "this is just an excuse on which to have a dinner to raise some money. I am told we owe a million dollars more than we thought we did. We certainly could not have afforded to lose this election."

National Chairman John M. Bailey estimated the party deficit at \$2.8 million.

To demonstrate his affection for Truman, Kennedy told the party dinner he hopes to attend a ceremony at Independence April 15 dedicating a Thomas H. Benton mural in the Truman Library. The mural depicts the starting of westward trail blazing from Independence.

Truman, in return, promised to come to Washington to speak at the May 27 party fund-raising dinner.

Vice President Lyndon B. Johnson said that there "never was a time, rain or shine, warm or cold, dark or daylight" that Truman ever ignored a plea from a friend.

There was praise, too, from Henry A. Wallace, Truman's predecessor as vice president, who was fired from the Truman cabinet, and by Sen. Styles Bridges, R-N.H., chairman of the Senate GOP Policy Committee. Bridges said that Truman was "one of the most politically-minded men" he ever met.

Chief Justice Warren, another Republican, said that he had become through the years, "much attached to President Truman."

Memorial Hospital.

Mature Outlook Needed By U. S., Says Philosopher

SAN FRANCISCO (AP)—Americans need a mature, realistic outlook on global and domestic problems, says Dr. Abraham Kaplan, UCLA philosopher.

Speaking to the South Pacific Regional Conference on Child Welfare, Dr. Kaplan said: "A mature self is secure, but our politics is beset by anxiety. Unfortunately today we have more to fear than fear itself, but the fear makes matters worse."

Abroad, he went on, Americans suffer from a sense of guilt.

"We extend foreign aid, not just with the idea of strengthening democracies abroad, but as a penance for our wealth. And then we demand forgiveness and love because we have exploited our sins."

Americans, he said, tend toward manic depression ("alternating between the rosiest self-confidence and the blackest despair.")

The Soviets, he said, tend toward grandeur and of persecution."

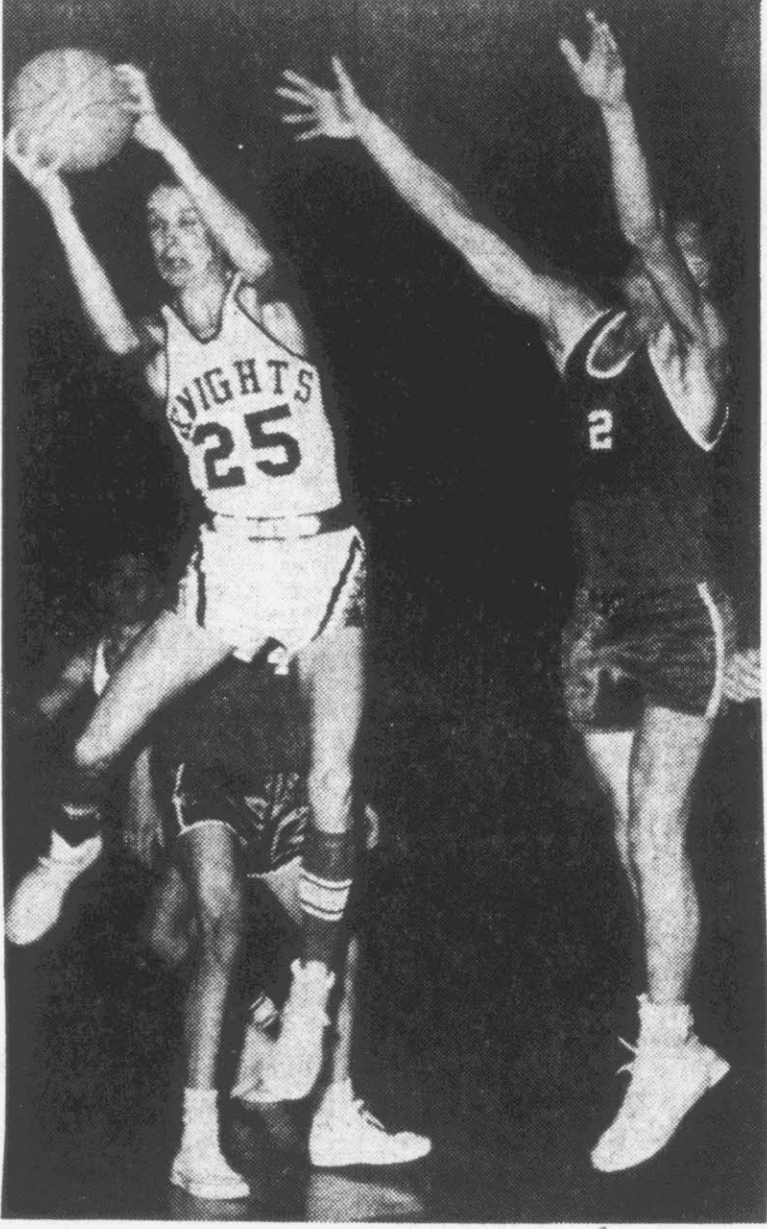

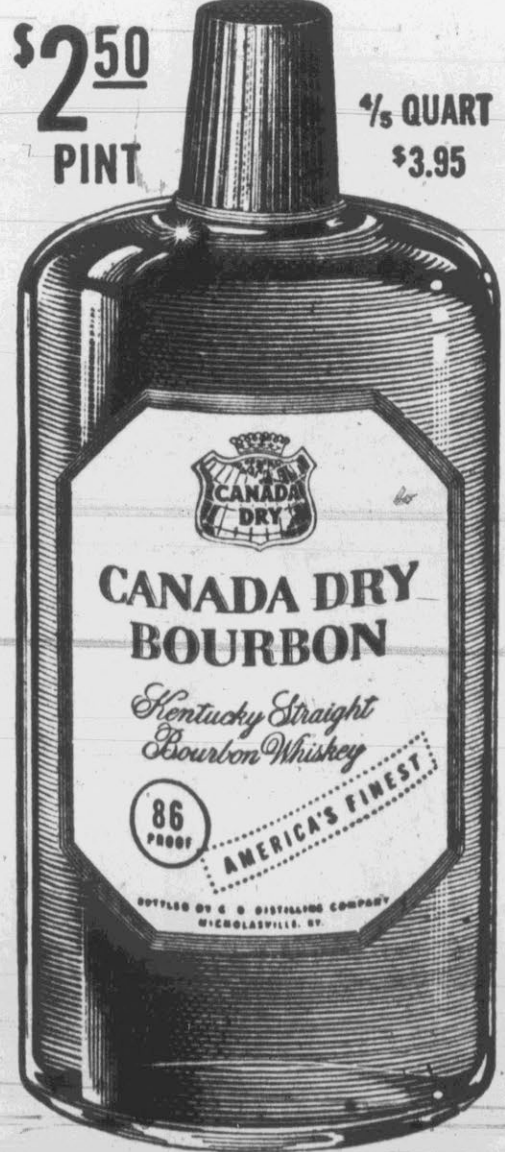

Kentucky Earns NCAA Tourney Berth

Who's the biggest stumbling block in mighty Ohio State's bid to repeat as National Collegiate basketball champion? Down Blue Grass way, and maybe elsewhere too, they're likely to tell you it's Adolph Rupp, now that his revitalized Kentucky Wildcats have parlayed a 10-game winning

streak into a record 12th appearance in the NCAA tournament.

The Wildcats, all but written off after they lost three of their first four conference games and won only eight of their first 15 over-all, showed Thursday night they've come all the way back by crushing Vanderbilt 88-67 in a neutral court playoff to determine the Southeastern Conference rep-

representative in the tournament.

Now it's on to the NCAA Mid-East regional at Louisville for the Wildcats. If Kentucky gets past its first NCAA game, March 17, and Ohio State also wins its first game, they'll be matched in the Mid-East regional final the next night.

For the record, Ohio State—everybody's No. 1 and now riding a 28-game winning streak—has

lost only three games in the two years Jerry Lucas and buddies John Havlicek, Larry Siegfried and Mel Nowell have been together. One of the three losses was to you guessed it—the Kentucky Wildcats, 96-93, back in December 1959.

The Wildcats have one tune-up before the tournament opens—playing their regular season finale against another NCAA-bound team, Marquette, at Chicago Stadium Saturday night.

regular Western Conference season, they won the conference tournament last week, beating co-champions East Mecklenburg and Gastonia on successive nights.

Gastonia had won two earlier games from Myers Park.

For the first half against Reynolds, Myers Park treated the crowd of 1,500 to the finest exhibition of the tournament to date.

The Charlotte team set up plays beautifully, passed sharply, shot only when good opportunities were present and seldom missed, to lead Reynolds, winner of 19 in a row, 27-20 at the half.

Reynolds came back to tie the score at 49-all at the end of regulation. Each team hit six points in the first overtime, during which Reynolds' ace Richard Herring fouled out.

In the sudden death period, Graham grabbed a rebound and tossed

the ball in for the clincher to touch off a riotous demonstration in which Mustang supporters mobbed their heroes.

Myers Park hit 20 of 55 shots, with Bobby DuRose the leader with 20 points and Graham collecting 13. Herring had 23 for Reynolds, which stayed in contention by hitting 19 of 25 free throws.

One of Rozsavolgyi's rivals will be Bruce Kidd, 17, of Toronto, youngest athlete ever to win a National AAU title which he took in the three-mile run. The Canadian schoolboy recently ran the two-mile indoors in 8:49.2, second fastest time for the event ever recorded in this country.

The other schoolboy star is Tom Sullivan, 18, Chicago St. George High School senior, who is entered in the Harry Gill 1,000-yard run against such seasoned joggers as Ed Moran of Penn State and Olympian Peter Close.

Sullivan got a standing ovation from 13,000 fans in Los Angeles earlier this winter when he ran a 4:13.7 mile.

Rozsavolgyi's 4:01.8 clocking in last week's Knights of Columbus meet in New York was only four-tenths of a second off Don DeLaney's indoor mile record of 4:01.4 set in 1959. Rosy's other

rivals in the Baker's Mile include Charles (Deacon) Jones, a 4:07.8 winner of the Boston K of C Mile this winter and Lt. Lew Stierliw, winner of the Chicago Relays' two-mile title in 1959.

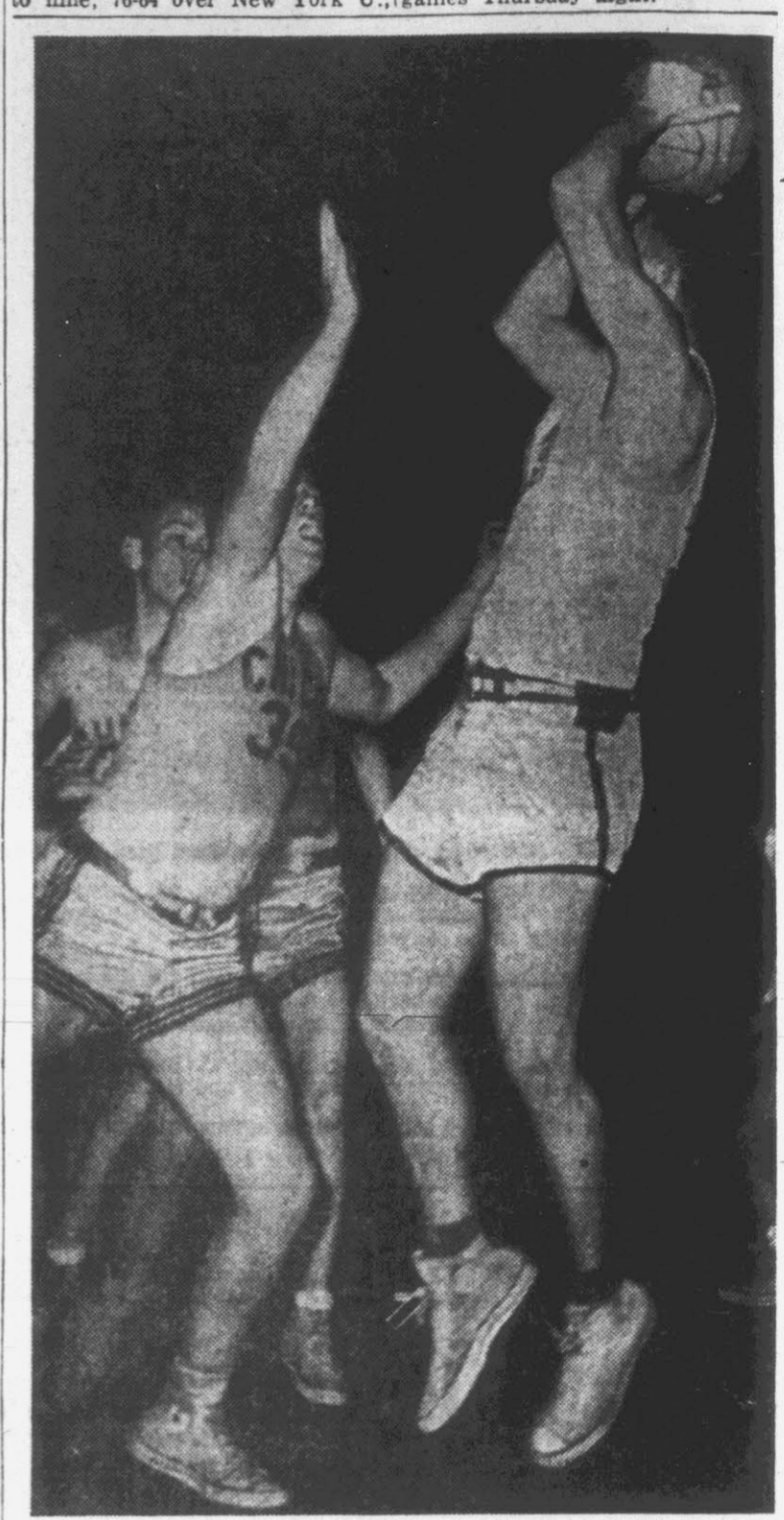
Warriors' Wilt Cracks Record

The students claimed the record anyway.

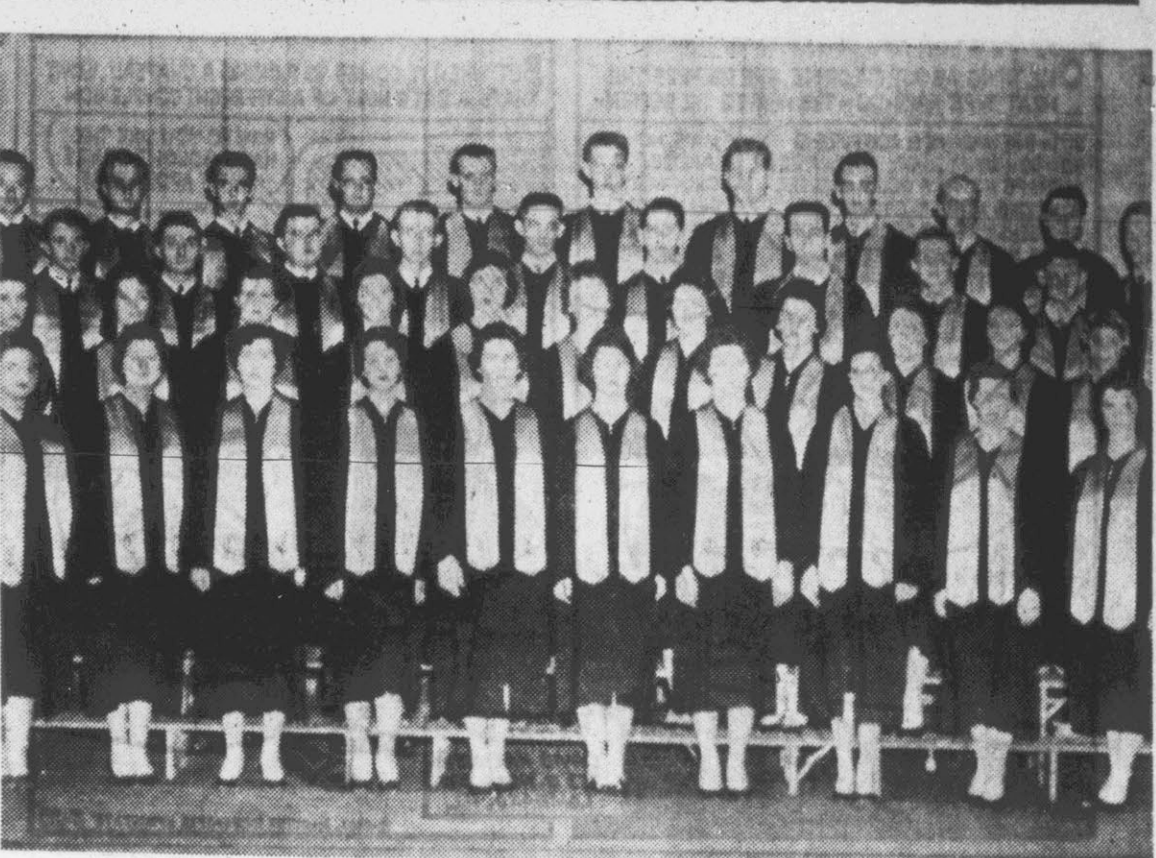
Unpopular Nazi Term Retained

Ed Sullivan Offers Debate Price War On Paar's Show

By ANDREW MEISELS

NEW YORK (AP)—Ed Sullivan offered today to take his price war with Jack Paar over performers' fees before the late-night television public and to debate Paar on Paar's own show.

Sullivan, star of a show on CBS, made the offer in answer to Paar's challenge that the two settle their differences by staging a rating duel.

Paar issued the challenge on his nationwide NBC-TV program Thursday night, suggesting he appear on the NBC network from 8 to 9 p. m. some Sunday against Sullivan and see who gets the higher audience rating.

The feud stems from a statement Sullivan made Thursday.

He said he would cut the salaries of performers who collect thousands of dollars for appearing on his show and then perform Paar's informal program for the minimum scale of \$320.

Sullivan said he had nothing against performers going on the Paar show to talk. But it was unfair, he said, for performers to ask—and get—as much as \$7,500 for a performance from him and then do the same work for Paar for the minimum.

One performer scheduled to appear on the Paar show Thursday night, comedian Myron Cohen, canceled at the 11th hour because of the Sullivan ultimatum.

Stung by Sullivan's stand, Paar told his audience: "Ed Sullivan today declared war on this show."

Reading a letter that he had sent to Sullivan, Paar said he was "appalled" that the CBS star had raised the question of performers' fees.

"I don't have the money to pay performers what you do," Paar said. "This show is a low-budget break that caught on because performers want to come on and want time to entertain people."

Paar said he had given many new performers their first break on television and that he was delighted when these performers could later appear on Sullivan's show for more money.

Where except on a show like his, could new performers start their television careers, Paar asked in the letter. He recalled that Sullivan had given him a break four years ago by booking him on his show five times at \$5,000 per performance.

Paar said he never forgot that kindness, and that when NBC and Steve Allen subsequently asked him to appear on Allen's show, which competed with Sullivan, "I said no, he is my friend. He treated me well."

"I can't be bought, Ed," he added, "nor can my loyalty to a friend."

Then Paar went into his challenge, urging Sullivan to name the night and to take the first choice of talent. He suggested both should contribute their salaries that night to a fund for needy actors.

"Then all of you, in a way, can vote," Paar told his audience. "Watch the show you want to watch, and maybe I'll learn a terrible lesson. But it will be fun, Ed, wouldn't it? Come on, old boy."

Sullivan was quick to pick up the gauntlet, but he suggested a different choice of time, place and weapons.

"I think tonight's the best show

Paar's ever had," he said. "When you go on and abuse somebody it makes very exciting listening. It does to me, and I was the one being abused."

Wins Honorable Mention In Competition

Thomas T. Jackson of Godwin, senior at East Carolina College has received notification that he was accorded honorable mention in competition for election as a Woodrow Wilson Fellow for 1961-1962. Competitors numbered 10,453 from colleges and universities throughout the country.

The Woodrow Wilson National Fellowship Foundation has just named as fellows 1,333 students from 381 college and universities in the nation; and as recipients of honorable mention a total of 1,614 others.

Fellowships cover the first year of graduate study and are aimed at attracting newly-elected fellows into college teaching as a possible career.

"On the basis of past experience," an announcement from the Foundation states, "the Foundation anticipates that most of those winning Honorable Mention will receive alternate awards either directly from universities or from other organizations."

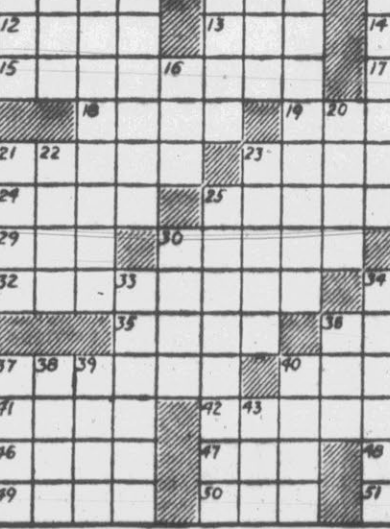

Crossword Puzzle

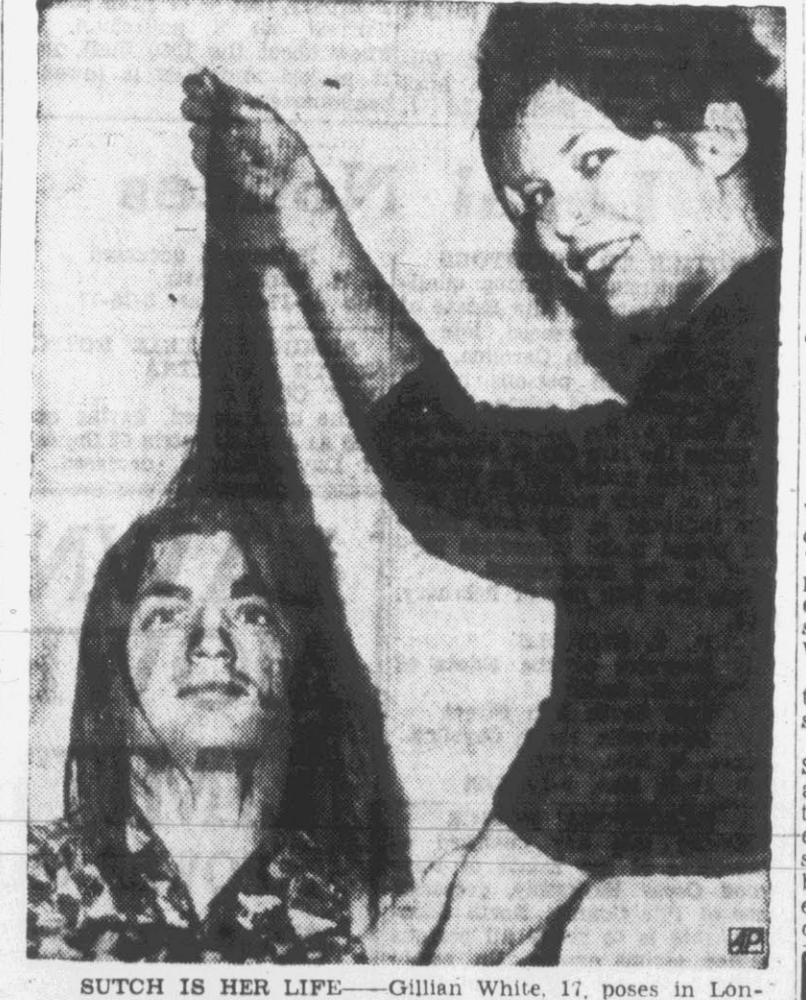

Light Snow Falls Over Northeast

By THE ASSOCIATED PRESS A light snow fell early today over most of the northeast portion of the country.

Some snow, of varying density, also fell over portions of the Northwest. About the heaviest there was one-fourth inch in the Portland, Ore., area.

The Northeast's snow, driven by a low pressure area out of the Atlantic, overlapped into the Upper Ohio Valley, over the Appalachians and into eastern Tennessee.

Most of the Northeast was hit Thursday by a storm that dropped up to 18 inches of snow under power of 40 miles-per-hour winds. In a two-day sweep from the Midwest to Northeast, the storm took a total of 27 lives, 16 of them in Wisconsin.

The Chicago Weather Bureau said most of northern Maine today lay under a blanket of 40 or more inches of snow.

Showers fell early today over most of Washington state, Oregon and northern California. Scattered snow was noted over upper elevations of Montana, Wyoming and Idaho.

Early temperatures ranged under the freezing mark in the Northeast, the north central area and in the northern Rockies. Most of the country had readings in the upper 20s and 40s, except the Southwest where 50s and 60s predominated, and along the western Gulf Coast and southern Florida where temperatures were in the 50s.

Over a period of years he worked his way to the position of cashier and member of the board and was serving in this capacity when the bank merged with the old Greenville Banking and Trust Co. in 1931. At that time, Ives continued to serve as cashier. The bank's name was changed to the Guaranty Bank and Trust Co. in 1935, and then in May, 1960 to Wachovia Bank and Trust Co. Ives now serves as head of the office and assistant vice president.

Ives is a past president of the Rotary Club and a charter member. He has served on numerous occasions and presently serves as a member of the Bethel Board of Commissioners. He is presently a Steward of the Bethel Methodist Church, and for over 20 years he has also served as a trustee. He has been secretary of the Board of Pitt Memorial Hospital and currently is a trustee.

Likens Campaign To Battlefield

SMITHFIELD, N.C. (AP)—Gov. Sanford said here Thursday night his campaign for better schools in North Carolina is of equal—if not greater—importance than the battle campaigns of World War II.

"For the first prerequisite to democracy is an educated citizenry," declared Sanford, a veteran of World War II.

He told an education rally in the Smithfield High School gymnasium he has traveled more miles across North Carolina during the last 13 months, asking for support for the schools, than he traveled all through the war.

Sanford proposed to the legislature Monday night that his school improvement program be financed by removing exemptions, including food, from the 3 per cent sales tax and increasing the tax on whiskey.

"No one is going to go hungry because of this tax," Sanford said. "But the children of North Carolina will go thirsty for quality education if we do not enact this program for better schools."

"North Carolina," he said, "is rightly concerned when anyone attempts to lower our tobacco parity of 90 per cent. Yet we have let our children's educational parity fall to less than 66 per cent."

Phone Company Finishes Work In Rural Project

Telephone Company construction forces have completed work on a project which provided service to some 25 applicants and the location of one paystation along U.S. Highway 264 East of Greenville to Grimesland and vicinity.

This was disclosed today by Frank Harrington, local manager for Carolina Telephone and Telegraph Company at Greenville, who stated the accomplishment of this project involved placing approximately 11 miles of buried cable and three miles of aerial wire at an estimated expenditure of \$45,095.

This is one of many such rural projects being undertaken by the Telephone Company to provide service to its 41-county operating territory.

In 4-H Club work a large variety of projects and activities are available for the members. Any 4-H'er can choose exactly the project that is of the greatest interest to him. Project work helps to increase knowledge of a particular subject, thus improving a member's club, community and country.

Suspect Cake A Factor In Illness Following Dinner

Dr. Georgia V. Mills today pointed a suspecting finger at a "mushy" coconut cake served at a group of county and state officials at the Pitt County Home Monday. Some of the officials were ill Monday evening.

The Pitt County health director singled out the coconut cake as the food "that could have been, and evidently was, the causative factor" in a wave of nausea that affected at least eight of the 15 officials who lunched at the county home Monday.

She made known her suspicion of the cake today after she received reports from Raleigh's state health department laboratory stating negative results in tests of samples of barbecue and sweet potato pie also served Monday.

Dr. Mills said samples of the cake and cole slaw, another item on Monday's menu, were not available after the noon meal. "Both the slaw and the coconut cake were all eaten up," she said.

The reason for suspecting the cake, she pointed out, was twofold. She said 11 of the 15 officials who ate lunch at the county home were contacted and eight of the 11 had eaten the cake and reported symptoms of nausea.

The other reason, she said, was that no illness was reported among the county home inmates and no cake was given to them. She said the health department's investigation showed some of the other food was fed to the inmates in spite of instructions Monday night "to bury it."

Substantiating her suspicion of the cake she said was described as "mushy." Dr. Mills said the county home dietitian reported baking the cake Sunday night and setting it out, unrefrigerated, until Monday noon.

She also said County Home Supt. Horace Hardee reported the coconut used in preparing the cake was left over from Christmas. She pointed out coconut, unless properly preserved, is easily contaminated.

Nominations Made For Elmhurst PTA Officers

Nominations for next year's officers were presented last night during the monthly Elmhurst P.T.A. meeting. Dr. Douglass Jones of the East Carolina College Education Department was guest speaker.

Nominations for the officers were presented by Mrs. Ed Rawl, as follows: Mrs. Bill Corbett, president; Dr. Sam T. White II, vice president; Mrs. O. A. Verner, recording secretary; Mrs. Bill Watson, corresponding secretary; and Bill Hudson, treasurer. These were unanimously accepted by the members.

Dr. Badger Clark introduced Dr. Jones who spoke on "Healthy and Irritating Signs of Independence in the School Child," using a movie film to emphasize his remarks. Dr. Jones has done considerable work on the elementary grade level.

"A feeling of independence comes to most of all of the well adjusted children, but it will be ushered in by different signs," Dr. Jones said. As a child grows in maturity and experience, he begins to develop his own way of doing things and sometimes this way doesn't meet with the approval or acceptance of other children.

This child may have many emotional fears, frequently a result of a lack of security and of a feeling of not belonging to the group. A child who is neglected of attention, love and companionship at home, most assuredly will not be completely well adjusted and will probably attempt his independence in irritating ways. Dr. Jones continued.

This child will, in general, make a nuisance of himself, attempting to create attention in the classroom and on the playground by being boisterous, clowning, temper tantrums or by complete withdrawal from the group. By recognizing and accepting these signs of independence, both parents and teachers may better handle these unattractive antics in so far as causing his efforts to conform with the group. Once the group accepts him for what he is, or the way he thinks, he will have achieved a well adjusted independence, Dr. Jones said.

He pointed out some of the healthy signs of independence, such as helping with younger brothers and sisters and accepting responsibilities, which are given at home. The healthy child will have an interest in his personal appearance, but will also have a desire to be alone to play and plan activities, even to the extent of "Keep Out" notices on the club house or bedroom doors.

"We must not rush the child into early growing up nor leave him groping for a pattern, but rather we should behave as we would like our children to behave," Dr. Jones concluded.

In the absence of President Dr. Henry Aldridge, Mrs. Bill Corbett, vice president, presided. The minutes of the last executive council meeting were read by acting secretary Mrs. T. R. Jones. Sam Weeks reported on the last project for this school year, picture sales of each class.

A report on legislative efforts toward educational improvements was given by Sam Underwood.
